PTI Accuses Establishment Of Exerting Pressure On State Institutions Following Delay In Iddat Ruling

ISLAMABAD: A delay in the ruling on the un-Islamic nikah case has apparently shattered Pakistan Tehreek-e-Insaf (PTI) hopes of the early release of its founder Imran Khan from prison.

Addressing a press conference in Islamabad on Wednesday, PTI Information Secretary Raouf Hasan said state institutions were trying to keep the party founder behind bars despite him securing bail in several cases.

"Establishment's pressure on state institutions is piling up," he stated while reacting to the delay in the announcement of a reserved verdict in the iddat case against the PTI founder and his wife Bushra Bibi by an Islamabad sessions court earlier today.

The Islamabad court had reserved the verdict last week on appeals filed by the PTI founder and his wife against their conviction in the iddat case.

However, District and Sessions Judge Shaukht Arjumand sought his recusal from the case because it would not be appropriate for him to announce the verdict owing to repeated expression of no-confidence by Khawar Maneka, Bushra's ex-husband and the petitioner in the case.

In the presser today, the



PTI spokesperson said the party has been witnessing "murder of justice" for the last two years and expressed fears that the former prime minister would have to spend more time in jail.

Khan, the deposed premier, has been behind bars since August last year after he was convicted in the Toshakhana case.

Although, the PTI founder was granted bail in the case, he remains incarcerated owing to his conviction in other cases including un-Islamic marriage and eptier. He said the PTI founder should have been released from jail after his sentence was suspended in the Toshakhana case.

"We fear that more cases will be lodged against the PTI founder soon," the party's spokesperson said, claiming that iddat and other cases against him were

Supreme Court Rejects British Envoy's Comments On February General Elections

ISLAMABAD: The Supreme Court has severely criticised British High Commissioner to Pakistan Jane Marriott's recent speech targeting the South Asian nation's general elections in 2024, calling on the UK to learn from past mistakes and move on.

In a speech during the Asma Jahangir conference last month, Marriott while quoting British Foreign Secretary David Cameron raised concerns about Pakistan's February 8 elections.

"...not all parties were formally permitted to contest the elections and that legal processes were used to prevent some political leaders from participation, and to prevent the use of recognisable party symbols," Britain's top diplomat had said.

She then noted that Pakistan's government, civil society, and global players should work to nurture an "open society" and "vibrant democracy" as open societies are transparent.

The top court's registrar, in a letter to the envoy, said that her criticism of a certain political party being sidelined by stripping it of its symbol was unfounded as it did not follow the law.

The letter, drawing attention to the court's role, said elections were required to be held within 90 days of the completion of the tenure of the national and provincial assemblies.

However, they did not



take place because then-president Arif Alvi and the Election Commission of Pakistan (ECP) were at odds regarding who was empowered to announce the election date.

"The matter was resolved in just 12 days by the Supreme Court, and general elections were held throughout Pakistan on 8 February 2024," the registrar said.

Previously, it mentioned, that many wanting to contest elections in Pakistan faced a lifetime ban because they were not considered honest and trustworthy (Sadiq and Ameen) by the Supreme Court.

However, a larger seven-member bench overruled the earlier decision, it said, holding that it did not conform to the Constitution and the law.

The registrar said that the law enacted by Parliament (Elections Act, 2017) requires democracy within political parties via the holding of periodic intra-party elections, to forestall autocracy or even dictatorship within them.

To ensure compliance with this democratic princi-



ple the law stipulates, it said, that if a political party does not hold intra-party elections, then it would not be eligible for an election symbol.

"A political party (which had itself voted in this law) did not hold the mandated intra-party elections. The Supreme Court reiterated what the law stipulated," the letter said.

Therefore, the registrar said: "...your Excellency's criticism with regard to this decision, with utmost respect, was unjustified."

It is worthy to mention that it was upon the current chief justice's assumption of office that cases of public importance began to be broadcast live for the first time in Pakistan's history. This allowed the public at large to view Supreme Court proceedings in their entirety, with transparency in regard to how decisions came to be made. The decision regarding intra-party elections and party symbols was one of many to be broadcast live as such.

Updating Britain regarding a recent ruling, it stated:

"It was gratifying that your Excellency had repeatedly stressed the importance of open societies' which you stated are necessary for vibrant democracies. You will be pleased to learn that the Supreme Court has recognised the right to information and vigorously applied it to itself, a copy of its decision is attached as D".

"Persisting in the violent undemocratic mistakes of the past condemns present and future generations, and perpetuates cycles of violence. Let us embrace truth, which sets us free," it added.

Raising some questions, the top court's letter read: "Should the overthrow of the elected democratic government of Mohammad Mossadegh in 1953, to capture Iranian oil, not be revealed after over seven decades of cover-up? Will this not prove therapeutic for the perpetrator and the victim? Will it not engender trust, possibly friendship, and peace?"

"Ceding to what it described as Jewish Zionist aspirations, the British government wrote to an individual, its own citizen, on 2 November 1917 convening its decision to establish a settler-colonial state. This decision was not voted upon by the people of the area who were impacted by it, nor even by your own. The British government, and not Parliament, unilaterally decided it. The Balfour Declaration became the foundation on which an

ethnic state was established. Those who had always lived there were excluded from this ethnic state, contained in ghettos, humiliated, deprived, brutalised, maimed and killed."

Let us step back from the precipice of settler-ethnic superiority. Deaths of thousands of children and many thousands more innocents may unjustifiably come to define a people, which would be an abomination. Let us all stand up and be counted for equality, peace and humanity, the apex court stressed.

"Let us be honest and acknowledge past mistakes in the spirit of openness, advocated by your Excellency. And, jettison the unholy concept of ethnic superiority, and its concomitant humanity — an inferior humanity."

"The Supreme Court of Pakistan has acknowledged the mistakes made in its past, addressed them in detail, and taken steps to ensure that they are not repeated. Since the Government of His Majesty King Charles III has stressed the need for open societies and democracy, and offered criticism on the decisions of the Supreme Court of Pakistan, reciprocity would presumably be acceptable. —This letter is written on instructions of the Chief Justice of Pakistan, who extends to you and the people of your country his yearning for openness and democracy, and his best regards," it concluded. —RT/Agency

28 Dead As Bus Overturns In Balochistan's Washuk

WASHUK: At least 28 people, including women and children, were killed after a passenger bus turned turtle and plunged into a ditch in Balochistan's Washuk district on Wednesday morning.

According to rescue and Levies officials, about 22 people sustained injuries in the accident and have been moved to the Civil Hospital in Basima.

The accident took place after the tyre of the passenger bus burst, said the rescue officials. The bus was travelling from Gwadar to Quetta. Prime Minister Shehbaz Sharif expressed his condolences over the incident, praying for the departed souls.

The premier also directed the authorities concerned to provide assistance to the injured.

Balochistan's Chief Minister Sarfraz Bugti offered his condolences over the loss of lives in the horrific accident and prayed for those who were wounded.



In two similar incidents in May, 13 people belonging to the same family were killed and nine others got wounded as a truck plunged into a ditch in Punjab's Khushab district.

The accident occurred because of a brake failure on Panj Pir Manawan Road in Khushab, consequently, the truck driver lost control of the vehicle and it fell into the ditch.

The deceased of the ill-fated crash included women, too, and the family was going to Khushab. Meanwhile, 20 people

lost their lives while 21 sustained injuries after a passenger bus veered off a narrow mountain road and plummeted into a ravine in a remote area of Diamer district, Gilgit Baltistan.

The mishap took place at the Yashokhal area on the Karakoram Highway in Diamer early Friday morning at around 5:30am, according to police. The bus was on its way from Rawalpindi to Gilgit. Meanwhile, the police said there were at least 38 passengers on board. —RT/Agency

International Consensus Wanes As Russia Hints At Recognizing Taliban

ISLAMABAD: When Kabul fell to the Afghan Taliban in August 2021 without firing a single shot, there was a near-international consensus among the big powers as well as regional players on the future of Afghanistan.

All major powers, including the US, China, Russia, and regional players such as Pakistan, Iran, and others, agreed the Taliban had to fulfil certain conditions before their de facto government was recognised. Those conditions included forming an inclusive government, respecting women's and human rights, and not allowing Afghan soil to be used again by terrorist groups. Pakistan was one of only three countries that recognised the Taliban's first rule from 1996 to 2001, but this time it aligned with the international consensus on the question of recognition.



Among the major players and stakeholders remained in place for a good two years before the international consensus started falling apart. The first sign of rupture came in March when China accepted the full-time ambassador appointed by the Taliban regime. Though Beijing never officially recognised the Taliban government, its move to accept a full-time ambassador was seen as tacit recognition. Now, another major power and stake-

Farooq Naik Calls For Withdrawal Of Amendments In NAB Law

ISLAMABAD: People's Party leader Farooq H. Naik has demanded withdrawal of recent amendments in the NAB law made by an ordinance, media reported on Wednesday.

He called the NAB (Amendment) Ordinance 2024 a draconian law. He said the PDM had made three amendments in the NAB law. "Now this new ordinance has come to force, which was not taken before the parliament. This practice should not be followed," he stressed.

He said more than 14 days' remand period negates the law. "Why the officer involved in registering fake cases should not be convicted," he questioned while com-

menting on the amended NAB law. "While the NAB accused getting 14-14 years sentences from courts," he said.

The National Accountability Bureau (NAB) can now detain the individuals accused in cases under the anti-graft watchdog for 40 days after acting President Yousaf Raza Gilani signed the NAB (Amendment) Ordinance 2024 into law.

The new ordinance has extended the period of remand accused in NAB cases from 14 days to 40 days. Moreover, the sentence duration for the officer convicted for framing cases based on ill will, has been reduced to two years from five years. —RT/Agency

Imran Challenges Punjab Cabinet's Decision On New Cases In LHC

LAHORE: Pakistan Tehreek-e-Insaf (PTI) founding chairman Imran Khan petitioned the Lahore High Court (LHC) on Wednesday, challenging the Punjab cabinet's decision to register additional cases against him and other PTI lawmakers.

The former prime minister's petition, filed through prominent party counsel Sardar Latif Khan Khosa, argued that the cases are "unlawful and unconstitutional," asserting that he and his party members are being falsely accused. On May 24, Punjab Chief Minister Maryam Nawaz's cabinet approved the initiation of 'fresh legal action' against Imran and other party leaders for their purported involvement in crafting a 'narrative of hate' against state institutions, especially the army. The petition stated that PTI Maryam's cabinet approved a request from the home secretary to register new cases



against PTI members. Imran, through his counsel, requested certified copies of agenda item 11 from the May 24 cabinet meeting, along with the minutes and recommendations. However, he has not received the requested information. In his petition, Imran stated that numerous cases against him stemmed from events on May 9, when he was arrested at the Islamabad High Court (IHC), leading to widespread unrest and damage in various cities, including Lahore's Corps Commander House. He emphasised that approximately 10,000 PTI workers and nearly all party leaders were detained, with many still imprisoned a year later. In response to these detentions, Imran filed a writ petition in the LHC seeking a declaration that the charges against him in multiple FIRs are illegal and beyond jurisdiction. The court admitted the petition on July 7 and ordered on July 14 that no coercive action could be taken against Imran in cases where he is not named until further hearings. —RT/Agency

PTI Lawyers Accused Of Assaulting Khawar Maneka

ISLAMABAD: In an unpleasant turn of events, Pakistan Tehreek-e-Insaf (PTI) lawyers Wednesday attacked former first lady Bushra Bibi's ex-husband Khawar Maneka in the premises of the court as he appeared for a hearing of the un-Islamic nikah case in a district and sessions court in Islamabad.

During the hearing of appeals filed by Bushra her husband and PTI founder Imran Khan against conviction in the iddat case, Judge Shahrukh Arjumand went into his chamber without announcing the verdict.

Following the development, PTI lawyers hurried into the courtroom which prompted Maneka's lawyers to escort him out. However, while being escorted out, a PTI lawyer then attacked Maneka within the



court premises after which he fell to the ground.

The court, on May 23, reserved the verdict on the appeals which was to be announced today.

Maneka, in January, had moved the court challenging Khan and Bushra Bibi's marriage and terminating their nikah as fraudulent, stressing that the marriage was solemnised during her iddat (the time a woman goes into isolation

after a divorce or her husband's death).

The trial court then handed down a seven-year sentence to the couple in February and imposed a fine of Rs500,000 each on the duo. In its 51-page detailed verdict, the court maintained that the record proves that both of the accused, Khan and Bushra, were in relation before the 2018 "fraudulent" nikah. —RT/Agency

pressed that in Quetta, where they can work comfortably and their families can live in peace.

The relocation typically lasts for three to four months until the weather changes, after which they return. This pattern highlights the severe impact of the heat and electricity crisis on the livelihoods and daily lives of Jacobabad's residents.

FIA Larkana summons varsity officials over irregularities

LARKANA: The Federal Investigation Agency (FIA) Circle in Larkana has issued summonses to several individuals affiliated with Shaheed Mohtarma Benazir Bhutto Medical University (SMBBMU), Chandra Medical College (CMC), and Ghulam Muhammad Mahar Medical College (GMMMC) Sukkur for an investigation scheduled on May 30th. In a letter addressed to the Registrar of SMBBMU, the FIA summoned six individuals, including five senior and one

junior clerk associated with CMC, Asifa Dental College, and GMMMC Sukkur, as well as a former principal. The officers summoned by the FIA include Dr. Nadeem Baloch, Deputy Director of Pharmacy at SMBBMU, Dr. Om Kash, Head of the Pathology Department, Waheed Zaman, Administrator of Chandra Medical College, Professor Muhammad Rafiq Memon, former Principal of Ghulam Muhammad Mahar Medical College Sukkur, Prof. Dr. Qaim Din Shaikh of Asifa Dental College, and Junior Clerk Riaz Ahmed Hulo. Ad-

ditionally, a day prior to this, Registrar Dr. Saifur Shaikh of Shaheed Benazir Bhutto Medical University was also summoned by the FIA for the same investigation. The summonses indicate a significant development in ongoing investigations, although the nature and specifics of the investigation were not disclosed in the statement. It is anticipated that the summoned officials will cooperate with the FIA in the investigation process to ensure transparency and accountability within the medical institutions under scrutiny.

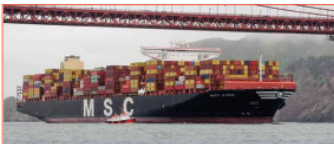

CTD Arrests Eight Suspects In Operations Across Sindh

Sindh CM Prioritizes Teachers' Training And Data Bank For Students

KARACHI: Sindh Chief Minister Syed Murad Ali Shah has directed the School Education Department to strengthen teacher training, establish a comprehensive data bank of students, and recruit teachers for the upcoming session.



Presiding over a meeting at CM House, Shah emphasized improving the educational environment and ensuring well-trained teachers to produce a well-educated new generation. He stated, "We are committed to improving the educational atmosphere in the classroom and ensuring teachers are properly trained."

Education Minister Syed Sardar Shah briefed the CM on the status of 43,027 schools, noting that 19,808 were damaged by recent floods, yet classes continue in makeshift arrangements. The CM assured that reconstruction would be supported by donor agencies and the federal government in the next financial year.

The CM directed the Education Department to maintain a detailed data record of teachers from appointment to promotions. He also stressed developing a data bank for students from pre-primary to higher secondary levels based on their B-form for accurate tracking and to address dropout rates effectively. Shah highlighted the importance of accurate data for school-going children and out-of-school children to incentivize education. The meeting revealed 30,000 vacant teaching positions, and the CM instructed the department to provide recommendations for filling these positions in the next budget.

Additionally, the CM ordered regular inspections and upgrades of science labs, libraries, and workshops in high schools, extending these facilities to up-graded primary and elementary schools.—RT

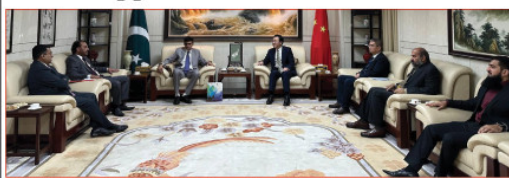
ACE Intensifies Investigation Into Massive Irregularities In KWSC

The removal of harassment and corruption will lead to more tax compliance

The recent move to unblock over 7,000 SIM cards following the submission of income tax returns is a welcome development in Pakistan's ongoing efforts to broaden its tax base. This innovative approach by the Federal Board of Revenue (FBR) has demonstrated that out-of-the-box solutions can yield tangible results, as evidenced by the filing of 7,167 new tax returns. However, while this initial success is commendable, the journey to bring a significant number of citizens into the tax net is far from over.

The FBR's strategy of leveraging mobile connectivity to enforce tax compliance is clever, yet it also underscores the need for deeper reforms

within our tax system. The current cumbersome tax filing process must be streamlined to encourage voluntary compliance. One significant barrier



is the pervasive fear of harassment by tax authorities, which deters many from filing returns. To address this, the introduction of a fixed tax scheme with a no-questions-asked policy could be a game-changer. Such a scheme would reassure taxpayers that they will not be subjected to undue scrutiny or corrupt practices, potentially increasing compliance rates. Moreover,

the government must lead by example. If we are to instill a culture of tax compliance, it should be mandatory for every parliamentarian, officeholder, bureaucrat, and even non-civilians to file their taxes annually, including the rejection of zero returns when applicable. This would not only set a precedent but also build public trust in the tax system. And while blocking SIM cards has yielded positive results, sustainable progress will require comprehensive reforms. Simplifying the tax process and ensuring that all public officials lead by example are crucial steps. Only then can we hope to significantly increase tax compliance and secure a fair contribution from all citizens towards national development.

Terminated employees of Kario Ghanwar Oil Field demand justice

TANDO MUHAMMAD KHAN: The residents of Pir Ali Shah village in the Tando Ghulam Hyder area, including Ali Asghar Shah, Muhammad Yousef Shah, and Ahmed Ali Shah, have raised their voices against injustice as they demand justice for their wrongful dismissal from the Kario Ghanwar Oil Field four years ago.

Narrating their ordeal to journalists, the aggrieved workers revealed that they were unjustly terminated from their positions at the oil field by the contractor, Noor Muhammad Bhatti, leaving them without employment. Despite seeking assistance from various local leaders, their pleas for justice fell on deaf ears, as the contractor's influence thwarted their efforts.

Faced with no other recourse, they turned to the legal system, where the Civil Judge issued notices to Noor Muhammad Bhatti. pealing to the Senior Superintendent of Police (SSP) Tando Muhammad Khan, the Station House Officer (SHO) Tando Ghulam Hyder, and the Civil Judge to intervene, provide them with protection, and take swift action against Noor Muhammad Bhatti, including his arrest.

The plight of these sacked workers highlights the pressing need for accountability and protection of labor rights, as they continue to pursue justice against powerful interests.

He scored 19 goals and had six assists in 28 league games this season, and tallied 23 goals and 12 assists in all competitions for the club. Bellingham, who could not attend Tuesday's ceremony in Sardinia as he was preparing for the Champions League final at Wembley against his former club Borussia Dortmund, said he was honoured to have received the award.

"I would like to dedicate it to my team mates, the coaching staff and, most importantly, to the fans of the best club in the world," he said in a message.

"It's a pleasure every time I play for this team. Hala Madrid!"

The Englishman also won the 2022-23 Bundesliga Player of the Season playing for Dortmund before moving to Real for a fee of around 103 million Euros (\$111.71 million).

Earlier on Tuesday, Dortmund sporting director Sebastian Kehl was full of praise for Bellingham. "I know how strong Jude is and I know his personality very much, so he's an amazing player, an amazing character and of course, he will do everything to win that final," he said. —Agency

Djokovic shrugs off troubles in winning start at French Open



PARIS: Defending champion Novak Djokovic shrugged off his recent troubles to sweep his way to the top of the French Open, extending his run of first round Roland Garros victories to a perfect 20.

Djokovic, chasing a fourth title in Paris and record 25th Grand Slam triumph, came through against 142nd-ranked French wildcard Pierre-Hugues Herbert 6-4, 7-6 (7/3), 6-4.

The 37-year-old, who saw career-long rival and 14-time champion Rafael Nadal exit the tournament on Monday, had arrived under a cloud.

For the first time since 2018, he is without a title and has yet to reach a final this season.

He has also endured recent misfortunes being accidentally hit on the head by a metal water bottle in Rome

and then suffering stomach problems in Geneva.

"It was a solid performance," said Djokovic. "I could have done better, especially on the return, but bravo to him for serving well."

"It's a victory in three sets, that's what matters at this moment. I felt better compared to the last few weeks. I was focused. I encouraged myself. I am satisfied with my state of mind."

Djokovic, who has advanced to the French Open quarter-finals or better every year since 2010, will face Spain's 63rd-ranked Roberto Carballes Baena for a place in the last 32.

Australian Open champion Aryna Sabalenka, a semi-finalist in 2023, overpowered Russian teenager Erika Andreeva 6-1, 6-2 in just 68 minutes under the roof of Court Philippe Chatrier as heavy rain caused a five-hour delay to action

around the grounds.

World number two Sabalenka fired 27 winners past the 100th-ranked Andreeva and broke serve five times in a dominant display.

"I'm trying to do well on clay, it is tough conditions here but I enjoy playing here and I'm just trying to bring my best tennis every time - whatever the surface," said Sabalenka.

The Belarusian has made at least the last-four at her past six Grand Slams and is expected to be Iga Swiatek's toughest rival in the Polo's bid for a fourth French Open title. There was better luck for Andreeva's younger sister Mirra, who went to the fourth round as a 16-year-old in 2023.

PERTH: AC Milan captain Davide Calabria said on Wednesday that the departure of Olivier Giroud to Major League Soccer will leave a leadership hole at the seven-time European champions.

Veteran French striker Giroud will play his final match for Milan in a post-season friendly against Rome in Perth on Friday in front of an expected crowd of 50,000 at the Optus Stadium.

The 37-year-old is heading to Los Angeles FC next season and will bow out of international football for France after the Euros, which begin in Germany next month.

Giroud was given an emotional farewell by the Milan fans as he signed off from Serie A with a goal in a 3-3 draw with Salernitana on Saturday.

American midfielder Christian Pulisic and winger Rafael Leao are missing from Milan's tour squad but Calabria said he had long journey to Australia.

"He's an important leader on-and-off the field, particularly off the field," Calabria told reporters in Perth on Wednesday.

Naukot family protests against police apathy after abduction of a 15-year-old girl

NAUKOT: Tensions escalate in Naukot as the family of a 15-year-old girl, allegedly abducted a week ago, accuses the police of inaction and extortion, prompting a fervent protest against the perceived indifference of law enforcement authorities.

The distressing ordeal began when Shamooin Kohli, a young girl, was reportedly kidnapped from the Sonara Otaq area, falling under the jurisdiction of Kaloi Police near Naukot. Despite the family's immediate report to the authorities, including the detention of one suspect, Kanji Kohli, by Kaloi Police, Shamooin remains missing.

In a harrowing turn of events, the family alleges that instead of earnestly pursuing Shamooin's recovery, the police are now demanding a bribe for their assistance. Krishan Kohli and Ganga Bai, parents of the abducted girl, expressed their anguish during a protest, highlighting the ordeal their family has en-

Amidst their anguish, the family decries the deteriorating law and order situation in Thar, expressing profound concern for Shamooin's safety in the hands of influential kidnappers. They implore the Senior Superintendent of Po-

lice (SSP) Tharparkar to ensure Shamooin's safe return within 24 hours, failing which they threaten to stage a sit-in protest on the Naukot-Mithi road, disrupting traffic as a last resort to amplify their grievances.

The family's desperate plea for justice underscores the broader challenges faced by marginalized communities in accessing effective law enforcement and protection of their rights. As their anguish reverberates through the streets of Naukot, the urgency to address their plight and ensure Shamooin's safe return becomes increasingly apparent.

Benazir Hari Card To Enable Banking Transactions And Subsidy Access Via ATMs: Murad

KARACHI: Sindh Chief Minister Syed Murad Ali Shah announced the launch of the Benazir Hari Card, aimed at benefiting farmers through various government programs and ensuring transparent implementation of interventions.

Presiding over a meeting with the agriculture department, Shah emphasized the card's role in supporting agricultural development, a key component of the national economy. The meeting included Agriculture Minister Muhammad Bux Mahar, Secretary Agriculture Rafiq Burro, Secretary Finance Fayaz Jatoti, and other officials.

The Benazir Hari Card will enable farmers to access banking services such as deposits, withdrawals, balance checks, and transfers, as well as government subsidies via ATMs. All agricultural landholders, regardless of landholding size, are eligible. Initially, cards will be issued to over 150,000 verified farmers under the Wheat Seed Cash Reimbursement Program, with eligibility verified by the revenue department.



Farmers owning land jointly must provide a No Objection Affidavit from other owners to register. Those with multiple landholdings will receive one card reflecting their total landholding. The Agriculture Department will collaborate with top technology firms to develop the necessary software and digital infrastructure, supported by the Sindh Water and Agriculture Transformation Project (SWAT) and the World Bank.

A robust IT-based system will manage the Benazir Hari Card registration, involving the Revenue and Agriculture departments, banks, and beneficiaries. The Revenue Department will upload required documents to the Agriculture Department's web/app, while joint teams will geo-tag farms and verify data.

The Agriculture Department will collect information from landholders, and a system will authenticate and randomly check entries. Verified data will be sent to a partner bank for NADRA verification, and the bank will issue the cards, which will be distributed to farmers at the taluka level.

Shah directed the Agriculture Department to expedite this process to ensure timely support for farmers, enhancing the overall efficiency and transparency of agricultural interventions in Sindh.—RT

BSEK: Matric And Ninth Grade Exams Postponed On May 28 Rescheduled For First Week Of June



KARACHI: The Board of Secondary Education Karachi (BSEK) has announced that the May 28 postponed exams will now take place on Sunday (June 2).

The federal government declared May 28 a national holiday on the occasion of Youm-e-Takbeer, the day when Pakistan conducted successful nuclear tests in the hills of Chagai in 1998.

In a statement issued on Wednesday, a spokesperson for the education board said that since the intermediate's annual examinations would also be taking place simultaneously, the delayed papers would be taken at the same examination centres.

The communique stated that in the morning shift, the ninth class (Science Group) will give their Urdu Normal Course, Sindh Normal Course (Compulsory), Geography of Pakistan Paper-I, and English Literature in lieu of Urdu.

It added that matric class (General Group) students, in the evening shift, will give their Arabic, Persian, and Household Accounts papers.—RT/Agency

K-Electric Has Overbilled 20 Billion Rupees In 10 Years: Nasir Shah

KARACHI: Provincial Minister of Energy and Planning, Syed Nasir Hussain Shah, revealed significant overbilling by K-Electric amounting to 20 billion rupees over the past ten years in government institutions. He noted that despite receiving billions of rupees for the installation of smart meters to prevent overbilling, K-Electric has not yet installed these meters in government institutions.



Speaking to members of the Council of Economic and Energy Journalists (CEEJ) in his office on Wednesday evening, Syed Nasir Hussain Shah highlighted the transparency achieved through the installation of smart meters by SEPCO and HESCO, which provide real-time data to the government. The meeting was attended by Provincial Minister Saeed Ghani, the Energy Secretary, and other officials.

Syed Nasir Hussain Shah expressed concerns over K-Electric's failure to submit Metering Units (MUs) to the Sindh government but indicated that progress is expected soon. He emphasized the dire situation of overbilling in government institutions and questioned the implications for citizens, announcing that the government will form a joint committee to protect Karachi's residents from K-Electric's overbilling practices. This initiative aligns with the directives of Pakistan People's Party Chairman Bilawal Bhutto.

Addressing a query, he mentioned the disparity in coal power tariffs, with Tharcoal at 5.50 rupees compared to other coal power plants at 15 rupees. He also discussed the province's 5736 ongoing schemes, stating that efforts are underway to allocate more funds in the new budget to ensure the completion of 4800 schemes.

Sindh Chief Minister Syed Murad Ali Shah has directed K-Electric, SEPCO, and HESCO to develop mechanisms to reduce bills and load shedding. Additionally, the government plans to provide 200,000 solar panels to the province's residents, with an 80% subsidy from the Sindh government and a 20% contribution from the public.—RT

KATI Raises Alarm Over IMF's Trade Deficit Forecast

KARACHI: The Korangi Association of Trade and Industry (KATI) President Johar Qandhari has expressed deep concern over the International Monetary Fund's (IMF) forecast that the trade deficit will exceed \$27 billion in the coming financial year. Qandhari attributes the widening trade deficit to increased production costs, the highest interest rates in the region, and stagnant export growth.



Qandhari emphasized the difficult conditions faced by industrialists, noting that the high cost of doing business is hampering industrial growth. He called for the government to swiftly implement an economic policy that includes reducing the interest rate to single digits. "The sky-high

prices of electricity and gas need to be brought down to promote industrialization, set up new industries, eliminate unemployment, and accelerate economic activities," he said.

The KATI President also urged the government to develop a long-term economic policy in consultation with industrialists. He stressed that reducing energy and production costs is crucial to boosting exports immediately. Additionally, Qandhari advocated for measures to control imports and reduce dependence on foreign goods by increasing duties on unnecessary and luxury items.

Qandhari remains optimistic that, with the right policies developed in collaboration with the industrial sector, the government can achieve results that contradict the IMF's grim projections. "If the government formulates a policy in consultation with industrialists, we can see outcomes that defy the IMF's estimates," he concluded.—RT

Sharjeel Criticizes Imran Khan's Objectives



KARACHI: Sindh Information Minister Sharjeel Inam Memon expressed concerns about Imran Khan's objectives, alleging that the PTI founding chairman's actions were not in the country's best interests. Memon accused Imran Khan of conspiring against Pakistan, claiming that his recent social media activity, allegedly operated from Adiala jail, posed a threat to national unity. Referring to a controversial post

equating Imran Khan with Sheikh Mujibur Rahman, Memon questioned the PTI's response and accused them of confusion.

He further criticized Imran Khan's policies, alleging favoritism and financial mismanagement during his tenure. Memon underscored the need for accountability and urged against compromising national interests for political gain.—RT

Murad Urges Swift Issuance Of Benazir Mazdoor Cards For Workers

KARACHI: Sindh Chief Minister Syed Murad Ali Shah has directed the Sindh Employees' Social Security Institution (SESSI) to expedite issuing Benazir Mazdoor Cards to provide additional support and incentives to workers.



During a meeting attended by Labour Minister Shahid Tahim, Secretary Finance Fayaz Jatoti, Secretary Labour Hafze Abbasi, Commissioner SESSI Saleem Khuhro, and other officials, Shah emphasized the need to enhance workers' welfare as per PPP Chairman Bilawal Bhutto Zardari's vision. This includes health benefits, educational grants, marriage assistance, and small business loans.

The CM stressed that the importance of quick card issuance, noting that delays deprive workers of their entitled benefits. With approximately 800,000 workers in the province, SESSI has partnered with NADRA to issue 625,000 cards in the first phase. So far, 150,000 cards have been issued, with an additional 250,000 expected by the end of June.

Shah instructed the Labour Department to collaborate with NADRA to ensure timely card distribution. He also directed the SESSI Commissioner to accelerate worker registration and card development, utilizing 54 fully functional registration sites. Biometric verification of dependents is being conducted at SESSI healthcare facilities, and NADRA is supporting capacity-building workshops and providing hardware for new registration sites.

Two Senior Karachi Police Officials Acquitted In Robbery Case

KARACHI: An additional district and sessions judge acquitted SSP Imran Qureshi, DSP Tariq Bajari and other accused on Wednesday in a case pertaining to an alleged robbery in Karachi's Orangi Town.



The court acquitted SSP Imran Qureshi, DSP Tariq Bajari and other accused while accepting their acquittal plea.

During the hearing, the prosecution did not identify the accused as responsible and stated that they were not involved in the incident. The prosecution also failed to provide any evidence to prove otherwise.

The plaintiff filed a no-objection on the acquittal plea. Lawyer Amir Qureshi stated that the plaintiff had asked in writing not to prosecute the case and others involved.

According to the police, a case was registered against the accused in Pirabad police station. They were accused of robbing around Rs15 million from the house of a citizen named Shakirullah.

Earlier in December 2023, the two officers were declared innocent in the interim challan of the case involving alleged robbery by police personnel in the house of a businessman in Orangi Town.

According to the interim challan, no evidence could be found against SSP Imran Qureshi and other accused in the case.—RT/Agency

Finance Ministry Claims Economy Poised For Moderate Recovery

ISLAMABAD: The Ministry of Finance has painted a positive picture of the economy, highlighting that key indicators demonstrating stability in the real, fiscal, and external sectors.

In its Monthly Economic Update and Outlook report for May 2024, the finance ministry's Economic Adviser's Wing noted that signs of economic stability were becoming more evident as the country approached the end of the outgoing fiscal year.

As the fiscal year is about to end, the economic indicators demonstrate the strengthening of stability in the real, fiscal and external sectors," according to the report released on Wednesday. According to the report, GDP growth is elevating while inflation rates are on a decline with a positive primary balance, reflecting the effectiveness of recent fiscal consolidation efforts.

The economic performance also indicates that agriculture has been a major contributor to this fiscal year's economic upswing, registering a growth of 6.25% in the agriculture sector's recovery



is mainly attributed to government initiatives through improved input supply and increased credit disbursement to farmers.

Large Scale Manufacturing (LSM) growth in 2024 Quarter 3, became positive and is expected to remain moderately positive on average throughout the second half of the current fiscal year. It witnessed a minor decline of 0.1% during July-March FY 2024 against the contraction of 7.0% same period last year. During this period, 11 to 22 sectors witnessed positive growth.

The Consumer Price Index (CPI) inflation stood at 17.3% on a year-on-year basis in April 2024 as compared to 36.4% in April 2023. The major drivers in-

clude housing, water, electricity, gas & fuel, perishable food items, furnishing & household equipment maintenance, clothing, footwear and transport.

On the fiscal front, during July to March FY24, the revenue growth outpaced the growth in expenditures. Within revenues, both tax and non-tax collection grew significantly by 29.3% and 90.7%, respectively.

Moreover, measures to control non-mark-up spending helped in improving the primary surplus to Rs1615.4 billion (1.5% of GDP) from Rs503.8 billion (0.6% of GDP) last year. While, the overall fiscal deficit remained at 3.7% of GDP, the same as recorded last year.

On the external front, the current account for FY2024 (July-April) narrowed down significantly, recording a deficit of \$0.2 billion compared to last year's \$3.9 billion, primarily due to an improved trade balance. In April 2024, the current account surplus was recorded at \$491 million, an increase from \$434 million in March 2024. Year-on-year, exports in April 2024 increased by 23.4% to \$2.6 billion, fueled by eased import restrictions that enhanced the supply chain for export industries.

In the same period, imports also rose by 22.8% to \$4.4 billion. The trade deficit for April 2024 was recorded at \$1.8 billion. Furthermore, the FDI witnessed an increase of 39.1% and reached \$358.8 million in April 2024, as against an inflow of \$258.0 million last month.

The remittances in April 2024 were encouraging, as they increased on a year-on-year basis by 27.9% to \$2.8 billion. On the back of a persistent policy rate at 22%, during 1st July - 03rd May, FY2024 money supply (M2)

shows a growth of 7.1% (Rs 2,229.8 billion) as compared to 7.0% growth (Rs1,943.4 billion) in last year.

Although the signs of a moderate economic recovery are evident. But to sustain this positive momentum, the policy efforts and reforms to raise productivity, and competitiveness are imperative.

In Jul-Apr FY2024, workers' remittances recorded at \$23.8 billion (\$23.0 billion last year), increased by 3.5%.

YoY remittances increased by 27.9% in April 2024 (\$2.8 billion) as compared to April 2023 (\$2.2 billion). However, MoM remittances declined by 4.8% as compared to March 2024 (\$3.0 billion) mainly owing to post Eid factors.

Pakistan's total liquid foreign exchange reserves increased to \$14.3 billion on May 24, 2024, with SBP's reserves stood at \$9.1 billion and commercial banks' reserves remained at \$5.2 billion.

"Going forward, the economy will gain momentum in the coming months of this fiscal year," the report added.—RT/Agency

PTI Urges CJP Isa And CEC To Investigate Nawaz's Election As PML-N President

ISLAMABAD: The Pakistan Tehreek-e-Insaf (PTI) has called on Chief Justice of Pakistan (CJP) Qazi Faez Isa and Chief Election Commissioner (CEC) Sikandar Sultan Raja to look into Nawaz Sharif's election as Pakistan Muslim League-Nawaz (PML-N) president, media reported on Wednesday.

"The election commission and the supreme court should take notice of the unopposed election of the fugitive and analyse it on the same criteria on which the fair elections of the PTI were tested," the PTI spokesperson said.

"The nation is watching every raton sitting on the state thrones very carefully and will deal with those who deviate from the Constitution and the law," he added.

The former ruling party's remarks come as Nawaz, a three-time former prime minister, was elected as the PML-N President "unopposed" — six years after a court ruling had removed him from office.

Nawaz had lost the prime minister's office in 2017 and the presidency of his party in 2018, as a result of the Panama Papers ruling.

However, he was elected as the party president today once again as no other party leader submitted their nomi-



nation papers against the party supremo for the top post.

PTI's objections refer to its own woes with the intra-party elections that were scrutinised by the ECP and eventually led to the party losing its "bat" electoral symbol before the February 8 polls.

The party then held its intra-party elections on March 3 which too have been challenged with the ECP raising questions over the current "status" of the former ruling party after losing "its organisational structure on lapsing of 5 years".

Termining the PML-N as "nothing more than the personal estate of the Sharifs and the inheritance for their young children," the PTI spokesperson rebuked the "venomous propaganda" against its incarcerated founder Imran Khan stressing that the former premier

and the party were "guardians of national interests and would fight against the corrupt and oppressive regime until the end". The spokesperson further rejected the PML-N's statement May 28 "Youm-e-Takbeer" celebration as "absurd" stressing that the government was attempting to use the national atomic program for their political gains and using public funds to that effect. Underlining that Pakistan's nuclear program was a great national asset which was acquired by the nation by "cutting its belly," he lauded the scientists for making the country a nuclear power and stressed that the program was materialised owing to the competent, hardworking and intelligent patriotic scientists under the unwavering leadership of Dr Abdul Qadeer Khan.—RT/Agency

Verdict Delayed In Iddat Case As Judge Requests Transfer Of Appeals To Another Court

ISLAMABAD: In a dramatic turn of events, the sessions judge hearing the Iddat case sought its transfer to another court on Monday when announcing the reserved judgment many thought would overturn the incarcerated premier Imran Khan and his wife Bushra Bibi's conviction.

Judge Shahrukh Arjumand left the courtroom after complainant Khawar Maneka expressed no confidence in him. The complainant made emotional arguments after asking the court to grant him 10 minutes to speak.

Shortly after, the judge wrote to the Islamabad High Court (IHC) requesting it to fix the case for hearing in some other court. Judge Arjumand wrote in the letter "Though earlier application of complainants has already been dismissed in this regard on April 30, 2024, but I think it will not be appropriate to decide the IHC hearing in this case as it is being held in the Presiding Officer."

It added "As arguments at length were heard in the matter, therefore, it is humbly submitted to transfer the appeals to any other court of competent jurisdiction." "It is further submitted that complainant and his counsel always tried to frustrate and delay the proceedings on one pretext or other, therefore, time frame may be fixed for disposal of appeals," the judge wrote.

As the hearing commenced, an hour later than



scheduled, Maneka appeared before the court along with his counsel Rizwan Abbasi.

The judge observed that prosecutor Abbasi was yet to present arguments on two points, following which he stepped onto the dais. However, Maneka requested the court for some time to present his arguments. At this, the judge asked him to let his counsel speak first. "My lawyer will not be able to explain my suffering. I will speak myself," replied Maneka.

At this point, Bushra Bibi's counsel Usman Gill urged the court to issue contempt notices to Maneka for interrupting court proceedings. Maneka asked for 10 minutes of speaking time, saying he belonged to a village and that rumors were being spread about him and his daughter's divorce every day. "Fake divorce letters are being made and spread on social media," the complainant maintained.

Court Halts Fake Bank Accounts Case Against President Zardari



KARACHI: A banking court on Wednesday put the fake bank accounts case against President Asif Ali Zardari on backburner after an immunity plea from his counsel, media reported.

The banking court judge said that the case could not be heard against President Zardari owing to the presidential immunity. The court also granted a plea of Faryal Talpur for exemption from appearing in the court.

The banking court adjourned further hearing of the case until June 09.

Advocate Muhammad Waqas, an associate of senior

lawyer Farooq H. Naik, filed two applications before the court on behalf of their clients in a previous hearing, pleading that Asif Ali Zardari has been elected president.

He submitted that Article 248 (2) of the Constitution safeguarded the president from legal proceedings in court during his term of office and claimed the presidential immunity and asked the banking court to halt the criminal proceeding against him in fake bank accounts case.

While in another application, his sister Faryal Talpur sought exemption from the court appearance for one day.—RT/Agency

PML-N Decides To Provide Relief To Masses In Upcoming Budget

Poet Ahmed Farhad In AJK Police's Custody: AGP Informs IHC

ISLAMABAD: The Attorney General for Pakistan, Mansoor Usman Awan, Wednesday informed the Islamabad High Court regarding the whereabouts of missing Kashmiri poet Ahmed Farhad.

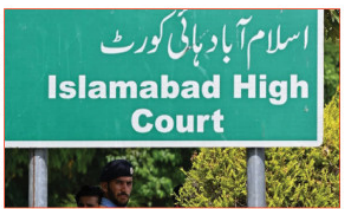
According to the AGP, the poet has been "arrested and currently in police custody" in Azad Jammu and Kashmir. The AGP revealed the information during the hearing of a petition seeking the recovery of the poet.

Urooj Zainab, Farhad's wife who moved IHC on May 15, sought her husband's recovery and requested the court to identify, investigate, and prosecute those responsible for his disappearance.

The plea is being heard by Justice Mohsin Akhtar Kayani, while human rights lawyer Iman Mazari is representing Zainab in the case.

A report by the DhirKot Kashmir police station was also presented before the court.

In conversation with journalists outside the IHC, Federal Law Minister Azam



Nazeer Tarar said the police is investigating the Kashmiri poet's case.

"Ahmad Farhad is in Azad Kashmir, I assisted on constitutional matters as a judicial assistant," he said, explaining his presence at the court today.

Farhad, known for his defiant prose, was allegedly abducted from his house on May 14.

During the hearing of the case on May 21, AGP Awan assured the court about rescuing and recovering the poet following the IHC orders.

"[We] will do whatever it takes [We] will rescue and recover [Farhad]," the AGP said while addressing the

IHC judge and taking the responsibility to look into the matter.

During the hearing, Justice Kayani ordered the AGP to ensure that "no one gets picked up from Islamabad."

"If a person does not get recovered, it will be a failure of the state," the judge said.

Responding to the remark, AGP Awan asked for time to ensure the poet's recovery.

Meanwhile, the petitioner's lawyer asked the AGP to share the progress on recovery made in the last six days.

"If the agencies don't have him [Farhad] then he can be traced at least," she argued.—RT/Agency

IHC Restricts Telcos From Recording Calls And Data For Surveillance

ISLAMABAD: The Islamabad High Court (IHC) in an order on the audio leaks case restrained on Wednesday telecom companies from recording phone calls and data for surveillance purposes.

Justice Babar Sattar heard the petitions of former first lady Bushra Bibi and former chief justice Saqib Nisar's son against their respective audio leaks.

The court demanded clarity regarding the law authorizing the Pakistan Telecommunication Authority (PTA) to carry out surveillance activities.

Additional Attorney General Munnawar Iqbal replied, "It is being done under a legal framework."

Justice Babar Sattar remarked "under which law are you recording peoples' calls", asking the AAG to inform the court officially. "Who has given the permission; who has given the authority to record calls?" the judge said.

one has been permitted to carry out legal interception. "If the authority to conduct surveillance has been granted, tell us where and how," the judge remarked.

At this, the AAG stated that rules should be made in this matter if none exist.

The judge questioned who would make the rules, and also asked who would notify the institutions about the rules. He further asked if any secret recording has been made till now after seeking permission from the courts.

"Under the law, every six months one's permit for such secret recording will be reviewed, has any such review committee been formed to date?"

Justice Babar questioned AAG whether the phone recording, without judicial permission was also punishable. "Did the PTA's license mention these conditions or has the PTA given a policy in this regard? Has this law been followed in the last one year or not?"—RT/Agency
