## PM's Comments On 'Black Sheep' Draw Supreme Court Judges' Ire

ISLAMABAD: Prime Minister Shehbaz Sharif recent "black sheep remarks" have drawn the ire Supreme Court's judges, who asked the top executive official to knock on the doors of relevant forums if he had complaints.

The remarks from the judges came during a hearing of National Accountability Bureau (NAB) amendment case earlier today.

Addressing an event on Tuesday, PM Shehbaz had said: "You are Pakistanis; you are judges. If development does not return to Pakistan, then there will be no judges, no politicians, and no one else."

Do you want this? I believe that most of these judges are Pakistanis and think about Pakistan's development, but some 'black sheep' are helping [PTI founder] Imran Khan."

The incumbent premier said when former PM Nawaz Sharif was under trial, he would not get bail in his cases, but currently, there are discussions about how the PTI founder can be



sent out on bail and his cases be dismissed. During the hearing, a five-member SC larger bench headed by Chief Justice Qazi Faez Isa and comprising Justice Amin-ud-Din Khan, Justice Jamal Khan Mandokhail, Justice Minallah and Justice Hasan Azhar Rizvi conducted the hearing on NAB amendment case.

During the hearing, Justice Mandokhail, while interacting with Attorney General for Pakistan (AGP) Mansoor Usman Awan, observed that the prime minister labelled the judges as "black sheep." "If you like the decision then a judge is fine but if you dislike the

verdict then a judge becomes black sheep," Justice Mandokhail remarked. Responding to the remarks, the AGP clarified that the PM did not label the "honourable judges" as black sheep. "This [black sheep remarks] was not aimed" at incumbent judges," the AGP added. Justice Minallah also apparently expressed annoyance over the remarks, saying: "We are not black sheep [but] we are black bumble bee so PM can get the benefit of doubt."

"The judge also told the AGP to ask the premier to file reference against 'black sheep' in the judiciary.—RT/Agency

## COAS Emphasizes Justice For May 9 Culprits To Uphold Stability And Rule of Law

RAWALPINDI: The country's military leadership Thursday called for bringing to justice the planners, perpetrators, abettors, and facilitators of May 9 riots for the "collective good of the country."

The Pakistan Army also maintained that stability in the country will remain hostage to the machinations of such elements without swift and transparent dispensation of justice to the culprits and establishing the rule of law, the military's media wing said in a statement.

According to the Inter-Services Public Relations (ISPR), the military's resolve was communicated during the 83rd Formation Commanders Conference at the General Headquarters (GHQ) presided by Chief of Army Staff (COAS) General Syed Asim Munir.

The statement issued by the ISPR about the forum — attended by Corps Commanders, Principal Staff Officers, and all Formation Commanders of Pakistan Army — comes weeks after the country observed the completion of a year to the violent riots that ravaged the nation, harming the sanctity of state institutions, on May 9, 2023.

The riots followed Pakistan Tehreek e Insaaf (PTI) founder Imran Khan's arrest on the aforementioned date during which party workers protested and took to the



streets across the country, damaging public and private property.

During the forum, the military leadership underscored that politically motivated and vested digital terrorism, unleashed by conspirators duly abetted by their foreign cohorts, against state institutions is clearly meant to try to induce dependency in the Pakistani nation, to sow discord among national institutions, especially the Armed Forces, and the people of Pakistan by peddling blatant lies, fake news, and propaganda.

"However, the nation is fully cognisant of their ugly and ulterior motives and surely the designs of these nefarious forces will be comprehensively defeated, InshaAllah," said the forum.

The forum, the ISPR added, was briefed on the dynamics of the geo-strategic environment, emerging challenges to national security, and the Army's strategy to counter multi-domain

nally propagated narratives of exclusion, exploited by foreign-sponsored proxies to lead Balochistan's youth away from peace and progress.

It resolved to continue its full support towards government initiatives in various domains for sustainable economic growth and curbing illegal activities, including smuggling, hoarding, electricity theft, implementation of one document regime, dignified repatriation of illegal foreigners, and safeguarding of the national database, etc.

"The COAS appreciated the high standard of training displayed by formations during various exercises and the excellent performance of officers and troops in counter-terrorism operations," the statement read.

It added that the COAS commended the formations for their high morale and round-the-clock operational readiness.

The participants at the forum expressed their complete satisfaction with the steps being taken at the army level for the training, administration, and welfare of serving and retired officers and troops. The forum noted the significant milestone achieved by Pakistan on Youm-e-Takbir and its stabilising impact on the region.

Reviewing the prevailing situation on the Eastern border and the latest round of extra-judicial 'murders' in IIOJK, the forum expressed complete solidarity with the Kashmiri people in their just struggle for the inalienable right to self-determination as enshrined in UNSC Resolutions.

The forum showed concern over the treatment of minorities, especially Muslims, in India and noted the growing fascism being perpetrated to achieve vested political ends, the statement mentioned.

The country's military leadership also expressed complete solidarity with the people of Palestine and condemned serious human rights violations and war crimes being perpetrated in Gaza, supporting the International Court of Justice decision to stop Rafah Operation and all other operations within the Gaza Strip.

The conference concluded by affirming the resolve to neutralise all threats to the security and stability of the country with the full backing of the prod nation.

The leadership of the country's military also offered fatha and paid tribute to the supreme sacrifices of martyrs, including officers and men of the armed forces, law enforcement agencies, and citizens of Pakistan who laid their lives for the country's safety, security, and sovereignty.—RT/Agency

## PAKSAT MM1: Pakistan Launches Second Satellite Into Space To Enhance Internet Connectivity

ISLAMABAD: Pakistan's advanced communication satellite, PAKSAT MM1, has been launched into space in collaboration with China, making it Islamabad's second satellite to be sent into orbit.

The satellite, launched from China's Xichang Satellite Launch Center (XSLC), will help usher Pakistan into the digital era by helping to provide internet to remote areas, the Spa-ce and Upper Atmosphere Research Commission (SUPARCO) said.

The satellite — which will take around four days to reach space — is expected to contribute to the establishment of a sophisticated communication network and help meet the growing demands of the telecom sector and its advanced capabilities will address the increasing demand for high-speed internet and seamless connectivity.

The agency, in a statement, had said: "This high-power multi-mission satellite will provide communication services in C, Ku, Ka Bands and SBAS services in L Band."

Based on advanced



communication technologies, PakSat-MM1 will play a pivotal role in the socio-economic uplift of the country, SUPARCO said.

Prime Minister Shehbaz Sharif congratulated the nation on the satellite's launch, hoping it would help provide the fastest internet facility throughout the country. "I am particularly excited about the potential impact of PakSat MM1 on internet connectivity across Pakistan," the premier said in a statement.

The prime minister said that PakSat MM1 would not only enhance the lives of Pakistani citizens but also contribute to the promotion of economic activities, e-commerce, and e-governance.

Before PAKSAT MM1, Pakistan's historic



lunar mission (ICUBE-Q) was launched on May 3 on board China's Chang'E6 from Hainan, China.

The satellite iCube-Q was designed and developed by the Institute of Space Technology (IST) in collaboration with China's Shanghai University SJTU and Pakistan's national space agency SUPARCO.

The satellite successfully captured and transmitted its inaugural images from lunar orbit, providing a unique perspective of the moon's surface.—RT/Agency

## Acting President Gilani Pledges Public Relief In Upcoming Budget

The finance minister briefed the acting president about the ongoing preparations for the upcoming people-friendly budget and the government's measures to reduce inflation.

The minister said that a remarkable reduction in the inflation rate manifested the government's constant and undeterred actions by the government.—RT/Agency

## Leghari Announces Power Outages For Areas On Loss-Making Feeders

ISLAMABAD: Energy Minister Awas Leghari has stated that areas that fall in the loss-making feeders would continue to face power outages amid sizzling weather with temperatures rising above 50°C in some areas of Sindh.

His statement came as sporadic protests continue in various parts of the country against unannounced loadshedding amid scorching heat.

Addressing a press conference in Islamabad on Thursday, Leghari said he directed the power distribution companies (Discos) to improve their overall performance and minimise loadshedding duration.

The energy minister also instructed the distribution companies to present details of the demand and supply of electricity on a daily basis before the public.

He said the management of power distribution companies will be replaced with competent personnel.

Blaming the high-loss



feeders, technical faults and Punjabicity theft as a major reason for power outages, the energy minister said a system was being revamped gradually to overcome loadshedding.

He said there is a shortfall of 4,232 megawatts in the country and high-loss feeders were not in a position to bear this shortfall.

Leghari said that there are 150 loss-making feeders in Punjab, 700 in Sindh, 350 in Khyber Pakhtunkhwa and around 80 in Balochistan, which will be overhauled.

He said there is an ample capacity for electricity generation available in the country and vowed to fulfil the demand for electricity during this summer and the upcoming year.

The energy minister also reiterated that the federal government was discontinuing the solar net metering policy and added that any decision in this regard would be made with the consultation of all stakeholders.

Speaking on the occasion, State Minister for Power Ali Pervaiz Malik urged people to identify power theft as their cooperation is inevitable to overcome loadshedding.—RT/Agency

## Khadro Police arrest most wanted drug dealer Noor Bakhsh Brohi

## Prolonged power outages irk Kunri residents

KUNRI: Despite achieving 100% recovery, residents of Kunri find themselves grappling with the onset of severe load shedding amidst scorching temperatures, sparking frustration and discontent among the populace. The sudden escalation in power outages has dealt a significant blow to the daily lives of Kunri's residents, resulting in substantial losses and exacerbating the already challenging circumstances exacerbated by the extreme heat. ## Teacher Suspected In Arson Attack On Girls' School In North Waziristan

PESHAWAR: Police in North Waziristan on Thursday revealed that a teacher was found involved in torching a girls' school after carrying out an initial investigation into the incident.

The Golden Arrow Girls Middle School in Shakhimmar village of Razmak tehsil was set ablaze on the night of May 25.



According to a first information report (FIR) registered against the teacher, the five masked armed men barged into the school and torched the classrooms.

The FIR stated that the school was set on fire at the behest of the teacher in a bid to create fear and harass the students.

Furniture, ceiling, computers, books, and other equipment of the school were gutted in the blaze.

The school administration said the enemies of education had also damaged the school solar system with firing some time ago.

Over 400 girl students are enrolled in the school. The locals have shown resentment over the incident and demanded restoration of educational activities in the school at the earliest.

A day earlier, federal education ministry drew urgent attention of Khyber Pakhtunkhwa's (KP) chief secretary regarding the destruction of schools by terrorists in newly merged districts and demanded prompt action against the menace of terrorism.

In a letter written to KP chief secretary, the federal secretary of the education ministry had expressed grave concern over the recent incidents of destruction of schools in the newly-merged districts of the province.

"It is particularly disheartening to note that these heinous acts of terrorism are disproportionately targeting institutions dedicated to girls' education," the letter said.—RT/Agency

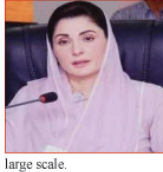
## Maryam Asserts Government's Efforts Towards Economic Development

"The 11-year-old Maryam died in the house while Rafia, aged nine, died at the hospital," the police said. ## Petition Lodged In Lahore High Court Challenging Election Ordinance

LAHORE: A writ petition has been filed in the Lahore High Court challenging a specific clause in the recent Election (Amendment) Ordinance 2024, signed by Acting President Yousaf Raza Gillani. The petition contends that the ordinance violates the doctrine of judicial independence as outlined in Articles 2-A and 175 of the Constitution.

Mashkoor Hussain, the petitioner, submitted the plea through his advocate Nadeem Sarwar, requesting the court to suspend the operation of the ordinance until the final resolution of the petition.



"The acting President signed the Election (Amendment) Ordinance 2024 on the advice of Prime Minister Shehbaz Sharif, following approval by the federal cabinet," Hussain stated in his petition.

The disputed clause in the ordinance stipulates: "For the trial of election petitions under this Act, the Commission shall appoint as many Election Tribunals as may be necessary for swift disposal of election petitions. An Election Tribunal shall comprise- (a) in the case of an election to an Assembly or the Senate, a person who is or has been a Judge of a High Court; and (b) in the case of an election to a local government, a District and Sessions Judge or a person who is or has been an Additional District and Sessions Judge. In the case of the appointment of a sitting judge as an Election Tribunal, the commission shall

consult with the Chief Justice of the High Court concerned."

Hussain argued that the ordinance is unconstitutional and a blatant violation of the principles established by the Supreme Court of Pakistan. "The right to access justice through an independent judiciary is a fundamental right. Without an independent judiciary, the fundamental rights enshrined in the Constitution are meaningless," he asserted.—RT/Agency

The CM said the usage of drugs had increased to an alarming level for which serious and coordinated measures for effective prevention were need of the hour.—RT/Agency

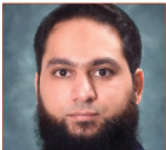

## A convenient poetic justice

The sudden raid on Bahria Town's Rawalpindi office by the National Accountability Bureau (NAB) has been a striking development in Pakistan's ongoing struggle against corruption. For years, Malik Riaz, the influential owner of Bahria Town, has been perceived as untouchable due to his powerful connections. This recent raid seems less an act of justice and more a poetic reckoning for a man long considered above the law.

## Pakistan-India clash: New York administration fortifies security amid terrorist threat

NEW YORK: Amid threats of terrorist attack, the New York administration has beefed up security for the high-octane Pakistan-India T20I World Cup 2024 match slated for June 9.



According to reports, a terrorist outfit has threatened of attack during the World Cup in New York. Pakistan will play two matches, while India has to play four matches in the metropolis. On the other hand, New York Governor Kathy Hochul has said for months she had been working with the law enforcers to ensure safety of visitors and New Yorkers during the cricket

World Cup. Dismissing the reports of threat, Hochul said there was "no credible public safety threat at this time". Although, she said they were continuously monitoring the situation closely. "I have also directed the New York State Police to engage in elevated security measures, including an increased law enforcement presence, advanced surveillance, and thorough screening processes. Public safety is my top priority and we are committed to ensuring the Cricket World Cup is a safe, enjoyable experience," she maintained. While corroborating

proofs for the reported threat are yet to be found, the International Cricket Council has stated that safety and security at the event was their top priority. "The safety and security of everyone at the event is our number one priority and we have a comprehensive and robust security plan in place. We work closely with authorities in our host countries and continually monitor and evaluate the global landscape to ensure appropriate plans are in place to mitigate any risks identified to our event," an ICC spokesperson was quoted as saying by a cricket website.—Agency

## Pakistan improve in T20I ranking ahead of T20 World Cup 2024



LAHORE: Pakistan men's team has improved their T20I rankings ahead of the upcoming ICC Men's T20 World Cup 2024, scheduled to be played in the United States of America (USA) and the West Indies from June 1. Pakistan moved one place up courtesy of South Africa's clean sweep loss against the West Indies in the three-match T20I series. The Proteas lost three places to seventh, and the West Indies jumped two spots to reach fourth. Meanwhile, Pakistan clinched the sixth spot. "Two-time champions West Indies have moved up to fourth position in the ICC Men's T20I Team Rankings, their players showing some great form ahead of the ICC Men's T20 World Cup 2024, which they co-host from 1-29 June," the ICC stated in a recent press release. "The winners of the 2012 and 2016 editions of the tournament are ahead of New Zealand and South Africa after their 3-0 win over South Africa, who were pushed

down to seventh position in the list led by India.

"India, winners of the inaugural edition in 2007, are on 264 rating points, 2021 champions Australia are second with 257 points, defending champions England third with 254 points and the West Indies two points behind them on 252. New Zealand are on 250 while Pakistan and South Africa are both on 244 points with Pakistan slightly ahead on decimal points."

Pakistan players also made significant gains in the T20I players' rankings as Fakhar Zaman jumped six places up to reach 51st in the ICC T20I batting rankings. Meanwhile, Shaheen Afridi, rose up three spots to equal 11th with Australia's Adam Zampa.

Haris Rauf also gained two places to 25th after picking two wickets in the second T20I against England. Notably, this was his comeback game after missing out on the series against New Zealand and Ireland due to a shoulder injury.—Agency

## Ricky Ponting predicts highest run-scorer, wicket-taker for T20 World Cup 2024



SYDNEY: Legendary Australian captain Ricky Ponting has unveiled his predictions for the highest run-scorer and the top wicket-taker for the upcoming ICC Men's T20 World Cup 2024, starting from June 1. Ponting predicted that Indian pace bowler Jasprit Bumrah would be the leading wicket-taker at the mega-event. Meanwhile, for the highest run-getter, Ponting picked Australian top-order batter Travis Head. "The former captain appreciated Bumrah's ability to swing the ball as well as his impressive economy. Bumrah claimed 20 wickets in 13 games at an economy of 6.48 during the recently concluded IPL. "My leading wicket-taker for the tournament will be Jasprit Bumrah. I just think an outstanding performer, and contributor for a number of years now. He's just come off an outstanding IPL," Ponting told The ICC Review. "What he can do with the new ball, he swings the new

## El Kaabi gives Olympiakos Europa Conference League glory

ATHENS: Olympiakos became the first Greek club ever to win a European title after a 1-0 extra time defeat of Fiorentina in the Europa Conference League final.



Moroccan striker Ayoub El Kaabi scored the winning goal in the 116th minute that allowed Jose Luis Mendilibar's side to make history in the home of local rivals AEK Athens. Prior to Olympiakos' success, Panathinaikos were the only club from Greece to make a European final when they lost to a Johan Cruyff-inspired Ajax in the 1971 European Cup decider. "I'm really happy. The team has made history. Mendilibar has made us a strong team. He told us we have to play as a family," said midfielder Santiago Hezze.

Mendilibar, 63, became the Greek side's third manager of the season when he took over the reins in February. He has the seam up. But at the end, his economy rate was less than seven runs an over. "He takes wickets. He does bowl a lot of the hard overs too. When you bowl the hard overs in T20 cricket, it gives you a chance to pick up a lot of wickets along with him." Ricky Ponting then praised Head for his batting prowess across formats in the last two years. Head scored crucial centuries in the finals of the ICC World Test Championship and ICC ODI World Cup 2023. "My prediction for the leading run-scorer will be Travis Head. I just think everything he's done, whether it be red-ball or white-ball in the last couple of years, has been of the highest quality. I think he's playing fearless cricket at the moment," Ponting said. "His IPL had its ups and downs, but when it's been good, it's been very good. And it has won games of cricket for his team," Ponting noted.—Agency

But this was the last big chance of regulation time as the match ebbed its way inevitably to extra time. Olympiakos appealed vainly for a penalty four minutes into extra time, but the defender's arm was adjudged to be in a natural position when Stevan Jovetic's cross struck it just inside the box. Ex-Fiorentina icon Jovetic, introduced from the Olympiakos bench, forced a good save from Terracciano with a curling 20-yard strike one minute later as the match seemed to spark back to life.—Agency

## Jude Bellingham tops list of football's most valuable players

MADRID: England and Real Madrid star Jude Bellingham possesses the highest transfer value in world football, according to a new study.



The 20-year-old has had a sensational debut season at the Bernabeu following his €100 million transfer from Borussia Dortmund last summer, scoring 19 goals as the club clinched the La Liga title. He will eye to win first Champions League title on Saturday when Madrid take on Borussia Dortmund at Wembley before setting his sights on a successful Euro 2024 campaign with England. According to the CIES Football Observatory, his achievements this year have seen his transfer valuation soar to an astonishing €280 million (£237 million), more than any other player in the world. The CIES study involved analysing numerous factors to calculate the value of the world's top 100 players. These factors include age, contract length, level of matches played, and the economic strength of the players' clubs and leagues. The resulting list is dominated by Real Madrid and Manchester City players. Bellingham's former Dortmund teammate Erling Haaland is valued at €255 million, with Madrid's Brazilian duo Vinicius Junior (€240 million) and Rodrygo (€220 million) next on the list. Phil Foden concluded the Premier League season in sensational form and ranks fifth on the list at €203 million, ahead of his England teammate Bukayo Saka (€195 million). Other Premier League stars in the top ten include Julian Alvarez (€168 million) and Martin Odegaard (€135 million), while Cole Palmer's breakout season sees his value calculated at €126 million. One notable absentee from the list is Kylian Mbappe, who is not included as his contract with Paris Saint-Germain is set to expire this summer, rendering him almost worthless from a transfer value standpoint.—Agency

## FAPUASA, SAUTA condemn decision to stop funding of provincial universities

TANDO JAM: Under the call of the Federation of All Pakistan Universities Academic Staff Association (FAPUASA), the Sindh Agriculture University Teachers' Association (SAUTA) observed a "Black Day" at Sindh Agriculture University Tando Jam along with faculty members. The event was attended by President Dr. Fahad Nazir Khoso, Vice Chairman Dr. Javed Ali Gadahi, Secretary Dr. Khalid Hussain Talpur, Joint Secretary Dr. Imdad Hussain Laghari, Dr. Asmatullah Kaka, and others. Addressing the gathering, SAUTA President Dr. Fahad Nazir Khoso opposed the federal government's decision to stop funding provincial universities. He revealed that universities across the country are already facing financial difficulties, with some unable to pay their staff salaries. He further stated that this decision would worsen the situation, especially since funds for current expenses have been frozen for eight years. Additionally, the HEC has withheld grants amounting to 65 billion for



more than 160 universities. During the pre-budget meeting in Islamabad this year, a request was made to double the HEC fund. However, before finalizing the budget, the government reduced the grant from 65 billion to 25 billion and stopped HEC funding for provincially chartered universities, allocating funds only to federal universities. Moreover, the developmental grant was reduced from 50 billion to 21 billion. SAUTA Secretary and FAPUASA Pakistan's Executive Council member Dr. Khalid Hussain Talpur, during a press briefing, said that this decision is detrimental and violates the federal government's constitutional authority. According to the constitution, any decision regarding the HEC budget must be presented at the Council of Common Interests

(CCI) meeting. The sudden announcement just before the new budget means that only federally chartered universities will receive funds for current expenses, putting higher education and the country's future at risk. The speakers stated that the teachers at Sindh Agriculture University Tando Jam oppose this decision and demand that the government refrain from interfering in higher education. They call for substantial funding for higher education institutions and emphasize the need for a gradual transfer of powers and responsibilities, including all stakeholders. SAUTA demands that funds be allocated for all universities in the upcoming budget and proposes forming a committee to prepare recommendations for this transition.

## 14-year-old Larkana boy attempts suicide

## HESCO issues clarification about load shedding hours

HYDERABAD: Electricity load management is currently underway in the HESCO region. There are 78 grids in the HESCO region, and with the help of 11,662 feeders, electricity is being provided to consumers according to the Load Management Schedule based on the AT&C Policy. The shutdown schedule for each feeder is determined according to categories one (1) and two (2), which include a total of 176 feeders with losses ranging from 10% to 20%. Load shedding is not being carried out on these feeders under the AT&C policy. Category three (3) includes 5 feeders with losses ranging from 20% to 30%, where 2 hours of load shedding is being implemented. Category four (4) includes 10 feeders with losses ranging from 30% to 40%, where 4 hours of load shedding is being implemented. Category five (5) includes 29 feeders with losses ranging from 40% to 60%, where 6 hours of load shedding is being implemented. Category six (6) includes 93 feeders with losses ranging from 60% to 80%, where 8 hours of load shedding is being implemented. And category seven (7) includes 309 feeders with losses of 80% and above, where 12 hours of load shedding is being implemented. Furthermore, according to the operational circle of Hyderabad, a total of 153 feeders are being managed according to the Load Management Schedule based on the AT&C Policy, with 38 feeders in category one (1) where no load shedding is being carried out, and 4 feeders in category four (4) where 4 hours of load shedding is being implemented, and 3 feeders in category five (5) where 6 hours of load shedding is being implemented, and 51 feeders in category six (6) where 8 hours of load shedding is being implemented, and 57 feeders in category seven (7) where 12 hours of load shedding is being implemented. In addition, according to the operational circle of Nawabshah, a total of 213 feeders are being managed according to the Load Management Schedule based on the AT&C Policy, with 92 feeders in category one (1) where no load shedding is being carried out, and 3 feeders in category two (2) where 2 hours of load shedding is being implemented, and 57 feeders in category three (3) where 4 hours of load shedding is being implemented, and 2 feeders in category four (4) where 4 hours of load shedding is being implemented, 20 feeders in category five (5) where 6 hours of load shedding is being implemented, 16 feeders in category six (6) where 8 hours of load shedding is being implemented, and 105 feeders in category seven (7) where 12 hours of load shedding is being implemented. Finally, according to the operational circle of Mirpurkhas, a total of 168 feeders are being managed according to the Load Management Schedule based on the AT&C Policy, with 24 feeders in category one (1) and (2) where no load shedding is being carried out, and 3 feeders in category three (3) where 2 hours of load shedding is being implemented, and 2 feeders in category four (4) where 4 hours of load shedding is being implemented, 20 feeders in category five (5) where 6 hours of load shedding is being implemented, and 105 feeders in category seven (7) where 12 hours of load shedding is being implemented.—RT

The malfunctioning of the RO plant's motor has led to inconvenience for residents, who are now compelled to drink polluted water due to the unavailability of clean drinking water. Despite two rounds of maintenance efforts led by supervisor Pir Bukhsar, the motor remains unresponsive, exacerbating the plight of the community.

In response to the pressing issue, the District Commissioner of Shaheed Benazirabad and Assistant Commissioner Qazi Ahmed

have been apprised of the situation. A notice has been issued urging swift action to address the damaged motor at the RO plant, ensuring the provision of clean and safe drinking water to the residents of Nawab Wali Muhammad city. The demand for the replacement of the out-of-order motor underscores the urgent need to prioritize public health and well-being by rectifying infrastructure issues and ensuring access to clean water for all.

## Unidentified Gunmen Kill Two Owner Brothers Of Baloch Ice Cream In Guru Mandir And Injure Two Others



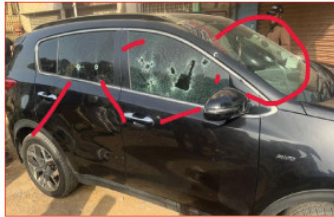

KARACHI: At least two brothers were killed and two were injured after unidentified gunmen opened fire on their car near Guru Mandir in Karachi Thursday morning, police told media.

According to Superintendent of Police Aleena Rajpar, the incident appears to be a case of target killing in which six suspects on three motorcycles targeted the car.

All the occupants of the car were identified as brothers and were commuting to the city court for a hearing, as per the police.

"Efforts are being made to find out the motive behind



the incident," said the police. The suspects are seen targeting the vehicle in a CCTV footage obtained by media.

The SP added a 9mm pistol was used in the firing,

while 18 bullet casings have been recovered from the incident's site.

The occupants of the car, the police said, were shifted to a private hospital for treatment during which two of them died and the other two remain severely injured, while one of them is in critical condition. One brother, however, miraculously survived the attack, said the police official.

The police said it had collected evidence from the crime scene and added that the gun attack had been allegedly carried out due to enmity.

Earlier SP Rajpar of the Jamshed Quarters, during a presser, said that the police were trying to obtain the CCTV video of the crime scene.

She informed the media that both brothers killed in the gun attack were identified as Sajid Aurangzeb and Omair Aurangzeb, while those injured were Wajid and Zubair.

Meanwhile, Sindh Governor Kamran Tessori has sought a report on the incident from the city's police chief, a spokesperson of the Governor House said.

"Those involved in the firing should be immediately arrested," the governor in his directives, adding that such an incident in the middle of the city is very alarming.—RT/Agency

It is pertinent to mention here that the at least two brothers were killed, two other injured after unidentified gunmen opened fire on their car near Karachi's Guru Mandir area on Thursday morning.

Furthermore, recent developments have revealed that the culprits are close relatives of the deceased individuals and the incident occurred due to personal enmity.

According to the police, the attack involved four suspects who fired multiple rounds at the vehicle. "Two of the victims were critically injured and later succumbed to their injuries while the other two injured have been shifted to the hospital," she said.

A 9mm pistol was used in the firing, while 18 bullet casings have been recovered from the incident's site, she added.

The police said it had collected evidence from the crime scene and launched investigation into the incident.—RT/Agency

## Nasir Shah Unveils Plan To Provide 100 Units Of Free Electricity To Low Income Users

KARACHI: Provincial minister Nasir Hussain Shah on Thursday said that a plan has been prepared to provide free electricity to consumers of up to 100 units, media reported.

Talking to media, Sindh's energy minister said that the government will provide 100 free power units to consumers from solar parks and mini grid stations.

He said the Government of Sindh has allocated amount for solar energy and mini grid in the budget. "The government initially allocating five billion rupees for solar energy in the budget," minister said.

"We are also introducing a scheme in budget to provide solar panels on an extremely concessional price," said energy minister said. "Poor and middle-class people will be provided two lac solar panels," he said. "The government will pay 80 percent of solar panel's price, while 20 percent will be taken from people," Nasir Shah added.—RT

## Police Turn Arrested Dacoit Into A Gutka Dealer After Capture

KARACHI: After arresting the robbers red-handed in Karachi's Landhi area, Sindh Police officials allegedly took bribes and released them, media reported on Thursday.

Sources close to the development claimed that the Karachi police officials released both of the arrested robbers, one after allegedly taking bribes while another was booked for possessing Gutka.



It is pertinent to mention here that the patrolling party of police officials arrested the robbers two days ago along with weapons and stolen mobile phones.

Sources claimed that the police arrested the accused individuals in injured condition, while the motorcyclist's family also identified the accused robbers on the spot.

However, Korangi policemen arrested both the suspects and took them to the police station, and allegedly SHO Korangi and others finalized a 'deal' with the suspects.

According to sources, one of the accused was released after allegedly taking a bribe while the other accused was booked in the Gutka possession case.

The metropolis has seen an increase in the street crime as the Citizens-Police Liaison Committee (CPLC) report revealed that 5,789 crimes occurred in April 2024 in Karachi.

According to the report,

162 cases of robbery and 4,184 cases of motorbike theft were reported in April, with 1,368 mobile phones snatched from citizens at gunpoint.

Additionally, 15 cases of extortion and one case of kidnapping for ransom were reported, whereas 59 citizens lost their lives in various incidents during last month. In the last four months, 28,416 major crimes were reported, with 62 citizens losing their lives due to robbery resistance.—RT/Agency

## SHC Reserves Verdict On Inclusion Of Municipal Tax In Electricity Bills

KARACHI: The Sindh High Court (SHC) has reserved its verdict on the petition concerning the collection of Municipal Utility Charges and Taxes (MUCT) through K-Electric bills, media reported on Thursday.

After hearing the argument from both sides, a two-member bench, headed by Justice Salahuddin Panwar, ruled that the petitions were resolved on assurance of review of the tax collection agreement.

During the session, Mayor Karachi Murtaza Wahab and various legal representatives presented their cases.

The court said that according to Mayor Karachi Murtaza Wahab, the municipal tax agreement will be reviewed again, assuring that K-Electric will not deduct the municipal tax directly.

According to the court, Mayor Karachi Murtaza Wahab has assured that the municipal tax agreement will be revisited, confirming that K-Electric will not directly deduct the municipal tax from consumers.

Instead, a special committee consisting of local council members will be formed to handle the tax collection process.

Additionally, the Mayor stated that citizens who pay less than Rs 10,000 to K-Electric will not be subjected to the municipal tax.

Acknowledging the already burdened citizens of Karachi due to inflation, the court directed the relevant authorities to provide direct relief to consumers using electricity below 300 units monthly.

The court has granted three months to review the agreement and complete the necessary processes.—RT/Agency

## VCs Of Sindh's Varsities Appeal To PM For Rs16 Billions In Funds

KARACHI: The Vice Chancellors of 21 public universities in Sindh have penned a letter to Prime Minister (PM) Shehbaz Sharif, requesting Rs 16 billion to avoid default, media reported.

The letter, signed by the Vice Chancellors, expresses concern over the withholding of federal government grants to provincial universities, including 29 public sector universities in Sindh.

The Vice Chancellors stated that the federal government provides over Rs 13 billion to Sindh's universities through the Higher Education Commission (HEC), which has been frozen since 2018.

The letter expressed hope that the Prime Minister will take necessary steps to stabilize and support universities and higher education institutions, considering the high returns on investment in education, as seen in countries like China, Korea, Malaysia, and India.

The Vice Chancellors emphasized that increasing investment in education, particularly higher and technical education, is a significant development.

It is pertinent to mention here that the Higher Education Commission (HEC) stopped funding for provincially chartered universities as the federal government has made a big cut in its grant from 65 billion to 25 billion rupees.

The HEC had requested 126 billion rupees to support 160 universities nationwide, but the federal government decided to reduce the previously allocated 65 billion rupees.

As a result, the HEC will no longer provide funds to provinces, and universities will now have to rely on provincial financing fundings.—RT/Agency

## IHC Rules Individuals Engaged In And Aiding In Surveillance Of Citizens Will Be Prosecuted

ISLAMABAD: Islamabad High Court's (IHC) Justice Babar Sattar has said that prima facie no state official was authorised to surveil citizens and anyone doing so or aiding such an endeavour would be "liable for offences".

The observation came in a written court order issued today (Thursday) for yesterday's hearing on a case in connection with petitions filed last year by ex-premier Imran Khan's spouse Bushra Bibi and Najam Saqib, son of former chief justice of Pakistan Saqib Nisar, against alleged audio leaks.

The IHC judge had earlier dismissed multiple petitions from different authorities requesting that he recuse himself from the case. The detailed court verdict of the April 29 hearing had said there was a "growing abhorrent practice" of using recusal requests accompanied by efforts to "scandalise the court and intimidate the judge into disqualifying himself/herself from hearing a matter, in which a party to the proceedings suspects that the outcome might not be to its liking".



In a later hearing, he had issued contempt notices to the director generals (DGs) of the Federal Investigation Agency (FIA) and the Intelligence Bureau (IB) as well as the Pakistan Telecommunication Authority (PTA) chairman and members for filing "collusive applications" seeking his recusal.

The court order for Wednesday's hearing, a copy of which is available with media, said that the additional attorney general's responses showed that "no entity or agency of the country has been authorised to undertake surveillance or undertake legal interception of telephone calls or telecom data."

"It appears prima facie that no official of the executive/federal government, intelligence agency or police is authorised to undertake surveillance of the citizens of Pakistan. To the extent that any employee of the government or investigation or intelligence agency is undertaking surveillance and/or telecom companies and service providers are affording their facilities to facilitate surveillance, all such individuals are liable for offences under provisions of the Telegraph Act, the Telecommunication Act, the Fair Trial Act and Peca."

"Any such unauthorised surveillance would also be in breach of fundamental rights of citizens guaranteed by Articles 9, 10A, 14 and 19 of the Constitution read with Article 4 and would cause irreparable harm to the liberty, dignity and privacy of the citizens being surveilled."

He also ordered the defence, interior and law ministries to file reports on whether phone tapping has occurred since the enactment and entering into force of the Fair Trial Act.

Justice Sattar also ordered the ISI, IB, intelligence agencies of the military, navy and air force, along with the Islamabad police chief, to file individual reports on whether they discharged their statutory obligation to appoint an authorised officer in terms of Section 4 of the Fair Trial Act and complied with the act's requirements in seeking approval for surveillance.

"PTA shall file a report stating whether any SOPs or instructions have been issued to telecom operators to facilitate lawful interception and/or share telecom data with anyone in breach of provisions of the Fair Trial Act. If so, the report will accompany the SOPs or instructions issued along with an explanation regarding the legal authority under which they have been issued."

The judge also directed that the reports be filed by June 14 for perusal and adjourned the hearing to June 25.—RT/Agency

## FIA Cyber Crime Wing To Investigate Imran's Controversial Post

ISLAMABAD: The Federal Investigation Agency's (FIA) Cyber Crime Wing (CCW) has decided to initiate action against Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan due to his controversial social media post on X.

A post on X, formerly Twitter, was attributed to the former prime minister, which read: "Every Pakistani should study the Hamood ur Rahman Commission Report and get to know who was the true traitor," General Yahya Khan or Sheikh Mujibur Rahman."

However, PTI Chairman Barrister Gohar told a local media outlet later that the post had nothing to do with Imran as he did not see the text of the posts that were uploaded to his account.

"Imran Khan has nothing to do with this [post] because he did not see its content or other things. [The PTI founder] does not approve each and every video or context."

Gohar also defended the tweet and said it was taken out of context. "The context and comparison that we drew with



1971 was in a political context and not otherwise — nothing about the army," the PTI leader said. The post on PTI supreme's account drew severe criticism from the PTI on this issue, the sources said. ## Imran Seeks Legal Advice In NAB Law Case, Complains To CJP About Difficulties

ISLAMABAD: Former premier Imran Khan complained to Chief Justice of Pakistan (CJP) Qazi Faez Isa on Thursday about the challenges he faced in obtaining legal assistance for the NAB law amendments case as the two interacted for the first time in the courtroom.

Incarcerated at Adiala Jail, the ex-premier attended the hearing via video link. Imran informed the CJP, "The jail authorities do not allow me to meet my legal team. I am being kept in solitary confinement without access to any materials or a library to prepare for the case."

Imran's remarks came as a five-judge bench of the Supreme Court (SC) led by CJP Isa, and including Justice Aminuddin Khan, Justice Jamal Khan Mandokhail, Justice Athar Minallah, and Justice Syed Hasan Azhar Rizvi, resumed hearing the accountability laws amendment case.

At the outset of the hearing, the apex court rejected the Khyber-Pakhtunkhwa government's petition seeking



the hearing to be broadcast live. The federal government challenged the apex court's majority verdict in September last year, declaring amendments to the National Accountability Ordinance (NAO) 2002 illegal. The proceedings held on May 14 were telecast live. However, the last one as well as today's was not. Both of them had the ex-premier in attending the hearing via video link.

Justice Minallah dissented from the majority 4-1 decision and said that it is a matter of public interest and therefore should be live-streamed. The chief justice said the court has never received such a plea before and all judges deliberated on the

petition before a decision was reached. At the outset of the hearing today, Justice Minallah said the hearing should be broadcast in the same manner earlier hearings were. However, the chief justice said the case is "technical" in nature and is not a matter of public interest.

"The last hearing was not broadcast live and neither will we broadcast today," added Justice Isa.

Following these remarks, the bench took a recess to deliberate if the hearing should be broadcast live. The hearing resumed after a break of almost an hour with the court announcing its verdict on the K-P petition.—RT/Agency

## Court Clears Imran Of Charges In Two Cases Linked To May 9 Riots

ISLAMABAD: A district and sessions court of Islamabad on Thursday acquitted Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan in two cases related to the May 9 riots.

The petition challenging the two cases lodged at Shehzad Town police station against the PTI founder was approved by Judicial Magistrate Umar Shabbir.

"Because of insufficient evidence presented by the prosecution, the PTI founder has been acquitted," the district and sessions court said in its verdict. Earlier, Khan was acquitted in two cases pertaining to May 9 vandalism on May 15.

His acquittal orders were issued by Judicial



Magistrate Sahib Bilal, who approved the former prime minister's plea challenging the cases. Both those cases against Khan were filed in Khanna Police Station in Islamabad. His acquittal plea was approved by court because of insufficient evidence in the cases against him. The cases were registered against the PTI founder for long march and violation of Article 144. Khan, who remains behind the bars in Adiala jail, and several others including some PTI leaders are facing various allegations in the cases related to the violence following his arrest on May 9.—RT/Agency
