BJP Scrambles For Majority As Opposition Surprises In Indian Election

NEW DELHI: Indian Prime Minister Narendra Modi's alliance was headed for a narrow majority as vote-counting in the general election neared completion on Tuesday, with the tally well short of a widely expected landslide.



Modi's own Bharatiya Janata Party (BJP) was falling short of a majority of its own in the 543-member parliament, the trends showed. Having to depend on allies to form the government could introduce some uncertainty in policy-making as Modi has ruled with an authoritative hold in the last decade. The Hindu nationalist BJP won a majority of its own when it won power in 2014, ending India's era of unstable coalition governments, and repeated the feat in 2019. The prospect of Modi having to rely on allies spooked markets with stocks falling steeply. The blue-chip NIFTY-50 (NSEI) opens new tab sank 5.9% and the S&P BSE Sensex (BSESN) opens new tab tumbled 5.7%, posting their steepest decline on an elec-

tion outcome day since 2004. The rupee also fell sharply against the dollar and benchmark bond yields were up. Markets had soared on Monday after exit polls on June 1 projected Modi and BJP would register a big victory, and the ruling National Democratic Alliance (NDA) was seen getting a two-thirds majority and more. At 1100 GMT, TV channels showed the NDA was ahead in nearly 300 of the 543 electorates in the lower house of parliament, where 272 is a simple majority, with about half the votes counted. Full results are likely later on Tuesday evening. They showed BJP ac-

counted for under 250 of the seats in which the NDA was leading, compared to the 303 it won in 2019. BJP's numbers were likely pulled down by the party's poor showing in the country's most populous state, Uttar Pradesh, which also sends 80 lawmakers to parliament, the highest of any state. The party was leading in 36 seats in the state, down from the 62 it won there in 2019, with analysts saying bread-and-butter issues had overshadowed the BJP's appeal to the Hindu majority. A grand temple to Hindu god-king Lord Ram that Modi inaugurated in January had not boosted BJP's fortunes as it was expected to, they said.—RT/Agency

ECP Errors Cost PTI Party Symbol, Says Justice Akhter In SIC Reserve Seats Case

KARACHI: Justice Munib Akhtar during the full court hearing on reserved seats case highlighted a string of legal mistakes made by the Election Commission of Pakistan (ECP) that compelled PTI-backed candidates to contest elections as independents.



He further stated that the issue regarding reserved seats came down to whether these candidates should be "denied those reserved seats simply because now they have taken shelter under [the Sunni Itehad Council]."

These remarks were made as the full bench of the apex court resumed hearing the SIC's plea on Tuesday against the denial of reserved seats in assemblies for women and minorities.

A 13-member bench headed by Chief Justice of Pakistan Qazi Faez Isa and comprising Justices Syed Mansoor Ali Shah, Munib Akhtar, Yahya Afandi, Aminuddin Khan, Mandokhail, Muhammad Ali Mazhar, Ayesha Malik, Athar Minalah, Syed Hasan Azhar Rizvi, Shahid Waheed, Inam Saadat Khan and Naeem Akhtar Afghan, resumed the hearing today. SIC's lawyer, Advocate Faisal Siddiqui, asserted that although the SIC didn't participate in the elections as a

party, independent candidates did indeed take part. He further emphasized that the SIC did provide a list of its candidates, but the ECP rejected it, claiming that the party hadn't contested the elections. CJP Isa pointed out that the SIC had identified itself as a parliamentary political party twice and as a political party once.

In response, Advocate Siddiqui argued that a political party could also be a parliamentary political party. "The Constitution makes a distinction between a parliamentary political party and a political party," noted the chief justice.

"We were a political party before the February 8 elections and became a parliamentary political party after [winning] independent candidates joined us," the SIC lawyer replied, emphasizing that the Constitution doesn't

include the term "parliamentary party" except in Article 63A. Responding to the SIC lawyer's argument that there wouldn't have been any issue if the apex court had clarified its verdict on the bat symbol, the chief justice stated that the matter of reserved seats would not exist if the PTI had conducted its intra-party elections.

"Don't attribute everything to the SC," he emphasized. "The PTI deprived its people of democratic rights [...] if the elections had been held, PTI members themselves would have benefited."

"If you want to talk about democracy, then adhere to it strictly," the chief justice remarked. Meanwhile, Justice Akhtar, recalling that the independent candidates had indicated their affiliation with the PTI, and that their nomination papers were accepted and they won the elections,

stated that a candidate who presents themselves as part of a party will be considered affiliated with it.

He remarked, "Only those who will be considered as independent candidates who submit an affidavit that he is not affiliated with any political party."

"How can the ECP's law could declare PTI's candidates as independents," Justice Akhtar noted.

Responding to Justice Akhtar's comments that the controversy arose after a political party was deprived of its electoral symbol, the chief justice questioned why the PTI didn't challenge the court's orders in this regard.

"Why did you not ask for the bat as an independent candidate," the CJP asked Advocate Siddiqui. "All independent candidates cannot ask for bat," the counsel replied, stressing that Salman Akram Raja had even requested the ECP to be declared as a PTI candidate. However, he added, Raja's request was dismissed. "There's a different form for each constituency, why can't you ask for it," the judge stressed. He said that the party should've declared its candidates as independent and should've then sought the bat symbol.

"You should've at least tried to secure the bat symbol. The SC would then would have seen whether it was to be allotted to you or not," the CJP said. The court then adjourned the hearing till June 24. In yesterday's hearing, the SIC's lawyers approached the rostrum, with Siddiqui reading out the May 6 order. He argued that assigning reserved seats to other parties violated specific articles of the Constitution. Siddiqui referenced an ECP letter to support the SIC's entitlement to reserved seats in the National Assembly. CJP Isa then asked Siddiqui for details on the beneficiaries and a breakdown of the additional seats allocated to ruling coalition parties. Siddiqui noted discrepancies in the numbers provided by the electoral watchdog. Justice Isa further inquired about the party-wise allocation of these additional seats, which Siddiqui provided along with details for provincial assemblies. The ECP counsel was summoned to clarify the number of additionally allocated reserved seats for women in the NA, confirming 23 seats. Siddiqui also presented the number of general seats won by each party in the recent elections, emphasizing the SIC's status as a parliamentary party.—RT/Agency

Iddat Case Set For June 7 Following Bushra Bibi's Plea

ISLAMABAD: Bushra Bibi, the wife of Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan, Tuesday moved a district and sessions court in the federal capital, seeking an early hearing of her appeals filed against her conviction in the iddat case.



In her petition, the former first lady argued that the appeals against conviction are scheduled for hearing in the local court, requesting it to fix the appeals for hearing this week.

Following her appeal, the court fixed the hearing of the appeals on June 7, seeking arguments on the case.

The plea by Bushra has been filed a day after the Islamabad High Court accepted District and Sessions Judge Shahrul Arjumand's request seeking transfer of the iddat case to another court.

The IHC's decision came days after the judge wrote a

letter to its registrar, stating it would not be appropriate for him to announce the verdict in the aforementioned case due to reservations raised by Bushra's former husband and petitioner Khawar Maneka. Following the judge's request, the IHC transferred the case to the court of Additional District and Sessions Judge Muhammad Afzal Makka. Bushra Bibi's lawyers, Salman Safdar and Khalid Yusuf, appeared in Judge Makka's court, requesting the suspension of the sen-

tence which has been pending since March 11. Safdar said that the verdict was handed down on March 29, but Maneka expressed his lack of confidence in the judge — which has delayed the hearing. He added that Bushra Bibi did not even get the right to defend herself.

"The innocent has been held prisoner. Her health is bad," the lawyer argued and requested the court to suspend the sentence this week.—RT/Agency

Foreign Office Receives Declassified Cipher Copies



ISLAMABAD: With the verdict of the cipher case announced, the foreign office has received all the declassified copies of cipher.

The FO has received declassified copies from the Senate and National Assembly as the documents had been provided to these institutions during the PTI government.

In 2023, the FO had written a letter to the NA speaker and Senate chairman where they asked for the return of declassified copies. Sources said the FO's

step to get the declassified copies back was crucial to stop the use of cipher for political reasons.

The PTI government had sent the declassified copies of cipher to NA and Senate after the approval of cabinet to bring the matter before the parliament.

In this regard, a parliamentary committee had also been formed in which the representatives of all political parties were invited, however no PDM member participated in the meeting.—RT/Agency

PTI Willing To Engage In Dialogue With Key Stakeholders, Asserts Arif Alvi

ISLAMABAD: Former president and Pakistan Tehreek-e-Insaf (PTI) senior leader Dr Arif Alvi said on Tuesday that his party would hold dialogue with the one who has real power to make decisions.



He stated this while responding to a question about the impression that incarcerated PTI founder Imran Khan was not in favour of holding dialogue with his political opponents to bring stability to the country.

The statement came after multiple calls from the incumbent government urging the embattled Imran Khan-founded party to hold talks to find a solution to end the political crisis, however, the former ruling party failed to give a clear response so far.

Addressing a press conference in Lahore, Alvi also said that he has "lost all hope as accountability is impossible in Pakistan." He praised the Islamabad

High Court's (IHC) verdict in the diplomatic cable case for which he claimed that "the case was lodged for no reason." As a former head of the state, Dr Alvi maintained that it was prerogative of a prime minister to decide whether to apprise the nation or not regarding a cipher.

The ex-president criticised that the "entire elite class is opposing the accountability or investigation" into the sensitive matters. "I have lost all hope as accountability is impossible in our country," he added.

"From [former military ruler] Ayub Khan till today, accountability is not our priority. Our people are so sure to see no justice here in Pakistan," he alleged.

"Pakistan has suffered a major loss due to regime change," Alvi said referring to the ouster of PTI-led government in April 2022.

He went on to say that the political developments also impacted the national economy by creating uncertainty everywhere which led the local business class to invest abroad.—RT/Agency

NEPRA Announces Electricity Rate Increase To Rs3.76 per Unit

ISLAMABAD: The National Electric Power Regulatory Authority (NEPRA) has notified an increase in electricity rates by up to Rs3.76 per unit due to a quarterly adjustment.



The hike allows power companies to recover over Rs46 billion from consumers for the third quarter of FY 2023-24. Of this total, Rs28.515 billion will be charged as capacity charges, which will be directed to independent power plants (IPPs) that have not produced any electricity and have remained idle. As a result, diluted consumers who regularly pay their bills will bear the burden of this significant amount. The substantial costs are a consequence of past governmental agreements to install power plants in large quantities, with guarantees to purchase the electricity produced. These guarantees also included payments to the IPPs even if the electricity was not taken from them.

Consequently, although there is available capacity, it is not being added to the national grid, yet consumers are still required to pay for this 2023-24 already intimated to the energy ministry (Power Division) on May 31, 2024. Accordingly, the Authority has decided to allow the instant positive quarterly adjustments of Rs46.613 billion pertaining to the 3rd quarter of the FY 2023-24, in a period of three months i.e. June 2024 to August 2024. Out of the total burden of Rs46.613 billion, Rs28.515 billion will be charged on account of capacity charges, whereas Rs10.284 billion will be recovered on account of less FCA impact of T&D losses, Rs5.309 billion O&M, and Rs 2.541 billion use of system charges.—RT/Agency

He further said that promotion of interfaith harmony was a need of the hour. Azam Nazeer Tarar said that teaching of "Guru Nanak" negate the material-

ism, adding that no religion permits for hate and violence. Service to the humanity should be our mission, he said, adding that the Prime Minister of Pakistan has sent his greetings to the Sikh community.

The law minister said that the government was taking measures to further facilitate the Sikh people who arrived here Pakistan.—RT/Agency

Vawda Declines To Offer Unconditional Apology In Contempt Case

ISLAMABAD: Senator Faisal Vawda has refused to issue an unconditional apology to the Supreme Court in the contempt case and sought an end to the matter, saying that several others had issued remarks similar to his.



Over his anti-judiciary remarks during his press conference on May 15, Vawda asked the court to show restraint in the contempt of court proceedings.

In response to the notice, he asked the Supreme Court to withdraw the contempt of court case against him, saying that the purpose behind his allegedly malicious press conference was the country's wellbeing. The politico issued the statement a day prior to his appearance in the contempt of court case for his tirade against the judiciary over the Islamabad High Court (IHC) judges' letter pointing out the intelligence agency's meddling in judicial affairs and alleged dual nationality of a senior judge.

The apex court has fixed the hearing of the case against the independent senator and Muttahida Quami Movement-Pakistan (MQM-P) senior leader Mustafa Kamal on June 5, as Kamal has also held a similar press conference on May 16. In the response submitted to the Supreme Court, Senator Vawda submitted transcripts of Prime Minister Shehbaz Sharif, Jamiat Ulema e Islam-Fazl chief Maulana Fazlur Rehman and Pakistan Tehreek-e-Insaf (PTI) leader Raouf Hasan's speeches wherein they had made hard-hitting speeches against the judiciary.

He apprised the court that Hasan had threatened judges and the judiciary as well as called a judge "tout". Whereas, Shehbaz had called judges "black sheep" and Fazl threatened judges in a speech outside the top court's building. On the other hand, Vawda said he had every respect and regard for the judiciary and could never imagine doing any act which lowered the estimation of the judiciary in any manner. However, he said, "highlighting or critique of judgements of the courts deemed to have had a negative impact on the lives of the citizens of Pakistan is not contempt."—RT/Agency

Larkana boy severely injured for trying to free a pigeon from a high tension electric wire

Cases of mouth cancer on the rise in Thatta

THATTA: An alarming increase in cases of mouth cancer has been reported in the Thatta district, primarily linked to the consumption of harmful chewing substances such as Gutka, Mawa, and Mainpuri. Dr. Sham Lal, head of the Dental Department at Civil Hospital Thatta, disclosed that the district has witnessed a significant surge in oral cancer cases, with 210 patients diagnosed over the past five years. Dr. Lal provided detailed statistics, indicating that out of the 210 diagnosed patients, 165 are in the early stages of cancer, while 50 have progressed to the third and final stage, experiencing severe pain and distress. He emphasized the crucial role played by Gutka and similar banned products in the onset of this devastating disease. "The situation is alarming and requires immediate attention from authorities," Dr. Lal stated. The consumption of Gutka, Mawa, Mainpuri, and similar substances is the primary cause of this surge in mouth cancer cases. We must act swiftly to eradicate the sale and use of these deadly products. Dr. Lal issued a passionate appeal to the residents of Thatta, urging them to refrain from using these harmful substances to prevent life-threatening diseases. He highlighted the severe health consequences of these products and called for a concerted community effort to address this growing health crisis. In response to this troubling trend, Dr. Lal is advocating for decisive action from local authorities to curb the distribution and consumption of Gutka and other harmful substances.

He believes that only through collective efforts can the community shield itself from the devastating effects of these products. The situation in Thatta underscores the urgent need for increased awareness and preventive measures to combat the rise in oral cancer associated with these dangerous substances. Dr. Lal's call to action emphasizes the importance of community involvement and stringent regulatory measures to tackle this public health issue.

Thatta Police arrest 13 during operations against drug dealers

THATTA: Police in Thatta, under the guidance of SSP Dr. Muhammad Imran Khan, have launched a rigorous crackdown on drugs, criminal elements, habitual offenders, and the sale of banned items like Gutka and mairpuri. As a result of these efforts, authorities have apprehended 12 Gutka material suppliers, one drug dealer, and one active criminal, filing cases against them under various criminal laws. During the operations conducted in Makli, Dhabeji, and Thatta, law enforcement

seized a significant amount of contraband and vehicles, including 561 kg of Gutka material, 450 packets of Mawa, 2 Cultus cars, 2 rickshaws, 1020 grams of hashish, 30 bags of local alcohol, and 1 pistol. The arrested gutka material suppliers have been identified as Mumtaz Dolo, Salman Dolo, Ismail Pathan, Shehzad Pathan, Shakeel Memon, Zahid Abdullah Mallah, Hamida Samjo, Shaista Samjo, Sanam Samjo, Maryam Samjo, Ameena Samejo, and Kulsom Samejo. Additionally, Sajid alias Sajo Dayo, a drug dealer, and Addo alias Eid Muhammad Gandro, wanted in connection with a robbery case by Makli police, have been apprehended. Further operations led to the seizure of an additional 261 kg of gutka material and 450 packets of Gutka Mawa. Separate cases under the Gutka Act, Narcotics Act, Drugs Ordinance, and Arms Act have been registered against the arrested individuals at their respective police stations. The Thatta police affirm their dedication to continuing efforts to eradicate illegal substances and criminal activities from the community.

Pithoro residents apprehend two thieves

Talk about bad optics!

The recent barring of journalist Imran Riaz from boarding a Hajj flight at Islamabad Airport is a stark reminder of the draconian measures that have plagued Pakistan in recent months. This act is not only unlawful but also deeply unethical, especially given that the Islamabad High Court (IHC) Chief Justice Aamer Farooq had granted Imran permission to travel for the sacred pilgrimage. It is an outright violation of his fundamental rights, setting a dangerous precedent for the treatment of individuals under scrutiny.

Imran Riaz has endured significant hardships, including a period of enforced disappearance, and his very survival is nothing short of miraculous. His ordeal epitomizes the controversial and oppressive measures that have been increasingly employed over

the past 26 months. The fact that a journalist, whose profession is crucial for the functioning of any democracy, is subjected to such treatment speaks vol-



umes about the current state of affairs in Pakistan. The federal cabinet's decision to place Imran's name on the Exit Control List (ECL) on the suggestion of the Federal Investigation Agency (FIA) appears to be a politically motivated move rather than a step towards justice. This becomes even more evident when we consider that other individuals, including PTI leader Babar Awan, had their names re-

moved from the ECL. The selective enforcement of these measures undermines the very purpose of the ECL, which is to address legal matters and prevent those under investigation from evading justice.

Pakistan, a nuclear-armed nation, cannot afford to continue on this trajectory of arbitrary and unjust actions. It is imperative that better sense prevails and that an understanding is reached to restore the rule of law and respect for human rights. Imran Riaz's case is a litmus test for the country's commitment to justice and fairness. Preventing him from performing Hajj, a religious obligation, is not only a legal affront but a moral one. It is high time that the authorities reconsider their stance and allow Imran to fulfill his pilgrimage, signaling a commitment to upholding justice and human dignity.

Seminary teacher shot and injured in KN Shah robbery

KN SHAH: Muhammad Jabir Brohi, a resident of Khairpur Nathan Shah, fell victim to a harrowing ordeal at the hands of three unidentified armed robbers who mercilessly attacked and injured him. The incident occurred near Makhdoom Bilawal on the main Indus Highway, where the assailants brazenly robbed him of his 2018 CD motorcycle, leaving him wounded and traumatized.

GUYANA: Afghanistan defeated Uganda by 125 runs in the fifth match of the ongoing T20 World Cup 2024 at Providence Stadium in Guyana on Tuesday.

Earlier, Uganda won the toss and chose to bowl first against their opponents in the Group C match. They were handed over a target of 184 runs.



Afghanistan's Fazalhaq Farooqi bagged career-best figures of 5-9. The winners dismissed Uganda for only 58 in 16 overs.

Farooqi claimed two wickets in the very first over of the innings which put Uganda on the backfoot during the run-chase. After the early loss of wickets, Uganda weren't able to recover and

were bundled out for a low total.

Naveen-ul-Haq and Rashid Khan also claimed two wickets each.

In a sorry batting display, Robinson Obuya was the top scorer for Uganda with 14 runs in 25 balls.

Uganda had won the toss and decided to bowl first against Afghanistan in the fifth match of the World Cup.

Batting first, Afghanistan finished on 183-5 in 20 overs.

Afghanistan opens provides a solid start to their side with a 154-run stand for the first wicket. Rahmanullah Gurbaz scored 76 runs in 45 balls, meanwhile Ibrahim

Zadran added 70 in 46. Gurbaz and Zadran's opening stand of 154 was the second highest in men's T20 World Cup history, second only to the 170 partnership between England's Jos Buttler and Alex Hales at the 2022 World Cup. However, after the strong start, the Afghans lost their way and lost four quick wickets for just 15 runs which helped Uganda stem the flow of runs. Captain Brain Masaba was the pick of the bowlers for Uganda with impressive figures of 2-21 in four overs. Cosmas Kyewute also claimed figures of 2-25. In the last five overs, Afghanistan were only able to muster 27 runs for the loss of four wickets at a run-rate of 5.40.—Agency

'Fakhar Zaman can win match alone': Ex-Indian player warns Rohit Sharma's team



NEW YORK: While portraying the Pakistan batting as a feeble lineup, former Indian cricketer Mohammad Kaif has warned Rohit Sharma's explosive batting which he said could alone win a match.

Kaif said this during an appearance on Star Sports while analysing Pakistan's potential ahead of the first T20 World Cup 2024 clash with India on June 9. The high-octane game will take place at New York's Nassau County International Cricket Stadium.

The former batter stated that except for a couple of players, the rest of Pakistan played at a low strike rate. He said Fakhar and Iftikhar Ahmed were quick hitters to be reckoned with.

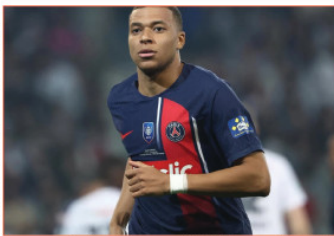
He said it was an open secret that Pakistan had a weak batting. "Fakhar plays a little fast, (and) if he fires, he can

Mbappe makes 'dream' move to Real Madrid



MADRID: Kylian Mbappe signed a five-year deal to move to Real Madrid from Paris Saint-Germain on Monday and hailed the move as a "dream come true".

The announcement is the culmination of Real's long courtship of one of the most prolific forwards in world football.

"Real Madrid have reached an agreement for the player to be at Real Madrid for the next five seasons," the club said in a statement.

"So happy and proud to join the club of my dream @realmadrid. Nobody can understand how excited I am right now. Can't wait to see you, Madridistas, and thanks

for your unbelievable support." 25-year-old Mbappe added on social media.

He will earn 35 million euros (\$38 million) a season, according to reports in Spain. Mbappe's last contract with PSG, signed in 2022, was a two-year deal worth some 72 million euros before tax with loyalty bonuses of a similar amount and a signing-on fee of 150 million euros.

Mbappe had verbally agreed to move to Real in February and then announced in May he would leave PSG at the end of the season.

Real, fresh from winning their 15th Champions League on Saturday with a 2-0 victory against Borussia Dortmund, moved to confirm the deal on Monday before Mbappe is involved in pre-Euro 2024 friendlies for France.

A World Cup winner as a teenager in 2018, Mbappe scored a club record 256 goals for PSG since joining the Qatar-owned club from Monaco on an initial loan in 2017.—Agency

Serbia's Mitrovic the lynchpin for Euro newcomers



LONDON: Serbia striker Aleksandar Mitrovic, a prolific marksman at club level and among the top scorers in Euro 2024 qualifying, carries the hopes of a stuttering side who will rely heavily on their attacking firepower in a long overdue Euros debut.

Mitrovic comes into the tournament with 28 goals in 28 matches in the big-paying Saudi Pro League, beaten only by its poster boy Cristiano Ronaldo, and will need that form if Serbia are to stand any chance of reaching the knockout rounds.

The Eagles, in their first Euros as an independent nation, have tough rivals to contend with, drawn in Group C with Slovenia, 1992 champions Denmark, and England, runners-up in 2020 and among the favourites to win the title.

Mitrovic, 29, has much to prove in Germany after his shootout miss in a playoff with Scotland cost World Cup regulars Serbia a spot at Euro 2020, a fourth straight

Germany held by Ukraine in Euro warm-up



GERMANY: Germany were held to a 0-0 draw by Ukraine as the European Championship hosts lacked a cutting edge at a sold out Max-Morlock stadium in Nuremberg.

More than 44,000 fans were in jovial mood at kick-off, expecting a Germany that have rediscovered their form under Julian Nagelsmann put on a show less than two weeks before they start Euro 2024 against Scotland in Munich on June 14.

What Germany's supporters got was something quite different, as Nagelsmann's side dominated long periods and created many chances but failed to make the breakthrough against a resilient Ukraine.

"I had the impression that the team wanted to win and we played very well for long stretches," Nagelsmann told German public broadcaster

Das Erste. "The first 20 minutes of the game were very, very good. We had to take the lead then."

"I think we need to be even more aggressive."

"We simply need to get more players into the box and put a bit more stress not their penalty area. The players we brought on didn't need any time to get into the game, they all did well," the 36-year-old added.

Germany came into this game having turned a corner under Nagelsmann, winning their last two games against France and the Netherlands with an aggressive, high tempo style and sparking optimism that, with home advantage, this European Championship could be a successful one.

Nagelsmann was without Real Madrid's Toni Kroos and Antonio Rudiger, both rested after winning the

Champions League final as well as Borussia Dortmund pair Nico Schlotterbeck and Niclas Füllkrug.

Brighton midfielder Pascal Gross deputised for Kroos admirably, pulling the strings alongside Bayer Leverkusen's Robert Andrich, and Germany were relatively comfortable at the back, as Stuttgart's Waldemar Anton enjoyed an assured full debut alongside Jonathan Tah.

It was rather in attack where Germany laboured, lacking a cutting edge - despite the impact of Nagelsmann's subs.

Arsenal's Kai Havertz was isolated at times and Bayer Leverkusen's Florian Grillitsch, whose every touch sent a buzz of excitement around the stadium, failed to get going before his withdrawal at half time.—Agency

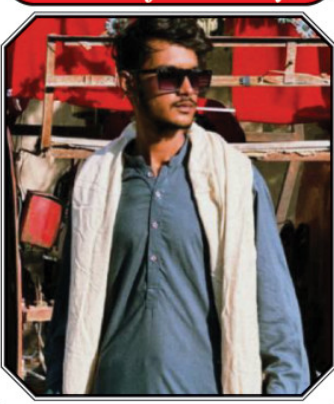

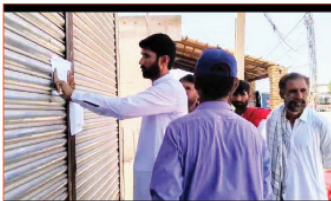

The demonstrators accused government officials of ineffective action, exacerbating the severity of the crisis and leaving residents grappling with the devastating effects of water scarcity. Mounting debts, coupled with the loss of crops, have left many residents struggling to make ends meet. In a collective call for action, the protesters urged the government to intervene immediately and resolve the

water crisis plaguing the region. They demanded accountability from the authorities, including the Sindh Government, and called for swift measures to address the root causes of the crisis and ensure justice for the affected residents. As the protest rages on, the plight of Naukot's growers underscores the urgent need for decisive action to alleviate their suffering and safeguard the region's agricultural livelihoods.

22 injured in Banglani community clash during Thul wedding ceremony

THUL: Chaos erupted during a wedding celebration hosted by the Banglani family in the Ghawanwani Banglani area, falling under the jurisdiction of the C-Section Police Station, resulting in a clash that left 22 individuals injured. They forcibly snatched his motorcycle, mobile phone, and cash, and started beating him. This is when Ittiqa put up resistance, prompting the muggle to open fire.

Kamal condoled with the parents of Ittiqa and said that people of urban areas are being oppressed under the quota system in Sindh for the last 50 years.

He alleged that jobs are given to the people of rural Sindh on the quota of rural Sindh by creating fake domiciles and now these talented youths are being killed under the guise of robbery.—RT/Agency

Karachi Man Abducted While Riding A Bike



KARACHI: In a bizarre incident, the traffic police in Karachi lifted a motorcycle along with the rider for resisting the towing of his vehicle, media reported on Tuesday.

The incident occurred near the Passport Office in Karachi's Saddar Area on Monday, where the traffic police officer and lifters lifted the motorcycle along with the citizen and drove away.

The citizen resisted and tried to retrieve his motorcycle, but the police officer refused to listen. The video of the incident is going viral on social media.

Meanwhile, DIG Traffic Ahmed Nawaz has ordered an investigation into the matter.

Police officials claimed that the citizen had initially lain down in front of the lifter's vehicle and later sat on his motorbike.

The police have returned the motorbike to the citizen after he submitted a written apology at the police station.—RT/Agency

Robbery Attempt In DHA Leaves Karachi Businessman Dead

KARACHI: A businessman was killed by motorcycle-riding assailants during a robbery attempt in Karachi's upscale Defence Housing Authority (DHA) neighbourhood on Tuesday.

According to details, the incident took place on Street No. 12, DHA Phase II. The armed motorcyclists followed Asif Balwani, the owner of an embroidery factory, and shot him near his home.

SSP South Sajid Sadozai stated that Balwani, around 60 years old, had recently bought a house in DHA. He had withdrawn a significant amount of money from a bank and was heading home when he was attacked.

"The assailants failed in their robbery attempt, as the victim's mobile phone and the Rs1 million cash he had withdrawn were still in the car," Sadozai said.

The SSP South added that all evidence from the crime scene has been collected, and CCTV footage from the surrounding area is being reviewed.—RT/Agency



CM Inaugurates Disabilities Training Center

KARACHI: Sindh Chief Minister Syed Murad Ali Shah today inaugurated the Vocational Training Centre for Persons with Disabilities, Ancholi in a simple ceremony organised at CM House's Conference Room on Tuesday. He got the plaque unveiled by a differently-abled person - Ali Ansar.

KARACHI: Jamaat-e-Islami (JI) Karachi Ameer Munem Zafar has expressed his profound grief and grave concerns over the target killing of another youth while offering resistance to street criminals.



The JI leader expressed these views at Idara Noor-e-Haq, here on Tuesday while commenting over the recent spike in target killing and street crimes in the mega city.

Speaking on the occasion, he said that 20-year-old Abdul vander Basti was gun downed in Karachi in a bid to snatch mobile phone and cash, whereas Asif Salman Balwani was targeted in the broad day light.

At one hand, Karachiites have already been facing a hell like situation due to skyrocketing street crimes, whereas on the other hand a fresh spree of target killing has been witnessed in the city, he said, asking what their fault was. The Sindh government, the police de-

partment and other law enforcement agencies have failed in Karachi when it comes to the security of life and possession, he said.

He further said that corruption, political interference and recruitment have plagued the Sindh police. He also highlighted the failure of the Safe City Project that had consumed billions of rupees.

On the occasion, he demanded to purge the police of black sheep, recruit locals in the Karachi police and bring in across the board reforms in the police department.—RT/Agency

Ban Imposed On Public Display Of Weapons

KARACHI: The Sindh government on Tuesday imposed an immediate ban on the display of weapons across the province for three months, media reported.

According to the notification issued by the Sindh Home Department, private security guards could carry weapons only at the site of their duty, while display of weapons in vehicles during travel would be prohibited.

The ban would not be applicable on personnel of police and other law enforcement agencies during their duty hours. Whereas, private security companies would only be allowed to carry weapons at the place of duty within the working hours.

However, they were prohibited from displaying weapons openly in vehicles during transportation. They could keep their weapons inside the vehicle.

The SHOs of police stations across the province have been authorised to register complaints under section 188 of the Pakistan Penal Code over violation of the ban. The development comes as Karachi has witnessed a significant rise in street crime incidents in recent months, with 71 people losing their lives at the hands of criminals in 2024 so far.—RT/Agency

MQM To Unveil An Alternative Budget: Sattar

KARACHI: MQM leader Farooq Sattar has said they are presenting a shadow budget for the development of the people of Pakistan.

Talking about the shadow budget, he said Muttahida Business Forum had prepared the budget after intense working.

He said anti-Karachi budget were presented and the party had always opposed that moves.

The police said that the security guard, identified as Ahmed Gul, 35, opened fire on Saad Ahmed, 24, while he was making a TikTok video near Sereena Mobile Mall in the Buffer Zone area of Karachi.

According to police, the security guard stopped the young man and then opened fire on him.

Senior Superintendent of Police (SSP) Central said that the incident occurred within the limits of Taimooria police station and the security guard has been arrested.



The SSP said that in the initial interrogation, the guard claimed that '222' was seized. The police said that the weapon used in the incident is recovered while further investigation is underway.—RT/Agency

Eid ul-Adha Expected To Fall On June 17

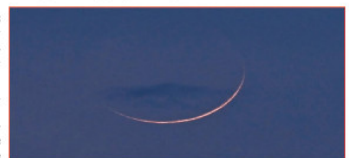
KARACHI: As Pakistanis prepare for Eidul Adha by purchasing sacrificial animals, an official on Tuesday announced that the Zil Hajj moon is expected to be born on June 6.

Chief Meteorologist Sardar Sarfaraz stated that the new moon, which marks the start of the Islamic month of Zil Hajj, will be born precisely at 5:38 pm local time.

He said that there were high chances of the moon being sighted on June 7 as it would be of more than 26 hours by then.

Eidul Adha marks the end of the Hajj which is one of the five pillars of Islam and should be undertaken by every Muslim who can afford to do so. It takes place between the 10th and 13th day of the Islamic month of Zil-hajj, the sacred pilgrimage that is the fifth and final pillar of Islam - finishes in Saudi Arabia. PM Promises Chinese Firms Great Dividends For Investing In Pakistan

ISLAMABAD: As Prime Minister Shehbaz Sharif departed for a five-day official visit to China, he reiterated his commitment to strengthening bilateral ties by engaging in discussions with Chinese business leaders to secure investments and yield dividends mutually beneficial for companies on both sides.

"We are coming with serious plans. We will engage with you and return to Pakistan with great dividends that will benefit Chinese and Pakistani companies and the two countries will have their relations strengthened and become much higher than the Himalayas or any other highest peaks and deeper than the deepest oceans," the prime minister said in an interview with the representatives of different Chinese media groups including Xinhua news agency, national broadcaster CCTV and CGTN Urdu, prior to his first official visit to China after assuming office.

He said through the visit, Pakistan hoped to promote interaction between enterprises in both countries, utilize Special Economic Zones and Pakistan's labor advantages to establish joint ventures, facilitate the transfer of



industries and technologies, and enhance Pakistan's manufacturing output, to promote constructing upgraded China-Pakistan Economic Corridor, the prime minister said.

In a detailed interaction, the prime minister spelled out his government's priorities to improve the national economy through structural and institutional reforms, cost-cutting, industrialisation and facilitation of the investors.

He said Pakistan wanted to learn from Chinese experiences and build the SEZs with the first one to be developed at Pakistan Steel Mills premises already connected with the rail network and located near the port. He invited the Chinese provinces and companies to build SEZs and enter into joint ventures with Pakistani companies for

through the most difficult times and said Pakistan considered China one of its most trusted friends around the globe. He said Pakistan firmly adhered to the one-China principle and this commitment would always be unwavering. About the Chinese development, he said, "Today, China has become a giant through vision, hard work, and serious and untrifling efforts... All doubts about the Chinese model have been rubbished by the evidence of history." Referring to the congratulatory message from Chinese President Xi Jinping after his election, Prime Minister Shehbaz said, "This reflected the two countries' friendship, which will always be fresh in his mind." Xi's leadership which steered millions of the Chinese people out of poverty and that during the visit, he wanted to learn from the Chinese model of poverty alleviation. He said Pakistan was also ready to learn from China's governance experience, deepen reforms and counter-corruption, create enabling circumstances for Chinese investors, and provide policy support for investors.

Similarly, by learning from Chinese agriculture technology, Pakistan desired to multiply its agricultural produce and export them. Discussing the bilateral relations, the prime minister said, "We are two iron brothers, our friendship is unshakable and our hearts beat together."

He appreciated the Chinese support of Pakistan Economic Corridor (CEC), he said since the start of its construction in 2013, the achievements of the project had been obvious to all. "From a more convenient and faster transportation network to a cleaner and more stable energy infrastructure, the CPEC has brought broad development opportunities to Pakistan." He said as CPEC was entering the second phase, and a new stage of high-quality development, the two countries were cooperating in agriculture, mining, labor-intensive light industry and other fields. Referring to the launch of Pakistan's first moon satellite and multi-mission communication satellite with Chinese support, the prime minister said the scientific and technological cooperation between the two countries had promoted Pakistan's scientific and technological progress. The multi-mission communication satellite is expected to change Pakistan's current digital environment, provide fast internet facilities for the whole country, improve people's lives, and promote e-commerce, online government affairs and economic development, he added.—RT/Agency

Naval Chief Urges Action Against Grave Threats To Marine Ecosystems From Human Activities

ISLAMABAD: Chief of the Naval Staff, Admiral Naveed Ashraf on Tuesday demanded the stakeholders and nation as a whole to address the grave threats to marine ecosystems due to the anthropogenic activities posing serious risk to marine life and ecology.

In his message in connection to the World Environment Day issued by the Pakistan Navy, the Admiral said, "World Environment Day (WED) is observed on 5th of June each year and calls for protecting our natural surroundings. The day, celebrated under the ambit of United Nations Environment Programme (UNEP) marks an occasion to raise awareness on the challenges facing our environment such as pollution, illegal wildlife trade, unsustainable consumption, rising sea levels and food insecurity."

This year's theme for the WED is 'Land Restoration, Desertification, and Drought Resilience'. The occasion will serve as a stark reminder of the urgent need to protect our land, sea, and everything in between.

He said, "Pakistan's long coastline provides access to rich resources of livelihood for millions of people. Our marine resources are a treas-



ure trove of biodiversity that support a vast array of marine life, from majestic sea turtles to colourful coral reefs."

However, the coastal areas and marine ecosystems were facing grave threats from human activities that include marine pollution, such as oil spills and industrial effluents endangering marine life and contaminating the food chain, he added.

The Naval Chief added that overfishing and unsustainable fishing practices are depleting fish populations, damaging the delicate balance of our marine ecosystem. "Rising sea levels are causing coastal erosion which is accentuated by deforestation and construction activities that threaten the very existence of our coastal communities," he said.

Pakistan Navy, he said celebrates WED to highlight the significance of environment in Pakistan to promote awareness amongst personnel and encourage them to adopt practices conducive to the marine environment. PN has initiated numerous measures and actions ranging from collection of solid waste from harbour, establishment of Reedbed Plants in all areas under its jurisdiction and extensive tree plantation campaign. PN also continues to sensitize concerned Government and Non-Government organizations and departments to join hands and take actions to stem marine pollution and desertification.

A number of activities are planned by Field Commands and PN Units to inculcate a sense of responsibility amongst all to save and preserve our environment. Fawad Advocates Dialogue With Imran As The Only Way Forward

ISLAMABAD: Former Federal Minister Fawad Chaudhry said that there is no other way except to hold dialogues with the Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan, media reported.

Speaking to media representatives outside the Supreme Court (SC) of Pakistan, Fawad Chaudhry asked the PTI not to get 'excited' and hold dialogues. "You (PTI) have got an opportunity to resolve the issues through dialogue," he added.

The former minister said that the PTI founder has the "power of the people" of the country, adding that no one can stand against the power of the people.

Fawad Chaudhry said that what was going to occur already happened but now the country cannot be run through the use of force.

He said that former Army Chief and President General (ret) Pervez Musharraf was sentenced to death not for toppling the Pakistan Muslim League-Nawaz's (PML-N) government but for 'sending' the judges home.

"Those who are seeking martial law in the country should read the episode of Pervez Musharraf," Fawad Chaudhry said.



It is pertinent to mention here that the PTI refused to hold dialogues with those who have "no authority or credibility" to mediate.

Reacting to the dialogue offer from Minister for Petroleum Division and PML-N leader Musadik Malik and Khyber Pakhtunkhwa (KP) Governor Faisal Karim Kundi, the PTI spokesman termed the offer as ridiculous.

The PTI spokesperson said that those who offered to hold talks were "imposed through fake mandate". "National criminals do not have the authority to take decisions in the interest of the nation, nor is there room for reconciliation," it added.

The PTI made it clear that it would not hold talks with "mandate thieves" including Pakistan Muslim League-Nawaz, Pakistan People's Party, and Mutahida Qaumi Movement.

PTI Leaders Challenge FIA Summons In Imran's X-Post Controversy

ISLAMABAD: The Pakistan Tehreek-e-Insaf (PTI) has moved the Islamabad High Court (IHC) against the Federal Investigation Agency's (FIA) summons issued to party leaders as the body probes Imran Khan's X post on the 1971 war.

In the petition, PTI Chairman Barrister Gohar Khan, Information Secretary Raouf Hasan, and Secretary-General Omar Ayub Khan alleged that the government and its allies were targeting the party through a "pre-planned attack". A post on X, formerly Twitter, was attributed to the former prime minister, which read: "Every Pakistani should study the Hamood ur Rahman Commission Report and get to know who was the true traitor, General Yahya Khan or Sheikh Mujibur Rahman."

The post drew flak from government members and other politicians, with Prime Minister Shehbaz Sharif saying that Khan's true face was finally in front of the nation, implying that he wanted to divide the country. In response, the party said the PTI founder had nothing to do with the post since he was in jail. Later, a leader said everything was posted with Khan's approval, opening a new Pandora's box. However, the party later owned the post



and said it was uploaded to inform the public about past mistakes as it was crucial to learn from them so they aren't repeated. The FIA then issued notices to the party leaders. In the petition filed today, the PTI leader said, "In the garb of the alleged tweet, the FIA is hell-bent on making another case against Imran Khan, workers of PTI and its leadership." The notices issued to the leaders, the plea said, are void, illegal, without jurisdiction, and mala fide, having been issued without lawful authority, and are liable to be set aside. The plea said that the contents of the notices—issued on May 30—were vague and the purpose of the notice, its connection with the complaint has not been explained. They mentioned that "it is well established" that the right to a fair trial includes the right to a fair investigation. In this case, however, it said, it is

clear from the complaint and surrounding circumstances and the notice that the petitioners would not be treated in accordance with the law and would also be denied a fair investigation. They added that in the case, it appears that the complainant, namely Anees Ur Rehman, technical assistant FIA, CCRC, made the alleged complaint without approval of the federal government and under a dictation. The plea said that Rehman is neither personally aggrieved nor is there any reference to any previous approval with regard to the alleged commission of offence granted by any authority or institution. The plea said that the FIA's decision to initiate an inquiry regarding the misuse of the X account is tainted with "malice" in a bid to "victim[ise], oppress, and target the workers and leadership of PTI" with a view to causing irreparable damage to the party.—RT/Agency

IHC Halts Execution Of Five Court-Martialed Former Navy Officials

ISLAMABAD: The Islamabad High Court (IHC) has stayed the execution of five ex-Navy officers who were previously sentenced to death through a general court martial decree, it emerged on Tuesday.

IHC's Justice Babar Sattar issued a written order for Monday's hearing on the request of Navy officers who said they were not provided legal assistance during the general court martial order.

The court order, a copy of which is available with media, said the counsels for the petitioners argued that the documents permissible to be shared with their clients, such as the abstract of evidence and court of inquiry, were also not shared with them.

The lawyers asserted that an appeal was filed against the death sentence without access to these documents and was dismissed, adding that the reasons for the appeal court upholding the sentence were not shared with the petitioners.

Furthermore, the lawyers said that they were given limited access to documents despite a court order and this prevented the petitioners from defending their rights. Meanwhile, Assistant Attorney General (AAG) Akeel Akhtar Raja said that Chief of the Naval Staff Admiral Naveed Ashraf had the authority to access the documents and according to rule 193 of the Pakistan Navy Rules, 1961, discretion was vested with him to form "an opinion that supply of any proceedings may be prejudicial to the safety or interests of the state". The AAG that in terms of



the above rule, the naval chief had formed an opinion in the cases that sharing details of the proceedings, including the findings recorded by the general court martial and the order passed in appeal upholding the death penalty, "would be detrimental to the safety or the interests of the state". When asked as to whether the naval chief's opinion was placed on file, the AAG replied in the negative and Deputy Judge Advocate General Hamid Hayat said that it would be available with the Pakistan Navy headquarters.—RT/Agency

ECP Reserves Verdict On Parvez Elahi's By-Election Plea For PP-32



ISLAMABAD: The Election Commission of Pakistan (ECP) Tuesday reserved its decision on the petition filed by former chief minister of Punjab Parvez Elahi for by-elections on PP-32.

A three-member bench headed by Chief Election Commissioner (CEC) Sikandar Sultan Raja conducted the hearing.

Elahi's lawyer alleged that they had not even allowed his client to submit his nomination papers in the by-election on April 21. The by-election was allegedly rigged, as Pervez Elahi's 70

Muzaffarabad Court Rejects Poet Ahmed Farhad's Bail Plea

MUZAFFARABAD: An anti-terrorism court in Muzaffarabad has rejected the bail petition of poet Ahmed Farhad.

The development comes a day after the court reserved its verdict after hearing arguments from both sides.

Speaking with journalists about the court's orders, the poet's wife Urooj Zainab said she will challenge the decision.

"Details of why the bail was rejected were not disclosed," she said addressing the press.

Just two days before the hearing of his bail plea, the ATC had ordered a medical examination of the poet amid concerns of slow poisoning.

Last week, the ATC ordered a medical examination of the poet by a team of doctors from the Abbas Institute of Medical Sciences. The development came during the hearing of case



involving Farhad whose counsel, Iman Mazari, requested the court to have the Kashmiri poet medically examined. Mazari said that Farhad was transferred to Muzaffarabad from DhirKot under multiple sections of the Anti-Terrorism Act (ATA). Farhad, known for his defiant prose, came into the spotlight after he went missing during recent protests in Azad Jammu and Kashmir. His wife, Urooj Zainab, said her husband was allegedly abducted from his

house on May 14. Subsequently, she moved the Islamabad High Court (IHC) seeking her husband's recovery along with requesting the court to identify, investigate, and prosecute those responsible for his disappearance. The poet remained missing for 15 days before Attorney General for Pakistan, Mansoor Usman Awan, on May 29, in response to IHC's directions to recover the missing poet, said Farhad was arrested and in AJK police's custody.—RT/Agency
