Moon Sighting Confirmed As Nation To Celebrate Eid ul Azha On June 17th

KARACHI: The Central Ruet-e-Hilal Committee on Friday announced that it sighted the Zilhajj moon and Eidul Azha will be observed on June 17.

This meeting took place at the Pakistan Meteorological Department building in Karachi with simultaneous zonal meetings in the provincial capitals and Islamabad. Officials from the Peshawar zonal meeting said the moon was spotted about the central committee would make the official announcement.

Addressing a press conference in Karachi later, Central Ruet-e-Hilal Committee Chairman Maulana Abdul Khabeer Azad said Eid will be celebrated on June 17 after testimonies of moon sightings were received from various cities all over the country, including Peshawar, Attock, Kohat, Mianwali,



Taxila, Murree, Narowal and Lahore.

"You know this is a very blessed month and the merits of these 10 days [of Hajj] have also been explained," he said and urged people to spend the days in worship.

Maulana Azad said the country was moving forward and called on the nation to unite to foil the schemes of its enemies.

He also said the nation's prayers were behind law en-

forcement agencies working to ensure the country's security.

A day ago, Saudi Arabia's Supreme Court announced the sighting of the Zilhajj moon with the last month of the Islamic calendar beginning today.

The rituals of Hajj will commence on June 14 with the Day of Arafat on June 15. Eidul Azha will be observed in the kingdom on June 16.—RT/Agency

Pakistan And China Pledge To Safeguard CPEC Against Critics And Opposition

BEIJING: Pakistan and China have vowed to protect the China-Pakistan Economic Corridor (CPEC) from its detractors and adversaries as Prime Minister Shehbaz Sharif assured Beijing of providing complete security to personnel working on multi-billion projects.

PM Shehbaz is visiting China from June 4 to 8 at the invitation of President Xi Jinping, seeking to upgrade cooperation under the multi-billion dollar China-Pakistan Economic Corridor (CPEC), a key part of Beijing's Belt and Road Initiative.

In a statement, the PM's Office said during the meeting, the two sides discussed the significance of Gwadar as an important pillar of CPEC and agreed to expedite the timely completion of all related infrastructure projects to transform Gwadar into a regional economic hub.

"They also expressed



their firm commitment to protect CPEC from its detractors and adversaries and to upgrade CPEC in the form of enhanced cooperation," the statement said.

The prime minister also reaffirmed Pakistan's unflinching resolve to ensure the safety and security of Chinese personnel and projects in Pakistan.

Islamabad is able to meet external financing needs at a time when foreign reserves are critically low.

China has also invested billions in various power projects and road networks in Pakistan under the \$65-billion CPEC plan, but the implementation of various projects has slowed in recent months.

During the talks, the two leaders discussed the entire spectrum of bilateral relations and discussed regional and global developments of mutual interest.

They noted that the Pakistan-China All-Weather Strategic Cooperative Partnership was characterised by mutual trust, shared principles and strategic convergence.

Premier Li congratulated Prime Minister Shehbaz on Pakistan's election as a non-permanent member of the UN Security Council.

The two leaders reaffirmed unwavering support for each other on core issues and expressed continued commitment and support for the high-quality development of CPEC.

They also emphasised the timely completion of all on-going projects with a special focus on industrial development, agriculture modernisation, Science & Technology and the development of Special Economic Zones for mutually beneficial and socio-economic development of Pakistan.

The two sides agreed to

maintain high-level exchanging institutional linkages at all tiers and in all spheres of bilateral cooperation.

Pakistan and China will also continue to consult closely on issues of regional and global significance and multilateral fora, especially during the two-year tenure of Pakistan as a non-member of the UNSC.

The delegation-level talks were followed by an MoU signing ceremony, witnessed by Prime Minister Shehbaz and Premier Qiang, where both signed 23 MoUs and agreements deepening cooperation in transport infrastructure, industry, energy, agriculture, media, health, water, socio-economic development and others of mutual interest.

The meeting was followed by an official banquet hosted by Premier Li Qiang in honour of the prime minister.—RT/Agency

PTI Criticizes FIA For Issuing Notice In Imran's Tweet Controversy

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) Secretary-General Omar Ayub Khan has launched sharp criticism of the Federal Investigation Agency (FIA) for serving him a call-up notice in the party founder Imran Khan's controversial tweet case.

Ayub, speaking on the floor of the National Assembly on Friday, slammed the probe agency's notices to him and other PTI leaders — including the party's Chairman Barrister Gohar Ali Khan and Central Information Secretary Raouf Hasan — in the controversial X post case.

Ayub, who is also the Leader of the Opposition in the lower house of parliament, stressed that the parliamentarians were part of the state as per the Constitution. "Parliament is superior than to any other institutions in the country."

The politico questioned higher authorities about the jurisdiction of a probe agency's sub-inspector which allowed him to issue a call-up notice to the parliamentarians.



He demanded the House summon the FIA's director general to question his jurisdiction and also about the language which was used in the call-up notice.

Ayub said that he and several other PTI leaders were booked in terrorism cases in Sargodha. He alleged that "aliens" were involved in the disappearances of party workers whenever they came out of jail.

He slammed that association with the Imran-founded party was seemingly becoming a crime in the country while there was no law in place which could stop such illegal activities.

He went on to say that the former prime minister,

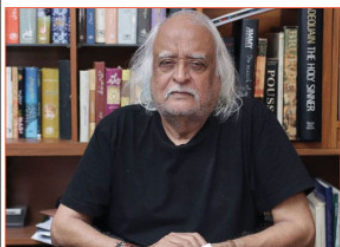
who was removed from power in April 2022, was facing "solitary confinement" which was proved from the pictures of his prison cell at Rawalpindi's Adiala Jail.

He further alleged that former first lady Bushra Bibi was also not given any facilities at the jail.

The PTI secretary-general alleged that other PTI women leaders — Aliya Hamza Malik and Sanam Javaid — were not being released despite the mandates of their release being prepared.

"Is this a banana republic? This kind of Gestapo state policy should be eliminated and let the country go ahead," he added.—RT/Agency

Imran Cooperates With FIA Investigation On Controversial X Post

ISLAMABAD: After refusing to appear before investigators twice in connection with the controversial tweet case, the incarcerated Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan has finally joined the probe into the debatable video that appeared on his official X account a few days ago, sources told media.

The former premier Khan formally joined the FIA's probe which was launched after a controversial video regarding the Fall of Dhaka incident had been posted on his official X account.

"Every Pakistani should study the Hamood ur Rahman Commission Report and get to know who was the traitor, General Yahya Khan or Sheikh Mujibur Rahman," the post read.

The sources said that an investigation team comprising FIA's Additional Director Ayaz Ahmed and Sub-Inspector Munir reached the Adiala Jail, again, to question the PTI founder.

It emerged that Khan joined the investigation in the presence of his lawyers Chaudhry Zaheer Abbas and Intezar Hussain Panjthra.

During the probe, the FIA team grilled Khan after showing his debatable X post in jail.



Not only Khan, but the FIA had also served notices to three other PTI top leaders in connection with the case, including Barrister Gohar Khan, Omar Ayub and Raouf Hasan.

However, Omar had excused from appearing before the FIA due to a "busy schedule", whereas, Gohar and Raouf appeared before the investigators on Wednesday.

Additionally, the Islamabad High Court (IHC), following a petition against the FIA's call-up notices, also directed the probe agency not to take any adverse action against them, besides directing the PTI leaders to join the probe.

Expressing severe outrage over being summoned by the probe agency for the X post probe, PTI Secretary General Omar blasted the FIA for issuing call-up notices to the parliamentarians and other

party leaders. Speaking on the floor of the National Assembly today, the Leader of the Opposition questioned the jurisdiction of a probe agency's sub-inspector which allowed him to issue a call-up notice to parliamentarians.

Omar added that the parliamentarians were part of the state as per the Constitution and the parliament was superior to any other institutions in the country.

He slammed that association with the Imran-founded party was seemingly becoming a crime in the country while there was no law in place which could stop such illegal activities.

He demanded the House to summon the FIA's director general to question his constitutional limits and also about the language which was used in the call-up notice.—RT/Agency

Unapologetic Vawda And Kamal Summoned In Contempt Proceedings

ISLAMABAD: The Supreme Court (SC) of Pakistan summoned Muttabahda Qaumi Movement-Pakistan (MQM-P) Deputy Convener Syed Mustafa Kamal and independent Senator Faisal Vawda in contempt of court case, media reported.

The SC issued a written order of Thursday's hearing, maintaining that Syed Mustafa Kamal tendered an unconditional apology and left himself at the mercy of the court.

The order said that Faisal Vawda's counsel sought time to submit an additional reply while the Pakistan Electronic Media Regulatory Authority (PEMRA) submitted the transcript of the press conferences held by both parliamentarians.

The apex court in its order maintained that Faisal Vawda's press conference was broadcast by 34 news channels and while Syed



Mustafa Kamal's press conference by 28 news channels.

"In Prima facie, broadcasting such press conferences falls under the contempt of court," the order read.

The apex court also sought replies from the news channels and asked as to why contempt of court action should not be taken against them.

It is pertinent to mention here that the SC rejected the unconditional apology tendered by Syed Mustafa Kamal while Faisal Vawda refused to apologies.

The Supreme Court (SC) has issued contempt of court notices to independent Senator Faisal Vawda and MQM-Pakistan MNA Mustafa Kamal over anti-judiciary rhetoric.

The apex court sought notice of press conferences held by Senator Faisal Vawda and Kamal wherein they demanded evidence of interference in the judiciary.

The top court then issued notices to both leaders and asked them to submit their response before the court.—RT/Agency

Video Statement By Shah Mahmood Recorded In May 9 Proceedings

RAWALPINDI: The Lahore police on Friday recorded a video statement of incarcerated PTI leader Shah Mahmood Qureshi in cases related to the violence that erupted in the country after party founder Imran Khan's arrest on May 9 last year, media reported.

A 9-member team of Lahore Police, led by DSP Javed Asif, visited Adiala Jail to interrogate the former foreign minister.

The team, which included experts from the Punjab Forensic Science Agency, brought modern equipment to record Qureshi's statement. The team also brought a polygraph test kit with them.

This is the third time Lahore Police have visited Adiala Jail to investigate Qureshi.

Sources told media that the investigation team probed cases registered at various police stations, including Shadman, Sarwar



Road, Mughalpur, Shahdara, Race Course, Gulberg, and Gujranwala.

Earlier, a Lahore anti-terrorism court (ATC) approved a five-day physical remand of incarcerated PTI leader Shah Mahmood Qureshi in eight cases related to May 9 violence.

ATC Judge Khalid Arshad approved the physical remand while hearing the May 9 cases registered in different police stations of Lahore.—RT/Agency

Justice Kayani Observes Importance Of Institutions Operating Within Their Boundaries

ISLAMABAD: Justice Mohsin Akhtar Kayani of Islamabad High Court (IHC) on Friday says no one is above the law and all institutions should work within their constitutional jurisdiction.

He gave these remarks while hearing the petition for the recovery of poet Ahmed Farhad Shah.

Advocate Iman Mazari appeared on behalf of the petitioner while senior journalist Hamid Mir assisted the court as amicus curiae.

Additional Attorney General Munawar Iqbal and Assistant Attorney General Barrister Usman Ghuman were also present in the court.

Advocate Iman Mazari said that the bail petition of Ahmed Farhad had been rejected by a local court of Muzaffargarh.

Advocate Riasat Azad said that the court shouldn't dispose of the case as it is a matter of basic human rights.



Farhad had been recovered. The court cannot proceed its hearing further when the missing person is recovered, he said.

"I am writing to chief justice to constitute a larger bench over the issue of missing persons," Justice Mohsin Akhtar Kayani said. The larger bench is required to have a diversified viewpoint, he added.

He was of the view that there is a need to draw a red-line. According to Justice Kayani, all the institutions should respect the constitution and no one is above the law.

Later, the IHC disposed of the petition for the recovery of missing poet.

"You can contact this court again if required in future. I know very well how to get implement my orders," remarked Justice Kayani. It may be recalled that poet Ahmed Farhad Shah had been allegedly abducted from his home on May 15.

Farhad's wife Arooj Zainab had lodged a complaint in the IHC for recovery of her husband.—RT/Agency

DC Sujawal Zahid Hussain Rind Leads Strict Drainage Cleaning Ahead of Impending Rains

SUJAWAL: Deputy Commissioner Zahid Hussain Rind took charge of preparations for the looming rainy season with a thorough inspection of crucial drainage systems including the Three R Drain and Karo Gogro sim nullah.



During his visit, Rind meticulously reviewed the ongoing cleaning operations, leaving no stone unturned in ensuring that all necessary measures are in place to avert any potential public inconvenience when the rains arrive. He particularly emphasized the need for the Executive Engineer Drainage Division, Asif Ali Baloch, to expedite the cleaning process and guarantee the effectiveness of the drainage system.

Sehwan's Growers Demand Action Against Water Shortage

SEHWAN SHARIF: The residents of various areas of Sehwan Sharif staged protest demonstration against the closure of irrigation water canals and the closure of the Shahbaz Pumping Scheme. Press clubs in the affected areas observed symbolic black day and demonstrators also staged protests against the concerned officials. On these occasions, prominent residents including Daim Talpur, Roshan Ali Burdi, Qurban Ali Talpur, Liaquat Ali Talpur, Comrade Gul Hassan Rind, Abdul Khaliq Sarki, and several others participated in the protests. The demonstrators expressed their grievances that in the 4 irrigation zones of Sehwan, including Bobak, Arzi, Jafarabad and Del, they have been deprived of agricultural water, resulting in them resorting to symbolic strikes, and the failure of irrigation officials to take action has led to a complete halt in agriculture. Since the last major devastation in 2022, when the Shahbaz Pumping Scheme was inaugurated by a significant figure of Sindh's government with the intention of revitalizing agriculture, only 3 motors out of 15 have been operational in the scheme, and only three were supplying water which has now been closed to supply water to the affected areas. As a result, we have faced significant losses in our agricultural produce, and we are struggling to make ends meet. Affected residents have demanded action from Sindh CM, Syed Murad Ali Shah, regarding the revival of the Shahbaz Pumping Scheme, and if this is not done, they have threatened to continue their strikes.

SEPA Team Investigates Environmental Pollution Reports In Taluka Kaloi

MITHI: After taking strict notice of the pollution caused by various coal kilns and brick kilns in the surrounding areas of Kaloi, the district administration issued directives to the relevant authorities. In response to these directives, a team from the SEPA, comprising Director General Naeem Ahmed Mughal and Regional Incharge of the Environment Department, Regional Office Mirpurkhas, Ali Muhammad Rind, along with Assistant Director Technical Abdul Aziz Mahar, Chemist Shahid Rehman, and Inspector Muhammad Iqbal Nohri, conducted a visit to Kaloi and Wangoo Mor and its surrounding areas to inspect the brick kilns and coal kilns. During the inspection, the team observed that wood was being burnt on the brick kilns, which is strictly prohibited. No prohibited fuel, such as plastic, shoes, bottles, or cloth, was found on the kilns. However, on the other hand, the process of making coal from wood was ongoing in the coal kilns. The artificial coal produced in these kilns is made by burning wood, which results in the emission of smoke affecting the surrounding areas. Regional Incharge of the Environment Department, Regional Office Mirpurkhas, Ali Muhammad Rind, stated that the team from the SEPA has visited and submitted a report. Accordingly, action is being taken under the Environmental Protection Act 2014. He further mentioned that no individual would be allowed to pollute the environment. Anyone found engaged in such activities would face severe consequences. Moreover, it was informed that the SEPA had previously taken action against the brick kilns present at Wangoo Mor, which is why no plastic, shoes, or cloth was being burnt. Prior notices were sent to them through the police, and they were also warned personally. They were strictly instructed not to burn plastic, shoes, or other waste and further stringent action would be taken against them if they fail to comply.

Sindh On High Alert Ahead Of Anticipated Heavy Rains And Flooding

KARACHI: Chief Secretary Sindh, Syed Asif Hyder Shah, chaired a crucial meeting at the Sindh Secretariat to review preparations for the heavy rains and flooding expected from July to September. The meeting included Provincial Ministers Saeed Ghani and Makhdoom Mehboob Zaman, senior government officials, and representatives from the Army, Police, HESCO, and SEPCO Divisional, Deputy, and Assistant Commissioners participated via video link. Makhdoom Mehboob

Zaman highlighted that above-average rainfall, combined with glacial melt, could bring 500,000 to 900,000 cusecs of water into the Indus River. He noted extreme rainfall in Padidan and Larkana last year and stated that warehouses in Karachi, Jamshoro, and Sukkur are stocked with emergency supplies. Chief Secretary Syed Asif Hyder Shah directed departments to maintain contact with the Meteorological Department and PDMA and convene District Disaster Management Authority meetings to prepare flood contingency plans. He emphasized the need for an inventory of emergency resources and heightened preparedness due to climate change. Saeed Ghani announced the setup of relief camps at the union council level and the stocking of essential supplies in district warehouses. He assured funding for WASA in Hyderabad for cleaning stormwater drains. The Secretary of Irrigation briefed on measures to protect the LBOD and manage water flow from Balochistan.

Maryam Orders For Full Implementation Of RUDA Master Plan



LAHORE: A decision was made to collaborate with China and other international organisations to complete the Ravi Urban Development Authority (RUDA) projects. The establishment of a special police force to prevent encroachment on RUDA's land was also discussed. On this occasion, Nawaz Sharif stated that in 2013, he had planned to develop a new city on the bank of the Ravi River. However, successive administrations created barriers. Nawaz also called for action against those delaying the future development of Lahore. —RT/Agency

Son Of CM's Aide Accused Of Arms Smuggling

JACOBABAD: A Joint Investigation Team (JIT) formed to probe arms smuggling to Katcha area (riverine area) dacoits, revealed the involvement of the son of a Sindh cabinet member, media reported. According to a JIT report available with media, Altaf Bhayo, the son of Sindh CM adviser on Forest and Wildlife Babal Khan Bhayo, was in contact with the suspects arrested while transporting the weapons to Katcha area dacoits. The JIT's report revealed that Altaf Bhayo provided the mobile van of his father's security protocol to the suspects. "The police mobile van was provided to the smugglers on their wish," the JIT report added. The JIT also revealed that Mehboob Bhayo, another relative of Babal Khan Bhayo, provided Rs 400,000 to the suspects to purchase the weapons. The JIT report said that one Ishiaq Lashari is the key member of the gang involved in smuggling weapons to the Katcha area dacoits. Sindh police foiled an attempt to smuggle arms to Katcha area dacoits and arrested seven individuals including three policemen allegedly involved in the offense in Shikarpur on April 19. Sindh Inspector General of Police (IGP) Ghulam Nabi Memon formed a JIT headed by Deputy Inspector General (DIG) Larkana and tasked it to conduct a thorough investigation into the matter. The police spokesperson said that thousands of bullets and two Kalashnikovs were recovered from the possession of the arrested individuals during the operation. The spokesperson asserted that the consignment of arms was being smuggled from Balochistan to Shikarpur in the police mobile which was assigned to the security of the CM Adviser. —RT

Fake Law Enforcement Officer Arrested In Karachi



KARACHI: In a significant operation, Liaquatabad police have arrested a man posing as an officer of a federal law enforcement institution in Karachi, media reported on Friday. The match in Dallas was a spectacle of missed opportunities and poor performance. Pakistan's top order crumbled early, with the team reduced to 26-3 inside five overs, thanks to a disciplined bowling attack led by the USA's Nosthush Kenjige and Saurabh Netravalkar. Despite a brief recovery by Babar Azam and Shadab Khan, who put on a 72-run partnership, the Green Shirts never managed to dominate the game.

The USA, having set a modest target of 159-7, leveled the score to push the game into a super over, a scenario in which Pakistan's weaknesses were



brutally exposed. Naseem Shah's early breakthrough proved futile as the US batsmen, particularly Andries Gous and Monank Patel, comfortably kept the scoreboard ticking, showcasing a calm and calculated approach that was glaringly absent in the Pakistani camp.

In the super over, the USA set a challenging 19-run target, which Pakistan failed to chase, manag-

ing only 13 runs. This defeat is not just a statistical embarrassment but a testament to the deep-rooted issues plaguing Pakistani cricket. Favoritism and poor selection policies continue to overshadow merit and performance, leading to such humiliating defeats.

The Pakistani cricket management must introspect and address these systemic flaws. The team's loss to the USA, a nation with significantly less cricketing history and infrastructure, underscores the urgent need for reform. Embracing meritocracy over favoritism could prevent such historic lows and restore pride in Pakistani cricket. Until then, the nation can only hope for a day when talent and performance dictate team selection, not favoritism and politics.

Pakistan now play arch-rivals India next on June 9 in New York, should they suffer another defeat, their chances of qualifying for the World Cup Super 8 would be little to one. It was also highlighted that in the state, journalists are working under risk, and those who work for human rights are targeted, with notable examples like Nasrullah Gadani, Jan Muhammad Mahar, and many others who have been killed since 2002, with 23 being killed so far, and their families have not received justice. If journalists are not safe in Sindh, how can an ordinary person be safe? The Sindh Commission for Journalists' Protection, established for their protection, is inactive. The Sindh Human Rights Defenders Network's Director Advocate Ali Palh that Karachi witnessed 71 citizens being killed last year due to mugging resistance. On the other hand, in North Sindh, dacoits are making life difficult for citizens. The situation in Sindh is such that journalists are working under threats, and those who work for human rights are targeted.



Journalists have been killed, and the conditions of human rights in the province are alarming. He emphasized the need for protecting the rights of women, addressing unjust court decisions, and ensuring the protection of journalists and lawyers. The role of Karachi Bar Association was appreciated for organizing the program, aiming to unite defenders, lawyers, and media for human protection. Hyderabad Police Seize Journalists' Mobile Phones And Cameras During Operation

TANDO JAM: In a crackdown on illicit activities, a joint operation led by SSP Headquarter Hyderabad, Shahwanaz Chachar, and CIA In-charge Aslam Langah resulted in the confiscation of 2000 liters of illegal liquor in Sobho Maggi village. However, the operation took a contentious turn as clashes erupted between police personnel and journalists covering the event, leading to the confiscation of their mobile phones and reports of violence. Reports emerged detailing a raid near Sobho Maggi village, close to Tando Jam city, spearheaded by SSP Headquarter Hyderabad Shahwanaz Chachar and CI In-charge Aslam Langah, accompanied by officers from various police stations in the district. The operation culminated in the demolition of a property suspected of harboring illicit substances. Speaking to the media, SSP Shahwanaz Chachar affirmed the seizure of 2000 liters of illicit liquor,

underlining the administration's zero-tolerance stance towards such activities within Tando Jam and the wider district. He vowed to eradicate the scourge of illicit substances with unwavering determination and integrity. However, the operation was marred by confrontations between police personnel and journalists covering the event. Several journalists reported having their mobile phones confiscated, and some were allegedly subjected to violence. In response to these allegations, the Tando Jam Media Center raised concerns and sought answers from SSP Headquarter Shahwanaz Chachar. The SSP assured that an inquiry would be conducted into the reported mistreatment of journalists, pledging that justice would be served swiftly and impartially. The incident underscores the delicate balance between law enforcement activities and the protection of press freedoms, prompting calls for accountability and respect for journalistic rights in such operations.

DC Thatta Munawar Abbas Soomro Pledges Strict Action Against Illegal Practices

THATTA: Under the guidance of Deputy Commissioner Munawar Abbas Soomro, Inspector Incharge IBD Ghulam Muhammad Soomro, along with officials from the Revenue Department, Market Committee, and Bureau of Supply and Prices, conducted surprise raids targeting illegal stockpiling and unlicensed manufacturing activities in Thatta. During a raid on Hemant Das' warehouse on Hyderabad Road, Thatta, officials discovered a significant

amount of goods including 3,000 bags of urea, 5,000 bags of DAP (Diammonium Phosphate), 2,000 bags of Zabarad urea, 500 bags of wheat, and 100 bags of pulses. Authorities warned against illegal hoarding of urea and directed that the excess stock be transferred to their shop on Sujawal Road, Thatta. In another operation, a factory producing chemically contaminated milk was found behind the maternity hospital in Thatta. Here, 3,000 liters of milk were confiscated. The factory owner, Altaf Hussain, son of Musa Bajoro, was given a strict ultimatum to register his facility with the Bureau of Supplies and Market Committee within a week or face legal consequences. Furthermore, a raid near Ghora Barr Stop uncovered a warehouse containing 3,000 liters of counterfeit NCP cooking oil. The premises were promptly sealed to prevent further distribution of the illicit product. These measures demonstrate the authorities' dedication to combating illegal activities and ensuring the safety and welfare of the community.

Keti Bandar Mother Fatally Stabs Six-Month-Old Daughter

KETI BANDAR: A harrowing incident has shaken the community near the Baghan police station limits of Keti Bandar, where a mother tragically took the life of her six-month-old daughter. Zahida, the wife of Ilyas Dal, wielded a knife to perpetrate the heinous act, fatally stabbing her infant daughter, Rehana, near Saddar Bridge in the Baghan area. The horrifying crime was unveiled when authorities at Keti Bandar police

station received distressing information regarding the incident. Swiftly responding to the call, SHO Keti Bandar, Sain Dino Buriro, arrived at the scene. He took custody of the infant's body and arranged for its transfer to a postmortem examination. Both Zahida Mallah and her husband, Ilyas Dal, were apprehended by law enforcement officials in connection with the grievous crime. Upon interrogation, Zahida reportedly confessed to the murder,

shedding light on the somber circumstances surrounding the tragic event. SHO Keti Bandar revealed that investigations are currently underway to unravel the motive behind this heartbreaking act and delve deeper into the circumstances leading to the untimely demise of the innocent child. The community of Keti Bandar is reeling from shock and grief over the loss of a young life, as authorities strive to navigate through the complexities of this distressing case.

Domestic Issues Behind Increased Suicides In Talhar

TALHAR: The village of Bachal Laghari near Talhar witnessed a heart-wrenching incident as 24-year-old Rehana, wife of Mohabatt Laghari and mother of two, took her own life by hanging herself inside her home, succumbing to the weight of domestic turmoil. Meanwhile, in another grievous event unfolding in the village of Muhammad Juman Barani, 19-year-old Meena, wife of Raich Kohli, also tragically ended her life by hanging herself at her residence. Authorities responded

swiftly, with police officers conducting necessary legal formalities before handing over the bodies to the respective families. The sorrowful incidents underscore the grim reality of domestic issues plaguing communities, often resulting in irreversible consequences. These tragedies serve as poignant reminders of the profound impact of economic hardships on mental health and familial stability. Sindh Govt Stands Firm: Karachi's Town Jurisdictions Remain Intact, Declares Saeed Ghani

The meeting decided that the Local Government Commission would not resolve this issue until the court issued a judgment, and the two towns reached a consensus. The jurisdiction issue was deferred to

the next meeting of the Local Government Commission. Attendees included Additional Chief Secretary of the Local Government Department Syed Khalid Hyder Shah, ECP representative Khuda Bakhsh, Local Government Commission members Abdul Rahim, Ali Ahmed Baloch, Wasim Usmani, and the commission's DG, Abu Bakar.—RT

-Can you believe this? Female Examiner Confesses To Leaking Paper During Inter Exams



KARACHI: As the annual Intermediate examinations continue in Sindh, including Karachi, reports of paper leaks before exams have unfortunately become commonplace. Recently, a female examiner in Karachi confessed to leaking the second year's Zoology paper. The examiner, from Government Degree Girls Arts and Commerce College, admitted her involvement and issued an apology to the Chairman of the Board of Intermediate Examination, Karachi (BIEK).

In her apology, the teacher clarified that the college staff was not involved in the Zoology paper leak, taking full responsibility for her actions. She expressed remorse and pledged to avoid such mistakes in the future.

The BIEK chairman assured that appropriate action would be taken against the female examiner in accordance with the rules and regulations. Earlier, the BIEK's Controller of Exams, Zarina Rashid, expressed disappointment over the paper leak incidents, emphasizing the board's efforts to prevent cheating during exams. She mentioned the implementation of watermarks on question papers to trace the source of leaks, aiming to address the recurring issue of cheating and paper leaks.—RT/Agency

STDC To Strike Deal With Private Companies For 600MW: Nasir Shah

KARACHI: Sindh Provincial Energy Minister Syed Nasir Hussain Shah chaired a board meeting of the Sindh Transmission and Dispatch Company (STDC) today in the committee room of the Energy Department. The meeting confirmed the decisions of the previous session and made several new important decisions.



The board decided that Go Energy Pvt Ltd, which aims to install a 500 MW floating solar power project on Kenjhar Lake, will connect with K-Electric via the Dhabiji grid station through STDC's transmission line. The meeting also approved the signing of a Memorandum of Understanding (MoU) for this project.

Additionally, the board was informed that Gul Ahmed Group Power Company Private Limited and Gul Ahmed Renewable Energy Private Limited intend to generate 50 MW each and supply this electricity to Gul Ahmed Textile Mills through STDC's transmission lines. Minister Nasir Shah, serving as Chairman, approved the MoU between STDC and the Gul Ahmed Group. The performance of STDC was thoroughly reviewed during the meeting. Nasir Shah emphasized the need to enhance the company's performance and noted that the Sindh Government has established the Sindh Electric Power Regulatory Authority (SEPRa) to provide affordable electricity, compared to the National Electric Power Regulatory Authority (NEPRA). He stressed that all initiatives should be pursued through SEPRa whenever possible. Minister Shah also stated that officers and employees demonstrating good performance would be rewarded as hardworking and capable staff are valuable assets to any organization. The meeting was attended by key officials and board members of the Sindh Electric Power Regulatory Authority (SEPRa) to STDC.—RT

Sharjeel Slams MQM-P For 'Politicizing' Law And Order In Karachi

KARACHI: Sindh Minister for Transport and Mass Transit, Sharjeel Inam Memon, criticized the Muttahida Qaumi Movement-Pakistan (MQM-P) for politicizing the law and order situation in the province, particularly in Karachi.



Speaking to media outside the Sindh Assembly, Minister Memon accused MQM-P of attempting to politicize the Hyderabad cylinder blast incident, stating, "Gone are the days when the city used to be shut down on a call from London."

FPCCI Demands Abolition Of Section 7E Of Income Tax Ordinance

KARACHI: Mr. Atif Ikram Sheikh, President of the Federation of Pakistan Chambers of Commerce & Industry (FPCCI), has urged the government to abolish Section 7E of the Income Tax Ordinance (ITO) 2001, calling it unproductive and unfair for levying deemed or imaginary income on immovable properties. He noted that Section 7E has not significantly increased tax collection and has instead caused chaos in the real estate sector.



Mr. Sheikh also advocated for the establishment of a Real Estate Regulatory Authority (RERA) in Pakistan, similar to other regional countries, to ensure the sector operates optimally and contributes to the national economy. He emphasized that this should be done in consultation with stakeholders.

PKR 225 billion annually. He argued that a significant portion of this should be spent on infrastructural development in Karachi to improve the real estate market.

Mr. Saquib Fayyaz Magoom, SVP FPCCI, pointed out that the real estate sector can attract more foreign exchange through remittances from overseas Pakistanis. He stressed the need to facilitate investment from overseas Pakistanis to stabilize the rupee-dollar parity and bolster foreign exchange reserves. Syed Saquib Shah, Convener of FPCCI's Central Standing Committee on Real Estate Property and Builders, called for the digitalization of the property registration system to enhance transparency and fairness. He also suggested implementing an e-stamp system in Karachi similar to Punjab's. Shah emphasized that taxes should be imposed on property owners, not real estate agents, to prevent disenchantment and stagnation in the industry.—RT

NEPRA Announces Another Shocking Electricity Rate Hike For Karachi

KARACHI: The National Electric Power Regulatory Authority (NEPRA) has announced a significant increase in electricity rates for Karachi, raising the tariff by Rs1.1 per unit. The hike is part of the monthly fuel cost adjustment (FCA).

According to the notification, consumers will face an additional charge of Rs2.68 per unit in June, increasing to Rs3.11 per unit in July. This extra cost will continue to rise, reaching an additional Rs3.22 per unit in August before seeing a smaller increase of Rs1 per unit in September.

NEPRA clarified that these increments will not affect K-Electric, lifeline consumers, or electric vehicle charging stations. Yesterday, NEPRA increased the power tariff by Rs3.33 per kilowatt-hour (kWh) on account of fuel cost adjustment (FCA) charges for April 2024. This adjustment will be reflected in the current month's bills for consumers of power distribution companies (Discos). The adjustment shall be applicable to all consumer categories except Electric Vehicle Charging Stations (EVCS), lifeline consumers, and consumers of K-Electric. Discos are directed to ensure compliance with any court orders regarding the FCA charges. Non-compliance with court orders will hold the concerned Discos responsible for violating or defying the orders of the honorable court(s), according to NEPRA's decision on the FCA of April 2024.—RT/Agency

Business Delegation Returns Triumphant From Morocco And Biryani Festival



KARACHI: A delegation of businessmen, led by Ishfaq Baig, Chairman of the Pak-Morocco Business Council and Honorary Consul General of Morocco, has returned after a fruitful visit to Morocco. The delegation, consisting of 25 prominent businessmen from various sectors, also included Miza Ikhtiar Baig, a member of parliament and former Senior Vice President.

During the visit, the delegation held meetings at the Casablanca Chamber of Commerce & Industry with President Mr. Hassan Berkani and his team, as well as at the Rabat Chamber of Commerce with the President and his team. Business-to-business (B2B) meetings were conducted between the businessmen at various chambers.

As per the initial reports, the incident occurred after a dispute between the boy and the private security guard, identified as Ramzan, in the North Karachi area.

During the heated argument, the guard fired a shot, hitting the child in the stomach, and fled from the scene along with the weapon.

The police officials confirmed that the child who

was injured by a guard's gunfire has succumbed to his injuries during treatment. The unfortunate event took place within the jurisdiction of the Sir Syed police station.—RT/Agency

Thieves Target Advocate Musa Kolachi And His Family In Malir Home Invasion

IHC Directs Investigation Officer To Record Poet Ahmed Farhad's Statement Before Magistrate

ISLAMABAD: Justice Mohsin Akhtar Kayani of the Islamabad High Court (IHC) Friday ordered the investigating officer of Loh Bhir police station to record the Kashmiri poet Ahmed Farhad's statement under Section 164 of the Code of Criminal Procedure (CrPC) before a judicial magistrate.



Following the order, the judge disposed of the petition seeking the poet's recovery after his whereabouts were ascertained following the confirmation of his custody with the police in Azad Jammu and Kashmir.

Justice Kayani, who was hearing the plea filed by the poet's wife Urooj Zainab, told the petitioner to refer to the court again if they feel the need.

"I know how to get my orders implemented," the judge said. Zainab had moved the IHC seeking her husband's recovery along with requesting the court to identify, investigate, and prosecute those responsible for his disappearance.

The poet remained missing for 15 days before Attorney General for Pakistan,

Mansoor Usman Awan, on May 29, in response to IHC's directions to ensure his recovery, said Farhad was arrested and in AJK police's custody.

The poet was arrested and transferred to Muzaffarabad from Dhirkot under multiple sections of the Anti-Terrorism Act (ATA). Known for his defiant prose, the poet's matter came into the spotlight after he allegedly went missing during protests in AJK in May.

Human rights lawyer Iman Mazari appeared before the court as the petitioner's counsel, while journalist Hamid Mir appeared as a judicial assistant.

Additional Attorney General

other was said to have been filed.

"I think his problems are increasing. It is now believed that he is in judicial custody," said the judge. He added that if the police detains someone during the trial and does not present them for two days, then the trial is concluded.

Justice Kayani questioned about the poet's whereabouts before his arrest, stating that the issue pertains to enforced disappearance.

"If the abductee is recovered, the plea of habeas corpus is dismissed. They say that instructions to identify the kidnappers should also be issued," the additional attorney general told to the court, adding that this matter will be revealed during investigation.

The AAG said that the poet is now in judicial custody and a statement under Section 161 has been recorded. Justice Kayani asked the AAG to show if the investigating officer went to Kashmir and recorded Farhad's statement.

"It is written that I am mentally and physically unable to give a statement. It is also written that he will appear in the court himself or give a statement through a lawyer," remarked Justice Kayani.

The judge also said he is writing about the matter to the chief justice, requesting him to form a larger bench on all missing persons cases. The judge added that he is sending the matter to the larger bench, so that if the position of one judge is different, others can also see it.

"The rest of the members may not agree on summoning the heads of the intelligence agencies," said the judge.

He also remarked about sending the matter to the committee on how law in Islamabad should be enforced. "Respect the law, no one is above the law including judges," the IHC judge said that the court is always standing for the protection of the poet's rights. "The investigation will proceed as a result of Ahmad Farhad's statement before the magistrate."

He remarked that institutions should work within their limits. The court will ban in-camera proceedings and reporting on matters of national security. Justice Kayani said.—RT/Agency

Pakistan and China Ink 23 MOUs To Bolster Bilateral Relations In Diverse Sectors

BEIJING: Pakistan and China have inked 23 Memorandums of Understanding (MoUs) aimed at enhancing collaboration across various sectors.



The MoUs signed Friday in Islamabad included transportation infrastructure, industry, energy, agriculture, media, healthcare, water management, socioeconomic development, and other mutual areas of interest.

Following delegation-level discussions between Prime Minister Shehbaz Sharif and Chinese Premier Li Qiang in Beijing, Foreign Office spokesperson Mumtaz Zahra Baloch briefed the media, emphasising the robust Pakistan-China Strategic Cooperative Partnership founded on mutual trust, shared principles, and strategic governance.

Both nations reiterated staunch support for each other's key concerns and reaffirmed their dedication to advancing the China-Pakistan Economic Corridor (CPEC) and completing ongoing projects in a timely

manner. Prime Minister Shehbaz Sharif reassured commitment to ensuring the safety and security of Chinese personnel and projects within Pakistan while safeguarding the CPEC from detractors and adversaries.

Additionally, they agreed to sustain high-level engagements, bolster institutional connections across all sectors, and continue consultations on bilateral and global issues, especially during Pakistan's upcoming non-permanent membership on the UN Security Council for the term 2025-2026.

During his visit, Prime Minister Sharif engaged with Chinese investors and entrepreneurs, promoting investment opportunities in Pakistan and facilitating the signing of numerous MoUs in sectors such as economy, green energy, textiles, and manufacturing.

Foreign Office Stresses Visa Regulations For Movement Across Pak-Afghan Border

ISLAMABAD: The Foreign Office on Friday stated that movement across the Pakistan-Afghanistan border should be regulated by visas.

During a media briefing in Islamabad, Foreign Office Spokesperson Mumtaz Zahra Baloch said that individuals wishing to enter Pakistan from Afghanistan must possess a visa and an Afghan passport. She emphasised that border movement between Pakistan and Afghanistan should be conducted under visa regulations.



The spokesperson further mentioned that Pakistan was elected as a non-permanent member of the United Nations Security Council yesterday. She affirmed that Pakistan's laws guarantee human rights and reiterated that Pakistan takes the implementation of its Constitution seriously in response to other governments' reactions.

The foreign office also reiterated its call for India to be held accountable for ongoing human rights abuses in Indian Illegally Occupied Jammu and Kashmir (IIOJK), where over 7,000 Kashmiris have died in the custody of Indian forces over the past three decades.

Baloch further highlighted the reported death of a Kashmiri civilian at a police station in Pulwama district of IIOJK.

She emphasised that Pakistan, as a member of the United Nations Security Council, would advocate for the peaceful resolution of disputes, oppose unilateral

force, combat terrorism in all its forms, support UN peacekeeping efforts, and promote democracy, transparency, and accountability.

Additionally, Baloch noted that Prime Minister Shehbaz Sharif is on an official visit to China. Following discussions at the delegation level, 23 memorandums of understanding were signed. Security for Chinese citizens in Pakistan was also discussed during the meetings. The premier participated in a business conference in Shenzhen as well.

Furthermore, the FO spokesperson condemned the bombing by Israeli forces of a UN-run school sheltering Palestinian refugees, which resulted in multiple deaths, primarily of women and children.

"This attack is another crime in a series of assaults against civilians, including an IDP camp attack last week that killed 45 Palestinians. The deliberate targeting of civilian populations and facilities is a grave violation of international law and constitutes war crimes," she stated.

FO statements on cross-border travel come in light of the rising insurgent attacks on Pakistan's northern territories that have been found to have roots to Afghan soil.

Previously, at least five Chinese engineers and their Pakistani drivers were killed in a suicide attack on the Karakoram Highway on March 26.

Speaking at a press conference in Lahore along with the National Counter Terrorism Authority (NACTA) coordinator, Interior Minister Mohsen Naqvi said evidence of Afghan linkage to the Besham attack had already been shared with the Afghan government. "Unfortunately, there is no positive response yet from the Afghan government," the interior minister said. Pakistan not only demanded the arrest of three TTP terrorists responsible for the Besham attack but also wanted TTP chief Noor Wali Mehsud and the entire leadership detained.—RT/Agency

Judicial Commission Recommends Three Judges For Elevation To Supreme Court



ISLAMABAD: The Judicial Commission of Pakistan (JCP) Friday sent the names of three high court judges to be considered for elevation to the Supreme Court for final approval by the Parliamentary Committee, sources told media.

The names, recommended for appointment to vacant SC seats, were recommended during a meeting of the Judicial Commission held under chairmanship of Chief Justice Qazi Faez Isa, said the sources.

During the meeting, the names of Lahore High Court Chief Justice Malik Shahzad Ahmad, Sindh High Court Chief Justice Aqeel Abbasi, and LHC Justice Shahid Bilal have been proposed, the sources said.

JCP Isa had, last month, convened the JCP meeting for deliberations over the appointment of three judges in the SC.

The JCP was constituted under the 18th Constitutional Amendment mandated to appoint judges in the superior

Imran Chooses To Adopt A Flexible Approach To Reduce Political Tensions

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan has decided to "step back" from his rigid stance, ordering his party leaders to establish contacts both inside and outside the Parliament to ease the ongoing political tension, sources told media.



According to the sources, the party's leadership would hold talks with various political parties outside the Parliament, while its lawmakers would also enhance its relations with parties in the ruling coalition government.

The PTI founder's decision came after his interaction with Chief Justice of Pakistan, Qazi Faez Isa, when he appeared for a hearing before the Supreme Court a day earlier.

During the hearing pertaining to the National Accountability Bureau (NAB) law amendments, CJF Isa suggested that Khan go to the Parliament to help resolve Pakistan's problems "as the country needs to move forward."

The incarcerated PTI founder — during his appearance before the SC bench via video link from Adiala jail, where he remains behind bars since August 2023 — complained about facing political "victimisation" since his ouster from power in April 2022.

The former prime minister has given his party's

three-member committee the authority to establish contact with the establishment, said the sources.

On the other hand, Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur is also engaged in back-door communications, they added. The sources revealed that it has been decided that PTI would support the state for political and economic stability to de-escalate tension.

"The party will move forward by holding negotiations on multiple matters including on committees of the Senate and National Assembly," the sources said. Former president and PTI leader Dr Arif Alvi, on June 5, claimed that the incarcerated party founder was being told to "strike a deal and leave the country."

Alvi had said that Khan rejected the offer and decided not to leave the country "at any cost." The former president had predicted that those who were colluding to sentence

Khan — the former prime minister — would face a complete failure.

Commenting on dialogue offers, the politico had said that his party was ready to hold talks with "stakeholders but not with the non-stakeholders". He had asked the stakeholders to let go of hatred and practice compassion.

Alvi had further said that his party could not hold the incumbent rulers who were as much "powerless" as they came into power via "Form 47" and didn't have "authority" to make decisions.

On June 5, he had said that his party would hold dialogue with the one who has real power to make decisions.—RT/Agency

Zardari Establishes National Economic Council, Appoints Shehbaz As Chairman

ISLAMABAD: President Asif Ali Zardari has constituted the National Economic Council under the chairmanship of Prime Minister Shehbaz Sharif, a notification issued by the Cabinet Division said on Friday.

"In exercise of the powers conferred by clause (1) of Article 156 of the Constitution of Pakistan, the president of the Islamic Republic of Pakistan is pleased to constitute the National Economic Council [...]" the notification read.

As per the document, the chief ministers of all four provinces, Punjab, Sindh, Khyber Pakhtunkhwa, and Balochistan will be part of the newly formed body.

Moreover, Deputy Prime Minister and Foreign Minister Ishaq Dar, federal ministers Khawaja Asif, Muhammad Aurangzeb and Ahsan



Iqbal are also members of the NEC.

The notification stated that Planning Commission's deputy chairman, finance secretary, secretary on economic affairs and federal minister Ahmad Cheema could also attend the meetings of the council on special invitation.

PM Shehbaz given guard of honour at Great Hall of the People



BEIJING: Prime Minister Shehbaz Sharif on Friday was given a guard of honour at the Great Hall of the People where he arrived to meet the top Chinese leadership.

As the prime minister arrived at the formal reception ceremony, Chinese Premier Li Qiang warmly received him which followed the introduction of their respective delegations to each other.

The national anthems of Pakistan and China were played as the prime minister stood at the salute dias along with his Chinese counterpart.

The smartly turned-out contingents of the People's Liberation Army presented the guard of honour to the prime minister which he reviewed before proceeding to the bilateral meeting.—RT/Agency

PTI Alleges Deliberate Delays In Imran And Bushra Bibi's Iddat Case

ISLAMABAD: The Pakistan Tehreek-e-Insaf (PTI) has alleged a "deliberate delay in the provision of justice" to the incarcerated party founder Imran Khan and his wife Bushra Bibi as the iddat case was transferred to another court on a district and sessions judge's request.



The statement was issued by the Imran-founded party's core committee after holding a session on Friday in which they reviewed the status of ongoing trials against the former prime minister and the ex-first lady, as well as other developments in the country.

In a statement, the core committee stated that Khan and Bushra Bibi deserved to be immediately released from jail. It alleged that the pace of trials against the duo was being "deliberately delayed" via deferring the hearings with delayed dates.

The former ruling party expressed hopes that the "false, baseless and unfounded cases" would meet their fate very soon. Commenting on the iddat

case, the PTI termed the Islamabad High Court's (IHC) decision to transfer the trial to another court "illegal".

It is noteworthy to mention here that the IHC had accepted the district and sessions judge Shahrukh Arjumand's request for transferring the iddat case related to the marriage of Khan and Bushra.

The case was transferred to the court of additional district and sessions judge Muhammad Azeem Mujahid who will conduct the hearings of the case.

Subsequently, the former ruling party also expressed concerns over Bushra Bibi's

health. Despite serious reservations, Bushra's medical tests were carried out at the Pakistan Institute of Medical Sciences (PIMS), whereas, her medical reports were not being provided for unknown reasons, the statement read.

Additionally, the PTI core committee also raised concerns over the appointments of retired judges in the election tribunals by the Election Commission of Pakistan (ECP). It added that the party would raise a strong voice against the Chief Election Commissioner (CEC) and the ECP members in and outside parliament.—RT/Agency
