## Gandapur Pledges To Enforce Constitution With Stringent Measures

PESHAWAR: Toning up his rhetoric against the Centre, Khyber Pakhtunkhwa's firebrand Chief Minister (CM) Ali Amin Gandapur pledged on Saturday to "hang" those who have violated the country's Constitution. "I swear to God, you will not be able to live in Pakistan, let alone Islamabad," he said while addressing a public gathering in Swat. "The constitution of Pakistan was violated. Those who break the constitution will be hanged," the Pakistan Tehreek-e-Insaf (PTI)-backed chief minister roared. He asked those, who lodged "fake cases" against jailed PTI founder Imran Khan, to identify themselves. Naming Punjab CM Maryam Nawaz, Prime Minister Shehbaz Sharif and President Asif Zardari, the KP CM asked the crowd to name those responsible for the alleged victimisation of the embattled party. "We will have to hold



them accountable for each day. We are silent just because of the PTI founder," he added. He alleged that Pakistan was dismantled to "give power" to late prime minister Zulfikar Ali Bhutto. "Today, plots are being hatched again to break Pakistan." Addressing the rally, PTI Chairman Barrister Gohar Ali Khan concurred with Gandapur, saying the country couldn't be governed without the Constitution and law. ## CJP Isa Proposes Providing Bicycles To Judges At Climate Conference

ISLAMABAD: Addressing a climate change conference hosted by the Supreme Court, Chief Justice of Pakistan (CJP) Qazi Faez Isa called for adopting eco-friendly measures and a healthy lifestyle to cope with the prevailing climate-related challenges. The top court organised the conference titled "Navigating Climate Governance: Executive Action and Judicial Oversight" on Saturday which was addressed by honourable top jurists, environmental experts, government high-ups and other notable speakers. "Whenever we consult doctors, they advise us to leave smoking and do walk. A rise in the human body's temperature indicates our illness but today, earth is also facing ailment like a fever as it is absorbing a lot of smoke into it," said the top judge. CJP Isa pointed out that plastic products were being manufactured across the world but we lacked a solid mechanism to dispose of them. He also urged returning to a healthy lifestyle which is closer to nature. "Every physician is now advising to eat vegetables instead of



meat." "Justice] Mansoor Ali Shah talked about hybrid vehicles here but we need to walk. Bicycles can be provided to all judges if they want," suggested CJP Isa. He added that human beings were facing severe consequences for neglecting the common practices today like conserving electricity and food which led to a shortage of natural re-

sources. "We failed to know nature and we need to rebuild the values for environmental protection from our homes. The natural environment can be saved from further destruction by avoiding wastage of resources," said CJP Isa. Pakistan has been facing severe impacts of climate change like devastating floods, flash droughts, scarcity of water resources and excessive heat despite the country's total contribution to the global emissions being less than 1%. ## Dar Urges Ceasefire In Gaza, Condemns Israeli Actions Against Palestinians

ISTANBUL: Foreign Minister Ishaq Dar on Saturday described the situation in Gaza as worrying and said Palestinian civilians in the enclave were facing barbarism. In his address to an extraordinary meeting of D-8 foreign ministers, he said even aid workers were being targeted in Gaza, adding that the whole state of affairs was a tragedy. Demanding an immediate ceasefire, Dar, who is also the country's deputy prime minister, noted that over 40,000 had so far been martyred since October — when Israel started using brute force against more than two million civilians living in the narrow Gaza Strip which is located along the Mediterranean Sea. Bordered by Egypt in the east and north, Egypt is located in its south. That's why it is often described as the world largest open air prison.

## Controversial Defamation Bill Signed Into Law By Acting Punjab Governor

LAHORE: The controversial Punjab Defamation Bill, 2024, has become law after acting Governor Punjab Malik Muhammad Ahmad Khan signed it, media reported citing sources on Saturday. The bill that garnered immense criticism, particularly from journalists and digital rights activists, received the final nod from Malik Muhammad Ahmad Khan, who currently holds the position of acting governor in the absence of Punjab Governor Sardar Salim Khan, as per the sources. The sources added that Governor Sardar Salim has gone on leave. The Punjab Assembly, on May 20, passed the Punjab Defamation Bill, 2024 amid a strong and noisy protest by the opposition as well as immense backlash from journalists and rights bodies including those based internationally. Reacting to the development, Lahore Press Club President Arshad Ansari slammed the Pakistan Peoples Party's (PPP) deceptive attitude, saying that the party deceived journalists. "The bill was signed by the acting governor by send-



ing the Punjab governor on leave under a plan," said Ansari. The senior journalist added that the PPP was apparently with the journalists and was conniving with the provincial government from within. "A meeting of the action committee will be called soon and future strategy will be announced," said the journalist. Meanwhile, soon after its approval today, the law was challenged in the Lahore High Court. The petitions challenging the law have been filed by journalist Jaffar Ahmad Yar and a citizen Raja Riaz. In the pleas filed by the two individuals, Chief Minister Maryam Nawaz, the governor, and the provincial government have been nomi-

## Bushra Bibi Appeals To IHC To Suspend Sentence In Iddat Case

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan's wife Bushra Bibi Saturday moved the Islamabad High Court (IHC) seeking suspension of her sentence in the iddat case also known as the "un-Islamic nikah" case. Bushra filed the petition through her lawyer Barrister Salman Safdar which claims that the hearing of her appeal against the conviction remains pending. Lamenting the former first lady's "prolonged incarceration", the petition underscored her right to the suspension of sentence. "It is imperative to decide the suspension of sentence of the petitioner [Bushra] as early as possible in the interest of justice," the plea reads. Khan and Bushra were each sentenced to seven years in prison in February earlier this year after a trial court found their nikah to be fraudulent after Khawar Maneka, Bushra's ex-husband, had moved the court against their nikah, stressing that it was solemnised during her iddat period. In its 51-page detailed verdict, the court maintained that their marriage reflected dishonesty and also imposed a fine of Rs500,000 each — for which the failure to pay



provisions additional four months of incarceration. The couple had then filed appeals against their conviction in a district and sessions court — a case which has been transferred to additional District and Sessions Judge Muhammad Afzal Majuka after Maneka expressed no confidence in Judge Shahrukh Arjumand. The development irked the former ruling party which has alleged a "deliberate delay in the provision of justice". In a statement, the party's core committee stated that Khan and Bushra Bibi deserved to be immediately released from jail. It alleged that the pace of trials against the duo was being "deliberately delayed" via deferring the hearings with delayed dates — an argument also cited in the former first lady's petition in the IHC.

## Pakistan Plans To Boost Participation In UN Peacekeeping Missions

NEW YORK: Interior Minister Mohsin Naqvi called on United Nations Secretary General Antonio Guterres at the UN headquarters in New York and discussed matters related to the engagement of Pakistan police personnel with the UN peacekeeping operations. The UN Secretary General expressed his best wishes to the people and the government of Pakistan on the occasion. It was agreed to increase the number of Pakistani personnel in the UN peacekeeping missions. Due to the personal efforts of the interior min-



ister, the stalled process of deployment of Pakistani police officers in UN peace missions will be revived after many years. As many as 128 Pakistani police officers will soon be able to go to the UN and get deployment. The UN Secretary General and the interior minister also discussed the establishment of a unit of the United Nations Counter-Terrorism Force. Referring to the sacrifices rendered by Pakistan in the war on terrorism, Mohsin Naqvi offered Pakistan's support for the unit.—RT/Agency

## PTI And JUI-F Move Closer To Forming Opposition Alliance

ISLAMABAD: PTI founding chairman Imran Khan and JUI chief Maulana Fazlur Rahman, once political rivals are now coming together for a joint effort against the incumbent PML-N led government. A committee has been formed to address common issues and have begun to mend their past differences. Imran assured Maulana to address his concerns, and this message has been conveyed to the JUI chief. The former premier has proposed the formation of a three-member committee, chaired by senior PTI leader Asad Qaiser, to resolve the issues between the two parties. This committee will determine the agreed strategy for their collaboration. It's reported that before finalizing any plans in this regard, both parties will agree on other points, including any possible protest movement. Once settled, Imran and Maulana will sign off on the agreement,



signaling their united front against the government. On April 2, in a bid to give tough time to the government, the PTI formed a "grand opposition alliance", which reportedly, will be led by Pashtoonkhwa Milli Awami Party (PKMAP) chief Mahmood Khan Achakzai. A meeting of five opposition parties was held in this regard. PTI Chairman Gohar Khan, Jamaat-e-Islami acting amir Liaquat Baloch, Balochistan National Party-Mengal (BNP-M) President Akhtar Mengal, Opposition Leader in the National Assembly Omar Ayub, Majlis Wahdat-e-Muslimeen (MWM) chief Allama Nasir Abbas, PTI leader Asad Qaiser and Achakzai attended the huddle. Fazl had already issued a call for opposition against the government. It was reported that after the JUI-F joins the grand opposition alliance, the PTI along with the party would announce protest demonstrations under the leadership of Achakzai, and will move forward in unison.—RT/Agency

## Father and Son Demand Justice in Ghanghro

KANDIARO Residents of Andal Ghanghro village near Kandiaro, including Badal Ghanghro and his son Wajid Ghanghro, protested at the Kandiaro Press Club against the injustices inflicted by influential community members. ## Growers in Sehwan Rally Against Water Shortage

SEHWAN SHARIF: Farmers from various regions of the Sehwan Taluka continued their protest against the closure of the Shahbaz Pumping Scheme. They held a symbolic hunger strike in front of the Sehwan Press Club, chanting slogans against irrigation officials. One farmer fainted due to the heat. According to the details, the farmers from five Union Councils (UCs) of Sehwan Taluka, including Bobak, Arazi, Jaffarabad, Channa and UC Dal, are deprived of agricultural water. The protest, led by landowners Daim Talpur, Roshan Ali Burdi, Qurban Ali Talpur, Li-aqat Ali Talpur, Gul Hassan Rind and Abdul Khaliq Sarki, criticized the inefficiency of the irrigation department. The affected farmers stated that the Shahbaz Pumping Scheme was restored with 15 motors through efforts by the Chief Minister of Sindh, but only 3 motors were operational for two days before the scheme was shut down due to burnt transformers and motors. Despite collecting and paying PKR 50,000 as demanded by the officials, the money was misappropriated, preventing them from planting crops. Consequently, their agricultural lands remain barren, and their children and livestock suffer from thirst. The farmers, loyal voters from the Chief Minister Syed Murad Ali Shah's constituency, expressed their frustration, stating that while they do not demand jobs from the Sindh Government, they need water for their lands. They warned the Chief Minister to replace the incompetent irrigation officials and repair the burnt transformers to restart the Shahbaz Pumping Scheme. If their demands are not met, they threatened to escalate their protest by blocking the Indus Highway.

IG Sindh, Ghulam Nabi Memon, disclosed that the number of security guards in Karachi is more than the police appointed for the metropolis.

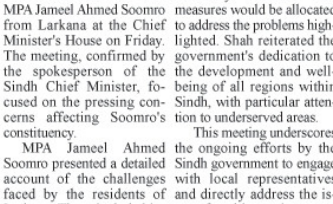
"The number of police personnel is 44,436 while the number of security guards is more than 50,000 in Karachi," IG Sindh revealed.

Following the loss of lives of citizens due to the negligence of security guards in Karachi, IG Sindh stressed that the unlicensed security companies should be shut down by the authorities.

"The number of registered security companies are closer to 200, which came under purview of the Home Department," Memon said.

IG Sindh stated that the police can only take action if the law is violated, adding that earlier, anyone with unclear background can join a security company, but now these companies have access to police software, which has helped arrest many criminals.

## Sarim Burney Remanded To Judicial Custody In Human Trafficking Case

KARACHI: A local court Saturday sent social worker Sarim Burney to jail on judicial remand, rejecting the Federal Investigation Agency's (FIA) request seeking an extension in his physical remand.

Judicial Magistrate (East) Khaliq ul Zaman also fixed Burney's bail petition for hearing on June 10 (Monday).

Burney was produced today before the court after completion of two-day physical remand.

In conversation with journalists at the court, the social worker said he was not at mistake with regards to the case.

"I do not believe there is any mistake in the papers. I am running the system and suffering as a punishment," Burney said.

The social worker added that the FIA itself does not know what all is being said about the matter.



"The FIA is not giving its position." Burney - who runs the Sarim Burney Welfare Trust International, a non-profit entity - was taken into custody on June 5 after he landed at the Jinnah International Airport in Karachi following his US visit.

The social worker's arrest and subsequent remand by the FIA came in the wake of charges on him which include human trafficking, smuggling and illegally sending children to the US after American authorities filed a complaint against him.

The social worker is accused of smuggling a newborn girl named Haya to the US, FIA said. The officials added that Burney bought the baby from her parents for Rs1 million and sent her to the US.

"More than one person assisted Sarim Burney in the purchase of the girl," they added. The FIA officials also recorded the statement of the baby's parents who, it added, are extremely poor.—RT/Agency

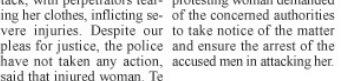

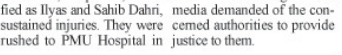

## A license to abuse

The recent decision by the Punjab government to implement the Defamation Bill 2024 is not just disappointing but deeply concerning. This bill, signed into law by Acting Governor Malik Ahmad Khan, represents a severe blow to freedom of expression and press freedom in the province. Its passage, despite objections from journalists, media bodies, and human rights organizations, demonstrates a disregard for democratic principles and the voices of those it purportedly serves.

The bill's broad scope and potential for abuse are alarming. By criminalizing the spread of 'fake news' across various media platforms, including social media, it provides authorities with excessive power to silence dissent and stifle legitimate criticism. The threat of hefty fines and expedited judicial proceed-

ings further compounds the risk of arbitrary enforcement and intimidation of journalists and citizens alike. Governor Saleem Haider Khan's initial reluctance

to assent to the bill highlights the lack of consensus and proper deliberation surrounding its passage. All stakeholders, particularly the journalist community, deserved to be consulted and heard before such far-reaching legislation was enacted. Instead, their concerns were disregarded, and the bill was pushed through the assembly amid protests and boycotts.

Attendees included DIG Sukkur, SSPs of Sukkur and Khairpur, DCs of Sukkur, Khairpur, and Ghotki, CEO SEPCO Sukkur, SE Sukkur, Khairpur and Ghotki and RT Transport Department officials. During the meeting, Divisional Enforcement Committee Chairman for Anti-Theft Electricity Campaign Sukkur, Fayaz Hussain Abbasi, was briefed on electricity theft, recovery, and load shedding by the CEO SEPCO Sukkur. The meeting expressed sorrow over the loss of lives in the LPG gas incident in Hyderabad. Reports were presented by the DCs of Sukkur, Khairpur and Ghotki regarding actions against illegal LPG gas sellers and unauthorized cylinders in vehicles and motorbikes. DC Ghotki presented a report on the Ghotki-Kandhkot bridge project, stating that the Revenue Department is swiftly completing land acquisition, road work has been ongoing for one and a half months on the Ghotki side, and 70% of the road work on the Kashmore side is complete. Commissioner Sukkur emphasized the implementation of the Chief Secretary's directives to completely control electricity theft and accelerate recovery efforts to end load shedding. Regarding the LPG issue, Commissioner Sukkur instructed DCs and police to coordinate with OGRA officials to ensure full compliance with LPG laws and SOPs to prevent future incidents.

Earlier, New Zealand invited Afghanistan to bat first. Rahmanullah Gurbaz, playing a brilliant innings, lifted his team's total to 159 at the loss of six wickets.

Rahmanullah Gurbaz was the highlight of the game as he scored 80 off 56 balls with the help of five boundaries and as many maximums. Gurbaz was followed by Ibrahim Zadran who hit two maximums and three fours to score 44 runs off 41 balls.

Meanwhile, Aizatullah Omarzai played 13 balls to score 22 runs. Captain Rashid Khan returned to the pavilion after hitting 6 runs.

Trent Boult and Matt Henry claimed two wickets each. This was the 14th game in the ongoing premier cricket tournament. New Zealand hit the ground for the first time in the event. Meanwhile, Afghanistan beat Uganda in their tournament opener.

"One of the greatest performances from us in T20 cricket against a big team. It is a great team effort. The way Ibrahim and Gurbaz started again... the wicket was not easy. They did not throw away their wickets in overs 7-10. Great win for Afghanistan and it is a privilege to be leading this side and winning against NZ," Rashid said after the match.

"Anything around 160-170, with the bowling unit we have, we will give tough competition to the opposition, as long as we hit the right areas consistently. The spinners and especially the seamers, the way Nabi bowled the second over - that gave us a sign the ball was turning. The skill we have as a bowling unit, if we use that, it will be hard for the opposition to score 160," he added.—Agency

T20 World Cup 2024: South Africa beat Netherlands by four wickets



NEW YORK: South Africa defeated Netherlands by four wickets in the 16th match of the T20 World Cup 2024 played at Nassau County International Cricket Stadium, New York on Saturday.

David Miller once again stood for the Proteas and cruised them to victory as they were once near to losing to the Netherlands for the third time in ICC events.

Chasing the 104-run target, South Africa had a terrible start as their top order was shaken by the Dutch bowlers and they were 12-4 in just 2.3 overs.

Reeza Hendricks (3 off 10), Quinton de Kock (0), Aiden Markram (0) and Heinrich Klaasen (4 off 7) walked back to the pavilion which put the Proteas in an uncomfortable position.

However, Tristan Stubbs and Miller combined for 59 runs which brought the Proteas back in the game. Stubbs was removed by Bas de Leede in the 17th over and soon, Marco Jansen too departed for the pavilion. The wickets kept falling but Miller continued the charge against the Dutch and eventually led his side to victory with an innings of 59 not out.

Earlier in the first innings, the Proteas bowlers dominated the match and put the Dutch batters on the back foot from the very first over as their opener Michael Levitt was removed by Marco Jansen on the third ball of the innings. South African bowlers continued with their attack against the Dutch and kept on sending their batters back to the pavilion without scoring big runs.

The Netherlands were soon 48-6 in 11.5 overs and it looked like another early collapse in New York but Sybrand Engelbrecht and Logan van Beek formed a crucial 54-run partnership that helped them cross the 100-run mark.

Babar Azam has not improved as captain in four years: Shoaib Malik



LAHORE: Former Pakistan captain Shoaib Malik has criticized the national team's white-ball captain Babar Azam for his performance as captain after a shocking loss against the United States (USA) in the ongoing ICC Men's T20 World Cup 2024.

"Pakistan endured a five-run defeat against the co-hosts in the Super Over as they failed to chase down the 19-run target.

Senior pacer Mohammad Amir bowled the Super Over for Pakistan and conceded 18 runs. In response, the Green Shirts only managed 13/1.

After the match, Malik, who also played under Azam, stated that the right-handed batter has not evolved as a captain and makes predecided decisions on the field rather than improvising according to the situation.

"This captaincy talk, I would like to go into its depth. You [Babar Azam] have set a blockage in your mind, that is the problem. If you have decided that Shadab [Khan] has to bat at a certain number, and Azam [Khan] and Iftikhar [Ahmed] have to bat in the last overs, and you do that exactly, these are the blockages," said Malik while talking on a local channel.

"The most important thing which needs to be fixed is Babar's captaincy from four years ago and now, I cannot see any difference. If someone is improving then you give them time because the results will be seen in the long run but in Babar's case, as a leader, he is still where he was four years ago.—Agency

Zverev sets up French Open final with Alcaraz



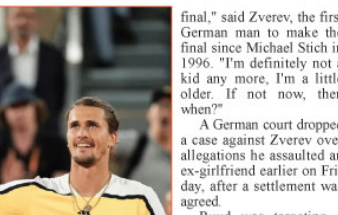
PARIS: Alexander Zverev exacted revenge on Casper Ruud at the French Open on Friday to reach his second Grand Slam final and first since 2020, with Carlos Alcaraz standing between him and the title.

Fourth seed Zverev, who had lost in the semi-finals at Roland Garros in each of the past three years, fought back to beat Ruud 2-6, 6-2, 6-4, 6-2 in a repeat of their last-four clash 12 months ago.

Zverev won just seven games when the pair met in the 2023 semis and a similar story was on the cards after Ruud cruised through the opening set.

But the German raised his game, reaching his first French Open final and keeping his hopes of a maiden Grand Slam title alive. Zverev holds a career 5-4 winning record against Alcaraz, including a victory in their only previous Roland Garros meeting in the 2022 quarter-finals. Alcaraz earlier battled past incoming world number one Janik Sinner in five sets.

"If you're in the final of Roland Garros, you deserve to be there. That goes for him, as well," said Zverev. "He played a fantastic match today. Played a fantastic tournament in general, I think.



final," said Zverev, the first German man to make the final since Michael Stich in 1996. "I'm definitely not a kid any more, I'm a little older. If not now, then when?"

Ruud was targeting a fourth Grand Slam final, but the two-time Roland Garros runner-up was well below his best and struggling with illness.

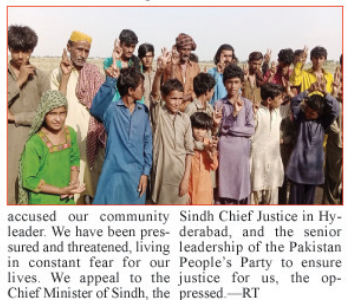

The sources linked to Crime Investigation Agency (CIA) confirmed that the "murderers" of Moin had been arrested. They said that the suspects had fled to Balochistan after showing resistance during the robbery in the city.
