## PTI Protests ATC's Dismissal Of Omar Ayub's Bail Plea For Non-appearance In Court

ISLAMABAD/SAR-GODHA: A special anti-terrorism court (ATC) in Sarogodha Monday dismissed PTI Secretary-General Omar Ayub's bail petition over non-appearance as police personnel stopped him from presenting himself before the judge, his lawyer said, prompting a strong protest from the party.



Ayub had arrived earlier today at the court premises to appear before the judge, however, he could not ensure his attendance due to the law enforcers, his lawyer told reporters, which led to his bail plea's dismissal in the May 9 and 10 riots case.

"They have taken the special court's judge hostage," alleged Ayub, who is the opposition leader in the National Assembly. "Under the guise of security, the police have stopped me from presenting myself before the judge. But I will not leave before marking my attendance," he had said but failed to do so.

Several politicians, including Ayub, Amjad Khan Niazi, and Malik Ehsan Ullah Tiwana, have been nominated in the case. With several leaders set to appear, authorities had deployed additional police personnel near the compound.

For his part, the PTI leader and lawyer Babar Awan, who was also present there, said the government should "punish others to the extent that they can bear themselves", while also alleging that a few people were playing with the country's security. He said that his clients

were not being allowed to appear before the court. "Chief Justice of Pakistan [Qazi Faez Isai] should take notice. Which door will we knock on for justice?" In response, PTI MNA Asad Qaiser said on the floor of the National Assembly that the opposition leader was not allowed to appear before the court today, asking the treasury benches under which law he was stopped. "We condemn this and we're staging a walk-out. In the Punjab Assembly, Hafiz Farhat Abbas said that Ayub and other PTI leaders were not allowed to appear before the court. He asked the speaker to summon Punjab's top cop in this regard.—RT/Agency

## SBP Slashes Key Rate By 150bps To 20.5% As Inflation Eases

-Too little, too late!

KARACHI: The State Bank of Pakistan (SBP) cut its key interest rate by 150 basis points on Monday in a widely expected move, marking its first rate reduction in nearly four years in its effort to boost growth amid a sharp decline in retail inflation.



The decision to cut the key rate to 20.5% comes two days ahead of budget and a week after data showed inflation slowed to a 30-month low of 11.8% in May.

However, the Monetary Policy Committee (MPC) foresees a risk of inflation to rise significantly in July 2024 from current levels, before trending down gradually during FY25.

The MPC in its statement noted that while the significant decline in inflation since February was broadly in line with expectations, the May outturn was better than anticipated earlier.

The Committee assessed that underlying inflationary pressures are also subsiding amidst a tight monetary policy stance, supported by fiscal consolidation.

At the same time, the MPC viewed some upside risks to the near-term inflation outlook associated with the upcoming budgetary measures and uncertainty regarding future energy price adjustments.

Notwithstanding these risks and today's decision, the Committee noted that the cumulative impact of the earlier monetary tightening is expected to keep inflationary pressures in check.

As per a survey conducted by Topline Research, 43% of participants expected the policy rate to decline by 100bps.

Similarly, in a poll conducted by CFA Society Pakistan, 48% expected the policy rate to decrease by up to 100bps.

According to a Bloomberg survey, 63% of the participants expected a

100bps decline in the key rate.

Also, for the first time in the last four years (Since June 25, 2020), SBP has decided to onset monetary easing.

The central bank last changed rates in an emergency meeting in late June last year, when it raised rates by 100 basis points to a record high of 22%.

## UN Security Council Set To Decide On US-backed Israel-Hamas Ceasefire Proposal

UNITED NATIONS: The United Nations Security Council will vote later on Monday on a United States (US)-drafted resolution backing a proposal outlined by US President Joe Biden for a ceasefire between Israel and Hamas in Gaza.



The US finalised its text on Sunday after six days of negotiations among the 15-member council. It was not immediately clear whether veto powers Russia and China would allow the adoption of the draft.

The draft resolution welcomes the new ceasefire proposal, "which Israel accepted, calls upon Hamas to also accept it, and urges both parties to fully implement its terms without delay and without condition."

A resolution needs at least nine votes in favour and no vetoes by the US, France, Britain, China, or Russia to pass. Biden laid out a three-phase ceasefire plan on May 31 that he described as an Israeli initiative. Some Security Council members questioned whether Israel had

accepted the plan to end the fighting in Gaza.

It also goes into detail about the proposal, and spells out that "if the negotiations take longer than six weeks for phase one, the ceasefire

will still continue as long as negotiations continue."

The council in March had demanded an immediate ceasefire and unconditional release of all hostages held by Hamas. For months, negotiators from the US, Egypt, and Qatar have been trying to mediate a ceasefire.

Hamas says it wants a permanent end to the war in Gaza and Israeli withdrawal from the enclave of 2.3 million people.—RT/Agency

## Government Grants 'Conditional Permission' For Exporting 150,000 MT Of Sugar



ISLAMABAD: The federal government granted "conditional" permission to export 150,000 metric tonnes of sugar following a decision taken by the Sugar Advisory Board (Sab) on Monday, according to an official statement.

The development came during the Sab meeting chaired by Federal Minister for Industries and Production Rana Tanveer Hussain in Islamabad earlier today.

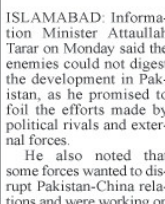
The meeting was also attended by the federal secretary for industries and production, as well as other stakeholders including Pakistan Sugar Mills Association (PSMA), Kissan Ittehad and federal and provincial representatives.

The agenda of the meeting was to discuss and re-

view the sugar stock availability, current market prices, sugarcane rates, present global market sugar prices, and industry production cost.

The Board has conditionally allowed exporting 150,000 metric tons of sugar. It was agreed to maintain sufficient local stocks to ensure the smooth supply of the commodity in local markets at a sustainable price. In this regard, an agreement was reached between the government and the PSMA to ensure smooth supply and stable prices of sugar in the local market. The federal minister said that ex-mills sugar price would not be increased under any circumstances while all the pending payments to farmers will be cleared on a priority basis by PSMA.—RT/Agency

## Efforts To Disrupt Pakistan-China Ties Will Be Thwarted: Tarar



ISLAMABAD: Information Minister Attaulah Tarar on Monday said the enemies could not digest the development in Pakistan, as he promised to foil the efforts made by political rivals and external forces.

He also noted that some forces wanted to disrupt Pakistan-China relations and were working on the nefarious agenda of creating a situation where there could not be any peace in the country.

The minister promised to extend complete security to the Chinese nationals living and working in Pakistan while rooting out the menace of terrorism forever.

Referring to his recent visit to China as member of a delegation accompanying Prime Minister Shehbaz Sharif, he said an agreement had been reached on upgradation of China-Pakistan Economic Corridor (CPEC).

However, Tarar stressed that political stability was a prerequisite for economic stability, as



he criticised those aiming at creating uncertainty in Pakistan.

Tarar told a press conference that no political leader could be bigger than Pakistan with reference to PTI founding chairman Imran Khan, as he questioned the "clean chit" being given through court proceedings.

He said a so-called leader had humiliated Pakistan around the globe, but the things were changing, as Pakistan was a historic juncture leading to development and prosperity.

"All the prisons in Pakistan should be emptied if a clean chit is awarded in 190 million pound mega corruption case, he re-

marked and also cited the cipher case about which clear evidence is available.

He also defended the Punjab Defamation Act which came into effect on Monday, arguing that the legislation was for everyone.

Tarar wondered if the local TV channels and others could submit apology before courts in other countries, then why the same could not happen in Pakistan.

When asked about the rumours and reports about restricting social media access, the minister quipped that he did see the Great Wall of China but didn't notice any "fire-wall".—RT/Agency

## IHC Declares Poet Ahmed Farhad 'Missing Person' Pending His Return Home

ISLAMABAD: The Islamabad High Court (IHC) has issued a written order in the case of missing Kashmiri poet Ahmed Farhad Shah, declaring him a "missing person" and directing authorities to ensure his safe return home.



The court observed that, given the facts, Shah forcibly disappeared and that state agencies have failed to recover him despite their best efforts.

IHC's Judge Mohsin Akhtar Kiyani issued the written order, stating that Ahmed Farhad's arrest was illegal and that he must be produced before a judicial magistrate for a statement under Section 164 of the Code of Criminal Procedure (CrPC).

Section 164 of the CrPC states that a magistrate can record any confession or statement made to him, regardless of whether he has jurisdiction in the case or not.

The court further directed that the investigation should proceed in light of Farhad's statement.

The court's order also called for the formation of a

larger bench to hear all cases of missing persons, with the chief justice exercising administrative powers to constitute the bench.

Additionally, the court ordered that the heads of the Military Intelligence (MI), Inter-Services Intelligence (ISI), and Intelligence Bureau (IB), as well as the in-charge of the Counter-Terrorism Department (CTD), be summoned to the next hearing of the criminal justice committee.

They are to present their recommendations and reports to the committee, and national security cases are to be fixed for in-camera hearings. The court also observed that the heads of high-level investigative agencies should refrain from briefing the media after in-camera brief-

ings and that the attorney general and the Law Minister should ensure the missing poet's safe return home.

The court also emphasized the "absurdity" surrounding Shah's enforced disappearance - a shift from the jurisdiction of Lohi Bher police station to that of Dheer Kot, Azad Kashmir.

Consequently, the court deemed the circumstances of his arrest illegal. On June 4, an anti-terrorism court (ATC) in Muzaffarabad denied bail to poet Ahmed Farhad.

The Kashmiri poet was missing from his home in Islamabad on May 14 and was found in police custody at a police station outside Muzaffarabad, the capital of Azad Jammu and Kashmir (AJK) on May 29.—RT/Agency

## Sheikh Rashid Calls For General Asim Munir To Announce Amnesty For May 9 Riot Detainees

RAWALPINDI: Former interior minister Sheikh Rashid Ahmed on Monday demanded that army chief General Asim Munir announce amnesty for all those languishing in jails in connection with the May 9 riots.

"People have suffered tremendously in May 9-related cases. All innocents must be granted amnesty," the chief of the Awami Muslim League said while speaking to the media on the District Courts premises.

Rashid reiterated his appeal to Gen Munir and ISI Director General Nadeem Anjum to grant amnesty to the innocent people, noting that the authority held by the ruling coalition was quite insignificant.



He also expressed concern over the way PTI women leaders Alia Hamza and Sanam Javed were being transferred from one jail to another.

Rashid said politicising the battle over Form 45 and Form 47 would only lead the country into a pit, as well as the devastation of the country's economy.

In response to a query about the India-Pakistan T20 match, Rashid said the feelings of the Pakistani people were hurt.—RT/Agency

## Modi Responds To Sharif Brothers' Congratulations Message On Indian Election Victory

ISLAMABAD: Indian Prime Minister Narendra Modi on Monday thanked the Sharif brothers for their congratulatory messages on him becoming the premier for a third time.



Modi was sworn in on Sunday at a ceremony attended by leaders from Bangladesh, the Maldives and Sri Lanka. However, China and Pakistan were not present.

Earlier today, Prime Minister Shehbaz Sharif offered a brief congratulations to his counterpart on his re-election, almost a week after the results came in.

"Felicitations to Narendra Modi on taking oath as the prime minister of India," he posted on X, in the first official comments from Pakistan.

Former PM and PML-N President Nawaz Sharif also congratulated the Indian premier. "Your party's success in recent elections reflects the confidence of the people in your leadership," Nawaz said in a post on X.

"Let us replace hate with hope and seize the opportunity to shape the destiny of the two billion people of South Asia," he added.

Hours later, PM Modi responded to the two, thanking PM Shehbaz for his "good wishes".

"Appreciate your message Nawaz Sharif. The people of India have always stood for peace, security and progressive ideas. Advancing the well-being and security of our people shall always remain our priority."—RT/Agency

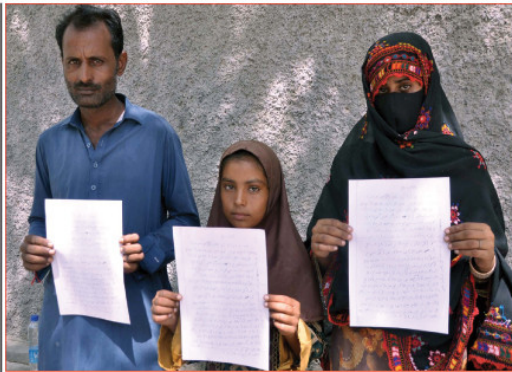

## Daulatpur growers protest against shortage of water in Lundki Mines

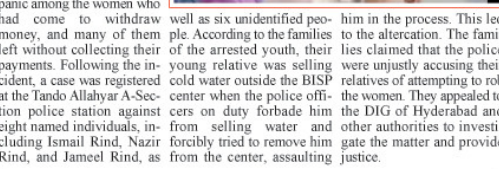
## SUP Titans Manzoor Abro And Shabbir Dero Slam Proposed Destruction Of Syed Zahoor Shah Hashmi Library

## Tando Allahyar Police and beneficiaries clash at BISP Centre

TANDO ALLAHYAR: In Tando Allahyar, a dispute occurred between the police and citizens over a minor issue at the Benazir Income Support Centre. Fourteen people were charged under the Anti-Terrorism Act, and four were arrested. According to reports, the conflict started at the Benazir Income Support Program center, established in the Provincial High School of Tando Allahyar, between the citizens and the police officers on duty. During the altercation, blows and kicks were exchanged, causing chaos. This led to panic among the women who had come to withdraw money, and many of them left without collecting their payments. Following the incident, a case was registered at the Tando Allahyar A-Section police station against eight named individuals, including Ismail Rind, Nazir Rind, and Jameel Rind, as well as six unidentified people. According to the families of the arrested youth, their young relative was selling cold water outside the BISP center when the police officers on duty forbade him from selling water and forcibly tried to remove him from the center, assaulting him in the process. This led to the altercation. The families claimed that the police were unjustly accusing their relatives of attempting to rob the women. They appealed to the DIG of Hyderabad and other authorities to investigate the matter and provide justice.



## BISP Chairperson Urges Enhanced Services For Beneficiaries, Vows Strict Action Against Violations

LARKANA: Chairperson of the Benazir Income Support Program (BISP), Rubina Khalid, emphasized the need for BISP officers to provide maximum facilities to beneficiaries to ensure they do not face any inconvenience. The protesters said that Dr. Khalil Ibupoto should have voluntarily resigned following the viral unethical videos. Although the court has canceled Khalil Ibupoto's leave, it has not issued any clear orders reinstating him as Vice Chancellor. They condemned the failed attempts by Khalil Ibupoto's indecent associates to support him. The protesters urged to act sensibly, warning that if Khalil Ibupoto is reappointed and sent back to the university, they will use legal means to prevent his return. They called on the country's higher judiciary and the Sindh Government to remove Khalil Ibupoto from Shah Abdul Latif University and appoint an honest Vice Chancellor.



## -Can you believe this? Punjab Killer Roaming Free As Security Guard In Karachi

KARACHI: A proclaimed offender and absconder from Punjab was discovered working as a security guard in Karachi, media reported on Monday. The man, identified as Waseem, was arrested two days ago in a joint operation by Punjab and Karachi police. During his interrogation, Waseem revealed how he had been recruited and managed to work as a security guard in the city for 14 months without proper documentation. Waseem allegedly murdered a man named Nasir in Lahore's Bachee banpura area in 2023 and subsequently fled with the victim's wife, first to Rawalpindi and later to Karachi. After arriving in Karachi, Waseem and the woman initially hid in Madhu Goth in the Gulshan area. According to



the police, Waseem rented a house for Rs. 9,000 per month in Madhu Goth. He initially worked at Sabzi Mandi before being hired by a security company. "The security company didn't demand any documents from me. Following his arrest, Waseem and the woman were handed over to the Punjab police for further investigation. I needed an identity and obtained the authority letter with difficulty." Police officials stated that Waseem had been hiding in Karachi after committing the murder, prompting the Punjab police to search for him. ## Sindh Energy Minister Declares SEPRAs An Autonomous Power Authority

KARACHI: Sindh Provincial Energy Minister Syed Nasir Hussain Shah has announced that the Sindh Electric Power Regulatory Authority (SEPRAs) will become a fully authorized body for power generation, distribution, and transmission in Sindh. This makes SEPRAs the first autonomous energy organization in the province, and it will operate independently from the National Electric Power Regulatory Authority (NEPRA).

Minister Shah made these remarks while presiding over an awareness meeting regarding SEPRAs legislation at the Sindh Energy Department's office. The meeting was attended by Secretary Energy, Mossadiq Ahmed Khan and NEPRA Member Rafiq Ahmed Sheikh, who briefed the Minister on energy regulations.

Minister Shah emphasized that SEPRAs aligns with



Chairman Bilawal Bhutto's vision of providing relief and welfare to the people. He noted that the establishment of the SEPRAs Board aims to offer affordable electricity tariffs, with expected discounts of 30% to 40% compared to current rates. This initiative is intended to simplify electricity tariff issues and provide facilities to the public.

The Minister also mentioned plans to establish mini-grid stations in every district across the province. He assured that the SEPRAs board members will be selected based on merit and transparency, comprising experienced and capable individuals. Once SEPRAs is established, electricity distribution companies will no longer need to seek approvals from NEPRA.

This move is seen as a significant step towards decentralizing power regulation and enhancing energy management within Sindh, ultimately benefiting consumers with lower electricity costs and improved service delivery.

## SAI Chief Deems 1.5% Interest Rate Cut Insufficient

KARACHI: The Site Association of Industry (SAI) President, Muhammad Kamran Arbi, expressed disappointment over the State Bank of Pakistan's (SBP) decision to cut the interest rate by just 1.5%. He described the move as "insufficient to address the challenges faced by the industrial sector".

In a statement, Mr. Arbi highlighted that the SITE Association of Industry had submitted budget proposals to the State Bank, advocating for a policy rate reduction to 13-14 percent. This, he argued, would alleviate capital shortages resulting from the escalating costs of operating industries.

Mr. Arbi further emphasized that the central bank should establish a roadmap for reducing interest rates, outlining measures aimed at alleviating the capital shortage faced by industries. He urged that if such a roadmap exists, the industrialist community should be informed, as this would facilitate the implementation of mutually



beneficial economic and business-friendly measures through collaborative consultation.

Kamran Arbi expressed hope that measures like the recent reduction in interest rates will continue in the next monetary policy. He urged the State Bank to seriously consider their proposal and bring the interest rate down to 13-14%. He noted that the rate of inflation is gradually decreasing in the country, which needs to be taken into account to provide relief to both the general public and the business and industrial community.—RT

## Karachi Man Shot Dead While Resisting Robbery



KARACHI: In a tragic incident, a man was shot dead by unknown armed robbers in the Quaid Abad area of Karachi on Monday, according to media reports.

The incident occurred at a dairy shop when 35-year-old Baqir, a resident of Hamal Goth, was buying milk. Witnesses told police that two armed robbers attempted to snatch Baqir's mobile phone. When he resisted, they opened fire, killing him. The robbers fled without taking the phone, and a police investigation is underway.

In a separate incident, another man was gunned down by unknown armed robbers in the Gulshan-e-Iqbal area

of Karachi. The robbers intercepted the victim and attempted to steal his motorcycle. When the man resisted, they shot him and escaped with the bike. Rescue sources confirmed that the man was killed for resisting the robbery.

These incidents are part of a worrying trend. In 2024, there has been a sharp increase in robbery-related killings, with 56 people killed and over 200 injured so far. During Ramadan alone, at least 19 people were killed and 55 injured while resisting robberies, highlighting the rising crime rate in Karachi.

## Sharjeel Condemns Journalist's Murder, Emphasizes Government Initiatives

KARACHI: Sindh Senior Minister Sharjeel Inam Memon expressed sorrow over the tragic death of journalist Nasrullah Gadani, denouncing it as an attack on press freedom. He emphasized the government's duty to counter such threats and announced the arrest of three suspects in the case, thanks to the efforts of the Glorix Police and DIG Sukkur.

At the Karachi Press Club, Minister Memon handed over a relief cheque of 10 million rupees to Gadani's family, highlighting the Sindh government's support for free journalism. He assured that the Pakistan People's Party (PPP) stands with journalists and promotes press freedom.

Minister Memon also addressed accusations against the PPP, asserting the party's commitment to supporting journalists. He noted the swift police response and the Sindh Chief Minister's immediate actions to aid Gadani. Memon reassured the public that the accused in Gadani's

## KCCI President Disappointed By Token Interest Rate Cut, Urges SBP For Drastic Measures

KARACHI: Iftikhar Ahmed Sheikh, President of the Karachi Chamber of Commerce & Industry (KCCI), expressed disappointment over the State Bank's decision to reduce the interest rate by 1.5 percent, bringing it to 20.5 percent. Sheikh noted that while the business community had anticipated a more substantial reduction, the modest decrease fell short of expectations.

Sheikh emphasized the importance of further interest rate reductions to reach single-digit figures, aligning with international trends. He highlighted the potential benefits for the economy, including increased borrowing by the private sector to spur business expansion and in-



While acknowledging the decline in inflation to slightly above 11 percent, Sheikh attributed this more to government measures and improved agricultural production rather than the SBP's monetary policy stance. He cited administrative measures and stability

in the rupee value as contributing factors to inflation control. Sheikh welcomed the initial step toward reducing interest rates but urged for additional cuts to alleviate the high cost of doing business, which has adversely affected the entire business community.—RT

## PPP Vows To Play Role In Repealing Punjab Defamation Law

ISLAMABAD: As Punjab Defamation Bill, 2024, led to protests by opposition, journalists and rights bodies, Pakistan Peoples Party Central (PPP) Punjab General Secretary Syed Hassan Murtaza said on Monday that his party would play its part in the "withdrawal" of the controversial law.

"PPP was neither taken on board regarding the Punjab defamation law nor budget preparations," Murtaza said while speaking to journalists in Lahore.

He added that the Bawal-led party's legal team was working on the disputed legislation and will make efforts to convince the provincial government to withdraw it.

The PPP senior leader claimed that his party was informed about the defamation bill when it was presented before a committee. "PPP was never willing to be part of that legislation," he added.

He further clarified that Punjab Governor Sardar Saleem Haider's foreign visit had been



planned before the legislation was tabled and passed in the provincial assembly. He criticised the PML-N led government for not holding consultations with its allies and stakeholders for the budget 2024-25.

He alleged that the Punjab government failed to table a comprehensive plan for addressing the issues of the labourers, salaried persons, students and other segments in the budget proposals.

Commenting on the Punjab defamation bill, another PPP leader and Sindh Information Minister Sharjeel Memon said that his party's Punjab governor did not sign the

controversial law. He added that the PPP would never introduce a bill that would compromise the press freedom.

He blamed the former Pakistan Tehreek-e-Insaf (PTI) government led by ousted prime minister Imran Khan for introducing same genre of law which was named after the Prevention of Electronic Crimes Act (Peca) during his tenure in the name of legislating against harassment and hate speeches.

Memon said that his party is firmly standing for press freedom and the journalist fraternity.

He detailed that the PPP government took stern actions against those who tried to target the journalists — including the slain journalists Wali Khan Babar, Aziz Memon and Narullah Gadani — and arrested all culprits behind the killings.

The Sindh minister signalled that the murderers of another martyred journalist Jan Mohammad Mahar would also be arrested soon.

Yesterday, Governor

Haider had said that the PPP was against the controversial defamation law passed by the provincial legislature.

"I tried to stop the [passage] of the defamation bill as governor," he said while speaking to the media in Dubai on Sunday. His statement came a day after interim Punjab Governor Malik Muhammad Ahmad Khan signed the bill into law in the absence of Haider.

The Punjab Assembly, on May 20, passed the Punjab Defamation Bill, 2024 amid a strong and noisy protest by the opposition as well as immense backlash from journalists and rights bodies including those based internationally. A day earlier, the central Joint Action Committee (JAC) of the media bodies announced boycotting the coverage of government affairs including official events, such as National Assembly and provincial assembly sessions and upcoming federal and provincial budgets to protest the approval of the defamation law.—RT/Agency

## PM-led NEC Meeting Deliberates Investments And Future Plans

ISLAMABAD: The newly constituted National Economic Council (NEC) convened a meeting on Monday, under the leadership of Prime Minister Shehbaz Sharif, to review ongoing projects, future investments, and targets for the upcoming fiscal year.

The meeting will review the progress report of the Executive Committee of the National Economic Council (NEC) and the Central Development Working Party (CDWP).

In the meeting, the annual plan for FY 2024-25 will be approved and the one for the prior FY will be reviewed. It is also expected to consider the 13th five-year plan (2024-29) and approve it for implementation.

The 13-member committee's objective is to attain a 3.6 percent growth rate, aligning with the planning division's effort to raise next year's federal Public Sector Development Programme to Rs1.5 trillion.

This marks an increase from the Rs1.22 trillion suggested by the Annual Plan Coordination Committee (APCC) the previous week.

The committee includes



four provincial chief ministers, four federal ministers (responsible for foreign affairs, defense, finance and planning), and four provincial cabinet members representing their respective provinces.

President Asif Ali Zardari on June 8 constituted the NEC aimed at enabling the coalition government to approve the new fiscal year's development budget and macroeconomic framework.

For the outgoing fiscal year, the government had diverted the funds meant for the equal regional development towards financing the hydropower projects and the country's space mission.

Under the constitution,

the PM held the authority to nominate four members in the NEC. Shehbaz Sharif nominated Mohammad Ishaq Dar, Deputy Prime Minister and Foreign Minister; Khawaja Muhammad Asif, Minister for Defense; Muhammad Aurangzeb, Minister for Finance and Ahsan Iqbal Chaudry, Minister for Planning, Development & Special Initiatives as the members of the NEC.

Every provincial chief minister also has the constitutional mandate to appoint one member on the NEC. From Punjab, Mariyum Aurangzeb, Senior Minister for Planning & Development has been appointed as the NEC member.—RT/Agency

## Budget 2024: MQM-P Urges Shehbaz For Rs38b Allocation To Sindh

ISLAMABAD: The Muttahida Qaumi Movement-Pakistan (MQM-P) has presented its demands to PM Shehbaz Sharif, seeking Rs 38 billion for various development projects in Sindh in Budget 2024-25, media reported citing party sources.

According to sources, MQM has demanded a 5-year socio-economic development plan for Karachi and sought development funds for its MNAs.

Sources said the party has demanded completion of the Greater Karachi Sewerage Plan and sought funds for various other projects, including Green Line, Blue Line projects, KCR (Karachi Circular Railway), Karachi Port-Pipri Freight Corridor and Bin Qasim Textile City project.

MQM-P has also demanded interest-free loans for the youth of Sindh's urban areas and ensure the provision of complete funds for



K(IV) project under the SIFC.

Earlier, MQM-P—a coalition party in the federal government—demanded a long-term strategic master plan for Karachi from the centre.

The MQM-P delegation tabled a list of complaints regarding the lack of civic facilities in the city to Federal Minister for Planning and Development Ahsan Iqbal.

The MQM-P asked the federal government to complete major uplift projects in Karachi including K-IV designed to provide 650 million gallons of water to the

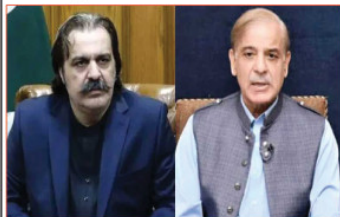
city daily at the earliest.

The MQM-P, a coalition party in the federal government, maintained that Karachi is the biggest city and economic hub of Pakistan, yet "deprived" of transportation facilities.

It is pertinent to mention here that the budget 2024-25 which was earlier scheduled to be presented on June 10 is now likely to be presented on June 12.

The Pakistan Economic Survey 2023-24 will be presented on June 11 after a meeting of the council on June 10, the sources said.—RT/Agency

## Gandapur Expresses Concern Over Exclusion Of KP Projects From PSDP



PESHAWAR: Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur has written a letter to Prime Minister Shehbaz Sharif regarding the exclusion of 91 development projects of the province from the Public Sector Development Programme (PSDP).

In the letter, Gandapur stated that the Planning Committee's decision was deeply disappointing, observing that the exclusion of 91 development projects from the PSDP would significantly impact the province.

The CM termed the exclusion of ongoing develop-

ment projects a violation of the decisions made during meetings of the Special Investment Facilitation Council (SIFC) as well as the National Economic Council (NEC).

In the letter, Gandapur also mentioned the decision taken during the NEC meeting where emphasis was placed on prioritising the completion of ongoing projects. He said that the exclusion of development projects by the federal government would exacerbate the province's deprivation.—RT/Agency

## ECP Approves Transfer Of PML-N Lawmakers' Cases To Other Election Tribunals

ISLAMABAD: The petitions from three Pakistan Muslim League-Nawaz (PML-N) lawmakers in the federal capital have won the Election Commission of Pakistan's (ECP) approval, which sought the transfer of their cases to other poll tribunals.

The poll organising authority approved three PML-N lawmakers' prays for their cases to be transferred to other election tribunals in which their election victory was challenged by opponents with allegations of vote rigging.

In its verdict, the commission ordered transferring the case to other tribunals to hear the pending petitions against the PML-N lawmakers' victory in three constituencies.

It is noteworthy to mention that three Pakistan Tehreek-e-Insaf (PTI) backed candidates — Muhammad Ali Bokhari, Shoaib Shaheen and Aamir Mughal — had challenged the poll victory of



the PML-N Members of the National Assembly (MNAs) from Islamabad constituencies after the 2024 nationwide polls by levelling the poll manipulation allegations.

The ECP's four-member bench headed by Chief Election Commissioner (CEC) Sikandar Sultan Raja had reserved its verdict on the pleas filed by the ruling party's lawmakers in the National Assembly including Anjum Aqeel Khan, Tariq Fazal

Chaudhry and Khurram Shehbaz Nawaz on June 7, Friday, which was announced today.

The Islamabad High Court (IHC) had also suspended the lawmakers' victory notifications while their petitions were being heard by election tribunals. The PML-N leaders expressed a lack of confidence in the tribunals and sought to transfer the cases to other tribunals.—RT/Agency

## Imran To Write Supreme Court To Initiate Talks With Political Parties

ISLAMABAD: PTI founder Imran Khan decided to write a letter to the Supreme Court of Pakistan to initiate talks with other political parties.

Sources said Imran Khan stated that the purpose of the letter was to address the economic difficulties and political instability the country faces. He expressed his willingness to engage with any serious party that wants to resolve these issues.

The letter will outline his readiness to discuss solutions with parties capable of addressing economic and



political problems. He also demanded the return of the electoral mandate, and fair trials in political cases, including the judicial inquiry into May 9 cases. The key allegations of the letter have

been dictated by the PTI founder. This move came after judges in the NAB amendments case advised Imran Khan to engage in dialogue with other political parties.—RT/Agency

## PM Invites AKDN To Invest More In Pakistan's Tourism Sector

ISLAMABAD: Prime Minister (PM) Shehbaz Sharif on Monday invited the Aga Khan Development Network (AKDN) to increase its investment in Pakistan's tourism sector.

LAHORE: Prime Minister Muhammad Shehbaz Sharif on Monday attended Namaz-e-Janaza of Shaheed Captain Faraz Ilyas in Kasur who was martyred in an improvised explosive device (IED) attack in District Lakki Marwat, Khyber Pakhtunkhwa.

The funeral prayer was attended by Minister for Information and Broadcasting Attaullah Tarar, IG Police Punjab and a number of senior military officers, civil authorities and residents.

The prime minister also met with the parents of shaheed captain and expressed condolences.

He announced to transform the native village of martyred officer as model village and renamed it as "Faraz Ilyas Shaheed".

He told the parents that the sacrifice of their son would not go in vain and prayed for the bereaved family to bear the loss with fortitude.

Under the Quranic teachings, a shaheed had an elevated place in Jannah, he said, adding that



a large number of Jawans of armed forces had laid down their lives for the motherland.

It is pertinent to note that a civil court sentenced the PTI founder Imran Khan and Bushra Bibi seven years imprisonment on Feb 3 in illegal marriage case.—RT/Agency
