IMF Bailout Prevails Over Populism: Tax-Heavy Rs18.9 Trillion Budget 2024-25 Unveiled

ISLAMABAD: Federal Minister for Finance Muhammad Aurangzeb has unveiled a budget of Rs18.877 trillion for the fiscal year 2024-25, a 30% increase over the previous year.

While presenting the budget in National Assembly on Wednesday, Aurangzeb described the budget as balanced, with resources matching expenditures at Rs18.877 trillion.

On the parliament floor, Aurangzeb announced a historic development budget (PSDP) of Rs1.5 trillion. He also declared a 25% salary increase for government employees in grades 1-16 and a 22% increase for those in grades 17-22. Pensions will rise by 15%.

Minimum wages in the private sector will increase to Rs36,000 per month, up from Rs32,000 last year. Funds for the Benazir Income Support Programme will grow by 27% to Rs593 billion for FY25.

Aurangzeb confirmed that income tax rates for salaried individuals remain unchanged, with the exemption limit at Rs600,000 annually.

The budget presentation was marked by opposition uproar in the National Assembly.

Aurangzeb expressed gratitude to Prime Minister Shehbaz Sharif, PML-N leader Nawaz Sharif, and other coalition leaders for



their guidance in preparing the budget.

"Mr Speaker, despite political and economic challenges, our progress over the past year has been impressive," Aurangzeb said, urging the nation to revitalise the economy.

He praised the government's determination in addressing economic challenges and pledged to accelerate development under Shehbaz's leadership.

He highlighted a homegrown agenda that has navigated economic difficulties and stimulated development.

Aurangzeb acknowledged hurdles such as depleted foreign reserves, a 40% rupee depreciation, stagnant growth, and soaring inflation pushing citizens below the poverty line.

He credited the previous PDM government for securing a crucial nine-month IMF programme in June 2023, which averted economic collapse.

"The previous IMF programme was ending, and a new deal was essential to prevent a default. I commend Shehbaz Sharif's government for their efforts," he said.

Aurangzeb noted improvements in economic indicators, attributing these successes to the efforts of the PM and his team.

"Inflation stood at 11.8% in May, a notable achievement considering the chal-

lenges. We're on the right track, and inflation is likely to decrease further," he said.

He highlighted bolstered foreign exchange reserves and growing international investor interest. He applauded the State Bank's decision to cut interest rates to combat inflation, congratulating Shehbaz Sharif and his team.

"These achievements are not ordinary. As a result, the country has exited a difficult time," he said.

Aurangzeb emphasised patience and collective effort for sustainable economic development, cautioning that progress cannot be accelerated overnight.

"There is a need for patience and extreme hard work, combined with homegrown corrective plans. The public must work together with institutions to achieve our economic goals," he said.

Aurangzeb highlighted several key measures and reforms. The FBR's tax policies and digitisation efforts have registered 3,400 retail-

new households included in the programme.

Aurangzeb noted Rs5 billion allocated for an agriculture mark-up scheme, with financing to boost the sector, which constitutes 24% of GDP.

The energy sector will receive Rs253 billion, focusing on reducing losses and promoting wind and solar power. Efforts are underway to freeze debt from power reforms and involve the private sector.

The IT sector will receive Rs79 billion, with plans for an IT park in Karachi and efforts to increase exports to \$3.5 billion this year.

A national digital commission will be introduced to advance digital solutions. The social welfare and education sectors will see Rs206 billion allocated for water resources, Rs8 billion for an IT park in Karachi, and Rs206 billion for drinking water projects.

Smart screens, tablets, blended learning, and e-libraries will be provided in schools, with six-month IT courses offered to students.

Overseas Pakistanis will be facilitated in sending remittances, with Rs90 billion allocated for this purpose, recognising their crucial role in the economy.

Aurangzeb presented a positive economic outlook, expecting 3.6% growth in the next fiscal year and keeping

inflation around 12%. Significant allocations include defence (Rs2,015 billion), pensions (Rs1,014 billion), and power sector subsidies (Rs1,363 billion).

Efforts are being made to attract global climate finance and improve Pakistan's economic growth through a homegrown reform agenda. The PSDP allocation of Rs1,500 billion will focus on infrastructure, social sector development, and strategic projects.

In FY25, Rs50 billion has been earmarked for the production sector, with a comprehensive Karachi package introducing special projects for Karachi, Hyderabad, Sukkur, and Benazirabad.

The tax-to-GDP ratio will be increased through economic digitisation and a progressive tax system. The undocumented economy will be brought under the tax net through digitisation, with the FBR introducing personal income tax reforms.

Under these reforms, tax exemptions will remain unchanged at Rs600,000 for salaried individuals. The minimum wage is set at Rs36,000.

The government is committed to facilitating exports, recognising their crucial role as the economy's backbone. Different tax slabs have been implemented for filers and non-filers, with a capital gains tax fixed at 15% for fil-

ers and up to 45% for non-filers.

Sales tax exemptions on many products will be reduced or eliminated, with an 18% sales tax imposed on mobile phones and motor cars based on vehicle price.

BISP beneficiaries will increase to 10 million, with sales tax on textiles and leather raised to 15%. Advance tax scope will expand to document traders, while tax on the Pakistan Stock Exchange will increase from 1% to 2.25%.

Capital gains tax on non-filers will go as high as 45%, while for filers, it will stay at 15%.

The FBR will impose personal income tax on incomes exceeding Rs600,000 annually, ensuring higher incomes are taxed more.

The government has allocated Rs4 billion for e-bikes and plans to support exporters through joint ventures, especially with Chinese companies under CPEC Phase-II.

Recent visits to China resulted in several MoUs aimed at promoting trade and investment in sectors such as iron and steel, automobiles, and textiles.

The Pakistan Climate Change Authority will be activated to promote solar and wind energy, with Rs206 billion allocated for water projects.

Iron and steel scrap will be exempted from sales tax to eliminate the misuse of fake invoices. Tax rates for textile and leather manufacturing will be adjusted from 15% to 18%, which will not impact consumers.

The GST on the tier-1 textile retail sector will be enhanced from 15% to 18%. Sales of cigarettes without tax stamps will be penalised, and the Federal Excise Duty (FED) on cement will increase to Rs3 per kg from Rs2 per kg.

Customs duty exemptions on hybrid car imports will be abolished, and duties on steel and paper products will increase. Incentives will be introduced for the import of plant and machinery, raw materials, and batteries for the solar panel industry.

Health insurance will be provided to 5,000 journalists initially, and later to 10,000 journalists. Rs79 billion has been proposed for the IT sector, with incentives for importing plant and machinery for the solar panel industry.

The budget aims to mitigate people's problems, transform the agriculture sector, promote information technology, boost exports, promote industrial growth, and bolster businesses. It has been formulated considering domestic and international challenges, aiming to present a pro-people, business-friendly, and progressive federal budget.—RT/Agency

PPP Extended Invitation To Rejoin Federal Cabinet

ISLAMABAD: Prime Minister Shehbaz Sharif has decided to expand the federal cabinet after the budget and has invited the Pakistan Peoples Party (PPP) to join the government formally, sources told media.

According to the report published today, senior political leaders from the ruling Pakistan Muslim League-Nawaz (PML-N) and allied parties will be included in the cabinet.

The publication stated that the prime minister has started working for the inclusion of new cabinet members and has once again invited the PPP to be a part of the cabinet with talks going on in this regard.

After the decision of the leadership, this matter will be kept before the top decision-making body of the party — the Central Executive Committee (CEC) — which will make the final call.

The report said that Federal Minister Ahsan Iqbal has



been given an important task by the PML-N leadership following which he has contacted Balochistan Chief Minister Sarfraz Bugti and Qamar Zaman Kaira on the issue.

It is important to note that after the elections, the PPP decided against joining the PML-N alliance in the Centre and Punjab but voted for Shehbaz Sharif as prime minister.

The PPP had initially decided not to take any ministries and had limited itself to only constitutional and parliamentary posts as per a

fresh employees, a contributory pension scheme would be introduced for the government employees who deposit their share every month.

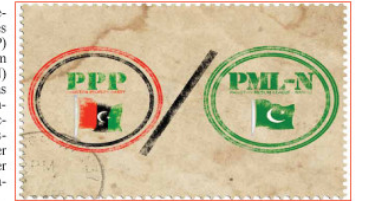
Moreover, a pension fund would be created to manage the liability, he added.

He proposed a 20-25% increase in the salaries on ad-hoc basis and 15% enhancement in the pensions of the federal government employees, realising their financial hardships due to the increased inflation.

The minister said despite financial constraints, the government had decided to give 25% ad-hoc relief in the salaries of employees from Grade 1-16 and 20% to Grade-17-22 employees aimed at increasing their purchase power. He also announced to increase the minimum wages from existing Rs32,000 to Rs 36,000 per month.—RT/Agency

PPP Warns PML-N: Do Not Underestimate Us

ISLAMABAD: Rifts between the Pakistan Peoples Party Parliamentarian (PPPP) and the Pakistan Muslim League-Nawaz (PML-N) deepened on Wednesday as main ally of PML-N government had only a token participation in the National Assembly's budget session after the ruling party didn't bother to address PPPP's reservations about budget.



The disgruntled lawmakers of the PPPP only had a token participation in the budget session, that too after the Deputy Prime Minister & Foreign Minister Ishaq Dar rushed to PPP chairman Bilawal Bhutto-Zardari's chamber, requesting that the party should attend the budget session.

However, the PPP chairman only sent three of his MNAs, Naveed Qamar, Khurshid Shah and Ijaz Jakhani, to represent PPPP in the session as the party feels that PML-N has not only deviated from its post-election agreement but it has started taking PPPP for granted. The PPP chairman and the rest of the party lawmakers were conspicuous by their absence when the session started.

"The PML-N has violated the agreement that it reached with PPPP before forming the government in the Centre as it has not taken any input from its key ally in the PSDP budget," PPPP Secretary In-sharraf Shazia Marri shared with The Express Tribune, "the government is taking us for granted."

The party spokesperson said that both the parties had agreed that they would consult on Public Sector Development Programme (PSDP) programme and take PPPP's recommendations in this regard but that hasn't happened. Marri said that the government side only briefed a few party lawmakers a few days ago but nothing has happened after that, adding that the token participation in today's session makes it clear PM Shehbaz and the government hasn't given any assurances to PPPP.

Had Dar not come to request Bilawal and assure that the government will look into the issue, Marri said, PPPP wouldn't even have participated in the session at all. To a question what will be PPPP's next move, Marri said that it was up to the government how it moves on from here on as the ball was in the government's court.

Responding to the question if PPPP would help the government pass the budget, Marri said that the government still has time to address PPPP's concerns. "We are not blackmailers, we act responsibly," she said, "but the government shouldn't take us for granted." She said that PPPP wants to subsidise farmers, strategic taxation and avoid regressive taxation.—RT/Agency

Arrest Warrant Issued For Khawar Maneka In Land Grabbing Case

SAHIWAL: A special judge of anti-corruption has issued arrest warrant for Former first lady Bushra Bibi's ex-husband Khawar Maneka and his son Musa Maneka, media reported. As per details, special judge anti-corruption Asif Bashir also ordered the authorities to arrest Khawar Maneka and his son and present them before court. On August 11, 2023, anti-corruption Okara booked Maneka and his sons in a case pertaining to constructing a market after grabbing the land. The Anti-corruption stated that the market construction has costed millions of losses to the national kitty. On September 25, 2023, the Punjab Anti-Corruption Establishment (ACE) arrested Khawar Farid Maneka, ex-husband of Pak-



istan Tehreek-e-Insaf (PTI) chief Imran Khan's wife Bushra Bibi, on illegal construction charges in Lahore. An ACE spokesperson confirmed the arrest of Maneka saying that he was apprehended on charges of illegally constructing a marriage hall on the cemetery land. Later, in another case the National Accountability Bureau (NAB) commenced inquiry against Bushra Bibi's ex-husband, over complaints of financial irregularities. Khawar Maneka and his family are accused of taking huge financial benefits during the tenure of the Pakistan Tehreek-e-Insaf government. The NAB has begun collecting the record of the assets owned by Khawar Maneka and his family members.—RT/Agency

Opposition Denounces Budget As Fake And Anti-People

ISLAMABAD: Leader of the opposition in National Assembly Omar Ayub termed the federal budget as anti-people and said that the government didn't consult any stakeholder.

Talking to media outside the parliament house after the budget speech of Finance Minister Muhammad Aurangzeb, the opposition leader said that the constitution was violated for the very first time in National Assembly during the presentation of budget.

"I have presented four budgets in this house. These are fake documents as government didn't mention the total volume of budget and its deficit," said the opposition leader.



He added that the PTI government eliminated electricity loadshedding by 80 percent during its tenure.

"The PPP has stabbed the government in the back as their MNAs didn't want to participate in the budget session today," Ayub said.

MNA Ali Muhammad Khan of Sunni Ittehad Council said that the budget is anti-people as it doesn't have anything for the masses. "The party that got majority in the house was thrown on the opposition benches. The budget was presented by those who reached parliament on Form-47," said Ali Muhammad Khan.—RT/Agency

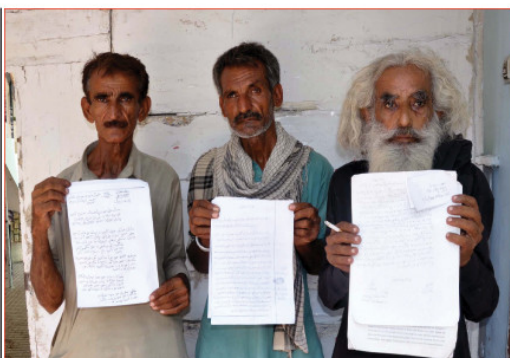

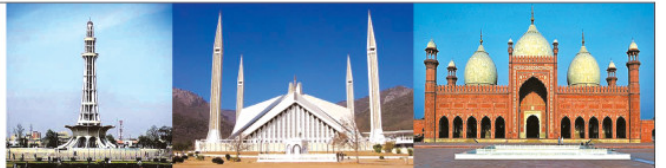

PTI Selects Achakzai To Lead Talks: Release Of Leaders And Electoral Transparency On Agenda

ISLAMABAD: The Pakistan Tehreek-e-Insaf (PTI) Wednesday picked Pash-tunhwa Milli Awami Party (PkMAP) Chairman Mahmood Khan Achakzai to lead the negotiations via opposition alliance's platform Tehreek-e-Tahafuz Ayeen (TTAP), sources told media.



The PTI chairman noted that the former prime minister wanted the avenues of dialogue to be opened. He told journalists that Khan is ready to forgive what has happened to him for reconciliation.

"PTI founder has said many times that 'I am ready to forgive what happened to me,'" said the PTI chairman.

When asked if the negotiations will take place at the behest of the Supreme Court's advice, Barrister Gohar said, "The option given by the SC is also under consideration."

Furthermore, the PTI's political leadership will also be part of the negotiations, the sources said.

The development comes a day after PTI Chairman Barrister Gohar said that the party's incarcerated founder, Imran Khan, had given his approval for talks with the government and said that the party would initiate negotiations after talking to Achakzai.

"We told the PTI founder that dialogue is necessary, as the distance is widening. He agreed with us [on this]," said Gohar, when speaking with journalists outside the Adiala jail.

However, he emphasised that it is PTI's "own decision" to negotiate. "PTI founder did not write any letter to the SC for negotiation. PTI will also respond to its negotiation option." The PTI chief's comment comes days after Khan decided to "step back" from his rigid stance, ordering his party leaders to establish contacts both inside and outside the Parliament to ease the ongoing political tension, sources told media.—RT/Agency

Farooq Sattar Advocates For Taxation Of Large Agriculturists And Privatization Of Loss-Making Entities

ISLAMABAD: Senior Leader of Muttahida Qaumi Movement-Pakistan, Muhammad Farooq Sattar, on Wednesday proposed taxing large agricultural landowners to provide relief to the general public.

Refraining from commenting on the budget, he mentioned that he had presented a shadow budgetary document for review to make it more people-friendly.

Farooq further proposed that the government should use the income from privatized organizations to reduce the external debt burden on the national exchequer. He urged the government to establish a scientific mechanism for debt management.

He also recommended that the government should privatize loss-making organi-



zations, emphasizing that business operations should fall under private entities' jurisdiction rather than the government.

Farooq suggested that the government should further enhance Karachi's infrastructure, highlighting its importance as a business hub. He noted that investing Rs100 billion in the metropolitan city could boost the country's annual growth rate by one percent.

He also called for a reduction in electricity, oil, and gas prices to improve the purchasing power of the common people. Additionally, he proposed providing small loans to help them come economically self-sufficient.—RT/Agency

Fatal Shootout In Jhelum Claims Lives Of Two ANF Personnel And Private Employee

JHELUM: A shootout between the Anti-Narcotics Force (ANF) and armed riders resulted in the deaths of two ANF personnel and a private employee near Jhelum on GT Road, media reported.



The incident occurred near Kala Pul on GT Road when an ANF team attempted to stop a suspicious car. The car's occupants opened fire on the ANF team, leading to the immediate deaths of Head Constable Gulzar and Constable Mazhar. A private employee, Zeeshan, was critically injured and later succumbed to his injuries in the hospital.

Three suspects managed to escape into a nearby forest while firing. Police and a large contingent of ANF per-

sonnel have launched a search operation along GT Road to locate the suspects.

An ANF spokesperson reported that a car driver named Shehzad has been arrested. In his initial statement, Shehzad claimed that a person named Bilal from Kharian had booked his car.

The search for the remaining suspects continues as authorities intensify their efforts to apprehend those responsible for the attack.—RT/Agency

ANF Seizes Large Cache Of Drugs In Pasi

The ANF officials conducted an Intelligence-Based Operation (IBO) against drug traffickers in the Chor Bandar area adjacent to Makran coastal line and seized a consignment of drugs hidden for smuggling abroad.

The operation was carried out keeping in mind the activities of a group involved in drug trafficking. Raids are being conducted to arrest the ring leaders of the drug trafficking group namely Liaqat Baloch and Wahid Baloch.

Members of the group are involved in drug smuggling abroad by sea. On receiving the intelligence information, the ANF team conducted a raid in the area and recovered the drugs which were stored in a secret location, he informed.

During the operation, more than one ton drugs and 51,000 narcotic capsules were also recovered. The recovered drugs weighing 1014 kg drugs included 850 kg hashish and 164 kg ice.

The spokesman said that ANF is making all-out efforts for a drug free society.—RT/Agency

Let them eat cake!

The recent unveiling of the federal budget for the fiscal year 2024-25 by Finance Minister Muhammad Aurangzeb paints a picture of a government completely out of touch with the reality faced by the common man. Despite the finance minister's assertions of progress and stability, the budget's priorities seem skewed towards pleasing international financial institutions like the IMF rather than addressing the pressing needs of the people.

Much like Marie Antoinette's infamous "let them eat cake" remark, this budget seems indifferent to the dire economic conditions faced by the masses. While the finance minister boasts of economic growth targets and inflation projections, the ground reality for the average citizen remains grim. With a budget deficit of 6.9% of GDP and a primary surplus of just 1%, it's clear that the burden of eco-

The emphasis on securing an IMF bailout at any cost is



alarming. While short-term stability may be achieved through such measures, the long-term ramifications for the economy and the people could be catastrophic. The focus on meeting ambitious fiscal targets to appease international lenders neglects the everyday struggles of ordinary Pakistanis, who continue to grapple with rising inflation and stagnant wages.

Furthermore, the allocation of funds in the budget

seems misguided. While substantial amounts are earmarked for sectors like defense and infrastructure development, essential social welfare programs receive only token increases. The Benazir Income Support Programme, a lifeline for millions of vulnerable families, sees a mere 27% hike in allocations, hardly enough to keep pace with inflation.

Thus, the federal budget for 2024-25 reflects a government that is disconnected from the plight of its citizens. Instead of prioritizing the needs of the people, it prioritizes pleasing international financial institutions and maintaining a facade of economic stability. If this trend continues, the gap between the rulers and the ruled will only widen, leading to further discontent and unrest. It's high time for the government to listen to the voices of the common man and take concrete steps to alleviate their suffering.

T20 World Cup 2024: India beat USA by 7 wickets in another low-scoring encounter

NEW YORK: India defeated United States by 7 wickets and became the first team from Group A to enter Super Eights' phase of the T20 World Cup after today's match played at Nassau County International Cricket Stadium, New York, on Wednesday.

Subsequently, India became the third team after South Africa and Australia to qualify for the next round.

Earlier, India put the USA into bat first and restricted them to 110/8. Pacer Arshdeep Singh was the best bowler for India, securing figures of 4/9 - the best-ever by an Indian in the history of the competition.



He dismissed Shayan Jangir, Andries Gous, Nitish Kumar and Harmeet Singh. Hardik Pandya secured the USA, scoring 27 off 23 balls. Opener Steven Taylor chipped in with 24 (30) from Arshdeep.

T20 World Cup 2024: Petition seeks sedition case against PCT and Form 47 Babar Azam



A petition seeking to register a sedition case against the Pakistan cricket team and its captain, Babar Azam, was submitted to a local court in Gujranwala on Wednesday, media reported.

The petition was filed under sections 22A and 22B of the criminal code at the District and Sessions Court of Gujranwala.

The petition, submitted by a lawyer in Gujranwala, calls for charges of treason against team captain Babar Azam and other members of the team. The case was filed in the court of Additional Sessions Judge Tamsal Zaib Naem.

The petition alleges that the team's performance is a waste of money and has brought dishonour to the nation. It claims that tens of millions of rupees have been squandered on the players and that the management prioritises financial gain over national pride.

The application also requests a case against the team manager, coach, and chief selector.

It should be noted that in the initial two matches of the ICC T20 World Cup, the national team had to face defeat against USA and India, which makes it unlikely for Pakistan to advance to the Super 8 round.

The petition highlights the emotional toll on the nation after losses against the United States and India, demanding a ban on the team until an inquiry is conducted and a report is submitted to the Home Secretary.

The court has requested a report from the police on the registration of the case and directed the SHO of the police station to submit the report by June 21.—Agency

T20 World Cup 2024: Australia humble Namibia to qualify for Super 8

ANTIGUA: In a superb display of the game, Australia outclassed Namibia after chasing the target of 73 runs in just 5.4 overs at the Sir Vivian Richards Stadium, North Sound, Antigua, on Wednesday.

With the win, Australia also qualified for the Super 8 stage of the cricket event.



Namibian bowlers could only claim the wicket of David Warner, who scored 20 off 8 balls before being dismissed. Travis Head and Mitchell Marsh remained unbeaten with 34 and 18 runs respectively. Travis hit 5 fours and 2 sixes.

Earlier, Australia won the toss and invited the rivals to bat first who were all out after scoring only 72 runs in 17 overs.

Achieving the milestone, Australia's Leg-spinner Adam Zampa became the first Australian male cricketer to claim 100 wickets in T20I cricket. He achieved this feat with 4-12 figures in four overs.

Australian bowlers overpowered the batters throughout Namibia's innings.

Pacer Josh Hazlewood took two wickets for 18 runs in four overs. Marcus Stoinis also contributed with two wickets as

Namibia was dismissed in 17 overs.

Namibia captain Gerhard Erasmus played 17 balls to score his first runs. However, he was the highest run-getter with 36 runs in 43 balls with the help of four fours and a six.

Apart from Erasmus, Michael van Lingen was the only batter who got into double figures with 10 runs.

This was the first competitive T20I between Australia and Namibia. But they played each other in a warm-up game before this tournament, with Australia registering a convincing seven-wicket win.—Agency

Former cricketer Ijaz Ahmed slammed over racist remarks against Pashtuns

Sindh's Budget Presentation Expected On June 14

KARACHI: The Sindh government is set to present its budget for fiscal year 2024-2025 on June 14, sources told media on Wednesday.

According to the sources, Chief Minister Murad Ali Shah will present the provincial budget for the upcoming financial year.

At least 10% to 15% increase in the salary of Sindh's government employees will be proposed in the budget, said the sources.

They added that no money will be allocated for new development schemes in Sindh's budget and that funds for development projects will be released for ongoing projects.

The federal government, on the other hand, will unveil



the upcoming budget for the next financial year, 2024-2025, today.

As per analysts, the budget sets ambitious fiscal targets as it looks to strengthen the case for a bailout deal with the International Monetary Fund (IMF), Reuters reported.

The budget comes a day after the government said economic growth of 2.4% expected in the current year would miss a target of 3.5%, although revenues were up 30% over last year, and the fiscal and current account deficits were under control. Pakistan is in talks with

the IMF for a loan estimated to range from \$6 billion to \$8 billion, as it seeks to avert a default for an economy growing at the slowest pace in the region.

But a recent economic uptick, following stabilisation measures and falling inflation, as well as Monday's interest rate cut by the central bank, has made the government optimistic about prospects for growth.

The key policy rate could fall further this year and economic growth would continue to rise, Finance Minister Muhammad Aurangzeb, set to present his first budget, told reporters on Tuesday.

Markets will watch the budget for a target for proceeds from privatisation, as

Pakistan looks to make its first major sale in nearly two decades with the disposal of a stake in its national airline, kicking off a series of such moves.

But concerns remain about the government's ability to pursue reform, since it is vulnerable to the quirks of coalition politics in the face of rising public pressure against inflationary reform measures.

Tapping under-taxed sectors such as agriculture and retail for additional revenues would prompt protests by farmers and small traders, while spending cuts in discretionary funds for MPs have already squeezed alliances and party loyalties.—RT

KARACHI: Muhammad Kamran Arbi, President of the SITE Association of Industry, has praised the efforts of the Director General of Pakistan Rangers Sindh to curb freshwater theft in collaboration with the Karachi Water & Sewerage Corporation (KWSC).

"Unfortunately, no solution to the water shortage problem has been implemented by KWSC yet, despite the substantial increase in water in their system. They must supply uninterrupted water seven days a week so we can focus on fulfilling our orders on time," he remarked.

The SITE President has demanded that KWSC make urgent arrangements to provide uninterrupted water to SITE area industries 24/7 to ensure their smooth functioning and avert production losses amid the current difficult economic conditions.—RT

Eid ul Adha Holidays: Banks To Be Closed For Four Days



KARACHI: As the preparations for Eid ul Adha are in full swing across the country, the State Bank of Pakistan announced a three-day public holiday for all the banks in Pakistan on Wednesday.

The bankers will have a cumulative four-day off as Saturday and Sunday weekly offs are falling ahead of the Eid holidays.

A press release issued by the central bank said: "The State Bank of Pakistan will remain closed from 17th to 19th June 2024 [Monday to Wednesday] being public holidays on the occasion of Eid-ul-Adha."

After the statement, all the banks and other financial institutions will witness a country-wide closure during the said period. The commercial activities will commence from June 20, 2024, Thursday.

The statement comes a day after the federal government announced Tuesday a three-day country-wide holiday for Eid ul Adha from June 17 to 19.

Media reported citing sources that Prime Minister Shehbaz Sharif has given his assent to the summary forwarded by the Cabinet Division.

Pakistan will celebrate Eid ul Adha on June 17 after the Zil Hajj moon was sighted on June 7 last week.

The festival falls on the 10th day of Zil Hajj and marks the Hajj pilgrimage.

With Eid ul Adha just around the corner, cattle markets have been set up in different areas for people to purchase cows, goats, sheep and camels for sacrifice.—RT/Agency

Truck Carrying Sacrificial Goats Robbed In Karachi's Gulistan-e-Johar

KARACHI: A truck loaded with sacrificial goats became the target of a brazen robbery near Kamran Chowringi in the city's Gulistan-e-Johar area, police told media.



Sharing details of the incident, the police revealed that four suspects on a motorcycle approached the truck that carried at least 30 sacrificial goats.

Two among the suspects dragged the driver out of the vehicle on gunpoint before fleeing with the truck.

Abdul Manan, the trader who became victim to the unfortunate robbery, revealed that the goats were being transported from Hyderabad to Gulistan-e-Johar.

Furthermore, the police said that an investigation into the incident has been initiated after the trader registered a first information report (FIR).

The incident comes days ahead of Eid ul Adha, a festival celebrated by Muslims at the end of every Islamic year across the globe when they sacrifice cattle, including goats, cows, bulls and camels.

Such robberies have become frequent as the annual celebration draws near with masses bringing home sacrificial cattle and this is not the first of its kind this year.

A few weeks ago, two such incidents were reported

in Lahore where citizens lost their sacrificial goats to armed men, media reported.

In Lahore's Samanabad neighbourhood, robbers snatched two goats from a young boy at gunpoint and fled.

In a separate incident in Nishtar Colony, Lahore, a group of muggers snatched a goat from a citizen but police immediately arrested one of the dacoits, while his accomplice managed to flee from the scene.—RT/Agency

Boy Commits Suicide After Father Denies Motorbike Request

KARACHI: In a tragic incident, a 10-year-old boy from Karachi took his own life after his father refused to get him a motorbike, media reported.

As per details, the incident occurred near Ghaghar Phatak, Karachi where the boy used his father's pistol and killed himself.

The police officials stated that the child had asked his father for a motorcycle, but was refused.

The police are investigating the incident and statements are being taken from family members. The father had obtained a license for the pistol, which has now been taken into custody by the authorities, police officials added.

In a similar incident occurred in India, a 10-year-old girl allegedly committed suicide after her mother refused to take her on a trip to a tourist spot.—RT/Agency

Pakistan Steel Mills Axes Employment Of 562 Daily Wage Workers

KARACHI: Pakistan Steel Mills terminated 562 daily wage workers on Wednesday, citing the contract end, media reported.

According to a notification issued by In-charge Manager A&P, all daily wage employees of Pakistan Steel Mills have been terminated from their jobs.

The employees have been laid off after end of their contract and they will not be re-hired by the PSM, the notification stated.

In December 2023, the then caretaker government removed the Pakistan Steel Mills from its privatization list of the state-owned entities.

Finance Minister Muhammad Aurangzeb, during his address at the launch of the Economic Survey 2023-24 in Islamabad on Tuesday, expressed a grim outlook regarding the revival prospects of the PSM. With an air of certainty, he asserted that there exists a bleak zero percent probability for the resuscitation of this once-thriving entity. Highlighting his point, Aurangzeb boldly proclaimed that the only foreseeable fate for PSM is to be relegated to the realm of scrap.

Shehbaz Pledges Full Eradication Of Polio

ISLAMABAD: Prime Minister Shehbaz Sharif has directed authorities concerned to depute the most capable health professionals in Health Ministry and its relevant department to provide best medical facilities to people.

Chairing a meeting in Islamabad today (Wednesday) to review matters related to health sector, he announced state of the art constructions of Quid-e-Azam Health Tower in the Federal Capital. He also directed to prepare an action plan related to the establishment of health tower under the public-private partnership.

The Prime Minister said despite establishing the highly standard hospitals, medical and nursing universities, state of the art laboratories and diagnostic centers will also be established in the health tower.

Expressing concerns over the emergence of new polio



cases in the country, the Prime Minister vowed to eradicate polio from the country by utilizing all resources in collaboration with all stakeholders.

Shehbaz Sharif directed relevant authorities to conduct a third-party audit of the nursing schools and colleges and Drug Regulatory Authority under the Ministry of Health.

He also directed the authorities concerned to conduct audit of all the nursing

schools and colleges across the country. He also instructed to set up a plan of action to separate Drug Pricing from DRAP.

A detailed briefing was also given to the Prime Minister about health related issues. It was informed that work has already been initiated on National Action Plan 2025-30 in view of growing population.

It was told that medical equipment and ambulances at a cost of 711 million have been purchased for the hospitals in the Federal Capital. The Prime Minister directed to conduct third party audit of this purchase.

The meeting was informed that Waste Processing Plants have been working in five government and four private hospitals in Islamabad, while a modern Hospital Management System will also be installed in the hospitals of the federal capital.

The Prime Minister was further briefed that National Blood Transfusion and Blood Products Policy is also in the pipeline while preparation of National Policy Framework on Nursing and Midwifery is also in the final stage.

In order to increase the number of nursing graduates, the Prime Minister was informed that evening classes will be started in some nursing colleges.

Fafen Criticizes Slow Pace Of First 100 Days In National Assembly

ISLAMABAD: The performance of Pakistan's 16th National Assembly, which concluded its first 100 days following the oath-taking of legislators on February 29, has been described as "slow-paced despite high attendance".

According to a report published by the Free and Fair Election Network (Fafen), the assembly's focus on "parliamentary transparency and gender responsiveness" was described as a defining characteristic of NA's first 100 days.

The report added that the House encouraged bipartisanship by allocating nearly 54% of the time used for points of order to the opposition.

Following the February 8 general elections, the Pakistani government descended into instability as no political party secured a clear majority.

However, several of the winning parties formed an alliance with the Pakistan Muslim League-Nawaz (PML-N), forming a coalition government at the Centre.

The PML-N, therefore, formed the federal government with the support of eight parties, including the Pakistan Peoples Party Parliamentarians (PPPP), Mut-

tahida Qaumi Movement-Pakistan (MQM-P), Pakistan Muslim League Quid (PML-Q), Istehkam-e-Pakistan Party (IPP), Pakistan Muslim League Zia (PML-



Z), Balochistan Awami Party (BAP) and the National Party (NP).

The House, however, still remains short of 26 members.

Conducted to Fafen, at least 23 sessions have been conducted in the lower house of the Parliament up until now, spanning over 66 hours and 33 minutes. The speaker and deputy speaker chaired 84% of the proceedings.

Prime Minister Shehbaz Sharif has, so far, attended only two sessions, which makes up 10% of his attendance as compared to former premier and Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan's 29% in the first 100 days of his ousted government.

Fafen added that the assembly elected its standing committee on May 17 after a month-long delay. In the first 100 days, only a money bill has been approved by the House.

The Fafen report highlights that at least 159 members, or 51%, actively partici-

ated by sponsoring agenda items or participating in discussions out of the 310 members, 61% of which were females and 49% males.

On average, 230 members were present in one session, with a maximum attendance of 302 and a minimum of 176.

The House addressed 76% of its business, including 20 legislative bills, 93 questions, 28 calling attention notices (CANs), and 11 resolutions.

In his maiden speech, PM Shehbaz outlined his government's plans for foreign relations, agriculture, economic affairs, tax reforms, energy, human development, and law and order, the Fafen report maintained.

Specific commitments, it added, included providing high-quality seeds to farmers, creating export zones, broad tax reforms, renewable energy projects, scholarships for students, and addressing terrorism as well as the issue of missing persons in Balochistan.—RT/Agency

Gohar Advocates For Dialogue, Stresses Absence Of Permanent Allies Or Enemies In Politics

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) Chairman Barrister Gohar Ali Khan stated on Wednesday that there are no permanent friends or foes in politics, emphasising the former ruling party's desire for political dialogue.

Ahead of a party meeting at Khyber-Pakhtunkhwa House in Islamabad, Gohar indicated openness to Pakhtunkhwa Milli Awami Party (PKMAP) chairman Mahmood Khan Achakzai and Tehreek Tahafuz-e-Ain-e-Pakistan (TTAP) chief leader the negotiation effort.

"We seek elections free from rigging and a robust judiciary," Gohar said.

The PTI chairman confirmed ongoing discussions with Maulana Fazlur Rahman, head of a Jamiat Ulema-e-Islam-Fazl, expressing hope for his support.

Gohar mentioned additional meetings with the JUI-F leader, noting, "Consensus is essential for national stability."

The PTI leader highlighted the party's unique negotiation style, asserting, "Achakzai will act as he sees fit."



Gohar dismissed any "deal" prior "guarantees" by PTI founder Imran Khan, saying that the political process will continue.

He concluded by expressing optimism about the role of allies. "If they wish to advance this issue, it would be much better."

A day earlier, PTI decided that a delegation led by PKMAP chairman Mahmood Khan Achakzai would negotiate with the government—

for the sake of "political stability" in the country, to grab back their "stolen" mandate, and secure the release of the party's incarcerated activists.

However, the party clarified that the body would only hold talks with the rulers, reiterating its earlier stance of not striking a

Government Seeks To Court PPP Amid Budget 2024 Disagreements

ISLAMABAD: The PML-N-led federal government has intensified efforts to placate Pakistan People's Party (PPP) following the latter's criticism for not taking its input at all while preparing the annual budget 2024-25, media reported on Wednesday, citing sources.

Sources told media that the government has invited the Bilawal Bhutto-led party for another round of talks, which the party has accepted.

According to sources, the two sides have agreed to continue the dialogue process and the PPP delegation will meet with government representatives tomorrow.

The previous round of talks between the government and the People's Party ended without a breakthrough, sources added. PPP has decided not to back down from its demands, including the Public Sector Development Programme (PSDP) issue.

The PPP has vowed to continue protesting until its concerns are addressed, the sources said, noting that the

absence of Bilawal Bhutto and Aseefa Bhutto from the budget session is a clear message.

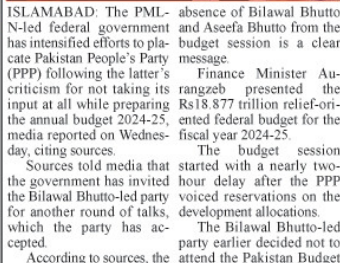
Finance Minister Aurangzeb presented the Rs18.877 trillion relief-oriented federal budget for the fiscal year 2024-25.

The budget session started with a nearly two-hour delay after the PPP voiced reservations on the development allocations.

The Bilawal Bhutto-led party earlier decided not to attend the Pakistan Budget 2024 session in National Assembly, but the PML-N managed to placate them.

Later, the PPP lawmakers attended the session to complete the required quorum without party chairman Bilawal Bhutto Zardari. Earlier, Khurshid Shah said the party had reservations with regard to the Public Sector Development Programme (PSDP) budget and that the PPP should have been taken into confidence for the budget.

It was decided that the PSDP for the four provinces would be decided together," he said while speaking to the media.—RT/Agency



Anchorperson Imran Riaz Handed Over To Police In Fraud Case

LAHORE: A Lahore district court on Wednesday remanded anchorperson Imran Riaz, who was arrested last night, in police custody for one day in a fraud case.

Riaz was taken into custody at the Allama Iqbal International Airport late Tuesday night while he was departing for Saudi Arabia for Haj. The visuals of the arrest, which showed the journalist clad in an ihram, went viral on social media.

He was later presented before Judicial Magistrate Muhammad Kamran Zafar of the Nishtar Town police. According to the first information report (FIR), a copy of which is available with Dawn.com, Riaz has been accused of abuse of trust. It invoked Section 406 (Punishment for criminal breach of trust) of the Pakistan Penal Code.

During the hearing today, the police sought seven-day physical remand of Riaz. The prosecutor stated that the anchorperson had borrowed Rs0.25 billion from the complainant but he never returned the money.

Meanwhile, Riaz's lawyer, Mian Ashfaq, alleged that the case against his client was fake. "The complainant was an agent at Maryam Nawaz's polling station," he contended.

After hearing the arguments from both sides, the judge reserved the verdict. "I judge arrested," he said. Later, he granted police



one-day physical remand of Riaz.

Earlier in the day, Riaz's lawyer Azhar Siddique filed a petition in the Lahore High Court (LHC) seeking details of the first information report (FIR) under which the anchorperson was arrested.

The petition, a copy of which is available with media, stated that Riaz was to depart for Saudi Arabia for Haj from Lahore when "many civil-dresses officers from various authorities came and arrested him without providing any details" and "took him to an undisclosed location."

"No information has surfaced as to which FIR was used in order to apprehend the Applicant on the eve of 11.06.2024, therefore, it is the need of the day that the respondents be summoned by this court and they inform this court as to which FIRs have now been registered, of course, frivolously, against the applicant due to which he was being kept under "illegal and unlawful" detention.—RT/Agency

name was removed from the Exit Control List on June 11.

The plea prayed that the petition be accepted and the police, Federal Investigation Agency (FIA), Interior secretary and the Anti-Corruption Establishment be directed to place on record details of the FIR under which the anchorperson was arrested.

Separately, Riaz's brother filed another petition in the LHC demanding that the anchorperson be immediately released from "illegal and improper custody" and be produced in court. It has been fixed for hearing before Justice Amjad Rafique.

The plea, seen by media, named the Punjab inspector general, Lahore capital city police officer, Cantt superintendent of police, FIA director and cyber crime wing director as respondents in the case. It stated that Riaz was "unlawfully and illegally" stopped from travelling abroad and was being kept under "illegal and unlawful" detention.—RT/Agency

Pakistan Unable To Purchase Spot LNG Despite Summer Heat

ISLAMABAD: Pakistan is unlikely to buy liquefied natural gas (LNG) cargoes on the spot market until at least the beginning of winter in November due to oversupply and high prices, Petroleum Minister Musadik Malik told Reuters.

Extreme temperatures across Asia have pushed countries to seek more cargoes of LNG to address higher power demand, driving spot prices to their highest since mid-December. Asia spot LNG last traded at \$12.00 per million British thermal units (mmBtu) on Friday.

However, LNG demand in the second largest south Asian LNG buyer was "subordinate to supplies," the minister told Reuters, despite heatwaves baking the country of 300 million people with temperatures surging to a near-record.

"The question of getting more LNG when we can't sell the amount of LNG that we already are obtaining from our long-term contracts, it does not apply," Malik told Reuters in an interview.

Annual power use in Pakistan, which gets over a third of its electricity from natural gas, is expected to fall consecutively for the first time in 16 years, due to higher tariffs curbing household consumption.



Poor and middle class households are still feeling the impact of the International Monetary Fund's (IMF) bailout of Pakistan last year, which contributed to higher retail prices. A series of power tariff hikes over 12 months was a key part of the IMF programme which ended in April.

Industrial demand has also remained tepid due to a cloudy economic outlook.

Pakistan, which last bought a spot LNG cargo in late 2023, cancelled its spot LNG tender for delivery in January. Malik attributed the cancellation to oversupply, adding that there were "not a lot of customers" at current LNG spot prices.

Malik said Pakistan is expected to adopt more renewable energy to cut its import bill and expensive due to geopolitical shocks. The country suffered widespread power

Recommendation Made For Closure And Merger Of Government Departments

ISLAMABAD: A high-powered committee, constituted by the Prime Minister for submitting recommendations to curtail government expenditures and cut government's size, has recommended closing, merger or handing over some government departments to the provinces.

It was informed at a high level meeting of the committee held in Islamabad today with Prime Minister Shehbaz Sharif in the chair.

The committee headed by Deputy Chairman of Planning Commission and comprising Federal Cabinet, Establishment and Power Secretaries, Dr Qaiser Bangali, Dr Farrukh Saleem and Muhammad Naveed Iftikhar, presented the report to the Prime Minister in the meeting.

The committee presented short and medium-term recommendations containing introducing a contributory pension mechanism for newly-appointed employees, and abolishing vacancies lying vacant for over a year.

The committee suggested to engage private sector for service delivery in the government departments, besides banning unnecessary travels of government officials to cut expenditures by promoting teleconferencing.

The committee also recommended withdrawal of official vehicles from the officers availing the monetization facility.

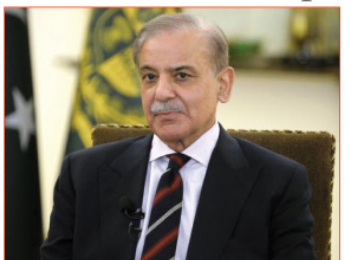
