FBR Chief Announces Electricity and Gas Cutoff for Non-Filers

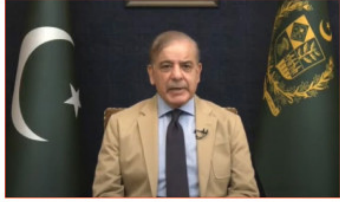
ISLAMABAD: As Pakistan eyes boosting its tax revenues in budget 2024-25, the Federal Board of Revenue (FBR) chief has said that electricity and gas connections of the non-filers will be suspended along with SIMs. In a latest development, the Senate's Standing Committee on Finance and Revenue on Saturday okayed the proposal to impose a foreign travel ban on non-filers. A series of decisions were made in today's session of the Senate body held under the chair of Saleem Mandviwalla. FBR Chairman Zubair Tiwana informed the upper house body that those who failed to file tax returns would face actions under the Income Tax General Order (ITGO), however, exemptions would be given to non-filers. He added that the non-filer list included 500,000 people with over 2 million in annual income. He added that the listed individuals had already disclosed their income statements with their tax return documents in the past. The FBR's top officer said that temporary filers will also have to pay additional tax during the purchases of vehicles, plots and residences. Additionally, the Senate body also approved a proposal to reduce the salary slab and hike tax besides, approving the imposition of a



75% withholding tax on cellular and internet bills of non-filers. Earlier this week, Finance Minister Muhammad Aurangzeb emphasised the need for widening the tax net, saying that the country cannot run with a 9.5% tax-to-GDP ratio. "We have to bring everyone into the tax net. We are aiming to bring everyone on the active taxpayers' list," said the finance czar while speaking on Geo News programme Aaj Shahzeb Khanzada Kay Sath on Wednesday. "We have to abolish the non-filer category in the country," he added. His statement comes hours after he unveiled the federal budget for the fiscal year 2024-25 in the National Assembly, with a total outlay of Rs18.9 trillion.—RT/Agency

Shehbaz Vows No More IMF Deals For Pakistan

ISLAMABAD: Prime Minister Shehbaz Sharif on Saturday said that government departments and institutions incurring billions in losses to the nation and the exchequer would be shut down once a committee finished its review of the matter. In an address to the nation today, the prime minister said it was the first duty of the government to reduce lavish expenses and close departments and ministries not related to public service such as the Pakistan Public Works Department, saying it was included among those institutions that were infamous for corruption. He said a ministerial committee was made to deliberate on the issue of such redundant ministries and departments, saying he would bring positive results in the next two months and all such departments which had become a burden on the country and its people would be shut down. "I think this is a step that will save billions," he said. He further said that the government had decided that all those organisations and institutions which were becoming a basis for losses worth billions to the country would be privatised and those amounts recouped. The premier said the government had decided to save expenses wherever possible and adopt austerity. PM Shehbaz said the government



would no longer set up businesses of its own but would promote the private sector and private investment. The premier recounted how the coalition government of the Pakistan Democratic Movement had taken the reins of power in April 2022 and saved the country from default. He credited the leaders of the coalition and its allies for the achievement, mentioning Jamiat Ulema-Islam-Fazl chief Fazur Rehman as well. "Today, Pakistan is steadily getting out of economic difficulties and moving towards the path of development and prosperity," he said. He said the journey ahead was not only difficult and long but also demanded "sacrifice" from the elites and government functionaries. "The whole nation's gaze is focused on the government and how we will bring a revolution of prosperity in the country by ending its economic troubles." PM Shehbaz said since the PML-N had assumed

control of the government again after the February 8 elections and he was re-elected as the premier, inflation had dropped to 12 per cent due to the government's efforts, terming it a "positive change". Similarly, he said the interest rate was slashed to 20pc from 22pc and this would promote investment in the country and reduce the burden of loan interest on the country. Shehbaz said 100 days had passed of the incumbent government and pointed out Friday's slashes in the prices of petroleum products, saying it would afford "some relief" to the people from inflation. "This I think is not enough," he said, adding that there were great expectations of further relief for the people from the current economic indicators so far. He said the government would strive to further reduce inflation, promote business and investment and provide education to the country's youth. "I think crying over the past will achieve nothing but we should learn a lesson from its mistakes about what we lost in the past and how we will restore Pakistan its lost status by making up for those mistakes." He said if the whole nation decided to bury personal ego and interest in pursuit of serving the poor then "I can assure you very soon that stage will come of which Quaid-i-Azam and all those who migrated during partition dreamt of." Mentioning his recent trips to the Middle East and China, he said commitments for investment were secured and the government had devised a road map to benefit from and implement the agreements. The premier said the environment also needed to be made conducive for domestic investment before any foreign investment. The prime minister vowed that once the nation strictly followed through on a likely upcoming programme with the International Monetary Fund and the government achieved its targets, then the upcoming programme would hopefully be the last one in the country's history. "We will then stand on our own feet and leave our neighbours behind in the race towards progress." PM Shehbaz said 300,000 Pakistani students would be trained by China in information technology every year and the sector would be further promoted in the country. Explaining the decision to make the industrial and export sectors competitive, he said electricity prices were reduced for the sectors in a "historic step and quantum jump" that will reduce the burden of Rs200 billion on them. He said another testament to the government's recently unveiled federal budget was the rise in the Pakistan Stock Exchange to 77,000 points, an all-time high. "This means business and trader groups have endorsed the budget," he added. PM Shehbaz said the government had decided to further promote the agriculture sector and "establish new records" for IT exports. The prime minister said it would not be an "easy path" and recounted the past, saying that whenever the country was progressing forward, setbacks occurred to derail the momentum. He said the enemy of the country's progress was "every terrorist who spreads chaos and is busy in running off investment from the country", along with smugglers, power utility thieves, profiteers, hoarders, tax evaders, inefficient state departments, lazy state employees, those who abused martyrs and those who spread political instability.—RT/Agency

Shehbaz Vows Zero Tolerance for Delays in Reforms

ISLAMABAD: Prime Minister (PM) Shehbaz Sharif on Saturday issued directives to all federal ministries to fully cooperate with the reforms agenda, warning that any laxity in implementation will not be tolerated. He was chairing an important meeting to discuss departmental strategic reforms in the federal government. The prime minister emphasised that the government's reform agenda focused on improving governance and providing better services to the people. The meeting was briefed on the Strategic Reforms Roadmap, and it was announced that a Task Management System was being introduced, which was in its final stages. Experts would be hired to



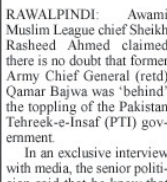

PTI Must Choose Democracy or Chaos, Warns Ahsan



ISLAMABAD: Federal Minister Ahsan Iqbal on Saturday said that a handful of people won't be allowed to keep the future of 240 million people at stake, media reported. Pakistan's Planning and Development minister said that the PTI will be dealt with iron hands if it will try to derail the country with its negative politics. "The PTI has to decide if it wants the politics of chaos or it opts for a positive pro-democracy politics," he said. "If you have any pain from the system, you should resign and get out of the system," Ahsan Iqbal addressing the PTI said. Replying to a question about the People's Party he said, "They are our allies, and we are not at war with them. Small quarrels will be part of an alliance," he added.—RT/Agency

Sheikh Rasheed Blames Bajwa For PTI Government's Fall



RAWALPINDI: Awami Muslim League chief Sheikh Rasheed Ahmed claimed there is no doubt that former Army Chief General (ret'd) Qamar Bajwa was 'behind' the toppling of the Pakistan Tehreek-e-Insaf (PTI) government. In an exclusive interview with media, the senior politician said that he knew that the Imran Khan-led PTI government was bound to be toppled. "The Muttahida Qaumi Movement-Pakistan had informed (to vote against) Imran Khan in the no-confidence motion me," Sheikh Rasheed Ahmed added. "I told Imran Khan that the MQM-P made it clear that the government is bound to be toppled as signalled by the real forces," he added. The host asked as if General Bajwa was involved in toppling the PTI government. "There is no doubt about it,"



the former interior minister replied. "No one has entered in politics of Pakistan, including me, without (backing) of the Gate No. 4," he claimed. Sheikh Rasheed Ahmed said that he does not see dialogue between the PTI and the government. "I am not seeing successful dialogue and neither hopeful for it," former federal minister said in his exclusive interview. "Initially they were not holding talks, now they will not accept the conditions set for signing. Nawaz Sharif has been better than Shehbaz and 'less corrupt'." "Shehbaz has only been in good books and could not aspire for it"—RT/Agency

Saudi Imam Urges Unity and Helpfulness In Hajj Sermon

MAKKAH: Sheikh Maher Al-Muaiqly, an imam of the Grand Mosque in Makkah, Saturday stressed cooperation and creating a spirit of helping each other in the annual Hajj sermon delivered at the Masjid-e-Nimrah. In the sermon, the imam urged pilgrims to pray to Allah for themselves, for their parents, and those related to them. "Whoever supplicates for his brother in the back of the unseen, the angel entrusted to him will say to him, Ameen, and the same for you." The Saudi imam emphasised the significance of the Sharia in leading one's way of life to help flourish and achieve development. "It prevents harming others or harming them. It enjoins justice, virtuous morals, honouring one's parents, maintaining ties of kinship, telling the truth, preserving rights while delivering them to their rightful owners, performing trusts, and fulfilling contracts," he said.



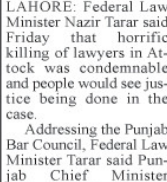

Sources revealed that the mission's YouTube channel was also compromised, with its name, banners, and content altered. The attack took place on June 14 at 4 pm according to US time. The Pakistani mission has requested that all emails and videos be ignored until they regain control of their accounts. 15 injured in Pithoro road mishap

PITHORO: On the Mirpurkhas-Umerkot Road a coaster with registration number R 0934, lost control due to brake failure and as a result it overturned with passengers on board. Fifteen people were severely injured, and three injured were in critical condition and were transferred to the Hyderabad River for treatment. Deputy Commissioner of Umerkot, Naveed Rehman Lashari and DSP Amjad Qaimkhani received information about the accident. The DC Umerkot directed immediate medical assistance and transportation of the injured to hospitals and BHUs in the area. Local ambulances and Rescue 1122 ambulances were used to transfer the injured to hospitals in Pithoro. However, due to the late arrival of the ambulance from the hospital in Pithoro, some delay occurred. Eventually, 30 people were riding in the coaster, out of which 15 were injured. Those injured in critical condition were transferred to the Hyderabad. Among the injured were Azizullah Samo, a resident of Chhachhro, Sajjan Nohri, Muhammad Rahim, Muhammad Shahid, Ghulam Mustafa and others.

Murad Orders For Cleanup Efforts Ahead Of Eid ul Azha And Monsoon Season

KARACHI: Sindh Chief Minister Syed Murad Ali Shah has instructed local bodies, the Solid Waste Management Board (SSWMB), and other relevant authorities to ensure Karachi remains clean during Eid ul Azha. Additionally, he emphasized the need to desilt stormwater drains ahead of the monsoon season.



Chief Minister Shah directed the SSWMB to lift 154,482 tons of offal and garbage expected during Eid ul Azha. To manage this, 99 collection points have been set up across 246 union committees in Karachi. The SSWMB has initiated training sessions for staff and established complaint cells in Karachi, Hyderabad, Sukkur, and Larkana.

Murad Ali Shah highlighted the need for proactive measures to handle potential flash and urban flooding, with monsoon rains expected to start around June 28-29. Commissioner Karachi Hassan Naqvi reported 310 choking points and 207 low-lying areas across the city.

Mayor Karachi Murtaza Wahab has enforced a contingency plan, fixing choking points in 45 nullahs and starting desilting operations. Dewatering machines are ready to be deployed in low-lying areas in case of heavy downpours. The Chief Minister called for close coordination between SSWMB, KMC, the water board, city towns, cantonments, and PDMA to implement contingency plans effectively.—RT/Agency

ASI of Elite Force Shoots Two Lawyers in Attock Due to Personal Dispute



ATTOCK: An Elite Force officer was arrested on Saturday for allegedly killing two lawyers, including former district bar president, over personal enmity in Punjab's Attock district, media reported citing police.

Police said that the arrested suspect, Intizar Shah—who is an assistant sub-inspector (ASI) of the Elite Force—was shifted to Attock City Police Station.

The slain lawyers were identified as former Attock Bar President Israr Ahmed and Advocate Mirza Zulfiqar, who were shot dead by the cop in their chamber, sources affiliated with the police said.

The bodies of the slain lawyers were shifted to District Headquarter Hospital, Attock and later sent to their hometown after post-mortem.

Reacting to the gruesome murders, Law Minister Azam Nazeer Tarar expressed deep grief over the lawyers' deaths and offered condolences to their families.

The minister directed Punjab inspector general of police (IGP) to initiate investigation into the matter immediately and assured the bereaved families of taking the case to a special court.

He said that a probe team was formed to investigate the dual murder. Addressing a ceremony at Punjab Bar Council, Tarar said that Punjab Chief Minister Maryam Nawaz spoke to the police chief soon after the reports of murder. He quoted Maryam as saying that "government was responsible for ensuring the security of lawyers".—RT/Agency

KCCI Appreciates PM For Reducing Electricity Tariff For Industrial Sector

KARACHI: President of the Karachi Chamber of Commerce & Industry (KCCI), Ifkhar Ahmed Sheikh, has expressed gratitude to Prime Minister Shehbaz Sharif for fulfilling his promise of rationalizing electricity rates by reducing the tariff by Rs10.60 per unit for the industrial sector.

In a statement issued, KCCI President stated that the entire business community, particularly Small & Medium Enterprises (SMEs), were very grateful as they were struggling to survive due to exorbitantly high electricity rates. The reduction in rates will provide significant relief.

"We are hopeful that similarly, gas prices will also be brought down to regionally competitive levels as promised by the Prime Minister," he said. He added that energy tariffs need to be reduced to regionally competitive levels to lower the cost of doing business and manufacturing to international standards. President KCCI extended full support and cooperation to the government for its future endeavors to promote industrialization and exports while once again thanking the Prime Minister for making the right decision.

However, he also called on the Prime Minister to address the issue of K-Electric's significant increase in fixed charges, which have risen by 300 percent from Rs460 to Rs2,000. This, he noted, requires government intervention, otherwise, the relief provided by the federation would be undermined.—RT/Agency

MQM-P Criticizes Sindh Budget for Neglecting Urban Areas



KARACHI: The Muttahida Qaumi Movement-Pakistan (MQM-P) termed the Sindh budget 'anti-urban areas', expressing concerns over 'ignoring' urban parts of the province particularly Karachi, media reported. The MQM-P held a meeting presided over by Chairman Dr Khalid Maqbool Siddiqui to discuss federal and Sindh budgets. The party spokesman in a statement said that Karachi contributes 97 percent of Sindh's revenue yet it was deprived of major development projects.

The MQM-P also expressed concerns over the federal budget despite being the coalition partner in the centre, maintaining that the tax burden on the salaried class was increased. The party maintained that the increase in income tax on the salaried class would disproportionately affect the middle and lower classes. "Raising taxes on the salaried class is tantamount to providing protection to the country's big landlords, capitalists and Waderas," the spokesman added.

The spokesman said that the party also discussed the political situation in detail while expressing deep concern over the political scenario of the country. Dr. Khalid Maqbool Siddiqui formed a four-member committee that will approach political parties and hold meetings with them. The committee included Syed Mustafa Kamal, Dr. Farooq Sattar, Syed Aminal Haq and Faisal Sabzwari.—RT/Agency

Maryam Boosts Lawyers' Welfare Grant to Rs1 Billion

LAHORE: Punjab Chief Minister Maryam Nawaz on Saturday increased the grant meant for the lawyers' welfare to Rs1 billion and also announced establishing a hall and daycare centre for the female members of the community at Punjab Bar Council's premises.

Sindh Government Tapping Renewable Resources To Reduce Power Tariff: Murad

KARACHI: Sindh Chief Minister Syed Murad Ali Shah has announced that his government is committed to rapidly tapping into renewable resources to reduce the overall tariff set by the National Electric Power Regulatory Authority (NEPRA). This initiative aims to make electricity more affordable for the general public.



"Apart from reducing tariffs, renewable energy will also help achieve the Sustainable Development Goals (SDGs) by creating a clean, reliable, and sustainable environment," he stated. The announcement was made during a meeting held before the signing ceremony of a Memorandum of Understanding (MOU) between the Sindh Transmission & Dispatch Company (STDC) and private partner Gul Ahmed Group. The agreement involves laying a 60 km transmission line from Jhimpir to Landhi, where Gul Ahmed Group is setting up a 100 MW wind power plant in Jhimpir.

Energy Minister Nasir Shah briefed the Chief Minister that Gul Ahmed Group had approached STDC for constructing a 132kV transmission line from their wind power plant in Jhimpir to their facility in Landhi. The Sindh Government has allocated 524 and 558 acres of land in the Jhimpir wind corridor for this purpose. The STDC will lay a 60 km transmission line from Jhimpir, Thatta, to the Landhi area of Karachi to transmit the 100 MW of wind power. This business-to-business (B2B) project is expected to be completed by the end of 2027. Minister Nasir Shah emphasized that these environmentally friendly projects would promote green energy in the province, provide cheaper electricity sources, and boost the economy by creating jobs in Sindh. Sindh Chief Minister Syed Murad Ali Shah, along with provincial ministers Sharjeel Memon, Nasir Shah, Zulfiqar Shah, Dost Rahimoo, and others, witnessed the signing ceremony between STDC and Gul Ahmed Group at the CM House. Director General of STDC Saeed Shaikh and Gul Ahmed Group representatives Zain Bashir and Ziad Bashir signed the MOU.—RT/Agency

-Can you believe this? Unscrupulous Karachi Trader Arrested For Selling Sacrificial Goat With Plastic Teeth

KARACHI: Police in Karachi arrested a trader on Saturday for allegedly selling sacrificial goats fitted with plastic teeth in the Gulberg Chowringhi area, according to media reports.

A viral video circulating on social media showed a customer removing what appeared to be plastic teeth from one of the goats, prompting swift action from authorities. The trader was apprehended, and police seized seven other goats as evidence.

Authorities clarified that they acted upon receiving information about the sale of goats with artificial teeth as depicted in the viral video. During interrogation, the detained trader, hailing from Hyderabad, stated that he had come to Karachi to sell his animals for Eidul Adha. Police have initiated further investigation into the matter.—RT/Agency

LHC Suspends SP and ASP for Failure to Recover Shehbaz Gill's Brother

LAHORE: The Lahore High Court (LHC) has ordered to suspend the Superintendent of Police (SP) and Assistant Superintendent of Police (ASP) for failing to recover Pakistan Tehreek-e-Insaf (PTI) leader Shehbaz Gill's abducted brother. The LHC's Justice Amjad Rafiq has issued the two-page written verdict of the case against non-recovery of Shehbaz Gill's brother Ghulam Shabbir.



As per written verdict, the court issued the orders of kidnapped person recovery on June 10 and directed inpector general (IG) to appoint senior officer for the recovery of abducted, Ghulam Shabbir.

Meanwhile, ASP couldn't satisfy the court on the recovery of kidnapped person case. The court's order stated that SP requested petitioner's assistance for the recovery of kidnapped person and then police will take action.

The court ordered to appoint senior officer for tracing and monitoring of the abducted person case.

The LHC's written judgement mentioned to trace and recover missing person through geo-fencing, CCTV, safety city, motorway and media sources.

The court has ordered to use modern tools from home to Faisalabad and Islamabad for tracing of abducted person.—RT/Agency

Arrangements Finalized For Disposal Of Sacrificial Animal Offal

KARACHI: Commissioner Karachi Syed Hassan Naqvi chaired a revenue meeting to finalize arrangements for the collection and disposal of sacrificial animal offal during Eid ul-Azha.

SSWMB Resources: Vehicles, staff, and other resources have been allocated to all towns. Monitoring: Deputy Commissioners will oversee the collection work in coordination with SWMB and municipal administrations.

Contingency Plans: Include detailed information such as vehicle numbers, driver names, and contact details. Deputy Commissioners assured full support to ensure efficient offal disposal.—RT/Agency

Eid-ul-Azha 2024: Over 12,000 Police Officers Deployed Across Karachi

KARACHI: As Eid-ul-Azha approaches, approximately 12,781 police officers have been deployed across Karachi to ensure security during prayers and festivities, according to media reports.

A Karachi Police spokesman announced on Saturday that under the directives of Additional IGP Karachi Imran Yaqoob Minhas, the deployment includes 5,600 officers and personnel in the East Zone, 3,656 in the South Zone, and 3,525 in the West Zone. An additional 2,170 officers and personnel will oversee security at collection points for sacrificial animals.

Security measures have been intensified at major shopping centers, markets, and other crowded locations, with traffic police instructed to maintain smooth traffic flow throughout the city during Eid-ul-Azha. Pakistan will celebrate Eidul Adha on June 17 following the sighting of the Zil Hujj moon on June 7. Eidul Adha, known as the Feast of Sacrifice, commemorates Prophet Ibrahim's willingness to sacrifice his son to God. It is marked by the slaughter of animals, with the meat shared among family members and the less fortunate.

The faithful continue the tradition of sacrificing animals over the three days of Eid in remembrance of Prophet Ibrahim's act of obedience and devotion.—RT/Agency

13 Special Prosecutors Reassigned in Punjab for May 9 Cases

These prosecutors will now represent the state in court for the May 9 cases, ensuring legal proceedings are conducted efficiently and effectively.

Derailing democracy

The recent revelations by Sheikh Rashid Ahmed about former Chief of Army Staff General (Retired) Qamar Bajwa's alleged role in toppling the elected government of former Prime Minister Imran Khan are deeply concerning. According to Rashid, General Bajwa orchestrated the fall of the Pakistan Tehreek-e-Insaf (PTI) government, a claim that echoes the sentiments of many Pakistanis who fear speaking out.

At the time of the government's ousting, Pakistan was witnessing significant economic growth, with a GDP growth rate exceeding six percent and rising foreign exchange reserves. The country was on the brink of an economic transformation, driven by strategic reforms and poli-

In a blow to Babar Azam, PCB decides to retain Shan Masood as red-ball captain



LAHORE: Pakistan's wretched performance in T20 World Cup 2024 has ostensibly put Babar Azam's captaincy prospect in peril as the Pakistan Cricket Board (PCB) has "decided against appointing him" as skipper in the red-ball cricket.

Sources told media that Babar Azam will continue to hold the team's reins for the two-match Test series against Bangladesh in August, as the board management is disappointed of Babar's ability to lead, following the T20 World Cup debacle.

Former Australian player Jason Gillespie will be Pakistan's head coach during the Bangladesh encounter in his first assignment.

Babar was appointed as the white-ball captain in 2019 and as Test skipper in 2020. Under leadership of

the 29-year-old batter, the Green Shirts have not won any ICC or Asia Cup title so far.

Following this and the team's drubbing in the ICC ODI World Cup 2023, the PCB under Zaka Ashraf appointed Shaheen Shah Afridi as white-ball captain.

Nevertheless, the stint lasted for a brief period as PCB chief Mohsin Naqvi, after taking charge of his office, reinstated Babar as the white-ball skipper on March 31. However, he did not announce his decision about the red-ball format.

On the other hand, Masood was given the Test format captaincy by the previous management. It was believed that Babar could again get back his Test captaincy but the team's recent performances have dashed all the hopes in this regard.—Agency

T20 World Cup 2024: PCB bosses mull 'major surgery' in late night huddle

LAHORE: The Pakistan Cricket Board (PCB) has decided to review central contracts after the team's embarrassing early exit from the ongoing T20 World Cup 2024, sources told media on Saturday.

Following the late-night consultations headed by PCB Chairman Mohsin Naqvi and the board officials, as per the sources, players with poor performances are expected to be demoted with regards to their central contracts in the first phase.

Meanwhile, several others are likely to lose their central contracts altogether, the sources added.

The development comes as the Green Shirts have been eliminated from the ongoing mega event and failed to even proceed to the Super Eight stage of the tournament after losing their two initial matches against the new entrants USA and arch-rivals India.

With the match between



the US and Ireland abandoned due to rain on Friday, the co-hosts secured one point, consequently ending Pakistan's hopes of proceeding in the tournament.

The national team's last league game against Ireland will only be a formality after which the squad will return home.

This is the third time in the tournament's history that Pakistan has been eliminated in the league round.

Earlier, media had reported that the board is likely to make significant changes in the team with players including Mohammad Amir, Imad Wasim, Ifikhar Ahmed, Azam Khan, and Usman Khan expected to face difficulties in maintaining their place in the national side's future.

The sources also said that a group of three players in the Pakistan team were blacklisting PCB officials at the behest of the players' manager, who represents all three players and had pressured the board to secure a significant remuneration increase in the players' central contracts.

PCB chief, earlier this

week, also hinted at major changes in the national team and said: "It seemed that a minor surgery would work but after this bad performance, I'm now sure that a major surgery is required. The nation will soon see a major overhaul." It is to be noted that the players had pressurised former PCB Chairman Zaka Ashraf to secure a three-year central contract last year, which came into effect from July 1, provisioning increased remunerations.

Since then, the Men in Green have appeared and failed in multiple international tournaments including the Asia Cup 2023, ODI World Cup 2023 and the ongoing T20 World Cup 2024.

Furthermore, the national side also failed in the tours of Australia and New Zealand.

However, the board will now decide on the prospects of keeping the current remuneration packages of the players.—Agency

'Babar Azam should have supported Shaheen,' says Boom Boom



KARACHI: Following the Pakistan team's early exit from the ongoing T20 World Cup 2024, former skipper and all-rounder Shahid Afridi has opened up on the national side's captaincy saga, saying that Babar Azam should've backed Shaheen Afridi on the said issue.

Speaking on the issue of changes in the team's captaincy on his YouTube channel, Afridi said: "If the decision on Shaheen's captaincy had been made and you [Pakistan Cricket Board (PCB)] had stated that he would remain the captain till the [T20] World Cup, then I think Babar [Azam] should have supported Shaheen." The veteran cricketer's remarks come after heavy criticism of Babar Azam's captaincy under which Pakistan lost major cricket competitions Ex-PCB chief Zaka Ashraf had appointed Shaheen as white-

T20 World Cup: Azhar Ali reacts to Pakistan's embarrassing World Cup exit

LAHORE: Former Pakistan captain Azhar Ali has opened up on the mindset of the Men in Green after they couldn't qualify for the Super 8 of the T20 World Cup 2024.

"Very disappointed. It is what they call 'writing on the wall'. We lost the first two games and then when you depend on the weather and other teams the same thing does not repeat itself again and again. You just can't move forward in events based on luck," the former captain stated on a local sports channel.

"We are very complacent. We lose games in easy situations. We need to put on our A game all the time, especially against teams you can easily win. The matches that you are expected to win you should win them and dominate in them. I think we are complacent and irresponsible in this matter," he added.

Pakistan only managed to win one of their three group games against Canada and a relatively inexperienced team from the USA. Then the team depended on the result of their remaining match against Ireland which is to be played on Sunday in Florida and the results of USA vs Ireland. Pakistan required the USA to defeat Ireland and



defeat Ireland by a margin to earn their place in the Super 8. However, the match between USA and Ireland was called off due to excessive rain in Florida ending Pakistan's hopes to qualify for the Super 8s.

"This is very sorrowful for me that the Pakistan team could not qualify for the Super 8 from this pool of teams. India was the only strong team (in the pool) but we had the USA match in our hands, the conditions were in our favour and it was not like we lost early wickets or lost the toss that is why we lost the match. There was nothing like this in the match. We lost it because of game awareness and the selection policies," the former captain stated. Azhar also fumed about the head coach coming in just days before the T20 World Cup and said that the team can not always perform in unsettling situations.—Agency

he's not up there with, I would say, the top 15 batters in the world in T20 cricket. I think there are better players at the top of the order who could play fearless cricket and whack it 360 degrees,"

the media after the match against Uganda. He also addressed his long partnership with Tim Southee, with whom he played in some of the tournaments like ODI World Cup 2015 and 2019 where New Zealand lost to Australia and England in the final respectively and others.

Boult felt that there would be some opportunities to bowl with Southee, indicating to the 2025 Champions Trophy as he has not retired from ODIs so far.—Agency

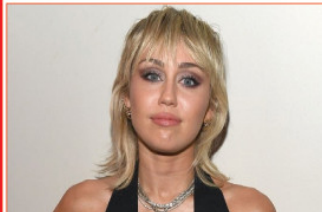

No Attempt Made To Pressurize Sindh Judiciary: SHC CJ

KARACHI: Commenting on alleged "interference and pressure" on the judiciary, Sindh High Court (SHC) Chief Justice Aqeel Ahmed Abbasi on Saturday "categorically" stated that nobody pressurized him about any case.

"Some attempts were made, but, by the grace of God, no one coerced me," said the SHC chief justice while talking to the media in Karachi. He said this in response to a question posed by a journalist to him.

The chief justice's comments came after six Islamabad High Court (IHC) judges in the recent past wrote a letter to the Supreme Court on March 25, accusing spy agencies of meddling in judicial affairs.

The IHC judges had demanded Chief Justice of Pakistan Qazi Faiz Isa to convene the judicial convention to consider the matter of alleged interference of intelligence operatives in the judicial functions or "intimidation" of judges in a manner that undermined the independence of the judiciary.

However, Justice Abbasi



clarified that a couple of times such efforts were made which were right away dispelled and later they turned out to be a misunderstanding. He said no attempt had been made to pressurize the Sindh's judiciary in any case.

He said the judiciary's independence was reflected through its judgments. He believed that a judge could not be dishonest or corrupt, he said.

The SHC CJ said the transfer of the election tribunal's judge was a normal procedure. The system of judges' transfer was extremely complex, he said.

The SHC CJ statement comes a day after Lahore High Court (LHC) Chief Justice Malik Shehzad Ahmed Khan said he believed that

interference of the establishment in the matters of the judiciary will end soon.

"Interference in the judiciary will have to be fought with faith that it will come to an end," said the LHC chief justice while addressing the opening ceremony of the judicial complex in Rawalpindi.

Justice Khan said there was an issue of establishment's interference in the judiciary's matters, adding that they receive letters claiming involvement in the judicial affairs. "The establishment's interference in judiciary will end and my experience [tells me] that it will come to an end," said the judge, assuring that these difficulties will end if there is fear of God.—RT/Agency

-Can you believe this? Five Arrested For Chopping Off Camel's Leg In Sanghar



KARACHI/SANGHAR: Sindh Senior Minister Sharjeel Inam Memon announced on Saturday that a case had been registered and five individuals arrested for cutting off the leg of a camel in the Sanghar district, according to media reports.

In a statement, Minister Memon said that Sindh Chief Minister Syed Murad Ali Shah had taken notice of the incident. Despite the matter being settled between the accused and the camel's owner, the act was deemed inhumanly unacceptable, prompting the state to register a case.

The incident occurred in Mund Jamrao village in Sanghar district on Friday, where a landlor allegedly chopped off the camel's leg as punishment for scavenging in his field for fodder.

Soomer Khan, the camel's owner, recounted the incident at Sanghar Press Club, expressing confusion and distress. "I have no enmity with anyone. I don't know why this was done to my camel," he said. Sanghar SSP took notice of the incident after a video of the camel with its leg chopped off went viral on social media. Police officials stated that the peasant refused to identify the culprit and press charges, leading to the police lodging an FIR on behalf of the state against unknown persons under sections 429 and 34 of the PPC.—RT/Agency

Contempt Plea Filed Against Mayor Karachi For Municipal Tax Collection

KARACHI: The Jamaat-e-Islami (JI) has lodged a contempt of court petition against Mayor Karachi Barrister Murtaza Wahab, accusing him of breaching directives from the Sindh High Court (SHC) by implementing municipal taxes via electricity bills, according to media reports.

Saifuddin, the leader of the opposition in the City Council from JI, asserted in the petition that Mayor Wahab violated court orders and bypassed legal

Charges and Taxes (MUCT) on consumers using less than 300 units per month. "The Mayor Karachi had submitted an affidavit promising to form a committee for consultation with the opposition prior to city council approval," added the petitioner. The JI informed the SHC that Barrister Murtaza Wahab introduced a resolution to levy municipal taxes without adhering to proper protocols, thereby allegedly flouting the court's instructions.—RT/Agency

CJP Isa Affirms Imran's Audio Not Leaked from Supreme Court

ISLAMABAD: After quizzing the Supreme Court staff, Chief Justice Qazi Faez Isa has said that the audio conversation allegedly featuring Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan and judges was not leaked from the apex court, media reported Saturday.



The top judge said he had inquired the IT staff who apprised that there were some voices in the audio which did not belong to the top court.

The conversation between the PTI founder and judges during second hearing of a case pertaining to the National Accountability Bureau (NAB) amendment was widely shared on social media platforms. Nevertheless, Justice Athar Minallah, asked what the issue was even if the audio was leaked as the dialogues were made during an open court.

It should be noted that during the first hearing of the NAB amendment case, a picture of Imran from Courtroom No 1 was leaked, as the former prime minister appeared in the court via a video link from Adiala Jail. The image quickly went viral on social media.

The court has issued directives to shift Shah Mahmood to jail on judicial remand by instructing challan submission of registered cases in Lahore.—RT/Agency
