Imran And Bushra Bibi's Pleas For Suspension Of Sentence In Iddat Case Rejected

ISLAMABAD: A district and sessions court in Islamabad Thursday rejected the pleas seeking suspension of the sentences handed down to Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan and his wife Bushra Bibi in the iddat case.



The verdict drew strong condemnation from the PTI, which called it "absolutely ridiculous", and its leaders — who were hoping for Imran's release today — staged a protest outside the Adiala jail, where the court had been set up to ensure the security of the ex-prime minister.

Additional Sessions Judge Afzal Majoka announced the verdict today, reserved on Tuesday, after the hearing on the main plea related to the annulment of their conviction set to take place on July 2.

The PTI founder and Bushra were each sentenced to seven years in prison in February earlier this year after a trial court found their nikah to be fraudulent as Khawar Maneka, Bushra's ex-husband, moved the court against the couple's marriage.

In the 10-page order, the court mentioned that there was no reason to suspend the sentence.

"...[there is] no ground

for suspension of [the] sentence is available to both the petitioners. Accordingly, both the petitions under section 426 Cr.PC are dismissed," it said.

In response to the verdict issued by the lower court, PTI Secretary General Omar Ayub Khan said: "[We] will challenge the verdict in the high court immediately."

Following the announcement, PTI workers began protesting outside the district and sessions court and also blocked the road. The protesters include women, who chanted slogans in favour of the PTI founder.

Meanwhile, heavy police deployment was also present outside the court.

Khan, the deposed prime minister who was ousted from power via the opposition's no-confidence motion in April 2022, has been facing a slew of

charges ranging from corruption to terrorism since his removal as the premier. He has been behind bars since August last year after he was sentenced in the Toshakhana case and subsequently sentenced in other cases ahead of the February 8 elections.

Despite securing relief in other cases including £190 million reference and Toshakhana, and acquittal in the cipher case earlier this month, the former premier remains behind bars due to his conviction in the iddat case.

Khan has also been granted bail in the May 9 cases registered in Lahore, Rawalpindi, and Faisalabad. On the other hand, the Federal Investigation Agency also twice interrogated him in the jail regarding an anti-state post shared on X, formerly Twitter. There is, however, no new case against the PTI founder.—RT/Agency

Pakistan To Enforce International Border Laws To Curb Terrorism From Afghanistan: Asif

ISLAMABAD: In a major policy shift, Pakistan has decided to stringently enforce international laws at its borders with Afghanistan, to restrict the inflow of militants and smuggled goods into the country, Defence Minister Khawaja Asif said on Thursday.

The government seeks not only to curb economic losses caused by the smuggling of oil, fertilisers, and other goods from Afghanistan into Pakistan, but also to thwart the infiltration of terrorists, avert potential breaches, and implement security checks at the borders.

"All traffic from Afghanistan will only be allowed entry into Pakistan with a valid passport and visa," said Asif talking to



media, hinting at the end of the longstanding practice of Afghans entering Pakistan without proper documentation.

The statement comes as Pakistan has witnessed a significant surge in cross-border attacks on security forces in recent months with the militants using advanced weaponry and equipment.

Islamabad has time again

called on the interim Afghanistan government to prevent its land from being used by the Tehreek-e-Taliban Pakistan (TTP) and other militant organisations for carrying out attacks against Pakistan.

"We must secure our country, and these crossing points have been compromising our security," the defence minister said in today's

interaction.

He further pointed out that after the withdrawal of US troops from Afghanistan, there had been a spike in terrorism, with most incidents tracing back to Afghan soil. "Currently, all terrorism is emanating from Afghan territory," Asif said that formal borders, where passports were required for crossing, were a standard global practice, noting that despite Pakistan's repeated requests for cooperation, Kabul was yet to respond adequately. "Our borders with China, Iran, and India operate with strict regulations, and it should be the same with Afghanistan," he asserted. Replying to a question, Asif said they were cognisant of the fact that there were families on both sides of the Pakistan-

Afghanistan border. Rationalising the decision to implement visa and passport restrictions, he compared them to the families divided in Kashmir since the partition of the subcontinent. Addressing other divided borders, Asif mentioned that similar issues exist along the Siakot borders — with India — and the working boundary, where families are split. Afghanistan does not recognise the Durand Line, the border between the two countries, arguing it was created by the British to divide ethnic Pashtuns. The 2,640-kilometer (1,640-mile) border was established in 1893 through an agreement between British-ruled India and Abdur Rahman Khan, then ruler of Afghanistan.—RT/Agency

'Absolutely Ridiculous': PTI To Challenge Iddat Case Verdict In IHC

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) has slammed the district and sessions court's "ridiculous" decision to reject the pleas seeking suspension of the sentence handed down to party founder Imran Khan and his wife Bushra Bibi in the iddat case.

Speaking outside the court in Islamabad, PTI Secretary General Omar Ayub Khan said that the party will



be challenging the verdict in the Islamabad High Court (IHC).

"We will challenge this verdict in the high court at once," the National Assembly opposition leader said while

lamenting the politicisation and weaponisation of private matters between a husband and a wife.

The party's reaction comes after Additional Sessions Judge Afzal Majoka announced the verdict, reserved on Tuesday, with the hearing on the central plea related to the annulment of their conviction set to take place on July 2.

The PTI founder and

Bushra were each sentenced to seven years in prison in February earlier this year after a trial court found their nikah to be fraudulent as Khawar Maneka, Bushra's ex-husband, moved the court against the couple's marriage.

The couple were indicted in the iddat case on January 16, 2024. After a 14-hour hearing in the Adiala jail, the trial court reserved its verdict on February 2 and handed

out seven years imprisonment each to Khan and Bushra on February 3.

In the 10-page order today, the court mentioned that there was no reason to suspend the sentence. "...[there is] no ground for suspension of [the] sentence is available to both the petitioners. Accordingly, both the petitions under section 426 Cr.PC are dismissed," it said.—RT/Agency

Hyderabad business community leader Farooq Shaikhani slams uncalled for crackdown against LPG shops

HYDERABAD: Muhammad Farooq Shaikhani, President, Hyderabad Chamber of Small Traders & Small Industry, has raised serious concerns over the ongoing crackdown on LPG gas shops in Hyderabad, which has been intensifying over the past month. Shaikhani questioned the timing and rationale behind these actions, noting that such measures are often taken only after a major accident occurs. He demanded clarity on which department issued licenses to these shops and why they were allowed to operate in densely populated areas for years without intervention.

Shaikhani highlighted the severe impact of this crackdown on thousands of domestic consumers, including tea houses, tandoors, eateries, small hotels, restaurants and domestic users, which rely heavily on LPG. He emphasized that with the skyrocketing prices of natural gas by the Sui Southern Gas Company and a ban on new connections for over three years, LPG cylinders had become the only viable option for many consumers. The sudden crackdown has jeopardized the livelihoods of countless individuals in Hyderabad and disrupted daily cooking routines for households.

The Chamber President underscored the global context of LPG production, noting that the annual global production stands at approximately 300 million metric tons, with major producers being the United States, China, Saudi Arabia, and Russia. In contrast, Pakistan's annual LPG consumption is around 1.2 million

He highlighted the enduring fraternal relations between Pakistan and Azerbaijan, which have spanned decades. He believed that there were significant opportunities for trade and investment between Azerbaijan and Pakistan. "Foreign investment in the country is on the rise due to the government's business and investment-friendly policies," the prime minister mentioned.

The prime minister directed the development of a comprehensive action plan to boost trade efficiency and expand current trade between the two countries.

During the meeting, the prime minister was briefed on initiatives aimed at enhancing trade volume, capacity, and trade and investment between Pakistan and Azerbaijan. It was highlighted during the briefing that there was substantial potential for energy cooperation with Azerbaijan, and discussions were ongoing for a preferential trade agreement between both countries. Algerian-Pakistani Business Forum Aims To Boost Bilateral Ties

ALGIERS/ISLAMABAD: Pakistan participated in the 55th Edition of the International Fair of Algiers from June 24-29, 2024, with a significant delegation led by the Trade Development Authority of Pakistan (TDAP), comprising over 30 economic operators across sectors such as surgical instruments, textiles, sports articles, cosmetics, motorbike tires and tubes, safety gloves and wears, and electronics.

Tribal Jirga Has Rejected Operation Azm-e-Istehkam as 'Destabilizing,' Says Fazl

ISLAMABAD: Maulana Fazlur Rehman, the chief of his own faction of Jamiat Ulema-e-Islam (JUI-F), has rejected the government's decision to launch an operation against terrorists and extremists, stating that the tribal jirga also declared the "Azm-e-Istehkam" operation as destabilizing and expressed no confidence in it.

In a media briefing following a tribal jirga in Peshawar on Thursday, Fazl explained that the jirga was convened before the Azm-e-Istehkam operation decision made by the government and that it was not on the agenda.

However, the jirga deemed the operation destabilizing and expressed its lack of confidence in it.

He pointed out that armed groups have spread to several areas, controlling traffic and setting up checkpoints, with police in the southern districts avoiding leaving their sanctuaries at night. Fazl highlighted the sacrifices made by the people of Swat, who were displaced from their homes. "Youth have become unemployed, and women are begging. Those whose homes were completely destroyed were given token compensation of 400,000 rupees, but they have not received the money yet," he said. He condemned the violations of tribal sanctity and economic destruction, adding that fencing had forced 20,000 to 30,000 people to cross the border and return more powerful.—RT/Agency



Omar Ayub Resigns As PTI's Secretary-General

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) top leader Omar Ayub Khan has said that he stepped down as secretary-general of the party "to focus on my role as Leader of the Opposition in the National Assembly of Pakistan." "I am most grateful to [former] PM Imran Khan sahib for accepting my resignation as Secretary-General PTI to focus on my role as Leader of the Opposition in the National Assembly of Pakistan," he wrote on his official X handle on Thursday.

Ayub said he had tendered his resignation on June 22, 2024 via letter addressed to jailed PTI founder Imran Khan and party Chairman

Barrister Gohar Ali Khan sahib. "Leader of the Opposition in the Senate, Senator Shibli Faraz sahib conveyed my message to [former] PM Imran Khan sahib today during their meeting in Adyala Jail," he added. The NA opposition leader further said further changes will be made

in the organisational structure of the PTI in the coming days on the directions of the party founder. "I want to thank all members of the PTI family, Parliamentarians, and Tazameen Office Holders who have worked tirelessly and braved tremendous hardships for [ex] PM Imran Khan sahib and PTI." The surprise development came amid reports of rifts in the ranks of the PTI with Geo News reporting citing sources on Wednesday that PTI-backed 27 Sunni Itehad Council (SIC) lawmakers deliberated on the option of resignation from the National Assembly in protest against the party's top leadership.—RT/Agency



Verdict Reserved on Acquittal Pleas Of Imran And Qureshi In 'Azadi March' Case

ISLAMABAD: The District and Session Court Islamabad reserved its verdict on acquittal pleas in Azadi March cases of former premier Imran Khan, former foreign minister Shah Mahmood Qureshi and Senator Faisal Hayat Khan on Thursday.

Judicial Magistrate Yasir Mehmood conducted hearing on pleas of the Pakistan Tehreek-e-Insaf leaders.

PTI counsels Sardar Masroof, Amna Ali and Mirza Asim Baig appeared before the court.

PTI lawyer Sardar Masroof argued before the judge that the First Information Report (FIR) was not submitted by the mandated authority, expecting that sentence would not be awarded in the case of the trial. He pleaded that prosecution had no substantial evidence except the party's flags. Later, the court reserved the verdict on twin cases registered in the Aabpara Police station without giving any date of pronouncement.—RT/Agency

For Pakistan, Polio is only about donor funding, apathy and photo opportunities

Polio continues to be a thorn in Pakistan's side, a stark reminder of the country's struggle with preventable diseases. Despite substantial efforts, including those led by Prime Minister Shehbaz Sharif and significant funding from the Bill and Melinda Gates Foundation, the eradication of polio remains elusive. Every few months, new cases emerge, underscoring the inefficacy of current strategies and the persistent gaps in the nation's health infrastructure.

The involvement of global figures like Bill Gates often turns into more of a photo opportunity than a harbinger of real change. Successive Pakistani prime ministers have posed with Gates, pledging to eliminate polio, yet the virus stubbornly persists. These high-profile meetings create headlines and perhaps a temporary boost in funding, but they fail to translate into sustained, on-the-ground improvements. The narrative remains the same: significant donor

funds flow into Pakistan, but the desired outcomes remain frustratingly out of reach.



For the Gates Foundation and other international donors, Pakistan is a challenging partner. The recurring issues and lack of tangible progress make it seem like a perpetual cycle of hope and disappointment. While donors are keen to see Pakistan succeed, the country's inability to deliver consistent results despite decades of support makes it a global headache.

A critical factor behind this enduring struggle is the lack of genuine commitment and proactive measures from the government. The approach to polio eradication often ap-

pears half-hearted, with more focus on securing donor funding and managing the optics rather than addressing the root causes. Vaccine hesitancy, driven by misinformation and mistrust, remains widespread, and efforts to counter this are neither robust nor sustained. Moreover, the safety of polio workers, who face significant risks, is not adequately prioritized.

Without sincere efforts and a shift from superficial commitments to deep, systemic action, polio will remain a grim reality in Pakistan. It's a tragic irony that in an era when most of the world has eradicated this virus, Pakistan still grapples with it. The government must move beyond symbolic gestures and adopt a more determined, comprehensive approach to protect its children from this preventable disease. Only then can Pakistan hope to shed its polio burden and join the global community in declaring victory over this crippling virus.

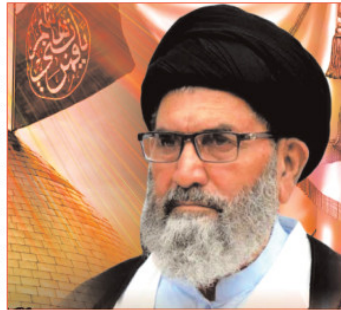
On the occasion, the growers demanded that the government take immediate notice of their grievances and revise the budget to be more pro-people and farmer-friendly.

Euro 2024: Turkey defeat Czechs to secure Last-16 spot



HAMBURG: Turkey secured a place in the Euro 2024 last-16 with a hard-fought 2-1 victory over a resilient 10-man Czech Republic on Wednesday. Goals from Hakan Calhanoglu and Cenk Tosun ensured Turkey's progression, while the Czechs were sent packing.

Midfielder Antonin Barak, 28, was shown a harsh second yellow card in the 20th minute, leaving the Czechs with a steep hill to climb. Despite their disadvantage, the Czech team showed impressive spirit and determination throughout the match.

Calhanoglu broke the deadlock in the 50th minute with a precise low shot, marking his first goal in his third Euros. His strike ignited celebrations among Turkish fans, who had turned out in large numbers, creating a raucous atmosphere in Hamburg.

Czech goalkeeper Jindrich Stanek, who appeared to injure his shoulder during a save, was unable to continue after Calhanoglu's goal. The match took another dramatic turn when 19-year-old Arda Guler missed a golden opportunity to double Turkey's lead. Moments later, Tomas Soucek equalised for the Czechs in the 66th minute, pouncing on a chaotic long throw-in to score.

In a thrilling climax, Tosun netted the winner in stoppage time, sparking wild celebrations on the Turkish bench and among their supporters. The victory exercised the ghosts of Euro 2020, where Turkey had suffered three defeats and conceded eight goals.

"We all fought very well together," said defender Mert Muldur. "We had a hard time against such teams in the past. I think we have improved ourselves."

Turkey finished second in Group F behind Portugal, setting up a last-16 clash with Austria on 2nd July in Leipzig. "When we talked with our friends before the game, our only goal was to get out of the group. We kept our promise," said winger Baris Alper Yilmaz. "Now we will proceed step by step. We are very happy."

The Czechs, who were left to rue their missed opportunity. Captain Soucek expressed his disappointment, criticising the "disrespectful" red card that had tilted the game. "It is a disappointment because we all wanted to advance," he said.

"Everyone did the maximum. The morale was huge. Just a sad end... But that is football!"

Portugal, already assured of top place in the group, surprisingly lost to Georgia, who advanced as one of the best third-placed finishers. Czechs ended their campaign at the bottom of the group with just one point. —Agency

T20 World Cup 2024: India overpower England to seal berth in final

GUYANA: India overpowered England by 68 runs in the second semi-final of the T20 World Cup 2024 at the Providence Stadium in Guyana on Thursday.

After edging out England, India will now face South Africa in the final of the T20 World Cup on Saturday, June 29 in Barbados.

Chasing the 172-run target, England got off to a good start as they scored 26 runs without losing a single wicket. Jos Buttler looked in good touch but was dismissed by Axar Patel on the first ball of the fourth over.

England never recovered after losing their skipper as Jasprit Bumrah increased their troubles by removing Phil Salt's stumps.



India's spin department continued to dominate the defending champions as Jonny Bairstow (0 off 3), Moeen Ali (8 off 10), Sam Curran (2 off 4) and Liam Livingstone (11 of 16), all failed to score big for the team.

Harry Brook provided some respite by contributing 25 runs on 19 balls but he

was removed by Kuldeep Yadav.

For India, Patel and Kuldeep bagged three wickets each while Bumrah got two as the entire English team was out for 103 runs in 16.4 overs.

In the first innings, India didn't have a great start as Virat Kohli, once again, failed to perform in the ongoing tournament as he was bowled by Reece Topley after just scoring nine runs.

Following Kohli's dismissal, Rishabh Pant too walked back to the pavilion after scoring just four runs, leaving India 40-2 in 5.2 overs.

However, after losing two wickets, India bounced back as Suryakumar Yadav and Rohit Sharma formed a 73-run partnership. The Hitman completed his half-century but fell to Adil Rashid's goody after contributing 57 runs.

Yadav continued India's attack after Sharma's dismissal but he missed his half-century by just three runs by losing his wicket to Jofra Archer. —Agency

Michael Vaughan highlights India's "unfair advantage" in T20 World Cup

LONDON: Former England cricketer and renowned commentator Michael Vaughan slammed the International Cricket Council (ICC) for allegedly favouring India during the ongoing T20 World Cup 2024.

Vaughan, a notable voice in world cricket, spoke about Afghanistan's tight schedule for their semi-final against South Africa and stressed that India and England should have played the first semi-final.

"Surely this [Afghanistan vs South Africa] semi should have been the Guyana one... but because the whole event is geared towards India it's so unfair on others," he further stated.

Earlier, Afghanistan head coach Jonathan Trott also expressed dissatisfaction with his side's tight schedule as they got less time to prepare than their opposition.

"Playing the last group game and then playing the first semi-final isn't ideal - travelling and not really having a day off if you like. But that's not a reason we didn't win. —Agency



South Africa demolish Afghanistan's Cinderella run, reach their first T20 World Cup final

TAROUBA: South Africa demolished Afghanistan's T20 World Cup dream in ruthless fashion on Wednesday, thrashing the minnows by nine wickets with more than 11 overs to spare to reach the final of the cricket showpiece for the first time.

Left-arm wrist-spinner Tabraiz Shamsi (3 for 6) and gangling pacer Marco Jansen (3-16) spearheaded the rout of Afghanistan's brittle batting line-up for just 56 off 11.5 overs after they chose to bat.

Fast bowlers Kagiso Rabada and Anrich Nortje maintained the relentless pressure with two wickets apiece at the Brian Lara Stadium in Trinidad.

On a surface which encouraged all bowlers but left Afghanistan with too little to defend, South Africa lost Quinton de Kock early in reply for Fazalqah Farooq's

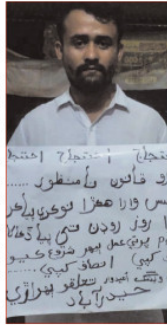

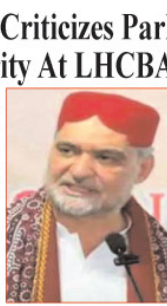

Rain Provides Relief To Karachiites After Days Of Scorching Heat

KARACHI: Karachiites experienced a welcome respite on Thursday as rain brought relief following four consecutive days of temperatures soaring above 40 degrees Celsius. Various parts of the metropolis, including Gadap, Bahria Town, and Malir, reported dust storms and heavy rainfall, easing the heatwave conditions.

According to reports, the rain initially began on the city's outskirts before spreading to other areas later in the day. Chief Meteorologist Dr. Sardar Sarfaraz of the Pakistan Meteorological Department (PMD) forecasted that while Friday and Saturday would remain warm, the intensity of the heat would diminish gradually.



Dr. Sarfaraz, speaking to media, anticipated intermittent rain over the next few days, with breaks expected during the afternoon and

evening periods. He attributed the weather pattern to a lingering low pressure system affecting the region.

"The next two days will be warm but noticeably less intense," Dr. Sarfaraz noted. The PMD had earlier issued a press release forecasting "rain, wind/thundershower with isolated heavy falls" across Sindh from Wednesday onwards.

Despite the relief brought by the rain, recent heatwave-related fatalities have been reported in Karachi, with four deaths recorded on Tuesday alone. The Sindh

health department confirmed a total of eight heat-related deaths over the past month, primarily among vulnerable groups such as drug addicts and the homeless.

Karachi Commissioner Hasan Naqvi disclosed that ten individuals succumbed to heatstroke earlier in the week, underscoring ongoing challenges despite the recent weather change. The maximum recorded temperature in Karachi reached 42°C on Monday and 41°C on Sunday, highlighting the severity of the recent heatwave.—RT/Agency

The petition names the Ministry of Energy, NEPRA, and KE as respondents, seeking the court's intervention to ensure uninterrupted electricity supply in Karachi. It criticizes KE's load-shedding schedule, alleging that 71% of feeders are unfairly exempt from power cuts.

Additionally, the petition highlights NEPRA's imposition

of a Rs 50 million fine on KE for subpar performance and demands accountability for technical faults affecting electricity supply.

According to the petition, Karachi residents endure an average of 16 hours of daily load shedding amid temperatures exceeding 40°C, severely impacting daily life and essential services.

The outcome of this legal challenge could potentially influence measures to mitigate power interruptions and enhance service reliability in Karachi.—RT/Agency

Ali Khurshedi Criticizes Sindh Government's Delay On K-IV Project

KARACHI: Media reports indicate that Ali Khurshedi, the Leader of the Opposition in the Sindh Assembly, has criticized the government for a decade-long delay in implementing the K-IV water project.

During discussions on the budget in the Sindh Assembly, MQM's Ali Khurshedi expressed disappointment that the government has only discussed the K-IV project without taking decisive action. He emphasized the need for progress on projects like K-V and K-VI to address Karachi citizens' pressing needs.

Khurshedi criticized the Sindh government, alleging that it has failed to fulfill promises outlined in the People's Party manifesto. He sharply condemned K-Elec-

tric for widespread load shedding in Karachi during intense heat, likening the utility to an incorrigible entity that requires stern measures to rectify.

Demanding accountability, Khurshedi called for registering FIRs against K-Electric officials and urged the Sindh Chief Minister to engage with the Prime Minister regarding the performance of all three power companies in the province. He emphasized the necessity for these entities to either correct their course or face expulsion from the province.

The statements by the opposition leader underscore growing frustration over delayed infrastructure projects and service delivery issues affecting Karachi's residents.—RT/Agency

NEPRA Reviews KE's Tariff Petitions For Reliable Power Supply In Karachi

KARACHI: The National Electric Power Regulatory Authority (NEPRA) conducted a hearing on June 27, 2024, to deliberate on K-Electric's (KE) distribution, transmission, and supply petitions as part of its Multi-Year Tariff for the period spanning from FY 2023-24 to FY 2029-30.

KE's petitions underscore essential components aimed at maintaining and enhancing investments to ensure efficient and reliable power supply across its service territory in Karachi.

The focus of the hearing and subsequent decisions does not affect the electricity pricing structure on customers' monthly bills, which remains governed by a uniform tariff policy ensuring equitable charges nationwide for different customer categories.

These hearings are part of an ongoing Multi-Year Tariff process where NEPRA has already issued decisions on KE's approximately USD 2 billion investment plan for Transmission and Distribution, as well as its Power Acquisition Programme aimed



at increasing the use of renewable and local resource-based energy sources.

The current tariff petitions lay the groundwork for securing Karachi's sustainable energy future. They propose a cost-reflective tariff structure that includes annual and quarterly indexation mechanisms to align tariffs with changes in macroeconomic conditions, ensuring sustainability for KE.

Additionally, mechanisms are proposed to adjust for changes in energy volume dispatched to Karachi (in gigawatt-hours), vital for recovering prudent costs necessary to maintain service quality and support network expansion to meet increasing

energy demands.

As part of its investment plan, KE is expanding its transmission and distribution network, including the introduction of the first 500 kV facility at KKI, to cater to growing customer needs. Simultaneously, the Power Acquisition Programme aims to add 1300 MW of renewable energy projects, promoting sustainability and affordability.

KE is deploying advanced technologies such as Advanced Distribution Management Systems to enhance network governance and reduce line losses and power interruptions, thereby improving network stability.—RT/Agency

Reserved Seats Case: SC Judge Asserts ECP Lacks Authority To Exclude Any Party From Polls

ISLAMABAD: Supreme Court Justice Athar Minallah said Thursday that the Election Commission of Pakistan (ECP) lacks the authority to kick out any party from the elections.

"Election Commission does not have the authority to exclude any political party from [taking part in] elections," Justice Minallah said in a 13-member full court, headed by Chief Justice of Pakistan (CJP) Qazi Faez Isa, heard the Sumi Ihtedad Council (SIC) plea against the Peshawar High Court (PHC) verdict denying them reserved seats.

The bench comprises Justice Syed Mansoor Ali Shah, Justice Muneeb Akhtar, Justice Yahya Afridi, Justice Amin-ud-Din Khan, Justice Jamal Khan Mandokhail, Justice Muhammad Ali Mazhar, Justice Malik, Justice Athar Minallah, Justice Syed Hassan Azhar Rizvi, Justice Shahid Waheed, Justice Irfan Saadat



Khan and Justice Naeem Akhtar Afghan.

During the hearing today, Justice Muneeb questioned which party SIC Chief Hamid Raza associated himself with, whereas Justice Mandokhail inquired whether a candidate can change his party after withdrawing his nomination papers.

Apprising the court of details regarding Raza's documents and political affiliation, ECP's lawyer Sikander Bashir noted that the document submitted by the SIC

Furthermore, CJP Isa inquired whether it is necessary to attach a certificate of affiliation to the party from which the election is to be contested.

"It is necessary to show the candidate's declaration and affiliation with the party," responded the ECP's lawyer, adding that a candidate is considered independent if the declaration and political affiliation do not match.

However, the chief justice noted that there was no discrepancy in the certificate and the ECP was in fact changing the candidate's status.

"Why shouldn't we consider [candidates] as belonging to the PTI?" CJP Isa said, highlighting that there are issues with the documents submitted by the ECP in the court.

Additionally, Justice Malik questioned why the ECP declared the candidates as independent when they

were in fact declaring their association with a political party.

Moreover, Justice Muneeb, while referring to the apex court's earlier decision wherein it had upheld the ECP's decision to revoke the PTI's "bat" symbol, clarified that the SC had not intended to exclude the PTI from the polls.

"You [ECP] conveniently said the candidates must be declared independent as [PTI] wasn't allocated an election symbol [..] how did you reach such a major decision?" Justice Muneeb said.

"An independent candidate may also be allocated the 'bat' sign," CJP Isa said, adding that the court cannot do anything if someone misinterprets their decision.

The court then directed the electoral body to provide PTI's list regarding reserved seats with the certificates and declarations of the candidates.—RT/Agency

'They Won't Allow Imran To Be Released At This Moment,' Says Sheikh Rashid

ISLAMABAD: Awami Muslim League (AML) chief Sheikh Rashid Thursday claimed that Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan is unlikely to come out of imprisonment soon.

"They won't allow PTI founder to be released at this moment," Rashid said while speaking to the media at a district and sessions court in Islamabad.

The former federal minister's remarks come as Khan, who has been serving various sentences and has been behind bars since August last year, might have a chance to be free if a district and sessions court rules in his favour in response to his plea seeking suspension of his sentence in iddat case today.

The former premier — who has previously secured relief in £190 million reference, cipher and Toshakhana cases — was handed down a seven-year sentence along with his wife Bushra Bibi in the said case after a trial court deemed their nikah fraudulent in February this year.

However, the Pakistan Muslim League-Nawaz (PML-N) government has said that it will try to keep the PTI founder behind bars.

"Imran Khan's main agenda is to destabilise the country and spread chaos and anarchy in the country that's



why the government will certainly try to keep him behind bars as long as possible," the PM's adviser said while speaking on Geo News programme 'Aaj Shahzeb Khanzada Kay Saath' on Tuesday.

"Persistently he [Khan] has only one agenda — spread anarchy and mischief in the country, hence for the betterment of the country he [Imran Khan] should be kept behind bars," the official added.

Meanwhile, the issue of the former PM's release has also become a contentious issue among the PTI ranks as 21 of its lawmakers have hinted at forming a forward bloc over the party's top leadership's failure to secure his release along with other leaders, sources told Geo News on Wednesday.

"More than 27 PTI lawmakers held consultations after Shehryar Afridi's statement about his resignation. Meanwhile, Shandana Gulzar Khan, Sher Afzal

Marwat and several lawmakers also protested over the incompetence of the party's top leadership," the sources added.

Furthermore, expressing his views on the prevailing political landscape, Rashid claimed that PML-N President Nawaz Sharif will also change his narrative by the end of July.

The politico's remarks come as earlier this week, Geo News citing sources, reported that the three-time former prime minister had in fact decided to play an active role in national politics.

Nawaz, the sources added, would hold more meetings with the party's leaders and workers besides playing an active role in strengthening the prevailing political system. Additionally, the AML chief also stressed that a middle ground needs to be carved out by negotiation with the army to send "this corrupt government" packing.—RT/Agency

Pakistan To Participate In UN-Hosted Doha Talks On Afghanistan

ISLAMABAD: Pakistan has decided to participate in the United Nations-hosted talks on Afghanistan in the Qatari capital scheduled for this weekend, diplomatic sources told media on Thursday.

Earlier this month, Taliban authorities also confirmed their participation in the third round of the Doha talks scheduled to start on June 30, a Taliban spokesperson had told AFP after snubbing an invitation to the previous round.

The sources said Pakistan's Special Representative to Afghanistan Asif Durrani and Ahmad Naseem Warraich, assistant secretary for West Asia in the Ministry of Foreign Affairs, will represent Pakistan in the talks.

It should be noted that Pakistan has times and again requested the Taliban government to stop cross-border terrorism from Afghanistan into Pakistan by preventing its territory from being used by the Tehreek-e-Taliban Pakistan (TTP) and other terrorist groups.

The diplomatic sources said the Afghan Taliban's interim government had boycotted the second Doha talks of 2024 over the participation of women and civil society



representatives.

It would be the first time that Afghanistan's interim administration will sit face to face with special representatives on Afghanistan from different parts of the world, they maintained.

The sources said prior to the Doha talks, the United Nations held consultations with representatives of the Afghan civil society present inside and outside Afghanistan.

After completion of the talks, representatives of the civil society members and women would hold discussion with the special representatives on Afghanistan on July 2.

"In the third Doha talks, progress on recognising the Afghan Taliban and Afghanistan's interim government is out of the ques-

tion," the diplomatic sources added.

Restrictions on women's rights continue to prevent Afghanistan's "reintegration" into the international community, a senior UN official said on June 21, noting the Taliban's participation in upcoming talks in Doha is not legitimisation of the isolated government.

Since their 2021 return to power, Taliban authorities have not been formally recognised by any nation. Restrictions on women and girls, particularly in education, "deprive the country of vital human capital" and lead to a brain drain that undermines the impoverished country's future, Roza Onunbayeva, head of the UN mission in the country, UNAMA, told the UN Security Council.—RT/Agency

IMF Raises Concerns Over Pakistan's Pension Burden In Budget For 2024-25



ISLAMABAD: The International Monetary Fund (IMF) has raised concerns regarding the raising pension burden in Pakistan as some retired government employees in the country receiving more than Rs 1.6 million in pension, media reported on Thursday, citing sources.

Sources close to the development disclosed that the IMF is worried about the issue of double pensioners. According to documents, an estimated Rs 1,014 billion will be allocated for pensions in the upcoming budget 2024-25. The documents further reveal that pensions will see a 15 percent increase in the new budget, requiring an additional Rs 122 billion to cover this increment. Notably, the monthly pension for 95 retired officers in Pakistan exceeds Rs 500,000, while

3,081 retired officers receive more than Rs 200,000 per month. Earlier, the Federal Minister for Finance and Revenue Senator Muhammad Aurangzeb announced 'significant' relief for government employees, increasing their salaries up to 25 percent. Presenting the budget for the fiscal year 2024-25 on the National Assembly floor, the finance minister said that the government proposed to raise salaries by 25 percent for grade 1-16 employees and a 20 percent increase for grade 17-22 employees.

In the budget, the finance minister also proposed a 15 percent increase in pensions for retired employees. The minimum monthly wage for a worker has been raised from Rs 32,000 to Rs 37,000.—RT/Agency

LHC Judge Asserts PM Must Take Responsibility For 'Subordinate' Agencies

LAHORE: Lahore High Court's (LHC) Justice Shahid Karim on Thursday remarked that Prime Minister Shehbaz Sharif should take responsibility for any insubordination by intelligence agencies under him.

The judge's remarks were made in the written order for a case on the alleged threats to a judge of a Sargodha anti-terrorism court (ATC) and his harassment by the intelligence and law enforcement agencies.

On June 13, Justice Malik Shalazad Ahmad Khan, the then chief justice of the high court, had summoned Punjab Inspector General of Police (IGP) Usman Anwar and other officials on the complaint. The LHC registrar's office had received a special report on June 7 from District & Sessions Judge (DSJ) Muhammad Abbas, wherein he said that on May 25 — the first day of his new charge as Sargodha ATC judge — a message was conveyed to him that some authority of the Inter Services Intelligence (ISI) wanted to meet him in his chamber.

Upon refusing to meet the said authority, DSJ Abbas alleged that ever since then, he had been encountering various incidents, such as firing outside his ATC and questioning from family members, among others. CJ Ahmad had reserved his verdict in the matter on June 13. The verdict was announced in a June 20 hearing. Following Justice Ahmad's elevation to the Supreme Court, Justice Shahid Karim is presiding over the case. In today's hearing, Justice Karim converted the suo moto notice into a writ petition. He said that he would appoint a prosecutor as well as a judicial assistant in this case. "If we find out who tried to meet the judge, we are ready to investigate him," the counsel for the federal government



said. "The court will issue a directive that the prime minister of Pakistan (Shehbaz Sharif) take responsibility with regards to ISI and IB."

Justice Karim said, "If anything happens after that, we will directly ask the prime minister." The prime minister has to take responsibility, ISI and IB are subordinate to the prime minister, Justice Karim said. He said that direction would be issued to Punjab IGP that the decision to block the road to be taken after consulting the judge, Justice Karim said, noting that the Punjab IGP should issue directions to all police officers in this regard. Justice Karim further said that all judges of ATC courts should have call recording apps on their phone.—RT/Agency

Pakistan Considers Tit-for-Tat Response Following US Election Probe Demand

ISLAMABAD: The Pakistani government is mulling a tit-for-tat response to the US House of Representatives resolution demanding an investigation into the February 8 elections.

"In response to [US Congress], we will also bring about a resolution. We must show our sovereignty, we must show our unity, we must show that we mean business. This [resolution] makes no sense," Foreign Minister Ishaq Dar said while speaking on the floor of the National Assembly.

The US House of Representatives, earlier this week, in an overwhelming majority, voted to demand a "full and independent investigation of claims of interference or irregularities" in the polls.

The resolution HR 901 was passed by a massive 368 against seven votes on Tuesday, which makes 85% of the total American lawmakers in the legislature.

The move triggered a strong response from Islamabad, with the Foreign Office saying it "stems from an incomplete understanding of the political situation and electoral process in Pakistan".



in Pakistan and requested the government to uphold democratic and electoral institutions, human rights, and the rule of law.

It also condemned "any effort to subvert the political, electoral, or judicial processes of Pakistan".

In his speech today, Dar maintained that the Pakistani parliament could also pass resolutions on matters related to other nations, but the South Asian country refrains from such things.

"I believe that the [US] should reciprocate mutual dignity and respect," Dar said, noting that a draft resolution has been prepared, which would be shared with the parliamentary leaders — from the treasury and opposition benches.

"We should come in unity with a clear resolution against the US resolution," the deputy prime minister said.

Government Proposes 13 Amendments To Pension Scheme



ISLAMABAD: Thirteen amendments have been proposed by the federal government to the pension scheme to relieve the burden on the national exchequer.

According to sources, the first amendment proposes that government employees will receive a gross pension equal to seventy percent of their salary from two years before retirement.

The second amendment allows employees to retire willingly after twenty-five years of service. The third revision stipulates that those who opt for voluntary retirement at least three years before reaching the age of sixty will face a pension deduction of between five and twenty percent per annum. The fourth amendment

bases the annual increase in pension on the amount received at the time of retirement. The fifth amendment counts the annual increase in pension as a separate amount. The sixth amendment mandates that the Pay and Pension Commission will review the baseline pension every three years.

Also, the seventh amendment allows a pensioner's family to receive the pension for up to ten years. The tenth amendment provides lifetime pensions for the children of pensioners if they are physically or mentally disabled. The eleventh one specifies that those who join government service after retirement can receive either a pension or a salary.—RT/Agency

Naqvi Updates Chinese Counterpart On Progress Of Dasu Attack Probe

ISLAMABAD: Federal Minister for Interior Mohsin Naqvi Thursday met his Chinese counterpart Qi Yanjun and briefed him about the progress on the investigation of the Dasu terror attack involving Chinese citizens in Pakistan. "Foolproof arrangements have been made for the security of Chinese citizens," said Naqvi, in a meeting with the Chinese minister at the office of China's mission to the United Nations in New York, United States. The meeting between the two ministers comes days after Islamabad approved Operation Azm-e-Istehkam amid an increase in terror incidents as "a collective multidimensional operation and national vision of the entire state system" Naqvi, in a meeting with Chinese Ambassador Jiang Zedong earlier this month, had also assured providing foolproof security to Chinese citizens working on different projects in Pakistan, reiterating that no one can create rifts between the two



countries. Following the briefing today, Yanjun expressed satisfaction over the ongoing probe of the case, affirming that Pakistani institutions handled the case in a diligent and professional manner.

On the other hand, the Chinese minister also extended an invitation to Naqvi to participate in the Global Security Forum in September this year, which the interior minister accepted. Minister Naqvi also invited his counterpart to visit Pakistan, reiterating the strong friendship between the two nations. "We are all proud of our country.—RT/Agency
