## Justice Aalia Neelum Makes History As First Female Top Judge At Lahore High Court

ISLAMABAD: Justice Aalia Neelum has been nominated as the chief justice (CJ) of the Lahore High Court (LHC) in a first event of a woman judge being named for the post, sources said on Tuesday.

The jurist was unanimously nominated by the Judicial Commission of Pakistan (JCP) during a meeting headed by Chief Justice of Pakistan Qazi Faez Isa earlier in the day.

Justice Aalia is third in the seniority list of the LHC after the elevation of former LHC CJ Malik Shahzad Ahmad Khan and Justice Shahid Bilal Hassan to the Supreme Court.



Justice Shujaat Ali Khan had been appointed as the acting CJ for the high court by President Asif Ali Zardari under Article 196.

Meanwhile, Justice Shafi Muhammad Siddiqui was also unanimously nominated for post of Sindh High Court (SHC) top judge. The slot was vacated after former SHC CJ Aqeel Ahmed Abbasi's elevation as a top court judge with Justice Shahzad and Justice Shahid earlier this month.—RT/Agency

## Afghan Taliban, Pakistani Diplomats Meet In Doha Amid Terrorism Dispute

DOHA: In a fresh diplomatic engagement after Islamabad announced an operation against Afghanistan-based terrorists, an Afghan Taliban delegation headed by Afghan interim government's spokesperson Zabihullah Mujahid met Pakistani diplomats on the sidelines of the Doha-III conference.

Pakistan and Afghanistan enjoyed close and brotherly ties as South Asian neighbours which lately became strained due to frequent cross-border attacks largely carried out by the banned outfit — Tehreek-e-Taliban Pakistan (TTP) — which, according to Pakistan's security officials, operates from the Afghan soil.

The Afghan interim government's representatives are currently visiting Doha to attend talks to "discuss increasing engagement with Afghanistan and a more coordinated response to the country, including economic issues and counter-narcotics efforts".

They were due to meet UN officials and over 20 envoys, including the US special representative to Afghanistan as the international community grappled with its approach to Kabul's new rulers, according to Reuters.

During their visit,



Pakistani Ambassador to Qatar Muhammad Aejaz hosted a dinner for the Afghan Taliban delegation at his residence in Doha which was attended by senior diplomats, including Pakistan's Special Representative to Afghanistan Asif Durani and the country's Deputy Head of Mission in Kabul Ubaid Ur Rehman Nizamani.

Durani posted photos of the occasion on X (formerly Twitter) while welcoming and hosting the Taliban representatives where they discussed developments at the "Doha-III conference, bilateral and regional issues".

The Pakistani envoy to Qatar also reacted to the recent meeting on X, saying: "Very delighted to have hosted tonight the AIG [Afghanistan interim government] and

Pakistan delegations attending the Doha-III [conference]."

"Both remain neighbours and brothers and have a lot in common, including a strong desire for regional peace and security," Aejaz added. It was an "unusual meeting" between both sides, diplomatic sources told me, adding that the Taliban representatives also met an Indian delegation in Doha.

The sources said that the latest diplomatic engagement was held in a "positive environment" in which the representatives of the Afghan interim government thanked Islamabad for supporting Kabul's stance in the Doha conference, as well as the latter's backing on a national level.

Mujahid wrote on the microblogging website

regarding the meeting, "We had a very good evening meeting with Pakistan's special representative Asif Durani, the ambassador and consuls in Doha."

"We thank them for their hospitality and hope for good and constructive relations for both countries," he added.

From a diplomatic point of view, the high-ups' gathering from neighbouring South Asian states is an apparent move to improve relations by discussing bilateral issues. The federal government last week approved a fresh operation — Operation Azm-e-Ishtekam — a reinvigorated and re-energised national counter-terrorism drive, to eliminate terrorism from the country. A few days back, Federal Minister for Defence Khawaja Asif, in an in-

terview with BBC Urdu, rebuked the Afghanistan government for inaction against militants along the Pakistan-Afghanistan border, despite repeated requests made by the Pakistan government.

The defence czar, in another interview with the Voice of America (VoA), said that under Operation Azm-e-Ishtekam, Pakistan could target terrorist hideouts across the border in Afghanistan. He had also dismissed the possibility of negotiations with the outlawed TTP.

Amid concerns over the impacts of the newly-launched operation, Prime Minister Shehbaz Sharif clarified that it was not a large-scale military operation and that there would be no population displacement. During the Afghan Taliban's rule, Pakistan had carried out intelligence-based operations (IBOs) in the border regions inside Afghanistan against terrorists belonging to Hafiz Gul Bahadur Group in March, which was responsible for the March 16 attack in Mir Ali, North Waziristan and multiple other terrorist attacks in the country.

However, the Afghan interim government strongly reacted to the "air strikes" and warned that it "does not allow anyone to compromise security by using Afghan territory".—RT/Agency

## Court Grants Pre-Arrest Bail To Bushra Bibi In Landmark £190 Million Reference Case

RAWALPINDI: An accountability court on Tuesday granted former premier Imran Khan's wife Bushra Bibi pre-arrest bail in a £190 million corruption reference.

In December, the National Accountability Bureau (NAB) had filed a corruption reference against Khan and seven others, including his wife, in connection with the Al-Qadir University Project Trust. The case alleged that Khan and Bushra Bibi obtained billions of rupees and land worth hundreds of kanals from Bahria Town Ltd for legalising Rs50 billion that was identified and returned to the country by the UK during the previous PTI government.

The reference filed by NAB further alleged that Khan, who is currently in jail, played a "pivotal role in the illicit transfer of funds meant for the state of Pakistan into an account designated for the payment of land by Bahria Town, Karachi". It also claimed that despite being given multiple opportunities to justify and provide information, the accused deliberately, with mala fide intention, refused to give information on one pretext or another.

Khan and his wife were indicted in the case by a Rawalpindi accountability



court on February 27, a day after the Islamabad High Court (IHC) had issued notices to NAB on the couple's post-arrest bail plea in the same case.

As of March 13, Khan, Bushra bibi, property tycoon Malik Riaz, his son Ahmed Ali Riaz, former accountability czar Mirza Shahzad Akbar, Farhat Shahzadi (also known as Farah Khan), and Zulf Bukhari had been nominated as accused people in the reference. Except for the ex-premier and his wife, the rest have been declared proclaimed offenders.

In May, the IHC had approved Imran's bail application in the case, setting it at Rs1m.

Accountability court judge Muhammad Ali Waraich conducted a hearing related to the case today in which lawyers Salman Saf-

dar, Zahir Abbas Chaudhry, and Usman Riaz Ghul appeared in court on behalf of the married couple. Meanwhile, NAB Prosecutor General Sardar Mazhar Abbasi, Amjad Parvez, Irfan Bhola, and others appeared on the watchdog's behalf.

During the hearing, Bushra Bibi's lawyers submitted a bail request for her in the case.

Meanwhile, Abbasi argued that the request was not merited since her arrest was not sought in the case and nor had any warrants been issued to this effect, adding that the watchdog had previously maintained this position as well. The judge reserved his verdict decision on the bail application after the completion of arguments by both sides and later applied to the case today in a brief recess.—RT/Agency

"When a person faces

injustice or inequality, we say that politics is being done with him," Rana Sana said.

"We all should be clear in it that this country can only be run through politics," said the veteran politician.

He added that we should move forward in form of a movement and there is a dire need to

bring change in ourselves. The provincial sports come in the ambit of Inter-Provincial Coordination ministry and it needs drastic changes, he added.

## Veteran Publisher Kazi Afzal Abid Passes Away At 82

KARACHI: Kazi Afzal Abid, the son of the late ex-Federal Minister Kazi Abdul Majeed Abid and a veteran publisher, has passed away at the age of 82 in Karachi. Kazi Afzal was a prominent figure in the political and publishing spheres of Pakistan, known for his significant contributions to the Pakistan Peoples Party (PPP) during its early years. He was the former PPP president of Hyderabad City and played a pivotal role in the party's formative growth.

He was also the nephew of the late Kazi Mohammad Akbar, former Sindh Education Minister and Ambassador to Portugal. ## Nisar Khuhro accuses MQM Pakistan of conspiring for Jinnahpur's formation

LARKANA: Nisar Khuhro, President of the Pakistan People's Party Sindh, has leveled serious accusations against MQM Pakistan, alleging a conspiracy to revive the controversial "Jinnahpur" issue in Sindh's history. In a press conference, Khuhro criticized the recent appointment of a Governor from the Muslim League-N as part of what he called an internal understanding with MQM Pakistan.



Khuhro asserted, "The blame on Shaheed Zulfiqar Ali Bhutto for dividing the country was propagated by MQM, which now conspires to sow division within Sindh." He pointed to historical grievances and alleged criminal activities of MQM Pakistan, which he claimed are orchestrated from London. Further addressing MQM Pakistan's political alliances, Khuhro accused the party of supporting figures like Pervez Musharraf, Imran Khan, and PML-N, while remaining silent on issues like the abolition of the quota system. He also remarked that the people of Karachi no longer support MQM and its leader Altaf Hussain, attributing this to current circumstances sur-

## Two men injured for resisting robbers in Tando Jam

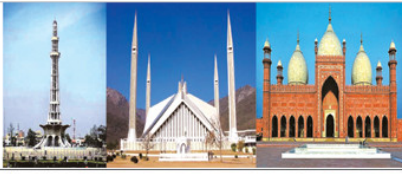


HYDERABAD: Residents of Ghummanabad are holding a protest demonstration at the Hyderabad press club for the acceptance of their demands.-RT

## PTI To Hold Major Power Show In Islamabad On July 6

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) has announced plans to hold a major rally in Islamabad on July 6, following a meeting with PTI founder in Rawalpindi's Adiala Jail on Tuesday.

PTI leader Ali Muhammad Khan addressed the media, urging the nation to join the rally in support of freedom and the rule of law.

"On July 6, PTI will organize a significant rally in Islamabad," stated Khan. "This is a message for the entire nation to step out for freedom and the rule of law. Our fight is to bring the powerful under the law," he added.

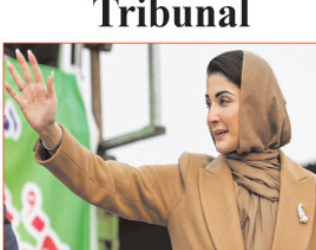
needed, and no one is addressing these issues," he stated.

## Maryam's Election Victory Challenged In Tribunal



LAHORE: The Lahore High Court's Election Tribunal (ET) has directed the Election Commission of Pakistan to produce the record of Form-45 related to the Punjab Chief Minister, Maryam Nawaz.

The court summoned the record as the success of the CM in the general elections has been challenged. Justice Anwar Hussain of the ET judge heard the appeal filed by Mehar Shafiq who contested against Maryam Nawaz from PP 159, Lahore.

Submitting his application, the applicant claimed that the victory notification of Maryam Nawaz is contrary to the facts and should be invalidated. During the proceedings, the CM's lawyers argued that the appeal is not admissible. In response to a query from the tribunal judge, the Election Commission lawyer said that 102 polling stations were set up in the constituency.

The tribunal judge asked why Form-45, carrying the signature of the presiding officer and other candidates, was not uploaded on the website. The Election Commission's lawyer sought time to produce the original record of Form-45, and the tribunal accepted the request.—RT/Agency

## SSP Abid Baloch vows to continue operations against TMK's criminals and drug dealers



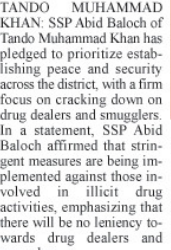

He highlighted significant progress in reducing drug trafficking under his tenure, attributing it to ongoing raids on drug dens and relentless efforts against drug-related crimes.

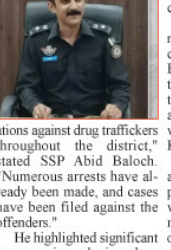

## Punjab Issues SOPs For Majalis During Muharram



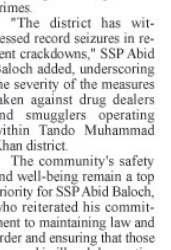
LAHORE: Punjab home ministry on Tuesday issued Standard Operating Procedures (SOPs) for majalis during Muharramul Haram.

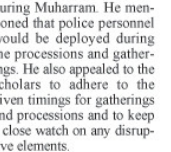
## Robbers Break Into ATM And Steal Cash In Lakki Marwat

## Sujawal's residents decry acute water shortage

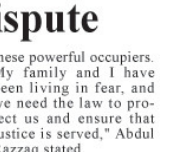

## District Council Thatta approves budget for fiscal year 2024-25

Only 5% of the budget has been allocated for salaries and pensions, indicating efforts to minimize administrative costs and prioritize district welfare. Panhwar underscored the council's commitment to reducing unnecessary expenditures to maximize the budget's impact. Council member Abdul Khaliq Soomro expressed disappointment over the Sindh government's lack of financial support for the families of the 20 Jokhio community members who tragically perished in a recent road accident near the Shah Noorani shrine. He criticized officials for ignoring the concerns of elected representatives and failing to fulfill their responsibilities. Soomro also highlighted issues in Thatta's agricultural sector, particularly the exploitation of farmers by suppliers charging exorbitant prices for fertilizers, seeds, and medicines. ## Kapri community youth shot dead in Umerkot

## Mercurial Pakistan qualify for T20 World Cup 2026, confirms ICC



DUBAI: With the recent conclusion of the T20 World Cup, the 12 teams for the next edition of the mega event - which will take place in 2026 in India and Sri Lanka - have been finalised.

The upcoming ICC tournament will also have 20 teams, divided into four groups of five sides each.

The first two spots of the event have been taken by India and Sri Lanka as hosts. The next 10 spots were determined by the Super Eight qualifiers at the 2024 and T20I team rankings.

Through this, Afghanistan, Australia, Bangladesh, England, South Africa and the West Indies all secured 2026 T20 World Cup spots as well as United States.

However, the Babar Azam's side managed to secure a place in the next edition with their T20I ranking (7th), alongside New Zealand (6th) and Ireland in 2026 in India and Sri Lanka.

Meanwhile, the final eight teams for the 2026 World Cup will be confirmed by regional qualifiers.

There are two qualification spots for Africa, Asia and Europe and one spot for Americas and East-Asia Pacific regions.

India secured the T20 World Cup 2024 trophy after beating South Africa by seven runs.

Rohit Sharma's men joined England and West Indies to win the T20 World Cup title two times as they won their first in 2007 by beating Pakistan in the final. —Agency

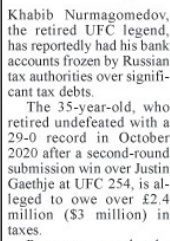

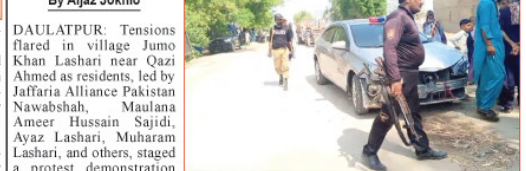

"We demand that the occupation of this public thoroughfare be immediately removed, allowing unfettered access for all residents of Jumo Khan Lashari," Ayaz Lashari asserted firmly. The protest highlighted widespread community dissatisfaction with the road closure, which has disrupted daily life and posed significant challenges during emergencies. Residents expressed frustration over the lack of action from local authorities to resolve the issue, calling for swift and decisive measures to reopen the vital route. "We urge the relevant authorities to take immediate notice of our plight and ensure that justice is served by reopening the road without further delay," urged Muharam Lashari, amid chants of solidarity from the gathered crowd. The protest by Jaffaria Alliance Pakistan underscores the community's determination to uphold their rights and access to public infrastructure. As tensions escalate, residents remain resolute in their demand for justice and the restoration of unrestricted access to their village.

## Tando Adam growers decry shortage of water in Sui Kandhar Branch

TANDO ADAM: The local growers of Tando Adam continued their protest demonstration against the ongoing water shortage in the Sui Kandhar Branch, gathering at Qaisar Ghot stop on Tuesday. The protesting growers, including prominent figures such as PPP Councillor Imran Brohi, Ibrahim Hakro, PML-F leader Muhammad Qasim Hakro, Nazir Pathan, Saeed Brohi, and others, voiced their frustrations and concerns to the media. The protesters highlighted that water theft from the Sui Kandhar Branch has been rampant for the past 20 years, severely impacting the agricultural productivity of the region. "Our fields

have turned barren, and our crops are dying due to the lack of water, yet the authorities remain indifferent," said PPP Councillor Imran Brohi. ## Jan Muhammad Dahri demands pensioners' rights

MAQSOODO RIND: Jan Muhammad Dahri, President of the All Sindh Government Retired Pensioners' Welfare Organization, issued a stern statement demanding the protection of pension rights for widows and orphans under the Sindh Government. ## Dhoronaro man dies from consuming alcohol

## Karachi Police Crush Notorious Gang Stealing And Selling Motorcycles Online

KARACHI: Police in Gulbhar Colony, also known as Golimar, on Tuesday arrested a gang of high-tech young thieves specialising in stealing motorcycles, forging documents, and then selling them online—cleverly staying off the radar of anti-vehicle lifting agencies.

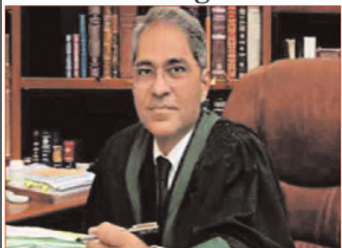


According to SSP Central Zeeshan Siddiqui, the modus operandi of the motorbike lifters was a sophisticated three-stage operation, which they had been successfully using to make illegal money for quite a while now.

The gang members would first acquire legitimate documents for motorcycles. These documents were the foundation of their illicit trade," said Siddiqui while talking to the media. "Then, using these genuine papers, they would forge fake documents for the stolen motorcycles, ensuring that the bikes appeared legal and trustworthy." With tampered engine and chassis numbers, these motorcycles were then listed and sold on various online platforms, conning unsuspecting buyers, the SSP revealed. Siddiqui said that the gang was highly active across various parts of Karachi. The culprits, identified as Bilawal, Shah Rukh, and Rizwan, have confessed to tampering with and selling dozens of stolen motorcycles. During the operation, police recovered eight stolen motorcycles and five chassis from the gang's possession. The police said that each gang member had his own expertise in this criminal operation. Rizwan, one of the gang members, admitted to faking the documents

and later selling the stolen motorcycles online. Bilawal, another of the thieves, confessed to lifting the motorcycles, often targeting specific models on demand. Shah Rukh, an expert in tampering with engine and chassis numbers, used to charge Rs3,000 for each alteration, the police said. "With the gang now in custody, formal legal proceedings have been initiated against them," SSP Central said, adding, "The successful operation marks a significant step in curbing motorcycle theft and fraud in Karachi."—RT/Agency

## Pakistan's Agro And Food Exports Skyrocket To \$8 Billion, Shattering Previous Records

KARACHI: Pakistan has achieved a historic milestone in its agro and food exports, reaching \$8 billion during the financial year 2023-2024, up from \$5.8 billion in the previous year—a remarkable increase of 37%. This surge underscores the growing importance of Pakistan's agricultural sector in the global market.

Maize Exports: Maize exports reached \$421 million, up from \$190 million, marking a growth of 121%. Global price increases following the Russian-Ukraine conflict boosted demand, with major markets in Vietnam, Malaysia, Korea, and Oman benefiting.

Rice Exports: Pakistan's rice exports soared to \$3.8 billion from July to June 2023-2024, compared to \$2.179 billion in the previous year, marking a growth of 78.26%. This increase is attributed to strong performance in the EU, Africa, ASEAN, and GACC countries, bolstered by Minimum Export Price (MEP) regulations and improved compliance with Sanitary and Phytosanitary (SPS) standards.

Meat Exports: Meat exports grew by 17.66%, totaling \$507 million, compared to \$431 million in the previous year. Expansion into new markets and the addition of new slaughterhouses contributed to this growth.

Sesame Seed Exports: Export of sesame seeds surged to \$410 million, up

from \$151 million, showing a growth of 171%. Increased production and heightened demand from China, Korea, and Japan contributed to this growth, supported by awareness campaigns in key production areas. Mr. Zubair Motiwala, Chief Executive of the Trade Development Authority of Pakistan (TDAP), attributed this growth to robust efforts in the agro sector. TDAP conducted workshops across various regions to boost production capacity and facilitate export registration. Motiwala highlighted new opportunities in the Chinese market for Pakistani meat, including the historic export of cherries. He emphasized efforts to explore non-traditional export products and expand into new markets like Jordan, Uzbekistan, Lebanon, and Egypt. With recent legislation supporting inland fisheries export, Motiwala expressed optimism in achieving a \$10 billion target for the current fiscal year.—RT

## Shahid Khaqan Abbasi Demands The Abolition Of Controversial NAB

KARACHI: Former Prime Minister Shahid Khaqan Abbasi demanded to abolish NAB, otherwise, he warned the country will remain paralysed.



Talking to the media in Karachi, Abbasi also criticized the justice system.

He said that NAB has been created to make political cases. He said that former NAB Chairman Javed Iqbal used to say that he didn't make cases without the direction of former PM Imran Khan. He said that the government's people said that the budget was a failure, the additional tax of Rs four thousand billion was a new thing in this budget, and the burden would fall on the people. He said that if the government starts taxing its exports it will be difficult to do export. Abbasi said that the institutions that are harming the country should be closed. The people are being robbed, the government has not made any monetary policy. The former PM said that the government was also angry at my press conference yesterday, the government has increased its expenses by 25% by putting a burden of Rs 4000 billion on the people. He said that additional tax was imposed on the income of the common man, petrol, diesel and that cigarettes are being smuggled. He said that the steel mills in Karachi and Lahore pay all the taxes. He noted that economic depression was happening due to the unfair tax policy. The former prime minister said that they support whatever operation is done for the country, but we have to think about why these operations are needed. He said that they were forming a political faction 'Awam Pakistan Party'.—RT/Agency

## Sindh Imposes Hefty Sales Tax Hike On Wedding Halls, Restaurants, And Cafes

Karachi: The Sindh government increased the sales tax from 13 to 15 percent with effect from July 1, media reported.



The provincial government hiked the Sindh Sales Tax to 15 percent in a recently passed budget for the fiscal year 2024-25 which will apply to various businesses, including restaurants, hotels, and wedding halls.

According to the revised tax, restaurants, cafes, bakeries, and hotels will have to pay 15 percent sales tax. The guest houses, farmhouses, clubs, and wedding halls will also be charged 15 percent sales tax. The credit card payments will be subject to an 8 percent sales tax while the cash payments will be subject to a 15 percent sales tax. "To promote digitalisation in the economy, it was proposed to reduce SST rate to 8 percent for the restaurant services involving customers' payments through digital means like debit/credit card, mobile wallet, QR Scanning, etc. For promoting the Telecom services which pay high rate of 19.5 percent SST to utilize input items paying Federal Sales Tax of up to 18 percent (which was previously 17 percent), it is proposed instead of 17 percent as at present," Chief Minister Syed Murad Ali Shah said while presenting the budget.—RT

## Karachi Police Launch Special Committee To Probe Shocking Murder Of PPP Councillor

KARACHI: Karachi police on Tuesday constituted a six-member committee to probe the killing of a Pakistan People's Party (PPP) councillor in Korangi.

The probe team will be headed by the SDPO Landhi, while SHO Zaman Town, Awami Town and two inspectors of Sindh police will be the member of the probe team.

As per details, SSP Korangi Tauheed Rahman has formed a committee following the PPP chairman took notice of the killing of Aamir Abbasi, a councillor, elected from Bhattai Colony, Korangi. SSP Tauheed said the

team will probe the killing of businessman Waseem and Aamir Abbasi. The probe team will be headed by the SDPO Landhi, while SHO Zaman Town, Awami Town and two inspectors of Sindh police will be the member of the probe team. The team will present its progress report on a daily basis, the SSP said.—RT/Agency

## Sindh Assembly Set To Declare Karachi As New York's Sister City, Announces Murad Shah

## PM Shehbaz Demands Revolutionary Boost In Trade And Connectivity With Tajikistan

DUSHANBE: Prime Minister Shehbaz Sharif has urged for increased trade, investment, and connectivity between Pakistan and Tajikistan, Radio Pakistan reported.

Prime Minister Shehbaz, on a two-day visit at President Rahmon's invitation, was received with full honours, including the playing of national anthems and a guard of honour, which he reviewed.

The leaders introduced their respective delegations, which included Deputy Prime Minister and Foreign Minister Muhammad Ishaq Dar, Defence Minister Khawaja Muhammad Asif, Information and Broadcasting Minister Attaullah Tarar, and Special Assistant to PM Tariq Fatemi. Prime Minister Shehbaz also laid a wreath at the monument of Tajikistan's national hero Ismail Somoni, a revered historic figure who significantly developed the region during his rule in the 9th and 10th centuries.—RT/Agency

## Justice Minallah Slams ECP For Misinterpreting SC Verdict In Reserved Seats Case

ISLAMABAD: Supreme Court Justice Athar Minallah said Tuesday that it is a "proven fact" that the Election Commission of Pakistan (ECP) misinterpreted the apex court's verdict denying the Pakistan Tehreek-e-Insaf (PTI) of its "bat" symbol over failure to hold valid intra-party polls.

"Should the court give its validation to an unconstitutional interpretation done by a constitutional body? [...] Do you want us to re-visit the doctrine of necessity?" Justice Minallah remarked.

His remarks came as a 13-member global SC bench heard the Sunni Ittehad Council's (SIC) plea against the Peshawar High Court's (PHC) verdict upholding the Election Commission of Pakistan's (ECP) decision denying them the reserved seats.

The bench, led by Chief Justice of Pakistan (CJP) Qazi Faez Isa, comprises Justice Syed Mansoor Ali Shah, Justice Muneeb Akhtar, Justice Yahya Afridi, Justice Amin-ud-Din Khan, Justice Jamal Khan Mandokhail, Justice Muhammad Ali Mazhar, Justice Syed Hassan Azhar Rizvi, Justice Shahid Waheed, Justice Irfan Saadat Khan and Justice Naem Akhtar Afghan.



During the hearing today, Attorney General of Pakistan (AGP) Mansoor Usman argued that independent candidates are considered to be a part of a political party if they join it.

"The question is whether independent candidates can join the SIC under Article 51?" the AGP said.

At this, Justice Minallah stressed that a political party has rights under Article 51 of the Constitution and remarked that people voted for a political party, however, the ECP excluded a political party from the polls. The attorney general further contended that independent candidates can neither form a parliamentary party nor they can join a political party which doesn't have the status of a parliamentary party. Additionally, SIC lawyer Faisal Siddiqui submitted the notification issued by the National Assembly Secretariat regard-

ing Zartaj Gul's appointment as parliamentary leader and argued that the ECP—in its response—acknowledged the independent candidates' joining of the SIC. This prompted Justice Muneeb to remark that the electoral body was in fact accepting the independent candidates as belonging to the SIC. "Now, the ECP's own record is accepting these people as belonging to the SIC [...]. I tell me how is the ECP depriving them of the reserved seats despite acknowledging them as a parliamentary party?" the judge questioned, adding that independent candidates become a parliamentary party if they join a political party. Furthermore, Justice Ayesha questioned how could the electoral body consider the SIC a parliamentary party when it doesn't regard it as a political party in the first place.—RT/Agency

## US Labels Imran's Detention As Pakistan's 'Internal Crisis'

WASHINGTON: The US State Department has said that the detention of former prime minister Imran Khan is an internal matter for Pakistan.

This statement was part of a broader discussion during a recent press briefing where Vedant Patel, Principal Deputy Spokesperson of the State Department, addressed various concerns involving Pakistan and Afghanistan.

Patel addressed the United Nations arbitrary detention committee's declaration that Khan's detention was illegal and deferred to the UN for further clarification on their statement, emphasising that the US has no additional assessment to offer on the matter.

Yesterday, a UN human rights working group stressed that the former premier's detention is arbitrary and in violation of international law, adding the jailed politician should be released immediately.

It also alleged "wide-



spread fraud on election day, stealing dozens of parliamentary seats."

The department further reiterated its call for Pakistan to respect human rights and fundamental freedoms, including freedom of expression, freedom of association, peaceful assembly, and freedom of religion.

"We urge the government of Pakistan to respect human rights and fundamental freedoms, including the freedom of expression, freedom of as-

sociation, peaceful assembly, and the freedom of religion as well," he said.

To a question about the credibility of Pakistani elections and allegations of massive rigging, Patel said Pakistani elections continued to be an area of focus for the US.

"This is something that we have continued to raise with our partners in Pakistan, yes. That continues to be an area of focus of ours."—RT/Agency

## Government Tarnishing Country And Military's Reputation: Bushra Bibi



ISLAMABAD: Bushra Bibi, the jailed wife of Pakistan Tehreek-e-Insaf (PTI) imprisoned founding leader Imran Khan has said that the government is responsible for bringing disrepute to the country and its military.

While having an informal conversation with journalists at Adiala Jail, Bushra Bibi stated that in the afterlife, there are two places: Alim Barzakh, where there are muttaqis, abstainers, and righteous people, while the other is the prison where souls come to Earth, where there is a place where there is a government of devils.

She went on to say that the country is ruled by fraudsters and thieves, and labelled every individual within the government as the devil.

Bushra, who was sen-

tenced to 14 years in prison on January 31 along with Imran in a gift repository case, was confined to a room at Bani Gala which was declared a sub-jail on the order of Islamabad chief commissioner on the same day, January 31. The couple was later acquitted in the case.

Imran Khan and Bushra Bibi were later also convicted in the Nikkah Iddat case in February, just days before the general elections.

Earlier during the day, an accountability court in Islamabad had granted bail to Bushra Bibi, in a £190 million corruption case, providing some relief in the ongoing legal battles faced by the former first lady. However, prison officials stated that she cannot be released due to her conviction in the Iddat case.—RT/Agency

## Government Defends Imran's Arrest As Pakistan's 'Internal Crisis' Amid UN Criticism

## Government Courts Opposition For High-Stakes PAC Chairmanship Negotiations

ISLAMABAD: The federal government has contacted the PTI-backed opposition in the National Assembly for appointment of a new Chairman of the Public Accounts Committee (PAC), media reported on Tuesday, citing sources.

Sources told media that Chief Whip Tariq Fazal has written a letter to Leader of Opposition in National Assembly, Omar Ayub, seeking four names for the position of PAC Chairman.

The letter stated that the government wants senior and experienced individuals to be considered for the position, and that the selection will be made through mutual consensus.

A copy of the letter has also been sent to PTI Chief Whip, Amir Dogar.

Earlier, it was reported that Sunni Ittehad Council (SIC) had replaced maverick Sher Afzal Khan Marwat with Sheikh Waqas Akram for Chairmanship of the Na-



tional Assembly's Public Accounts Committee (PAC).

SIC chief Hamid Raza formally apprised the National Assembly (NA) Secretariat about the party's nominee for the slot.

"Sheikh Waqas Akram has been nominated for the chairmanship of the PAC," Hamid Raza told the NA secretariat.

It is pertinent to mention here that the slot became a bone of contention and triggered a tug-of-war between senior Pakistan Tehreek-e-

Insaf (PTI) members as Sher Afzal Marwat, who was earlier named by the party, openly criticised the party leadership.

Earlier on May 11, the PTI issued a show-cause notice to Sher Afzal Marwat for making 'irresponsible' statements.

The notice was issued by PTI Secretary General Omar Ayub Khan who asked Marwat to explain his statements within three days, which have been deemed damaging to the party's reputation.—RT/Agency

## ECP Issues Ultimatum: Parties Must Submit Financial Statements For 2023-24 By August 29



ISLAMABAD: The Election Commission of Pakistan (ECP) has advised political party heads to file their 'Consolidated Statement of Accounts' for the financial year 2023-24 (ended on June 30) on Form-D by August 29. This directive follows section 210 of the Elections Act, 2017, according to a press release issued on Tuesday. Section 210 mandates that political parties must submit a consolidated statement of accounts, audited by a Chartered Accountant, within sixty days of the financial year's end.

This statement must include details of annual income and expenses, funding sources, and assets and liabilities. The submission to the ECP must be complete, including an auditor's report on the party's accounts and a certificate from an authorised party official stating no prohibited funds were received under the Elections Act, 2017. This ensures an accurate financial representation of the party Form-D, as outlined in the Elections Act, 2017, is available free of charge at the ECP Secretariat in Islamabad. Provincial Election Commission offices in Punjab, Sindh, Khyber Pakhtunkhwa, and Balochistan, and on the ECP website. Additionally, political party leaders must provide an attested copy of the Auditor's Membership Certificate from ICAP and the latest renewal certificate with Form-D.—RT/Agency

Kanwal Shauzab alleged that the ECP has violated Article 17 of the constitution of Pakistan by unjustly delisting the largest party—PTI. She also claimed that the PTI candidates were pressured to contest as independent candidates.—RT/Agency

## Muhammad Zubair Slams Government For Burdensome Tax-Heavy Budget

KARACHI: The former governor of Sindh, Muhammad Zubair, voiced his concerns regarding the newly imposed taxes on the salaried class in the budget 2024-25, media reported on Tuesday.

In a discussion on private TV, the former governor criticized the unequal tax imposition by the federal government, stating that both direct and indirect taxes have affected salaried citizens.

"If everyone was taxed equally, no one would ob-

ject," Zubair said. He pointed out that the new budget includes not only a tax but also an additional surcharge on the salaried class.

Responding to a question, he noted that the current government is unpopular among the salaried and middle-class sections, who traditionally do not favor the Pakistan Peoples' Party (PPP) and Pakistan Muslim League-Nawaz (PML-N).

Addressing the issue of

rising electricity bills, Zubair predicted that prices of electricity bills are expected to increase by 20 percent.

"If a consumer have to pay a bill of Rs 100 today, it will be Rs 120 soon. People do not understand the reason behind constant increase in bills," he remarked. Opposition, he remarked. Opposing the nature of taxes imposed, Zubair expressed argued that despite higher taxes, the revenue remains unchanged, making them ineffective.—RT/Agency
