Bilawal Lambasts PML-N Government's Strategy In Budget 2024-25

QUETTA: Pakistan Peoples Party (PPP) Chairman Bilawal Bhattu-Zardari has once again criticised its key ally in the Centre, the Pakistan Muslim League Nawaz (PML-N), for what he said not taking his part's input in the preparation of the Budget 2024-25.

"The opposition should be engaged in matters related to budget and economy. The government's strategy regarding the budget was very weak," said Bilawal addressing a press conference flanked by Balochistan Chief Minister Sarfaraz Bugti at the CM House in Quetta on Friday.

"The overall economic situation in the country has attracted criticism from various quarters," the PPP chief said adding that the allies of the ruling coalition would have been approached, had there been a consultation process in place.

Bilawal's criticism comes after the tax-heavy budget cruised through the National Assembly following its endorsement by the ruling alliance, including



the PPP. On June 30, President Asif Ali Zardari green-lighted the Finance Bill 2024, which went into effect on July 1, which marks the beginning of the next fiscal year.

The federal government presented the tax-loaded Rs18 877 trillion budget for fiscal year 2024-25 (FY25) two weeks ago, drawing sharp criticism from opposition parties, which termed it "economic terrorism" against the people.

"The PPP sticks to what it says. We are not forcing that all our recommendations should be accepted," Bilawal said adding that the PPP-led government would bring everything to the lower and upper houses of parliament after creating

consensus in its 2008-13 stint in power in the Centre. Responding to a question on election rigging, he said that the PPP witnessed rigging in every election, adding that free and fair elections would benefit the PPP eventually.

The PPP's political rivals are destined to wail and wince whether they win the elections or lose them.

He also said that the party would send its representatives to the All Parties Conference (APC) being convened by the federal government to evolve consensus on the newly launched Operation Azm-e-Istehkam. The PPP will put forward its stance regarding the situation in Balochistan, said Bilawal.—RT

Military's Bold Response To Azm-e-Istehkam Operation Criticism

RAWALPINDI: The top military brass on Friday denounced the undue criticism against the newly launched anti-terrorism operation, Azm-e-Istehkam (Resolve for Stability), stating that the "vision" was being misrepresented deliberately for "vested interests".

The statement came after the 26th Corps Commanders' Conference (CCC) held at the General Headquarters (GHQ) in Rawalpindi with Chief of Army Staff (COAS) General Syed Asim Munir in the chair, according to the Inter-Services Public Relations (ISPR).

It said the forum undertook a comprehensive review of the internal and external security situation of the country and had a detailed discussion on various aspects of "Azm-e-Istehkam".

The military's media wing said the new operation



is aimed at harnessing the national counter-terrorism efforts in a synchronised manner to dismantle the nexus of terrorism and illegal spectrum in the country for enduring stability and economic prosperity.

"Forum noted with concern the unwarranted criticism by some quarters and deliberate misrepresentation of the vision, only for furthering their vested interests," said the ISPR.

"The forum affirmed that military leadership is cognizant of the full spectrum of

sow discord through peddling of blatant lies, fake news and propaganda," the military's media wing said.

It said that the armed forces and the nation are fully aware of all such machinations and stand united and committed to defeating the "notorious designs of the enemies".

Moreover, the military top brass also deliberated upon the regional security situation, especially Afghanistan, and reaffirmed its commitment to regional peace and security.

They expressed solidarity with the people of Kashmir and Palestine and condemned serious human rights violations, war crimes and genocide being perpetrated in Kashmir and Gaza.

The forum paid rich tribute to the supreme sacrifices of martyrs of the armed forces, Law Enforcement Agencies (LEAs) and the citizens of Pakistan who

have laid their lives for peace and stability in the country.

It also renewed the resolve to continue full support of ongoing efforts in uplifting socioeconomic growth and wholeheartedly assisting the government in curbing all illegal activities that hamper investors' confidence, economic stability and growth.

Expressing satisfaction with the army's commitment to national security, COAS Gen Munir stressed upon maintaining high standards of professionalism and operational preparedness.

In his concluding remarks, the army chief stated that the Pakistan Army has always been fully prepared to thwart all internal and external challenges and play its due role in the stability and prosperity of the country, regardless of the challenges posed, the military's media wing added.—RT/Agency

Imran Affirms PTI's Participation In APC Despite Reservations On Operation Azm-e-Istehkam

RAWALPINDI: Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan said Friday that his party would participate in the all-parties conference (APC) in which the government is expected to take political parties into confidence over Operation Azm-e-Istehkam.

"My party will participate in the all-parties conference and hear what the government has to say," the PTI founder told reporters as he appeared in a case at Rawalpindi's Adiala jail, where he is imprisoned.

The PTI founder, while noting that his party has reservations over the new anti-terrorism action, said it would "only lead to further instability" in the country.

With terrorism on the rise, the government has launched a reinvigorated and re-emergised national counter-terrorism drive, which would be intelligence-based operations' focused. Khan's comments came after media reported that Prime Minister Shehbaz Sharif has decided to organise an APC "to gain political parties' confidence" in newly announced Operation Azm-e-



Istehkam. PM Shehbaz will hold consultations to decide on the date of the APC, the sources said, adding that the date would be announced later.

The federal cabinet last week approved the launching of the counter-terrorism operation following the National Action Plan's Central Apex Committee's recommendations to turn up the heat on militants targeting Pakistan.

However, opposition parties including the PTI, Jamiat-e-Ulema Islam Fazl (JUI-F), Awami National Party (ANP), and others have voiced concerns over the military operation, demanding that parliament must be taken into confidence before taking any such decision.

In response to the criticism, the PMO had clarified that "no large-scale military operation is being launched" in the country.

"The recently announced vision for enduring stability named Azm-e-Istehkam is being erroneously misunderstood and compared with earlier launched kinetic operations like Zarb-e-Azab, Rah-e-Najata etc.," read a statement issued by the PMO on June 24. The federal government had further stated that there are no such no-go areas in the country since the ability of terrorist entities to carry out large-scale organised operations inside Pakistan was decisively degraded by earlier kinetic operations.—RT/Agency

Imran Threatens Hunger Strike, Escalating Protest Against Government: Ali Muhammad Khan



ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) leader Ali Muhammad Khan has said that the PTI founder may go on hunger strike after consulting his colleagues.

Talking to the media, Ali Muhammad Khan said that the trial of the PTI founder in the Al-Qadri Trust case was held in Adiala Jail.

He said that the founder of PTI had said that if the cruelty against him does not stop, he will observe a hunger strike in the jail.

The PTI leader further questioned why is there no political solution to these issues.

He would not bow. PTI founder while giving a message to the workers about the

Islamabad rally said that his message was true freedom. The PTI founder further said that there will be no compromise on real freedom.

He said that the PTI founder said that slavery is not allowed in any case. Everyone is free to give his opinion. Talking about news of differences, he said that there is no grouping in the party. "There is only one group, that is the founder PTI group." He said that the PTI founder will decide who may come to the party.

Pakistan Pushes For Enhanced Relations With UK Following Keir Starmer's Election Triumph

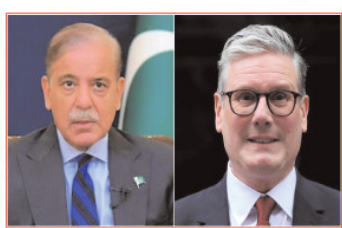
ISLAMABAD: Pakistan Friday congratulated UK Prime Minister-elect Keir Starmer after his party won a landslide victory in the British general elections, seeking to further boost the ties between the two nations.

Starmer's centre-left Labour won a massive majority in the 650-seat parliament. Rishi Sunak's Conservatives suffered the worst performance in the party's long history as voters punished them for a cost of living crisis, failing public services, and a series of scandals.

Taking to X, Prime Minister Shehbaz Sharif felicitated his British counterpart Keir Starmer on the landslide victory of the Labour Party in the general elections.

"Looking forward to working closely with the new UK government, under Sir Starmer's wise and able leadership, to further strengthen and broaden the Pakistan-U.K. partnership," he added.

He noted that Pakistan and the UK share deep-rooted and broad-based ties founded in shared history and people-to-people contacts.



"I am confident that under his stewardship our relationship will be further strengthened and we can work together for global peace, prosperity and development," he added.

The election result has upended British politics. Labour won more than 410 seats, an increase of over 210, while the Conservatives, the western world's most successful party, lost about 250 lawmakers, including a record number of senior ministers and former Prime Minister Liz Truss.

A glum Sunak conceded defeat and will meet King Charles later to formally resign before Starmer is appointed in his place. "Today power will change hands in a peaceful and orderly manner, with goodwill on all sides,"

Sunak said. "There is much to learn and reflect on and I take responsibility for the loss to the many good hard-working Conservative candidates... I am sorry."

In his victory speech, Starmer said: "We did it. Change begins now... We said we would end the chaos, and we will, we said we would turn the page, and we have. Today, we start the next chapter, begin the work of change, the mission of national renewal and start to rebuild our country."

The election victory represents an incredible turnaround for Starmer and Labour, which critics and supporters said was facing an existential crisis just three years ago when it appeared to have lost its way after its 2019 drubbing.—RT/Agency

Dar Extends Congratulations To Starmer On Labour Party's Triumph In UK Elections

ISLAMABAD: Deputy Prime Minister and Foreign Minister Muhammad Ishaq Dar has congratulated Keir Starmer, the leader of the UK's Labour Party, on the party's historic victory in the parliamentary election.

In a statement posted on his X timeline, Dar extended "heartfelt felicitations" to Starmer, expressing confidence that the "deep-rooted and broad-based ties" between Pakistan and the UK, founded on shared history and people-to-people contacts, will be further strengthened under Starmer's leadership. DPM Dar expressed optimism that the two countries will work together to promote global peace, prosperity and development.

Earlier today, the Labour Party under the leadership of Keir Starmer emerged victorious in the United Kingdom's general election, end-



ing 14 years of Conservative rule. Starmer is poised to become the country's next prime minister, replacing outgoing Prime Minister Rishi Sunak. World leaders, including the presidents of Israel and Ukraine, as well as the prime ministers of Canada, Australia, and New Zealand, have extended their congratulations to Keir Starmer on his party's landslide victory. They have expressed optimism for continued cooperation and the strengthening of bilateral ties under the new Labour government. The Labour Party is projected to secure a significant majority

in the 650-member House of Commons, with forecasts indicating they will win 410 seats. The Conservatives are expected to hold 144 seats, while the centrist Lib Dems are anticipated to claim 58 seats. Sunak, the outgoing Conservative Prime Minister, has gracefully acknowledged the electorate's verdict, conceding defeat to Starmer's Labour Party. This paves the way for a smooth transition of power, with Starmer set to assume the role of prime minister within 24 hours.

In his victory speech, Starmer pledged a vision of "national rejuvenation" with a focus on putting the country's interests above partisan concerns. The Labour leader expressed delight as his party is poised to secure a considerable majority in Parliament, paving the way for significant changes under his leadership.—RT/Agency

ATC Withdraws Arrest Warrants Against KP CM Gandapur Amid Controversy



ISLAMABAD: An anti-terrorism court (ATC) in the federal capital withdrew arrest warrants of Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur issued in the case pertaining to violent protests and violation of Section 144.

Gandapur had filed a petition seeking suspension of the arrest warrant in the case registered against him at the 1-9 Police Station in the federal capital. The KP CM surrendered before the court, saying that he could not attend the hearings earlier due to official engagements.

On July 2, the court issued non-bailable arrest warrants against Gandapur and other PTI leaders, warning that they would be declared proclaimed offenders if they continued to remain absent.

Gandapur had filed a plea seeking exemption from attending the hearing, saying that he was out of the city. However, Judge Tahir Abbas Sipra had termed the reason as invalid. Gandapur's counsel had then requested the court for another opportunity, assuring his client would appear in the next hearing.—RT/Agency

Electricity Tariff Hiked By Rs3.33 Per Unit, Sending Shockwaves Through Consumers

ISLAMABAD: The National Electric Power Regulatory Authority (Nepra) on Friday notified an additional fuel cost adjustment (FCA) of Rs3.33 per unit for electricity consumed in May, media reported.

According to an order issued by the regulator, Nepra "reviewed and assessed a National Average Uniform increase of Rs3.3287/kWh in the applicable tariff for XWDIS-COs on account of variations in the fuel charges for the month of May 2024."

The "adjustment of Rs3.3287/kWh shall be applicable to all consumer categories except electric vehicle charging stations (EVCS) and lifeline consumers. The said adjustment shall be shown separately in the consumers' bills" based on units billed in May 2024, and it will reflect in the billing month of July 2024. Nepra's notification stated.

Meanwhile, the regulatory authority also notified a tariff reduction of Rs1.67 per unit for K-Electric



consumers on account of fuel cost adjustment (FCA) for April 2024.

"The authority after discussing and incorporating adjustments decided to allow the negative FCA for the month of April 2024, to be passed on to consumers in their monthly bills of July 2024," a separate notification stated.

The "negative adjustment shall be applicable to all the consumer categories except lifeline consumers, domestic consumers consuming up to 300 units, EV Charging Stations and Agriculture Consumers of K-Electric". It added that negative monthly FCA is also applicable to the domestic con-

sumers having Time of Use (TOU) meters irrespective of their consumption level.

"The adjustment shall be shown separately in the consumers' bills on the basis of units billed to the consumers in the month of April 2024", it concluded.

A day earlier, the federal cabinet has approved an increase of Rs5.72 per unit in the basic electricity tariff through circulation.

NEPRA made this decision for the fiscal year 2024-2025, with the implementation set to begin on July 1, 2024. The average basic electricity tariff was approved to be raised from Rs 29.78 to Rs 35.50 per unit.—RT/Agency

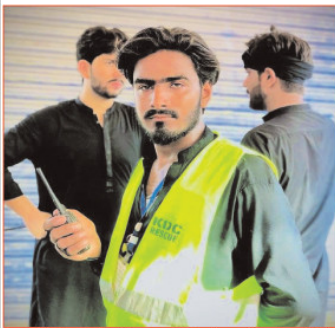

Khairpur woman stripped naked by her in-laws demands justice

KHAIRPUR: In a distressing press conference held at the residence of social activist Shahnaz Shaikh, a woman named Saima Shaikh from Mir Ali Bazaar, Khairpur, has spoken out against the harrowing abuse she endured at the hands of her in-laws. Accompanied by her brother, Saima detailed her ordeal on Friday.

Saima recounted that she was married to Aslam Shaikh, also known as Nadeem Shaikh, a resident of Hyderabad, in 2017. Unbeknownst to her at the time, Aslam was already married. The situation escalated when Saima discovered her husband was attempting to issue B forms for her children in the name of another woman.

Her resistance to this deceit led to severe repercussions. According to Saima, she was stripped and locked in a bathroom for four days without clothes by her husband and brother-in-law, Ghulam Rasool Shaikh. During this period, she was subjected to torture.

Desperate for help, Saima managed to contact a local trader, Tufail Shaikh, who, along with the police and social activist Shahnaz Shaikh, arrived at the residence and facilitated her release.

Saima is now demanding justice for the abuse she suffered, calling for legal action against her husband and brother-in-law. Her plea has highlighted the urgent need for protection and justice for victims of domestic violence in the region.

Education Dept accused of misappropriating Rs 3.1 million of contingency funds in Jhudo

JHUDO: An alleged corruption of 3.1 million rupees has been revealed in the Education Department of Jhudo. Civil society has demanded an inquiry from higher authorities. In the primary section of the Education Department of Jhudo, an amount of 3,187,110 rupees was withdrawn for the purposes of staff uniforms, stationery purchases, furniture repairs, and other purposes under the contingency of four schools. This money was neither spent on the schools nor did the school administration have any information regarding this.

The contingency of the four schools in Jhudo, which includes Government Girls Primary School Jhudo, Government Boys Primary School Main Jhudo, Government Boys Primary School Naukot, and Government Boys Primary School Ganj Bakhs, was involved.

In this regard, political and social leaders of Jhudo, including Muhammad Nawaz, Ali Hassan Khan, Muhammad Asif, Muhammad Ashraf, Shahid Ahmed, Sajjad Ahmed and others have demanded from the Provincial Education Minister, Education Secretary, and other higher officials to conduct a transparent inquiry into the embezzlement of funds allocated for the improvement of schools and education, and to take strict action against the officers involved in the corruption.

Manchar Rehabilitation Movement demands historic lake's restoration

SEHWAN SHARIF: The Manchar Rehabilitation Movement has staged a protest outside the Selwan Press Club, demanding the restoration of Manchar Lake to protect the residents of Taluka Selwan from potential floods. Leaders Imam Ali Detho, Manzoor Ahmed Jamali and Kamaluddin Khakheli held a press conference, stating that due to the Sindh Government's negligence, the condition of Manchar Lake is worsening. They highlighted that since the great flood of 1942, there have been seven significant floods in the area, occurring roughly every 12 years. Currently, the area between Sehwan and Bhan Syedabad has become "Manchar's Kacho," a 182-square-kilometer stretch that experiences recurring floods. The devastating floods of 2022 caused extensive damage, displacing homes, destroying millions of acres of crops and resulting in significant property losses. The

government's assistance has been minimal, providing only Rs 300,000 to build a single row for the affected families, a scheme that is now in its third year. The leaders expressed their disappointment over the lack of comprehensive government support. After the last flood, the Manchar Rehabilitation Movement organized a high-level conference in Sehwan, involving water experts, relevant government officials, civil society members and World Bank representatives.

The conference aimed to provide useful recommendations for aiding flood victims and restoring Manchar Lake. The leaders urged the Sindh Government to strengthen and widen the lake's banks with stone pitching, but pointed out that the MNV drain remains neglected. The MNV banks are eroded due to the previous flood, and immediate repairs are needed from Zero Point to 20 RDs to prevent the embankment from breaking during heavy water flows, which could result in another catastrophic flood in the area. The leaders called on the Sindh Government to restore Manchar Lake to its original state, approve a flood canal for Manchar and stop the discharge of water into the lake through the MNV drain to save the distressed local population from potential flood devastation.

NOC Suspended For PTI's Public Gathering In Islamabad

ISLAMABAD: Islamabad Chief Commissioner on Friday suspended the no-objection certificate (NOC) issued to Pakistan Tehreek-e-Insaf (PTI) for public gathering just a day before the scheduled meeting, media reported.

The decision was made during a meeting chaired by the Islamabad Chief Commissioner, wherein security agencies expressed their reservations about the potential risks associated with the rally.

During the meeting, the participants reviewed the applications related to the rally and the Deputy Commissioner's prior permission.

The Chief Commissioner, after reviewing the requests and security concerns, decided to suspend the NOC for the meeting.

According to the authorities, the decision to suspend the NOC was made to ensure the maintenance of law and order in the city. The authorities have emphasised that the safety of the citizens is their top priority, and all necessary measures will be taken to ensure that peace and tranquility are maintained in the city.

Earlier, the district administration of the federal capital granted permission to the PTI to hold a public gathering on July 6 near Tarnol Chowk.

After the NOC was issued, the Islamabad High Court (IHC) disposed of the application for the issuance of NOC for a meeting. Justice Babar Sattar of the Islamabad High Court heard the petition seeking permission for the PTI's meeting in the federal capital.—RT/Agency

Energy Minister Urges Urgent Overhaul Of Power System

ISLAMABAD: Energy Minister Awaiz Ahmad Khan Leghari informed the Upper House on Friday that Pakistan's entire electricity system is outdated and requires a complete overhaul.

Addressing a calling attention notice from Senator Falak Naz regarding excessive and unannounced load shedding in Upper and Lower Chitral, which has been causing significant problems for residents, Leghari assured that the electricity system would be fully restored within two weeks.

He explained that the Golan Gol Hydropower Project, which generates 108 megawatts of electricity, had ceased power generation due to technical issues.

The alternative solution was to supply electricity from the national grid through PESCO, but the line



managed by WAPDA also experienced faults, exacerbating the problem. However, teams are working on an urgent basis to restore electricity in Chitral.

The minister apologized for the inefficiency of employees and emphasized that without a complete overhaul, no substantial improvements could be expected in the system. "Our actions are

yielding good results, and we are working diligently to restore electricity for the people of Chitral," he stated.

Senate Chairman Syed Yousaf Raza Gillani assured Senator Naz that the issue would be addressed when the Ministry briefs the Committee of the Whole of the Senate on the power crisis.—RT/Agency

The Punjab government has recommended to the ban social media to control spread of hate material and misinformation to avoid sectarian violence.—RT/Agency

Punjab Introduces Key Performance Indicators To Evaluate Performance Of Police Officers



LAHORE: The Punjab government has introduced a Key Performance Indicators (KPIs) to evaluate the performance of police officers across the province, media reported on Friday.

The performance-based evaluation system is based on 33 key performance indicators (KPIs) that will be used to evaluate the performance of police officials.

According to the system, officials will be awarded marks for achieving specific targets, such as: Three points for resolving cases promptly, three points for reducing crime rates, four points for preventing kite flying and aerial firing and four points

for foiling terrorist plots and making arrests in high-value operations.

On the other hand, officials will be penalised for under-performance, including: three points deducted for failing to resolve cases within a specified timeframe and three points deducted for failing to reduce crime rates.

The performance-based evaluation system will also lead to the transfer of officers who fail to perform well for three consecutive months. Meanwhile, station house officers (SHOs) and In-charge investigation has been briefed on the new numbering system.—RT/Agency

Punjab Seeks Deployment Of Pakistan Army And Rangers To Aid Police For Muharram Security

LAHORE: The Punjab government on Friday requested the deployment of the Pakistan Army and Rangers to assist the provincial police in establishing "peace and order" during the month of Muharram.

A statement issued by the Punjab Home Department's spokesperson said the provincial government had sought the services of 150 contingents of the military and Rangers following the requirements of different districts.

It added that a letter was written in line with the police's request for cooperation

in maintaining security and the services of 60 army contingents and 81 Rangers contingents were sought.

"Law enforcement agencies will render their services for the peaceful observance of Muharram," the statement said.

Akin to Punjab, a security plan has also been formulated in Rawalpindi, under which over 7,500 police personnel and two contingents of the military and Rangers will be on standby to deal with any emergency.

Each year, law enforcement agencies develop comprehensive security plans to prevent untoward incidents during the Islamic month, especially when mourning processions are held on the 9th and 10th of Muharram across the country.

In the past, militants have targeted Muharram processions several times, including a bomb blast that killed more than 40 people attending the main Ashura procession on Karachi's M. Jinnah Road in December 2009.—RT/Agency

Enough Is Enough!

The recent suspension of the no-objection certificate (NOC) for Pakistan Tehreek-e-Insaf (PTI)'s public gathering in Islamabad raises serious concerns about the state of democratic freedoms in our country. Such actions, reminiscent of repressive measures from our colonial past, only serve to fuel public discontent and bolster support for the PTI. History has repeatedly shown that attempts to stifle political dissent through administrative hurdles often backfire, leading to increased popular sympathy and mobilization.

The decision to suspend the NOC, purportedly due to security concerns, underscores a worrying trend where legitimate political activities are curtailed under the guise of maintaining law and order. While ensuring public safety is crucial, it should not come at the expense of fundamental

democratic rights, including the right to peaceful assembly and expression.

The PTI's determination to proceed with the public gathering despite the suspension demon-

Mangrio to leave. Upon his refusal, he was threatened and his access to the village shrine was restricted. Mangrio shared his ordeal on social media, and in retaliation, the Khari community blocked the entrance to his home to pressure him into leaving. He named Khalifo Waryam Faqir Khaskheli, Albelo Mangrio and Rafiq Khari as responsible if any harm comes to him or his family. He condemned this act as outright thuggery and highlighted the Sanghar police's incompetence and corruption, accusing them of ignoring the situation in exchange for bribes. The journalist community has called on the SSP of Sanghar to take action against the Khari community members challenging the rule of law and to hold the SHO of Sanghar accountable for his failure to address the situation.

Pakistan to host England for Test series in October



LAHORE: The Pakistan Cricket Board today announced the full match schedule for the Pakistan Men's Test Series against England in October 2024.

The tour begins with the First Test in Multan from October 7-11, before moving to Karachi for the Second Test from October 15-19. The Third Test will be in Rawalpindi from October 24-28.

The three-match series forms part of the ICC World Test Championship 2023-25. It will be the second time England Men have played Test series in Pakistan in under two years, with England having won the last series 3-0 in December 2022.

Richard Gould, ECB Chief Executive Officer, said: "We're really excited to be returning to Pakistan for this three-match Men's Test tour in October.

"Our last Men's Test tour of Pakistan produced some memorable matches and I'm sure fans can look forward to more exciting cricket across this forthcoming series."

It is worth mentioning here that the three-match home Test series against England is part of the Pakistan men's cricket team's busy home international season 2024-25.

Besides England, Pakistan will host Bangladesh for a two-match Test series in August, followed by a three-match series against West Indies in January next year while they will play two away Tests against South Africa in December-January.

The nine Tests against Bangladesh, England, South Africa and the West Indies will be part of the ICC World Test Championship 2023-25. To date, Pakistan has played five Tests in two series against Sri Lanka and Australia, winning two and losing three. This has placed them in fifth position on the points table with 22 points.

India leads the table with 74 points after three series, followed by Australia (90 points from four series), New Zealand (36 points from three series), and Sri Lanka (24 points from two series). With each of the top nine Test-playing nations scheduled to play six series (three home and three away) in the ICC World Test Championship 2023-25 cycle, strong performances in the upcoming four series could put Pakistan in contention for a place in the final, scheduled for Lord's in June 2025.—Agency

Top teams set to tour Pakistan as PCB announces bumper schedule for 2024-25 season

Whereas, the West Indies will visit here for two Tests - in Karachi (January 16-20) and Multan (January 24-28). Additionally, New Zealand and South Africa will participate in an ODI tri-series in Multan from February 8 to 14.

PIR JO GOTH: A longstanding dispute between the families of Azizullah Kharos and Jamal Kharos in village Qaisar Bindi, Kingri, erupted into a tragic and violent confrontation. During the early morning hours, armed assailants, reportedly led by a stepbrother, launched a deadly attack on the household of Bilawal Kharos.

The assailants indiscriminately opened fire, resulting in the fatal shooting of Bilawal Kharos, who was

asleep at the time, and his 4-year-old daughter, Farhana Kharos. Bilawal's wife, Soorat Khatoon, sustained severe injuries during the assault. The attackers fled the scene, continuing to fire shots as they escaped. Local law enforcement swiftly responded to the incident, rushing Soorat Khatoon to Pir Jo Goth Hospital for emergency medical treatment. She was later transferred to Khairpur Hospital for further care. Meanwhile, the bodies of Bilawal Kharos and Farhana Kharos

were handed over to their grief-stricken relatives, sparking profound mourning within the community. Despite the gravity of the incident, authorities have yet to file a formal case or take decisive action to quell the escalating conflict. The deteriorating law and order situation, compounded by unresolved tribal disputes, has left residents in Kingri grappling with fear and uncertainty. Some community members are now contemplating relocation in search of safety and security amidst ongoing tensions.

Utility Stores Employees Arrested for Extortion Attempt

SUKKUR: In a startling development, police in Sukkur apprehended two Utility Stores employees for attempting to extort money from their Zonal Manager, Qaiser Saeed. Following swift action through alleged involvement with local criminals known as Katcha dacots.

Reports indicate that four individuals, including Moazzam Ali, Izhar Ali, and Liaquat Ali, all employees of Utility Stores, were implicated in demand-

ing Rs4 million as ransom from their superior. The scheme involved leveraging the threat of Katcha dacots to intimidate the Zonal Manager into compliance. Following swift action by law enforcement, two of the accused have been arrested and are currently on physical remand. Authorities continue their efforts to locate and apprehend the remaining suspects involved in the extortion plot, including another Utility

Stores staff member and an alleged dacot.

The incident highlights growing concerns over criminal activities involving Katcha dacots in Sindh, particularly concerning incidents of kidnapping for ransom that have seen an uptick in recent times. Police efforts to dismantle such networks remain ongoing as they strive to ensure public safety and uphold the rule of law in the region.—RT

18-year-old girl electrocuted in Larkana

LARKANA: A devastating incident occurred in Naudero, where 18-year-old Sitara Shaikh, daughter of Abdul Sattar Shaikh from the Gerag Shah neighborhood, tragically lost her life due to electrocution. The incident occurred while she was attempting to fix a wire of a fan into an electric board, resulting in immediate loss of consciousness.

In a rush of panic and concern, Sitara's family swiftly transported her to the emergency department of CMC Hospital in Larkana. Despite the best efforts of medical staff, doctors confirmed her untimely death upon arrival.

Following necessary procedures, Sitara Shaikh's body was respectfully handed over to her grieving family by hospital authorities. The entire community is deeply saddened by this unfortunate

loss, and condolences pour in for the Shaikh family during this difficult time.

The incident serves as a poignant reminder of the critical importance of electrical safety measures and vigilance in households. Authorities are expected to conduct an investigation into the circumstances surrounding Sitara Shaikh's tragic accident to prevent similar incidents in the future.

Sindh CM Engages World Bank In Bold Keenjhar Lake Expansion Talks

KARACHI: Sindh Chief Minister Syed Murad Ali Shah met with a World Bank delegation led by Country Director Najib Benhaiane to discuss increasing the storage capacity of Keenjhar Lake to manage Karachi's growing water demand. The project, estimated to cost around \$300 million, includes improving the KB Feeder Lower Canal System, extending Keenjhar Lake, and developing social and environmental plans.



Minister Irrigation Jam Khan Shoro provided details on the Keenjhar Lake expansion and KB Feeder improvement projects. Additionally, a detailed feasibility study for modernizing the right bank canals of Sukkur Barrage will be conducted under the Sindh Water and Agriculture Transformation Project (SWAT) at an estimated cost of \$200 million.

Petroleum Dealers Call Off Nationwide Strike, Avert National Crisis

KARACHI: The Pakistan Petroleum Dealers Association (PPDA) announced the immediate cessation of the nationwide petrol pump strike on Friday.



At a press conference in Karachi, PPDA Chairman Abdul Sami Khan, accompanied by other officials, disclosed the decision to halt the strike. "We have decided to end the strike immediately due to the plight of tourists stranded in northern areas. While our one-day strike was successful, it has adversely affected daily commuters," Khan stated.

He elaborated that tourists in Malakand, Swat, and Hazara regions were a primary consideration in ending the strike. "The decision to strike was not taken lightly, especially against the taxes introduced in the federal budget resulting in the closure of some petrol stations across many cities and major highways. However, most petrol pumps in major cities like Lahore and Karachi remained operational. Despite several petrol pumps in Karachi being closed on Friday morning, others continued to function as usual, notably along Rashid Minhas Road, University Road, and Shahrah-e-Faisal. Conversely, a majority of fuel stations in Lahore did not participate in the strike. The Petroleum Division and the Oil and Gas Regulatory Authority (OGRA) issued directives to ensure continuous operation of petrol pumps.—RT/Agency

FPCCI Demands Immediate Cancellation Of Exploitative IPP Contracts

KARACHI: Acting President of the Federation of Pakistan Chambers of Commerce and Industry (FPCCI), Saqib Fayyaz Magoon, has urged the federal government to cancel all agreements with Independent Power Producers (IPPs) and procure electricity from cheaper, cost-effective sources without capacity charges.

Mr. Magoon highlighted that exorbitant electricity tariffs have led to widespread industrial closures and massive job losses. Despite an installed generation capacity of over 40,000 MW, the peak demand and transmission capacity is only 25,000 MW, resulting in significant excess generation capacity. He noted that PKR 2 trillion in capacity payments to 40 companies is paralyzing the national economy, with IPPs receiving payments even when no electricity is generated. Capacity charges make up two-thirds of the total electricity cost, while fuel costs are only one-third. Studies show that IPPs have been enjoying returns exceeding 73% in dollar terms, which is unusually high by international standards. Problematic contracts since the 1994 Power Policy have led to escalating circular debt, reaching PKR 2.64 trillion in February 2024. Mr. Magoon pointed out that guarantees indexed to the US dollar increase returns for IPPs with any depreciation of the Pakistani rupee, adding a financial burden on the government and public. Initial return on equity for IPPs was set at 18% and later reduced to 12% in the 2002 Power Policy, still high compared to global norms. Cost comparisons reveal that many IPPs were funded through inflated invoicing on capital goods, leading to perpetual returns on ghost equity. The tariff for coal-based plants in Pakistan is 9 cents per kWh, compared to 5.6 cents in Bangladesh. Imported coal-based plants have the highest capacity charge of PKR 60.48 per kWh. Mr. Magoon stressed that misreporting and overbilling by IPPs are common, with actual oil consumption and operational costs overstated. The recent surge in electricity rates could trigger civil unrest and discontent among the business community. FPCCI demands a comprehensive review of IPP agreements, price re-evaluation, and improved oversight to prevent over-invoicing. The federal government must devise a strategy to ensure affordable electricity prices for the industry in the national interest.—RT

UAE Aviation Team Praises Pakistani Airports For Impeccable Security Measures



KARACHI: A delegation from the General Civil Aviation Authority (GCAA) of the United Arab Emirates (UAE) has expressed satisfaction with the security arrangements at Karachi and Islamabad airports. Led by Senior Director Mr. Abdullah Al Kaabi, the UAE-GCAA team conducted a thorough aviation security assessment at both airports, which was hosted by PCAA. The assessment covered critical areas such as passenger and baggage screening, cargo handling, and catering security. Additionally, the team reviewed operations of airlines flying directly to the UAE, ground handling agents, regulated cargo entities, and catering services.—RT

PSX CEO Resigns, Shocking Financial Markets

KARACHI: Mr. Farrukh H. Khan has resigned from his position as Chief Executive Officer of Pakistan Stock Exchange Limited (PSX) as of July 4, 2024. Mr. Khan stated that it was a great honor to serve as CEO and expressed his gratitude to all market participants, including domestic shareholders, PSBA, and the media. He also thanked PSX's Board, Chairperson, SECP, and the Chinese Consortium for their consistent support and guidance throughout his tenure.

An emergent meeting of PSX's Board was convened today at 3:00 PM (PST) to consider Mr. Khan's resignation. The Board, with utmost respect for Mr. Khan's decision to pursue other opportunities, accepted his resignation and acknowledged his significant contributions to the progress of PSX and Pakistan's capital markets. The current high performance of the stock exchange is a testament to the strong partnership between the Chairperson and Mr. Khan, who have worked together to elevate PSX's results over the past few years.—RT

KATI President Urges Axing IPP Contracts To Save Economy From Collapse

KARACHI: Johar Qandhari, President of the Korangi Association of Trade and Industry (KATI), has called for the cancellation of contracts with Independent Power Producers (IPPs), citing significant economic harm. Qandhari emphasized that the government's agreements with IPPs, which guarantee payments in dollars, are severely damaging the economy. "The government is buying electricity from these IPPs in dollars and selling it in rupees," Qandhari stated. "Their profits are soaring due to the rupee's devaluation." He pointed out that last financial year, the government paid 1,800 billion rupees to these IPPs, with over 2,100 billion rupees due this financial year.

Qandhari criticized the contracts, noting that some IPPs have not generated any electricity yet receive billions in payments. He described this as a burden on the public exchequer and an oppression of the poor. He also raised concerns about capacity charges imposed on people for unused electricity, calling such agreements unprecedented worldwide. He urged the government to cancel all existing contracts with IPPs and negotiate new ones, stipulating payments in local currency based solely on the amount of electricity purchased. Qandhari emphasized that the current terms, leading to electricity rates exceeding 55 rupees per unit, have caused an economic crisis, inflated production costs, and hindered the competitiveness of Pakistani products in the global market. Qandhari has appealed to the Prime Minister and the Federal Minister of Energy to urgently address this issue to avert further economic instability.—RT

UAE Delegation Lands In Karachi To Propel Pakistani Dates Onto The Global Stage



KARACHI: A delegation from the United Arab Emirates (UAE) has arrived in Karachi to introduce Pakistani dates to the world. The delegation met with the Consul-General of the UAE in Karachi, H.E. Bakheet Ateeq Al-Rumaihi, to discuss ways to increase agricultural production and industrial output in Pakistan. Pakistan ranks fifth in global date production but exports only three percent of its yield. Al-Rumaihi stressed the need to increase Pakistan's exports to boost its economy, highlighting the exceptional quality of Pakistani dates that deserve global recognition.—RT

SSGC Disconnects Gas Supply To PSML Due To Unpaid Bills

KARACHI: Sui Southern Gas Company (SSGC) has taken the decision to disconnect gas supply to Pakistan Steel Mills Limited (PSML) after repeated notices and failed payments. PSML began defaulting on its gas bills partially from November 2008 and completely ceased payments after March 2015. Despite multiple termination notices served by SSGC in July and August 2015 for continuous defaults, SSGC to issue a final disconnection notice.

Efforts by the Federal Government and related ministries to revive PSML, including through various privatization proposals, did not materialize. A recent decision from PSML, communicated after an ECC meeting, indicated a cessation of payments beyond June 30, 2024, prompting SSGC to issue a final disconnection notice. Despite years of support and extensions, including partial payments by PSML since February 2020, outstanding dues have accumulated to Rs. 97.697 billion as of June 30, 2024, including significant late payment charges. SSGC, while expressing regret over the necessity of disconnection, emphasized its long-standing efforts to facilitate PSML's operations amid financial challenges, ultimately compelled by the lack of viable payment solutions and withdrawal of federal support. The discontinuation of gas supply, effective July 4, 2024, marks a critical juncture in the ongoing financial and operational challenges facing PSML, amidst broader efforts to resolve outstanding liabilities and ensure sustainable operations.—RT/Agency

Murad Commands Provincial Narcotics Wing Reinforcement To Crush Drug Epidemic



KARACHI: The Sindh government has decided to further strengthen the Excise & Narcotics Control Department to protect the new generation, especially children, from the dangers of drugs. This decision was made during a meeting chaired by Sindh Chief Minister Syed Murad Ali Shah at the CM House. Senior Minister for Information and Excise & Narcotics, Sharjeel Memon, Chief Secretary Asif Hyder Shah, PSCM Agha Wasif, Secretary of Excise & Taxation Saleem Rajput, DG Narcotics Control Usman Siddiqui, and others attended the meeting. Minister Sharjeel Memon briefed the CM on efforts to control drug peddling in Hyderabad and strict measures taken in Karachi to prevent drug penetration into educational institutions and slum areas. CM Shah highlighted the serious threat of synthetic drugs in schools and called for a coordinated effort between the police, ANF, and the Excise & Narcotics Department to eradicate this issue. The senior minister announced the establishment of Excise & Narcotics checkpoints in Sindh's bordering areas with other provinces, including the revival of the checkpoint at Hub, which was abolished in 2007, to control drug smuggling into Sindh.

CM Shah stated that the Excise & Narcotics Control Department has 47 police stations, including six in Karachi, 11 in Hyderabad, eight in Sukkur, 10 in Larkana, five in Mirpurkhas, and seven in Shaheed Benazirabad. The department also has checkpoints, three each in Karachi and Larkana, and two each in Hyderabad, Sukkur, and Shaheed Benazirabad divisions. Murad Ali Shah directed the Minister of Excise & Narcotics to further strengthen the Narcotics police with necessary equipment, vehicles, and gadgets to ensure they operate at full capacity.—RT

Government Anticipates Imran's Firm Commitment To Azm-e-Istehkam Agenda During APC

ISLAMABAD: Information Minister Attallah Tarar has confirmed media reports that the federal government is planning to hold an all-parties conference (APC) to evolve a broader consensus on the newly launched Operation Azm-e-Istehkam and also 'welcomed' the Pakistan Tehreek-e-Insaf (PTI) founder's statement signalling to attend the key huddle.



The minister's confirmation comes a day after media citing sources reported that Prime Minister Shehbaz Sharif had decided to convene an APC "to gain political parties' confidence as the opposition parties have voiced concerns over the new operation and demanded the government to take parliament into confidence before launching any counterterrorism drive."

"Certainly, consultation is underway with the allies [...] to summon the APC regarding [Operation] Azm-e-Istehkam," the information minister said while addressing the press conference in Islamabad on Friday.

Government Has Splurged Rs9 Billion On Print Media Ads, Rs6 Billion On TV, Reveals Tarar

ISLAMABAD: Information Minister Attallah Tarar shared that the country's newspapers received advertisements worth Rs9 billion while news channels were allocated Rs6 billion in government advertisements.



Responding to Senator Sarmad Ali Khan's query regarding the criteria for news channels and newspapers, the minister emphasised that the newspapers were facing a financial crisis, prompting the current government to provide special attention and support.

Tarar explained that, according to the 1997 Services Manual, advertisements are distributed to news and media outlets. He added that a new advertisement policy was introduced in 2021 and amended in 2022.

"There is no specific criteria to gauge the eligibility of electronic media for advertisements. However, our rates committee allocates advertisements based on the ratings of news channels," he said.

The minister confirmed that no advertisements for any news channel had been halted by the current government. He further clarified that the main criterion for advertisements is to effectively

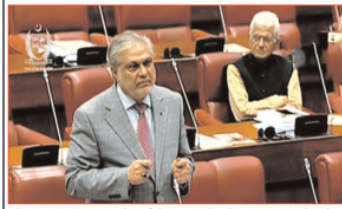

Federal Government Challenges IHC Ruling In Bushra Bibi Audio Scandal, Sparking Controversy

ISLAMABAD: The federal government has challenged the Islamabad High Court's (IHC) order in the Bushra Bibi audio leak case.

The federal government has filed a petition in the Supreme Court against IHC's order.

The plea contended that summoning heads of state institutions and seeking reports from them was equivalent to fact-finding, which was against the court's jurisdiction.

It argued that Najam Saqi's petition was against the parliamentary committee's summons, and that matter had been resolved.

The federal government's plea also mentioned that the IHC was proceeding against points of inadmissible application. It was added that the IHC had no right to take suo moto notice.

IHC's Babar Sattar remarked during the hearing of Bushra Bibi audio leak case: "There is no law regarding phone tapping in the country and what is currently taking place is illegal."

The court ordered the telecommunication companies to refrain from recording phone calls for surveillance purposes.

PM Shehbaz Pushes Tax System Digitization To Curb Billions In Evasion

ISLAMABAD: Prime Minister Shehbaz Sharif has emphasised the government's priority of digitising the taxation system to prevent tax evasion worth billions of rupees. He directed the relevant authorities on Friday to immediately create a dashboard to monitor the ongoing digitisation and implementation of the reforms.



Chairing a meeting to review the Federal Board of Revenue (FBR) reforms process, the prime minister instructed that taxable non-filers be brought into the tax net; discretionary powers of customs appraisers be revoked, and sought an implementation report from the FBR chairman within 24 hours.

During the briefing on FBR's digitisation, it was revealed that 4.5 million taxable individuals who were not part of the tax net had been identified. Additionally, over 300,000 more individuals filed their tax returns within a few weeks as a result of the government's measures.

The meetings also disclosed that refunds for 4,000 companies had been halted in the last two weeks following

the detection of under-invoicing and forged sales tax returns.

PM Shehbaz stated that both tax evaders and the officers and staff facilitating them would be punished, and assured that those fulfilling their tax responsibilities on time would be acknowledged.

He also requested a comprehensive report on the magnitude of tax evasion and measures for its prevention.

The prime minister vowed to introduce a taxation system of international standards in the country and called for engaging well-respected professionals and experts to formulate tax policy. He sought a comprehensive strategy for FBR's digitisation and reforms, along with set targets for the next meeting.

He further announced plans to install state-of-the-art scanners at airports to ensure transparency and prevent corruption in the system.

The meeting was attended by federal ministers Muhammad Aurangzeb and Ahmad Khan Cheema, Minister of State Ali Pervaiz Malik, PM's Coordinator Rana Ehsan Afzal, FBR chairman, Pakistan Business Council CEO Ehsan Malik, and Karandaz CEO Waqasul Hassan while Dr Shamsah Akhtar, Naveed Andrabi, Asif Pir, and Ali Malik joined the meeting via video link.—RT/Agency

Government Retreats From Imposing Advance Turnover Tax On Petroleum Dealers

ISLAMABAD: The federal government withdrew the advance tax imposed on petroleum dealers after successful talks with their association, media reported.

According to a notification, 0.5 percent additional withholding tax on petrol pumps has been abolished.

The government had imposed a 0.5 percent withholding tax per litre on petrol pumps in the budget 2024-25, in addition to the 12.5 percent withholding tax that petrol pumps were already paying on their margins.

Earlier in the day, the Pakistan Petroleum Dealers Association announced the end of their strike and the reopening of petrol pumps across the country.

The association leader, Abdul Sami Khan said that they would go on strike

again, if their demands are not met. Abdul Sami Khan said that there is no grouping among petroleum dealers.

He said that the government's decision to impose a tax of Rs 1 million petrol pump is not acceptable.

"Finance Minister Muhammad Aurangzeb assured us that our issues will be resolved, but our demands have not been met yet," he added.

Abdul Sami Khan said, with the ending of the strike, fuel pumps will be reopened across Pakistan.

It is pertinent to mention here that Karachi faced fuel shortage as the stock of petroleum products has run out due to the strike of the Pakistan Petroleum Dealers Association.

As per details, the fuel stations in Karachi and

across Pakistan were shut-down on the call of the PPDA from 6 AM today.

According to sources, the supply of petroleum products from Pakistan State Oil (PSO) and other oil marketing companies' terminals is ongoing. Meanwhile, the Oil Tanker Owners Association has distanced itself from the petroleum dealers' strike. Fazalur Rehman and Shahid Khaqan Slam Budget As 'IMF-Dictated'

were not transparent. He demanded that the right to vote be restored to the people and fresh elections be held under a transparent system.

Fazl also referred to US Congress's recent resolution on Pakistan's elections, saying that it has raised questions about the legitimacy of the polls. He questioned the passage of such resolution, asking whether this was a diplomatic failure.—RT/Agency

Gandapur Warns: Maryam's Punjab Situation Could Trigger K-P Intervention

PESHAWAR: Khyber Pakhtunkhwa (K-P) Chief Minister Ali Amin Gandapur criticised Punjab Chief Minister Maryam Nawaz, saying, "Our ancestors freed us from the British, and we will free ourselves from these looters. If Maryam Nawaz continues to oppress people in Punjab, K-P will go to Punjab to support the people."

Addressing a protest rally organised by Pakistan Tehreek-e-Insaf (PTI) in Masehra, he issued a stern warning to Pervez Khattak, stating that if he testifies against Imran Khan as an ap-

prover, he will not be allowed to stay in K-P.

"If Pervez Khattak decides to testify against Imran Khan or makes any statement, living in this province will become impossible for him," he added.

Gandapur cautioned, "Fear the day when Imran Khan gives the call, your future generations will remember it. If Imran Khan loses confidence in the institutions, we will take justice and our rights into our own hands."

He added, "I proclaim that Bajwa is a traitor, and anyone who acts like Bajwa will be called a traitor. 'The CM urged the institutions not to interfere in this political struggle, emphasising that Imran Khan is peaceful for the sake of the country and the nation. 'The day Imran Khan calls us, we will come out in full force. The penalty for breaking the Constitution is death, and we will punish those who break the Constitution according to the law.' He reiterated, 'The day we believe that justice will not be served, and we take the law into our own hands, let's see who stands in our way.—RT/Agency

Cabinet Body Greenlights Six-Month Extension In Refinery Policy 2023

ISLAMABAD: The Cabinet Committee on Energy, which met under the chairmanship of Prime Minister Muhammad Shehbaz Sharif Friday, approved the extension of six months in the Refinery Policy 2023 regarding the upgradation of the existing refineries.



The committee directed the Ministry of Petroleum to take into confidence the oil refineries established in the country and prepare a comprehensive plan for their upgradation on a priority basis.

The committee was also presented with a detailed report on the circular debt of the power sector from July 2023 to May 2024.

The report stated that the volume of the power sector's circular debt was Rs 2,655 billion till May 2024.

The committee also approved the Standardized Security Package Document under the Power Policy 2015 for small water projects of the private sector. This initiative

is aimed at promoting private investment in the electricity sector and quickly resolving the tariff and other issues. The prime minister directed to resolve complaints regarding the electricity supply of the people of Gilgit-Baltistan. He constituted a committee to prepare a plan of action to ensure the uninterrupted supply of electricity in Gilgit-Baltistan. The committee also approved setting up a support unit with two-year tenure to increase the efficiency of electricity distribution companies, prevent

electricity theft and timely collection of bills. After the Federal Cabinet's approval, the first support unit would be established for the Multan Electric Power Company (MEPCO).

The committee also approved an incentive package for recovery of unpaid and overdue electricity bills.

Under the package, rewards would be given to the personnel of law enforcement agencies and officials of DISCOs for the recovery of unpaid and overdue electricity bills.—RT/Agency

ECP Clarifies Controversial Reports On Forms 45 In Lahore's Constituencies

ISLAMABAD: The Election Commission of Pakistan (ECP) on Friday clarified that the Forms 45 of Lahore's constituencies had already been uploaded on the Commission's website.
