Dar Plans Imminent Visit To Afghanistan Amid Cross-Border Terrorism Concerns

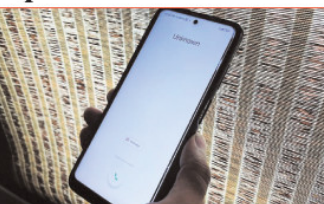
ISLAMABAD: Deputy Prime Minister and Foreign Minister Ishaq Dar said Tuesday that he would soon visit Kabul as Pakistan tackles a rise in terrorism, which it attributes to terrorists being harboured in Afghanistan.



Responding to a question, the foreign minister said Chinese nationals were attacked in Dussu, adding that such attacks are meant to create rifts between Pakistan and China. Unfortunately, the clues of these incidents signal the involvement of the Tehreek-e-Taliban Pakistan (TTP) and the outfit exists in Afghanistan, he underscored. During the second quarter of this year, Pakistan witnessed 380 violence-linked fatalities and 220 injuries among civilians, security personnel, and outlaws, resulting from as many as 240 incidents of terror attacks and counter-terror operations. This includes 236 fatalities among civilians and security forces personnel, the Centre for Research and Security Studies (CRSS) Annual Security report said. "Security is our major problem that Pakistan has with Afghanistan," he said, also highlighting that the polio virus has resurfaced in Pakistan. However, the crippling disease was uprooted in 2018, he noted. Dar also spoke about the financial situation, saying, "Prime Minister Shehbaz Sharif has clearly stated he would not seek debt from any brotherly country, any longer. "Pakistan will have to focus on economic diplomacy if it has to steer clear of the current financial crunch, he said, clarifying, "I have made the utmost effort to lend assistance to the government's economic team." —RT/Agency

Government Authorizes ISI To Trace And Intercept Communications

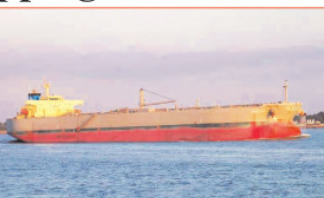
ISLAMABAD: The federal government has given its nod to the country's premier spy agency Inter-Services Intelligence (ISI) to intercept and trace calls and messages in the apprehension of an offence against national security.



The federal cabinet has approved the relevant circular allowing a designated officer of the ISI to carry out the tracing of calls under Section 54 of the Telecommunication (Re-organization) Act 1996. However, the officer nominated by the agency cannot be of less than grade 18. The aforementioned section of the Telecommunications Act allows the federal government to authorise any person or persons to intercept calls and messages or to trace calls through any telecommunication system in the interest of national security. It also states that the government will have preference and priority in the telecommunication system over any licensee for the defence or security of the country against any foreign aggression. "The federal government in the interest of national security and in the apprehension of any offence is empowered to authorise the officers [...] to be nominated from time to time by ISI to intercept calls and messages or to trace calls through any communication system," read the notification issued by the Ministry of Information on Monday. The move comes against the backdrop of Prime Minister Shehbaz Sharif-led government's steps towards stricter social media regulations citing national security concerns and the prevailing ban on popular social media platform X. In May, PM Shehbaz approved a draft to amend the Prevention of Electronic Crimes Act (PECA) 2016 which suggested the establishment of a Digital Rights Protection Authority. Moreover, the government is also installing a national firewall on different internet service providers (ISPs) to rein in social media with filters capable of blocking unwanted content from reaching a wider audience.

Shehbaz Urges Urgent Resolution To Pakistan's Shipping Crisis

ISLAMABAD: During a press conference in Islamabad on Tuesday, Prime Minister Shehbaz Sharif highlighted Pakistan's annual payment of \$5 billion in freight charges for imports and exports, despite having insufficient vessels at its disposal. "We annually pay \$5 billion in freight charges for importing and exporting goods through maritime vessels, and yet we have only 12 ships at the disposal of our national entity, Pakistan National Shipping Corporation (PNSC), with annual salaries totalling Rs5 billion," he said. PM Shehbaz pointed out that countries like Bangladesh possess hundreds of ships, which not only facilitate imports and exports but also save on freight charges. In contrast, Pakistan faces a dire situation with a nominal fleet, which he emphasised as a significant setback. "This is our misfortune—a looming crisis that demands immediate attention," remarked the prime minister, stressing the urgency of resolving this issue. He underscored the necessity for swift action to address Pakistan's maritime deficiencies, calling upon relevant authorities to formulate effective strategies to enhance the country's shipping capabilities. —RT/Agency



PM Announces Three-Month Tariff Concession For Electricity Consumers

-Too little, too late!

ISLAMABAD: Prime Minister Shehbaz Sharif on Tuesday announced that the government would not be increasing the electricity rates for protected customers who consume up to 200 units of power for a period of three months. "The household consumers who consume up to 200 units of electricity will get a subsidy for three months—July, August, September," Prime Minister Shehbaz Sharif told an event in Islamabad. The announcement comes after public outcry over a government's decision to massively increase the tariff, touted as a pre-condition to secure the International Monetary Fund's (IMF) loan. The prime minister, whose government has been under severe criticism for burdening the salaried class through the new budget, said the subsidy would cost the national exchequer Rs50 billion. "These households make up 94% of the electricity consumers. This subsidy will be funded through our budget's development fund," he said, reminding the nation that the Pakistan Tehreek-e-Insaf (PTI) government had slashed power prices sans allocation in the budget. PM Shehbaz said under the package, cost of per unit electricity will be Rs4 to Rs5 per unit and consumers of K-Electric will also be eligible for this subsidy. The premier said the decision has been taken to provide relief to common man in the wake of increase in prices of electricity. He said these three summer months are the hardest to cope with and ultimately from October onwards as the weather gets pleasant, the electricity consumption also gets down. The PM said the coalition government will overcome all difficulties together and added that the only way to overcome economic woes is to nab corruption. In a bid to unlock the IMF programme of over \$6 billion, the federal government earlier this month increased the applicable end-power tariff of protected consumers by up to 51% and unprotected consumers by up to 43%, which was earlier slated to take effect from July 1, 2024 before the PM's announcement of power subsidy. Among protected consumers' categories, tariff for those who fall under the slab of 1-100 units increased by



Rs3.95 per unit from Rs7.74 to Rs11.69 per unit, according to The News report. Also, those protected consumers who fall under the slab of 101-200 will have to at least 41% more as their tariff has increased by Rs4.10 per unit from Rs10.06 to Rs14.16 per unit. For the unprotected consumers, the first four categories will experience a 22-43% increase in their power tariffs. The unprotected consumers falling in the slab of 1-100 units a month will experience a maximum hike in the tariff in percentage term as these consumers will pay 43% more in their tariff as their tariff has increased by Rs7.11 per unit to Rs23.59 from Rs16.48 per unit. And those who fall in the slab of 101-200 units a month will be swelled by Rs7.15 per unit to Rs30.10 from the existing Rs22.95 per unit. Those falling under the slab of 201-300 units per month will pay 26% more as their tariff has increased by Rs7.12 per unit because their tariff has escalated to Rs34.26 from Rs27.14 per unit. Likewise, those who fall in the fourth category of the 301-400 units slab will experience a 22% surge in the tariff as their tariff has jumped by Rs7.12 per unit to Rs39.15 from Rs32.03 per unit. Similarly, consumers who fall in the category of 401-500 per month unit slab will face 17% increase as their tariff has surged by Rs6.12 per unit to Rs41.36 from Rs35.24 per unit and those using 501-600 units a month will also have the increase in tariff by 17% as their tariff has swelled to Rs42.78 from 36.66 per unit. Consumers who utilise 601-700 units a month will face 16% increase as their tariff has gone up by Rs6.12 per unit to Rs43.92 from Rs37.80 per unit and those who consume above 700 units per month will face a 14% hike as their tariff has increased by Rs6.12 per unit to Rs48.84 per unit from Rs42.72 per unit. —RT/Agency

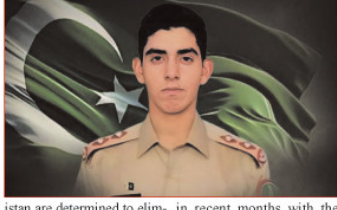
No Plans To Return To Politics: Asad Umar



LAHORE: Former federal minister Asad Umar stated on Tuesday that he currently has no intention of re-entering political arena. "During a media interaction following his appearance before an anti-terrorism court regarding the May 9 arson cases, Asad wished former prime minister Shahid Khaqan Abbasi and former finance minister Miftah Ismail good luck with their newly formed political group. When asked if he would join Awaam Pakistan, Asad replied that he would not be joining Shahid Khaqan Abbasi's political party. Earlier, Asad Umar, who recently underwent leg surgery, appeared before the Anti-Terrorism Court seeking interim bail in the May 9 arson cases. During the hearing, the former minister pleaded with the court, "I have recently had surgery, I have difficulty walking. My attendance is complete. Please allow me to leave." Subsequently, the court granted him permission to leave upon completion of his attendance. —RT/Agency

Army Captain Martyred In North Waziristan Gunbattle With Terrorists

RAWALPINDI: A Pakistan Army captain embraced martyrdom in a gunbattle with terrorists in Khyber Pakhtunkhwa's North Waziristan district, the Inter-Services Public Relations (ISPR) said on Tuesday. As the security forces ramp up efforts to wipe out the scourge of terrorism from the country, 24-year-old Captain Muhammad Osama bin Arshad, a resident of Rawalpindi district, laid down his life in the motherland's defence. "On 9 July 2024, a fire exchange took place between security forces and terrorists in the North Waziristan district," the military's media wing said. The ISPR statement said that two terrorists "were sent to hell" as troops effectively engaged effectively engaged the terrorists' location during the fierce exchange of gunfire. However, Captain Muhammad Osama, who led his troops from the front, fighting gallantly, made the ultimate sacrifice and embraced Shahadat, the ISPR said. The ISPR further said that the sanitisation operation is being carried out to eliminate any terrorists found in the area. "Security forces of Pak-



istan are determined to eliminate the menace of terrorism from the country and such sacrifices of our brave soldiers further strengthen our resolve," it added. Last week, the security forces conducted the IBO on the reported presence of high-profile local terrorist commander Irfan Ullah Adnan, who was killed during an intense exchange of fire, the ISPR had said. The slain terrorist was actively involved in numerous security activities against security forces as well as extortion and targeted killings of innocent civilians, according to the ISPR. He was a most-wanted terrorist by law-enforcement agencies. Since the Taliban came into power in Afghanistan in 2021, Pakistan has witnessed a significant surge in terrorist attacks on security forces, especially in provinces bordering the neighbouring country. In recent months with the militants using advanced weaponry and equipment. With the security forces hitting hard on terrorism, frequency of such incidents of violence went down in recent month. The Centre for Research and Security Studies (CRSS) Annual Security report stated that during the second quarter of the current year, Pakistan witnessed 380 violence-linked fatalities and 220 injuries among civilians, security personnel, and outlaws, resulting from as many as 240 incidents of terror attacks and counter-terror operations. In the backdrop of this, the federal cabinet last month approved the launching of the counter-terrorism operation — Operation Azm-e-Istehkam — following the National Action Plan's Central Apex Committee's recommendations to root out terrorism from the country. —RT/Agency

Pakistan and IMF Make Strides In Virtual Talks On Latest Bailout Package



ISLAMABAD: In ongoing virtual negotiations between Pakistan and the International Monetary Fund (IMF) regarding a new program with the possibility of finalising a staff-level agreement within the next two weeks, as reported by media on Tuesday. According to sources within the Ministry of Finance, substantial consensus has been reached in the virtual sessions with the IMF on all objectives and conditions related to the new program. It was revealed that detailed discussions have taken place over the volume, duration, and other intricacies of the agreement during the three-day virtual negotiations. Following this, the IMF has given the green signal for a new loan program. Sources added that Pakistan was required to meet several targets and conditions set by the IMF before July 10, all of which have been successfully met. Prime Minister Shehbaz Sharif has taken firm decisions to fulfill the IMF conditions. They further stated that federal government measures include adjustments in the budget as well as increases in electricity and gas prices. —RT/Agency

IHC Rejects Maneka's Review Plea Seeking Indefinite Adjourment Of Iddat Case

ISLAMABAD: The Islamabad High Court has dismissed Khawar Maneka's review petition seeking an indefinite adjourment of the Iddat case being heard in the District and Sessions Court. Justice Miangul Hassan Aurangzeb of the Islamabad High Court pronounced the reserved judgment. The IHC had directed the District and Sessions Court to decide on the central appeals filed by former prime minister Imran Khan and his spouse Bushra Bibi against their sentences in the Iddat case within a month. In the plea seeking adjourment of the Iddat case, the assistant lawyer for Khawar Maneka's counsel Zahid Asif requested the court to adjourn the case for

some time, arguing that senior lawyer Rizwan Abbasi was busy with a case being heard in the Supreme Court. In his arguments, the counsel for Imran Khan, Salman Akram Raja, stated that Maneka's lawyer had written that he wanted to go to Iraq and Iran for pilgrimage, adding that for that reason he was requesting the court to terminate its order for the District and Sessions Court to decide the case within a month. After hearing the two sides, Justice Aurangzeb reserved his judgment and adjourned the hearing. Shortly after, the judge announced the reserved decision, rejecting Maneka's review petition. —RT/Agency

DC Mirpurkhas ordered to complete city survey of Tando Jan Muhammad

MIRPURKHAS: According to the announcement by the Regional Director of the Sindh Ombudsman in Mirpurkhas, Zulfiqar Ali Junejo, the Provincial Ombudsman of Sindh has directed the Deputy Commissioner of Mirpurkhas to complete the city survey of Tando Jan Muhammad. This directive comes following a request by Iftikhar Gandhi and other residents of Tando Jan Muhammad, who sought a survey after the burning of records on completion of the city survey within 60 days of the former Prime Minister Shaheed Benazir Bhutto's assassination. In response, the relevant department ap-

pointed the Assistant Commissioner of Digri as the inquiry officer, who resolved 450 out of 2000 claimant cases. Further investigation revealed that the Senior Member of the Board of Revenue issued a notification appointing the Assistant Commissioner of Digri as the inquiry officer, instructing him to complete the city survey records of Tando Jan Muhammad within 180 days. Additionally, the Deputy Commissioner of Mirpurkhas was directed to oversee the completion of the city survey within 60 days and investigate any delays in the survey process, ensuring that responsible officers are held accountable.

Jacobabad's civil society rallies against excessive load shedding of electricity

JACOBABAD: Leaders and concerned citizens of Jacobabad, including Nadeem Qureshi, Abdul Sami Soomro, Noor Muhammad Manjho, Babal Korejo, and Gul Hassan Soomro, spearheaded a protest rally across various parts of the city to denounce the extreme electricity load shedding amidst scorching temperatures. The demonstrators converged in front of the press club, staging a sit-in protest that disrupted traffic flow as they voiced their grievances under the relentless sun. Addressing the gathered crowd, leaders emphasized Jacobabad's status as one of Asia's hottest cities and condemned the severe electricity shortages plaguing its residents. They lamented the disparity in relief efforts compared to other cities facing similar climatic



challenges. According to the leaders, urban areas endure between 14 to 16 hours of daily power cuts, while rural areas sometimes go without electricity for days, severely impacting daily life and local businesses. Accusations were leveled at authorities, alleging deliberate negligence that has crippled businesses and exacerbated the city's economic woes. The protesters demanded immediate measures to alleviate the electricity crisis during the heatwave, urging authorities to reduce load shedding durations and rectify unfair billing practices. They issued a stern warning, threatening to intensify their protests by besieging electricity company offices if their demands for immediate relief were not met. As tensions simmered, Jacobabad's civil society rallied behind these demands, expressing solidarity in their struggle for essential services and relief from the severe electricity crisis gripping the city.

Government Intervention Urged As Iron & Steel Industry Faces Collapse

KARACHI: Khalid Tawab, Chairman of the Iron & Steel Merchants Association, has issued a stark warning about the precarious state of Pakistan's economy and industries, particularly in the iron and steel sector. Tawab cited uncompetitiveness with neighboring countries and skyrocketing energy prices as key factors pushing industries to the brink of collapse. "The recent surge in electricity and gas tariffs has rendered production unsustainable for many of our members," Tawab stated. He emphasized the urgent need for the government to reduce power tariffs to 9 cents/kWh and lower mark-ups to 15%, measures he believes will rejuvenate the economy,

stimulate exports, attract investments, and create jobs. Tawab underscored the critical nature of immediate action to prevent a worsening unemployment crisis across sectors. He called for the government to terminate agreements with Independent Power Producers (IPPs) and procure electricity from more cost-effective sources, eliminating hefty capacity charges currently burdening the national economy. "The IPPs are imposing exorbitant capacity payments of Rs 24 per unit, which are unsustainable," Tawab explained. "Canceling these agreements could relieve the economy of Rs 2 trillion in capacity charges associated with non-operational IPPs."

Highlighting Pakistan's surplus electricity generation capacity of over 40,000 MW against a peak demand of 25,000 MW, Tawab argued that providing electricity at lower rates could significantly boost exports by USD 6 billion, increase grid demand by 300 MW, generate Rs 500 billion in revenue, and reduce debt servicing by Rs 240 billion. Tawab stressed the importance of government engagement with stakeholders to create a conducive business environment and level playing field. He also advocated for lower bank interest rates, citing the current 12% inflation rate, and highlighted the potential of the business community to contribute significantly to tax revenue if supported adequately.—RT

Chairman Tariq Aziz Baloch Launches Tree Plantation Campaign In Gadap Town



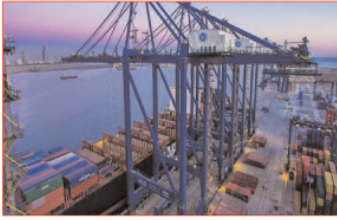

Karachi Port Sees Remarkable 24.43% Increase in Cargo Handling For FY 2023-24

KARACHI: Karachi Port Trust concluded fiscal year 2023-24 with exceptional cargo handling performance, marking a significant 24.43% increase. Total cargo throughput reached 51.65 million tons, comprising 40.24 million tons of Dry Cargo (a 31.39% growth) and 11.41 million tons of Liquid Bulk Cargo (a 1.69% increase), compared to 41.85 million tons in FY 2022-23. Export cargo handling surged to 18.80 million tons, up by 47.16% from 12.78 million tons in the previous fiscal year, while imports reached 32.85 million tons, a 13% increase from 29.07 million tons. Export Dry Cargo rose to 17.66 million tons (49.12% increase), driven by substantial Clinker handling, and Export Liquid Bulk Cargo reached 1.14 million tons (22.24% increase), bolstered by



Furnace Oil and Molasses. Import Dry Cargo totaled 22.58 million tons (20.21% increase), largely due to imports of Wheat, Fertilizer, R/Phosphate, and Iron Ore, while Import Liquid Bulk Cargo remained steady at 10.27 million tons. Container handling, vital for international trade, saw a notable rise to 2.28 million TEUs (17.90% increase), underscoring KPT's role in global logistics. Ship movements also saw growth, with 1767

Heavy rain disrupts routine life in Thatta

THATTA: Heavy and intermittent rain inundated cities and villages of district Thatta, causing gutters and drains to overflow, particularly in low-lying areas. Thatta city was notably affected, with rainwater entering several shops and causing losses for traders. Citizens of the historical city faced significant hardships due to poor sanitation work and inadequate pre-monsoon preparations, despite forecasts from the Meteorological Department. Areas in Thatta city, including Bukhari Muhalla, Kazi Muhalla, Islampura Muhalla, Brohi village, the vicinity of the historical Shah Jahan Mosque, Katchi Abadi, Shah Mubeen Muhalla, and wards including 1, 2, 3, 4, streets and Shahi Bazaar, resembled rivers due to the rain runoff. While the rain brought much-needed water to seasonal rivers such as Loach, Gemman, and Jangshahi, bringing relief to animal owners in the hilly areas who had been struggling with a lack of fodder and water, it also filled ponds, ensuring sufficient water for the inhabitants. However, the residents of Thatta city faced challenges such as load shedding, overflowing gutters, and accumulated dirt. Local government authorities and the public health engineering department appeared constrained and unable to take immediate actions to provide necessary facilities to the citizens.

Mirpurkhas' civil society demands action against increasing encroachments, open sale of drugs

MIRPURKHAS: Encroachment has increased at the Khipro stop bus terminal on Hyderabad Road, making it difficult for passenger vehicles to navigate. The actions of municipal staff and the police's ticket system have exacerbated the encroachment issue, leading to vendors occupying the roads. All the entry and exit roads of the city are now under the control of encroachments, making it challenging for citizens to move around, especially in emergencies. Another main problem in Mirpurkhas city is the open sale of drug as the concerned authorities failed to curb drug trafficking. The sale of Gutka and other banned items is continuing particularly in Jarwari Shakh and other areas of the city. The police have been unsuccessful in stopping the drug trade. This unchecked sale of drugs is pushing the younger generation and society toward destruction. Citizens urge the IG Sindh to take notice and take stringent action against those involved in the drug trade to eliminate this menace from society.

Badin's growers protest against shortage of water in Golarchi Taluka

BADIN: In order to address the artificial water shortage and the bribery involving irrigation staff in Taluka Golarchi, a protest rally was organized under the leadership of Ameer Azad Panhwar, Nazeer Mirza, Jakro Nohani, Tariq Bilal, Feroz Shahani, Amir Dahri, Fayaz Memon and others. The rally commenced from Ahmed Raju Road and culminated in a sit-in protest at Shaheed Fazl Rahu Chowk in the city. The protest resulted in the complete blockade of Karachi Badin National Highway and Kario Ghanur, Ahmad Raju Road, causing hundreds of vehicles to come to a standstill. Despite attempts to reroute lands barren through water scarcity in Taluka Golarchi, the involvement of irrigation officials in this conspiracy was also highlighted. A warning was issued that all water channels in Taluka Golarchi must be immediately reopened; otherwise, those responsible would face severe public accountability. Addressing the gathering, it was emphasized that there is sufficient water in the system, but corrupt officials are deliberately withholding water in Golarchi for personal gain. This action has led to the destruction of crops across millions of acres in Golarchi. Local leaders cautioned that if water is not restored promptly and corrupt officials are not removed, a sit-in protest will be staged on Thursday, July 11, on Karachi-Badin National Highway.

KCCI Urges FBR To Revisit SRO 350 Immediately

KARACHI: The President of the Karachi Chamber of Commerce & Industry (KCCI), Ifkhar Ahmed Sheikh, has called on the Federal Board of Revenue (FBR) to urgently revisit the contentious SRO 350(I)/2004. The unresolved issue has created significant confusion and anxiety among the business community, who have been seeking KCCI's assistance. In a letter to FBR Chairman Malik Amjed Zubair Tiwana, Sheikh requested an immediate visit to KCCI or

an online meeting to resolve the matter. He highlighted that complications arising from SRO 350 have even prevented utility providers like SSGC and K-Electric from timely filing their sales tax returns. Sheikh emphasized that SRO 350's requirement linking buyers' tax return filing with suppliers' compliance has caused widespread disruption across the supply chain. The mandate for balance sheet submission, which could contradict previously submitted de-

tails, has further complicated compliance procedures, raising concerns within the business community. Sheikh warned that further delays in addressing SRO 350 could halt exports of livestock, meat, fish, vegetables, and fruits, as the system lacks proper registration mechanisms. The uncertainty around sales tax returns and liabilities is a significant issue for businesses already facing challenging times.—RT/Agency

The notification, issued under Section 54 of the Pakistan Telecommunication (Re-organisation) Act, 1996, ostensibly aims to protect the nation. However, history shows that such powers often lead to overreach and misuse. Opposition leader Omar Ayub Khan's stark warnings about the potential for this decision to backfire are not unfounded. The capacity to intercept any person's phone conversations can easily be

exploited to target political adversaries, journalists, and activists under the pretext of security concerns. The implications of such an Orwellian prac-



tice are profound. It not only threatens the privacy of individuals but also undermines democratic principles by stifling dissent and free expression. The use of wiretapping as a political weapon can lead to a climate of fear, where opposing voices are silenced not through debate and discussion, but through intimidation and coercion. This decision sets a dangerous precedent. In a democracy, the bal-

ance between security and civil liberties must be carefully maintained. The honourable courts have a critical role to play in scrutinizing this notification. It is imperative that judicial oversight ensures that the government does not trample on constitutional rights in the name of national security. The courts must act swiftly to prevent the potential abuse of power and safeguard the fundamental freedoms of the Pakistani people. Thus, while the need for national security cannot be understated, it should not come at the expense of civil liberties. The government must reconsider this notification, and the courts must intervene to ensure that Pakistan does not slide further down the slippery slope of authoritarianism. The protection of our democratic values and individual freedoms must remain paramount.

Young Man Brutally Murdered Over Money Dispute In Hyderabad

HYDERABAD: In a harrowing incident, a young man named Nasser Shah was fatally beaten by several individuals in Kahoot Colony, Hyderabad, allegedly over a dispute regarding borrowed money, police confirmed on Tuesday.

According to police sources, the gruesome incident unfolded when Nasser Shah confronted the accused to recover the money he had lent. The perpetrators mercilessly tortured him before dumping his severely injured body near a police station. Tragically, Nasser Shah succumbed to his injuries while being rushed to the hospital for medical treatment.

Police authorities have obtained a video capturing the heinous assault, which vividly depicts the accused brutally attacking the victim. A case has been promptly registered against the suspects, and an intensive investigation is currently underway to apprehend all involved individuals. Amer Shah, the victim's grief-stricken brother, recounted the tragic sequence of events, asserting that Nasser Shah's life was tragically cut short due to a dispute over a loan repayment. He lamented that his brother had simply sought to retrieve the money owed to him when he met with this brutal fate.—RT/Agency

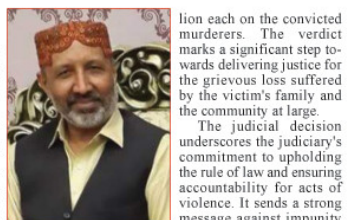
of Karbala epitomizes the resilience of Islam, underscoring how the sacrifices of Karbala continue to uphold the essence of the faith in the modern world.

CM Murad orders for timely drainage of rainwater in Karachi

KARACHI: Sindh Chief Minister (CM) Syed Murad Ali Shah issued directives to municipal and other institutions to ensure coordinated efforts to address issues related to rainwater drainage and traffic management during the ongoing rains, media reported.

The chief minister directed the Karachi Metropolitan Corporation (KMC) and cantonment boards to carry out coordinated efforts to ensure effective rainwater drainage and facilitate citizens.



CM Murad also directed the Transport Department has expedited work on the Red Line Corridor project to alleviate the difficulties faced by residents of Gulshan Iqbal and Taimur Nagar.

He directed the Traffic Police to be more active in managing traffic in Karachi especially in areas where uplift works are being carried out to avoid difficulties for citizens. He also emphasised the need for better traffic management in areas where development work is underway.

Earlier in the day, many parts of Karachi received moderate to heavy rain. Surjani Town, New Karachi, North Karachi, Nagan Chowranghi, Nazimabad, North Nazimabad, Golimar and other parts received the rainfall.

Meanwhile, the Shadman Nullah in Nusrat Bhutto Colony overflowed, causing flooding and difficulties for the people in the surrounding areas.

The area around Hassan man No. 1, Sakhi Shad Graveyard Road, and adjacent parts have been particularly affected, with waterlogged streets and garbage littering the roads.—RT

DSP Ali Raza Murder: Suspect Captured On CCTV Footage



KARACHI: The CCTV footage of alleged suspect, involved in killing Counter Terrorism Department (CTD) Deputy Superintendent of Police (DSP) Ali Raza, has been emerged on Tuesday, media reported.

The CCTV footage available with media showed the alleged attacker, wearing a white shirt, entering the flats on a motorcycle.

The CCTV footage also shows Ali Raza's vehicle arriving at the gate and stopping momentarily before the attacker strikes.

Later, the suspect can be seen fleeing from the flats after firing shots at the martyred official's vehicle.

On July 7, CTD DSP Ali Raza and a security guard were assassinated near Karachi's Karimabad area. A security guard, who belonged to a private security company, was also injured in the firing and later succumbed to wounds during treatment at the Jinnah Post Graduate Medical Centre (JPMC), Khattab said.

In a statement, the police said the investigation team has found 11 bullet shells at the scene, indicating that the attackers fired multiple shots.—RT/Agency.

SHCC's Anti-Quackery Unit Achieves Significant Milestones

KARACHI: Under the leadership of Chairman Sindh Healthcare Commission (SHCC) Dr. Khalid Hussain Shaikh, the Board of Commissioners, and CEO SHCC, the Directorate of Anti-Quackery has reported substantial progress during the fiscal year.

Throughout the financial year (FY July 23 - June 24), SHCC steadfastly pursued its mission to eradicate quackery in accordance with regulatory laws. A total of 5625 inspections were conducted, identifying new "quack zones" across various districts and talukas.

In adherence to the law, 2334 quack outlets were sealed, and 1541 warning notices were issued to non-compliant healthcare practitioners to improve their practices. Additionally, 682 follow-up inspections were carried out on previously sealed outlets to ensure ongoing compliance, with 1068 outlets found operating within legal parameters.

The financial penalties recovered amounted to PKR 13.3 million, achieving an average recovery rate of 55%. Director Anti-Quackery S. Zeeshan A Shah emphasized the expansion of the work-



force to combat the growing challenge of quackery. In a proactive move, SHCC launched the SHCC HIV Outbreak Control Action Plan in collaboration with stakeholders such as WHO, CDC, SBTA, PPH District Government, and IG Office. This initiative, now in its 44th week, has led to the closure and sealing of over 1000 quackery outlets, with ongoing operations in District Mirpur Khas to address the rising HIV cases exacerbated by illegal clinics.

Key successes included effective stakeholder engagement, with Commissioners' Offices and District Commissioners forming joint task forces with SHCC Inspection & Enforcement teams. Law enforcement support from IGP Office and DIGs ranges facilitated timely deployment of police forces for on-field operations, advocating for simplified FIR processes at police stations for swift justice.

Director Anti-Quackery continued collaboration with DG Health Office to enhance support from District Health Officers in gathering authenticated quack data for expedited legal actions at district and taluka levels. Positive media coverage has been crucial in highlighting SHCC's efforts to combat and eliminate quackery. With an expanded workforce, SHCC Anti-Quackery Operations are set to intensify, extending operations to remote areas alongside major cities in the ongoing fight against quackery province-wide.—RT

Victim's Brother Reveals Startling Details About CEO's Murder



KARACHI: Karachi police lodged a murder case of a software company's Chief Executive Officer (CEO) who was stabbed to death allegedly by an employee over unpaid salary in Karachi, media reported.

Meanwhile, Imtiaz, the victim's brother, lodged a case against the alleged murderer Shoaib at the Tipu Sultan police station.

The shocking incident came to light in Karachi, where the CEO of a software company was allegedly murdered by an employee over unpaid salary.

According to the complaint, the victim, Naveed, was the CEO of Euro Tech Software House, located on the fourth floor of a building at Shahrah-e-Faisal.

The complainant said that Shoaib, an employee of the company who was not paid his salary for three months, had a heated argument with Naveed over the issue.

"Shoaib attacked Naveed with a knife, leaving him severely injured. Naveed was rushed to the hospital but succumbed to his injuries," the FIR read.

The police said that accused Shoaib had been employed at the company for nine months and was to be paid Rs 150,000 salary per month.—RT/Agency

Mayor Wahab Warns Medical Officers Over Performance Issues

KARACHI: Mayor Karachi Barrister Muraza Wahab has stated that the Karachi Metropolitan Corporation (KMC) aims to improve its hospitals but stressed the need for a system of rewards and penalties to achieve this goal.

Wahab announced the suspension of Dr. Ghulam Abbas, Medical Superintendent of Sarfraz Rafique Shaheed Hospital, for being absent from duty. He warned that medical superintendents and other officers who fail to improve their performance will no longer be tolerated.

During a meeting of the KMC Medical Services Department, attended by Municipal Commissioner SM Afzal Zaidi, Senior Director Medical Services, and medical superintendents of all KMC hospitals, Wahab instructed all medical superintendents to submit a report within a week detailing the number of citizens treated in the past year. He warned that strict action would be taken against those providing incorrect figures.

Wahab expressed dissatisfaction with the performance



of major hospitals under KMC and required all medical superintendents to provide a written account of the officers and staff members on duty at their hospitals. He also emphasized that service books and personnel files of all doctors, paramedical staff, and employees should be readily available in hospitals.

Additionally, Wahab mandated that all doctors working in KMC hospitals take an oath within a week affirming that they are not serving or practicing elsewhere, and submit this oath to the Mayor's Secretariat.

He urged medical superintendents to enhance the performance of their hospitals to ensure standardized medical services for patients. Immediate steps should also be taken to maintain cleanliness and ensure the availability of necessary medicines and medical equipment.

Wahab highlighted that KMC hospitals provide cost-effective medical facilities to citizens but stressed that this objective can only be achieved with improved performance and patient satisfaction. He warned that any delay or negligence would be tolerated, and those responsible, including superintendents and other officers, would face disciplinary action.

The Mayor emphasized that all instructions must be implemented without delay, and the performance of all KMC hospitals will be continuously reviewed and monitored for improvement.—RT

ANF Officers Accused Of Short-Term Kidnapping Incident In Karachi



KARACHI: Plainclothes officers at a recently established checkpoint allegedly detained the driver of a private ambulance and demanded bribe, media reported on Tuesday.

According to the details, the ambulance driver claimed that the narcotics officials after detaining him demanded bribe of Rs 50,000.

The ambulance driver reported that he was threatened with being falsely charged in a drug case if he did not pay the asked amount.

Under the pretext of conducting a search, the officers reportedly tore the cushions of all the ambulance seats and damaged the fuel tank and other parts of the vehicle.

The driver was on his way to deliver the body of a deceased child from a hospital in Hub area to the child's family when the incident occurred.

The narcotics control officials stopped him while he was en route to deliver the body.

The driver claimed that the officers removed his shirt, tied it around his mouth, and took him to a room where they interrogated him about an alleged drug dealer named Maryam.

The ambulance driver stated that he could identify the officials involved in the incident.

He also mentioned that a copy of the death certificate was shown to the child's family via WhatsApp during the ordeal.—RT/Agency

Supreme Court Reserves Verdict In Vital SIC Reserved Seats Case

ISLAMABAD: The Supreme Court's (SC) full bench led by Chief Justice Pakistan (CJP) Qazi Faez Isa has reserved its verdict regarding the Sunni Ittehad Council's (SIC) case on reserved seats, requesting to dismiss SIC's appeal and uphold the verdict of the Peshawar High Court (PHC) on the matter.



The full court, led by CJP, heard the case. The Election Commission of Pakistan (ECP) has already submitted a written response to the apex court, stating that the SIC is no longer entitled to the reserved seats. It reiterated that the SIC's eligibility was compromised on several grounds.

He continued, "Just as the prime minister cannot vote, parliamentary parties are not bound to implement political party decisions." "You're absolutely right," acknowledged Siddiqui as Mandokhail's statement drew laughter from the courtroom.

The court raised a question regarding what would happen if a political party were to secure seats in several provinces but none in a particular province. "The Balochistan Awami Party won seats in other provinces but none in Khyber-Pakhtunkhwa. The Election Commission's lack of transparency is evident," Siddiqui accused.

"If an independent candidate declares affiliation, they can join it [SIC]," PTI's legal counsel Salman Akram Raja said. The PTI's counsel explained that PTI-backed SIC candidates did have any other choice apart from joining SIC. He further noted that whatever precedent ECP set about independents before was their fault. The court has reserved the verdict and adjourned the hearing. The ECP on March 1 refused to allot these reserved seats to the SIC.

PTI Plans To Challenge Notification Granting Phone Tapping Powers To ISI

ISLAMABAD: In response to the government's formally allowing the top intelligence agency to trace calls of citizens to counter threats to the "national security", the Pakistan Tehreek-e-Insaf (PTI) on Tuesday announced to challenge the government's move.



Leader of Opposition in National Assembly Omar Ayub said he would challenge the notification through his lawyer Babar Awan in the court, as it was unconstitutional and against the fundamental rights envisaged in the constitution.

The said section of the Telecommunications Act allows the federal government to authorise any person or persons to intercept calls and messages or to trace calls through any telecommunication system in the interest of national security. It also states that the government will have preference and priority in the telecommunication system over any licensee for the defence or security of the country against any foreign aggression.

The court announced that the reserved verdict on the SIC case will be announced after consultation. At the outset of the hearing, Faisal Siddiqui, a senior counsel representing the SIC, raised significant allegations against the ECP, accusing it of failing to fulfil its duties transparently.

"The chief justice pressed for clarity on the ECP's adherence to constitutional texts in their decision-making processes, asking, 'Was the Election Commission's decision regarding reserved seats for the Balochistan Awami Party under the law?'" To which the SIC's counsel responded that the ECP had not conducted a transparent allocation process for reserved seats, as he cited precedents and legal texts to support his arguments.

"Do you want the Supreme Court to take judicial notice?" CJP Isa inquired. He continued, "If not, why mention it? If you want to file a case regarding the 2018 elections, do it!" The SIC's counsel Advocate urged if the "Election Commission was behaving discriminatorily, the Supreme Court should examine it."

"Does this mean the 2018 Election Commission was correct?" the CJP further questioned. "The Greeks used to say if they couldn't speak with evidence, they would punish the individual," Siddiqui likened. "Is the Greek example a good argument? Is it constitutional?" CJP Isa probed. "Not a good argument, but their [ECP's] hypocrisy is evident," Siddiqui countered. Justice Mandokhail queried the potential implications for those individuals who are associated with the Pakistan Tehreek-e-Insaf (PTI) but later joined the Sunni Council (SIC).

To which the SIC's counsel responded that the ECP had not conducted a transparent allocation process for reserved seats, as he cited precedents and legal texts to support his arguments.

"Did the Balochistan Awami Party participate in the elections in Khyber-Pakhtunkhwa?" asked Justice Irfan Saadat. Advocate Siddiqui clarified that the Balochistan Awami Party participated but did not win any seats. "Political parties cannot be arbitrarily denied their rightful share of representation," CJP Isa remarked. CJ Jamal Khan Mandokhail queried, "Is the Election Commission treating all political entities equally in terms of seat allocation?" The court noted that there is a distinction between political parties and parliamentary decisions made within Parliament. "Political parties do not have the authority to make such decisions," Justice Jamal Mandokhail emphasised while noting that parliamentary parties are not bound to follow political decisions.

"The Peshawar High Court (PHC) on March 25 also upheld the ECP order, prompting the SIC to approach the apex court.—RT/Agency

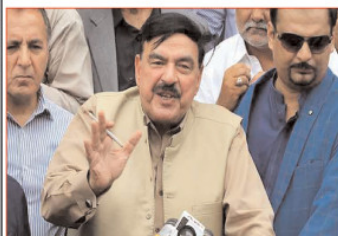
Three Soldiers Martyred In South Waziristan Gunfight With Terrorists

RAWALPINDI: Three Pakistan Army soldiers embraced martyrdom in an exchange of fire with terrorists in Khyber Pakhtunkhwa's (KP) South Waziristan district on Tuesday, Inter-Services Public Relations (ISPR) said. According to military's media wing, an exchange of fire took place between security forces and terrorists in South Waziristan district. During the fierce engagement, the ISPR said, three soldiers — Sepoy Asadullah, Sepoy Muhammad Sufyan and Zain Ali — embraced martyrdom. "Sanitisation operation is being carried out to eliminate any terrorists found in the area," it said, noting that security forces of Pakistan were determined to eliminate the menace of terrorism from the country and such sacrifices of our brave soldiers further strengthen our resolve. Earlier in the day, ISPR reported that a Pakistan Army captain was martyred while two terrorists were killed in a gun fight in Khyber Pakhtunkhwa's (KP) North Waziristan district. "During the fierce engagement, the Pakistan Army troops effectively engaged the terrorists' location, as result of which two terrorists were gunned down," the ISPR said.



However, during the intense exchange of fire, Captain Muhammad Osama bin Arshad, 24, resident of Rawalpindi District, embraced martyrdom. Pakistan has witnessed a surge in terrorist activities, especially in KP and Balochistan, since the outlawed militant group Tehreek-i-Taliban Pakistan (TTP) ended its ceasefire with the government in November 2022.—RT/Agency

Sheikh Rashid Acquitted In Government Interference Case



MURREE: A local court on Tuesday acquitted former interior minister Sheikh Rashid in interference in government affairs case. Judicial Magistrate Muhammad Zeeshan heard the case. Imran's Bail Pleas Rejected In May 9 Cases Despite Hopes For Early Release

LAHORE: An anti-terrorism court in Lahore on Wednesday rejected interim bail pleas of Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan in three cases related to May 9 violent protests. Judge Khalid Arshad of Lahore's ATC announced the verdict today that he reserved three days ago after hearing Khan's interim bail pleas in the May 9 riots cases — the Jinnah House, Askari Tower and Shadman Police Station vandalism cases. The May 9 mayhem referred to the riots that broke out in many parts of the country last year following the ex-PM arrest in a corruption case. The alleged PTI supporters attacked several state building including military installations, prompting the civil and military authorities to try the rioters under Army Act.



The deposed prime minister, who was ousted from power in the deposition's no-confidence motion in April 2022, has been facing a slew of charges ranging from corruption to terrorism since his removal as premier. He has been behind bars since August last year after he was sentenced in the Toshakhana case and subsequently sentenced in other cases ahead of the February 8 elections. Khan secured relief in the other cases, including £190 million reference and Toshakhana, and was acquitted in the cipher case last month. However, he remains behind bars due to his conviction in the iddat (un-Islamic nikah) case only. Pleading before the Lahore's ATC today, the government demanded Khan's arrest in all three cases, including the Jinnah House case, saying his arrest was essential for interrogation with him. The former premier along with his spouse Bushra Bibi is currently serving seven-year jail term each at Rawalpindi's Adiala Jail after the couple was convicted in the iddat case on February 3, 2024. The rejection of bail pleas come as PTI is hoping for Khan's release from prison this month as district and sessions court in Islamabad is expected to announce verdict on the PTI founder's main appeal challenging conviction in the iddat case. Last month, the sessions court turned down the pleas of the ex-premier and his wife to suspend their seven-year sentences in the iddat case.—RT/Agency
