At Least 15 Dead, 2 Injured As Passenger Jeep Plunges Into Neelum River In AJK

MUZAFFARABAD: At least 15 people lost their lives and two were injured when a passenger jeep tumbled down from the Leswa Bypass Road near Devlian village onto the bank of the Neelum River on Wednesday while they were travelling from Lawat Bala to Muzaffarabad, Azad Jammu and Kashmir (AJK).



Though police and rescue teams rushed to the accident site, their efforts faced certain difficulties due to the occurrence of rain, according to Rescue 1122. They added that the bodies were sent to the District Headquarters Hospital, whereas, the wounded passengers were taken to the Muzaffarabad Combined Military Hospital. Additionally, a woman cutting grass and two children were also injured at the scene. They were also admitted to the hospital. Notably, at least 17 passengers were travelling in the jeep including the driver, out of which six men, four women, and three children could not survive the accident. Additionally, two other

Federal Cabinet Extends Registered Afghan Refugees' Stay By 1 Year

ISLAMABAD: Pakistan on Wednesday decided to grant a one-year extension in the stay of registered Afghan refugees, allaying their fear of being sent back to Afghanistan. The caretaker government had announced the repatriation of all illegal foreigners citing security concerns in October last year. The decision was alleged to be meant for Afghan refugees, a charge that was denied by officials. Repatriation of undocumented Afghans began on November 1 and officials now say that up to 500,000 have gone back. Officials had earlier stated there were nearly 1.7m illegal Afghans with most having lived in Pakistan for 40 years. A statement issued by the Prime Minister's Office today said, "The federal cabinet approved one-year extension of the validity of PoR (Proof of Registration)



cards of 1.45 million Afghan refugees. Their PoR cards have been expired on June 30, 2024. The extension has been granted until June 30, 2025" said a statement issued by the Prime Minister's Office. According to the UN refugee agency, Pakistan is still home to around 1.3 million registered Afghans. PoR is a critical identity document held by registered Afghan refugees. Besides registered, more than 800,000 have Afghan citizenship cards, according to the United Nations High Commission for Refugees (UNHCR). The federal cabinet approved the extension of the validity of PoR cards for Afghan refugees that expired on June 30. Prime Minister Shehbaz Sharif presided over the meeting. The cabinet took the decision amid reports that Pakistan had suspended the repatriation of Afghans without legal documents. The UNHCR welcomed

the government's decision. "This is a big relief for refugees who were facing uncertainty and anxiety," UNHCR spokesman Qaisar Khan Afridi told media. He said the "generous gesture" demonstrated Pakistan's commitment to the global refugee cause and showed "solidarity and compassion towards refugees at a time when displaced people need our support". Afridi said that 52 per cent of PoR cardholders lived in Khyber Pakhtunkhwa while over 315,000 lived in Balochistan, around 1,950,000 in Punjab, 75,000 Sindh, 40,000 in Islamabad and some in Azad Jammu and Kashmir. UN High Commissioner for Refugees Filippo Grandi confirmed the suspension of the repatriation plan after meeting with Pakistani leaders a day ago at the conclusion of his three-day visit. Grandi had expressed appreciation that the "Illegal Foreigners Repatriation Plan" had been suspended and sought assurances that it would remain on hold, according to a UNHCR statement. "He called for Pakistan's proud tradition of hospitality towards those Afghans with international protection needs to continue." However, the Foreign Office spokesperson denied the UNHCR chief's claim regarding the repatriation plan's suspension. "This is not true. It may be noted that no such understanding has been given by Pakistan to the UNHCR, including in recent meetings with the High Commissioner for Refugees," Mumtaz Zehra Baloch told media. She said the repatriation plan remained in place and was being implemented in an orderly and phased manner.—RT/Agency

NAB Amendments Case: 'It's About The Country, Not Me,' Says Imran

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan has said that the issue of amendments in the National Accountability Bureau (NAB) ordinance is not about himself but in fact relates to the whole of the country. "This was not about personal gain but the greater good of our country and millions of Pakistanis who place their faith in a system that should serve them," Khan said in his written submission to the apex court. The former premier made the request while referring to a previous apex court order. The PTI founder's submission comes as the SC, last month, reserved its verdict on the federal and provincial governments' pleas challenging the apex court's September 15 majority 2-1 judgement, which was announced by a bench led by former chief justice Umar Ata Bandial. In 2022, the Pakistan Democratic Movement government made amendments to the National Accountability (NAB) Ordinance which were challenged by Imran Khan in the top court. The move comes as the incarcerated prime minister



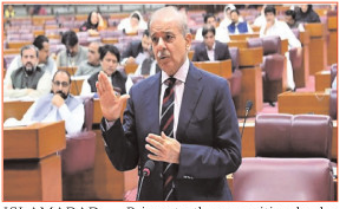
shares a rather contentious history with CJP Isa as it was his government that had filed a presidential reference against the incumbent chief justice in 2019 for allegedly owning properties abroad under his wife and children's names and not mentioning them in his health statement. The reference was challenged by the judge in the SC and subsequently, a 10-member larger bench headed by the then chief justice Umar Ata Bandial dismissed it. Later, Khan admitted that the filing of the presidential reference against CJP Isa was a "mistake". Moreover, the incumbent CJP has been part of various cases involving the former premier and his party has voiced concerns in this regard. PTI spokesperson, as per media, has complained of his party being deprived of justice and that even its petitions weren't being taken up by the courts. "The PTI core committee wants that CJP Isa should not sit on benches in our cases [...] unfortunately, the kind of decisions that are being delivered are seen to be biased, the element of favoritism in case verdicts strengthens our demand," he claimed. In his four-page written submission, the PTI founder further said: "Throughout my political career, I have consistently taken a stand against corruption, even at great personal risk and sacrifice, including my current imprisonment. My life's work and sacrifices have always been dedicated to the fight against corruption and the establishment of justice," Khan said.—RT/Agency

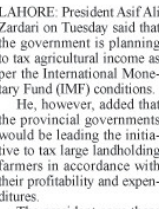

No Decision Yet On Wheat Export: Shehbaz



ISLAMABAD: Prime Minister Shehbaz Sharif on Wednesday told the National Assembly that the government had made no decision for the export of wheat. "No decision has been made for the export of wheat. I want to bring it on record before the House that there is no such decision for the wheat export," he told the National Assembly responding to a point of order raised by a parliamentarian. However, referring to the PTI government's sugar and wheat scams, he recalled that it was also on record that in the past wheat and sugar were first exported and later imported and where the billions and trillions of rupees went was part of the history. The prime minister also appreciated National Assembly Speaker Sardar Ayaz Sadiq for showing "generosity" to give floor to the opposition leader which was not practiced during the speakership of Asad Qaiser. Meanwhile, the House today passed "the State Owned Enterprises (Governance and Operations) Bill, 2024. According to the statement of objects and reasons, the bill is aimed at reconstituting the boards of SOEs to better align them with the reform initiatives for restructuring and the transformation as well as privatization of certain entities. Besides, "The Pakistan Citizenship (Amendment) Bill, 2024 was introduced in the House today. Earlier, The House offered feteiha for the departed soul of Captain Osama bin Arshad and others embraced Shahadat in South Waziristan. The House also prayed for the victims of the Neelum Valley incident.—RT/Agency

Government Plans To Tax Agricultural Income Under IMF's Directive: Zardari

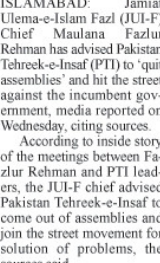


LAHORE: President Asif Ali Zardari on Tuesday said that the government is planning to tax agricultural income as per the International Monetary Fund (IMF) conditions. He, however, added that the provincial governments would be leading the initiative to tax large landholding farmers in accordance with their profitability and expenditures. The president gave these remarks while addressing the Professor Waris Mir Memorial Seminar in the provincial capital where he also spoke on issues related to media and democracy. While highlighting the economic challenges, Zardari called for adopting a holistic approach and prudent financial policies to put the country on the path to development. He said different sectors of the economy, especially the agricultural sector, need to be developed along modern lines. During the address, the



president highlighted that the media had given power to people by amplifying their voices, however, recent years witnessed grouping in media. He cautioned that a strong religious lobby in the world was manipulating and managing perceptions aiming to sow divisions in Muslim societies. He said he was a supporter of the freedom of the press and had always tolerated harsh criticism from the media. "Societies need to be careful against agenda-driven information. One has to face trials and tribulations in life, however, one needs to stay steadfast in the face of challenges." He paid tribute to the political struggle and sacrifices of Benazir Bhutto for democracy, saying the Pakistan Peoples Party had a history of facing pressures and assassinations, but it continued its struggle for the cause of democracy in Pakistan. "Assassination attempts could not deter us from our mission as we firmly believe that life and death are in Allah's hands," the president said.—RT/Agency

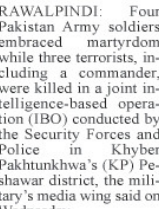
Fazl Calls On PTI To 'Quit Assemblies



ISLAMABAD: Jamiat Ulema-e-Islam Fazl (JUI-F) Chief Maulana Fazlur Rehman has advised Pakistan Tehreek-e-Insaf (PTI) to 'quit assemblies' and hit the street against the incumbent government, media reported on Wednesday, citing sources. According to inside story of the meetings between Fazlur Rehman and PTI leaders, the JUI-F chief advised Pakistan Tehreek-e-Insaf to come out of assemblies and join the street movement for solution of problems, the sources said. Pakistan Tehreek-e-Insaf (PTI), rejecting the advice of Fazlur Rehman said the party already made a mistake by coming out of assemblies in the past. A decisive meeting on forging alliance between the JUI-F and PTI is likely to be held next week, the sources said. Earlier on May 2,

Maulana Fazlur Rehman once again rejected the results of the general elections and demanded fresh polls, citing "widespread rigging and irregularities". Addressing a public gathering in Karachi, Maulana Fazlur Rehman said that assemblies were "sold" and "Sindh Assembly and President House were also sold," he added. The JUI-F chief demanded for immediate elections to ensure the integrity of the democratic process. "The recent elections were fake, and its results are unacceptable," he added. The JUI-F chief demanded fresh elections to ensure that the people's voice is heard and their mandate is respected.—RT/Agency

Four Soldiers Martyred, Three Terrorists Killed In Peshawar Operation



RAWALPINDI: Four Pakistan Army soldiers embraced martyrdom while three terrorists, including a commander, were killed in a joint intelligence-based operation (IBO) conducted by the Security Forces and Police in Khyber Pakhtunkhwa's (KP) Peshawar district, the military's media wing said on Wednesday. According to Inter-Services Public Relations (ISPR), the security forces and police conducted a joint intelligence-based operation in Hassan Khel area of Peshawar District on July 10, 2024. During conduct of the operation, three terrorists including high value target, commander Abdul Raheem were killed whereas weapons and ammunition were also recovered from them, the ISPR said. The military's media wing noted that commander Abdul Raheem was highly wanted by the Law Enforcement Agencies (LEA) and the government had fixed "head money of Rs6 million on



him", as he remained actively involved in numerous terrorist activities, and was also responsible for martyrdom of Captain Hussain Jahangir Shaheed and Havildar Shafiq Ullah Shaheed on 26 May 2024. "Today's operation has avenged the heinous act and has brought the main perpetrator to justice," the ISPR said. The martyred soldiers were identified as Sepoy Muhammad Idrees (age: 34 years, resident of Swabi District), Sepoy Badam Gul (age: 34 years, resident of Kohat District) of Pakistan Army and Sub Inspector Tajmir Shah, (age: 38 years, resident of the Peshawar District) and Assistant Sub Inspector Muhammad Akram (age: 34 years, resident of Mansehra District) of CTD KPK, who having fought gallantly, embraced Shahadat. "Pakistan's Security Forces stand shoulder to shoulder with other law enforcement agencies to ensure peace and stability across of Pakistan and such sacrifices of our brave men further strengthen our resolve," the ISPR said. The operation came amid a surge in terrorist activities in Pakistan, especially in KP and Balochistan, since the outlawed militant group Tehreek-i-Taliban Pakistan (TTP) ended its ceasefire with the government in November 2022.—RT/Agency

LAHORE: Punjab CM Maryam Nawaz has announced 1,224 flats for labourers in Taxila and Sundar labour colonies without any cost.

Robbers Steal Gold Worth Rs15 Million in Brazen Burewala Heist

BUREWALA: Six dacoits looted cash and gold ornaments worth Rs 15 millions from a house, at Chak No 447/E/B in tehsil Burewala, media reported on Wednesday. According to police sources, six armed persons entered into house of Muhammad Shehzad, the owner of tractor showroom, and made members of the family hostage at gun point.

They looted cash Rs 3 million and gold ornaments worth Rs 12 millions. The dacoits kept looting for one hour. City police rushed to the site and started investigation into the incident.—RT/Agency

BISP beneficiaries facing a myriad of problems in Jamshoro

KOTRI: In the four tehsils of Jamshoro district, difficulties are being encountered in disbursing funds from the Bazar Income Support Program (BISP) at over seven centers. It has been revealed that limited devices intended for cash withdrawal are being used away from the designated centers. At the Sehwan center, only 6 out of 14 devices are operational and a similar situation is occurring

at three centers in Kotri, where minimal devices are being used, leading to significant problems to the beneficiaries. Due to collusion between the device holders and other staff at the centers, affected women are facing hardships at the Government Primary School Christian Colony Kotri Center. The women have to wait for hours in the scorching heat without receiving any money and they return home disappointed after a whole day of

waiting in the heat. The treatment of these women by the government appears to indicate massive corruption involving millions of rupees. Various means are supposed to be used to distribute money to women, but instead, these women are being humiliated by the device holders. There are no provisions for electricity, water, or even a place to sit and wait while trying to obtain their money, forcing them to endure day-long struggles.

Man kills sister over Karo Kari

Murad Orders Irrigation Dept to Address Sukkur Barrage Right Bank Water Shortage, Ensure Rabi Crop Protection

KARACHI: Sindh Chief Minister Syed Murad Ali Shah has directed the Irrigation Department to address the water shortage on the Right Bank of Sukkur Barrage to protect Kharif crops. The directive came during a meeting at CM House and other officials.



The Sukkur Barrage Right Bank irrigates 2,094,975 acres, including 185,000 acres in Balochistan. The Right Bank includes the Dadu, Rice, and North West Canals. The Rice Canal operates at 80-89% of its allocated discharge, with water reaching tail-enders. However, Dadu

Canal is only at 50% of its allocated share, severely affecting areas below Dadu City. Shah instructed the Irrigation Department to supplement the Dadu Canal from the Rice Canal and operate pumping stations to alleviate shortages. The North-West Canal also faces a 50% water shortage, affecting Balochistan. Shah emphasized the need for a rotation plan and vigilant monitoring to ensure equitable water distribution and mitigate shortages. He also recommended using hydraulic excavator machines to clear obstacles in the North-West Canal for better water flow.—RT

'Enough chances for Babar': Boom Boom wants real surgery in team

LAHORE: Shahid Afridi, the former captain of Pakistan national cricket team, has said that he was unable to "comprehend" the recent removal of Wahab Riaz and Abdul Razzaq from Pakistan Cricket Board's (PCB) selection committee.

The removal of Riaz and Abdul Razzaq comes after a disappointing performance from the national team during the T20 World Cup 2024 as the PCB management had lost confidence in the duo and their opinions had not been taken into account for some time now, according to sources.

While speaking to reporters on Wednesday, Afridi, 47, broke his silence over the recent removal of the former cricketers from the selection body as part of



PCB Chairman Mohsin Naqvi's much needed 'surgery' for the body.

Afridi, who is currently participating in the World Championship of Legends 2024 in England as part of Pakistan Champions, told reporters that he did not understand PCB's latest move when asked about it.

He emphasised that Riaz and Abdul Razzaq are not the only members of the selection committee and there are several other people involved as well. "I just found out that they sidelined Abdul Razzaq and Wahab Riaz," he said. "I don't understand this kind of 'surgery'."

Afridi also said that whatever "surgery" is needed, it must be done once and for all. He added that whoever is brought forward now must be given ample time to improve their captaincy skills.

While discussing the performance of Babar Azam, Pakistan's current T20 cap-

tain, Afridi highlighted that the 29-year-old cricketer has been given many chances to prove his captaincy skills.

"As far as Babar is concerned, no captain has been given such chances (to prove their captaincy)," Afridi told reporters, highlighting that Azam had played in several international tournaments.

However, he did not seem impressed by Azam's captaincy skills despite the "incredible" opportunities he had.

About the removal of Riaz, 39, and Abdul Razzaq, 44, sources stated: "Their influence was significant in the selection of the T20 World Cup squad and they showed more support to players who did not perform well.—Agency

Yamal makes history as Spain sink France to reach Euro 2024 final



MUNICH: Lamine Yamal, 16, became the tournament's youngest ever goalscorer as Spain came back to beat France 2-1 in Munich and reach the Euro 2024 final.

Trailing after Randal Kolo Muani headed in a Kylian Mbappe cross in the ninth minute, Spain turned the match around in a four-minute period, scoring twice against a side who had only conceded once in five previous games in this tournament.

Yamal, who turns 17 a day before Sunday's final against either the Netherlands or England, equalised with a superb strike from outside the box, curling a long-range effort into the top corner and past the fingertips of an airborne Mike Maigman.

Spain took the lead on 25 minutes, Dani Olmo expertly gathering a loose ball and firing a low shot into the net with the aid of a deflection off Jules Kounde.

Masters of midfield game management, Spain shut shop after taking the lead, frequently holding possession rather than attacking on the counter, controlling the match and claiming the win.—Agency

Retiring James Anderson picks best batter he bowled against



LONDON: Retiring England pacer James Anderson picked India's batting great Sachin Tendulkar as the best batter he bowled in his glittering career.

During a Q&A session with Sky Sports Cricket ahead of his farewell Test at the Home of Cricket Lords, Anderson picked legendary Tendulkar ahead of renowned batters like Virat Kohli, Kane Williamson, David Warner and Steve Smith.

"The best batter I would have to say is Sachin Tendulkar," said Anderson. Notably, James Anderson dismissed Sachin Tendulkar nine times in Test cricket and thrice in ODIs. All in all, he has 149 wickets to his name against India in 39 matches, the most by him against any cricket-playing nation.

When probed about the best bowlers he ever faced, Anderson picked Australia's Glenn McGrath and South Africa's Dale Steyn, terming them world-class.

"The best bowler I faced was probably Glenn McGrath or Dale Steyn. Hard to pick between the two. Slightly different bowlers, but both world-class," Anderson stated.—Agency

Argentina beat Canada to seal spot in Copa America final

NEW JERSEY: Defending champions Argentina booked their place in the Copa America final after goals from Julian Alvarez and Lionel Messi gave them a 2-0 win over Canada in Tuesday's semi-final in New Jersey.

Argentina have won a joint-record 15 Copa titles and reached the final six times in the past eight editions but Canada caused them problems in the opening 20 minutes, Jacob Shafteburg twice shooting wide from promising positions.

After soaking up the early pressure Argentina went ahead when Rodrigo De Paul played through Alvarez, who ghosted in between two defenders to score with a tidy



finish in the 22nd minute.

2022 World Cup winners Argentina gradually took control of the match and Messi had a chance to double their lead in the 44th minute as he created space in the box with silky footwork before lashing his effort wide.

Canada nearly snatched an equaliser against the run of play in first-half stoppage time as Jonathan David sneaked in ahead of his marker to get on the end of a long throw, but his close-range shot was hit straight at goalkeeper Emiliano Mar-

tinez. Messi then scored Argentina's second in the 51st minute when he stuck out a boot to divert Enzo Fernandez's shot from the edge of the area past Canada goalkeeper Maxime Crepeau.

The goal moved Messi to joint fifth in the all-time Copa America scoring charts, level with Peru's Paolo Guerrero and Chile's Eduardo Vargas on 14.

The 37-year-old's 109th goal for Argentina also saw him surpass Iran's Ali Daei on the all-time international scoring charts. Messi is second behind Cristiano Ronaldo, who has scored 130 goals for Portugal.—Agency

PCB confirms sacking Wahab Riaz, Abdul Razzaq



LAHORE: The Pakistan Cricket Board Wednesday confirmed axing former cricketers Wahab Riaz and Abdul Razzaq from the board's selection committee following the team's dismal performance in the T20 World Cup 2024.

"The PCB today confirmed that it has notified Abdul Razzaq and Wahab Riaz that their services will no longer be required in the national selection committee setup," read the board's press release.

The confirmation comes a day after media, citing sources, reported that the board had removed the ex-cricketers from the selection committee after losing confidence in them due to their support for players who failed in the mega-event.

The former cricketers' ouster comes as the PCB had reorganised the men's national selection committee, having equal powers in March earlier this year in order to bring more transparency in the process, but the team selected by the panel failed to deliver in all the series since then. Riaz was a member of the men's selection committee, whereas Razzaq was part of the selection committees for

India thump Zimbabwe in third T20I to take lead in five-match series

HARARE: Shubman Gill's brisk half-century, followed by Washington Sundar's three-for steered India to a 23-run victory over Zimbabwe in the third T20I of the five-match series here at Harare Sports Club on Wednesday.

The inexperienced India side, who succumbed to a narrow defeat in the series opener, now lead the five-match series 2-1 with two games to spare.

Opting to bat first, India racked up a commendable total of 182/4 on the tricky surface of the Harare Sports Club.

Leading the way was their young skipper Shubman Gill, who scored a magnificent half-century. Gill gave India a solid start with his 67-run opening



partnership with Yashasvi Jaiswal.

The solid opening stand lasted in the ninth over when Jaiswal fell victim to Sikandar Raza in the ninth over after scoring 36 off 27 deliveries.

Gill was then involved in yet another important partnership for India when he added 72 runs for the third

wicket with Raturaj Gaikwad before finally walking back in the 18th over.

He remained the top-scorer for India with a 49-ball 66 which included 10 boundaries including three sixes.

Gaikwad bolstered India's total at the backend with clean hitting but failed to convert his bril-

liant knock into a well-deserved half-century as Blessing Muzarabani dismissed him in the final over.

Raturaj Gaikwad was the other notable run-getter for India with a quickfire 49 off just 28 balls with the help of four fours and three sixes. For Zimbabwe, Sikandar Raza and Blessing Muzarabani bagged two wickets each.

In response, Zimbabwe racked up 159/6 in the allotted overs as they failed to recover from the dismal start.

Avesh Khan and Washington Sundar ran through Zimbabwe's top order, reducing the home side to 39/5 in seven overs.—Agency

The lyrics said, "I do recall now the smell of the rain, fresh on the pavement, I ran off the plane / That July 9th, the beat of your heart / I jumps through your shirt, I can still feel your arms."

Moreover, Taylor Swift previously played the song last year in Kansas City on July 8, as there wasn't a show on July 9. In regards to the "Karma" hitmaker and Joe Jonas, they dated back in 2008 for a

handful of months before their relationship soured.

Swift infamously put her ex on blast during a November 2008 interview on "The Ellen DeGeneres Show" when she hinted that he broke her heart via a short phone call as she quipped, "Some day, I'm gonna find somebody really, really, really great, who's right for me."

When I found that person that is right for me, he'll be wonderful and when I look at that person, I'm not even gonna be able to remember the boy who broke up with me over the phone in 25 seconds when I was 18."

It is pertinent to mention that the next year, Joe Jonas released a track, "Much Better" with their album "Lines, Vines and Trying Times."

However when Swift visited "Ellen" again in 2019, she admitted calling out Jonas "too much. We laugh about it now, but that was mouthy... just teenage stuff there."

Furthermore, Swift confirmed that she will officially wrap the record-breaking tour in December.

HESCO's Indiscriminate Operations Against Electricity Thieves And Defaulters Continue Unabated

HYDERABAD: In the HESCO region, with the assistance of Sindh police officers and personnel, indiscriminate operations against electricity thieves and defaulters are currently underway. Recovery magistrates are actively present to enforce immediate legal actions against electricity thieves, including fines, case registrations, and arrests on the spot. These operations are in accordance with the Prime Minister's directive to intensify the anti-theft recovery campaign, aimed at reducing the circular debt in the energy sector and improving electricity services for the public.



Sures the complete recovery of dues and takes stringent actions against electricity thieves throughout the entire HESCO region.

According to a spokesperson from HESCO, as of now, 79,851 individuals have been accused of electricity theft, leading to 70,690 filed cases, 215 arrests, and a recovery exceeding PKR 13.17 billion. Under the supervision of HESCO Chief Executive Officer Mohammad Roshan Otho, the ongoing anti-electricity theft campaign has achieved significant progress. In the past 24 hours alone, 283 illegal connections were identified across the region. Among these, 266 FIRs are being processed at various police stations, with 4 FIRs already registered. All identified connections have been disconnected, resulting in a charge of 135,713 units through detection bills, amounting to over PKR 3.51 million. At the directive of CEO Mohammad Roshan Otho, HESCO administration en-

Several illegal power connections have been disconnected due to unauthorized usage and non-payment of dues by defaulters. Detailed disconnections include: Sakrand Sub-Division: 894 illegal and 686 defaulter connections. Qazi Ahmad Sub-Division: 875 illegal and 402 defaulter connections. Mirpurkhas Sub-Division: 957 illegal and 394 defaulter connections. City Mirpurkhas Sub-Division: 714 illegal and 321 defaulter connections. Heerabad Mirpurkhas Sub-Division: 894 illegal and 402 defaulter connections. Satellite Town Sub-Division: 946 illegal and 426 defaulter connections. Mirwah Gorchani Sub-Division: 904 illegal and 407 defaulter connections. Umarkot Sub-Division: 841 illegal and 378 defaulter connections. Samaro Sub-Division: 934 illegal and 420 defaulter connections. Pithoro Sub-Division: 975 illegal and 439 defaulter connections.

Over 780 letters have been forwarded to police stations for FIR registration against electricity thieves. Additionally, more than PKR 11.978 million has been recovered from defaulters, and over 6,237 connections have been disconnected due to non-payment. Reconnection of these connections is contingent upon full payment of outstanding dues.

HESCO urges the public to eliminate electricity theft and ensure timely payment of dues. The sustainability of HESCO's infrastructure depends on receiving payments for electricity services. Strict legal action will be taken against anyone involved in electricity theft, including HESCO employees. Consumers are strongly advised to settle their outstanding bills promptly to avoid disruptions in electricity supply.

Electricity theft is both a legal offense and a moral violation. Offenders may face FIRs, fines, and detention under the applicable law. HESCO seeks the cooperation of all consumers in this crucial endeavor.—RT

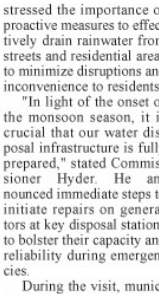

Terrorist Plotting Attack On Muharram Procession Apprehended

KARACHI: The Counter-Terrorism Department (CTD) on Wednesday claimed to have arrested a high-profile terrorist affiliated with the banned Tehreek-e-Taliban Pakistan (TTP), who according to the law enforcers was planning to attack a Muharram procession in Karachi, media reported.

He claimed that the CTD team has arrested Shoaib from Itrahad Town and recovered a suicide jacket from the arrested terrorist. "He [the terrorist] had joined the TTP after arriving in Karachi," he added. The arrested terrorist has provided valuable information to the authorities, and a significant press conference, DIG CTD Asif Ijaz Sheikh said that the arrested terrorist - identified as Muhammad Shuaib - was planning to attack an 8th Muharram in Karachi's Orangi Town and the facilitators of terrorists would also be brought to justice.

Pakistan has witnessed a surge in terrorist activities across the country, especially in KP and Balochistan, since the outlawed militant group Tehreek-i-Taliban Pakistan ended its ceasefire with the government in November 2022. It is pertinent to mention here that militants have targeted Muharram processions several times, including a bomb blast that killed more than 40 people attending the main Ashura procession on Karachi's M.A. Jinnah Road in December 2009.—RT/Agency

CTD In-charge Raja Umar Khatab has stated that the CTD in a raid in Cantt Station arrested railway employees Sanauallah and Gul Islam and recovered a sub-machine gun (SMG) and a pistol from their possession. Two accused smuggled arms from Khyber Pakhtunkhwa to Karachi. "An arms dealer in KP had handed over arms to them," official said. The railways authorities have been informed about the arrest, police official added. The CTD in April foiled arms smuggling bid in Karachi. Raja Umar Khatab said that an in-service constable of Khyber Pakhtunkhwa KP have sent heavy weapons to Karachi till now," he said. "CTD has arrested two members of the gang earlier," he said. "Mostly retired or terminated FC officials have been involved in the arms smuggling," CTD officer said.—RT/Agency

PM Warns Ministers To 'Roll Up Your Sleeves' For Downsizing Agenda Implementation

ISLAMABAD: Prime Minister Shehbaz Sharif Wednesday asked the ministries to work hard to make a difference and meet the nation's expectations, warning against any laxity in the implementation of the government's downsizing agenda.

"I will not allow my time to waste and I am sure you will not allow your time to be wasted. The only thing that will make the difference is action and implementation. Roll up your sleeves as this is a matter of country, its resources and resolution of its issues," the prime minister said in his remarks while chairing the meeting of the federal cabinet.

Apprising the members of his visits to Tajikistan and Kazakhstan, he referred to his interactions with world leaders, particularly Russian President Vladimir Putin and said he had formed a committee under Planning Minister Ahsan Iqbal for follow-ups.

Similarly, he said he had chaired a meeting a couple of days ago to review the progress on the follow-up of "very productive" discussions with Chinese President Xi Jinping and Premier Li Qiang during his China visit



and would hold another meeting on July 20.

The prime minister said the government had launched the solarisation of 28,000 tube-wells in Balochistan to save bleeding of annual Rs80 billion. He also appreciated the Balochistan chief minister and other relevant ministries and departments for taking the project to the implementation stage.

He told the meeting that the finance ministry had been tasked to work out a business plan for the solarisation of a million tube-wells in the country which were currently running on imported fuel, putting a burden of \$3.5 billion in the form of foreign exchange.

The prime minister high-

lighted that Pakistan had immense solar energy potential which must be exploited to save energy costs and provide low-cost electricity to the farmers.

"Time is running fast and we are racing against time. You have to accept the challenge and deliver. You will become the nation's heroes and if you bring about a revolution of development in your ministries. For this, we will have to work day and night," he remarked.

Coming to the downsizing agenda, the prime minister categorically said that he would not listen against the closure of Public Works Department (PWD) as the government also found an alternative solution on the pattern of Punjab. He said

the two-week time he had given for PWD's closure, was already over.

"I will not tolerate if any ministry used delaying tactics. Please make no mistake about it. It is okay if there is any valid reason for any subsidiary but protecting any entity for the sake of perks and privileges is a thing of the past, not today. It will not happen and it must not happen," he remarked.

The prime minister also highlighted that Pakistan spends \$5 billion on freight of exports and imports but the Pakistan National Shipping Corporation was running a fleet of just 12 ships while getting Rs5 billion for salaries. This is contrary to around 600 ships being run by Bangladesh and around 1500 ships by India.

"But no one cares. At least they should have flagged the issues to seek their resolution," he said and also referred to the evasion of import duties worth Rs1200 billion on Karachi Port.

He told the meeting that on Tuesday, the government had announced a Rs50 billion relief package to support the power consumers of the protected category for three

months. "During these three months, I want massive fiscal space through enforcement like plugging financial leakages and addressing tax evasion," he added.

He said the government had imposed taxes on the real estate sector to generate Rs100 billion in revenue and to do away with a culture of tax evasion.

"This cannot go for long. We need to bring deep structural reforms and take bitter pills. I pray that this should be the last IMF programme but it needs sacrifices," he commented.

He reiterated his call for the ministers to work hard and sought plans from commerce and IT ministers to boost exports. "I beg of you in the name of Pakistan. Let us stand up and accept the challenge, move forward in unison and create a difference as the nation wants results," he added.

Prime Minister Shehbaz asked the interior minister and interior secretary to ensure coordination with the provinces during the month of Muharram and extend the maximum possible support to provinces as well as Azad Jammu and Kashmir and Gilgit Baltistan.—RT/Agency

Supreme Court Expected to Announce Verdict on PTI-SIC Reserved Seats Case Today

ISLAMABAD: The Supreme Court (SC) is expected to announce a verdict on a case related to reserved seats of the Pakistan Tehreek-e-Insaf (PTI) backed Sunni Ittehad Council (SIC) on Thursday (today), media reported citing sources.

A special session of the apex court's 13-member full bench was held under the chair of Chief Justice of Pakistan (CJP) Qazi Faez Isa today, the sources added.

The important consultative session was summoned by the top judge to hold a discussion over the order related to the reserved seats case.

It is noteworthy to mention here that the Supreme Court reserved the verdict on the SIC's appeal yesterday, against the Peshawar High Court's (PHC) verdict that upheld the Election Commission of Pakistan's (ECP) decision denying them the reserved seats.

The CJP-led full court reserved the verdict after conducting nine hearings on the SIC's appeals to listen to arguments from all parties, including the federal government and the poll organising body.

The bench also comprises Justice Syed Mansoor Ali Shah, Justice Muneeb Akhtar, Justice Yahya Afridi, Justice Amin-ud-Din Khan, Justice Jamal Khan Mamoon, Justice Muhammad Ali Mazhar, Justice Athar



Minallah, Justice Syed Hasan Azhar Rizvi, Justice Ayesha Malik, Justice Shahid Waheed, Justice Irfan Saadat Khan and Justice Naeem Akhtar Afghan.

The reserved seats' issue first emerged after over 80 PTI-backed independent candidates emerged victorious in the February 8 elections and subsequently joined the SIC in a bid to claim seats reserved for minorities and women.

However, the Imran Khan-founded party ECP, citing a setback after the SIC, filed its list of candidates, denied allocating the reserved seats to the SIC.

The party then approached the PHC which upheld the electoral body's decision on the matter.

Subsequently, the SIC moved the apex court seeking to set aside the PHC verdict and the allocation of 67 women and 11 minority seats in the assemblies.

The allocation of reserved seats holds significance as the PTI-backed in-

dependent candidates, who made up the majority of the opposition benches, lost as many as 77 reserved seats in NA and provincial assemblies due to the PHC's verdict.

It is also to be noted that the PHC verdict allowing the allocation of reserved seats to the ruling coalition comprising the Pakistan Muslim League-Nawaz (PML-N), the Pakistan Peoples Party (PPP) and others, led to them securing a two-thirds majority in the National Assembly.

The move propelled the PML-N's number in the lower house of parliament to 123, the PPP to 73, whereas the PTI-backed SIC numbers stood at 82.

A three-member SC bench comprising Justice Mansoor, Justice Minallah and Justice Mazhar, took up the SIC's plea on June 6 and suspended PHC's verdict as well as the ECP's decision on the said issue. Following the SC's decision to suspend the ECP order, the coalition lost its two-thirds majority in the lower house.—RT/Agency

PM Decides To Abolish Five Key Ministries In Government Overhaul

ISLAMABAD: Prime Minister Shehbaz Sharif has decided to abolish five key ministries and departments as part of a major government restructuring effort. The Institutional Reforms Cell, established by the prime minister, has commenced work on "rightsizing." According to sources, recommendations have been sought from five federal ministries within a week. These ministries include Information Technology, Kashmir Affairs, Ministry of Safeguard, Ministry of Industries and Production, and Ministry of Health Services.

PM Shehbaz has directed to form a committee comprising the Finance Minister Muhammad Aurangzeb and Member of National Assembly Bilal Azhar Kiani to explain the role of provincial ministries. On the other hand, the federal cabinet has formally approved the abolition of the Ministry of Planning, Development, and Special Initiatives. Approval for the entire plan related to the Ministry of Planning, Development, and Special Initiatives has been granted. The prime minister has instructed to immediately provide relief on electricity bills and expedite work on solar tube wells. In the cabinet meeting, ap-



proval was also given to run advertisements for medicines on TV, radio, and print media. Previously, the federal government further reduced the Public Sector Development Programme (PSDP) by Rs50 billion within 10 days of the start of the new fiscal year 2024-25, the National Assembly Standing Committee on Planning Ministry was informed on June 9. The committee which met here with its chairman Saad Abdul Qadir Gilani in the chair, sought details of the revised PSDP and the ongoing development projects. During the meeting, Planning Secretary Awais Manzoor Sumra gave a briefing on the working of the ministry. Planning Minister Ahsan Iqbal, who also attended the meeting, gave an overview of the prevailing

economic conditions in the country. He painted a grim economic situation, saying that the country was being run on borrowing. Pakistan's Strikes On TTP Hideouts in Afghanistan Are A Domestic Matter: Pentagon



WASHINGTON DC: The US Department of Defense "Pentagon", addressed Pakistan's recent announcements of continued airstrikes on TTP hideouts in Afghanistan, categorizing it as a domestic matter.

During a press briefing, Pentagon Spokesperson Maj Gen Patrick S Ryder emphasized that Pakistan retains autonomy in decisions concerning border protection and internal security.

Pakistan's defence minister Khawaja Asif has said few days ago that Pakistan will continue to launch attacks against Afghanistan as part of a new military operation aimed at countering terrorism.

Khawaja Asif said the aerial strikes were targeting groups which Pakistan accuses of targeting security forces and civilians.

"I am not going to delve into Pakistani domestic decisions. There are regional concerns regarding terrorism, but Pakistan's sovereign decisions on border security and internal security are theirs," Gen Ryder remarked.

He highlighted the longstanding counterterrorism partnership between the US and Pakistan. "We have a longstanding relationship with Pakistan focused on counterterrorism efforts. Discussions regarding support are ongoing between the US and Pakistan. We continue to explore avenues for collaboration to combat regional terrorism," he stated.

Responding to inquiries about intelligence sharing between the two nations, the Pentagon Spokesperson declined to comment on future operations or intelligence matters.—RT/Agency

IHC Justice Tariq Jahangiri Receives 'Suspicious' Calls and Messages

ISLAMABAD: Islamabad High Court's (IHC) Justice Tariq Mehmood Jahangiri has been targeted by suspicious calls and messages, it was revealed on Wednesday.

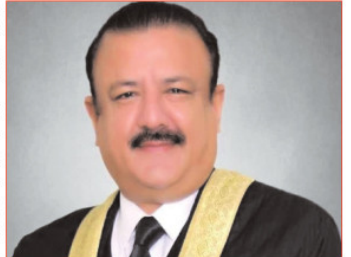
Sources from the judiciary disclosed that the caller purported to be the Director-General of the FIA (Federal Investigation Agency). However, subsequent investigations determined that the FIA DG did not place any such call. The individual behind the suspicious communication attempted to directly contact Justice Jahangiri.

In response, the top jurist has directed the court registrar to promptly inform the FIA, providing them with the mobile number associated with the incident.

According to insiders, the suspicious call was directed to Justice Jahangiri's office at the Islamabad High Court just two days ago. Additionally, messages were sent to the judge's personal mobile number from the same suspicious source.

Previously, the Islamabad High Court (IHC) has decided to confront head-on the alleged government-backed social media campaign targeting its judges, particularly Justice Tariq Mahmood Jahangiri, with a robust institutional response.

IHC on July 8 started contempt proceedings against the people allegedly running a smear campaign



against IHC judge Tariq Mehmood Jahangiri on social media platforms and issued notices to three journalists—Gharidhi Farooqi, Ammar Solangi and Hasan Ayub.

IHC Chief Justice Aamer Farooqi formed a 7-member bench comprising all IHC justices excluding Justice Jahangiri to hear the case.

He said the smear campaign against judges is intolerable and questioned if the Pakistan Telecommunication Authority (PTA), the Federal Investigation Agency (FIA), and the Pakistan Electronic Media Regulatory Authority (Pemra) were unaware of it. The Islamabad advocate general told the bench that the government would take action based on the judges' response.

"Are judges left to respond to such questions? Should we also hold press conferences? We are not

afraid of accountability, but we will not tolerate campaigns against judges. Whoever is found responsible will not be spared and will spend their summer in Adiala Jail," responded Justice Farooqi.

At the start of the full court hearing, Chief Justice Aamer Farooqi stated that the court had explained many times, but no one learned a lesson, adding that the contempt of court proceedings are an institutional response to the social media campaign.

Since May last year, IHC judges have been facing the heat for resisting the alleged interference by executive agencies in their judicial duties. To address the issue, they met with the then CJP Umar Ata Bandial and the incumbent CJP Qazi Faez Isa to discuss the harassment, especially following the Tyrion case.—RT/Agency

NAB Chief Nazir Ahmed Butt Visits Grave Of Watchdog's Victim

ISLAMABAD: Lieutenant General (ret'd) Nazir Ahmed Butt, the chairman of the National Accountability Bureau (NAB), recently visited the grave of brigadier (ret'd) Asad Munir, who had taken his own life several years ago.

Asad, a retired brigadier known for his integrity, had pointed to harassment by NAB as the sole reason for his suicide in his note which he wrote before taking his own life, hoping to prevent others from enduring similar treatment "for the crimes they had not committed".

Three years after his death, an accountability court acquitted Asad.

Last month, a representative from the Nazir's office contacted Asad's widow, Saeda, and sought permission for his superior to visit her. She declined to meet with the NAB chairman but he insisted.

Butt had been intrigued by Asad's suicide note and, while he wanted to express his condolences to Saeda, he also wanted to know more about his last note. In response, the family agreed to



meet. Nazir told Saeda and Asad's brother, Khalid, that the NAB was in the process of drafting Standard Operating Procedures (SOPs) for investigating government officers.

He also wanted to learn what Asad went through, so that it was not repeated. He was also keen to know why NAB went after Asad without a solid reason. The family was not very aware of the motives.

Saeda, who was initially reluctant to meet him, was appreciative of his gesture. "I found him to be a very nice person," she said. The NAB chairman also wanted to visit several other

"victims" of the accountability organisation with Asad's family being the only one he has visited so far.

Three days later, he visited Asad's grave in a graveyard located in Islamabad's Sector H-8.

A friend of Asad, who visited the grave a few days after Nazir, found a floral wreath at his friend's grave along with note that read: "Lt General (ret'd) Nazir Ahmed Butt, Chairman NAB".

According to a NAB source, Nazir plans to see a former vice chancellor during his next trip to Lahore. He was handuffed by NAB and that picture resonated with people across the divide.—RT/Agency

Bill Presented In National Assembly To Amend Citizenship Act



ISLAMABAD: A bill to amend the Pakistan Citizenship Act 1951 has been brought to the National

Assembly, enabling him to get his or her citizenship of Pakistan.

He said that now a new amendment is being introduced stating that if either parent is a Pakistani citizen, the child can be granted Pakistani citizenship.

The bill has been sent to the concerned standing committee for further deliberation.—RT/Agency

Barrister Gohar Slams Phone Tapping as 'Unconstitutional'

LAHORE: PTI Chairman Barrister Gohar has asserted that the Constitution of Pakistan guaranteed the privacy of all citizens, terming the government's decision to authorise Inter-Services Intelligence (ISI) to tap phones "unconstitutional," media reported.

Speaking to international media, Barrister Gohar said that such a "blanket notification" violates the constitution, adding that only the people involved in criminal activities could be subjected to such surveillance.

When asked about PTI founder Imran Khan's own support to phone tapping while he was in power, he said: "Whatever it is, it should be according to the constitution."

Meanwhile, Defence Minister Khawaja Muhammad Asif said he supported



the government's decision to authorise Inter-Services Intelligence (ISI) to intercept phone calls. He emphasised that it was essential "under the current circumstances" as the country strives to eradicate militant violence. "In matters of national security, this measure becomes necessary and should be supported by everyone," the minister, adding, "At the very least, during the ongoing war against terrorism, this action is essential." He dismissed criticism from the opposition, Act.—RT/Agency

saying the PTI members should recall Khan's statements over the issue who justified phone tapping during his own stint in power. In a notification issued on Monday, the Information and Broadcasting Minister said the government had authorised the ISI to tap phone calls and messages "in the interest of national security."
