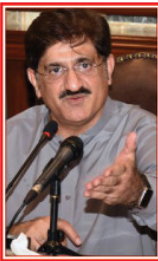

Supreme Court To Announce Verdict On PTI-SIC Reserved Seats Today

ISLAMABAD: The Supreme Court will announce its much-awaited verdict tomorrow (Friday) on a case related to the denial of reserved seats to the Pakistan Tehreek-e-Insaf (PTI)-backed Sunni Itehad Council (SIC), according to a cause list issued on Thursday.

The development came after the apex court's full bench held its second round of consultation on the reserved seats case verdict for the second consecutive day on Thursday.

A special session of the country's top court's 13-member full bench was held under the chair of Chief Justice of Pakistan (CJP) Qazi Faez Isa, the sources said, adding all the judges of the bench attended the session.

The cause list issued on the SC website following the meeting said a full bench led by CJP Isa will announce the short ruling at 12pm on Friday (July 12) on the SIC plea challenging the Peshawar High Court (PHC) decision upholding the Election Commission of Pakistan (ECP) move to deny the PTI-backed lawmakers reserved seats in the assemblies.

The apex court reserved the verdict on the SIC's appeals on Tuesday after conducting nine hearings on the SIC's appeals with all parties including the federal government and the ECP presented their arguments against the



SIC's plea.

The full bench also comprises Justice Syed Mansoor Ali Shah, Justice Muneeb Ali Shah, Justice Yahya Afridi, Justice Amin-ud-Din Khan, Justice Jamal Khan Mandokhail, Justice Muhammad Ali Mazhar, Justice Athar Minallah, Justice Syed Hassan Azhar Rizvi, Justice Ayesha Malik, Justice Shahid Waheed, Justice Irfan Saadat Khan and Justice Naeem Akhtar Afghan.

What is reserved seats case? The reserved seats' issue first emerged after over 80 PTI-backed independent candidates emerged victorious in the February 8 elections and subsequently joined the SIC in a bid to claim seats reserved for minorities and women.

However, the Imran Khan-founded party suffered a setback after the ECP, citing the party's failure to submit its list of candidates, denied allocating the reserved seats to the SIC.

The party then ap-

proached the PHC which upheld the electoral body's decision on the matter.

Subsequently, the SIC moved the apex court seeking to set aside the PHC verdict and the allocation of 67 women and 11 minority seats in the assemblies.

The allocation of reserved seats holds significance as the PTI-backed independent candidates, who make up the majority of the opposition benches, lost as many as 77 reserved seats in NA and provincial assemblies due to the PHC's verdict. It is also to be noted that the PHC verdict allowing the allocation of reserved seats to the ruling coalition comprising the Pakistan Muslim League-Nawaz (PML-N), the Pakistan Peoples Party (PPP) and others, led to them securing a two-thirds majority in the National Assembly.

The move propelled the PML-N's number in the lower house of parliament to 123, the PPP to 73, whereas the PTI-backed SIC number stood at 82.—RT/Agency

Pakistan And Azerbaijan Pledge To Increase Investments To \$2 Billion

ISLAMABAD: Pakistan and Azerbaijan decided to increase their bilateral investment level to up to US\$2 billion in the sectors which will be benefiting both countries, media reported.

Addressing a joint presser with Azerbaijan President Ilham Aliyev, Prime Minister (PM) Shehbaz Sharif said that they discussed an initial figure of US\$2 billion of investment in areas of mutual beneficial projects.

Both leaders also witnessed the signing of agreements and Memorandums of Understanding (MoUs) in diverse areas between the two countries. The prime minister hoped that upon his November 2024 visit to Azerbaijan, the two countries would be prepared to sign agreements valued at US\$2 billion initially, given the considerable potential for both parties to increase this amount in the years to come.

"In today's in-depth conversation, we have agreed to



enhance our bilateral trade besides discussing areas of cooperation and joint investments," PM Shehbaz added.

He said that bilateral investment volume of less than US\$100 million does not reflect the strength of brotherhood and friendship between Pakistan and Azerbaijan in the field of joint investment.

The prime minister expressed satisfaction with the bilateral meeting and said that both parties reaffirmed their steadfast commitment to moving forward and reaching higher levels of success in the areas of trade and investment. The discussions were based on mutual

trust and confidence, he added.

PM Shehbaz said that Pakistan consistently backed Azerbaijan's position, just as the friendly nation has consistently championed the cause of millions of Kashmiris who have given enormous sacrifices for over 70 years in order to attain their right to self-determination in accordance with UN Security Council resolutions.

The prime minister also recalled the President Aliyev's visit in 2017 during the tenure of then PM Nawaz Sharif, saying that history was repeating as Nawaz Sharif's younger brother was now receiving

him along with people of Pakistan.

PM Shehbaz hoped that the COP29 to be hosted by Azerbaijan in Baku would be a significant international event for all developing countries including Pakistan. "We are confident that under our wise stewardship, COP29 will deliver on the climate change related issues of developing countries like Pakistan."

He said the government was impressed by the beautification of Baku therefore it decided to copy Baku. Speaking on the occasion, Azerbaijan President Ilham Aliyev said the brotherhood between the two countries was based on deep feelings between peoples of the two sides. "This connection is a big asset, we are brothers, we are friends, and we support each other on every international issue," he added. The president said that Azerbaijan supports Pakistan's stance on the issue of Jammu and Kashmir. "It is our commitment

to our brotherhood and also our respect to international law, the rights of Kashmiris are ignored and violated for decades."

He said the United Nations Security Council (UNSC) resolutions clearly indicated how this issue must be resolved but the resolutions had no mechanism of implementation. "But we as brothers and friends will always stand side by side with you, with our brothers in Kashmir, with International law, with justice and I am sure justice will prevail," he added. President Aliyev said the two sides are analysing the projects for the initial investment of US\$2 billion. "During our today's conversation, we reviewed several projects in the areas of energy, connectivity, infrastructure, and defence industry. We will build strong partnerships not only on the political level that we already had but on economic and trade investment levels as well," the president stated.—RT/Agency

ATC: 'Reasonable Grounds Exist' To Link Imran Khan To May 9 Offences

LAHORE: An anti-terrorism court in Lahore has issued a written verdict on dismissing Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan's bail in cases related to May 9, 2023, riots.

ATC Judge Khalid Arshad issued a four-page written verdict on Thursday after his court rejected interim bail pleas of the former prime minister in three cases related to the May 9 violence protests two days ago.

The May 9 mayhem referred to the riots that broke out in many parts of the country last year following the ex-PM's arrest in a corruption case.

The alleged PTI supporters attacked several state buildings including military installations, prompting the civil and military authorities to try the rioters under Army Act.



The verdict stated that two witnesses produced by the prosecution told the court in their testimonies that a meeting was held at Khan's Zaman Park residence in Lahore on May 7, 2023, which they also attended along with 15 senior leaders of the former ruling party.

In the meeting, the petitioner [Imran Khan] expressed fears about his arrest in the Islamabad High Court (IHC) on May 9, the verdict

read, adding that the politico also ordered the PTI leaders to gather the party workers under the leadership of Dr Yasin Rashid in case of his arrest. The party leaders, in the same meeting, was instructed by the petitioner to "attack military installations, government properties and the police officials to create pressure on the government and armed institutions for his release," the verdict read.—RT/Agency



ISLAMABAD: Federal Minister of Energy Awaiz Leghari on Thursday said that the issue of the IPPs has been under consideration.

Talking to media, Awaiz Leghari said that the issue of the independent power producers (IPPs) being seen from various angles. "We are seeing, how much time of an IPP is remaining," he said.

"We also seeing, how much benefit or loss given by an IPP and what mechanism required to remove an expensive power producer and what price we have to pay for

it," energy minister said. "Can we bear the price of removing the IPPs," he questioned.

Pakistan's energy minister said that "We will reach to a decision soon under the instructions of the prime minister," he said.

He said the power tariff for all consumers will go down after January.

"I could not issue statements like Sheikh Rashid," the minister replied when a media person asked about the future of the IPPs.—RT/Agency

Pakistan Agrees To Implement Tax On Agricultural Income On IMF's dictates



ISLAMABAD: Pakistan has 'agreed' to the imposition of tax on agriculture income during talks with the International Monetary Fund (IMF), ARY News reported on Thursday, citing sources.

International Monetary Fund (IMF) officials held virtual negotiations with the provincial officials of Pakistan for the new loan programme.

Sources said the IMF officials urged the provincial authorities to slap tax on agricultural income, which the provinces of Pakistan reportedly agreed upon. The provincial governments of all four provinces of Pakistan sought time to submit a plan for imposing tax on agricul-

tural income. The plan would be submitted to the IMF by July 12. The sources further said that the tax on agriculture income will be slapped from yearly income of Rs600,000. Subject to signing of the new agreement, the sources said that the global lender has set the October 2024 deadline to amend the existing provincial laws to bring them in par with the federal income tax law. The IMF has also asked for rescinding any income tax exemption for the livestock sector by October this year. It is to be noted that finance ministry officials anticipate that an agreement for the new loan program will be finalized in July.—RT/Agency

Rana Sanaullah Quips: 'Avoid Conversations That Make You Fear Call Tapping'

ISLAMABAD: Prime Minister's Adviser on Political and Public Affairs Rana Sanaullah has remarked that people shouldn't engage in such controversial conversations in the first place that they have to fear their calls being tapped.

"If somebody is worried over their conversations being 'heard', then they should not engage in such verbal exchanges to begin with," Sanaullah said while speaking on Geo News' programme "Capital Talk" on Wednesday.

The senior politician's remarks come as the PM Shehbaz Sharif-led government has authorised the country's premier spy agency Inter-Services Intelligence (ISI) to intercept and trace calls and messages in the apprehension of an offence against national security.

The federal cabinet approved the relevant circular allowing a designated officer, not below grade 18, of the ISI to carry out the tracing of calls under Section 54 of the Telecommunication (Re-organization) Act 1996.

The move reflects the government's stance in favour of stricter social media regulations and comes against the backdrop of prevailing ban on X.

The decision, however, has been received with notable scepticism by the Pak-



istan Tehreek-e-Insaf (PTI) as well as the Human Rights Commission of Pakistan (HRCP).

Expressing his views on the same programme, PTI leader Salman Akram Raja said that the state has no right to pry into someone's house and that no one would be safe if conversations are to be "heard" on the basis of mere suspicion.

His remarks came as a day earlier, Leader of Opposition in the National Assembly Omar Ayub announced that he would challenge the notification through his lawyer Babar Awan in the court, as it was unconstitutional and against the fundamental rights envisaged in the constitution.

"Asif Zardari, Nawaz Sharif, Shehbaz Sharif, Bilawal Bhutto Zardari and Maryam Nawaz will also go to prison because of this law," Ayub said, adding that all of them would be seen

pursuing their cases in courts.

Whereas, the HRCP has expressed concern over the "unconstitutional notification" of the government and has stressed that owing to the government and spy agencies' poor track record, the measure would invariably be used to clamp down on political dissent through means of blackmail, harassment and intimidation.

Slamming the "flagrant violation of citizens' constitutional protected rights to liberty, dignity and privacy under Articles 9, 14 and 1," the watchdog has called on Islamabad to urgently introduce "watertight" checks and balances to all surveillance practices. Meanwhile, the government's notification empowering the ISI to tap and intercept phone calls has been challenged in the Lahore High Court, The News reported on Thursday.—RT/Agency

IHC CJ Aamer Farooq: Verdicts Pronounced In Anger Lead To Travesty Of Justice

ISLAMABAD: Chief Justice Islamabad High Court, Justice Aamer Farooq said on Thursday that decisions announced by judges out of anger did not meet the standards of justice.

The IHC CJ was speaking at a ceremony organised by the Islamabad High Court Bar Association.

Expressing concerns over young lawyers' lack of learning, the IHC CJ said that in the past, a new entrant in the field of law used to spend around six months in the chamber of a senior lawyer where he was groomed to meet grinding demands of legal practice.

He conceded that he also flew off the handles at times for grooming people, insisting that people didn't usually understand if



Justice Farooq deplored that idea of chamber institution was fast fading as lawyers spent more time in gossiping instead of learning, which he said was the nursery for producing the best legal minds. He said that our predecessors kept the chamber alive while it had been kept defunct for the last ten years. "I was

part of the chamber run by Mian Nisar, the father of former Chief Justice Saqib Nisar and ex-CJP himself. I learnt a lot from them," he added. Lawyers should come to the court fully prepared with proper notes before starting their arguments, adding that ethics to work in the courts must be learnt by the newbies of law.—RT/Agency

JI Reschedules Sit-In Protest Against High Power Bills

LAHORE: Jamaat-e-Islami Emir Hafiz Naeemur Rehman postponed the planned sit-in against the government due to Ashura.

Earlier, JI had announced to hold sit-in in Islamabad against the exorbitant electricity bills on July 12 (tomorrow).

Addressing a press conference in Lahore, JI emir said that they will now hold sit-in on July 26 instead of July 12. "We have a track record of holding sit-ins in the country. We have only rescheduled our plan in respect of Ashura," said Hafiz Naeem.



He added that rallies will reach Islamabad on July 26 from all parts of the country. The JI emir was of the view that the government has failed to provide relief to the masses. Hafiz Naeem announced that he will visit

all the major cities of the country to hold meetings with the traders and lawyers. "If the government wants us to cancel our sit-in then it should provide relief to the people," said JI emir.—RT/Agency

UMERKOT: The budget meeting for the fiscal year 2024-2025 of the District Council Umerkot was held under the chairmanship of Haji Muhammad Baqa Palli. During the meeting, the budget of 994.9 million rupees for the year 2024-2025 was presented. Vice Chairman of the District Council Umerkot, Mian Khalid Walhari, shared the budget figures, stating that the budget is both a savings and public budget. The total income for the year is estimated at 337.275 million rupees, while the total expenditures are 994.930 million rupees. Salaries for employees account for 170.169 million rupees, new development schemes are allocated 263.7 million rupees, and ongoing development schemes have been allocated 463.360 million rupees. The overall savings for the year amount to 5,863 rupees. Additionally, the budget includes 300,000 rupees for grants to various press clubs in the district, 10 million rupees for financial assistance to needy students, and 1 million rupees for employee financial aid. 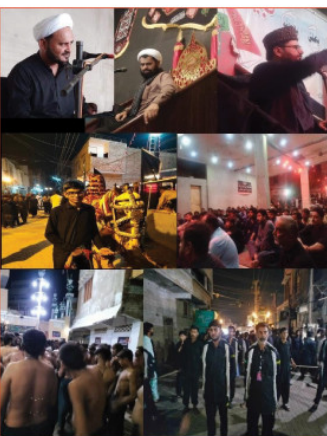
Jinnah Law Association Pakistan, ILF hold a seminar on the rule of law

DHQ Hospital Dadu lacks basic facilities

DADU: The building of DHQ Hospital Dadu, which was inaugurated by President Asif Ali Zardari in 2012, has been stalled. Despite efforts by Education Minister Pir Mazhar-ul-Haq, the people of Dadu District have been denied modern health facilities. The control of the DHQ Hospital was handed over to the LUMHS Jamshoro but the hospital has still proved fruitless for the people due to lack of facilities. The hospital lacks essential services such as electricity which has adversely affected the medical treatment of patients and has put a strain on the hospital's operations. There are 12 wards at the hospital which are lying closed. Dr. Amjad Ali Mazdot, MS of the hospital favored the decision of handing over hospital to the LUMHS and condemned the SEPCO authorities for not supplying power to the hospital.

SSP Shahzeb Chachar orders for foolproof security in Shikarpur

SHIKARPUR: SSP Shikarpur Shahzeb Chachar has issued strict orders to the police to maintain law and order and uphold the rule of law during Muharram in the district. During Muharram, security arrangements for mourning processions and gatherings in the city and throughout the district have been made extremely stringent. A total of 3,124 officers and personnel from the Shikarpur police have been deployed for security during Muharram. According to SSP Shikarpur Shahzeb Chachar, there will be 231 processions and 1,019 gatherings held during Muharram. Among the gatherings, 19 are general, 107 are highly sensitive, and 110 are sensitive processions. Major processions will include those from Imambargah Karbala Maula Lakhidar, Imambargah Dargah Jhangal Shah, Panj Pir Hathidar, Imambargah Shah Najaf Hyderi Muhalla and Imambargah Javadia Lakh Ghulam Shah. Additionally, 200 Rangers personnel and 200



soldiers from the Pakistan Army will also perform their duties during Muharram. For the inspection of women, 231 voluntary lady health workers and 14 lady police officers have been appointed. The deployment of commandos aims to ensure the protection of people's lives and property and to provide a swift response to any terrorist threats. All DSPs and SHO's will increase mobile and motorcycle patrolling and will periodically review the security arrangements made by the police. Commandos will also be stationed on high-rise buildings during gatherings and processions to perform their duties. Snap checking at entry and exit points of the city has been intensified, and suspicious individuals will be closely monitored. All traffic police personnel will maintain the flow of traffic in the city to prevent any inconvenience to the citizens. A control room has been established at the police headquarters during Muharram. CCTV cameras have been installed in Shikarpur city and other important locations, and drone cameras will be used to monitor the processions.

Haji Tariq Aziz Baloch chairs budget session of Gadap Town

KARACHI: Chairman Town Municipal Corporation Gadap, Haji Tariq Aziz Baloch, has presented a budget of Rs 3,148,871,161 for the fiscal year 2024-2025. Alongside him, Vice Chairman Jam Muhammad Jokhio and Municipal Commissioner Ahmed Yar are also present. The Financial Committee Chairman, Muhammad Rafique Jokhio briefed the council members about the budget details. The estimated revenue from own sources is Rs 2,741,201,020. The total estimated income amounts to Rs 3,148,871,161. The total non-development expenditures including salaries amount to Rs 1,651,830,451 and other miscellaneous expenses for maintenance total



Rs 251,692,000. Chairman Haji Tariq Aziz Baloch emphasized that this is the town's second budget, aimed at providing the best facilities to the citizens, including improved street lights, sanitation, sports facilities, parks, and other development projects. He reiterated the commitment to fulfill the basic municipal needs of the people as per the manifesto of the Pakistan People's Party and to enhance the quality of life. The budget has been prepared in consultation with council members and senior officials to ensure it is people-oriented.

-This is sheer madness! NEPRA approves massive hike in power tariff

KARACHI: The National Electric Power Regulatory Authority (NEPRA) has approved the government's request to increase the basic electricity tariff by up to Rs 7.12 per unit, media reported on Thursday.

This tariff hike will apply uniformly across the country, including Karachi, while the Households and consumers with up to 200 units monthly are exempted from the hike for three months.

As per the notification, the domestic consumers will see a new tariff structure with the consumers between 201 and 300 units per month, the tariff will increase by Rs 7.12 to Rs 34.26 per unit. Those consuming units between 301 and 400 will experience an Rs 7.02 increase, bringing rate to Rs 39.15 per unit. Consumers using between 401 and 500 units will see their rates go up by Rs 6.12 to Rs 41.36 per unit.

The tariff for those consuming between 501 and 600 units will rise by Rs 6.12 to Rs 42.78 per unit, and for those using between 601 and 700 units, the rate will increase by Rs 6.12 to Rs 43.92 per unit. Additionally, the consumers exceeding 700 units per month, the tariff will increase by Rs 6.12 to Rs 48.84 per unit.

Meanwhile, the lifeline consumers, who use up to 50 units per month, will continue to pay Rs 3.95 per unit. Those consuming between 51 and 100 units will maintain a rate of Rs 7.74 per unit. NEPRA has sent the notification for this tariff increase to the federal government, which is expected to issue an official notification soon. The tariff hike will apply uniformly across the country, ensuring a standardized rate for all regions, including Karachi.

Lahore High Court's first woman CJ Aalia Neelum sworn in

LAHORE: Justice Aalia Neelum shattered the glass ceiling, becoming the first woman chief justice in the 142-year history of the Lahore High Court. Punjab Governor Saleem Haider Khan administered the oath to the new chief justice at the Governor House, with Punjab Chief Minister Maryam Nawaz in attendance. Headed by Chief Justice Qazi Faez Isa, the Judicial Commission of Pakistan had unanimously greenlighted her elevation after considering the nomination of three judges for the position of LHC chief justice.



Justice She will now be serving as the 47th chief justice of the Lahore High Court since 1920 and 54th overall since March 21, 1882, when this judicial institution was called the Chief Court of Lahore.—RT/Agency

Bin Qasim Police recover two abducted girls

KARACHI: In the jurisdiction of the Bin Qasim Police Station, from the area of Rafiq Qad Colony, two innocent sisters, 7-year-old Shabana Khuhawar and 4-year-old Saman Khuhawar, were abducted. Following a complaint from the grandmother of the abducted girls, Amiran, the Steel Town Police took prompt action under the supervision of DSP Bin Qasim, Naem Bhatti and SHO Aga Abdul Rasheed. The police successfully re-



covered the abducted girls near link road and apprehended the female abductor, Faiza, and the rickshaw driver. According to SHO Aga Abdul Rasheed of Steel Town, upon interrogation, the female abductor confessed to drugging and then abducting the mentioned girls. Both abducted girls have been transferred to the hospital for medical treatment. Meanwhile, based on the complaint of the grandmother of the abducted girls, a case has been registered against the abductors at Bin Qasim Police Station.

-Can you believe this? Poultry, egg prices to be hiked

KARACHI: The inflation hit citizens of Karachi is like to slap with another burden as the price of chicken meat and eggs per dozen is expected to increase in the next few days, media reported on Thursday.

The price of chicken meat is expected to increase by Rs 100 to Rs 150 per kg, while the price of eggs is likely to increase by Rs 50 to Rs 70 per dozen.

It is pertinent to mention here that the price of chicken meat is Rs 480 per kg while eggs are being sold

at Rs 240 per dozen in Karachi.

Last month, the Senate Standing Committee on Finance supported the decision to cease tax exemptions on chicken feed. In the standing committee meeting, FBR officials stated that a 10 percent exemption on chicken feed is being abolished.

The officials said that 10 percent sales tax will be imposed on livestock feed, including cows and buffaloes, which will generate Rs 47 billion in terms of sales tax.—RT/Agency

FIA Raids MCB Bank in Karachi for Illegal Currency Trading

KARACHI: A source informed authorities about illegal foreign currency trading at MCB Bank's West Wharf branch in Karachi. Enquiry No. 45/24 was registered at the Federal Investigation Agency's (FIA) State Bank Circle (SBC) in Karachi.

Subsequently, a raiding party from FIA SBC was formed and proceeded to the branch, where they recovered \$10,000 and apprehended Branch Manager Shujaudin S/O Qamarudin along with two other suspects (one dealer and one rider). Initial interrogations revealed that Shujaudin had been involved in the illegal sale and purchase of foreign currency for a long time, operating with a main dealer named Hussain S/O Abdul Gaffar. Further investigations are currently underway.—RT

Labor organizations not happy with Sindh Labor Code

KARACHI: The leaders of representative labor organizations today rejected the anti-worker draft of the "Sindh Labor Code" presented by the International Labour Organization (ILO) and the Sindh Labor Department without consultation.

They rejected the draft while addressing a joint press conference of workers' representatives in Karachi. They declared that any attempt to legalize it will be strongly resisted.

Nasir Mansoor, General Secretary National Trade Union Federation told the press conference that the code draft was a conspiracy to impose anti-labor laws on the workers of Sindh without the established tripartite consultation process. He further said that the Sindh Labor Code draft aimed to usurp the basic rights of workers, which they had achieved through over a century of struggle. It was a blatant violation of the core conventions of the ILO, where the identity of the worker and his relationship with the employer had been eliminated.

Mansoor said that the current labor laws grant the right to permanent employment to workers, but the "Sindh Labor Code" seeks to legalize the illegal contract labor system, thereby imposing a wage slavery system in workplaces and providing capitalists with a legal excuse to evade their responsibility.

Naseem Rao, Senior Vice President Pakistan Workers Federation said that instead of making the definition of workers modern, comprehensive, and better aligned with current needs, this code had made it more complicated, leaving workers entirely at the mercy of contractors, sub-contractors, or third-party recruiting agencies, which will reduce millions of workers to unrecognized wage slaves.

Liaquat Ali Shah, General Secretary State Bank of Pakistan CBA Union said that the proposed "Sindh Labor Code" shamelessly redefined factory owners into different categories, exempting them from their legal responsibilities and informalizing the formal sector. As a result, in the event of any industrial dispute, workers will be deprived of all basic rights such as legal action, social security, pension, unionization, bonuses, working hours, and gratuity. Hussain Badshah, General Secretary People Labour Bureau said that the Sindh Labor Code also proposes to legalize the inhuman system of advance (PASHGI) payments, allowing owners to buy and sell workers, which will degrade the lives of workers in kilns and agricultural fields to worse than that of animals. The advance payment system was a modern form of slavery and a clear violation of

the ILO conventions.

Farhat Parveen, Secretary Legal Affairs, All Pakistan Lady Health Program Workers Union said that the worst aspect of the code was that it attempted to strip many employees in government institutions from grades one to fifteen of their right to unionize and collective bargaining, violating ILO conventions 87 and 98. Furthermore, she said that "Sindh Labor Code" aimed to end worker solidarity by eliminating their identity and dividing them into several layers and categories. Zehra Khan, General Secretary of Home Based Women Workers Federation (HBWWF) said that the code, imposed by the ILO and Sindh Labor Department, places restrictions on the right to strike, making it practically ineffective and nearly impossible, even though it is a fundamental right. She further said that the "Sindh Labor Code" significantly increases bureaucratic powers. Instead of simplifying the procedure for resolving industrial disputes, it makes it more complicated, time-consuming and impractical. Inman Ali, General Secretary Pakistan Federation of Chemical, Energy and Mines (PECM) said that the code severely undermines workers' basic right to health and safety and found ways to exempt owners from their responsibilities.—RT/Agency

Naqvi apprises Bohra community's spiritual head about Muharram security measures

KARACHI: Federal Interior Minister Mohsin Naqvi on Thursday said that the federal government was fulfilling all demands of the provinces during Muharram-ul-Haram. He was on a visit to Karachi to check security arrangements for Muharram-ul-Haram. Interior Minister visited Imam Bargah Shah Shaheedan and Burhani Palace in Burhani Palace, he met the head of the Bohra community, Syedna Muffazzal Saiful Din. Minister Naqvi expressed best wishes for Syedna Muffazzal, saying that the government welcome him in Pakistan. Duo also thanked each other for taking time out for the meeting. During his visit to the Imam Bargah Shah Shaheedan, Naqvi met Allama Aqeel Gharrawi who was on a brief visit to Pakistan for Muharram-ul-Haram. Successful taxation requires representation and the nation's trust

The government's recent negotiations with the International Monetary Fund (IMF) to impose a tax on agricultural income reflect a broader issue plaguing Pakistan: a growing trust deficit between the government and its citizens. This trust deficit must be addressed before implementing any new taxes, as it significantly contributes to tax evasion.

History teaches us that there can be no taxation without representation. Citizens must feel represented and trust that their taxes are being used effectively and transparently. However, the controversy surrounding Form 47 has only deepened the public's mistrust. Many feel unrepresented and doubt the government's commitment to fair and equitable tax collection. This skepticism is particu-

larly pronounced when new taxes are introduced, such as the proposed agricultural income tax.

The provincial governments' recent reassurances



to the IMF about implementing this tax are a step towards meeting the lender's demands. Yet, without addressing the underlying trust issues, these measures may fall short. The government's ambitious tax revenue target of Rs13 trillion, a significant increase from previous years, will likely place additional burdens on already taxed sectors, particularly salaried workers. This approach risks further alien-

ating the public if they do not see improvements in governance and accountability.

For meaningful progress, the government must prioritize rebuilding trust. This involves not only transparent and equitable tax policies but also genuine efforts to address the grievances highlighted by the Form 47 controversy. Ensuring that all sectors, including agriculture, are taxed fairly is crucial, but it must be accompanied by a commitment to good governance and representation.

Ultimately, bridging the trust gap is essential for the government's financial strategies to succeed. Only then can the nation move forward with a unified approach to taxation, ensuring that all citizens feel represented and confident in their government's actions.

District Council Mirpurkhas passes budget for fiscal year 2024-25

Wanindu Hasaranga steps down as Sri Lanka T20I captain



Wanindu Hasaranga has resigned as Sri Lanka's T20I captain after roughly six months in the role. He did not specify a reason for this decision, but said in a statement put out by the board that his decision was in the best interest of Sri Lanka's cricket.

"Sri Lanka will always have my utmost best efforts as a player, and I will support and stand by my team and leadership as always," Hasaranga said in his resignation letter, according to the board.

Although Hasaranga's resignation comes on the heels of a poor World Cup in which Sri Lanka failed to qualify for the Super Eight, it is still something of a surprise.

There was little public pressure on him to be ousted, partly because he was still so new in the role. He also appeared to be relishing the job, even prioritising Sri Lanka commitments over IPL appearances this year as he recovered from a foot injury.

Sri Lanka now sits the 10 T20Is they played under Hasaranga, winning bilateral series against Zimbabwe and Afghanistan to start 2024. He had also been suspended for two matches for abusing an umpire during this stint.

He remains captain of the Kandy Falcons Lanka Premier League team in the ongoing franchise tournament.

While there are no obvious candidates to replace him as captain of Sri Lanka in T20Is, Charith Asalanka's name will be discussed. He took the reins in the two matches Hasaranga had been suspended for, and also leads Jaffna Kings in the LPL this year.

Sri Lanka's next T20I assignment is the three-match series against India at the end of this month. Sri Lanka will enter that series with a new coach as well, with Sanath Jayasuriya taking over in an interim capacity after Chris Silverwood stepped down following the World Cup. Mahela Jayawardene, too, had quit as consultant coach last month.—Agency

PCB chalks out new formula for selection committee formation



KARACHI: After making notable changes in the national side's management, the Pakistan Cricket Board (PCB) has chalked out a new formula for the constitution of the selection committee, sources told Geo News on Wednesday.

The selection committee, the sources claimed, will now include coaches for white-ball and red-ball formats as well as the captain of the relevant format along with ex-cricketers Mohamud Yousuf, and Asad Shafiq.

The PCB's move comes against the backdrop of the aftermath of Green Shirts' dismal performance and elimination from the T20 World Cup 2024 which has prompted Mohsin Naqvi-led board to make changes in the team management.

A day earlier, the board confirmed sacking former pacer Wahab Riaz and all-rounder Abdul Razaq from the seven-member selection committee while retaining Yousuf, Shafiq and Bilal Afzal.

Wahab was a member of the men's selection committee, whereas Razaq was part of the selection committee for the women's team. Furthermore, the board has also removed Riaz from the post of senior team manager along with team manager Rana Mansoor due to the lack of discipline during the last three tours of the men's and women's teams.

Both Wahab and Razaq, the sources have claimed, extended undue favours to certain players and PCB Chairman Mohsin Naqvi decided to oust the duo only after the culmination of the investigation into the said matter.

The players supported by the duo turned out to be the ones who didn't perform and were in fact opposed by other members of the selection committee as well, the sources added.

However, reacting to his removal, the former pacer questioned how could one individual's vote dominate six, as the selection committee comprised seven members. He stressed that everything was documented on record in the minutes of the meeting.—Agency

Thatta Police recover narcotics during drug arrests

On the directives of SSP Thatta Dr. Muhammad Imran Khan, Thatta Police have intensified their crackdown on narcotics and criminal activities. The operation aims to recover narcotics, arrest criminal elements and habitual offenders, and curb the preparation and supply of contraband cheques like Gutka and Main Puri.

In a recent successful operation, police thwarted an attempt to supply Gutka materials and drugs using a KIA vehicle with a fancy number plate. Additionally, they recovered Gutka materials hidden in the petrol tank of a Mehran car. Two suppliers of Gutka and drug materials were arrested, and cases were registered against them. The operation led to the seizure of 100 kg of Gutka materials, 2350 grams of hashish, 400 packets of Gutka Maawa, a KIA vehicle, and a Mehran car. Acting on the orders of SSP Thatta, SHO Thatta Sub-Inspector Attar Channa, along with his staff, conducted a successful operation at Ojri Mosque in Thatta based on a tip-off. They arrested one supplier, Zain son of Zahid Memon, and recovered 2350 grams of hashish, 50 kg of Gutka materials, and two fancy number plates. Separate cases have been registered against the accused at Thatta police station.

In a parallel operation, SHO Dhabaji Inspector Mubeen Pariyar and his team conducted a raid at the Dhabaji check post. They intercepted a suspect, Zia-ur-Rehman son of Fazal Rehman Pathan, who was attempting to supply Gutka materials hidden in the petrol tank of a Mehran car. The operation resulted in the recovery of 50 kg of Gutka materials and 300 packets of Gutka Maawa. A case has been registered against the accused at Dhabaji police station.

These operations underscore the commitment of Thatta Police to eradicate the menace of narcotics and contraband in the region.

Watkins sends England past Netherlands and into Euro 2024 final

DORTMUND: Ollie Watkins struck a stunning injury-time winner as England beat the Netherlands 2-1 on Wednesday to set up a Euro 2024 final showdown with Spain in Berlin.

It was an incredible finish to an evening that began badly for England, as Xavi Simons gave the Netherlands an early lead in the semi-final in Dortmund.

However, England were soon level through a Harry Kane penalty following a contentious VAR call by German referee Felix Zwayer, and the match looked set for extra time until Watkins struck.

On for Kane, Watkins received a pass from fellow substitute Cole Palmer with his back to goal in the first minute of stoppage time, turned and fired low into the far corner to leave the Netherlands bewildered.

"I'm lost for words really," said Watkins, the Aston Villa striker. "I don't think

It has rarely been a convincing campaign from Gareth Southgate's England side, but they are through to their second consecutive European Championship final

as they dream of finally winning a first major trophy since 1966.

To do that they will surely have to perform better than at any point so far in Germany as they face an outstanding Spain team, who beat France 2-1 on Tuesday.

"We play the team who've been the best team in the tournament and we have a day less to prepare so it's a huge task. But we're still here and we're fighting," Southgate said. The Netherlands had been hoping to repeat their triumph at the last Euros in Germany, in 1988, but their current side lacks anyone with the star quality of Marco van Basten or Ruud Gullit.—Agency

Earlier, it was reported that Shaheen misbehaved with the coaches and management during recent tours but no action was taken by the team managers on the

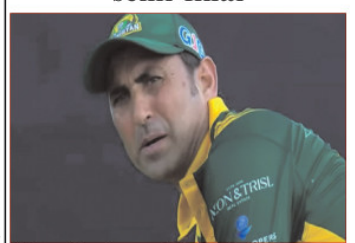

Concurrently, the cabinet has designated the Khasar area for granite mining, pending clearance from the Forest & Wildlife Department.



lapping forested regions. Approval for mining was granted contingent upon fulfilling environmental regulatory requirements.

Under the leadership of Chief Minister Syed Murad Ali Shah, the decision was reached during a session held at the CM House on Thursday. The meeting was attended by provincial ministers, advisors, Chief Secretary Asif Hyder Shah, and other key officials.

Furthermore, amendments to the Provincial Motor Vehicle Ordinance (PMVO) 1965 were endorsed to expedite vehicle registration processes, bolster public safety, and fortify revenue collection efforts.

Court approves FIA's search warrant plea for Sarim Burney Trust

KARACHI: A local court in Karachi Thursday approved Federal Investigation Agency's (FIA) plea to issue search warrant for Sarim Burney Trust in the 'human trafficking case', ARY News reported.

Sarim Burney appeared before the court in today's hearing via video link. The court of Judicial Magistrate East took up the case.

At the outset of the hearing, the FIA team stated that they want to record the statements of trustees of Sarim Burney Trust and pleaded to approve the plea for issuance of search warrant of the trust.

The plea was approved by the court and the hearing was adjourned until July 25.

Burney was taken into custody on June 5 after he landed at the Jinnah International Airport in Karachi following his US visit.

The Federal Investigation Agency (FIA) registered first information report (FIR) against rights activist Sarim Burney for allegedly trafficking newborn babies to United States (US).

In the FIR, the investigation agency booked the rights activist for 'trafficking a newborn baby - identified as Haya - to the US. Haya, who according to FIA was the last girl trafficked to US, was allegedly bought from her parents for Rs1 million.

Sarim Burney trafficked 20 newborns to the US in the past year on pretext of adoption. The FIA claimed that 15 of the trafficked children were girls.

The FIA, in a statement, said that the records of the allegedly trafficked children were provided by the Pakistan embassy. Citing the Trust documents, the agency said Burney's wife was also among the beneficiaries. According to the FIA, Haya's parents are extremely poor, and their statements have been recorded. Further cases related to human trafficking and money laundering will be registered against Burney, the agency said.—RT/Agency

Electricity bills have a whopping 71% capacity charges: Mustafa Kamal



KARACHI: Mustafa Kamal on Thursday said that out of 100 rupees of the electricity bill 71 are capacity charges, media reported.

"Why we pay for the electricity, which is even not being generated," MQM-P MNA talking to media here said.

Salt Manufacturers Urge PM To Tackle Axle Load Rules For Transporters

KARACHI: The implementation of axle load regulations for truck transport has inadvertently sparked a surge in extortion targeting traders across Pakistan. This exploitation has resulted in escalated transport costs, critically impacting the nation's export operations.

Qasim Yaqoob Paracha, Chairman of the Salt Manufacturers Association of Pakistan (SMAP), has petitioned Prime Minister Shahbaz Sharif and Federal Minister of Communications Abdul Aleem Khan to address the mounting issue of transporter extortion. He stressed the crucial need for strict en-



forcement of the Ministry of Communication's axle load regulations to ensure equitable transport charges for goods.

Paracha underscored that transport cartels are

exploiting loopholes in axle load limits, imposing exorbitant fees on traders for loads exceeding the mandated 30 to 32 tons. He cited arbitrary fines and delivery delays as tactics used to unjustly inflate costs, severely impacting sectors like the salt industry and impeding export activities.

The SMAP Chairman urged the government to establish clear and stringent nationwide guidelines for axle load limits, mandating transporters to adhere strictly to government-regulated charges based on prescribed load limits.—RT

Petition filed in SHC against tree cutting in Karachi

KARACHI: A citizen has filed petition in Sindh High Court (SHC) against tree cutting by the city government of Karachi, media reported on Thursday.

The high court has served notices to Mayor Karachi and others in the case and summoned reply from the respondents on the next hearing of the case.

The bench adjourned further hearing of the case until August 21.

The petitioner has made the KMC, D.G. Parks and other respondents in the case. Petitioner pleaded to the

court that the D.G Parks has ordered cutting of trees on the instructions of the city's mayor. "The trees have been cut around the city's Jail Chowrangi (roundabout)," according to petitioner.

"It is violation of the court's prohibition order of cutting trees," according to the petitioner.

Cutting of trees amid extreme weather events has been seen as a step that will further aggravate the climate problems for the city including prolonged heatwaves and soaring temperatures.—RT/Agency

Sri Lankan woman's death: Flight makes emergency landing at Jinnah International

KARACHI: A foreign airline flight en route from Dubai to Colombo made an emergency landing at Karachi airport following the sudden deterioration of a female passenger's health.

Tragically, the 57-year-old Sri Lankan woman, identified as Palawini, died during the flight.

According to sources, the incident occurred when Palawini's health, a passenger on the Dubai-Colombo flight, suddenly worsened mid-flight. The flight captain immediately requested Karachi's air traffic control for an emergency landing at its airport to seek urgent medical assistance.

Upon landing, doctors from the Civil Aviation Authority (CAA) boarded



the aircraft to check on the passenger. Despite their efforts, Palawini was pronounced dead. Sources confirmed that she suffered from a cardiac arrest during the flight.

The federal health officer stationed at the airport subsequently issued a death certificate for the woman. After completing

Islamabad Rules Out Talks With TTP Involved In Killing Pakistanis And Foreigners

ISLAMABAD: Pakistan has ruled out any dialogue with the banned terrorist outfit Tehreek-e-Taliban Pakistan with the Foreign Office saying no talks are possible with elements involved in the killings of Pakistanis and foreigners.

"The TTP is involved in the killing of Pakistani and foreign citizens inside Pakistan," FO Spokesperson Mumtaz Zahra Baloch said in a weekly news briefing in Islamabad on Thursday. She said that Pakistan respects Afghanistan's sovereignty and territorial integrity and expects the authorities in the neighbouring country to uphold their sovereignty and take action against terrorist groups that have found sanctuaries on its soil and are using it for launching terror attacks across the border.

Responding to a question, Baloch said Pakistan is committed to implementing the Illegal Foreigners Repatriation Plan [IFRP].

"The IFRP is meant for the implementation of the laws of Pakistan," she said, adding that the plan was



designed to launch an action against the illegal immigrants residing in Pakistan without documentation. She further stated that illegal immigrants from several countries have been sent back to their respective countries under the IFRP. While referring to the repatriation of illegal foreigners including Afghans to their home countries, the FO spokesperson said that the first phase of this plan was near completion.

Clarifying there were multiple categories of Afghan refugees residing in the country, the spokesperson stressed the country had not given any understanding to the

United Nations High Commissioner for Refugees (UNHCR) about the "sustainable" plan.

She pointed out that the government had extended the validity of the Proof of Registration cards of the Afghan refugees for a year.

In a July 9 meeting with top Pakistani officials including Prime Minister Shehbaz, UNHCR Filippo Grandi appreciated the country for "suspending the Illegal Foreigners Repatriation Plan", a statement by Grandi further said.

The statement further said that Grandi had also sought assurance from Pakistani authorities that the repatriation plan would

remain on hold. To a question, Baloch said Pakistan and the United States have a multifaceted and robust partnership.

She said we believe this relationship should move forward on the basis of mutual respect, sovereign equality and non-interference in each other's internal affairs. "Kashmir Martyrs Day to be observed on July 13 in her media briefing, Baloch also reaffirmed Pakistan's commitment to providing political, diplomatic, and moral support to the Kashmiri people for the just and peaceful solution of the Kashmir dispute in accordance with UN Security Council resolutions.

Baloch said the 93rd 'Youm-e-Shuhada-e-Kashmir' (Kashmir Martyrs Day) would be observed on July 13 to honour the martyrdom of 22 Kashmiris who sacrificed their lives in Srinagar in 1931, bravely facing the indiscriminate firing of Dogra forces under the former Maharaja of Jammu and Kashmir. "We salute their courage, which ignited a determined movement for

the rights and freedoms of the Kashmiri people and their right to self-determination. This movement continues to this day," she said. The FO spokeswoman mentioned that like the Dogra forces, Indian occupation forces have killed thousands of Kashmiris in the Indian Illegally Occupied Jammu and Kashmir (IIOJK) in recent decades simply for advocating their rights. "Burhan Muzaffar Wani, an iconic youth leader from Kashmir, was among the hundreds who fell victim to extrajudicial killings in the IIOJK. His eighth martyrdom anniversary was observed on July 8th," she remarked.

Commenting on Israeli aggression in Gaza, Baloch said Pakistan strongly condemned this week's indiscriminate attacks by Israel on four schools in the besieged territory, which resulted in the massacre of dozens of women and children seeking shelter there. These attacks are further evidence of Israel's genocidal campaign against the people of Gaza," she concluded. —RT/Agency

Shehbaz Orders For Removal Of Obstacles In Customs Operations

ISLAMABAD: Prime Minister Shehbaz Sharif on Thursday emphasised taking all-out measures to do away with corruption in customs operations, removing unnecessary hurdles and using artificial intelligence and hi-tech equipment to ensure full enforcement of customs duties.

The prime minister, chairing a meeting to discuss the matters related to the Federal Board of Revenue (FBR) and Pakistan Customs, called the customs sector a backbone of the country's economy and said the FBR reforms and complete digitalisation would guarantee economic security.

He instructed the authorities concerned to ensure the third-party audit of reform initiatives in FBR and other departments and bring all such projects under one umbrella.

Prime Minister Shehbaz directed to increase revenue collection through better enforcement and establish a project management unit for reforms in the customs sector.

He said all the issues related to the mis-invoicing should be resolved and under-invoicing be eliminated to protect Pakistan's in-



terests and products. He also sought details of revenue Rs240 billion in additional revenue through valuation enforcement and also instructed establishing a regulatory framework for the operations of the shipping industry.

The prime minister called for a third-party audit of a web-based one-customs system (WeBOC).

During the briefing on the customs operations, it was told that the operations of the Pakistan Customs had been fully automated and experts of international repute had been engaged to bring in reforms that would feature modern AI-based systems.

It was told that around 72.4 percent of imports and exports were cleared through

the green channel and Pakistan Customs collected Rs240 billion in additional revenue through valuation controls from July 2023-June 2024, which was around 80% above the previous year's collection.

Federal cabinet members Ahmad Khan Cheema, Muhammad Aurangzeb and Ali Pervaiz Malik, Deputy Chairman of Planning Commission Jahanzeb Khan, Attorney General Mansoor Awan, PM's Coordinator Rana Ehsan Afzal, Member of National Assembly Barrister Aqel Malik, FBR Chairman Zaib Tiwana and relevant senior officers attended the meeting. —RT/Agency

Flour Shortage Feared As Millers Strike Against Withholding Tax

ISLAMABAD: Flour mills in several cities of the country have stopped wheat grinding and flour supply across the country from today (Thursday), prompting fears of a flour crisis, as they observe a strike against the newly-imposed withholding tax.

In the budget 2024-25, the government has imposed withholding tax on different stages of the supply chain of staple food by up to 5.5%, the flour mills association leaders have said, making the product more expensive.

Pakistan Flour Mills Association (PFMA) Central Senior Vice Chairman said that the authorities had also asked the mills to collect another 2.5% and 2% withholding tax on the sale of flour from non-filer retailers and wholesalers, respectively.

Meanwhile, PFMA Chairman Asim Raza reiterated that the mills would not bear the responsibility of collecting the withholding tax as it made the flour dearer by Rs200.

The PFMA said at least 1,725 flour mills had ceased their operation across the country, including 1,100 in Punjab, 300 in Khyber Pakhtunkhwa, more than 300 in Sindh and 25 in Balochistan.



Additionally, it also said flour consumption during summer was 40-45,000 tonnes in the country.

After the announcement of strike by the PFMA against the withholding tax, 73 flour mills of Gujranwala district are completely shut down, whereas, all 100 flour mills are closed in the four districts of the Multan Division, including 60 flour mills in Multan.

According to the spokesperson of the PFMA, due to the closure of flour mills in Faisalabad, the supply of 200,000 bags of flour per day has stopped, while all 10 flour mills in Kamalia city and four flour mills in Khasab district are closed.

On the other hand, the strike is being observed in Peshawar and Quetta too, where mills have been locked.

PFMA Chairman (South Zone) Aamir Abdullah said

flour mills in Sindh had stopped grinding wheat and the supply of flour as well.

"Tax collection is the FBR's job, we should not be made tax agents. Until our demands are approved, the supply of wheat products will remain closed," he said.

The flour mills association sources warned that it was feared that the commodity would go scarce if the deadlock between the government and association persisted. As per the association, flour bags of 5kg, 10kg and 20kg will not be prepared from today.

It should be noted that a few days ago flour mills owners had announced a strike, while holding a press conference, and said that they had tried to negotiate with the government. They had conveyed their demands to the government through talks, but negotiations failed. —RT/Agency

Azeri President Ilham Aliyev Receives A Warm Welcome During Pakistan Visit



ISLAMABAD: Prime Minister Shehbaz Sharif on Thursday received Azerbaijani President Ilham Aliyev, who touched down in Islamabad on a two-day official visit on the premier's invitation.

President Aliyev landed at Pakistan Air Force's Nur Khan base where he was greeted with a red carpet welcome as PM Shehbaz along with Interior Minister Mohsin Naqvi received him. The foreign dignitary was also presented with a 21-gun salute.

During his visit, President Aliyev will hold meetings with the PM, President Asif Ali Zardari, and other senior officials.

With the two sides set to engage in wide-ranging discussions on areas of mutual interest to further strengthen bilateral cooperation, several memorandums of understanding (MoUs) are expected to be signed between Islamabad and Baku.

Earlier, The News had reported that President Zardari would host a banquet in the president's honour and that the foreign dignitary would also meet Chief of Army Staff (COAS) General Asim Munir.

The foreign ministers of the two countries will have talks at the Foreign Office, the publication said.

On Monday, it reported that five heads of state, including the Azeri president, were expected to visit Pakistan in the next five months namely Saudi Arabia's Crown Prince Mohammed bin Salman, United Arab Emirates President Sheikh Mohamed bin Zayed Al Nahyan, Qatar's Emir Tamim bin Thani, and Turkey's President Recep Erdogan.

In April this year, Islamabad hosted late Iranian president Ebrahim Raisi on a three-day visit wherein the two sides held productive discussions and agreed to advance bilateral cooperation in multiple domains including trade, connectivity, energy and people-to-people contacts. During his three-day visit to the country, the Iranian president held meetings with President Asif Ali Zardari, Prime Minister Shehbaz Sharif, Army Chief General Munir, Senate Chairman Yusef Raza Gilani, Speaker of National Assembly Sardar Ayaz Sadiq, and the chief ministers and governors of Sindh and Punjab. —RT/Agency

ECP Issues Arrest Warrant For Fawad In Contempt Case

ISLAMABAD: The Election Commission of Pakistan (ECP) has issued a bailable arrest warrant to former federal minister Fawad Chaudhry in the (ECP) contempt case.

A four-member commission, headed by ECP member Nisar Durran, heard the contempt of ECP case against Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan and Fawad Chaudhry.

Imran Khan and Fawad Chaudhry's counsel absent. Imran Khan's counsel Shoaib Shaheen's assistant counsel appeared before the court during the hearing and informed the court about the presence of the Islamabad High Court (IHC).

ECP member Khyber Pakhtunkhwa inquired from assistant counsel that wasn't this case crucial and did he possess legal licence.

ECP deputy director law stated that the last hearing of this case was held in January but the high court prohibited it from issuing final verdict on this case, however, proceedings could be done.

PTI founder's counsel said the ECP could allow virtual appearance of respondents during the hearing.

ECP inquired about the virtual appearance of the respondent through video link. ECP members remarked that respondents appearance was necessary in criminal cases but not in civil cases.

ECP Sindh members inquired about Fawad Chaudhry and his lawyer. Fawad Chaudhry's lawyer's assistant lawyer Faisal Chaudhry informed that Fawad Chaudhry's counsel was also present in the IHC like Shoaib Shaheen.

ECP issued a bailable arrest warrant to Fawad Chaudhry on continuous absence in the hearing.

ECP members stated that Fawad Chaudhry was not in jail, an arrest warrant could be issued against him. Absence of lawyer could be acceptable but where was Fawad Chaudhry, verdict must be issued on Fawad Chaudhry's matter.

Assistant counsel stated that Fawad Chaudhry's case was ongoing in high court

and their cases were challenged in the high court. ECP is independent, not subordinate to anyone.

The ECP member responded that Fawad Chaudhry's appearance in the high court was not necessary; however, the ECP commission was independent and not subordinate to anyone. Consequently, ECP issued the bailable arrest warrant to Fawad Chaudhry adjourning the case hearing until August 7.

It is pertinent to note that cases of ECP and CEC contempt against Imran Khan and Fawad Chaudhry were fixed for hearing on June 20.

Imran Khan and Fawad Chaudhry were indicted in the ECP contempt case on January 3. It is worth noting that ECP issued notice for levelling allegations on CEC and ECP during public gatherings and TV interviews. —RT/Agency

Azm-e-Istehkam: Government Decides To Initiate National Dialogue On New Anti-Terror Operation

ISLAMABAD: Finalising its strategy regarding Operation Azm-e-Istehkam, Prime Minister Shehbaz Sharif-led government has decided to initiate a national dialogue to root out terrorism and extremism in the country, sources told Geo News on Thursday.

PM Shehbaz, the sources added, has taken cabinet members into confidence over the new counter-terrorism operation's scope and the reason behind launching the new anti-terror drive.

Last month, the federal cabinet approved the decisions taken by the National Action Plan's Central Apex Committee including the Launch of Operation Azm-e-Istehkam.

The sources said that the security forces handed over the cleared areas from the terrorists to the provincial governments.

"Due to the failure of the Khyber Pakhtunkhwa government, terrorists returned



to the cleared areas," the added.

The government's decision drew reservations from several political parties including the Pakistan Tehreek-e-Insaf (PTI), Jamiat Ulema-e-Islam (JUI-F), the Awami National Party (ANP), Jamaat-e-Islami (JI) and others.

In response, the Centre has maintained that "no large-scale military operation is being launched" in the country which might result in mass evictions and has reassured that the matter will be brought before

the parliament.

PM Shehbaz has also decided to convene an all-parties conference (APC) to evolve consensus on the operation with PTI founder Imran Khan supporting the initiative, saying his party would attend the government-hosted huddle. Meanwhile, the Pakistan Army has also denounced the undue criticism against the newly launched anti-terrorism operation stating that the "vision" was being misrepresented deliberately for "vested interests". —RT/Agency

Parvez Elahi Granted Exemption From Appearing In Graft Reference

LAHORE: The accountability court in Lahore on Thursday granted former Punjab chief minister Parvez Elahi's request for exemption from physical appearance in a case involving alleged corruption in development projects.

Appearing before the court, a counsel for the PTI leader filed a request for his absence from the hearing, citing his health condition.

Through the application, Elahi informed the court that he was unwell and his physi-



cian had advised bed.

He requested the court to approve his application for exemption from physical appearance.

The court, while granting Elahi's request, adjourned hearing until Aug 16 (Tuesday). —RT/Agency

Centre Agrees To Settle Khyber Pakhtunkhwa's Dues

ISLAMABAD: The federal government has accepted the stance of Khyber Pakhtunkhwa (KP) regarding its dues and has agreed to pay Rs37 billion within a year, ARY News reported, citing sources.

Sources indicate that Khyber Pakhtunkhwa's longstanding demand regarding the Net Hydrol Profit has been accepted, resolving a dispute that had been pending for two years.

The Ministry of Finance sources confirmed that the federal government is now willing to pay Rs3 billion monthly for the Net Hydrol Profit instead of the previous Rs1.5 billion.

For the past two years, there have been disagreements between the federal government and Khyber Pakhtunkhwa on the accurate calculation of the Net Hydrol Profit dues. Sources report that KP's Finance



Advisor, Muzammil Aslam, held extensive negotiations with the federal Secretary Energy and Finance secretary on the matter.

The Council of Common

pur put forward KP demands in Special Investment Facilitation Council (SIFC) meeting and asked the federal government to clear its dues to the province.

Speaking to journalists after SIFC's meeting, the KP chief minister said that his government will not compromise on province rights and will not allow anyone to take "undue advantage". —RT/Agency
