Chief Justice Clarifies PTI Candidates Were Not Granted Independent Status By Election Commission

ISLAMABAD: Chief Justice Qazi Faez Isa clarified that the Election Commission erroneously interpreted the Supreme Court's decision by granting independent status to supported candidates of Pakistan Tehreek-e-Insaf (PTI), which was not within its authority.


During the hearing of a case related to seats allocated for Sunni Ittehad Council candidates, Chief Justice Qazi Faez Isa highlighted that the Election Commission misinterpreted the Supreme Court's decision. He noted that no PTI candidate challenged the Election Commission's decision, emphasizing that the Peshawar High Court's decision regarding the distribution of specific seats and the Election Commission's directive are deemed null because PTI was not included as a party in that decision. It was revealed dur-



ing the proceedings that multiple candidates, while submitting their nomination papers, declared themselves as PTI candidates and submitted party certificates for verification, but they were designated as independent candidates, a decision not authorized by the Election Commission. The hearing underscored that neither PTI nor any of its candidates appealed against the Election Commission's order in this

The President of Pakistan highlighted the importance of Gwadar port, saying that Central Asian Countries and Azerbaijan can benefit from it for promoting regional trade, connectivity and tourism, besides bringing shared economic prosperity to the



region. He also welcomed the signing of Memoranda of Understanding between Pakistan and Azerbaijan, adding that the MoUs would give a new impetus to bilateral cooperation in the fields of trade, commerce, tourism, mines and minerals, science and technology, law and justice, and culture.

He said Pakistan wants to build a sustainable and result-oriented engagement with Central Asian Republics and Azerbaijan.

Speaking on the occasion, President Ilham Aliyev said the two countries needed to promote business-to-business relations for enhancing economic relations. He added that Pakistan and Azerbaijan can also explore the possibility of working together in the renewable energy sector.

Later, the President also hosted a banquet in honour of President Ilham Aliyev and his delegation, which was also attended by Prime Minister Muhammad Shehbaz Sharif, Federal Ministers, parliamentarians, diplomats, and journalists, at the President's House.

PTI Given Unwarranted Relief: Rana Sanaullah




ISLAMABAD: PML-N senior leader and PML-N's advisor on political affairs Rana Sanaullah Khan talking to media said the government would accept the majority verdict of the SC in the Sunni Ittehad Council (SIC) reserved seat case. He said the government's legal team has been reviewing the verdict and would respond accordingly. Rana Sanaullah said the legal team would decide whether a review petition would be filed or not.

Commenting on the verdict Rana Sanaullah claimed, "SIC petitions were rejected but PTI was given that relief which was neither asked in the petition nor contest during the proceeding."

"PML-N-led unity movement did not have a two-thirds majority as parties formed the governments with a simple majority, he said.

Rana Sanaullah said PTI should contest Elections tribunals and the government would implement the decisions.—RT/Agency

PTI Suspends Controversial Sher Afzal Marwat's Membership



ISLAMABAD: The Pakistan Tehreek-e-Insaf (PTI) has reportedly suspended the membership of Sher Afzal Marwat, a firebrand party leader who was elected to the National Assembly in the Feb 8 polls, media reported on Friday citing sources.

Sources said the PTI leaders met incarcerated party founder Imran Khan on Thursday where the decision regarding Marwat was taken.

The party leaders claimed that Sher Afzal Marwat was constantly violating the party discipline and over the past month.

"During the meeting with Imran Khan, it was agreed that no leader is above the party and all other leaders would face the same fate if they crossed the party line," they added.

Reserved Seats Verdict: Ruling Coalition Loses Two-Thirds Majority In National Assembly

ISLAMABAD: Following the Supreme Court's (SC) verdict on reserved seats, Pakistan Tehreek-e-Insaf (PTI) is poised to become the majority party in the National Assembly.

The Supreme Court (SC) of Pakistan overturned the denial of reserved seats to the PTI-backed Sunni Ittehad Council.

Following the verdict of the SC, the ruling coalition has lost two-thirds majority in the lower house of the Parliament (NA), however, they still enjoy the simple majority with 210 seats in the house. The opposition will have 125 seats.

Previously, the Election Commission of Pakistan (ECP) allotted reserved seats to other parties in the assemblies.

The issue came to limelight after over 80 Pakistan Tehreek-e-Insaf (PTI) backed independent candidates emerged victorious in the February 8 elections.

The SIC then approached the ECP on February 21 seeking allocation of reserved seats.

In Khyber Pakhtunkhwa, JUI-F was allotted 10 seats, while PML-N and PPP each



received 7 seats, and ANP got 1 seat. In Punjab, PML-N secured 23 seats, PPP 2, and both PML-Q and Isteqam-e-Pakistan Party received 1 seat each.

In Sindh Assembly, PPP received two reserved seats, and MQM was given a single seat by the ECP.

Reserved seats issue had approached the court after the ECP refused to allocate the seats due to the party's failure to submit its list of candidates before the deadline. The Peshawar High Court (PHC) upheld the ECP's decision, leading the SIC to appeal to the Supreme Court.—RT/Agency

The election commission distributed the seats for women and minorities among other political parties.

The PTI-backed SIC had approached the court after the ECP refused to allocate the seats due to the party's failure to submit its list of candidates before the deadline. The Peshawar High Court (PHC) upheld the ECP's decision, leading the SIC to appeal to the Supreme Court.—RT/Agency

JUI-F Partially Accepts SC's Decision, Expresses Goodwill Towards PTI: Fazl

ISLAMABAD: Jamiat Ulama-e-Islam-Fazl (JUI-F) Chief Maulana Fazlur Rahman reacted to the Supreme Court (SC) of Pakistan's decision declaring the Pakistan Tehreek-e-Insaf (PTI) backed Sunni Ittehad Council (SIC) eligible for reserved seats, media reported.

In a statement issued here, Maulana Fazlur Rahman said that only constitutional and legal experts could give an opinion on the decision.

"The JUI-F partially accepts the SC's decision and expresses goodwill towards the PTI," he added.

Maulana Fazlur Rahman hoped that this would improve relations between the two parties and be beneficial. He said that it would be helpful in creating an environment for negotiations to address reservations between the PTI and JUI-F.

The JUI-F chief said that his party, which would lose reserved seats in the Khyber Pakhtunkhwa Assembly,



is not going to file a review appeal in the apex court.

Earlier in the day, the SC overturned the denial of reserved seats to the PTI-backed Sunni Ittehad Council.

Justice Mansoor Ali Shah announced the 8-5 majority verdict on a petition filed by the Sunni Ittehad Council (SIC), an ally of the PTI.

Justice Athar Minallah, Justice Shahid Waheed, Muneeb Akhtar, Muhammad Ali Mazhar Ayesha Malik, Syed Hassan Azhar Rizvi and Irfan Saadat Khan ruled in favour of the PTI. The top court nullified

the Peshawar High Court's order wherein it had upheld the ECP's decision denying the reserved seats to the SIC.

In its order, the apex court said that the Election Commission of Pakistan ECP's decision of allocating reserved seats to the ruling coalition was unconstitutional.

The bench accepted SIC's petition and ruled that the party is eligible for the allocation of reserved seats. The apex court accepted PTI as political party and asked Imran Khan-led party to submit reserved seats candidates list to ECP within 15 days.—RT/Agency

Earlier, Pakistan Tehreek-e-Insaf issued a show-cause notice to Sher Afzal Marwat for making irresponsible statements. As per details, the notice was issued by PTI Secretary General Omar Ayub Khan and asked Marwat to explain his statements within three days, which have been deemed damaging to the party's reputation.

The notice states that such statements are against the party's discipline and violate the clear instructions of the party's founder, Imran Khan, who has emphasized the importance of responsible behavior.

Marwat was warned that failure to respond or provide a satisfactory explanation may lead to further disciplinary action.—RT/Agency

PTI Praises Judiciary Following Landmark Victory In Reserved Seats Case

ISLAMABAD: The Pakistan Tehreek-e-Insaf (PTI) has hailed the Supreme Court's (SC) verdict on the allocation of reserved seats as a 'historic decision' in the country's history.

"We finally got what we deserved," PTI chairman Barrister Gohar Ali Khan said while speaking outside the apex court along with other PTI lawmakers following the Supreme Court's announcement of its verdict on Friday.

The chairman said that "today is a day of happiness for the 250 million people of Pakistan."

He noted that 11 judges of the top court voted in favour of PTI and also expressed gratitude to the judiciary for deciding in favour of the party.

"The greatest contribution was from KP Chief Minister Ali Amin Gandapur. He delayed the oath in the KP Assembly. There is no question of re-election," Gohar added.

"The Supreme Court has granted the right to its rightful owner today," Sunni Ittehad Council (SIC) leader Sahibzada Hamid Raza.

He criticised the Election Commission, accusing it of attempting to steal the mandate, and highlighted the Supreme Court's lack of con-



fidence in the electro watchdog Raza demanded the immediate resignation of the chief of ECP.

"We aim to uphold democracy in Pakistan," PTI's senator Shibli Faraz stated.

He emphasised that the current government was established based on Form-45 and called for the restoration of the mandate.

Faraz praised the courts for allocating them the reserved seats, paying tribute to their decision to "uphold the flag of justice."

The Supreme Court of Pakistan in its verdict said that Pakistan Tehreek-e-Insaf was entitled to reserved seats and that the Election Commission of Pakistan (ECP)'s decision to allocate reserved seats to the ruling coalition

was unconstitutional. During the announcement, PTI leaders chanted slogans on the SC premises. Before the announcement today, Chairman Barrister Gohar expressed optimism about the allocation of their reserved seats while speaking to the media in Islamabad.

Barrister Gohar stated that the wait for the public is nearing its end and they are hopeful for a favorable decision from the Supreme Court.

"This is an issue of the basic rights of 250 million people," Barrister Gohar remarked, emphasizing the significance of the matter. He expressed confidence that PTI would receive their due seats, which he believes will strengthen democracy in the country.—RT/Agency

DC Thatta Munawar Abbas Soomro reviews arrangements for monsoon season

THATTA: A crucial meeting was held at Darbar Hall Makli, chaired by Deputy Commissioner Munawar Abbas Soomro, to review the arrangements for dealing with the monsoon rains. The meeting was attended by officials from various departments including Revenue, Health, Education, Livestock, Local Government, Social Welfare, Police, Irrigation, Public Health, Education Works, MURF, PPHI, Rescue 1122 and representatives from NGOs. During the meeting, Deputy Commissioner Munawar Abbas Soomro directed all relevant department officials to ensure that all necessary arrangements are in place to deal with the monsoon rains, so that people do not face any difficulties in case of an emergency. He emphasized that all departments, particularly the Irrigation, Local Government, Livestock, and Health departments, should remain alert during such situations.



He instructed the Irrigation Department officials to ensure the repair and monitoring of all vulnerable embankments of the Indus River and the presence of necessary machinery. He also directed the officials from Local Government and other relevant departments to ensure timely drainage of rainwater, cleaning of disposals and drain channels, and to keep dewatering pumps and other machinery operational. The Deputy Commissioner stressed the importance of coordination among all departments to effectively handle any potential emergencies. He instructed the Health Department officials to ensure the availability of necessary medicines, doctors, and paramedical staff at the district headquarters hospital, BHUs, and RHCs. Prior to this, officials from all relevant departments provided a detailed briefing on the pre-emptive arrangements in view of the monsoon rains.


6-year-old Kunri girl killed in a hit and run

PM directs preparing action plan for PASSCO's privatization

ANP wins PK-22 Bajaur by-election



Awami National Party's (ANP) candidate Nisar Khan emerged victorious in the PK-22 by-election in Khyber Pakhtunkhwa's (KP) Bajaur district after securing 11,926 votes, according to unofficial and unconfirmed results released on late Thursday night.

As per the unofficial results, independent candidate Najeibullah Khan came in second with 10,622 votes, followed by Jamaat-e-Islami's (JI) Abid Khan, who bagged 10,593 votes in by-election.

In Pakistan Tehreek-e-Insaf-led KP, Sumi Ittehad Council's (SIC) Rahatullah Khan was at fourth place with 7,146 votes.

It is pertinent to mention here that the polling began at 8am and continued till 5pm without any break. The KP assembly seat fell vacant after the incumbent, Mubarak Zeb Khan, was elected to the National Assembly.

Flour prices hiked as mill owners' strike enters second day

MULTAN: The flour prices have jacked up as the flour mill owners' strike against the imposition of a 2.5 percent withholding tax in the budget 2024-25 has entered into its second day, media reported.

As per details, the prices of 15-kilogram flour bags have increased by Rs 100 to Rs 180, reaching Rs 1,330 to Rs 1,500. Similarly, the prices of 10-kilogram flour bags went up by Rs 50 to Rs 150, reaching Rs 900 to Rs 1,000.

On the other hand negotiations between flour mill owners and the Federal Board of Revenue (FBR) have failed, with the FBR chairman refusing to withdraw the withholding tax.

The chairman of the Flour Mill Association Shafeeq Anjum said that the strike will continue until demands are met.

He said that there are fears of a widespread flour crisis in the next two days, with wholesale dealers hav-



ing only a two to three-day stock of flour. Earlier, the flour mill owners announced a strike on July 11 against the imposition of a 2.5 percent withholding tax in the budget 2024-25.

The flour mill owners said that due to increasing electricity bills, they are already facing difficulties in running their business.

"The additional 2.5 percent withholding tax will further ruin our business," they added.

While demanding the government withdraw its decision to impose the tax, the flour mill owners announced to go on strike on July 11.

The association's chairman, Aamir Abdullah, warned that if the government does not withdraw the newly imposed tax, a strike may be called, which could include the closure of flour mills across the country.

"The government needs to reconsider and withdraw the tax on wheat products, withholding tax implementation will inevitably drive up prices, affecting consumers and retailers alike," Abdullah stated. —RT/Agency

NEPRA approves massive tariff hike for domestic consumers

ISLAMABAD: The National Electric Power Regulatory Authority (Nepra) on Thursday approved the government's request to increase the tariff for domestic electricity consumers in the country by up to Rs7.12 per unit — meeting yet another condition set by the International Monetary Fund (IMF) for its bailout programme.

However, according to a notification issued by the power regulator, domestic consumers using up to 200 units will be exempt from this hike for three months — from July to September.

The base tariff for other domestic consumers has been inflated by up to Rs48.84 per unit.

The consumers using 201 to 300 units per month will be charged Rs34.26 per unit with an increase of Rs7.12.

Similarly, those consuming between 301 and 400 units will be charged Rs39.15 per unit after being jacked up by Rs7.02.

Likewise, the consumers using 401 to 500 units will face a hike of Rs6.12 per unit



after reaching Rs41.36.

For those consuming from 501 to 600 units, they will be slapped with an increase of Rs42.78 per unit with a hike of Rs6.12.

Those falling in the category of those using from 601 to 700 units will face an increase of Rs6.12 — paying Rs43.92 per unit.

The consumers whose usage exceeds 700 units will be charged at the rate of Rs48.84 per unit following a hike of Rs6.12.

The per unit cost of electricity will be jacked up in accordance with the tax slabs.

The tax slab will remain unchanged for lifeline consumers using up to 50 units per month at the price of

Rs3.95.

Similarly, it will continue to stay at Rs7.74 for other lifeline consumers using 51 to 100 units per month.

Nepra has sent its decision to the federal government for notifying the hike after the latter requested uniform tariff for all power distribution companies (Disco) and K-Electric.

In the same decision, the power regulator also approved the tariff increase for commercial, agricultural, general services and bulk consumers.

The base tariff for commercial consumers was hiked by Rs8.04, after which they would be charged by up to Rs77.15 per unit from July. —RT/Agency

Tourist van accident injures 10 at Islamabad's Daman-e-Koh



ISLAMABAD: In a tragic incident, at least 10 people sustained injuries as a tourist van crashed in Daman-e-Koh area of Islamabad, media reported.

As per details, the incident occurred in Daman-e-Koh where the van carrying tourists from Gujrat overturned due to brake failure, however, miraculously the van didn't plunge into the ravine.

The injured have been shifted to the nearby hospital where they have been given the necessary treatment.

In a separate incident, at least four people were killed while six others sustained injuries after a tourists' van suffered an accident in Skardu's Bishu valley.

Yesterday, the FIA offloaded eight women passengers from a Saudi Arabia-bound flight at Multan Airport.

"The women were allegedly going to Saudi Arabia for begging," a spokesperson of the Federal Investigation Agency's (FIA) immigration wing said.

"The women were identified as Sobia, Khadija, Aasia, Saira, Sajda, Salma, Sameena and Naghma," FIA spokesperson said.

"The women passengers are natives of Bahawalnagar. The officials recovered 200 Saudi Riyal from each woman," FIA stated.

The women were transferred to the FIA's anti-human trafficking circle Multan for further legal action.

The FIA last year in December offloaded five alleged beggars traveling to Saudi Arabia, disguised as Umrah pilgrims from Multan. —RT/Agency

Flight operations resume at Peshawar airport after fire incident

After a brief interruption due to a fire incident, operations at Bacha Khan International Airport in Peshawar have returned to normalcy.

Officials confirmed that all flights, including Pakistan International Airlines (PIA), resumed their schedules as usual.

The runway closure on Thursday, prompted by a fire incident in a flight of the Saudia airlines, temporarily disrupted air operations.

However, authorities swiftly responded to the situation, ensuring that safety protocols were adhered to throughout the incident.

Flights destined for Dubai, Sharjah, and Karachi are set to proceed according to their planned schedules today, reassured airport officials.

The Air Accident Investigation Board team promptly conducted inspections and the aircraft involved in the incident was removed from the taxiway for assessment. Under the leadership of the airport manager, efforts were



underway to ensure the smooth operations of the runway.

Flights resumed gradually starting from 7:50pm on Thursday, marking a swift recovery in airport operations.

A private airline flight ER-852 originating from Jeddah successfully landed at Bacha Khan airport.

On Thursday morning, a fire broke out in an aeroplane belonging to a foreign airline at the Peshawar airport. According to aviation sources, the fire broke out in the landing gear of Saudia airlines flight SV-792 from Riyadh during landing at the Peshawar airport. The air traffic

controller informed the authorities about the fire. The incident triggered emergency protocols as 276 passengers and a 21-member crew were swiftly evacuated using emergency slides. The incident caused temporary disruptions at Peshawar airport. The airport was declared shut for 24 hours due to the presence of the plane on the airport taxiway. According to a Notice to Airmen (Notam), the duration of the runway closure was supposed to be from 10:35am on Thursday to the same time Friday. All flights to the Peshawar airport were to be diverted to alternative airports. —RT/Agency



FIA busts visa fraud scheme in Rawalpindi

The gang provided fake visas to Greece in exchange for large sums of money. After collecting substantial sums from their victims, the suspects went into hiding.

The arrests are part of FIA's ongoing efforts to crack down on human trafficking and visa fraud on the directive by Federal Interior Minister Mohsin Naqvi.

The FIA urges citizens to verify the authenticity of job offers and visas through official channels to avoid falling prey to such scams.

Earlier on July 6, the FIA Anti-Human Trafficking Cell in Rawalpindi conducted a raid on the office of an overseas employment promoter, arresting a suspect allegedly involved in visa fraud.—RT/Agency





Lahore falls victim to urban flooding again despite government's tall promises

LAHORE: Lahore, the capital city of Punjab, witnessed severe flooding in several areas following torrential rains, transforming streets into virtual rivers.

More than 177 feeders operated by Lahore Electric Supply Company (LESCO) tripped due to the heavy rainfall, causing widespread power outages across the city.

The monsoon deluge inundated various parts of the city, with Tajpura recording the highest rainfall at 242 millimeters.

At least 130 millimeters of rain is recorded at Lakshmi Chowk, 132 millimeters in Mughalpur, and 133 millimeters in Gulshan-e-Ravi.

In addition to these areas, Chaak Nakhuda received 122 millimeters, Iqbal Town 128 millimeters, Qaraba Chowk 125 millimeters, Samanabad 135 millimeters, and Airport



71 millimeters of rainfall. Significant disruptions in power supply were reported from 120 feeders in Lahore, with 15 feeders in the Kasur circle also affected.

The Sheikhupura circle experienced interruptions in power supply from 26 feeders, while the Okara circle reported disruptions from 6 feeders.

Local authorities have initiated emergency drainage operations in response to the heavy rainfall, deploying machinery and personnel to manage water accumulation in affected areas.

Punjab Chief Minister Maryam Nawaz Sharif has directed comprehensive measures to mitigate the impact of flooding and ensure swift recovery from the aftermath of the rainfall across all districts of Punjab, focusing particularly on Lahore.—RT/Agency

MQM's Mustafa Kamal Criticizes Supreme Court Decision As Blow To Democracy

Karachi: Mustafa Kamal, Senior Deputy Convener of the Muttahida Qaumi Movement (MQM), has voiced strong opposition to the Supreme Court's decision granting specific seats to Pakistan Tehreek-e-Insaf (PTI), stating that today's verdict has inflicted damage to democracy.



Addressing a press conference in Karachi alongside MQM leaders, Kamal expressed disappointment over the long-awaited decision by the Supreme Court, describing it as a spectacle that began in 2018. He emphasized that decisions like these, influenced by strong so-

cial media presence, dictate the course of democracy and asserted that today's verdict has undermined it. Kamal referred to the ruling as a "popular decision," highlighting his party's abstention from

elections as the Sunni Ittehad Council's head had not sought this decision. He criticized the previous Chief Justices for building dams, arresting Hanef Abbasi for drugs, and restraining Rana Sanaullah.—RT/Agency

Flight with Israeli nationals makes emergency landing in Karachi

A Flydubai flight en route to Sri Lanka, carrying two Israeli citizens, made an emergency landing in Karachi, Pakistan, overnight. However, the Civil Aviation Authority has denied having any knowledge of the presence of the Israeli citizens on Pakistani soil.



The incident occurred despite the lack of diplomatic relations between Israel and Pakistan.

The Israeli Foreign Ministry confirmed the incident, stating that they worked with relevant parties to ensure the well-being of the Israeli passengers, according to Times of Israel.

The flight resumed its journey to Sri Lanka shortly after the emergency landing, with the Israelis remaining on board.

Pakistan does not recognize Israel and passports issued to its citizens are not valid for the latter based on diplomatic support for Palestine.

The Pakistan Civil Aviation Authority (PCAA) spokesperson Saifullah Khan said on Thursday that they were unaware of any reported presence of Israeli nationals on a Flydubai flight that made an emergency landing in Karachi, Pakistan earlier this week.

The Flydubai flight FZ-569, which was traveling from Dubai to Colombo, Sri Lanka, had to make an emergency landing at Karachi's Jinnah International Airport at 11 PM on Wednesday after the condition of a passenger on board deteriorated.

"The report about the Flydubai flight 569 just had that it was en route to Colombo from Dubai and the condition of some woman [board] worsened and it landed at 11pm [on Wednesday] in Karachi. But she expired. Her body was sent to [Pakistani charity] Khidmat-e-Khalq Foundation in Malir and the plane left at 3am [on Thursday]. It was not mentioned [in the report] how many passengers were aboard and what their nationalities were," Khan told Arab News.

Khan clarified that the passenger who died on the Flydubai flight was a Sri Lankan national. Her body was later flown to Sri Lanka on a separate flight. Pakistan does not have diplomatic relations with Israel and has repeatedly called for an independent Palestinian state based on pre-1967 borders. The country has also demanded the world stop Israel's military actions in Gaza. Pakistan's foreign office spokesperson, Mumtaz Zahra Baloch, stated that the Flydubai flight was diverted to Karachi due to a medical emergency. The Sri Lankan woman on board was examined by a medical team and declared dead, after which her body was removed from the plane. No other passengers disembarked.—RT/Agency

Muharram threat alert issued for Karachi



KARACHI: A threat alert has been issued for the anti-enforcement police in Karachi, warning of possible terrorist attacks during Muharram Haram, media reported on Friday.

According to guidelines issued by DSP Tariq Islam, the anti-enforcement police personnel have been warned against going alone on official duty during Muharram Haram in the wake of recent attacks.

The notification stated that government officials could be targeted in Karachi during Muharram. The officials were directed to use police vans for official assignments and avoid wearing uniforms and shoes while returning home after finishing duties.

The federal government on Monday approved the de-

ployment of armed forces across the country to ensure security during the month of Muharram. The move comes on the request of the authorities in Sindh, Balochistan, Khyber-Pakhtunkhwa, Islamabad, Gilgit-Baltistan and Azad Jammu and Kashmir to deploy military to control the law and order situation.

The Centre, under Article 245 of the Constitution, authorised the "deployment of army troops/assets and civil armed forces troops/assets" to ensure peace.

The Ministry of Interior has clarified that the deployment of the army will be based on the ground situation and that the provinces will have the authority to determine the deployment locations.—RT/Agency

Sharjeel Criticizes Supreme Court's Decision, Accuses Judiciary Of Favoring Imran Khan

KARACHI: Senior Minister of Sindh, Sharjeel Inam Memon, has stated that the Pakistan People's Party (PPP) respects court decisions, even when they are unfavorable to the party. Speaking at a press conference in Karachi, Memon described the recent Supreme Court decision as ambiguous and criticized the federal government's discretion over appealing it. He claimed the decision exhibited

partiality towards Khan, including during the 2018 elections and subsequent controversies. He alleged that the judiciary's actions have consistently favored Khan and disadvantaged the PPP.

Regarding the recent Supreme Court decision, Memon emphasized that the PPP does not advocate for banning any political party but called for decisions to adhere strictly to the constitution and law. He condemned the practice of favoritism and stressed the importance of merit-based decisions. Memon also criticized

Imran Khan for hiring lobbyists in the US after accusing the country of interfering in Pakistan's affairs. He expressed concern over international reactions to Khan's arrest, particularly from Israel.

In response to a question, Memon stated that legal experts would review the detailed decision and formulate a plan for the future. He reaffirmed the PPP's commitment to engaging in dialogue with democratic parties and emphasized the need for adherence to constitutional principles.

CTD Karachi apprehends two TTP linked terrorists

KARACHI: The Counter Terrorism Department (CTD) anti terrorism financing unit on Friday arrested two terrorist in Karachi for funding TTP, media reported.

As per details, the CTD carried out an operation in Karachi's Jhanjhan Goth area, resulting in the arrest of two terrorists affiliated with the banned Tehreek-e-Taliban Pakistan (TTP) Hafiz Gul Bahadur group. According to DIG CTD, Asif Ijaz, the accused were in contact with TTP leaders in Afghanistan through social media and were collecting funds for the banned outfit.

Both the arrested terrorists belong to Waziristan and have been identified as Abu and Yaqub Mehsum. They had recently returned to Karachi to carry out a funding operation and were seized with a significant amount of funds.



Earlier, police killed three terrorists in an Intelligence Based Operation (IBO) in Hasan Khel Peshawar. The police officials stated that an intelligence-based operation was carried out in the Hasan Khel area of Peshawar on the information regarding the presence of terrorists. During the operation, two police personnel of CTD embraced martyrdom and one sustained injuries, police officials added. In a separate incident, security forces gunned down

a terrorist commander Irfan Ullah aka Adnan in an intelligence-based operation (IBO) in Bajaur District, Inter-Services Public Relations (ISPR). "On 3 July 2024, security forces conducted an intelligence-based operation in Bajaur District, on the reported presence of a high profile terrorist," the statement added. It added that during the conduct of the operation, the terrorist commander was killed after intense fire exchange.—RT/Agency

Woman's body found dismembered in Sohrab Goth



KARACHI: Police on Friday found body of a woman in pieces from Karachi's Sohrab Goth graveyard, Media reported.

The women was murdered brutally and then cut into pieces before being dumped and hidden, police said. The body pieces stuffed in a gunny bag were recovered from the Sohrab Goth area of the city. Meanwhile, Police have launched further investigation into the matter.

Earlier in November 2023, the body of a woman was found inside a water drum in an empty plot in the Phase VII area of Karachi's Defence Housing Authority. The body of the unidentified woman — wrapped in a plastic bag — was recovered from the water drum on an empty plot near Fatima Masjid. Preliminary investigations suggested that the woman had been murdered.—RT/Agency

Aurangzeb's \$15 Billion Energy Debt Talks With China Rescheduled

ISLAMABAD: Finance Minister Muhammad Aurangzeb's visit to China for talks to restructure the \$15 billion energy debt has been rescheduled to the third week of this month due to other engagements of the Chinese authorities.

In place of the finance minister, Planning Minister Ahsan Iqbal has taken the letters on behalf of Prime Minister Shehbaz Sharif to Beijing. The prime minister has requested the Chinese leadership to constitute a working group to resolve the issues related to \$15 billion Chinese energy debt payments and clearance of \$1.8 billion outstanding dues of the Chinese power plants.

"The Chinese leadership is busy with the third plenum till July 18th, so the visit is now being scheduled for the week after," said Finance Minister Muhammad Aurangzeb after the meeting of the National Assembly Standing Committee on Finance.

Earlier, Prime Minister Shehbaz Sharif had asked the minister to take a letter from him to the Chinese leadership with a request to reschedule the energy debt. The idea was that the finance minister would fly along with the planning minister as the premier's special envoy.



"On behalf of the Prime Minister, I am delivering the letters to the Chinese leadership during my ongoing visit," said Iqbal while talking to The Express Tribune. But he said that the finance minister would also visit once the Chinese leadership is free from the plenum meetings.

Iqbal had left for Beijing on Wednesday to participate in the Global Development Initiative (GDI) meetings. Aurangzeb could not accompany the planning minister as the Pakistani mission in Beijing could not secure the meetings with the Chinese leadership.

The Pakistani embassy in Beijing had advised that the finance minister should wait until the Chinese leadership gets free from its other scheduled business.

Last Saturday, the prime

Against the remaining Chinese energy debt of over \$15 billion, payments by 2040 would total \$16.6 billion, according to government sources.

The Pakistani proposal involves extending debt repayments from 10 to 15 years. This would reduce the outflow of foreign currency by about \$550 million to \$750 million per annum and decrease prices by Rs3 per unit.

According to the existing IPP deals, the current power tariff structure requires debt servicing repayments during the first 10 years, leading to a significant burden on consumers who are paying the interest and principal of these loans through higher tariffs. But due to the extended repayment period, the country will also have to make an extra \$1.3 billion payment to China, sources said.

It is not clear what Pakistan is going to offer to China in return for securing debt restructuring. China's two biggest concerns are security of its national and clearance of \$1.8 billion dues that Pakistan has not paid against the power that it purchased from around one-dozen Chinese power plants.

If China agrees to debt restructuring, the repayment period will be extended to 2040, including interest pay-

ments. According to Pakistani authorities, repayment would be \$600 million less this year and can be reduced to just \$1.63 billion after restructuring. For 2025, debt repayments would decrease from \$2.1 billion to \$1.55 billion—a benefit of \$580 million, sources said. However, the upfront relief would result in more repayments from 2036 to 2040.

In April, the prime minister had ordered all imported coal-fired power plants, including three Chinese plants, to convert to local coal to save \$800 million annually and reduce consumer rates by Re3 per unit. At least five major imported coal-fired power plants with a total capacity of 5,940 megawatts are affected, including three Chinese-owned plants in Sahiwal, Port Qasim, and Hub, totaling 3,960 MW.

During Prime Minister Shehbaz Sharif's last month meeting with the President Xi Jinping, the Chinese leadership had indicated reviewing the possibility of using either the blend of local or imported coal or converting to the local coal. Through these letters, Pakistan has invited China to find a win-win solution to the problems of Chinese energy debt repayments and the coal conversions.—RT/Agency

Pakistan And Azerbaijan Sign 15 MoUs To Strengthen Bilateral Ties

ISLAMABAD: Pakistan and Azerbaijan signed 15 Memoranda of Understanding (MoUs) and agreements on Thursday to enhance bilateral cooperation across various sectors including trade, commerce, tourism, minerals, science and technology, law, justice, and cultural exchange programs.

Prime Minister Muhammad Shehbaz Sharif and Azerbaijan President Ilham Aliyev witnessed the signing ceremony at the PM House. Deputy Prime Minister and Foreign Minister Ishaq Dar, along with Azerbaijan's Deputy Minister of Foreign Affairs Samir Sharifov, signed an MoU between the Ministries of Foreign Affairs of both countries on Consular Affairs.

Commerce Minister Jam Kamal Khan and Azerbaijan's Deputy Minister of Economy Sahib Mammadov signed a Preferential Trade Agreement between the governments of Azerbaijan and Pakistan.

Similarly, Minister for Privatization Abdul Aleem Khan and Azerbaijan's Deputy Minister of Economy Sahib Mammadov signed an MoU on cooperation between the Ministries of Economy of both countries in privatization of state property.

An agreement on Transit Trade between the governments of Azerbaijan and Pakistan was also signed.

The two sides agreed on a Memorandum of Coopera-



tion (MoC) between Azerbaijan's Ministry of Justice and Pakistan's Ministry of Law and Justice, signed by Minister for Law Azam Nazeer Tarar and Azerbaijan's Minister for Defence Industry Yugar Mustafayev.

An MoU between the governments of Pakistan and Azerbaijan on cooperation in mineral resources and geology was signed by Petroleum Minister Dr. Musadik Malik and Azerbaijan's Minister of Energy.

Minister for Heritage and Culture Attaullah Tarar and Azerbaijan's Minister of Foreign Affairs Samir Sharifov signed the Cultural Exchange Program between Pakistan and Azerbaijan for the years 2024-2029.

An MoU on cooperation in information and communication technologies between Azerbaijan's Ministry of Digital Development and Transport and Pakistan's Ministry of Information Technology and Telecommunication was signed.

Secretary of Information Shahera Shahid and Azerbaijan's Ambassador Khazar Farhadov signed an MoU be-

tween Azerbaijan Television and Radio Broadcasting (CJSC) and Pakistan Television Corporation (PTVC). An MoU on establishing twinning links between Baku and Islamabad was signed, along with another MoU between Azerbaijan's Small and Medium Business Development Agency and SMEDA Pakistan.

An agreement for scientific and technological cooperation between the governments of Pakistan and Azerbaijan was also signed.

Secretary IPC Nadeem Irshad Kayani and Azerbaijan's Minister of Defence Industry signed an agreement on cooperation in tourism.

Chairman of Pakistan Academy of Letters Prof. Dr. Najeeba Arif and Azerbaijan's Ambassador Khazar Farhadov signed an MoU on cooperation in literature between Azerbaijan's Institute of Literature named after Nizami Ganjavi and Pakistan Academy of Letters (PAL).

Additionally, an Air Services Agreement was signed between the governments of Pakistan and Azerbaijan.—RT/Agency

"No Danger" To Government, Says Law Minister After SC Verdict

ISLAMABAD: Law Minister Azam Nazeer Tarar said that the Supreme Court's verdict on the Pakistan Tehreek-e-Insaf's (PTI) reserved seats case does not pose any threat to the government.

"We still have a majority of 209 members and the verdict has not been completed yet," said the minister after the top court ruled that the PTI was eligible for the allocation of reserved seats.

Tarar said that he was unsure whether the government will file review petition challenging the verdict or not.

The development comes after the SC announced 8-5 majority verdict, nullifying the Peshawar High Court's (PHC) order wherein it had upheld the Election Commission of Pakistan's (ECP) decision denying the reserved seats to the SC.

The verdict was supported by Justices Athar Minallah, Shahid Waheed, Muneeb Akhtar, Muhammad Ali Mazhar, Ayesha Malik, Syed Hassan Azhar Rizvi, and Irfan Saadat Khan.

The PTI candidates did not contest the polls on a single election symbol, forcing them to join hands with the SC, but that could not get them the reserved seats as the ECP ruled against



them. In its decision today, the court declared that the lack or denial of an election symbol does not in any manner affect the Constitutional or legal rights of a political party to participate in an election, whether general or by, and to field candidates and that the commission is under a Constitutional duty to apply all statutory provisions accordingly.

"PTI was and is a political party, which secured general seats in the national and provincial assemblies in the general elections of 2024," read the verdict. The court ordered the Imran Khan founded party to present a list of names of the candidates eligible for the reserved seats within 15 days of this decision. "Reserved seats in Punjab, Khyber Pakhtunkhwa and Sindh should be given to PTI," it said.

"There are constitutional and legal flaws in this verdict that will remain under discussion," said the law minister.—RT/Agency

Released TTP Members Involved In Terror Activities



ISLAMABAD: The Senate standing committee on interior was informed on Thursday that Azm-e-Istekam initiative was part of the National Action Plan (NAP) against terrorism and it was not the kind of operation being generally perceived.

During a committee meeting, chaired by its Chairman Saleem Rehman, Interior Minister Mohsin Naqvi said that the government released the people belonging to the Tehreek-e-Taliban Pakistan (TTP) from jails under an agreement but those people were involved in acts of terrorism in the country. The meeting was also attended by the interior secretary and officials of the subordinate institutions including the Frontier Corps (FC) Balochistan and the Pakistan Coast Guards (PCG). In the meeting, several committee members raised their concerns over a deteriorating law and order situation.

Senator Umar Farooq said that his father was kidnapped from Quetta, while he himself faces threats. On the other hand, the police worked as if they had out-sourced the police stations. He charged that the interior secretary of police remained seated in his office while the policemen on the roads collected money. Senator Nasima Ehsan said that her house had been attacked and her children could not go out. She added that her family could not travel in their own area, while the security officials told them not to travel after 3pm. She also said that whenever she called the IG, he was nowhere to be found.

Senator Saifullah Abro pointed out that there were a few problems in Sindh: in 2023 Dr Ajmal Sawand was killed and a policeman was the accused, but he had not been arrested so far; a journalist was killed and his killer had not been arrested; killers of three journalists had not been arrested in three years.—RT/Agency

PTI Demands Resignations Of CEC And Other Top ECP Officials

ISLAMABAD: The Pakistan Tehreek-e-Insaf (PTI) demanded the resignations of the Election Commission of Pakistan's (ECP) top officials including Chief Election Commissioner (CEC) Sultan Akram Raja after the Supreme Court (SC) of Pakistan's decision in the reserved seats case, media reported.

Addressing a presser in Islamabad after the apex court's verdict that declared PTI-backed Sunni Ittehad Council eligible for reserved seats, PTI General Secretary the immediate resignation of the Chief Election Commissioner (CEC) and all four provincial election commissioners.

Omar Ayub accused the ECP of "deliberately" taking away PTI's electoral symbol to disrupt the election process.

The PTI general secretary termed the ECP's actions tantamount to treason, saying that Article 6 of the Pakistani constitution should be imposed on the CEC.



He said that the PTI is committed to upholding the constitution and ensuring justice. Omar Ayub also praised his legal team, calling their efforts a victory for "truth and justice". Earlier in the day, the SC overturned the denial of reserved seats to the PTI-backed Sunni Ittehad Council.

Justice Mansoor Ali Shah announced the 8-5 majority verdict on a petition filed by the Sunni Ittehad Council (SIC), an ally of the PTI. The apex court accepted PTI as political party and asked Imran Khan-led party to submit reserved seats candidates list to ECP within 15 days.—RT/Agency

Government Highlights Cross-Border Terrorism Efforts

ISLAMABAD: Pakistan has reported ongoing efforts to combat cross-border terrorism, particularly from Afghanistan. Security forces conducted 7,500 operations in Khyber Pakhtunkhwa and Balochistan between April and June 2024, resulting in the elimination of 181 terrorists reportedly affiliated with TTP and ISKP.

The government highlighted several recent terrorist incidents, including an attack on a marble factory in Mohmand Agency in May 2024, the killing of two miners in Duki, Balochistan on June 2, and the murder of a news reporter in Landikotal on June 19.

Pakistani officials said that evidence suggests most terrorist activities originate from Afghanistan, with the



TTP having strong safe havens there. The United States has also confirmed the presence of TTP and ISKP in Afghanistan, actively planning attacks against Pakistan.

In response to these challenges, the Pakistani government has exempted terrorist-affected districts from taxes for one year.

The government also addressed claims of propaganda against Pakistan from Afghan media sources, stating that investigative reports have disproven these allegations.—RT/Agency

No Decision Yet In Iddat Nikah Case Against Imran And Bushra Bibi

ISLAMABAD: Additional District and Sessions Judge Muhammad Afzal Majoka presided over the hearing of central appeals against the sentences handed to Pakistan Tehreek-e-Insaf (PTI) Founder Imran Khan and his wife Bushra Bibi in the iddat nikah case.

Despite extensive arguments, the court was unable to reach a decision even today, adjourning the hearing until Saturday morning.

During the proceedings, Judge Majoka remarked that both Imran Khan and Bushra Bibi are followers of Hanafi jurisprudence, which stipulates that the right of recourse ends after the pronouncement of triple divorce. He emphasized that jurisprudence theories cannot be challenged in court.

Khawar Maneka's lawyer argued that the judgements referenced by the PTI founder's lawyers during the trial were based on different grounds and



were not applicable to the current case. PTI lawyer Salman Safdar presented a decision before the court marked on a witness's testimony, who claimed he had learned about the marriage a day later. He reiterated that under Hanafi jurisprudence, the right of recourse ends after divorce, and such doctrines cannot be contested in court. Consequently, the judge noted that an iddat case might not hold up under these principles.

The court adjourned the hearing until Saturday morning, leaving the fate of the appeals undecided for now.—RT/Agency

New Party Positions In Punjab Assembly Revealed Following Reserved Seats Distribution

LAHORE: In the latest development in the Punjab Assembly, the allocation of 27 reserved and minority seats has significantly impacted the party positions.

Despite the Sunni Ittehad Council gaining these seats, the government alliance, led by PML-N, continues to hold a substantial majority.

The total number of seats for the Pakistan Muslim League-Nawaz (PML-N) in the Punjab Assembly has now reached 205. This includes 164 general seats, 5 seats reserved for minorities, and 36 seats for women.

The Sunni Ittehad Council, which previously had 104 members, now has a total of 131 seats after the addition of the reserved seats. This increase, however, still leaves them behind the PML-N in terms of overall strength.

The Pakistan Peoples' Party (PPP) has a total of



14 seats in the Punjab Assembly. This includes 10 general seats, 1 seat from an independent member who joined them, and 3 seats reserved for women. The Pakistan Muslim League-Quaid (PML-Q) holds 10 seats, which includes 8 general seats and 2 seats reserved for women.

The Istekham-e-Pakistan Party (IPP) has a total of 6 seats, including 5 general seats and 1 seat reserved for women. The Tehreek-e-Labbai (TLP), the Pak-

istan Muslim League-Zia (PML-Z), and the Majlis Wahdat-e-Muslimeen (MWM) each have one seat in the Punjab Assembly, with the Punjab Assembly, with a total of 371 seats, now has 369 members after the inclusion of the reserved seats. One constituency, PP-269, has yet to hold an election. Additionally, Mian Aslam Iqbal, the successful candidate from the Sunni Ittehad Council in Constituency 171 of Lahore, has not yet taken his oath.—RT/Agency
