ISLAMABAD: Prime Minister Shehbaz Sharif on Saturday directed Federal Bureau of Revenue (FBR) authorities to tighten their belts and serve the nation by formulating a strategy to broaden the tax net base without further burdening the honest tax payers.



The prime minister made it clear that he would not tolerate any lapses, adding that when determination was made with sincerity, paths leading to future were usually carved out.

During a visit to FBR Headquarters, the prime minister said that the incumbent government had the sole agenda of putting Pakistan on path of progress with consistent improvement in the economic indicators.

"If we want to get rid of debts, the FBR should levy taxes on those who had not been paying any taxes, he opined.

"I will quit if I need to, but I will not come under any pressure, I want that to be loud and clear."

"Though it may be a difficult journey which requires collective and individual efforts, sincerity and sacrifices and putting forth the national interests supreme over all other interests," he emphasized.

Earlier, the prime minister arrived at the FBR Headquarters where he was welcomed by Minister for Finance and Revenue Muhammad Aurangzeb, Minister of State for Finance and Revenue Ali Pervaiz Malik and Chairman FBR Malik Amjad Zubair Tiwana.

Termining the staff level arrangement with International Monetary Fund (IMF) as a positive omen for the country's economy, he expressed the hope that IMF board would also give a go ahead in this regard.

The prime minister also directed the FBR chairman to bring forth all the hidden issues related to the department on table without wasting time.

The prime minister laid down floral wreaths on memorial of shuhada and offered Fatha, PM Office Media Wing said in a press release.—RT/Agency

Nawaz Convenes High-Level PML-N Meeting Following Supreme Court Verdict

LAHORE: Pakistan Muslim League-Nawaz (PML-N) President Nawaz Sharif summoned an important meeting to devise further course of action after the Supreme Court (SC) of Pakistan's verdict in the reserved seats case, media reported citing sources.



Justice Athar Minallah, Justice Shahid Waheed, Muneeb Akhtar, Muhammad Ali Mazhar Ayesha Malik, Syed Hassan Azhar Rizvi and Irfan Saadat Khan ruled in favour of the PTI.

The meeting will be attended by Prime Minister Shehbaz Sharif, Chief Minister (CM) Punjab Maryam Nawaz, and other bigwigs of the PML-N, the sources privy to the development said.

The federal cabinet members will also attend the meeting which is specifically called for discussing crucial matters aftermath of the apex court's verdict, declaring the Pakistan Tehreek-e-Insaf (PTI) backed Sunni Ittehad Council (SIC) eligible for reserved seats.

The top court nullified the Peshawar High Court's order wherein it had upheld the ECP's decision denying the reserved seats to the SIC.

The sources added that the Nawaz Sharif-headed meeting will also engage in consultations on other key issues.

"If the government does not file a review petition, the suspended members of the assembly may file review appeals," he added.

In its order, the apex court said that the Election Commission of Pakistan ECP's decision of allocating reserved seats to the ruling coalition was unconstitutional.

Prime Minister's Advisor on Political and Public Affairs Rana Sanaullah said on Friday that the decision in the reserved seats case cannot be termed a 'conspiracy' against the government.

Rana Sanaullah said that the government has great regard for the apex court and the judges.

The bench accepted SIC's petition and ruled that the party is eligible for the allocation of reserved seats. The apex court accepted PTI as political party and asked Imran Khan-led party to submit reserved seats candidates list to ECP within 15 days.—RT/Agency

PML-N To Challenge Supreme Court Ruling On PTI Reserved Seats

RAWALPINDI: The Pakistan Muslim League-Nawaz (PML-N) has announced it will challenge the Supreme Court's ruling on PTI's reserved seats. During a press conference in Rawalpindi, PML-N leader Hanif Abbasi criticised the decision, stating that the Pakistan Tehreek-e-Insaf (PTI) was not even a party in the case but was granted undue relief.



According to Express News, her lawyers arrived at the jail with court orders, and the jail authorities completed the legal formalities for her release. However, before she could leave, a heavy contingent of Islamabad police, in coordination with Gujranwala police, was waiting outside and took her into custody.

Abbasi questioned the constant reinterpretation of the Constitution, which he claimed favoured PTI.

Abbasi criticised what he described as judicial facilitation reminiscent of former chief justice Saqib Nisar's tenure.

He accused the court of violating constitutional and legal principles and mentioned planned protests and legal battles against the ruling.—RT/Agency

Abbasi favoured that independent members have been given 15 days to join a party, a period he argued is excessive.

He pointed out that the Election Commission of Pakistan (ECP) only withdrew the party's electoral symbol due to a failure to conduct

intra-party elections, and not because it dissolved the party. Abbasi also condemned the Supreme Court's recognition of 39 PTI candidates for reserved seats, calling it an illegal move. He announced that PML-N, along with other political parties, would file a review petition against the decision.

IMF Reaches \$7 Billion Staff-Level Loan Agreement With Islamabad

ISLAMABAD: The International Monetary Fund (IMF) has announced that it has reached a staff-level agreement with Pakistan for an extended fund facility (EFF) of around \$7 billion.



The IMF issued a statement in the wee hours of Saturday according to Pakistan terms, praising the country for adhering to the terms set out in the Stand-by Arrangement (SBA) that Shehbaz Sharif led PDM government signed with the Fund in 2023.

Under the 2023 Stand-by Arrangement (SBA), IMF staff and the Pakistani authorities have reached a staff-level agreement on a 37-month Extended Fund Facility Arrangement (EFF) of about US\$7 billion. This agreement is subject to approval by the IMF's Executive Board" the statement from the Fund read.

Faced with chronic mismanagement, Pakistan's economy has found itself on the brink, challenged by the Covid-19 pandemic, the effects of the war in Ukraine and supply difficulties that fuelled inflation, as well as record flooding that affected a third of the country in 2022.

Reserves dwindling, Pakistan found itself in a debt crisis and was forced to turn to the IMF, obtaining its first emergency loan in the summer of 2023.

In a nation of over 240 million people and where most jobs are in the informal sector, only 5.2 million filed income tax returns in 2022. During the 2024-25 fiscal year which starts July 1, the government aims to raise nearly \$46 billion in taxes, a 40 per cent increase from the previous year.

As part of the push, Pakistan's tax authority earlier this month blocked 210,000 SIM cards of users who have not filed tax returns in a bid to widen the revenue bracket.

The latest bailout, coming to Pakistan in the form of loans, follows a commitment by the government to implement reforms, including a major effort to broaden the country's tax base.

According to the statement, Pakistan will be receiving the money in the next three years if it lives up to the promises the current government has made with the Fund. These include measures to tax everyone in the county and privatise the state's own organisations.

Additionally, Pakistan will be required to secure more loans from its friends, namely China, Saudi Arabia, and the UAE.

"Continued strong financial support from Pakistan's development and bilateral partners will be critical for the program to achieve its objectives," it said.—RT/Agency

Immediate Release of Imran and Bushra Bibi Unlikely After Arrests In Other Cases



ISLAMABAD: The National Accountability Bureau (NAB) is expected to issue arrest warrant for Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan's wife Bushra Bibi in a new Toshakhana case, Geo News reported citing sources.

In another development, the sources revealed that Lahore police did not make any progress to nab the former prime minister after his interim bail was dismissed by the anti-terrorism court (ATC) two days ago. It emerged that Khan's arrest was not declared in May 9, 2023, riots cases as per the Adiala Jail records. A police team is expected to reach Adiala Jail tomorrow to arrest the PTI founder, the sources added.—RT/Agency

IMF Program To Aid In Achieving Macroeconomic Stability: Finance Minister

ISLAMABAD: Finance Minister Muhammad Aurangzeb on Saturday said that the newly inked bailout deal with the International Monetary Fund (IMF) will help achieve macroeconomic stability.



The finance minister made the remarks after the cash-strapped country reached a 37-month, \$7 billion aid package deal, with the Washington-based institution, giving much-needed respite to the struggling economy.

Aurangzeb said that under the programme "we need to ensure structural reforms and bring self-sustainability in areas of public finance, energy, and state-owned institutions" which he hoped to achieve in the next few years.

Islamabad also aims to reduce its fiscal deficit by 1.5% to 5.9% in the coming year, heading another key IMF demand.

The new loan program, which needs to be validated by the Fund's Executive Board, should enable Pakistan to "cement macroeconomic stability and create conditions for stronger, more inclusive and resilient growth," the IMF said while announcing the deal.

The last loan — a nine-month \$3 billion IMF deal — proved a lifeline.

Faced with chronic mismanagement, Pakistan's economy has found itself on the brink, challenged by the COVID-19 pandemic, the effects of the war in Ukraine and supply difficulties that fuelled inflation, as well as record flooding that affected a third of the country in 2022.

Water shortage intensifies in Umerkot

UMERKOT: In Umerkot, the scarcity of drinking water has intensified due to the crisis in water supply during the month of Muharram-ul-Haram. Municipal administration officials have been absent, prompting civilian protests. Various areas of the city such as Chang Muhalla, Shaikh Muhalla, Chana Muhalla, Ayesha Market, Shivani Muhalla, Makra Chowk, Kunbar Muhalla, Chandiram Muhalla and Harchandani Muhalla are facing severe water shortages, causing distress among residents. The lack of water has led to the emergence of various diseases, forcing residents to use contaminated water sources, exacerbating health concerns. The municipal committee has remained silent and inactive, drawing criticism from political and social circles in Umerkot. Leaders like Abdul Ghaffar Nagori, Ali Muhammad, Ramesh Kumar, and others have blamed administrative negligence for the ongoing water crisis, which has persisted for 12 days without any relief in sight. Tail-end growers of Noor Wah Canal protest against acute water shortage

JACOBABAD: The growers living along the tail-end areas of the Noor Wah Canal, Jacobabad, protested against the shortage of irrigation water. Under the leadership of Syed Qurban Shah, Hashim Brohi, Farhan Bhangar, Syed Imtiaz Shah, Gulsher Khoso and Hakim Manjho, they staged a protest march against the water scarcity and shouted slogans against the officials of the Irrigation Department. Demonstrators gathered at the location of 11-Miles, stating that there is no shortage of water in the Indus River and Began Canal, but engineers and the district police officer of Jacobabad have illegally cut off water to the growers of Noor Wah Canal. They mentioned that due to the lack of water, thousands of acres of agricultural land are turning barren, and seeds for rice crops on hundreds of acres are drying up, causing significant financial losses to the residents. They further noted that despite several complaints to the Irrigation Department officials about water scarcity, no action has been taken. Last year, water was provided on the basis of bribes, and now they are demanding that Chief Minister Sindh and other high officials provide full-flow water to the tail-end growers of Noor Wah Canal to prevent economic disaster. They also announced plans to continue their protest to bypass if their demand is not accepted.

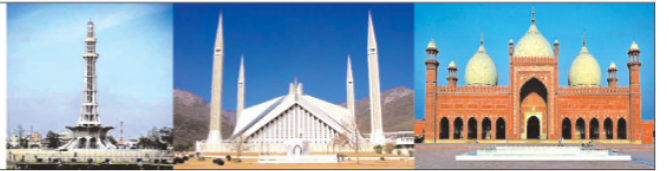
Meghwar community protests against Khanpur Mahar Police

Article 151, 106 rewritten in reserved seats case verdict: Khawaja Asif

ISLAMABAD: Defence Minister Khawaja Asif on Saturday said that the Supreme Court's decision in reserved seats case was not constitutional.

Talking to media Khawaja Asif, a PML-N veteran, said that political ramifications can be clearly seen in the verdict.

Federal minister claimed that in decision the court has rewritten the constitution's Article 151 and 106. "Re-writing the constitution has not been the judiciary's function, this can be done by the parliament," he pointed out.

Khawaja Asif said that the Sunni Ittehad Council (SIC) went to the court in the case, the PTI was not anywhere in it. "When the complainant didn't knock the door for justice, you are providing relief to it," minister said.

He said, when the members have submitted affidavit of the Sunni Ittehad Council, the Supreme Court announced its split verdict with 8-5 division on Friday over a petition with request to allocation of special seats filed by the Sunni Ittehad Council (SIC).

Cellular and internet services to be suspended in Quetta on Muharram 7 and 10

QUETTA: In a bid to scale up security measures, the Balochistan government has announced to suspend mobile phone and internet services in Quetta on Muharram 7 and 10, while imposing Section 144 in seven districts.

"The cellular and internet services will remain suspended from 6am to 12am midnight," said Balochistan Home Minister Meer Ziaullah Langau on Friday.

Muharram started on July 8 in the country, after the lunar month's crescent was sighted. Faithful hold processions and majalis across the country in Muharram, while religious scholars address huge gatherings amid tight security, with thousands of law enforcers deployed to ensure security.

During his visit to review security arrangements in various areas of the metropolis, Langau said 8,000 security personnel would be deployed in Quetta on the day of Ashura, 10th Muharram.

Meanwhile, five Quick Response Force platoons of Pakistan Army would remain



on standby. Whereas, the home minister said that the cellphone services would be suspended in Jhal Magsi, Jafarabad and Usta Muhammad districts on Muharram 9 and 10.

The provincial government has also banned pillion riding and imposed Section 144 from Muharram 1 till 10 in seven districts.

It was the government's responsibility to maintain law and order situation in the city, stated Langau, apprising media that security arrangements regarding Muharram had been completed.

On the other hand, the federal government on July 8 approved the deployment of the Pakistan Army and Civil

Armed Forces (CAF) across the country as a security measure during Muharram. According to a notification issued by the interior ministry, the government has sought the deployment of the military to maintain law and order.

The notification states that the details of troop deployment, which will be enforced for an indefinite period, will be finalised with the authorities concerned.

Additionally, the notification stated: "The date of de-requisitioning of said deployment will be decided subsequently after mutual consultation among all stakeholders."—RT/Agency

FBR to enforce retailers tax scheme in 42 cities

ISLAMABAD: The Federal Board of Revenue (FBR) has decided to expand the fixed tax scheme for retailers to 42 cities with a minimum tax amount ranging from Rs100 to 10,000 per month, depending on the valuation rates of shops.

Under the International Monetary Fund (IMF) programme, the FBR has envisaged an annual collection of Rs50 billion from the scheme during the current fiscal year.

Prime Minister Shehbaz Sharif is scheduled to visit the FBR headquarters on Saturday (today) to get a detailed briefing on digitisation and the way forward for placing end-to-end connectivity for broadening the tax base.

Official sources said the FBR shared a detailed working of fair valuation rates of all 42 cities with the retailers' representatives. A minimum



tax of Rs1,200 to Rs120,000 was proposed for retailers depending on the valuation of shops across the country.

"A detailed working has been done by the FBR and shared with retailers. Now the FBR chairman has taken the firm stand that all retailers will have to contribute to national kitty," said the sources.

The FBR has not yet been notified to expand the tax the Tajir Dost Scheme net.—RT/Agency

Petrol and diesel prices set to rise again in upcoming review

ISLAMABAD: Continuing with the rising trend, the major petroleum products — petrol and high-speed diesel (HSD) — are estimated to increase by more than Rs7.60 and Rs3.50 per litre, respectively, with effect from July 16 for the next fortnight, mainly because of higher global oil prices.

Sources said the prices of petrol and HSD had increased in the international market by about \$4 and \$2 per barrel, respectively, in the last fortnight. Depending on

final calculation and existing tax rates, the price of petrol is projected to rise by Rs7.60 per litre and that of HSD by Rs3.50.

The government has jacked up the maximum limit of petroleum development levy (PDL) to Rs70 per litre in the Finance Bill to collect Rs1.28 trillion in the current fiscal year against Rs960bn collection during the previous year, at least Rs91bn higher than the Rs869bn budget target.—RT/Agency

Villa close to signing Everton's Onana for £50m



Aston Villa are in advanced talks to sign midfielder Amadou Onana for Everton for a fee in the region of £50m.

The 22-year-old featured for Belgium at Euro 2024 and would have the opportunity to play Champions League football next season.

Onana joined from Lille for £33m in August 2022 and has gone on to make 72 appearances for the Toffees, scoring four goals.

Arsenal held an initial conversation with Onana's representatives earlier this year but did not follow up on their interest.

It is understood Villa's fee meets Everton's valuation of the midfielder, who also had interest from Manchester United.

Senegal-born Onana has also played for Hamburg, having progressed through

the ranks at Hoffenheim after starting in Anderlecht's academy.

Villa have been in the market for a new midfielder after selling Douglas Luiz to Juventus for £42.35m last month.

They are also expected to complete the return of Jaden Philogene in the coming days after the Hull winger flew back from the Tigers' training camp in Turkey on Friday.

The England Under-21 winger is due to sign a five-year contract in a move worth about £18m, returning to Villa Park less than 12 months after being sold to the Tigers.

Villa included a matching option in his move last September and snatched him from Ipswich, who had agreed an £18m deal with Hull. —Agency

Australia win thriller to clinch series against Wales



Wales suffered a ninth successive international defeat as Australia wrapped up the series 2-0 with victory in an eight-try thriller in Melbourne.

Two tries from Filipo Daugunu, further scores from Jake Gordon and Allan Alaalatoa and 13 points from Noah Lolesio's boot helped Australia achieve a successful start to Joe Schmidt's era following the 25-16 win in Sydney last weekend.

Wales responded with two tries from inspirational captain Dewi Lake, while returns Liam Williams and Rio Dyer also crossed.

Warren Gatland's side rallied from a sluggish start as they slipped to a 17-0 deficit inside 25 minutes, but left themselves with too much work to do.

Lake has been the Wales' success story of this tour with his tries coming from rolling mauls, which have proved the tourists' most potent attacking threat.

Gatland under scrutiny

Gatland will find himself under pressure because of the wretched recent record with Wales having not won a Test match since the 2023 World Cup pool win against Georgia nine months ago.

They are now just one loss away from equalling the nation's worst losing sequence of 10 under Steve Hansen between 2002 and 2003.

This ninth defeat marks the longest number of matches without a Test win during Gatland's association with Wales that began in 2008, ended 11 years later and resumed ahead of the 2023 Six Nations.

Gatland has only won six out of 21 matches since his return and Wales have finished bottom of the Six Nations for the first time in 21 years and slipped to 11th in the world rankings, their lowest ever position.

Their losing record against the Wallabies in Australia has also extended to 13 consecutive defeats with no victory since 1969.

While there is a tour match to follow against Queensland Reds in Brisbane next Friday, Wales do not play another international until Fiji arrive at Cardiff's Principality Stadium in November. —Agency

Wales suffered a ninth successive international defeat as Australia wrapped up the series 2-0 with victory in an eight-try thriller in Melbourne.

Two tries from Filipo Daugunu, further scores from Jake Gordon and Allan Alaalatoa and 13 points from Noah Lolesio's boot helped Australia achieve a successful start to Joe Schmidt's era following the 25-16 win in Sydney last weekend.

Wales responded with two tries from inspirational captain Dewi Lake, while returns Liam Williams and Rio Dyer also crossed.

Warren Gatland's side rallied from a sluggish start as they slipped to a 17-0 deficit inside 25 minutes, but left themselves with too much work to do.

Lake has been the Wales' success story of this tour with his tries coming from rolling mauls, which have proved the tourists' most potent attacking threat.

Gatland under scrutiny

Gatland will find himself under pressure because of the wretched recent record with Wales having not won a Test match since the 2023 World Cup pool win against Georgia nine months ago.

They are now just one loss away from equalling the nation's worst losing sequence of 10 under Steve Hansen between 2002 and 2003.

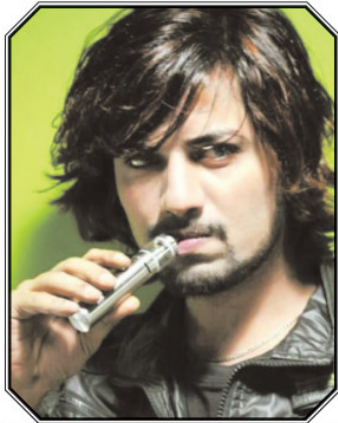
This ninth defeat marks the longest number of matches without a Test win during Gatland's association with Wales that began in 2008, ended 11 years later and resumed ahead of the 2023 Six Nations.

Gatland has only won six out of 21 matches since his return and Wales have finished bottom of the Six Nations for the first time in 21 years and slipped to 11th in the world rankings, their lowest ever position.

Their losing record against the Wallabies in Australia has also extended to 13 consecutive defeats with no victory since 1969.

While there is a tour match to follow against Queensland Reds in Brisbane next Friday, Wales do not play another international until Fiji arrive at Cardiff's Principality Stadium in November. —Agency

BIRMINGHAM: Ambati Rayudu's half-century after Anureet Singh's three-for led India Champions to beat Pakistan by five wickets and win the World Championship of Legends here at Edgbaston on Saturday.



Set to chase 157, India Champions knocked the winning runs on the first delivery of the final over when Irfan Pathan hit Sohail Tanvir for a four.

Younis Khan's decision to bat first after winning the coin toss did not bear fruits for the Pakistan Champions as they put a par total on the board.

Pakistan Champions had a shaky start to their innings as their in-form hard-hitting opener Sharjeel Khan (12) fell victim to Anureet Singh in the second over with just 14 runs on the board.

Sohaib Maqsood then joined Kamran Akmal in the middle for a briefly anchoring partnership as the duo could raise 29 runs for the second wicket.

Maqsood, who tried to counterattack the India Champions bowlers fell prey to Vinay Kumar in the fifth over after scoring a quick 21 off 12.

Pakistan Champions then lost two more wickets in quick succession — Kamran Akmal (24) and Younis Khan (7) — and consequently slipped to 79/4 in 11.3 overs.

Shoaib Malik, the leading run-scorer of the World Championship of Legends, took the reigns of Pakistan Champions batting expedition against India Champions and kept the scoreboard ticking with an anchoring knock.

Malik put together brief partnerships with Misbah-ul-Haq (18) and Aamer Yamin (7) before walking back to the dugout on the last delivery of the 18th over.

He remained the top-scorer for Pakistan Champions with a gutsy 41 off 36 deliveries, laced up with three sixes. —RT/Agency

Wood added to England squad for second Test



England have added fast bowler Mark Wood to their squad for the second Test against West Indies at Trent Bridge.

Wood, 34, missed the huge win in the first Test after being part of the England squad for the T20 World Cup in June.

The Durham man takes the place of James Anderson, England's all-time leading wicket-taker who ended his international career at Lord's.

If England opt to retain Chris Woakes and Gus Atkinson in their XI, Wood will be vying with Matthew Potts and the uncapped Dillon Pennington for the remaining pace-bowling slot.

Should Nottinghamshire's Pennington, 25, make his debut, it would be on his home ground.

The second Test in the three-match series begins on Thursday, with the third Test at Edgbaston starting on 26 July.

Barrett sparks fightback as All Blacks beat England



Replacement Beauden Barrett inspired a New Zealand fightback in their 24-17 win over England to claim the series 2-0 at Eden Park.

The All Blacks trailed by four points before two-time world player of the year Barrett was introduced off the bench to set up Mark Tele'a's second try and break English resistance.

England had threatened to become the first side to win at Eden Park in 30 years after excellent tries by Immanuel Feyi-Waboso and Tommy Freeman handed them a slender advantage at half-time.

In a frenetic game littered by handling errors on the grassy Auckland surface, the All Blacks struggled to wrestle back momentum and Marcus Smith stretched England's lead with a penalty before Barrett's arrival from the bench.

The full-back cut a composed figure as he first kicked Scott Robertson's New Zealand ship as he first

England arrived at the spiritual home of All Black rugby sensing an opportunity to spring a famous upset after their narrow defeat in last week's first Test in Dunedin.

Many of England's young squad were not born the last time New Zealand were beaten at Eden Park, by France in 1994, but they were undaunted.

Tele'a handed the All Blacks the lead as he reacted quickest to pick up the ball from a ruck and scamper clear but England hit back through his opposite number Feyi-Waboso.

The wing latched on to a pinpoint Marcus Smith crossing-field kick before beating Tele'a and Damian McKenzie to score his fourth try in six England appearances.

Smith was disappointing from the tee in Dunedin but his accurate kicking from hand is a real weapon for England and New Zealand failed to heed the early warning as Freeman was the beneficiary of another smart cross-field kick to hand the visitors the lead.

They held a one-point advantage at the break but the All Blacks were boosted by the introduction of Beauden Barrett — the oldest of the three Barrett brothers in the matchday squad.

The utility back prowled the back field and nullified England's kicking game as the hosts began to control the battle for territory. —Agency

They said his application has been dismissed to protect him from injuries, since he plays in all three formats of the cricket for the national side and he faced some fitness challenges last year.

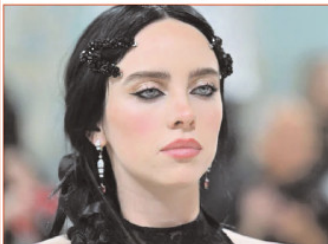
Naseem underwent a successful surgery to treat his shoulder injury in October 2023. Following which, he had been ruled out of the ICC World Cup 2023.

Government bans wheat imports and flour exports

ISLAMABAD: The federal government of Pakistan on Friday imposed a ban on import of wheat and export of flour following excessive import of wheat than country's requirement, stated a notification issued by Ministry of Commerce.



The government has made amendments to the Import and Export Policy Orders 2022, imposing a ban on the import of wheat and export of flour.

Moreover, a ban has also been imposed on export of flour prepared from imported wheat, the notification added. Earlier in March, the federal government had conditionally allowed the export of flour made from imported wheat under the Export Facilitation Scheme 2021.

On July 10, Prime Minister Shehbaz Sharif told the National Assembly that the government had made no de-

cision for the export of wheat even as the State-Owned Enterprises (Governance and Operations) Bill, 2024 was rushed through the legislature. "No decision has been made for the export of wheat. I want to bring it on record before the House that there is no such decision for the wheat export," he told the National Assembly responding to a point of order raised by a parliamentarian. However, referring to the PTI government's sugar and wheat scams, he recalled that it was also on record that in the past wheat and sugar were first exported and later imported and where the billions and trillions of rupees went was part of the history. The amendment, which allows the government to remove board members of SOEs based on recommendations from the board nomination committee, had been passed by the Senate the previous week and will become law upon President Asif Ali Zardari's assent.

Traffic plan announced for Karachi's Muharram processions

KARACHI: Karachi Traffic Police has issued a comprehensive traffic diversion plan in light of Muharram processions that will be taking place in the country's financial hub from 8 to 10th Muharram, The News reported on Saturday.

The metropolis, each year, witnesses thousands of mourners participating in several Muharram processions wherein the government and law enforcement agencies chalk out a detailed security plan including cordoning off several streets as part of relevant security measures.

For the Ashura — the 10th day of Muharram falling on July 17 — the Sindh government has banned 143 ulema and zakireen hailing from 13 districts for 60 days as part of security measures during the month of Muharram.

The primary procession will start from Nishtar Park and will culminate at Imam-bargah Hussainian Iranian at



Kharadar.

In light of the procession, MA Jinnah Road will be closed off to traffic from Guru Mandir to Tower and only vehicles possessing the necessary permits will be allowed access to it — vehicles with relevant stickers will be allowed to enter the procession through the Highway Leaders Society Light Signal.

No vehicles will be allowed to go beyond Guru Mandir and will be diverted towards Bahadur Yar Jung Road Soldier Bazar from there.

CJP Isa 'not interested' in extension: Law Minister Azam Tarar

KARACHI: Law Minister Azam Nazeer Tarar said Saturday that Chief Justice of Pakistan (CJP) Qazi Faez Isa had told him that he was "not interested" in extension of his tenure as the top judge.

Tarar gave the clarification about CJP Isa's extension in tenure while speaking during Geo News programme "Aaj Shahzeb Khanzada Kay Sath".

The law minister said that the chief justice, after the meeting of the judicial commission, had told him in the presence of the attorney general that he was not interested in extending his tenure.

He said that CJP Isa had told him that rumors had been circulating about his extension.

"I told him (CJP) no such thing is happening at all," he said, adding that the top judge then appreciated him for clarifying the matter.

The law minister noted that he informed the chief justice that work on pension reforms was however under way, which included a sug-

Karachi to sizzle again from July 15

KARACHI: After receiving some respite from the scorching heat due to light rain earlier this week, Karachiites are once again expected to witness another heat spell next week with temperature expected to increase by up to 3°C from July 15 (Monday).

The metropolis, as per weather expert Jawad Memon, is likely to experience an increase in temperature as there's a possibility of a decrease in the speed of the sea breeze due to the formation of a low-pressure area.

The weather update comes after the city received heavy rain on Tuesday in several areas of the city followed by light showers. However, despite the rain, the residents have not yet experienced significant relief from the heat.

Memon said that a rain system might affect the country's southern parts including Karachi between July 16 and 18.

Earlier, the Pakistan Meteorological Department (PMD) forecast heavy rains in the metropolis after July 20.

NDMA warning



Several parts of the country are currently witnessing monsoon rains with Lahore receiving 315 millimetres of downpour a day earlier which broke a 30-year-old record.

A day earlier, the National Disaster Management Authority's (NDMA) National Emergencies Operation Centre said that it anticipates an increase in flows in the River Ravi nullahs (Deg, Basanter and Bein) and River Chenab catchments in the next 48 hours.

Consequently, people living in low-lying areas may be affected, said the NDMA body.

accounts misusing the name and identity of the Sindh Police. About 47 accounts have been identified on Facebook, 12 on Instagram, and 6 on Twitter. In total, more than 70 accounts are using the Sindh Police's name and identity incorrectly. —RT/Agency

Wahab announces plans to redirect heavy traffic to Lyari Expressway

Karachi Mayor Barrister Murtaza Wahab announced plans to divert heavy traffic to the Lyari Expressway to alleviate the pressure on Karachi's main roads.

During a meeting with senior officials from the National Highway Authority, Karachi Port Trust, and Karachi Metropolitan Corporation (KMC) on Friday, Wahab emphasised the need for efficient use of existing infrastructure to manage the city's increasing traffic.

Wahab noted that Karachi's roads are unable to withstand the continuous pressure from heavy traffic. He stated that, pending a positive third-party report, heavy traffic would be redirected to the Lyari Expressway, which is expected to improve overall traffic flow in the city.

The meeting, held at the KMC headquarters, reviewed various aspects of using the Lyari Expressway more ef-



fectively. Wahab highlighted the urgent need to organise traffic on Karachi's major roads due to increasing congestion.

He pointed out that the Lyari Expressway's opening to heavy traffic would reduce the burden on other key roads and enhance traffic movement. The mayor also noted that heavy traffic passing through various parts of the city severely affects areas from Mauripur to Landhi.

Shehbaz Promises New IMF Program Will Be Pakistan's Last

ISLAMABAD: Prime Minister Shehbaz Sharif on Saturday said that Pakistan needed to embark on a "long and difficult journey" to prevent knocking on the doors of the International Monetary Fund (IMF) again.

"If we want to get rid of loans, we need to consider this IMF programme as the final one," he said.

In the wee hours of Saturday, the international lender announced that Pakistan and the Fund had reached a three-year \$7 billion aid package deal, giving much-needed respite to the nation.

The programme, which needs to be approved by the IMF's Executive Board, should enable Pakistan to "cement macroeconomic stability and create conditions for stronger, more inclusive and resilient growth," it said in a statement.

Coming to Pakistan in the form of loans, the latest bailout follows a commitment by the government to implement reforms, including a major effort to broad-on the country's tax base.

Addressing a meeting at the headquarters of the Federal Board of Revenue (FBR) today, the premier congratulated Finance Minister Muhammad Aurangzeb and other cabinet members for clinching the programme.

"This cabinet has done a great deal of work to make sure we achieved this goal," he said. "But, we need to pursue a long and difficult journey to augment our macro-

economic numbers. We will spend whatever amount of money to acquire the gadgets required for this purpose. It is our national interest and our duty," he affirmed.

The prime minister further emphasised that now was the time for a "paradigm shift".

"We need to tighten our belts and serve the public," he said. "For the first and last time, we need to act in the national interest. If there's any honest mistake, we'll rectify that. I will quit if I need to, but I will not come under any pressure. I want that to be loud and clear."

Earlier, Geo News quoted the finance minister as saying that the new IMF deal would aid Pakistan in achieving macroeconomic stability.

Under the programme "we need to ensure structural reforms and bring self-sustainability in areas of public finance, energy, and state-owned institutions", he said.

Faced with chronic mismanagement, Pakistan's economy has found itself on

the brink, challenged by the Covid-19 pandemic, the effects of the war in Ukraine and supply difficulties that fuelled inflation, as well as record flooding that affected a third of the country in 2022.

With its foreign currency reserves dwindling, Pakistan found itself in a debt crisis and was forced to turn to the IMF, obtaining its first emergency loan in the summer of 2023.

The IMF statement issued earlier today quoted the Fund's mission chief to Khan, Nathan Proter, as saying that the new programme "aims to capitalise on the hard-won macroeconomic stability achieved over the past year by furthering efforts to strengthen public finances, reduce inflation, rebuild external buffers and remove economic distortions to spur private sector-led growth."

"In this regard, the authorities plan to increase tax revenues through measures of 1.5 per cent of GDP in FY25 and 3 per cent of GDP over the programme," the lender said. The increase in revenue collections will be achieved through "simpler and fairer direct and indirect taxation, including by bringing net income from the retail, export, and agriculture sectors properly into the tax system".

The statement added that federal and provincial governments have agreed to rebalance spending activities in line with the 18th Constitution Amendment by signing a "National Fiscal Pact". Under the agreement, sub-

Imran Urges Establishment To Hold 'Transparent' Elections

RAWALPINDI: Pakistan Tehreek-e-Insaf (PTI) founding chairman Imran Khan has reportedly called on the establishment to conduct fresh elections, expressing doubts over the utility of forming a government under current circumstances.

Imran Khan's comments followed Friday's Supreme Court (SC) verdict favouring the PTI in the reserved seats, according to an Express news report.

Speaking informally with journalists during a hearing at Adiala Jail regarding the ₹190 million reference, the PTI supremo emphasised the need for transparent elections.

Welcoming the SC's recent decision to allocate reserved seats to PTI, Imran described it as a positive step that restored public hope. "I thank Allah that the Supreme Court judges stood up for the rule of law, where the powerful are also held accountable," he said.

Referring to the reserved seats verdict, Imran expressed his hope that there was any point in coming into power now, he maintained, "The establishment must conduct clean and transparent elections. If we get reserved seats, we will not engage in any political manoeuvring. The only way to save the country is through fair elections."

Earlier today, in what ap-



pears to be a major breakthrough, an Islamabad district and sessions acquitted Imran and his spouse Bushra Bibi against their conviction in the Iddat case, clearing the last legal hurdle keeping the PTI founder in jail.

Imran criticised past judicial decisions, highlighting Justice Munir's capitulation to power, and the denial of party symbols.

Imran also addressed the current economic situation, predicting that next year's budget would be harsher than the present one, with increased tax burdens on the public.

The PTI founder also commented on the possibility of negotiation with the current government setup, he stated his readiness, given three conditions: the dismissal of cases against him, the release of his people, and the restoration of his mandate.

Imran also questioned the ethical propriety of Chief Justice of Pakistan (CJP) Qazi Faez Isa hearing his cases, citing personal biases.

"Justice Gulzar's five-member bench had ruled that Qazi Faez Isa should not hear my cases. The Chief Justice's wife has made statements against me," he asserted.

Imran revealed plans for a hunger strike to draw international attention to his situation, accusing ISI of orchestrating staff transfers in jail to intimidate him.

He humbly mentioned that even a cat that had become attached to him had been relocated. Commenting on internal party issues, Imran downplayed them as private matters.

He demanded a medical examination for a party worker, Abid, whose son had died in solitary confinement and who allegedly attempted self-immolation.—RT/Agency

Islamabad and Washington To Hold Joint 'Law Enforcement Dialogue' In October

ISLAMABAD: As the country continues its efforts to rein in the scourge of terrorism, Pakistan and the United States have agreed on holding a "Law Enforcement Dialogue" in October this year.

The development came during a meeting between Interior Minister Mohsin Naqvi and US Ambassador to Pakistan Donald Blome wherein both sides discussed matters of mutual interests and strengthening of bilateral relations.

Earlier this week, sources told Geo News that Prime Minister Shehbaz Sharif-led government has decided to initiate a national dialogue to root out terrorism and extremism in the country.

The move came after the federal government, last month, announced its decision to launch a new anti-terror drive titled "Operation Azm-e-Istehkam" — which drew reservations from several political parties including the Pakistan Tehreek-e-Insaf (PTI), Jamiat Ulema-e-Islam (JUI-F), the Awami National Party (ANP), Jamaat-e-Islami (JI).

The Centre has maintained that "no large-scale military operation is being

launched" in the country which might result in mass evictions and has reassured that the matter will be brought before the parliament. PM Shehbaz has also decided to convene an all-parties conference (APC) to evolve consensus on the operation with PTI founder Imran Khan supporting the initiative, saying his party would attend the government-hosted huddle. Meanwhile, the Pakistan Army has also denounced the undue criticism against the newly launched anti-terrorist operation stating that the "vision" was being misrepresented deliberately for "vested interests".

In today's meeting with the US envoy, Naqvi underscored the significance of US support in strengthening Pakistan's law enforcement agencies. The meeting also focused on issues such as enhancing cooperation in combating terrorism, narcotics trafficking and bolstering security. The security czar also highlighted the recent discussions in New York to foster collaboration between the Islamabad Police and the New York Police Department.

It was decided that a delegation from Islamabad Police will soon visit New York to explore further opportunities for cooperation including training programmes. Reaffirming Islamabad's commitment to protecting all minorities, the minister emphasised their equal rights under the Constitution and said that all those accused in Jararwala tragedy have been arrested and brought before the court.—RT/Agency

SC Ruling Could Result In PTI's Fragmentation: Faisal Vawda

ISLAMABAD: Senator Faisal Vawda has said that the Supreme Court's decision on the reserved seats case will have an adverse effect on the Pakistan Tehreek-e-Insaf (PTI). Vawda said the opposition would continue to splinter in the coming days, making it increasingly difficult to manage.

He said the PTI could soon face internal conflicts and the emergence of "forward blocs" since the nomination of reserved seats candidates has to be made by the chairman who is not in the position to do so and hence the party could further fragment. The larger bench of the Supreme Court led by Chief Justice Qazi Faez Isa announced its short order on Friday. The decision was reached with an 8-5 split, with five judges issuing dissenting notes. However, the majority decision of eight judges, including Syed Mansoor Ali Shah, Munir Akhtar, Muhammad Ali Mazhar, Ayesha A. Malik, Athar Minallah, Syed Hasan Azhar Rizvi, Shahid

Waheed and Irfan Saadat Khan was delivered by Justice Mansoor Ali Shah on the recommendation of the CJP. The SC majority verdict overturned the Peshawar High Court judgment dated March 25 and also declared the Election Commission of Pakistan (ECP) order dated March 1 unconstitutional, lacking lawful authority and having no legal effect. The apex court declared that the denial of an election symbol does not affect the constitutional and legal rights of a political party in any manner to participate in an election and to field candidates whereas the ECP is under a constitutional duty to act, construe and apply all statutory provisions accordingly.—RT/Agency

FIA Declares Moonis Elahi And Five Others As 'Absconders' In Money Laundering Case

LAHORE: The Federal Investigation Agency (FIA) has declared Chaudhry Moonis Elahi and five other suspects as absconders in a money laundering case.

The declaration was made during a hearing at Lahore's Special Central Court where the FIA presented an incomplete challan.

The FIA's challan includes Moonis Elahi and co-accused Farayast Ali, Imtiaz Ali, Aamir Sohail, Wajid Ahmed, and Aamir Fayyaz as absconders, while Zara Elahi, Ahmed Farhan, and Saghim Abbas are mentioned as being out on bail.

The FIA requested the court to freeze the properties of all nine accused.

The court approved the freezing of properties for seven suspects, excluding Moonis Elahi and Saghim Abbas, whose lawyers sought time to present arguments.

The court has scheduled the submission of these arguments by August 20.

Judge Tanveer Ahmed Sheikh issued a written

order following the preliminary hearing, stating that the FIA is coordinating with international police to apprehend Moonis Elahi.

Interpol has already issued red notices against him.

The order also includes allegations against Zara Elahi for receiving kickbacks due to her association with Moonis Elahi.

The investigating officer reported that Zara Elahi failed to account for her income.

The challan indicates that Saghim Abbas acted as Moonis Elahi's cash handler, facilitating illicit fund transfers into the bank accounts of other accused individuals, with Ahmed Farhan responsible for depositing the money into these accounts.—RT/Agency

Justice Served: Barrister Gohar Ali

ISLAMABAD: PTI Chairman Barrister Gohar has lauded the decision by an Islamabad district court to overturn Imran Khan and Bushra Bibi's conviction in the Iddat case, saying that "justice has been served."

Islamabad's District and Sessions Court led by Judge Muhammad Afzal Majoka initially reserved the decision in the Iddat case. The court later announced its decision acquitting the PTI supremo and his spouse while accepting their appeal against their February 3 conviction.

Lauding the judiciary strength, Gohar highlighted that Imran Khan consistently advocated for the rule of law and constitutional supremacy.

The PTI chairman

claimed that the case against Imran Khan was a form of pressure intended to compromise him.

Reflecting on the case, Gohar criticised its foundation and declared it baseless, further adding that Imran Khan had two cases pending, but he looked forward to his release, expressing confidence that the PTI founder would be released and welcomed by the nation.—RT/Agency

Imran Outlines Three Conditions For Talks With Government

RAWALPINDI: Incarcerated Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan on Saturday put forward three conditions to hold talks with the government in a bid to bring political stability in the country.

"The first condition is that my cases should be dismissed, the second is to release our party members and third is to return our mandate," Khan said while having an informal talk with the journalists in the courtroom.

Khan has time and again refused to hold talks with the ruling coalition, however, last month, he agreed to hold negotiations with his political rivals and picked Pashatunkhwa Milli Awami Party (PkMAP) Chairman Mahmood Khan Achakzai to lead the parleys.

Recalling that he held negotiations with former chief of army staff Gen (ret'd) Qamar Javed Bajwa, the PTI founder said that they had formed

a three-member committee consisting of Asad Umar, Pervez Khattak and Shah Mehmood Qureshi at that time.

"We were told at that time that the 'baray sahib' [big boss] has decided not to conduct elections," said Khan, emphasising that his party cannot forget the "February 8 robbery" — a reference to the alleged rigging in the polls.

Khan warned that they will go on a hunger strike and highlight it on a global level. Speaking about Supreme Court's verdict on reserved seats, the PTI founder welcomed the decision and called it a "positive development". "The SC's verdict has given hope to the people," said Khan, thanking the top court's judges for standing up for the supremacy of the law.

The apex court on Friday ruled that the party is eligible for the allocation of reserved seats, nullifying the Peshawar High Court's decision where it had upheld the Election Commission's decision denying the reserved seats to the PTI-backed Sunni Ittehad Council (SIC).—RT/Agency

IMF's 'Tough Conditions' Hindered Budget Relief: FBR Chairman

ISLAMABAD: Federal Board of Revenue (FBR) Chairman Zubair Tiwana revealed that the government had planned to provide relief in the budget 2024-25 but the efforts were hindered by the International Monetary Fund's (IMF) 'tough conditions',

media reported on Saturday. During a meeting of the National Assembly's Standing Committee on Finance, the FBR Chairman Zubair Tiwana explained that while there was a desire to offer relief, the IMF did not agree to these measures.

He highlighted the IMF's reluctance to extend relief to the salaried class and cited a lack of trust during negotiations as a significant barrier. The IMF's mistrust stemmed from previous instances where reforms were not implemented in a timely manner.—RT/Agency
