Court Approves 8-Day Remand For Imran And Bushra Bibi

RAWALPINDI: An accountability court on Sunday approved eight-day physical remand each of Pakistan Tehreek-e-Insaf (PTI) founder and former prime minister Imran Khan and his wife, Bushra Bibi, in a fresh graft reference. The order comes less than a day after the PTI founder and his wife were acquitted in the iddat or illegal marriage case, but their hopes of coming out of prison were dampened as the National Accountability Bureau (NAB) arrested them in a new Toshakhana reference. Additional Sessions Judge Muhammad Afzal Majoka had a day earlier nixed the couple's conviction — in which they were sentenced to seven years in prison and awarded a fine of Rs500,000 each after a trial court found their nikah to be fraudulent as Khawar Maneka, Bushra's ex-husband, moved the court against the couple's marriage. However, soon after the verdict overturning their conviction, a team of the anti-corruption watchdog headed by Deputy Director Mohsin Haroon arrested the couple in the Adiala Jail in the new reference related to alleged "misuse of power for acquiring Toshakhana gifts".



The PTI, after securing a key legal victory after a 13-member Supreme Court bench declared the party eligible for the allocation of reserved seats, was looking forward to their founder's release — which if it had happened would've given a major boost to the former ruling party. However, the accountability court today has directed the NAB to interrogate the two suspects in Adiala jail and also ordered to produce the couple before the court on July 22. Khan's lawyer Zaheer Abbas Chaudhary, while speaking to media persons, said that NAB had requested a 14-day physical remand of PTI founder and Bushra Chaudhary said that they opposed the physical remand, pleading that they have engagements in the £190 million reference. The lawyer said that the ex-premier and his wife's arrest was against the law, adding that their petition seeking bail was already being heard in the Supreme Court. PTI founder's legal woes Khan has been behind bars since August last year after he was sentenced in the Toshakhana criminal case and subsequently sentenced in other cases ahead of the February 8 elections. Although the former PM has been granted bail in several May 9 cases registered in Lahore, Rawalpindi, and Faisalabad, an anti-terrorism court (ATC) last week cancelled his bail in one of the May 9 cases registered against him and thousands of his supporters in connection with violence against the military and other state installations that erupted following his brief arrest in May 2023. In June, the Islamabad High Court overturned Khan's conviction on charges of leaking state secrets in the cipher case wherein he was handed down a 10-year prison sentence on charges of making public a classified cable sent to Islamabad by Pakistan's ambassador in Washington in 2022.—RT/Agency

-Bullet Grazes The Donald's Right Ear Trump Shot At Pennsylvania Rally

WASHINGTON: Donald Trump was shot in the ear during a Saturday campaign rally, streaking the Republican presidential candidate's blood across his face and prompting his security agents to swarm him, before he emerged and pumped his fist in the air, appearing to mouth the words "Fight! Fight! Fight!"



The shooter was dead, one rally attendee was killed and two other spectators were injured, the Secret Service said in a statement. The incident was being investigated as an assassination attempt, a source told Reuters. Donald Trump, 78, had just started his speech when the shots rang out. He grabbed his right ear with his right hand, then brought his hand down to look at it before dropping to his knees behind the podium before Secret Service agents swarmed and covered him. "I was shot with a bullet that pierced the upper part of my right ear," Trump said on his Truth Social platform following the shooting in Butler, Pennsylvania, about 30 miles (50 km) north of Pittsburgh. "Much bleeding took place."

He emerged about a minute later, his red "Make America Great Again" hat knocked off, and could be heard saying "wait, wait," before agents ushered him into a vehicle. "I was shot with a bullet that pierced the upper part of my right ear," Trump said on his Truth Social platform following the shooting in Butler, Pennsylvania, about 30 miles (50 km) north of Pittsburgh. "Much bleeding took place." The shooter's identity and motive were not immediately clear. Leading Republicans and Democrats quickly condemned the violence. The Donald Trump campaign said he was "doing well." Bloomberg reported he had been released from the hospital. The shooting occurred less than four months before the Nov. 5 election, when Trump faces an election rematch with Democratic President Joe Biden. Most opinion polls including those by Reuters/Ipsos show the two locked in a close contest. Biden said in a statement: "There's no place for this kind of violence in America. We must unite as one nation to condemn it." Biden spoke with Trump following the shooting, a White House official said. Republican U.S. Representative Ronny Jackson of Texas told Fox News his nephew had been wounded at the rally. The shooting raised immediate questions about security failures by the Secret Service, which provides former presidents including Trump with lifetime protection. WITNESS ACCOUNT Ron Moose, a Trump supporter who was at the rally, described the chaos: "I heard about four shots and I saw the crowd go down and then Donald Trump ducked also real quick. Then the Secret Service all jumped and protected him as soon as they could. We're talking within a second they were all protecting him." Moose said he then saw a man running and being chased by officers in military uniforms. He said he heard additional shots, but was unsure who fired them. He noted that by then snipers had set up on the roof of a warehouse behind the stage. The BBC interviewed a man who described himself as an eyewitness, saying he saw a man armed with a rifle crawling up a roof near the event. The person, who the BBC did not identify, said he and the people he was with started pointing at the man, trying to alert security. The shots appeared to come from outside the area secured by the Secret Service, the agency said. The FBI said it had taken the lead in investigating the attack.—RT/Agency

PM Expresses Concern Over Repeated Malfunctions In Neelum Jhelum Hydropower Project



ISLAMABAD: Prime Minister Shehbaz Sharif expressed serious concern over the repeated malfunctions and stoppage of production in the Neelum Jhelum Hydropower Project and directed them to take strict action by directly identifying those who are responsible. Prime Minister Shehbaz Sharif chaired a meeting regarding the Neelum Jhelum Hydropower Project in which a preliminary report was presented on the reasons for the closure of the project. According to the report, the hydropower project was constructed in a weak geological and earthquake-prone area. In the meeting, there was opposition to conducting an inquiry through a third-party audit, on which the Prime Minister indicated to form a cabinet committee to determine the responsible parties. The prime minister said that despite spending billions of dollars, there were flaws in the project's design as well as in the construction, with places where sand should have been filled in instead of concrete infill. China Energy addressed the challenges that need to be handled to operationalize the project as soon as feasible before the Giza Group. Prime Minister said that it is not about me or WAPDA, the fate of the people of Pakistan is connected with it. In the meeting, a committee consisting of former Secretary Shahid Khan and Secretary Water Resources Syed Ali Murtaza was established and given the task of investigating the defects of the project.—RT/Agency

Shehbaz And President Zardari Condemn 'Shocking' Attack On The Donald

ISLAMABAD: Prime Minister Shehbaz Sharif Sunday condemned the attack on former US president Donald Trump during an election rally and wished him a swift recovery. "Just learnt that former President Trump was shot at an election rally. This is a shocking development. I condemn all violence in politics," the prime minister said in a post on X, formerly Twitter. "Wish the former President swift recovery and good health."



President Asif Ali Zardari also "strongly" condemned the attack on former US president in Pennsylvania. Expressing shock over the attack, President Zardari said that such violence had no place in politics. He expressed his best wishes for the speedy recovery of Trump and also offered heartfelt condolences over the loss of life in the attack. In his statement, Senate Chairman Yousaf Raza Gilani condemned the attack, while terming it an unfortunate incident. He said that political violence has no place in democratic societies. He also expressed his good wishes for the early recovery of the former president. Azma Bukhari: Gandapur Should Focus On KP, Not the Centre

ISLAMABAD: Punjab Information Minister Azma Bukhari has advised Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur to worry about his province rather than the federal government after the Supreme Court's decision on the reserved seats case. "They [PTI] should not give a lecture to us," she said in a statement while reacting to the KP Information Minister Muhammad Ali Saif's comments. Earlier in the day, Saif said that KP CM Gandapur's actions would be a nail in the "Form 47" government. He claimed that the federal ministers could not sustain the apex court's judgment. On July 13, a full-court SC bench set aside orders of the Peshawar High Court and Election Commission of Pakistan taking away reserved seats from the Sunni Ittehad Council. The court ruled that the Pakistan Tehreek-e-Insaf should be considered a political party and given reserved seats. "Pakistan Tehreek-e-



Insaf was and is a political party which secured and won... general seats in the national and provincial assemblies in the general elections of 2024," said the majority decision read by Justice Syed Mansoor Ali Shah Saif claimed that the federal and provincial ministers in Punjab were committing contempt of court by anti-court statements. He said that after the court rulings, the "incompetent government has become delirious and the fake representatives of the incompetent government are speculating venom against the judiciary in scheduled press conferences." He alleged that the government had earlier played politics on important national security matters like the Operation Azm-i-Ishtekham. "This group can go to any extent to save their power, and the purpose of the scheduled press conferences is to occupy the TV screen, with the aim of creating a narrative against the judiciary and suppressing the opposition's opinion," Saif said. As PML-N's Bukhari slammed Saif's comments, she criticised the PTI-led government over the state gifts case and sent a judicial reference against the CJP Faez Isa when the PTI was in power.—RT/Agency

PTI's Sanam Javaid Rearrested Just One Hour After Release

ISLAMABAD: Pakistan Tehreek-e-Insaf's (PTI) Sanam Javaid, who has been jailed for months, was rearrested once again just almost an hour after her release following acquittal by an Islamabad court on Sunday in a case registered by the Federal Investigation Agency (FIA). The social media political activist had walked free earlier today following months of incarceration, but was taken into custody by Islamabad police soon after.



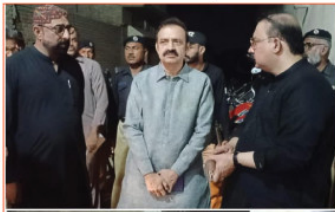
It may be noted that Javaid's release has been blocked multiple times as she had been released from a jail in Gujranwala on Saturday as well but the FIA handcuffed her again minutes after her release. The Lahore High Court (LHC) last week cleared the PTI activist of charges in a case linked to the May 9 riots, while allowing her plea against physical remand granted by an anti-terrorism court. However, the FIA team booked and arrested her in a new case pertaining to the May 9 events, upon her release from prison on Saturday. The FIA Cyber Crime Cell had lodged a case against her for allegedly posting inciting remarks on May 9, urging people to attack the Jinnah House. The News reported Following her arrest, the FIA team transported Javaid to Islamabad, where she was presented in a district and sessions court for acquisition of remand. The magistrate on duty, Malik Imran acquitted her on her request, only to be rearrested by the Islamabad police. Her arrest was confirmed by her lawyer in an X post. However, it has not yet known in which case Javaid has been rearrested. The PTI firebrand campaigner has been embroiled in various cases, all linked to the vandalism and unrest triggered by PTI founder Imran Khan's arrest on May 9, 2023. There were 12 cases registered against her, including the Zaman Park vandalism, the PML-N house fire and a Racecourse Police Station incident.—RT/Agency

Khairpur's Langah community demands justice, protection in murder dispute

KHAIRPUR: The Langah community in Khairpur is in turmoil following a series of violent incidents that have left them feeling vulnerable and unsafe. Retired government officer Abdul Waheed Langah and Advocate Ghulam Shabbir Shaikh, both residents of Pahl village within the Khairpur Babaroli police station's jurisdiction, held a press conference to shed light on these troubling events.



Younus Palah. The Pahl community has accused Naeem Ahmed of immorality involving Anita, wife of Malir Pahl, for the second time. This accusation has raised suspicions among the Langah community, especially since a similar false adultery case was filed against Naeem Langah in 2014, which allegedly resulted in a black-mail fine of 1.2 million rupees. A murder case for the killing of Zaheer Pahl has been registered against seven known and three unknown individuals from Abdul Waheed's side, who have secured bail in this case. Two days before the attack on their homes and the death of Zaheer Pahl, suspects Anwar Pahl, Rafiq, Anis, and others from the Pahl community attempted to kidnap Abdul Waheed's 15-year-old son, Hamad Langah, on his way back to the village from Therhi. Hamad's cries for help attracted people, causing

the suspects to flee after assaulting him. A case has been registered at the Babaroli police station, but the suspects remain at large. Abdul Waheed Langah and Advocate Ghulam Shabbir Shaikh have accused Malir Pahl and Rustam Pahl of fabricating accusations of immorality and turning murder into a business. They appealed to the Chief Justice of Sindh High Court, the IG of Sindh, and other authorities to take notice of these events and ensure justice is served. The Langah community is now living in fear and uncertainty. They demand immediate action against the perpetrators and protection from further attacks. The community is also calling for a thorough investigation into the accusations and the motives behind them. They hope that justice will be served and that they can live in peace without the constant threat of violence.

Johi residents protest against deteriorating law and order situation

JOHI: The small town of Johi, nestled in the Union Council Kamal, was thrown into a state of agitation after an alarming incident involving one of its residents, Seth Muhammad Jamali. Seth Muhammad Jamali, known for his community contributions and peaceful demeanor, faced a harrowing experience when he was accosted by more than four unidentified armed thieves on Bhan Road. This incident occurred as he was making his way from Johi to his village in Addo Khan Jamali.



The brazen thieves, wielding weapons, forcefully took from Seth Jamali his motorcycle, mobile phone, a prized Rado watch, a gold ring, and thousands of rupees in cash. Despite promptly reporting the crime to the Johi police, no immediate action was taken, leaving the residents feeling unprotected and ignored. This incident sparked outrage among the local populace, leading to an organized protest. More than fifty village elders and residents from Union Council Kamal, alongside the victims of similar incidents, gathered to demand justice. The protest saw the participation of notable community leaders including Haji Muhammad Moosa Jamali, Muhammad Jamali, Muhammad Jamali, Muhammad Jamali, Maulvi Abdul Kareem Shahani, Muhammad Umar Jamali, Anwar Jamali, Haji Mehar Jamali, Rasheed Channa, and Dado Abdul Kareem Rodnani. The agitated crowd blocked the main road in front of Johi police station and later established a camp at Johi Naka Bypass. The protesters voiced their grievances loudly, accusing the Johi police of being complicit with the criminals. They alleged that the police station had transformed into a haven for thieves and robbers, who now roamed freely and terrorized the locals, especially during the evenings. Villagers narrated multiple instances where criminals openly targeted innocent residents on the link roads, with the police failing to intervene. The protesters demanded that higher authorities, including the IG of Sindh and the SSP of Dadu, take stringent action to recover the stolen motorcycle and goods and address the deteriorating law and order situation. They called for a comprehensive inquiry into the allegations of police collusion with criminals. The intensity of the protest forced DSP Johi and SHO Johi to respond. They arrived at the protest site with a police force four hours after the protest began, attempting to pacify the crowd. The officials assured the affected parties that efforts would be made to recover the stolen motorcycle and goods within three days. Residents, however, remained skeptical of these promises. They emphasized that this was not an isolated incident, and without systemic changes, the safety of Johi's residents would continue to be at risk. The protesters vowed to continue their demonstrations until tangible actions were taken and visible changes were seen in the security landscape of their community. This incident has highlighted the broader issues of security and police accountability in Johi. The residents are now calling for a community meeting to discuss further actions and strategies to safeguard their village and ensure that such incidents do not recur. They also plan to petition the government for increased police patrols and better training for local law enforcement.

Growers rally against acute water shortage at Daulatpur's Lundki Minor branch

DAULATPUR: Farmers in Daulatpur have taken to the streets to protest against the artificial water shortage in the Lundki Minor branch and the alleged corruption of the irrigation officials stationed there. The protest, led by farmers Wajid Rahu, Punhal Khoso, Imam Bux Jamali, and others, highlighted the severe impact of the water shortage on their livelihoods. The protesters, chanting "Why isn't there water, Karbala, Karbala?" entered the Daulatpur Minor branch and held banners while staging a demonstration in front of the media. Speaking to journalists, they claimed that the irrigation officials assigned to the Lundki Minor branch are selling the water meant for the tail-end to influential people, leaving the tail-end lands barren and causing severe devastation. The situation has become so dire that some farmers have been forced to sell their children. Every six months, irrigation officials take bribes ranging from one lac to one and a half lac per watercourse. They break the watercourses, install illegal outlets and dams, and sell the tail-end water, depriving the farmers of the essential resource they need for their crops. As a result, no water reaches the tail-end during both the winter and summer crops, rendering thousands of acres of land barren. The farmers have demanded from the irrigation minister and other high authorities to remove the corrupt irrigation officials, stop the economic massacre of the farmers, and provide them with justice. They are calling for immediate and effective action to ensure that water reaches the tail-end lands and that the corrupt practices of the irrigation officials are brought to an end. This protest is a desperate plea for help from the farmers of Daulatpur, who are struggling to survive in the face of corruption and mismanagement. The farmers hope that their voices will be heard and that measures will be taken to address their grievances and ensure a fair distribution of water.

Nooriabad man shot and injured in ambush

NOORIABAD: In a distressing incident that has left the community in shock, a young man named Aijaz Palari from Dada Bhai village was shot and severely injured by unidentified armed men. This incident took place near Dada Bhai stop within the jurisdiction of the Nooriabad police station. Aijaz Palari, who was returning home from his duties, found himself ambushed by three armed men on a motorcycle. The attackers, without any provocation, opened fire on him, leaving him with severe injuries. His immediate family and relatives, who were quick to respond, rushed him to the Nooriabad police station to obtain the necessary documents before taking him to the hospital for urgent medical treatment. Aijaz Palari's brother, Mazar Khan Palari, expressed deep concern and frustration over the incident. He detailed how his brother was merely returning home from work when the attack happened. Mazar Khan demanded that the Nooriabad police take swift and decisive action to apprehend the attackers, warning that failure to do so would lead to further protests by the community. This shooting incident has heightened fears among the residents of Nooriabad, who feel increasingly unsafe due to the rising incidents of armed attacks and robberies. The community is now calling for increased police presence and better security measures to prevent such violent crimes.

The local authorities have assured the family that they will investigate the incident thoroughly. Army and Extra Police Deployed in Pindi Until Ashura

RAWALPINDI: As many as six companies of the Pakistan Army as well as extra police will be deployed in the garrison city from Muharram 7 (today) onwards to deal with any emergency situation. Additionally, close circuit TV (CCTV) cameras have been installed for full monitoring of category A processions.



During a briefing given to a delegation of the Punjab Cabinet Committee on Law and Order in Rawalpindi on Saturday, the meeting was informed that three-tier security had been laid out to protect processions, including metal detectors, walk-through gates and physical checking.

The delegation of the cabinet committee was headed by Cabinet Committee Chairman and Punjab Minister Khawaja Salman Rafique, who also presided over a review meeting at the Commissioner's Office.

Punjab ministers Mujtaba Shujaat Rahman and Bilal Akbar Khan as well as Special Assistant Zeshan Malik were part of the delegation. Punjab Home Secretary Noorul Amin Mengal, IG Punjab Dr Usman Anwar, Additional IG CTD, DIG Special Branch, Commissioner Engineer Aamir Khat-

tak and RPO Babar Sarfraz Alpa, deputy commissioners of all districts, DPOs and representatives of the departments concerned as well as members of the divisional and district peace committees were also present on the occasion.

Khawaja Salman Rafiq directed that a zero-tolerance policy should be adopted towards any violation of the code of conduct of Muharram, adding that the scheduled time and route of the procession should be followed.

He said on the instructions of Punjab Chief Minister Maryam Nawaz, for the first time arrangements for Sabeel, Niaz and Langar were being made by the government. Apart from fool-proof security arrangements, peace committees should be

mobilised for communal harmony and inter-Muslim unity, he added. Punjab Minister Bilal Akbar said we should forget differences and discuss commonalities. He alerted to deal with any emergency, adding that during an emergency situation, more damage was caused by mismanagement and thus it was necessary to conduct mock exercises. Mujtaba Shujaat Rehman said the atmosphere of inter-faith harmony and tolerance should be nurtured in the holy month of Muharram. He said apart from monitoring loudspeakers and social media, audio and video recordings of Majalis and processions should be compiled.—RT/Agency

Raheel Sharif Tied Nawaz's Panama Leaks Relief to Extension: Senator Irfan Siddiqui

ISLAMABAD: Pakistan Muslim League-Nawaz (PML-N) Senator Irfan Siddiqui revealed that former chief of army staff General (ret'd) Raheel Sharif had asked then-prime minister Nawaz Sharif for extension in his tenure in return for relief in Panama Papers case, The News reported.



"It is no longer a secret that Gen Raheel Sharif used to ask for an extension. He had asked for it more than once," Senator Siddiqui said while speaking during Geo News programme "Jirga" on Saturday.

The senator recalled that a meeting was held in Raiwind a couple days after social worker Abdul Sattar Edhi's funeral. "One of our senior leaders said Raheel Sharif had given him a message that 'you are delaying in extending my tenure'," said the senator, adding that Nawaz proposed him the position of chairman of the Joint Chiefs of Staff Committee instead.

Siddiqui said that the former army chief also suggested to extend the services of three other chiefs so that he was not singled out. "The second suggestion was that he should be promoted as a

field marshal and with it his tenure as army chief would also be extended. However, Nawaz Sharif did not accept his suggestions," he added.

The senator said that another offer was made to Raheel Sharif, whether he wanted it or not, but the environment was entirely the same as what Raheel Sharif had left behind. Only the army chief was changed, the rest were sitting in their place. man Muhammad Ali Randhawa and his team for their proactive approach. "The CDA team deserves accolades for this initiative," he stated.

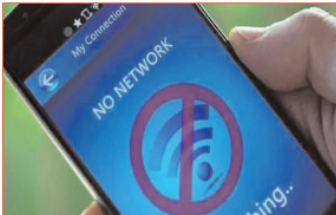

Internet Services To Remain Suspended During Muharram

QUETTA: The Balochistan government has decided to suspend mobile and internet services in various cities on 7, 9, and 10 Muharram, media reported.



Balochistan home ministry spokesperson said that the suspension will affect Quetta, Kachhi, Jhal Magsi, Jaffarabad, and Usta Muhammad.

The government has deployed over 18,000 personnel in Quetta to ensure security on Youm-e-Ashurah. Additionally, two helicopters will be used for aerial surveillance of processions on 7, 9, and 10 Muharram.

Section 144 has also been imposed in seven districts until 10 Muharram, banning pillion riding and imposing other restrictions to maintain law and order.

Earlier, the federal government approved the deployment of armed forces across the country to ensure

security during the month of Muharram. The move comes at the request of the authorities in Sindh, Balochistan, Khyber-Pakhtunkhwa, Islamabad, Gilgit-Baltistan and Azad Jammu and Kashmir to deploy military to control the law and order situation.

The Centre, under Article 245 of the Constitution, authorized the "deployment of Indian army troops/assets and civil armed forces troops/assets" to ensure peace.

It is pertinent to mention here that Ashura will be observed in Pakistan on July 17 (Wednesday). The provincial government has imposed a ban on pillion riding in Sindh during 10 days of Muharram.

Ashura is observed on the 10th day of Muharram, the first month of the Islamic year, which marks the great martyrdom of Imam Hussain (RA) and his companions in the Battle of Karbala.—RT/Agency

Four Dead, Ten Injured in Chitral Ravine Crash



CHITRAL: In a tragic incident, four died, while ten others, including four women, were injured after a vehicle plunged into a ravine in the Yarkhun Valley of Chitral, media reported.

In a similar incident that happened in Neelum Valley, at least six people, including women and children, had been killed in a road accident in the Taobat area of Neelum Valley district. A jeep carrying 23 people from Kail to Taobat plunged into the river when the driver lost control over the vehicle, said police. As a result, all the passengers inside drowned in the river. The bodies were retrieved later by local rescuers, the official added. Eyewitnesses said that the car was swept away by the river's strong current, making it difficult for rescue teams to locate it.—RT/Agency

The accident occurred at around 11am when a jeep skidded off the highway and plunged into Neelum River. The deceased included four women and three children. As soon as the incident was reported, the rescue officials immediately reached the site of the accident and started rescue operation.

The rescue teams shifted the bodies to a morgue for medico-legal procedures and the injured to a nearby hospital for medical assistance.

BAHAWALPUR: In a heart-wrenching plea for justice, Iram Bibi, wife of Muhammad Altaf Machhi, spoke to journalists at the press club about the harrowing experience of her daughter's abduction. She recounted the traumatic incident that occurred yesterday while her husband was transporting their children in a rickshaw for labor work. As they reached Boys Degree College, Uch Sharif, the accused, identified as Muhammad Rajib and Muhammad Fayaz, ambushed them on two motorcycles.

"They assaulted and beat me mercilessly, then forcibly took my 10-year-old daughter, Alishba Bibi, away on their motorcycle, Iram Bibi tearfully recounted. Despite her desperate attempts to seek help from the police, her pleas have gone unanswered. "I have visited the police station repeatedly

for three days, but the accused were released, and the case was not registered. It's as if my cries for help have fallen on deaf ears," she lamented.

Biden leads condemnation after Trump wounded at rally shooting

WASHINGTON: US President Joe Biden led the condemnation after his election rival Donald Trump was wounded in an apparent assassination attempt at a Pennsylvania rally on Saturday, as some Republicans blamed the Biden campaign for the violence.

Political leaders on both sides of the aisle slammed the attack minutes after the Republican candidate was rushed off stage by the Secret Service with blood running down his face.

"There's no place in America for this kind of violence. It's sick. It's sick. It's one of the reasons why we have to unite this country... We cannot be like this, we cannot condone this," Biden told reporters in an emergency briefing in Rehoboth Beach, Delaware.

"The idea that there's political violence, or violence in America like this, is just unheard of. It's just not appropriate. Everybody, everybody, must condemn it. Everybody," Biden said.



Vice President Kamala Harris said on X: "We are praying for him, his family, and all those who have been injured and impacted by this senseless shooting."

Biden's former boss, Barack Obama, echoed his words in a statement, saying there was "absolutely no place for political violence in our democracy."

"Although we don't yet know exactly what happened, we should all be relieved that former President

Trump wasn't seriously hurt, and use this moment to recommit ourselves to civility and respect in our politics," he said on X.

Former president George W. Bush condemned the "cowardly" attack.

"Laura and I are grateful that President Trump is safe following the cowardly attack on his life. And we commend the men and women of the Secret Service for their speedy response," the Republican said in a statement.

Bill and Hillary Clinton also condemned the violence.—Agency

"Our mansions and rooms were raided, and our supporters were fired upon and intimidated. Farmers and workers associated with us have been attacked," he said.

He further described the legal injustices his brother has faced. "Mir Shahid Talpur has been falsely convicted, and his arrest is part of a broader scheme to tarnish our reputation and undermine our political standing," he asserted. Mir Noor Ahmed Talpur called upon the Chief Justice of Pakistan and the Chief Justice of Sindh to intervene and protect his brother's life, ensuring he receives fair legal representation and due process.

The family has urged authorities to investigate the illegal and inhumane treatment of Mir Shahid Talpur in jail. "We demand justice and fair treatment. This is not just about our family, but about upholding the principles of justice and human rights," he concluded.

10 Booked In A Case For Stealing Equipment From Transmission Towers In Jamshoro

KOTRI: In a significant crackdown on theft, police in Nooriabad and Jamshoro have registered a case involving the pilferage of equipment from seven transmission towers. The stolen items include 49 plates of 500 KV and 120 bolts from Mehran Engineering University, and the case has been registered against ten individuals, including Jameel Khaskheli, Shakil Khaskheli, and Qasim Khaskheli.

The accused allegedly stole equipment from the double-circuit transmission lines of the towers, causing substantial financial losses and disruptions in electricity supply. Qasim Khaskheli, in particular, is accused of steal-

ing 139 plates of 500 KV and 191 bolts from five towers and fleeing the scene.

Despite efforts to report the incident, theft of equipment worth millions of rupees from National Transmission and Dispatch Company towers has become a recurring issue.

The authorities have expressed concern over the frequency of these thefts, which not only cause financial damage but also disrupt essential services.

Investigations are ongoing, and the police have vowed to bring the perpetrators to justice. "We are committed to cracking down on such crimes and ensuring that those responsible are held accountable," said a police spokesperson.

Former Pakistan all-rounder Billy Ibadulla passes away at 88



Former Pakistan all-rounder Billy Ibadulla passed away on Friday at the age of 88. He had a brief career for Pakistan during which he played four Tests from 1964 to 1967.

He is known for being the first-ever Pakistani player to score a hundred on his Test debut. The former all-rounder made his Test debut in 1964 against Australia at Karachi's National Stadium.

While opening the innings, he struck 166 runs in the first innings, during which he also constructed a 249-run opening stand with fellow debutant Abdul Kadir, who scored 95.

This partnership remains the highest between two debutants for any wicket in Test cricket.

However, Ibadulla went on to play only three more Test matches for Pakistan, scoring a total of 253 runs in four matches. He also took one wicket with his off-spin bowling.

The Pakistan Cricket Board (PCB) also sent their condolences to Ibadulla's friends and family through a

statement on their official X (formerly Twitter) account.

"The PCB is deeply saddened by the passing of former Test cricketer Khalid Ibadulla on 12 July. He played four Tests from 1964 to 1967, scoring 253 runs, and was the first Pakistani batter to score a century on Test debut," the cricket board posted.

"In 417 first-class matches, he amassed 17,078 runs and took 462 wickets. PCB extends its heartfelt condolences to his friends and family."

He was one of the first Pakistani players to play county cricket in England, where he made a respectable career playing for Warwickshire.

"He was a special cricketer, one of the greatest, and we had lots of fun times together," Warwickshire president Dennis Amiss, who played alongside Ibadulla at the club, wrote in a tribute to his former team-mate as quoted by ESPN-Cricinfo.—Agency

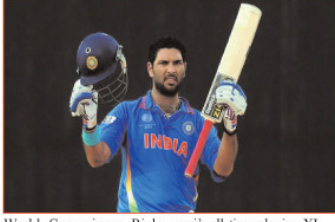
Wasim Akram makes it to Yuvraj Singh's all-time playing XI

The Spokesman said farmers should make proper arrangements to drain out rainwater from the crop in case of excessive rains.—RT/Agency

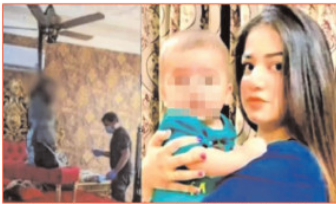
Sania Zehra Case: Forensic report reveals cause of death

The police spokesperson in a statement disclosed that the post-mortem examination revealed no signs of violence or injuries on the woman's body, adding that the woman lost her life due to suffocation from a rope.

Torrential rains expected to lash Punjab on 8th and 9th of Muharram

LAHORE: The Punjab Provincial Disaster Management Authority (PDMA) on Sunday said torrential rains were likely to hit the provinces in the next couple of next days — till Muharram 9 (July 16).

The PDMA spokesperson said the managements of mourning processions should take preventive measures viewing intensity of the weather as heavy downpours were expected to lash the province tonight as well as on Muharram 8 and 9 (July 15 and 16).

Moreover, the PDMA also directed the rescue department to stay alert, particularly on the aforementioned days.

The spokesperson advised people to keep distance from electricity poles and wires. The official also said majalis should not be held on ramshackle roofs, while going near crossings of rivers, streams and nullahs should be avoided as much as possible.

Meanwhile, the Punjab disaster management body said flooding was feared in mountainous regions of Dera Ghazi Khan.

It should be noted that multiple cities of the province on Friday received heavy rains, including La-



hore which experienced as high as 315 millimetres of rain, breaking a 30-year-old record and leaving the city completely drenched in water.

The PDMA had earlier issued a flood alert sheet, which includes data on the monsoon rains situation, and water levels in rivers, barrages, and dams across Punjab.

Due to the heavy rains, 12 citizens lost their lives, 14 houses were affected, and 27 citizens were injured, including five children, three women, and four men.

Additionally, three civilians were killed by lightning in Narowal and Multan.

PDMA Director General Irfan Ali Kathia stated that arrangements have been completed to address flood risks in vulnerable districts.

Kathia said flood relief camps had been established in mountainous areas because of the threat of urban lands.

"There is a risk of flood flooding in Lahore, Sialkot, Faisalabad, and Gujranwala. The administration of major cities remains on high alert in view of the emergency situation," he said. As per APP, the water flow in all the rivers and barrages of Punjab is curbed at normal levels. The water level in Mangla Dam is at 53% capacity, while Tarbela Dam is at 74%. The water levels in Indian dams on the Sutlej, Beas, and Ravi rivers are up to 37%.

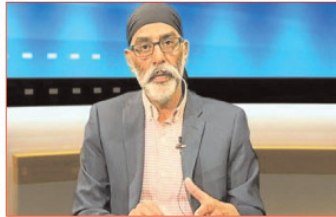
Suspected Trump rally shooter had explosive devices in his car, claims report

WASHINGTON: United States authorities found explosive devices in the car of the man who officials said tried to assassinate former president Donald Trump, the American Wall Street Journal reported on Sunday, citing unnamed sources. The car driven by the suspected shooter, Thomas Matthew Crooks, was parked near the Trump rally in Butler, Pennsylvania, on Saturday, the newspaper reported. The newspaper and ABC News both reported that the gun Crooks used was purchased by his father. Meanwhile, CNN reported that the shooter had explosive material inside his residence as well. The incident was being investigated as an assassination attempt Trump, who is again a candidate for US presidential elections, was attacked at a polls campaign rally. He was shot in the ear, streaking the Republican's blood across his face and prompting his security agents to swarm him, before he emerged and pumped his fist in the air, mouthing the words "Fight! Fight! Fight!" as identified by the Federal Bureau of Investigation, the shooter was a 20-year-old named Thomas Matthew Crooks. He was shot and killed by the Secret Service right after he fired multiple shots towards Trump.

The US Secret Service said in a statement that the shooter "fired multiple shots towards the stage from an elevated position outside the rally" before being "neutralised" by agents.—Agency

Sikh rights group likens Trump shooter's mindset to Modi's

Condemning the attack on former president Donald Trump at an election rally, a US-based Sikh rights group has likened the shooter's mindset to the ultra-nationalist Indian Prime Minister Narendra Modi, who, it claims, "takes pride in getting his political opponents killed at home and abroad."



The FBI has identified the suspect as 20-year-old Thomas Matthew Crooks from Bethel Park, Pennsylvania, a registered Republican. The incident also tragically claimed the life of rally attendee Corey Comperatore, 50, from Sarver, Pennsylvania, who Governor Josh Shapiro confirmed died while shielding his family from gunfire.

"We, the pro-Khalistan Sikhs seeking a referendum for Punjab's independence from Indian occupation, unequivocally condemn the assassination attempt on Trump," stated Gurbatwant Singh Pannun, General Counsel to Sikhs for Justice (SFJ).

The attack occurred just before Trump, 78, was scheduled to formally accept the Republican presidential nomination at a campaign speech in Butler, Pennsylvania. Gunshots rang out, injuring Trump's right ear and causing minor facial injuries.

Pannun compared the Trump attack and the alleged actions by India's Modi government, accusing them of targeting dissenting voices within the pro-Khalistan movement, such as Hardeep Singh Nijjar in Canada and multiple incidents of alleged "Murder for Hire" plots in New York City.

"There is no place for political violence in a democracy. Political differences should always be resolved through votes, not violence," emphasised Pannun, calling for a peaceful resolution through democratic processes like the Khalistan Referendum.—Agency

Elon Musk says he fully endorses Trump, hopes for rapid recovery



Elon Musk, the billionaire CEO of Tesla, said in a social media post on Saturday: "I fully endorse President Trump and hope for his rapid recovery."

Earlier, multiple shots rang out at Donald Trump's rally in Pennsylvania on Saturday, with the Republican presidential candidate grimacing and raising his right hand to his right ear as shots rang out, video footage showed.

Trump is "safe" after an incident Saturday at a rally in Pennsylvania, which saw him rushed off the stage after what sounded like possible shots were heard.

The Secret Service has implemented protective measures and the former president is safe. This is now an active Secret Service investigation and further information will be released when available," Secret Service communications chief Anthony Guglielmi said on X.

The former president was rushed off stage by Secret Service agents after a series of loud bangs that sounded like possible gunshots were heard at the start of a campaign rally in Pennsylvania.

Trump was seen with blood on his right ear as he was surrounded by security agents, who rushed him off the stage as he pumped his fist to the crowd.

The "former president is safe," the secret service said after Trump was bundled into an SUV and driven away.

"Shooting Makes Me Stronger": Donald Trump Attack T-shirts Go On Sale Online

Former US President Donald Trump was hit in the ear in an apparent assassination attempt by a gunman at a campaign rally today in Pennsylvania, a shocking incident that will fuel fears of instability ahead of the 2024 US presidential election. Several politicians, tech leaders and followers of Mr Trump condemned the attack, stressing that political violence is intolerable. Shortly after the news broke out, t-shirts featuring a defiant image of Donald Trump with blood visible on his face and fist in the air went viral online. According to a report in the South China Morning Post, within two hours after the attack, the first batch of the t-shirts went on sale on a popular Chinese e-commerce platform Taobao, owned by Alibaba. A 25-year-old Taobao seller, got her T-shirts on her online stores before morning in China. Her factory is located in the northern province of Hebei. To produce new goods, she just needs to download an image and hit the print button. A T-shirt takes the factory half a minute on average to finish.

"We put the T-shirts on sale as soon as we saw the news about the shooting, though we hadn't even printed them, and within three hours we saw more than 2,000 orders from both China and the US," she said.—Agency

Firing incident claims two lives in German town



FRANKFURT: Two people were killed in southwestern Germany on Sunday, police said, adding that the suspected gunman was also found dead in what appeared to be a domestic incident.

The attacker was reportedly a hunter, according to a Bild newspaper and broadcaster SWR.

Police in the Reutlingen region said they received several reports of gunshots in the town of Albstadt-Lautlingen shortly after 12:30 pm (10:30 GMT).

Officers arrived at the scene to find three people dead — including the suspected perpetrator," Reutlingen police wrote on X.

Two others were injured, they said, in what appeared to be a family tragedy.

"Initial findings point to a domestic incident," they said on X. Regional broadcaster SWR, citing security sources, said the gunman was a 63-year-old man who killed his mother and son and injured his wife and daughter.—Agency

Melania Trump breaks silence after Donald Trump shooting

WASHINGTON: Former first lady Melania Trump said Sunday that a gunman who opened fire at a Donald Trump rally was a "monster," as she condemned the assassination attempt in which the Republican presidential candidate was injured.

"A monster who recognized my husband as an inhuman political machine attempted to ring out Donald's passion — his laughter, ingenuity, love of music, and inspiration," Melania said in a statement shared on X. "When I watched that violent bullet strike my husband, Donald, I realized my life, and Barron's life, were on the brink of devastating change," she said, referencing the couple's 18-year-old son. "I am grateful to the brave secret service agents and law enforcement officials who risked their own lives to protect my husband," Melania said.—Agency

Nationwide car sales up 137.9% in June 2024

ISLAMABAD: Sale of cars in Pakistan witnessed an increase of 137.91 per cent in June 2024 compared to the same month of the preceding year (2022-23), a data released by the Pakistan Automobile Manufacturing Association (PAMA) said.

Sale of cars rose to 10,128 units in June 2024 compared from 4,257 units during the same month of the previous year.

Sale of cars during the fiscal year 2023-24 (July-June) however decreased by 15.63 per cent when compared to the sale during the same period of the last year 2022-23.

According to the data, as many as 81,677 cars were sold during the period under review as opposed to 96,811 units in the same period of last year.

The breakup figures disclosed that 11,501 units of



Honda Civic and City were sold as compared to the sale of 12,823 units in last fiscal year (2022-23).

Toyota Corolla and Yaris car sales also declined by 13.44 per cent as it went last year down to 16,305 units from 18,838 units in last year.

Suzuki Swift's sales also decreased by 40.38 per cent as its sales went down to 35,379 units during the year under review, whereas the sales of Suzuki Bolan decreased to 2,774 units as opposed to sales of 4,447 units in last year.—RT/Agency

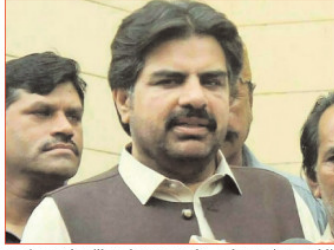

Brain-eating' amoeba claims Karachi youth's life

KARACHI: A 22-year-old youth died of primary amoebic meningoencephalitis (PAM) — a disease of the central nervous system caused by Naegleria fowleri, commonly called 'brain-eating' amoeba, in Karachi, taking the tally to three this year. The 22-year-old Aurangzeb, a resident of Cattle Colony, was under treatment at the Jinnah Postgraduate Medical Centre (JPMC).



The youth had gone for a picnic with friends at a farm house in Quaidabad on July 7, where they swam in the pool. Aurangzeb started showing symptoms on July 8, including fever, headache, and nausea. He was admitted to the hospital on July 10, and the virus was confirmed on July 11.

that's responsible for the disease called Primary Amoebic Meningoencephalitis (PAM). The infection is fatal in 98 per cent of the cases.

He was the third victim of the deadly infection this year in the city, with the other two cases reported in Korangi and Malir. The health department has confirmed that the virus was responsible for the deaths.

A free-living amoeba, Naegleria, is commonly found in warm fresh water (such as lakes, rivers, and hot springs) and soil. Only its one species, Naegleria fowleri, infects people. It infects people when water containing the amoeba enters the body through the nose. This typically happens when people go swimming, diving, or when they put their heads under fresh water, like in lakes and rivers.

The amoeba then travels up the nose to the brain where it destroys the brain tissues and causes the PAM. The first symptoms of PAM usually start about five days after infection that may include headache, fever, nausea, or vomiting. Later symptoms can include stiff neck, confusion, lack of attention to people and surroundings, seizures, hallucinations, and coma. After symptoms start, the disease progresses rapidly and usually causes death within five days. The germ cannot survive in cool, clean and chlorinated water.—RT/Agency

Wahab vows to undertake anti-encroachment operation after Ashura

KARACHI: Karachi was drowned in the past, but we will not allow the city to be drowned, the city's mayor said on Sunday.



Mayor Murtaza Wahab talking to media here said that the city authorities bringing additional water in the city from Hub Dam after 20 years. Criticizing his predecessor Waseem Akhtar, Murtaza Wahab said that he closed running buses in the city. "We are introducing a plan of revival of these buses." Mayor said that the New M.A Jinnah Road has been a six lanes track, two of them are operational while remaining space has been encroached by the make-shift shops, cart vendors or vehi-

cles. "We will launch an operation after Ashura to remove encroachments. We will complete this work if the anti-Karachi card not played over it," he added. It is to be mentioned here that the city is replete with encroaching spaces on public spaces for the past many years. The Supreme Court and the Sindh High Court have issued numerous orders asking the authorities to remove them, but to no avail as the footpaths, pavements, walkways, green belts, parks, grounds, service lanes, streets and roads remain encroached not only by common people or traders but even by law enforcement agencies, government and private organisations.—RT

Intermediate Board's Vigilance Team robbed in Karachi

Karachi: A vigilance and monitoring team — transporting mobile phones seized during exam cheating — was robbed at the gate of the Board of Intermediate Education in Karachi, media reported on Saturday.

According to the sources, the vigilance and monitoring team of intermediate board had confiscated phones being used for cheating at Islamia College. As the team approached the interboard gate, armed robbers intercepted them and took the seized mobile phones. The guards stationed at the gate did not resist the robbers, allowing the theft to occur without confrontation. Former SHCBA Chief: SC Practice Law Ends Trend Of Like-Minded Benches Among CJPs

ISLAMABAD: Commending the Supreme Court Practice and Procedure Act after the reserved seats verdict, the Sindh High Court Bar Association (SHCBA) former president Barrister Salahuddin Ahmed asked the Pakistan Tehreek-e-Insaf (PTI) to review its decision to oppose the law which "ceased trend of chief justices' like-minded benches".

Barrister Salahuddin, while talking to Geo News on Sunday, backed the top court's decision in the case of the reserved seat related to the PTI-backed Sunni Ittehad Council (SIC) and termed it a "good decision" which paved the way for proper allocation of special seats for women and minorities candidates.

"For important matters, larger benches should be formed to get the opinions of the majority of judges," he said.



The senior lawyer was of the view that the Election Commission of Pakistan's (ECP) decision was "beyond the Constitution" for not allocating reserved seats to the PTI-SIC successful candidates in the February 8 nationwide polls.

He was of the view that the ECP did not adopt a constitutional way to fully strip PTI of reserved seats and the top court rectified it.

"It becomes possible after

[the new law] the CJ's powers devolved to three senior judges to form benches," he said and recalled the past where "chief justices used to form benches of their own choice".

The SHCBA former chief said that the SC Practice and Procedure Act "stopped the trend of like-minded benches" and such decisions revolving around "one man". He added that in the like-minded benches, judges usu-

ally endorsed the CJ's decision. He urged that the top court's verdicts should be taken with consultations after taking views from all jurists where chief justices may have faced a minority while issuing verdicts.

Barrister Salahuddin asked the former ruling party should rethink its decision to register opposition to the SC practice law besides celebrating the reserved seats' verdict in its favour.

He also suggested that all political parties should welcome structural reforms which strengthen institutions and devolve powers instead of choosing short-term political benefits.

The senior lawyer expressed his views in a detailed X thread a day ago, saying "In rightful celebration of SC judgment, I wonder if some PTI friends now

reviewing their opposition to SC Practice & Procedure Act & support for CJ's God-given right to form benches."

"Last CJP in minority in a major constitutional case was Nasir-ul-Mulk [who served as the 22nd chief justice from 2014 to 2015] in 21st Amendment case. CJPs are that (esp Saqib Nisar & Bandial) just formed humkhayal [like-minded] benches so they were in minority. Structural reform should not be sacrificed at altar of political expediency," the SHCBA former president said. "Allowing CJPs to dominate the Court through bench/case fixation was a bad idea then and now. Regardless of who is CJP," he wrote, adding "I'm always surprised by how people in power (and their supporters) never ever think about the days they will not.—RT/Agency

PML-N Lawmakers Warn SC Decision Could Lead To Instability

ISLAMABAD: Pakistan Muslim League-Nawaz (PML-N) MNA from Islamabad Anjum Aqeel Khan and MNA from Rawalpindi Raja Qamarul Islam and the party's Divisional President Malik Ibraron Saturday criticized the decision of the Supreme Court on reserved seats.

Addressing separate press conferences in Rawalpindi and Islamabad, they said the decision was apparently an attempt to re-write the constitution could lead to instability in the country.

Addressing a press conference at the National Press Club, MNA Aqeel said "The court gave the PTI what it had not asked for," he said, adding "The entire nation is bearing the brunt of the PTI's four-year rule."

The press conference was in reaction to the Supreme Court of Pakistan's decision on Friday which declared Imran Khan's Pakistan Tehreek-e-Insaf (PTI) eligible for seats reserved for women and minorities, dealing a major setback to Prime Minister Shehbaz Sharif's ruling coalition.

"If an MNA has joined the Sunni Ittehad Council, how can the court declare him a PTI member?" he asked.

"The people were expecting a decision that could bring stability to the country, but unfortunately, it did not



happen," remarked the PML-N MNA.

Mr Aqeel asserted the decision would not cause any trouble for the government, claiming that it would complete its five-year term.

In the garrison city, PML-N local leaders at a press conference at Rawalpindi Press Club, District Coordination Committee Chairman and MNA Raja Qamarul Islam along with PML-N Divisional President Malik Ibraron said it is felt that the focus of the judiciary is on amending the Constitution instead of interpreting the Constitution.

"The legislation is the work of the Parliament and the conduct of elections are the responsibility of the Election Commission. It is not right to interfere with the powers of the Parliament and the Election Commission," MNA Raja Qamarul Islam said. He said that if a certain section of the country is

happy with the decision of the Supreme Court, on the other hand, the nation is also disappointed and surprised.

He said though the PTI was not a part of the petition, it was given a big favour.

"We accepted the decision of the courts but the question still exists in presence of the parliament how can the constitution be re-written through judiciary," he said.

"Amending the constitution is the responsibility of the Parliament, and judiciary can interpret the constitution," he said.

He said that the limits and restrictions of the constitution are more important, a clear example of which is that even if the whole of Pakistan unites, no non-Muslim can be made the president of Pakistan, because under the Constitution, only Muslim can be made president of Pakistan.—RT/Agency

PTI MNA Ameer Sultan 'Abducted' In Lahore By Unknown Individuals

LAHORE/ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) Member of National Assembly (MNA) Ameer Sultan was "abducted" by unknown men in Lahore, a top party leader said Sunday.

Sultan, who was elected to the lower house of the parliament when he won the elections from NA-110 in Jhang, was abducted while he was at his house at Sarwar Road in Punjab's capital, PTI Lahore Secretary General Hafiz Zeeshan claimed.

"Unknown men arrived [at this house] in two vehicles and abducted him last night," the PTI leader said, claiming that after Supreme Court's order on the reserved seats, the party members are "unsafe".

The apex court has ruled that the PTI is eligible for reserved seats, meaning that once the party gets those seats, it will become the largest party in the National Assembly.

In response, SSP Cantt Awais Shafiq told Geo News that neither had the



police arrested the PTI MNA nor did the law enforcers receive any complaint about his alleged abduction.

Zeeshan, when inquired as to why no complaint had been filed so far, told Geo News that the party was drafting the complaint and would submit it to the police station tomorrow (Monday).

In a statement, PTI's top leader Asad Qaiser said he had received information that his party's MNA was abducted, questioning "[how] can a country run where politicians' loyalties are shifted".

"Law of the jungle prevails here; there's no respect for the judiciary.

There's an open opposition to the court's decisions," the former NA speaker said.

Qaiser asked the government whether it would run the country's affairs "by force", but at the same time, he said that his party members would continue their struggle within the parameters of the country's laws. "The time for condemnations is over; it's time to resist," he stated, urging that PTI's MNAs, who have to submit forms showing their party affiliation following SC's order, should be allowed to make their decisions. "MNA Ameer Sultan should be released immediately," he demanded.—RT/Agency

Flour Millers Postpone Strike For 10 Days



LAHORE: The federal government and flour mill owners, in view of the first 10 days of Muharram, have reached an agreement to resume wheat grinding across the country after a three-day pause following assurances extended by the former abut giving a sympathetic view to the latter's demand for abolishing the withholding tax on the supply chain.

The News reported that both sides showed a consensus on the issue on Saturday in a meeting held in Islamabad between a four-member government delegation comprising Federal Minister for Law Azam Nazir Tarar, State Minister for Finance Ali Pervez, Federal Minister for Economic Affairs Ahsan Ishaq Chaudhry and FBR Chairman Amjed Zubair Tiwana and PFMA delegation headed by its Chairman Asim Raza Ahmed along with senior member Farukh Shahzad.

Accordingly, the Pakistan Flour Mills Association (PFMA) and Progressive Flour Millers Group have decided to resume operations from Sunday (today) after observing a strike since July 11.

The decision to discontinue the strike comes after the government negotiation team provided assurances of a positive resolution by July 22, said an office bearer of PFMA.

The delegation's meeting with the committee was seen as a significant step towards resolving the ongoing strike in the flour milling industry.

Earlier on Saturday evening, tandoor owners in the provincial metropolis warned that they were facing a scarcity of flour, which may lead to the closure of their shops in the next two to three days.

"You Are Answerable To God, Not The ISI," Khan Tells Accountability Court Judge

ISLAMABAD: Former prime minister Imran Khan urged on Sunday the accountability court judge to release his wife Bushra Bibi in the new state gifts case against them as his legal battles continue.

Hopes for the release of Khan and Bibi were dashed on Saturday when the national-graft buster arrested them in a state gifts reference hours after a court acquitted both in the unlawful marriage case. Khan is accused of illegally acquiring and selling 74 watches as the prime minister, according to the inquiry report.

The former prime minister has long denied such accusations against him and accused the security establishment of cases against him.

The jail trial notification has been issued under Section 10B of the NAB Ordinance 1999. The notification states that the accountability court may conduct the trial of the accused persons in jail if deemed necessary in view of the law and order situation.

At the outset of the hearing, Khan told accountability court judge Muhammad Ali Warrich that he would walk out if media persons were not allowed in the courtroom. On his insistence, the court ordered re-



porters should be allowed in the courtroom and the hearing started.

"Me and my wife have no link to the Toshakhana," Khan told the judge when the hearing resumed. "I have read the Quran four times in jail and Allah has placed a great responsibility on the judges."

He claimed that his wife was being jailed only to inflict him pain.

"There is no difference between NAB Chairman and prostitutes," Khan said while accusing the anti-graft body's chief of compromising with his conscience.

Without naming the individual, Khan claimed that his wife was being "targeted" by the "king". He said, "I removed him from the post of Inter-Services Intelligence chief and my wife did not make any recommendation for that."

Khan alleged that accountability court judge Mohammad Bashir, who convicted Khan and his spouse Bibi in the Toshakhana case, had made a decision under duress. He also claimed that a former prime minister was informed about a new case at midnight, right before a new case was to be heard in the morning. The PTI founder accused the National Accountability Bureau officials of being "robots" who can be made to do anything by paying them salaries. In a previous reference case where he was convicted, Khan said the jewellery set worth Rs180 million that was in their possession was later shown to be worth over Rs3 billion.—RT/Agency

TLP Faizabad Sit-In Disrupts Daily Life For Twin Cities Residents



Faizabad: Citizens' routine life has been disrupted as faced difficulties due to the sit-in by Tehreek-e-Labbaik (TLP) that is being held at Faizabad — the confluence of the Federal capital Islamabad and Rawalpindi.

Faizabad is considered the main gateway to the capital city of Islamabad. In the past, many parties blocked the road at Faizabad besides holding sit-ins.

The protesters marched from Rawalpindi's Liaquat Bagh to Faizabad to express 'solidarity' with the Palestinians, after which a sit-in was announced. As per reports, the Islamabad administration started negotiations with

the three-member team of protesters. The protesters' demands are not clear.

It is pertinent to note that at least 16 Palestinians have been killed in overnight strikes in Gaza City. It follows an Israeli attack on al-Mawasi in southern Gaza that killed at least 90 Palestinians.

People there have described it as a horrific massacre, with many reported to be still missing under the rubble. Thousands of displaced people were seeking shelter in al-Mawasi, since Israeli forces had designated the area a so-called safe zone. Al Jazeera's Tareq Abu Az-Zumair has the latest from Deir el-Balah in central Gaza.—RT/Agency

Imran Arrested In Jinnah House Attack Case

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan has been arrested in connection with the Jinnah House attack case.

The Investigation Police formally detained Khan at Adiala Jail, where he will be investigated for charges related to incitement against the state.

According to authorities, the PTI founder faces charges in 12 cases, including the May 9 Jinnah House attack.

The police initially sought to transfer him to Lahore for further investigation, but the Rawalpindi court denied the request due to security concerns.

Imran Khan is scheduled to appear before the Anti-



Terrorism Court in Lahore via video link on Monday, where the police are expected to request his transfer for further investigation related to the Jinnah House incident.

In a separate case, the National Accountability Bureau (NAB) arrested

Imran Khan and his wife, Bushra Bibi, in connection with a new reference to the Toshakhana case.

They were granted an eight-day physical remand. The federal government has since issued a directive for their trial to be held at Adiala Jail.—RT/Agency
