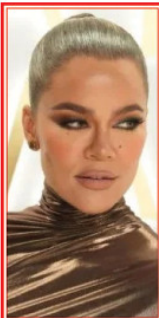

## Petrol hiked by Rs10 per litre

ISLAMABAD: The government has announced another increase in petroleum product prices, adding to the financial strain on the public amid ongoing inflation.

As per the latest notification, the price of petrol has risen by Rs 9.99 per litre, now costing Rs 275.60 per litre. High-speed diesel has also seen a significant hike, increasing by Rs 6.18 per litre, bringing its new price to Rs 283.63 per litre. Additionally, kerosene



prices have gone up by Rs 0.83 per litre. This latest household budgets and price surge is expected to threaten economic stability. —RT/Agency

## PPP Opposes PTI Ban, Urges Political Resolution

LAHORE: General Secretary of the Pakistan People's Party (PPP) Central Punjab, Hasan Murtaza, criticised the decision to impose restrictions on political parties and Article 6 sanctions on PTI leaders, deeming it unjustified.

PPP leader emphasised that political disagreements should not lead to the dissolution of any party and stressed the importance of political entities adhering to democratic norms. Murtaza clarified that Article 6, historically applied to former Generals Musharraf and Zia-ul-Haq but not enforced against political leaders or workers, does not encompass leaders and workers of political parties.

He further stated that im-



posing restrictions cannot eliminate any political party, advocating instead for dialogue as the primary solution to national issues.

Just days after the Supreme Court resurrected PTI, the PML-N-led ruling coalition decided on Monday that a reference will be sent to the top court seeking a ban on PTI, adding that the government will also initiate Article 6 (high treason) proceedings against ex-PM Imran Khan, ex-President Dr Arif Alvi and ex-deputy

# Government To Ban PTI, File Treason Charges Against Imran Khan And Arif Alvi: Atta Tarar

ISLAMABAD: Upping the ante against the Pakistan Tehreek-e-Insaf (PTI), the federal government has decided to ban the former ruling party as well as file references against PTI founder Imran Khan and former president Arif Alvi for treason under Article 6.

"PTI and Pakistan cannot co-exist," Tarar told a press conference in Islamabad, saying that the matter would go to the federal cabinet and the Supreme Court.

The decisions, as per Tarar, were taken in light of the former ruling party's involvement in the May 9 events and the PTI's former or current leaders' attempts to sabotage Pakistan's deal with the International Monetary Fund (IMF).

The development comes following PTI Vice Chairman Shah Mahmood Qureshi's indictment in cases related to the May 9 riots and Khan's arrest in cases pertaining to the incidents taking place on the day.

Touching upon the foreign funding issue, the information minister said that the PTI failed to defend itself in the foreign funding case wherein, he claimed, the ex-ruling party received funds from Indian-born United States citizens.



"Why did you [PTI] seek a stay order [in said case] for six years?" he questioned, adding that the Khan-founded party had nothing to say in its defence.

Stressing that whoever provides financial support to a political party, does so with the hopes that the party would serve its interests if it comes to power, Tarar said that the PTI failed to explain and defend itself regarding the funds received by certain lobbyists abroad, including Israeli ones.

Reflecting on the May 9 riots, triggered after Khan's arrest in a graft case wherein party workers and supporters vandalised several military installations, the minister said that the PTI founder targeted national interests for his own personal ones.

"Your whole family was involved in those attacks. Your three sisters were pres-

ent to the Supreme Court after the cabinet's approval. Referring to what is known as the cipher case, Tarar said that the PTI founder and his party "played" with the diplomatic cable and used it to create a false narrative around it.

"Our ambassador in US Asad Majeed said that there was no threat [but you] [PTI] still maintained that it was otherwise," he said, adding that the party damaged the country's relations with other countries for its own interests.

Lambasting the former ruling party, Tarar said that a perception has been made that the party is "untouchable" despite its leaders being involved in May 9 cases, iddat case or £190 million case.

"He [Khan] was the worst fascist leader. He inherited the pattern of putting mothers and sisters to jail," said the Pakistan Muslim League-Nawaz (PML-N) leader.

The information minister, speaking about mending ties with the PTI, said that the government's patience and tolerance were considered its weakness.

"No more," said Tarar. "Enough is enough. They have played with the country's fate too much," he added. —RT/Agency

## PML-N Split Over PTI Ban Decision



ISLAMABAD: Pakistan Muslim League (PML-N) is reportedly divided over the federal government's decision to ban Pakistan Tehreek-e-Insaf (PTI), media reported citing sources.

According to an inside story of the party's meeting revealed by sources, the PML-N leadership has differing opinions on the matter, with some leaders expressing reservations over the government's political strategy.

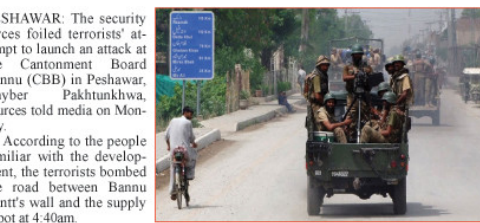
The party's meeting, which was scheduled to discuss the ban on PTI, was postponed due to internal disagreements.

A senior party leader told sources that they were not invited to the meeting because they would have expressed opposing views, which could have led to disagreements.

Another leader said that they are against ban on any political party being banned, but will stand with the party's decision.

It is pertinent to mention here that the federal government has decided to ban Pakistan Tehreek-e-Insaf (PTI). Federal Information Minister Ata Tarar said in a presser that Article 17 of the constitution empowers the federal government to ban a political party. He said there is credible evidence to support a ban on the PTI and cited the party's involvement in foreign funding, the May 9 incident, its role in the resettlement of terrorists in Pakistan, the cipher episode, and the resolution passed in the United States. —RT/Agency

## Terrorism Attempt Foiled At Bannu Cantt



PESHAWAR: The security forces foiled terrorists' attempt to launch an attack at the Cantonment Board Bannu (CBB) in Peshawar, Khyber Pakhtunkhwa, sources told media on Monday.

According to the people familiar with the development, the terrorists bombed the road between Bannu Cantt's wall and the supply depot at 4:40am.

The terrorists, who were inside a vehicle, detonated an improvised explosive device (IED). The police said that those who sustained injuries were brought to the district headquarters hospital.

The sources revealed that the terrorists tried entering the Cantt but the security forces foiled their attempt by taking timely action and cornered the militants.

They added that the security forces began a clearance operation in the area following the attack.

The incident comes as violence and casualty rates

across the country plummeted in the second quarter of 2024, according to the Centre for Research and Security Studies (CRSS) Annual Security report.

As per the report, the country experienced a 12% reduction in overall violence, with 380 fatalities recorded compared to 432 in the first quarter of this year.

During the second quarter of 2024, Pakistan witnessed 380 violence-linked fatalities and 220 injuries among civilians, security personnel, and outlaws, resulting from as many as 240 incidents of terrorism attacks and counter-terrorism operations.

This includes 236 fatalities among civilians and security forces personnel, the report said.

KP and Balochistan provinces — both bordering Afghanistan — were the epicenters of violence, accounting for nearly 92% of all fatalities and 87% of attacks (including incidents of terrorism and security forces operations) during this period.

Individually, KP suffered 67% of all fatalities in Q2, 2024. —RT/Agency

## PTI Founder, Alvi, And Suri To Face Article 6 Charges

ISLAMABAD: Pakistan's government has decided to file a reference before a Supreme Court to try former prime minister and PTI founder Imran Khan, former president, Arif Alvi and former deputy speaker NA, Qasim Suri under Article 6.

Information Minister Attaullah Tarar announced this in a press conference on Monday. The reference will be forwarded to Supreme Court after approval from the federal cabinet, he added.

The minister said the country had been toyed with a lot and if there has to be any development in the country, Pakistan and the PTI could not co-exist.

The minister further said the government believed that under Article 17 of the Constitution, it was empowered to ban political parties, adding that looking at the



"evidence", the PTI should be banned. "They tried to sabotage the IMF deal," he alleged.

The Information Minister said the government and its allied parties have also decided to file a review petition against Supreme Court's judgment in the reserved seats case.

He emphasized that the judgment has legal lacunae and that they have strong

legal grounds to file the review. He pointed out that the PTI had not sought relief in the case.

The Information Minister said the government will complete all these processes while remaining within the domain of law and constitution. He said these matters will be taken forward so that in future nobody could dare to violate the constitution, hurt the national interests and attack the defense institutions. —RT/Agency

## PTI Calls Government's Ban Attempt Desperate And Illegal

ISLAMABAD: The Pakistan Tehreek-e-Insaf (PTI) said on Monday that the federal government was attempting to ban the party "out of desperation" as the Supreme Court had ruled in its favour in the reserved seats case. Speaking to Geo News, senior PTI leader Senator Ali Zafar said his party would not allow the decision's implementation "even for a second" as it is against the law of the land. Zafar's comments came in response to Information Minister Attaullah Tarar's announcement that the government had decided to ban the PTI and file treason references against the party founder Imran Khan and former president Arif Alvi. "As far as their announcement of banning PTI is concerned, I believe that they live in a world which exists outside



the law. There's no provision in the law that allows the government to resort to such a move." The senator further said: "This statement itself disqualifies him [Tarar], and even if they think about such an impossible thing, then the courts are present and so are we. We will not allow such a decision to be implemented even for a second." Taking a jibe at the information minister, Zafar said he thinks the minister spoke out of "desperation" after the reserved seat's judgement. "This is an illegal decision" Article 6, review plea. The decision to not only ban the party, but file treason cases against the leaders was based on a number of factors, including the proven charge that Khan's PTI had received foreign funds from sources that are illegal in Pakistan, as well as rioting by the party's leadership and supporters last year that targeted military installations, Minister Tarar said. —RT/Agency

## Government Lacks Authority To Ban Any Political Party: Shahid Khaqan

ISLAMABAD: Former prime minister Shahid Khaqan Abbasi has said that the government has no mandate to impose ban on a political party, media reported on Monday.

Convener Awam Pakistan Party (APP), talking to media said that if the Article six invoked against anyone than those in government today could also face it.

He was commenting on the government's decision to ban the opposition's Pakistan Tehreek-e-Insaf (PTI).

"This is the time to unify the country, are you want more grouping and chaos," he questioned.

"An year and two months have passed to the May 9 incidents, the government didn't prosecute," he said. "Three days after the supreme court's decision on



reserved seats, the government has started talking about ban on a political party," he said. "These decisions of courts boost democracy. The government's holding press conferences and criticism has not been appropriate," Abbasi said.

"What impression you want to give, confrontation among institutions," former PM questioned. "Are you want more chaos," he asked. "You were happy when these judges were giving decisions in your favour," he remarked. —RT/Agency

## Non-Bailable Arrest Warrants Issued For PTI MNA Sher Afzal Marwat

ISLAMABAD: A local court on Monday issued non-bailable arrest warrants for Pakistan Tehreek-e-Insaf (PTI) leader Sher Afzal Marwat in a case pertaining to his alleged involvement in illegal construction.

A case was lodged in Naseerabad Police Station against Marwat, wherein he was accused of illegal construction on a piece of land near the Thallian Motorway Interchange, without obtaining permission from the authorities.

The judicial magistrate directed the police to arrest the MNA and produce him before the court on July 30.

The order comes after the former ruling party accused the government of using various tactics to coerce PTI leaders to change their allegiance after the Supreme Court verdict pertaining to



the reserved seats. PTI Chairman Gohar Khan said on Saturday his party had prepared a list of MNAs, including Marwat, in compliance with the apex court verdict.

Talking to journalists in Adiala jail, he had said they would submit the lists to the Election Commission of Pakistan within 15 days.

Seeking the top court's intervention to resolve the matter, Gohar claimed on Sun-

day that lawmakers of his party were being forced to switch their loyalties. He condemned the "abduction" of PTI leaders and their family members — including MNA Sahibzada Ameer Sultan, PTI media wing member Rizwan Malik, Mian Fayyaz Ahmad Chajra's son Mian Tajamal Hussain and brother Mian Intiaz Hussain and other social media activists. —RT/Agency

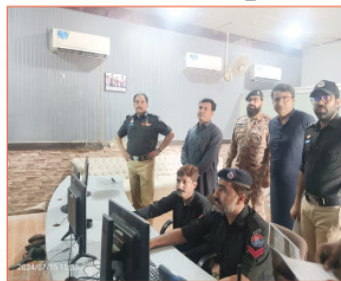

Maryam Nawaz said the Punjab government was dedicated to providing resources of vocational training to youth.

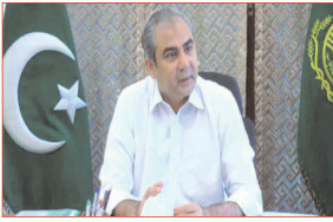
Punjab CM highlighted the importance of information and communication Technology (ICT) roles in the global job market.

## Mohsin Naqvi's senate membership challenged in IHC



ISLAMABAD: A petition has been filed in Islamabad High Court (IHC) challenging the senate membership of Federal Interior Minister Mohsin Naqvi, media reported.

As per details, the petition, filed by citizen Muhammad Fahad Shabbir through Advocate Nadeem Sarwar, names the Law Ministry, Election Commission of Pakistan (ECP), Pakistan Cricket Board (PCB), and Mohsin Naqvi as respondents.

The petitioner argues that according to Article 7 of the PCB constitution, the chairman of Pakistan Cricket Board PCB is an office of profit, and therefore, he is not eligible to be a member of parliament under Article 63(D) of the constitution.

The petition also cited other sub-clauses of Article 63, stating that Naqvi does not meet the eligibility criteria to be a member of parliament.

The petitioner urged the court to restrain Naqvi as a senator and to declare his senate membership null and void.

It is pertinent to mention here that the former caretaker chief minister of Punjab Mohsin Naqvi is currently serving as the chairman of Pakistan Cricket Board PCB, Federal Interior Minister and Member of senate.—RT/Agency

## Ministry of Foreign Affairs introduces apostille attestation service thru courier companies

In a bid to facilitate applicants seeking apostille attestation, the Ministry of Foreign Affairs, Islamabad, and its liaison offices in Karachi and Lahore have collaborated with courier companies to provide document attestation services.

As part of this initiative, designated courier companies will collect documents from applicants, which will then be attested by the Ministry of Foreign Affairs.

The courier companies authorized to collect documents for apostille attestation in Islamabad, Lahore, and Karachi include TCS, M&P, Gerry's, Leopard, and ECS.

According to a Foreign Office statement, the courier companies are authorized to accept all documents except Power of Attorney.

Earlier, the Ministry of Foreign Affairs has eased the apostille legalisation services by listing five courier companies for the delivery of documents.

This new initiative aims to facilitate applicants by allowing them to submit their documents through courier companies, including Gerry's International, Leopards Courier Service, Excellent Courier Services, M&P Express Logistics, and TCS. "The service charges and delivery rates for these courier services have been standardised and are now available in a comprehensive table," it said in a post on X.—RT/Agency



PTI submits affidavits confirming party affiliations of 25 MNAs to ECP

ISLAMABAD: The Pakistan Tehreek-e-Insaf (PTI) has submitted affidavits to the Election Commission of Pakistan (ECP) confirming the party affiliations of 25 out of 41 Members of the National Assembly (MNAs). PTI's party chief, Barrister Gohar Ali Khan, stated that the affidavits of 7 more MNAs will be submitted shortly. This development comes in response to a landmark Supreme Court verdict in the reserved seats case. The Supreme Court had directed the ECP to seek confirmations from the 41 PTI MNAs regarding their party memberships. The court's order clarified that out of the 80 returned candidates (now MNAs), 39 were shown as PTI members in the ECP's records. The remaining 41 were shown as independents. The court ruled that the 39 PTI-affiliated MNAs had secured their seats on behalf of the PTI, for the purposes of Article 51 provisions. This verdict represents a win for the PTI party, as it has been declared eligible for the reserved seats based on the confirmed party affiliations of its MNAs. "In the peculiar facts and circumstances of the general election of 2024, it is further ordered that any of the remaining 41 returned candidates out of the aforesaid 80—may, within 15 working days of this order file a statement duly signed and notarised stating that he or she contested the general election as a candidate of the political party specified therein," the order read.—RT/Agency



## Two sanitary workers die while cleaning Faisalabad manhole

FAISALABAD: In a tragic incident, two sanitary workers lost their lives while cleaning a manhole in Faisalabad, media reported.

As per details, one of the deceased workers identified as Shakeel was an employee of Municipal Corporation.

The second death was reported when the man went to save the TMA personnel, also fell into the manhole.

Earlier, three sanitary workers lost their lives while cleaning a manhole in Bhawal area of Sargodha.

The deceased workers were identified as Irfan Masih, Ratan Masih, and Babar Masih. Another worker was reportedly in critical condition and shifted to the District Headquarters Hospital (DHH) for treatment. In a similar incident earlier, two sanitary workers died while cleaning a manhole in Sargodha's Lari Adda area.

Three sanitary workers fell into a manhole while cleaning the manhole in Lari Adda area of Sargodha, Punjab. Two labourers died on the spot due to toxic gas in the manhole, while the third one was retrieved by the rescue sources team.—RT/Agency

## Cement dealers go on nationwide strike



LAHORE: Cement dealers in Pakistan begin their countrywide strike for an indefinite period against higher withholding tax on cement in the federal budget 2024-25, media reported on Monday.

The government has increased the withholding tax to 2.5 percent for non-filers under Section 236H of the Finance Act 2024 which has made the cement business unsustainable given the current market conditions besides the new turnover taxes imposed on dealers and retailers.

All Pakistan Cement Dealers Chairman Sajid Chaudhry highlighted concerns that taxes and PoS measures have badly distributed their business.

He criticized the requirement for Point of Sale machines, arguing that such demands are impractical for many dealers and retailers, who lack the necessary resources and education. The association

urged the government to intervene, suggesting a presumptive tax regime as a solution. They warned that failure to address these issues could force many businesses to shut down, worsen unemployment, and hurt the economy. The federal government in budget 2024-25 has also imposed a higher FED on cement to Rs4 per kg compared to Rs2 in the previous fiscal year. Meanwhile, the exports of cement witnessed an increase of 40.46 percent during the first eleven months of the financial year 2023-24, as against the exports of the corresponding months of last year.

The cement exports from the country were recorded at US \$236.797 million during July-May (2023-24) against US \$168.583 million during July-May (2022-23), according to the Pakistan Bureau of Statistics (PBS).—RT/Agency

## The Ban

The government's decision to ban Pakistan's largest political party, the PTI, has sparked widespread concern among civil society, raising critical questions about democracy and constitutional rights. This move, described as "ridiculous" and "desperate" by various legal and political experts, threatens to undermine the very fabric of the nation's democratic principles.

Banning a political party is not only a drastic measure but one that history has shown to be fraught with peril. The dissolution of the National Awami Party during the Bhutto regime serves as a grim reminder of the potential for political instability such actions can unleash. Pakistan's constitution, under Article 17, ensures citizens the right to form political parties, emphasizing that any re-

strictions must be reasonable and justified in the interest of the nation's sovereignty and integrity. The government's reliance on this article to justify



its actions against PTI raises significant legal and ethical questions.

Legal experts, such as Barrister Asad Rahim, argue that banning PTI would equate to silencing the voice of a substantial portion of the electorate, effectively disenfranchising millions. The lessons from Pakistan's political history underscore the dangers of using bans and legal proceedings as tools of political retribution. The government's actions must be scrutinized not only for their immediate impact but also for their long-term implications on the nation's democratic health. As Pakistan navigates this contentious issue, it is imperative that all stakeholders prioritize democratic norms, legal integrity, and the will of the people.

## Maulana Muhammad Ilyas Attari Qadri stresses need for following the message of Karbala

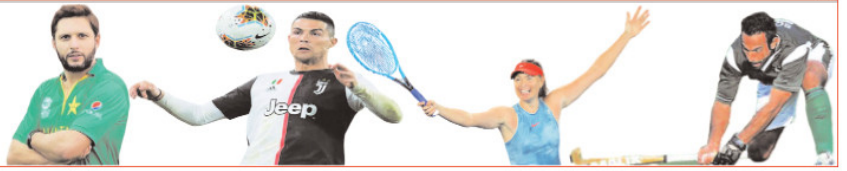

## Lionel Messi becomes football's most decorated player



Argentina's star player Lionel Messi has secured his legacy as one of the greatest footballers of all time with his national team's latest victory in the Copa America final, after defeating Colombia 1-0.

The win marked Messi, 37, and his team's second Copa America triumph and his historic 45th trophy with both club and country, surpassing the record previously held by Brazil's Dani Alves, India Today reported.

This feat highlights Messi's remarkable journey to become the most decorated player in football history.

How many trophies does Messi have?

Once criticised for his lack of international stardom, the Argentina captain has now won four major trophies with Argentina in just three years, including one World Cup, two Copa Americas, and a Finalissima from 2021 to 2024.

The former Barcelona star has also won four Champions League titles and 10 La Liga championships.

Individually, Messi has clinched a record eight Ballon d'Or awards and six European Golden Boots.

Out of Messi's 45 titles, 39 have been achieved during his 17-year tenure with Barcelona. His accolades include 12 league titles (10 with Barcelona, two with PSG), four UEFA Champions League (all with Barcelona), and 17 domestic cups (15 with Barcelona, one each with PSG and Inter Miami).

Additionally, he has won the UEFA Super Cup three times and the FIFA Club World Cup three times.

With Argentina, Messi's victories include the 2005 U-17 World Cup, the 2008 Olympic Games, the 2021 Copa America, the 2021 Finalissima, and most memorably, the 2022 World Cup, where Argentina triumphed over France in the final.—Agency

## Argentina beat Colombia to win second consecutive Copa America title

Defending champions Argentina won a record 16th Copa America title by beating Colombia 1-0, thanks to a late extra-time goal from substitute Lautaro Martinez after an end-to-end contest at the Hard Rock Stadium in Florida on Sunday.

Inter Milan striker Martinez, the tournament's leading goalscorer, latched onto a precise through ball from Giovanni Lo Celso before lifting his effort over advancing Colombia goalkeeper Camilo Vargas in the 112th minute, Reuters reported.

Argentina's latest title comes on the back of their triumphs at the 2022 World Cup and 2021 Copa America.



The game was delayed by more than an hour after thousands of unruly fans without tickets, breaching security gates two hours before the game.

With this win, Argentina marks its third major international crown they earned in a three-year span, after winning the Qatar World Cup in 2022 and the Copa America title in 2021.

Argentina's best player, Messi, 37, suffered a knee injury in the 64th minute of the game when he tried to run but fell to the pitch, and immediately signaled for trainers.

Messi's right cleat and captain band was removed, and he slowly limped to the Argentine bench before bursting into tears.

His right foot was visibly swollen after sustaining an ankle injury.

Colombia was unable to extend its 28-game unbeaten streak. They've lost their last two matches against Argentina.—Agency

## PCB goes back to 'old model' of one-year central contracts, no pay cuts

LAHORE: The Pakistan Cricket Board (PCB) Monday announced going back to its old model of granting a one-year central contract to the national side's players, conditional to their performance.

Among several decisions taken during a meeting of the board's top brass, the officials decided against cutting the salaries of the players, who are under fire after their dismal T20 World Cup 2024.

The monthly salaries of the players and their income were under discussion after the Pakistani side failed to live up to the fans' expectations and crashed out of the tournament before even entering the Super 8 stage.

In a statement, the board said: "The central contract's tenure will be of a year. The players' performance and fitness will be reviewed every



per month.

Meanwhile, Shadab Khan, Fakhar Zaman, Haris Rauf, and Naseem Shah are paid Rs3 million per month in Category B.

Category C players are paid between Rs750,000 to Rs1.5 million per month and include players such as Imad Wasim.

Meanwhile, Category D players are also paid the same as Category C and include players with the likes of Iftikhar Ahmed, Hasan Ali, Saim Ayub and others.

It is to be noted that the aforesaid figures reflect only the monthly salaries of the players who also earn match fees and win bonuses across all three formats (Test, ODI, T20I) along with sponsorship perks.

The existing three-year central contracts were awarded last year and came into effect from July 1, 2023, after the then-PCB chairman Zaka Ashraf was pressurised by players for increased remunerations, sources had told Geo News.

NOCs and 'grouping'

The statement further added that a technical process for issuing non-objection certificates (NOC) to the players would be worked out and those who would fulfil the requirements would be granted the NOC.—Agency

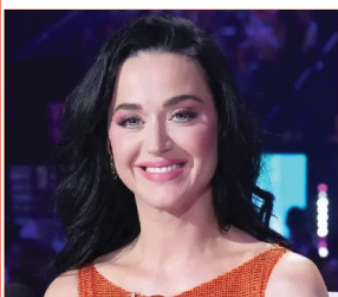

He vowed that justice would continue if the Steel Town police did not register a case against the SHO and his team. After Muharram, we will resume our protests in Sindh against police excesses, he declared. The family has filed a petition under Section 22-A in the Malir court, seeking to lodge an FIR for murder against the SHO and the police team. 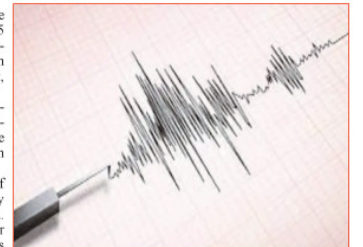

## Civil society slams PTI ban, treason reference against Imran and Arif Alvi

KARACHI: The federal government has announced that it plans to ban Pakistan Tehreek-e-Insaf (PTI) in its bid to intensify measures against the former ruling party.

Information Minister Attaullah Tarar made the announcement during a press conference in Islamabad where he also revealed the government's plans to file references against PTI founder Imran Khan and former president Arif Alvi for treason under Article 6.

The decision was based on a number of factors including the proven charge that Khan's PTI had received foreign funds from sources that are illegal in Pakistan, as well as the party's involvement in May 9 riots.

Analysts and experts have also given their take on the ban on PTI.

'Not an unprecedented measure' Reacting to the government's decision to ban PTI, veteran journalist Hamid Mir said that it was "not an unprecedented measure."

Mir said: "Several government ministers have previously signalled that PTI and Pakistan can't work together and they have dis-



cussed a ban as well. "This discussion began when Shehbaz Sharif became PM in 2022, and talks over this were intensified especially after May 9."

He said that previously, the government believed that if a reference were to be filed against PTI, it would have been difficult with PTI leader Arif Alvi serving as president at the time and the reference would not be forwarded.

However, with Alvi no more serving as president, this decision to ban PTI seems to have been taken yesterday during a meeting led by former PM Nawaz Sharif.

'Desperate move' Anchorperson Shahzeb Khanzada said the government's announcing to ban the

PTI, just two days after the Supreme Court ruling that declared the former ruling party a parliamentary party, was a desperate move.

He said 11 out of 13 judges of the apex court, including the chief justice, had recognised the PTI as a parliamentary party.

"Are you responding to the PTI (through this move) or the SC. If you are responding to the SC then you are responding to the current chief justice, the next CJ and the CJ after that as well," he said.

The journalist said the government would itself have to approach the top court for implementation of the government decision, as it has already announced.—RT/Agency

## Karachi's BRT Green, Orange lines suspended



KARACHI: In order to ensure security, Karachi's Green and Orange lines will remain suspended during 9 and 10 Muharram, media reported on Monday.

As per the announcement, both BRTs will resume services from July 18.

Meanwhile, Peoples Bus Service also announced the suspension of its operations on specific routes during 9 and 10 Muharram.

A day earlier, the city's traffic police issued a traffic management plan for processions on the 8th, 9th and 10th of Muharram.

According to the traffic plan issued, on 8th Muharram, a procession will start from Nishtar Park and end at Hussainian Iranian Imambargah in Kharadar.

Muhammad Ali (MA) Jinnah Road will remain closed from Gurumandir to Tower due to security concerns.

## K-Electric apprises SHC about Karachi load shedding

KARACHI: K-Electric submitted its reply in the Sindh High Court (SHC) on Monday over loadshedding during the "heatwave" in Karachi, media reported.

The court hearing a petition of Jamaat-e-Islami with regard to the loadshedding and unannounced power outages in Karachi during the heatwave by the city's sole power utility.

The K-Electric in its reply said that technical faults could not be counted in loadshedding. The power utility repeated its claim that 70 pct feeders of Karachi have been exempted from loadshedding.

"The power supply affected at 30 pct feeders over action against power theft," the company claimed.

The KE in its reply further claimed that loadshedding did not happen from June 24 to 27 from 1:30 to 4:30.

"K-Electric also arranged relief camps in



different areas during loadshedding," the company said.

"A plan for increasing power generation has been submitted to the NEPRA," the power company stated.

"Under the plan 95% feeders will be free from power outages and loadshedding by 2029-30," the reply read.

The court summoned arguments over the reply of the company and adjourned further hearing of the case until August 15.

The petitioner had pleaded to the court to di-

rect the K-Electric to ensure an uninterrupted power supply especially during the heatwave.

"K-Electric's claim of 71% power feeders as loadshedding free in the city has been wrong," JI petition has read. "Technical faults are also the responsibility of the power supplier, which required to be addressed."

"The city has been undergoing average 16 hours loadshedding daily," The Ministry of Energy, NEPRA and K-Electric have been made respondents in the petition.—RT/Agency

## SC Cannot Amend Constitution, Only Parliament Can: Rana Sanaulah On Reserved Seats Verdict

ISLAMABAD: Commenting on the recent Supreme Court's verdict on reserved seats' case, Prime Minister's Adviser on Political and Public Affairs Rana Sanaulah has said that the ruling does not match the clear orders written in the Constitution for independent candidates who are willing to join political parties.

The senior leader of the ruling Pakistan Muslim League-Nawaz (PML-N) criticised the top court's verdict for which he claimed that it violated Article 51 and relevant clauses which clearly bound independent candidates to join political parties within three days after elections.

Sanaulah was talking to Geo News programme Naya Pakistan on Sunday in which he emphasised that the Constitution provides clear instructions for dealing with independent candidates and the allocation of re-



served seats among political parties without any vagueness. While expressing his views, the senior politician claimed that the top court's bench mentioned in their joint judgement that the independent candidates would be given 15 days to join political parties, which went above the Constitution. He also criticised the ruling for granting two more weeks to process the independent candidates' affilia-

tions to their desired political parties. The PM's aide also censured that the verdict would be tantamount to "opening the front gate for horse-trading". "The judiciary cannot alter the Constitutions, but parliament can," he added. In a major legal victory for the Imran Khan-founded Pakistan Tehreek-e-Insaf (PTI), the Supreme Court on Friday ruled that the party is eligible for the allocation

of reserved seats". The decision has not only paved the way for the PTI's return to parliament, which was kicked out of the February 8 polls owing to the ECP's December 2023 ruling, but has also increased the pressure on the coalition alliance by changing the composition of the National Assembly.

Regarding the incarcerated PTI founder's arrest in new cases, Sanaulah said that Imran Khan would do nothing but spread anarchy and political chaos in the country after coming out of jail. He added that it would be better not to release the former prime minister to bring political and economic stability to the country.

Sanaulah also blamed the PTI for organising the May 9, 2023 riots and running a campaign against the heads of the defence institutions. He said that the prosecution had an equal right to pursue trials like the former premier possessed the right to defend himself. The lawyer-cum-politician said that no one had stopped the PTI founder from knocking on the doors of the courts against his arrest. Khan and his wife Bushra Bibi were arrested in a new NAB reference related to Toshakhana gifts yesterday soon after getting acquitted in the iddat case — also known as the un-Islamic nikah case — which was the last hurdle in the couple's release from jail. The couple was sentenced to seven years in prison and awarded a fine of Rs500,000 each, in February this year after a trial court found their nikah to be fraudulent as Khawar Maneka, Bushra's ex-husband, moved the court against the couple's marriage. —RT/Agency

## PTI MPs Being Coerced To Defect: Gohar

ISLAMABAD: Seeking the Supreme Court's intervention to resolve the matter, Pakistan Tehreek-e-Insaf (PTI) Chairman Gohar Ali Khan said Sunday parliamentary members of his party were being forced to switch their loyalties, media reported.

Talking to media, Gohar condemned the "abduction" of PTI officials and their family members — including MNA Sahibzada Ameer Sultan, PTI media wing member Rizwan Malik, Mian Fayyaz Ahmad Chajra's son Mian Tajamal Hussain and brother Mian Imtiaz Hussain and other social media activists.

On this occasion, the PTI chairman was flanked by PTI Information Secretary Raaf Hasan, MNAs Atif Khan and Sheikh Waqas. The PTI leadership urged the top court to ensure implementation of its historic judgement pertaining to the reserved seats, taking notice of the harassment and abduction of PTI parliamentary members and their relatives.

The PTI chief slammed the government for re-arresting PTI supporter Sanam Javed and the party founder's spouse Bushra Bibi, demanding their immediate release.

## PML-N Seeks Review Of SC's Reserved Seats Ruling

ISLAMABAD: The Pakistan Muslim League-Nawaz (PML-N) on Monday filed a review petition in the Supreme Court against reserved seats verdict that declared the Pakistan Tehreek-e-Insaf (PTI) eligible for the reserved seats for minorities and women.

The ruling party has nominated 11 respondents in the plea including the Sunni Ittehad Council (SIC) and its chairman Hamid Raza, praying the court to suspend its ruling dated July 12, 2024, on the reserved seats.

The petitioner claimed the apex court's verdict was silent on some points. The review petition asked a number of questions including whether the SIC should be granted the reserved seats.

It questioned if reserved seats could be granted to a political party who had not submitted a party list within the prescribed time, whether a political party can be given reserved seats whose candidates have not even filed nomination papers within the



time provided by the Election Commission of Pakistan and if independents could even join a political party which did not win a single general seat in parliament.

The plea also raised question if the seats could be left vacant or have to be distributed amongst the political parties contesting for the said seats.

The petition has been filed in response the apex court ruling last week, that declared the PTI eligible for the allocation of reserved seats.

He added, "It would have been better if they had given us the two-year sentences we deserve, which we would have served."

Rashid also criticized the impending increase in electricity rates, warning that the country is on the brink of chaos, stating, "You want to create such turmoil that it becomes unmanageable. This is



not the job of politicians. The poor are suffering immensely. The country is heading towards a state similar to Kenya. Conditions in Khyber Pakhtunkhwa and Balochistan are dire. People are cursing this government. For God's sake, save your honour and the country."

He further commented on the current administration's inability to stabilize the economy, predicting that Nawaz Sharif would introduce a new narrative, leaving the public humiliated. Questioning the release of

Imran Khan, Rashid stated, "They keep saying he's coming, but he isn't. One grave and three bodies: Nawaz, Shehbaz, their fate will soon be decided. One will flee to the East, the other to the West."

Rashid concluded by praising the judiciary for their historic decision on reserved seats, acknowledging their significant role in saving the country. "I salute the judiciary for their historic decision and their crucial role in saving the nation," stated Rashid. —RT/Agency

## Shah Mahmood Indicted In May 9 Case By Anti-Terrorism Court

LAHORE: An anti-terrorism court on Monday indicted Pakistan Tehreek-e-Insaf (PTI) top leader Shah Mahmood Qureshi in a May 9 riots case.

Qureshi, who was brought to Kot Lakhpat jail from Adiala jail under tight security, has several cases related to May 9 including arman filed against him at the Shadman police station.

The court had summoned the PTI leader to initiate indictment proceedings against him.

The court has ordered to present witnesses in the next hearing, which is scheduled to take place on July 22.

The former foreign minister, currently imprisoned in Rawalpindi's Adiala jail on multiple charges, was indicted in eight more cases related to the May 9 unrest earlier this year.

In addition to those case,



a special court established under the Official Secrets Act had handed Qureshi 10 years imprisonment in the cipher case.

However, the Islamabad High Court (IHC) in June nullified Qureshi's conviction in the cipher case registered under the Official Secrets Act.

The May 9 riots were triggered almost across the country after the deposed prime minister Imran Khan's arrest in the £190 million set-

tlement case. Hundreds of PTI workers and senior leaders were put behind the bars for their involvement in violence and attacks on military installations last year.

During the protests, the mercenaries targeted the civil and military installations including — the Jinnah House and General Headquarters (GHQ) in Rawalpindi. The military termed May 9 "Black Day" and decided to try the protesters under the Army Act. —RT/Agency

## Democracy Or Civil Martial Law? PTI Urges Clarity From Government Allies On Ban Plan

ISLAMABAD: The PTI, without naming the PML-N, demanded invoking Article 6 of the Constitution against those who undertook the unconstitutional steps despite the fact that there is a Constitution in the country, calling on allies of the ruling coalition government to clear their position on plan to ban the former ruling party.

Addressing a press conference in Islamabad on Monday, the party leadership also condemned the federal government's decision to ban the Imran Khan-founded party. Earlier today, the federal government decided to impose a ban on the former ruling party after filing references against ex-prime minister Imran Khan and former president Arif Alvi for treason under Article 6.

The senior party leader said at least 30 million people voted in favour of the PTI and Imran Khan in the February 8 elections — the combined of which all other political parties could not grab.

Criticising the incumbent government over its budget, Ayub said the country is facing increased inflation based on the steps the government has taken so far. He added that the price hike is yet to scale more heights as the government has raised power tariffs. "The electricity was at Rs17 per unit under the PTI's government, which has exceeded Rs85 per unit today,"

he claimed, predicting the power tariff would touch Rs100 per unit. "The dollar has been artificially pegged at Rs275, the greenback will surmount to Rs350."

The Supreme Court's 11 judges gave a declaration that the PTI is a political party, he said. Commenting on the government's intention of banning the PTI, the leader of the opposition in the National Assembly claimed that the PML-N high-ups — including Nawaz Sharif, Shehbaz Sharif and Maryam Nawaz — sat together in Murree for three days and came up with what came to be the fore on today (Monday).

"This is the same Nawaz Sharif who tried to become Amirul Momineen," he said.

What Tarar said in today's press conference could be merely his desires, he added.

The PML-N has remained involved in all-out efforts to suppress the judiciary, the PTI stalwart said, adding that the N-League activists blocked roads against verdicts of the judiciary. —RT/Agency

## IHC Stops Transfer Of Activist Sanam Javed To Balochistan Police

ISLAMABAD (Dunya News/Web Desk) - The Islamabad High Court ordered the authorities to prevent activist Sanam Javed from taking out of Islamabad and also ordered them to present her in the court at 5:30 pm.

The High Court also summoned IG Islamabad and DG FIA in person.

The IHC Justice Mian Gul Hasan Aurangzeb heard the petition of Sanam Javed's father for her release. Counsel Mian Ali Ashfaq appeared before the court.

Ali Ashfaq argued that the petitioner's daughter was illegally contained from the lawyer's office. He said that yesterday the magistrate ordered to discharge her from the case.

The court inquired whether the Additional Attorney General was present or not. Advocate General Islamabad appeared before the court on it.

Mian Ali Ashfaq advocate said that yesterday my client was discharged in the 12th

FIR. He said that there are court decisions related to all the cases. He apprised the court that she was arrested on July 13 outside Gujranwala Jail.

The court inquired that the Islamabad police had arrested her. Responding lawyer Ali Ashfaq said that after being discharged from Gujranwala, she was arrested by FIA Islamabad. The court inquired about the current situation? The Advocate General Islamabad was not updated on the arrest of Sanam Javed. —RT/Agency
