'No One Can Dare Ban PTI': CM Gandapur Admonishes PML-N Government

PESHAWAR: After the federal government announced taking adverse actions against the Pakistan Tehreek-e-Insaf (PTI), Khyber Pakhtunkhwa (KP) Chief Minister Ali Amin Gandapur said Tuesday that "no one can dare to ban the PTI which secured highest number of votes" in the February 8 nationwide polls.

PTI-backed CM Gandapur made the statement in a press conference in Peshawar today after the controversial decision of the Pakistan Muslim League-Nawaz (PML-N)-led coalition government to slap a ban on the Imran Khan-founded party opening Pandora's box amid ongoing political crisis.

The chief minister visited Supreme Command Post Kohi Gate in Peshawar along with the Peshawar commissioner, the KP Assembly speaker, CCPO, and others to review security arrangements for Muharram processions. While talking to the journalists, he said that Muharram events were going on peacefully across the province and all provincial departments were working in complete coordination to maintain law and order.

Reacting to the Federal Information Minister Ataullah Tarar announcement to ban the former ruling party, Gandapur slammed the federal government and alleged that the current rulers "stole the mandate" to get into power.

Upping the ante against the embattled PTI, the PML-N-led government decided to ban the former ruling party as well as file references against the top party leaders founder



— Imran Khan, Arif Alvi and Qasim Suri — under Article 6 (high treason) for dissolving the National Assembly in April 2022.

"They are talking about banning a political party [PTI] that secured the highest number of votes," the PTI stalwart said.

Welcoming the Supreme Court's verdict declaring PTI eligible for reserved seats for women and minorities, the chief minister termed it the "victory of PTI's stance" on reserved seats matter.

He demanded Chief Election Commissioner (CEC) Sikander Sultan Raja to step down following the verdict — which overturned the Election Commission of Pakistan (ECP) and the Peshawar High Court's (PHC) rulings to deny reserved seats to the PTI-backed Sunni Ittehad Council (SIC) successful candidates.

To another question, he replied that his party was "not in favour of ad hoc judges' appointments at the top court" and announced that the issue would be taken up in the assembly. He insisted that the appointments of the jurists should be based on merit instead of ad hoc basis.

He said that PTI founder

Imran Khan will decide on initiating political dialogue with the ruling parties.

After the government's decision drew condemnations from PTI political rivals, CM Gandapur termed it a political gimmick, asking the opponents to openly oppose the government's plan to ban the former ruling party.

He added that all parties should come forward with a united stance if they wanted to counter unjust move.

Meanwhile, Deputy Prime Minister and Foreign Minister Senator Ishaq Dar clarified earlier in the day that the decision to impose a ban on the former ruling party has not been taken yet by the federal government.

Dar, while addressing a press conference in Lahore, said that Information Minister Tarar had clearly announced a day ago that the government would deliberate on the ban on the PTI and make a decision after consulting its allies.

The ruling PML-N faced a backlash following the PTI ban announcement which was strongly opposed by its major ally in the coalition government, Pakistan Peoples Party (PPP), and other opposition parties. —RT/Agency

Two Soldiers, Five Civilians Martyred In Terrorist Attack On DI Khan Health Centre

ISLAMABAD: Seven people including two security forces' personnel and five civilians including children were martyred in a terrorist attack on the Rural Health Centre (RHC), Kirri Shamozai area in Dera Ismail Khan district of Khyber Pakhtunkhwa, the Inter-Services Public Relations (ISPR) said on Tuesday. As per the military's media wing, the civilians who lost their lives in the gun attack were the staff of RHC, including two lady health workers and a watchman of the facility, besides the two minors. "On the night between July 15 and 16, the terrorists carried out a cowardly attack on Rural Health Centre (RHC), Kirri Shamozai in Dera Ismail Khan District



and opened indiscriminate fire on RHC staff," the ISPR said in a statement after the incident. "Security forces in vicinity were immediately mobilised for clearance operation in RHC and in ensuing fire exchange, own troops effectively engaged the terrorists as a result of which three terrorists were sent to hell."

Meanwhile, the security

forces personnel who were martyred during the intense exchange of fire were identified as Naib Subedar Muhammad Farooq, 44, and Sepoy Muhammad Javed Iqbal, 23. The military's media wing stated that sanitisation of the area was being carried out to eliminate any other terrorists found in the area. —RT/Agency

Imran And Bushra Bibi Questioned For Four Hours By NAB In Toshakhana Case

ISLAMABAD: The National Accountability Bureau (NAB) grilled Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan and Bushra Bibi for about four hours in Adiala Jail in a new Toshakhana reference.

The anti-graft watchdog team, led by Deputy Director Mohsin Haroon, arrived at the jail at 11 am and left after 3 pm on Sunday.

The interrogation focused on allegations that the accused failed to deposit a Bulgarian set in the Toshakhana, sold the set at a low price, and violated the Toshakhana Procedure of 2018. They were also questioned about alleged abuse of authority, illegal use of



government assets, and selling these assets unlawfully.

The Bureau arrested Khan and Bushra Bibi on Saturday evening and secured an eight-day physical remand on Sunday. Following the completion of this remand, the accused will be presented before the accountability court on July 22. Sources indicate that the investigation aims to uncover the misuse of official positions and misappropriation of state gifts, highlighting ongoing efforts to uphold accountability and transparency in government. —RT/Agency

8 Soldiers Martyred As Security Forces Neutralize 10 Terrorists In Bannu Clash

RAWALPINDI: At least eight Pakistan Army soldiers embraced martyrdom as security forces effectively thwarted a terrorist attack at Bannu Cantonment killing all 10 militants, the Inter-Services Public Relations (ISPR) said in a statement on Tuesday.

The military's media wing said that the terrorists attacked the Bannu Cantonment in the early hours of July 15, but their attempt to enter the facility was effectively thwarted by the security forces personnel.

Following their failure to enter the premises, the militants rammed an explosive-laden vehicle into the perimeter wall of the cantonment, said the ISPR.

The suicide blast, the ISPR said, led to the collapse of a portion of the wall and damaged the adjoining infrastructure, re-



sulting in the martyrdom of eight brave sons of soil.

This timely and effective response by the security forces prevented a major catastrophe, saving precious innocent lives. The gallant and selfless action of the security forces is a testament to their unrelenting resolve in the fight against terrorism," read the statement.

The attack, as per the

necessary measures as deemed appropriate against these threats emanating from Afghanistan.

It is to be noted that Pakistan, back in November 2023, had summoned the head of the Afghan diplomatic mission in Islamabad and demanded the extradition of terrorist Gul Bahadur — the leader of a faction of the outlawed Tehreek-e-Taliban Pakistan (TTP).

Bannu Cantt attack comes as Islamabad time again called on the Afghan Taliban administration in Kabul to prevent its soil from being used by various banned outfits for terrorist attacks against Pakistan.

Last month, the government approved the launching of operation "Azm-e-Istehkam", a renewed national anti-terror drive, in light of the surge in terrorist

attacks in the country in recent months.

The country, during the second quarter of 2024 witnessed 380 violence-linked fatalities and 220 injuries among civilians, security personnel, and outlaws, resulting from as many as 240 incidents of terror attacks and counter-terror operations, said a Security Studies (CRSS) Annual Security report.

This includes 236 fatalities among civilians and security forces personnel, the report said. Khyber Pakhtunkhwa and Balochistan, both of which share borders with neighbouring Afghanistan, have faced the brunt of the terrorist attacks and reported nearly 92% of all fatalities and 87% of attacks — wherein the former suffering 67% and the latter 25% of all fatalities in Q2, 2024. —RT/Agency

Fazl Blames Political Instability On Military Involvement



ISLAMABAD: Jamiat Ulama-e-Islam chief Fazl-e-Rehman has stated that one of the major reasons for instability in the country is the interference of military institutions.

Speaking at the JUI's provincial council session on Tuesday, Fazl said that powerful circles should understand that their interference in politics is detrimental to the country.

He pointed out that the results of the 2018 and 2024 elections have exposed widespread interference by institutions.

The JUI-F leader further stressed that Operation Azm-

e-Istehkam will exacerbate unrest across the country, particularly in Khyber Pakhtunkhwa.

During the council session, discussions were held on the overall national situation, and crucial decisions were made regarding tackling inflation, deteriorating security conditions, and other issues.

Plans were also prepared for upcoming events including a farmers' convention in Mardan on August 10, a traders' convention in Peshawar on August 11, and a peace rally in Lucky Marwat on August 18. —RT/Agency

Four Pakistanis Among Six Fatalities In Shooting Near Mosque In Oman

MUSCAT: At least six people including four Pakistanis and an Indian were killed by gunfire in the vicinity of a mosque in Oman's capital of Muscat, the Omani police said on Tuesday, a rare breach of security in one of the most stable countries in the Middle East.

Police say three gunmen behind attack were also killed as officers conclude "procedures for dealing with shooting".

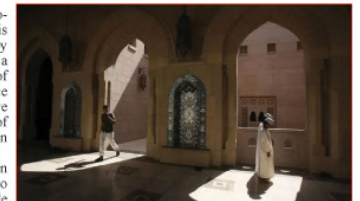
A police officer was among those killed in the gun attack, according to Omani officials.

Pakistan's Ambassador to Oman Imran Ali told The National that at least 50 Pakistani expatriate workers had been injured in the deadly attack, of which 20 were being "treated for bullet wounds in three hospitals in Muscat".

Others with minor injuries had been discharged, he added.

However, the Omani police said that 28 people of "various nationalities" including a security personnel were also wounded.

"The Royal Oman Police have responded to a shooting incident that occurred in the vicinity of a mosque in the Al-Wadi Al-Kabir area," police said in a statement.



They have not said whether they have identified a motive for the attack or if they had made any arrests. The identity of the attackers has also not been released.

The law enforcement officials also said that all security measures have been taken to deal with the situation while procedures are underway for collecting evidence and probing the attack.

According to the Embassy of Pakistan, a terrorist attack took place on July 15 in the Wadi Kabir Muscat area by unknown assailants.

It said that the authorities have cordoned off the area with drone and the surveillance is underway, adding that the operation by the Omani authorities started at 2:30am Muscat time after evacuation.

"Government has put up high alert and emergency at

state level as well as some injured are shifted to nearby hospitals," said the embassy, adding that it established an Emergency Response Centre and teams which are in contact with patients and their families.

It also mentioned that Ambassador of Pakistan in Oman Ali has visited the hospitals and meeting with affected Pakistani families.

Indian embassy in Oman confirmed the death of one of its citizens. In a statement posted on X, the embassy said that the casualties included one Indian national, while another was among the injured.

Meanwhile, US embassy in Muscat said it was following the situation closely.

"US citizens should remain vigilant, monitor local news and heed directions of local authorities," it said in a statement. —RT/Agency

PTI's Sanam Javaid Moved To KP House On Gandapur's Orders

KP: Pakistan Tehreek-e-Insaf (PTI) activist Sanam Javaid has been shifted to Khyber Pakhtunkhwa House in Islamabad on KP Chief Minister Ali Amin Gandapur's orders, the CM's spokesperson confirmed on Tuesday. "KP CM was in touch with Javaid's father and husband," said Focal Person to CM Gandapur on Digital Media Yar Muhammad Khan Niazi, adding that the PTI activist along with her family would remain at the KP House in the federal capital. The spokesperson's remarks come a day after the prominent PTI campaigner got relief in her months-long legal woes after the Islamabad High Court (IHC) on Monday ordered her release and stopped the police and other law enforcement agencies from arresting her. Javaid has faced arrests and re-arrests in multiple cases related to the May 9 riots, triggered after former prime minister and PTI founder Imran Khan's ar-



rest in a graft case, which saw several military installations being vandalised. She has been behind bars for almost a year, embroiled in various cases all linked to the vandalism and unrest triggered by Khan's arrest in May last year. Before a latest case lodged in Balochistan, there were 12 cases registered against her, including the Zaman Park vandalism, the Pakistan Muslim League-Nawaz (PML-N) house fire and a Racecourse Police Station incident. She has been acquitted in a total of four cases counting the latest Federal Investigation Agency (FIA) case, and has acquired bail in the remaining eight cases. —RT/Agency

Mushir Alam Declines To Become Ad Hoc Supreme Court Judge

ISLAMABAD: Justice (ret) Mushir Alam has declined to accept the nomination for his appointment as an ad hoc judge of the Supreme Court.

"After careful deliberation, under present circumstances, it is with a heavy heart that I regret to inform you that I am unable to accept this esteemed appointment," read Justice (ret) Alam's letter addressed to SC Chief Justice and Chairman Judicial Commission Justice Qazi Faez Isa.

The former judge's refusal to accept the said post comes after sources told media that CJP Isa had nominated him along with Justice (ret) Maqbool Baqir Justice (ret) Mazhar Alam Miankhal and Justice (ret) Sardar Tariq Masood for appointment as ad hoc judges due to increasing accumulation of cases.

A retired judge can be appointed ad hoc judge in three years or less and four former judges of the SC



have been proposed to be made ad hoc judges for three years.

The meeting of the Judicial Commission will be held on July 19 at 3pm in the top court's conference room.

Appointment of ad hoc judges is aimed at ensuring more cases are decided than instituted and to reduce, and hopefully eliminate, the cases which are pending adjudge for several years, said the SC notification.

As per the statistics reflected in the bi-annual report of the Law and Justice Commission of Pakistan,

the number of pending cases in the courts surged to 2.26 million during the second half of the year 2023, increasing the overall percentage of cases by 3.9%.

The report revealed that 82% of the pending cases (1.86 million) were at the district judiciary level and the remaining 18% (0.39 million cases) were at the upper tier, including the SC, Federal Shariat Court, and high courts. As per the report, 2.38 million new cases were filed during the period, while the courts managed to decide 2.30 million cases. —RT/Agency

CM Murad Reviews Muharram Arrangements in Sukkur

SUKKUR: The Chief Minister of Sindh, Syed Murad Ali Shah, conducted a comprehensive review of the arrangements for Muharram processions and gatherings during a briefing held at the Mayor's House in Sukkur. This crucial meeting was attended by Commissioner Sukkur Fayaz Hussain Abbasi, DIG Pir Muhammad Shah, and Deputy Commissioner Sukkur Dr. Muhammad Bux Dharejo, who provided detailed updates on the preparations undertaken to ensure the security and comfort of mourners during this significant period.

Shuttle services have also been arranged to assist mourners in reaching the main procession sites, demonstrating the administration's commitment to their convenience and safety.

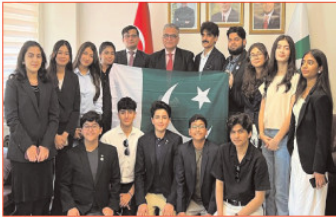
Pakistani Students Win Top Awards in Turkiye's Largest Public Speaking Contest

'Ban Military Interference, Not Political Parties,' Says ANP's Aimal Wali

PESHAWAR: Awami National Party (ANP) President Aimal Wali Khan has voiced his opposition to the government's decision to ban the Pakistan Tehreek-e-Insaf (PTI), despite political and ideological differences.

"We oppose the ban on PTI. Our history shows that we have never supported undemocratic and dictatorial measures," Wali Khan lamented on Tuesday.

He recalled that the precedent for banning political parties in Pakistan was set by military dictator General Ayub Khan, he added that lessons from history are often ignored in the country.

It has emerged the PML-N-led government has not taken all coalition partners on board before announcing a ban on PTI on Monday. Earlier, Central Secretary Information of Pakistan Peoples Party (PPP), Shazia Marri, reacted to the decision to ban Pakistan Tehreek-e-Insaf (PTI), stating that PPP was not taken into confidence regarding this decision, adding that the party will discuss the government's decision internally.

ANP's leader criticised the shifting allegiances to-



wards military leadership depending on political power. "In power, the army chief is treated like a father, but once out of office, the same figure is branded as a traitor," he remarked.

He further highlighted the irony in political slogans, stating, "Respect the vote" is only chanted when out of power, but once in control, that "vote" becomes "boor".

He drew parallels between the current government and PTI's actions between 2018 and 2022. "The game and its reference remain unchanged; only the players have switched sides. Those who benefited from this dirty game yesterday are suffer-

ing today," he commented.

He also noted the cyclical nature of political power in Pakistan.

"Today's beneficiaries will be tomorrow's victims, who will once again raise hollow slogans of revolution and democracy when out of power."

Khan stated, rather ironically, "The military dictator who set the trend of imposing bans now sees his grandson's party facing a ban."

He reiterated that the ANP, valuing democratic traditions, cannot support any ban on political parties. "If a ban is to be imposed, it should be on the military's interference in politics," he concluded.—RT/Agency

According to sources, LESCO has issued the notification to lift the ban on green meters for solar systems.

According to the notification, the temporary installation of bi-directional green meters is permitted until October 15.

The notification said consumers will be given a No Objection Certificate (NOC)

for bi-directional green meters for solar systems.

It is noteworthy to mention that LESCO had ordered the installation of AMI meters instead of green meters starting from July 1, 2024. The notification for AMI meters resulted in a significant price increase. Due to a shortage of stock at meter manufacturing companies, the supply of meters had become impossible, so now the government has lifted the ban on green meters.—RT/Agency

PML-Q Urges Caution on PTI Ban

The Pakistan Muslim League-Quaid (PML-Q) expressed on Tuesday caution regarding the federal government's decision to ban the Pakistan Tehreek-e-Insaf (PTI).

Expressing his thoughts, PML-Q spokesperson Mustafa Malik emphasised that the government should avoid rushing into a ban on the PTI. He stated, "The heart of the country is big, and it must show broad ability and the PTI must also reflect on its behaviour, as the country cannot tolerate extremism."

Malik said: "PML-Q chief Chaudhry Shujaat Hussain's stance on the issue is clear that the government must substantiate the reasons for the ban on the PTI before the Supreme Court."

Rebuking the PTI, he said, "The PTI as a political party and the opposition had not fulfilled its responsibilities."

Malik warned that escalating confrontations could hinder the path to political and economic stability in the country.



On the other hand, JI Emir Hafiz Naemur Rehman on Monday said that the decision to ban the Pakistan Tehreek-e-Insaf (PTI) reflects "fascism."

Reacting to the government's decision to ban the PTI, Rehman said: "There is no room for such decisions in democratic societies. There exist both the constitution and courts in this country."

He took a dig at the government, saying, "Only the political parties with the dictatorial mindset can think this way."

Meanwhile, JI acting emir Liaquat Baloch condemned the government's

decision during a press conference describing it as a "mockery of the constitution, democracy, and the parliamentary system."

He criticised the government for what he termed "negative politics," asserting that a controversial and unrepresentative government has no right to ban any political party.

Baloch emphasised that such undemocratic tactics pose a significant threat to both the constitution and democracy in Pakistan. He warned that the announcement would likely lead to increased instability and negative consequences for the country.—RT/Agency

Data Ganj Bakhsh's Urs Commences in Lahore

LAHORE: The 981st annual Urs celebrations of renowned sufi saint Hazrat Data Ganj Bakhsh Ali Hajwary (RA) started in Lahore today.

Deputy Prime Minister Ishaq Dar along with Provincial Ministers and officers performed Ghul of the shrine with rose water. On the occasion, prayers were offered for development, peace and prosperity of the country. Thousands of devotees are visiting the shrine.

Data Ganj Bakhsh was a 11th-century Sunni Muslim scholar and mystic from Ghaznavid Empire, who became famous for composing the Kashf al-

ma'jub, which is considered the "earliest formal treatise" on Sufism in Persian.

He is believed to have contributed "significantly" to the spread of Islam in South Asia through his preaching, with one historian describing him as "one of the most important figures to have spread Islam in the Indian subcontinent."

In the present day, Data Ganj Bakhsh is venerated as the main saint of Lahore, Pakistan by the traditional Sunni Muslims of the area. He is, moreover, one of the most widely venerated saints in the entire South Asia, and his tomb-shrine in Lahore, popularly

known as Data Darbar, is one of the most frequented shrines in South Asia.

At present, it is Pakistan's largest shrine "in numbers of annual visitors and in the size of the shrine complex," and, having been nationalized in 1960, is managed today by the Department of Awaqaf and Religious Affairs of the Punjab.

He migrated to Punjab from Afghanistan and brought the light of Islam to a land where majority of the people were Hindus. Data Ganj Bakhsh was born in Ghazni, in present-day Afghanistan, in around 1009 to Uthman ibn Ali or Bu Ali.—RT/Agency

Boat Capsizes in Khushab: 4 Teenagers Rescued, 6 Missing

KHUSHAB: Four teenagers were rescued while six remained missing as a boat capsized in Khushab's Noorpur Thal teshil on Tuesday, according to the Provincial Disaster Management Authority (PDMA).

According to a statement from the Punjab PDMA spokesperson, the rescue team immediately reached the location and began searching for the teenagers, who were all said to be between 14 and 16-years-old. "Four youths have been rescued and the search for the rest is on," the statement said. It added that Punjab PDMA Director General Irfan Ali Kathia also con-



tacted Khushab Deputy Commissioner Zeeshan Shabbir Rana and directed the district administration to speed up the operation.

"Strict legal action should be taken against those who put youth on the boat without life jackets," the statement quoted DG Kathia as saying.

All of the teenagers belonged to the rural village of Pelowaince. Mass drownings are common in Pakistan

when aged and overloaded vessels lose their stability and pitch passengers into the water. In April, eight persons drowned when a boat capsized in the Indus River near Kund Park in the Nowshera district on the second day of Eidul Fitr Separately, a woman and five children were killed after a boat ferrying them across a swollen river capsized in Indian-held Kashmir.—RT/Agency

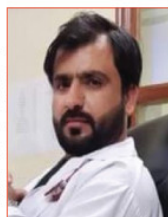

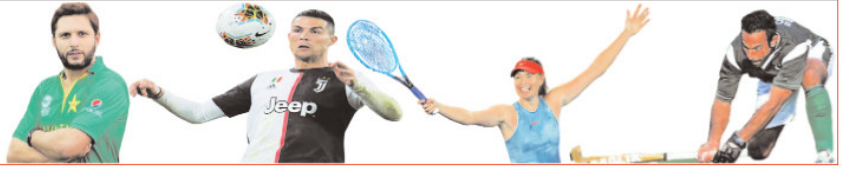

The young man allegedly strangled and brutally tortured the child to death in an agricultural field, then discarded the body in a hedge and easily escaped. The villagers brought the boy's body back to their home, where his mother, upon seeing the lifeless body, screamed in agony and fainted. The body was then taken to a government hospital for a post-mortem examination, where the hospital administration informed the police and sent the relatives to the police station for a letter. The B-Section

police gave a letter to the relatives and sent them back, but no FIR was registered regarding the incident. In response to the brutal murder, the Kolhi community, including women, men, and nationalist activists, held a protest and chanted slogans. The mother of the murdered child, Rekha, along with his grandmother Lali, grandmother Rashi Kolhi, nationalist leaders Javed Halipoto, Ali Sher Parhiyar, Saleem Halipoto, and others, accused the young man Zakir Laghari of holding a minor boy hostage and brutally torturing and killing him, breaking his arms and legs. They criticized the B-Section police for not registering an FIR for the murder and demanded the immediate arrest of the culprit and the filing of an FIR against him. They warned that the protest

would continue if no action was taken. Political and social circles in Tando Muhammad Khan strongly protested the brutal murder of the innocent child, demanding the registration of a murder case and the arrest of the brutal young man responsible. Meanwhile, the police stated that the relatives had taken the child's body to Umerkot for final rites and would register an FIR upon their return, after which the police would proceed with further action and arrest the culprit. Villagers claimed that the main culprit, Zakir Laghari, had already been taken into custody. The father of the brutally murdered child, Ranjho, being a resident of Umerkot, had taken the body there, where the final rites were performed according to Hindu customs.

It added that the two men had also punched a security manager.

Ramon, his son and other family members are believed to have been trying to go on the pitch to take part in the awards ceremony.

The start of the final of the Americas' most prestigious football tournament was delayed by 80 minutes after ticketless fans forced their way into stadium, leading to several arrests after clashes with police and security personnel.

England unveil Playing XI for second West Indies Test

Youngster Shoaib Bashir will lead England's spin bowling attack with Joe Root providing the cover.

England started their busy summer season on a high as Gus Atkinson's heroics with the ball gave them a confidence-boosting victory.

The debutant pacer dismantled the West Indies batting lineup in the first innings with a seven-for. The touring side, as a result, only managed to register 121 runs on the board.

England batters banked on the momentum provided by Atkinson and scored 371 runs in response with Zak Crawley, debutant wicketkeeper batter Jamie Smith, Joe Root, Ollie Pope and Harry Brook scoring half-centuries.—Agency

Gareth Southgate resigns as England boss after Euro 2024 final defeat

Gareth Southgate resigned from his role as England manager on Tuesday after yet another heart-breaking final loss at the European Championship, their second straight failure in the title decider of the continental tournament.

England lost 2-1 to Spain in Sunday's showpiece in Berlin and the 53-year-old Englishman said after the game that he would discuss his future in charge of the national team.

"As a proud Englishman, it has been the honour of my life to play for England and to manage England. It has meant everything to me, and I have given it my all," Southgate said in a statement.

"But it's time for change and for a new chapter. Sunday's final in Berlin against Spain was my final game as England manager."



"I have had the privilege of leading a large group of players in 102 games. Every one of them has been proud to wear the three lions on their shirts, and they have been a credit to their country in so many ways."

Britain's Prince William, who is also the president of the FA, thanked Southgate for his service.

"Thank you for creating a team that stands shoulder to shoulder with the world's finest in 2024," he said.

"Thank you for showing humility, compassion, and true leadership under the most intense pressure and scrutiny. And thank you for being an all-round class act."

"You should be incredibly proud of what you've achieved."

From youth to senior team

Having coached the England youth side for several years, Southgate took the senior job when Sam Allardyce resigned after one match in charge when he sought a lucrative sideline role while talking to undercover reporters.

A former international with 57 caps, Southgate took over an England side that had seen its "golden generation" of players fail to impress at major tournaments.—Agency

Brian Lara names THIS player who he believes is better than himself, Tendulkar



West Indies legend Brian Lara, who has broken several records during his time as a cricketer, named a player who he believes more gifted than him and even India's Sachin Tendulkar.

Lara holds the record for the highest score by a batter in Tests (400) and First Class Cricket (501) while Tendulkar is the all-time leading run-scorer in both Tests (15,921) and ODIs (18,426).

However, Lara named his former teammate Carl Hooper the best player he has ever seen in terms of raw talent.

"Carl was easily one of the best players I've ever seen. I would say that not even Tendulkar and myself would come close to that talent. Separate Carl's career from playing to captaining and his numbers are very different. As a captain he averaged near to 50, so he enjoyed the responsibility. It's

said that only as a captain did he fulfil his true potential," Lara wrote in his new book, as quoted by ESPNcricinfo.

Lara also picked two players each from England and India who he believes can break his record of 400 runs in a Test innings.

"There were players in my time who challenged, or at least went past the 300 mark — Virender Sehwag, Chris Gayle, Inzamam-ul-Haq, Sanath Jayasuriya. They were pretty much aggressive players," Lara told The Daily Mail.

"How many aggressive players do you have playing today? Especially in the England team. Zak Crawley and Harry Brook. Maybe in the Indian team? Yashasvi Jaiswal, Shubman Gill. If they find the right situation, the records could be broken — both of them," he added.—Agency

Quaidabad Police Accused of Killing a Youth in Fake Encounter

KARACHI: The family members of a youth named Atif Khan staged a protest demonstration against the alleged murder of their loved one in a fake police encounter. The incident, which has sparked outrage and demands for justice, occurred in the Quaidabad area and has raised serious questions about police conduct and accountability.

Atif Khan, a young man from the Quaidabad neighbourhood, was reportedly shot dead by officers from the Quaidabad Police Station. According to the family, Atif was not involved in any criminal activity and was wrongfully targeted by the police. Karachi Heatwave Alert: Feels-Like Temperature May Hit 43°C or Higher

KARACHI: Feels-like temperature in Karachi is expected to touch 43°C or surge past it, said a weather expert on Tuesday, as the citizens continue to bake under the heat.

Weather expert Jawad Memon said mercury in the port city is likely to hover between 38-39°C on Tuesday and Wednesday.

However, he added that thunderclouds could develop in the north, north-east and north-west neighbourhoods of Karachi from today to July 18.

"Clouds may form after afternoon because of moist winds blowing from the Arabian Sea," the weather analyst said.

Moreover, he predicted light to moderate rain for Gadap, Superhighway areas, Malir, Surjani and Gulshan-Maymar till Thursday.

Meanwhile, the Pakistan Meteorological Department (PMD) recorded current temperature at 36°C and humid-



ity at 50% in the port city, saying the feels-like heat was currently being experienced at 43°C.

The PMD said hot and humid weather had gripped the metropolis, while sea breezes were blowing at a speed of 18 kilometres an hour.

The Met Office on Monday forecast that the city will potentially experience a rise in temperatures, after experiencing a cloudy weather for the past few days.

Despite prediction for growth in heat intensity, the meteorology department, on Sunday, had ruled out another heatwave in the megapolis, and predicted a new monsoon spell that would affect Sindh, including its provincial capital from July 19.

Although the country's financial hub received some scattered downpour last week, the residents did not have much respite from the heat.—RT/Agency

More NADRA Officials Linked to Fake Passport Scandal



KARACHI: The Federal Investigation Agency (FIA) identified more officials of the National Database and Registration Authority (NADRA) allegedly involved in issuance of Computerised National Identity Cards (CNICs) to Afghan nationals, ARY News reported.

The FIA's investigation has reached its final stages, and responsible officials have been identified. It was revealed that Afghan citizens were issued Pakistani ID cards in exchange for bribes, with the help of Pakistani families, the sources said.

The investigation was initiated after the arrest of an Afghan national, Majidullah, who attempted to obtain a Pakistani passport.

The investigation revealed that Majidullah bribed and pretended himself a member of the family to obtain an ID card. The FIA already recorded statements from relevant NADRA officials and is set to take action against the accused persons.

The sources said that more arrests are expected to be made soon as the investigation progresses.

Earlier, the Ministry of Interior directed to initiate the legal proceedings against the Afghan nationals who were caught in Saudi Arabia for possessing fake Pakistani passports and identity cards.

According to the FIA sources, in light of Ministry of Interior directives, the relevant authorities decided to issue the notice under section 18 of the NADRA ordinance to 12,500 Afghan nationals.

Sources within the FIA revealed that the fake Pakistani identity cards to the 593 Afghan nationals were issued from Islamabad, while a total of 5,500 Pakistani identity cards were issued from Quetta and Peshawar.—RT/Agency

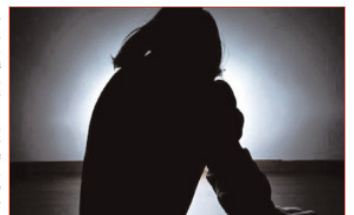
Nine-Year-Old Girl Victim of Sexual Assault in Karachi

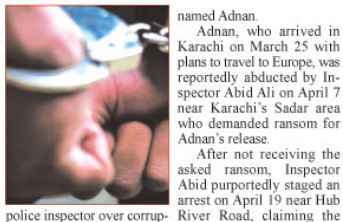
Suspect Arrested in Kidnapping Case of Two Sisters in Karachi

No Decision On PTI Ban Yet: Dar

ISLAMABAD: Deputy Prime Minister and Foreign Minister Senator Ishaq Dar said Tuesday that the decision to impose a ban on the Pakistan Tehreek-e-Insaf (PTI) has not been taken yet by the federal government.

Upping the ante against the embattled Imran Khan-founded party, the federal government led by Pakistan Muslim League-Nawaz (PML-N) decided to ban the former ruling party as well as file references against the top PTI leaders — including Imran Khan, Arif Alvi and Qasim Suri — under Article 6 (high treason) of the dissolution of the National Assembly in April 2022.

Dar, while addressing a press conference in Lahore today, clarified that Federal Minister for Information Attaulah Tarar had clearly announced a day ago that the government would deliberate on the ban on the PTI and make a decision after consulting its allies.

The ruling PML-N faced a backlash following the PTI ban announcement which was strongly opposed by its major ally in the coalition government, Pakistan Peoples Party (PPP), and other opposition parties.

"Decision would be taken according to the law and the Constitution," the deputy premier assured.

"Whatever decision we take, it would not be above the law and the Constitution, nor politically motivated," he added.



It is noteworthy to mention here that Tarar blamed the former ruling party for May 9 riots, foreign funding from questionable sources, and illegal dissolution of assemblies during the no-confidence move against the former premier Khan in April 2022.

"PTI is foreign-funded" "May 9 events are unacceptable," said Dar, adding that however, national integrity should be prioritised at any cost.

"Whoever is involved in the May 9 riots must face penalties. Either it's us or anyone else, if someone is working against the country, then it will be unacceptable," Dar insisted.

The May 9 riots had erupted following ex-PM Khan's arrest from Islamabad High Court (IHC) premises last year in which protesters targeted government and military installations.

Commenting on possibilities to initiate political dialogue, he said, "Reconciliation is possible as I have always worked for it."

The arrest was made after their acquittal in the iddat case — also known as the un-Islamic nikah case — which was the last hurdle in the couple's release from Rawalpindi's Adiala Jail.

Moreover, Khan's arrest had also been declared in 12 cases related to May 9 mayhem a day ago and an anti-terrorism court (ATC) in Lahore granted his 10-day physical remand.

"PML-N, PDM took responsibility in its initial remarks, the former minister said that Pakistan became the 24th largest economy in a short period of three years in 2016 under the leadership of former prime minister Nawaz Sharif when "inflation rate was only 2%, general inflation rate was standing at 3.6% and with the growth

rate of 6%". Pointing towards the PTI and its founder Khan, he alleged that ex-PM Nawaz had been removed from office through a "conspiracy", political chaos was created in the country and "a hand-picked [leader] was introduced by spending millions at Minar-e-Pakistan in 2011".

He further alleged that the 2018 general elections were "stolen" to defeat the Nawaz-led party which led to severe outcomes for the country's economy, politics and diplomacy.

Dar added that Pakistan's economic ranking had dropped to 47th from 24th during the PTI's rule and faced the risk of default due to the poor governance of the former rulers.

"The PML-N and the Pakistan Democratic Movement (PDM) had no eagerness to get a chance to rule the country, but it took responsibility to pull the country out of the crises," he said.

"We saved the country from default after much effort in the short tenure of 16 months and restored diplomatic ties with foreign countries."

It is pertinent to mention here that after ousting ex-PM Khan from office via a successful no-trust move in 2022, the PDM — a multi-party opposition alliance — came to power in the Centre with the PML-N's top leader Shehbaz as the prime minister. —RT/Agency

'Not Consulted': PPP Distances Itself From Government's PTI Ban Move

ISLAMABAD: The federal government's announcement to ban the main opposition party Pakistan Tehreek-e-Insaf (PTI) hasn't bode well with its key ally Pakistan Peoples Party (PPP), which has distanced itself from the arguably controversial move.

PPP's Information Secretary Shazia Atta Marri has said the Bilawal Bhutto Zardari's party, a key ally of the Pakistan Muslim League-Nawaz (PML-N) led government in the centre, wasn't consulted on the move to ban the Imran Khan founded party.

Marri's remarks come against backdrop of the PTI which in return has also demanded invoking Article 6 of the Constitution against those who undertook the unconstitutional steps despite the fact that there is a Constitution in the country. The party has called on allies of the ruling coalition government, including the PPP and the Mutahida Qaumi Movement-Pakistan (MQM-P) to clarify their position on the said issue.

Elaborating on the PPP's stance, Marri said that the party would hold consultations on the government's decision to ban the PTI. She said, "I don't think the PPP is in the favour of banning any political party."

Gohar Claims Ad Hoc Judges' Appointments Aimed At Reserved Seats Judgment

ISLAMABAD: Reacting to the proposal of appointing ad hoc judges at the apex court, Pakistan Tehreek-e-Insaf (PTI) Chairman Barrister Gohar Ali Khan on Tuesday said "there is a genuine apprehension the move is aimed at PTI's reserved seats judgment and its standing as a party".

"The move to appoint ad hoc judges and that too four judges at once and during vacation, is uncalled-for and unprecedented," PTI Chairman Barrister Gohar Ali Khan stated expressing suspicion about the proposal, in a post on X (formerly Twitter).

The Imran Khan-founded party raised alarm over four judges — Justice (retired) Mushir Alam, Justice (retired) Maqbool Baqir, Justice (retired) Mazhar Alam Miankhan, and Justice (retired) Sardar Tariq Masood — as ad hoc judges in the Supreme Court.

According to sources, the JCP stated that it would consider the proposal to reduce the number of pending cases in the country's top court.

The apex court, in its July 12 short order, ruled that the PTI is allowed to have seats reserved for women and minorities in all legislatures including the National Assembly.

The PTI chairman argued that not a single ad hoc judge had been appointed in the apex court since 2015. "It was decided in principle that 'ad hocism' is prejudicial to the 'independent judiciary,' Gohar said.

Dissenting from the argument regarding easing the SC's workload, the PTI leader said that the appointment of four ad hoc judges would not reduce the case burden. Instead, he stressed that these appointments would compromise the entire Supreme Court and its justices. It should be mentioned here that the JCP will meet on July 19 at 3pm in the top court's conference room. The official note for the meeting says that despite best efforts, the cases in the top court continue to accumulate.

In view of the huge number of pending cases and the ever-increasing trend of the institution of cases in the SC, an effective way to ensure that more cases are decided than instituted and to reduce, and hopefully eliminate the backlog of cases pending adjudication for several years, it would be appropriate to appoint experienced judges as ad hoc judges of the SC," said the notification. Percentage of cases surges by 3.9% to 2.6m. The Law and Justice Commission of Pakistan (LJCP), in its bi-annual report of judicial statistics, said the number of pending cases in the courts surged to 2.26 million during the second half of the year 2023, increasing the overall pendency by 3.9%. —RT/Agency

Barrister Gohar Ali Khan, overseeing the process, aims to finalize around 77 to 78 names for these reserved seats within the stipulated timeframe.

Once approved by PTI founder Imran Khan, these lists will be formally submitted, ensuring comprehensive representation across key legislative bodies.

IMF Deal Expected To Enhance Pakistan's Funding Needs: Moody's



ISLAMABAD: Global rating agency Moody's on Tuesday said that Pakistan's recent staff-level agreement with the International Monetary Fund (IMF) will improve funding prospects for the cash-strapped South Asian nation. The Shehbaz Sharif-led government and the IMF reached a three-year, \$7 billion aid package deal on Saturday, providing much-needed respite to the nation. This agreement marks a critical step towards stabilizing Pakistan's economy, which has been under severe strain.

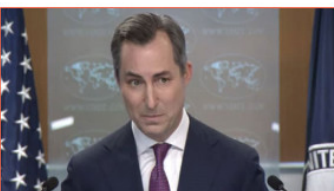
'Matter Of Great Concern': US Opposes PML-N Government's Plan To Ban PTI

ISLAMABAD: Hours after the well in debate issue in Pakistan, the United States on Monday expressed concerns over the PML-N-led government's surprise announcement that it is planning to impose a ban on its political rival PTI over its alleged involvement in anti-state activities.

Information Minister Attaulah Tarar earlier today announced that the federal government would file a reference against then-former prime minister Imran Khan, then-president Arif Alvi and then National Assembly deputy speaker Qasim Suri — for treason under Article 6 for dissolving the lower house of parliament in April 2022.

This is a fact and on the record that the PTI has been involved in anti-state activities. And, to this end, the government and its allies have decided to initiate legal proceedings to ban the PTI under Article 17 of the Constitution which empowers the federal government to ban any such a party," the informal minister announced at a press conference in Islamabad.

Responding to a question during a daily press briefing,



State Department Spokesperson Matthew Miller referred to the media reports and the Pakistani government's announcement, saying the development "is a beginning of the complex process".

"[...] certainly banning of the political party would be of great concern to us," he added. The spokesperson stressed his country supports the peaceful upholding of the country's Constitution and democratic principles including respect for human rights and freedom of expression.

"We support the democratic processes and broader principles including the rule of law and equal justice under the law and as these internal processes continue to play out we will monitor the further decisions," Miller said. The government's announcement drew severe criticism from several quarters including leaders of mainstream political parties.

The PTI, without naming the PML-N, demanded invoking Article 6 of the Constitution against those who undertook the unconstitutional steps in the country, calling on allies of the ruling coalition government to clear their position on the plan to ban the former ruling party.

Addressing a press conference in Islamabad on Monday, the party leadership also condemned the federal government's decision to ban the Imran Khan-founded party.

"We call on the PPP and the MQM-P to clarify their position as the ANP has already clarified its position on the issue," PTI Secretary General Omar Ayub said. —RT/Agency

Khawaja Asif Intensifies Criticism Of Judiciary After Reserved Seats Verdict

ISLAMABAD: Doubling down on the criticism of the judiciary following the Supreme Court's July 12 verdict on the reserved seats case in favour of the Pakistan Tehreek-e-Insaf (PTI), Defence Minister Khawaja Asif on Tuesday urged the courts to refrain from giving "political verdicts" and to pass judgments that uphold their respect.

"I respect the courts but courts should also get themselves respected and the politicians should not be mistaken as being too weak," he said while addressing a press conference in Sialkot on Tuesday.

The defence minister's remarks came days after the Supreme Court issued its short order in the reserved seats case, declaring the Imran Khan-founded party eligible for reserved seats for women and minorities in the assemblies.



Amid criticism pouring in from all political quarters, the Pakistan Muslim League-Nawaz (PML-N) has defended its decision to ban the PTI as Defence Minister Khawaja Asif said consultations would be held with the allies of the ruling coalition and the ruling party would bring the matter in parliament. Information Minister Attaulah Tarar announced Monday that the federal government had decided to ban



the PTI and initiate Article 6 proceedings against them, prime minister Imran Khan, then president Dr Arif Alvi and then deputy speaker of the National Assembly Qasim Suri for dissolving the National Assembly in April 2022. The PTI only intends to ascend to power. Article 6 applies to those who violate the Constitution," the deputy minister said highlighting the need to invoke the treason charges against the PTI leaders. —RT/Agency

Abbasi and Ismail Criticize Government's Decision To Ban PTI

LAHORE: Awam Pakistan (AP) convenor Shahid Khaqan Abbasi said on Tuesday that the attempts to ban political parties have always failed.

Expressing his thoughts on media, Abbasi said: "Whenever any step is taken, questions raise on the country's premier. How will one [government] enforce Article 6 on others whose jurisdiction is questionable?"

Abbasi said, "None of the political parties cannot be banned. The government's reputation will be damaged further if they take the decision to ban the PTI."

Meanwhile, expressing his thoughts, former finance minister Miftah Ismail asserted: "Shehbaz Sharif has taken the government by force and is implementing restrictions."

"It would have been better for Shehbaz Sharif to admit defeat in the general elections," he added.

Criticising the govern-



ment's hasty decision to ban the PTI, Ismail said: "The government will retract its decision to ban the PTI."

Ismail asserted: "The government came to power with a suspected mandate, is in a state of panic."
