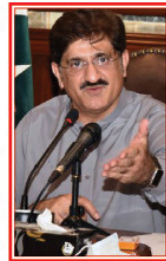

## PML-N And PPP To Continue Discussions On PTI Ban

ISLAMABAD: The Pakistan Muslim League-Nawaz (PML-N) and the Pakistan People's Party (PPP) decided on Friday to hold further consultations regarding the ban on Imran Khan-founded PTI and actions under Article 6 against Imran Khan, Arif Alvi, and Qasim Suri, media reported, citing sources.



A meeting was held between the ruling coalition - PML-N and PPP - to discuss administrative matters in Punjab, the current political situation, and the government's proposal to ban PTI. The PML-N delegation included National Assembly Speaker Ayaz Sadiq, Deputy Prime Minister Ishaq Dar, Law Minister Azam Nazeer Tarar, and Rana Sanaullah. The PPP delegation comprised of Sherry Rehman, Raja Pervaiz Ashraf, and Nadeem Afzal Chan. Meanwhile, the Attorney General of Pakistan (AGP) and other officials were also present at the meeting.

Sources told media that the PPP delegation emphasised the party's commitment to democratic processes and reviews. During the meeting, it was decided that further consultations would be held regarding the ban on PTI. It was also agreed that the parties will reconvene after con-

sulting with their leadership to finalise their decisions. The federal government had announced its plans to ban Pakistan Tehreek-e-Insaf (PTI) and seek Article 6 proceedings against its founder Imran Khan, ex-president Dr Arif Alvi, and former deputy NA speaker Qasim Suri. The announcement came following the relief given to the party by the top court in the reserved seats case as well as to the party founder Imran Khan in the Iddat case.

Addressing a presser, Information Minister Attaullah Tarar said the country could not move forward with the Imran Khan-founded party's existence. "In view of the foreign funding case, May 9 riots, and the cipher case as well as the resolution passed in the US, we believe that there is credible evidence present to have the PTI banned," he said.

Earlier on Tuesday, Deputy Prime Minister Ishaq Dar said that the decision to ban Pakistan Tehreek-e-Insaf (PTI) will be made after consultations with allied political parties. He also noted that the Election Commission has evidence of PTI being a foreign-funded party. Dar highlighted the importance of following the constitution and laws, and mentioned that Federal Minister of Information Attaullah Tarar's recent statements would be discussed with allied parties before any decision is made.—RT/Agency

## JCP Approves Appointment Of Two Ad-Hoc Judges To Supreme Court

ISLAMABAD: The Judicial Commission of Pakistan on Friday approved the appointment of Justice (ret'd) Sardar Tariq Masood and Justice (ret'd) Mazhar Miankhal as ad-hoc judges to the Supreme Court (SC), media reported.



Sources privy to the development said that the Judicial Commission meeting considered the proposals for the appointment of ad hoc judges and approved two names for the ad-hoc judges with the majority of votes. The sources said that the apex court's Justice Munib Akhtar opposed the appointment of Justice (ret'd) Sardar Tariq Masood as an ad-hoc judge. After Justice Munib Akhtar's disagreement, the name of Justice (ret'd) Sardar Tariq Masood was approved for the ad-hoc role with a majority of 8-1.

The sources added that three members of the Judicial Commission also opposed the appointment of Justice (ret'd) Mazhar Miankhal as he was okayed with a ratio of 6-3.

Both the former judges have been appointed as ad-hoc judges for a period of one year. Besides these two former judges, the names of Justice (ret'd) Mushir Alam and Justice (ret'd) Maqbool Baqar were also being considered for the ad-hoc role before they declined the offer.

Justice Alam retired from the Supreme Court on August 21, 2021; Justice Baqar, who served as the Sindh chief minister during the last caretaker set-up, retired on April 4, 2022; Justice Miankhal retired on July 13, 2022; and Justice Masood on March 10, 2024.

Earlier on Thursday, the Pakistan Bar Council called for the formation of more courts in the country through a constitutional amendment. The council has also expressed support for the appointment of ad hoc judges to help expedite the decision-making process in cases. "Currently, a significant amount of the Supreme Court's time is spent hearing political cases, and the establishment of a constitutional court would help alleviate this burden," the PBC viewed.—RT/Agency

## FO: Political Party Bans Are Pakistan's Internal Affairs

ISLAMABAD: The Foreign Office (FO) spokesperson Mumtaz Zahra Baloch on Friday emphasised that countries should refrain from commenting on Pakistan's domestic matters, asserting that Islamabad can handle its internal issues independently. "Banning political parties is an internal issue of Pakistan," said Mumtaz during a media briefing.



Addressing the recent attack on Bannu Cantt by the Tehreek-e-Taliban Pakistan (TTP), Mumtaz revealed that Pakistan has expressed its serious concerns to the Afghan interim government. The FO spokesperson expressed alarm over the use of Afghan territory for terrorism against Pakistan and urged the Afghan government to take immediate and effective action against the Hafiz Gul Bahadur group. She said that Pakistan has shared intelligence with Afghanistan regarding terrorist groups and has maintained continuous communication with Afghan authorities.

Concerning immigration, Mumtaz clarified that Pakistan's immigration laws are strict, with daily deportations of illegal Afghan residents. "Currently, 44,000 Afghan citizens are awaiting relocation," she added. While the spokesperson was not aware of Malala Yousafzai's recent statements on this issue, she expressed hope that Yousafzai would advocate for the expedited relocation of these refugees. The FO condemned the attack on a Shia mosque in Muscat on Muharram 9, describing it as a barbaric act of terrorism. Pakistan expressed solidarity with the victims and highlighted the importance of collective action against terrorism. Additionally, Pakistan condemned the Israeli attacks on Palestinian refugee camps, particularly the assault on Khan Younis camp, which resulted in the deaths of 19 Palestinians, calling it a violation of United Nations regulations.—RT/Agency

## LHC Chief Justice Denies CEC's Tribunal Reformation Request



LAHORE: Lahore High Court (LHC) Chief Justice Aaliya Neelum rejected the request of the Chief Election Commissioner (CEC) seeking the reformation of the election tribunals in the province, media reported, citing sources.

Chief Election Commissioner Sultan Akram Raja met the LHC chief justice and requested her to reconstitute the existing election tribunals, the sources said. Justice Aaliya Neelum turned down the CEC's request, maintaining that the present election tribunals will continue to function as usual. The LHC chief justice said that the final decision on the election tribunals will be made by the Supreme Court (SC) of Pakistan. Earlier on June 20, the Supreme Court (SC) re-

jected an appeal moved by the Election Commission of Pakistan (ECP) against formation of election tribunals by the Lahore High Court. The two-member bench of the Supreme Court, headed by Justice Qazi Faez Isa and also comprising Justice Naem Afghani, heard the Election Commission's appeal. The commission's lawyer, Sikanar Bashir, and PTI lawyer Salman Akram Raja appeared before the court. Justice Isa questioned whether the Chief Election Commissioner and the CJP could not meet to resolve disputes. He remarked that if every issue is to be made contentious, then Parliament should be shut down. He asserted that using ordinances is a disregard for Parliament and a violation of its authority.—RT/Agency

## Bangladesh imposes curfew after deadly protests

DHAKA: Bangladesh on Friday announced the imposition of a curfew and the deployment of military forces as police failed to quell days of deadly unrest that has spread throughout the country.



This week's clashes between student demonstrators and police have killed at least 105 people, according to an AFP count of victims reported by hospitals, and pose a momentous challenge to Prime Minister Sheikh Hasina's autocratic government after 15 years in office. "The government has decided to impose a curfew and deploy the military in aid of the civilian authorities," Hasina's press secretary Nayemul Islam Khan told AFP.

He added that the curfew would take immediate effect. Police in the capital Dhaka earlier took the drastic step of banning all public gatherings for the day - a first since protests began - in an effort to forestall more violence. "We've banned all rallies, processions and public gatherings in Dhaka today," he added. "Shocking and unacceptable." At least 52 people were killed in the capital on Friday, according to a list drawn up by the Dhaka Medical College Hospital and seen by AFP. Police fire was the cause of more than half of the deaths reported so far this week, based on descriptions given to AFP by hospital staff. UN human rights chief Volker Turk said the attacks on student protesters were "shocking and unacceptable." "There must be impartial, prompt and exhaustive investigations into these attacks, and those responsible held to account," he said in a statement. The capital's police force earlier said protesters had on Thursday torched, vandalised and carried out "destructive activities" on numerous police and government offices. Among them was the Dhaka headquarters of state broadcaster Bangladesh Television, which remains offline after hundreds of incensed students stormed the premises and set fire to a building. Dhaka Metropolitan Police spokesman Faruk Hossain told AFP that officers had arrested, Ruhul Kabir Rizvi Ahmed, one of the top leaders of the main opposition Bangladesh Nationalist Party (BNP)—RT/Agency

## K-P Assembly Passes Resolution Opposing PTI Ban, Calls For Imran Khan's Release

The resolution highlighted that the recent Supreme Court decision against the freedom to form political parties, the PTI, standing with the Constitution, pledged to challenge any such ban both judicially and publicly.—RT/Agency

## Leaked phone call of TTP chief surfaces



ISLAMABAD: A leaked call between the leader of the banned Tehreek-e-Taliban Pakistan (TTP) Noor Wali and his associate revealed the plans to carry out terrorist attacks on schools, hospitals, and security forces, media reported.

The TTP leader, Noor Wali, can be heard directing his associate to target government schools and hospitals with explosives and not to claim responsibility for the attacks. He also directed his subordinate to attack the homes of police and military personnel, and to target schools and hospitals in order to create fear and chaos. Noor Wali can be heard saying that on the call to blow up the houses of the police and army personnel who are on duty.

Earlier on July 11, Pakistan Foreign Office (FO) on Thursday said that it has no plans to enter into any talks with the banned TTP. At her weekly news briefing in Islamabad, Foreign Office Spokesperson Mumtaz Zahra Baloch said the terrorist entity is involved in the killing of Pakistani and foreign citizens inside the country. She said that Pakistan respects Afghanistan's sovereignty and territorial integrity. "We expect the Afghan authorities to uphold their sovereignty and take action against terrorist groups which have found sanctuaries inside Afghanistan and using their territory for terrorist attacks against Pakistan," Mumtaz Zahra Baloch added.—RT/Agency

## Pakistan Pledges Counterterrorism Support To Oman



ISLAMABAD: Prime Minister Shehbaz Sharif on Friday offered Pakistan's support to Oman in dealing with menace of terrorism while condemning the recent attack on an imam-bargah in Muscat that claimed six lives and injured over 30 people. The offer was extended during a courtesy visit by the Ambassador of Oman Fahad Sulaiman Khalaf Al Kharusi to the premier at the Prime Minister's House, said a statement issued today.

Talking to Ambassador, PM Shehbaz appreciated Oman's swift response and cooperation with the Pakistan mission in the repatriation of the dead bodies and treatment of the injured. The attack on imam-bargah had resulted in the death of six people, including four Pakistani nationals, and over thirty injured, nearly all of whom were Pakistani.

On Thursday, Omani police said that three suspects — all brothers and Omani nationals — adhering to "misguided ideas" were behind the attack and were killed upon resisting security forces. Meanwhile, the prime minister said Pakistan had itself been the victim of terrorism for the past several decades. Prime Minister Shehbaz also conveyed his good wishes for Sultan Haitham bin Tariq while fondly recalling his telephone conversations with the Sultan on Eid ul Adha as well as Eid ul Fitr earlier in the year. The prime minister reiterated his invitation to the Sultan of Oman to undertake an official visit to Pakistan at his earliest convenience. On the bilateral front, the prime minister stressed that Pakistan and Oman enjoyed close, brotherly ties with a shared history, faith and culture. He expressed Pakistan's desire to further strengthen bilateral cooperation between the two countries, particularly in trade, investment, energy, and defense. In this regard, Prime Minister Shehbaz thanked the ambassador for encouraging a trade and investment delegation to undertake a visit to Pakistan next week, while assuring him that the relevant Pakistani authorities would extend full cooperation to the delegation while seeking mutually beneficial outcomes. The ambassador thanked the prime minister for receiving him and conveyed the greetings of the Sultan of Oman. He reaffirmed his country's desire to further enhance its trade and investment relations with Pakistan.—RT/Agency

## PML-N has not consulted PPP regarding PTI ban: Nisar Khuhro

LARKANA: The President of Pakistan People's Party (PPP) Sindh, Nisar Khuhro stated that in his opinion, no political party should be banned. However, he emphasized that PTI should disassociate itself from its militant wing, including the Tiger Force. Khuhro made these remarks in a statement he issued. Nisar Khuhro said that if PTI considers itself a political party, it must practically prove itself to be a complete political party. He stated that no political party should have a militant wing, and therefore, Imran Khan should publicly disassociate PTI from any militant elements within the party. He further added that the federal government led by Pakistan Muslim League-N (PML-N) has never consulted PPP nor taken it into confidence regarding the potential ban on PTI. Khuhro said that when the federal government approaches PPP for consultation on banning PTI, PPP will inform them of its final opinion and decision. Khuhro highlighted that the federal government has not yet made a final decision on whether to ban PTI. When



the federal government formally initiates consultations, PPP will then communicate its final stance to PML-N. He explained that constitutionally, the final decision to ban any party lies with the Supreme Court. The federal government sends a reference to the Supreme Court regarding any ban, and the court makes the ultimate decision. Khuhro also addressed ambiguities surrounding the Supreme Court's decision on reserved seats, which he said remain unclear to the public. He pointed out that the Sumi Ittehad Council had filed the petition regarding reserved seats, and the decision was made in favor of PTI, which had not filed the petition. He questioned how PTI could be entitled to reserved seats when it did not even have a party symbol in the elections and independent candidates contested on various symbols. Khuhro further criticized the Supreme Court for allowing members of the Sumi Ittehad to join another party, effectively setting aside the anti-floor crossing clause. He questioned whether this decision has nullified the anti-floor crossing clause, stating that clarification is needed. Additionally, Nisar Khuhro visited the village of Nazir Dhoki, the media coordinator of PPP chairman, to offer condolences to his sons and other relatives on his passing. He expressed his sorrow and grief during the visit. PPP Sukkur Division President Syed Bachal Shah and other leaders were also present.

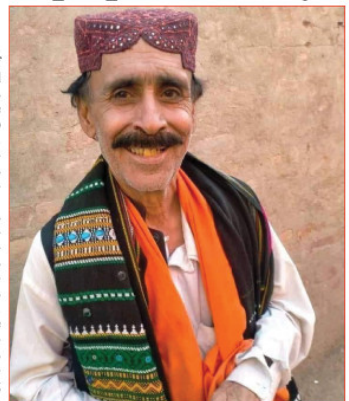


devices and the number of deserving women is high. Many women fainted due to heat at BISP center and were shifted to taluka hospital Kunri.

## Sindh Food Authority bans 11 packaged snack products of Korean company

THATTA: The Sindh Food Authority (SFA) has prohibited the sale of 11 packaged snack products following a laboratory assessment deeming them unfit for human consumption. SFA Director General Muzamil Hussain Halepoto instructed the concerned private company to promptly withdraw Slanty Vegetable, Snackers Hot Masala, Snackers Pizza, Twitch Classic, Potato Sticks, Cheese Ball Masala, Cheese Balls Cheese, Kai Korean Hot, Kai Spicy Mala, Kai Mala Wok and Kai Korean Kimchi from the market. Laboratory tests conducted

by the Food Testing Laboratory at the University of Karachi's Department of Food Science and Technology determined these products were unsafe for consumption.

The company, which submitted 24 products for registration around two and a half months ago, was notified that 11 of them failed to meet essential safety and quality standards as of the April 19 report. A letter addressed to the company on Monday highlighted the significant health risks posed by these products and cited violations of law and regulations. Consequently, the SFA invoked relevant sections of the Sindh

Food Authority Act 2016 to order a full recall of the affected products, emphasizing the severity of the public health threat.

The SFA directive mandates the company to immediately cease production and sales of the specified products, withdraw them from the market, and provide detailed information on the remaining stock within three days. Failure to comply will result in legal action. The order also allows the company recourse. If aggrieved by this directive, the company may appeal to the SFA Board within one week under the relevant provisions of the Sindh Food Authority Act.

## 8-year-old Mehar boy brutally tortured after being tied up to a tree for picking a few dates

MEHAR: An 8-year-old boy named Muzaffar Lahari was brutally subjected to torture after being tied up with a tree for picking a few dates from the orchard of Molvi Wahan Jatoi. The employees of the influential man after tying

up the minor boy subjected him to torture and recorded his video also which they bravely circulated on the social media to mock the Sindh Police like dacoits of Kashmir-Kandhot. The police have still not taken any step in this regard, while the minor boy has been hospitalized as the culprits left him in unconscious condition. The father of the tortured boy condemned the torture on his minor son and demanded arrest of the accused men in the incident including Molvi Wahan Jatoi, otherwise he has announced to widen his protest.

## Maryam urges Supreme Court judges to support Pakistan's progress

LAHORE: Launching a salvo against the Supreme Court verdict allowing the Pakistan Tehreek-e-Insaf (PTI) to claim reserved seats in the parliament, Punjab Chief Minister Maryam Nawaz on Friday said the apex court judges should let the country progress.

"I would like to ask the SC judges to let the country function," Maryam said addressing an event in Lahore.



She alleged the apex court judges of rewriting the constitution to bring one person back to the mainstream politics. "Who are those (people) who do not like the country making progress and re-write the Constitution," she said.

In a major legal victory for the PTI, the SC on July 12 ruled that the party was eligible for the allocation of reserved seats.

The decision has not only paved the way for the PTI's return to the parliament, which was kicked out of the February 8 polls owing to the

enormity will complete its five years' tenure. If anyone tries to create political instability, they will be dealt with iron hands," the Pakistan Muslim League-Nawaz (PML-N) leader warned.

"It was said that verdicts were announced according to their conscience," Maryam noted, adding that decisions should be according to the constitution, not according to a person's conscience.

## Osama bin Laden's associate arrested in Gujrat: CTD Punjab



LAHORE: In a significant development, the Counter-Terrorism Department (CTD) Punjab said Friday that the law enforcers had arrested Amin al-Haq, a close aide of Al-Qaeda founder Osama bin Laden.

"The terrorist was apprehended during an intelligence-based operation," DIG CTD Usman Akram Gomard said, adding that he was taken into custody from Sarai Alamgir, a town in the Gujrat district.

Associated with bin Laden since 1996, the CTD noted that Haq was among the top fighters of the extremist group and that he was involved in several terrorist activities. Haq — responsible for coordinating security for the deceased Al-Qaeda chief — has also been designated as a terrorist by the United Nations.

The high-ranking official said that a case had been registered against Haq, noting that the authorities would probe what was a high-profile terrorist doing in Pakistan.

"He was seen in Afghanistan in 2021. He also has Pakistan's ID Card, on which Lahore and Haripur's addresses have been added," the CTD officer added.

The United Nations Security Council's website shows that Haq, who was born in Afghanistan's Nangarhar province in 1960, was designated as a terrorist on January 25, 2001.

In 2011, the United States troops carried out a raid on bin Laden's compound in Abbottabad, Khyber Pakhtunkhwa, and eliminated the global terrorist, who was also involved in the deadly 9/11 attacks. —RT/Agency

## Punjab police unable to justify 30% crime reduction claim

LAHORE: The Punjab police adamantly disputed Geo Fact Check's report which showed a 46% surge in registered crimes across the province in 2023. But the provincial police has failed to present any data, facts, or evidence supporting their department's stance, to date.



On May 13, Geo Fact Check released a report refuting the assertions made by Interior Minister Mohsin Naqvi, who claimed a notable 30% reduction in crime rates during his tenure as caretaker chief minister Punjab in 2023.

Naqvi had headed the province from January 2023 to February 2024.

Contrary to Naqvi's statements, a factual analysis conducted by Geo Fact Check revealed a stark reality: registered cases of all crimes had in fact surged by 46% in 2023 compared to 2022, showed official police data and that documented by the Human Rights Commission of Pakistan (HRCPC).

In fact, heinous crimes such as rape, gang rape, murder and acid attacks witnessed a significant increase over the past year in the province.

In response to Geo Fact

Check's findings, the Punjab police issued a press release on May 15, denying the accuracy of the report while asserting that several critical factors had been overlooked by the fact check.

The press release claimed that a policy was rolled out in 2023 which allowed for the free registration of crimes. Due to which all old cases and first information reports (FIRs) which could not be recorded in the online system in the year 2022, were instead registered in 2023.

Specifically, the press release addressed the category of "crime against properties," claiming that over 130,000 cases from this category, were registered in 2022, were added in 2023, therefore bringing the overall tally of 2023 up.

Curiously, the press release ignored all other categories of crimes.

Furthermore, the release claimed that the true measure of crime rate lies in the calls received on the police helpline (15), which purportedly reduced by 30% in 2023.

In an attempt to verify the Punjab police's assertions, Geo Fact Check reached out to Punjab's Inspector General Police, Dr Usman Anwar.

Requests were made for copies of all FIRs not recorded in the 2022 tally but added in 2023, specifically cases of rape, gang rape, murder, honor killing, dacoity, acid attacks, attempted murder, kidnapping and abduction, kidnapping and ransom, robbery, motor vehicle theft, and hurt. —RT/Agency

## Murad Directs For Review of Solar Projects for Free Electricity for Low-Income Households

KARACHI: Sindh Chief Minister Syed Murad Ali Shah, presiding over a meeting, has decided to implement the PPP Chairman Bilawal Bhattu's program to provide free-of-cost electricity to consumers living off-grid and to those using 50 to 100 MW electricity by implementing the solar energy solution.



This decision was taken in a meeting held at the CM House in which different proposals were discussed. Minister P&D and Energy Nasir Shah, CM Advisor for Cooperative Societies Ahsan Mazari, Chief Secretary Asif Hyder Shah, PSCM Agha Wasef, Secretary Energy Musadiq Khan, and others attended the meeting.

On-Grid: Minister Energy Nasir Shah, briefing the CM, said that on his directives, his department has worked out that around 80,000 households were using 50 MW of electricity per month. They

include 441,483 in KE jurisdiction, 229,338 in HESCO, and 125,500 in SEPCO. Similarly, the number of households using 100 MW per month comes to 1.9 million, with 1,054,000 in Karachi (KE), 566,427 in the Hyderabad region (HESCO), and 356,073 in the Sukkur region (SEPCO).

Off-Grid: The CM was said that there were 2.6 million off-grid households of them 500,000 may be provided Solar Home Systems (SHS) in the first phase. The CM said that a

100-watt SHC was enough for 3 LED bulbs, a 35W DC fan and a 6-hour battery backup with Mobile charging ports. Nasir Shah told the CM that the cost of an SHS comes to around Rs50,000 each and the total cost for 2.6 million SHS would be around 25 billion.

Microgrids: The CM said that six microgrids, each one of 75kW, could be established in all six divisions as a pilot project to cover a 100-household cluster. —RT

## Pakistan and Romania Ink Agreement to Enhance Trade Ties



KARACHI: Pakistan and Romania have signed a memorandum of understanding (MoU) to strengthen bilateral trade and economic cooperation.

The MoU signed by Edward-Robert PREDA, Charge D'Affaires, Embassy of Romania to the Islamic Republic of Pakistan, and Chairman of PRBC, Sohail Sharim FIRPO, and recognized the outstanding services rendered by PRBC since 2011 in promoting bilateral trade between the two countries.

The agreement establishes a framework for cooperation between the Embassy of Romania and PRBC, with the Embassy extending full support to PRBC's endeavours to promote and strengthen bilateral trade.

Additionally, the protocol acknowledges the recent expansion of PRBC through the formation of its North Chapter.

The embassy and PRBC have agreed to collaborate in enhancing economic cooperation and bilateral trade between Romania and Pakistan. This partnership aims to foster greater economic ties and mutual benefits for both nations.

The signing of this protocol marks a significant milestone in the bilateral relations between Romania and Pakistan. —RT

## IHC orders recovery of missing citizen

The Islamabad High Court (IHC) on Friday ordered the recovery of missing citizen Samiullah within three days and warned police that failure to recover him within this timeframe would result in legal action against them. The directive came during a hearing led by Justice Mohsin Akhtar Kayani, who addressed the case involving Samiullah's disappearance from the Sangiani Police Station jurisdiction.



At the hearing, officials including the SSP Operations, SP Sadder, and SHO Sangiani were present.

Justice Kayani questioned the progress of the investigation, specifically asking whether CCTV footage had been reviewed. The petitioner's lawyer reported that while Safe City cameras did not provide useful evidence, footage of the vehicle used in

the abduction was available. The vehicle was captured on camera picking up Samiullah at the Sangiani Toll Plaza and was later observed in the Red Zone, near the Judges' Sector. In response to concerns about potential judicial involvement, Justice Kayani clarified that while the evidence did not suggest any judges were involved, the vehicle's presence in the Red Zone for two days was concerning. The Assistant Attorney General confirmed that the vehicle was not currently in Islamabad, prompting the court to suggest it

might be held by another agency Justice Kayani emphasized that if no progress was made within eleven days, it would imply that further progress might be unlikely. He gave the police a final three-day period to recover Samiullah, warning that if the individual was not found within this time, he would order a case to be filed against the Inspector General (IG).

The court adjourned the case until July 22 and transferred it to another bench for further proceedings. —RT/Agency

## Are Ad Hoc Judges A Quick Fix Or Judicial Quagmire?

The recent approval by the Judicial Commission of Pakistan (JCP) to appoint two retired judges, Justice Sardar Tariq Masood and Justice Mazhar Miankhel, as ad-hoc judges to the Supreme Court (SC) has reignited the longstanding debate about the practice of ad hocism within Pakistan's judiciary. This decision, met with both support and opposition within the commission, underscores the controversial nature of appointing temporary judges to the highest court in a country already grappling with a highly polarized political environment.

Ad hocism, by its very nature, is a stopgap measure. While it may provide short-term relief, it raises significant concerns about the stability and integrity of judicial processes. The appointment of ad-hoc judges often appears as a quick fix to systemic issues, rather than addressing the root causes of judicial inefficiency. In this context, one must question the optics and implications of these recent

appointments. Can temporary judges, no matter how competent, truly offer the same consistency and long-term vision as their permanently appointed counterparts?

The JCP's decision was not unanimous, highlighting the

contentious nature of these appointments. Justice Munib Akhtar's opposition to Justice Masood's appointment and the narrow approval margins for both judges reflect deep divisions within the commission itself. Such dissent signals a broader unease about the reliance on ad hoc solutions in a system that requires permanent, sustainable reforms.

Furthermore, in the current charged political climate, the optics of appointing ad-hoc judges can be particularly troubling. The perception, whether accurate or not, that such

appointments might be influenced by political considerations, undermines public confidence in the judiciary. It also raises questions about the independence of the judiciary, a cornerstone of democratic governance.

While the Pakistan Bar Council has supported the move, citing the need to expedite the decision-making process amidst a backlog of cases, the call for constitutional amendments to establish more courts seems a more prudent long-term solution. Ad hoc measures, while expedient, cannot replace the need for comprehensive judicial reforms that ensure both efficiency and impartiality.

In conclusion, the practice of ad hocism in Pakistan's judiciary remains fraught with controversy and potential pitfalls. As the nation navigates its complex political landscape, it is imperative to seek solutions that reinforce the judiciary's independence and integrity, rather than relying on temporary fixes that may exacerbate existing challenges.

"On and off the field, I am sure that this legacy will be honored and will continue to be built."

Portugal's defeat to France was Ronaldo's 212th cap, and the attacker has scored 130 goals for his country.

The former Manchester United, Real Madrid and Juventus star has played for Portugal in six Euros and four World Cups. He helped Portugal reach the 2004 and 2016 Euros, winning the latter.

## Babar, Shaheen, Rizwan 'unlikely' to get NOC for Canadian league



LAHORE: Pakistan skipper Babar Azam, pacer Shaheen Shah Afridi and wicket-keeper-batter Mohammad Rizwan are unlikely to get a no-objection certificate (NOC) to participate in the upcoming league Global T20 Canada, sources told Geo News on Friday.

The insiders revealed that the players will not get a NOC despite the Canadian league, which is scheduled from July 25 to August 11, not clashing with any series.

This is because all-format players will not be issued the certificate as per the policy. The Pakistan Cricket Board (PCB) is not in favour

of this due to busy international schedule, said the sources.

The development comes days after the cricket body decided not to grant fast bowler Naseem Shah the NOC to play The Hundred cricket league due to being an all-format player.

However, the Global T20 Canada has not yet received an approval from the International Cricket Council (ICC) due to several issues, the sources said.

They added that the NOC of the players will be formally decided only after the league gets an approval.

Pacer Mohammad Amir, Mohammad Nawaz, Asif Ali and Iftikhar Ahmed also have contracts in the Global T20 Canada.

Earlier this week, the PCB said that it would work out a technical process to issue NOC to the players and those who would fulfil the requirements would be granted the NOC.

"The players will be promoted on the basis of their fitness and performance. There's no place for players who do not fit the criteria. There'll also be no compromise on discipline," said PCB chief Mohsin Naqvi.—Agency

## Pakistan's chances bleak as Women's T20 Asia Cup begins today



DAMBULLA: The Pakistan women's cricket team will be back in action for the first time after their series defeats against West Indies and England, in the Women's T20 Asia Cup, which starts here on Friday.

While the opening fixture of the eight-team tournament will feature Nepal and UAE, Pakistan's first outing in the event will come against archrivals and favourites India a day later.

The Nida Dar-led team is drawn in Group 'A', along with India, UAE and Nepal. Group 'B', meanwhile, consists of Bangladesh, Malaysia, Thailand and Sri Lanka.

Given Pakistan's recent performances, their prospects to lift the trophy are bleak. In their last 14 matches, which included both One-day Internationals and T20s, Pakistan have tasted victory only once.

The disastrous run resulted in yet another change in their coaching setup, with Moham-mad Wasim taking over as the team's third head coach in the last 12 months.

## Zverev outlasts Gaston to reach Hamburg quarter-finals



HAMBURG: Roared on by Hamburg fans defending champion Alexander Zverev battled through to the quarter-finals Thursday with a 4-6, 6-2, 7-5 victory over Frenchman Hugo Gaston.

Hope Hope Zverev is recovering from a knee injury he suffered at Wimbledon but still covered the court as Gaston played a string of drop shots.

Gaston took the first set after a 30-ball rally, which Zverev was convinced should have been halted for a double bounce.

Zverev bounced back to break in the next game on his way to taking the second set.

The decider included five breaks of serve but Zverev took the last to lead 6-5 before holding serve to 15 to seal victory.

In the quarter-finals the German will face Chinese eighth seed Zhang Zhizhen who beat Flavio Cobolli, 6-1, 7-6 (7/5).

French fifth seed Arthur Fils also advanced, beating Serb Laslo Djere, last year's losing finalist, 7-6 (7/3), 6-2.

Fils, who made the semi-finals in Hamburg a year ago, reached his sixth four-level quarter-final this season.

That consistency has the 20-year-old top of the rankings in the ATP's 'Race to Jeddah', where the Next Generation under-21 finals will be played in December.

Fils has reached just one final, when he won on clay in Lyon in May 2023.

"When I'm practising super hard like I'm doing, of course I am able to show a great level and great fitness for a few hours," said Fils. "If a guy

wants to beat me, it has to be tough. I am not going to let the match go."

Fils will face second seed Holger Rune, who beat Marco Tringolli 6-4, 6-3 in 80 minutes.

The Dane said he had tried to turn his round of 16 straight sets loss to Novak Djokovic at Wimbledon into motivation.

"It's been very intense since Wimbledon. I only had one day off, actually," said Rune on court.

"I was like, 'I don't want to rest, I want to go straight back to practice', because I was very disappointed. I went straight back to work on the things that needed to be done, and now I have the chance to train those things in matches.—Agency

## Fresh injury concerns for Australia ahead of T20 World Cup



Australia are monitoring injuries to a pair of key players less than three months out from the start of this year's ICC Women's T20 World Cup in Bangladesh.

Spinner Sophie Molineux is the major injury concern, with the left-armed sufferer an acute rib fracture after being struck in the chest by a ball while batting last week.

Molineux is expected to be sidelined for up to eight weeks, leaving the 26-year-old with little time to return to full fitness ahead of Australia's first match at the T20 World Cup against Sri Lanka in Sylhet on October 4.

Molineux was named Player of the Series during Australia's recent T20I series in Bangladesh and is expected to lead a strong spin bowling contingent at the T20 World Cup alongside the likes of Georgia Wareham, Ash Gardner and Alana King.

Teammate Grace Harris is also battling her own injury concern, with the hard-hit-

ting all-rounder aggravating a calf problem recently and forced to withdrawal from England's domestic T20 competition The Hundred.

Harris was part of Australia's side when they won the most recent T20 World Cup in South Africa last year, while Molineux played her role in helping the six-time champions to success at the two tournaments prior in 2018 and 2020.

Cricketer Australia confirmed the injuries via a short statement.

"Molineux suffered an acute rib fracture after being struck by a ball in the chest while batting last week," the statement read.

Harris suffered an aggravation of a calf injury sustained in her preparation for the Hundred and the upcoming season. She is now working through a graduated rehabilitation and return to play program.—Agency

## Japanese gymnast sent home from Paris Olympics for smoking



PARIS: Japanese gymnast Shoko Miyata has been sent home from the Paris Olympics over allegations of smoking, local media reported Friday.

The Japan Gymnastics Association was investigating the 19-year-old captain of the women's gymnastics team to decide if she had breached their code of conduct, reports said.

Smoking is illegal under the age of 20 in Japan.

Several reports said that Miyata, who was expected to contend for a medal in Paris, had already left the team's training camp in Monaco.

Her participation in the Games was still "unclear", according to reports.

The reports said she did not attend training on Wednesday, with a JGA official saying her absence was "for certain reasons".

Japanese Olympic officials were set to hold a press conference in Tokyo on Friday afternoon.

Miyata won bronze in the balance beam at the 2022 world championships in Liverpool.

She won the all-around title at Japan's national championships earlier this year.—Agency

"It's fantastic to be a part of this team."

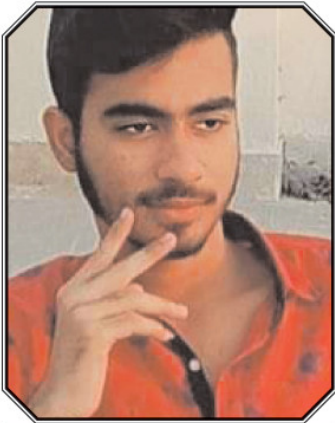
Bayer said they had signed the 27-year-old until 2029 but did not mention a fee.

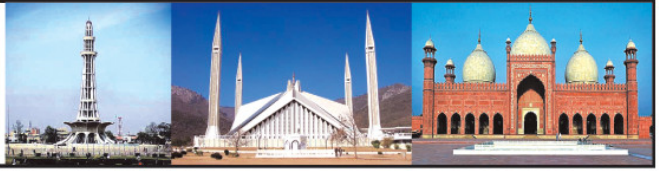
Lopez ditched the wedding ring yet again after her inconsistency over the past few weeks.

## K-P Assembly sets electricity rates at Rs. 15 per unit

The Khyber Pakhtunkhwa Assembly has approved a contract to set electricity rates at Rs. 15 per unit in the province. According to details, the agreement on electricity tariffs was presented by government member Fazal Elahi and has been accepted.

The contract stipulates that electricity generated at a cost of Rs. 2 per unit will be sold to the public at 70 to 80 rupees per unit, providing relief by supplying electricity at 10 to 15 rupees per unit and ending load shedding.

It was clarified in the agreement that under the constitution and laws, the province has the first right on its production. The issue of prolonged load shedding and hefty bills has sparked strong public reactions, evidenced by protests at electricity houses and forcible power reconnections, while provincial and federal governments have exchanged accusations over the matter.—RT/Agency

## Gohar Ejaz urges increased employment opportunities

Former interior minister Gohar Ejaz on Friday called for increasing employment opportunities.

## Cement and construction material prices surge post-strike

Lahore is experiencing a significant spike in cement prices and those of other construction material following a strike by the cement industry and the imposition of new taxes. This price hike is likely to impact the construction process.

The price of a cement bag has risen by Rs250 to Rs300, now ranging from Rs1,480 to Rs1,500. This increase has had a ripple effect, causing prices for other construction materials like sand, gravel, and bricks to also rise.

Shopkeepers are expressing deep concern about the impact on construction activities and the potential for a complete halt in business if the strike persists.

Shopkeepers are calling on the government to reconsider its decision on the new taxes to help stabilize prices and ensure the ongoing employment of those in the industry. They argue that the increased costs are not only affecting their businesses

but also putting a strain on the broader construction process, which could lead to delays and halted projects.

As the situation unfolds, both buyers and sellers are anxiously awaiting resolution, hoping for an end to the strike and a reassessment of the tax policies to mitigate the financial strain on the construction industry and protect jobs.—RT/Agency

## Senate body requests details of IPP agreements

ISLAMABAD: The Senate Standing Committee on Power sought details from the Power Division regarding the payments made to Independent Power Producers (IPPs) over the past 20 years, media reported.

The committee sent a questionnaire to the secretary Power Division and sought information of the payments made to IPPs.

The Senate Standing Committee on Power also sought the reasons behind these payments, and the details of the sponsors of all power plants set up in the private sector.

The committee also asked the Power Division to apprise on the construction costs of wind power plants and the production costs of electricity in the last six years.

The Ministry of Power has been directed to provide



all relevant details to the committee.

The secretary has been directed to submit all relevant record within three weeks.

Earlier, Federal Minister of Energy Awais Leghari said that the issue of the IPPs has been under consideration.

"We also seeing, how much benefit or loss given by an IPP and what mechanism required to remove an expensive power producer and what price we have to pay for it," energy minister said. "Can we bear the price of removing the IPPs," he questioned.—RT/Agency

## Stray dog kills infant inside home



PAKPATTAN: In a tragic incident occurred in Pakpattan, a seven-month-old baby died after being mauled by a stray dog, media reported quoting rescue sources.

According to the details, the stray dog entered the house and attacked the infant, who succumbed to his injuries during treatment at the hospital.

The rescue sources said that the infant was attacked by the dog inside his home in Pakpattan's Kamriyari village.

The child was being rushed to the hospital in injured condition but died on his way. The dog was later caught and beaten to death by the area people.

A staggering 5,641 dog-bite cases have been reported across Pakistan in just one

week, ARY News reported earlier citing National Institute of Health (NIH) sources.

Punjab topped the list dog, media reported quoting rescue sources. Khyber Pakhtunkhwa reported 615 cases, while Balochistan saw 80 cases. Meanwhile, 75 cases were reported in Azad Kashmir and 6 in Gilgit-Baltistan, sources added.

Last month, a shocking increase was reported in the number of dog bite cases as 7,957 cases were reported in one week across Pakistan.

In a significant development, the Dow University of Health Sciences (DUHS) in Karachi launched its own anti-rabies vaccine (ARV), namely DowRab, for the dog bites victims in Sindh.—RT/Agency

## Balochistan dismisses over 200 police officers



The Balochistan Police Department has dismissed over 200 personnel due to negligence and prolonged absence from duty.

The notification stated that the dismissed personnel include constables, head constables, and Assistant Sub-Inspectors (ASIs).

The notification further elaborated that the dismissed officers belong to various regions across Balochistan, including Quetta, Loralai, Sibi, Kalat, Zhob, Naserabad, and Makran. This widespread dismissal reflects the

department's commitment to upholding high standards of professionalism and dedication among its ranks.

The police department reiterated that negligence and absenteeism would not be tolerated, as they undermine the overall effectiveness of law enforcement operations.

The department urged all remaining personnel to adhere strictly to their duties and responsibilities, warning that similar actions would be taken against those failing to meet the required standards.—RT/Agency

## Khawaja Asif warns of potential constitutional crisis, election annulment

Pakistan's Defense Minister Khawaja Asif has acknowledged that the PML-N government acted hastily in announcing a ban on the Pakistan Tehreek-e-Insaf (PTI). He added that a constitutional meltdown is about to happen.

While speaking on Geo News on Thursday, Asif admitted that the decision was made prematurely and that consultations with coalition partners were crucial.

The government's surprise announcement on Monday, which also included plans to charge former Prime Minister Imran Khan, former President Anif Alvi, and Deputy Speaker Qasim Suri with high treason under Article 6, has faced strong opposition from both within and outside the ruling coalition.

Even the PML-N's key ally, the PPP, has criticized the move as undemocratic.

Asif clarified that the government will now seek a broader consensus among its allies before taking any fur-



ther action against the PTI. He emphasized that the decision to ban the party will be made only after achieving a unified stance.

He added that there is increasing chatter about elections being annulled by October.

When questioned about the perception that the government is facilitating a crackdown on Imran Khan, Asif vehemently denied the claim. He asserted that the government's actions are solely in the best interest of Pakistan.

Asif further accused the PTI of posing an existential threat to the country due to its behavior since being ousted from power. Expressing concerns about a potential constitutional crisis, Asif warned of a "constitutional meltdown" in Pakistan. While he did not elaborate on the specifics, he clarified that he was not referring to a possible military takeover.—RT/Agency

## PPP's Talha Mehmood seeks to mend JUI-F ties with the Centre

ISLAMABAD: Former federal minister and Pakistan Peoples Party (PPP) leader Talha Mehmood has offered to mend ties between the PML-N led coalition government and the Jamiat Ulema-e-Islam (JUI) to resolve their differences, media reported.

In an exclusive interview with ARY News, the former federal minister claimed that he had been approached by several leaders to help resolve the JUI issues with the government. He expressed his willingness to play a key role in mediating between the two parties.

Mehmood also advised PPP to accept the challenge and reconsider its decision to join the federal cabinet, as PML-N has been consistently asking them to join the cabinet.

Earlier, Prime Minister (PM) Shehbaz Sharif



The former minister claimed that he was awarded a ticket for senate membership by JUI but was not made a senator. He revealed that he had to seek votes from other parties to get elected, as the JUI did not have enough votes to get him elected on their own.

Called on Jamiat Ulema-e-Islam chief Maulana Fazlur Rehman at his residence in Islamabad. Prime Minister Shehbaz Sharif reached a former ally's residence to mend the ties that witnessed a rift after the February 2024 general elections. During the meeting, PM Sharif lauded the role of Fazlur Rehman for protecting democracy in Pakistan and also appreciated his religious services. ## Flour Mills threaten strike over wheat tax dispute

LAHORE: Following unsuccessful negotiations between Flour Mills and a government committee regarding the wheat holding tax issue, Flour Mills have once again threatened to strike. Last week, flour mills across Pakistan had initiated a strike, prompting the government to announce talks and form a negotiation committee.

The government had proposed a resolution to end the strike announced by the Pakistan Flour Mills Association, but with no progress in negotiations between the government committee and Flour Mills Association, there's a renewed threat of nation-



wide strikes and mill closures. Chairman of the Pakistan Flour Mills Association, Aamir Abdullah, warned that if the government does not abolish the wheat holding tax, mills will shut down again from July 23.

Just days ago, the Flour Mills Association had announced the postponement of their strike

for 10 days, citing record price increases in flour across many cities due to the strike.

It is clear that the Chairman of the Flour Mills Association has stated that the unfair tax measures will open a new door to corruption, leading to an additional Rs. 8 per kilogram increase in flour prices due to FBR taxes.—RT/Agency

## CM Bugti calls for integrated coordination to improve Balochistan's law and order

LORALAI: Balochistan Chief Minister, Mir Sarfraz Bugti, on Friday said that integrated coordination amongst all institutions was inevitable for improving law and order situation in Balochistan.

## Faisal Vawda Foresees PTI's Political Decline Amid Rising Tensions

KARACHI: Senator Faisal Vawda has warned that the Pakistan Tehreek-e-Insaf (PTI) is heading towards political turmoil, comparing its trajectory to that of the Muttahida Quami Movement Pakistan (MQM-P), media reported on Thursday.

Speaking on the media program, Faisal Vawda emphasized that PTI will face significant challenges, hinting at an approach political turmoil.

"No anarchist party can operate in Pakistan. Just as MQM becomes MQM-P PTI will also need to transform into PTI-P," Vawda stated.

He criticized PTI's current political strategy, suggesting that recent actions and slogans stem from confidence gained from court decisions. Vawda believes these actions have pushed PTI beyond constitutional limits, leading to a shaky position.

"After the court order,



PTI has gone 10 times ahead raising slogans against institutions, now they should be ready for the bulldozer," Vawda said.

Vawda further predicted that PTI's founder is unlikely to release from the jail, suggesting that internal calculations and government strategies will determine PTI's future.

He asserted that the Pakistan Democratic Movement II (PDM-2) has the intelligence to topple the government if needed.

The senator also accused the government of creating confusion and presenting an image of conflict with PTI and the institutions.

He anticipated that the political climate will heat up, predicting that the government may not adhere to the Supreme Court's decisions, further complicating the situation.—RT/Agency

## Rain Hits Karachi After Prolonged Heatwave



KARACHI: Heavy to light rain lashed different areas of Karachi on Friday after residents of the port city experienced sizzling temperatures in the last few days, with two deaths reported in the port city due to heatstroke a day earlier.

The areas that received showers include Gulistan-e-Johar, Gulshan-e-Iqbal, Surjani, North Karachi, New Karachi, Malir, Cantt, Mosmiyat, Shabrae Faisal, Bahadurabad, Tipu Sultan, Gulshan-e-Maymar and Gadap and others.

The metropolis has been in the grip of a heatwave for the last few days making life miserable for the masses as they face hours-long unannounced load-shedding despite the power utility's assurances.

The normal temperature in the city in July, as per the Pakistan Meteorological Department (PMD), has been

27.9°C and Tuesday night was the second hottest of this year after July 1 — when the temperature was also 32°C.

Two days earlier, the mercury in the port city reached a sweltering 40.5°C which in reality felt like scorching 56°C.

In a weather forecast today, the Met Office said monsoon currents from Arabian Sea were penetrating southern parts of the country and a westerly wave was affecting upper parts of the city.

As per the forecast, rain coupled with thundershower is likely to take place in Sindh, south Punjab, Khyber-Pakhtunkhwa, northeastern Balochistan, Potohar Region, Islamabad and Kashmir.

In addition, heavy falls are expected at isolated places in south Punjab and lower Sindh during the period.—RT/Agency

## Sindh Government Revitalizing Waterways with LBOD Syphons, Espinal Escape: Murad

KARACHI: Sindh Chief Minister Syed Murad Ali Shah has said that the construction of LBOD Syphons and Espinal Escape regulator at RD-210 has revived old and natural waterways intending to protect the lands of Badin, Mirpurkhas, Sanghar, and Nawabshah from deterioration.

This he said while presiding over a meeting to review the revival of natural routes of old and natural waterways here at the CM House on Friday.

Minister Irrigation Jam Khan Shoro, Advisor to CM Ahsan Mazar, Chief Secretary Asif Hyder Shah, PSCM Agha Wasif, Secretary Irrigation Zarf Khero and others attended the meeting.

Minister of Irrigation, Jam Khan Shoro, briefed the CM, stating that the Left Bank Outfall Drain (LBOD) Syphons have been constructed to restore the natural old waterway route from Dhoro Puran to Shahkoo Dhandh. Additionally, he mentioned the benefits of diverting the MM Drain and Digri Dhoro discharge into Dhoro Puran via a siphon at RD 275, connecting to Hakro Dhoro.

The CM said that during



the heavy rainfall of 2022, Pangrio Dhoro posed a significant threat to the LBOD system and its vicinity. He observed that the siphon would manage the higher discharge from Pangrio Dhoro by diverting it into Dhoro Puran, which ultimately falls into Shakoor Lake, thus mitigating the risk and enhancing the system's capacity.

Minister Irrigation told the CM that during monsoon 2022, the spinal gauges have risen over to its ever-maximum gauges of 2011. The spinal was designed for providing 4600 causes, whereas at present about 12000 causes water passing through it sea.

Murad Ali Shah said that the two major breaches in Puran Dhoro occurred in RD-7 & 8 on August 28, 2022, out of which the breach of RD-8 of Puran Dhoro was closed on the very next day

while the efforts for the closing breach of RD-7 Puran Dhoro were successful at the first attempt. "After the construction of siphons this issue would be resolved," he said.

Rehabilitation of LBOD Spinal Drain Secretary of Irrigation Zareef Khero told the CM that after the revival of natural dhoro through the construction of siphons and the rehabilitation of the LBOD system, the excess load on the spinal drain will be alleviated. This will lower the spinal drain levels, providing unimpeded access to the main drains of the LBOD system, including the drainage networks of Nawabshah, Sanghar, Mirpurkhas, and Badin. The High Flood Level (HFL) of the Spinal Drain recorded in 2022 was 27.53 feet. The top level has now increased by 4 feet, reaching 31.53 feet.—RT

## Karachi's Peoples Bus Service Introduces New Routes

KARACHI: The Sindh Transport Department has announced to launch of three new routes for the Peoples Bus Service in Karachi, media reported.



Sindh Transport Minister Sharjeel Inam Memon said that the new routes for the Peoples Bus Service include Hawksbay to Tower, which will commence operations on July 22, and an extension of Route 12.

From July 23, the Peoples Bus will start its service from Qaidabad, Korangi, and Memon Goth to Tower, which was earlier from Khokhrapur.

Additionally, an electric bus route will be introduced from Kathore to Numaisht, starting on July 24, and a new route from Yousuf Goth to Tower will begin operations on July 25.

The transport minister

said that the aim of these new routes is to provide affordable transportation services to the citizens of Karachi.

Furthermore, the department plans to introduce more new buses and routes in the future to enhance the public transport system in the city.

Last month, the Sindh government announced new routes for People's Bus Service in Karachi.

Sindh Transport Minister Sharjeel Inam Memon addressed the transport workers of Karachi by announcing additional Peoples Bus Service routes. The meeting, attended by elected MPs from Karachi, deputy mayor and others decided to launch new routes in Malir, Keamari, Lyari and district West of the port city. The meeting decided to launch a new bus route from Numaisht to Hawks Bay.—RT

## Karachi Police Capture Six Notorious Dacoits in Landhi



KARACHI: The police on Friday arrested a group of wanted dacoits, who used to loot people withdrawing cash from banks, from Karachi's Landhi area.

Senior Superintendent of Police (SSP) Korangi Theerth Rehman said the arrested group has confessed to several incidents in different areas of the city.

Rehman said that the police recovered 18 stolen mobile phones and cash from the group as well as weapons. He added that the group was very active in Shah Latif, Sohrab Goth, Saddar, Sharea Faisal and Korangi.

The SSP also said that the initial investigation revealed that the suspects also looted dozens of shops.

"The suspects had robbed the shop of a famous biryani seller in Landhi no 6 and a CCTV footage of them robbing Rs55,000 had also gone viral," said SSP Rehman.

The group also robbed a citizen of Rs170,000 in Shah Faisal on the sixth day of Eid ul Fitr. The suspects also stole Rs300,000 from a person in Qaidabad 1.5 months ago, Rs168,000 in a robbery at general store in Akhtar Colony last month.

Rehman said that they also committed robberies at Singer Chowringhi and Landhi 89, adding that they used to loot people withdrawing cash from bank as well as shops.

"One of the suspects, Abid, revealed that he shot a citizen during a robbery in New Karachi area," said the SSP.

He said that Ali Raza, Zafar Iqbal, Haider, Abdul Rehman, Liaquat and Abid have been arrested while raised are being conducted to arrest two other accomplices.—RT/Agency

## Home Minister, IGP Attend Funeral of Martyred Policeman

The Sindh Home Minister expressed his condolences and sympathy with the relatives of the martyred constable and said that the Sindh government and the Sindh Police Department were with them in the time of sadness. Paying tribute to the services of the martyred constable of the Sindh Police, Lanjar said that the sacrifices of the police martyrs for the security of life and property of the people and the establishment of peace were priceless and unforgettable. On this occasion, the home minister issued special orders to the senior officers present there to provide the prevailing benefits to the heirs of the martyr.—RT

## German Consulate in Karachi Reopens Services for Non-EU Nationals

The German consulate general in Karachi has resumed its normal operations for non-European Union citizens, said a statement on Friday.



"The Consulate General of the Federal Republic of Germany, Karachi has resumed normal operation for non-EU citizens," the consulate said in a statement shared on Facebook.

Earlier this month, the consulate closed its services for non-European Union citizens until further notice. It did not mention any reason for that. But already issued visas for non-EU citizens were allowed to be picked up.

Germany is one of the top destinations for international students, including those from Pakistan.

The EU country recently launched an Opportunity Card to entice skilled workers from outside the bloc to come to the country and seek work for up to a year if they fulfill the right criteria.

According to the Face-

book groups, several people from Pakistan have filed for visa interviews and waiting for appointments.

The German embassy in Pakistan opened the student visa registration list for students holding university admission letters for the winter semester of 2024-2025 on May 21.

An exclusive online registration category called "Registration to Apply for a Master's Program" is specifically for students with a cumulative grade point average (CGPA) of 3.7 or above, who will also receive prioritized consideration.

The basic documents required for this include an application form, a biometric picture, passport copies, ID copies, an applicant declaration and appointment confirmation email, and information about any previous visa refusals with a curriculum vitae, admission letter, enrollment certificate, confirmation of sufficient language skills in the language of instruction, sufficient financial means, and health insurance.—RT/Agency

## Bodies of Four Pakistanis Killed in Oman Returned Home

KARACHI: The bodies of four Pakistanis who were killed in a rare attack at a mosque in Muscat, Oman, were repatriated to the country, a spokesperson for Pakistan International Airlines (PIA) said Friday.

The assault — for which the terrorist organisation Daesh took responsibility and Pakistan labelled as a "dastardly" terror attack — occurred on Monday evening at the Ali bin Abi Talib mosque in the Wadi al-Kabir neighbourhood of Muscat.

The Royal Oman Police said the three gunmen — all Omani nationals — were brothers and "were killed due to their insistence on resisting security personnel". It said that police investigations had indicated the three gunmen were "influenced by misguided ideas".

The six people killed by the gunmen were four Pakistani nationals, an Indian, and a police officer responding to the attack. Twenty-eight others were injured.

In the statement, the PIA said the body of deceased Syed Qaiser had been brought to Karachi and would later be transported to Lahore. Meanwhile, the bodies of Ghulam Abbas and Hasan Abbas have been transported to Islamabad, while Suleman Nawaz's to Lahore.

It was the first known operation claimed by the Daesh group in the sultanate, which is among the most stable countries in the Middle East.

Monday's attack came ahead of Ashura, an annual day of mourning that commemorates the seventh-century martyrdom of Imam Hussain, his family, and companions in the battle of Karbala.—RT/Agency

## Pakistan Bar Council clarifies about letter issued against Secretary Irrigation

KARACHI: The Pakistan Bar Council has intervened in a matter involving Advocate Akhtar Hussain Jabbar and Advocate Sajid Qamar Shaikh of the Sindh Bar Council. It appears that Advocate Jabbar caused a disturbance during a visit to the office of Secretary Irrigation, Zarf Iqbal Khero. Following this incident, Advocate Sajid Qamar Sheikh, on advice from Advocate Jabbar, issued a letter on the official letterhead of the Sindh Bar Council requesting the filing of a case against Secretary

Zarf Iqbal Khero. Upon learning of this development Secretary Zarf Iqbal Khero reported the matter to the Pakistan Bar Council. Subsequently, the Pakistan Bar Council has suspended the letter issued by the Sindh Bar Council, emphasizing that no bar council has the authority to request the filing of a case against any individual citizen. The Council has sought explanations from Advocate Sajid Qamar Sheikh and Advocate Akhtar Hussain Jabbar regarding their actions. It has also warned that their bar licenses may be suspended pending further investigation and explanations. Secretary Zarf Iqbal Khero has expressed gratitude for the swift action taken by the Pakistan Bar Council, stating that Advocate Jabbar's unwarranted behavior led to the unjust letter being issued against him by the Sindh Bar Council. He appreciates the Pakistan Bar Council's intervention, which he believes upholds the integrity and prestige of the legal profession.—RT

## TLP Ends Faizabad Sit-In After Reaching Agreement With Government

Faizabad: The Tehreek-e-Labbaik Pakistan (TLP) on Friday called off its sit-in in the Faizabad area of Islamabad after the federal government assured them that they would ramp up efforts to help out Palestinians, who have been facing Israeli atrocities since the clash began in October last year.

The TLP's decision came this afternoon after the incumbent government engaged in successful negotiations with them.

Before the TLP started their protest sit-in at the Faizabad Interchange almost a week ago, the party's activists, led by their top leader Saad Rizvi, took out a protest rally from Liaquat Bagh in Rawalpindi to Faizabad last Saturday.

The TLP, in their demands, asked the PML-N-led government to officially boycott Israeli products and send food and medical aid to Palestinians, especially those suffering from Israel's relentless military aggression in Gaza.



One of their demands was that Pakistan's government declare Israeli PM Netanyahu a "terrorist." He added that Israel emerged as a terrorist state and Prime Minister Benjamin Netanyahu committed war crimes against innocent citizens.

"The Israeli PM is committing war crimes in his personal capacity," the PM's adviser said, adding that Prime Minister Shehbaz Sharif had condemned Israeli atrocities in Palestine during the Shanghai Cooperation Organisation (SCO) summit held earlier this month in Kazakhstan's capital of Astana.

The government will push ahead in its condemnation of Israel in the future as well, he said, adding that the government would seek to tap into every resource possible to extend assistance to people in Gaza as well as condemn the Zionist state and its head of government involved in terrorism against innocent Palestinians.

"Netanyahu is a terrorist who has perpetrated war crimes," the former security czar said, calling on the community of nations to bring the Israeli PM to task.

He also called on world leaders, particularly the Muslim world, to play their due role in the resolution of the humanitarian crisis unfolding in Palestine.

The week-long protest posed serious traffic problems for the residents of the twin cities as the TLP workers in large numbers remained camped at Faizabad Interchange, a main traffic junction linking the two cities. The sit-in brought vehicular traffic to a complete halt between Murree and Rawalpindi, and Peshawar and Lahore. The activists effectively also blocked the Islamabad Expressway which caused massive gridlocks in the area, leaving commuters to face troubles for hours at a stretch.—RT/Agency

## ECP To Enforce Supreme Court's Order On Reserved Seats

ISLAMABAD: The Election Commission of Pakistan (ECP) has decided to implement the Supreme Court's order on allotting reserved seats to the Pakistan Tehreek-e-Insaf (PTI).

In a major legal victory for the PTI and a setback for the rulers, the apex court had on July 12 ruled that PTI was and is a political party that won general seats in the national and provincial assemblies in the February 8 elections, thus, is entitled to reserved seats.

The court, by a majority of 8, set aside the Peshawar High Court's judgement of March 25 and declared the ECP order of March 1 to be ultra vires the Constitution, without lawful authority and of no legal effect.

Justice Mansoor Ali Shah of the SC's full bench announced the 8-5 majority verdict, nullifying the PHC's order wherein it had upheld the ECP's decision denying the reserved seats to the PTI-backed SIC.

In a statement, the ECP said the decision was taken after the electoral body held two meetings on Thursday and Friday to deliberate on the reserved seats case verdict.

The statement further said that directives have been issued to the ECP's legal team to immediately "identify" any obstacle in the implementation of the verdict so that the apex court could be approached for guidance.



Moreover, the commission strongly condemned and rejected the undue criticism of the chief election commissioner and honourable members by a political party," the ECP's said without naming the Imran Khan-founded party.

"Demanding the resignation [of CEC and members] is ridiculous," it added while referring to the demand put forward by the PTI after a legal victory in the Supreme Court.

The commission further stated that it worked in line with the Constitution and laws while not succumbing to any type of pressure.

Moreover, the ECP stated that 39 candidates who had been declared as PTI MNAs had shown their affiliation with the embattled party in their nomination papers, while to be a candidate of any party, it is necessary to submit the party ticket and declaration to the returning officer (RO).

But in the case of the said MNAs, these documents were not submitted to the ROs; therefore the ROs couldn't declare them PTI candidates, it added.

Meanwhile, the 41 candidates who had been declared independents hadn't mentioned PTI in their nomination papers neither they disclosed their affiliation with the party nor submitted the ticket of any party.

"Therefore, the ROs allowed them to contest the election as independents. Later, these MNAs voluntarily joined the Sunni Ethab Council (SIC) within three days as required by law after winning the election," the statement read.

The party appealed the decision of the Election Commission and the PHC in the Supreme Court, but it was rejected.

It further added that the PTI was neither a petitioner in the case against the ECP in the apex court nor the PHC.

The ruling party, Pakistan Muslim League-Nawaz, has filed a review petition in the apex court against the verdict, which came as an unexpected legal victory for the main opposition party.—RT/Agency

## PTI Urges JCP Members To Reject Ad Hoc Judges Appointments In Open Letter

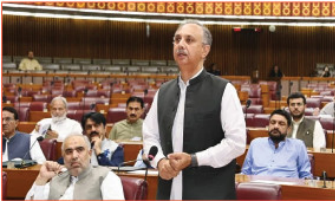
ISLAMABAD: The Pakistan Tehreek-e-Insaf (PTI) Friday asked the Judicial Commission of Pakistan (JCP) to turn down a proposal of hiring ad hoc judges to the Supreme Court as it may create concerns about the judiciary's independence.

The PTI has been raising concerns over the appointment of ad hoc judges, claiming that the move is aimed at targeting the party, while the government has supported the decision, saying it falls under the ambit of law.

The JCP, set to meet today, was about to consider the appointment of four ad hoc judges for a three-year term — Sardar Tariq Masood, Mushir Alam, Maqbool Baqar, Mazhar Alam Minkhel. However, Baqar and Alam have rejected the offer.

While Alam noted that he was busy with philanthropic work post-retirement, Baqar opted out due to "personal reasons" and said that the criticism of the appointment of ad hoc judges was baseless.

In his letter to the JCP members, Ayub said that he has "great concern" at the recent proposal to appoint as many as four ad hoc judges in the Supreme Court for a period of three years.



Ayub noted that he was writing the letter as the matter of the appointment was not being presented before the parliament's committee, therefore, PTI lawmakers did not have a platform to voice their concerns.

"This is particularly so since the Opposition in the National Assembly and Senate, which may otherwise have had an opportunity of presenting its perspective in the Parliamentary Committee in the matter of appointment of judges, would not have any other opportunity of presenting its view in the matter of appointment of ad hoc judges."

In such a serious matter as the appointment of judges, Ayub said, there should not be any room to give any impression that the appointment of ad hoc judges in the Supreme Court is an attempt

## US Urges Protection Of Journalists After Hassan Zaib's Murder



WASHINGTON: The US State Department has stressed the need to protect journalists across the globe after the murder of Pakistani reporter Malik Hassan Zaib, who lost his life last week in a targeted attack in Nowshera, Khyber Pakhtunkhwa.

Zaib — who, according to the International Press Institute, was the eighth journalist to be killed in Pakistan since the beginning of 2024 — was in a car with his brother when two unidentified assailants on a motorbike stopped his vehicle and shot the journalist dead on the spot.

His brother survived the attack and filed a first information report (FIR) of the incident. The motive behind the 40-year-old journalist's killing is unclear.

"Journalists need to be protected and they need to be allowed to do their jobs, whether that be the United States, whether that be Pakistan, whether that be in the Gaza Strip," State Department's Principal Deputy Spokesperson Vedant Patel said Thursday.

His response came during a press briefing when he was asked to comment on the death of Zaib.

"That is something that we feel strongly, and it's something that is deeply personal to the Secretary [Antony Blinken]," he noted. "It's obviously personal to us and this team having — spending most of our days engaging with you all. But simply put, journalists need to be protected and need to be able to do their jobs," Patel added.

At a daily publication, Zaib covered health and city beats. He was also a member of the Khyber Union of Journalists and the Peshawar Press Club (PPC).—RT/Agency

## PM Consults Allies on Supreme Court Reserved Seats Decision

ISLAMABAD: Prime Minister Shehbaz Sharif on Friday will begin consultations with allied parties including Pakistan Peoples Party (PPP) over the Supreme Court's 8-5 verdict on reserved seats.

According to the sources, Pakistan Muslim League-Nawaz (PML-N) has decided to take its main ally, PPP, into confidence. The talks will take place at the President's House this afternoon.

The leadership of both the political parties will meet today, said the sources, adding that the meeting will also be attended by President Asif Ali Zardari.

The sources revealed that Foreign Minister Ishaq Dar, Law Minister Azam Nazeer Tatar, Information Minister Attallah Tarar will attend the meeting on behalf of the PML-N.

Meanwhile, Special Assistant to PM for Law Irfan Qadir, Ahmed Cheema Irfan Qadir, Ahmed Cheema, National Assembly Speaker Ayaz Sadiq will also participate in the talks, they added.

From PPP's side, Farook H Naek, Sherry Rehman and Nayyar Bokhari will participate in the talks, claimed the sources. Attorney General Mansoor Awan will give a



briefing to President Zardari and other members.

The development comes a week after the top court ruled that Pakistan Tehreek-e-Insaf (PTI) was eligible for the allocation of reserved seats for women and minorities.

Justice Mansoor Ali Shah of the SC's full bench announced the 8-5 majority verdict, nullifying the Peshawar High Court's (PHC) order wherein it had upheld the Election Commission of Pakistan's (ECP) decision denying the reserved seats to the SIC. Following the verdict, the PML-N on Monday filed a review petition in the Supreme Court against its verdict. It nominated 11 respondents in the plea including the Sunni Ethab Council (SIC) and its chairman Hamid Raza, praying the court to suspend its ruling

dated July 12, 2024, on the reserved seats.

The review petition asked a number of questions including whether the SIC should be granted the reserved seats.

It questioned if reserved seats could be granted to a political party who had not submitted a party list within the prescribed time, whether a political party can be given reserved seats whose candidates have not even filed nomination papers within the time provided by the Election Commission of Pakistan and if independents could even join a political party which did not win a single general seat in parliament.

The plea also raised question if the seats could be left vacant or have to be distributed amongst the political parties contesting for the said seats.—RT/Agency

## PTI And JUI-F Agree To Start Formal Talks

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) and Jamiat Ulema-e-Islam-Fazl (JUI-F) have agreed to hold formal talks, ending a three-week-long deadlock between the two parties, media reported.

As per details, the meeting was held at the residence of JUI-F chief Maulana Fazal-ur-Rehman last night, attended by PTI leader Asad Qaiser and Maulana Abdul Ghafoor Haideri.

The meeting discussed various issues, including the country's political situation, economy and parliamentary affairs.

The two sides also discussed the possibility of forming an alliance, on the situation emerged after February 8 elections.

PTI and JUI-F agreed to establish negotiating committees to hold formal talks. The PTI has already formed a five-member committee, while the JUI-F is expected



to announce its committee soon.

The development was confirmed by Maulana Abdul Ghafoor Haideri, stating that the talks will focus on finding common ground between the two parties.

Earlier, Maulana Fazlur Rehman said that it would be "fortunate" if his party and the Pakistan Tehreek-e-Insaf (PTI) develop a consensus. Maulana Fazlur Rehman said that there were big "mountain-sized" differences between the two parties. "PTI's delegation has come to us and as per our

tradition, we have welcomed them," Maulana Fazlur Rehman added. The JUI-F chief said that if their issues with the PTI get resolved, it would be good. "If not, every political party has its stance and opinion," he said. Maulana Fazlur Rehman said that PTI's delegation had suggested resolving some issues, and both parties agreed to do so.

He said one or two people from PTI come up with "inappropriate" statements to hold formal talks, adding that they don't take those statements seriously.—RT/Agency

## PTI And PML-N Warn Of 'Constitutional Crisis'

ISLAMABAD: After the Pakistan Muslim League-Nawaz (PML-N), the Pakistan Tehreek-e-Insaf (PTI) has also expressed fear of a constitutional breakdown in the country, amid an ongoing tug of war over reserved seats.

Talking on media programme "Aaj Shahzeb Khanzada Kay Sath", senior PTI leader Hamid Khan said Thursday that the incumbent government was dragging the country towards a constitutional breakdown with its unconstitutional moves.

Pointing towards the PML-N government's opposition towards the Supreme Court verdict allowing the PTI to claim reserved seats in the parliament, Hamid said the entire constitutional system would collapse if the apex court's judgments were not implemented.

On the other hand, Defence Minister Khawaja Asif, during the same programme, also expressed fears about a "constitutional meltdown" in the country.

"I don't have any information [but] this is just my gut feeling that constitutional breakdown is about to happen, sooner or later [but] it is going to happen," he said without elaborating further.

However, the PML-N leader clarified that he was



not discussing the possibility of martial law being imposed in the country. "There should be a political solution to political problems," he maintained.

Amid facing opposition from friends and foes alike, the federal minister admitted that the PML-N-led government announced the move to ban the PTI in a haste. "Yes, you can say that we declared this prematurely and consultation with the allies [in this regard] is mandatory," he added. Asif said any decision regarding imposing a ban on the PTI would be taken in line with the consensus among the allies. "We will take this major step after creating broad consensus InshaAllah," he maintained. When asked about the perception that the incumbent rulers are playing the role of facilitator in the institutions' alleged fight against jailed PTI founder Imran Khan, he rejected the

## Microsoft Announces Fix For Worldwide IT Outage



Microsoft (MSFT.O) said on Friday that underlying cause for a global outage has been fixed, but the residual impact of cybersecurity outages are continuing to affect some Office 365 apps and services.

A software update wreaked havoc on computer systems globally on Friday, grounding flights forcing some broadcasters off air and hitting services from banking to healthcare. An update to a product offered by global cybersecurity firm CrowdStrike (CRWD.O), appeared to be the trigger, affecting customers using Microsoft's (MSFT.O) Windows Operating System. Microsoft said later on Friday the issue had been fixed. CrowdStrike CEO George Kurtz said on social media platform X that

the company was "actively working with customers impacted by a defect found in a single content update for Windows hosts" and that a fix was being deployed.

"This is not a security incident or cyberattack," Kurtz said in the post.

Early on Friday, major U.S. airlines - American Airlines (AAL.O) Delta Airlines (DAL.N) and United Airlines (UAL.O) - grounded flights, while other carriers and airports around the world reported delays and disruptions. Banks and financial services companies from Australia to India and Germany warned customers of disruptions and traders across markets spoke of problems with executing transaction.—RT/Agency
