KP Government To Form Commission To Investigate Bannu Incident

PESHAWAR: The Khyber Pakhtunkhwa government on Saturday announced to form a commission to conduct a transparent investigation into the Bannu incident in which at least four people were killed while several others sustained injuries.

The development comes a day after the civilians were killed in a firing incident during a protest rally in Bannu district against the worsening law and order.

The protest was staged on the call of the trader community, where a complete shutter-down strike was observed. They were demanding action against the armed groups operating in the city and its adjoining areas.

Many people were also injured due to the stampede. KP Chief Minister Ali Amin Gandapur has taken notice of the ongoing situation in Bannu and an-



nounced the formation of a commission for transparent investigation of the incident," said Adviser on Information Barrister Muhammad Ali Saif.

The adviser said that the commission will conduct a transparent and impartial investigation and submit its report which will be made public and legal action will be taken against those responsible.

He also said that the commission's report would

identify those who were involved in the incident, stressing that rumours and unverified allegations should be avoided before the report.

Barrister Saif said that the security is usually on high alert in sensitive places. He highlighted that the sensitive nature of the area was also the reason behind the incident. He advised the people to remain careful amid the ongoing wave of terrorism.—RT/Agency

Teflon Nawaz Admits Power Bills Are Unaffordable For Many, Laments Current State Of Affairs

LAHORE: Criticising the decisions of the previous rulers, ruling Pakistan Muslim League-Nawaz (PML-N) President Nawaz Sharif said Saturday that the country "is not being treated well which was achieving development goals and got rid of the International Monetary Fund (IMF)".

"Justice is offered to a man roaming in the street," said Nawaz who stepped down as prime minister in 2017 after the Supreme Court disqualified him for not declaring a receivable salary.

"What is the need [of such decisions] which increased sufferings of this country," the former premier questioned, lamenting that the country was suc-



cessfully achieving the milestones of development and prosperity before his ouster from power.

He made the statement while chairing a high-level session alongside Punjab Chief Minister Maryam Nawaz to review matters related to the CM Solar Panel Scheme 2024 in Lahore today.

"Electricity bills be-

come a trouble for everyone [...] not only for poor people but for everyone," he added. The PML-N president claimed that his government "eliminated loadshedding and controlled electricity rates".

He also took credit for maintaining a low inflation rate and a stable currency, as well as "getting rid of the IMF" programme but

all positive efforts went in vain after the change of regime in 2018. "All of us know well, who bring the IMF to this country, again."

"The decision-makers will have to think now and care about our people," he insisted.

He asked Prime Minister Shehbaz Sharif-led administration "to do everything to provide relief to the masses". Nawaz's statement came after cash-strapped Pakistan and the global lender reached a three-year, \$7 billion bailout programme "endorsed by the federal and provincial governments", the Washington-based institution announced last week.

Regarding the new loan, PM Shehbaz, in his address

to the nation, pledged that the new bailout package with the global lender will be the last in the country's history.

"The new programme, which needs to be validated by the IMF's Executive Board, should enable Pakistan to cement macroeconomic stability and create conditions for stronger, more inclusive and resilient growth," according to a statement issued by the global lender. Subsequently, tough measures in line with the IMF conditions such as raising tax on agricultural incomes and lifting electricity prices have prompted concerns about poor and middle-class Pakistanis grappling with rising inflation and the prospect of higher taxes.—RT/Agency

Pakistani Students In Bangladesh Moved To Safety Amid Deadly Protests: FO

ISLAMABAD: As the ongoing deadly protests in Bangladesh widened, Pakistani students present in the South Asian country have been moved to safety to keep them from harm, a Foreign Office spokesperson said on Saturday.

Student-led protests against the job quota have killed at least 110 people this week, with the government deploying army to quell the deadly events.

For five days police bullets have fired tear gas, rubber pellets and hurled sound grenades to scatter protesters throwing bricks and setting fire to vehicles.

Assuring the safety of the Pakistani students present in Dhaka and other cities of Bangladesh, the FO said that they had been shifted to secure locations.

The spokesperson said that Pakistan's mission in Dhaka is in contact with all the Pakistani students and the deputy head of the mission has met some of them present in Chitagon.

"All students are safe," the FO spokesperson said, adding that the Pakistani



High Commission has accommodated them at safe sites.

"These include the high commission building, the Pakistani ambassador's residence, and some other safe places," the statement added.

The demonstrations — the biggest since Bangladesh Prime Minister Sheikh Hasina was re-elected for a fourth successive term this year — have also been fuelled by high unemployment among young people, who make up nearly a fifth of the population.

With the death toll climbing and police and other security forces unable to contain the protests, Hasina's government imposed a national curfew and deployed

the military, who were given orders to shoot on sight if needed.

Soldiers patrolled the deserted streets of the Bangladesh capital Dhaka on Saturday, setting up roadblocks during a curfew imposed in response to the protests.

Internet and text message services have remained suspended since Thursday, cutting the nation off as police cracked down on protesters who defied a ban on public gatherings. Overseas telephone calls mostly failed to connect while websites of Bangladesh-based media organisations did not update and their social media accounts remained inactive.—RT/Agency

IPPs Received Rs 450 Billion In First Three Months Of The Year: Gohar Ejaz



ISLAMABAD: The independent power producers (IPPs) have been made heavy payments of Rs 450 billion in first three months of the current year.

Former caretaker commerce minister Gohar Ejaz has shared the data of the capacity payments to IPPs. "Various IPPs were paid monthly 150 billion rupees from January to March," Gohar Ejaz has said.

He said that among the independent power producers' 50 per cent operating with below 10 per cent of their generation capacity. "Four power plants getting 10 billion rupees monthly without generating electricity," former minister said.

"Our hard-earned money being paid to 40 families in capacity payments," he said. "These power plants should be made payments when they generate electricity," he said.

Gohar Ejaz also de-

mandated representation to all stakeholders in the National Electric Power Regulatory Authority (NEPRA).

"The government should not run its business with the public money and avoid excesses with power consumers," he added.

Gohar Ejaz had earlier demanded record of the payments made to the independent power producers.

He demanded that the nation should be informed about how much electricity generated by each power plant according to their capacity.

He had also demanded the record of capacity payments made to the IPPs should be made public and the data of their generation costs should also be disclosed. He also demanded that the agreements with the IPPs should be converted into "take and pay" mode.—RT/Agency

PM Orders For Swift Implementation Of Deals To Boost Foreign Investment From China

ISLAMABAD: Prime Minister Shehbaz Sharif on Saturday directed the authorities concerned to expedite process of implementing the agreements and memorandum of understandings (MoUs) made with the Chinese government and companies, saying that delay in implementation of the agreements would not be tolerated.

China is a time tested friend of Pakistan who helped Pakistan in every hour of need, the prime minister said while chairing a review meeting regarding P-China cooperation at the PM House.

The meeting was attended by Deputy Prime Minister and Foreign Minister Ishaq Dar, federal ministers including Jam Kamal Khan, Abdul Aleem Khan, Ahd Khan Cheema, and other officials including PM's aides.

During the meeting, PM Shehbaz said the Chinese leadership was determined to further expand investment in Pakistan.

He pointed out that the transfer of the Chinese industry to Pakistan would help improving the country's overall economy, increasing Pakistan's exports, and creating new employment opportunities.

During the meeting, the premier was briefed on



progress of different projects that were launched with the Chinese cooperation.

He was told that Sukkur-Hyderabad Motorway would be completed through Public-Private Partnership.

Moreover, the authorities informed the PM that the plan to send 1,000 students for modern agricultural vocational training at government expense had been completed.

The first batch of students was being sent to China at the beginning of this academic year while the next batch would be sent to the Chinese modern agricultural universities after completing Chinese language course in Pakistan.

Furthermore, the meeting was informed that the plan to transfer the power plants running on imported coal to local coal was also in the final stages.

In regard with the business and investment opportunities in Pakistan, a road

show was being organised in Beijing with the cooperation of China. A comprehensive road map was presented to the meeting regarding the transfer of Chinese industries in Pakistan.

It was informed in the meeting that the Chinese textile, medical and surgical equipment, plastic and leather industries will move to Pakistan.

"78 Pakistani companies have initially expressed interest in cooperation for the transfer of Chinese industries to Pakistan," the meeting was informed.

In this regard, the Board of Investment (BoI) presented a comprehensive report on the progress and action plan. PM Shehbaz appreciated the steps and recommendations of BoI and directed the relevant departments and officers to provide all kinds of facilities to Pakistani companies in collaborating with Chinese companies.—RT/Agency

Imran Rules Out Talks With PPP On No-Confidence Motion

ISLAMABAD: Former prime minister and PTI founder Imran Khan firmly ruled out any possibility of discussions with the Pakistan Peoples Party (PPP) regarding a no-confidence motion.

During an informal conversation with journalists at Adiala Jail on Saturday, Khan expressed his unwavering stance, asserting that PPP and Pakistan Muslim League-Nawaz (PML-N) were indistinguishable and both were products of "manipulated" electoral processes.

Khan criticised the current political climate, describing it as detrimental to democracy.

He highlighted the restrictions placed on his party, stating that key leaders, including the chairman and vice chairman, were already imprisoned, yet the government still threatened further bans on the party.

He condemned this as an attack on democratic principles. Addressing the conditions in Adiala Jail, Khan detailed the harsh treatment he faced,



including unsanitary conditions and inadequate food. He called for an investigation into the alleged poisoning and mistreatment during his imprisonment.

Khan also voiced his strong condemnation of the Bannu incident, where he claimed the military fired on unarmed civilians during a peace march.

He demanded a judicial inquiry to ensure accountability.

On the economic front, Khan criticised the government's fiscal policies, questioning the increase in the presidential budget and accusing the ruling elite of burdening the public while avoiding personal sacrifices.

He emphasised that

transparent elections and economic reforms were essential for Pakistan's recovery from its current crisis.

Khan dismissed allegations related to his involvement in dissolving assemblies, stating that actions were taken in response to foreign interference, specifically referencing Donald Trump's statement.

He called for an investigation into the events of May 9, questioning why CCTV footage had not been released and why a judicial commission had not been established.

Despite facing potential lifelong imprisonment, Khan declared his readiness to stand by his principles.—RT/Agency

Assigning Political Cases To Retired Judges Is Inappropriate: Fawad



LAHORE: Former federal minister Fawad Chaudhry raises objection to the appointment of retired judges for the adjudication of political cases.

Speaking to media outside the anti-terrorism court, Lahore, where the ex-minister was due to attend the hearing of the arson case, he said it's a good gesture that the Election Commission of Pakistan was not going to file a review petition against the Supreme Court's ruling on reserved seats.

He urged the ECP to follow the Lahore High Court chief justice's decision regarding tribunals. He claimed that Punjab Chief Minister Maryam Nawaz would be in a hot seat if Form 45 is opened.

He emphasised that only serving judges, not those who retired, should be at the helm of political cases. Meanwhile, the anti-terrorism court extended the interim bails of Fawad Chaudhry and others in the arson case until Aug 7.—RT/Agency

UK Court Orders MQM-P To Pay £65,000 To Altaf Hussain

LONDON: Three Lord Justices of the UK Court of Appeal have ordered the Muttahida Qaumi Movement-Pakistan (MQM-P) to pay £65,000, which amounts to around Rs23,333,855 or Rs23.3 million, to the MQM founder Altaf Hussain before July 30, 2024, in legal costs.

Hussain won at the Court of Appeal against his former devotees at MQM-P, who defected from him in August 2016.

According to the order released by the court following a unanimous decision by three judges accepting Hussain's appeal and overturning an earlier decision favouring MQM-P.

The Court of Appeal's Civil Division has ordered the MQM-P to pay £65,000 towards the costs of the appeal.

Generally, the courts order the losing party to make such payments to the claimants or winning side when such applications or petitions are opposed, to begin with, by the defendants. The court has also per-



mitted Hussain for the release of £77,760 into his lawyer's account — the amount he was asked to deposit earlier after the single bench judge gave a decision against him.

MQM spokesperson Mustafa Azizabadi told media that Hussain will soon be launching a claim of over £100,000 at the court against MQM-P for the legal costs incurred during the first part of the trial before the Insolvency and Companies Judge Jones. MQM-P leader and the claimant in the case Syed Aminul Haque told media over the phone from Karachi that he will instruct his lawyer in London to comply

with the court orders. The former federal law minister said: "We are a rule of law party. We will comply with all court orders. We won unequivocally before the Insolvency and Companies Judge Jones and we will win again. MQM-London is making it as if the case is over. It's not." The UK Court of Appeal has sent the case back to the lower court to look at a few unresolved issues. We are confident we will win there, again.

The UK properties belong to MQM-P and we will get these properties for the benefit of the families or our workers and our martyrs.—RT/Agency

Sindh CM Orders Plan For Renovating KMC Buses

KARACHI: Sindh Chief Minister Syed Murad Ali Shah directed Mayor Karachi to propose adding 28 air-conditioned CNG buses from the Karachi Metropolitan Corporation (KMC) to the Peoples Bus Service fleet. These buses could be used on existing or new routes in the city.

The meeting included Local Government Minister Saeed Ghani, Mayor Karachi Muratza Wahab, PSCM Agha Wasif, Secretary Local Government Khalid Hyder Shah, Secretary Finance Fayaz Jatoi, and KMC Municipal Commissioner Afzal Zaidi.

Mayor Muratza Wahab informed the CM that the defunct city district government of Karachi had procured 75 CNG buses, with 14 donated to various organizations and 10 to Karachi University. The re-



maining buses operated until 2017 but were discontinued due to the non-availability of CNG and poor maintenance. Currently, 51 buses are in different stages of decay, with 28 potentially operable if repaired. One bus has already been reconditioned and converted to diesel for Rs 8 million.

Local Government Minister Saeed Ghani suggested first estimating the cost of renovating the 28 buses be-

Karachi Customs Seizes Major Tech Haul From Dubai Flight

KARACHI: Pakistan Customs officials have seized a significant quantity of iPhones, laptops, and other items from two passengers arriving from Dubai at Jinnah International Airport on Saturday.

During a routine inspection at the terminal, customs officials discovered the contraband with two passengers who had flown in from Dubai.

The operation, led by Deputy Collector Customs Faisal Khan, took place at the arrival terminal. The passengers were attempting to pass through the green channel, which is designated for those with no dutiable goods, however, their suspicious behaviour prompted officials to redirect them to the red channel for scanning.

The passengers, identified as Shahroz and Sohail Amin, arrived on Fly Dubai flight 329.

Upon inspection, officials found 28 high-value iPhones concealed within their luggage and on their persons.



Additionally, the suspects were carrying 50 embroidered suits, 40 bottles of Prime drinks, and two expensive laptops.

Customs authorities have registered a case against the two passengers, seized the goods, and initiated further legal proceedings.

Earlier this year in March, it was reported that the Directorate Customs Intelligence Karachi, during its campaign against smuggling recovered smuggled goods worth millions of rupees in a period from July 2023 to February 2024.

Deputy Director Customs Intelligence Karachi Wasif Malik told The Express Tribune that in light of the instructions of DG Customs Intelligence Faiz Ahmed Chaudhry, smuggled items worth Rs100 million were seized in intelligence-based operations during February 2024 alone.—RT/Agency

Business Community Condemns Excessive Power Tariffs



KARACHI: Pakistan's business community leaders on Saturday unanimously demanded of the government for decreasing power rates, media reported.

"We have to pay 2,100 billion rupees for capacity charges this year," the chambers of commerce of Karachi, Lahore, Multan and Faisalabad have said. "Either the government save 240 million people of the country or 42 IPPs," the chambers of officials said while commenting over the inflated power tariffs in the country.

Senior Vice President of Faisalabad Chamber of Commerce and Industries (FCCI) Sajjad Arshad said that the traders are not rioters, but the water has now gone above the head. "If the problem not resolved

promptly, it could go beyond the control," he warned.

"There are 130 independent power producers (IPPs) operating in the country," he said.

LCCI's Vice President Zafar Mehmood Chaudhry while calling agreements with the IPPs as 'cruel', said that 25% industries have been shut down in two years. The electricity price in the country has been 25 to 30 rupees per unit, he said.

"It is surprising that this big secret that we have to pay 2,100 billion rupees for capacity charges this year, had remained under the carpet till now," another chamber official Johar Ali said.—RT/Agency

Advisor Syed Najmi Alam Launches Livestock Vaccination Campaign

KARACHI: Syed Najmi Alam, Advisor to the Chief Minister for Livestock and Fisheries, inaugurated the Sindh government's campaign aimed at protecting livestock from diseases at Cattle Colony Secretary Kazim Jatoi was also present at the event. The Sindh government has launched a vaccination campaign to safeguard livestock from diseases through the administration of vaccines across the province. The decision was made to upgrade the livestock hospital at Cattle Colony to operate 24/7 to ensure that livestock owners can receive emergency medical assistance. Syed Najmi Alam stated that the goal is to make the Cattle Colony veterinary

hospital the largest center of its kind. During the ceremony, Syed Najmi Alam announced that the staff involved in the vaccination campaign would have tracker systems installed on their motorcycles to monitor livestock from diseases at the event. He also emphasized the need for further improvements to hospitals for animals to ensure effective treatment. He mentioned that five major veterinary hospitals are being established in Sindh. Although the department has not yet succeeded in vaccine production, work continues on vaccines for dog and snake bites. Alam highlighted the ongoing spread of foot-and-mouth disease among animals and stressed the importance of its prevention. Additionally,

Najmi Alam announced that the department would provide chickens to impoverished women in Sindh, with the sale of eggs benefiting them financially. Goats will also be provided to poor people in rural areas. Furthermore, the department will allocate funds for the establishment of small fish farms in the province. The inauguration ceremony was attended by a large number of participants, including PPP Malir General Secretary Imdad Jokhio, Town Chairman Ibrahim Haidari, Nazir Ahmed Bhutto, PPP District Information Secretary Shahjahan, Khan Dairy Farm Association leader Shabbir Dar, cattle ward members, milk suppliers, and union leaders.

KATI President Calls For Forensic Audit Of IPPs And Electricity Market Reforms



KARACHI: Johar Qandhari, President of the Korangi Association of Trade and Industry (KATI), has called for significant economic reforms during an emergency press conference. He demanded that electricity prices be set at 9 cents per unit, criticizing the high payments to Independent Power Producers (IPPs).

Qandhari highlighted that IPPs receive more money than Pakistan's defense budget, arguing that the interests of the 240 million Pakistani citizens should come before the 40 families running the IPPs. He called for the cancellation of unnecessary private company contracts and a forensic audit of the IPPs.

Joined by Senator Abdul Haseeb Khan, Senior Vice President Nighat Awan, Standing Committee Chairman Danish Khan, and other notable figures, Qandhari

pointed out that while Pakistan has an installed electricity capacity of 45,000 megawatts, only 22,000 megawatts are utilized. The cost of electricity for consumers is Rs. 35 per unit before tax and Rs. 60 after tax, with Rs. 18 per unit going to capacity charges for unused electricity.

Qandhari proposed several measures to alleviate economic pressure: Changing capacity conditions for government-owned IPPs to reduce management costs. Shifting from LIBOR to KIBOR for payments. Renegotiating privately-owned IPP contracts from "Take or Pay" to "Take and Pay" agreements.

Persuading China to negotiate debt restructuring and extend repayment periods for IPPs under CPEC.

Expanding transmission lines to fully utilize surplus

electricity. Establishing an electricity market in Pakistan to foster competition and allow consumers to choose their electricity providers. He urged the government to halt new IPP projects, improve capacity through negotiations with existing IPPs, and lower electricity prices from 16.5 cents to 9 cents. This reduction would lower production costs, reduce inflation, boost exports, decrease circular debt, and reduce import dependence, ultimately driving Pakistan's economic growth.

Senator Abdul Haseeb Khan, Standing Committee Chairman Danish Khan, and Rehman Javed echoed Qandhari's sentiments, calling for Federal Minister for Energy Sardar Owais Laghari to examine IPP contracts under government supervision and ensure they are audited by international companies.—RT

-Can you believe these bloodsuckers? KE Wants Another Rs 5.45 Per Unit Increase In Power Tariff



KARACHI: The K-Electric (KE) sought an increase of Rs 5.45 per unit for the consumers of the city, dealing a blow to already burdened households, media reported.

The power utility requested the National Electric Power Regulatory Authority (NEPRA) for the hike under the monthly fuel adjustment.

The increase in electricity prices for the KE consumers is expected to add an additional burden of over Rs 10 billion on Karachiites.

The KE asked the NEPRA to approve Rs 2.53 per unit for May's monthly fuel adjustment and Rs 2.92 per unit for the month of June. The NEPRA will hold a hearing on July 30 on the KE's plea.

Six-Year-Old Karachi Girl Found Alive In Body Bag

KARACHI: In a shocking incident, a six-year-old girl was reportedly found alive in a closed sack near the graveyard located at Sherpao colony area of Karachi's Landhi, media reported on Saturday. The police spokesperson disclosed that the

minor girl - identified as Sadaf - was subjected to torture while the suspect(s) also made an attempt to rape her.

The spokesperson added that the girl has been shifted to Jinnah Hospital for immediate medical assistance. Meanwhile, the police - after registering a case on the complaint of the girl's family - has arrested a suspect on the identification of the victim girl for his alleged involvement in the case.—RT/Agency

Sindh CM Urges For Urban Flood Control System In Karachi

KARACHI: Sindh Chief Minister Syed Murad Ali Shah stressed the need for an urban flooding control system in Karachi. He called for identifying low-lying areas prone to flooding and designing sewer tunnels to channel water to the main interceptor tunnels at Lyari and Malir Rivers.

In a meeting at CM House on Saturday, attended by Local Government Minister Saeed Ghani, Mayor Karachi Muratza Wahab, Chief Secretary Asif Hyder Shah, PSCM Agha Wasif, Secretary LG Khalid Hyder Shah, CEO Salahuddin, and KMC Municipal Commissioner Afzal Zaidi, the CM highlighted the main causes of urban flooding: clogged drains, lack of outfall infrastructure, and growing encroachments.

Efforts to address these issues by removing unauthorized settlements and cleaning drains have been ineffective long-term. The CM



proposed constructing new sewage tunnels in flood-prone areas to carry sewage to treatment plants. These plants, being built based on city wastewater output, could use by-products for agriculture and horticulture.

Murad Shah suggested a modern tunneling system using earth pressure balance machines that prevent surface settlement issues. This system, along with pipe jacking, would collect floodwaters and restore natural streams of Lyari and Malir Rivers.

The CM instructed the Karachi Water & Sewerage Corporation (KW&SC) to propose a combined sewerage system for Karachi. Industrial effluent discharge should be treated alongside domestic wastewater.

Murad Shah called for a master plan study to control urban flooding, including a tunneling option, to be completed in six months. A financial model would be developed based on the study's findings.

The KW&SC proposed a pilot study for wastewater management until 2047, aligning with their Master Plan. Mayor Muratza Wahab suggested using old city areas as pilot projects for the urban flooding control system.

As per details, the notice demanded the Governor to retract his statement and apologize for claiming that the chief minister had signed the draft of Operation Istehkam Pakistan in the Apex Committee meeting. The notice stated that the Governor had made this statement on TV and if the Governor does not apologize, he will have to pay a fine of Rs 1000 million. Earlier, Ali Amin Gandapur called to convene an All Parties Conference (APC) to discuss Operation Istehkam Pakistan, address the current situation and foster peace in the region. It is pertinent to mention here that the war of words in-



tensified between Ali Amin Gandapur and newly-appointed Governor Faisal Karim Kundi, with the former threatening to block latter's grant. The altercation appeared to have started after CM Ali Amin Gandapur, while addressing a public gathering, threatened to occupy the governor's house if the governor's rule was imposed in the province. The chief minister said he was not afraid of the governor's rule in Khyber Pakhtunkhwa. However, if it was imposed, the people would occupy both the Governor's House and CM House as only people's rule is permissible in the province. Responding to the Gandapur's statement, Faisal Karim Kundi said he knew how to protect the Governor's House if Gandapur attacked it. "If you try to occupy the Governor House, come and try it, but you will be dragged through the streets," he claimed that he has experience in handling the political hooligans.—RT/Agency

Officials Of Forest Division Faisalabad Accused Of Financial Irregularities In Gojra Range

 TOBA TEK SINGH: Allegations have surfaced against officials in the Gojra Range of the Forest Division Faisalabad regarding financial misconduct. It is reported that the Range Officer has embezzled millions of rupees in salaries meant for lower staff members. According to Forest Guard Shahid Mehmood, who is stationed in the Khairwala Beat of the Nawar Lahore Block, he arranged plantation activities through laborers. The bills for these services were processed and passed by Range Officer Muhammad Siddique, amounting to a total of approximately 925,000 rupees. However, it is alleged that only 300,000 rupees were paid to Shahid Mehmood and other laborers, while the remaining amount was misappropriated by the Range Officer. Shahid Mehmood has stated that the laborers have not yet been paid, leading to severe hardship for them. Despite repeated demands for payment, the Range Officer has reportedly refused to return the embezzled funds. He has allegedly transferred the blame for the shortfall onto the Forest Guard and the Block Officer. Further complicating the situation, telephone conversations between Range Officer Muhammad Siddique and Shahid Mehmood have been leaked, showing mutual accusations of wrongdoing. Shahid Mehmood has also alleged that the Range Officer is involved in widespread corruption and the distribution of commissions for departmental irregularities. Shahid Mehmood has urged higher authorities to conduct a transparent and impartial investigation into the corruption related to the plantation and other bills and to take strict action against those responsible. He claims that a thorough inquiry will reveal additional evidence of the Range Officer's corruption. Notably, Range Officer Muhammad Siddique had previously been suspended for departmental irregularities and alleged corruption.

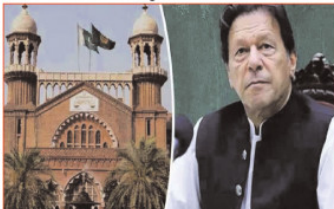

Dua Zehra Case: Parents Granted Custody Of Karachi Girl

KARACHI: A latest development has emerged in Dua Zehra case in which the family court has directed to hand over the custody of the girl to her parents, media reported on Saturday. A hearing was held in the family court in Karachi regarding the father's request to hand over his daughter to her permanent parents. The court ordered that the girl's custody be given to her parents, who are required to deposit a bond of Rs 200,000. The court ruled that the girl will stay with her parents until she reaches adulthood, emphasizing the importance of the child's welfare. The parents are responsible for her needs, including education and food, and must present her in court whenever required. The court noted that the girl willingly agreed to go with her parents and that Zaheer Ahmed failed to prove any mistreatment. Records showed that the parents made significant efforts to ensure the girl's safety. Earlier to this, the Sindh High Court had previously decided to grant temporary custody to the parents. The court then disposed of the father's request for permanent custody.—RT/Agency



LHC to Hear Imran's Petition Against ATC's 10-Day Physical Remand In May 9 Cases



LAHORE: The Lahore High Court on Saturday fixed for hearing petitions filed against an anti-terrorist court's (ATC) order to grant PTI founder Imran Khan's 10-day physical remand for investigation over his alleged involvement in violence on May 9. The hearing scheduled for Monday will be presided over by a bench comprising Justice Tariq Saleem Sheikh and Justice Anwarul Haq. Countrywide protests erupted on May 9 last year after the paramilitary Rangers whisked away Imran from the Islamabad High Court in a corruption case. While the protests were underway, social media was flooded with footage of rioting and vandalism at various spots, including the Lahore Corps Commander's residence and General Headquarters, the army's head office in Rawalpindi. A 13-member team of the Lahore police's investigation wing visited Adiala Jail last week to quiz the former prime minister regarding the violence and arrested him in 12 out of the total 16 cases registered by the Lahore police over the May 9 attacks. On Monday, a Lahore ATC granted police Imran's 10-day physical remand in the 12 cases against a request for a 30-day remand. The former premier had petitioned the LHC on Thursday against the ATC's decision. He filed the writ petition through his counsel, Barrister Salman Safdar, arguing that on July 15, the ATC had granted his custody to police in a hearing which he attended on a WhatsApp video call from Adiala jail. He argued that the order issued by the court was tantamount to "misreading" established principles on the law of remand and urged the court to set it aside for being "unlawful".—RT/Agency

The rescue officials disclosed that the eight-year-old boy, identified as Salim, drowned in a water relay at Katti Pahari in North Nazimabad. After the incident, the rescue teams responded promptly to the situation and transported the body of the deceased to Abbasi Shaheed Hospital. The Pakistan Meteorological Department (PMD) has forecast more rain-wind/thundershowers in various parts of the country with occasional gaps during the next week. The PMD has advised all the concerned authorities to remain vigilant and take necessary measures to avoid any untoward situation. Strong monsoon currents



were likely to penetrate from Arabian Sea and Bay of Bengal in upper parts from July 22. Police Officers Assault Hotel Staff For Not Giving Them Free Food

KARACHI: The police officers have been accused of abusing their authority against hotel employees over a breakfast bill dispute in Karachi's Korangi area, media reported on Saturday. According to the details, the police officers allegedly subjected the employees to torture and registered a case against them for possessing a gas cylinder. An affected hotel employee, Ali Muhammad, in a statement, claimed that the police officers frequently visited the hotel for breakfast and left with paying. He added that a total of five police officers arrived at the hotel for breakfast on Friday morning, worried about the rising inflation, when policemen were asked for the breakfast bill, they started torturing him. The hotel employee asserted that the police arrested three other hotel employees after registering a case against them, accusing them of keeping cylinders unlawfully. Additionally, the officers are alleged to have stolen 18 chairs and Rs 30,000 from the hotel's counter. According to Ali Muhammad, the head-muhamarrir of Korangi police station allegedly accepted money to the release of the detained employees on a personal guarantee. In response to the allegations, SSP Korangi Tauheed Rehman has suspended the three officers—Shakir, Muhammad, and Waqas—involved in the incident, pending further investigation. The case has been assigned to SP Shah Faisal for a thorough inquiry into the incident. The suspended officers have been placed on administrative leave until further orders.—RT/Agency

Man Kills Wife After Learning She Was Expecting A Girl

JARANWALA: In a tragic incident, a husband has reportedly murdered his pregnant wife after an ultrasound revealed the gender of the unborn child in Jaranwala, Punjab, media reported on Saturday. The victim, a mother of two other daughters, was reportedly killed by her husband, Nadeem, who had previously assaulted her along with his brother-in-law. The police were notified about the incident and managed to apprehend the accused Nadeem and his brother-in-law, Phool Abbas. The police have registered a case against the accused and initiated the further investigation into the case.—RT/Agency

FIA Offloads Eight Passengers At Multan Airport

MULTAN: The Federal Investigation Agency (FIA) Immigration offloaded eight passengers at Multan Airport, media reported. As per details, the passengers, who were traveling to Saudi Arabia on Umrah visas, were found with 900 packets of cigarettes and other items. According to the FIA, the passengers had less than 500 riyals (approximately Rs 37,000) each, which is below the required amount for travel. Earlier, the FIA offloaded eight women passengers from a Saudi Arabia-bound flight at Multan Airport. "The women were allegedly going to Saudi Arabia for begging," a spokesperson of the Federal Investigation Agency's (FIA) immigration wing said.—RT/Agency



Sindh Transport Department Announces Three New Peoples Bus Service Routes For Karachi

KARACHI: The Sindh Transport Department has announced the launch of three new routes for the Peoples Bus Service and the extension of one route to improve public transport in Karachi. Additionally, the transport department has announced the extension of Route No 12, which will now start from



Memon Goth instead of Khokhrapar to the Tower, effective from July 23. Sindh Transport Minister Sharjeel Inam Memon stated that these new routes are part of the Sindh government's efforts to enhance public transport in Karachi, providing affordable, convenient, and comfortable travel options for citizens. People of Shahdadpur being cheated by illegal housing societies

SHAHDADPUR: In Shahdadpur, the Town Planning Department has initiated investigations following revelations of the illegal sale of welfare plots designated for schools, dispensaries, parks, and community halls in residential schemes. The sale of these amenity plots is illegal, and those involved in buying and selling such plots in our scheme will be held responsible, stated Ali Muhammad Keerio, the owner of Kazim Bungalows, while speaking to the media. It has been found that in Shahdadpur and surrounding areas, many housing schemes are causing distress to the public instead of providing them with facilities. Promises of clean drinking water, electricity, gas, hospitals, schools, drainage systems, roads, and boundaries are made, but the public is deceived as these facilities are not provided. The illegal housing schemes are selling plots under false pretenses, exploiting the poor and underprivileged, shattering their dreams of a better life. Many people, who

bought plots in installments, have been misled by false promises and have migrated from various villages to settle in these housing schemes in the city. Today, thousands of people in these colonies are forced to live in conditions worse than those in rural areas. Ali Muhammad Keerio, owner of the prominent residential colony Kazim Bungalows, clarified to the media that their colony is registered and most plots have been sold legally. He emphasized that in their scheme, anyone involved in selling or buying such plots will be held accountable. He stated that they do not sell amenity plots, which are a trust for the residents of the colony. Any broker selling such plots for commission or buyers purchasing them do so at their own risk. He also mentioned that they have no connection with other colonies where such illegal activities are taking place. In response to public complaints, the Town Planning Department has taken notice of the illegal sale of welfare plots in these housing schemes and has started investigations.

Tando Allahyar Police arrest 45 drug dealers, criminals within three weeks

TANDO ALLAHYAR: Tando Allahyar Police have intensified their crackdown against drug dealers, making significant seizures and filing separate cases. According to reports, within the past three weeks, police have released details of their operations across various police stations in Tando Allahyar, including Payaro Lund, Sulatanabad, Bukera Sharif, Mashaikh Hote, Daso Dahri, Umar Sand, Chamber and both A and B Section police stations. During these operations, the police have recovered 7 stolen motorcycles, 50 maunds of raw material used in Gutka manufacturing, 1.5 kilograms of hashish, 365 liters of alcohol, 3,090 maunds of illegal substances, 1,790 maunds of mawa (condensed milk used in drug preparation), 170 packets of Safina (a type of Gutka), illegal weapons, bhong, whiskey, among other drugs. In total, 45 suspects, including fugitives and absconders,



have been arrested and 36 separate cases have been registered at the respective police stations. SSP Abrez Abbasi stated that the IG Sindh and DIG Hyderabad have issued strict instructions not to spare any drug dealers or criminals. He emphasized that there is increased control within the district and warned that those involved in the illicit drug trade will face severe action and be brought to justice if they do not cease their activities.

PCB confirms denying NOCs to Babar, Rizwan, Shaheen to play Global T20

LAHORE: The Pakistan Cricket Board (PCB) has confirmed rejecting skipper Babar Azam, pacer Shaheen Shah Afridi and wicket-keeper-batter Mohammad Rizwan's request for a no-objection certificate (NOC) to feature in the upcoming league Global T20.

"The PCB had received NOC requests from Babar, Rizwan and Shaheen for the Global T20 event. Following consultations with the three players as well as the national selection committee, it has been decided to decline their requests," the PCB said in a press release on Friday.

The board's confirmation comes after sources have told Geo News that the trio were unlikely to get the PCB's nod to participate in the said tournament which is scheduled from July 25 to August 11 in Canada.

The sources had said that



the PCB wasn't in favour of issuing NOCs to all-format players due to the busy international schedule.

This has now been confirmed by the board which has said that the decision to reject the players' request for the NOCs has been made in light of the team's packed cricket calendar in the period from August 2024 to March 2025, which includes nine ICC World Test Championship matches and next year's ICC Champions Trophy 2025.

The PCB maintains that in line with its workload management policy, it is in the best interest of Pakistan cricket and the players that they skip the upcoming event in Canada so that they are in their best mental and physical shape for the season, which commences with the two-Test series against Bangladesh.

"The three are all-format cricketers and their services are expected to be required in

the upcoming eight months during which Pakistan will play nine Tests, 14 ODIs, and nine T20Is," read the PCB's statement.

The development comes days after the cricket board decided not to grant fast-bowler Naseem Shah the NOC to play in The Hundred league due to being an all-format player.

However, the board has approved NOCs for Asif Ali, Iftikhar Ahmed, Mohammad Amir, and Mohammad Nawaz as they are "predominantly white-ball cricketers", while Iftikhar and Nawaz are centrally contracted players.

It is to be noted that PCB Chairman Mohsin Naqvi, earlier this week, had said that it would work out a technical process to issue NOC to the players and those who would fulfil the requirements would be granted the NOC.—Agency

Alcaraz declares Djokovic 'greatest of all time'



Carlos Alcaraz recently clinched his second Wimbledon title and his fourth Grand Slam title after beating Novak Djokovic in straight sets at the Centre Court.

The Spaniard claimed his first Wimbledon title in 2023 where he also beat Djokovic in five sets but his battle with the Serb in 2024 was not very tough as Alcaraz managed to cruise to victory in just three sets.

Despite defeating Djokovic in two Grand Slam finals, Alcaraz still believes that the Serb is the Greatest of All Time (GOAT) because of his unmatched numbers.

In a Q&A interview with the ATP Tour released after Wimbledon, Alcaraz was asked which tennis player is the GOAT (Greatest of All Time).

"As far as numbers go, it's Novak Djokovic without a doubt," Alcaraz said. "The other two: Federer and Rafa. For me, they're tops."

After the Wimbledon final, Alcaraz expressed his desire to "sit at the same table as the big guys", but ruled out specifying a specific Grand Slam target.

"I don't know what is my limit. I don't want to think about it," the world No 3 in his post-tournament press conference.

"I just want to keep enjoying my moment, just to keep dreaming. So, let's see if at the end of my career, it's going to be 25, 30, 15, four. I don't know. All I want to say is I want to keep enjoying, and let's see what the future brings for me."

"I'm really happy with the work that I'm doing with my team. I'm really proud of myself, all the things that I'm doing great. I'm really proud of the people around my team."

"Everything we have done already has been unbelievable, an amazing journey so far. As I said, I really want to keep going, to keep improving, to keep growing up, trying to keep winning. That's all that matters to me right now."

"It doesn't matter if I already won four Grand Slams at the age of 21. I really want to keep going. I will try to keep winning and end my career with a lot of them."—Agency

Harbhajan Singh fumes over Rizwan-Dhoni comparison

Shahadat Hossain (15 not out, 32b, 2x4s) and Hasan Murad, yet to open

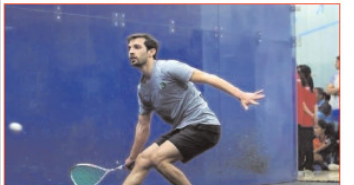


his account, will resume the batting for Bangladesh A on day three.

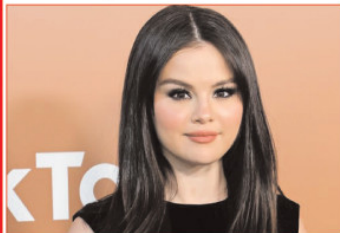

Punjab Government Appeals Sanam Javed's Case Dismissal In Supreme Court

Badin's Samo community demands registration of case against cops in woman's death

BADIN: The Samo community people protested outside the Badin Press Club against the death of Saran Samo, who was killed by police firing in Karachi. They demanded that a case be filed against the SHO responsible for the shooting and murder. The protest rally, organized by Samo Ittehad Sindh, was held to seek justice for Saran Samo, a woman who was fatally shot by Steel Town Police near Sassui Toll Plaza fifteen days ago. Leaders and activists from various political and social organizations also joined the protest. During the event, leaders including Shahnawaz Zargar Samo, Azad Samo, Muhammad Umar Samo, Ali Nawaz Samo and Abdul Rasool Samo, along with Advocate Ameer Azad Panhwar, the Central Vice President of the Sindh United Party, addressed a press conference at the Badin Press Club. They explained that on July 4, Saran Samo, who was receiving treatment at a Karachi hospital, was returning home after her recovery when SHO Agha Rasheed and his team opened fire on the car she was in. Saran Samo, the sister of Yaqoob Samo, was seriously injured along with

Ghinwa Samo, and Saran succumbed to her injuries. The Samo community and other political and social leaders criticized the Sindh government for its lack of interest and negligence, and condemned the hostility of the Sindh police towards the people, which resulted in the death of an innocent woman and the injury of another. Despite appeals and complaints, an FIR has not been filed against SHO and his police party. The protesters called for justice and demanded that a case be registered against SHO Agha Rasheed and the police officers involved in the shooting.

Fazl Claims PTI Is Prepared To Step Down From Assemblies And Dissolve KP Legislature

ISLAMABAD: After forming a committee to hold dialogue with the Pakistan Tehreek-e-Insaf (PTI), Jamiat Ulema-e-Islam-Fazl (JUI-F) chief Maulana Fazlur Rahman on Saturday claimed that the embattled party agreed to step down from the assemblies and dissolve the Khyber Pakhtunkhwa (KP) legislature to force the government into elections.



The religio-political party constituted a committee headed by Kamran Murtaza whose members include Maulana Murtaza Wahidi, Murtaza Ghaffoor, Aslam Ghauri and Maulana Amjad to hold talks with the Imran Khan-founded party.

He also slammed "powerless" ruling parties in the Centre — the Pakistan Muslim League-Nawaz (PML-N) and the Pakistan Peoples Party (PPP) — and said that both the parties did not deserve to be in power.

After the 2024 nationwide polls, the religious party had developed differences with the PML-N and the PPP after they formed a coalition government as the former levelled serious allegations of election rigging, interference and manipulation of poll results and demanded fresh elections.

At the same time, the JUI-F chief also termed the mandate of the PTI in Khyber Pakhtunkhwa province "fake".

ISLAMABAD: Pakistan has decided to carry out a forensic analysis of the leaked phone call featuring Tehreek-e-Taliban Pakistan (TTP) Chief Noor Wali Mehsud and pursue strict legal action against him and terrorist Ghat Haji after their leaked call exposed the terror plots being planned by the banned organisation, sources told Geo News on Saturday.

Sources say that the government will not only seek the extradition of terrorists from Afghanistan but will also lodge a strong protest with the Afghan Taliban-led interim administration over the TTP head's presence in the country and his direct involvement in terrorist attacks inside Pakistan.

A day earlier a disturbing phone call featuring Noor came to the surface wherein he could be heard giving instructions to his henchmen for attacks in Pakistan.

The other voices in the audio call were identified as local commanders Ahmad Hussain Mehsud alias Ghat Haji, and Saqib Gandapur.

The conversation revolves around the TTP chief's orders on how to inflame the security situation

in the country. In that conversation, he can be heard outlining two main methods for disrupting peace and order in Pakistan.

Suggesting that one method is to target government schools or hospitals with bombings, the TTP leader orders his men to carry out attacks on one or two schools or hospitals without claiming responsibility for them.

Noor could also be heard hashing out a second method, which he says involves destroying the homes of police officers and soldiers.

He instructs his lieutenants to keep the conversation confidential and ensure that no one else is aware of the plan and stresses that if questioned, he should not be

linked to the operations and nothing should be traced back to TTP.

Ahmad Hussain, while affirming the TTP chief's deadly plans, can be heard telling Gandapur to target the homes of high-ranking police, army, and FC officers with bombs and to either close down or blow up schools secretly — without taking credit for the attacks.

The leaked telephone call effectively reaffirmed Islamabad's stance wherein it had time again called on Kabul to prevent its land from being used by TTP and other terrorist organisations against Pakistan. The legal action against the terrorists, the sources added, will be taken in light of the report of the phone call's forensic analysis. —RT/Agency

ISLAMABAD: Chief Justice of Pakistan Qazi Faez Isa stressed the importance of promptly scheduling review petitions regarding reserved seats, highlighting the constitutional right to a timely hearing.

During the 17th meeting of the Supreme Court Practice and Procedures Committee, chaired by Justice Isa, a consensus emerged about the urgency of these cases.

Justice Isa argued that judges should prioritise constitutional duties over personal convenience, stating that delaying the hearing would be unjust.

He emphasised that the right to review is enshrined in the Constitution and should not be hindered by judges' vacations.

Justice Mansoor Ali Shah and Justice Muneeb Akhtar, however, contended that only the 13 judges who originally heard the case could conduct the review, noting that many judges are currently on summer break or abroad.

They suggested that the review petitions be scheduled after the holidays.

Justice Isa opposed this majority decision, insisting that the hearings should proceed immediately, even if it meant cancelling the summer break.

He argued that awaiting a detailed decision while postponing the review hearings would strip individuals of their rights and undermine the law.

The committee ultimately decided, by a 2-1 majority, to schedule the review petitions post-holidays, despite Justice Isa's dissent.

He maintained that the delay would lead to a miscarriage of justice, stressing the need for immediate action to uphold constitutional integrity. —RT/Agency

Islamabad To Pursue Legal Action Against TTP Chief After Leaked Call Exposes Terror Plot

ISLAMABAD: Pakistan has decided to carry out a forensic analysis of the leaked phone call featuring Tehreek-e-Taliban Pakistan (TTP) Chief Noor Wali Mehsud and pursue strict legal action against him and terrorist Ghat Haji after their leaked call exposed the terror plots being planned by the banned organisation, sources told Geo News on Saturday.



Sources say that the government will not only seek the extradition of terrorists from Afghanistan but will also lodge a strong protest with the Afghan Taliban-led interim administration over the TTP head's presence in the country and his direct involvement in terrorist attacks inside Pakistan.

A day earlier a disturbing phone call featuring Noor came to the surface wherein he could be heard giving instructions to his henchmen for attacks in Pakistan.

The other voices in the audio call were identified as local commanders Ahmad Hussain Mehsud alias Ghat Haji, and Saqib Gandapur.

The conversation revolves around the TTP chief's orders on how to inflame the security situation

in the country. In that conversation, he can be heard outlining two main methods for disrupting peace and order in Pakistan.

Suggesting that one method is to target government schools or hospitals with bombings, the TTP leader orders his men to carry out attacks on one or two schools or hospitals without claiming responsibility for them.

Noor could also be heard hashing out a second method, which he says involves destroying the homes of police officers and soldiers.

He instructs his lieutenants to keep the conversation confidential and ensure that no one else is aware of the plan and stresses that if questioned, he should not be

linked to the operations and nothing should be traced back to TTP.

Ahmad Hussain, while affirming the TTP chief's deadly plans, can be heard telling Gandapur to target the homes of high-ranking police, army, and FC officers with bombs and to either close down or blow up schools secretly — without taking credit for the attacks.

The leaked telephone call effectively reaffirmed Islamabad's stance wherein it had time again called on Kabul to prevent its land from being used by TTP and other terrorist organisations against Pakistan. The legal action against the terrorists, the sources added, will be taken in light of the report of the phone call's forensic analysis. —RT/Agency

CJP Stresses Importance Of Timely Hearing For PTI's Reserved Seats Review Petition

ISLAMABAD: Chief Justice of Pakistan Qazi Faez Isa stressed the importance of promptly scheduling review petitions regarding reserved seats, highlighting the constitutional right to a timely hearing.



During the 17th meeting of the Supreme Court Practice and Procedures Committee, chaired by Justice Isa, a consensus emerged about the urgency of these cases.

Justice Isa argued that judges should prioritise constitutional duties over personal convenience, stating that delaying the hearing would be unjust.

He emphasised that the right to review is enshrined in the Constitution and should not be hindered by judges' vacations.

Justice Mansoor Ali Shah and Justice Muneeb Akhtar, however, contended that only the 13 judges who originally heard the case could conduct the review, noting that many judges are currently on summer break or abroad.

They suggested that the review petitions be scheduled after the holidays.

Justice Isa opposed this majority decision, insisting that the hearings should proceed immediately, even if it meant cancelling the summer break.

He argued that awaiting a detailed decision while postponing the review hearings would strip individuals of their rights and undermine the law.

The committee ultimately decided, by a 2-1 majority, to schedule the review petitions post-holidays, despite Justice Isa's dissent.

He maintained that the delay would lead to a miscarriage of justice, stressing the need for immediate action to uphold constitutional integrity. —RT/Agency

Opposition Alliance To Hold Nationwide Protest On July 26

ISLAMABAD: Opposition alliance of Tehreek-e-Taliban Pakistan (TTAP) announced on Saturday that it will hold a countrywide protest on July 26 (Friday) for the release of all political prisoners, including PTI founding chairman Imran Khan and reclaiming the "stolen mandate".



While passing a unanimous resolution seeking immediate release of political prisoners, the TTAP leadership also demanded an empowered judicial commission to probe firing on peaceful marchers in Bannu. The opposition alliance also sought resignation from the ruling party and demanded fresh elections. It lauded the recent Supreme Court's decision on reserved seats as well.

The meeting of the opposition alliance was presided over by senior politician and head of the movement Mahmood Khan Achakzai, which was attended by PTI Chairman Barrister Gohar Ali Khan, PTI secretary general and Leader of Opposition National Assembly Omar Ayub Khan, Leader of Opposition in Senate Senator Shibli Faraz and PTI Central Information Secretary Raouf Hasan. Chairman Sunni Ittehad Council Sahibzada Hamid Raza, Chairman Majlis Wahdat Muslimen Allama Nasir Abbas and JUI Shirani Group leader Syed Qasim Agha also participated in the meeting. In the meeting, the participants held a detailed discussion over the prevailing political and economic situation of the country along with the future course of action. They also passed a unanimous resolution demanding an immediate release of Imran Khan, his wife Bushra Bibi and all other PTI's leaders and workers, stating the cases framed against Imran Khan and other party leaders and workers were a violation of laws and the principles of justice. They also demanded that an independent judicial commission should be constituted immediately to probe into the deaths and injuries caused by the firings on Bannu Aman March. The participants stressed the need that a judicial commission should be headed by a serving judge, which should be free from any external pressure, to ensure a transparent investigation into the violent incidents in Bannu. They demanded that the incumbent IG and Chief Secretary of Khyber Pakhtunkhwa (K-P) miserably failed in restoring peace in the province, hence "they should be dismissed forthwith." Through the resolution, they urged the government to immediately withdraw the rapid escalation in prices of electricity and gas.

They lamented that the nation was paying the price for the incompetence and ineptitude of the "unselected and non-representative government" in the shape a skyrocketing price hike of various kitchen items as well as power and gas. —RT/Agency

Bushra Bibi Fears For Imran's Life, Alleges Inhumane Conditions In Jail

ISLAMABAD: Bushra Bibi, the wife of former prime minister Imran Khan, expressed grave concerns about her husband's safety in Adiala Jail.



Speaking informally to journalists at the prison on Saturday, she revealed fears for her own life as well.

Bushra Bibi stated that Imran Khan's life is in danger, mentioning past incidents where he was allegedly poisoned and shot at.

She added that their legal request to investigate the poisoning has not been addressed by the court yet.

Describing conditions in the jail, Bushra Bibi alleged that Imran Khan was kept in unsanitary conditions and given contaminated food to eat.

She mentioned that during their meeting in Attock Jail, Khan appeared emaciated and had to pick insects from his hair through the night.

Bushra Bibi also criticised the treatment of political prisoners compared to convicted criminals.

She highlighted that other

prisoners received VIP treatment, while Khan struggled without basic amenities.

During the conversation, a journalist questioned Bushra Bibi about claims of adding toilet cleaner to food and her accusations against the authorities.

She responded firmly, asserting that these claims are true, despite lacking physical evidence.

Imran Khan intervened briefly, cautioning his wife about the limitations of the media, which led to a brief protest from the attending journalists.

Despite Khan's concerns, Bushra Bibi insisted on sharing her story with the media. —RT/Agency
