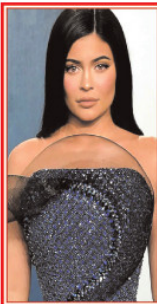

## Sleepy Joe Quits US Presidential Race

WASHINGTON: US President Joe Biden ended his reelection campaign on Sunday after fellow Democrats lost faith in his mental acuity and ability to beat Donald Trump, leaving the presidential race in uncharted territory.

Biden, in a post on X, said he will remain in his role as president and commander-in-chief until his term ends in January 2025 and will address the nation this week.

"It has been the greatest honor of my life to serve as your President. And while it has been my intention to seek reelection, I believe it is in the best interest of my party and the country for me to stand down and to focus solely on fulfilling my duties as President for the remainder of my term," Biden wrote. By dropping



his reelection bid, he clears the way for Vice President Kamala Harris to run at the top of the ticket, the first Black woman to do so in the country's history. Biden, 81, did not mention her when he announced his move. It was unclear whether other senior Democrats would challenge Harris for the party's nomination, who was widely seen as the pick

## Information Minister Claims Imran's Adiala 'Presidential Suite' Surpasses Middle-Class Homes

ISLAMABAD: Information Minister Attaullah Tarar slammed Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan for claiming that he was imprisoned in a death cell when, in actuality, he was in a "presidential suite", which is better than a middle-class family's house.

"You are telling the West that you're facing troubles, and you're imprisoned in a death cell. This death cell is a 'presidential suite' in Adiala jail, which is better than a middle-class house," Tarar said during a press conference in Islamabad.

Imran, in an interview with the Sunday Times through his lawyers, claimed that he was imprisoned in a death cell, where "terrorists" are kept to ensure "they have no contact with anyone".

The 71-year-old cricket-turned-politician has been in prison for almost a year now in three cases — the Toshakhana case, cipher case, and the un-Islamic marriage case. His wife, Bushra Bibi, is also behind bars.

However, a court suspended his sentence in the Toshakhana case, while other courts overturned his convictions in the cipher and iddat cases, respectively.

While there were hopes for his and Bushra's release in July, they were dashed when the National Accountability Bureau (NAB) arrested them on fresh charges related to the sale of state gifts.



As Imran remains behind bars, he has kept claiming that he's not being provided several facilities, but to set the record straight, the government submitted documentary evidence of facilities being provided to the PTI founder in Adiala jail, rebutting his claims that he was being kept in solitary confinement.

The pictures shared with the court showed that the PTI founder was provided with several facilities that a common prisoner cannot imagine — since he's a former prime minister.

Imran has an exercise bike and stretching belt for physical fitness, books, a separate kitchen, a special menu, an exclusive gallery for a walk, LED, a room cooler, and a study table.

In his presser, while referring to the interview, he reminded the people of how a "dictator" Imran would treat his political opponents — regardless of their gender.

"[They knew] Shehbaz Sharif had a pain in his back. Despite that, he was brought

in an armoured car and pushed, and it is visible in the footage. Maryam Nawaz was in a 7x8 cell, where she could not even spread the prayer mat properly, she was not even allowed to walk."

Recalling how former prime minister Nawaz Sharif was treated, Tarar said the Pakistan Muslim League-Nawaz president's wife died while he was in prison. He claimed that a fire was lit using wood outside Rana Samaulah's jail cell in extremely hot weather.

"These are his words, I will take off the AC and TV and not give you food. I will not allow them medicines or visits," Tarar said, reminding the people about what Imran would say about his plans for imprisoned PML-N leaders.

In response to a question, Tarar said his government did not want to victimise its political opponents and that the authorities also follow through on Imran's requests for "desi murghi".

In response to a question about disruption in the internet, Tarar claimed that the in-

ternet services were disrupted across several countries and flights were also affected in the US.

"The government has nothing to do with it, it's an overall problem," he said, noting that the IT Ministry and the Pakistan Telecommunication Authority (PTA) would inform about cyber security.

He added that if the government were to install a firewall, it would be for data and cyber security, not to gag freedom of expression. "This is as per my knowledge."

He said that on social media, there are several issues — some people deserve to be killed, women harassment, and child pornography. "You can see what kind of content is being uploaded on Twitter (now X)."

The info minister noted that the interim government had placed a ban on the social media platform as its policies did not meet with the nation's compliance rate.

"There is some content that terrorists and anti-state elements use [to their benefit]. The interior minister has taken this matter up in court," he added.

According to the information minister, "Some armed people from political parties, including the PTI," attended the Aman (peace) March organised by Bannu traders and created chaos by resorting to firing near Bannu Cantt's wall on Friday where eight troops were martyred last

## Islamabad Condemns Attack By 'Extremist Group' On Consulate In Germany

ISLAMABAD: Pakistan on Sunday strongly condemned an attack by a gang of extremists on its consulate in Germany's Frankfurt and the failure of the German authorities to protect the sanctity and security of the premises of its consular mission.

The Foreign Office's statement comes a day after a group of Afghan nationals vandalised and attacked the Pakistani consulate, pelting stones at the building and removing the country's flag.

The statement said that the responsibility to protect the premises and ensure the security of diplomats falls under the host government under the Vienna Convention on Consular Relations, 1963.

"We are conveying our strong protest to the German government and urge to take immediate measures to fulfil its responsibilities under the Vienna Conventions," the



Foreign Office said. Pakistan also sought the German authorities to take immediate measures to arrest and prosecute those involved in yesterday's incident and hold to account those responsible for the lapses in security.

The video of the incident went viral on the internet in which the Afghan nationals could be seen storming the Pakistani consulate. There are reports that they also tried burning the Pakistani flag.

According to media reports, the situation has drawn significant attention among the international communities, raising concerns about the diplomatic security of the installations.

However, the officials have been assured of a thorough investigation by the German authorities in Frankfurt.

They have also arrested several people who are being investigated after the video went viral.—RT/Agency

## Government Committed To Providing 100% Free Medical Care To Eligible Patients: PM

ISLAMABAD: Prime Minister Shehbaz Sharif has said that the government is determined to provide state-of-the-art free healthcare services to deserving patients from across the country at the Jinnah Medical Complex in Islamabad, which he said would be one of the best medical facilities in the region.

Addressing the groundbreaking ceremony of the complex, the prime minister said that the facility will offer 100% free medical services.

"This is the gift of the coalition government not only for the residents of Rawalpindi and Islamabad but for the people from Khyber Pakhtunkhwa, Azad Jammu and Kashmir and Gilgit Baltistan as well," he said.

Premier said that once completed, the medical complex would offer the world's best healthcare facilities with various sections of diseases related to heart, kidneys, lungs, cancer, and others.

He said that a modern first aid emergency section would also be established at the hospital with an air ambulance service for patients in hard-to-reach areas.

PM Shehbaz pledged that the nursing schools



and laboratories would also be established in the hospital and the deserving patients would avail 100% free lab tests facility.

The prime minister emphasised that this was the same model envisioned by Pakistan Muslim League-Nawaz (PML-N) President Nawaz Sharif to provide free medical facilities only to the poor and on-payment facilities to the well-off people at the same place.

He specifically thanked Habib Bank Limited (HBL) Chairman Sultan Ali Allana and Prince Rahim Agha Khan for providing technical consultation support free of cost for the project. He paid tribute to the decades-long services of the Agha Khan Foundation for the country.

PM Shehbaz directed the authorities concerned to complete the project in one year.

## Gohar Ejaz Claims Corrupt Contracts Behind High Electricity Costs



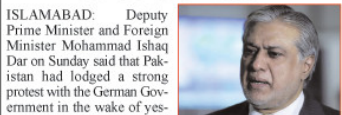
ISLAMABAD: Former caretaker commerce minister Gohar Ejaz has disclosed data on payments to Independent Power Producers (IPPs), revealing significant financial burdens on consumers.

Ejaz shared on Sunday that over the past year, IPPs received payments amounting to Rs1.95 trillion. He criticised corrupt contracts and mismanagement that result in electricity being sold at Rs60 per unit, calling for public action against these deals. He highlighted that the government purchased electricity from one power plant at a record Rs750 per unit, and from coal power plants at an average of Rs200 per

unit, while wind and solar plants sold electricity at over Rs50 per unit. Ejaz pointed out that despite operating below 20% capacity, IPPs were paid substantial sums, including Rs140 billion to one plant operating at a 15% load factor and Rs120 billion to another at 17%.

These agreements, according to him, allow IPPs to invest heavily without generating equivalent power, stressing the need for "no capacity payment" agreements. He urged the government to only purchase from the cheapest electricity providers and treat all IPPs as merchant plants.—RT/Agency

## PTI's Shafqat Mahmood Resigns From Politics, Denies Pressure To Do So

ISLAMABAD: Shafqat Mahmood, a once prominent leader of the Pakistan Tehreek-e-Insaf (PTI), Sunday announced quitting politics but stressed that the decision was not due to coercion.

"34 years back, I resigned from a government job and entered politics. But after deliberations, I have now decided to retire from politics," Mahmood, a former federal minister, said in a post on X, previously known as Twitter.

A plethora of politicians left the former ruling party or quit politics altogether following the May 9 attacks on state installations, with the former saying that they were forced to quit the Imran Khan-founded party.

The leaders who deserted the now embattled PTI include Fawad Chaudhry, Asad Umar, Shireen Mazari, Fayazul Hassan Chohan, Maleeka Bokhari, Ali Zaidi, and Musarrat Jamshed Cheema.

While some leaders have tried joining the party ranks once again, the PTI leadership — which consists of several new faces — has decided that deserters would not be brought back to the fold.

"There's no pressure on me [to quit PTI] and neither



do I plan on joining any other political party," Mahmood said, explaining that he took the decision due to "time" and his "age".

Reflecting on his political decades-long career, the former federal minister said he saw several ups and downs. "I have served as a member of the Senate and the National Assembly."

Not only that, he said that he was also appointed as a federal as well as provincial minister. Mahmood, on a lighter note, said he also "visited" jail during his political career.

The now-former PTI leader said that as the federal education minister, he rolled out the Single National Curriculum for the first time in history and also oversaw education-related affairs during the pressing period of COVID-19.

When he was the education minister during the coronavirus period, the students were in awe of him as he not only introduced several relaxations but also passed students without exams.

He thanked Khan and PTI for giving him to opportunity to "serve". Mahmood also extended his gratitude towards the voters of his constituency, who elected him to parliament twice.

"I am satisfied that I have always performed all my responsibilities honestly and performed at every position as a duty. No one, thank God, has levelled any allegation against me." Revealing his future plans, Mahmood said that he wanted to spend the rest of his life teaching and writing. "I agree with those who say that the youth should participate in politics."—RT/Agency

## PTI Prepares To File Reference Against CEC And ECP Members

## 14-Year-Old Hingorja Boy Disappears Under Mysterious Circumstances

HINGORJA: In a distressing turn of events, 14-year-old Siraj Ahmed Solangi, the nephew of journalist Muhammad Siddique Solangi, has gone missing under mysterious circumstances. Siraj, the son of Inayat Hussain Solangi, disappeared on his way home from Mirak Madrasa.



The family suspects that Siraj has been kidnapped. Inayat Hussain and journalist Muhammad Siddique Solangi reported the incident at the Hingorja Press Club. They explained that Siraj, a diligent student at Mirak Madrasa, failed to return home, prompting immediate concern and suspicion of foul play.

The family has lodged reports at both Hingorja and Sobhodoro police stations, urging authorities to expedite their search efforts. They have also reached out to human rights organizations, appealing for assistance in locating the missing boy.

## Car-Rickshaw Collision Near Dargah Misri Shah Results In One Death, Two Injuries

KUNRI: A tragic accident occurred near Dargah Misri Shah on Kanji road when a car overtaking a rickshaw lost control and collided with the rickshaw. The incident resulted in the death of one person and left two others injured.



The collision led to severe injuries for the rickshaw driver, Riyaz Gishkuri, 9-year-old Shahzeb Gishkuri, and another youth named Riyaz Gishkuri. All three were rushed to the Taluka Hospital for emergency treatment. Tragically, the young boy, Shahzeb Gishkuri, succumbed to his injuries and was pronounced dead at the hospital. The other injured individuals are currently receiving medical care.

In the aftermath of the accident, local residents apprehended the car driver. The body of the deceased boy was handed over to his grieving family members. When Shahzeb's body arrived home, it was met with an outpouring of mourning and sorrow from family and friends.

## NA Speaker Refuses To Provide New Vehicles To Standing Committee Chairmen



ISLAMABAD: National Assembly Speaker Ayaz Sadiq has turned down a request from chairmen of Standing Committees for new vehicles, citing budgetary constraints and government policy.

According to sources within the National Assembly, the committee chairs had requested new vehicles despite already having vehicles in good condition.

Sadiq refused the demand, explaining that current fiscal limitations and a government directive against purchasing new vehicles, to prevent economic strain, made it impossible to fulfill their request.

Sources revealed that several committee chairs had voiced dissatisfaction with the condition and efficiency of their assigned vehicles.

In response, Speaker Ayaz Sadiq pointed out that the vehicles in question were from 2017 and 2019 models, emphasizing that even his own vehicle was a 2015 model.

The Finance Ministry reportedly declined to allocate funds for new vehicles, reinforcing the Speaker's decision.

Instead, Sadiq instructed that existing vehicles be repaired and reassigned to the committee chairs, as vehicles from the National Assembly secretariat are deemed serviceable.

It is noteworthy that chairmen of Standing Committees receive new vehicles, offices, petrol allowances, in addition to their salary, allowances, and other benefits as Members of the National Assembly (MNAs).—RT/Agency

## Consumers In AJK Receive Rs 3 Per Unit Power Bills Following Successful Protests

MUZAFFARABAD: The Azad Kashmir government has issued electricity bills according to the new tariff, charging consumers Rs3 per unit, media reported.

As per details, the development came after violent protests and an agreement was signed between the government and the Jammu Kashmir Joint Awami Action Committee (JAAC).

The Azad Kashmir government has fulfilled its promise to provide affordable electricity to the public by issuing bills at the new rate, with no surcharge. The outstanding amounts will be collected in 12 installments.

As per the agreement signed in May, the electricity rate was fixed at Rs3 per unit. The Azad Kashmir government issued a notification implementing the new tariff, with rates of Rs3 per unit for up to 100 units, Rs5 per unit for 100-300 units, and Rs6 per unit for above 300 units.



Azad Kashmir witnessed violent clashes between the police and activists of a rights movement amid a wheel-jam and shutter-down strike across the territory, which left at least one police official dead and several others injured.

Sub-inspector Adnan Qureshi succumbed to the chest in the town of Islamgarh, where he was deployed to stop a rally for Muzaffarabad under the banner of the Jammu Kashmir Joint Awami Action Committee (JAAC).

The JAAC had sought the provision of electricity as per hydropower generation cost in AJK, subsidised wheat flour and an end to the privileges of the elite class. The violent protesters damaged multiple vehicles, including a magistrate's car at the Poonch-Kotli road. "These agents were recruiting citizens for begging in Saudi Arabia, and they used to receive their share from the money begged in the holy land," FIA said.

FIA spokesperson said that nine passengers destined to the Kingdom of Saudi Arabia, were arrested yesterday.

The FIA recently offloaded eight passengers at Multan Airport from a Saudi Arabia bound flight.

The passengers, who were natives of Bahawalnagar. The officials recovered 200 Saudi Riyal from each woman," FIA stated.

According to the FIA, the passengers had less than 500 riyals (approximately Rs 37,000) each, which is below the required amount required for travel.

## Pakistan's First Air Ambulance Successfully Transfers Patient

LAHORE: A rescue air ambulance, an initiative undertaken by the Punjab Chief Minister Maryam Nawaz, successfully transferred a patient for the first time in Pakistan, media reported on Sunday.

The patient, identified as Halima Bibi - a 40-year-old woman from Mianwali, suffered paralysis after falling from a roof two days ago.

Following CM Maryam Nawaz's directive, Halima Bibi was shifted from Mianwali to Rawalpindi within the critical "golden hour" in an air ambulance.

Nawaz, calling her an "angel" for facilitating the transfer. Punjab Chief Minister emphasised that quality and timely medical treatment is the right of every citizen and will be ensured. She also announced the commencement of Pakistan's first air ambulance operations while appealing to the nation to pray for Bibi's recovery. First female Punjab Chief Minister Maryam Nawaz had made an announcement of launch of the air ambulance service within weeks in her maiden address at the Punjab Assembly.

Earlier in March, the Punjab cabinet approved the project, marking a significant step forward in emergency medical services. These ambulances will be equipped to transport doctors, paramedics, and essential medical equipment, along with life-saving medicines. The air machines are designed to operate from short runways. They will also have the capability to land and take off from national highways and motorways.—RT/Agency

TANDO MUHAMMAD KHAN: Deputy Commissioner Dharmoon Bhawani has confirmed an outbreak of gastroenteritis in Moya town and its surrounding areas within Taluka Tando Ghulam Hyder. Responding swiftly, DC Bhawani has directed the District Health Officer, PPHI, and the in-charge of the local medical hospital to station themselves in Tando Ghulam Hyder to manage the crisis.

## Youth Killed In Fatal Umerkot Road Mishap

## Kashmore Youth Electrocutted While Repairing A Transformer

KASHMIRE: The incompetence of SEPCO staff has tragically claimed another life. In Solangi Muhalla, Rafique Ahmed Channa, a young man in his early twenties, was electrocuted while attempting to repair a faulty transformer on a private line.

## India Has Historic Relationship With Russia, Not Going To Cut It Off: US



Washington: There is no tangible evidence of India deepening its military and technology relationship with Russia, US National Security Advisor Jake Sullivan has said, asserting that Moscow, which has become a "junior partner" to China, is not necessarily going to be a "great and reliable friend" to India in a future contingency.

Mr Sullivan made remarks at the Aspen Security Forum in Colorado while responding to questions about the recent visit of Prime Minister Narendra Modi to Russia for bilateral talks with President Vladimir Putin.

"I think the biggest question is: Do we see tangible evidence that India is deepening its military and technology relationship with Russia? And I did not see tangible evidence out of that visit that it was deepening. I didn't see deliverables in that space," Mr Sullivan said.

"How concerned were you when Prime Minister Modi met President Putin, essentially at the same time that President Joe Biden was hosting the NATO leaders in Washington?" he was asked.

"Don't you think the bear hug was significant then?" he was asked. "Well, Modi has a certain way, of course, of greeting world leaders. I've seen it up close and personal, actually," Mr Sullivan said.

The Biden administration, he said, never wants to see countries that the US cares about, who are its partners and friends, show up in Moscow and hug Putin.—Agency

## Bangladesh top court scraps majority of job quotas that caused violent protests



DHAKA: Bangladesh's Supreme Court on Sunday scrapped most of the quotas on government jobs that have sparked student-led protests in which at least 114 people have been killed in the South Asian country, local media reported.

The court's Appellate Division dismissed a lower court order that had reinstated the quotas, directing that 93% of government jobs will be open to candidates on merit, without quotas, the reports said.

It was not immediately clear how the protesters would react to the decision.

## Pakistan Exported Seafood Worth \$410.2 Million In FY2024

ISLAMABAD: Pakistan earned \$410.268 million by exporting 200,709 metric tonnes of fish and fish preparations during the fiscal year 2023-24, Pakistan Bureau of Statistics (PBS) reported.

As compared to the exports of \$496.565 million during fiscal year 2022-23, the fish exports during the FY2023-24 witnessed a decline of 17.38 percent, according to PBS data.

In terms of quantity, the exports of fish and fish preparations decreased by 6.45 percent during the year when compared to exports of 214,542 metric tonnes during the last fiscal year.

On a year-on-year basis, the seafood exports decreased by 22.19 percent to \$31,044 million in June 2024 as compared to the exports of \$39,896 million in June 2023.

In terms of quantity, the exports decreased by 16.99 percent because by going down from 18,901 metric tonnes last year to 15,689 metric tonnes during FY 2024.

On a month-on-month basis, the seafood exports declined by 16.26 percent when compared to the exports of \$37,970 million in May, according to the PBS data.

In terms of quantity, fish exports decreased by 16.45 percent in June compared to the exports of 13,778 metric tonnes in May 2024.



The overall food group exports from Pakistan increased by 46.77 percent during the year as compared to the corresponding period of last year.

## Hezbollah Fires Rockets At Israel After Strike On Lebanon

Beirut: Lebanon's Hezbollah on Sunday said it fired Katyusha rockets at northern Israel in response to an overnight Israeli strike that, according to state media, hit a weapons depot and wounded six people.

Hezbollah has traded near-daily cross-border fire with Israeli forces in support of Hamas since the Palestinian militant group's October 7 attack on southern Israel triggered war in the Gaza Strip.

The Iranian-backed Hezbollah said it targeted northern Israel's Dafina area with Katyusha rockets "in response to the Israeli enemy's attacks that targeted civilians in the town of Adloun, injuring several of them".

This comes after an Israeli military said its air force struck two Hezbollah weapons storage facilities in southern Lebanon, containing rockets and additional weaponry." Late on Saturday, Lebanon's state-run National News Agency said "the Israeli enemy launched a raid"

on the town of Adloun, about 30 kilometres (19 miles) from the border with Israel, later saying the target was "an ammunition depot".

Sixteen civilians sustained moderate injuries, the NNA said on Sunday, revising the figure up from three the night before. Rockets were still exploding about an hour after the strike was first reported, the NNA said, with videos circulating online showing several large explosions in Adloun.—Agency

## SFA Vigilance Team Uncovers Severe Violations At Suaad Bakery

KARACHI: The SFA Vigilance team recently conducted an inspection at Suaad Bakery's large manufacturing unit located in Memon Goth, Malir. The inspection revealed numerous critical violations, including: Unhygienic conditions throughout the facility; High levels of cross-contamination in the freezer; Use of expired food colors and flavors; Personal hygiene issues among staff; Missing Manufacturing Records (MRD) on food products; Uncovered food products; Dirty floors and utensils; Extremely poor sanitary conditions; Substandard product quality; Unpleasant smells emanating from cakes; Uncovered dustbins; Lack of pest management.



In response, the SFA team conducted a thorough counseling session with the bakery management. A fine of 600,000 PKR was imposed, and a 7-day period was granted for the implementation of necessary improvements. The SFA has warned that failure to comply with their Standard Operating Procedures (SOPs) will result in stringent actions. DG SFA Muzamil Husain Halepoto emphasized that ensuring food safety remains the top priority. He urged all stakeholders to work together to uphold high standards and safeguard public health.—RT

## FO Summons German Ambassador Over Vandalism At Pakistan Consulate In Frankfurt

ISLAMABAD: In a rare move, the Foreign Office on Sunday summoned the German ambassador in Islamabad to demand an apology for the vandalism of Pakistan's diplomatic mission in Frankfurt by Afghans.

The protest had been lodged with the German Embassy but didn't say if its envoy was called to the ministry. The handout urged protesters a "gang of extremists", without identifying their nationalities. "Pakistan strongly condemns yesterday's attack by a gang of extremists on its consulate in Frankfurt, Germany, and the failure of the German authorities to protect the sanctity and security of the premises," it read.

The statement reminded that under the Vienna Convention on Consular Relations, 1963 it was the responsibility of the host government to protect the sanctity of the consular premises and ensure the security of diplomats. Sources said that the German ambassador was summoned to the Foreign Office over the incident. An official handout issued by the Foreign Office confirmed that

are conveying our strong protest to the German government," it added. The Foreign Office urged the German government to take immediate measures to fulfill its responsibilities under the Vienna Conventions and ensure the security of the diplomatic missions and staff of Pakistan in Germany. "We also urge the German authorities to take immediate measures to arrest and prosecute those involved in yesterday's incident and hold to account those responsible for the lapses in security," it demanded. ## Supreme Court Judges Divided On Reviewing Reserved Seats Verdict

ISLAMABAD: The top three judges of the Supreme Court are at odds over fixing review petitions, against the apex court's verdict on reserved seats in the national and provincial assemblies, for hearing.

Media reported on Sunday that Chief Justice of Pakistan (CJP) Qazi Faez Isa was at loggerheads with Justice Syed Mansoor Ali Shah and Justice Munib Akhtar over fixing the review petitions for hearing as the former wants it to be immediately fixed, while the latter wanted it to be heard after summer vacations, when the detailed ruling is released.

CJP Isa said that it would be an injustice if the pleas were not fixed for hearing now. While, Justice Mansoor and Justice Munib believed that it could be fixed only after detailed verdict on the July 12 ruling was released by the 13-member bench.

During the 17th meeting of the committee constituted under Section 2 of the Supreme Court (Practice and Procedure) Act 2023 held on July 18, both the senior



judges of the apex court opposed the idea.

Justice Munib participated in the meeting through a video link, as he is on vacation.

The majority of the committee members decided to fix the hearing's date after summer vacations, when the complete bench that announced the judgement would be available.

The committee secretary pointed out that in two urgent applications that were filed with the review petitions, the petitioners said that the order under review had set a deadline of 15 days, and if that order was executed, the petitions would already

become redundant.

Under order XXVI, Rule 8 of the Supreme Court Rules 1980, Justices Mansoor and Munib made the following observations that the review petitions could only be scheduled before the bench that heard the case initially and given that the court is in the midst of its summer vacation and that the majority of its judges are either abroad or on vacation, hence, it would be suitable if the matter was fixed after the vacations.

"Additionally, it was also pointed out that the review petitions are not fixed until detailed judgement is released by the bench and in

this case the detailed judgement is still awaited," read the minutes of the meeting.

Chief Justice Isa, nevertheless, urged that the right of review had been provided under the Constitution and such right had to be preferred over the judges' convenience.

"Also, as the judges had taken oath to abide by the Constitution, it would be unjust and unfair if the review petitions were not fixed urgently," the chief justice told the committee, emphasising that the order under review required reopening of the court even if it required cancellation of vacations.

In response, Justice Munib commented that summer vacations were provided under Order II of the Rules. Rule 3 of the said Order which provides that the judicial year of the Court shall commence on the second Monday in September each year and continue until the commencement of the vacation in the year next following.

Justice Munib said that Rule 4 provides that summer

vacation of the Court shall commence on June 15 or on such date as may be fixed in each year by the CJ and notified in the gazette.

The judge pointed out that the chief justice through a notification dated June 4, 2024, extended the date of commencement of summer vacations as July 15, 2024, however, there is no provision in the said order for cancellation of the summer vacations once the same have been announced unless the matter is put up before the full court and the rules are amended accordingly.

"Hence, cancellation of vacation cannot be resorted to by the committee or the chief justice," the judge further told the body. Meanwhile, the committee considered and approved the court rosters during summer vacations from July 29 to September 6. Meanwhile, CJP Isa said that the minutes of the meeting have been written by his colleagues with whom in respect of agenda items 1 and 3, he cannot agree and has written his separate note.—RT/Agency

## Chinese IPPs Urged To Use Local Coal In Effort To Lower Power Prices

ISLAMABAD: Pakistan has decided to press Chinese independent power producers (IPPs), which rely on imported coal, to switch to locally sourced solid fossil fuel to cut generation costs and provide relief to consumers tormented by bloated utility bills.

"Pakistan this month will ask Chinese power plants operating in the country to shift to using coal from Thar region rather than imported coal," Federal Minister for Energy (Power Division) Awas Leghari told Reuters on Sunday.

He added that the transition could save Pakistan more than Rs200 billion a year in imports, translating to a decrease of as much as Rs2.5 per unit in the price of electricity.

Islamabad may also begin talks on re-profiling Pakistan's energy sector debt during the visit to Beijing."

Such a transition would benefit the Chinese-owned plants in Pakistan by reducing pressure on the country's foreign exchange reserves, he said, making it easier to repatriate dividends and offering a better return in dollar terms.

The power czar will be part of the delegation to discuss structural reforms to the power sector suggested by the International Monetary Fund (IMF), which last week agreed on a \$7 billion bailout for the heavily indebted South Asian nation.

Neighbouring China has set up over \$20 billion worth of energy projects in Pakistan.

"One of the key purposes of going along is the conversion of our imported coal



units to the local coal. That would have a huge impact on the cost of energy, of power in the near future. So that is one of the biggest (items on the) agenda," Leghari said in an interview.

In April a subsidiary of conglomerate Engro agreed to sell all of its thermal assets, including Pakistan's leading coal producer, Sindh Engro Coal Mining to Liberty Power.

Liberty said the decision stemmed from Pakistan's foreign exchange crunch and its indigenous coal reserve potential.

The minister declined to elaborate on the possible talks with China over re-profiling energy debt.

Pakistan's power sector has been plagued by high rates of power theft and distribution losses, resulting in accumulating debt across the production chain — a concern raised by the IMF.

The government is implementing structural reforms to reduce circular debt — public liabilities that build up in the power sector due to subsidies and unpaid bills — by Rs100 billion a year, Leghari said.

Poor and middle-class households have been af-

ected by a previous IMF bailout reached last year, which included raising power tariffs as part of the funding programme that ended in April.

Annual power use in Pakistan is expected to fall consecutively for the first time in 16 years as higher tariffs curb household consumption, despite summer temperatures surging to near records, which typically boosts air conditioning and fan use.

"We have seen a shrinking demand trend in the past year or year and a half, and we are expecting this to continue unless we rationalise the price of power," Leghari said, adding that the government's major challenge was getting demand to stop shrinking.

He said that since the per-unit tariff for power is more expensive, both urban and rural households are moving towards alternatives such as solar. "Right now we have close to 1,000 megawatts that are on the grid itself in the form of net metering systems and others. It's a very conservative estimate that (solar) could be five to six times more than that on the grid right now," Leghari said.—RT/Agency

## Kirmani Criticizes PML-N As 'Non-Serious And Incompetent' After Leaving Party

LAHORE: Dr Syed Asif Kirmani, the former political secretary of ex-prime minister Nawaz Sharif, voicing strong opinion about the current state of the party, has said that members of the Pakistan Peoples Party (PPP) and the Jamaat-e-Islami (JI) have infiltrated the ranks of the N-League, adding that these individuals "do not represent the true face of the PML-N".

Kirmani, in a surprise statement on Saturday, announced quitting the PML-N, criticising the top leadership of the ruling party. He said he had already distanced himself from the political affairs of the Nawaz-led party for a long time.

The former N-League veteran quit the party over differences with the top party leadership's decision to form a government following the February 8 general election despite rigging allegations.

Sharing his insights in an interview with media on Sunday, he expressed concerns about the calibre of current party members holding key positions, also describing them as "non-serious and incompetent".

"It seems Nawaz Sharif has been rendered helpless," the former politico claimed. "This is not the same Nawaz Sharif I once knew."

Despite his departure, the PML-N's deserter stressed he still maintains his respect for Nawaz, saying: "I respected Nawaz Sharif in the past, and



I respect him now as well."

The former PML-N leader said he gave almost 19 to 20 years to the party and remained a close associate of Nawaz, adding that they have left a "loyal companion behind".

Reflecting on his decision to part ways with the party, he admitted: "It was painful leaving my home." He also called on the PML-N supremo to engage with the general public to have an idea of what they are going through. "Mian Sahib, everything is not alright. Come out, [mingle with people] and see for yourself!"

Responding to a query about his future political plans, Dr Kirmani insisted that he was not joining any political party, adding he was a "born PML-N supporter" and wished to die as a member of the PML-N family."

Kirmani was appointed by then-prime minister Nawaz as his political secretary during his rule in

2013. Being a close aide of the three-time PM, he played an active role during the PML-N's election campaign before the party rose to power in 2013.

Moreover, Abbas Khan Afridi also called it quits last month, claiming that the party's president Nawaz was "no longer relevant in the country's politics".

Similarly, senior PML-N leader and former Sindh governor Muhammad Zubair, ex-prime minister Shahid Khaqan Abbasi and former finance minister Mifath Ismail had left the ruling party in recent months.

Abbasi and Ismail had launched a new political party, Awaam Pakistan, earlier this month which was joined by several former PML-N leaders including Sardar Mehtab Ahmed Khan Abbasi, Javed Abbasi, Syed Zaeem Hussain Qadri, Rana Zahid Tauseef, Zahid Binnouri, and Sardar Anwar Soomro.—RT/Agency

## Ban On PTI Is Solely PML-N's Decision: Governor Punjab



WAZIRABAD: Governor Punjab Sardar Salim Haider Khan stated that the decision to ban Pakistan Tehreek-e-Insaf (PTI) was made solely by the Pakistan Muslim League Nawaz (PML-N) leadership without consulting the Pakistan Peoples' Party (PPP), media reported on Sunday.

Speaking to the media, Sardar Salim expressed that the PPP will address this issue in its party meeting and Central Executive Committee (CEC).

He added that, in his opinion, PTI should be considered in two parts: those involved in the May 9 incidents should be punished, but action against those patriotic to the country is inappropriate.

It is pertinent to mention here that the federal information minister Ata Tarar has announced that the government has decided to ban PTI.

Addressing an explosive presser, Ata Tarar said Article 17 of the constitution empowers the federal government to ban a political party. He said there is credible

evidence to support a ban on the PTI and cited the party's involvement in foreign funding, the May 9 incident, its role in the resettlement of terrorists in Pakistan, the cipher episode, and the resolution passed in the United States.

Attaulah Tarar stated that a reference would also be filed against former President Arif Alvi, former Prime Minister Imran Khan, and former Deputy Speaker Qasim Suri for violating the Constitution when the assemblies were dissolved following the no-confidence motion against the PTI government. He said the reference will be forwarded to the Supreme Court after approval by the federal cabinet.

The minister said certain lobbies are sitting abroad that promote an anti-Pakistan agenda, support separatist movements, and conspire against the country's security and institutions. He mentioned the government has decided to take strict legal action against them, which may involve blocking their passports and identity cards.—RT/Agency

## 2018 Elections Were Not Rigged But Managed: Fawad

ISLAMABAD: Former Federal Minister Fawad Chaudhry has claimed that 2018 elections, wherein Pakistan Tehreek-e-Insaf (PTI) emerged victorious, were not rigged but managed, media reported on Sunday.

In an interview, the former federal minister also castigated Chief Election Commissioner (CEC) Sikandar Raja Sultan and alleged that Pakistan Muslim League-Nawaz (PML-N) "installed" the latter through former director-general (DG) Inter-Services Intelligence (ISI) Faiz Hamid.

Fawad Chaudhry also claimed that former Chief of Army Staff (CAJS) Qamar Javed Bajwa sought an extension from PTI and wanted to get another extension from PML-N. He said 2018 elections were not rigged but 'managed'.

The former minister claimed that when Nawaz Sharif was allowed to travel abroad in 2019, he



realised that "work" had started on the other side.

He emphasised that the solution to all problems lies in a "Grand Dialogue" and that PML-N and Pakistan People's Party (PPP) are realities that need to be engaged with.

Earlier on July 3, Fawad Chaudhry expressed surprise at PTI's willingness to engage in talks with establishment, saying that this decision was tantamount to "deal-seeking".

Speaking to an international media outlet, the former minister said that

negotiating with the establishment is equivalent to seeking a deal, and that talks will only be successful if held on an equal footing.

Chaudhry suggested that the PTI should only be talking to opposition parties at this stage, and that negotiations with the government should come later. He also criticised PTI's approach to negotiations, saying that seeking a deal with the establishment would be no different from what Prime Minister Shehbaz Sharif would do.—RT/Agency

## NAB Investigates Imran And Bushra Bibi In New Toshakhana Reference

RAWALPINDI: The National Accountability Bureau (NAB) team, headed by Deputy Director Mustansar Imam Shah probed Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan and his spouse Bushra Bibi in the new Toshakhana reference at Adiala Jail.

According to jail sources, today marks the seventh day of the NAB team's investigation at Adiala Jail and the NAB team will present a progress report on the investigation in court tomorrow.

The NAB team is keeping to gather information and evidence related to the case.

Sources revealed that the court has ordered the reappearance of the PTI founder and Bushra Bibi on July 22. It is pertinent to note that Imran Khan and Bushra Bibi are on eight-day judicial remand in new Toshakhana

reference. Imran Khan and Bushra Bibi were arrested in a NAB Toshakhana reference, hours after their acquittal in the Iddah nikah case.

According to jail sources, Imran Khan and his wife were arrested for not cooperating in the inquiry.

A NAB team headed by Deputy Director Mohsin Haroon reached Adiala Jail to arrest the former prime minister and his wife in new case.

The sources said that the new case was related to keeping and selling the ten valuable gifts which was against the law.

According to the NAB inquiry report, the PTI founder is accused of taking and selling seven precious watches which include Rolex, diamonds, and gold watches. The gifts were sold without taking ownership as per the law.—RT/Agency

## Imran Reveals Harrowing Prison Experience In Rare Interview, Describes 'Death Cell For Terrorists'

ISLAMABAD: In a rare interview from prison, former prime minister and Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan denounced his harsh confinement conditions, likening them to those of a terrorist.

Khan described it as solitary confinement with minimal space and constant surveillance, highlighting the denial of basic rights, including visitation.

"I am confined in a 7ft by 8ft death cell, typically reserved for terrorists to ensure they have no contact with anyone," he told The Sunday Times. "It is solitary confinement with barely any space to move. I am under constant surveillance by the agencies, being recorded 24/7, and I am denied basic prisoner and human rights such as visitation," he said.

Khan, 71, has been imprisoned for nearly a year on various charges, including corruption, treason, and an illegal marriage. His third wife, Bushra, is also incarcerated. The interview was conducted through his lawyers due to restrictions on his access to writing materials.

Recently, a UN working group declared Khan's de-



ment as arbitrary and in violation of international law, calling for his immediate release. Despite recent court rulings overturning some of his convictions, Khan remains in jail as bail was denied on allegations of inciting riots last year.

The government is contemplating a ban on Imran Khan's party, PTI, which won the most seats in the February elections. Khan argues that the elections were marred by "unprecedented pre-political rigging," including his imprisonment and the banning of his party's symbol.

He urged the international community to review the findings and address the issues impacting Pakistan's democracy and its people.—RT/Agency

ISLAMABAD: Defence Minister Khawaja Asif has said when Shafqat Mehmood was with Shahbaz Sharif, he used to write columns against Imran Khan in very good English.

"I know Mehmood since 1964. I had a misunderstanding of a close friendship with him for 50 to 55 years. During that period,



they both conducted good and bad deeds together, on him, Mehmood conducted a very smoky press conference against him upon his residence and salary broad.—RT/Agency
