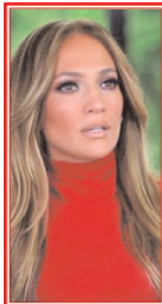

PPP Files Review Plea On SC's Reserved Seats Verdict, Following PML-N's Lead

ISLAMABAD: After the Pakistan Muslim League-Nawaz (PML-N), its coalition partner Pakistan Peoples Party (PPP) has also filed a review petition against the Supreme Court verdict granting reserved seats to the Pakistan Tehreek-e-Insaf (PTI).

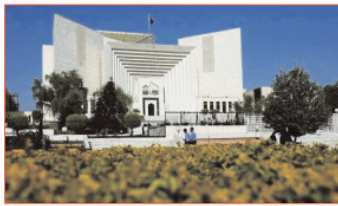
On behalf of the PPP, Farooq H Naek filed the plea, seeking to overturn the apex court verdict of July 12 pertaining to reserved seats of women and non-Muslims.

In its appeal, the PPP objected to granting the reserved seats to the PTI, arguing that the former ruling party had not claimed any entitlement to them.

The PML-N had on July 15 filed a review petition in the SC against the same verdict. The review petition had asked a number of questions including whether the SIC should be granted the reserved seats.

The decision not only paved the way for the PTI's return to the parliament, which was kicked out of the February 8 polls owing to the Election Commission of Pakistan's (ECP) December 2023 ruling but has also increased the pressure on the coalition alliance by changing the composition of the National Assembly.

The 8-5 majority verdict



declared that the lack or denial of an election symbol does not in any manner affect the constitutional or legal rights of a political party to participate in an election, whether general or by, and to field candidates and that the commission is under a constitutional duty to apply all statutory provisions accordingly.

The PPP has requested the SC to fix the hearing of the review petition at the earliest as "the order under review has given a strict timeline of 15 days" and if the order is implemented, the plea will become infructuous.

The political party stated that the SC verdict was silent on the main controversy in the reserved seats case which was whether the Sunni Ittehad Council (SIC) should be granted the reserved seats; whether the seats could be granted to a political party

that had not submitted a party list within the prescribed time; if a political party whose candidates have not even filed nomination papers can be given reserved seats; if independents can even join a political party which did not win a single general seat in the parliament; if the seats can be left vacant or have to be distributed amongst the political parties contesting for the said seats and what is the "proportional representation system of political parties' lists of candidates".

Similar questions were raised by the PML-N as well in its review plea. The PPP plea said the SC judgment contradicted the Constitution as it provided only three days to the returned candidates to decide which party to join, while the ruling has given 15 days that too from the date of the order.—RT/Agency

Salman Akram Raja: Imran Khan Did Not Admit To Any May 9 Allegations

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) legal counsel for beleaguered party founder Imran Khan, Salman Akram Raja, on Tuesday stated that Khan has not admitted to any wrongdoing regarding the events of May 9.

Raja noted that following the Rangers' action in Zaman Park, it was unanimously decided that protests would occur at designated locations, whether GHQ or any other office.

After meeting with the PTI founder at Adiala Jail today, the lawyer spoke to the media, saying, "We are ready to discuss Pakistan's welfare. We want to move forward, ensuring that there is no chaos in the country and that the economy progresses, lifting people out of poverty and inflation."

He added, "The current environment being created will lead to disaster."

PTI's legal counsel highlighted the importance of public involvement, saying, "You cannot achieve the welfare of the state by distancing it from the people. It is es-



sential to move forward with the people and their elected leadership."

He relayed the PTI founder's message, stating, "The news about an admission is completely false. The PTI founder has not admitted to anything regarding May 9."

He maintained that Imran's stance remains that the attacks on March 14 at Zaman Park and on March 18 at the judicial complex involved Rangers, police, and ISI personnel.

Last night, Senator Faisal Vawda accused PTI supreme Imran Khan of being responsible for Pakistan's current political instability, citing evidence provided by former director general Inter-Services Intelligence Lt Gen (ret'd) Faiz Hameed, linking

ing Khan to the May 9 vandalism incident.

"I cannot champion law and democracy when multiple cases are pending against me in courts. Some time ago, I revealed that Imran Khan's close associate, Faiz Hameed, provided evidence of Khan's involvement in the May 9 vandalism," stated Vawda during an interview with a private TV channel.

During media talk today, Salman Akram Raja explained that following these incidents, the party decided that if there was further interference by the Rangers or ISI in police matters, peaceful protests would occur at appropriate locations, including GHQ or other offices, without causing damage.—RT/Agency

Barrister Gohar: PTI Leaders Don't Need To Prove Their Patriotism

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) founder and barrister Gohar says his party has always condemned the incidents of terrorism without any ifs or buts.

In a statement on Tuesday, the PTI leader said, "Members and leaders of the party do need to prove their patriotism to anybody as they have always worked for the prosperity of the country."

Gohar added that "PTI is the most popular party in the country right now



and no ban will be able to curtail its rise." The PTI chief said that all the cases against the PTI founder have proved nothing but the resilience of the party and its leaders who have stood against heavy odds.—RT/Agency

PTI Launches Hunger Strike Demanding Release Of Imran Khan And Other Leaders

ISLAMABAD: The embattled Pakistan Tehreek-e-Insaf (PTI) on Tuesday established a hunger strike camp outside the Parliament House in Islamabad to demand release of the party founder Imran Khan and other leaders.

The former ruling party has faced back-to-back setbacks in a few days as its central secretariat in the federal capital was sealed by the authorities earlier today a day after the party's Information Secretary Raof Hasan was nabbed along with the other party workers.

A day earlier, Islamabad police took Hasan into custody from the party's Central Secretariat for heading a digital media cell and its alleged involvement in running anti-Pakistan propaganda.

Speaking to journalists outside parliament, the party chairman Barrister Gohar Ali Khan said that the hunger strike will be observed daily till 8pm as a token protest against "injustice" and for the PTI founder's release and the supremacy of the parliament.

He added that he con-



veyed his party's reservations to National Assembly Speaker Ayaz Sadiq over "illegal and unconstitutional actions".

The lawyer-cum-politician said that his party raised voice for the PTI lawmakers and their families who were being picked up.

"[The] PTI founder and his wife have been imprisoned for no reason. This camp will continue till the release of the PTI founder."

Gohar strongly condemned the sealing of the party's secretariat in the federal capital.

It is noteworthy to mention here that the Islamabad administration sealed the

High Court (IHC).

Another PTI senior leader and former NA speaker Asad Qaiser said, "Our first demand is to release the PTI founder, his wife Bushra Bibi and other detainees, including Hasan and party workers."

He held the federal government responsible for the recent wave of lawlessness and inflation across the country.

Qaiser urged the Pakistan Muslim League-Nawaz (PML-N) government to immediately resign over "bad governance and mismanagement of the economy".

PTI's Secretary-General Omar Ayub Khan said that the token hunger strike was being observed for the release of the incarcerated former premier, PTI Vice Chairman Shah Mahmood Qureshi and other arrested leaders and workers.

The opposition leader in the National Assembly censured the Metropolitan Corporation Islamabad (MCI) for sealing the PTI's central office once again. Instead of

the PTI secretariat, the MCI should seal its own office "where mice running everywhere" he slammed.

"Omair also demanded the 'Form 47' government—a reference to the alleged manipulation in the February 8 election results—to immediately resign and announce fresh elections. He added that the PTI wanted free and fair polls to pull the country out of crisis."

Addressing the participants of the hunger strike camp, Shibli Faraz said that today's event was part of the PTI's political struggle. He also announced that the Imran-founded party will hold a countrywide protest on Friday, July 26, 2024.

Several PTI lawmakers joined the hunger strike camp including Gohar, Qaiser, Omar, Faraz, Latif Khosa, Ali Muhammad Khan, Falak Naz Chitrali, Sheikh Wasim, Senator Humayun Mohmand, Saifullah Abro, Shabbir Ali Qureshi, Sahibzada Sibghatullah, Melhboob Shah, Sajid Mohmand, Dawar Kundli, and others.—RT/Agency

PM Shehbaz Urges FBR To Facilitate Smooth Refunds For Exporters



ISLAMABAD: Prime Minister Shehbaz Sharif on Tuesday warned the Federal Board of Revenue (FBR) against any delays in refunding exporters, aiming to alleviate concerns about meeting the \$60 billion export target.

While speaking at the National Export Development Board (NEDB), the prime minister directed the commerce ministry and other departments to take "all necessary measures" to achieve the ambitious export target of \$60bn in exports within three years.

The prime minister directed the ministry to resolve the issues raised by exporters and present a report within two weeks. He added that he would personally chair the NEBD meetings every six weeks. The prime minister noted that the country's exports had surpassed the \$30 billion mark during the previous fiscal year, with IT exports contributing over \$3.2 billion, thanks to government policies. He called it a "welcome development."

He lauded the business community and investors for their role in increasing exports despite challenging circumstances. Furthermore, he tasked the ministry of national food security to work with the provinces to improve extension services and enhance agricultural exports.—RT/Agency

Imran Khan Declines Polygraph Test In May 9 Cases



RAWALPINDI: Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan has refused to undergo polygraph and voice matching test as part of investigation launched by Lahore police regarding May 9 cases.

The Lahore police—led by DSP Javed Asif—had visited Adiala Jail in Rawalpindi and completed the first round of its investigation against Imran Khan in the May 9 cases. The PTI founder answered the questions of police for 15 minutes after DSP Javed Asif vowed to dispense justice. Meanwhile, the former premier refused to undergo the above mentioned tests to the Punjab Forensic Science Agency's team. The PTI founder said he was under the investigation of many institutions and he would give time to the police after the completion of his earlier inquiries.—RT/Agency

Ambassador Durrani: TTP Pakistan's 'Red Line,' Expects Afghan Taliban To Take Action

ISLAMABAD: Pakistan's Special Envoy for Afghanistan Ambassador Asif Khan Durrani on Tuesday said the banned militant Tehreek-i-Taliban Pakistan (TTP) group was the country's "red line" and there were hopes that the interim Afghan government would take effective action against the outfit.

"Terrorism emanating out of Afghanistan is a concern not only for Pakistan but other neighbouring countries like China, Iran, Tajikistan and Uzbekistan as well," Ambassador Durrani said at a roundtable discussion on "Pak-Afghan Relations: Challenges and Opportunities" at the Institute of Regional Studies (IRS) Islamabad.

He urged the Afghan interim administration to take steps against terrorist groups.

At the same time, Durrani said, "We have to deal with the Afghan government with patience and perseverance. Pakistan desires peace and stability in Afghanistan."

The comments come a day after the Pakistan army killed three terrorists trying to infiltrate the Pak-Afghan border in Khyber Pakhtunkhwa's Dir district.

Ambassador Durrani said Pakistan desired socioeconomic and political conditions in Afghanistan that would facilitate the return of over three million Afghan refugees currently residing in the country.

He urged the international community, especially the



UN Refugee Agency UNHCR, to come up with strategies for the dignified return of Afghan refugees to their homeland.

Ambassador Durrani shared that the Afghan administration's efforts for poppy eradication were acknowledged by stakeholders at the UN Doha meeting that concluded earlier this month.

The special representative called for removing obstacles to trade between the two neighbours and the transit of Pakistan's goods from Afghanistan to Central Asia.

He also called for expediting regional connectivity projects such as the Turkmenistan-Afghanistan-Pakistan-India (TAPI) gas pipeline project and the Casa-1000 power transmission line from Kyrgyzstan and Tajikistan to Afghanistan and Pakistan.

Ambassador Durrani urged the government to continue its crackdown against smuggling from Afghanistan.

Speaking on the occasion, Abrar Hussain, Pakistan's former ambassador to Afghanistan, highlighted the

importance of border management in the relations between the two countries.

He appreciated people-to-people as well as diplomatic contacts between Afghanistan and Pakistan at the highest levels.

Hussain urged regional countries to assist the Afghan interim government in addressing its capacity issues regarding dealing with terrorism emanating out of Afghanistan.

In concluding remarks, IRS President Ambassador Jaubar Saleem, highlighted the multiple commonalities and linkages between Pakistan and Afghanistan, besides the economic interdependence.

He termed terrorism as the major source of friction between the two neighbouring countries and called upon the Afghan interim administration to honour its commitments about not allowing its soil to be used for terrorism against any other country, underscoring that supporting counter-terrorism would be in the interest of Afghanistan itself.—RT/Agency

Justice Jahangiri: Bench And Bar Must Collaborate To Ensure Justice

ISLAMABAD: Justice Tariq Mehmoob Jahangiri of the Islamabad High Court (IHC) said on Tuesday that if "we don't dispense justice then there is also a court of the Almighty."

During his address a ceremony organised by the Islamabad High Court Bar Association (IHCBA), he said that problems face by the bar must be solved as he also belonged to the bar, adding that bench would also have to play its part. Criticising the lawyers for appearing late in hearings, Justice Jahangiri suggested that lawyers



should prepare the case very well and come to the court on time. He further reiterated that he "recites the Holy Quran" daily for avoiding any injustice through his verdicts, adding that as much as 80%

people expect us to give justice. "I have never gone against the merit, whoever commits travesty of justice is a criminal in the eyes of pleader and the Almighty," he added.—RT/Agency

Former Provincial Minister and Senator Sassui Palijo Criticizes Critical Issues in Thatta and Sujawal

KETIBUNDAR: Sassui Palijo, former provincial minister and senator, has voiced grave concerns over the dire conditions in the Thatta and Sujawal districts, exacerbated by a severe heat wave and prolonged electricity outages. Palijo reported that both businesses and residents are struggling, with some areas experiencing power cuts lasting up to 14 to 20 hours daily. Despite the severity of these issues, WAPDA and other relevant authorities have not taken adequate action.



Palijo, who has been actively visiting various villages to offer condolences and meet with local communities, highlighted the suffering of Sindh's residents, attributing it to governmental neglect. She pointed out that Sindh, being the highest revenue-generating province, particularly in the districts of Thatta and Sujawal, faces severe shortages of water and electricity due to its position at the end of the supply chain. She criticized WAPDA and IRSA for their failure to adequately provide essential services, which has worsened the crisis. Palijo also condemned the recent digital population census, alleging that it was fraudulent and manipulated. She claimed that the census results were rejected by the people of Sindh, accusing the process of criminally and unconstitutionally reallocating seats from Sindh to Karachi. She has called for accountability for what she describes as a grave injustice.

Commissioner Faisal Ahmed Uqaili Forms Committees to Oversee LBOD Projects

MIRPURKHAS: Divisional Commissioner Faisal Ahmed Uqaili has established tehsil-level committees to oversee ongoing work on the Left Bank Outfall Drain (LBOD) and address urban flooding issues. The move aims to enhance coordination and ensure the effective management of the LBOD projects across the Mirpurkhas, Umerkot, and Tharparkar districts.



The committees, chaired by the Assistant Commissioner of each tehsil, will include the Sub-Divisional Police Officer, Chairman of the Town Committee, Chairman of the Union Council, and representatives from the Irrigation Department of Nara Canal and the LBOD Department. In Tehsil Hussain Bux Marri and Tehsil Mirpurkhas, the Mayor of Mirpurkhas and the Municipal Commissioner will also be members of the committees.

These committees will play a critical role in coordinating emergency responses during heavy rains and floods. They are tasked with reviewing the progress of the LBOD Dhoro Puran Nullah project every 15 days, forming a WhatsApp group for efficient communication, inspecting weak embankments, and addressing any issues that arise.

Assistant Commissioners have been instructed to provide immediate reports to the Deputy Commissioners to keep them informed about the status and challenges of the LBOD projects. The establishment of these committees is expected to improve oversight and management of the LBOD infrastructure, contributing to better flood control and drainage solutions in the region.

DC Dr. Syed Muhammad Ali and District Council Chairman Bangal Khan Mahar Review Flood Precautionary Measures

GHOTKI: Deputy Commissioner Dr. Syed Muhammad Ali and District Council Chairman Bangal Khan Mahar conducted an on-site inspection of the Qadirpur Shank bund to evaluate flood precautionary measures. Sindh Government To Launch Decisive Crackdown On Drug Use

KARACHI: The Sindh government has resolved to take decisive action against drug use across the province. Provincial Minister for Narcotics Control, Sharjeel Inam Memon, presided over a key meeting with officers of the Excise Narcotics Control Wing at the Directorate of Excise and Narcotics Control in Karachi. The meeting was attended by Secretary Excise, Taxation and Narcotics Control Salim Rajput, Director General of the Narcotics Control Wing Usman Ghani Siddiqui, and other senior officers.



During the meeting, Memon was briefed on the anti-narcotics operations and ongoing initiatives through-

gent and effective measures against drugs in every city, regardless of its size. He assured that the police would always be ready to support the excise teams. He reiterated that the Sindh government's policy against drugs is based on zero tolerance, and there would be no leniency for anyone involved in drug trafficking.

The minister also emphasized the need to strengthen the prosecution of cases to ensure that drug peddlers face the full consequences of their actions. He called for tighter checks at inter-provincial border areas to curb the movement of narcotics.—RT

Sindh Reinstates 15% Service Tax On Card Payments at Restaurants

KARACHI: The Sindh government has reinstated a 15 per cent service tax on debit and credit card payments at restaurants and hotels across the province.



This move marks a reversal from a previous reduction in the tax rate, which had been lowered to 8 per cent earlier in the year.

The Sindh Revenue Board confirmed that 58 establishments in Karachi have been authorised to apply the increased tax rate.

This adjustment aims to address revenue shortfalls and improve tax compliance across the hospitality sector.

The higher tax rate will be applied to card transactions at these venues, affecting both local patrons and visitors.

The reinstatement of the 15 per cent tax follows a period of reduced rates intended to stimulate consumer spending and support the restaurant industry amid economic challenges.

However, the increase is expected to lead to higher costs for diners and may influence spending patterns in the city's vibrant food and hospitality sector.

Officials have stated that the adjustment is part of broader fiscal measures aimed at balancing the provincial budget and addressing revenue gaps.

The tax on card payments is a significant revenue source, and this change underscores the government's efforts to ensure that the sector contributes adequately to the public finances.

The actual impact of this tax increase on restaurant sales and revenue remains to be seen, as card transactions constitute a substantial portion of many establishments' business. The Sindh Revenue Board has indicated that further evaluations of tax compliance and revenue outcomes will be conducted in the coming months.—RT/Agency

Jirga Decides On Couple's Murder Case In Karachi's Manghopir

KARACHI: The decision about killing of a young couple in Manghopir area, was made by a Jirga, citing police sources media reported on Tuesday.

Police sources claimed that the parents of both husband and wife, were agreed over murder. "Initially both parties refused to register the murder case," according to sources.

Deceased Saira's mother and maternal aunt had key role in dual murder, police sources said. "Saira's mother accompanied by her sister entered in the house and talked for long time," sources said.

"Slain woman's mother called killers in home, who entered in the house and opened fire and also used knives in the gruesome dual murder crime," according to sources. "Four 30 bore spent bullets, two coins and other things recovered from the crime scene," police sources added.

The couple who had contracted free-will marriage was found dead inside their home in the Manghopir area on Monday.

According to SSP West Hafeezur Rehman Bugti, the bodies of the couple, identified as Adil and Sidra, were found inside their house with gunshot wounds.

The police officer said that the preliminary investigations revealed that the couple had married a few months ago and were living in hiding in the locality. SSP Bugti said that the girl's family discovered their whereabouts, and her brothers allegedly opened fire on the couple, killing both of them. He said that the twin murder was an honor killing, saying that the police are currently investigating into the incident.—RT/Agency

Sindh CM And Energy Minister Discuss Solar Energy For Households



KARACHI: Chief Minister Murad Ali Shah and energy minister Nasir Shah discussed solar systems project in a meeting, media reported on Tuesday.

Sindh's CM and energy minister discussed to provide solar systems to 5,00,000 households in the province.

Murad Ali Shah said that party chairman Bilawal Bhutto wants an immediate distribution of two lac solar panels in Sindh.

Haji Shaista Khan Achakzai Demands Justice After Attack On Nephew

KARACHI: In a troubling incident within the jurisdiction of the Site Super Highway Police Station, specifically in the New Sabzi Mandi area, Askar Khan, the nephew of Pakistan People's Party (PPP) leader and renowned businessman Haji Shaista Khan Achakzai, was attacked by over 20 individuals. Askar Khan, son of Faiz Muhammad Achakzai, sought refuge inside the New Sabzi Mandi police post during the assault. However, the attackers followed him inside, severely beating him and stealing 2 million rupees he had with him.

The enraged attackers

also assaulted Askar Khan in front of the post-in-charges, causing him serious injuries. Upon receiving the report, the severely injured Askar Khan was taken to Abbasi Shaheed Hospital.

Haji Shaista Khan Achakzai, a prominent trader and PPP leader from New Sabzi Mandi, confirmed these details to journalists. He added that he and his family have been receiving threats of severe consequences from ASI Ijaz and others involved. He demanded that the concerned authorities take notice of the matter and provide protection and justice for him and his family.

Mastermind Behind May 9 Unrest Admits Guilt: Maryam

LAHORE: Punjab Chief Minister Maryam Nawaz said on Tuesday the masterminds of the May 9 incidents had confessed to their crimes. Without quoting the name of a political party, she said in her statement "it's not a party rather a group of people who aim to undermine the state through chaos."

She claimed that Zaman Park - residence of PTI founder Imran Khan - had been a training centre for unscrupulous elements, where they were taught how to make petrol bombs and launch attacks on state establishments.

She questioned what kind of peaceful protest led to at-



tacks on more than 200 military installations. The participants set fire to Air Force planes and corps commanders' houses and showed disrespect to martyrs' memorials, she added. The chief minister also claimed that a conspiracy

was hatched to push Pakistan towards default. Sending letters to the International Monetary Fund and revealing the cipher were also part of the conspiracy. She demanded strict action against those involved in unlawful activities.—RT/Agency

Landlord In Punjab Allegedly Severed Donkey's Legs

JATOI: Another gruesome incident was reported from Jatoi Tehsil (an administrative subdivision), in Muzaffargarh district, Punjab province, where a landlord cut off two legs of the donkey after trespassing on his fields, media reported on Tuesday.

The cruel landlord cut off two legs of the donkey for trespassing on his fields, the police spokesperson stated

that the incident took place in Rampur, after which the accused has been arrested and a case has been registered.

The injured female donkey has been provided medical aid by the Livestock Department.

A similar incident was reported last week, where a landlord brutally killed a female donkey by ripping open its stomach with a sickle as punishment for scavenging in

his field. According to the details, a cruel landlord named Saqib brutally tortured the female donkey before killing it by ripping open its stomach with a sickle. The incident occurred in the 210 Jb Tarrar, located in the Chiniot district of Punjab province within the jurisdiction of Langrana police station.—RT/Agency

Commissioner Bilal Ahmed Memon Assures Monsoon Preparedness and Highlights Development Initiatives

Dilapidated Bridges in Kachho Pose Serious Threats to Residents

JOHI: The deteriorating condition of three key bridges in Kachho, Sindh, is posing serious risks to residents and tourists. These bridges, which connect hundreds of villages in Kachho and lead to the popular Gorakh Hill Station, are in a state of disrepair. They have demanded that the administration take immediate steps to reinforce both sides of the three dilapidated bridges to prevent further tragedies.

The community is urging for swift intervention to ensure the safety of residents and tourists and to prevent any more loss of life due to the poor condition of these vital infrastructure links.

Three Injured After Police Vehicle Collides with Motorcycle in Nawabshah

Messi and Suarez to miss MLS All-Star Game due to injuries



MIAMI: Inter Miami's Lionel Messi and Luis Suarez will not play in the MLS All-Star game scheduled for tomorrow due to injuries, the league and Inter Miami said in a statement.

A new MLS roster dedicated to the game against the Mexican Football All Stars in Columbus, Ohio excluded Messi and Suarez among others.

Messi is still recovering from a knock that saw him out of two MLS matches last week due to a right ankle injury sustained during the Copa America final against Colombia. While Suarez, who just rejoined the team after more than 40 days of national team duty, will also not play in the All-Star game because of knee pain, the team said.

It was supposed to be Messi's debut MLS All-Star game since the ace joined Inter Miami in July last year. A record eighth-time Ballon d'Or winner, who played the Argentine international in the 2022 World Cup, guided Miami to the recent celebration of the Leagues Cup last year, a competition created for MLS and Mexican league squads.

Miami also pointed out that Messi and Suarez are listed as doubtful for the Saturday home game against Mexico's Puebla to begin their Leagues Cup title defence. Whether or not these players will be available for the match will depend on their recovery process on that day, the team stated.—Agency

Afghanistan search options for tri-series with Pakistan, UAE

KABUL: The Afghanistan Cricket Board (ACB) has floated a plan to play a tri-series with Pakistan and the United Arab Emirates (UAE), as well as a team tour to Bangladesh and Zimbabwe.

The ACB Chairman, Mirwais Ashraf, and CEO, Naseeb Khan were in Colombo to attend the International Cricket Council (ICC) annual Board Meeting where they also met with Cricket South Africa, Cricket West Indies to discuss the possibility of a white-ball series before the Champions Trophy 2025.

"Afghanistan Cricket Board's Chairman, Mirwais Ashraf, and CEO, Mr



Naseeb Khan, attended the ICC Board Meeting which was held this week in Sri Lanka and was attended by representatives from other member countries," the ACB said in a press release. "During the meeting, ACB's leadership presented recent achievements, activities, and future plans for the Afghanistan Cricket Board. They also held discussions

with representatives from Cricket South Africa, Cricket West Indies about potential white-ball bilateral cricket ahead of the ICC Champions Trophy 2025. "The discussions also included a team tour to Bangladesh and Zimbabwe, and the possibility of a Youth Tri-Series against Pakistan and the United Arab Emirates, with the dates and venues to be confirmed. "The ICC leadership and meeting participants praised ACB and AfghanAtalan's recent accomplishments in the ICC Men's T20 World Cup 2024 and highlighted the team's remarkable performances and their significant contribution to entertaining fans around the world and the development of cricket in Afghanistan." The Afghanistan cricket team, under the leadership of Rashid Khan, recently surprised the cricket world in the T20 World Cup 2024. They defeated the likes of Australia, New Zealand and made their way to the semi-final, their first-ever last-four qualification in an ICC event.—Agency

LeBron James helps US win exhibition series with 5-0 record



LONDON: LeBron James led Team USA to a thrilling 92-88 win over Germany at the O2 Arena in London on Monday, wrapping up their final tune-up game before the Paris 2024 Olympics.

The 39-year-old star scored 20 points, shooting 8-11 from the field, and was instrumental in the final moments, netting the last 11 points for the team. Joel Embiid contributed 15 points, while Stephen Curry and Anthony Edwards added 13 and 11 points, respectively.

James' dominance in the closing moments sealed the victory, outscoring Germany 11-6 in the final 3:57. Despite holding a lead for most of the final minutes, Germany couldn't withstand the pressure from James and Team USA. Germany's top scorers included Franz Wagner with 18 points, Andreas

Obst with 14, Dennis Schroder with 13 points and 10 assists, Daniel Theis with 13, and Moritz Wagner with 12.

As per results, Team USA finished their exhibition series with a 5-0 record, having faced significant challenges from several teams. Canada, Australia, and South Sudan provided stiff competition, with Germany holding a lead over the US until the final four minutes.

Earlier, James was named the male flagbearer for the US at the opening ceremony along the River Seine.

Reflecting on the game, he said, "It was a good test for us. I'm glad we were able to keep our composure and persevere like we did the other day versus South Sudan. It was a good win for us.—Agency

England all-rounder disappointed over Naseem's unavailability for The Hundred

LAHORE: England all-rounder Moeen Ali expressed his disappointment over Naseem Shah's unavailability for The Hundred 2024, scheduled to run from July 23 to August 24.

Moeen Ali, who was named Birmingham Phoenix captain last week, claimed that Naseem Shah was their first-choice pacer and was anticipated to deliver notable performances to the side.

He further revealed that the Pakistan pacer's absence has damaged the team's balance and speculations made the decision in a bid to prevent Naseem from potential injuries and to ensure his workload management as he is Pakistan's first-choice pacer in all three formats.

For the unversed, Naseem Shah, who was signed by the Phoenix in the £125,000 category, was denied the No Objection Certificate (NOC) by the Pakistan Cricket Board (PCB).



According to the details, the cricketing body made the decision in a bid to prevent Naseem from potential injuries and to ensure his workload management as he is Pakistan's first-choice pacer in all three formats.

Considering Pakistan's upcoming busy season which includes World Test Championship (WTC) matches against Bangladesh, England and

For the unversed, Naseem also missed the ICC Men's Cricket World Cup 2023 in India due to a shoulder injury. The right-arm pacer suffered the injury during the

ACC Men's Asia Cup 2023 fixture against India which resulted in him ruling out of the tournament remainder.

Briefly, after Pakistan's 228-run defeat against arch-rivals India, the PCB called up Zaman Khan and Shahnaaz Dahani as backup pacers for the rest of the tournament, as a precautionary measure to provide a cover for injured Naseem and Harris Rauf.

Later, the PCB confirmed that Naseem Shah was ruled out of the Asia Cup 2023 and Zaman was added to the Pakistan squad.—Agency

Women's Asia Cup: Pakistan create history by posting 10-wicket win



DUBAI: Pakistan women's cricket team has created history by winning a match by ten wickets in the ongoing Women's T20 Asia Cup on Tuesday. Earlier, different teams won their respective matches by 9 wickets eight times.

The Girls in Green defeated the United Arab Emirates (UAE) by 10 wickets in a must-win match of the ongoing Women's T20 Asia Cup at the Rangiri Dambulla International Stadium today.

It was the second win for the Pakistan team in the tournament owing to an all-round performance. Pakistan lost their first match of the tournament to India. The Green Shirts have one step in the semi-final with four points from two victories.

In today's match, Pakistan opening duo Gull Feroza and Muneeba Ali, chasing the target of 104 runs, displayed formidable form with the bat as they reached home in just 14.1 overs without losing a single wicket, with 35 balls remaining.

Feroza hit 62 off 55 deliveries with eight fours while Muneeba contributed 37 runs on 30 balls with four boundaries. Winning the match by ten wickets in the tournament's history.

Nepal will lock horns with India in the last match of Group A today and the Green Shirts require the Blues to beat their opponents to ensure a secure entry into the semi-finals.

Earlier, Pakistan won the toss and asked the UAE women to bat first. However, they could not have a great start as they kept on losing wickets at regular intervals.

Skipper Esha Oza (16 off 26) and Theertha Satish (40 off 36) were the top two scorers for UAE as only Khushi Sharma (12 off 13) managed to contribute runs in double figures. For Pakistan, Sadia Iqbal, Nashra Sandhu and Tuba Hassan took two wickets each while skipper Nida Dar managed to get one.—Agency

LAHORE: Former Pakistan captain Younis Khan broke silence on the tragic death of former head coach Bob Woolmer amid ICC Men's World Cup 2007.

Woolmer passed away a day after Pakistan's early exit from the tournament due to their upset defeat against Ireland on March 17.

He was found dead in his room and speculations emerged that it might have been a murder. However, thorough investigations, carried out by the Pakistan Cricket Board (PCB) and Jamaican authorities confirmed it was a natural death.

Meanwhile, legendary batter Younis Khan, during



an interview at a local news channel, spoke highly of Bob Woolmer and claimed that had the latter remained Pakistan's head coach, the team would have achieved great success. "I have no doubt that if Woolmer had remained head

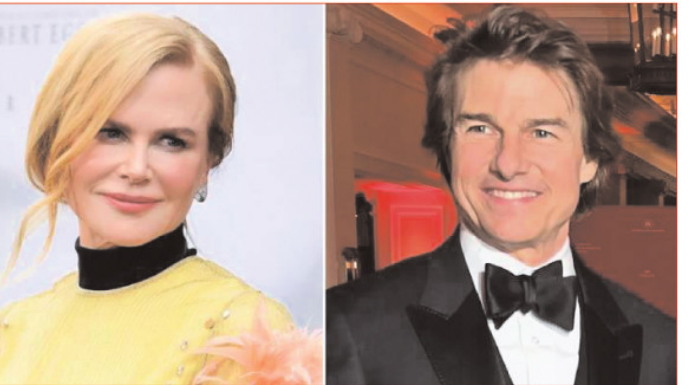

Assistant Commissioner Iqbal Ahmed Tunio Seals Three Shops for Contaminated Milk Sales

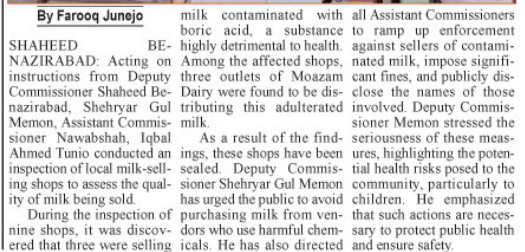

SHAHEED BENAZIRABAD: Acting on instructions from Deputy Commissioner Shaheed Benazirabad, Shehrvar Gul Memon, Assistant Commissioner Nawabshah, Iqbal Ahmed Tunio conducted an inspection of local milk-selling shops to assess the quality of milk being sold. During the inspection of nine shops, it was discovered that three were selling

milk contaminated with boric acid, a substance highly detrimental to health. Among the affected shops, three outlets of Moazam Dairy were found to be distributing this adulterated milk.

As a result of the findings, these shops have been sealed. Deputy Commissioner Shehrvar Gul Memon has urged the public to avoid purchasing milk from vendors who use harmful chemicals. He has also directed

all Assistant Commissioners to ramp up enforcement against sellers of contaminated milk, impose significant fines, and publicly disclose the names of those involved. Deputy Commissioner Memon stressed the seriousness of these measures, highlighting the potential health risks posed to the community, particularly to children. He emphasized that such actions are necessary to protect public health and ensure safety.



PTA Attributes Ongoing WhatsApp Disruption In Pakistan To 'Technical Glitch'

ISLAMABAD: Pakistan's telecommunication regulator has downplayed the ongoing issues with WhatsApp services being experienced by cellular users in the country, attributing it to a possible "technical glitch."

On July 20, numerous users in Pakistan began reporting difficulties in sending and receiving media files, such as voice notes, photos, and videos, on the popular messaging application while using their mobile networks.

Complaints included media files either taking too long to download or not downloading at all, with some users receiving the following message from WhatsApp: "Couldn't download document. Try again. If the problem keeps happening, try connecting to Wi-Fi."

According to a 2024 report by the World Population Review, there are 52.3 million WhatsApp users in Pakistan.

The disruptions have persisted for many users. In the last 24 hours, Downdetector, a global platform that monitors problems with websites and online applications, has continued to receive reports

regarding outages of WhatsApp in Pakistan. Private telecommunication services in the country have also confirmed the issue. A spokesperson for Jazz, Pakistan's largest mobile network, who asked to remain anonymous, told media Fact Check that the company has received reports of WhatsApp disruptions.

"We are looking into the matter, and our commitment to providing uninterrupted services continues," he added.

While a representative from Telenor Pakistan mentioned that they too had received "some complaints over the weekend" about WhatsApp's quality.

"We investigated the complaints and concluded

that there were no issues from our side or due to our network," he said. "If there was an issue from the backend or elsewhere, they can tell you better about it. That is beyond us."

A Zong Pakistan representative stated it was difficult to pinpoint the exact issue and declined to comment further.

However, Malahat Obaid, the spokesperson for the Pakistan Telecommunication Authority (PTA), denied any issues with WhatsApp presently. "There is no issue with WhatsApp or any social media apps currently," she told Geo Fact Check through a written response. SUP's Khamiso Khan Bhand Ensures Repair of Out-of-Order Motors at RO Plant

NAWAB WALI MUHAMMAD: In Nawab Wali Muhammad town, the RO (reverse osmosis) plant, which had been out of order for the past two months, has been restored to operational status thanks to the efforts of SUP leader Chairman Khamiso Khan Bhand. The repair work was carried out on the motors of the plant, which had previously been malfunctioning.

The RO plant, installed at a cost of millions of rupees, was crucial for addressing the arsenic contamination in the drinking water of Nawab Wali Muhammad town and surrounding areas. Residents of Esarpur Protest Against Poor Sanitary Conditions

SHAHEED BENAZIRABAD: Residents of Esarpur, including prominent figures such as Kashif Qazi, Faizan Jamali, Saber Jhooli Waro, Rashid Shah, Wasim, and others, have staged a protest against the Nawabshah Municipal Corporation, voicing their frustration over the area's poor sanitary conditions.

The demonstrators gathered to highlight their grievances, informing the media that their neighborhood has endured a dilapidated drainage system for over forty years. They reported that sewage water has been infiltrating their homes, resulting in severe mosquito infestations and numerous illnesses among their young children.

PTI Central Office In Islamabad Sealed Again

ISLAMABAD: The central office of Pakistan Tehreek-e-Insaf (PTI) in Islamabad has been sealed once again, this time due to inadequate fire and life safety arrangements. Islamabad's Metropolitan Corporation took the action, citing the lack of necessary safety measures. This development comes amid ongoing legal challenges faced by PTI.

On Monday, Islamabad Police arrested PTI Information Secretary Raouf Hasan during a raid on the party's Secretariat.

Earlier today, Hasan and 10 other male detainees were handed over to FIA on a two-day physical remand. The raid resulted in the seizure of computers and other items from the PTI office.

Traders Threaten Nationwide Shutdown Over Advance Income Tax

ISLAMABAD: The traders' community threatened to observe a country-wide shutdown if the government does not withdraw the recently issued Statutory Regulatory Order (SRO) under the Tajar-Dost Scheme, media reported.

President Ali Pakistan Anjum-e-Tajirain Ajmal Baloch in a statement rejected the SRO issued by the Federal Board of Revenue (FBR). He said that if the SRO

is not withdrawn, the traders will be forced to announce a nationwide shutdown.

Ajmal Baloch demanded from the FBR to immediately withdraw the SRO or else they would announce the strike.

Ajmal Baloch said that the SRO should be issued in accordance with the agreement terms between the government and the traders. The All Pakistan Anjum-e-Tajirain president

said that out that during the negotiations, the FBR was informed that the scheme has failed, and both filers and non-filers are already paying advance income tax through electricity bills.

Ajmal Baloch categorically said that traders will not pay any further advance income tax under any circumstances.

It is pertinent to mention here that the FBR extended the Tajar Dost scheme to 42 cities. —RT/Agency

Murad Orders SPSC To Conduct Annual Combined Competitive Exams

KARACHI: Sindh Chief Minister Syed Murad Ali Shah has directed the Sindh Public Service Commission to ensure the holding of a Combined Competitive Examination every year so that the shortage of officers can be met in time.

This he said while speaking in a meeting held with a delegation of SPSC members led by its Chairman Mohammad Waseem at the CM House on Tuesday. The member who attended the meeting includes Rizwan Memon, Rizwan Ahmad, Malik Ghori, Qazi Shahid Parvaiz, Arif Hanif, Farhat Kamal, Vikram Singh Sodho, Nusrat Mangan, Ms Kalpana Devi, Rabia Salauddin, Dr Qazi Masood, Muzaffar Leghari, Dr Saeed Mangrojo, and Secretary Nazeer Qureshi.

The Chairman SPSC briefing the CM said that the



SPSC was a constitutional body with the primary task of recruiting competent officers for the Sindh government. He added that the SPSC endeavored to recommend the most suitable candidates through a fair, transparent, and merit-based recruitment process. The CM was informed that approximately 28 requisitions were received from various departments of the provincial government for

the recruitment process against different posts. SPSC issued eight consolidated advertisements and Combined Competitive Examination-2023 promptly. Subsequently, more than 30 interview programs/sessions for different posts under different Committees were scheduled simultaneously, and results were announced promptly to complete the recruitment process. The CM was informed

that after due diligence, 5435 appropriate and qualified individuals, including Medical Officers (male/female) BPS-17, Staff Nurses BPS-16 Division-wise, Lecturers BPS-17, and Subject Specialists BPS-17, Municipal Officers BPS-17, Town Officer BPS-16, were recommended to the concerned administrative departments.

The CM instructed the Chairman SPSC to establish a computer-based testing laboratory to bring more transparency to the Commission and uphold meritocracy.

The number of Posts Recommended by the Sindh Public Service Commission for Various Departments in 2022 (September 2022 to December 2022), 2023 (January 2023 to December 2023), and 2024 (January 2024 to April 2024) is 9836.

Chairman SPSC informed the CM that the five

major departments served by the commission include the Health Department with 591 Posts, the Livestock Department with 257 Posts, Agriculture Supply & Prices with 127 Posts, Environment, Climate, 93 Posts, and College Education with 83 Posts.

To a question, the CM was informed that the commission was in the process of selecting 9466 posts, including 2600 posts of School Education, 1659 College Education, 383 Agriculture, 34 Works & Services, 179 Health Department, 1881 ASI, 1300 medical officers, and others. Murad Ali Shah directed the commission to select the best teachers for school and college education. The Chairman of SPSC along with his members presented an annual report to the CM.—RT

Mustafa Kamal Labels Independent Power Producers As National Security Threat

KARACHI: MQM leader Mustafa Kamal has termed independent power plants (IPPs) as threat to the national security, media reported on Tuesday.

Mustafa Kamal in a statement demanded immediate removal of the capacity payments clause from the IPP agreements. "We are paying billions of rupees for the electricity, which is not being generated," MQM leader said.

He said the amount allocated for capacity payments has been more than the defence budget.

"These agreements were signed in various governments, but we don't want to talk over it, we want a solution of the problem," Mustafa Kamal said.

He said Pakistan and



these agreements could not go side by side. "We don't want to do politics by threatening to quit the government," he added.

MQM leader said the national economy and development have dropped down. "People could not buy electricity on 60 rupees per unit price," he

said. "These contracts required to be reviewed," he said.

He asked the prime minister to discuss the matter with China, "inform them, we have committed mistake, Pakistan could not bear the burden of these agreements," he added.—RT/Agency

Sindh Extends School Summer Vacation Until August 14 Due to Heatwave

KARACHI: The summer vacations for all the public and private schools in Sindh have been extended till August 14 in the wake of ongoing heatwave and monsoon season.

The government notified the extension in an official statement issued on Tuesday.

As the heat continues to swelter Karachi and rest of the province, parts of Sindh and especially the port city is likely to get hit by another spell of monsoon rains between Wednesday and Sunday (July 24-28), depending on whether a weather system developing in the Bay of Bengal im-

pacts Gujarat, India's coastal state. A weather expert has forecast another spell of hot and humid weather starting Wednesday.

At the same time, he said a rain system, developing in the Bay of Bengal, might affect Sindh between July 24 and 28. He said if the same system hit India's Gujarat then Karachi might also receive showers.—RT/Agency

UK Parliamentarians Call For Immediate Release Of Imran Khan

LONDON: Nearly two dozen UK members of parliament have called for the immediate release of Imran Khan, the former prime minister of Pakistan, currently imprisoned in Adiala jail with his wife Bushra Begum.



The demand for Khan's release was made at a hearing today in the House of Lord's Committee Room about the erosion of democratic norms in Pakistan and the "illegal incarceration" of the former prime minister. The hearing was jointly convened by Labour MP for Bradford West Naz Shah, and Conservative Peer Lord Hannan of Kingsclere.

Sayed Zulfikar Bukhari, who was appointed Imran Khan's International Affairs Adviser today, and PTI candidate in the 2024 Pakistani general election Meher Bano Qureshi were guest speakers, as was Sarwar Bari, founder of Patten Development.

This hearing was attended by over 22 parliamentarians from all major parties, including the former Leader of the Conservative Party and Cabinet Minister Sir Iain Duncan Smith MP, the former Home Secretary Priti Patel MP, former Security Minister Baroness Neville-Jones, former Minister of

State in the Foreign Office Lord Ahmad of Wimbledon and former Conservative Party Chairwoman and Foreign Office Minister Baroness Warsi. Newly elected independent MPs Shocket Adam, Barrister Ayoub Khan, Iqbal Mohammad and Labour's Naushabah Khan were also in attendance.

PTI UK's leader Jahanzeb Khan was also in attendance as well as four other office bearers. The hearing resolved that parliamentarians will call on Prime Minister Sir Keir Starmer MP and the Secretary of State for Foreign, Commonwealth and Development Affairs David Lammy MP for the UK government to take note of the recent United Nations report into former prime minister

Imran Khan's incarceration, demand his immediate release and the return of democracy to Pakistan.

Bukhari spoke for ten minutes and gave a rundown of what has happened since the removal of Khan from power in April 2022. He alleged that this year's February elections were massively rigged and that there are fears Khan may be tried in the military courts.

He said: "Pakistanis deserve the right to self-determination. The current government of Pakistan is illegitimate and the world needs to be aware of the atrocities committed by the government of Pakistan against freedom and democracy over the past two years. I welcome that leading parliamentarians from the UK are now calling for the return

of democratic norms in Pakistan."

He told the meeting that PTI's former social media lead Azhar Mashwani was also set to attend the meeting as a "victim" of the state but he received a call from his abducted brother's phone, warning him that his other family members will be taken away too if he joined the meeting. He alleged that hundreds of PTI workers remain abducted and missing.

Meher Bano spoke for nearly 17 minutes, narrating the difficulties she and PTI candidates faced in general elections.

She said: "It has been disappointing [to see] the eerie silence from West democraticies, we would have expected they would stand up for democracy in Pakistan. It is wonderful to have these platitudes about being resilient and brave. I don't want to be resilient or brave, nor do the people of Pakistan, all we just want to be free. Free to choose what political party we support, free to choose what political party we contest the elections from, and free to our representatives. We want our voices to be heard and our votes to be counted."

She said the last general

elections were a farce and her father Shah Mahmood Qureshi, the former foreign minister, was being punished for siding with Imran Khan. She said the basis of the whole cipher case was to intimidate and cajole Khan and Qureshi into submission through draconian means.

Lord Hannan of Kingsclere said: "As friends of Pakistan and friends of Pakistani democracy, we want to see that country prosper. We want to see the UN's recommendations implemented, including an end to the detention of Imran Khan and a timetable for free and inclusive elections. We will continue to press for democracy on a cross-party basis, and in both parliamentary chambers. And we will link up with parliamentarians in other friendly countries to make the case internationally." Naz said the hearing on Pakistan was a "pro-Pakistan" event. She regretted that some people had called it "an event against Pakistan". She said that she decided to get involved in the event to become the voice of a significant section of Pakistanis who wanted Khan's release and wanted an end to all kinds of political incriminations.—RT/Agency

Court Grants FIA Two-Day Remand Of Raouf Hasan

ISLAMABAD: A district and sessions court in Islamabad on Tuesday granted a two-day physical remand of Pakistan Tehreek-e-Insaf (PTI) Information Secretary Raouf Hasan to the Federal Investigation Agency (FIA) in a case related to his alleged involvement in disseminating anti-state propaganda.



Presenting the PTI official before the court, the FIA prosecutor requested the court to grant physical remand of the suspect for recovering devices — allegedly used for anti-state propaganda.

A day earlier, Islamabad Police took Hasan into custody from the party's Central Secretariat for heading a digital media cell and its alleged involvement in running anti-Pakistan propaganda.

Commenting on the arrest, the police had maintained that the "PTI digital media centre had become a centre of international disinformation, from where anti-Pakistan propaganda is run throughout the world".

Although it was initially reported that party Chairman Barrister Gohar Khan was also arrested, the ICT later clarified that they had only arrested Hasan during the raid at PTI's Central Secretariat.

The police's raid drew a strong reaction from the former ruling party with Chair-

man Gohar condemning Hasan's arrest.

Flanked by National Assembly Opposition Leader Omar Ayub, and former NA speaker Asad Qaiser, the PTI chairman reassured that the party would fight for Hasan and would leave no resource untapped to secure his release at the earliest.

It is to be noted that the party's information secretary, in May, was left bloodied after being attacked by apparently four transgender persons in Islamabad.

The incident's CCTV footage showed Hasan being interrupted by an apparent transgender person while he was walking on the side of a road, subsequently, the attacker engaged in conversation with the PTI leader for a few seconds.

During the hearing today, the agency's prosecutor apprised the court that a 30-day physical remand can be granted in an FIA case

He then urged the court to hand over the PTI official to the investigative agency on a 10-day physical remand.

However, Hasan's lawyer Latif Khosa opposed the prosecutor's request for physical remand.

Meanwhile, defence counsel Bokhari questioned the need for a 10-day remand when there was no evidence against the PTI official.

Stressing that Hasan had nothing to do with the social media [team], the lawyer inquired what investigation had the FIA carried out in the last 24 hours.

"Is it a crime to use a mobile phone?" Bokhari said while further asking if on the suspect had posted anything on X. The court then granted Hasan and other PTI workers' two-day physical remand to the FIA, whereas two female PTI workers have been sent to jail on a judicial remand for 14 days.—RT/Agency

Faisal Vawda Claims Faiz Hameed Presented Evidence Of Imran Khan's Involvement In May 9 Riots

ISLAMABAD: Senator Faisal Vawda has accused PTI supremo Imran Khan of being responsible for Pakistan's current political instability, citing evidence provided by former director general Inter-Services Intelligence Lt Gen (ret'd) Faiz Hameed, linking Khan to the May 9 vandalism incident.



"I cannot champion law and democracy when multiple cases are pending against me in courts. Some time ago, I revealed that Imran Khan's close associate, Faiz Hameed, provided evidence of Khan's involvement in the May 9 vandalism," stated Vawda during an interview with a private TV channel.

Vawda further stated that Imran admitted to directing his supporters to march towards GHQ. He pointed out that parties like PML-N, PPP, JUI-F, and MQM-P had also clashed with the establishment in the past but eventually sat down for negotiations.

When questioned if Faiz Hameed had advised the protest at GHQ on May 9, Vawda clarified, "This was not Faiz Hameed's suggestion; however, Imran Khan was part of the entire scheme."

Vawda expressed that the government does not face threats from a technocrat

government or martial law, but rather from the ongoing power struggle within the PML-N. He added that the IMF had reached a deal with the finance minister, but the decision regarding reserved seats will not be implemented, with the Election Commission, Parliament, Speaker of the National Assembly, and President standing in the way."

Finance Minister Aurangzeb Travels To Beijing To Discuss Rescheduling \$15 Billion In Chinese Loans



ISLAMABAD: Federal Finance Minister Mohammad Aurangzeb is set to embark on a three-day visit to China today, aiming to discuss the rescheduling of a \$15 billion energy loan.

According to sources from the Ministry of Finance, a joint working group may be established between Pakistan and China to facilitate the loan rescheduling.

The discussions will also address issues related to

China's energy circular debt, which currently amounts to approximately Rs500 billion. The minister is also expected to engage in talks regarding the Panda Bond, as Pakistan seeks to secure \$30 million through this financial instrument in China.

The finance minister's discussions will also cover the ongoing efforts and developments on CPEC and other collaborative projects.—RT/Agency

Pakistan Increases Minimum Marriage Age To 18 For Christians



ISLAMABAD: President Asif Ali Zardari has said that all minorities are equal citizens of Pakistan who have equal rights, underscoring the need to further enhance the employment quota for them in all government jobs.

President Zardari said this while addressing a special ceremony at Aiwan-e-Sadr after he signed into law the Christian Marriage (Amendment) Act 2024, raising the marriageable age for Christian men and women to eighteen years, according to the press release issued on Tuesday by the President's Secretariat Press Wing.

Speaking about increasing the employment quota for minorities in all government jobs, the president said that he would write to the government in this regard. Highlighting equal rights for all minorities in Pakistan,

he stressed that minorities should not be disheartened by some isolated incidents, saying that they had equal ownership over the homeland as much as anybody else.

The president accorded approval to the Christian Marriage (Amendment) Act 2024 under Article 75 of the Constitution. The act amends Section 60 of the Christian Marriage Act of 1872.

Previously, the age of Christian men and women intending to be married was 16 and 13 years respectively. The ceremony was attended by the Federal Minister for Religious Affairs and Inter-Faith Harmony (MORA), Chaudhry Salik Hussain, Secretary Ministry of Religious Affairs, Zulfikar Haider, members of the Christian community and senior government officials.—RT/Agency

Pakistan Navy Takes Command Of Multinational Task Force For Maritime Security

ISLAMABAD: Pakistan Navy has assumed the charge of Combined Task Force 150 (CTF-150) for the 13th time at an impressive change of command ceremony held at Headquarters US Naval Forces Central Command Headquarters in Bahrain.

Aurangzeb Anticipates IMF Board Approval Of Staff-Level Agreement By Late August

ISLAMABAD: Minister for Finance Senator Mohammad Aurangzeb has stated that discussions are ongoing with the International Monetary Fund (IMF) regarding the financing gap, and he expects the loan deal to be approved by late August. Talking to media on Tuesday night, before his departure for China, the top economic executive, however, assured that these discussions would not impact the approval of the staff-level agreement.



"The International Monetary Fund's (IMF) executive board was expected to approve the staff-level agreement by the end of August, following the summer break," the finance czar told media. This month, Pakistan and the IMF reached an agreement for the \$7 billion loan programme spanning 37 months. Tough measures such as raising taxes on agricultural incomes and lifting electricity prices have prompted concerns about poor and middle-class Pakistanis grappling with rising inflation and the prospect of higher taxes. He also in-

formed the news channel that he would be leaving tonight for the visit to China along with Federal Minister for Energy (Power Division) Awais Leghari. To a question, the minister said, on the top of the agenda for the trip were discussions on energy sector reforms and Panda bonds with Chinese officials in his visit to China, the finance minister may explore the possibility of rescheduling Chinese independent power producers' (IPPs) debt of \$15.4 billion by halving the tenure of the amount extended by five years, from 2036 to 2041. The News reported citing sources last week Aurangzeb said he would also thank his Chinese

counterpart of Beijing's unwavering support to Pakistan through various forums.

Noting that Pakistan was aiming to enter China's capital market, Aurangzeb said Beijing was as important to Islamabad as Washington. The former banker said that during his visit, he would update Chinese officials on changes to power distribution companies and their boards. "Stability is not achieved overnight and discussions are ongoing in all sectors," the finance minister said, adding, "Negotiations have already begun with retailers and developers, and similar talks will be held with stakeholders in the agricultural sector"—RT/Agency

ECP Requests Political Parties To Submit Wealth Statements By August 29

ISLAMABAD: The Election Commission of Pakistan (ECP) asked all political parties to submit their respective wealth statements for the last financial year 2023-2024, a mandatory requirement under the relevant electoral laws, by August 29. The ECP asked all political parties to submit their consolidated statements of accounts for financial year 2023-24 on or before August 29.



"The Election Commission of Pakistan reminds all the heads of Political Parties, in terms of section 210 of the Elections Act, 2017 read with section 204 of the Act ibid and rule 159 & 160 of the Election Rules, 2017, thereof, that they are required to file with Election Commission their Consolidated Statement of Accounts on (Form-D) for financial year, 2023-24 ended on 30th June, 2024 on or before 29th August 2024." The ECP said in a press statement. It is pertinent to mention here that Section 210 of the Elections Act, 2017 provides that a Political Party shall, in such a

manner as may be prescribed, submit to the Commission, within sixty days from the close of a financial year, a consolidated statement of its accounts audited by a Chartered Accountant on Form-D containing, annual income and expenses, sources of its funds and assets and liabilities, if further said. The statement of accounts is to be submitted on Form-D as provided in the Elections Act, 2017. Printed Forms are available, free of cost, in the Election Commission Secretariat, Islamabad and in the offices of the Provincial Election Commissioners, Punjab, Sindh, Khy-

ber Pakhtunkhwa and Balochistan. Form-D / Proforma for source of funds are also available on ECP's Website. The attested copy of Membership/Certificate issued by ICAP in respect of Auditor engaged shall be annexed to the Form-D along with the last valid renewal certificate. "The subject statement shall be addressed to the Secretary, Election Commission of Pakistan, Constitution Avenue, G-5/2, and Islamabad and shall be delivered through an office-bearer of the party; duly authorized by the party head in terms of rule 156 of the Election Rules, 2017.—RT/Agency
