Government 'Surrenders' Fuel Pricing To OMCs

ISLAMABAD: The government has decided to relinquish its authority to set fuel prices, transferring this critical responsibility to oil marketing companies (OMCs), sources said on Wednesday, as part of a phased plan to deregulate the petroleum sector and allow market-driven product rates.

Oil sector analysts say the deregulation proposal seeks to empower the OMCs to determine fuel prices based on various market forces.

However, local consumers getting petrol and diesel from places closer to ports and refineries would get relatively cheaper products due to the transportation cost.

Prime Minister Shehbaz Sharif has directed that the government's powers to fix the prices of petroleum products be abolished.

In response to this directive, Minister for Petroleum Musadik Malik has convened an important meeting scheduled for tomorrow.

"Petroleum Division has been directed to finalise and present the deregulation framework for the petroleum sector. The Minister for Energy (Petroleum Division) has been pleased to convene a meeting on Thursday," said a notification issued by the Ministry of Energy (Petroleum Division).

As per the notification, the Oil and Gas Regulatory Authority (Ogra) has been tasked to present the subject matter along with analysis, implications, and a way forward for deregulation of petroleum products.

"Accordingly, Ogra is also requested to provide the requisite presentation at the earliest as the same is to be discussed in the said meeting," the notification said.

When ready, the final framework for deregulating petroleum prices will be presented to the prime minister.

However, this decision has met with fierce opposition from petroleum dealers. They have expressed concerns that granting oil marketing companies the authority to set prices might lead to unfair profiteering, impacting their businesses negatively.

On the other hand, the refineries said the deregulation

could jeopardise nearly \$6 billion of investment, as it is better to spend money on upgrading the refineries, according to a The News report.

Despite these objections, the government appears determined to move forward with its plan, aiming to create a more competitive and market-responsive petroleum sector.

The Oil Marketing Association of Pakistan (OMAP) last week appealed to Prime Minister Shehbaz Sharif to intervene and finalise a mechanism to recover exchange rate losses incurred by the industry. In a letter to the prime minister, Chairperson of OMAP Tariq Wazir Ali highlighted the issue of unrecovered exchange losses due to flaws in the current system. These losses, he claimed, have accumulated to a staggering Rs26 billion.—RT/Agency

PM Vows To Crush PTI's New Tactics Against Armed Forces

ISLAMABAD: Prime Minister Shehbaz Sharif has said that the government will not tolerate any propaganda against the armed forces of Pakistan, warning the Pakistan Tehreek-e-Insaf (PTI) against running smear campaign targeting the country and the army chief.

"The perpetrators of the May 9 riots, who had also attacked parliament and PTV and besieged the PM House in the past, have resorted to new tactics to malign the country and its armed forces as a malicious campaign was run against Army Chief General Asim Munir from the official website of the PTI," said PM Shehbaz, while chairing a meeting of the federal cabinet on Wednesday.

"We will not tolerate any such steps against the country, its innocent people, and its armed forces."

The prime minister's remarks came two days after Inter-Services Public Relations Director-General (DG ISPR) Lt General Ahmed Sharif Chaudhry called on the nation to stand up against militants and "digital terrorists".

"Digital terrorism is being done on social media. The army is standing up against terrorists and digital terrorists. The time has come for the entire nation to stand up against them," the chief military spokesperson stated on Monday.

On the same day, PTI's Information Secretary Raouf



Hasan was arrested from the party's central secretariat in the federal capital for being allegedly involved in propaganda against the country and its integrity.

In today's cabinet meeting, the premier also reiterated his call for national unity to protect the national interest.

The federal cabinet did not discuss about the government's decision to ban the Pakistan Tehreek-e-Insaf (PTI) during its meeting, sources told Geo News on Wednesday.

However, the federal cabinet did not discuss the much-hyped matter of imposing ban on the opposition PTI and invoking Article 6 (high treason) against the former prime minister Imran Khan, ex-president Arif Alvi and former National Assembly deputy speaker Qasim Suri.

There were reports that the matter of banning the Imran Khan-founded party will come under cabinet's discussion today after Information Minister Attaullah Tarar recently announced

one in DI Khan and the other in Bannu. Two soldiers and five civilians were martyred in DI Khan while eight other soldiers were martyred while trying to foil a terrorist infiltration into the Bannu Cantonment in the wee hours of July 15.

PM Shehbaz termed this current wave of terrorism a machination against the country, arguing that it was taking place at a time when the coalition government was making efforts for development as it reached a staff level-agreement with IMF despite challenges and announced a three-month relief package for 96% of domestic power consumers.

Highlighting the role of Afghanistan in the wave of terrorism, the prime minister said the government was in interaction with them as Defence Minister Khawaja Muhammad Asif also visited there.

He highlighted that the country was hosting Afghan refugees only to be rewarded with the attacks by terrorists from the Afghan soil.

"But how is it possible that he hosted millions of their people here without any complaint? We treated them like our brothers and never considered them as a burden. But we were rewarded in the form of TTP attacks on our citizens to mar the country's peace and business. This is not acceptable," he remarked.

The prime minister apprised the members of a de-

cision to abolish visa fees for 126 countries as a "quantum jump" to bring ease of doing business and attract businessmen, tourists and travellers to Pakistan.

The decision, made after a three-day discussion, would be tabled before the cabinet for its consideration, he added.

Prime Minister Shehbaz said that visitors would get visas within 24 hours through the electronic travel authorisation form. Besides, E-gates would be set up at Gwadar Port and nine airports — initially at the Islamabad, Lahore and Karachi airports.

The prime minister also strongly condemned the unprecedented human rights abuses of Israel against Palestinians as around 40,000 Palestinians have been killed including thousands of children and women.

He said despite the resolutions passed by the United Nations Security Council and UN General Assembly and the decision by the International Court of Justice, Israel remained adamant on its oppression which was highly condemnable.

The prime minister drew attention to the attacks on Pakistan's missions in Germany and London. He said the Foreign Office had timely taken up the matter and that the envoys of the countries concerned should be given demarches to seek the protection of Pakistan's missions.—RT/Agency

Imran Rejects GHQ Protest Claims, Labels May 9 Riots 'False Flag'

ISLAMABAD: Imran Khan, the founder of Pakistan Tehreek-e-Insaf (PTI), on Wednesday stated that a narrative has been created with an agenda to accuse him of inciting the public to protest at the General Headquarters (GHQ) during the May 9 riots.

In a statement released on the social media platform X (formerly Twitter), he clarified that in the nearly three-decade history of PTI, there has never been an instance of violent protests. "Over the past two and a half years, the worst tactics were used against PTI to incite violence," he added.

In November 2022, he said that there was an assassination attempt on him, and even his request for an FIR of his choice was denied.

The former prime minister further revealed that his residence was attacked twice by military personnel. On one occasion, during his



court appearance, there was a deliberate plan to assassinate him by deploying plainclothes individuals, he added.

On May 9, he explained that the masses were incited by the humiliating abduction of a former prime minister and the leader of Pakistan's largest and most popular political party, which could have led to a major incident.

He added that PTI's political training does not include elements of violence and the party believes in political,

constitutional, and legal struggles. Imran Khan said that May 9 was a false flag operation. "Those who stole the CCTV footage of May 9 are the real culprits of that day. Their intellect is such that they compare the May 9 incident to the Capitol Hill protest in the USA, where a thorough investigation and review of CCTV footage led to the punishment of only those involved, without implicating the entire Republican Party," he added.—RT/Agency

Shah Mehmood Qureshi's Remand Extended Again In May 9 Cases

LAHORE: An Anti-Terrorism Court (ATC) has extended the judicial remand of former foreign minister Shah Mehmood Qureshi, by 12 days in seven May 9 cases, media reported.

The court has ordered the police to submit the challan by August 5. Due to security concerns, Qureshi was not produced in court, and the prosecution requested a proceeding without his presence.

The court allowed the proceeding without Qureshi's presence due to security concerns. Qureshi's attendance was marked through a video WhatsApp call.

Earlier, the PTI leader Shah Mehmood Qureshi



was sent to judicial remand following his alleged involvement in May 9 riots.

The court after rejecting the plea to extend the physical remand, sent the PTI leader to judicial remand under police custody for 14 days.—RT/Agency

Biden Administration Seeks \$101 Million To Rescue Cash-Strapped Pakistan

WASHINGTON: US Assistant Secretary for South and Central Asia, Donald Lu said that US President Joe Biden has requested \$101 million in aid for Pakistan to support democracy and human rights in the country.

Lu, whom Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan blamed for toppling his government in 2022, made the statement before a committee of the American House of Representatives, which was summoned to discuss the United States budget for South Asia.

The assistant secretary stated that the funds would be allocated to combat terrorism, support economic reforms, and provide debt relief.

Lu highlighted that this financial assistance aims to stabilise Pakistan's economy, which is in dire straits even after the government secured a 37-month-long International Monetary Fund (IMF) programme.

The staff-level agreement caps negotiations that started in May after Islamabad completed a short-term, \$3 billion program



that helped stabilize the economy, avert a sovereign debt default, and set challenging revenue targets in its budget to get IMF approval.

The new agreement introduced increased tax on agricultural incomes, underscoring the need to increase government revenue and reduce recurrent deficit to win the lender's approval.

Under the IMF deal, the highest effective tax rate can rise to as much as 45% from the current 15%. It will be implemented from 2025, a move that was termed "unprecedented" by brokerage and investment banking firm JS Global.

Moving forward, he also expressed concern over the situation of women and mi-

nority groups in Afghanistan, noting that relations with the Taliban government cannot normalise until the rights of Afghan citizens are respected.

The senior State Department official also demanded the Afghan Taliban to release all American prisoners in their custody.

The US remains the largest aid donor to impoverished Afghanistan nearly three years after the Taliban seized Kabul as the last US troops followed a chaotic pullout completing 20 years of war with the Islamist militants. Since the US withdrawal was completed on August 30, 2021, Washington has provided more than \$17.9 billion in assistance to Afghanistan.—RT/Agency

ECP Holds Verdict In Election Expenses Case

ISLAMABAD: The Election Commission of Pakistan (ECP) on Wednesday reserved its verdict in the case related to the expenditures incurred on the general elections held on Feb 8.

The hearing was conducted by a four-member bench headed by ECP member Nisar Durani.

According to ECP officials, ANP, Move on Pakistan, People's Muslim League Pakistan, Pakistani Awami Raj, Awami Jamhoori Party Pakistan, Haq Do Tehreek Balochistan and Pakistan People's League didn't submit the details of expenditures incurred on general elections.

ECP said that ANP's Mian Iftikhar Hussain Shah was contacted sev-



eral times but the party failed to submit the details.

The Move on Pakistan party didn't attend the phone calls, said the ECP officials.

People's Muslim League said that the party didn't run the election campaign and therefore no expense was incurred in this regard. "The political parties

gave advertisement seeking applications for party tickets. The ECP gave election symbol to 149 parties," said the officials.

As many as seven political parties didn't submit the details of expenditures yet.

"The election symbol of these parties should be taken back," said the ECP.—RT/Agency

Imran and Bushra Bibi Defy NAB In Toshakhana Case



RAWALPINDI: PTI founder Imran Khan Wednesday refused to be part of an investigation in the new Toshakhana case in absence of his lawyers.

The NAB team stayed in Adiala jail for an hour or so but the PTI founder and his wife did not cooperate in the investigation. The NAB team was led by Deputy Di-

rector Mohsin Haroon. The NAB team had records of the purchase of jewelry. Initially, they obtained an 8-day remand, followed by a 7-day remand.

The investigation team later left Adiala Jail as both Imran Khan and his wife, Bushra Bibi, did not cooperate.—RT/Agency

Manchester Police Accused Of Brutally Assaulting Two Pakistanis At Airport

MANCHESTER: Two Pakistani young men were brutally tortured in front of family members by British police officers at Manchester Airport as video of the incident went viral.

The mother of one of the Pakistanis tried to intervene and stop the violence but the policeman kept beating him.

In the video, the police officers repeatedly punched and kicked the young men.

Five police officers involved in the incident have been suspended, and an investigation is underway against the seven officers involved. Meanwhile, the Greater



Manchester Police (GMP) said that officers were called to reports of an altercation between members of the public in Terminal 2 at Manchester Airport.

"Whilst attempting to arrest one of the suspects of the earlier altercation, three officers were subject to a violent assault, where they were punched to the ground. A fe-

male officer suffered a broken nose and all three were taken to hospital for treatment. "As the attending officers were firearms officers, there was a clear risk during this assault of their firearms being taken from them. "Four men were arrested at the scene for affray and assault on emergency service workers.—RT/Agency

District Council Badin Greenlights Ambitious Annual Budget for Fiscal Year 2024-25

BADIN: The budget meeting of the District Council Badin, chaired by Chairman Jam Ali Asghar Halipoto, took place at the Badin Gymkhana. An annual budget exceeding 91 crore 92 lacs for the fiscal year 2024-25 was presented and unanimously approved by the members. Chairman Jam Ali Asghar Halipoto provided details of the proposed budget, including an opening balance of 27 crore 56 lac 51 thousand 404 rupees. He explained that the total estimated expenditure for the budget is 91 crore 46 lac 99 thousand 638 rupees. This includes 49 crore 56 lac 60 thousand 48 rupees for development works, 4 crore 55 lac rupees for purchases, 37 crore 35 lac 39 thousand 590 rupees for the commutation and benefits of retired district council employees and 24

crore rupees allocated for new construction projects. Regarding revenue, Chairman Halipoto reported that 584.42 million rupees were collected from various sources including OZT tax, fisheries, local seas tax, sales tax, immovable property tax, tower tax, and fair tax. Additionally, 2 lac rupees were collected as fees, 9 lac ten thousand rupees from rents, and 27 lac 50 thousand rupees from other income sources, bringing the total revenue to 58 crore 81 lac 13 thousand rupees.

The budget includes allocations of 20 crore 20 lac 78 thousand 84 rupees for salaries and pensions of district council employees, 25 lakh rupees for scholarships for deserving students and girls, 90 lac rupees for social welfare, sports grants, and relief for natural calamities. DC Zahoor Ahmed Marri Pushes for Bigger Budget for JIMS Visit

JACOBABAD: Deputy Commissioner Jacobabad, Zahoor Ali Marri, has taken note of public complaints and conducted an unscheduled visit to JIMS Hospital. During the visit, Deputy Commissioner Memon inspected various wards of the hospital, including the OPD Ward, General Surgery Ward, Eye Surgery Ward, Orthopedic Ward, Physiotherapy Ward, Normal Delivery Ward, C-Section Ward, OT Ward, NICU Ward, Dialysis Ward, Echo Cardiography Ward, ETT Ward, Chest Pain Unit,

Ultrasound Ward, X-ray Machine Ward, and the hospital's laboratory. He met with the hospital's Medical Superintendent and other staff members to receive a detailed briefing about the hospital's issues. Speaking to the media after the visit, Deputy Commissioner Memon said that he had been receiving periodic complaints about JIMS Hospital being non-functional, with issues related to staff shortages and lack of medication for the public. However, he reported that the situation at the hospital appeared to be contrary to the complaints he had received.

He observed a high turnout of patients and noted that the entire hospital staff was present and performing their duties. Deputy Commissioner Memon mentioned that, by 11 AM, more than 700 patients had arrived at the hospital, and daily patient numbers range from 1,500 to 2,000. He confirmed that all necessary facilities were being provided to the patients. Deputy Commissioner Memon urged the Government of Sindh to increase JIMS Hospital's budget for medicines from 150 million to 250 million rupees to prevent any future shortages.

Eradicating Forced Labor To Combat Poverty And Boost Businesses

KARACHI: The eradication of forced labor in the brick kiln sector is essential for the industry's sustainability and poverty reduction, emphasized EFP Secretary General Syed Nazir Ali during a capacity-building workshop organized by the Employers Federation of Pakistan (EFP) with the support of the International Labor Organization (ILO). The workshop, held in Lahore under the BRIDGE Project, aimed to empower members of the Brick Kilns Owners Association Pakistan (BKOAP) to understand and address forced and bonded labor issues.



Syed Nazir Ali highlighted that forced labor violates human rights and local laws, harming individuals and perpetuating poverty. He underscored the importance of eliminating forced labor to ensure decent working conditions and promote responsible business practices. This session was part of a series to raise awareness and strengthen the capacity of informal sector associations in

Shoab Niazi, Chairman of BKOAP, expressed gratitude to EFP and ILO, noting that the workshop would enhance brick kiln owners' understanding of forced labor, international standards, and relevant laws. He urged EFP and ILO to advocate for amendments to minimum wage and social security laws to reflect the realities of the brick kiln sector.

Dr. Javaid Gill, the session consultant, presented on forced and bonded labor, linking it to ILO Conventions No. 29 and 105 and local laws like the Bonded

Labour System (Abolition) Act. He stressed the role of District and Provincial Vigilance Committees in enforcement and rehabilitation and referenced the ILO's Handbook for Employers to combat forced labor. Participants discussed various issues, clarifying that forced labor is not practiced in the sector but noting challenges with social security registration and minimum wage laws. Concerns were raised about accommodating family-based work dynamics under current labor laws.—RT

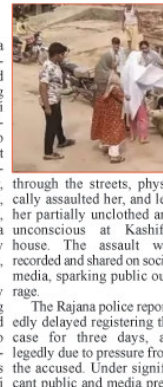

Powerful Figures Accused Of Abducting And Assaulting Teacher In Toba Tek Singh

Pakistan: Forever Trapped Between US and China

Pakistan once again finds itself in a precarious position, needing financial support from international allies to stay afloat. The US has recently sought a budget of \$101 million to help Pakistan strengthen democracy, fight terrorism, and stabilize its economy. While this aid is crucial for addressing immediate challenges, it highlights the deeper issue of Pakistan's ongoing dependence on foreign assistance.

The country's internal politics have left it in a state of perpetual instability. Corruption, political infighting, and inconsistent policy-making have hindered progress, preventing Pakistan from building a self-sustaining economy. This cycle of reliance on external aid raises questions about the nation's future. Will Pakistan ever reach a point where it can stand on its own two feet without

having to seek financial support from other countries?

Historically, Pakistan has balanced its alliances between the US and China, leveraging support



from both superpowers. However, this strategy has often left Pakistan in a limbo, unable to fully align with one without risking the ire of the other. The recent US budget request explicitly aims to counter China's growing influence in Pakistan, reflecting a broader strategic contest between the two nations.

China's extensive investment in Pakistan, primarily in the form of loans rather than grants, has created a significant debt burden. This depend-

ence on Chinese financial aid has drawn criticism and concern, both domestically and internationally. The US, on the other hand, frames its assistance as a means to promote democratic values and sustainable economic reforms.

While external support is vital for immediate relief, it is not a long-term solution. Pakistan must address its internal issues to achieve true independence and economic stability. Political reforms, anti-corruption measures, and consistent economic policies are essential for building a resilient economy that can withstand external pressures and reduce the need for foreign aid.

As the US and China maneuver strategically in Pakistan's affairs, we, as Pakistanis, must ask ourselves a crucial question: Are we better off today than we were two years ago? Have we ever truly been stable enough to prosper?

Tourists Fume Over Facilities Shortage at Mohenjo Daro

DOKRI: At Mohenjo Daro, the ancient and significant archaeological site in Sindh, tourists are facing a severe shortage of facilities. It has been revealed that the rest house rooms, which are supposed to be reserved for tourists, are being allocated to ordinary people instead. This has led to significant inconvenience for visitors and has sparked frustration among knowledgeable circles, with protests being announced. Details indicate that both local and foreign tourists at Mohenjo Daro are deprived of basic amenities such as cold drinking water, shaded resting areas and affordable, quality food. The rest house rooms, which are supposed to be designated for tourists, are reportedly being used by local individuals under questionable circumstances. These rooms, equipped with air-conditioning, are now occupied by locals, causing a considerable loss of revenue for the Archaeology Department due to high electricity bills. The lack of facilities and the presence of local people



in tourist accommodations have led to several incidents of alleged misconduct with tourists. This situation has resulted in a decrease in the number of visitors, both domestic and international. Recent visitors to Mohenjo Daro, including Rizwan Mangi and Gul Hassan, have expressed their dissatisfaction, stating that there are no provisions for clean water, shaded resting areas, or affordable food.

They highlighted that local people have taken over the rest house rooms and have been occupying the air-conditioned rooms throughout the day, causing significant discomfort for tourists and leading to substantial financial losses for the government. In response, politi-

cal and social groups have condemned the failure to provide proper facilities for tourists and the alleged misuse of rest house rooms. They have demanded that the provincial minister and secretary of the Tourism and Culture Department, along with other officials, take notice of the situation. They have warned of potential protests if the issue is not addressed promptly. On the other hand, Mohenjo Daro's administration has claimed that the rest house rooms are reserved for foreign tourists and official authorities only, and that they are not meant for local residents. They have denied the allegations, asserting that efforts are being made to provide facilities for tourists.

Ollie Pope: England to Blitz 600 Runs in a Single Test Day



LONDON: Ollie Pope believes England could yet score 600 runs in a single day of Test cricket in the right circumstances for Ben Stokes' men.

Pope was one of three century-makers for the hosts as England won the second Test against the West Indies at Trent Bridge by 241 runs, with Harry Brook and Joe Root following him to three figures in a series-clinching success.

Victory in Nottingham was also the first time England had passed 400 in both innings in the 147-year history of Test cricket.

Ollie Pope was one of four batters to score a hundred when England piled up 506-4 on the first day against Pakistan at Rawalpindi in December 2022, despite facing a mere 75 overs.

The England vice-captain believes the team now have the capacity to surpass that feat, but also an ability to adapt to more bowler-friendly conditions as they refine their aggressive 'Bazball' approach.

"I think when Baz (England coach Brendon McCullum) and Stokesy took over, we were a batting unit with, not a lack of experience, but a lack of confidence at the time," said Pope.

"At the time it was about building confidence, now it's about hopefully becoming more and more ruthless. "Sometimes we might score 280-300 in a day but that's OK and probably because we're reading situations." The 26-year-old Surrey star added: "We saw at Trent Bridge, when the lights were on and it started swinging more that was the time just to manage the game a little bit and that's something we want to keep getting better and better at."

"But there might be a day where we go and get 500 or 600 at some point in the future as well. That's a cool thing to have."

England, who previously thrashed the West Indies by an innings and 114 runs at Lord's, have now won a Test series for the first time since 2022 as they lead 2-0 ahead of this week's finale at the Edgbaston ground in Birmingham.—Agency

For the unversed, the Pakistan Cricket Board (PCB), last week, appointed Australia's Tony Hemming as the new head curator on a two-year contract.

Hemming's immediate tasks will be to prepare pitches for Pakistan's upcoming five home Test matches, which are part of the ICC World Test Championship.

Pakistan will play two matches against Bangladesh in August/September, followed by a three-Test series against England, scheduled to be played in October.

Hemming will also oversee pitch preparations for the upcoming ICC Men's

Champions Trophy 2025, which Pakistan will host from 19 February to 9 March.

Hemming is a highly respected curator with nearly four decades of experience. He has worked at various iconic cricket grounds in Australia, including Melbourne, Perth and Tasmania, as well as in countries such as Bangladesh, Qatar, Saudi Arabia and the United Arab Emirates, where he was the ICC's Head Curator from 2007 to 2017 in Dubai.

During his time with the ICC, Hemming also oversaw pitch preparation at the Dubai International Cricket Stadium, which was one of Pakistan's home venues between 2009 and 2019.

Prior to joining PCB, Tony Hemming was involved with the Bangladesh Cricket Board (BCB), where we worked from July 2023.—Agency

'Who Else but Babar Azam?': Former Pakistan Skipper Throws Full Support Behind Captaincy

LAHORE: Former Pakistan Younis Khan has thrown his weight behind current national white-ball captain Babar Azam, pointing out the lack of captaincy options in the country.

Babar Azam has been under fire following Pakistan's lacklustre ICC Men's T20 World Cup 2024 campaign, where they got knocked out from the group stage.

Many fans and critics have attributed the Green Shirts' disastrous performance to Babar's captaincy and called for his removal as captain.

However, Younis Khan disagreed with the notion, highlighting the country's inadequate cricket infrastructure. He blamed it for



not preparing backup players to replace the struggling players.

"We give our views very quickly. If we talk about our current team, the players don't have a fault. Instead, I will blame the infrastructure. If we don't have the back-up, how will you replace the (out of form) players?"

Younis said during an interview with a local news channel.

He defended Babar and shifted the blame on previous management and selection committees for not building players who could lead the team.

"We generally speak that Babar Azam should not be the captain. If not

Babar Azam, who else should be the captain? That's not Babar Azam's fault," he added.

"Neither this is the current selection committee's fault. This is the fault of something that happened 5-6 years back. We should have built our bench strength," Younis Khan concluded.

It is worth noting that in the aftermath of Pakistan's T20 World Cup debacle, the Pakistan Cricket Board (PCB) sacked Abdul Razaq and Wahab Riaz from selection committee, while the latter also lost his job as senior team manager. Meanwhile, team manager Mansoor Rana was also removed from the post.—Agency

Women's Asia Cup: Pakistan Clinches Semi-Final Spot Thanks to India's Triumph Over Nepal



LAHORE: The Pakistan women's cricket team qualified for the semi-finals of the 2024 Women's Asia Cup after India claimed an 82-run win over Nepal at Rangiri Dambulla International Stadium on Tuesday.

India were already in a strong position to qualify in the final four after they posted 178/3 in 20 overs. The bowlers restricted Nepal on 96/9. India had defeated Pakistan and UAE previously too.

The Girls in Green had defeated the United Arab Emirates (UAE) by 10 wickets in a must-win match earlier today.

Chasing the target of 104 runs, Pakistan's opening duo of Gull Feroza and Muneeba Ali showed impeccable performances with the bat as the

Green Shirts reached home in just 14.1 overs without losing a single wicket.

Feroza scored 62 off 55 balls with eight fours while Muneeba contributed 37 runs on 30 deliveries with four boundaries.

Pakistan also became the first team to win a match by 10 wickets in the history of the Women's T20 Asia Cup.

After being asked the bat first, the UAE women did not have a great start as they kept on losing wickets at regular intervals.

Skipper Esha Oza (16 off 26) and Theertha Satish (40 off 36) were the top two scorers for UAE as Khushi Sharma (12 off 13) managed to contribute runs in double figures.—Agency

Arshad Nadeem Vows to Break Pakistan's Olympic Medal Drought

LAHORE: Star javelin thrower, Arshad Nadeem on Wednesday, expressed his ambition to end Pakistan's 32-year-long wait for an Olympic medal at the 2024 Paris Games.

Pakistan last won a medal in the Olympics during the 1992 Summer Games in Barcelona, however, Arshad is hopeful that he will once again bring the glory to the country.

"I'm fit and well-prepared and I've worked really hard for this prestigious event," he told reporters in Lahore. "I feel I can achieve my goal of winning a medal."



"I will continue my training in Paris to bring further improvement before competing in the event and if everything goes to plan, I

will get a medal for the country at the Olympics," he added.

Arshad Nadeem will compete in the qualification

round on August 6, with the final scheduled for two days later.

Notably, Pakistan will compete in shooting, athletics and swimming in the Paris Olympics. Out of the seven athletes four of them earned direct qualification while sprinter Faiqa Riaz and swimmers Jehanara Nabi and Mohammad Ahmed Durrani will feature in the biggest sporting event on the basis of the universality places.

Pakistan failed to qualify for major disciplines like Hockey, Wrestling, Volleyball, Boxing and Weightlifting.—Agency

MQM Moves Bold Resolution Against IPPs In Sindh Assembly

KARACHI: The MQM-Pakistan has submitted a resolution in Sindh Assembly against the independent power producers (IPPs), media reported on Wednesday.

Leader of Opposition in Sindh Assembly Ali Khurshidi and Najam Mirza submitted resolution in the assembly's secretariat.

"It will become an issue of survival if capacity charges continued to be paid to the IPPs," the resolution read.

"Per unit price of the electricity has reached to an unbearable level for the industrial and domestic consumers," according to the MQM resolution.

"Agreements with the IPPs and payments are burden on the economy. The power tariff has become intolerable with erroneous agreements made with the IPPs in past," according to resolution.

The resolution called the IPP agreements a threat to the national security and sovereignty.

Earlier, MQM leader Mustafa Kamal demanded of government to cancel the capacity charges agreement with local IPPs.

Mustafa Kamal talking to media said the situation has reached to the extreme where a brother kills another over the electricity bill payment.

"I plead to the prime minister that 70 percent IPPs have been locally owned. Talk to them over the mistaken policy, they have earned thousands of billions and now we could not pay them more," MQM leader said.

Mustafa Kamal said he has talked with the NEPRA to fix the K-Electric tariff. The regulator must bound the company, not to close a feeder over non-payment, he said.

"The shutdown of a feeder over non-payment suspends power supply to every consumer," he said.

He said the power supply system in Pakistan could not be corrected until more than one companies operating in the field. "There are more than one companies across the world and until the monopoly will not end, a common consumer could not get relief," he added.—RT/Agency

Dozens Of Pakistanis Deported From Iraq Over Fake Visas

KARACHI: Sindh Tourism Minister Zulfiqar Shah has revealed that dozens of Pakistanis were detained in Iraq for travelling on fake visas and passports. The minister noted that these individuals were subsequently deported.

Shah also said that the UAE and other countries have tightened visa requirements for Pakistanis due to similar complaints.

On July 12, the Federal Investigation Agency (FIA) arrested two key members of a gang involved in a massive visa fraud scheme that deceived over 350 citizens.

According to an FIA spokesperson, the suspects, identified as Ghulam Murtaza and Anjum Javed, were apprehended during a raid in Islamabad.

Speaking at a ceremony for travel and tour operators on Wednesday, Shah stated, "We have initiated actions against companies and travel agencies involved in human smuggling, fake passports, and fake visas".

"We need the cooperation of travel and tour operators in this effort. Licences of those involved in illegal activities will be revoked."

The event was attended by Sindh Minister for Local Government Saeed Ghani, former provincial assembly member Abdul Rashid, Chairman Gulshan-e-Iqbal Town Dr Fawad Ahmed, Jamat-e-Islami leader and CEO of Dunya Travel and Tours Hafiz Farhan Ahmed, and Waqas Azmi.

Shah disclosed that the UAE Consul General had complained about a large number of Pakistanis absconding upon entering the UAE, leading to stricter visa conditions for Pakistanis.

He emphasised that some travel agencies are implicated in these illicit activities.

"Travel agents' associations should identify these fraudulent agents to facilitate our actions," Shah said.

"These individuals not only cause problems for Pakistanis abroad but also tarnish Pakistan's reputation. Every country has tightened their visa policies for us, making it difficult worldwide."

Saeed Ghani, Sindh's Labour Minister, highlighted that despite the country's economic challenges, the number of pilgrims travelling to the holy sites has not decreased. "The Sindh government will provide all possible support to those working in this sector to ensure maximum facilities for pilgrims," he added.—RT



MPA Muhammad Sajid Jokhio: Basic Needs Are Fundamental Rights

KARACHI: MPA Muhammad Sajid Jokhio has emphasized that access to basic needs is a fundamental right and criticized any organization that hinders essential services as a violation of human rights. Despite multiple complaints about the lack of water supply in Azzabab Block 2, Muhammad Colony, and Bhangoria Goth, the concerned executive engineer and his staff have yet to address the public's grievances.

According to a senior officer of the Water and Sewerage Corporation, Gulberg Town currently has the highest number of complaints about water shortages in the city. This is attributed to the failure of the officer in charge to effectively fulfill his responsibilities.

Sources indicate that representatives of all political parties have held meetings with the relevant officers and staff of the Water and Sewerage Corporation regarding the water supply issues in Gulberg Town, but the situation has only worsened.—RT

K-Electric Unleashes Citywide Crackdown On Power Theft, Files 980 FIRs

KARACHI: K-Electric, in collaboration with the Federal Investigation Agency (FIA), has ramped up efforts to combat electricity theft across various areas of Karachi by eliminating illegal connections (kundas) from its infrastructure. Anti-theft initiatives are integral to the company's operations, ensuring network safety and minimizing line losses.

Since the launch of the national campaign against electricity theft in September 2023, over 168,000 cases of electricity theft have been reported, involving the theft of more than 298.7 million units of electricity. In FY 2023-24, actions supported by law enforcement agencies have led to the filing of 980 FIRs and the arrest of 33 individuals across Karachi.

Those involved in power theft not only by-pass safety protocols of the network but also negatively impact the loss profile of those areas, thus impacting the duration of loadshedding. KE acknowledges that current macroeconomic conditions may be affecting customers' propensity to pay and is organizing facilitation camps across the city. Customers can visit these camps, as well as KE Customer Care Centers located around the city, to clear their dues and receive assistance in obtaining regularized connections. K-Electric Spokesperson urged elected officials and community leaders to promote a culture of regular bill payment and actively discourage power theft. These measures are crucial for ensuring uninterrupted power supply to the city.—RT/Agency



Karachi Police Office Attack Mastermind Gunned Down In CTD Raid

KARACHI: The "mastermind" of the February 2023 terror attack on the Karachi Police Office (KPO) was killed during a shootout with the personnel of the Counter-Terrorism Department (CTD) in Mochko area of the metropolis.

According to the CTD, Omar Farooq, the mastermind, was killed during an intelligence-based operation (IBO) near Northern Bypass in Mochko.

Last year on February 17, three terrorists with suicide jackets entered the multi-storey KPO building.

In the hours-long operation, all three terrorists had been killed and four persons, including two policemen and a Sindh Rangers sub-inspector, embraced martyrdom. At least 17 other people, including police and Rangers personnel, were also injured in the terror attack.

Talking to journalists at Civil Hospital, CTD DIG Asif Aijaz Shaikh said that the slain terrorist was affiliated with the banned Tehreek-e-Taliban Pakistan (TTP). "Omar Farooq was the mastermind of the KPO," he added.

A pistol and motorcycle were also recovered from the possession of the killed terrorist.

In a statement, the CTD spokesperson said that the terrorist was involved in the 2013 Abbas Town bombing and that 10 cases had been lodged against him in 2014.

According to the spokesperson, the slain terrorist was sent to jail in 2014 and travelled to Afghanistan after being acquitted.

Cases were registered against him in the Mubina Town Police Station, Sachal, CTD, Ititahad Town, Surjani Town, and Gulshan-e-Maymar.

The country has been witnessing a rise in terrorist attacks, especially in KP and Balochistan, during recent months. The last terrorist attack came last week when two soldiers and five civilians were martyred in DI Khan.—RT/Agency



Sindh Government Seizes Control Of Sarim Burney Trust

KARACHI: The Sindh government has decided to take control of the Sarim Burney Welfare Trust's affairs following arrest of the trust's chief Sarim Burney over allegations of child trafficking, media reported on Wednesday.

The social activist is accused of trafficking children from Pakistan to the USA.

As per details, the Sindh government's Department of Social Welfare has issued directives to this effect.

According to the letter, the Department of Social Welfare will now manage the orphanage affairs previously overseen by Sarim Burney.

Sarim Burney was arrested on June 5 upon his return from the USA following a request from the American Consulate.

The Federal Investigation Agency (FIA) registered first information report (FIR) against rights activist Sarim Burney for allegedly trafficking newborn babies to United States (US). In the FIR, the investigation agency booked the rights activist for 'trafficking' a newborn baby - identified as Haya - to the US. Haya, who according to FIA was the last girl trafficked to US, was allegedly bought from her parents for \$81 million.

Sarim Burney trafficked 20 newborns to the US in the past year on pretext of adoption. The FIA claimed that 15 of the trafficked children were girls.

The FIA, in a statement, said that the records of the allegedly trafficked children were provided by the Pakistan embassy. Citing the Trust documents, the agency said Burney's wife was also among the beneficiaries.—RT/Agency

Business Community Forces KCCI Strike Call, Claims Iftikhar Sheikh

KARACHI: President of the Karachi Chamber of Commerce & Industry (KCCI), Iftikhar Ahmed Sheikh, expressed frustration over the lack of government attention to critical issues such as high energy tariffs, rising business costs, and excessive taxes.

He noted that only street protests and strikes seem to get government attention, while ongoing appeals and press conferences by KCCI and other trade bodies have not yielded results.

Sheikh pointed out that despite repeated efforts to engage the government, relief has only been granted when groups like the inhabitants of Azad Jammu Kashmir and flour mills staged strong protests. He emphasized the need for immediate action to address the business community's legitimate demands, including renegotiating agreements with Independent Power Producers (IPPs).

While appreciating Prime Minister Shehbaz Sharif's willingness to meet with KCCI, Sheikh criticized the Finance Minister for not responding to KCCI's requests for meetings. He highlighted the pressure from the business community to call for strikes and protests, despite KCCI's preference for dialogue over disruption.

Sheikh warned that ongoing strikes would harm daily wage workers and the poor, exacerbating the already struggling economy. He urged the government to engage in serious negotiations to find solutions and prevent further economic decline and social unrest. He also cautioned that some businesses might relocate outside Pakistan, worsening the economic situation due to capital flight.

The KCCI President stressed the need for urgent relief measures to keep the industry running and prevent the country from descending into anarchy.—RT

PTI Ban: Fawad Chaudhry Warns Nawaz And Zardari Of 'Historic Blunder'

ISLAMABAD: Fawad Chaudhry, the former federal minister in the erstwhile Imran Khan-led administration, has claimed that PML-N President Nawaz Sharif and President Asif Ali Zardari are standing on the wrong side of the history, warning the duo against making "worst mistake in the history by slapping a ban on the Pakistan Tehreek-e-Insaf (PTI)".



The former minister's remarks came after Information Minister Ataulh Karar doubled down on the government's decision to ban the PTI, saying the government had made up its mind to go ahead with its "principled" decision. "We have consulted with the Pakistan Peoples Party with regards to the PTI ban and are currently in talks with the Muttahida Qaumi Movement-Pakistan [...]

make any difference?" he asked while talking to the media outside the anti-terrorism court in Lahore on Wednesday. "You deprived the PTI of the election symbol of the bat. You gave them myriad of symbols instead. Despite all this, people voted in favour of the PTI."

He also ruled out the PTI's role in the "digital terrorism", saying it is being executed from abroad. PTI's Information Secretary Raouf Hasan was arrested from the party's central secretariat in the federal capital for allegedly heading a social media cell involved in running anti-state propaganda. Issuing his statement after Hasan's arrest, the Islamabad police said, "The PTI digital media centre had become a centre of international disinformation, from where anti-Pakistan propaganda is run throughout the world."

Justice Minallah Urges Courts Stay Open Amid Martial Law Threat

ISLAMABAD: Supreme Court Justice Athar Minallah has expressed his desire for the courts to remain open whenever there's a threat of martial law being imposed in Pakistan.



The nation has seen a total of three martial laws — 1958-1971, 1977-1988, 1999-2008 — spanning decades since its independence in 1947.

Justice Minallah, in his address to an event of the New York City Bar Association, said, "I wish every time there's a threat of martial law, the courts remain open."

The judge's response came in response to a question, when a participant in the event asked him why did he open the Islamabad High Court (IHC) on April 9, 2022, at midnight — the day when former prime minister Imran Khan was ousted from power. The judge, who served as the IHC chief justice from 2018-2022, told the participant that when he was appointed to the high-ranking office, he issued a circular that the high court would operate 24/7.

He said that he set a procedure that no matter what the time anyone could file a petition, which would then be sent to the then-IHC CJ on WhatsApp — whether it be 3am or 4am. "1,400 benefited from

that circular. Nobody knows about them because they were not political people, they were ordinary people. Only the Islamabad High Court did that. The high court was open for everyone," Justice Minallah said. Clarifying that the media reports were wrong when they ran the news that he had arrived at the high court, "I was in my pyjamas [...]

I was informed that Supreme Court Bar Association President Ahsan Bhoon wants to file a petition. But all petitions were frivolous and I didn't pass any order." Justice Minallah added that while he was at home, a private television channel was broadcasting that he had reached the high court and was lamenting over this development. "My wife told me this [...]

and I said, 'really?' He added that if he had passed any order, people could question his integrity, but he did not resort to any such move. "Despite that, a political narrative was created. [...]

"[A private television] channel created a situation as if martial law is going to be imposed," the senior jurist said, about the news being aired amid the session on the no-confidence motion against then-PM Khan in April 2022.

"I wish every time there's a threat of martial law, the courts remain open. I wish they were open on July 5 when General Ziaul Haq was removing an elected prime minister. I wish they were open on October 12 when General Pervez Musharraf had thrown out an elected prime minister. If anyone had attempted to remove unconstitutionally an elected prime minister till then, Imran Khan, then it would have been a test of the Islamabad High Court, whether it stands to uphold the Constitution or not." —RT/Agency

US State Department Alarmed By Arrests Of PTI Leaders

WASHINGTON: The United States has expressed concern regarding the recent arrest of opposition leaders in Pakistan, emphasizing the need to uphold democratic principles and constitutional law.



US State Department spokesperson Matthew Miller addressed the issue during a press briefing on Tuesday, specifically referring to the arrest of Pakistan Tehreek-e-Insaf (PTI) leader Raouf Hasan and the raid on the party's office. Hasan, who serves as a spokesperson for the PTI, was detained by Islamabad police on Monday. The arrest followed a raid conducted by the Islamabad police and the Federal Investigation Agency (FIA) on the PTI's digital media wing. The interior ministry has accused the PTI of spreading "anti-state propaganda."

In response to questions about the raid and the potential ban on the PTI, Miller acknowledged the reports of the arrests and stated that the US is "always concerned when we see arrests of opposition leaders."

He added a personal touch by expressing his own concern about the arrest of a fellow spokesperson, which elicited laughter from the attendees.

Miller reiterated the State Department's stance on supporting constitutional and democratic principles, including the rule of law, equal justice, and human rights such as freedom of expression and peaceful assembly.

He urged that these principles be respected according to Pakistan's constitution and laws. When asked about the state of democracy in Pakistan and Bangladesh, he emphasised the US commitment to democratic values worldwide. He stated that the US will continue to advocate for these values, recognising that sovereign nations make their own decisions. Miller stressed the importance of influencing countries to uphold fundamental freedoms and human rights. Regarding questions about the deportation of Afghan refugees and the Pakistan Army's stance on "digital terrorism," he reiterated the US support for media freedom in Pakistan and globally. —RT/Agency

Government Launches Special Courts For PECA Law Cases

ISLAMABAD: The federal government has constituted special courts to conduct trials of cases under the Prevention of Electronic Crimes Act (Pecca), 2016, after holding consultations with Islamabad High Court Chief Justice Aamer Farooq.



The Ministry of Law and Justice has issued an order for the establishment of special courts wherein additional district and sessions judges, civil judge East and West have been given the authority to conduct Pecca law trials in the special courts.

The said bill was passed by the National Assembly in 2016 during the Pakistan Muslim League-Nawaz (PML-N) government and was largely criticised by various sections of the society who expressed concerns that the legislation denied human rights and gave overarching powers to law enforcement agencies.

The Act prohibited copying or transferring of data without securing relevant permission and also included provisions aimed at tackling unsolicited messages, hate speech, online criticism of the country, its courts, religion, armed forces etc.

In February 2022, then-president Arif Alvi promulgated the "Prevention of Electronic Crimes (Amendment) Ordinance, 2022" to amend the PECA law as the

government moved to curb "fake news". However, the IHC, in response to a petition filed by the Pakistan Federal Union of Journalists (PFUJ), declared the ordinance unconstitutional and struck down its Section 20 — related to defamation.

With regards to the newly constituted courts, sources say that the judges in these special courts will be nominated in consultation with chief justices of other high courts.

They also added that Pakistan Tehreek-e-Insaf's (PTI) Information Secretary Raouf Hasan and others might be tried under the Pecca Act.

Hasan, who was arrested by Islamabad Police on Monday was handed over to the Federal Investigation Agency (FIA) on Tuesday in a case related to his alleged involvement in disseminating anti-state propaganda.

The charges against the 12 suspects — two of whom

PM Overhauls Boards Of Six DISCOs



ISLAMABAD: Prime Minister Shehbaz Sharif on Wednesday reconstituted boards of six power distribution companies over unsatisfactory performance, media reported.

The prime minister reconstituted six boards including Lahore Electric Supply Company (LESCO), Faisalabad Electric Supply Company (FESCO), Multan Electric Power Company (MEPCO), Peshawar Electric Supply (PESCO) Hazara Electric Supply Company (HESCO) and Islamabad Electric Supply Company (IESCO).

Similarly, Tahir Masood will be the chairman of IESCO board and Omar Farooq has been appointed chairman board of directors of FESCO.

Reserved Seats: PTI-Backed KP And Punjab Lawmakers 'Pledge Allegiance'

ISLAMABAD: The Pakistan Tehreek-e-Insaf (PTI) has submitted the affidavits of its lawmakers of Khyber Pakhtunkhwa and Punjab assemblies declaring their affiliation with the Imran Khan-founded party, sources privy to the party said Wednesday.



The Supreme Court, in its short order on July 12, allowed the PTI to receive reserved seats in the assemblies for women and minorities.

The top court also directed the PTI to submit a list of its eligible candidates for reserved seats to the electoral body within 15 days of the verdict. The ECP should then publish the list of reserved seats of the candidates on its website within seven days, the SC ruling stated.

The PTI submitted affidavits of 91 KP Assembly members and 105 Punjab Assembly lawmakers to the Election Commission, the party sources added.

Last week, as many as 37 PTI-backed MNAs sub-

mitted their affidavit of allegiance to the ECP, according to The News.

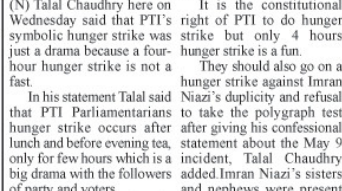
Out of the total 41 PTI-backed independent legislators, another four are expected to do the needful as per the apex court order in a couple of days.

When contacted, senior PTI leader Shibli Faraz, who is the Leader of Opposition in the Senate, had told The News that three lawmakers were sending their related documents from UAE and Saudi Arabia.

The election regulator, in its July 19 notification, said it would implement the top court's order to grant reserved seats to the PTI. Having been deprived of its election symbol, the PTI's candidates contested the February 8 elections as independents. However, these independents were directed by the party to join the Sunni Ittehad Council (SIC) to be eligible for the reserved seats.

The ruling Pakistan Muslim League-Nawaz (PML-N) and the Pakistan Peoples Party (PPP) also filed a review petition against the SC ruling declaring the PTI eligible for the reserved seats. —RT/Agency

Talal Chaudhry Slams PTI's Symbolic Hunger Strike As 'Pure Drama'



ISLAMABAD: Senior leader of Pakistan Muslim League (N) Talal Chaudhry here on Wednesday said that PTI's symbolic hunger strike was just a drama because a four-hour hunger strike is not a fast.

In his statement Talal said that PTI Parliamentarians hunger strike occurs after lunch and before evening tea, only for few hours which is a big drama with the followers of party and voters. He lamented that leader of PTI was enjoying delicious foods in the jail and here political workers are doing hunger strike for him. They are doing only for photo session and part time revolution nothing more just wasting the time of Parliament and nation. It is the constitutional right of PTI to do hunger strike but only 4 hours hunger strike is a fun. They should also go on a hunger strike against Imran Niazi's duplicity and refusal to take the polygraph test after giving his confessional statement about the May 9 incident, Talal Chaudhry added. Imran Niazi's sisters and nephews were present outside the corps commander who kept on instructing people to reach the target. They were sometimes plotting hunger strike and sometimes shutting down Pakistan, but they will not be succeeded in their aims. —RT/Agency

Senate Committee Clears Major Supreme Court Judge Expansion

ISLAMABAD: The Senate Standing Committee on Law and Justice agreed to raise the number of Supreme Court judges.



The committee, however, asked for details of cases pending in the higher judiciary. The chairman of the committee said that the number of judges of the Supreme Court will be decided upon analysing the details submitted by the Ministry of Law and Justice.

The law minister said that the registrar's office would furnish the details of the cases.

Committee Chairman Farooq H Naik said that the load of cases in the top court increased but the judges re-

mained the same (17). Anusha Rehman said that the bill has been pending since January 2023. The only need is to decide how many judges should be there in the top court. The Federal Law Minister said that 24 judges may be required in the apex court.

The federal law minister further said that the judge of one court deals with hundreds of cases, but the judge of another court deals with a few cases. He further said that the Bar Councils have suggested that the hearing under Article 184-3 cases should be done by the senior 5 judges only. —RT/Agency

Government To Rake In Rs 70 Billion From Packaged Milk Tax

ISLAMABAD: Well-known industrialist Muzaffar Hussain expressed reservations over the government's decision to impose an 18 percent sales tax on packaged milk, media reported. He said that the move will not only increase the finan-

cial burden on the already struggling masses but also benefit the dairy farmers who he said do not pay taxes. Muzaffar Hussain said that the government will earn approximately Rs 70 billion in taxes from packaged milk, which has a market share of only 5 percent. He said that the loose milk sold by dairy farmers has a market share of 95 percent. He said that the quality of loose milk is also substantial, and the government's decision will further exacerbate the situation. —RT/Agency
