FO Slams Modi's 'Counter-Productive' Anti-Pakistan Rhetoric

ISLAMABAD: The Foreign Office (FO) on Friday rejected the Indian Prime Minister Narendra Modi's "belligerent remarks" against Pakistan made in Ladakh today where Indian soldiers and top army brass gathered to commemorate the 1999 Kargil conflict.

The 1999 Kargil conflict was the last major battle between the two nuclear-armed foes, who have fought numerous wars since their partition into two nations upon independence from British colonial rule. It came just a year after tit-for-tat atomic weapons tests by the neighbours and spurred international alarm that the confrontation risked tipping into all-out nuclear war. Friday marked the 25th anniversary of the conflict's end.

During Friday's event, PM Modi held Islamabad responsible for the conflict and said that while "India was trying for peace, Pakistan had once again showed its untrustworthy face".

In response to Modi's comments, the FO said in a



statement that "bravado and jingoism" undermine regional peace and were counter-productive for resolution of long-standing disputes between the two countries, especially the core dispute of Kashmir.

"The Indian leaders' rhetorical statements cannot deflect international attention from India's heavy-handed approach to suppress the Kashmiri people's just struggle for realization of their fundamental rights and freedoms, particularly their inalienable right to self-determination," the FO said.

It added that India should reflect on its campaign of

"orchestrating targeted assassinations, subversion and terrorism in foreign territories" instead of accusing others of terrorism.

The foreign office said that Pakistan stood resolute in its intent and ability to safeguard its sovereignty against any aggression, as exemplified by its robust response to India's "reckless incursion" in February 2019.

It added that while Pakistan was ready to counter its neighbour's aggressive actions, it remained committed to "promoting peace and stability in the region"—RT/Agency

Ji Announces Sit-Ins In Islamabad And Rawalpindi Amid Crackdown

ISLAMABAD: Jamaat-e-Islami (JI) has announced sit-ins at three locations in Islamabad and Rawalpindi following the arrest of its workers and road blockages at D-Chowk. JI workers removed containers at Faizabad and opened the route, allowing a convoy to enter Rawalpindi and set up at Liaquat Bagh.

Ji's central spokesperson, Qaiser Sharif, stated that due to the arrests and barriers at D-Chowk, JI decided to hold sit-ins at three locations. "We will hold sit-ins at Murree Road in Rawalpindi, Zero Point, and Chungi No. 26," he said.

The sit-in at Murree Road will be led by Amirul Azeem, Deputy Amir Dr Osama Razi, along with provincial and district leadership. JI chief Hafiz Naemur Rehman will lead the sit-in at Zero Point, with Deputy Amir Liaqat Baloch, Mian Muhammad Aslam, and other provincial and Islamabad leaders joining.

The third sit-in at Chungi No. 26 will be led by Deputy Amir Dr Attaur



Rehman, Professor Muhammad Ibrahim, and provincial leaders.

These sit-ins will continue until their demands, including the shutdown of IPPs and relief from tax burdens on the salaried class, are met.

Qaiser Sharif declared, "Under the direction of JI leader Hafiz Naem, wherever there is an obstacle, participants will hold a sit-in. Jamaat-e-Islami will now hold multiple sit-ins."

He claimed that the police had arrested 1,150 of their workers and subjected dozens to violence. "Seeing the large public turnout at

the sit-ins, the government is panicking and resorting to fascism," he added.

Police arrested several Jamaat-e-Islami workers ahead of their planned sit-in against inflation, taxes, and electricity bills at D-Chowk in the federal capital. In response, JI altered their strategy, directing workers to gather at H-8 Bridge while a convoy led by JI chief Hafiz Naemur Rehman entered Islamabad.

Hafiz Naem arrived at the Islamabad Expressway sit-in to address the participants.

In his speech at the sit-in, Hafiz Naem stated,

"Billions are being embezzled, and the IPPs are exploiting this country. Our sit-in has commenced. We have one demand from the government: provide relief to the public and shut down the IPPs."

He further emphasised, "Protest is our constitutional right. Our arrested workers must be released, and the government should not obstruct our path, or we will hold sit-ins from Karachi to Chitral."

Media reported that police blocked all routes to D-Chowk with containers to prevent the sit-in, citing security concerns, and detained several workers in Islamabad.

Police sources indicated that no formal arrests were recorded; individuals were detained to prevent public disorder. No demonstrations had yet reached the press club, where police had stationed vans and personnel.

To stop people from reaching the sit-in, containers were placed at city entry points, and only one lane remained open on major

roads, causing long traffic queues and inconvenience for residents.

Ji workers blocked one side of Murree Road, threatening to block both sides if routes to D-Chowk were not opened. At H-8 Interchange, workers gathered, some wearing masks of JI leader Hafiz Naem, chanting slogans against the government.

Heavy police presence at H-8 Interchange attempted negotiations with the workers.

Ji's strategy shift included relocating all workers to H-8 Expressway, where sound systems and a stage were set up. Thousands of workers had already gathered, and senior JI leaders started arriving.

Led by Hafiz Naem, a convoy from Khyber Pakhtunkhwa crossed barriers at Chungi No. 26 to enter Islamabad.

Balochistan Assembly member and provincial leader Maulana Hidayatullah Khan Baloch also arrived from Gwadar with supporters.—RT/Agency

Harris to Netanyahu: 'I Will Not Be Silent' On Gaza Suffering

WASHINGTON: US Vice President Kamala Harris pressured Israeli Prime Minister Benjamin Netanyahu on Thursday to help reach a Gaza ceasefire deal that would ease the suffering of Palestinian civilians, striking a tougher tone than President Joe Biden.

"It is time for this war to end," Harris said in a televised statement after she held face-to-face talks with Netanyahu.

Harris, the likely Democratic presidential nominee after Biden dropped out of the election race on Sunday, did not mince words about the humanitarian crisis gripping Gaza after nine months of war between Israel and Hamas militants.

"We cannot allow ourselves to be numb to the suffering and I will not be silent," she said.

Harris' remarks were sharp and serious in tone and raised the question of whether she would be more aggressive in dealing with Netanyahu if elected president on Nov. 5. But analysts do not expect there would be a major shift in US Open policy toward Israel, Washington's closest ally in the Middle East.

Israel's retaliatory attack in Gaza has killed more than 39,000 people and caused a humanitarian calamity with



most of the coastal enclave leveled, people displaced from their homes, famine and a shortage of emergency relief.

Biden met with Netanyahu earlier and told him that he needed to close gaps to reach a ceasefire in Gaza and remove obstacles in the flow of aid, according to a readout of the meeting provided by the White House.

Netanyahu will meet Harris' Republican rival, Donald Trump, on Friday at Trump's Mar-a-Lago club in Florida.

A ceasefire has been the subject of negotiations for months. U.S. officials believe the parties are closer than ever before to an agreement for a six-week ceasefire in exchange for the release of Hamas of women, sick, elderly and wounded hostages.

"There has been hopeful

movement in the talks to secure an agreement on this deal, and as I just told Prime Minister Benjamin Netanyahu, it is time to get this deal done," Harris said.

Although she bluntly stated that he has mostly echoed Biden in firmly backing Israel's right to defend itself, she made clear on Thursday that she was losing patience with Israel's military approach. "Israel has a right to defend itself. And how it does so matters," Harris said.

Her appointment was made under Section 10 of the Civil Servants Act, 1973, the notification added.—RT/Agency

Ogra Eyes Policy Overhaul For Petrol Pricing

ISLAMABAD: The Oil and Gas Regulatory Authority (Ogra) is mulling changing the prevailing government policy for deciding fuel prices in the country, sources told media on Friday.

They added that Ogra has chalked out two proposals with the first one seeking the authority to decide fuel prices itself as a regulator. Whereas the second one suggests that the market will decide the prices itself which will be monitored by the government body.

The petroleum prices in the country are revised on a fortnightly basis where Ogra works out the rates by assessing various factors and forwards the summary to the Finance Division which then consults with the prime minister and notifies the official fuel prices.

The prices of petroleum products hold key significance as any change in them eventually has a trickle-down effect on the inflation-weary masses.

The government, earlier this month, increased the petrol and high-speed diesel prices by Rs9.99 and Rs6.18 per litre, respectively.

The prospective change in policy comes in light of Prime Minister Shehbaz Sharif's directions to get rid of the responsibility of deciding fuel prices.

Stressing that all the criticism is on the government for the increase in the prices of petroleum products, sources have said that the government does not set the price of anything except petroleum prices. Ogra's suggestions will be tabled in a high-level meeting, will be duly consulted with the Petroleum Division and subsequently will be approved by the prime minister. The Petroleum Division is expected to reach a final decision on the said issue within one week.—RT/Agency



The prices, as per the statement issued by the Finance Division, were assessed on the basis of price variations in the international market by Ogra.

Following the price hike, petrol and diesel are being sold at Rs275.60 and Rs283.63 per litre, respectively.

Sources say that it is also possible that the oil marketing companies (OMCs) will be given the authority to decide fuel prices — a proposal on which the petroleum dealers have expressed their reservations.

However, there's a risk that empowering OMCs to fix prices might lead to a monopoly in the market, the sources warned.

President Zardari Approves Ad Hoc Judges For Supreme Court

ISLAMABAD: President Asif Ali Zardari has approved the appointment of ad hoc judges to the Supreme Court of Pakistan.

According to a statement issued by the Presidency on Friday, the president gave his approval under Article 182 of the Constitution.

Following the president's approval, former Supreme Court Justices Sardar Tariq Masood and Justice Mazhar Alam Khan Miankhel will be appointed as ad hoc judges to the Supreme Court.

Despite severe criticism from a segment of lawyers and the PTI, the Judicial Commission of Pakistan (JCP) last week approved the



nomination of two retired Supreme Court judges for appointment as ad hoc judges of the apex court for one year.

A JCP meeting was held on last Friday to consider the nominations of both retired judges, with Chief Justice of Pakistan Qazi Faez Isa pre-

siding. By a majority vote of 8 to 1, the JCP approved the nomination of Justice (retired) Sardar Tariq Masood as an ad hoc judge of the apex court. The nomination of Justice (retired) Mazhar Alam Miankhel was approved by a majority of 6 to 3.—RT/Agency

Tajikistan Ambassador Holds High Stakes Meeting With PM Shehbaz

ISLAMABAD: Ambassador of Tajikistan to Pakistan Sharifzoda Yusuf Toir Friday paid a courtesy call on Prime Minister Muhammad Shehbaz Sharif at the PM House. The prime minister welcomed the ambassador and wished him a successful tenure in Pakistan.

While fondly recalling his recent visit to Dushanbe earlier this month, the prime minister said he was touched by the warm welcome extended to him and hailed the friendly and productive discussions with President Emomali Rahmon during the visit.

Expressing satisfaction at the MoUs/agreements signed between the two sides during his visit, PM Shehbaz Sharif urged that timely implementation and follow-up would help strengthen bilateral ties even further.

He renewed his invitation to President Rahmon to undertake an official visit to Pakistan at his earliest con-



venience, while adding that Pakistan was looking forward to Tajikistan's participation in the SCO Council of Heads of Government meeting in Islamabad in October this year.

The Tajik Ambassador briefed the prime minister on a number of proposals aimed at enhancing bilateral cooperation in various fields including education, agriculture and defence as well as connectivity through land and air routes. While noting

Chairman District Council Sukkur Syed Kumail Haider Shah chairs budget session

SUKKUR: The eighth budget meeting for the fiscal year 2024-25 was convened at the District Council Hall, presided over by Chairman Syed Kumail Haider Shah. During the session, council members tabled various proposals, which were subsequently approved by a majority vote. Key approvals included a grant of Rs 20 million for free medical treatment of underprivileged patients at Sukkur Blood Bank Hospital, as well as Rs 5 million for the construction of an additional emergency ward at Sukkur Civil Hospital. The meeting gave the green light to a proposal to levy new taxes on industrial establishments, cold storage facilities, fueling stations, LPG outlets (registered), poultry farms, and other commercial ventures in Sukkur. Furthermore, the meeting approved a revision of the existing tax structure and rental fees for shops of District Council. It also approved to establish mud checkpoints to enhance the security of police personnel. A proposal for transportation facilities for students from rural areas enrolled in Aror University's Art and Architecture



programs was presented in the council, and a bus was approved by a majority vote. Earlier, a lucky draw was held for Umrah tickets for District Council employees (grades 1-11), in which two employees, Allah Bakhsh Khatpar and Kazim Sarohi, were declared winners. Addressing the session, Chairman Syed Kumail Haider Shah said, that several beneficial proposals are being considered, including the Sukkur to Karachi air ambulance service, which are currently under discussion with relevant parties. He assured that the District Council is making every effort to utilize its available resources to provide maximum facilities to the public in all union councils of Sukkur. He announced that rural households will be equipped with solar panels, complete with batteries, fans, sewing machines, and water pumps. Furthermore, the District Council Sukkur has collaborated

Ongoing clash amongst Junejo, Kalhoro and Bhutto communities settled on Pir Sahab Pagara's orders

PIR JO GOTH: With the efforts of Pir Sahab Pagara and Syed Pir Muhammad Rashid Shah, a settlement has been reached regarding the deadly conflict over land ownership between the two communities of Junejo, Kalhoro, Bhutto and local landowners in the Kachho area of Kongri. The conflict resulted in 3 deaths, 6 injuries and damages amounting to a total of 2 crore 83 lac 88 thousand rupees. The land involved in the dispute will be seized. According to the report, the spiritual leader Pir Sahab Pagara and his son Syed Muhammad Rashid Shah facilitated the resolution of the ongoing tension in the Junejo, Kalhoro, Bhutto and local landlord communities in the Kachho area. The de-

cision was made by the Darbar Sharif Pir Jo Goth's decision committee, led by Mir Abid Khan Jatoti and Pir of Bharchundi Mian Abdul Khaliq. The committee included Riaz Chando, Najaf Kamario, Moazzam Ali Abbasi, Aijaz Ali Bughio, Mir Sheh Nawaz Khan Talpur, Syed Gul Muhammad Shah Rashidi, Dur Muhammad Sangi, Syed Ali Haider Shah Rashidi, Divyan Topan Das and Azhar Kamario, among others. The ruling stated that the Bhutto community would be paid 50 lac rupees for the murders of Azizullah Bhutto and Amir Bhutto, 6 lac rupees for the injuries of Muhammad Safar and Musal Narejo, 50 lac rupees for the firing on Sardar Amir Bux Khan Bhutto's residence, 50 lac rupees for damages to honor, 48 lac 80 thousand rupees in total damages. This amount will be paid by the Junejo and Kalhoro communities to the Bhutto community. 25 lac rupees will be paid for the death of Ghulam Mir Kalhoro, 9 lac rupees will be paid for the injuries of 3 individuals. In total, a fine of 2 crore 83 lac 80 thousand rupees was imposed, and the land in dispute in Deh Rajoo Dero and Deh Dosoo Dara will be seized. After the verdict, prayers were offered. It is worth noting that three months ago, a dispute over land ownership in the Kachho area between the Junejo, Kalhoro, and Bhutto communities resulted in 3 deaths, 5 injuries and the burning of the local landlord community's standing wheat crop, shelters, and solar panels.

Legal Action Announced Against Creators Of Deep Fake Video Targeting Azma Bokhari

ISLAMABAD: Minister of State for Information Technology Shaza Fatima has vowed to identify and take legal action against those responsible for creating and spreading a deep fake video of Azma Bokhari.

Speaking at a press conference with Pakistan Muslim League Nawaz (PML-N) women leaders, Shaza Fatima condemned the use of deep fake technology to malign Azma Bokhari and announced a crackdown on those involved in the dissemination of such propaganda. The Minister stressed that legal measures would be pursued against individuals creating fake photos and videos.

PML-N leaders alleged that a specific political party

Speaking at a ceremony organized by the Safe City Authorities on Friday, CM Maryam described the Safe City project as a key initiative of the Pakistan Muslim League Nawaz (PML-N). She emphasized the project's role in enhancing public safety through advanced surveillance and response systems.

The Chief Minister noted that Prime Minister Shehbaz Sharif had launched a similar pilot project in Lahore and expressed her intention to request further support from the PM to expedite the project's rollout across Punjab.

CM Maryam also highlighted the Women and Children Virtual project, which began three months ago with 1,200 personnel from the Dolphin force involved. She assured that female employees' concerns, particularly regarding hotel accommodations, would be addressed promptly.

"The welfare of our people is our top priority. Punjab is setting new benchmarks in development and aims to surpass previous records of growth," she said, adding that cities benefiting from the Safe City project would also offer free public Wi-Fi.—RT/Agency

Punjab Approves Solarisation Project For Agricultural Tube Wells

LAHORE: Punjab Chief Minister Maryam Nawaz has approved a new initiative to solarize agricultural tube wells across the province.

Under this project, farmers with at least 25 acres of agricultural land will be eligible for solarisation. The government will cover 67% of the project costs, leaving

farmers responsible for only 33% of the payment.

In the first phase, approximately 7,000 tube wells will be converted to solar energy. The project will expand in the second phase, aiming to solarize around 10,000 additional tube wells in collaboration with the federal govern-

ment. Currently, operating a tube well on diesel costs around Rs. 3,000 per acre, whereas using electricity costs approximately Rs. 1,500 per acre. This initiative aims to reduce these costs and promote sustainable energy use in agriculture.—RT/Agency

PA Speaker Announces Vacancy Of Opposition Leader Position Following SC Verdict

LAHORE: Punjab Assembly Speaker Malik Muhammad Ahmad Khan has announced that the position of Opposition Leader is currently vacant due to the Supreme Court's recent verdict on reserved seats.

At a press conference on Friday, the Speaker explained that the Opposition Leader, who represented the Sunni Ittehad Council (SIC), no longer holds the position since SIC is no longer recognized as a parliamentary party in the Punjab Assembly following the court's decision.

The Pakistan Tehreek-e-Insaf (PTI) has now assumed the status of the parliamentary party. "The office of the Opposition Leader is now vacant because SIC has been replaced by PTI as the parliamentary party," Speaker Malik Muhammad Khan stated. "You cannot



continue as Opposition Leader when your parliamentary party status has changed."

He also addressed the issue of conduct within the Assembly, stating that he holds the authority to suspend the membership of any MPA who uses abusive language. He expressed his disapproval of such behavior, particularly when it involves family members, and emphasized his commitment to ending this abusive culture.

The Speaker announced the formation of an ethics committee, which will soon present its findings to the Assembly. He also noted that 26 seats are still under legal scrutiny, but assured that the government's stability would not be affected if the verdict favors the opposition.—RT/Agency

Amir Muqam: Provincial Government Responsible for Maintaining Peace and Law & Order

ISLAMABAD: Federal Minister for Kashmir Affairs, Gilgit-Baltistan, and SAFRON, Engineer Amir Muqam, asserted on Friday that maintaining peace and law and order is the responsibility of the provincial government.

Speaking at a joint press conference with Federal Minister for Information and Broadcasting Atta Tarar, Amir Muqam emphasized that there is currently no ongoing operation in Khyber Pakhtunkhwa (KP). He dismissed Opposition allegations of false and unfounded, affirming that these claims are fabricated.

Muqam highlighted that law enforcement agencies are effectively maintaining peace in KP. He noted that political forces had united under the National Action Plan and that the previous Pakistan Democratic Movement (PDM) government had authorized the establishment of Counter-Terrorism Department (CTD) offices in KP to address security challenges.—RT/Agency

PTI's 'Neeli Pari' Sent To Jail On Judicial Remand

LAHORE: A local court in Lahore on Friday sent Pakistan Tehreek-e-Insaf (PTI) activist Aneela Riaz, also known as Neeli Pari, to jail on judicial remand.

The court's decision came after the Lahore Police had requested a physical remand for Riaz, who was presented before the judicial magistrate. The request was de-

nied, and Riaz was instead remanded to jail for further proceedings.

Riaz's arrest on Thursday followed an incident where she allegedly assaulted stage artist Tahir Anjum outside the Punjab Assembly. The altercation occurred during a PTI symbolic hunger strike protesting the incarceration of party founder Imran Khan.

According to the complaint filed by Anjum, Riaz stopped his vehicle and physically attacked him. Media footage shows Riaz slapping Anjum, who was subsequently rescued by party workers.

The case against Riaz was registered after the incident, leading to her arrest and subsequent judicial remand.—RT/Agency

Balochistan CM Vows to Depoliticize Police And Levies Force

QUETTA: Balochistan Chief Minister (CM) Mir Sarfraz Bugti announced the complete depoliticizing of the police and levies force and to make them capable of ensuring protection of citizens and the writ of the law across the province. He directed the IG Police from the floor of the assembly to appoint SPs, DPOs, SHO on merit and other provinces for posting in Balochistan if needed. He said no member of the assembly and politician would interfere in the police department's affairs and would not ask for the posting of blue-

eyed SP and SHO. Addressing the Provincial Assembly, Sarfraz Bugti said that the government would interdict the tenure of police officers until and unless they don't hurt the privileges of parliamentarians and self respect of a common man. "We are depoliticizing and providing free environment, would also keep accountability in the police department," he added. The chief minister said that police would be equipped with modern tools and would provide facilities to the police as the crime prevention is the top priority of the government. He directed the IG

Police to launch operation in collaboration with Levies force against organized crime and ensure security on national highways to curb the lawlessness in the province. Sarfraz Bugti said that the province is facing the challenges of terrorism and terrorists have launched organized RAW-driven war against the country and the province. He said that there is initiated a systematic conspiracy against Pakistan, one group is using violence in Balochistan and another group is defaming the state institutions through social media.—RT/Agency

According to the FIR, the teacher, Mohammad Rizwan, a cleric at Jamia Ghousia Rizvia, began beating the student on July 24 after Zuh prayers for reasons that remain unclear. Two other students, Mohammad Raza and Munawwar, intervened, pleading with Rizwan to stop.

When Rashid confronted Rizwan about the incident, the teacher reportedly became enraged and began verbally abusing him. The police investigation is ongoing.—RT/Agency

The Right To Peaceful Protest Must Prevail

The recent wave of protests led by Jamaat-e-Islami (JI) in Islamabad highlights a fundamental right that is intrinsic to every democratic society: the right to peaceful protest. This right, enshrined in democratic principles, is crucial for citizens and political parties to voice their grievances and demand accountability from their government. However, the government's knee-jerk reaction to these protests—marked by arrests, roadblocks, and the imposition of Section 144—is a stark sign of desperation from an administration that appears increasingly unpopular and barely clinging to power through controversial and outdated measures.

The decision to limit JI protestors to Zero Point and the subsequent arrests of several JI workers aiming to stage a sit-in at D-Chowk underscore a government strategy more suited to autocracies than modern democracies. The heavy-handed approach, including sealing routes, placing containers at critical access points, and deploying anti-terrorism squads, only exacerbates the public's frustration and paints a picture of a

government out of touch with the realities and hardships faced by its citizens.

The imposition of Section 144 across Punjab and Islamabad, banning public gatherings and rallies, is a blunt instrument



intended to stifle dissent under the guise of maintaining law and order. Such measures are increasingly seen as tools of suppression rather than genuine attempts to address security concerns. The inconvenience caused to residents, with severe traffic jams and restricted movement, further alienates the populace and adds to the growing discontent.

Ji's call for a protest against the hike in power tariffs and inflated electricity bills is a legitimate expression of public discontent. The party's peaceful approach, as emphasized by its leaders, stands in stark contrast to the government's op-

pressive tactics. Arresting protestors, raiding homes, and even targeting guests underlines a fear-driven response that is more about silencing opposition than ensuring public safety.

This crackdown reflects an administration desperate to maintain control in the face of mounting criticism and diminishing public support. The use of tear gas and water cannons, as threatened, would only deepen the rift between the government and its citizens, making peaceful resolution of grievances increasingly unlikely.

In a true democracy, the right to protest is a vital mechanism for citizens to hold their leaders accountable. The government's current strategy not only undermines this right but also signals a worrying trend towards authoritarianism. It is high time for the authorities to recognize the legitimate concerns of the populace and engage in meaningful dialogue rather than resort to outdated and repressive measures. The health of a democracy depends on its ability to accommodate dissent and address the issues raised by its citizens, not on suppressing them through force and intimidation.

Jason Gillespie reacts to PCB's stance on players' workload management

Earlier, the cricketing body denied the No Objection Certificates (NOCs) to Naseem Shah for the Hundred and also to Babar Azam, Mohammad Rizwan and Shaheen Shah Afridi for the Global T20 Canada 2024.

Meanwhile, Gillespie, in an interview with ESPN Cricinfo, said that the centrally contracted players are compensated well and thus the management has the right to instruct the players to rest, considering their availability for the national team.

"Players are centrally contracted and getting compensated really well. We have the right to be able to say, 'Look, in this situation, we need you to rest or have some downtime to give your body and mind a break, be ready for the next challenge for Pakistan'" Gillespie said.

Jason Gillespie, however, acknowledged the importance of the franchise leagues for the players to get exposure but if that participation impacts a player's readiness for national duty then a discussion and a decision would be essential.

"We want players to go and play in these leagues and have these great experiences. But if we believe it's going to be to the detriment of representing Pakistan in an upcoming series, then we'll have a discussion and have a decision to make."

"These are honest and difficult conversations. Ultimately, we're tasked with doing what's right by Pakistan cricket."

"If being honest is telling a player something they might not want to hear, well, then I'm willing to do that. I want to help them be the best player and person they can be."

It is worth mentioning here that the Pakistan men's team will embark on a busy international calendar 2024-25 with a two-match home Test series against Bangladesh, scheduled to take place from August 21 to September 3.—Agency

Babar Azam, Rizwan's replacement for GT20 Canada 2024 unveiled

LAHORE: Vancouver Knights have announced replacements for Pakistan's white-ball captain Babar Azam and wicket-keeper Mohammad Rizwan for the ongoing Global T20 (GT20) Canada 2024.

Pakistan's most reliable batting duo was scheduled to represent Vancouver Knights in the GT20 Canada 2024, however, they failed to secure the No Objection Certificates (NOCs) from the Pakistan Cricket Board (PCB).

According to the cricketing body, the three all-format players were denied NOCs, in light of Pakistan's busy and packed cricket calendar in the period from August 2024 to March 2025 which includes ICC Champions Trophy 2025.



"The PCB had received NOC requests from Babar Azam, Mohammad Rizwan and Shaheen Afridi for the Global T20 event, amongst other players," stated PCB.

"The three are all-format cricketers and their services are expected to be required in the upcoming eight months during which Pakistan will play nine Tests, 14 ODIs, and nine T20Is.

"As such, and in line with the PCB's workload management policy, it is in the best interest of Pakistan cricket and the players that they skip the upcoming event in Canada so that they are in their best mental and physical shape for the season which commences with the two-Test series against Bangladesh."

Khawaja led the Vancouver Knights in the GT20 Canada 2024 opener against the Toronto Nationals.

While batting first, the Knights were bowled out for a meagre 110, thanks to Junaid Siddiqui's four-fer. Toronto Nationals' captain Colin Munro led his side to a comfortable victory with a 44-run knock.—Agency

Shoaib Malik urges India to visit Pakistan for Champions Trophy 2025



LAHORE: All-rounder Shoaib Malik urged India to visit Pakistan to participate in the Champions Trophy 2025 which is set to take place in the country from February to March next year.

"I think there are many players in the Indian team who haven't played in Pakistan, so it would be great for them. We are good people. We're very hospitable people, so I'm sure the Indian team should come."

Three venues - Karachi, Rawalpindi and Lahore - will host the matches of eight matches and according to PCB's proposed schedule to ICC, all of India's matches will take place in Lahore. Except India, all eight teams that will participate in the Champions Trophy have already played in Pakistan and the PCB believes that India does not have a strong reason not to come here.—Agency

Paris ready to host 2024 Olympic Games under enhanced security

PARIS: France aims to wow the world on Friday with an extravagant Olympics opening ceremony through the heart of Paris, officially kicking off a Games fraught with security risks at a time of heightened geopolitical tensions.

Some 45,000 police, 10,000 soldiers and 2,000 private security staff will ensure the safety of the parade along the river Seine, its banks and surrounding monuments, in an unprecedented display of security.

A procession of barges will take nearly 7,000 athletes along the river past Paris's most famous landmarks, while more than 300,000 spectators will watch from the banks.

Since the last Olympics in Beijing in 2022, wars have erupted in Ukraine and Gaza, providing a tense backdrop to the Games. France is at its highest level of security - though officials have repeatedly said there is no specific threat to the opening ceremony or the Games.

As part of a vast security operation, authorities have turned to power passed under an anti-terrorism law, placing 155 people under surveillance measures that strictly limit their movement, according to official data and a Reuters review of cases.

Meanwhile, Israeli commentators are being escorted by elite tactical units to and from events and given 24-hour protection throughout the Olympics, officials say.

Scores of world leaders will be in Paris for the opening ceremony, which will be protected by snipers on rooftops. The Seine's riverbed has been swept for bombs, and Paris' airspace will be closed.—Agency

Australian swim coach avoids being kicked out of Olympics



PARIS: An Australian swimming coach who backed a South Korean rival to beat two of his countrymen avoided being kicked out of the Olympics Friday, with officials deciding it would be too disruptive.

Michael Palfrey told South Korea media this week he hoped Kim Woo-min won gold instead of Sam Short and Elijah Winnington in the men's 400m freestyle.

The trio -- all former world champions -- will face off on Saturday in the opening day of action at La Defense Arena.

Head coach Rohan Taylor blasted Palfrey as "un-Australian", deeming his actions "extremely disappointing".

But he stepped short of following through on a threat to send him home, saying athlete welfare across the 41-member pool team factored into his decision.

"We took the time to consider the two options -- for Mick Palfrey to stay, and for him to be sent home," he said in a statement.

"After extended conversations with athletes, the athlete leadership group, and coaching staff we have made the decision for Michael to stay."

"It is not one we have taken lightly and I stress this is an ongoing discussion for when we return home."

Palfrey works with Australian swimmers Zac Incerti, Abbey Connor and Alex Perkins, but also mentored Kim while he was training in Brisbane ahead of the Games.

According to the Sydney Morning Herald, Palfrey was wearing Australian team colours when he was interviewed by South Korean journalists and declared "Go Korea" while talking about his hopes for Kim.

"I support Rohan Taylor and his team and the decision they have taken in the interests of the swimming team," said Australian chef de mission Anna Meares.—Agency

Jasprit Bumrah praises Rohit Sharma, Virat Kohli's leadership skills

India pacer Jasprit Bumrah lauded the leadership skills of two veteran cricketers, Virat Kohli and Rohit Sharma, after the Blues ended their 11-year-long ICC trophy drought by lifting T20 World Cup 2024 in West Indies.

Bumrah was key to India's success in the tournament as he bagged 15 wickets and was also named the Player of the Tournament due to his heroics, especially in the final when all hopes were just for Sharma's men.

The speedster was asked how his favourite Indian captain is to which he hilariously picked himself.

"My favourite captain is me because I have captained a few games. Obviously, there are great captains, but I will take my name. I am my favourite captain," Bumrah told The Indian Express.

After sharing some laughter, Bumrah went on to praise Sharma for the way he has been leading the team. Especially during the five-Test against England where India played several youngsters.

"In the recent England series, when the youngsters came, Rohit made the atmosphere very comfortable," Bumrah said. In regards to the caption, the Murder Mystery actress wrote, "Happy Birthday @matleblanc," while adding a white heart emoji.


She continued by saying, "I hope you're doing so much nothing today. LOVE YOU."

Millions in Banned Indian Medicines Seized At Torkham Border

LANDIKOTAL: The district administration, under directives from the provincial government, conducted a major operation against smuggling at the Torkham Border, seizing millions worth of banned foreign cigarettes, Indian medicines, and paan from a warehouse, officials said on Friday.



The operation, led by Assistant Commissioner Landikotal Adnan Mumtaz and a special team from FC (North), took place late at night at Bacha Mena, near the Torkham Border. "Over 12,000 packs of illegal foreign cigarettes stored in the warehouse were seized," said Deputy Commissioner Khyber Captain (ret) Sanaullah Khan. The warehouse also contained 272 packs of banned medi-

cines, paan, and other items, he confirmed. "The banned items, including cigarettes, were intended to be transported from the Torkham Border to Peshawar and other districts," added the deputy commissioner. "Over 12,000 cigarette packs and 272 packs of other items have been taken into government custody, and legal action is being undertaken," he stated. The district administration continues to carry out ongoing operations at joint checkpoints and the Torkham Border against the smuggling of sugar, urea, and other non-banned items, according to the deputy commissioner.—RT/Agency

Naushehro woman's legs hacked for trying to end abusive marriage

SUKKUR: In a shocking incident in Sindh's Naushahro Feroz district, both legs of a woman named Sobia Batool Shah were savagely hacked by her bloodthirsty father and uncles in the name of patriarchal "honour" for filing for divorce to end an abusive marriage.

The deeply disturbing act of violence occurred in Gul Town of the district, leaving the victim in severe physical as well as mental trauma, which may result in a life-long handicap — with the possibility that she may never be able to walk again. Reportedly, Syed Mustafa Shah, Sobia's father, and her uncles Syed Qurban Shah, Ehsan Shah, Shah Nawaz, and Mushtaq Shah, who were armed with axes, injured Sobia, and fled the spot leaving her screaming for help in a pool of blood.

As soon as police reached the crime scene, Sobia was rushed to a Nawab Shah hospital. Sobia revealed to the police the savageries her patriarchs inflicted upon her for seeking a divorce from her abusive and deadbeat husband, who never took responsibility for his family.

The poor woman further told police that her husband

would regularly abuse her and failed to provide for her and their two children, leaving her to suffer on her own in Karachi.

According to Sobia, she repeatedly alerted her parents about the plight she was in, but her family turned a deaf ear to her grievances and dismissed her, calling her a disgrace.

In a desperate attempt to escape her abusive marriage, Sobia filed for divorce, which incited her father and uncles to confront her. According to the police, Sobia's enraged patriarchs accused her of bringing dishonour to the family by taking legal action against her husband. When she refused to withdraw her case, they attacked her with axes, they added. Taking immediate notice of the incident, the senior superintendent of police (SSP) of Naushahro Feroz, ordered the local station house officer (SHO) to bring all the accused to justice and ensure the victim's security.

Responding to the directions, the police have so far managed to arrest one suspect, Mushtaq Shah, and are conducting further raids in search of the remaining culprits.—RT/Agency

Achakzai: 'We Will Not Live Like Slaves,' Vows To Overthrow Government

QUETTA: Mahmood Khan Achakzai, leader of the opposition alliance Tehreek Tahafuz Ayeen-i-Pakistan (TTAP), has announced a bold move to overthrow the current government, pledging to rescue the nation from alleged corruption.



The rally saw leaders and workers from various opposition parties, including Tehreek-e-Insaf, Pashtun Khawa Map, and BNP Mengal, come together to demand change.

In a fiery speech at a rally in Quetta, the TTAP leader vowed to restore constitutional and legal supremacy in Pakistan and called for re-elections within three months condemning the current government as corrupt and illegitimate.

Achakzai emphasized the need for the supremacy of the constitution and law, saying, "We will not live like slaves in Pakistan." "If our resources are targeted under the guise of combating terrorism, it will lead to disaster."

He criticized the current government, accusing it of corruption and asserting that the national assemblies had been compromised. "This government is a

thief, and the assemblies have been sold," Achakzai declared. The TTAP leader underscored his commitment to justice and fairness, recalling his stance at the Afghan Jirga, where he supported the oppressed against their oppressors. High-Rise Building Catches Fire On Shahra-e-Faisal

KARACHI: A fire broke out at a high-rise building on Sharea Faisal near Metropole on Friday, leaving at least six people, including rescue officials, unconscious. The blaze affected the 7th, 8th, 9th, and 10th floors of the 16-storey building and was extinguished in a rescue operation involving one snorkel and 12 fire tenders, including those from the Pakistan Navy and Rescue 1122.



Of the six unconscious individuals, two are women who have been transported to the hospital for medical assistance.

The track from Jinnah Hospital to Metropole, which was closed due to the blaze, has now been reopened for traffic. Initially, traffic police diverted vehicles from FFC to Kala Pul.

The fire department reported that the blaze was contained, preventing further spread, and all 50 people in

the building were safely evacuated. No one else was reported to be inside the building.

Earlier, police suggested that some people might be trapped inside due to heavy smoke, leading to a temporary halt in the rescue operation.

This marks the third significant fire incident in Karachi this month. On July 15, a fire broke out in Karachi University's Mass cuit.—RT/Agency

Faqeerabad Town Chairman Nisar Hussain Khaskheli Commits To Honoring Election Promises

The Rotary delegation included IPDG Hanif Khan, PP Shahzad Sabir, PP Muneeb Khan, and Asher Ali PNPPC.

The meeting, chaired by EOC Coordinator Irshad Sodhar, was attended by WHO Team Lead Dr. Asif Ali, UNICEF Team Lead Dr. Shokat Ali, N-STOP Team Lead Dr. Shumaila Rasool, and other EOC officers.

Irshad Sodhar welcomed the Rotary delegation and presented an overview of the team's initiatives to eradicate polio. Trustee Aziz Memon emphasized the importance of gaining insights into Sindh's polio eradication efforts and the need for Com-

munity-Based Volunteers (CBVs) to improve community engagement and address vaccine refusals effectively.

Dr. Asif Ali provided an update on current polio cases and environmental positive samples in Sindh, reporting two cases: one in Shikarpur and another in the Kemari district of Karachi. He linked the Shikarpur case to low immunity due to malnutrition, affecting 52% of children in Sindh. While local virus circulation has been halted, current cases involve inactivated polio viruses. To prevent spread, mop-up sessions are being conducted in Jamshoro, Dadu, Mirpurkhas, and Badin districts, along with planned IPV and OPV campaigns. Let Injection will be administered to children aged 4-59 months in areas with persistent environmental positivity.

Irshad Sodhar emphasized the need for collaboration among PPHI, EPI, EOC, and Rotary. He suggested using gift packs containing soaps for hygiene purposes and balloons to attract children and parents to outreach sites. Trustee Aziz Memon shared that the Trust for Malnutrition & Stunted Growth (TMMSG) is actively working in Pakistan and offered full support for interventions in needed areas. He also mentioned that Rotary has developed a Speaking Book in Urdu, Sindhi, and Pashto to promote hygiene in high-risk communities.

Dr. Shaikh reported that two PITP shelters on the Karachi-Balochistan border and the motorway have been renovated and requested an inauguration. The meeting concluded with EOC Coordinator Irshad Sodhar expressing gratitude for Rotary's support and reaffirming EOC Sindh's commitment to eradicating polio from Pakistan.—RT

FIA And Drug Control Authority Shut Down Unregistered Pharmaceutical Company

KARACHI: The Federal Investigation Agency (FIA) and Drug Control Team, with police assistance, conducted a significant operation against a fake and unregistered pharmaceutical company. SHO Quaidabad Gulam Hussain Pirzada reported that in the Quaidabad area of Gulshan-e-Bohaira, a counterfeit drug factory was operating under the pretense of being a mosque and madrasa.

The factory was producing harmful and narcotic drugs. Acting on a tip-off, an intelligence-led raid resulted in the arrest of eight individuals, including the owner Abdul Wahab, who also serves as the Imam of the mosque and madrasa.

The operation uncovered counterfeit and narcotic drugs, raw materials, and packaging materials. The facility, which was distributing these dangerous drugs to various cities across Pakistan, was sealed. Additionally, the machinery and setup were found to be powered by stolen electricity.

Legal action under the Unregistered Drugs Act has been initiated against those involved, and the case has been handed over to the FIA for further investigations.

The new pipeline addresses the long-standing issue of low or zero gas pressure.

At a reception in his honor, MD Maniar explained how the pipeline isolates industrial from domestic connections, ensuring better gas pressure for industries and reducing unaccounted-for gas (UFG) losses. He highlighted the automation of 70% of Karachi's TBS, allowing one-touch regulation of gas pressure.

Discussions also covered RLNG blending, pricing, and billing. Maniar suggested the future might require a shift to LPG cylinders for domestic



users to minimize line losses. He answered various questions from the association members.

SITE President Muhammad Kamran Arbi and Patron-in-Chief Zubair Motiwala commended Maniar's efforts and achievements. Motiwala urged the elimination of gas blending and the replacement of conventional gas geysers with solar ones, funded through monthly bills. 17 Arrested Following Armed Clash Between Bugtis In DHA

KARACHI: Police arrested 17 people during raids conducted on Friday at various locations in connection with an armed clash that left five people dead in Karachi's Defence Housing Authority (DHA) Deputy Inspector General (DIG) South Syed Asad Raza confirmed the recovery of weapons from three suspects during these raids.



The violent incident occurred between the Fahad Bugti and Ali Haider Bugti groups in DHA's Khayaban-e-Nishat, resulting in the deaths of five individuals and injuries to two others. The deceased and the injured were relatives of the slain Baloch leader Nawab Akbar Khan Bugti.

The deceased were identified as Mir Esa Bugti, Ali Fahad Bugti, Naseebullah, and Mir Mesum Bugti. Mir Ali Haider Bugti and Qaim Ali sustained bullet injuries and were treated at the hospital.

While no first information report (FIR) has been registered yet, DIG Raza stated that two cases will be filed in coordination with both groups. The clash, attributed to an "old family dispute," occurred when both groups, initially meeting for talks,

opened fire after their vehicles encountered each other.

Heavy weapons were used in the altercation, and Fahad Bugti's body, which had two bullet wounds to the chest, has been handed over to his family. Sindh Home Minister Ziaul Hassan Larjar has taken notice of the clash and requested a detailed report from the Additional IGP Karachi. He reassured the public that all necessary measures will be taken to uphold the law.—RT/Agency

Probe Launched Against PTA For Failure To Recover Rs78 Billion From Telecom Companies

KARACHI: The National Accountability Bureau (NAB) Karachi has initiated a probe against the Pakistan Telecommunication Authority (PTA) for failing to recover over Rs78 billion in dues from telecom companies, media sources reported. According to the sources, the PTA has been directed to submit a response to NAB by July 29. The investigation has revealed that the delay in recovering dues has caused significant losses to the national exchequer. NAB has requested detailed information on the out-

standing amounts, court cases, and all relevant records from the PTA. PTA officials have been summoned to appear before NAB Karachi with the required documents. Sources also mentioned that Long Distance and International (LDI) companies have agreed to pay 100% of the principal amount. However, the recovery of dues has been impeded by court stay orders. Sanam Javaid On PTI's Reserved Seats List Submitted To ECP

ISLAMABAD: The Pakistan Tehreek-e-Insaf (PTI) has submitted a list of the candidates for the reserved seats to the Election Commission of Pakistan (ECP), picking Sanam Javaid, Aliya Hamza Malik, Yasmin Rashid among others for the seats reserved in assemblies for women and minorities, party sources said on Friday.



The development came after the Supreme Court, in its July 12 short order in the reserved seats case, allowed the former ruling party to have reserved seats in assemblies, paving the way for the party to potentially become the largest parliamentary party.

In the landmark ruling, the apex court directed the PTI to submit a list of its eligible candidates for reserved seats in national, Punjab, Sindh and Khyber Pakhtunkhwa assemblies, according to the sources.

The list includes 67 names for seats reserved for women and 11 for minorities seats, sources said, adding the names of Javaid, Hamza, Kanwal Shauzab, Rubina Shaheen and Seemab Tahir have been chosen for the National Assembly.

Complying with the short order of the top court, the PTI today submitted the list of its candidates for the reserved seats in national, Punjab, Sindh and Khyber Pakhtunkhwa assemblies, according to the sources.

Meanwhile, Lal Chand Malhi has been nominated by the party for the minority seat in the lower house of parliament, the PTI sources said, adding Dr Yasmin Rashid has been named for the reserved seat for women in Punjab Assembly.

A day earlier the polls regulator declared 39 PTI lawmakers — who contested the February 8 elections as independent candidates and later joined the Sunni Ittehad Council (SIC) — as PTI members in line with the Supreme Court's ruling.

Earlier this week, the PTI submitted relevant documents with declaration of party's affiliation to the Election Commission to be entitled to have reserved seats in the assemblies in line with the court's order.

Having been deprived of its election symbol, the PTI's candidates contested the February 8 elections as independents. However, these independents were directed by the party to join the SIC to be eligible for the reserved seats.

The SIC in multiple petitions, pleaded with the top court to allow the party to have reserved seats in legislature. On July 12, the court announced its short order in the PTI's favour. However, the ruling Pakistan Muslim League-Nawaz (PML-N) and the Pakistan Peoples Party (PPP) filed a review petition against the SC ruling declaring the PTI eligible for the reserved seats —RT/Agency

ADB Approves \$400M Loan For Pakistan's Flood Rehabilitation

MANILA: The Asian Development Bank (ADB) today approved a \$400 million concessional loan to support the reconstruction of houses and community infrastructure in Sindh damaged by the devastating floods in 2022.



The Sindh Emergency Housing Reconstruction Project will rehabilitate flood-damaged houses and community infrastructure and support livelihood recovery, with a focus on strengthening communities' resilience against climate change-induced natural hazards.

This project is a key part of ADB's multifaceted response to Pakistan's flood crisis and forms part of the government's commitment to provide \$1.5 billion in total assistance from 2023 to 2025 to accelerate the country's flood recovery.

"This project will help rebuild homes and communities, and restore livelihood and basic services in Sindh, the province most affected by the devastating 2022 floods," said ADB Director General for Central and West Asia Yevgeny Zhukov.

"It is part of ADB's extensive support to help Pakistan recover from the disaster which affected 33 million people and damaged houses and infrastructure across the nation."

Sindh sustained about 83% of the total housing damage inflicted by the 2022

floods, with around 2.1 million houses either fully destroyed or damaged.

Two years on, many victims still reside in inadequate, temporary shelters lacking essential services such as water, sanitation, and electricity.

The project will support conditional cash grants for the reconstruction of 250,000 houses with multi-hazard resilient and environment-responsive designs.

It will also support community-driven construction of infrastructure such as drinking water facilities, sanitation facilities, covered drainage, and renewable energy solutions for 100,000 households in around 1,000 flood-damaged villages in Sindh.

The project will also support conditional cash grants for livestock, agriculture, small enterprises, and e-commerce.

"ADB's support will not only help Pakistan build back better, but it will also promote community-led climate resilience and disaster risk management strategies to better prepare for future hazards," said ADB Director for Water and Urban Development Srinivas Sampath.

"We are coordinating closely with other development partners to support the government's recovery and reconstruction priorities." The project supports the government's resilient rehabilitation, reconstruction, and recovery strategy (4RP) and will follow an integrated and sequential approach so that investments across sectors complement each other. A \$500,000 technical assistance grant will further support the government's operational capabilities in procurement, safeguard compliance, and technical and financial management. —RT/Agency

Law Minister Tarar Rules Out Early Elections



ISLAMABAD: Federal Minister for Law, Azam Nazeer Tarar, has categorically rejected any possibility of early elections, stating that such a notion is merely a wish of the opposition leader.

In his statement, Azam Nazeer Tarar emphasized that the elections will be conducted as per the scheduled timeline, asserting the government's commitment to constitutional mandates.

Tarar highlighted that the constitution clearly stipulates a five-year term for the assemblies, thereby negating any speculations or rumors about early elections. He assured that the current situation does not necessitate premature elections, affirming that everything is functioning smoothly within the political framework. Ahsan Iqbal: AI Policy Set For Cabinet Approval Next Month

ISLAMABAD: Minister for Planning, Development, and Special Initiatives Professor Ahsan Iqbal announced on Friday that the final draft of Pakistan's Artificial Intelligence (AI) policy will be presented to the Federal Cabinet for approval in August.

Addressing a meeting of the Special Task Force on Artificial Intelligence, Iqbal urged relevant parties to expedite consultations with stakeholders. He emphasised AI's current role in global advancement, stating, "Artificial intelligence is not the future but the present reality in the world." Iqbal highlighted the PML-N government's achievements in AI, noting the establishment of the National Center for Artificial Intelligence in 2017 and the National Task Force on Artificial Intelligence in 2023. He stressed that these initiatives were crucial for Pakistan's progress in this field.

Reflecting on past challenges, Iqbal criticised previous inconsistencies in policy that hindered economic development. He also highlighted ongoing obstacles to economic progress, attributing these to disruptive elements within the country.

Finance Minister Briefs China On Bold Reforms And IMF Plans

ISLAMABAD: Federal Minister for Finance and Revenue, Senator Muhammad Aurangzeb, during a meeting with high-ranking officials from the Chinese institutions on Friday, briefed them about the government's reform agenda and engagement with the International Monetary Fund (IMF).

According to press release issued by finance ministry here, the finance minister and Minister for Power, Sardar Awais Ahmad Khan Leghari held meetings with Governor of People's Bank of China (PBOC), Pan Gongsheng and Vice Administrator National Energy Administration (NEA), Ren Jingong.

Ambassador Khalil Hashmi and officials of the Embassy accompanied the Ministers, according to the press release. The discussions focused on the significant strides made by Pakistan in improving its macroeconomic indicators by focused reforms in taxation, energy and privatization of the state-owned enterprises.

The reforms have already started showing their results, particularly, reducing inflation from 38% to 13% marks a substantial achievement for the economy.

Additionally, the stabilization of the exchange rate and the bolstering of foreign exchange reserves were highlighted as key factors contributing to the economic upturn.

There was consensus was that such reforms are indispensable for achieving long-



term stability and fostering sustainable economic growth.

The Governor's recognition of Pakistan's policy measures reflects a broader international perspective on the importance of economic resilience and the positive impact of prudent fiscal management, the statement added.

Underlining Pakistan's plan to launch Panda Bonds, Minister for Finance briefed PBOC and other Financial Institutions about the steps taken so far and sought cooperation of the Chinese institutional investors in the capital market and seek benefit from the pro-business policies of the new Government.

Lauding President Xi Jinping's Belt and Road Initiative (BRI) both the Ministers noted the achievements during the first phase of the China-Pakistan Economic Corridor (CPEC), a flagship project of BRI, for strengthening the infrastructure in energy, transport sectors along with others.

It was highlighted that during the next phase of CPEC, focus is on strengthening B2B cooperation, with

private sector playing the central role in the development and economic growth.

Meanwhile, in a meeting with Vice Administrator NEA, Minister for Power expressed government's conviction to introduce energy reforms aimed at enhancing efficiency of power sector by addressing systemic issues and cutting transmission losses. He appreciated NEA for signing the MoU on improving governance of the Power Sector and expressed resolve to fast-track implementation of the agreement.

The Ministers also met Executive Vice President of China Development Bank (CDB), President of National Association of Financial Market Institutional Investors (NAFMII), Chairperson of Silk Road Fund (SRF), Chairman of China International Capital Corporation (CICC). On the instructions of the Prime Minister, the two Ministers paid an official visit to Beijing from 24-26 July 2024 as part of the government's efforts to implement consensus reached at the former's recent visit to China. —RT/Agency

Britain Drops ICC Challenge Against Netanyahu And Gallant

LONDON: Britain said on Friday it would not proceed with efforts to question whether the International Criminal Court (ICC) has jurisdiction to issue arrest warrants for Israeli Prime Minister Benjamin Netanyahu and Defence Minister Yoav Gallant.

In May, the ICC's prosecutor said he had requested arrest warrants for Netanyahu, Gallant and three Hamas leaders over alleged war crimes.

Court documents made public in June showed Britain, an ICC member state, had filed a request with the court to provide written observations on whether "the court can exercise jurisdiction over Israeli nationals, in circumstances



where Palestine cannot exercise criminal jurisdiction over Israeli nationals (under the Oslo Accords)".

Since then, Britain has elected a new government run by the Labour Party, and Prime Minister Keir Starmer's spokesperson said the previous government had not submitted its proposal before the July 4 election. "On the ICC submission... I can confirm the government will not be pursuing (the proposal) in line with our long-standing position that this is a matter for the court to decide on," the spokesperson told reporters. —RT/Agency

Government Still Open For Talks: Tarar Accuses JI Of Sit-In Venue Violation

ISLAMABAD: Federal Minister for Information and Broadcasting, Attaullah Tarar accused Jamaat-e-Islami (JI) of breaching the agreement with the government about concluding their protest against inflation with a rally at Liaquat Bagh. However, the government remains open to dialogue, he added.

"When it was agreed to hold the rally at Liaquat Bagh, the march towards Islamabad is incomprehensible," he said while addressing a press conference alongside Amir Muqam in Islamabad on Friday.

Tarar emphasised that the government is still willing to engage in talks with Jamaat-e-Islami.

Reacting to Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur's speech at the Bannu rally, Tarar remarked, "We understand his constraints. He reassures in the Apex Committee, but speaks differently in public. After the decision to bring back TTP terrorists, terrorism has increased."

Tarar criticised the CM Gandapur further, saying, "What should have been



done is to outline your actions against terrorism. They have made an agreement with a fake artificial intelligence institution, un-certified by any organisation, which will not benefit the youth."

Meanwhile, the Islamabad police have arrested numerous participants of the Jamaat-e-Islami sit-in at the federal capital's D-Chowk, with ongoing efforts to detain more.

The arrested individuals have been transported in prisoner vans, and the routes leading to D-Chowk have been blocked with containers by the police and administration. Containers have also been placed at the city's entry points, and major roads and intersections are

only allowing one lane of traffic. This has resulted in long queues of vehicles and significant inconvenience for residents.

Additional containers have been placed under the Zero Point Bridge too, leaving only two lanes open for traffic. A heavy police presence is deployed at Faizabad, equipped with water cannons and tear gas. Operational police units have been issued 10,000 tear gas shells from police lines to manage the protesters. Heads of three government hospitals have been instructed to keep their emergency departments on high alert until Monday to handle any potential emergencies arising from the situation. —RT/Agency
