## Non-Bailable Arrest Warrant Issued For Gandapur

ISLAMABAD: A court in the federal capital city on Wednesday issued a non-bailable arrest warrant against Khyber Pakhtunkhwa (KP) Chief Minister Ali Amin Gandapur in a case pertaining to arms and liquor recovery.

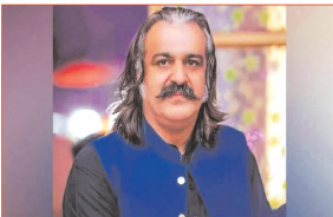
The KP chief minister's plea seeking exemption from attendance before the court on medical grounds was also rejected by the court.

Civil judge Shaista Khan Kundi ordered the Barakahu station house officer (SHO) to arrest Gandapur and produce him before the court.

Judge Kundi said the case was called thrice since morning and the suspect still did not show up.

Assistant to the lawyer, Fatahullah Burki said the chief minister could not turn up before the court due to the situation of floods.

Hasan, on the other hand, said he would submit a medical report about Gandapur as he was unwell.



Expressing bewilderment over the contrasting statements, the judge remarked: "You said he was not doing well while your assistant said it was due to flood that he could not appear."

Judge Kundi said she previously gave relief to the KP CM on the last hearing as well and adjourned the hearing for a long time as requested.

The lawyer said their acquittal plea was still pending before the court. The judge replied acquittal would not be granted, as per the

Supreme Court ruling, if the case was on its last stages; hence, it would be disposed of on merit.

She added that it was for the eighth time that a statement could not be recorded under Section 342. "Then you say that you are not given a free trial," she maintained. The lawyer maintained it was unjustified as the suspect was a provincial chief minister. The court said if the suspect was innocent, he should be brave and face the trial.—RT/Agency

## ECP Delays Islamabad Local Government Polls After Legal Changes

ISLAMABAD: Following the amendments to Islamabad Capital Territory Local Government Act, 2015, the Election Commission of Pakistan (ECP) has put off local bodies elections, that were scheduled to be held on October 9, until further notice.

"The ECP has decided to hold in abeyance, the Election Programme issued vide its notification even numbered 20/8/2024 for conduct of local government elections in Islamabad Capital Territory, till further orders," stated a notification issued today.

President Asif Ali Zardari, on August 29, assented to the Islamabad Capital Territory Local Government (Amendment) Bill 2024, after it was passed in the National Assembly and the Senate, amidst strong protest by the opposition.

In the new bill, the government has increased the number of general seats of union councils (UCs) from existing six to nine and



seats of women from two to three, according to The News.

According to an amendment to Section 7 of Islamabad Capital Territory Local Government (Amendment) Bill 2024, the electoral watchdog shall delimit union councils into nine wards for

the election of members on the general seats. Previously, there were six wards in a union council.

As per substitution of Section 15, all nine general members of each union council shall be directly elected by the voters registered in the corresponding union council.

Meanwhile, an amendment to Section 17 stated that the words, the expression the Representation of People Act, 1976 will be substituted with the Elections Act, 2017.

Another substitution of Section 11 noted there will be chairman and vice chairman of a union council as joint candidates, nine general members, one woman, one peasant or worker or business

or technocrat, one youth member and one non-Muslim.

Earlier, the election commission — in response to requests from political parties — had rescheduled polling for October 9 instead of September 29.

"To facilitate the participation of various political parties and prospective candidates in the election process and to provide them with all possible accommodations, the election commission has officially notified the revised election programme, according to which polling will now be held on October 9, 2024," said a statement.—RT/Agency

## Imran Warns Of Protest Movement If Supreme Court's Authority Is Compromised

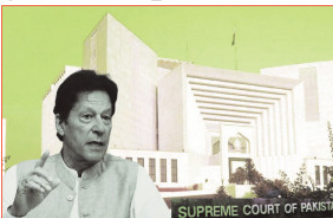
ISLAMABAD: Imran Khan, the founding leader of the Pakistan Tehreek-e-Insaf (PTI), has warned of a nationwide protest movement if any attempts were made to undermine the authority of the Supreme Court.

Speaking informally with journalists at Adiala Jail after attending a hearing in the 190 million pound reference case, Imran criticised efforts to weaken national institutions, stating, "The institution belongs to everyone, not just the army chief."

Imran expressed concern over the appointment of "corrupt and incompetent individuals" to key positions, arguing that such decisions were damaging the nation.

He cited the Pakistan cricket team's recent whitewash by Bangladesh as an example, blaming poor leadership and appointments for the decline of the sport.

He also raised concerns about delayed court rulings,



particularly regarding the National Accountability Bureau (NAB) amendments, which he believes are being postponed until a verdict is reached in his reference case.

The PTI founder pointed out that several high-profile cases involving former Prime Minister Nawaz Sharif and incumbent Prime Minister Shehbaz Sharif, along with President Asif Zardari, are stalled due to the pending NAB ruling.

Imran Khan further alleged that there were at-

tempts to close down the Al-Naqir University, stressing that while it would not affect him personally, the closure of Shaukat Khanum Hospital would greatly impact the public.

The former prime minister reiterated that the Supreme Court remains one of the last institutions representing the country's integrity, and any effort to destroy it would be met with nationwide protests.—RT/Agency

## PM Honors Brave Excavator Driver With Rs2.5m For Rescuing Flood Victims In Balochistan



ISLAMABAD: Prime Minister Shehbaz Sharif welcomed Mohibullah, an excavator driver who risked his life to save people stranded in floodwaters in Qila Abdullah, at the Prime Minister's House in Islamabad on Wednesday.

The prime minister praised Mohibullah's bravery and his dedication to saving lives, stating, "The entire nation, including myself, is proud of you." He added, "You are a hero of the nation. You displayed courage in saving precious human lives."

Shehbaz Sharif highlighted the significance of Mohibullah's actions, saying, "Risking your own life to save others in such difficult circumstances is an act of bravery. You have fulfilled a national duty by rescuing those in distress."

In recognition of his courage, the prime minister awarded Mohibullah with a cash prize of Rs2.5 million on behalf of the Government of Pakistan. He also announced free university education for Mohibullah's children and free healthcare for his family.

## US Reiterates Support For Pakistan In Fight Against Terrorism

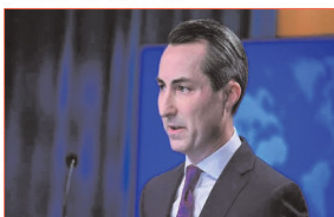
WASHINGTON: The United States strongly condemned the recent terrorist attacks in Balochistan, which resulted in the deaths of over 50 people, including 14 security personnel.

The US State Department's spokesperson Matthew Miller, at a news briefing, said that "Washington strongly condemned last week's deadly attacks that targeted security officials and civilians, including the murder of 23 innocent civilians in Musakhail."

Last week, over 50 people, including 14 security personnel, were martyred in different terrorist attacks in Balochistan. In one of the deadliest attacks, at least 23 passengers were killed after being offloaded from passenger buses and trucks in the Musakhail.

Separately, at least 10 people, including police and Balochistan Levies personnel, were martyred in a gun attack in Kalat.

Furthermore, at least 14 brave sons of soil, including 10 security forces soldiers



and four personnel of law enforcement agencies (LEAs), were martyred in clearance operations, wherein at least 21 militants were neutralised.

Responding to a question about Balochistan attacks, Miller said: "The Pakistani people have suffered greatly at the hands of violent extremist terrorists and our hearts go out to the families and loved ones of those killed."

The US and Pakistan have a shared interest in combatting threats to regional security, he said, adding that they will continue to stand shoulder-to-shoulder with Pakistan in its

fight against terrorism.

In response to another query about the Pak-Iran gas pipeline project, the State Department's spokesperson said, "So what I'll say is that we will continue to enforce our sanctions against Iran. And as a matter of course, we also advise anyone considering business deals with Iran to be aware of the potential ramifications of those deals."

"At the same time, helping Pakistan address its energy shortage is a priority for the United States, and we continue to discuss energy security with the government of Pakistan.—RT/Agency

## Akhtar Mengal Stands Firm On Resignation As Government Attempts To Satisfy Balochistan Leader

ISLAMABAD: Balochistan National Party (BNP-M) chief Sardar Akhtar Mengal on Wednesday refused to take back his National Assembly (NA) resignation, tendered over "prevailing situation" in Balochistan, as the government assured the politician of addressing his grievances.

"I have no intention of withdrawing [my] resignation," the veteran lawmaker said while speaking to journalists after meeting a government delegation, which was headed by Adviser to Prime Minister for Inter-Provincial Coordination Rana Sanaullah.

The delegation — which also comprises Tariq Fazal Chaudhry, Usman Badiani, Aijaz Hussain Jakhri and Khalid Magi — assured Mengal of addressing his grievances and asked him to withdraw his resignation.

However, the BNP-M chief said they tried to convince him, but instead "I convinced them". During the meet-



ing, Mengal said, he raised issues regarding Balochistan's exploitation, missing persons, and unfair distribution of resources.

A day earlier, Mengal tendered his resignation from the lower house of parliament over a "worsening situation" of his province, declaring no confidence in the state, the president and the prime minister.

"I announce my resignation from the Assembly today [Tuesday]. I said that the former had made this decision after witnessing the situation of Balochistan," he said during the NA's session. Regretting that he could do nothing for

the people of the province, the politician said they had not been given the right to rule for a year and that he had a lack of trust in the whole system. "People are not interested in the issues of Balochistan and every time this issue is raised, we face a blackout," he said. "This assembly does not listen to us, what's the point of sitting here?" Talking to media after meeting the BNP-M chief today, Sanaullah said that the former had been asked to change his mind and remain part of parliament. He [Mengal] has always spoken about the rights of his province.—RT/Agency

## Omar Ayub In NA: 'Balochistan's People Show Greater Patriotism Than Ours'

ISLAMABAD: As the political landscape of Balochistan witnesses turbulence in the wake of the August 26 terror attacks and the resignation of veteran lawmaker Sardar Akhtar Mengal, Omar Ayub — the leader of the Opposition in the National Assembly — has termed the people of Balochistan "more patriotic" than the rest of the country.

Speaking during a session on the floor of the lower house of parliament on Wednesday, Ayub, the Pakistan Tehreek-e-Insaf (PTI) secretary-general, insisted on taking Mengal's resignation seriously, asking for redressal of the grievances pertaining to the province's stakeholders.

"A fact-finding mission should go to Balochistan and assess the situation," the politician said, demanding the formation of a committee that could talk to Balochistan's people.

A day earlier, Balochistan National Party (BNP-M) chief Akhtar Mengal resigned as a member of the NA over the "worsening situation" of his province, declaring no confidence in the state, the president and the prime minister.



"I announce my resignation from the Assembly today. I made this decision after witnessing the situation of Balochistan," said Mengal during the lower house's session.

Regretting that he could not do anything for the people of the province, the politician said they had not been given the right to rule for a year and that he had a lack of trust in the whole system.

"People are not interested in the issues of Balochistan and every time this issue is raised, we face a blackout," he said. "This assembly does not listen to us, what's the point of sitting here?"

Meanwhile, speaking on the NA floor, Ayub insisted that the ministers of the Balochistan government cannot talk to

people and the province's youth does not want to listen to them.

"They [people of Balochistan] have a right to their resources. Talk to them," he said, claiming that the federal government doesn't want to talk to them.

"If they do not talk, how will the federation work?" he added. Hinting at the lack of interest by the government in resolving the issue, the PTI leader said, "The tragedy is that dictation is taken from elsewhere."

"The politico also spoke about the 'persecution' being faced by his own party and its founder, Imran Khan." The PTI people are being forcibly disarmed. Our prime minister [Imran Khan] is sitting in jail. The entire leadership has been put in jail in false cases.—RT/Agency

## DC Naveed Rehman Larik Reviews Eid Milad-un-Nabi (SAWW) Plans

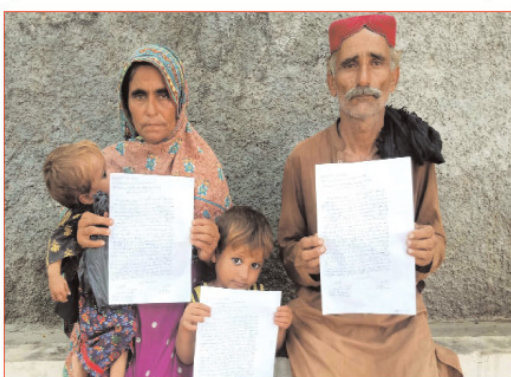

## Device Mafia Robs BISP Beneficiaries In Mirpurkhas

MIRPURKHAS: In Mirpurkhas, on Iqbal Pump, Chooona Factory Road, there are reports of open misconduct by the device mafia at the Benazir Income Support Center. The staff of the device mafia has been accused of exploiting underprivileged women from rural Sindh by demanding money from 1,000 to 1,500 rupees under duress. Despite the visible exploitation and corruption, both the police administration and the Benazir Income Support Program (BISP) administration have remained silent on the issue, and the reason for their inaction has not been clarified.

## SSP Ameer Saud Magsi Reviews Dadu's Law And Order

DADU: An important meeting regarding law and order and other departmental matters was held under the chairmanship of SSP Dadu, Captain (Retd) Ameer Saud Magsi. The meeting was attended by all DSPs, SHOs, DSP Legal, police station heads, and branch heads. SSP Dadu reviewed the overall law and order situation in the district, the crime statistics from police stations, and the performance of the police. SSP Dadu directed all officers to further improve their performance. He issued orders to expedite actions against the culprits in cases of murder, robbery, abductions, and police personnel martyrdom, and to maximize arrests. SSP Dadu instructed all SHOs to take effective actions against drug dealers and other social evils to achieve better results. Regarding case investigations, SSP Dadu instructed that cases should be investigated by trained investigation officers, completed within the stipulated time, and resolved promptly. He emphasized the need to improve the ratio of crime convictions and encouraged officers who achieve better results through quality investigations and diligent case follow-ups to receive exemplary sentences from the courts. Investigation officers will also receive timely payments for expenses incurred during investigations. SSP Dadu directed that duty officers should be appointed and ensured a good presence of officers with a positive mindset in police stations at all times. He instructed that duty officers are authorized to file FIRs in cases of known crimes and to treat complainants courteously. SSP Dadu advised all SHOs and Head Muharar to avoid filing false FIRs and not to create unnecessary obstacles in the registration of valid FIRs. SSP Dadu also stated that all SHOs have the authority to spend the allocated budget for police stations, but it should be used for the betterment of the department. He ordered all DSPs and SHOs to be present at the police stations daily from 5 PM to 7 PM to listen to public complaints and ensure their resolution. SSP Ameer Saud warned the negligent officers of departmental action.

## PHP Police Present Performance Report For August 2024

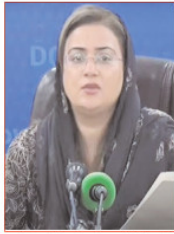


GUJRANWALA: Under the direction of Inspector General of Police Punjab, Dr Usman Anwar, the Punjab Highway Patrol (PHP) has been on high alert across the province, including Lahore. The force remains committed to citizen service, crime prevention, and law enforcement. The PHP has released its performance report for August 2024, detailing their activities and achievements. According to the report 3.8 million individuals were checked via the e-police post app, 601 wanted criminals and judicial absconders were apprehended. 15 million vehicles were inspected, resulting in the recovery of 269 stolen vehicles/motorcycles. Under the road safety campaign, 235,000 traffic violations were ticketed. More than 45,000 overloaded vehicles were fined and legally

processed for axle load violations. A total of 99.1 million rupees in fines was collected. 962 vehicles were subjected to legal action for illegal use of gas cylinders. 15,000 driving licenses were issued for public convenience. 58 missing children were reunited with their parents. 291 temporary and permanent encroachments were removed to improve traffic flow. Assistance and guidance were provided to 9,989 passengers. 6,017 citizens received various police services at police service centers. 84 cases were registered for illegal weapon use. 1,575 liters of alcohol and 10,225 grams of charas were seized from drug dealers. IG Punjab Dr. Usman Anwar praised the PHP force for their exceptional performance and instructed all teams to maintain their diligent field patrolling efforts. He stressed the importance of continuing efforts to combat crime and ensure the safety and service of citizens on the roads.

## Azma Expresses Readiness To Address IMF's Concerns Over Electricity Bill Relief

LAHORE: Punjab Information Minister Azma Bokhari asserted to talk and clear reservations of the International Monetary Fund (IMF) on subsidy in electricity bills.



Punjab information minister berated other provinces for copying Punjab CM Maryam Nawaz and her projects and also issuing statements against her. Azma Bokhari highlighted key projects of Punjab CM including lowering rates of Roti (Bread), decreasing fares of transportation and introducing air ambulance service.

Citizens could get a loan with a monthly installment of Rs 14,000 to pay back in seven years.

She revealed that more than Rs 78,000 citizens had applied for this project and around 0.2 million calls had been received for information and guidance of this project.

She stated that banks and other financial organisations take service charges for such projects but the government will pay the service charges

and tax for the Apni Chhat, Apna Ghar program.

Bokhari added that CM Maryam Nawaz herself baling this program every month for strict scrutiny and to avoid inclusion of convicted and criminals in this program.

She also clarified that projects were being announced after finalisation of programs funding and all details.

## Terrorists In Balochistan Will Be Held Accountable, Vows Sarfraz Bugti



QUETTA: Balochistan CM Sarfraz Bugti stressed that terrorists in Balochistan wouldn't get any refugee and would face the music. Talking at the cabinet session, he reiterated that the Balochistan Assembly condemned terrorism fiercely in the wake of a surge in terrorist attacks in the province.

## FIA Launches New Border Control Units And Forensic Lab

He praised the chief justice's recent short order on the finality of the prophethood (Khatam-e-Nabuwat) and expressed that issuing a detailed judgment would fully satisfy the Pakistani Muslims. —RT/Agency

## Committee Formed To Examine Foreign Funding Of NGOs

ISLAMABAD: The federal cabinet has notified the formation of a committee to review foreign funding received by both international and domestic nongovernmental organisations (NGOs), it emerged on Wednesday.

According to the notification dated September 3, a copy of which is available with media, the six-member committee will include Law and Justice Minister Azam Nazeer Tarar, Foreign Secretary Syrus Sajjad Qazi, Economic Secretary Dr Kazim

Niaz, Interior Secretary Capt (retired) Khurram Muhammad Agha, Finance Secretary Imdad Ullah Bosal, and Law and Justice Secretary Raja Naeem Akbar.

The committee will "review the channels" through which NGOs receive foreign funding, suggesting concrete measures to ensure transparency and visible funding trails, the notification read.

"The committee will also ensure that any funding received by NGOs will be utilised for the purpose for which they have been received".

The notification added that the committee has four weeks to submit its report to the federal cabinet.

The move came after sources previously told media that the government was set to decide whether to allow over a dozen international NGOs to work in the country or not.

A meeting of the special committee formed to look into this issue was chaired by Interior Minister Mohsin Naqvi on August 31. —RT/Agency

## Churna Island Named Pakistan's Second Marine Protected Area



QUETTA: The government of Balochistan has officially declared Churna Island as Pakistan's second Marine Protected Area (MPA), a significant move to safeguard the region's fragile marine ecosystem.

In a cabinet meeting on Wednesday, the decision was approved, following the declaration of Astola Island as the country's first MPA in June 2017.

Churna Island, located near Karachi, is recognised as a biodiversity hotspot, much like Astola Island, and is home to coral habitats that are rare in Pakistan.

The area is a popular destination for recreational activities such as scuba diving, snorkelling, cliff jumping, and jet skiing, while also serving as an essential fishing ground for both Sindh and Balochistan fishermen.

However, the marine ecosystem surrounding Churna Island faces mounting threats from human activities, including the development of power plants, oil refineries, single-point mooring, and extensive recreational usage.

WWF-Pakistan, in response to the cabinet's approval, has expressed its support for the declaration, viewing it as a vital step toward protecting the island's delicate environment.

In a statement, WWF-Pakistan applauded the efforts of the Balochistan government, particularly recognising the contributions of Dostain Jamaludini, Secretary of the Forest and Wildlife Department, and Sharfuddin Baloch, Chief Conservator of Wildlife.

The environmental organisation highlighted the importance of this designation in preserving marine biodiversity. Pakistan, as a signatory to the Convention on Biological Diversity, is committed to protecting 30% of its ocean areas by 2030 under the Kunming-Montreal Global Biodiversity Framework. The designation of Churna Island as an MPA is a crucial step toward achieving this 30x30 goal. —RT/Agency

During the ceremony, Minister Dharejo, along with Secretary Industries and Commerce Muhammad Yasin Shar Baloch, MD Site Ghazanfar Ali Qadri, Secretary Investment Department Raja Khurram Shahzad Umar, Secretary Information and Technology Noor Ahmed Samoo, and Secretary Agriculture Rafiq Ahmed Barro, emphasized that the MoU aims to foster employment opportunities and strengthen links between the two departments to support small-scale industries.

Dharejo stressed the importance of establishing agro-based industries in the

## A History Of Broken Promises

The recent statement from the U.S. State Department, expressing a commitment to stand "shoulder to shoulder" with Pakistan in combating terrorism, might seem like a reassuring gesture to some. However, seasoned observers of U.S.-Pakistan relations know better. This is not the first time Washington has made grand promises of support, only to later withdraw when the geopolitical winds shift. For the current Pakistani government, the Biden administration's latest rhetoric should be a reminder that they've been down this road before—repeatedly.

History is replete with instances where the U.S. has alternated between treating Pakistan as

a critical ally and viewing it with suspicion. The relationship has often been characterized by a "hot and cold" dynamic, with periods of intense



cooperation followed by abrupt distancing. Pakistan's strategic location has made it a valuable partner for the U.S., but this partnership has rarely been one of equals. The U.S. has often prioritized its own interests, with little regard for the long-term stability or security of Pakistan.

The Biden administration, widely seen as a lame duck due to its dwindling domestic support

and international credibility, offers little assurance that things will be different this time. While the State Department spokesperson's words may seem comforting in the face of rising terrorism, they ring hollow against the backdrop of history. Pakistan must approach this latest U.S. overture with caution and a clear-eyed understanding that Washington's promises have often been as fleeting as they are fervent.

Ultimately, Pakistan's fight against terrorism is its own. The U.S. can offer words of support, but true security will come from within—through policies and partnerships that put Pakistan's interests first, not those of a faraway ally with a record of unreliability.

## Govt High School Bagh Manik Demands Basic Facilities

## Sujawal's Rural Areas Still Flooded With Rainwater

SUAWAL: Sindh Chief Minister Syed Murad Ali Shah has taken serious notice of the failure to drain rainwater from residential areas in Sujawal city and has ordered the immediate removal of the water. Following his directive, the district and town administration deployed large machinery to drain water from the urban areas. However, Ward No-9 and the cemetery in the main area of the city are still submerged in rainwater. The surrounding area of the Boys High School Su-

jawal is also waterlogged, and students and teachers have to wade through water to reach the main school building. A road leading to the school, which is also used by thousands of women coming to collect their Benazir Income Support Program payments, has become difficult to navigate, causing significant inconvenience for both students and the women. In addition, rainwater has not been drained from hundreds of villages in the Sujawal district, leaving water standing in and around these villages and on the roads. Many villages are completely surrounded by water, leading to the destruction of homes and severe damage to crops. Millions of rupees worth of crops have been submerged and destroyed. The administration has not paid any attention to these villages, and in the affected urban areas, there has been an increase in cases of scabies, skin diseases, malaria, and stomach ailments. The residents have urged the government to set up medical camps in the affected areas and provide emergency medical treatment to the people.

## Pakistan Hits Rock Bottom in Test Rankings, Worst Since 1965



DUBAI: Shan Masood-led Pakistan succumbed to a historic series defeat against Bangladesh, leading to their fall to their lowest ICC Men's Test Team Rankings since 1965.

Bangladesh outclassed Pakistan by six wickets in the second Test match to complete the clean sweep and win their first-ever series against the Green Shirts. The touring side had won the first Test thumpingly by 10 wickets.

The back-to-back losses against Bangladesh resulted in Pakistan dropping two places to eighth with 66 rating points. "This is the lowest rating points Pakistan have had in the Test rankings table since 1965, barring a brief period where they did not have a place in the rankings due to an insufficient number of matches," the ICC press release stated.

Meanwhile, Bangladesh gained 13 rating points, however, they are still sitting in the ninth position behind Pakistan in the ICC Men's Test Team Rankings. Due to Pakistan's decline in the rankings, Sri Lanka and West Indies have both advanced one position to claim sixth and seventh place, respectively.

"Extremely disappointed, we were excited for the home season but the story has been the same as Australia," Pakistan skipper Shan Masood said after the loss in the second Test to Bangladesh. "We have not learnt our lessons. We thought we were playing good cricket in Australia but not doing the job, that's something we need to work on."—Agency

## Miandad, Inzamam React in Shock to Pakistan's Historic Loss to Bangladesh



KARACHI: Legendary Pakistan cricketers including Javed Miandad and Inzamam-ul-Haq reacted to the national men's team's first-ever Test series defeat against Bangladesh.

The Green Shirts succumbed to a 2-0 loss in the two-match series against Bangladesh, which culminated at the Pindi Cricket Stadium on Tuesday. Bangladesh outclassed Pakistan by six wickets in the second Test to complete the clean sweep. The touring side had won the first Test thumpingly by 10 wickets.

Former Test captain Javed Miandad, known for his blunt remarks, expressed his disappointment specifically with the team's batting woes while lauding the touring side for their disciplined performances.

"It is hurting that our cricket has come to this stage. Bangladesh deserve credit for their disciplined performances. But the way our batting has collapsed in this series is a bad sign," said Wasim Akram.—Agency

## Babar Azam Plummeted Out of Top 10 Test Batsmen

LAHORE: Star batsman Babar Azam has ostensibly lost the shine for which he was admired across the world as he has slipped out of the top 10 list in ICC men's Test baters ranking, for the first time in more than four and a half years.

The former captain has dropped to No12 with 712 points after losing three places as he seems to be in a lackluster form.

It can be established through the fact as well that the 29-year-old has not hit a half-century during his last 16 innings in Test format, while he scored 64 runs only across four innings at the home ground in the recently concluded two-match Test series against Bangladesh.

Mohammad Rizwan is the only Pakistani batter re-



taining a spot in top 10 that too on the edge at 10th position.

The third Green Shirts batsman that can be spotted among top 20 batters is Saud Shakil at 20th position. The middle-order batsman has plummeted by seven places from 13. Whereas, Salman Ali Agha moved nine spots up to reach 31 from 40.

On the other hand, after two back-to-back hundreds

achieved in July 2022 at Edgbaston following a century against India.

Len Hutton, Jack Hobbs, and Peter May are the only three English batters with higher career rating among Test batsmen.

Even though Root had several impressive performances in the second Test match against Sri Lanka, Gus Atkinson was the player of the match for his all-round performance.

The ICC said after becoming just the third player in Men's Test history to score a century and claim a five-wicket haul at the hallowed venue, Atkinson moved up 48 spots, into the top 20 for All-Rounders, and into the top 30 for bowlers.—Agency

## PCB Cracks Down on High-Stakes England Series



LAHORE: The Pakistan Cricket Board (PCB) has decided against showing leniency towards players in the lead-up to the series against England.

Following a disappointing performance against Bangladesh, the PCB is tightening its grip on player fitness and performance standards.

The decision comes as part of a broader strategy to address concerns over the team's recent form.

The PCB Chairman, Mohsin Naqvi, was unable to undergo a planned surgery, and the visiting Bangladesh team has departed after a standout performance that has raised alarms within the PCB.

In preparation for the England series, the PCB has

scheduled rigorous fitness tests for players on September 7 and 9 in Lahore.

All cricketers on central contracts will be required to participate, particularly those who missed earlier regional fitness evaluations.

The tests will include a two-kilometre run within eight minutes and additional sprint drills, with stricter criteria in place compared to previous assessments.

The PCB is also planning to announce new central contracts before the series.

However, there will be no increase in contract fees. Instead, player categories will be adjusted based on fitness test results and recent performance, reflecting the board's focus on improving the team's overall standards.—Agency

## Sarfraz Ahmed Breaks Silence on Future After Taking Champions Cup Role

LAHORE: Former Pakistan captain Sarfraz Ahmed has disclosed his future as a player after being named as the mentor of the Dolphins side for the Champions One-Day Cup, which is scheduled to be held in Faisalabad from 12-29 September.

Out of the five mentors announced for the Champions Cup, Sarfraz is the most active Pakistan player. The 37-year-old described this as a great learning opportunity for him and confirmed that he would be available for domestic and international duties.

"This is a great opportunity for me. It's also a chance for me to learn. I will strive to bring forward good play-



ers. Support your players in the Champions Cup."

Sarfraz revealed how he picked his side for the forthcoming competition. "I have selected the team while working closely. We have chosen players from a draft of 150 players.

Despite a few promising moments earlier this year, the Green Shirts are once again facing uncertainty as they prepare for the Asian Champions Trophy in Hulunbuir, China, starting on September 8.

Throughout the year, Pakistan's hockey team showed glimpses of progress. They secured a silver medal at the Sultan Azlan Shah Cup and placed fourth in both the Paris Olympics Qualifiers and the FIH Nations Cup. Yet, inconsistency in coaching and a lack of strategic planning have left the team floundering ahead of the

Despite limited preparation time, as Tahir will only have three days to work with the squad before the tournament kicks off, the PHF saw him as the most convenient option given the circumstances.

The PHF's financial woes have further complicated the team's preparations. The federation even faced challenges in covering travel costs for the China tour, underscoring the financial strain that prevented a long-term deal with Oltmans.

Moreover, key players such as Abdul Rehman Jr, Ahtisham Aslam, and Murtaza Yaqoob are unavailable, as they are committed to European leagues, while Arbaz Ahmed withdrew due to personal reasons.—Agency

Though the parties settled the matter last year, the backlash against the California Gurls singer was intense for giving him a platform.

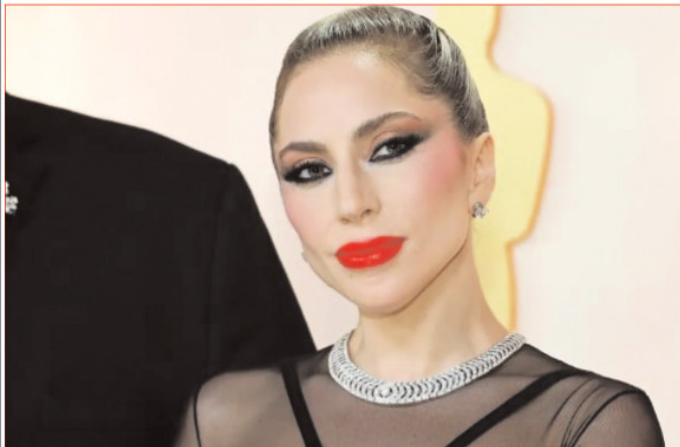

I have reviewed all the files and documents, and there is no mention of the said amount anywhere," the petroleum minister added. Musaddik Malik also refused to comment on the current status of the Iran-Pakistan gas pipeline project. "I will be able to comment after consulting with the Attorney General of Pakistan," the petroleum minister added. Earlier on March 21, Pakistan reaffirmed its commitment to Iran Pakistan gas pipeline project as Foreign Office Spokesperson Mumtaz Zahra Baloch said that it is the sovereign decision of the Pakistani government to move forward on the project. During her weekly news briefing, Mumtaz Zahra Baloch responded to the queries of the media persons regarding US congressional hearing. She made it clear that at this point there is no room for any discussion or waiver from any third party for the construction of the pipeline inside Pakistan's territory. She said Pakistan has also conveyed to the US authorities the importance of this project for its energy security. When asked about the concerns raised at the US congressional hearing over the alleged rigging in the general elections, the spokesperson said some statements made there reflected misunderstanding of Pakistan's domestic situation and electoral laws. She hoped to engage in meaningful discussion with the US to address these misunderstandings.—RT/Agency

## SSGC Disconnects Over 3,000 Illegal Gas Connections In Sindh And Balochistan



KARACHI: The Sui Southern Gas Company Ltd. (SSGC) has intensified its efforts to reduce unaccounted for gas (UFG) by actively targeting gas theft, a persistent issue affecting society. The Security Services and Counter Gas Theft Operations (SS&CGTO) teams, in collaboration with the Customer Relations Department (CRD) and Recovery teams, have been working diligently to curb the rising incidents of gas theft.

In the past week alone, SSGC has made significant progress, disconnecting 3,276 illegal gas connections across its franchise areas in Sindh and Balochistan. In Karachi, the teams removed 2,895 illegal connections, while in Balochistan, 365 illegal connections were cut off. Additionally, 16 illegal connections were disconnected in Upper Sindh. These operations involved raids on both domestic and commercial units suspected of gas theft.

Through extensive surveys, the teams identified high-risk areas for gas theft, conducted raids, and confiscated rubber pipes and other materials used to steal gas from the company's main service line. Following these actions, FIRs were filed against the offenders.—RT

## KCCI Calls On State Bank To Cut Policy Rate By 500 Basis Points

KARACHI: The Karachi Chamber of Commerce & Industry (KCCI) has called on the State Bank of Pakistan (SBP) to reduce the policy rate by 500 basis points, lowering it from 19.5% to 14.5% in the next monetary policy statement. KCCI Chairman Zubair Motiwala and President Iftikhar Ahmed Sheikh emphasized that with inflation dropping to 9.6% in August, its lowest in three years, there is a strong justification for a significant rate cut to stimulate economic growth.

They highlighted that the Large-Scale Manufacturing Index (LSMI) showed marginal growth of just 0.9% in FY24, underlining the negative impact of prolonged high-interest rates. The policy rate reduction, they argued, would provide much-needed relief to the manufacturing sector and boost economic activity by encouraging private sector borrowing and investment.

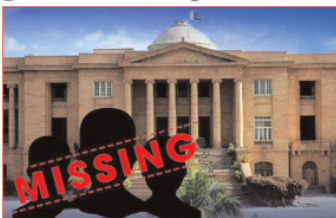
Motiwala noted that Pakistan's real interest rate, currently at 9.9%, is much higher than in neighboring countries, reducing the nation's regional competitiveness. He also pointed out that a 1% reduction in the policy rate could save the government approximately Rs467 billion in debt servicing costs.

Sheikh added that despite a sharp increase in the policy rate from 7% in August 2021 to 22% by May 2023, inflation was not effectively controlled, suggesting that alternative monetary tools should be considered. He further noted that the government's share of total credit has risen significantly, crowding out the private sector. A reduction in the policy rate, he argued, would help rebalance credit distribution towards the private sector.

The KCCI leadership expressed hope that the SBP would announce the recommended rate cut, which would provide essential relief to businesses struggling with the high cost of doing business.—RT

## Sindh High Court Criticizes Missing Persons Reports

KARACHI: The Sindh High Court has expressed dissatisfaction with the reports on the recovery of missing persons.



Justice Naimatullah Phulpoto presided over petitions related to missing persons. The court expressed frustration over the lack of progress and criticized the police officials.

Justice Phulpoto remarked that despite 13 years of JIT meetings, the progress was minimal, with sessions often ending with only tea being served.

He noted that elderly people who have been suffering for years must be curing the authorities.

He emphasized that if the police had worked honestly, the issue of missing persons would have been resolved by now.

He criticized the inability to determine who was responsible for the disappearances and warned that poor performance could lead officials into jail prison.

During the proceedings, Justice Phulpoto reprimanded the DSP of Pakistan Bazaar police station. The court has summoned the head of the JIT for the next hearing and directed effective measures for the recovery of missing citizens, including Syed Arif and Syed Abbas Shah.

The Sindh High Court had also asked for a report from federal government agencies within four weeks and adjourned the case.—RT/Agency

## Suspect in Karsaz Accident Seeks Bail In Court

KARACHI: Natasha Danish, the prime accused in the Karsaz accident case, has filed a bail plea in the local court on Wednesday, media reported.

Natasha has submitted her bail plea through her lawyer. The court has issued notices on bail application to relevant parties. In bail plea, the accused mentioned history of mental health issues and previous treatment from multiple psychiatrists. Natasha's lawyer argued that the charges against her client are bailable and that she should be granted bail considering her mental health condition. The lawyer also submitted medical certificates and records of Natasha's treatment history from private hospital. Separately today, the court granted interim bail to Danish Iqbal, husband of prime accused in the Karsaz accident case. The East court approved Iqbal's bail application against surety bonds of worth Rs. 100,000. ## ANF Discovers NGO Involved In Drug Trafficking In Landhi

## Information Minister Criticizes Absence Of Effective Systems To Counter Misinformation

ISLAMABAD: Information Minister Attallah Tarar on Wednesday lamented the "lack of mechanisms" to control and counter the spread of false information on digital platforms, stating that they cause damage to the country's image and fragile economy.



Addressing an event in Islamabad, the information minister said that in the digital age, verification, and authentication had become "the two most important tools that provided people with a true perspective on what's going on and what the reality is."

"If you look at the brief historical background, as far as newspapers and TV are concerned, you had some form of editorial control," the minister said. "You had systems, training, and people well-equipped to deal with information and how to disseminate it."

"In the digital age, unfortunately, we don't have mechanisms to authenticate and verify information and it causes a lot of damage and losses," Tarar lamented, citing the example of how misinformation could damage Pakistan's fragile economy. "Our economy is very

fragile and one small false news item can cause losses to the image of the country that can't be measured," he said.

Tarar stressed the need to impart training to digital journalists on how to verify and authenticate information online, in a similar vein to their counterparts in other mediums.

"Since I took office, I have advocated that we need to equip our journalists and digital freelancers with proper skills, so they can become ambassadors of this country and contribute towards the image building of this country and protect vulnerable groups," the information minister said.

Continuing his speech, Tarar cited the example of how misinformation affected

marginalised groups, in particular, were vulnerable to the spread of misinformation online, as at present, no mechanisms existed to protect them.

"They are at a loss because there is nobody to protect them and the spread of false information goes a long way in creating trust issues," he said.

Tarar added that besides misinformation, the digital space was being used by terrorists to further their political goals.

"We have been helpless against this issue because certain groups acting against the safety and security of the nation... we have no means of countering them," he said, highlighting that before the recent terrorist attacks in Balochistan, information about them had already spread on social media.

Tarar highlighted an initiative at the Ministry of Information that he dubbed "fact-check," where the ministry will mark information that needs to be verified and "make it go viral" so that it could be authenticated. He added that the platform had existed for two years and was active on all social media

platforms.

The information minister also said that Tech Valley, an organisation partnered with Google, will launch a programme to train journalists on how to verify reports online. Highlighting the wide-spread use of Google software within Pakistan, Tarar said that this training "will help build our society and bridge gaps we have between our communities."

He expected this training to "eradicate religious extremism and hater mongering on certain social media platforms."

"With the right amount of training and focus, we will be able to create an environment in which we will be able to provide harmony among our people," Tarar said, reiterating his ministry's commitment to working with these groups.

"The digital space can be used positively and negatively. With this training, we will not only create a positive image for our country but we will create a safe and secure environment for our people," the minister said.—RT/Agency

## Government Asserts No Nationwide Electricity Load-shedding



ISLAMABAD: Amid heightened scrutiny and ambiguity surrounding the independent power producers (IPPs) the federal government has claimed that no loadshedding is being carried out in the country due to generation shortfall.

Speaking on the National Assembly floor on Wednesday, Federal Law Minister Azam Nazeer Tarar said that distribution companies (DisCos) are carrying out load management in areas based on losses in corresponding feeders.

The minister's remarks come as the incumbent government faced much scrutiny owing to exorbitant electricity bills and hours-long power outages across the country — especially during this year's summer.

Ever since coming to power in February earlier this year, Prime Minister Shehbaz Sharif's administration has faced challenges on multiple fronts with power sector being one of them.

The Centre faced country-wide protests over prolonged loadshedding and sky-high bills throughout the summer. The incumbent rulers have also faced flak on the IPP issue with calls to review

the government agreements with them as the government has admitted that the country has the highest electricity tariffs in the region.

However, Energy Minister Awasi Leghari has said that the nation would receive "good news" regarding the IPPs soon.

Speaking in the lower house of parliament today, Tarar also underscored that feeders with up to 20% losses are exempted from loadshedding.

The minister also said that in the first phase, smart meters will be installed on transformers to keep a check on electricity theft.

Informing the House that Private Power and Infrastructure Board was working on promotion and development of Alternative and Renewable Energy technologies for power generation in line with the government's vision to diversify the energy generation, the lawmaker articulated that as many as 58 alternative and renewable energy based projects were operational which were producing 3,837 megawatts of electricity cumulatively.

Out of these, winds projects amounted to 1,845 megawatts, he added.

Meanwhile, expressing his view on the parliament floor, Minister for Petroleum Musadik Malik lamented the depletion of indigenous gas reserves and said that the incumbent administration was awarding new blocks for oil and gas exploration along with the import of liquefied natural gas (LNG).—RT/Agency

## Finance Minister Pledges Full Government Support To Foreign Investors

ISLAMABAD: Finance Minister Senator Muhammad Aurangzeb assured foreign investors of the government's full support in facilitating their ventures in Pakistan.



In a meeting with a delegation of international investors, led by Chief Executive Officer (CEO) J.P. Morgan Pakistan, Amin Mohammad Khawaja, the finance minister also welcomed their interest in contributing to the country's economic growth, a press statement issued here said.

Senator Muhammad Aurangzeb said Pakistan has made in improving its macroeconomic indicators including the 14 percent rise in exports, the decline in inflation to 9.6 percent (which is 34 months low), and an overall decline in the Current Account deficit.

The finance minister also pointed out the improvement in Pakistan's sovereign credit ratings which reflect a stable and promising economic outlook.

"The country's economic growth is underpinned by robust fiscal discipline, inflation management, and a favorable balance of payments," he stated.

Senator Muhammad Aurangzeb elaborated on the government's ambitious structural reforms agenda, aiming at broadening the tax base, rightsizing of the public sector, privatization drive, and energy sector reforms, to aid overall macroeconomic stability.

The finance minister reaffirmed the government's resolve to carry forward the comprehensive reforms agenda to enhance the efficiency and governance of public institutions.

"These reforms," he noted, "are designed to create a more conducive environment for foreign investment and to ensure the long-term stability of the economy."

He reiterated Pakistan's strong commitment to attracting foreign investments through maintaining a business friendly environment.

On the occasion, the delegation commended the government's efforts to create a business-friendly environment and expressed optimism about the prospects of increased investment flows into Pakistan, the statement added. The discussions covered a range of potential investment areas, including renewable energy, information technology, infrastructure development, and the financial sector.—RT/Agency

## £190m Case: Court Awaits Verdict On Bushra Bibi's Acquittal Plea



RAWALPINDI: An accountability court on Wednesday reserved verdict on Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan's wife Bushra Bibi's acquittal plea in £190 million settlement case.

The incarcerated former premier and his wife are accused of causing billions of rupees loss to the national exchequer in a case also involving a property tycoon.

Accountability Court Judge Nasir Javed Rana will announce the verdict on Bushra's plea tomorrow (Thursday) after the parties in the case concluded their arguments.

The couple was produced at makeshift court room setup in Adiala Jail today to security reasons in view of the hearing, however, cross-examination of the National Accountability Bureau's (NAB) investigation officer was not conducted due to the absence of the PTI founder's lawyer.

Bushra's counsel Usman Riaz Gul gave arguments on her acquittal plea. The anti-corruption watchdog opposed the former first lady's acquittal petition in the case.

Subsequently, the judge declared a request to initiate contempt proceedings against the NAB chairman "ineffective" due to the arguments raised by the prosecution and the defence on the acquittal plea.

The couple had secured post-arrest bail from the accountability court in the same case in early July, however, they remained imprisoned due to the iddat case — also known as the un-Islamic nikah case — at that time.

Later, the duo was acquitted in the iddat case on July 13 but they got arrested in a new Toshakhana reference filed by the anti-graft watchdog.—RT/Agency

## Opposition Alliance Demands APC On Deteriorating Security Situation In Balochistan



ISLAMABAD: The Opposition Grand Alliance — Tehreek-e-Tahafuz-e-Ayeen Pakistan (TTAP) — has called for an All Parties Conference (APC) to address the worsening security situation in Balochistan, expressing deep concern over the province's current state of affairs.

During a press conference in Islamabad on Wednesday, PTI leader Asad Qaiser stated, "Our alliance is seriously concerned about the situation in Balochistan. We will meet with the National Assembly speaker and urge him to take action, including convening an APC on Balochistan."

Qaiser emphasised the need to address the grievances of "our estranged Baloch brothers," noting that despite raising the issue in the assembly, the government has shown little interest. He also lamented Akhtar Mengal's resignation from the National Assembly, calling it "a regrettable development."

He stressed the importance of a serious discussion on Balochistan, warning, "Our enemies are exploiting this situation. We are planning nationwide protests and rallies, including a day of nationwide demonstrations." Latif Khosa criticised the government's economic policies and attempts to amend the Constitution,

which he said have caused widespread public concern. "They don't have the two-thirds majority to amend the Constitution, so they should stop this talk," Khosa said. Khosa also commented on the Mubarak Sani case, "If our demands are not calling the verdict a 'grave mistake' and explaining that it forced them to postpone their rally. 'But our rally on September 8 is final,' he said, adding that the Pakistani people will show their support for Imran Khan.

A committee, headed by Sahibzada Hamid Raza and including Khosa, has been formed to coordinate the APC. "We want to resolve these issues through an APC," Khosa said, adding that the opposition aims to save Pakistan and uphold the rule of law. Mahmood Khan Achakzai echoed Khosa's sentiments, calling it a positive sign that all parties believe in the supremacy of the Constitution. He announced the formation of a committee that will start working immediately to arrange the APC.

## IHC Orders IGP To Submit Detailed Report On Missing Faizan Usman By Sept 10

ISLAMABAD: The Islamabad High Court (IHC) on Wednesday ordered Inspector General of Police (IG) Dr Akbar Nasir Khan to submit a final report in the case of Faizan Usman's alleged abduction in court by September 10.

According to the petition, a copy of which is available with media, filed in the IHC by Usman's father for his recovery, the victim was taken away by men wearing black uniforms and civil dresses without a warrant on July 5.

The petition nominated the state, defence ministry, Federal Investigation Agency (FIA), Islamabad IG, and the station house officer (SHO) of the Shehzad Town Police Station as respondents.

In a court order given yesterday, sent by media, the Pakistan Telecommunications Authority, and the Counter-Terrorism Department (CTD) for more information on the disappearance. "The court enquired whether the charge (for the abduction) was on intelligence agency, so did you inquire anything from them?" Justice Sattar asked.

The police chief said the ministry of defence had been contacted in this regard. "Contact the intelligence agency, they don't come under the defence ministry but are subordinate to the prime minister," Justice Sattar said.—RT/Agency

## Fazl: Political Solutions Needed For Terrorism, Not Military Action

ISLAMABAD: Maulana Fazlur Rehman, leader of Jamiat Ulema-e-Islam-Fazl (JUI-F), has called for addressing terrorism through political measures rather than military force.



Speaking in the National Assembly, Rehman emphasised that blaming Afghanistan for Pakistan's security issues was misguided.

He urged the government to focus on its responsibilities along the borders.

Maulana Fazlur Rehman highlighted the recent attacks on Pakistan's military and institutions, stating that it is the parliament's duty to take these issues seriously.

He cautioned that using force to resolve such conflicts could escalate tensions and jeopardise national security.

He stressed upon the need for experienced political leaders to be at the forefront of resolving these challenges, rather than sidelining them in favour of less seasoned, more emotional figures.

The JUI-F chief advocated for empowering political leaders to manage these issues and criticised

the government's approach of centralising authority. "He argued that political engagement is more effective than military intervention in addressing the country's complex problems.

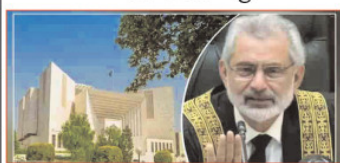
He also expressed concern over the situation in Balochistan, where unrest has reached a point where displaying the national flag and singing the national anthem have become contentious.

He warned that if these issues are not properly managed, they could worsen, further destabilising the region.

In his remarks, the JUI-F chief noted that Pakistan has become a battleground for proxy wars involving major international powers, complicating efforts to advance infrastructure projects like the China-Pakistan Economic Corridor (CPEC).

He called on the parliament and political leaders to engage directly with local issues to prevent further deterioration. Rehman also addressed the ongoing issue of missing persons, asserting that the government has a duty to inform families about the status of their relatives. He expressed concern that the actions taken in response to incidents like the Army Public School attack have eroded public trust, creating resentment that could persist for generations.—RT/Agency

## CJP Suggests For Dismissal Of Officials Involved In Unauthorized Tree Cutting



ISLAMABAD: Chief Justice of Pakistan Qazi Faez Isa remarked that officers and employees involved in deforestation must be sacked.

The three-member bench headed by CJP Qazi Isa heard a case pertaining to illegal cutting of precious Shisham trees (Indian rosewood) in Mardan. The Supreme Court has dismissed the appeal by upholding dismissal and imposed fines on a regional officer of the forest department, Meher Badshah. The SC has summoned details from the Khyber Pakhtunkhwa Government about the five year budget of the Department of Forest and illegal and legal cutting of trees by employees of the Forest Department.—RT/Agency
