## SC Ruling Favors Government In NAB Amendments Case, Sets Back For Imran

ISLAMABAD: In a major victory for the incumbent government, the Supreme Court on Friday accepted intra-court appeals filed against the September 15, 2023, majority judgement striking down the amendments to the National Accountability Ordinance (NAO).



A larger bench headed by Chief Justice of Pakistan (CJP) Qazi Faiz Isa and comprising Justice Aminuddin, Justice Jamal Khan Mandukhel, Justice Athar Minallah and Justice Hasan Azhar Rizvi announced the unanimous verdict.

It modified sections 2, 4, 5, 6, 25 and 26 of the NAB laws, however, 9 out of 10 amendments were declared "null and void" by the CJP. The five-member bench on the PTI founder's petition filed in June 2022.

The five-member bench reserved the verdict on June 6 on multiple appeals against the apex court's September 15 verdict which was announced by then-CJP Umar Ata Bandial.

Referred to the September 15 ruling, the court today pointed out that the Supreme Court (Practice and Procedure) Act, 2023—which required that a plea must be heard by "not less than five judges of the SC"—was enacted while Khan's petition was pending adjudication.

In the intra-party appeals, the top anti-graft body and the PTI founder were made respondents.

The top court noted that the petition challenging the amendments made to the Ordinance was not heard and decided in accordance with the SC (Practice and Procedure) Act—hereinafter referred to as the "Act".

The amendments—National Accountability (Second Amendment) Act 2022—were passed in a joint sitting of the parliament in April 2022 during the Pakistan Democratic Movement (PDM)-led government which came into power after ousting ex-premier Khan via a no-trust move in 2022.

"We allow these appeals by setting aside the impugned judgement," reads the SC order.—RT/Agency

## Naem Warns Of Consequences If Rawalpindi Agreement Is Not Enforced

GUJRANWALA: Jamaat-e-Islami (JI) chief Hafiz Naemur Rehman has warned that the government will be held responsible if the Rawalpindi agreement is not implemented within 16 days.



Speaking at a workers' convention and membership drive inauguration in Gujranwala on Friday, Hafiz Naem said, "The public will no longer bear the burden of government luxuries and Independent Power Producers (IPPs)".

He criticised past governments, including those led by PML-N, PPP, and PTI, for protecting IPPs, stating that "they are all equally complicit in this looting."

Consultations are ongoing with traders for a potential three-day nationwide strike, which would see the entire country shut down, he added.

The JI leader also announced the expansion of the "Haq Do Awam Ke" (Give People Their Rights) campaign, with a target of 5 million new members. "We have launched membership campaigns nationwide, and we are receiving overwhelming support. Our doors are open to anyone willing to fight for public rights and the establishment of an Islamic system," he said.

Hafiz Naem condemned electricity utility costs, noting increased electricity tariffs, gas prices, and taxes on petrol.

"When asked about various taxes in electricity bills, the government has no answers. How is there a TV tax in a mosque's electricity bill?" He accused the government of following IMF orders and warned that if the public doesn't resist, "they will continue looting the nation."

## Khawaja Asif Links Faiz Hameed's Issue With Imran

ISLAMABAD: Defence Minister Khawaja Asif Friday claimed matter of Lt. General (retired) Faiz Hameed is 'interlinked' with Pakistan Tehreek-e-Insaf (PTI) founder.



In his exclusive talk with media, Khawaja Asif said, during premiership tenure of Imran Khan, his [Faiz Hameed] were being implemented.

He said like 1965, today, Pakistan is also facing visible and hidden enemies. Referring to the situation of Balochistan, Khawaja Asif supported provision of special powers to the state institutions.

Expressing no information about PML-N's pact with 'anyone', Khawaja Asif said PTI founder is seeing dreams in Adiala jail.

The senior PML-N stalwart also claimed that during PTI government tenure, political leaders of opposition were booked in NAB cases.—RT/Agency

## COAS Urges To Prevent Political Dissent From Escalating Into Hatred

RAWALPINDI: Army Chief General Asim Muneer has advised against turning differences in political viewpoints into hatred, reiterating that the nation will not let "nefarious objectives" aimed at weakening national harmony to succeed.



He stated this while addressing the Defence and Martyrs Day ceremony at General Headquarters (GHQ) in Rawalpindi on Friday.

The strong bond between the people and the military is a guarantor of the country's enemies' defeat, the army chief said adding that the elements who create a rift between the army and the forces will have to face defeat as always.

The chief of army staff (COAS) said the martyrs' sacrifices for the country against terrorists have brought stability to the country and strengthened the national security.

Speaking about the newly launched Operation Azm-e-Istehkam, the army chief said it is not a new counterterrorism drive but rather a part of the National Action Plan (NAP) wherein strategy

"The relation between the armed forces and the nation is of heart," the COAS said. "The nation has always backed the army, be it the rescue works in the events of natural disasters, foreign hostilities or war against terrorism."

Furthermore, the five-member bench's judgement today also pointed out that last year's ruling did not demonstrate how the amendments violated or infringed any of the fundamental rights provisioned under Articles 14, 23 and 25 of the Constitution.

The army chief also asked to protect the rights of minorities, granted in the Constitution of Pakistan, by overcoming religious intolerance. "Quaid-e-Azam's principles of faith and unity are a lighthouse for the nation," he said.

"Petition and the impugned judgement failed to establish that the Amendments were unconstitutional, nor have we been so persuaded in this regard," the apex court noted, adding that the larger bench was persuaded by Khan and learned Senior Advocate Khawaja Haris Ahmed that the amendments violated the Constitution.

## Imran Threatens Legal Action Against IO And NAB Chief: 'We Will Not Spare You'



RAWALPINDI: Incarcerated Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan on Friday threatened the National Accountability Bureau (NAB) chairman and investigation officer (IO) with legal action.

"My spouse [Bushra Bibi] is facing imprisonment due to cases concocted by you," the deposed prime minister told NAB IO Mohsin Haroon while pointing a finger at him during a hearing of a new Toshakhana reference filed against the detained couple.

On September 2, an accountability court in Rawalpindi extended the judicial remand of the PTI founder and his wife in a new Toshakhana reference.

The new reference pertains to a case related to a jewellery set gifted to former first lady Bushra by the Saudi crown prince when Imran was the prime minister of the country from 2018 to 2022.

"I will take you both [IO and NAB chairman] to court [over fabricated cases]," the PTI founder added.

Notably, the anti-graft bureau had informed the media about threats made by the former premier at least four times.

This is not the first time Imran Khan has hurled threats at public officials with the most prominent being the case of Judge Zeba Chaudry.

Just months after his ouster in April 2022, the PTI founder gave a fiery speech directed towards Islamabad's top police officials and judge Chaudry threatening not to "spare" them and file cases against them for "torturing" his party leader Shahbaz Gill.

Meanwhile, the NAB prosecution team sought adjournment of the hearing citing the absence of prosecutor Umar Majeed. "[The

Supreme Court has given a verdict on NAB amendments case, and we have to review it," they added.

Subsequently, the accountability court adjourned the hearing till September 9 at the prosecution team's request.

Speaking to journalists after the hearing, Khan—without giving names—claimed that "some individuals" were plotting within the party against Khyber Pakhtunkhwa (KP) Chief Minister Ali Amin Gandapur.

He asked the party members not to "undermine Gandapur as I stand by him", saying that this was not the time for differences.

"Those plotting against Ali Amin Gandapur should not complain me of not getting [election] tickets in future," the PTI founder added.—RT/Agency

## Shibli Faraz: NAB Amendment Issue To Be Addressed Publicly



ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) senator Shibli Faraz asserted that today's decision was NRO 2 and announced to take up the matter in public.

He gave a response to the Supreme Court judgment that restored NAB amendments, accepted the appeals of the incumbent government and gave a setback to PTI founder Imran Khan.

Opposition leader berated the government, saying they were not the real representatives of the public instead selected on Form-47.

Faraz lamented that the incumbent government formed a fake parliament that protected thieves and violators instead of making legislation in favor of the public.

## Lawyers Assess SC Ruling On NAB Amendments



ISLAMABAD: In a landmark decision on Friday, the Supreme Court accepted the intra-court appeals filed by the federal and provincial governments against the September 15, 2023 majority judgement in the National Accountability Bureau (NAB) amendments case.

A larger bench, headed by Chief Justice of Pakistan (CJP) Qazi Faiz Isa, ruled unanimously against the ex-CJP Umar Ata Bandial-led bench's verdict striking down the amendments to the National Accountability Ordinance (NAO).

The five-member bench reserved the verdict on June 6 on multiple appeals against the apex court's September 15 verdict which was announced by Bandial.

Reacting to the SC verdict, Barrister Asad Rahim Khan said: "Yet another strange and barely reasoned decision by this

chief justice. That NAB had become an instrument of coercion and required reforming was plain for all to see.

"But the PDM regime's solution — to gut the entire organisation via a set of person-specific amendments — was laughably illegal; a small segment of the political class getting rid of cases against itself.

Barrister Khan said that the "act of desperation has now been legalised by the court" on the basis that the public's fundamental rights haven't been affected.

"This is Nero playing the lyre: by the same metric, the Supreme Court should have decided to the contrary when it came to the National Reconciliation Ordinance — another exercise in which under-mocratic forces had to launder politicians for cobbling together a government. "These are bad decisions making for bad jurisprudence — the kind bereft of law, precedent, or serving the public interest," he added.—RT/Agency

## ANF Seizes 'Ice' And Ecstasy Tablets From Drug Traffickers Near Quetta University

QUETTA: The Anti-Narcotics Force (ANF) arrested two drug dealers near a major university in Quetta, seizing 2 kilograms of crystal meth (commonly known as ice) and 40 ecstasy pills.

The arrests were part of an ongoing nationwide crackdown on drug peddlers targeting educational institutions. According to ANF officials, the first suspect, a resident of Pishin, was apprehended near a hotel close to the university, while the second suspect, also from Pishin, was arrested in a residential area adjacent to the university.

Both suspects admitted during interrogation that they had been selling drugs to university students. The arrests are part of a broader ANF operation aimed at curbing drug activity around educational institutions.

"We are utilising all resources to bring those who are destroying the future of our youth to justice," an ANF spokesperson said, calling



for greater cooperation from the public to protect students. Both suspects have been charged under the Anti-Narcotics Act, and further investigations are underway.

Two weeks ago, the Anti-Narcotics Force (ANF) in another raid seized more than two tons of Hashish and arrested four drug smugglers in Quetta. According to an ANF spokesman, a major operation against drug smuggling was carried out on Western Bypass near Mengalabad in Quetta. "Drugs were recovered from a truck," he said, adding that a small vehicle was also caught during the operation in which two suspects were getting the drugs-laden truck route cleared as facilitators.—RT/Agency

## 8 police officials including DSP Ghulam Shabbir injured during Karachi anti-encroachment operation

KARACHI: Under the instructions of Deputy Commissioner Malir Irfan Salam Mirwani, and led by Assistant Commissioner Airport and SSP Malir Kashif Aftab Abbasi, an anti-encroachment operation was conducted to vacate government land near Gulshan-e-Rumi. The operation, which involved heavy machinery, encountered significant resistance from the encroachment mafia, who fired at and pelted stones at the revenue

staff and police. The area turned into a battleground during the operation. As a result, eight police officers, including DSP Memon Goth Ghulam Shabbir Jamali, sustained injuries and were transferred to the hospital. During the operation, makeshift huts and permanent structures were demolished, and over 22 acres of government land, valued at more than 10 billion rupees, were reclaimed. A case has been registered at the Malir Cantt Police Station. SP Saeed Rind in-

formed journalists that the encroachers fired at the revenue officials and police during the operation, leading to the injuries of DSP Ghulam Shabbir and seven other officers. Deputy Commissioner Malir Irfan Salam also confirmed that the operation, which was conducted under the orders of higher authorities, successfully reclaimed the land. He emphasized that the anti-encroachment efforts will continue in various areas of Malir.

## Karachi Police Suspend More Officers For Social Media Use During Duty Hours

KARACHI: The Karachi Police have intensified their crackdown on officers using social media while on duty, suspending 12 more officers, including three women, for violating departmental protocols, media reported on Friday.

The total number of suspended officers now stands at 18, following the suspension of six officers the previous day. Additional IG Karachi took action following directives from Inspector General Sindh Police, Ghulam Nabi Memon, who called for swift measures against

officers recording and posting TikTok videos during duty hours.

IG Memon emphasized the need for strict departmental and legal action against officers involved in creating inappropriate content, such as double meaning voice-overs and vulgar videos while in uniform. He reiterated that any officer tarnishing the department's reputation would face immediate consequences, and uploading videos in uniform on any platform is now strictly prohibited for both male and female officers.—RT/Agency

The petitioner suggested that the Rs 2 billion allocated for the vehicles should instead be spent on public welfare projects.—RT/Agency

## An elite gets away with murder again

In Pakistan, where justice is often a privilege rather than a right, the recent Karsaz traffic accident case underscores the glaring divide between the affluent and the impoverished. Natasha Danish, the prime suspect in this tragic incident, has been granted bail under circumstances that highlight the systemic inequalities entrenched in the country's legal system. Danish, who was driving under the influence of methamphetamine, was involved in an accident that claimed the lives of a young woman and her father.

The core issue at hand is not just the accident itself, but the aftermath that reveals a deeper injustice. The victims' family, reportedly com-

pelled by financial strains and societal pressures, settled out of court. They issued an affidavit declaring their forgiveness and consenting to the



accused's bail, citing a religious motive and insisting they were under no duress. This settlement effectively undermines the pursuit of justice, reducing it to a transaction rather than a measure of accountability.

The disparity in how justice is administered between the rich and the poor is starkly apparent here. While Natasha Danish can afford legal

representation and bail, the victims' family, struggling with their loss and likely facing economic hardship, finds themselves in a position where out-of-court settlements become a necessary means of survival. This scenario highlights a disturbing trend where the wealthy evade substantial consequences for their actions, while the impoverished are left to navigate a legal labyrinth that favors the elite.

In a society where justice becomes a luxury reserved for the rich, the integrity of the legal system is severely compromised. Until reforms address these deep-seated inequalities, the judicial process will remain a tool that perpetuates injustice rather than dispenses it.

## Heirs Of Karsaz Accident Victims Pardon Suspect, Bail Granted

## PDMA Sindh Urges Coordinated Flood Response Efforts

KARACHI: On September 6, 2024, Imdad Hussain Siddiqi, Director of Operations at the Provincial Disaster Management Authority (PDMA) Sindh, led a crucial meeting with humanitarian stakeholders to address the extensive damage caused by recent floods in Sindh.



The meeting, held at the PDMA Sindh conference hall, brought together representatives from UN agencies and various international and national NGOs, including UNHCR, UNICEF, CESVI, ACTED, WFP, WHO, IRC, the Aga Khan Agency for Habitat Pakistan, UN FAO, IMC, Hands, FRPD, IRADO, and others.

Siddiqi emphasized the need for coordinated efforts across the flood-affected districts, which include Mirpurkhas, Sanghar, Badin, Matiari, Khairpur, Qambar Shahdadkot, Sajawal, Dadu, Jacobabad, and Umerkot. The meeting focused on urgent issues in health, education, water, sanitation, and dewatering.

He highlighted the severe impact on Union Councils and the critical need for dewatering to address stagnant water affecting schools and health facilities. Since July 1, 2024, the

floods have caused 73 fatalities, 153 injuries, the loss of 932 livestock, and significant damage to homes and crops. Additionally, 141,601 people have been displaced, with 163 relief camps and 40 medical camps established. The floods have damaged 327 partially and 198 fully destroyed houses.

Relief efforts have included vaccinating 6,906,302 animals, evacuating 5,085 individuals, and supplying 229 heavy-duty dewatering pumps to District Disaster Management Authorities (DDMAs). Relief items, including tents, tarpaulin sheets, mosquito nets, blankets, and hygiene kits, have been distributed from warehouses in Karachi, Jamshoro, and Sukkur.

Siddiqi also reported on the current flood situation at the Gudu, Sukkur, and Kotri barrages, noting a medium flood at Kotri. He called for innovative solutions, such as sky-lightening, to mitigate future casualties.

The meeting concluded with a call for a collaborative approach involving DDMAs and District Commissioners to address the needs of affected populations in the ten priority districts. The provincial heads of UN agencies, INGOs, and national NGOs discussed health, education, and water and sanitation issues in the flood-hit areas. Deputy Director Operations Mr. Shayan Shah suggested that all work be carried out with the consent of District Commissioners in the respective sectors.—RT

## K-Electric Removes 800 Illegal Connections In Surjani Town And Korangi



KARACHI: K-Electric, in collaboration with law enforcement, removed 800 illegal electricity connections (kundas) weighing over 750kg during anti-theft operations in Surjani Town and Korangi Industrial Area. In Surjani, 750 kundas weighing over 650kg were removed, while in Korangi, 50 kundas weighing 100kg were dismantled. These areas, including North Karachi and parts of Korangi, were stealing around 10,000 units of electricity daily. K-Electric emphasized that such operations aim to reduce power theft, prevent infrastructure damage, and enhance community safety. The utility urged local leaders and residents to support efforts to curb electricity theft and ensure reliable power supply.—RT/Agency

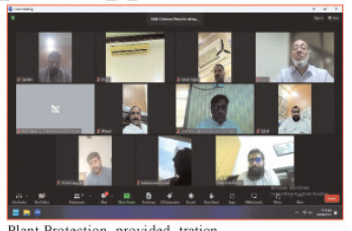
## Pakistan Navy Inducts Advanced Warships In Ceremony

## NA Passes 'Peaceful Assembly' Bill Following Senate Approval Despite Opposition Protests

ISLAMABAD: Following the approval from the Senate, the National Assembly (NA) on Friday passed the "Peaceful Assembly and Public Order Bill, 2024", proposing up to three-year imprisonment for organising unauthorised rallies in Islamabad.



The bill, introduced by Pakistan Muslim League-Nawaz (PML-N) senior leader Danyal Chaudhary, aims to regulate public gatherings in the federal capital and ensure they do not disrupt public order.

Speaking on the floor of the lower house of parliament, Minister for Law and Justice Azam Nazeer Tarrar said that the purpose of the bill is to maintain peace during public assemblies and processions.

He dismissed the opposition's concerns, saying that the increasing number of demonstrations in the federal capital has caused significant inconvenience to citizens.

"The bill seeks to address these challenges while preserving the right to peaceful assembly," the federal minister added.

Despite opposition from lawmakers of the Pakistan Tehreek-e-Insaf (PTI) and the Sunni Ittehad Council (SIC), the peaceful assembly was passed by a majority vote.

With approval from both houses of parliament, the bill will now be sent to President Asif Ali Zardari for final endorsement to become law.

The new bill empowers the district magistrate to regulate and ban public assemblies in the federal capital, proposing a punishment of up to three years or/and an unspecified fine to the members of an 'unlawful assembly'.

Meanwhile, it also proposed that repeat offenders will be liable to imprisonment for a term that may extend to 10 years.

As per a report published in media, the bill bounds the event coordinator of an assembly within the ICT, if: (a) the assembly poses a risk to national security or public safety; (b) there are credible reports from law-enforcement agencies indicating a substantial risk of violence or public disorder; (c) the assembly would significantly disrupt the daily activities of the community, impede the movement of people and goods, or infringe upon fundamental rights of citizens with regard to freedom of trade, business or profession guaranteed under Article 18 of the Constitution; or (d) another procession or assembly is already ongoing within the ICT, and the additional assembly would increase disruptions or pose additional security risks.

The bill says the ban on assembly would remain in force for the duration specified by the district magistrate, which may be extended if the conditions necessitating the ban persist.

"An officer-in-charge of a police station, on the instruction of the district magistrate, may command any assembly likely to disturb the public peace to disperse. It shall then be the duty of the members of such an assembly to comply and disperse accordingly," it reads.—RT/Agency

The law also seeks to empower the government to designate a specific area of the Islamabad Capital Territory (ICT) as a red zone or high-security zone, thereby prohibiting all types of assemblies in that area.

Likewise, according to it, a district magistrate would not permit any assembly in any area other than the defined, designated area and the assembly would proceed and take place at the specified locality or route, in the manner and during the times mentioned in the permission.

Whereas, the bill says a district magistrate would have the authority to impose a ban on any assembly within the ICT, if: (a) the assembly poses a risk to national security or public safety; (b) there are credible reports from law-enforcement agencies indicating a substantial risk of violence or public disorder; (c) the assembly would significantly disrupt the daily activities of the community, impede the movement of people and goods, or infringe upon fundamental rights of citizens with regard to freedom of trade, business or profession guaranteed under Article 18 of the Constitution; or (d) another procession or assembly is already ongoing within the ICT, and the additional assembly would increase disruptions or pose additional security risks.

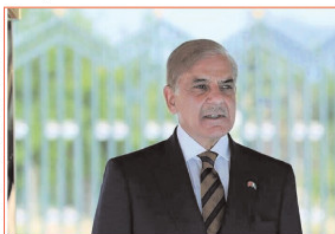

## PTI Seeks Legal Relief For Imran Following SC Decision On NAB Amendments

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) Chairman Barrister Gohar Khan on Friday hoped for legal relief for party founder Imran Khan, saying that major cases against him will no longer fall in the National Accountability Bureau's (NAB) jurisdiction.



Gohar made these comments after Supreme Court's decision to accept intra-court appeals filed against the September 15, 2023, majority judgement striking down the amendments to the National Accountability Ordinance (NAO).

Speaking to media after the verdict, the chairman said that the Toshakhana case and Al-Qadir Trust case do not fall in the anti-graft body's jurisdiction anymore. He added that the ₹190 million case should be settled on merit.

"The ₹190 million was also decided by the cabinet [...] and under the new amendments, the NAB law will not apply to the decisions of the cabinet," he stressed.

The PTI chief said the unanimous verdict has benefited Khan in a way that the Toshakhana case — which is worth Rs30-40

million — can no longer proceed.

Gohar further said that the ₹190 million can't be proceeded as well as it does not involve personal interest, adding that the top court has issued a verdict.

Earlier today, a five-member bench of the SC, headed by Chief Justice of Pakistan (CJP) Qazi Faiz Isa, accepted the intra-court appeals filed by the federal and provincial governments against the September 15 judgement.

Announcing the verdict today, the apex court remarked that the PTI founder could not prove that NAB amendments were unconstitutional. The five-member bench reserved the verdict on June 6 on multiple appeals against the apex court's September 15 verdict which was announced by then-CJP Umar Ata Bandial. The majority judgement had struck down some amendments made to the National Accountability Ordinance (NAO), 1999.

The amendments — National Accountability (Second Amendment) Act 2022 — were passed in a joint sitting of the parliament in April 2022 during the Pakistan Democratic Movement (PDM)-led government which came into power after ousting ex-prime minister Khan via a no-trust move in 2022. It modified sections 2, 4, 5, 6, 25 and 26 of the NAB laws, howsoever, 9 out of 10 amendments were declared "null and void" by the CJP Bandial-led bench on the PTI founder's petition filed in June 2022.—RT/Agency

## LHC Nullifies Appointment Of Nadra Chairman

LAHORE: The Lahore High Court (LHC) directed the removal of National Database and Registration Authority (Nadra) Chairman Lt Gen Munir Afsar on Friday, declaring his appointment null and void.



A citizen, Ashba Kamran, had challenged the appointment of Afsar as the chairman in a petition, which was approved by the LHC.

Directing for the chairman's removal, Justice Asim Hafeez gave a reserved verdict on Kamran's plea.

The illegality committed by way of an unauthorised appointment, by the appointing authority, cannot be concealed, Justice Hafeez said.

Hence, the judge in his remarks maintained, the appointment was "declared without requisite 'authority of law'".

He also directed to send a copy of the order to the federal cabinet, Ministry of Interior and all the departments concerned.

It was contended in the petition that the caretaker

government had approved the appointment of a serving army officer by amending the Nadra Ordinance. The caretaker government cannot interfere in permanent policy matters, it argued.

The petition pleaded that the high court should quash the Nadra amendment rules and declare appointment of the serviceman as Nadra chairman invalid media — in its report quoting sources on August 30, 2023 — said that the interim federal cabinet had approved the rules for the appointment of the Nadra chairman, which opened doors to the service-

men to be deputed as the head of the public institution. Credible sources had told media that the summary received by the Cabinet Division from the Ministry of Interior, in which filling the extraordinary position of NADRA chairman on a deputation or secondment basis had been clearly approved for inclusion in the new rules.

Earlier, the Nadra Ordinance clearly stated that only an independent person could be appointed to this post, which meant that no government official, retired officer or secretary could be given this position.—RT/Agency

## ECP Rejects PTI Request For Delay In Intra-Party Polls Hearing

ISLAMABAD: The Election Commission of Pakistan (ECP) on Friday dismissed the Pakistan Tehreek-e-Insaf's (PTI) pleas seeking deferment of the hearing of the case regarding its intra-party polls till the Supreme Court provides clarification on its July 12 ruling on the reserved seats matter.



In its decision, the ECP maintained that the PTI had already delayed the issue of intra-party polls a lot and it wouldn't be appropriate to defer the matter any further.

The ruling, reserved on August 27, was announced by the electoral body's three-member bench comprising Nisar Ahmed Durrani, Shah Muhammad Jatoi and Justice (ret'd) Ikram Ullah.

The development comes as the Imran Khan-founded party had filed a plea in the ECP seeking a delay in hearing of the intra-party elections issue and had also challenged its jurisdiction over the matter.

It is to be noted that the government body had taken up the matter after the apex court's full bench declared the party eligible for the allocation of reserved seats.

The months-long intra-party polls saga dates back to last year when the ECP revoked the party's bat symbol over unlawful elections within the party.

The PTI had then held another intra-party elections in March this year — which too were challenged in the electoral body.

Stressing that registered political parties are obligated to elect their officials at the federal and local levels, ECP's today's verdict says that arguments in the case regarding PTI's intra-party polls will be taken up on September 18.

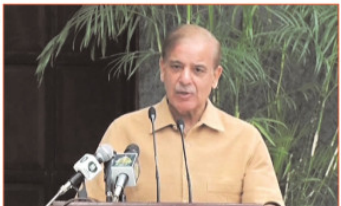
The ruling also pointed out that the former ruling party's own members had filed complaints with the commission on intra-party elections. Rejecting the former

ruling party's plea challenging its jurisdiction, the electoral body said that it is bound to verify the documents submitted by a party under Section 208 of the Elections Act.

The commission is bound to look into the matter before issuing the certificate to the party and is also responsible for seeing whether the intra-party elections have been conducted in accordance with the law and the party constitution or not, read the order issued by the three-member bench.

On the party's complaint regarding the seizure of records and computers by the Federal Investigation Agency, the ECP directed the former ruling party to approach the relevant forum for the return of said items.—RT/Agency

## Government Eliminates Vacant Posts And Bans New Purchases



ISLAMABAD: The federal government, while implementing austerity measures, has eliminated all vacant posts that have remained unfilled for the past three years, media reported on Friday.

An official notification has been issued by the Ministry of Finance detailing the cuts in expenditure, which also include a ban on creating new positions across all departments of government.

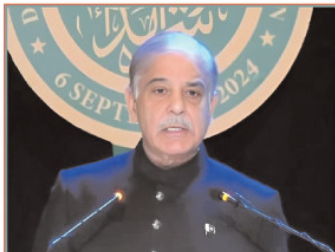
In a move to reduce unnecessary government ex-

pense, the notification further stated that the government has imposed a ban on the purchase of all types of vehicles, machinery, and equipment adding that the citizens seeking medical treatment abroad will no longer be able to do so at the government's expense.

In an additional measure to cut government expense, non-essential foreign travel funded by the government has also been prohibited.—RT/Agency

## PM Calls For Complete Eradication Of Fitna Al-Khawarij

ISLAMABAD: Prime Minister Shehbaz Sharif on Friday vowed to continue operations till the total elimination of terrorism as Chief of Army Staff (COAS) General Sayed Asim Munir stressed that political differences must not turn into hatred for the sake of "national unity."



The prime minister and army chief were speaking at the Defense Day ceremony held at the General Headquarters in Rawalpindi.
