Govt Racing To Restore PIA's UK Flights

LONDON: Deputy Prime Minister and Foreign Minister Ishaq Dar said on Saturday that they are making efforts to resume flights to and from the United Kingdom as soon as possible as the aviation services between the two countries remain suspended for over four years.

"We have made every effort, even we changed the laws as per the latest requirements of the Aviation Authority of UK to solve the issue of resumption of PIA flights," the deputy prime minister, who is currently visiting Britain, said while addressing the Pakistani diaspora there.

PIA flights to Europe and the UK were suspended after the European Union's Aviation Safety Agency (EASA) revoked the national carrier's authorisation to fly to the bloc in 2020 in the aftermath of a fake pilot licence scandal in Pakistan.

The issue resulted in the grounding of 262 of Pakistan's 860 pilots, including 141 of PIA's 434, whose licences were termed "dubious" by the then aviation minister Ghulam Sarwar Khan.



The deputy prime minister, while addressing the event, said that an "irresponsible statement" of a minister from the former minister of the Pakistan Tehreek-e-Insaf (PTI)-led government grounded all aircraft of the country in Europe, UK and the Western world.

He said the government was taking two more actions on privatisation of the Pakistan International Airlines (PIA) and outsourcing of Islamabad International Airport.

Dar went on to say that the process was moving on the fast track, hoping that it might be completed by the middle of October.

He pointed out that Pakistan attached high importance to the long-standing

partnership with the UK and the real pivot of the bilateral relationship was Pakistani diaspora.

Later, while addressing the press conference in London, the deputy PM further said that discussions on the resumption of PIA flight operations were held with the British authorities while talks with the European Union were also underway.

"We are determined to comply with the international standards in the aviation sector. All our efforts are being made for the resumption of services," he added. It may be noted that Deputy PM Dar had held meetings with UK officials including his British counterpart Angela Rayner, on the sidelines of his visit.—RT/Agency

Govt In Talks To Slash Power Tariffs Amid Soaring Costs

ISLAMABAD: The coalition government led by the PML-N is renegotiating contracts with independent power producers (IPPs) to rein in "unsustainable" electricity tariffs, Energy Minister Awaiz Leghari said as households and businesses buckle under soaring energy costs.

Rising power tariffs have stirred social unrest and shuttered industries in the \$350 billion economy, which has contracted twice in recent years as inflation hit record highs.

"The existing price structure of power in this country is not sustainable," Awaiz Leghari, the federal minister heading Power Division, told Reuters in an interview on Friday.



He said discussions were underway between power producers and the government because "there is a clear understanding on both sides that the status quo can't be maintained."

Leghari stressed that all stakeholders would have to "give in to a certain point" — though without compromising completely on business sustainability — and this would have to be done "as soon as possible".

Faced with chronic shortages a decade ago, Pakistan approved dozens of private projects by the IPPs, financed mostly by foreign lenders. The incentivised deals included high guaranteed returns and commitments to even pay for unused

power.

However, a sustained economic crisis has slashed power consumption, leaving the country with excess capacity that it needs to pay for.

Short of funds, the government has built those fixed costs and capacity payments into consumer bills, sparking protests by domestic users and industrial associations.

Four sources in the power sector told Reuters changes to contracts demanded included slashing guaranteed returns, capping dollar rates and moving away from paying for unused power. The sources requested anonymity as they were not authorised to speak to the media. Energy sector viability was the focus of a critical staff level

pact in May with the International Monetary Fund (IMF) for a \$7 billion bailout. The IMF's staff report stressed the need to revisit power deals. Pakistan has already initiated talks on repurchasing power sector debt owed to China as well as negotiations on structural reforms, but progress has been slow. Pakistan has also committed to stop power sector subsidies. Leghari said current rates were not affordable for domestic or commercial consumers and this was hurting growth because power prices were no longer regionally competitive, putting critical exports at a disadvantage. He said the aim was to bring tariffs down to 9 US cents per unit for commercial users from about 28 cents currently.—RT/Agency

Qureshi Vows Loyalty To Imran, Won't Consider Exit

LAHORE: Pakistan Tehreek-e-Insaf Vice-Chairman and former foreign minister Shah Mahmood Qureshi has stated that he is committed to Imran Khan and would not consider leaving the party.

Shah Mahmood Qureshi appeared before the court during the hearing of the May 9 vandalism cases at the Anti-Terrorism Court (ATC) Lahore.

He mentioned that he was not even in Punjab when the cases were filed and was arrested 14 months later. Upon his release, he was immediately re-arrested in connection with the May 9 cases.

Qureshi said that as Imran Khan's deputy, he could not even think of abandoning the party.

He criticised the authorities for fearing his presence into the public. He alleged that the sudden rise in number of cases, allegedly 55 cases, against him was an attempt to intimidate him, despite his 40 years in politics without a single case.

He questioned why arguments were not being presented in court by the prosecution, and accused the authorities of intentionally delaying the process. He urged the court to pass judgment if they believed he was guilty.

In an informal conversation with journalists after the court session, Qureshi called on PTI's ideological workers to attend the upcoming rally. He reminded that despite numerous challenges, the nation made correct decisions on Feb 8.

When asked about the proposed judicial package and increasing the number of judges, Qureshi criticised the bills as attempts to undermine parliament. He suggested that the details of the bills should be presented in front of the public.

Regarding the silence of PTI President Chaudhry Parvez Elahi, Qureshi explained that they were together in Adiala Jail and confirmed that Elahi was indeed unwell.

In response to queries about his alleged connections to attend the Establishment, Qureshi questioned why he would be in jail if he was associated with them.

He criticised the internal party campaign against him and challenged anyone to ask Imran Khan who else stood with him from the core cabinet other than himself.—RT/Agency



RAWALPINDI: Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan on Saturday sought acquittal from the £190 million case after the Supreme Court's verdict in the NAB amendments case.

During the hearing today at the accountability court in Rawalpindi's Adiala jail, the PTI founder filed a petition seeking acquittal in the case that accused both Khan and his wife, Bushra Bibi, of causing billions of rupees loss to the national exchequer.

The former prime minister's lawyer told the court that the £190 million case is no longer valid after the verdict as all the cabinet decisions are protected in NAB amendments.



"The question that arises here is whether the accountability court has jurisdiction in this case or not after the NAB amendments," the NAB prosecutor said.

He further said if the court has jurisdiction in the case, then the "acquittal plea can be heard."

At this, the PTI founder's advocate said they have not

challenged the jurisdiction of the court. He added that it is the discretion of the court to decide its jurisdiction.

The accountability court then adjourned the hearing on Khan's acquittal plea till September 10.

The PTI founder filed the plea after Supreme Court's decision on Friday accepting intra-court appeals filed against the September 15, 2023, majority judgement striking down the amendments to the National Accountability Ordinance (NAO), 1999.

The amendments — National Accountability (Second Amendment) Act 2022 — were passed in a joint sitting of the parliament in April 2022 during the Pakistan Democratic Movement (PDM)-led government which came into power after ousting ex-premier Khan via a no-trust move in 2022. It modified sections 2, 4, 5, 6, 25 and 26 of the NAB laws, however, nine out of 10 amendments were declared "null and void" by the CJP Bandial-led bench on the PTI founder's petition filed in June 2022.—RT/Agency

NEPRA Greenlights Rs1.74 Per Unit Hike For Sept-Nov

ISLAMABAD: The National Electric Power Regulatory Authority (Nepra) has approved an additional charge of Rs1.743 per unit for the next three months starting in September 2024, allowing distribution companies and K-Electric to recover Rs423.23 billion through quarterly adjustments for the fourth quarter (April-June) of fiscal year 2023-24.

This will affect customers of both state-owned distribution companies and K-Electric, adding to the financial burden on households already grappling with rising energy costs.

At the heart of this recovery lies a hefty Rs21.253 billion, or nearly half of the total amount, earmarked for capacity charges — payments that go to independent power producers (IPPs) to ensure generation capacity is maintained, regardless of how much electricity is consumed.

An additional Rs7.368 billion is being re-couped in system usage charges and market operator fees, Rs11.23 billion as impact of transmission and distribution (T&D) losses, and Rs3.5 billion for variable operation and maintenance charges.

Notably, the imposition of an 18% GST on the total recovery amount would further inflate the burden by Rs7.78 billion, raising the total to Rs51 billion to be collected from consumers.

On August 26, Nepra held a public hearing, led by Nepra Chairman Waseem Mukhtar. Electricity distribution companies (Discos) in a petition had submitted that adjustments were largely result of lack of sales as compared to the projections during the instant quarter.

However, Nepra observed that certain Discos, such as Peshawar Electric Supply Company (PESCO), failed to draw energy as per its demand, and opted to carry out loadshedding in its service area. While this reduced their share of capacity charges from overall pool, it also contributed to lower sales. These companies had sought for Rs1.9/unit additional collection. The CPPA, as an agent of the Discos, engaged in local and international legal proceedings had requested to allow Rs51 million on account of legal charges in the instant quarterly adjustment, but the authority turned it down. The authority noted that since such costs are included in Market Operation Fee (MOF), and for it the authority had already approved Rs500 million on account of legal charges as part of CPPA MOF for the FY 2023-24. The CPPA, in its plant-wise data, also included an amount of Rs72.23 million on account of Kot Addu Power Company (KAPCO) charges on account of tax differential for the period from July 1 to October 24, 2022. But the authority did not consider the amount claimed for Kapco. The authority also adjusted an amount of Rs73.18 million charged by the CPPA-G to Discos on account of PPB fee as part of PMLTC invoice for January 2024.



The matter of PPB is under consideration of the authority through separate proceedings; therefore, the matter would be decided once those proceedings were concluded.—RT/Agency

Security Forces Foil FC HQ Attack, Kill 4 Terrorists

RAWALPINDI: The security forces thwarted a deadly attack on a Frontier Corps Headquarters, killing a group of four suicide bombers in Khyber Pakhtunkhwa's Mohmand district, the military's media wing said on Saturday.

According to the Inter Services Public Relations (ISPR), the armed militants were wiped out in early hours of Friday as they tried to attack the FC HQ.

"The attempt to enter the camp was effectively thwarted by the security forces personnel, and resolutely the khawarij, all four suicide bombers, were sent to hell before they could cause the intended damage," it said.

The ISPR said sanitisation operation was being conducted to eliminate any other terrorists found in the area.

On the other hand, five terrorists were killed in an exchange of fire with security forces in Surkhay refugee camp in Pishin district.

According to a spokesman of the Counter Terrorism Department (CTD) on Saturday, a huge cache of arms and ammunition was recovered from the den of the killed terrorists.

Addressing a ceremony held at the General Headquarters (GHQ), Rawalpindi, in connection with the Defence Day, Prime Minister Muhammad Shehbaz Sharif on Friday reaffirmed his government's unwavering commitment to combating terrorism. On this occasion, he pledged to continue the ongoing operation against Fimral-Khawarij until their complete eradication. "All our armed forces and law enforcing agencies will continue their operation for which there is a national consensus," he said.—RT/Agency

Two Terrorists Eliminated In Balochistan Operation: ISPR



KALAT: Two terrorists were killed during an intelligence-based operation (IBO) conducted by security forces in Balochistan's Kalat district on reported presence of terrorists last night, the military confirmed on Saturday.

The Inter-Services Public Relations (ISPR) stated that troops surrounded and engaged the terrorists' position, neutralising both. "Weapons, ammunition, and explosives were recovered from the terrorists, who were involved in numerous attacks on security forces and civilians," the ISPR said. A sanitisation operation is ongoing to clear the area of any remaining threats. "Pakistan's security forces, alongside the nation, are committed to thwarting any attempts to destabilise peace, stability, and progress in Balochistan," the military added.—RT/Agency

PTI Names Salman Akram Raja As New Secretary General

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan has made significant changes to the party structure, media reported on Saturday citing sources.

According to sources, the former prime minister has separated parliamentary affairs from party's political matters.

Opposition Leader Omar Ayub and Senator Shibli Faraz will lead the parliamentary team, while political responsibilities will be look over by Salman Akram Raja who has been appointed secretary general of PTI.



A think tank will be formed under the leadership of Raouf Hasan who will oversee the issuance of a white paper on government performance and electoral matters.

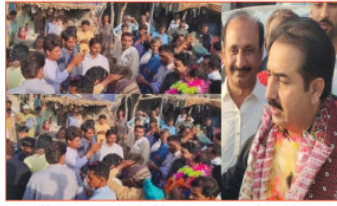

Minor girl struck by a stray bullet during Jagirani-Solangi clash in Pir Jo Goth

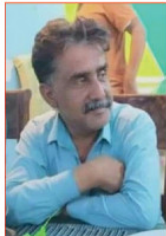

BISP Centres not functional in Shaheed Benazirabad division

SHAHEED BENAZIRABAD: In the towns of Shaheed Benazirabad Division, including Nawabshah, Sanghar, Shahdadpur, Tando Adam, Khipro, Jam Nawaz Ali, Daur, Sakrand, Moro, Naushahro Feroze, Bhiriya City, Kandiaro, Qazi Ahmed, and Daultapur, the Benazir Income Support Program (BISP) Jazz Cash centers have been non-functional for the past five days. Due to mismanagement, thousands of women have been forced to wander in frustration. It has also been revealed that Jazz Cash devices are being operated outside of the desig-

ned centers, contrary to official claims by the administration and Jazz Cash representatives. At these centers, women receiving the BISP stipend of 10,500 rupees have been struggling as the Jazz Cash system has been down for five days. Many women from nearby areas have gathered in large numbers, only to face disappointment. The slow processing speed of the system has further increased the crowd, adding to the chaos. The affected women have also reported the presence of an agent mafia, where they are being charged cuts ranging from 1,000 to 2,000 rupees. Furthermore, the Jazz Cash

centers are set up in open spaces, lacking basic amenities such as drinking water, restrooms, and privacy screens. Women are forced to sit on the ground, enduring extreme heat and discomfort. Sources have also indicated that in several towns, Jazz Cash devices have been moved outside the centers, where women are being charged extra fees. Women at these centers have voiced their frustration, complaining about the lack of facilities and the harsh conditions due to the heat. They also pointed out the blatant cuts of up to 2,000 rupees, further adding to their hardships.

Thul's civil society demands arrest of Sajid Dashti's killers

THUL: In Thul, a protest and sit-in were held demanding justice for the murder of Sajid Dashti, a young man who was killed two and a half months ago. Protesters also condemned the continuous threats being received by the family of the deceased. According to reports, the protest took place at Rabbar Chowk, where the family and residents gathered, carrying placards and chanting slogans as they marched through various streets of the city. The sit-in caused a disruption of traffic in the scorching heat. Speaking to the media, the protesters, including the victim's father, Muhammad Umar Dashti, Bajjo Dashti, Mumtaz Dashti, Shaikat Dashti, Ashgar Dashti, Raja Waseem Dashti, Sher Dashti, JSQM leader Comrade Liaquat Ali Sarki, and Alam Dashti, said



that Sajid Ali Dashti was brutally tortured and murdered, and his body along with his mobile phone and other belongings were found at the residence of the Burro family. The police investigation has already identified members of the Burro family as the culprits, and they have been arrested. The protesters, who described themselves as law-abiding citizens and businessmen, expressed their deep sorrow, stating that despite the ruthless killing of their young son on Eid day, the accused party continues to issue threats against them. They claimed that Burro community man is involved in the murder, and some members of the community are also facilitating the killers. The protesters demanded that the Inspector General of Sindh, the DIG Larkana, and the SSP Jacobabad take immediate action to arrest both the killers of Sajid Dashti and their accomplices who are issuing threats. They also called for legal action and protection for the family, warning that failure to do so would result in further protests.

She alleged in the first information report (FIR), filed under sections 292 and 376 of the Pakistan Penal Code (PPC), that she became friend with 'J' on a social media platform. She said the prime suspect promised to arrange US visas for her and her family members and received Rs5 million from her on the same pretext. She said she met the suspect two years back in Multan and another unidentified man on the complaint of the schoolteacher of a government school. She alleged that the suspect also raped her many times later and made objectionable videos. LAHORE: The Federal Investigation Agency (FIA) Lahore Zone has released its annual performance report for the Anti-Corruption Circle, media reported.

During the current year, the FIA Anti-Corruption Circle registered 277 cases and 157 inquiries. A total of 177 accused, including absconders, were arrested, according to an FIA spokesperson. The circle conducted raids on various premises, including those involved in overbilling, power theft, fake medicines, and land grabbing, resulting in the recovery of Rs 39 billion and the arrest of several high-profile individuals. Notable arrests included the LESCO Project Director, three XENs, and a commercial assistant who caused a loss of Rs 82 crore to the national exchequer. BISP To Abolish Franchise System Amid Corruption Claims

ISLAMABAD: The authorities have decided to abolish the franchise system of the BISP after disclosure of massive corruption, citing sources media reported on Saturday. After corruption complaints Chairperson Benazir Income Support Programme (BISP) Rubina Khalid has decided to abolish the franchise system to distribute monetary support to poor and needy people. Sources said that the BISP has inked agreements with six banks for distribution of monetary assistance among beneficiaries. "The monetary support money will be distributed with the online wallet account," according to sources. "Under the new arrangement the BISP card holders' remuneration will be transferred to the bank account," sources said. Chairperson BISP Rubina Khalid during her secret visits of franchise centres was acquainted with complaints of the women card holders of the BISP. The women members of the social safety net had complained about corruption. "Now all beneficiaries the BISP programmes will receive direct transfer of payments that will end corrupt practices," sources added. President Asif Ali Zardari had approved the appointment of a senior leader of the PPP Rubina Khalid as Chairperson of the BISP in May this year. After assassination of former prime minister Benazir Bhutto, the social safety network programme was launched after her name in 2008. BISP is considered as the largest and most systematic social protection initiative to be launched in Pakistan to give monetary support to poor and needy people.—RT/Agency

CTD: 33 Suspected Terrorists Nabbed In Intelligence-Driven Operations Across Punjab

LAHORE: The Punjab Counter-Terrorism Department (CTD) said on Saturday it had arrested 33 suspected terrorists in 475 intelligence-based operations (IBOs) conducted across the province in the past month. The counterterrorism efforts come amid heightened security concerns across the country. Pakistan experienced an increase in terrorist attacks as a total of 59 terrorist attacks occurred countrywide in August compared to 38 attacks in the previous month, according to a digital database maintained by the Pakistan Institute for Peace Studies (PIPS), an Islamabad-based think-tank. In a press release issued today, the Punjab CTD said it had interrogated 475 suspects during the IBOs and seized various items, including explosives, weapons and banned texts. "During these IBOs, 33 suspects belonging to defunct organisations were arrested," the statement said. The CTD detailed that the groups included Fitna Al Khawarij (Tehreek-i-Taliban Pakistan), Daish (also known as the militant Islamic State group), Al-Qaida, Sipah-i-Sahaba Pakistan, Lashkar-e-Jhangvi, Jamaat-ul-Ahrar, Zainebiyoun Brigade and others. It added that the IBOs were conducted in various Punjab districts to "effectively counter the menace of terrorism" and "to avert any upward incident". According to a list provided by the CTD of the 33 netted suspects, eight of them - the highest number - had been arrested from Lahore. Three suspects were taken into custody from Bahawalpur while two each were arrested from Sheikhupura, Hafizabad, Rahim Yar Khan, Attock, Nankana Sahib and Bahawalnagar. The department also arrested one suspect each from Gujranwala, Mianwali, Jhang, Khushab, Sargodha, Faisalabad, Rawalpindi, Narawal, Sahiwal and Bhakkar. As many as 32 first information reports were registered against the suspects - from August 4 to September 3 - under various sections of the Anti-Terrorism Act, 1997 (ATA), including Sections 7 (punishment for acts of terrorism), 8 (prohibition of acts intended or likely to stir up sectarian hatred) and 11 (membership, support and meetings relating to a prohibited organisation). The CTD press release added that the raid teams recovered almost five kilograms of explosives, two hand grenades, two improvised explosive devices (IEDs), 26 detonators, 73 feet of safety fuse wire and four 30-borj pistols with 19 rounds of ammunition. Additionally, the raid teams seized 17 pamphlets, seven magazines and 15 books from banned organisations, as well as 121 other pamphlets, 156 stickers, four receipt books, two mobile phones and Rs99,660 in cash. Separately, the Punjab CTD said it conducted 3,674 combing operations this week with the help of local police/law enforcement agencies (LEAs)—RT/Agency

Two Dead, Six Women Injured In Car Accident Due To Speeding In Killa Saifullah



KILLA SAIFULLAH: A speeding car overturned near the town of Muslim Bagh town in Balochistan province's Killa Saifullah district, killing a father and his daughter and injuring six women. The victims, all from the same family, were traveling from Quetta to Zhob when the accident occurred, according to authorities. The deceased have been identified as Juma Khan, a minerals inspector, and his daughter. Six women, all relatives of the victims, were injured in the crash, with two in critical condition. The injured were transported to a trauma center in Quetta. Local Levies forces conducted rescue efforts, and private vehicles transported the wounded to the hospital. Officials confirmed that speeding of the vehicle caused the accident.—RT/Agency

Pakistan Airports To Implement Paperless System With ERP Technology

ISLAMABAD: In a positive development, the Pakistan Airports Authority (PAA) has decided to transition all operations to an Enterprise Resource Planning (ERP) system, abolishing the use of paper entirely. The decision aligns with Prime Minister Shehbaz Sharif's directives to digitize government institutions and improve efficiency. The PAA's ERP system, soon to be fully functional, will streamline processes, enhance data management, and promote a sustainable working environment. The PM's e-office initiative aims to increase transparency and efficiency within the government. All government officers are required to conduct file work through the e-office system, with the PM Office staff already completing their training. A progress report on the e-office implementation is expected within the next two weeks. Last month, PM Shehbaz Sharif instructed the Ministry of Information Technology and other relevant departments to implement the e-office system in all government offices.—RT/Agency

Sindh Government Schools Face Ongoing Textbook Shortages

KARACHI: Despite passing two months since the academic year began, the students of public schools in Sindh still waiting to receive books from government, media reported on Saturday. A petition has been filed in the Sindh High Court against the educational department regarding the non-receipt of textbooks in government schools. The petition was filed against the Chairman Sindh Textbook Board along with Education Secretary, as well as directors of primary and secondary education. According to the lawyer representing the case, most schools in Sindh still waiting to receive textbooks from the education department.—RT/Agency



Imprudent Financial Priorities

The Sindh government's decision to allocate a staggering Rs 2 billion for the purchase of 138 luxury SUVs for Assistant Commissioners is not only a poor judgment of priorities but a glaring mismanagement of public funds. At a time when Pakistan faces immense economic challenges, with millions struggling to make ends meet, the justification for such an extravagant expenditure is indefensible.

This move has rightly been suspended by the Sindh High Court following a petition by Jamaat-e-Islami MPA Muhammad Farooq, who highlighted the absurdity of spending such a

large amount on vehicles when the public is in dire need of essential services like healthcare, education, and employment opportunities. The



court's intervention is a much-needed check on the provincial government's actions, which seem increasingly out of touch with the needs of the common man.

The Rs 2 billion earmarked for these vehicles could be far better utilized in areas that directly improve the lives of Sindh's citizens. For in-

stance, investing in education and vocational training would equip young people with the skills they need to secure employment, thereby fostering long-term economic growth. Similarly, improving healthcare infrastructure, especially in rural areas, is critical for ensuring basic human dignity for all citizens, not just the privileged few.

Ultimately, this decision by the Sindh government reflects a troubling disconnect between its priorities and the actual needs of the public. The court's suspension is a step in the right direction, but the government must reevaluate its spending choices and focus on projects that lead to real, sustainable development for the province.

Naqvi confirms England Test series will be held in Pakistan



LAHORE: Pakistan Cricket Board (PCB) Chairman Mohsin Naqvi on Saturday dismissed reports claiming non-availability of the venues for the upcoming three-match Test series against England, saying that the matches will be held in Pakistan.

"No Tests will be played outside [the country]. Multan and Rawalpindi venues are final," the PCB chief said in an interaction with journalists during his visit to oversee the ongoing renovation work being carried out at the Gaddafi Stadium.

Earlier this week, reports emerged that the schedule for next month's three-match series could be altered due to construction work at the country's major stadiums. The matches are scheduled to be held in Multan (Oct 7-11), Karachi (Oct 15-19) and Rawalpindi (Oct 24-28). But reports claimed that the Karachi Test was likely to be moved to the United Arab Emirates (UAE) - Pakistan's 'home venue' until cricket returned to the country.

England did not tour Pakistan between 2005 and 2022, owing to security concerns, with the PCB staging matches in the UAE throughout that period. Addressing the reports, Naqvi clarified that the Test series between Pakistan and England will be played in Multan and Rawalpindi. He further shared that the PCB is in contact with the England and Wales Cricket Board (ECB) and "there are no issues". —Agency

The ECB statement said that Wood sustained the elbow injury during the series against the West Indies, although he continued to play in the subsequent Test match against Sri Lanka.



"He had noticed increasing stiffness and discomfort in his elbow during the Test series against the West Indies earlier in the summer. He played a full part in the first Test against Sri Lanka at Old Trafford man-

Brazil secures narrow victory over Ecuador with Rodrygo's goal



Brazil got back to winning ways in the South American World Cup qualifiers by a drab 1-0 victory over Ecuador thanks to first-half goal by Real Madrid forward Rodrygo.

After its first streak of losses in three successive World Cup qualifiers, Brazil did just enough to earn the win that lifted the struggling five-time World Cup champions to fourth in the standings with 10 points.

They are eight points behind leaders Argentina and only two points over Ecuador in sixth, the last spot guaranteed a berth at the 2026 finals.

Playing their first match after a disappointing Copa America defeat to Uruguay in the quarter-final, Brazil had another lacklustre performance, dominating possession but failing to create clear chances throughout the match.

Brazil misplaced too many passes and struggled to connect up front, out of ideas on how to beat Ecuador's rock solid defensive block.

Ecuador were relentless while applying a physically aggressive pressure high with three hardworking forwards, making the locals uncomfortable when putting the ball in play. —Agency

Italy stages a comeback to defeat France 3-1 in a thrilling victory



Italy fell behind just 12 seconds into the match but staged a comeback to defeat France 3-1 in a captivating Nations League A Group 2 opener.

Bradley Barcola struck early, scoring in the first minute by exploiting a lapse from Giovanni Di Lorenzo and curling the ball past Gianluigi Donnarumma.

Italy equalized after 30 minutes when Federico Dimarco volleyed in a clever back-heel pass from Sandro Tonali, with the teams heading into the break level following an exciting first half.

Five minutes after the interval and France were rocked again with Davide Frattesi putting Italy ahead, and Giacomo Raspadori gave the visitors the breathing space they needed in the 74th minute to silence the Parc des Princes crowd.

Both sides came into the game looking for redemption after failing to impress at Euro 2024, but it was Italy

who earned the much-needed victory.

It was a terrible start for the visitors with Di Lorenzo taking far too long over a back-pass and Barcola pounced to score his first international goal.

A frantic start to the game gave Italy the chance to level five minutes later but Frattesi hammered a close range header off the crossbar.

Donnarumma pulled off saves from Kylian Mbappe and Michael Olise, making his debut, before Italy found the equaliser, with Tonali's assist just as impressive as the strike which found the net.

Tonali, back in the side after serving a 10-month ban for breaching betting rules, played a beautiful one-two with Dimarco who continued his run into the box and struck a sweet left-footed volley beyond the reach of Maignan. —Agency

Fritz defeats Tiafoe to book US Open final clash with Sinner

NEW YORK: Taylor Fritz fought back to defeat compatriot Frances Tiafoe at the US Open, becoming the first American man to reach a Grand Slam final in 15 years.

Fritz, the world number 12, won 4-6, 7-5, 4-6, 6-4, 6-1 and will take on top-ranked Jannik Sinner for the title on Sunday.

"He overwhelmed me at the start and I was freaking out a little," said 26-year-old Fritz after securing victory with a 16th ace.

"I just told myself to stay in it, hold serve and apply scoreboard pressure. I did all I could to stay in it. If I hadn't have done that, I'd regret it forever. In the final, I will come out and give it everything."

Australian Open champion Jannik Sinner earlier be-



came the first Italian man to make the US Open final with a 7-5, 7-6 (7/3), 6-2 win over Britain's Jack Draper.

Andy Roddick was the last American to make a man's singles final at the Slams at Wimbledon in 2009. He was also the last man from the country to capture a Slam title when he won the 2003 US Open.

Tiafoe went into Friday's match trailing 6-1 in his head-to-head record against his compatriot.

However, he boasted the more impressive Grand Slam credentials, playing in his second US Open semi-final in his last three appearances.

Taylor Fritz was in unknown territory, having fallen at the quarter-final stage at the Slams on four occasions.

Tiafoe used that greater experience to hit back from 3-0 in the first set to clinch the opener.

Fritz, who had reached the semi-final by defeating fourth-ranked Alexander Zverev in the previous round, was unable to convert a set point in the 10th game of the second set.

He succeeded at the next time of asking to level the match before handing the initiative straight back when Tiafoe broke for 1-0 in the third and held the advantage to retake the lead.

In a match where there were few rallies and little real drama, Fritz levelled again in the 10th game when Tiafoe dumped a lazy drop shot into the net. —Agency

Heavy machinery was used to repair the damage, and new pipelines were installed. This recent attempt at sabotage, which was unsuccessful, is now under investigation by municipal authorities. If clear evidence of the sabotage is found, immediate action will be taken, and an FIR will be filed.

Pakistan Blacklists Over 40 Technical Institutes: BEOE

ISLAMABAD: Bureau of Emigration and Overseas Employment (BEOE) an attached department of the Ministry of Overseas Pakistanis and Human Resource Development (OP&HD) had blacklisted around 40 technical trade centers across the country due to the complaints and involvement in fraud cases with innocent citizens. An official source revealed that the main function of this department is to control and regulate emigration under the Emigration Ordinance, 1979, and promote the Emigration of Pakistani Citizens.

It is also the responsibility to look after the emigrants' interests and welfare and advise the Federal Government on emigration policies and procedures. Monitoring and supervision of Overseas Employment Promoters through 7 Protectorates of Emigrants Offices and Processing of Overseas Employment Promoters (OEP) Licences, he added. BEOE also provides the platform for pre-departure briefing to Emigrants and mandatory insurance coverage to Pakistani workers abroad. Memorandum of Understanding with Foreign Countries for Export of Manpower and Management of State Life Emigrants Insurance Fund (SLEIF) were the main functions of this department. He said that BEOE has advised the foreign job-seekers to only reach out to the valid Overseas Employment Promoters to avert any loss of time, money, and their energies.—RT/Agency

Karachi Bus Terminal Relocation To Continue Despite Opposition: Sharjeel

KARACHI: Sindh Senior Minister Sharjeel Inam Memon stated that despite the provision of a free shuttle service to the new bus terminal in Karachi, some bus operators have filed cases against the action on false and fabricated grounds.

Some operators are resisting legal action or pursuing personal interests, attempting to pressure public office holders, he added.

In a statement, Sindh Senior Minister and Provincial Minister for Information, Transport, Excise, Taxation, and Narcotics Control, Sharjeel Inam Memon, said that the transfer of terminals will be ensured under all circumstances, pressure is being exerted, but the work will continue regardless.

He stated that the purpose of shifting the terminals outside the city of Karachi is to eliminate illegal bus stands from city



roads. The transport department is committed to upholding the rule of law and complying with court orders.

Senior Minister Sharjeel Inam Memon stated that the establishment of bus terminals outside the city limits is in accordance with court orders.

All stakeholders should respect and cooperate with the law. The Sindh government is aware of the challenges

posed by transporters and aims to resolve the sufferings of the citizens without adversely affecting the transporters' businesses.

He clarified that negotiations with the transporters will continue, with measures being taken to consider the interests of all stakeholders.

The Transport Department is committed to ensuring smooth and legal transport operations within the capital city of Sindh.—RT

Electrical Fault Disrupts Power At Civil Hospital; KE Assists In Restoration

KARACHI: A power outage at Civil Hospital was caused by an internal wiring fault, not an issue with the external grid, according to a statement by K-Electric (KE) on Saturday. Although internal wiring falls outside KE's jurisdiction, the utility provider stepped in to assist due to the hospital's critical role in patient care.

Upon the hospital administration's request, KE dispatched a team to help restore power. A KE spokesperson emphasized that while the company offered help on humanitarian grounds,

hospitals and other essential institutions should ensure they have trained electrical staff and conduct regular maintenance to avoid similar incidents in the future.

"While we were able to respond to this, critical institutions like hospitals should be equipped to handle such situations independently for faster resolution," the spokesperson added.

KE's distribution team worked closely with Civil Hospital's staff to resolve the issue, ensuring the quick restoration of power.—RT/Agency

Karachi Mayor Unveils Rs12.75 Billion Water Supply Initiative For The City

KARACHI: Karachi Mayor Murtaza Wahab has announced that the Sindh government has approved the installation of two new water supply lines at a cost of Rs12.75 billion to address the city's water shortage. The project is expected to be completed within a year.

During a media briefing at the Treatment Plant Three on Mauripur Road on Saturday, Wahab highlighted the global water crisis, stating, "Water scarcity is increasing worldwide, and in some countries, recycled water is used for drinking purposes. While this practice is not common in our country, it's time we consider recycling water and making seawater usable."

He added that treated water would be tested in laboratories to assess its suitability for industrial and construction purposes.



Wahab also mentioned that advertisements have been placed for the construction of a fourth treatment plant in Ibrahim Hyderi, which will soon be operational.

Speaking about modernisation efforts, the mayor remarked, "Countries that have made bold, innovative decisions are the ones providing better services to their people. Unfortunately, in our country, progress has stalled, and

decisions are delayed."

In response to a question, Wahab criticised the federal government for not opening the Lyari Expressway, claiming it is "being blackmailed." He also called on the MQM to explain what benefits they have secured for Karachi from the federal government.

The mayor criticised the MQM for protesting outside K-Electric's head office, reminding them that privatisation of the utility occurred during their tenure.

Murtaza Wahab praised the Water Corporation's officers and consultants for their swift action in addressing Karachi's water issues. He stated that efforts are underway to treat river, sea, and sewage water, promising to deliver on the commitments made to resolve the city's water problems.—RT

SHC Issues Notices To Government And Nepra In Capacity Payments Case

KARACHI: The Sindh High Court (SHC) on Saturday issued notices to the federal government

NEPRA, federal secretary energy, K-Electric and others over capacity charges payment to the IPPs, media reported.

A petition filed in the high court pleaded that the Supreme Court had ordered forensic audit of the independent power producers (IPPs). Instead of compliance of the order of the apex court capacity charges payments being made, petitioner's counsel said.

Petitioner seeks court order for suspension of the capacity payments until the forensic audit being conducted.

Capacity payment refers to the payment made monthly by consumers to the power-producing companies to maintain its capacity to generate electricity, ensuring that additional demand can be met.

Notably, these capacity payments to IPPs are made in US dollars, not in Pakistani rupees.

father fraudulently transferred her mother's property into his own name. Both Quratul Ain and her mother have reportedly been held captive by Hussain, restricting their freedom and forcing the girl to work against her will.

The local community has confirmed that Quratul Ain has been seen working under the guise of a boy. Police have yet to receive a formal complaint from the affected family.—RT/Agency

passports for Rs. 10 million each from an agent named Usman from Wazirabad.

WB-Supported WASH Program Encourages 'Behavior Change' In Karachi's Informal Settlements

PM Shatters 'Pakistan Isolation' Narrative

LONDON: Deputy Prime Minister and Foreign Minister Muhammad Ishaq Dar said on Saturday that the claims of Pakistan being in international isolation have been proven wrong due to the active guidance and tireless efforts of Prime Minister Shehbaz Sharif and his team.

Speaking to the media, Dar highlighted that Pakistan has secured a non-permanent seat on the United Nations Security Council (UNSC) for two years, garnering 182 votes—a significant increase compared to the single-vote majority it achieved 12 years ago. The first congratulatory message was received from David Lammy, the UK Foreign Secretary.

He stated that Pakistan will actively contribute as a non-permanent member during its term and is currently engaged in discussions with permanent member states to



finalize its agenda. Pakistan aims to play a proactive role in addressing global conflicts and plans to strongly advocate for the issues of Palestine, Kashmir, and Islamophobia at the UNSC.

He emphasized that it is the global community's responsibility to implement UN resolutions on international conflicts. He expressed

regret that the UN resolutions on Kashmir remained unimplemented. Similarly, resolutions concerning the Gaza bombings have yielded no results, despite the tragic loss of over 40,000 Palestinian lives. Pakistan will persist in advocating for these issues across all forums, including the OIC, D8, and the UN.

Dar mentioned that he has already taken up the issues of Palestine, Kashmir, and Islamophobia at various forums. Additionally, for the first time, the Organization of Islamic Cooperation (OIC) has appointed a special representative of the Secretary-General specifically to combat Islamophobia. He noted that Pakistan has already sent nine consignments of medical and essential supplies to Palestine. Moreover, Pakistan has decided to continue the education of Palestinian medical students whose studies were interrupted or left incomplete by admitting them to complete their studies in Pakistani medical colleges. Deputy Prime Minister and Foreign Minister Ishaq Dar stated that efforts are underway to quickly restore flights between Pakistan and the United Kingdom, which will benefit the Pakistani diaspora. "We've updated laws to meet UK Aviation Authority standards to resolve the PIA flight issue," Dar said. He also noted that a previous PTI minister's statement had led to the grounding of Pakistani aircraft in Europe and the UK.

During his UK visit, Dar revealed plans to privatize Pakistan International Airlines (PIA) and outsource Islamabad International Airport, aiming for completion by the 10th of next month. He stressed that Pakistan values its partnership with the UK, with the Pakistani diaspora being a key element of this relationship. Discussing his meetings with UK ministers and others, he described his discussion with the British Foreign Secretary as highly positive, with both parties committed to elevating their bilateral strategic relations.—RT/Agency

PTI Accepts Omar Ayub's Resignation As Secretary General

ISLAMABAD: The resignation of Omar Ayub as the secretary general of Pakistan Tehreek-e-Insaf (PTI) has been approved by the party amidst ongoing restructuring and reshuffling within the party.

Omar Ayub, who also serves as the Leader of Opposition in the National Assembly, submitted his resignation on September 5, citing the overwhelming workload associated with his multiple roles.

He expressed his gratitude for the approval and stated that he will continue to contribute to the party as a dedicated member.

In his resignation statement, Ayub revealed that he had previously resigned on June 22, but that resignation had not been accepted.



He attributed the decision to step down to the demanding nature of his responsibilities, which included managing party affairs, attending court hearings, and handling constitutional matters.

Party sources indicate that Salman Akram Raja has been appointed as the new secretary general, taking over Ayub's former role.

The PTI founder has also restructured the party's administrative functions, with Omar Ayub and Senator Shibli Faraz leading parliamentary affairs, while Raouf Hassan will head the party's think tank. The restructuring aims to streamline the party's operations and delegate responsibilities more effectively.—RT/Agency

President Signs 'Peaceful Assembly' Bill Into Law

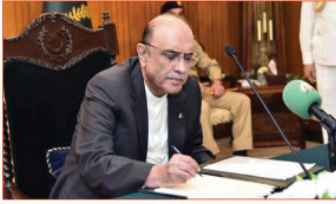
ISLAMABAD: Following approval from both houses of the parliament, President Asif Ali Zardari on Saturday gave assent to 'Peaceful Assembly and Public Order Bill, 2024'.

With the approval by the president, the bill has turned into law and ready to be implemented.

Under the new law, Islamabad DC would grant permission for rallies. In case of rejection, an appeal could be made to the Chief Commissioner.

The bill aimed to regulate public gatherings to ensure they do not disrupt public order.

After the passage of the bill in NA with a majority vote on Friday, Law Minister Azam Nazir Tarar said the



purpose of the bill was to maintain peace during public assemblies and processions.

He dismissed the opposition's concerns, noting that the increasing number of demonstrations in the federal capital had caused significant inconvenience to citizens.

Tarar added that, "the 'Peaceful Assembly and Public Order Bill 2024' is an effort to ensure that the public space is not disturbed by public gatherings.

He rejected the notion of the opposition and said the federal capital was seemingly "under siege" and the growing number of processions had made the lives of citizens miserable.—RT/Agency

Hafiz Naeem Demands Immediate Removal Of Electricity Taxes



LAHORE: Jamaat-e-Islami Emir Hafiz Naeem Rehman has called for the removal of taxes on electricity bills.

Speaking to the media in Lahore, Rehman demanded that the 36 types of taxes imposed on electricity bills be abolished.

He criticised the Punjab government's relief of Rs14 as insufficient. On the other hand, he argued that such

relief should be implemented nationwide. Rehman also mentioned that the recent shutter-down strike organized by his party was successful. He further said that they planned to hold more strikes and seek legal remedies if necessary. Additionally, he claimed that the ongoing terrorism in the country had links to India and the United States.—RT/Agency

"On September 7, 1965, the PAF's Shaheens created history of courage, bravery and courage," the prime minister said in a message.

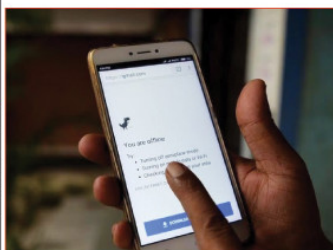
He particularly mentioned the heroics of MM Alam, who downed five enemy aircraft within a

Govt Stays Silent On Election Day Mobile, Internet Blackout



ISLAMABAD: The Federal Ministry of Interior has declined to provide reasons for shutting down mobile and internet services on February 8, the day of Pakistan's general elections, citing national security concerns.

According to media, a request was filed with the Pakistan Information Commission to learn why the services were disrupted during the election. In response, the ministry classified the information under the Right to Information Act, saying it could not be released due to national security.

The Information Commission granted the Interior Ministry an exemption from sharing the information. The Pakistan Telecommunication Authority (PTA) stated that it follows federal government directives, and the services were shut down on Election Day under orders from the ministry. The commission has yet to issue a detailed ruling, while the Ministry of Information made no remarks on the classification. The Interior Ministry maintained that disclosing the details would compromise national security.—RT/Agency

Sindh, Centre Clash Over Development Fund Allocation

ISLAMABAD: The federal and Sindh governments are at odds over the allocation provincial development funds, ARY News reported.

According to sources, the Ministry of Finance has written a letter to the Sindh government, stating that Rs 9 billion 97 crore has been released to all provinces as development funds.

In the current financial year, Sindh has received the highest amount of Rs 5 billion 58 crore, while Khyber Pakhtunkhwa has received the lowest amount of only Rs 39 crore. Balochistan has received over Rs 3 billion, while Punjab has received Rs 90 crore as development funds, sources added.

Despite receiving the highest amount of development funds, the Sindh government is complaining about the release of funds.

Prime Minister Shehbaz Sharif had given instructions



to the Ministry of Finance and Planning to release the development funds.

Later, Sindh Chief Minister Syed Murad Ali Shah wrote a letter to Prime Minister Shehbaz Sharif regarding the non-release of development funds. Moreover, the Ministry of Finance assured Sindh that funds will be released under the Annual Development Plan. Due to low revenue, 15% of development funds will be released during the first quarter of the current financial year, while 40% will be released during the last quarter. Its important
