## CJP Isa Joins Law Minister In Declining Extension Of Tenure

ISLAMABAD: After the federal law minister, Chief Justice of Pakistan (CJP) Qazi Faez Isa has confirmed that he does not wish to seek an extension in his tenure as the country's top judge.

During an informal conversation with journalists in Islamabad on Monday, the chief justice said he was told in a meeting that the tenure of judges would be extended. CJP Isa is set to retire in October this year, but as his retirement draws near, rumours of an "extension" in his tenure through judiciary-centric legislation in parliament have been rife.

"However, I had suggested extending the tenure of other judges but said that I won't accept an extension in my tenure," he told the newsmen, adding that he doesn't even know whether he will be alive tomorrow or not.

The top judge said that Law Minister Azam Nazeer Tarar, Justice Mansoor Ali Shah and Attorney General for Pakistan (AGP) Mansoor Usman Awan were present in the meeting.

Earlier, CJP Isa said that every judge has some inclination and if a case is assigned to a certain judge, it helps determine the prosecution's weightage.

The top judge made these



comments while addressing the full court reference at the beginning of the new judicial year at the Supreme Court today.

"Every institute has room for improvement. Earlier, it was easy to determine the verdict based on the formation of the bench, but now, even I am unaware of what the judges sitting beside me will decide," he said.

Earlier this month, Tarar rebuffed speculations centred on the imminent retirement of the CJP, saying that the top judge didn't want an extension in his tenure.

The Centre has time and again denied these reports, saying that nothing as such was on the cards as CJP Isa has "no interest" in getting an extension.

The legal experts say there is no constitutional mechanism for such an extension without amendments to the Constitution. Even if the government wants such an amendment, it would require a two-thirds majority in both houses of parliament, which is a challenge in the light of the recent Supreme Court verdict on reserved seats favouring Pakistan Tehreek-e-Insaf (PTI).

He said the chief justice "clearly told me and the attorney general that he doesn't want an extension".

The speculations about CJP Isa's extension gained attraction after the PTI sought an early issuance of notification regarding the next chief justice of Pakistan last month.—RT/Agency

## PTI Leaders Barrister Gohar And Sher Afzal Marwat Detained Outside Parliament

-Can you believe this?

ISLAMABAD: Islamabad police arrested Pakistan Tehreek-e-Insaf (PTI) Chairman Barrister Gohar Ali Khan and Member of National Assembly (MNA) Sher Afzal Marwat outside Parliament House following a National Assembly session on Monday.

According to media, a heavy police presence had gathered outside the Parliament House in anticipation. As PTI leaders exited the building, police took positions and swiftly moved to detain Marwat.

A scuffle reportedly broke out between Marwat's supporters and the police during Marwat's arrest. However, police managed to surround and apprehend the MNA, seizing his vehicle before leaving the scene.

While Sher Afzal Marwat was forcefully taken into custody, another PTI leader, Aamir Dogar, exited the Parliament House without any hindrance.

Sources indicate that Sher Afzal Marwat was arrested due to legal violations committed during last night's rally.

The violations include disrupting the agreed route, breaching commitments, attacking Islamabad police, exceeding permitted timings, and delivering anti-state speeches.



Sources within Pakistan Tehreek-e-Insaf have claimed that Advocate Shoaib Shaheen has also been arrested by police from his office.

Meanwhile, PTI leaders Aamir Dogar and Ali Muhammad Khan exited Parliament House without any hindrance.

Following Sher Afzal Marwat's arrest, several PTI leaders and parliamentarians decided to remain inside the Parliament building. Barrister Gohar, Zain Qureshi, and Waqas Akram have since returned to the premises.

The police have stated that Zartaj Gul and Omar Ayub will also be arrested.

According to sources, PTI leader Zartaj Gul managed to evade arrest by sitting in the back seat of a car and deceiving the police, a claim confirmed by a PTI spokesperson.

The development took place hours after police in Islamabad filed three cases

against the PTI leadership for failing to conclude last night's rally on time, pelting stones on police officers, and violating designated routes.

The cases were registered under the Public Order and Peace Act, following the PTI's public gathering at Islamabad's Sangiani.

The first case was lodged at Sangiani Police Station for the rally exceeding its permitted time limit.

A second case was registered at Sumbal Police Station for violating the pre-approved route by leading convoys through Sadaat Colony and Srinagar Highway.

The third case, filed at Noon Police Station, pertains to stone-pelting on law enforcement officials, including senior superintendent of police (SSP) Safi Sayed and other officers.

According to police sources, the prosecution has been prepared, with 28 local

turned Islamabad literally into a walled city with shipping containers blocking all the roads linking it to neighbouring Rawalpindi in anticipation of the rally and over 6,000 personnel of police and the Frontier Constabulary (FC) manning the routes.

Public transportation, including the Metro Bus service between Rawalpindi and Islamabad, as well as the Green and Blue Line bus services within Islamabad, were suspended while trains arriving in Islamabad and Rawalpindi were delayed.

All hotels, guest houses, and shops around the gathering venue were also closed on the order of the relevant police station.

Interestingly, last month, Marwat announced that he would personally oversee the planning of all future rallies and protests, taking full responsibility should any incidents similar to those of May 9 occur. He stressed that all future planning would be done independently, without consulting Imran Khan, to ensure any repercussions would fall solely on him. Marwat reaffirmed his commitment to leading peaceful protests and urged PTI supporters, especially students, lawyers, and farmers, to actively join the movement against the current political situation.—RT/Agency

## Patel Urges Gandapur To Revoke Unacceptable Remarks Against Journalists

ISLAMABAD: Pakistan Peoples Party (PPP) leader Abdul Qadir Patel on Monday said that the journalists community had demanded the retraction of inappropriate remarks by Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur made by him at the Sangiani meeting.

Speaking in the National Assembly, he said that the journalists had staged a walk-out from the House in protest against the KP CM's comments against their community.

Gandapur had deeply hurt the sentiments of media persons, he added. The journalists were facing threats to their lives and well-being, and they wanted the Parliament to take a stand in their support.

Leader of the Opposition Omar Ayub also condemned the remarks, calling the journalists community highly professional.

He said he and his party colleagues in the House tendered an unconditional apology to the journalists. Chief Minister Gandapur should do



the same, he added.

Syed Amin-ul-Haque of the Muttahida Qaumi Movement Pakistan also strongly condemned Gandapur's comments, assuring that his party stood with the journalists.

Pakistan Muslim League-Nawaz's (PML-N) senior leader Tariq Fazal Chaudhary said that on the Speaker's directive, he had met the journalists, who expressed their concerns regarding the remarks.

Pakistan Tehreek-e-Insaf (PTI) Chairman Gohar Ali

Khan apologized to the journalists on behalf of KP CM Gandapur and assured that his party supported the community.

The Parliamentary Reporters Association (PRA), however, asked the PTI leadership to ensure that Gandapur tenders an apology publicly as he had made offensive remarks publicly.

Gandapur should release a video message immediately, apologizing to the journalists for his remarks, it added.—RT/Agency

## Imran Claims August 22 Rally Was Delayed At Establishment's Request



ISLAMABAD: Former Prime Minister and Pakistan Tehreek-e-Insaf (PTI) founder, Imran Khan, has admitted that his planned rally on August 22 was postponed at the request of the establishment, citing concerns over potential unrest in the country.

During an informal conversation with journalists at Adiala Jail, Imran revealed that Azam Swati, acting as an intermediary on behalf of the establishment, approached him early that morning to request the rally's postponement.

Swati conveyed that with a cricket match and protests by religious parties in Islamabad, the rally could fuel instability.

Imran added that the establishment guaranteed full support for an alternate rally scheduled for September 8.

"I postponed the August 22 rally for the sake of Pakistan," he said.

In response to a question, Imran dismissed suggestions that he sought legal relief for personal gain, stating that he had been offered a deal to remain silent for three years, which would have led to his cases being dropped.

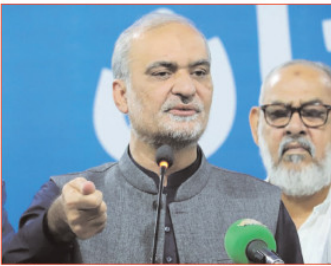
"If I wanted relief, I would have fled the country," he remarked. Imran also warned of launching a strong protest movement if Justice Qazi Faez Isa is reinstated, calling him the most biased judge in the country's history.—RT/Agency

## Hafiz Naeem Threatens Multiple Strikes And Long Marches Over Government's Inaction

KARACHI: Jamaat-e-Islami (JI) Pakistan chief Hafiz Naeemur Rehman warned on Monday that more than one strike could be organised, with options for a long march and a nationwide transport strike on the table. His remarks came during a press conference at Idara Noor-e-Haq upon his arrival in Karachi on Monday.

"It's been a month since we reached an agreement with the government, but we need action, not announcements. Interior Minister [Mohsin Naqvi] promised to brief us on progress, but we demand real solutions to public issues," Rehman said.

He added that after consulting party members, the JI is prepared for further actions. "We held a nationwide shut-down strike before, but now there could be several strikes, and long marches or transport blockades are possible as well. The public deserves to know the details of the negotiations with Independent Power Producers



(IPPs) and the oppressive agreements harming them."

Rehman also criticised the Pakistan People's Party (PPP) for failing to devolve powers to the local level in Karachi. "The situation in Karachi is alarming. The PPP has seized control of all institutions and, even if some powers were transferred to local bodies, the system remains under their control," he stated.

Accusing the PPP of corruption, he said, "Rs66 billion

are allocated to the KLC project, but 60-70% of the funds disappear due to corruption. The recent roadwork, costing billions, washed away after the first rain. The road from Guru Mandir to Mazar-e-Quaid is now called 'the one-day road' because it didn't last longer than a day." Rehman concluded by accusing the government of imposing rejected political parties on Karachi and neglecting the city's needs.—RT/Agency

## Ali Muhammad Khan Accuses Government Of Judicial Targeting

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) leader Ali Muhammad Khan accused the government of targeting the judiciary.

Talking outside Adiala Jail in Rawalpindi, Khan expressed gratitude on behalf of the PTI founder to the party workers for the success of the Islamabad rally. He further added that the PTI founder's morale was high. Referring to Imran Khan's stance, he said, "Weakening the power of the Supreme Court would be an attack on Pakistan itself." He criticised the government for undermining the judiciary. He also criticised Pakistan People's Party (PPP), claiming



that the party abandoned Bhutto's ideology by making Asif Ali Zardari the President. Ali Muhammad Khan stressed that if the country is to move forward,

the voice of the people must be heard. The nation had already delivered its verdict in favour of the PTI founder on February 8, he reiterated.—RT/Agency

## Shibli Slams Misuse Of State Resources Against PTI

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) leader Senator Shibli Faraz has stated that all state resources are being used against PTI.

Speaking during a Senate session on Monday, the senator remarked that no matter how many figures are manipulated, inflation remains unchecked.

"The country is heading towards institutional collapse, and the finance minister is left with no options," he claimed, adding that government members have turned the House into a chaotic market.

He noted that while PTI governed the country for



three years, the current government has been in power for 40 years and has led the country to ruin. He told the members of the House don't pass the laws that you have to regret.—RT/Agency

## Finance Minister Calls On Private Sector To Drive Economic Growth Through Public Confidence

ISLAMABAD: Finance Minister Muhammad Aurangzeb on Monday stressed the importance of restoring public trust in the government's economic policies, saying that the private sector must take the lead in driving the country forward.

His remarks came during the Senate session where he addressed economic challenges.

"We cannot move forward until public confidence is restored. The private sector must step up and lead the country," Aurangzeb stated, adding that currency stability and single-digit inflation have been achieved in the current fiscal year, with improved exports in July and August. Responding to a question from Senator Shibli Faraz regarding a shortfall in tax collection, the finance



minister explained, "We are Rs98 billion behind in tax collection. However, private sector credit has risen by half a trillion. The government needs to maintain fiscal discipline. As the prime minister has said, the government's job is not to run businesses but to empower the private sector."

Aurangzeb agreed that digitalising the Federal Board of Revenue (FBR) is essential for building trust. "We must restore confidence in the tax authority. It's impossible to develop without paying taxes. This country cannot run on charity; taxes are essential for progress," he added. He concluded by emphasising that institutional reforms could make the current IMF programme the last one for Pakistan.—RT/Agency

## 14 SU students receive cheques under PM's scholarship Fund

JAMSHORO: As many as 14 students of the Institute of Art and Design, University of Sindh, Jamshoro were awarded scholarship cheques under the Prime Minister Fund Scholarship program. Vice-Chancellor Professor (Meritorious) Dr. Muhammad Siddique Kalhoro personally handed over the cheques to 5 male and 9 female students at a ceremony held at his office. The event was also attended by the University's Registrar and Director of the Students Financial Aid Office Professor Dr. Mushtaq Ali Jariko, Focal Person Mohtarma Benazir Bhutto Campus Dadu Professor Dr. Nek Muhammad Shaikh, Dr. Rafique Ahmed Lashari, Dr. Muhammad Younis Laghari, and Ghulam Saqib Burro. While address-

ing the recipients, SU Vice-Chancellor Dr. Muhammad Siddique Kalhoro said that over the past four years, scholarships worth Rs. 860 million had been distributed among students of Alma Mater. He said that these scholarships had greatly benefited students, enabling them to continue their education without financial stress, even in the face of rising inflation. Some recipients have already graduated, thanks to the support provided. He also acknowledged the contributions of both federal and provincial governments, private donors and university teachers' welfare funds. He reassured that in cases of emergencies, where a student is unable to pay the tuition fees, their requests were considered, and the fees were covered through the Sindh University Teachers' Welfare Fund. Dr. Kalhoro pointed out that more than 5,000 students resided in the boys' and girls' hostels and many have achieved academic success with the provided facilities. He noted that if the university had stopped offering hostel facilities, it would have been difficult for 2,000 female and 3,000 male students to pursue higher education. He further stated that the tuition fees at the University of Sindh were very affordable, with senior batch students paying annual fees ranging from Rs. 5,000 to Rs. 10,000. The Vice Chancellor said that the university had initially received 14 scholarship slots under the Prime Minister Fund, but after a request to the authorities, 8 more slots were granted and additional students will soon receive their scholarship cheques.

## Students, teachers protest against posting of male Head Master at Girls High School in TMK

teachers. They argued that the presence of a male principal in a girls' school would make them feel unsafe. The protesters called on the provincial minister for education and other high authorities to take immediate notice of this important issue.

## Ghotki Police arrest three notorious criminals during ongoing operations

Additionally, firearms were recovered from Akhtar Bozdar, and a stolen motorcycle was recovered from local resident Shabbaz Panhyar. DSP Soomro stated that the three suspects were arrested during the three-day operation, and efforts are underway to apprehend other criminals as well. Meanwhile, SHO Khanpur Mahar Barkat Ali Bhatti emphasized that the police in Khanpur Mahar and surrounding areas should not be disturbed and assured that the operation against criminals will continue.

repression.

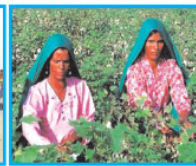

On his 30th birthday, Manchester United midfielder Bruno Fernandes fired Portugal's second-half equaliser after his former Old Trafford team-mate Scott McTominay gave Scotland a surprise early lead.

For Portugal boss Roberto Martinez, victory over Scotland could mean some awkward silences at his next family gathering. Martinez met his wife Beth while playing for Scottish club Motherwell in 2001 and joked before the match he would be delighted to upset his father-in-law by beating Scotland.

He did exactly that, leaving Scotland still waiting for their first win over Portugal.

Beaten 3-2 by Poland at Hampden Park on Thursday, Scotland have won just once in 14 matches, a barren sequence that included their lacklustre failure to make it out of the group stage at Euro 2024.

Steve Clarke's men have lost six of their nine matches in 2024, with only victory coming in a friendly against Gibraltar in June. "When you bring quality players from the bench like Roberto can do you always know there's a risk," Clarke said.—Agency

## Nissanka hits ton as Sri Lanka stun England in third Test



LONDON: Pathum Nissanka scored an unbeaten century in the run chase and powered Sri Lanka to a resounding eight-wicket victory over England in the third Test of the three-match series here at The Oval on Monday.

The victory marked Sri Lanka's fourth against England in the latter's backyard since their infamous win at Headingley in 2014.

But England took the three-match series 2-1, having won the Old Trafford Test by five wickets and Lord's Test by 190 runs.

Sri Lanka, set to chase 219, resumed their second innings at 94/1 with Pathum Nissanka (53\*) and Kusal Mendis (30\*) going strong.

England made an early inroad with an important scalp of Mendis, who could score just nine to his overnight score and returned after scoring 39 off 37 deliveries.

Meanwhile, Nissanka remained unfazed by the dismissal and kept dominating the English bowlers. He put together an unbeaten 111-run partnership with veteran all-

rounder Angelo Mathews (32\*) to steer his side to glory before Lunch on the penultimate day of the third Test.

He remained the top-scorer for Sri Lanka with an unbeaten 127 off just 124 deliveries, smashing 13 fours and two sixes amid his magnificent knock.

"It was a great opportunity to play in England and I enjoyed that innings," said Nissanka.

"I just wanted to play my normal game and I have done that," added the opener, who spent two years out of the Test side.

Sri Lanka captain Dhananjaya de Silva termed his side's long-awaited victory over England as one of the happiest moments of his career.

"This is one of the happiest moments in my career and my life," said De Silva. "We had a tough time in the last two weeks so to come here and get a win in English conditions against an English team, it is a very good moment for me, my team, and my country as well."—Agency

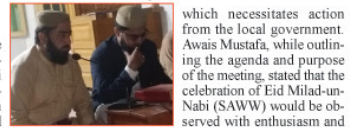

## Sick Passenger On Dhaka-Bound Flight Dies After Emergency Landing In Karachi



KARACHI: A Dhaka-bound flight from Sharjah made an emergency landing at Karachi's Jinnah International Airport on Monday due to a medical emergency involving a passenger. The Pakistan Airports Authority (PAA) spokesperson confirmed that the 42-year-old Bangladeshi passenger's health deteriorated mid-flight, prompting the airline to seek emergency landing approval.

The Pakistan Civil Aviation Authority (PCAA) further clarified that the landing was coordinated by Karachi's Air Traffic Control (ATC) after receiving the pilot's request. Medico-legal formalities were completed, and the body was handed over to the airline. This incident echoes a similar occurrence in February when a Saudia Airlines flight also made an emergency landing in Karachi due to a medical emergency on board a Riyadh-bound flight from Dhaka. In that case, the passenger was treated and the flight resumed its journey.—RT/Agency

## Suspect In Karsaz Accident Appeals Bail Denial In Drug Case

KARACHI: The lawyer representing the suspect in the Karsaz road accident has challenged the judge's decision to dismiss her bail petition in a drug-related case. The appeal was filed in the sessions court, arguing that the magistrate had overlooked key evidence in the bail petition. The suspect, involved in the fatal Karsaz accident on April 19, 2024, has been pardoned by the families of the victims—two deceased and two injured. Despite this, she remains entangled in legal trouble due to drug allegations.

Following the accident, methamphetamine, commonly known as crystal meth, was detected in her blood and urine samples. The Jinnah Postgraduate Medical Centre (JPMC) collected these samples, which led to a separate case being filed against her. According to police, the case was registered based on a fresh medico-legal report, and charges related to the use of prohibited substances were included. The police confirmed that the presence of the banned substance was detected in the suspect's blood samples. The ongoing legal battle continues as the suspect seeks to overturn the denial of her bail.—RT/Agency

## Sindh Assembly Proposes Resolution Against Dastardly Amendments To IRSA Act

KARACHI: Sindh President of the Pakistan People's Party (PPP), Nisar Khuro, presented a resolution in the Sindh Assembly on Monday, opposing proposed amendments to the Indus River System Authority (IRSA) Act and the non-implementation of the 1991 Water Accord.



Addressing the Assembly, Khuro stressed that the people of Sindh will not accept any changes to the IRSA Act without provincial consent, as water remains a provincial subject. He argued that no serving or retired bureaucrat should hold the position of IRSA Chairman and urged the federal government to avoid actions that could weaken the federation. Khuro reminded the assembly that the 1991

Water Accord was signed by all chief ministers, emphasizing that Sindh, being at the tail-end of the river system, has the first right to water under the law. He criticized IRSA for not distributing water according to 'para-II' of the accord, and urged equal water sharing among all provinces during shortages. He noted that many areas in Sindh are receiving water on a rotational basis, which has left lands uncultivated, and called for an end to the discriminatory treatment towards Sindh's water allocation.—RT

## Police Investigate Alleged Strangulation Death Of Woman By Husband In Landhi

KARACHI: A 24-year-old woman, identified as Fatima, was reportedly strangled to death by her husband in Karachi's Landhi area on Monday, according to police. Quaidabad police recovered Fatima's body from her home in Sherpao Colony near Aqsa Masjid. The body was transported to Jinnah Postgraduate Medical Centre for legal procedures. At present, no first information report (FIR) has been filed regarding the case.

Quaidabad Police Station House Officer (SHO) Ghulam Husain Pirzada informed the media that Fatima's death was attributed to strangulation, based on doctors' reports. Her husband has been detained following a complaint from her sister, though he maintains that Fatima died by suicide.

Fatima and her husband married in 2017 and had two children. They experienced marital discord, and the suspect had verbally divorced Fatima three months ago. A local religious scholar had given them a three-month period to reconcile, which expired on Sunday without resolution. The initial investigation revealed that Fatima had recently demanded her dowry and other valuables, leading to a heated argument with her husband. The argument allegedly escalated into her murder. Crime scene investigators found a rope attached to a door, which the suspect claims Fatima used to take her own life. However, circumstantial evidence suggests the incident may not have been a suicide. The police are continuing their investigation and will file an FIR for murder when the victim's sister formally approaches them.—RT/Agency

## Ministers And Senators Criticize Gandapur's Offensive Language At PTI Event

ISLAMABAD: A day after Pakistan Tehreek-e-Insaf (PTI) staged a much-hyped power show in Islamabad featuring fiery speeches and "threats", several federal ministers and senators condemned the main opposition party's firebrand leader Ali Amin Gandapur for his derogatory remarks during his address to the gathering.



"If the founder of the PTI is not legally released within one to two weeks, we will have him freed ourselves," the Khyber Pakhtunkhwa chief minister said during Sunday's event, announcing to hold a rally in Lahore in the face of any obstacles or restrictions in his typical tone.

The former ruling party held a public gathering — aimed at demanding the immediate release of its founding chairman Imran Khan from prison — amid clashes and violation of the rally deadline despite extraordinary security arrangements made by the Islamabad au-

thorities and roadblocks.

Federal Minister for Information Ataulah Tarar said that those who are "holow inside" can only hurl threats.

"[He is] challenging a woman while standing on the stage, while being scared of terrorists" the minister said while condemning the KP government's "failure" to control rising militancy in the province.

While addressing a press conference in the federal capital alongside federal Minister for Kashmir Affairs and Gilgit Baltistan Engineer Amir Muqam, Tarar said that Gandapur vented out his frustration of a failed rally on Punjab CM Maryam Nawaz and institutions.

He also asked the KP chief minister to be serious about his position as the ruler of a province instead of hurling threats.

Meanwhile, Amir in a strong condemnation of Gandapur's statement about the top brass of Pakistan Muslim League-Nawaz (PML-N), said that KP CM badly failed to show his provincial government's performance.

that the PTI was "once again promoting the politics of violence and chaos".

A statement issued by her office read that the Gandapur's threats against institutions were highly "condemnable".

"Does the PTI want the justice system to be run by rallies and gatherings?"

Those who threaten to free the accused with the help of mobs are armed groups, not the political parties," Rehman stated.

"They have not learned from May 9. Do they still think that threats, violence, and anarchy have any place in politics?" she added.

Rehman acknowledged that the PPP's leaders have also served time in prison, but none of its party workers ever threatened to free their leaders with force.

She added that the PTI threatened violence after institutions refused to hold a dialogue with them. —RT/Agency

## New Toshakhana Case Against Imran And Bushra Bibi Reassigned To Different Court

RAWALPINDI: After the Supreme Court's landmark verdict on the National Accountability Bureau (NAB) amendments, an accountability court on Monday transferred the new Toshakhana reference against the PTI founder Imran Khan and his wife Bushra Bibi to a relevant court.



The development was witnessed during a hearing of the incarcerated premier and former first lady's bail petitions in the new Toshakhana reference related to a Jewellery set gifted by the Saudi crown prince.

Accountability court Judge Muhammad Ali Warraich heard the bail pleas of the PTI founder and his wife at a makeshift court in Rawalpindi's Adiala Jail. The ex-PM and his wife were produced before the court.

At the outset of the hearing, PTI founder's lawyer Salman Safdar told the court that the new reference could not be heard by any accountability court under existing laws which came into effect after the restoration of the NAB amendments.

He pleaded with the accountability court to transfer the reference to another court after giving a verdict on the bail petitions.

Last week, a larger bench of the top court headed by Chief Justice of Pakistan (CJP) Qazi Faiz had approved the intra-court appeals filed by the federal government and restored the amendments made to the National Accountability Ordinance, 1999 via the National Accountability (Amendment) Act, 2022.

It was a unanimous verdict by the larger bench which was reserved on June 27.

The Special Secretary of the Establishment Division presented details about the hiring of the sitting MoITT Secretary from the private sector. She informed the committee that 77 applications were scrutinized by a review committee, leading to 15 candidates being shortlisted. Senator Palwasha requested that the criteria for shortlisting the candidates be presented in the next meeting. A senator warned that suspending LDI company operations could lead to significant network disruptions. PTIA officials confirmed that PTIA alone cannot manage the shortfall, meaning network restoration would take time if operations were halted.

The committee urged the federal government to provide a clear policy direction to avoid further complications and potential losses. Members also recommended that PTIA strengthen its legal team, as ongoing court stay orders have delayed proceedings. Without timely court rulings, license cancellations could further exacerbate the situation. —RT/Agency

Following the intra-court appeals against the top court's verdict that struck down the amendments to the NAB law passed by the Pakistan Democratic Movement (PDM) government in 2022 in response to the petition filed by the PTI founder.

Under the amendments, the NAB was restricted to investigate into any graft case worth less than Rs500 million.

Additionally, regulatory bodies operating in the country that the new reference could not be heard by any accountability court under existing laws which came into effect after the restoration of the NAB amendments.

When the judge sought arguments from the NAB prosecution team on the couple's bail petitions today, the anti-corruption watchdog officials opposed it, saying that the accountability court was not authorised to hear Imran and Bushra's bail pleas after the changes in the laws.

The prosecutor representing the top accountability body said that under the amended laws, the reference must be transferred to relevant court to decide on the bail.

After hearing arguments from the defence and the prosecution, Judge Warraich adjourned the hearing for three hours.

Later, the judge announced his verdict on the pleas to transfer the case to a special judge central.

He remarked that the relevant court will now hear bail pleas of the accused in the next hearing on Tuesday (tomorrow).

The accused couple had filed separate petitions seeking post-arrest bail in the new Toshakhana case.

Mentioning the state and chairman National Accountability Bureau (NAB) as parties to the case, both the applications filed through Barrister Salman Safdar under Section 9(b) of NA Ordinance 1999 and Section 497 of Criminal Procedure Code (CrPC) request the accountability court to grant post-arrest bail to the couple to go to their homes in "interest of justice and fair play".

The duo was arrested in the said case on July 13 hours after a district and sessions court in Islamabad acquitted them in the iddat case — also known as the un-Islamic nikah case — which was the last hurdle in the couple's release from jail before the filing of the new cases. —RT/Agency

## PTA Warns Senate of Major Network Disruptions Without LDI Licence Renewals

ISLAMABAD: The Pakistan Telecommunication Authority (PTA) Monday alerted the Senate Standing Committee on IT and Telecom to the imminent threat of severe network disruptions across Pakistan if the licences for Long Distance International (LDI) companies are not renewed at the earliest.



A meeting of the committee, chaired by Palwasha Mohammad Zai Khan, addressed the ongoing issues related to the renewal of Long Distance International (LDI) and Fixed Line Local Loop (FLL) licences.

Chairman of the Pakistan Telecommunication Authority (PTA), Major General (R) Hafaezur Rehman, briefed the committee on the matter, highlighting that the issue primarily affects four companies, including Wateen, which has an extensive fibre optic infrastructure across 24 cities, primarily in Balochistan and interior Sindh.

He said Wateen was also connected to 44 banks and NADRA, making its network critical to the country's communications infrastructure.

Despite a committee also acknowledged that in 2020, companies were permitted to pay their dues in instalments, but the same relief cannot be granted this year.

The committee discussed the Rs54 billion exemption sought by the LDI companies.

It was noted that the former IT Secretary had issued a policy directive on the matter, which was opposed by officials from the Ministry of Information Technology and Telecommunication (MoITT), claiming the directive exceeded the Secretary's authority.

Senator Palwasha Mohammad Zai Khan raised concerns about the potential impact on the national network if these licences were not renewed.

Regarding the payments required from LDI companies, Secretary MoITT suggested getting the stay orders vacated by the court to resolve the matter. The committee called for a clear policy directive from the federal government to prevent similar issues from arising in the future.

The Chairperson also expressed concerns about the accountability of the former secretary of IT, specifically questioning a letter issued in May 2024, where a policy directive was made without Cabinet approval. She requested a list of individuals responsible for overseeing the matter and questioned whether the actions taken were within legal bounds.

The Secretary of MoITT also detailed the meeting on the composition of the PTCL Board, noting that, per federal government directives, the remuneration for government officials on company boards is capped at Rs1 million annually.

The committee also discussed the qualifications and criteria for hiring consultants and advisors, with the secretary explaining that all such

positions were filled on a contract basis.

The Special Secretary of the Establishment Division presented details about the hiring of the sitting MoITT Secretary from the private sector. She informed the committee that 77 applications were scrutinized by a review committee, leading to 15 candidates being shortlisted. Senator Palwasha requested that the criteria for shortlisting the candidates be presented in the next meeting. ## PTI Leaders Issue Unconditional Apology for Gandapur's Comments About Journalists

ISLAMABAD: Journalists staged protests in both the Senate and National Assembly on Monday after Khyber-Pakhtunkhwa Chief Minister Ali Amin Gandapur made objectionable remarks about the media during last night's rally.



The Pakistan Tehreek-e-Insaf (PTI) leadership swiftly issued an unconditional apology.

During the Senate session, journalists boycotted proceedings in protest against Gandapur's speech. PTI Chairman Barrister Gohar personally approached the journalists, offering an apology.

"We respect the entire journalist community," Gohar said. "I extend an unconditional apology for any hurt caused by the chief minister's remarks, which were directed at only a few journalists."

He clarified that the speech was political, adding, "We have no intention of escalating tensions. If we wanted to take the law into our hands, we could have done so by now. There is immense public pressure for PTI founder Imran Khan's release."

Simultaneously, in the National Assembly, parliamentary reporters also boycotted the session.

Leader of the Opposition Omar Ayub, accompanied by Barrister Gohar, visited the media gallery to apologise.

Journalists however demanded a direct apology from Ali Amin Gandapur.

Later, Senators Afnan Ullah Khan and Aon Abbas Bappi also visited the press gallery to reconcile with the media representatives.

## Privatization Of PIA To Be Completed By October, According To Khawaja Asif

## PTI Challenges ECP's Investigation Into Internal Party Elections

LAHORE: Pakistan – Pakistan Tehreek-e-Insaf (PTI) on Monday challenged the Election Commission of Pakistan's (ECP) inquiry into the party's intra-party elections in the Lahore High Court (LHC), media reported.

According to details, PTI Chairman Barrister Ghar Ali Khan filed a petition in the LHC against the ECP for conducting an inquiry into the party's elections.

The petition, filed through lawyer Azhar Bhandari, also challenged the non-return of seized goods during a raid on the PTI office.

In the petition, the party argued that the ECP's behavior towards it is "biased", requesting the court to declare its acts as null and void.

Earlier on September 6, the ECP dismissed all four miscellaneous applications submitted by Pakistan Tehreek-e-Insaf (PTI) in the intra-party election case.

A 10-page decision was issued by the Election Commission of



Pakistan, authored by Sindh's member, Nisar Durani.

PTI's objection regarding the ECP's jurisdiction in the intra-party elections was overruled in the verdict. Additionally, the party requested to delay the proceedings in the case as well as struck down.

The plea to postpone action on intra-party elections until a decision on reserved seats was similarly turned down.

The ECP in its verdict advised the party to approach the court for the return of documents taken from the party of

In May, the ECP raised further objections to PTI intra-party elections, questioning the party's status after 'losing organisational structure'.

On December 22, 2023, the ECP stripped the PTI of its election symbol due to irregularities in its intra-party elections.

The Supreme Court later upheld the ECP order, forcing the party to field its candidates as independents in the Feb 8 general elections.

After the general elections, the party once again conducted its intra-party elections on March 3. —RT/Agency
