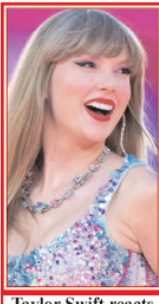

NA Speaker Suspends Sergeant At Arms For Failing In His Security Duties

ISLAMABAD: National Assembly Speaker Ayaz Sadiq on Wednesday suspended Sergeant at Arms Muhammad Ishfaq Ashraf for four months for negligence in security duties.

Four other security personnel were also suspended for the same duration due to their failure in ensuring the security of the House.

The suspended personnel include Security Assistant Waqas Ahmed and three junior security officers Obaidullah, Waheed Safdar, and Muhammad Haroon.

Chairing the House, the Speaker also announced the suspension of five employees of the Capital Development Authority (CDA) who were involved in switching the lights and directed their removal from the duty at the Parliament.

Sadiq called on the political parties to evolve a "charter of parliament" to ensure the smooth functioning of the House. He urged the opposition



members to collaborate with the treasury benches in addressing common issues.

He noted that the opposition members had been given more time to speak in the House, stating that he had acted according to his conscience in handling the issues.

Sadiq also pointed out that during the Pakistan Tehreek-e-Insaf government, the opposition members were denied production orders to attend parliamentary proceedings.

Federal Minister for Maritime Affairs Qaiser

Ahmed Sheikh praised the Speaker for wisely handling the recent issues. He urged the members from both sides of the aisle to focus on highlighting issues being faced by the ordinary people. Sheikh also highlighted the government's achievements on the economic front.

PML-Z leader Muhammad Ijaz UI Haq praised the Speaker for effectively managing the issues in the Parliament. He also suggested that a comprehensive debate should be held on the law and order situation.—RT/Agency

Bilawal Urges PTI To Keep Fighting Imran's Legal Issues But Focus On Parliamentary Responsibilities

ISLAMABAD: Pakistan People's Party (PPP) Chairman, Bilawal Bhutto-Zardari, has criticised the Pakistan Tehreek-e-Insaf (PTI) for leaving the assembly, stating that both the party and the country are suffering the consequences of their decision.

Speaking during a session of the National Assembly on Wednesday, Bilawal said, "I repeatedly advised PTI not to leave the assembly."

"Today, they are suffering, and so is the country."

He urged PTI to continue fighting the legal battle for its incarcerated chairman Imran Khan, but to prioritise serving the people by returning to the parliament.

Bilawal expressed concern over the current state of



politics, adding that the behaviour of politicians has turned politics into something undesirable for the younger generation.

"By watching our conduct, these children will not want to become politicians. We have turned politics into a disgrace," he remarked.

He stressed the need to

fulfil their responsibilities by creating employment opportunities for the youth.

Referring to the political environment, he criticised provincial leaders for engaging in abusive language during rallies instead of solving public issues.

"If a chief minister stands in a rally cursing the govern-

ment and judiciary, he cannot serve his province's people," Bilawal said, pointing to recent remarks made by CM Gandapur during PTI's Islamabad rally.

K-P Chief Minister Ali Amin Gandapur on Monday came under fire for his tirade against journalists during the Pakistan Tehreek-e-Insaf (PTI) power show in Islamabad, several federal ministers and senators condemned the main opposition party's firebrand leader.

"If the founder of the PTI is not legally released within one to two weeks, we will have him freed ourselves," the Khyber-Pakhtunkhwa chief minister said during Sunday's event, announcing to hold a rally in Lahore in

the face of any obstacles or restrictions in his typical tone.

He further stated that PTI's chairman has been in jail for months, urging the party to fight his case in court while continuing to serve the people.

"Politics has reached a point where we don't even shake hands with each other anymore," he said.

Bilawal also called for the formation of a parliamentary committee involving all political parties to address the ongoing issues.

"We can hold rallies, and so can they, but we need to create a parliamentary committee to resolve these matters," he suggested.—RT/Agency

PHC Grants Interim Bail To Omar Ayub And Asad Qaiser In Islamabad Rally Law Violation Case

PESHAWAR: The Peshawar High Court (PHC) on Wednesday approved Pakistan Tehreek-e-Insaf (PTI) leaders Omar Ayub, Asad Qaiser, Faisal Amin and Zartaj Gul's petitions seeking transit bail in connection with cases filed against them regarding the former ruling party's power show in Islamabad on September 8.

Justice Shakool Ahmed of the PHC heard the pleas and granted them bail till October 10.

In their petition, Omar and Qaiser said cases were filed against them and other party leaders by the Islamabad administration for ending the rally two hours after the scheduled time.

The petitioners said that they want to appear in the relevant courts and demanded for transit bail in this regard. The plea also said that they fear their arrest.

Omar, while speaking to media persons today, ques-



tioned the powers behind masked people entering the Parliament to arrest lawmakers.

"This does not work in a democracy. Ayaz Amin Gandapur is the chief executive of the province and he represents 40 million people," said the PTI leader.

The development comes after the Islamabad police launched a crackdown on PTI leaders including Chairman Barrister Gohar Khan and arrested them outside the Parliament House for allegedly violating the newly enacted public gathering law

during the rally. The Islamabad police said PTI leaders Omar and Zartaj would also be taken into custody. Heavy contingents of police were deployed outside the parliament while all entry and exit routes to the Red Zone were also closed from D-Chowk, Nadra Chowk, Serena, and Marriotti, except for Margala Road.

However, Ali Muhammad Khan was not taken into custody by the police when he departed from the parliament.—RT/Agency

ISLAMABAD: Veteran diplomat Amna Baloch has taken charge as the country's 33rd Foreign Secretary replacing Syrus Sajjad Qazi who stepped down after attaining superannuation, the Foreign Office said in a statement on Wednesday.

A Grade-22 officer of the Foreign Service of Pakistan, Baloch was appointed as Foreign Secretary last week — the second woman to be appointed on the said post after Tehmina Janjua.

Federal Government Demands Release Of Dam Funds From Supreme Court

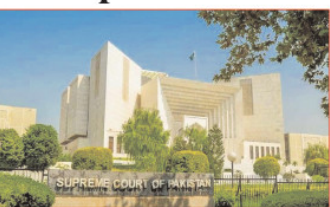
ISLAMABAD: The federal government has demanded release of dams funds from the Supreme Court (SC). A four-member bench headed by CJP Qazi Faez Isa heard the Diامر-Bhasha and Mohmand dams funds case today.

Additional Attorney General Amir Rehman informed the court that a miscellaneous application had been filed and dams funds must be handed over to the federal government and Water and Power Development Authority (WAPDA).

Amir Rehman said that the funds were deposited in the account opened in the State Bank in the supervision of the SC.

CJP inquired about the amount of funds collected for dams. Wapda counsel Saad Rasool informed the court that Rs 20 billion was deposited in dam funds.

CJP inquired how this case was started. WAPDA counsel responded that the SC took the suo-motu in



2018 during proceedings of the Auditor General of Pakistan on the matter of granting funds to the federal government. The SC ordered the appearance of the Auditor general of Pakistan or his authorized officer in the next hearing and provide assistance on the matter of provision of dams funds. Former attorney generals, Khalid Javed and Anwar Mansoor had been summoned. The apex court had also summoned judicial assistant Makhdoom Ali Khan on the next hearing for the assistance on matters pertaining to the dams construction and implementation bench.—RT/Agency

CJP inquired that "does the SC possess every project of Wapda?" Wapda counsel told the court about conflicts between private parties on the construction of dams matter. The SC itself fixed the cases of private parties' disputes for hearing instead of transferring it to relevant courts. Wapda counsel requested to proceed the private parties' disputes matter on relevant court forums.

Following Imran, Shehbaz And Hamza Seek Relief Through Changes To NAB Laws

ISLAMABAD: After incarcerated PTI founder Imran Khan sought relief under amendments to the National Accountability Ordinance 1999 recently restored by the Supreme Court, Prime Minister Shehbaz Sharif and his son Hamza Shehbaz demanded retransfer of Ramazan Sugar Mills reference to the National Accountability Bureau (NAB).

The apex court, on September 6, accepted intra-court appeals filed against the September 15, 2023, majority judgement striking down the amendments to the National Accountability Ordinance.

Approving the intra-court appeals filed by the federal and provincial governments, the top court remarked Imran could not prove that NAB amendments were unconstitutional.

During today's hearing, the father-son duo's counsel argued that the reference against their clients is "inadmissible" after the Supreme Court's verdict and that the "accountability court lacks jurisdiction to proceed in the case". In re-



sponse to the argument, the judge asked the lawyers to file an application for the transfer of sugar mills reference to the anti-graft body. The court added the hearing on the application will be conducted on October 1.

Meanwhile, it also accepted Hamza Shehbaz's plea for exemption from personal appearance.

On February 18, 2019, the anti-graft crusader filed a reference against Hamza and Shehbaz, alleging that the former Punjab chief minister had misused his authority to get a 10km sludge carrier constructed in district Chintot to facilitate Ramzan Sugar Mills, owned by his sons.

The anti-corruption bureau had alleged that the project had inflicted a loss of Rs213 million to the national exchequer.

The reference was reopened in November 2023 after the amendments — introduced by the coalition government of the Pakistan Democratic Movement (PDM) — were struck down.

Earlier, Imran also sought acquittal from the £190 million case under the NAB amendments — which he had challenged.

The deposed prime minister's lawyer told the accountability court in Rawalpindi's Adiala jail that the case was no longer valid after the verdict as all the cabinet decisions are protected in NAB amendments.—RT/Agency

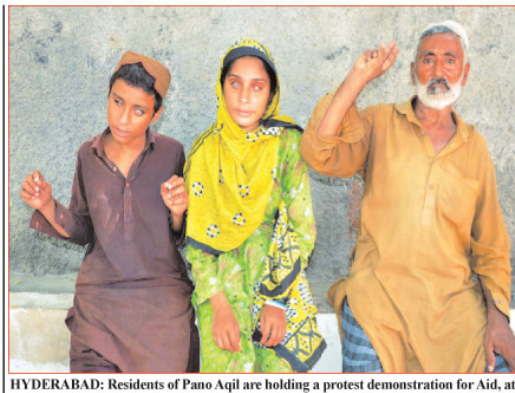

SHIKARPUR: A meeting was held at the Deputy Commissioner's Office in Shikarpur regarding the celebration of 12th Rabi-ul-Awal. Jagirani-Solangi clash settled after three months in Pir Jo Goth

PIR JO GOTH: A resolution has been reached regarding the ongoing deadly feud between the Jagirani and Solangi communities in the vicinity of Pir Jo Goth, Khairpur. The conflict, which has resulted in six deaths and 19 injuries, has now been settled with a fine of 21.9 million rupees imposed on the warring parties. Any further infractions will incur an additional penalty of 5 million rupees. According to the details, the deadly clash between the Jagirani and Solangi communities in the Khairpur district led to severe consequences, including the displacement of several families. Despite efforts by various leaders to mediate between the two communities, the attempts were unsuccessful.

Other dignitaries such as Syed Sadat, Gulshan Solangi, Ashraf Khan Solangi, Mir Israr Khan, Abdul Sattar Jagirani, Abdul Khaliq Jagirani, Syed Ali Haider Shah Rashdi, Ghulam Shabbir Ghumro, Hussain Bux Narejo and Syed Gul Muhammad Shah Rashdi were also present. The decision included a fine of 9.9 million rupees on the Jagirani community for the three murders and 12 injuries in the Solangi community, while the Solangi community was fined 12 million rupees for the three murders and seven injuries in the Jagirani community. The damages were to be covered accordingly. Following the decision, both communities embraced each other and reconciled, resolving their

disputes. This feud had been ongoing for the past three months, involving intermittent firing and creating a state of fear, with schools closed and people confined to their homes. The resolution was overseen by the Hur community's high-ranking officials, including Chief Khalifa Faqir Qadir Bux Mangrio, Khalifa Ali Muhammad Gaho, Khalifa Sultan Faqir Rajar, Khalifa Muhammad Rahim Hingoro, Khalifa Ahmad Saleh Mahar, Khalifa Faqir Muhammad Akram Khoso, and Dewan Topan Das. The session concluded with prayers for peace, brotherhood, and mutual tolerance. The efforts of Pir Sahib Pagara and Syed Muhammad Rashid Shah in resolving the conflict were acknowledged and praised.

HCSTSI President Muhammad Farooq Shaikhani decries ignoring contracts with Independent Power Producers

HYDERABAD: Muhammad Farooq Shaikhani, President Hyderabad Chamber of Small Traders & Small Industry (HCSTSI), has voiced grave concerns regarding the government's negligence in handling the contracts with Independent Power Producers (IPPs). He highlighted that, despite numerous demands and protests, the government's failure to either cancel or reschedule these contracts has plunged the business community into severe difficulties. Shaikhani pointed out that each month, the exorbitant electricity bills are compounded by various taxes, including electricity charges, television fees, general sales tax, income tax, surplus tax, additional tax, retailer sales tax, and fuel price adjustments. These additional costs are exacerbating the financial strain on the public. Furthermore, he revealed that payments to IPPs have surged by 33%, reaching Rs. 2.8 trillion in the new financial year, thus placing an extra burden on consumers. This year alone, the cost of electricity per unit has

risen by approximately Rs. 5, resulting in an added expense of Rs 310 billion. He stated that the escalating electricity prices are crippling industrial activities, leading to the closure of thousands of factories. Despite this crisis, the government persists in subsidizing IPPs and continues to make payments in dollars rather than terminating these contracts. Shaikhani emphasized that these inequitable IPP contracts and the dollar-based payments are placing a substantial burden on the Pakistani economy. Even power plants funded with local currency are receiving payments in dollars. According to NEPRA, 71% of the cost of power generation is being allocated to payments for IPPs, with a significant portion going to inactive power plants. Chamber President Farooq Shaikhani expressed that the current situation has exacerbated Pakistan's debt crisis to an unsustainable level and poses a severe threat to national security. Previously, citizens struggled to pay their household electricity bills, and now the business community faces the same issue with commercial bills. This has led to a significant disruption in business activities and a widespread disturbance in the entire business sector. Shaikhani highlighted that the soaring energy prices and tariffs are the most pressing issue in the country, directly undermining industrialization. Despite a generation capacity of 45,000 MW, only 22,000 MW is being transmitted through the main lines, with consumers still required to pay for unused electricity. Additionally, he pointed out that 56% of the electricity price is being spent on capacity charges, with the government paying Rs. 2 trillion in this regard. He urged the government to make a critical decision, whether to prioritize the interests of IPP owners or to safeguard the welfare of 250 million Pakistanis, who are already witnessing the shutting down of thousands of industries and numerous operations due to exorbitant electricity tariffs. Shaikhani warned that if immediate action is not taken, the escalating prices and mounting bills could overwhelm the entire economic system.

South Korea's Liberal Unification Vision vs North Korea's Two-State Approach

On the 79th anniversary of National Liberation Day, South Korean President Yoon Suk-yeol unveiled the "August 15 Unification Doctrine," focusing on improving human rights in North Korea, ensuring the right to survival, and increasing access to information. The doctrine also aims to rally international support for these initiatives.

In stark contrast, North Korean leader Kim Jong-un has adopted a more aggressive stance, labeling South Korea a "hostile state" and abandoning previous efforts at peaceful unification. During a Party session last year, Kim advocated for unification through military force, vowing to annex South Korea in the event of war. He declared that relations between the two Koreas have shifted to a "complete state of belligerency," fueled by North Korea's nuclear capabilities, and seeks to exploit the emerging Cold War tensions in Northeast Asia.

A key point in President Yoon's doctrine is the emphasis on the "right to know" for North Korean citizens. He

highlighted the importance of access to information, noting that many North Korean defectors and diplomats have testified that increased awareness of the outside world could undermine the regime. Yoon's policy suggests that dismantling North Korea's propaganda machine and exposing citizens to the realities of other nations could foster dissent within the country. In response, Kim Jong-un has taken steps to block the influence of South Korean culture, known as the "Korean Wave" (Hallyu), fearing that admiration for the South could weaken his regime. Measures such as the destruction of the Inter-Korean Liaison Office in 2020, along

Pakistan's Mpox Cases Rise To Six with New Reported Case In KP



PESHAWAR: Another case of the mpox, also known as monkeypox, was reported in Khyber Pakhtunkhwa (KP), taking the total tally of the virus to six in Pakistan, provincial Health Minister Syed Qasim Ali Shah said on Wednesday.

The KP health minister said: "A public health lab confirmed the presence of the mpox virus in the patients' blood samples." "The patient has been quarantined at his home in the Lower Dir area," the minister said, adding that he reached Islamabad from a Gulf country on September 9 and then stayed at a hotel in Peshawar.

This is the sixth case reported in the country this year and the fifth since the World Health Organisation (WHO) declared the recent outbreak of the disease as a public health emergency of international concern after the new variant of the virus was identified in August.

Shah further added: "Next day the patient went to a private clinic for (some) treatment and was then transferred to Khyber Teaching Hospital."

The latest patient is a resident of Lower Dir area of KP, according to the National Institute of Health Islamabad. He was isolated after the screening at the Peshawar Airport and after a medical test, he was confirmed as a carrier of the mpox virus, it added.

Mpox is a virus that causes flu-like symptoms and pus-filled lesions and, while usually mild, it can kill. Children, pregnant women and people with weakened immune systems are all at higher risk of complications, reported Reuters.—RT/Agency

Traffic Police Under CTO Ayesha Butt Create Major Hassles For Gujranwala Residents

GUJRANWALA: The daughter of Gujranwala, SP/CTO Ayesha Butt, has reportedly issued an excessive number of fines, causing distress among the citizens. Previously, people struggled with hunger and electricity bills, but now they are being pushed towards despair due to what they claim are unjustified fines imposed by their own city's officer. Citizens, who once celebrated her appointment with sweets, are now expressing disappointment as traffic jams continue, and many claim they are being humiliated in public to meet the fines quota. Allegations suggest that SP Ayesha Butt's directives have led to an overwhelming number of fines being issued around the CTO office, the DSP License Branch, and other areas. People feel that the government's treasury is being filled at

one case involving a traffic warden named Nadeem slapping a vendor. The city's poor feel increasingly marginalized, unable to make an honest living due to the authorities' actions. Two particular incidents have gained attention: in one, a vendor claims that he and his mentor were falsely accused of possessing drugs and harassed by the DSP after being detained for setting up a food cart without a permit. In another, a street vendor reported being slapped repeatedly by Inspector Nadeem, allegedly for operating without permission. The citizens of Gujranwala are now appealing to higher authorities, including the Chief Minister and Commissioner, for justice. They demand action against the alleged misconduct of the CTO and traffic officers, hoping for an end to the mistreatment of the poor and marginalized in the city.

Conjunctivitis Cases Surge Rapidly Across Punjab

TOKA TEK SINGH: The outbreak of conjunctivitis (pink eye) has worsened across Punjab, with a rapid increase in the number of affected patients and ineffective government measures. Healthcare professionals report a record rise in conjunctivitis cases over the past week. A survey conducted with ophthalmologists indicates a 10 to 15 percent increase in cases within a week, with major cities being particularly affected. Patients suffering from severe eye pain are flooding ophthalmology clinics, and there has been a notable increase in the sale of specific medications for this illness, leading to shortages of some eye drops. Eye specialists report that conjunctivitis causes itching, burning, swelling, and pain in the eyes. Continuous rubbing due to these symptoms leads to redness and watery discharge. The

typical duration of conjunctivitis is about one week, though it can last up to two weeks in some cases. Patients usually experience the most discomfort in the first three days, with symptoms gradually easing afterward. The majority of those affected are students from schools and colleges. Due to insufficient government preventive measures and lack of precautions, the number of patients continues to rise daily. Ophthalmologists emphasize that conjunctivitis is a contagious viral infection, and the belief that it spreads merely by looking at an infected person is incorrect. Instead, preventive measures are crucial to avoid the disease. People should avoid shaking hands with affected individuals, refrain from touching shared items like towels and handkerchiefs, and frequently wash their hands with soap. Infected individuals should avoid physical contact and maintain a safe distance to prevent transmission.

GUJRANWALA: Despite multiple complaints and reports from local residents about factories, kilns, and industrial units releasing toxic smoke and causing air pollution, these facilities are sealed only to be reopened the next day under the protection of the district administration and financial incentives. Factories such as Cannon Metal and Works,

also known as Baw Farukh Ijaz Factory, and other factories, kilns, and industrial units on Sheikhupura Road have not been sealed despite their contribution to air pollution. The factories and industrial units, which continue to emit toxic smoke 24 hours a day, have subjected local residents to severe discomfort, including allergies, asthma, and serious eye problems. Local residents have appealed to the Chief Minister of Punjab, the Secretary/DG of Environment, and the Secretary of Health to take immediate action against the negligent officials and initiate legal proceedings. This is to prevent such misconduct against the poor citizens of Punjab in the future and to ensure that the residents of the affected areas can live in a pleasant environment.

LHC Grants Bail To Minor In Defence Car Accident Case

LAHORE: A Lahore High Court (LHC) division bench on Wednesday granted bail to underage driver Afnan in connection with the Defence car accident case that tragically claimed the lives of six family members.

The division bench, headed by Justice Syed Shahbaz Ali Rizvi, heard the short-bail petition filed by Afnan's counsel arguing that the incident was a car accident and did not justify the inclusion of sections from the Anti-Terrorism Act, though the police had applied them. He further noted that the anti-terrorism court had dismissed the Afnan's bail petition based on inaccurate facts. He highlighted that three of Afnan's friends had been declared innocent during investigations, and the allegations made by the complainant had not yet been proven. He also raised objections to two statements made by witness Zubair Ghaffor, arguing that the witnesses were not present at the scene of the accident. The counsel emphasized that Afnan, being 17 years and six months old at the time of the accident, was classified as a juvenile in the charging-sheet (challan). According to the law, Afnan was entitled to bail, he submitted, requesting the bench to grant bail to his client. In response, the complainant's counsel argued that the witness statements were not relevant to the bail petition. Addressing the complainant's counsel, the bench remarked, "Bail decisions are made based on the evidence available.—RT/Agency"

commitment to maintaining democratic norms. His reminder that "two wrongs do not make a right" underlines the necessity of setting a



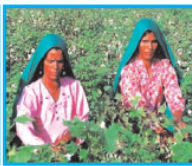
higher standard of governance, even in politically charged times. The suspension of security officials for their role in the arrests demonstrates that swift action has been taken to address the failure of parliamentary security.

Tando Adam's fabric manufacturing industry seeks relief amidst declining conditions

TANDO ADAM: The textile sector plays a crucial role in the economic development of any country, and in Pakistan the textile industry particularly power looms holds a prominent position. This sector is a key contributor to national economic strength and employment. The district of Sanghar in Sindh, especially the city of Tando Adam holds special significance in the textile industry due to its large production of high-quality cotton. The domestic power loom industry in Tando Adam has been established for the past 50 years providing thousands of people with employment, which not only helps individuals stand on their own feet but also brings valuable foreign exchange to the country.



Muhammad Irshad Ansari, the Official of the Pakistan Small Units Power Looms Association, stated that the fabric manufacturing industry and the textile sector play the most crucial role in the national economy.

In Tando Adam, there are over 500 small and large power loom units operating, with approximately 4,000 machines running. More than 3,000 workers are employed daily in these looms, earning their livelihood and supporting their families. He has been forcibly transferred and his salary has been stopped. His son, who is studying in the DVM faculty at the university, could not get admission due to the inability to pay the fees. His son, a congenital insulin-dependent pa-

tient, is experiencing frequent bouts of unconsciousness due to the lack of timely insulin. Additionally, the administration has blocked their medical cards. On this occasion, Assistant Registrar Administration Nizamuddin Bhatti and Lab Assistant Mohammad Bux Mashori appealed to PPP Chairman Bilawal Bhutto Zardari, Sindh Chief Minister Murad Ali Shah, local MPA Sharjeel Inam Memon, and other concerned officials to reverse their transfers back to Tando Jam Agricultural University and to restore their halted salaries so that they can escape the hardship of poverty and continue their children's education.

Taking to Instagram on September 11, the pop icon broke her silence and emphasised the importance of participation in the 2024 U.S. elections.

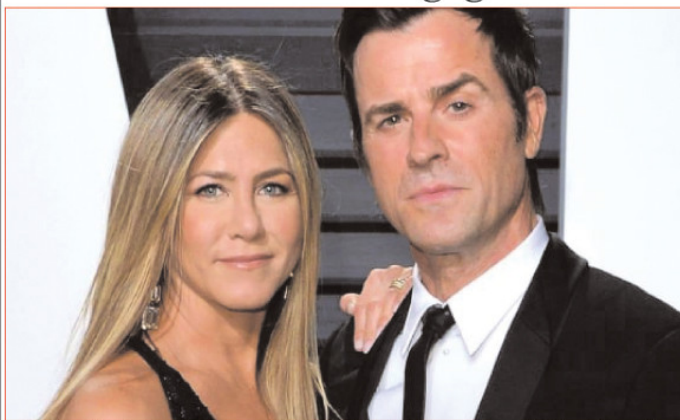

Malir Police seize Iranian diesel, generators and vehicle worth millions of rupees

KARACHI: At the Gadap City police station, under the supervision of SSP Malir Kashif Aftab Abbasi, SP Malir Saeed Randhawa, DSP Memon Goth Ghulam Shabbir Jamali, SHO Malik Saleem, and Kathore Chowki In-Charge Muhammad Khan Abro, the police conducted three separate operations and seized illegal Iranian diesel, generators, and a vehicle worth millions of rupees. In the first operation, police seized 25 large drums filled with illegal Iranian diesel, a Mazda vehicle (number NAG279), four generators, and a drum filled with chemicals near the PSO pump close to DHA City. In the second operation, they confiscated 1,000 liters of illegal Iranian diesel, a diesel tank, a generator, and 200 liters of diesel in drums near the Manzil Hotel in Kathore. The third operation took place at the Bis-

millah Hotel near Kathore, where 200 liters of Iranian diesel and a generator were recovered. SSP Malir Kashif Aftab Abbasi informed District News that following reports of illegal Iranian diesel and petrol trading in various areas of Malir, police raided three different locations within the Gadap police station limits and recovered illegal diesel worth millions of rupees. They also seized a vehicle and five generators. However, the suspects, Ali Sher Talani and others, son of Inayat Shah, have managed to escape, and efforts are underway to arrest them. It is noteworthy that the illegal Iranian diesel trade has been ongoing in the Gadap City police station area for several years, with no previous action taken by any SSP or SHOs. SSP Malir Kashif Aftab Abbasi successfully carried out operations, raiding the illegal Iranian diesel warehouses, and recovered millions of gallons of diesel. Three suspects, Kashif son of Muhammad Ilyas, Allah Bux son of Ramzan, and Naveed Shah, son of Inayat Shah, have been arrested.

Afghanistan Announces Start Of \$10 Billion Tapi Pipeline Project

ISLAMABAD: CHESHMA: Afghanistan said Wednesday work would begin on a \$10 billion gas pipeline traversing South Asia as officials joined dignitaries in neighbouring Turkmenistan to celebrate its completion on that side of the border.



"This project will benefit not only the economies of the countries participating but also the countries of the whole region," the President of Turkmenistan Serdar Berdimuhamedov said in a video broadcast live at the ceremony.

Progress on the TAPI pipeline — running through Turkmenistan, Afghanistan, Pakistan and India — has been repeatedly delayed because of security issues in conflict-ravaged Afghanistan.

Afghanistan, including Herat and Kandahar in the south, before crossing into Balochistan province in Pakistan and ending in Fazilka in Indian Punjab.

Pakistan and India will each purchase 42% of the gas deliveries, and Afghanistan 16%, while Kabul will also benefit from lucrative transit fees of around \$500 million per year, according to Afghan media.

Work on the Turkmen side began in 2015 and was initially scheduled to start in Afghanistan in 2018, but has been repeatedly delayed.

India's commitment to the pipeline has also previously been questioned over its relationship with Pakistan and easy access to liquefied natural gas markets, which are seen as potential stumbling blocks.

It will be pumped through a 1,800-kilometre (1,120-mile) pipeline traversing

Fazl Remains Resolute Against Government's 'Sweet-Talk', Pledges To Oppose Unconstitutional Legislation

ISLAMABAD: Amid government efforts to muster support of its allies and disgruntled partners ahead of potential judiciary-centric legislation, JUI-F chief Maulana Fazlur Rahman has stated that he will not support any legislation contradictory to Constitution and remain part of the opposition.



"I am and will remain part of the opposition," the veteran politician said during a meeting with former senator Muhammad Ali Durrani, who called on him at his residence in Islamabad.

His remarks came days after the veteran politician apparently lowered his rhetoric against the coalition government led by the PML-N after months after accusing it of coming to power via rigging in the February 8 elections.

Addressing the National Assembly session last week, Fazl had said that they had to accept the present "Form 45 or 47" parliament — reference to the alleged manipulation in the election results — and use it to address all the national issues.

Fazl's statement received scathing criticism from the Pakistan Tehreek-e-Insaf (PTI) who termed it an act of legitimising the current regime amid parliamentary cooperation agreement among the two parties.

The JUI-F chief's statement came after former senator Muhammad Ali Durrani held a lengthy meeting with him at the former's residence on the night between Tuesday and Wednesday, sources told media.

During the meeting, both politicians discussed ongoing political issues and future course of action, the insiders added. Durrani also took Fazl into confidence over his political interactions.

Speaking on the occasion, the JUI-F chief claimed that the incumbent rulers would not be able to gain support for a legislation "that contradicts the Constitution of Pakistan and democracy."

Furthermore, he said, the government's existence and its actions were contradictory to the interests of the people.

"Supporting such a government is tantamount to make the people angry," he said. "We want to come into power only with the votes of the people of Pakistan," Fazl said, reiterating that they will not allow anyone to steal

their mandate once again. Durrani, while responding to JUI-F chief's remarks, said that he was "standing on the right side of history", adding that Maulana has always remained "faithful" to political traditions and democratic values.

The development came after the incumbent government stepped up its efforts to woo disgruntled ally Fazl as President Asif Ali Zardari and Prime Minister Shehbaz Sharif held separate meetings with him and sought to assuage his concerns earlier this month.

Before the 2024 general elections, Fazl was one of the closest allies of the PML-N and the PPP and headed the multi-party opposition alliance — Pakistan Democratic Movement (PDM) — which successfully ousted the former premier Imran Khan from office via a no-confidence motion in 2022. —RT/Agency

IHC To Review Imran's Request To Avoid Possible Military Detention

ISLAMABAD: The Islamabad High Court (IHC) has scheduled a hearing on a petition filed by Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan, seeking to prevent his transfer to military custody.



The court's Registrar's Office set the petition for hearing despite objections, with Justice Mianqul Hassan Aurangzeb presiding over the case on Thursday (tomorrow).

Imran Khan had filed the petition expressing concerns over a potential trial in a military court for the May 9 cases. The PTI founder argued that the Pakistan Army had already detained a retired officer (Gen Faiz Hameed), who could testify against him, raising the possibility of his trial under military law.

Khan's legal team urged the court to ensure that he remains under the jurisdiction of civilian courts and not be handed over to the military. The petition cited the federal government, interior and defence ministries, Islamabad and Punjab police, and Adilabad authorities as respondents.

for to military custody have been circulating, with some observers speculating that the former prime minister may face court-martial proceedings. The petition also highlighted media reports on the potential military trial.

At a recent press conference, DG ISPR Lt-Gen Ahmed Sharif Chaudhry addressed these concerns, stating, "The matter is sub-judice, but military law will take its course if anyone uses individuals under the Army Act for personal objectives." Observers believe the remarks alluded to Imran Khan's possible involvement in ongoing military court proceedings.

The case also links to former ISI chief Lt-Gen (ret) Faiz Hameed, who faces multiple allegations, including misuse of authority and collusion with a political party. Khan has expressed concern that he might be implicated in these proceedings, particularly following Faiz's arrest.

The military has maintained that it has no political agenda, with General Sharif emphasising that the Pakistan Army functions in accordance with the Constitution, working alongside the elected government. —RT/Agency

Senate Committee Proposes Amendment Bill To Criminalize Necrophilia



ISLAMABAD: A Senate committee unanimously approved amendments to the Pakistan Penal Code (PPC) on Wednesday, moving to criminalise necrophilia.

Necrophilia refers to having sexual attraction to or committing sexual assault on a dead body. A meeting of the Senate Standing Committee on Interior was convened by Senator Shahadat Awan at Parliament House, attended by Senators Irfan-ul-Haq Siddiqui and Samina Mumtaz Zehri, along with representatives from relevant departments.

The committee was scheduled to review various private members' bills; however, due to the absence of the bill movers, these bills were deferred. Amidst the deferral of most bills, the committee unanimously approved the "Pakistan Penal Code (Amendment) Bill, 2024," introduced by Senator Samina Mumtaz Zehri. It acknowledges the "disturbing trend" of necrophilia in Pakistan, pointing out that other nations have also enacted laws to criminalise the act.

The bill aims to establish a clear legal stance against necrophilia by penalising it under relevant criminal laws. It is amending Section 377 (unnatural offences), which is punishable by life imprisonment. —RT/Agency

ECC Prioritizes Gas Supply For Industrial Sector

ISLAMABAD: The Economic Coordination Committee (ECC) approved a proposal for placing gas use for industrial processes as the first priority alongside domestic and commercial sectors, media reported.



The ECC meeting chaired by Federal Minister for Finance and Revenue Senator Muhammad Aurangzeb also considered other proposals from different ministries.

On the summary of the Ministry of Energy (Petroleum Division) regarding a change in the gas supply priority order, the ECC approved the proposal to amend the existing gas allocation priority by placing gas use for industrial processes as the first priority alongside domestic and commercial sectors.

The gas use for industries using captive power was relegated to a lower priority alongside the Compressed Natural Gas (CNG) sector. "This measure would facilitate the industry using gas in its processes, as they would be included in the top priority category," said a press statement issued here.

(NFSR) ECC took into account the recommendations of the Senate Standing Committee on Finance and Revenue and directed the concerned ministry to arrange the funds through the available budgetary resources and settle the long pending claims. On a proposal of the Ministry of National Food Security and Research for a loan of Rs. 656 million to the Pakistan Cotton Cotto

Committee (PCCC) to enable the organisation to pay salaries and pensions to its employees, the ECC deliberated on the rationale and decided that this entity should be considered for wound-up. —RT/Agency

Abbasi Criticizes Government For Implementing Restrictive Laws Under The Guise Of Democracy

ISLAMABAD: Awam Pakistan Party (APP) Chairman Shahid Khaqan Abbasi criticised the current government, calling it unfortunate that oppressive laws are being enacted under the guise of democracy.



In a press conference on Wednesday, Abbasi accused the government of crafting tough laws to stifle opposition rallies, asserting that true democracy is lacking in Pakistan's capital.

He remarked that members of the National Assembly and Senate are now answerable only to a local SHO and that political parties are subordinating themselves to police officers and deputy commissioners.

Abbasi pointed to the PTI rally on September 8, noting that the government's preemptive and subsequent ac-

tions demonstrated the prevailing political climate. Despite the rally being held outside Islamabad, the government blocked large sections of the city, disrupted internet services, and erected roadblocks, questioning the nature of the democracy in practice.

He also criticised the speeches delivered at the Islamabad rally, describing them as full of accusations

and insults rather than addressing public concerns. Abbasi expressed particular disapproval with the appointment with the language used by the KP chief minister, emphasizing that such conduct undermines democratic values. He stressed that leaders in responsible positions must choose their words carefully, as their statements are closely observed by the public. —RT/Agency

ISLAMABAD: Finance Minister Muhammad Aurangzeb Wednesday called on Saudi Arabia's envoy to Pakistan, Nawaf Bin Said Al-Malki in Islamabad.

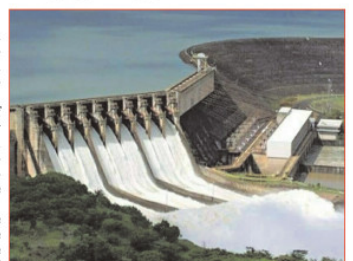
During the meeting, Finance Minister Muhammad Aurangzeb appreciated the Kingdom of Saudi Arabia's "consistent economic support to Pakistan."

Sindh And Balochistan Reject Amendment To Irsa Act

KARACHI/QUETTA: Balochistan and Sindh provinces have jointly rejected proposed amendments in the Indus River System Authority (IRSA) Act.



Irrigation ministers of Balochistan and Sindh, Mir Sadiq Umrani and Jam Khan Shoro in a joint press conference here said, "We jointly reject the amendment in the IRSA Act."

"Amendments in the IRSA Act violation of the constitution and against the provincial autonomy," Sindh's irrigation minister Jam Khan Shoro said.

He said Sindh Assembly yesterday rejected the IRSA amendments in a unanimously passed resolution.

"Under the current law Chairman IRSA becomes by rotation but under the proposed amendment the prime minister will appoint the chairman."

"The amendment in the law allows the PM to nominate the chairman with proposed amendments in law the prime minister could nominate or remove a member of the authority," Sindh's minister said.

He said the water has been a provincial subject, proposed amendments in law are a blow to the provincial autonomy.

Shoro said that after Sindh's political parties today Balochistan has also rejected the IRSA amendments.

The Sindh Assembly in a rare show of unity rejected the proposed amendment to the Indus River System Authority Act, resolving to never give up the province's right on water guaranteed in the Water Accord of 1991. The house unanimously adopted a resolution against the proposed amendment to the IRSA Act-1992, with members terming the proposal against the Constitution and democratic spirit of the federation. The resolution, tabled by Pakistan People's Party member Nisar Ahmed Khuro, demanded the federal government to implement the water accord in true letter and spirit and not change or amend the IRSA law. —RT/Agency

Government To Establish 'Economic Zones' To Stimulate Business Activity: Tanveer

ISLAMABAD: Federal Minister for Industries and Production Rana Tanveer Hussain on Wednesday said that incumbent government was establishing "economic zones" in different parts to boost business activity in the country. "We are working to promote industrial sectors and for this, all necessary steps are being taken to achieve the

objectives," he said while talking to a private television channel. In reply to a question, he said International Monetary Fund didn't raise any condition regarding economic zones. Commenting on constitutional amendment, he said, "we should have a required number of voters in the Houses to bring amendment." "We hope

that leader of Jamiat Ulama-e-Islam Maulana Fazal ur Rehman would support the government to bring legislation and amendment," he added to a question about role of PTI in the current situation, he said Pakistan Tehreek e Insaf (PTI), should avoid wasting time of the public through politics of agitation. —RT/Agency
