## IMF Board To Review Pakistan's \$7 Billion Loan On September 25 Following Fulfillment Of Key Conditions

ISLAMABAD: The International Monetary Fund (IMF) has confirmed that its Executive Board will meet on September 25 to discuss the approval of Pakistan's \$7 billion Extended Fund Facility (EFF). The loan is crucial for stabilising Pakistan's economy, which has been grappling with rising inflation and dwindling reserves.



IMF spokesperson Julie Kozack announced the meeting during a press briefing on Thursday, saying, "We are very happy that we can say now that the board meeting is scheduled for September 25."

This announcement comes after Pakistan secured the necessary financing assurances from development partners. The \$7 billion loan package had been under discussion since May, and a staff-level agreement was reached in July. Despite this, Pakistan faced delays in finalising the IMF Board's approval. The government has had to meet stringent IMF conditions, including the imposition of a record Rs1.8 trillion in new taxes and electricity price hikes of up to 51%.

Among other conditions, Pakistan agreed to halt the establishment of any new special economic or export processing zones. The country also accepted that tax incentives for existing zones would not be extended after expiry. These measures are part of a broader set of industrial policy changes that, critics say, effectively transfer control of key economic decisions to the IMF.

State Bank of Pakistan (SBP) Governor Jameel Ahmad confirmed that the country arranged over \$2 billion in external financing from lenders other than the IMF. "All those assurances and external financing have already been arranged by the government, and I don't see any further hurdle now in taking our case to the board," Ahmad said during an analyst briefing on Thursday.

Prime Minister Shehbaz Sharif, addressing the federal cabinet earlier in the day, praised the progress in negotiations with the IMF. "We are moving in the right direction with the Fund, and I am hopeful for a positive outcome," he said, while also acknowledging the harshness of the imposed measures. The prime minister thanked Pakistan's friendly countries for their support, stressing the need for Pakistan to free itself from dependence on external loans and build a self-reliant economy.

Kozack added that the successful implementation of the nine-month standby arrangement from 2023 had stabilised Pakistan's economy. She pointed to consistent policymaking that had brought about a return to growth, disinflation, and an increase in the country's international reserves.

Despite meeting these tough conditions, Pakistan had struggled to secure a date for IMF board approval, causing concern over the country's economic future. However, the upcoming September 25 meeting offers hope for much-needed relief, with IMF approval potentially unlocking additional financial support from other international partners. Meanwhile, Finance Minister Muhammad Aurangzeb has announced that all matters with the International Monetary Fund have been successfully settled.—RT/Agency

## Imran Khan Condemns Gandapur's 'Vulgar' Comments About Journalists

RAWALPINDI: Incarcerated Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan on Thursday expressed displeasure over Khyber Pakhtunkhwa (KP) Chief Minister Ali Amin Gandapur's vulgar remarks against journalists during a party's September 8 power show in Islamabad by deeming them "inappropriate".



During a public rally in Islamabad on Sunday, which was a major event for the embattled party, Gandapur spewed irresponsible and inappropriate comments about the journalists.

Hurling insults at the newsmen, the KP CM had alleged that a group of journalists were "campaigning against the PTI" besides vowing to "confront" them and asked the party workers to identify and expose them. While denouncing KP CM's act, the PTI founder in a statement said: "Ali Amin Gandapur should not have

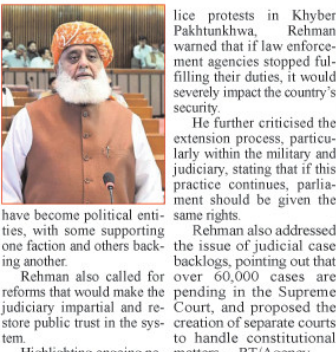
done such a conversation about the journalists." "Ali Amin Gandapur said way too much during his emotional speech," Khan said, adding: "I do not support Ali Amin Gandapur's remarks about the journalists."

Acknowledging the challenges faced by journalists in Pakistan, the PTI founder further added: "The pressure, in which, journalists are working, they are doing jihad." Notably, earlier on Monday, Imran was asked by journalists about Gandapur's

controversial remarks and the use of foul language against media workers at Rawalpindi's Adiala Jail. Responding to it, he expressed ignorance about what the party stalwart said in the speech. Journalists questioned how come the ex-PM was unaware of Gandapur's remarks when he knew all important developments taking place in the country, while being in jail. However, the PTI founder insisted that he is "completely unaware of what is happening outside the jail".—RT/Agency

## JUI-F Chief Questions Military Chief's Extensions, Demands Equal Privileges For Parliamentarians

ISLAMABAD: Jamiat Ulema-e-Islam-Fazl (JUI-F) leader Maulana Fazur Rehman has strongly criticised the practice of granting extensions to military officials, calling it a "flawed" policy that should apply equally to parliamentarians.



Addressing the National Assembly, he recalled how past military extensions were pushed through under pressure and questioned why such a privilege is not extended to lawmakers.

Rehman condemned the current judicial system as "outdated", urging the government to collaborate with the opposition on judicial reforms. He stressed that courts

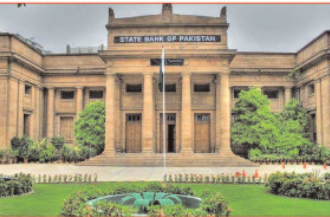
have become political entities, with some supporting one faction and others backing another. Rehman also called for reforms that would make the judiciary impartial and restore public trust in the system. Highlighting ongoing po-

lice protests in Khyber Pakhtunkhwa, Rehman warned that if law enforcement agencies stopped fulfilling their duties, it would severely impact the country's security. He further criticised the extension process, particularly within the military and judiciary, stating that if this practice continues, parliament should be given the same rights.

Rehman also addressed the issue of judicial case backlogs, pointing out that over 60,000 cases are pending in the Supreme Court, and proposed the creation of separate courts to handle constitutional matters.—RT/Agency

## SBP Slashes Policy Rate By 200 Basis Points To 17.5%

KARACHI: The State Bank of Pakistan (SBP) reduced its policy rate by 200 basis points to 17.5% on Thursday, as headline and core inflation saw a sharper-than-expected decline over the last two months.



The rate cut will be effective from September 13, 2024. The Monetary Policy Committee (MPC) of the SBP attributed this decision to falling global oil and food prices and a delay in the anticipated increase in administered energy prices.

The central bank, however, warned of potential risks tied to global economic volatility and domestic energy adjustments, urging a cautious approach to future monetary policies. Inflation fell to 9.6% year-on-year in August, down from 12.6% in June. Core inflation also dropped to 11.9%, reflect-

related to the timing and scale of adjustments in energy tariffs and the course of global commodity prices. The SBP's foreign exchange reserves stood at \$9.5 billion as of September 6, despite weak inflows and continued debt repayments. Remittance inflows and a rebound in exports helped keep the current account deficit contained at \$0.2 billion in July 2024. While the industrial and services sectors are expected to benefit from this policy easing, the agriculture sector faces challenges due to an expected shortfall in cotton production. Nonetheless, the SBP

maintains its projection for GDP growth between 2.5% and 3.5% for FY25. The central bank also reported that tax collection in July and August 2024 fell short of the Federal Board of Revenue's (FBR) target, adding pressure on fiscal policy measures to meet revenue goals for the remainder of the year. This will be critical for maintaining macroeconomic stability, the SBP noted. The MPC reiterated that its cautious stance on monetary policy remains necessary to control inflation while supporting sustainable economic growth over the medium term.—RT/Agency

## Omar Ayub Claims He Was Wrongly Included In FIR For Deceased Individual



ISLAMABAD: "They are so incompetent that a dead man was booked along with me in a case," PTI leader Omar Ayub said on Thursday.

Talking with media, Omar Ayub, the Leader of Opposition in the National Assembly, said that after my tweet they altered the FIR. "I have been booked in three cases and got bail from the Peshawar High Court yesterday," Ayub said. "I G Islamabad has said that the Speaker National Assembly was aware about the Parliament incident," PTI leader said. "What it means to attack the parliament, it must be investigated," he said. "Only suspension of the Sergeant-at-Arms is not acceptable," he further said. "Who were those people, whether they came from Nepal," he questioned. "They are hired men, how can they hold dialogue," he questioned. The opposition leader was talking about recent incident of the opposition PTI party's parliamentarians' arrest from the premises of Pakistan's parliament. Speaker National Assembly Ayaz Sadiq yesterday suspended the Sergeant-at-Arms and four other security personnel of the parliament over negligence in their duty.—RT/Agency

## PM Welcomes 2% Cut In Policy Rate, Predicts Boost In Economic Activity

ISLAMABAD: Prime Minister Shehbaz Sharif on Thursday welcomed the State Bank of Pakistan's (SBP) decision to reduce the policy rate by 2%, lowering it from 19.5% to 17.5%.



He expressed optimism that this move would stimulate exports, investment, business, agriculture, and overall economic growth in the country. While presiding over a meeting of the federal cabinet committee, the prime minister expressed hope that the policy rate cut would gradually decrease to single digits, in line with the country's inflation rate.

Speaking on the ongoing discussions with the International Monetary Fund (IMF), he noted that the negotiations were progressing smoothly. He further highlighted that, as in the past, friendly nations had once again committed to assisting Pakistan during this challenging time. With these developments, Pakistan has now met the prerequisites to secure loans from the IMF.

"Our friendly and brotherly countries have come all the way to support us again," he said.

He thanked the ministry of finance, other concerned departments and the ambassador of Pakistan to China who played important role in getting the support from the brotherly countries. The prime minister stressed that after achieving the goal of macro economic stability, the government will

now take measures to boost GDP growth of the country. As regards the Israel's continued atrocities over Palestinians, the prime minister demanded the global community to stop Israel from doing war crimes in Palestine.

Condemning the Israel's barbarism in strong words, the prime minister said that today, the Israeli forces had killed six staff members of United Nations relief mission in Palestine while it also martyred 17 more Muslims in Gaza.—RT/Agency

## Government Expected To Extend Judges' Retirement Age After Securing Two-Thirds Majority



ISLAMABAD: As soon as the government secures a two-third majority in both houses of parliament, it will make a constitutional amendment to extend the retirement age of the superior court's judges, a government source told media.

The source revealed that the government and treasury benches need just three more votes in the Senate to make an amendment in the Constitution to extend the tenure of superior court judges. But when contacted, Federal Minister for Information and Broadcasting Attallah Tarar neither confirmed nor denied anything. Upon showing inquisitiveness, the minister said he would get back after getting in touch with the law minister. However, he didn't return until filing of this report. The source, however, on condition of anonymity, said the government has already managed a two-third majority in the National Assembly. "We are short of only three votes in the Senate," the source said, adding, "We are expecting to get the magic number any time and as soon as it is achieved, the constitutional amendment will be introduced and passed by parliament." The Article 179 of the Constitution envisages that a judge of the Supreme Court shall hold office until he attains the age of 65 years or is removed from office under the Constitution. Article 195 of the Constitution says that a judge of a high court shall hold office until he attains the age of 62 years unless he sooner resigns or is removed from office following the Constitution.—RT/Agency

## KP CM's Proposal For Talks With Afghanistan Criticized As Attack On Federal Authority By Asif

ISLAMABAD: Defence Minister Khawaja Asif has come down hard on Khyber Pakhtunkhwa (KP) Chief Minister Ali Amin Gandapur's statement about holding direct dialogue with the Taliban government in Afghanistan, calling it a direct attack on the federation.



Addressing an event of the Peshawar Bar Council Association a day earlier, CM Gandapur announced sending a provincial government delegation to neighbour Afghanistan to hold dialogue and settle bilateral issues without waiting for the federal government's approval as his "province is bleeding" due to a surge in terrorist attacks.

KP and Balochistan. KP also witnessed 25 casualties in the 29 terrorist attacks during August. Islamabad has time again called on the interim Afghan government to prevent its land from being used by the banned Tehreek-e-Taliban Pakistan (TTP) and other militant organisations for carrying out attacks against Pakistan.

Asif, speaking on the floor of the National Assembly on Thursday, said that the provincial chief executive must not have given the statement. He added that no province has the authority to negotiate directly with any country, and in this context, the statement made by CM Gandapur, is extremely dangerous. Pakistan has witnessed a spike in terrorist attacks since the Taliban rulers returned to power in Afghanistan in 2021, particularly in the bordering provinces of

Afghanistan earlier this year, to restrict the influx of militants and smuggled goods into the country. Afghanistan does not recognise the Durand Line, the border between the two countries, arguing it was created by the British to divide ethnic Pashtuns. The 2,640km border was established in 1893 through an agreement between British-ruled India and Abdur Rahman Khan, then ruler of Afghanistan. Both countries share 18 crossing points, with Torkham and Chaman being the most frequently used for trade and movement of people. These crossings also connect Balochistan to Afghanistan's southern Kandahar province. In 2017, Pakistan started fencing the border with Afghanistan to contain terrorist cross-border movement, a move condemned by Kabul.—RT/Agency

## Two Murderers Nabbed By Thatta Police

THATTA: The police have arrested two suspects involved in the murder of a man who was killed three days ago in the jurisdiction of Makli Police Station. The victim, identified as Rizwan Samo, was shot dead by unknown assailants on a motorcycle while he was traveling in a Suzuki vehicle near the Makli Temple on the Thatta-Makli Road. Upon receiving the information, SSP Thatta, Dr. Muhammad Inam Khan, promptly took notice of the incident and formed a special investigation team. The team, led by DSP Thatta and consisting of SHO Makli, SHO

Thatta and other technical staff, was closely monitored by SSP Khan. Within three days the police successfully solved the blind murder case apprehending both main suspects, Pyar Ali Brohi and Ali Raza Brohi. During questioning, the suspects confessed to their involvement in the crime.

Investigations revealed that on the day of the incident, Rizwan Samo and his companions were traveling from Makli to Thatta in a Suzuki vehicle. The suspects, passing by on a motorcycle, got into a minor altercation with Samo over a dispute about giving way to each other's vehicles. The argu-

ment escalated, and in a fit of rage, the suspects opened fire, inflicting fatal injuries on Rizwan Samo, a resident of village Khameeso Samo, Thatta. The suspects fled the scene immediately after the shooting. The police team, demonstrating exceptional professionalism, diligence, and hard work, managed to trace and arrest the suspects promptly. SSP Thatta, Dr. Muhammad Inam Khan, praised the police team for their swift and effective operation, announcing that they would be awarded commendation certificates and cash prizes for their efforts. The investigation into the case is still ongoing.

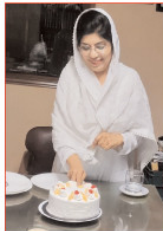
the media. He stated that Sindh has the first right to the waters of the Indus River since it is the lower riparian province.

## Khairpur Celebrates Lawyer Razia Danish's Birthday

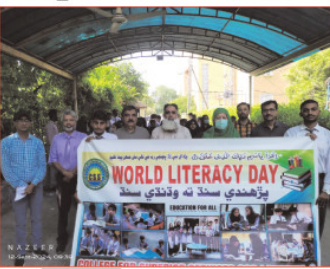

MIRPURKHAS: The Divisional Director of Information Mirpurkhas, Shehzad Shaikh, emphasized that democracy is essential for journalism. He stated that strengthening democracy is crucial for the freedom of the press. He expressed these views while addressing a training workshop organized by the Mirpurkhas Union of Journalists and the Pakistan Federal Union of Journalists (PFUJ), in collaboration with the National Endowment for Democracy and the International Federation of Journalists. Shehzad Shaikh further highlighted that for a free press, journalists need to be mentally and physically independent. Sheher Bano, Vice

President of the Pakistan Federal Union of Journalists and coordinator of the program, informed the participants that journalists are facing severe challenges in the current situation, and training programs like these are being held to help them overcome these issues.

Expert trainer Zubair Ashraf enlightened the participants about labor laws and journalists' rights, noting that journalists can only claim their rights if they are aware of the relevant laws. Junaid Khanzada, Vice President of the PFUJ, reiterated that the union is committed to protecting journalists' rights. He mentioned the PFUJ's strong campaigns against restrictions on press freedom, the killing of journalists, and actions that cause job losses in the industry, vowing never to compromise on press freedom. PFUJ leader Shahid Ghazali discussed the decline of print media and the challenges it

faces, noting that the issuance of licenses to private channels and the rise of social media have had a detrimental impact on print journalism. Mirpurkhas Union of Journalists President Qamaruddin Shaikh, General Secretary MA Rehmani and Program Coordinator Saleem Shaikh thanked the participants and the PFUJ training team. At the end of the workshop, certificates were awarded to journalists from Mirpurkhas, Digri, Jhuo, Mithi, Kunri, and Umerkot by PFUJ, IFJ, and NED. Journalists such as Hayat Qureshi from Mirpurkhas, Sajad Ali Qaimkhan from Umerkot, Qaisar Raja from Jhuo, Ashfaq Ahmed Ashfi, Sajid Yousef Qaimkhan, Imran Asad Qaimkhan, Sajid Bajir from Mithi, Ali Gul Rind, and others presented a detailed review of the challenges faced by journalists in interior Sindh. Later, other speakers also presented their papers.

## SU Opens Admissions For New Bachelor's Programs

JAMSHORO: The admissions to various bachelor degree programs and third year fifth semester are underway at the University of Sindh Jamshoro and its constituent campuses for the academic year 2025. The last date to submit online application forms is fixed on September 17, 2024. Candidates who have completed their intermediate (higher secondary) education or awaiting results are eligible to apply for ad-

missions to bachelor degree programs. Students in the latter category can upload their first-year mark sheets during the registration process. Applicants must deposit the admission processing fee through a self-generated challan during filling out online forms.

The challan can be deposited at any branch of Habib Bank or via mobile app as per the instructions mentioned on it. In this regard, Director Admissions Professor Dr. Ayaz Keerio in-

formed that online registration for admissions is ongoing and will continue till September 17, 2024. He highlighted the convenience of the online form submission, allowing candidates to apply 24/7, even on weekends. He also urged interested students not to wait until the last date and to submit their applications as early as possible. He reassured that candidates awaiting their second-year results are also eligible to apply for admission through the online portal.

## Aleema Khan Exposes Imran Assassination Plot In Jail

LAHORE: Aleema Khan, the sister of former Prime Minister and Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan, claimed that there is a plan to eliminate her brother while he is in prison, drawing parallels to the death of Egypt's former president Mohamed Morsi.

In a post on the social media platform X (formerly known as Twitter) on Thursday, Aleema Khan alleged that Imran Khan has been informed of a plot to assassinate him while he is incarcerated, following a pattern similar to Morsi's death in custody in 2019. She further claimed that her family received credible information from reliable sources regarding a decision to target the former prime minister. "Our family would like to address those behind this plot. Look at history and understand what happened to the Pharaohs and others who employed similar strategies. Under General Bajwa's tenure, there was an attempt on Imran Khan's life in Wazirabad. During General Asim Muniir's tenure, the



Inter-Services Intelligence (ISI) took control of the Islamabad Judicial Complex, preparing to eliminate him. She went on to allege that the ISI is currently in control of Adiala Jail, where her brother is being held. "Can you explain to the millions praying for his release why Imran Khan believes there is a plan to finish him off in jail, just as they did with Morsi in Egypt?" she asked in her post. The allegations made by Aleema Khan have sparked concern among PTI supporters, though there has been no official response from authorities regarding the claims.—RT/Agency

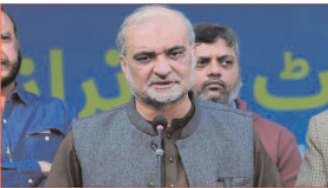
## Irfan Siddiqui Warns Of Looming Anarchy In Pakistan

## Quetta Cop Kills Blasphemy Suspect In Custody

QUETTA: A Quetta police officer killed a man being held in custody on suspicion of blasphemy charges, police officials said on Thursday. Quetta Senior Superintendent of Police (SSP) Muhammad Baloch said that the police officer accused of the killing had been arrested. The officer had accessed a police station where a man accused of blasphemy was being held by pretending he was his relative before opening fire on him. The man accused of blasphemy had been taken into custody earlier in the week and moved to a more heavily fortified station due to an enraged mob demanding that he be handed over to them. At the time, protesters belonging to the Tehreek-e-Lab-

baik Pakistan (TLP) and other religious parties had blocked traffic on the western bypass by placing burning tyres on the road and staged rallies in several parts of the provincial capital. They later hurled a hand grenade at the Kharotabad police station, which exploded outside the police station. No human loss was reported in the attack. "We have registered an FIR (first information report) against the blasphemy suspect and arrested him soon after receiving information about the incident," a senior police officer said. According to the complaint, a resident of Kharotabad used objectionable words against the Holy Prophet (peace be upon him). His alleged phone conversation was viral on social media, triggering sharp criticism and protests. The police informed the protesters that an FIR was registered against him under Sections 295C and 34 of the penal code and investigation was underway. Officials of the district administration and senior police officers after negotiations with the TLP leaders later managed to disperse the crowd and the western bypass was reopened. The TLP later rallied in other parts of Quetta and marched on different roads carrying placards and banners inscribed with their demands.—RT/Agency

## Gojra Municipal Committee Caught Installing Illegal Power Lines

TOBA TEK SINGH: The Punjab Government's own house faces electricity theft allegations with the municipal committee itself caught stealing electricity. FIA and FESCO officials conducted a joint raid and caught the municipal committee administration red-handed, cutting off three meters and suspending the electricity supply. According to the details, electricity theft was discovered within the Punjab Government's jurisdiction. The Gojra Municipal Committee administration was found to be stealing electricity. The raid was led by FIA Faisalabad Inspector Amir Shehzad and FESCO Gojra's Executive Engineer Nasir Abbas, following a tip-off. The municipal committee was caught stealing electricity by directly connecting wires from the main



power line behind the committee's office. The raid team disconnected three meters from the municipal committee and suspended the electricity supply. During the raid, Municipal Committee Administrator Assistant Commissioner Nauman Ali Dogar and Chief Officer Ishiaq Gondal fled the scene upon seeing the raid team. The sudden arrival of the team created panic among other municipal employees, who also

fled after their officers escaped. On this occasion, FESCO Gojra's Executive Engineer Nasir Abbas told local journalists that strict action would be taken against those responsible for the electricity theft, and all dues would be recovered after identifying the culprits. FIA Faisalabad and FESCO Gojra officials participated in the raid, and as of the latest reports, raids were ongoing at other localities as well.

## Bannu Police Protest After Polio Teams Attacked

BANNU: More than 100 police personnel who provide security for polio vaccination teams in Khyber Pakhtunkhwa's Bannu district went on strike on Thursday after a string of deadly militant attacks this week. Police officers who are routinely deployed to protect polio workers going door-to-door frequently

come under attack by militants waging a war against security forces. Hundreds of police and polio workers have been killed over the past decade. "Any constable who learns of the protest is leaving their polio duty to join the demonstration," said a police officer at the sit-in who asked not to be named. He told AFP that negotiations have failed between the protesting police and senior officials in Bannu. Since the launch of the latest vaccination drive on Monday, at least two police officers and one polio worker have been shot dead in separate attacks in rural districts near the border with Afghanistan, including one officer escorting a team on Thursday.—RT/Agency

## PTA Shuts Down 465 SIMs In Katcha Crackdown

ISLAMABAD: Minister of State for Information Technology and Telecommunication Ms Shaza Fatima on Thursday told the Senate that the Pakistan Telecommunication Authority had blocked some 465 SIMs used by dacoits in the Katcha areas of Sindh, including the districts of Shikarpur and Ghotki. Replying to a question of Senator Haji Hidayatullah Khan in the House, she said that

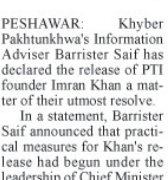

## Greed Over Lives: The Shah Faisal Colony Tragedy Exposes Karachi's Rotten System

The recent fire in Karachi's Shah Faisal Colony No. 3 is a grim reminder of the rampant corruption and indifference that plagues our system. A man lost his life, not due to an unfortunate accident, but because of a lethal combination of greed and systematic rot. The unauthorized petrol pump that caused the fire had been the subject of multiple complaints from residents, all of which fell on deaf ears. It was a disaster waiting to happen.

Ten families in the building had repeatedly

demanded the removal of this ticking time



bomb, and yet, nothing was done. Despite the authorities sealing the illegal pump, it reopened within a week—a direct result of the owner's brazen claim that he had officials in his pocket. This is the harsh reality of Karachi: lives can be bought and sold for bribes, and the people who are supposed to protect us are often complicit in the crimes

that endanger us.

Siraj, the victim, was just getting a haircut when the fire broke out. He wasn't even involved in the ongoing dispute between residents and the pump owner. His life was snuffed out because the very system that should have safeguarded him allowed this illegal operation to flourish unchecked.

We must demand justice, not only for Siraj but for the residents whose warnings were ignored. This tragedy must serve as a wake-up call to end the culture of bribery and negligence that places innocent lives in peril.

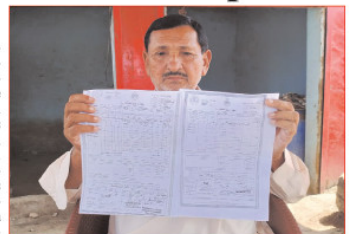

Previously, Sharjeel Memon had announced the introduction of a "Pink Taxi" service for women in Karachi. Speaking to the

media, Memon, who also oversees the information ministry, shared that the women-only taxi service will be launched under the Sindh Mass Transit Authority in its initial phase. He added that the pink taxis will be driven by women, equipped with cameras for safety, and launched under the directives of PM Bilawal Bhutto Zardari.—RT

## NEPRA Slaps K-Electric With Rs10M Fine Over Electrocution Deaths



ISLAMABAD/KARACHI: The National Electric Power Regulatory Authority (NEPRA) has fined K-Electric (KE) Rs 10 million for electrocution incidents in Karachi between 2022 and 2023, which claimed the lives of 33 people.

NEPRA dismissed K-Electric's response to the show-cause notice and ordered the utility to pay the fine within 15 days.

Additionally, NEPRA directed KE to provide Rs3.5 million in compensation to the families of each victim.

The authority also instructed the company to offer a job to a family member of Muhammad Aslam, one of the victims.

In response, K-Electric stated that NEPRA's investigation found no negligence on its part in 32 of the 33 cases.

"K-Electric has been fined for an unsatisfactory response in one incident. We will issue a formal response after a detailed review of the report," the company said.—RT/Agency

## Kamran Tessori Pushes For Public Holiday On 11th Rabiul Awwal

KARACHI: Sindh Governor Kamran Tessori has appealed to Prime Minister Shehbaz Sharif and Chief Minister Murad Ali Shah to declare a public holiday on 11th Rabiul Awwal.



In a letter addressed to both leaders, Tessori suggested the holiday be observed nationwide and in Sindh, noting that religious scholars had made this request during a recent meeting.

He emphasized that the holiday would enable devotees to participate fully in religious events celebrating the birth of the Holy Prophet Muhammad (PBUH).

Tessori added that declaring the holiday would demonstrate collective respect for this sacred occasion by both federal and provincial governments.

The governor expressed optimism that his proposal would be considered.

In a related move, Tessori also wrote to the Chairman of PEMRA, urging the authority to ensure that cable operators refrain from broadcasting entertainment content until 12th Rabiul Awwal in the honor of Eid Milad-un-Nabi.—RT/Agency

## Nationwide Push To Empower Local Governments, Boost Democracy

KARACHI: Starting August 1, 2024, a new initiative titled the Strengthening Local Governments and Promoting Democracy (SLGPD) project has been launched to enhance democracy and local governance across Pakistan. The project is being implemented by the Legal Rights Forum, Aawaz CDS, and the Pakistan Development Alliance, and will run until June 2025 in key cities including Islamabad, Lahore, Peshawar, Quetta, and Karachi.



Initial meetings for the project's rollout have begun, with the first gathering involving Sindh Assembly's Leader of the Opposition, Ali Khurshidi. Legal Rights Forum CEO Tahir Malik, and Program Manager Shireen Aijaz. They discussed ways to improve the project and ensure effective implementation.

Legal Rights Forum has requested that Provincial Assembly members be nominated for the program so that specialized training sessions can be organized. Ali Khurshidi assured that he would nominate representatives, including female MPs, minority members, and committee participants.

The SLGPD project is focused on empowering local governments by enhancing parliamentarians' understand-

ing of constitutional and financial reforms. It aims to improve local governance and help resolve public issues more efficiently. Further meetings with government officials and the Mayor of Karachi are planned to discuss the project's progress.

MPs Shariq Jameel, Mahesh Kumar, Tahana, Anil Kumar, and Najm Mirza were also present alongside the opposition leader during the meeting.—RT

KARACHI: A woman and her two young daughters tragically drowned in a water tank in Karachi.

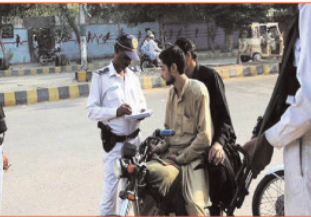
Rescue teams confirmed that the bodies have been transported to the hospital.

## Pillion Riding Ban Enforced Across Karachi, Other Cities



KARACHI: The Sindh government has imposed a ban on pillion riding in several districts, including Karachi, to ensure law and order during processions and Rabiul Awwal gatherings.

The provincial home department issued a notification detailing the restrictions, which will take effect from tomorrow in various districts.

The ban will apply to cities such as Karachi, Hyderabad, Larkana, Nawabshah, Sukkur, Kashmore, Khairpur, Dadu, Qambar, Shahdadkot, and Ghotki. In Karachi, the ban will be enforced in District South on September 13, 14, 16, and 17, in District East on September 13, 16, and 17, and in District West on September 16 and 17.

Hyderabad will implement the ban from the 12th of Rabiul Awwal, while Dadu will observe it on September 16 and 17. Nawabshah and Sanghar will enforce the restriction on September 17.

Similarly, pillion riding will be prohibited in Sukkur on September 16 and 17, while in Khairpur and Ghotki, the ban will be in place from September 13 to 17.—RT/Agency

## Bribery Tied To Illegal Petrol Pump In Shah Faisal Colony Tragedy

KARACHI: One person tragically died after a fire erupted at an illegal mini petrol pump located in a residential building in Shah Faisal Colony No.3, Karachi, according to reports on Thursday.

Local residents revealed in an interview that they had repeatedly lodged complaints with the Assistant Commissioner of Korangi about the illegal petrol pump operating in their building.

The building houses 10 families, all of whom submitted a formal request for the removal of the unauthor-

ized pump and called for a complete ban on such operations.

Residents further claimed that while the petrol pump was sealed by authorities, it reopened within a week.

The pump owner allegedly boasted, "No one can shut down my business because I pay off the DC, AC, and police."

According to eyewitnesses, the victim, identified as Siraj, was visiting a nearby salon when the fire broke out, causing him to suffocate to death inside the shop.—RT/Agency

## IHC Requests Federal Government's Position On Potential Military Trial For Imran Khan

ISLAMABAD: The Islamabad High Court (IHC) on Thursday sought clarification from the federal government over the prospects of Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan's military trial over his alleged involvement in the May 9 riots which witnessed military installations being vandalised following his arrest in a graft case last year.

"The PTI founder is a civilian [and] the military trial of a civilian is a matter of concern for the petitioner as well as the court," IHC's Justice Mianqul Hassan Aurangzeb said while hearing Khan's plea filed under Article 199 of the Constitution on September 3 amid speculations hinting at his trial in a military court.

The former prime minister's pleas came against the backdrop of statements by government high-ups including Defence Minister Khawaja Asif and Law Minister Azam Nazeer Tarar

which have fuelled such rumours. Commenting on the ex-PM's legal woes earlier this week, Asif had told a private news channel that it was becoming clearer day by day that the former prime minister would face a military trial based on "evidence against him".

It is pertinent to know that in July, an anti-terrorism court in Lahore — in a four-page written verdict — said that reasonable grounds existed to connect the PTI founder with the May 9 in-

government and inform the court on Monday.

"Is the PTI founder's military trial under consideration? If there's nothing as such then the plea will become ineffective. However, if it is then we [court] will hear the case and decide upon it," Justice Aurangzeb noted while pointing out that a decision of the SC on civilians' military trials exists already in response to additional AG's request for a decision on the objections raised on Khan's pleas, the judge said that he was re-

moving the objections raised by the IHC registrar's office. He was referring to the objections that the petitioner neither mentioned any specific information report (FIR) nor any documentation or order was attached to the petition and questioned how a petition be filed in a high court while the matter of military trials is sub-judice in the Supreme Court.—RT/Agency

Expressing his views during the hearing today, Justice Aurangzeb remarked the petitioner has referred to a statement issued by the director general Inter-Services Public Relations (DG ISPR) and said that if it is such, then the federation should present its clear stance on the matter. "Today if we [court] say that there's nothing [on the matter] and [then] tomorrow you produce an order for a military trial, what would happen then?" the judge said while directing the additional attorney general to take instructions from the federal

## PTI MNAs Arrested On Parliament Grounds Presented In National Assembly

ISLAMABAD: At least 10 Pakistan Tehreek-e-Insaf (PTI) Members of National Assembly (MNAs), who were arrested from the premises of Parliament House in a late-night raid for allegedly violating newly-enacted public gathering law, were brought to the lower house on Thursday after their production orders were issued by Speaker Ayaz Sadiq.

In the fresh crackdown on Monday, the law enforcement agencies (LEAs) and "masked men" — after late night — allegedly entered the Parliament House and whisked away at least 10 lawmakers of the jailed former prime minister Imran Khan's party.

A number of cases were filed against PTI leaders, which also include the reported attack on police at Chongi No 26 — which turned into a battleground as PTI workers and law enforcers clashed after the former deviated routes leading to Sangiani, venue of public gathering.

The arrests drew scathing criticism from the former ruling party but from the speaker as well as some members of the treasury benches.

Subsequently, Sadiq suspended five security staff, including the lower house of parliament's Sergeant at Arms Muhammad Ishaq Ashraf, for four months over failure to ensure the house's

security. He also issued production orders of the PTI MNAs in police custody — Malik Aamir Dogar, Zain Hussain Qureshi, Waqar Akram, Sher Afzal Marwat, Muhammad Ahmed Chatta, Zubair Khan Wazir, Owais Haider Jakhra, Syed Shah Adad Ali Shah, Naseem Ali Shah, and Muhammad Yusuf Khan.

Following the orders, the federal police presented them in the lower house of parliament today amid high security. A heavy contingent of police also reached the House along with the detainees.

Speaking on the NA floor, PTI firebrand politician Marwat thanked the speaker for issuing their production orders. "The police have not returned my personal pistol and five Kalashnikov — kept in car at the time of arrest."

Rejecting the cases registered against him, Marwat said he was booked for tearing uniform of a police officer. On the other hand, Leader

of Opposition Omar Ayub condemned the "storming of Parliament" by masked men, demanding NA Speaker to investigate the matter. "The Constitution and law have been violated," he said, asking how the Islamabad police chief dared to arrest the parliamentarians. "How a DSP [deputy superintendent of police] showed a pistol to Marwat?"

The opposition leader further said that the lawmakers were arrested and thrashed, adding the "masked men" had said they don't follow law.

He also asked the speaker how the law enforcers got keys of lawmakers' lodges. "Mr Speaker, who gave them the keys," he said, noting that suspension of security officials would not make a difference.

Meanwhile, the Islamabad High Court (IHC) has suspended the physical remand of the arrested lawmakers and adjourned the hearing till tomorrow.—RT/Agency

## Federal Cabinet Approves Initiative To Enhance Gwadar Port Operations

ISLAMABAD: The Federal Cabinet on Thursday approved a proposal by the Ministry of Maritime Affairs to direct all government departments to route 50% of their imports, such as wheat, sugar, and fertilizer, through the Gwadar Port.

Earlier, the prime minister had issued the directives to increase the Gwadar port operations to ensure development and prosperity of the Balochistan province. He also directed that 50% of all public sector imports should be ensured through the Gwadar Port. The meeting of the cabinet was held under the chairmanship of Prime Minister Shehbaz Sharif. The cabinet also instructed to increase the volume of exports from Gwadar Port in the future. A subcommittee of the cabinet will be formed to submit a quarterly report on imports and exports through Gwadar Port to the cabinet. The cabinet, on the recommendation of the Ministry of Communications, approved the signing of a Memorandum of Understanding between Pakistan and Sri Lanka for the issuance of a commemorative postal stamp to mark the 75th anniversary of diplomatic relations between the two countries. The Ministry of Industries and Production presented a report from the Cabinet Committee on Sugar Exports. The cabinet ex-

pressed satisfaction that, due to a well-timed decision on sugar exports, the country not only earned valuable foreign exchange, but sugar prices remained stable, and sugarcane farmers were adequately rewarded for their efforts. The cabinet, on the recommendation of the Ministry of Maritime Affairs, also approved the reconstitution of the Board of Directors of the Korangi Fish Harbour Authority, Karachi. The cabinet instructed that all provinces should be given representation on such government boards. Additionally, the cabinet directed that any government-owned corporations with incomplete boards should be fully constituted as soon as possible. On the recommendation of the Ministry of National Health Services, the cabinet approved the appointment of Muhammad Yaqoob, Assistant Director of the Drug Regulatory Authority of Pakistan, as the Federal Inspector Drug Balochistan. Likewise,

## Pakistan Seeks \$1.2 Billion Saudi Oil Facility For One Year

ISLAMABAD: In a bid to bridge the \$2-2.5 billion financing gap pointed out by the International Monetary Fund (IMF) for the ongoing financial year, Pakistan has requested Saudi Arabian authorities for \$1.2 billion Saudi oil facility (SOF) for the next 12 months, official sources told media.

The publication, on Thursday, reported that a finance ministry handout did not mention anything regarding the matter. A staff-level deal was signed with the IMF under the \$7 billion Extended Fund Facility (EFF), however, it is yet to be put before the Fund's Executive Board for the loan's approval.

Meanwhile, the Saudi Arabian government wants to procure 15% stakes in the Reko Diq project through investment in two phases; nonetheless, the transaction in this regard has not been made so far.

On the other hand, the Islamic Development Bank's ITC facility has also been requested to provide \$400 to \$500 million loan. In addition, the Gulf commercial banks as well as the Standard Chartered Bank (SCB) have also been requested for \$1 billion loan.

Besides fulfilling the additional financing of \$2.5 billion, Pakistan is also asking three bilateral creditors to roll over \$12 billion deposits lying with the State Bank of Pakistan.

The country also requires commercial re-financing of \$4 billion during the current fiscal year to meet the total requirements of \$26.2 billion for the ongoing fiscal year.

According to an official statement issued by the finance ministry, Federal Minister for Finance and Revenue Senator Muhammad Aurangzeb reaffirmed Pakistan's commitment to a homegrown economic agenda centered on comprehensive institutional reforms across key sectors of the economy. The minister made these remarks during a meeting with Saudi Ambassador Nawaf Bin Said Al-Malki, who called on him at the Finance Division on Wednesday.—RT/Agency

## Imran Khan Calls On PTI To Prepare For Nationwide Street Movement Under The Banner Of 'Jihad For Democracy'

ISLAMABAD: Imran Khan, the founder of Pakistan Tehreek-e-Insaf (PTI), has urged his party to prepare for a nationwide street movement, declaring that the fight is necessary to safeguard the country's freedom.

Speaking to journalists at Adiala Jail on Thursday, Khan said, "Our movement is a jihad for democracy. I call on the entire nation to take to the streets to save our freedom."

Khan accused Special Judge Humayun Dilawar of being behind his and his wife Bushra Bibi's imprisonment. "Humayun Dilawar was gifted land worth billions in return for his decisions against us. Khyber Pakhtunkhwa's Anti-Corruption department holds all the evidence, but now the FIA has filed a case against them."

He also criticised Interior Minister Mohsin Naqvi, alleging that Naqvi was rewarded with key positions including interior ministry and PCB chairmanship for his role in the government's crackdown on PTI. "Naqvi committed the worst atrocities against us, including the brutal killing of Zille Shah by the police. His body was dumped on the road, and an

FIR was lodged against me," Khan said. Khan further condemned Chief Justice Qazi Faez Isa, accusing him of protecting those responsible for PTI's oppression. "Justice Isa stripped us of our electoral symbol and refused to hear our petitions on human rights violations."

The former prime minister expressed concerns over electoral fraud, saying, "The former Rawalpindi commissioner held the chief justice and Election Commission of Pakistan (ECP) accountable for the rigging, yet Chief Justice Isa will be given an extension."

Drawing a parallel to historical events, Khan likened the current political situation to that of Yahya Khan's era, accusing the powers that be

of prioritising personal interests over the nation. "Nawaz Sharif has been kept in custody with a scare, otherwise he would have fled long ago. The entire nation must rise for a street movement to preserve our freedom," Khan urged, adding that the rule of law is essential for attracting investment to Pakistan.

He concluded by announcing that PTI's street protest plans will be revealed soon, while also highlighting ongoing injustices, including the abduction of Saadullah Baloch's wife and daughter. "They have entered the assemblies and arrested parliamentarians. This has never happened before, and my wife's imprisonment is also illegal."—RT/Agency

## Court Dismisses Imran Khan's Request For Acquittal In £190 Million Case

RAWALPINDI: An accountability court on Thursday turned down Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan's acquittal plea in the £190 million case.

The decision was announced during the hearing in Rawalpindi's Adiala Jail after arguments of all the parties were heard in the case.

The court fixed September 13 (tomorrow) as the date to cross-examine the investigating officer, who is the last witness of the reference.

The accountability court on September 10 had adjourned hearing of the plea seeking exoneration of the incarcerated former prime minister along with his wife in the case till today.

Previously, Khan and his spouse Bushra Bibi had appeared before the court during the hearing conducted by accountability court Judge Nasir Javed Rana at Rawalpindi's Adiala Jail.

The couple is accused of causing billions of rupees loss to the national exchequer. Last week, the court had reserved verdict on Bushra's acquittal plea in the said case. 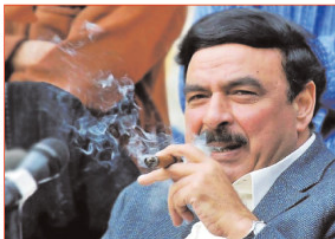

ISLAMABAD: Former interior minister and Awami Muslim League (AML) chief Sheikh Rashid Ahmed has reiterated his stance on the September 30 deadline, stating that the nation will soon know whether a "charter of democracy" is being formed or whether it's "the death of democracy."

Last month, Sheikh Rashid had predicted that a technocrat government will take control of the country by September 30. The former interior minister had claimed that the "intervention process" for installing the technocrat setup had already begun.

Speaking to the media outside an anti-terrorism court in Rawalpindi on Thursday, where he appeared in connection with the May 9 cases, Rashid criticised the current state of governance. "Democracy has been

stripped bare on Constitution Avenue. Even drug dealers aren't arrested the way MNAs were picked up from parliament. If the speaker has any conscience left, they should resign. Even if there's just one member, move a no-confidence motion against him, even if it fails," Rashid said. He condemned the defamation of state institutions and lamented the rising cost of electricity. "Another Rs50 billion burden has been placed on the people. They are squeezing the already dead even further. Those they favour aren't given remand, while others are handed over to police on physical remand. Sixteen months have passed, and no charge sheet has been presented.—RT/Agency
