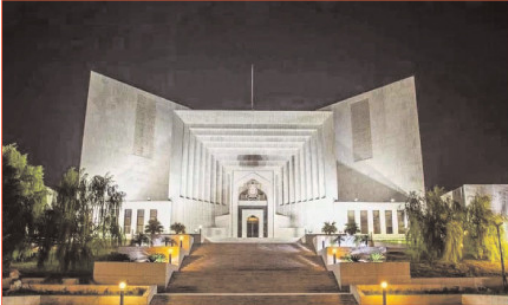

Supreme Court Criticizes ECP Delays, Orders Swift Implementation Of Reserved Seats Decision

ISLAMABAD: The Supreme Court on Saturday came down hard on the Election Commission of Pakistan for its "attempts to create confusion" on its July 12 reserved seats verdict, saying that the clarification sought by the commission was nothing but an attempt to "obstruct implementation" of the judgment declaring PTI eligible for reserved seats in parliament.



"Putting together the record placed before us [top court], and considering the same in light of the short order, leaves in little doubt that the clarification sought by the commission is nothing more than a contrived device and adoption of dilatory tactics," the eight judges stated in a clarification.

After notifying 39 out of 80 Members of the National Assembly (MNAs) as PTI members, the electoral watchdog had sought legal and constitutional guidance from the apex court on the

matter of the remaining lawmakers in the national and provincial assemblies.

The ECP submitted a plea to the top court's registrar via its secretary Omar Hamid Khan to seek an elaborated version of its July 12 order regarding the PTI-backed independent candidates in which the SC declared the former ruling party eligible

for reserved seats.

Following the apex court's July 12 ruling, PTI lawmakers in the national and provincial assemblies had submitted their affidavits of allegiance to the Imran-founded party to the ECP.

The electoral body had pointed out its records which did not authorise Barrister Gohar Ali Khan as the party

chairman, questioning the legal status of the PTI's confirmation of statements regarding the lawmakers in the assemblies by an "unauthorised person" on behalf of the party in absence of the "validly elected organisational bodies".

In its four-page clarification issued today, the SC said having issued notices to

the PTI through Barrister Gohar Ali Khan as its Chairman, the Commission "gave recognition to both the party and the office holder".

The court noted that the ECP, even if one were to consider the application in the most sympathetic light, has "apparently forgotten the well-known de facto doctrine or rule, in terms of which the acts of a person who holds an office are protected even if there may be any issue with the position de jure."

"It would be completely illogical to assume that a political party, a juristic person, is fully functional yet there are no natural persons who are either de facto or de jure performing its functions or running its affairs," it added.

Furthermore, the top court said the Election Commission cannot now turn around and purport to seek guidance from the court with regard to how the certifications are to be dealt with. "It cannot appropriate and reprobate, taking

whatever (shifting) stance as it desires and as may seem to suit its immediate purposes for the moment," it noted.

The ECP, in its clarification plea, had also stated that the PTI lacked an organisational structure as per the ECP's record, which "is statutory obligation of every enlisted political party to conduct intra-party elections in terms of Section 208 of the Election Act 2017."

Responding to this query, the court said, "It sufficed and the Commission was duty bound in terms of the Constitution to keep in mind that the admitted position (as stated before the Court during the hearing of the appeals) is that the PTI was, and is, an enlisted political party."

"Their lordship appears to have also accepted the validity of the party certificates (party tickets) issued by Barrister Gohar Ali Khan and thus his capacity to act for PTI as its Chairman."

"There could have been no conceivable doubt that the certifications referred to above were correct," the SC said, warning that the continued "denial and refusal of the Commission" to accept the same may expose it to action as may be warranted in terms of the Constitution and the law.

Alluding to another fundamental aspect, the court said it was categorically declared in paragraph 8 of the short order that the seat secured by such candidate shall be forthwith deemed to be a seat secured by that political party.

"As per the position so determined, the seat returned

candidates were and are the returned candidates of PTI and thus members of the parliamentary party of PTI in the National Assembly and Provincial Assemblies conferred, for all constitutional and legal purposes."

It further stated that the attempt by the ECP to confuse and cloud what is otherwise absolutely clear as a matter of the Constitution and the law must therefore be strongly deprecated."

Moreover, the apex court said the list required to be issued by the electoral body was "nothing more than a ministerial act", for the information and convenience of all concerned, and has no substantive effect.

"Nonetheless, the continued failure of, and refusal by, the Commission to perform this legally binding obligation may, as noted, have consequences. This obligation must be discharged forthwith", it concluded.—RT/Agency

Bilawal Demands Accountability For Imran's Remarks Against Army Chief

ISLAMABAD: Chairman of the Pakistan People's Party (PPP), Bilawal Bhutto-Zardari, has stated that if former Prime Minister Imran Khan made the recent statement accusing the army chief and committing contempt of court, he must face the constitutional consequences.



Speaking in the National Assembly, Bilawal noted that the nation read the statement last night, which accused key institutions of wrongdoing.

Bilawal praised his party's Southern Punjab organisation, commending their resilience in confronting lies through the power of the vote.

He urged political parties to accept election outcomes and emphasised the importance of trusting the people's decisions for the future of democracy.

He further stated that the people of Pakistan are no longer supporting conspiracies or abusive language, particularly referencing "Prisoner 804" (Imran Khan), who he claims is isolated in his political stance.

Bilawal urged PTI to investigate whether Imran Khan made the statement or not.

The PPP chairman also

criticised attempts to politicise the appointment of the army chief, recalling that as Director General of the ISI, General Asim Munir exposed corruption linked to the PTI founder.

He added that, instead of acting on corruption, Imran Khan had replaced the intelligence chief at the time.

Bilawal noted that this was part of a broader conspiracy, including rejecting the no-confidence motion, pushing for early elections before the army chief's appointment, and attempting to undermine the credibility of the position.

He warned that there would be significant revelations regarding the propaganda surrounding Forms 45 and 47.

Bilawal concluded by calling on PTI to reflect on

how actions tied to Imran are creating further instability, not only for the party but for the nation as a whole.

Referring to a social media post shared from the account of the PTI founder, Federal Interior Minister Attaullah Tarar said Imran was again turning to his previous practice of committing sedition.

He added the PTI founder wanted to create anarchy in the country, which was also condemnable.

The FIA would initiate an investigation against the PTI founder for inciting people, and questioning the country's integrity.

It would be ascertained that who was the handler of his social media accounts, and whether such posts were being made at his behest or someone else's directives, he added.—RT/Agency

Fatal Bus Crash In Sherani, Balochistan: 6 Dead, 20 Injured



QUETTA: At least six people were killed and 20 injured after a bus fell into a ditch in district Sherani's Damasar area of Balochistan's Zhob division, Levies told media on Saturday.

According to the Levies, those injured in the accident have been transferred to the hospital.

The ill-fated bus was going from Islamabad to Quetta, they added.

The Balochistan government has ordered probe into the deadly accident.

In the last one month, Pakistan has witnessed several accidents, claiming the lives of dozens of people.

In one of the deadliest recent crashes, a bus carrying pilgrims plunged into a ditch at the Makran Coastal Highway on August 25.

The incident killed 11 and

wounded more than 30 others, according to the police.

Another bus accident on the Kahuta-Rawalpindi route on the same day claimed the lives of 25 people, including 17 men, 7 women, and 1 child.

The accident occurred when a passenger bus travelling from Rawalpindi to Patalpindi plunged into a deep ravine near Garari Bridge, Azad Pattan. One critically injured passenger was rescued from the wreckage and rushed to hospital.

The accident was a stark reminder of the hazards on hilly roads across Pakistan. Many locals have long voiced concerns over the lack of infrastructure and safety measures on the Kahuta Road, urging government intervention to prevent further accidents.—RT/Agency

Pakistan Condemns U.S. Sanctions, Labeling Them Politically Driven And Unjust

ISLAMABAD: Spokesperson for the Ministry of Foreign Affairs, Mumtaz Zahra Baloch, on Saturday, said that Pakistan considered the United States' decision to impose sanctions on commercial entities over alleged connections to Pakistan's ballistic missile program as biased and politically motivated.



In response to media inquiries about the US decision to impose sanctions on commercial entities over alleged connections to Pakistan's ballistic missile program, she stated that similar listings of commercial entities in past years based on mere suspicion, involved items not listed by any export control regime, and yet were broad-catch-all provisions.

It is widely known that some countries while claiming strict adherence to non-proliferation norms, have conveniently waived licensing requirements for advanced military technologies to their favoured states.

Such double standards and discriminatory practices undermine the credibility of global nonproliferation regimes, increase military

asymmetries, and endanger international peace and security, said the spokesperson.

The US State Department on Thursday imposed sanctions on a Chinese research institute and several companies it said have been involved in supplying Pakistan's ballistic missile program. Washington similarly targeted three China-based companies with sanctions in October 2023 for supplying missile-applicable items to Pakistan. Department spokesperson Matthew Miller said in a statement that the Beijing Research Institute of Automation for Machine Building Industry had worked with Pakistan to procure equipment for testing rocket motors for the Shaheen-3 and Ababeel systems and potentially for larger systems.

The sanctions also targeted China-based firms Hubei Huachangda Intelligent Equipment Co, Universal Enterprise, and Xi'an Longde Technology Development. Innovative Equipment and China national, for knowingly transferring equipment under missile technology restrictions. Liu Pengyu, spokesperson for China's embassy in Washington, said: "China firmly opposes unilateral sanctions and long-arm jurisdiction that have no basis in international law or authorization of the UN Security Council." China will "firmly protect" Chinese companies' and individuals' rights and interests, Liu said.—RT/Agency

Govt To Establish Constitutional Court, Amend Defection Clause Amid Reforms

ISLAMABAD: The federal government is considering the formation of a constitutional court and modifications to Article 63-A, the defection clause, as part of its much-discussed constitutional package. This development arises amid speculation surrounding the extension of Chief Justice of Pakistan (CJP) Qazi Faez Isa's tenure, who is set to retire in October, following Pakistan Tehreek-e-Insaf's (PTI) call for an early announcement of the next CJP last month.



While the government has refrained from disclosing details of the proposed constitutional amendments, it emphasized that the reforms are not focused on any individual but aim to enhance judicial procedures. Among the proposed changes is an increase in the retirement age of superior court judges by three years. Currently, Article 179 stipulates the retirement age of Supreme Court judges at 65, and Article 195 sets the

high court judges' retirement age at 62.

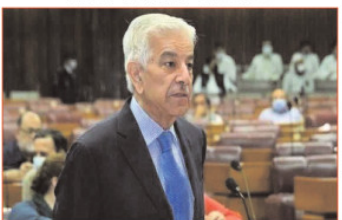
In addition, the government is contemplating revising the seniority principle in the selection of the CJP, according to Barrister Aqeel Malik, the government's legal spokesperson. At present, the senior-most Supreme Court judge is appointed as the CJP under Article 175A based on seniority.

Prime Minister Shehbaz Sharif has reportedly called for a federal cabinet meeting to approve the draft of the constitutional amendments. Sources indicate that parliamentarians from Pakistan

Muslim League-Nawaz (PML-N) and other allied parties have been consulted and assured their support for the amendments, which are expected to be presented in parliament tomorrow.

During a dinner with coalition parliamentarians, PM Shehbaz emphasized the need for legislative reforms in the national interest, underlining the supreme role of parliament in addressing key national issues. He reiterated that political stability is essential for economic progress and warned against involving constitutional institutions in politics.—RT/Agency

Khawaja Asif: PTI Founder Contemplating 'Separation Movement' In KP



ISLAMABAD: Defence Minister Khawaja Asif said that PTI founder Imran Khan sowed seeds of hostility to what would bear sore fruits.

Speaking in the National Assembly, Khawaja Asif stated that the language being used in the recent meeting reflects separatist sentiments.

He suggested that the PTI founder is keeping the option of a separation movement in Khyber Pakhtunkhwa. He accused the PTI

leader of fueling hatred in the province. He said that no path of reconciliation seems to remain open. The Defence Minister also commented on Faiz Hameed's support for the PTI founder, questioning the reasons behind the establishment's recommendation to postpone the meeting. Khawaja Asif further claimed that Ali Amin Gandapur is playing a double game, and urged that any public statements made should be verified to ensure they were genuinely from the PTI leader.—RT/Agency

FIA Interrogates Imran At Adiala Jail Over Alleged 'Anti-State' Social Media Post

RAWALPINDI: The Federal Investigation Agency (FIA) completed the first phase of its investigation regarding an anti-state post made from the X—formerly Twitter—account of the Pakistan Tehreek-e-Insaf (PTI) founder, Imran Khan, media reported citing sources. The FIA's three-member special team questioned the PTI founder in the presence of his legal team, focusing on the posts made from his X account, sources said. A team from the Federal Investigation Agency (FIA) arrived on Saturday at Adiala Jail to interrogate the founder of Pakistan Tehreek-e-Insaf (PTI) regarding an anti-state post shared by Imran Khan's account on X—formerly Twitter—account. The post had sparked serious concerns about its implications, leading to the launch of a formal investigation by the authorities. According to sources, the FIA's three-member team consisted of Assistant Director Ayaz Khan, Sub-Inspector



Muneeb Ahmed, and officer Anees. The team had already visited the prison last night to question the PTI leader but was unable to proceed as he refused to meet with them. The PTI founder reportedly declined the FIA's request for an interview, insisting that he would only participate in the investigation in the presence of his legal counsel. Sources indicate that this refusal prompted the FIA to return to the jail today in an effort to continue the investigation. The authorities are probing how an anti-state message was shared from the PTI founder's official X ac-

count. There were speculations that the account may have been compromised or that others may have accessed it to post the controversial content. However, during the investigation, the PTI founder reportedly stated that his media statements were posted on the X account and that his intent was not to target any specific institution or individual but rather to discuss the elite capture of the country. Following the interrogation, the FIA team left Adiala Jail, with sources indicating that further cases may be registered after the investigation is fully completed.—RT/Agency

APC demands justice for sexually abused Polio worker Abida Unar

JACOBABAD: Under the hosting of the Sindh Dost Committee at Shaheed Bhutto House, an All Parties Conference (APC) was held in Jacobabad. The conference saw large participation from political, social, religious, business, journalistic, educational, legal organizations, as well as leaders of the Hindu General Panchayat and civil society members. During the conference, Sindh Dost



Committee leaders including Intizar Chhalgeri, Nadeem Qureshi, Muhammad Alam Khoso, Zahid Soomro, Zubaida Jakhraani, GM Soomro, and others strongly condemned the heinous act of assault against lady polio worker Abida Unar by anti-social elements. They criticized the fact that instead of registering an FIR for the assault, the police had filed an FIR for robbery, which they claimed was an attempt to protect the culprits. This, they said, was a grave injustice to the victim, a daughter

of the city. They also demanded the removal of the DC Jacobabad, SSP Jacobabad and DHO for concealing the facts and mishandling the case. The conference expressed disappointment at the local MPA, MNA, and Senators for not issuing any statements condemning the assault. They called on these elected representatives to raise their voices in their respective assemblies against the injustice faced by the polio worker and to distance themselves from the incompetent administration. The APC also demanded that the government and higher judiciary register an FIR based on the actual facts of the incident, include terrorism clauses in the case, and transferred it to an anti-terrorism court. The conference unanimously agreed to launch a well-organized protest movement to seek justice for the lady health worker and improve the law and order situation in Jacobabad. The first phase of this protest will include a major demonstration on Monday, September 16 (tomorrow).

Polio worker Abida Unar reveals gang rape and Police coercion, claims assault was recorded

JACOBABAD: In Jacobabad, a shocking statement has emerged from polio worker Abida Unar, who has disclosed that she was gang-raped. She revealed that the assault was recorded on video. Abida Unar accused the police of pressuring her to change her statement under threats of murder. During a media briefing, she recounted that while she was in the village of Allah Bux Jakhraani for a polio campaign, a man lured her to another location under the pretense of administering

anti-polio drops. When she refused, he threatened her with a pistol and warned her that if she resisted, he would shoot the accompanying boy. She was then dragged to a secluded area where three masked individuals were already present.

Two of them restrained her while Ahmed Jakhraani raped her, and one person recorded the incident. She suffered severe physical abuse during the assault. After escaping, she was assisted by local women and taken to JIMS Hospital, where police coerced her into altering her statement. Abida Unar reported that her life has been devastated, her husband abandoned her and she is now living with her father. She also claimed that Ahmed Jakhraani is the main perpetrator and while she cannot identify the other three assailants due to their masks, she is in danger from her husband or his family. Her lawyer, Nisar Ahmed, confirmed that the police had forced her to change her statement under threat, which has put her life at risk. The lawyer called for protection for Abida Unar and demanded justice and security for her.

SSGC suspends gas supply after leakage in NWM's main line

NAWAB WALI MUHAMMAD: In response to a gas leak in the main line, instead of fixing the leak, the gas authorities cut off the gas supply, leaving hundreds of households without gas. This led to protests by local residents. The incident occurred near Lal Bux Gaincho village, located along the National Highway near Nawab Wali Muhammad. Due to the gas leak, areas such as Karimabad Stop, Mithalabad and Dino Machine Stop were affected, with no gas supply being restored for hundreds of homes. In protest against the gas shutdown, students gathered at Dino Machine



Stop on the National Highway, expressing their frustration. They stated that due to the lack of gas, they were forced to go to school without breakfast. Local residents also complained that rather than fixing the leak, the gas authorities had shut off the

supply for a week, causing difficulties in cooking. On the other hand, the gas authorities mentioned that water had accumulated at the site of the leak, making it difficult to repair. They assured that the leak would be fixed soon.

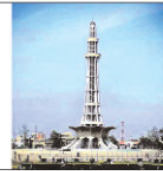

Kuchlak Explosion Near Quetta Claims Lives Of Two Police Officers

QUETTA: At least two police officials were killed in a blast near a police mobile van in Kuchlak town on Saturday, police told media.



The police added that rescue teams had reached the incident site situated near Quetta following the explosion.

Two cops injured in the incident were rushed to a hospital for treatment. One of them was pronounced dead after examination by doctors upon arrival at the hospital, while the other also succumbed to his wounds soon after, the police said.

The senior superintendent of police (operations) earlier said condition of the other policeman was critical.

Police said 8-10 kilogramme explosive material was used in the time bomb on Boston road that targeted the police van.

Federal Government Cracks Down On Newspapers Circulating Exclusively As PDFs

TOBA TEK SINGH: The federal government has decided to cancel the declarations of all newspapers and magazines across the country that are not being printed and are only operating as PDFs. These newspapers and magazines, which are not being regularly printed and are functioning solely through PDF files, will soon have their declarations revoked. After a report was presented by the Federal Ministry of Information and Broadcasting, the federal government sent a letter to the provincial govern-

ments, which will soon start issuing notices to these publications. Additionally, there has been news for journalists associated with PDF newspapers. In the future, they will no longer receive government perks, such as plots, accreditation cards, and discounted travel on trains and airplanes. These journalists will also not be able to obtain membership in local press clubs. Moreover, any news published against individuals in viral social media posts that appears in PDF newspapers will be considered illegal and punishable. The Federal Investigation Agency (FIA) will have the authority to take direct action against such offenses. The Punjab government has expressed willingness to launch an effective public awareness campaign soon to guide those associated with the field of journalism. Talks are also ongoing between the federal government and other provincial governments. Journalists have been urged to exercise caution and not become involved in any illegal activities without reason. They are advised to fulfill their journalistic duties only with newspapers and magazines that are printed and available in the market.

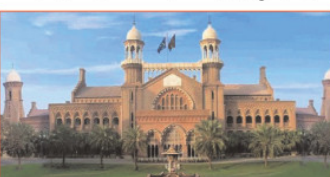
He pointed out that such ministers were either ignorant of constitutional provisions or attempting to mislead the public.

PTI's Shoaib Shaheen Secures Bail From Anti-Terrorism Court

RAWALPINDI: An Anti-Terrorism Court (ATC) has granted bail to PTI lawyer Shoaib Shaheen, ordering his immediate release, while the bail applications of other PTI leaders were postponed due to the absence of the relevant judge.



The bail hearing of PTI leaders Sher Afzal Marwat, Sheikh Waqas Akram, Shoaib Shaheen, and others took place before ATC Judge Tahir Abbas Siraj. PTI MNAs were represented by lawyers Riasat Ali Azad and Adil Qazi.

The court inquired about Shoaib Shaheen's physical remand, to which the lawyer responded, "Shaheen was remanded for eight days, but the remand was suspended on the same day. He, along with other assembly members, remains in jail."

Judge Siraj summoned the prosecution and the case record from Sangiani police station, after which a brief adjournment was called.

Following the break, the investigation officer presented the record in court. Since the prosecutor was not present, Judge Siraj stated, "The hearing for Sher Afzal Marwat, Saeed Shah, and Waqas Akram will be conducted by the relevant judge, but I will rule on Shoaib Shaheen's bail today."

PTI lawyer Riasat Ali Azad pointed out discrepancies in the case, saying, "While Shaheen is accused of carrying a pistol, only a baton was recovered. The FIR mentions assaulting a police officer, but no medical certificate is attached."

Judge Siraj asked about the recovery of the baton, to which the lawyer replied, "Yesterday, before the Islamabad High Court, the investigating officer confirmed the recovery of a baton from Shaheen."

The court granted Shoaib Shaheen bail against a surety of Rs100,000 and ordered his immediate release.

The hearing for other PTI leaders' bail applications was adjourned until Monday at 9am. Judge Tahir Siraj is currently presiding over jail trials at Adiala Prison in place of ATC Judge Abul Hasnat Zulqarnain, who is on leave. As a result, delays or postponements in hearings for the PTI leaders' bail applications are likely due to the absence of the designated judge.—RT/Agency

Pakistan's persistent reliance on borrowing, particularly from the IMF, has trapped the nation in a vicious cycle of debt. Instead of focusing on long-term solutions to its economic woes, successive governments have sought quick fixes, often at the expense of the country's fiscal sovereignty. The latest \$7 billion bailout from the IMF may provide temporary relief, but it does little to address the fundamental issues that plague the national economy.

Decades of IMF-dictated austerity measures have crippled Pakistan's ability to grow sustainably, leading to unprecedented levels

of stagflation. Constant borrowing has led to a weakened economy where growth remains stagnant while inflation spirals out of control.

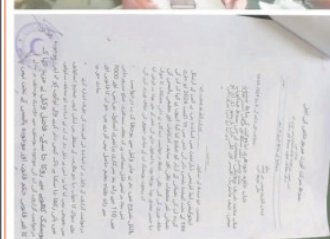

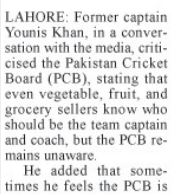

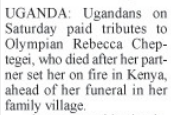

"As a father it has been very difficult," he told AFP, explaining he had not been able to break the news to their children. "Slowly we will tell them the truth."

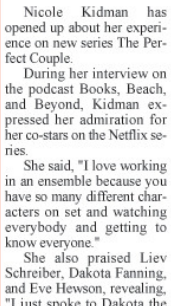

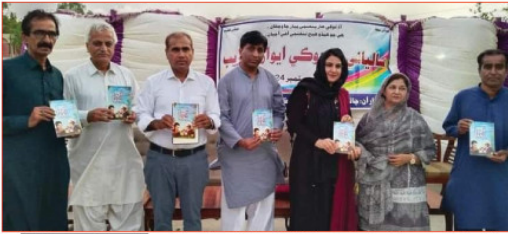

Saudi Arabia Proposes 15% Investment In Reko Diq Mining Project

ISLAMABAD: Saudi Arabia has offered fifteen percent investment in the mega Reko Diq gold and copper project, media reported. The Kingdom has also offered grants to build road infrastructure around the Reko Diq project. Special Investment Facilitation Council has approved the structure of the offer but the final decision has been left to the Cabinet Committee on Intergovernmental Transactions. Pakistan expects Saudi investment of up to five billion dollars in mining and agriculture sector by June next year. Last year in December, Pakistan and Barrick Gold Corporation have signed \$8 billion landmark agreement on project after Supreme Court (SC) termed the deal 'legal'. The \$8 billion landmark agreement was signed by Reko Diq Gold Corporation representative and federal and Balochistan government representatives. The Supreme Court (SC) of Pakistan on Dec 9 ruled that new deal on the gold and copper mining project in Balochistan is legal. Reko Diq is considered one of the world's largest undeveloped copper-gold mines. The project is being restarted after remaining on hold since 2011. "Reko Diq is one of the bigger copper-gold undeveloped projects in the world," said Mark Bristow, chief executive of Barrick, which aims to start mining in 2028 subject to an ongoing feasibility study. "It's a very big deal. Any copper mine right now is one of the world's largest a big deal."—RT/Agency

Sindh Education Minister Criticizes Lack Of Federal Cooperation On Education Emergency

KARACHI: Provincial Education and Mineral Development Minister Syed Sardar Ali Shah expressed disappointment over the federal government's declaration of an education emergency without consulting the provinces. Speaking at an event organized by the Sindh Education Foundation in Karachi, he emphasized that no collaboration had been made to address the crisis, despite the federal announcement. He also revealed that 20,000 schools in Sindh were affected by recent heavy rains, leaving 2 million children to study in inadequate conditions.



Shah criticized the absence of a clear federal policy for the country's 26 million out-of-school children, urging the central government to prioritize the restoration of Sindh's flood-damaged schools. He expressed hope that the federal government would fulfill its promises in this regard. The ceremony at the Marriott Hotel honored individuals who have adopted non-governmental schools under the Sindh Education Foundation's "Adopt a School Program." Shah praised the adopters for their role in revitalizing 319 schools, providing education to 125,000 children. He further urged lawmakers to take responsibility for at least three schools in their constituencies, reinforcing the importance of collective responsibility in improving education. Secretary of School Education Sindh, Zahid Ali Abbasi, and Sindh Education Foundation MD Qazi Kabir also commended the adopters, highlighting Sindh's leadership in educational reforms and the impact of the school adoption policy since its inception in 1998.

Customs Thwart Drug Smuggling At Karachi Airport

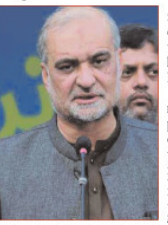


KARACHI: Customs officials successfully foiled an attempt to smuggle drugs at Jinnah International Airport on Saturday, seizing over one kilogram of ice heroin from a passenger, according to media reports. The passenger, who was planning to travel to Bahrain on a foreign airline, was stopped based on suspicion. Upon searching his luggage, authorities discovered the heroin. The suspect has been arrested, and further investigations are ongoing. In a separate incident, customs officers at the same airport intercepted two passengers bound for Dubai. Muntazir Mehd and Mohammad Kashif, who were preparing to board a Pakistan International Airline (PIA) flight, were found carrying over AED 100,000 during routine checks. The passengers claimed the money was for purchasing videography equipment, but customs officials seized the funds and initiated legal action for breaching currency regulations. Additionally, customs officials prevented a money laundering attempt when they stopped a passenger about to board an international flight to Doha. The suspect was arrested and investigations are underway.—RT/Agency

KCCI Urges CM And Mayor To Address Karachi's Deteriorating Road Infrastructure

KARACHI: Acting President of the Karachi Chamber of Commerce & Industry (KCCI), Altaf A. Ghaffar, has made a strong appeal to Chief Minister Sindh Murad Ali Shah and Mayor Karachi Muraza Wahab, calling for immediate action to repair Karachi's crumbling road network. He emphasized that the city's deteriorating roads, which suffer from frequent traffic jams, have become a source of daily frustration and mental stress for residents. Ghaffar highlighted the numerous complaints received by KCCI regarding the severe damage to roads, particularly following this year's monsoon rains. The delay in repairs, he said, has caused widespread anxiety not only among the business community but also the general public. He pointed out that most roads are now nearly im-

passable due to potholes and overflowing sewerage lines, making both driving and walking a challenge. He specifically mentioned areas such as Jodia Bazaar, Mauripur, Keamari, Bolton Market, Lyari, and MA Jinnah Road, describing them as "war-ravaged" due to the poor condition of the roads. Ghaffar warned that the public's frustration is growing, especially as Karachi continues to generate the largest share of national and provincial revenue yet remains neglected in terms of basic infrastructure. "Karachi contributes more than 65% to the national exchequer and 95% to the provincial budget, yet it receives little more than empty promises," he said. Ghaffar added that the worsening road conditions have made commuting in the city a dangerous ordeal, with frustrated drivers often violating traffic rules, leading to accidents and further congestion. He also pointed out the disparity between elite areas, which receive better services, and the rest of the city, where infrastructure is in dire straits. This imbalance, he warned, is fostering a growing sense of resentment that could escalate into serious social and law-and-order issues if not addressed. Ghaffar once again urged the Chief Minister and Mayor to prioritize the city's road infrastructure, stressing that Karachi plays a vital role in Pakistan's economy and deserves immediate attention from both provincial and federal governments.—RT

Sindh Cabinet Approves Key Reforms And Initiatives

KARACHI: The Sindh cabinet, in a significant meeting, approved the Sindh Defined Contribution Pension Scheme 2024, set to begin on 1st July 2024. Under this scheme, the government and employees will contribute 12% and 10% respectively towards pensions. The cabinet also approved an amendment to the Sindh Civil Servant Act 1973, introducing a Defined Contribution Pension Scheme for civil servants appointed after 2024, replacing the traditional pension system. In environmental protection, the cabinet declared the Karoonjhar Mountain Range, covering 21,000 acres, as a protected heritage site. To preserve marine life, the cabinet imposed a ban on bottom trawling, a destructive fishing method, through amendments in the Fisheries Rules 1983, prohibiting its use within 12 nautical miles off the Sindh coast. In economic matters, the cabinet approved Rs 3.3 billion in outstanding payments to sugar mills as part of Cash Freight Support and an additional Rs 281 million for further relief. The cabinet also sanctioned Rs 434 million for the rehabilitation of the Islamkot Mega RO Plant in Tharparkar to ensure water availability. A significant decision to hand over Cadet College Kakar to the Pakistan Navy was made, alongside a grant of Rs 250 million to complete its remaining components. Additionally, the cabinet approved raising the monthly pay for teachers under the National Commission for Human Development (NCHD) and Basic Education Community Schools (BECS) to Rs 37,000, alongside the issuance of the Benazir Hari Card to support small farmers.

Murad Inaugurates Pakistan's First Café Staffed By Differently-Abled Persons



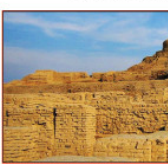

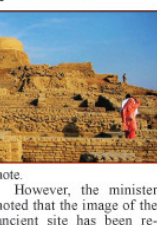

Imran Denies Knowledge Of Police Entry Into Parliament Lodges During His Tenure

ISLAMABAD: Imran Khan, founding leader of Pakistan Tehreek-e-Insaf (PTI), has claimed ignorance regarding the police operation at Parliament Lodges during his tenure as Prime Minister.

In March 2022, while Imran was in office, Islamabad police conducted a raid at Parliament Lodges, resulting in the arrest of 19 individuals, including JUI-F MNAs Salahuddin Ayubi and Maulana Jamal-ud-Din.

The operation sparked significant controversy and was widely covered on social media. When asked about the incident during an informal discussion with journalists at Adiala Jail on Saturday, Imran asserted that no one was forcibly removed from Parliament under his leadership and criticised the current government for



allegedly ignoring democratic norms.

Addressing queries about the drug case involving Rana Sanaullah, Imran stated that the case was initiated by the Anti-Narcotics Force (ANF).

He confirmed that he had called upon the ANF head, who briefed the cabinet and presented evidence related to

Sanaullah's case.

Imran acknowledged relying on the statements and evidence from the ANF, that is headed by a Major General, despite claims from PTI leaders suggesting the case was fabricated.

Imran also discussed his efforts to intervene in the abduction of journalist Matullah Jan and ac-

cessed the current government of human rights violations and electoral fraud through new constitutional amendments.

Imran also criticised Shehbaz Sharif, alleging intervention by Bajwa to prevent Sharif's conviction on money laundering charges.

He dismissed other legal issues involving Sharif, Nawaz Sharif, and Ishaq Dar as outdated claiming that only the money laundering case had proven charges.

Imran targeted Qazi Faez Isa and condemned recent amendments that he said undermined democratic processes. Imran argued that democracy in Pakistan is at risk with smaller parties gaining parliamentary representation and criticised media restrictions and judicial threats.

He urged his party to prepare for a street movement, indicating that if the government thought they would remain silent about these amendments, they were mistaken.

Despite restrictions, he announced a rally in Lahore on 21 September, asserting that holding such rallies is both a democratic and constitutional right.

He criticised the government for blocking rallies over the past year and a half, warning that the situation in Punjab could turn into a "police state" if these restrictions continued.

The PTI founder concluded by emphasising that his party would continue to fight for democratic principles and resist any attempts to enforce what he described as "slavery."

Dar: Constitutional Bill, Supported By All Parties Including PTI, Aligns With Charter Of Democracy

ISLAMABAD: Leader of the House in the Senate and Deputy Prime Minister, Senator Ishaq Dar on Saturday apprised the Upper House of the Parliament that the Constitutional Bill was in line with the provisions of the Charter of Democracy (COD) endorsed by all the political parties including the Pakistan Tehreek-e-Insaf (PTI).

The Leader of the House was addressing the 10th meeting of the 342nd Senate session held under Chairman Senate Syed Yousaf Gillani.

Senator Ishaq Dar underlined that there was a disconnect between the Leader of the Opposition's party leadership in the Senate and the National Assembly.

"It was the third in camera meeting of the Special Parliamentary Committee in the Parliament which was participated by Chairman PTI, Barrister Gohar Ali and Opposition Leader Omar Ayub Khan who was absent in the previous two meetings. There have been discussion on different agenda items," he said.

He added that the Opposition Leader should seek details from his colleagues on the special committee meetings.



Senator Dar informed the House that the issue emerged after Chairman Pakistan Peoples Party Parliamentarians (PPPP), Bilawal Bhutto Zardari made a statement for joint efforts to restore the prestige of the Parliament and proposed a committee of all political parties on the arrest of some members of the lower house of the Parliament.

"I on behalf of the government instantly endorsed the suggestion and after the House resolution, a committee was formed and all political parties in the National Assembly have their representation. I would request that committee to give representation to the Senate as it's a special body on general issues and the resolution TORs entitled matters pertaining to the parliament, parliamentarians, constitutions and rules and business of pro-

cedures," the Leader of the House said.

The issues pertaining to the Constitutional Bill have been discussed in the Special Committee, the Opposition Leader should get details from his colleagues, he said, adding, "Under the Charter of Democracy, the article four demanded a constitutional court in the country to hear constitutional petitions and dispose of them. The elite class in the country gets swift petition hearings whereas 60,000 cases are pending in the Supreme Court including 25% constitutional petitions and 50% constitutional petitions in the High Courts." The charter was not done by two political parties whereas after few weeks all political parties were convened, and they endorsed the document including the then PTI Chairman, and founder, he added.—RT/Agency

Prime Minister Sets November Deadline For Finalizing Electric Vehicle Policy

ISLAMABAD: Prime Minister Shehbaz Sharif on Saturday instructed relevant authorities to formulate a detailed financial framework for electric vehicles by November this year and streamline licensing regulations for their manufacture in Pakistan.

Chairing a meeting in Islamabad, the prime minister instructed that essential consultations be held with the Finance Ministry, the State Bank of Pakistan, all provinces, federal units, and relevant stakeholders concerning the electric vehicles policy.

Shehbaz Sharif emphasized, "The government is prioritizing the promotion of electric vehicles in the country."

He highlighted, "These vehicles will not only conserve valuable foreign exchange by reducing imports of petrol and diesel but also offer environmental benefits."

The prime minister announced plans to distribute e-motorbikes to exceptional students from government schools, following a model similar to the laptop scheme.

The prime minister stated that, moving forward, all federal government institutions would exclusively



purchase electric motorbikes to conserve national resources. He had instructed that directives be issued to all federal ministries accordingly. Additionally, he directed the Capital Development Authority (CDA) to develop a detailed plan for implementing electrified public transport in Islamabad.

During the briefing, it was reported that, since 2022, 49 licenses had been issued for the local production of two- and three-wheeled electric vehicles, with 25 factories were already operational. The forum was informed that the first license for the domestic production of four-wheeled electric vehicles was issued in September this year, and the first locally manufactured electric car is expected to be available in the market by December. The meeting was informed that the country currently has 45,000 two- and three-wheeled elec-

tric vehicles, as well as 2,600 four-wheeled electric vehicles. Additionally, it was told that the installation of recharging stations for electric vehicles would be prioritized along motorways, GT Road (National Highway 5), and National Highways 65 and 70.

The meeting was attended by Federal Minister for Economic Affairs Ahmad Khan Cheema, Federal Minister for Industries and Production Rana Tanveer Hussain, Federal Minister for Power Owais Ahmed Khan Leghari, Federal Minister for Science and Technology Dr. Khalid Maqbool Siddiqui, Minister of State for Finance and Revenue Ali Pervaiz Malik, Prime Minister's Coordinator for Climate Change Romina Khurshid Alam, Prime Minister's Coordinator Rana Insaan Afzal, and other senior government officials.—RT/Agency

Barrister Gohar Raises Alarm Over Rule Violations In Constitutional Amendment Process



ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) Chairman Barrister Gohar Ali Khan has criticised the government's potential move to introduce a constitutional amendment bill, stating that such action without following due procedure is against parliamentary rules.

Speaking to the media in Islamabad on Saturday, Gohar expressed frustration with the government's tendency to pass legislation "under the cover of darkness."

"We have always said that if you want to legislate, follow the proper procedure. The Constitution clearly outlines the legislative process, and we must adhere to the law and the Rules of Business," he remarked.

Gohar highlighted that private member bills first go to a committee, requiring permission a month prior, before being placed on the agenda. "Government bills are handled by the ministry, then passed through the cabinet with the prime minister's signature. Rules of Business 16 and 27 require the Ministry of Law and Parliamentary Affairs to advance these bills," he explained.

He further criticised the current government's approach: "There has been no cabinet meeting, no approval. If the bill is introduced without these steps, it will be a clear violation of the rules."

Zartab Gul, a PTI leader, also condemned the government's actions, referring to the abduction of the wife, daughter, and aunt of Faisalabad MNA Saadullah Baloch. "They were told to present themselves before unknown entities. Imagine, present themselves to whom?" she questioned.

She also raised concerns over the disappearance of another PTI member, Aurangzeb Kachhi, stating, "For three days, we've had no news of him. The PML-N's unconstitutional actions will not only harm Pakistan but also damage parliament."—RT/Agency

JUI-F Stands Firm On Extending Chief Justice's Tenure

ISLAMABAD: Jamiat Ulema-e-Islam (JUI-F) has once again rejected the proposal for legislative extension of the chief justice's term.

Sources said Prime Minister Shehbaz Sharif met JUI-F chief Maulana Fazlur Rehman to discuss proposed constitutional amendments.

The meeting, held at Maulana Fazlur Rehman's residence on Friday night, was meant to agree on co-operation on constitutional reforms.

Despite the discussion, Maulana Fazl did not give a positive response to the extension proposal.

He reiterated JUI-F's rejection of legislation for an individual's benefit.

Instead, he emphasised the need for judicial reforms and suggested that the government should



present a comprehensive package.

Earlier, the Jamiat Ulema-e-Islam (F) leader ruled out any possibility of imposing Governor's Rule in Khyber Pakhtunkhwa.

He told journalists in the National Assembly that the law and order situation in KP was not good. "Can the governor control such a situation," he asked.

He said KP CM's statement about talks with Afghanistan was an emotional one and far from reality.

Responding to his stance on the possible constitutional amendment, he claimed that his party would not back it.

He said his party members would support reforms if they are presented without ambiguity.—RT/Agency

IHC Suspends Arrest Orders For Sher Afzal Marwat By Law Enforcement Agencies

ISLAMABAD: The Islamabad High Court (IHC) on Saturday stopped the law enforcers from arresting Pakistan Tehreek-e-Insaf (PTI) leader Sher Afzal Marwat without permission in any case.

After hearing the plea filed by the PTI parliamentarian, the IHC has issued notices to the Ministry of Interior secretary, Islamabad inspector general, Punjab inspector general and Federal Investigation Agency in this regard.

The court has directed relevant authorities to submit paragraph-wise comments on Marwat's petition and also sought details of the cases lodged against him.

Issuing a written order on the PTI leader's plea, Justice Saman Rafat Imtiaz directed not to arrest the senior lawyer in any case without the court's permission.

Marwat had filed the plea through his counsels Adil Aziz Qazi and Riasat Ali Azad.

Police on September 9 arrested PTI Chairman Barrister Gohar Khan



and lawmaker Marwat from outside the Parliament House, for allegedly violating the newly enacted public gathering law during the party's power show in the federal capital on September 8.

Marwat had resisted the arrest and asked the police to show arrest warrant.

He was arrested for violating regulations devised under a new law — Peaceful Assembly and Public Order Bill, 2024, and also accused of clashing with police personnel on the rally day.

It should be noted that at least 10 PTI lawmakers, who were arrested

from the premises of Parliament House, were brought to the lower house on September 12 after their production orders were issued by National Assembly Speaker Ayaz Sadiq.

Speaking on the NA floor, PTI firebrand politician Marwat thanked the speaker for issuing the production orders. "The police have not returned my personal pistol and five Kalashnikov — kept in car at the time of arrest."

Rejecting the cases registered against him, Marwat said he was booked for tearing uniform of a police officer through a fake mandate. He

Fawad Warns Governor Rule In KP Could Aggravate Current Situation



LAHORE: Former federal minister Fawad Chaudhry said on Saturday that the government should not even think of imposing Governor Rule in Khyber Pakhtunkhwa, cautioning matters would spiral out of control otherwise. Speaking to reporters outside the Anti-Terrorism Court (ATC), the former minister said that the PM is sitting in the parliament with only 18 seats, adding that whole government was cobbled together through a fake mandate. He

said people were whisked away from inside the parliament while pointing out that whole country was standing behind the judiciary. "People should lend an ear to what Ali Amin Gandapur is saying. He is urging the government for resolving the issues. At least 90 people lost their lives during this month only. The government is not taking matter of terrorism seriously. Everyone should take responsibility for lowering political temperature," he concluded.—RT/Agency
