Bilawal Meets Fazl Again For Ongoing Constitutional Amendment Talks

ISLAMABAD: Pakistan Peoples Party (PPP) Chairman Bilawal Bhutto-Zardari, accompanied by a delegation, arrived at a residence of Jamiat Ulema-e-Islam (JUI-F) leader Maulana Fazlur Rehman for a second meeting within hours on Monday.

The meeting is part of ongoing discussions over proposed constitutional amendments.

According to media, Bilawal was warmly received by Maulana Fazlur Rehman. The PPP delegation included prominent leaders such as Syed Khurshid Shah, Engineer Naveed Qamar, and Karachi Mayor Murtaza Wahab.

On the JUI-F side, Secretary General Maulana Abdul Ghafoor Haideri, Maulana Abdul Wasay, Maulana Asad Mahmood, Senator Kamran Murtaza, Mir Usman Badini, and Maulana Misbahuddin were present.

Earlier in the day, Bilawal had a significant meeting with Prime Minister Shehbaz Sharif at the Prime Minister's House, where the two leaders discussed the political situation and the PPP chairman briefed the premier on his discussions with Maulana Fazlur Rehman regarding the constitutional amendments.

The government is preparing to present the much-anticipated constitutional amendments in the next National Assembly session.

Senator Irfan Siddiqui,



leader of the Pakistan Muslim League-Nawaz (PML-N) in the Senate and Chairman of the Foreign Affairs Committee, confirmed that a detailed briefing had been given during a three-hour committee meeting earlier in the day.

Senator Siddiqui mentioned that Maulana Fazlur Rehman did not fundamentally oppose the amendments but had requested more time and assurances regarding the vote count.

"There is no issue with the number game, as the required votes are already in place," Irfan Siddiqui stated. He further clarified that both houses of parliament are expected to adjourn indefinitely later today, with the new session introducing the constitutional amendments once consensus is reached within the committee.

The proposed amendments have created a political standoff between the ruling coalition led by PML-N and JUI-F, with the latter seeking

more clarity before moving forward.

The delay in presenting the amendments reflects the government's efforts to ensure political leaders' agreement before advancing the legislative process. Maulana Fazlur Rehman's stance, while cooperative, underscored the importance of a unified approach to passing the amendments.

In the midst of this, the role of Pakistan Tehreek-e-Insaf (PTI) has also been under scrutiny, with Senator Siddiqui highlighting that PTI members lack the authority to offer guarantees on the issue. This reflects the internal challenges the party is currently facing.

As the ruling coalition continues its consultations, both the PPP and JUI-F play crucial roles in shaping the future of the constitutional amendments, which are expected to bring significant changes to the political landscape.—RT/Agency

PML-N Announces Indefinite Delay In Constitutional Amendment Discussions Ahead Of NA Session

ISLAMABAD: As the ruling alliance is still busy with making all-out efforts to forge consensus on the much-disputed constitutional amendments, Senior Pakistan Muslim League-Nawaz (PML-N) leader Senator Irfan Siddiqui has claimed that the government's bid to table the constitutional package has been "postponed indefinitely".

Speaking to media on Monday, the PML-N parliamentarian revealed that the JUI-F chief Maulana Fazlur Rehman's "arguments were well-justified" and didn't oppose the amendments on principle grounds. However, Siddiqui said Fazl needed more time to review the amendment draft.

"Fazl agrees on certain amendments but needs time to study details of some provisions," he added.

The development comes after the government apparently failed to woo the JUI-F chief to lend his support for the prospective constitutional



tweaks after several meetings with him wherein the politico opposed the proposal to extend judges' tenure or increase their retirement age.

Several political leaders, including federal ministers and Pakistan Peoples Party (PPP) Chairman Bilawal Bhutto-Zardari, as well as a delegation of the Pakistan Tehreek-e-Insaf (PTI) held meetings with Maulana Fazl on Sunday.

The political saga continued late at night with former prime minister and Convener of the recently established Awaam Pakistan party

Shahid Khaqan Abbasi and party's secretary Miftah Ismail also visiting Fazl's residence.

Furthermore, Balochistan Chief Minister Sarfraz Bugti, Senator and former caretaker PM Anwaar-ul-Haq Kakar also called on the politician.

It is pertinent to know that a key aspect of the constitutional amendments is that, unlike any other legislation, the government will need to secure a two-thirds majority in parliament to successfully execute it.

In the National Assembly, the ruling coalition needs 224

votes to pass the constitutional amendments, whereas in the Senate the number stands at 64.

Currently, as per reports, treasury benches have 211 members against the opposition's 101 MNAs meaning that the government needs 13 more votes to pass the said constitutional amendment.

The ruling coalition comprises the PML-N (110); the PPP (68); Muttahida Quami Movement-Pakistan (22); Pakistan Muslim League-Quaid (four); Istehkam-e-Pakistan Party (four); Pakistan Muslim League-Zia (one); Awami National Party (one) and Balochistan Awami Party (one).

Meanwhile, the opposition comprises 80 MNAs of the Sunni Ittehad Council (SIC) which are supported by PTI-backed independent lawmakers. The JUI-F has eight members in the NA, whereas Balochistan National Party, Pashtunkhwa Milli Awaami Party (PKMAP) and Majlis-e-Walidat-Muslimin (MWM)

have one MNA each in the NA.

Therefore the support of the JUI-F and its eight MNAs holds key importance for the future of the prospective amendments.

The ruling benches of the Senate, as per the publication, comprise PPP (24), PML-N (19), BAP (4) and MQM-P(3) in addition to four independent senators.

The total strength of the ruling benches stands at 54 as the government is short of nine votes in the Senate to pass the constitutional amendment. As for the opposition benches in the Senate, PTI holds 17 seats, JUI-F (5) and ANP (3), while SIC, MWM, BNP, National Party and PML-Q have one seat each. Meanwhile, the total strength of the ruling benches stands at 54 and the government is short of nine votes in the Senate to pass the constitutional amendment, whereas the opposition has 39 senators in the upper house.—RT/Agency

Barrister Gohar Dismisses Leaked Draft Of Constitutional Amendments



ISLAMABAD: PTI Chairman Barrister Gohar Ali Khan has expressed strong opposition to the recently leaked draft of the constitutional amendment, stating that it is unacceptable.

Speaking to the media outside the Islamabad High Court, Barrister Gohar Ali Khan criticised the lack of transparency regarding the draft.

He revealed that his party had not been given access to the draft and had requested a copy for review.

He condemned the leaked draft, asserting that no one could agree with its provisions.

"The draft allows for the

transfer of judges against their will, meaning judges could be transferred at any time, and if a judge refuses, they could be forced to resign. This would impose severe restrictions on the judiciary," he said.

Barrister Gohar also raised concerns about the removal of powers from the Supreme Court, questioning how parallel courts would operate.

He emphasised that all political parties should have been consulted on the constitutional amendments and questioned how consensus could be achieved without a draft being presented on table.—RT/Agency

Imran Claims Constitutional Amendments Are Intended Solely To Keep Him Imprisoned

ISLAMABAD: Imran Khan, founding leader of Pakistan Tehreek-e-Insaf (PTI), has condemned the anticipated constitutional changes.

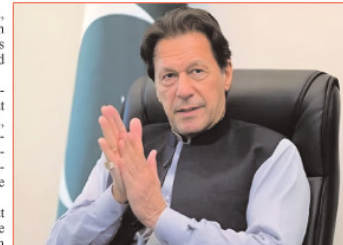
During an informal conversation with journalists at Rawalpindi's Adiala Jail, Imran claimed the government was pursuing the establishment of a new constitutional court out of fear of the Supreme Court.

He further claimed that the recent amendments are designed to keep him in prison and to dismantle the judiciary, Express News reported.

"The rulers have decided to destroy the judiciary," Imran said. "All this is being done to cover up election fraud and protect their corruption."

Imran criticised the amendments to the National Accountability Bureau (NAB) laws, claiming they were used to forgive billions in corruption.

He argued that the government's actions threaten the rule of law and increase



political instability through threats to judges and the elimination of political opposition.

Highlighting economic concerns, he noted that 4,000 Pakistani companies have been registered in Dubai during the past six months.

He attributed the country's inflation to government reliance on loans and highlighted that the elite, with assets abroad, are indifferent to the financial plight of ordinary citizens.

The PTI Founder also

pointed out that Mohsin Naqvi's wife's \$500 million property was revealed in the Dubai Leaks, and further claimed that those behind the amendments have 'hidden wealth abroad.'

Announcing a peaceful protest in Lahore, he called on the public to defend their rights and the judiciary by protesting on September 21.

"This is a matter of our country's future," Imran declared. "We will not remain silent and will protest vigorously."—RT/Agency

SC Urges Media To Implement Self-Accountability Mechanisms Following Vawda And Kamal Press Conferences

ISLAMABAD: The Supreme Court of Pakistan has called on media organisations to establish internal mechanisms for self-accountability, stating that such measures would enhance their credibility and effectiveness in exposing wrongdoing.

"If within the respective press/media organisations a mechanism for self-accountability is developed, it will improve their standing, credibility and resultantly become more effective in drawing attention to wrongdoing, and thus help in stemming it," Chief Justice Qazi Faez Isa wrote in a five-page order issued on Monday.

The statement was part of a ruling accepting the unconditional apology of several TV channels involved in a contempt case.

The case stemmed from the airing of a press confer-



ence by Senator Faisal Vawda and MQM-P MNA Mustafa Kamal, during which the politicians made remarks against superior court judges.

A four-judge bench led by Chief Justice Isa emphasised that while Article 19 of the Constitution guarantees freedom of the press, this right is not without limitations. The court noted that the freedom of the press is subject to restrictions, including the preservation of decency and

morality. "Another fundamental right is provided in Article 14 of the Constitution which requires that the dignity of man is to be ensured. The media is categorised as the fourth pillar of the state and an independent media broadcasting facts and the truth is essential for democratic rule as it highlights wrongdoing. However, its credibility and effectiveness is undermined when falsehoods are broadcast," the order stated.—RT/Agency

Gunvor Group Chairman And Total Energies VP Meet PM To Discuss Petroleum Sector Investments



ISLAMABAD: Gunvor Group Chairman Torbjorn Tomqvist and Vice President Oceania & Southeast Asia Total Energies Mehmet Celoglu Monday called on Prime Minister Muhammad Shehbaz Sharif and discussed potential investment in Pakistan's energy sector.

During the meeting, the prime minister highlighted that after attaining stability, the country's economy was now moving on the path of

growth and development. He said rapid reforms were underway to increase the investment to business activities, and economic policies were yielding positive results. He emphasized that the government was removing all the barriers for foreign investment in Pakistan.

Khawaja Asif Defends Constitutional Amendment As A Measure To Alleviate Judicial Burden

ISLAMABAD: Minister for Defence Khawaja Asif asserted that a potential constitutional amendment aimed at easing the burden on the judiciary.

Addressing the National Assembly session, he stated that parliament was representative of 250 million people and it's their responsibility to uplift this institution according to the constitution. He said that legislation and protection of the constitution was the collective responsibility.

Khawaja Asif highlighted that more than 2.7 million cases were pending in the courts and this amendment aimed to ease the burden on the judiciary.

The PML-N leader asked how the resolution of pending cases and making the common man's life easy could benefit political interests? Asif said that this amend-



ment was not to strengthen any party but to strengthen this institution and this constitutional court would be property of the judiciary.

Democracy was signed by Mian Nawaz Sharif and Benazir Bhutto in 2006 and later on other parties also signed it. There was no politics on amendment and its part of the Charter of Democracy. "There are two drafts circulating on the bill in the media. When a consensus

reaches on the draft then it will be tabled in the house."

He emphasised that these drafts meant to correct the constitutional imbalance and consensus of the whole house was needed on it. These documents included suggestions related to the formation of a constitutional court. The constitutional court wouldn't weaken Parliament as most of the democratic states have constitutional courts," Defence minister highlighted.—RT/Agency

Sheikh Rashid: Fazl Has Won Initial Round Of Debate On Constitutional Amendment Draft

RAWALPINDI: Awami Muslim League chief and former federal minister Sheikh Rashid claims that Maulana Fazlur Rehman has won the first round of the constitutional amendment draft debate.

K-4 Water Project Cost Soars To Rs126 Billion From Initial Rs25 Billion

KARACHI: The cost of Karachi's K-4 water project has surged to Rs126 billion, a steep rise from the original estimate of Rs25 billion, according to Sindh Minister for Local Bodies, Saeed Ghani, on Monday.

K-4, a joint venture between the provincial and federal governments aimed at enhancing Karachi's water supply, has faced significant cost overruns. Saeed Ghani disclosed the updated figures during a session of the Sindh Assembly.

Initially set for completion in mid-2019, the project is now expected to be finalized by April 2027. Ghani attributed the delays to the previous federal government's decision to halt funding, causing the project's costs to escalate further. He also mentioned plans for an additional canal to be drawn from the Hub Dam.

With the cost now projected to reach Rs150 billion, concerns grow as the value of the Pakistan Rupee continues to decline, potentially driving costs even higher in the future.—RT/Agency

The ongoing chaos surrounding the proposed 26th Constitutional Amendment is yet another stark reminder of how disconnected Pakistan's political elite remains from the plight of the common man.

For a nation where food prices have skyrocketed, and unemployment is rampant, the establishment of a new constitutional court or amendments to floor-crossing laws will do

nothing to alleviate the suffering of the masses. These political maneuvers, largely brokered by the ruling elites in closed-door



meetings, only serve their narrow self-interest. The common citizen, already shackled by economic despair, watches helplessly as the political class further distances itself from the core issues that truly matter—livelihood, security, and dignity.

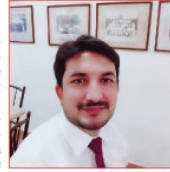

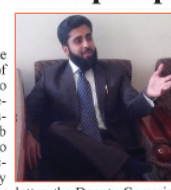

Sindh Makes Biometric Verification Mandatory For Registration And Transfer Of Vehicles

KARACHI: The Sindh government has introduced mandatory biometric verification for the registration and transfer of vehicles across the province, announced Sindh Excise Minister Sharjeel Inam Memon.



The new policy will be rolled out in three phases, Memon explained. Starting July 1st, biometric verification will be required for the registration of new vehicles. In the second phase, effective November 1st, it will apply to those purchasing vehicles. The final phase will mandate biometric verification for both buyers and sellers.

"This is just the beginning," said Memon, emphasizing that the process aims to prevent illegal transfers and fraud. Citizens can complete biometric verification at NADRA e-facilitation centers or district excise offices.

"Since taking charge, Memon has been modernizing the Sindh Excise and Taxation Department. In August, he directed vehicle registration to be available at showrooms for public convenience. Additionally, the minister announced that a second phase of issuing premium number plates, with 50 numbers earmarked for fundraising for flood victims, will soon be launched.—RT

Sindh Government Launches Investigation After Missing Frere Hall Paintings Appear In TV Drama

KARACHI: The Sindh government has launched an inquiry following a social media outcry over the theft of paintings from Karachi's historic Frere Hall, which recently resurfaced in a TV drama. In response, Sindh's Minister for Culture and Tourism, Syed Zulfiqar Ali Shah, has formed a two-member investigative committee to look into the matter.



The committee, which includes the Director General of Culture and the Director General of Antiquities, has been tasked with conducting a thorough investigation and submitting a detailed report on the missing artwork.

Minister Shah acknowledged that the issue came to light through social media after a young artist, Saifi Soomro, claimed his paintings had been stolen from Frere Hall years ago, only to reappear in the Pakistani drama Kabhi Mein Kabhi Tum. The minister assured that the investigation would be comprehensive, with further action to follow based on the findings. "Negligence or misconduct will not be tolerated," Shah said, adding that the government values and supports young artists. Soomro, a painter from Daharki, had initially displayed his work at Frere Hall as part of his thesis, only to be informed that his paintings had been stolen. After discovering his missing artwork in the TV drama, Soomro took to social media to share his experience, sparking widespread calls for legal action and accountability. The Sindh government has vowed to resolve the issue, with further measures to be taken once the investigation is completed.—RT/Agency

Saeed Ghani: Karachi UCs And Towns Lacking Authority For Private Waste Collection Permits

KARACHI: Sindh Local Government Minister Saeed Ghani announced that no union committees or town municipal corporations in Karachi have the authority to grant permits to private entities for door-to-door waste collection, labeling such permissions as illegal.



Ghani made these remarks during the Sindh Assembly session on Monday, addressing concerns raised by lawmakers. He criticized the private waste collectors, describing them as a "mafia" causing serious civic issues. These private operators, he noted, sort through municipal waste to retrieve valuable items, disposing of the remaining trash carelessly into stormwater drains.

The Minister proposed a system for door-to-door waste collection managed by the relevant union committees, which could also generate revenue for them. He emphasized that current private waste collectors should be barred from operating.

Ghani highlighted the Board (SSWMB). He reported improvements in waste disposal since the SSWMB's involvement but acknowledged the need for further progress. He detailed ongoing projects, including the construction of four out of five planned garbage transfer stations (GTS) to manage waste scientifically, with delays due to land issues affecting the Sobrab Goth GTS. Additionally, work is underway to expand the Hub canal's capacity and to construct a new canal to boost water supply to Karachi. The K-IV bulk water supply project is expected to be operational by April 2027.

BMA Calls for High Court Oversight Of KCCI Elections Amidst Controversies

KARACHI: The upcoming Karachi Chamber of Commerce & Industry (KCCI) elections for 2024-26 are facing significant controversy, with Asif Sakhi of the Businessmen Alliance (BMA) accusing the Election Commission of bias and unfair practices in favor of the ruling BMG group.

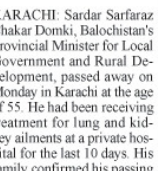
Plot Allotments In Gulistan-E-Sarmast Housing Scheme Have Been Made Public: Saeed Ghani

He informed lawmakers that the Hyderabad Development Authority (HDA) is overseeing the plot allotment process and that a proposal has been submitted to the Sindh cabinet for a financial grant to bolster the HDA's resources.

Balochistan Minister Sarfaraz Domki Dies At 55 In Karachi



KARACHI: Sardar Sarfaraz Chakar Domki, Balochistan's Provincial Minister for Local Government and Rural Development, passed away on Monday in Karachi at the age of 55. He had been receiving treatment for lung and kidney ailments at a private hospital for the last 10 days. His family confirmed his passing after he remained in critical condition for several days.

Prime Minister Shehbaz Sharif expressed deep condolences, recognizing Domki as a prominent figure in Balochistan's political scene. "His death leaves a void in Balochistan's leadership," the Prime Minister noted, offering prayers for his family during their time of grief. Former President Asif Ali Zardari also conveyed his sorrow, lauding Domki's contributions to Balochistan's politics and praying for his soul. Balochistan Chief Minister Mir Sarfraz Bugti echoed similar sentiments, calling Domki a wise and respected tribal leader who played a pivotal role in the region's political landscape. Bugti extended his heartfelt condolences to the Domki family, offering his support.

Domki, the chief of the Domki tribe, won 27,677 votes in the 2024 Balochistan Assembly elections as a PPP-P candidate. His political career included positions as Provincial Minister for Labour and Management (2018-2023) and a brief stint as Minister for Culture, Archives, and Tourism in 2018. Having been an influential figure in Balochistan's politics since 2013, his passing marks the end of an era. His funeral will be held in his hometown, Bakhtiyar Abad.—RT/Agency

Rangers Step In To Offer Emergency Support For People Of Sindh



KARACHI: With rising crime rates and local police struggling to maintain security, Sindh Rangers have stepped up, offering citizens vital information on how to seek assistance in emergencies, according to media reports on Monday.

Deputy Superintendent Rangers (DSR) Mazhar Abbas announced that the Pakistan Rangers in Sindh are dedicated to safeguarding the lives and property of citizens, particularly the youth. The emergency helpline, 1101, is in place to ensure swift response in critical situations. The Rangers' command and control center, equipped with extensive monitoring systems and a route map of Karachi, coordinates emergency responses. CCTV surveillance covers various parts of the city to enhance security efforts. DSR Mazhar Abbas highlighted that the 1101 helpline operates as a rapid response unit, capable of addressing complaints within 3 to 5 minutes. Citizens can reach the Rangers via WhatsApp, text messages, email, and the SOS app, with complaints categorized into immediate and verification-based responses. For urgent cases, mobile teams are dispatched to the scene, while calls requiring further investigation are handled through ground verification before action is taken.—RT/Agency

Hyderabad Industrialists' Concerns To Be Addressed Urgently, Assures Jam Ikram

Ismail Suttar Calls On Punjab Government To Consult Stakeholders Before Banning Raw Pink Salt Exports

KARACHI: Ismail Suttar, Founding Chairman of the Salt Manufacturers Association of Pakistan (SMAP), voiced serious concern over the Punjab government's potential ban on the export of raw pink Himalayan salt. Reacting to Chief Minister Maryam Nawaz Sharif's recent announcement, Suttar criticized the move as a hasty decision made without consulting key industry stakeholders.



holders. Citing the example of Indonesia's Trade Minister, who consulted widely before banning raw nickel exports, Suttar emphasized that developing value-added products requires time, investment, and research.

In a statement, Suttar expressed disappointment that the salt industry was not consulted before such a significant announcement. He stressed that SMAP had expected to engage with the government to discuss the potential implications of the export ban.

He suggested that, if the government is committed to promoting value-added exports, it should focus on processing other valuable minerals like lithium, rare earth elements, and sulphate of potash, which have the potential to generate significant revenue for Pakistan. SMAP is not opposed to a ban on raw salt exports if it benefits the nation but insists that the government must include industry stakeholders in the decision-making process to safeguard the country's remaining exports.—RT

IHC Seeks Government's Clarification On Potential Military Trial For Imran In May 9 Case

ISLAMABAD: The Islamabad High Court (IHC) on Monday once again sought clarification from the government over Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan's possible military trial over his alleged involvement in the May 9 riots.



IHC's Justice Mianqul Hassan Aurangzeb presided over the hearing on PTI founder's petition against the military trials in the May 9 case that witnessed military installations being vandalised following his arrest in a graft case last year.

"There is no clear answer from the government. I am giving you time to bring instructions in this regard," said Justice Aurangzeb during the hearing today.

The court ordered the Ministry of Defence to give a clear stance on the next hearing after which the ministry

sought time. The hearing was adjourned till next Tuesday (September 24).

The former prime minister's pleas came in the wake of statements by government high-ups including Defence Minister Khawaja Asif and Law Minister Azam Nazeer Tarar that fuelled rumours of his military trial.

It is pertinent to know that in July last year, an anti-terrorism court in Lahore — in

a four-page written verdict — said that reasonable grounds existed to connect the PTI founder with the May 9 incidents.

It is to be noted that Pakistan Democratic Movement (PDM) led government had initiated military trials of those involved in targeting state and military installations in last year's riots.

The matter ended up in the Supreme Court which de-

clared civilians' trials in military courts null and void in its October 23, 2023, verdict which was later superseded by the apex court in a 5:1 majority ruling in December.

The majority order was announced on the intra-court appeals filed by the federal and provincial governments and the defence ministry against the top court's verdict.

The December 13, 2023, verdict stated that military court trials would be conditioned on the apex court's final verdict on the intra-court pleas.

During the hearing today, Justice Aurangzeb asked the procedure of handing someone in military custody. "The Ministry of Defence has no information of military detention and trial till date," he remarked, adding that nothing regarding the matter has

been brought before the ministry.

The additional attorney general said: "If any request is made, action will still be taken according to the law."

At this, Justice Aurangzeb said he has nothing to proceed with in this case. The court then sought the procedure of civilians' trial in military court from the defence ministry.

The defence ministry's representative said they have a "very clean procedure".

"If a notice is issued to PTI founder before the military trial, then the case will be wrapped up," said Justice Aurangzeb, adding that the civil court will first frame the charge, according to the procedure. If the trial court says that the case is to be sent to the military court, then the notice should be issued first, he added.—RT/Agency

Pakistan Seeks Enhanced Cooperation With US To Address Economic And Security Challenges

ISLAMABAD: Deputy Prime Minister Ishaq Dar on Monday emphasised the importance of positive and productive engagement between Pakistan and the US, highlighting the ongoing macro-economic and regional security challenges, particularly the infiltration of insurgency through the porous Afghan border.



Dar, who is also the country's foreign minister, said this during an interaction with the US Acting Under Secretary of State for Political Affairs John Bass, at the Foreign Office in Islamabad. The meeting was also attended by Principal Deputy Assistant Secretary Elizabeth Horst.

Both officials discussed approaches to expanding bilateral cooperation on economic and security issues, including countering terrorism and violent extremism, and the importance of fostering regional stability and prosperity, according to a US Mission handout.

Earlier this month, the US strongly condemned the August 26 terrorist attacks in Balochistan, which resulted in the deaths of over 50 people, including 14 security personnel.

The US State Department's spokesperson Matthew Miller, at a news briefing, said that "Washington strongly condemned the deadly attacks that targeted

security officials and civilians, including the murder of 23 innocent civilians in Musakhail".

The assaults were the most widespread in years by ethnic militants fighting a decades-long insurgency to win secession of the resource-rich province, home to major China-led projects such as a port and a gold and copper mine.

Acting Under Secretary Bass expressed his gratitude for Pakistan's continued cooperation in assisting Afghans in resettlement pathways to the US.

The Under Secretary congratulated the Deputy Prime Minister on Pakistan's election as a non-permanent member of the United Nations Security Council for the 2025-2026 term and expressed the US's interest in working closely with the Government of Pakistan during his tenure.

Bass, also called on Chief of Army Staff (COAS) Gen-

eral Asim Munir. The meeting focused on matters of military cooperation, geopolitical issues, and security situation along the Pak-Afghan border.

Pakistan has witnessed a surge in militant attacks since the Taliban government returned to power in neighbouring Afghanistan in 2021, mostly in the border province of Khyber Pakhtunkhwa, but also in Balochistan, which abuts Afghanistan and Iran.

At least 170 militant attacks were killing 151 civilians and 114 security personnel in Balochistan last year, according to the Pakistan Institute for Conflict and Security Studies.

Against this backdrop, the federal cabinet in June this year approved Operation Azm-e-Istehkam, a reinvigorated national counter-terrorism campaign following the Central Appellate Committee's recommendations under the National Action Plan to root out terrorism.—RT/Agency

Azam Nazeer Initiates Consultations With Political Parties On Proposed Constitutional Reforms

ISLAMABAD: Minister for Law and Justice Azam Nazeer Tarar on Monday informed the National Assembly that the process of talks has been initiated with all the political parties in the Parliament (National Assembly and Senate) on the proposed constitutional package.



Responding to points raised by PTI lawmaker Asad Qaisar, the minister said it would be the government's efforts to evolve consensus on the document.

He urged the opposition parties to come up with positive recommendations instead of undue criticisms, assuring that these would be accommodated in the proposed constitutional package.

He called upon the opposition to come forward and support the positive move in order to provide relief to the people suffering for the last over last seven decades.

Azam Nazeer said any legislation in line with the constitutional structure was the prerogative of the Parliament. The proposed constitutional package envisaged formation of the judicial commission as per the spirit of the 18th amendment and Charter of

Democracy (CoD), he said.

He said under the package, it was proposed to empower the judicial commission to regulate and evaluate the performance of the judges of the high courts.

He said the judges enjoyed official perks and privilege and it was his sole responsibility to dispense timely justices to the masses. Justice delay was tantamount to justice denied, he added.

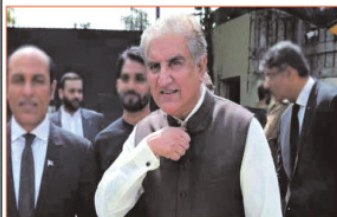
The minister said that during formation of the incumbent government proper consultation was made with different parties including Pakistan Peoples Party, PML-Z, IPP, ANP, Maulana Fazal ur Rehman, Mehmo-

Khan Achakzai and Dr Abdul Malik etc. After formation of the government, it was our top priority to bring judicial reforms as it was unfinished part of CoD, he added.

He said that the 18th constitutional amendment ratified all wrong doings made with the 1973 constitution. He paid tribute to the parliament for the said landmark amendment.

He said the package was a set of amendments to the Constitution. As per procedure, a constitutional amendment first needed to be cleared by the federal cabinet, he added. He said the constitutional package has not been presented before the federal cabinet yet.—RT/Agency

Shah Mahmood Warns Constitutional Amendments Will Undermine Judiciary



LAHORE: Pakistan Tehreek-e-Insaf (PTI) senior leader Shah Mahmood Qureshi said that the government's plan of constitutional amendment is tantamount to bury the constitution.

Talking to media on Monday after the court hearing, the veteran politician paid tribute to JUI-F chief Maulana Fazlur Rehman for not supporting the constitutional amendment.

"I request all the political parties to thoroughly study the draft of the amendment before voting in favour of the bill," he said.

The constitutional amendment is a serious issue and it shouldn't be passed in haste, he said.

Qureshi said that the draft of the bill should be tabled in the National As-

sembly to ensure transparency in the process.

The house should have debate over the constitutional amendment, he added.

"Your grandfather made the constitution of 1973 with consensus but you are burying it," Qureshi said, while addressing the PPP chairman Bilawal Bhutto Zardari.

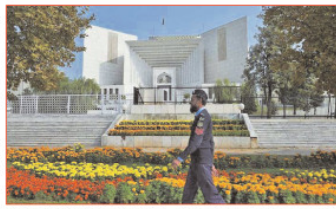
He also termed the proposed amendment an attack on the judiciary.

"The basic structure of constitution would be changed through this amendment," the seasoned politician said.

Supreme Court Approached To Block Controversial Constitutional Amendment Bill

ISLAMABAD: As the government seeks to introduce a controversial constitutional amendment bill, the Supreme Court has been petitioned against the proposed changes to the Constitution of Pakistan.



The country witnesses political turmoil revolving around the incumbent government's prospective constitutional amendment bill, aimed at making major changes to Pakistan's judicial and parliamentary systems, which the opposition parties, especially Pakistan Tehreek-e-Insaf (PTI) vehemently opposed. In a constitutional petition filed under Article 184(3), the apex court has been requested to set aside the proposed amendments and declare them "ultra vires" the Constitution, prin-

terfere or tamper with independence of judiciary and fundamental rights enshrined under the law. "It is requested that the separation of powers and independence of the judiciary and its powers and functions to enforce the fundamental rights be kindly declared as sacrosanct under the Constitution and beyond the power and competence of the Parliament to withdraw,

interfere or tamper with independence of judiciary in any manner whatsoever," the petition read. The petitioners requested the court to restrain the federal government from tabling the bill, order the suspension of the operation of the proposed amendments, and stop it from being signed into law by the president of Pakistan even if it sails through both houses of parliament.—RT/Agency

ATC Orders Release Of PTI Lawmakers Detained After Islamabad Rally



ISLAMABAD: An anti-terrorism court in Islamabad Monday ordered the immediate release of all the Pakistan Tehreek-e-Insaf's (PTI) members of the National Assembly arrested from the Parliament House in the wake of the party's September 8 political show in Islamabad.

ATC Judge Abul Hasnat Zulqarnain heard the bail pleas and granted post-arrest bail to the PTI MNAs who were taken into custody by the Islamabad police with their cases registered at the Sangjani police station.

The bails were granted against surety bonds worth Rs30,000 each.

During the hearing of the case, the prosecutor, Raja Naveed, told the court that Summi Itehad Council (SIC) MNA Muhammad Ahmed Chattha is also nominated in the case. He requested the court against approving bails

as the minimum sentence for provocation imposed in the case is three years.

"Has anything been recovered from Sher Afzal Marwat, Ahmed Chattha and other MNAs?" the judge questioned the prosecutor.

He responded to the question in the negative.

Meanwhile, the court also approved the pre-arrest bail petition filed by PTI leader Advocate Ali Bukhari in the case pertaining to his violation of the No Objection Certificate (NOC) and assault on police personnel in Islamabad during the party's gathering.

Following the hearing, the court issued a notice and adjourned the hearing of the case till October 1. The police, on September 8 and 9, arrested PTI lawmakers in the wake of the party's political gathering in the federal capital.—RT/Agency
