UNGA Passes Resolution Urging Israel To End Occupation Of Palestinian Territories Within A Year

UNITED NATIONS: The United Nations General Assembly on Wednesday adopted a Palestinian-drafted resolution that demands Israel end its unlawful presence in the Occupied Palestinian Territory within 12 months.



The resolution received 124 votes in favor, while 43 countries abstained and Israel, the United States and 12 others voted no.

The action isolates Israel days before world leaders travel to New York for their annual UN gathering. Israeli Prime Minister Benjamin Netanyahu is due to address the 193-member General Assembly on Sept. 26, the same day as Palestinian President Mahmoud Abbas.

The resolution welcomes a July advisory opinion by the International Court of Justice that said Israel's occupation of Palestinian territories and settlements is illegal and should be withdrawn.

The advisory opinion - by the highest United Nations court, also known as the World Court - said this should be done "as rapidly as possible," although the General Assembly resolution imposes a 12-month deadline.

The General Assembly resolution also calls on states to "take steps towards ceasing the importation of any products originating in the Israeli settlements, as well as the provision or transfer of arms, munitions and related equipment to Israel... where there are reasonable grounds to suspect that they may be used in the Occupied Palestinian Territory."

The resolution is the first to be formally put forward by the Palestinian Authority since it gained additional rights and privileges this

month including a seat among UN members in the assembly hall and the right to propose draft resolutions.

US Ambassador to the UN Linda Thomas-Greenfield urged countries to vote no on Wednesday. Washington - an arms supplier to and ally of Israel - has long opposed unilateral measures that undermine the prospect of a two-state solution.

The ICJ advisory opinion is not binding, but carries weight under international law and may weaken support for Israel. A General Assembly resolution also is not binding, but carries political weight. There is no veto power in the assembly.

"Each country has a vote, and the world is watching us," Palestinian UN Ambassador Riyad Mansour told the General Assembly on Tuesday. "Please stand on the right side of history. With international law. With freedom. With peace."

Israel's UN Ambassador Danny Danon criticized the General Assembly on Tuesday for failing to condemn the October 7 attack on Israel by Palestinian Hamas militants that sparked Israel's assault on the Hamas-run Gaza Strip.

He rejected the Palestinian text, saying "Let's call this for what it is: this resolution is diplomatic terrorism."

Fazl 'Firmly' Rejects Constitutional Package Despite Coalition Government's Efforts

ISLAMABAD: Jamiat Ulama-e-Islam Fazl (JUI-F) Chief Maulana Fazlur Rehman, who took the center stage as both the government and the opposition sought his support, has completely rejected the draft of the "controversial" constitutional package, aimed at making changes to Pakistan's judicial and parliamentary systems.



"The draft we were given was reviewed, and it was in no way acceptable," the veteran politician said while talking to journalists after attending a luncheon at Pakistan Tehreek-e-Insaf (PTI) leader Asad Qaiser's residence on Wednesday.

The government pushed the proposed constitutional package amid speculation about a potential extension in the tenure of Chief Justice of Pakistan (CJP) Qazi Faez Isa, who is set to retire in October this year, following the PTI's request last month for the early issuance of a notification regarding the appointment of the next top judge.

The ruling coalition left no stone unturned to woo the 'fate-decider' Fazl, with leaderships of Pakistan Muslim League-Nawaz (PML-N) and Pakistan People's Party (PPP) holding a flurry of meetings with the cleric, but to no avail.

Despite claims of securing the "magic number" needed to push the bill through, the government failed to table the amendments in parliament and postponed its move indefinitely — a development confirmed by PML-N Senator Inam Siddiqui.

The amendments allegedly include legislation to extend the tenure of CJP Isa as well as an increase in retirement age of the judges. To pass the constitutional amendments, the

government is short of 13 votes in the National Assembly (NA) and nine in the Senate.

The PTI and JUI-F, which have been arch-rivals traditionally, found common ground after the February 8 general elections and expressed mutual concerns over the alleged interference and manipulation during the polls.

Former NA speaker Asad Qaiser hosted a luncheon in honour of the JUI-F head in Islamabad today, which was also attended by other PTI lawmakers including Omar Ayub, Barrister Gohar and former president Arif Alvi.

Speaking to journalists following the meeting, Fazl

said they have completely rejected the constitutional amendments' proposed draft provided by the government. "It [the draft] was shared with specific individuals, not with everyone."

"Had we agreed to the constitutional package, it would have been the biggest breach of nation's trust," he added.

For his part, Asad Qaiser castigated the incumbent rulers for 'concealing' the draft of the constitutional package, which he said contained at least 56 amendments, even from its own parliamentarians.

"We do not accept this legislation in any respect."

The PTI leader further said that the future course of action will be decided after consultation with all opposition parties. However, he mentioned, they will table this matter in tomorrow's lawyers' convention in Lahore.

During their meeting, they engaged in productive discussions on matters of mutual interest, regional security dynamics, and bilateral cooperation across various sectors, the Inter Services Public Relations

(ISPR) said in a statement. The COAS reiterated Pakistan's commitment to fostering traditional defence ties with Russia. Both sides reaffirmed their resolve to strengthen security and defence cooperation in multiple domains.

The visiting dignitary praised the Pakistan Armed Forces' pivotal role in combating terrorism and their tireless efforts to promote peace and stability in the region.—RT/Agency

Russia To Support Pakistan's BRICS Membership Bid: Russian Deputy PM

ISLAMABAD: Russian Deputy Prime Minister Alexei Overchuk stated on Wednesday that Moscow supports Pakistan's inclusion in BRICS.



During a joint press conference with Pakistan's Foreign Minister Ishaq Dar in Islamabad, Overchuk responded positively to questions about Pakistan's request to join the group of leading emerging market economies.

Deputy Prime Minister and Foreign Minister Ishaq Dar stated that discussions with his Russian counterpart focused on expanding economic relations between Pakistan and Russia.

During the press conference, he noted that bilateral trade reached \$1 billion last year, and both countries prioritise expanding trade ties by addressing logistical and related issues.

Dar stressed the potential for energy cooperation with Russia and expressed Pakistan's eagerness to develop connectivity projects, including rail and road networks, between the two nations and beyond.

Regarding regional cooperation, he highlighted that Pakistan views Russia as a key player in West, South, and Central Asia, and strengthening mutually beneficial relations with Russia is a priority for Pakistan's foreign policy.

He also mentioned Pakistan's commitment to achieving peace and stability in Afghanistan.

Recognising Russia's historically strong ties with the Muslim world, the Organization of Islamic Cooperation (OIC), and its stance on the Palestine conflict, Dar appreciated Russia's position that freedom of speech should not be used to disrespect revered figures or religions, as it could hurt the sentiments of the Muslim Ummah.

Dar expressed hopes for continued high-level contacts and reaffirmed Pakistan's commitment to deepening relations with Russia.

On his part, Deputy Prime Minister Overchuk discussed the prospects for collaboration between Pakistan and the Eurasian Economic Union, which includes Armenia, Belarus, Kazakhstan, and Russia.

He noted that they discussed opportunities for implementing a free trade agreement between Pakistan and these five countries, looking forward to further discussions to finalise the agreement.

Overchuk also stated that the upcoming intergovernmental commission meeting later this year in Russia would provide an opportunity to enhance trade and economic relations between the two countries.

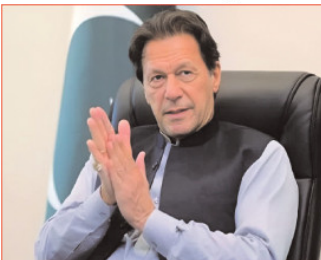
He added that their goals and visions for development and economic ties within the Shanghai Cooperation Organization are well aligned, particularly regarding connectivity, climate agenda, food security, energy transition, and energy security.

Moreover, Pakistan and Russia agreed to enhance dialogue and cooperation in various sectors, including trade, industry, energy, connectivity, science, technology, and education. This consensus was reached during delegation-level talks between Deputy Prime Minister Ishaq Dar and his Russian counterpart in Islamabad today.

Deputy Prime Minister Overchuk's visit aligns with the vision of Prime Minister Shehbaz Sharif and President Vladimir Putin to transform bilateral relations into a strong, mutually beneficial economic partnership.—RT/Agency

Imran Claims Constitutional Amendments Aim To Extend Tenure For 'Three Umpires'

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan has alleged that a constitutional amendments are being pursued to extend the terms of three top officials, including Chief Justice Qazi Faez Isa, Islamabad High Court's chief justice, and the Chief Election Commissioner.



Speaking to the media at Adiala Jail, Imran claimed that the government, despite losing previous political battles, is now resorting to these amendments to safeguard fraudulent election results and protect officials in power.

"They are amending the constitution to extend the terms of three umpires," Khan said.

He warned that if Chief Justice Isa is removed, investigations into the May 9 protests and the alleged rigged elections will be

launched. Imran expressed concern that if the new chief justice takes office, the true events of May 9 will come to light.

He also criticised the government for undermining Pakistan's judicial and electoral processes and delaying the tribunal decisions on the February 8 election.—RT/Agency

£190m Case: IHC Prohibits Trial Court From Final Verdict On Imran's Petition



ISLAMABAD: The Islamabad High Court (IHC) on Wednesday stopped the accountability court from issuing a final verdict in the £190 million settlement case against incarcerated Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan and his wife Bushra Bibi.

A two-member bench of the high court comprising Chief Justice Aamer Farooq and Justice Miangul Hassan Aurangzeb heard the couple's acquittal plea in the said case.

The PTI founder on September 7 had filed a plea seeking acquittal in the £190 million case after the Supreme Court's verdict in the National Accountability Bureau (NAB) amendments case wherein the court accepted the intra-court appeals filed against last year's verdict which struck down the changes made to the National

Accountability Ordinance (NAO).

The couple is accused of causing billions of rupees loss to the national exchequer.

The former premier and the ex-first lady also approached the IHC against the accountability court's ruling, seeking acquittal and pleading with the court to stop the trial court's proceedings until the case remains pending in the high court.

After hearing arguments, the IHC ordered the trial court to complete proceedings, however, it should not issue a final judgment.

The IHC bench also directed Khan and Bushra's lawyers to submit relevant documents. It also issued notices to the respondents over the couple's acquittal pleas and adjourned the hearing till September 26.—RT/Agency

NAB Amendments: Accountability Court Grants Relief To Former Finance Minister Hafeez Sheikh

KARACHI: An Accountability Court on Wednesday granted relief to former federal finance minister (fin-min) Abdul Hafeez Sheikh and others accused in a corruption case.



The case about the development of software for Port Qasim and other ports was heard in Karachi's accountability court.

In its verdict on the jurisdictional application, the court accepted the plea of the accused and directed that the National Accountability Bureau (NAB) reference be

returned to the NAB Chairman.

The defense argued that following amendments passed by the parliament, the accountability court no longer has jurisdiction to hear the case.

The court further stated that the prosecution lacked evidence showing that the accused received financial benefits. The court added that it was a prerequisite for the NAB reference.

Former federal minister Abdul Hafeez Sheikh and others are charged with abuse of power and corruption, according to NAB.

The accused are alleged to have caused a loss of \$11 million dollars to the national treasury. The NAB filed a reference for recovery.—RT/Agency

ECP Postpones Intra-Party Election Case Till October 2 As PTI Requests Additional Time

ISLAMABAD: The Election Commission of Pakistan (ECP) has adjourned the hearing of Pakistan Tehreek-e-Insaf's (PTI) intra-party election case until October 2, following a request by PTI for additional time to submit required documents. A three-member bench, led by ECP Member Sindi Nisar Durani, presided over the proceedings, with PTI Chairman Barrister Gohar representing the party. During the hearing, ECP Member Balochistan questioned whether PTI's intra-party elections were



conducted in Chamkani, Peshawar, to which Barrister Gohar clarified that the elections took place in Islamabad. Gohar also sought a 10-day extension to finalise the docu-

mentation. The Director General of Political Finance warned that if the results of the intra-party elections were not recognised, PTI could face an uncertain future without an organisational structure.

The bench instructed the DG Political Finance to provide further assistance on the matter to which he explained that under Section 208 of the Election Act, there should have been a five-year gap between two intra-party elections, with Barrister Gohar expressing his agreement.—RT/Agency

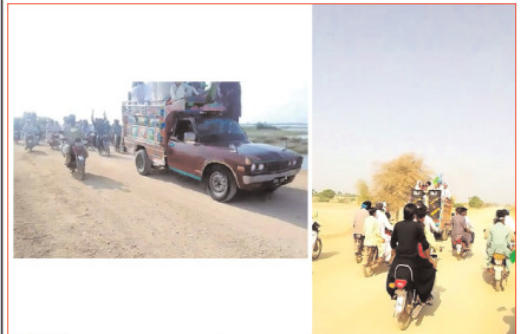

Does anyone care about the declining health of democracy in Pakistan?

The recent refusal by local authorities to allow Pakistan Tehreek-e-Insaf (PTI) to hold a public rally in Karachi under the pretext of security concerns raises serious questions about the health of democracy in Pakistan. Time and again, security threats are cited as a reason to suppress PTI's political activities, while other parties continue to function freely. The situation in Karachi, as heard by the Sindh High Court (SHC), paints a troubling picture of how selective security assessments are being used to curtail PTI's political freedoms.

Justice Yusuf Ali Saeed, in a pointed in-

quiry, questioned why only PTI faces such restrictions, while other political parties have been allowed to rally without issue. The fact



that the deputy commissioner East claimed that security clearance had not been granted without providing concrete evidence or explanation further deepens the concern. If security is such an overarching issue, a blanket ban on all political rallies, as suggested by the court, might seem more consistent. Yet,

only PTI's activities are being targeted.

A thriving democracy relies on a level playing field where all political parties are allowed to operate without fear or favor. PTI, like any other political entity, must have the freedom to engage with the public. Selective suppression of political activities, especially on dubious grounds, sets a dangerous precedent for future democratic processes in Pakistan. All political parties deserve equal rights to assembly and free expression, and no institution should hinder these essential democratic pillars in the name of security without clear justification.

Champions Trophy 2025: ICC delegation reviews arrangements at Karachi's National Stadium



KARACHI: An International Cricket Council (ICC) delegation visited the National Stadium in Karachi to assess the ongoing preparations for the 2025 ICC Champions Trophy, set to be held in Pakistan next February.

The five-member delegation, which included key officials from the ICC, is conducting a comprehensive review of facilities across several venues to ensure Pakistan's readiness for the prestigious tournament.

The delegation comprised Security Manager David Masker, Event Manager Sarah Edgar, General Manager Cricket Wasim Khan, Event Manager Aun Zaidi, and Broadcast Consultant Mansoor Manj.

During their visit to the National Stadium, they inspected the construction work in progress and captured photos and videos for further analysis.

Director of International Cricket Usman Wahla and Senior General Manager of

the National Stadium Arshad Khan provided a detailed briefing on the construction efforts aimed at upgrading the venue for the global event.

In addition to Karachi, the ICC team will visit other key venues in Islamabad, Rawalpindi, and Lahore during their four-day stay in Pakistan. These inspections will ensure that all facilities are in top condition for hosting the Champions Trophy.

The delegation's visit follows a previous inspection conducted by a three-member ICC team in April of this year.

The ICC delegation is scheduled to depart for Dubai on September 21, with Pakistan continuing its final preparations to host their first multi-team event since 2008.

Remember last week, ICC Chief Executive Geoff Allardice confirmed that there are currently no plans to relocate the ICC Champions Trophy 2025 from Pakistan.—Agency

SL vs NZ: Kamindu Mendis equals Saud Shakeel's record



Sri Lanka's Kamindu Mendis has etched his name into the record books by equalling a world Test record, becoming only the second batter to score 50+ runs in each of his first seven Test matches.

Pakistan's Saud Shakeel is the only other batter to achieve this remarkable feat.

Mendis brought up his eighth 50-plus score in Tests during the first day of the opening Test against New Zealand in Galle. This milestone also sees him surpass cricket legends Sunil Gavaskar (India), Saeed Ahmed (Pakistan), and Basil Butcher (West Indies), all of whom scored a fifty in each of their first six Test matches.

Kamindu's achievement follows a standout series in England, where he registered scores of 2, 113, 74, 4, and 64. He made his Test debut in 2022 against Australia in Galle, where he scored 61 in Sri Lanka's innings victory.

However, he did not feature in the Test side for almost two years after that. Upon his return against Bangladesh earlier this year, he showcased his form with scores of 102 and 164 in the opening Test, followed by an unbeaten 92 in Chattogram.

In the ongoing Test in Galle, Kamindu reached his fifty off 73 deliveries. He also put on a 72-run partnership for the fifth wicket with Angelo Mathews, who returned to bat after retiring hurt following a blow to his hand.—Agency

Samaro Police recover trader's stolen cash and mobile phone



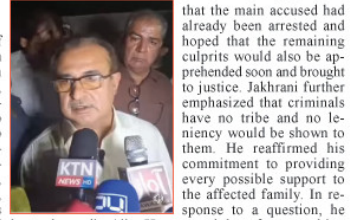

The paintings were reportedly lost, and seven years later, the same paintings appeared in a scene of an Urdu drama. The issue gained attention on social media, prompting the Minister for Culture of Sindh to take notice and form a two-member inquiry committee. According to the details, Saifi Soomro, known for his meticulous artwork, claimed that in 2017, he exhibited two paintings at Frere Hall in Karachi. Shortly after the exhibition, the hall's administration informed him that some paintings, including his, were missing and refused to return his work. Despite multiple follow-ups, the administration's responses remained unchanged, leading Soomro to remain silent for several years. Recently, Soomro discovered that the same paintings were featured in a scene of a popular Pakistani drama aired on Urdu channel. Recognizing his

work, Soomro attempted to contact the channel and relevant authorities but found no satisfactory resolution, prompting him to raise the issue on social media. The Minister for Culture and Tourism of Sindh, Syed Zulfiqar Ali Shah, took notice of the matter and formed a two-member committee to investigate. The committee contacted Soomro to gather information and is expected to submit a report by next Friday. Soomro stated that the Frere Hall administration has since been in touch with him and has confirmed that his paintings are available at the hall and ready for collection. However, he believes that fraud and deception were involved since his paintings were used in the drama without his permission, and any rental fees for their use were not compensated. Saifi Soomro also learned that his paintings might have been rented out for other TV stories, which he considers unfair. The young artist, who sees art as both his passion and obsession, expressed his dismay over the injustice he faced. He has called on the intellectuals and the Sindh Government to ensure that justice is served.

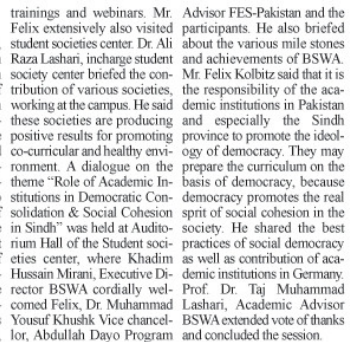

Murad Allocates Rs1.5bn For Repair Of Karachi's Rain-Damaged Roads

In a separate meeting, the CM was informed that floods also damaged 219 roads in Hyderabad Division and 178 roads in Sukkur Division. Meanwhile, Asif Sakhi, leader of the Businessmen Alliance (BMA), voiced concerns about possible electoral manipulation. He alleged that BMG, unsettled by the threat of losing power, is resorting to questionable and illegal tactics to secure victory. Internal divisions within BMG have surfaced, driven by unethical behavior and authoritarian practices, further weakening the group. Sakhi emphasized that

a broad coalition, including shopkeepers, traders, importers, and industrialists, is united in opposition to BMG. The ruling group, in response, attempted to discourage participation by illegally raising the nomination fee from Rs15,000 to Rs100,000, a move invalidated by the Director General of Trade Organizations (DGTO), who restored the original fee. He also accused BMG of manipulating voter lists, providing incomplete and inaccurate data. Despite DGTO directives, the group continues to pursue elections under questionable conditions, prompting the BMA to consider legal challenges.—RT

Haleem Accuses IRSA Amendment Ordinance Of Threatening Sindh's Agriculture

KARACHI: Haleem Adil Sheikh, President of Pakistan Tehreek-e-Insaf (PTI) Sindh, has vehemently denounced the IRSA Amendment Ordinance 2024, calling it a deliberate plot to render Sindh's agricultural lands barren.

In a recent statement, Sheikh accused President Asif Ali Zardari of masterminding the ordinance, claiming it was originally proposed during Dr. Arif Alvi's tenure, but Alvi had

refused to endorse it. Sheikh also criticized the Pakistan Peoples Party (PPP) for allegedly mismanaging Sindh's resources, accusing them of hypocrisy. He stated that while Zardari endorsed the ordinance, the PPP later presented a resolution against it in the Sindh Assembly to mislead the public. Sheikh urged the PPP to demonstrate its commitment to Sindh by participating in protests against the ordinance scheduled for September 19. PTI, along with its allies, plans to stage demonstrations across Sindh to resist any efforts to exploit the province's resources. He further accused the PPP of a 15-year track record of exploiting Sindh, from depleting its forests to selling off Karoonjhar, and now attempting to negotiate away the province's water rights.—RT/Agency

140 Chikungunya Cases Confirmed Through PCR Tests: Azra Pechuho

KARACHI: Sindh Health Minister Azra Pechuho revealed that 140 Chikungunya cases have been confirmed this year through PCR tests, as reported by the media on Wednesday. Speaking to the press, Pechuho also noted improvements in the Malaria situation across Sindh. The minister highlighted irregularities in admissions at Lyari General Nursing Hospital, where fake documents were used. She announced plans to scrutinize the fraudulent documents. Pechuho also addressed concerns raised about a milk bank set up in Korangi, stating that discus-



sions with NADRA's chairman revealed issues with the regulations. She added that the federal cabinet holds the authority to amend these rules and has written to the prime minister for action. Pechuho further mentioned that discussions have been held with the Council of Islamic Ideology regarding the matter, and changes to legislation will follow once federal government issues are resolved.—RT/Agency

Over Rs1bn In Financial Irregularities Discovered In PPHI Sindh

KARACHI: Significant financial irregularities, amounting to over Rs1 billion, have been uncovered in the People's Primary Health Initiative (PPHI) Sindh, according to a report by the auditor general. The report highlights an unauthorized loan of Rs1.18 billion taken from Sindh Bank, as well as over Rs1 billion worth of substandard and expired medicines stocked by the health initiative. Further irregularities include more than Rs950 million spent improperly on lab equipment procurement and Rs480 million misused during flood relief efforts intended for food aid. Additionally, Rs78 million was paid to various companies for the purchase of low-quality medicines, while Rs24.2 million allocated for civil works at the Rural Health Center in Bhan Saeedabad, Jamshoro, was also flagged in the report.—RT/Agency

SHC Halts NADRA From Charging Fees For Inheritance Certificates



KARACHI: The Sindh High Court (SHC) has suspended the National Database and Registration Authority (NADRA) from collecting fees for the issuance of inheritance certificates. This decision came during a hearing on a petition challenging NADRA's fee policy, where the court requested input from the deputy attorney general and assistant advocate general. The petitioner's lawyer argued that NADRA continues to charge fees even when applications for inheritance certificates are rejected, which violates its own regulations that only allow fees to be charged for services rendered. The lawyer further contended that the current fee of Rs22,000 for inheritance certificates is excessive, as these certificates are essential for distributing property according to Islamic law. The SHC ordered NADRA to stop charging fees for inheritance certificates and letters of administration, though it allowed fees for routine services like ID cards and family registration certificates (FRC) to continue. The court also questioned whether NADRA can impose fees based on property ownership and whether the state is entitled to collect fees for such services.—RT/Agency

King Charles Invites Shehbaz For Commonwealth Meeting In October

ISLAMABAD: King Charles III of the United Kingdom on Wednesday telephoned Prime Minister Shehbaz Sharif and formally invited him to attend the Commonwealth Heads of Government Meeting (CHOGM) in Samoa in October.

Accepting the invitation, the prime minister said that the "CHOGM in Samoa would be a significant moment in the Commonwealth's history".

According to a PM Office press release, it would be the first summit to be chaired by King Charles III since becoming head of the Commonwealth and his coronation.

PM Shehbaz reiterated Pakistan's commitment to the Commonwealth and the values enshrined in the Commonwealth Charter.

He said that the "CHOGM in Samoa would provide a forum to discuss opportunities for enhancing intra-Commonwealth cooperation on important issues such as fostering sustainable development, strengthening democratic institutions, and empowering Commonwealth youth".

Noting the king's longstanding interest in environmental issues and various initiatives for climate sustainability, PM Shehbaz said that he particularly looked forward to engaging with Commonwealth leaders on climate change, as Pakistan was highly vulnerable to its impacts. The prime minister also

inquired about the king's health and conveyed his best wishes for Kate Middleton, the Princess of Wales, who had completed her treatment.

The British royals have had a strong relationship with Pakistan and have visited the country on numerous occasions including visits from the late Queen Elizabeth II and the late princess Diana of Wales.

Recalling the fond memories of Charles' last visit to Pakistan, when he was the prince of Wales, Prime Minister Shehbaz hoped that the king and the queen would visit Pakistan soon.

The then prince of Wales and duchess of Cornwall (now Queen Camilla) visited the country in 2006 from October 29 to November 3 and toured parts of Pakistan.

"For my wife and I, it really is the greatest possible joy to be here with you in Pakistan," said the then prince during an event on his visit in 2006. "It has taken me very nearly 58 years to reach you and it's not from want of trying, I can tell you."

Years later, it was PM Shehbaz who had to visit the UK upon the death of Queen Elizabeth II in 2022 who reigned the kingdom for 70 years and 214 days.

During the funeral, the PM met with the new British sovereign, King Charles III and extended his condolences over the passing of the late monarch and said that she was a source of inspiration and strength for generations of Commonwealth citizens.—RT/Agency

Dar Describes Russia As A Key Player In Regional Cooperation

ISLAMABAD: Deputy Prime Minister and Foreign Minister Ishaq Dar said Pakistan viewed Russia as an important player in the West, South and Central Asia, and strengthening mutually beneficial cooperation with Russia remains an important priority for Pakistan's foreign policy.

Addressing a press conference, he said discussions with Russian counterpart Alexei Overchuk were focused on outlining further potential for expansion of economic relations between the two countries.

He said Pakistan-Russia bilateral trade touched the mark of one billion dollar last year, and expansion of trade ties by working out logistic and other related issues is a priority for both the countries.

The deputy prime minister said energy cooperation with Russia holds potential, and we aim to explore this avenue further. He said Pakistan is also eager to develop connectivity projects, including rail and road networks between two countries and beyond.

He said Islamabad aimed to continue cooperation with Moscow on realizing the

common goal of peace and stability in Afghanistan. Noting Russia's historically strong relations with Muslim world, OIC and its position on Palestine conflict, Ishaq Dar said Pakistan greatly appreciated Russia's stance that freedom of speech must not be an instrument to disrespect a revered personality or religion and not to hurt sentiments of Muslim Ummah.

He hoped to continue high-level contacts and reiterated Pakistan's commitment to deepen and strengthen relations with Russia.

On his part, the Russian Deputy Prime Minister said he discussed prospects for collaboration between Pakistan and Eurasian Economic Union which consists of Ar-

menia, Belarus, Kazakhstan, Caucasus and Russia. He said, "We have discussed opportunities for implementing free trade agreement between Pakistan and these five countries and we look forward to further discussing and finalizing the agreement."

The Russian deputy prime minister said inter-governmental commission meeting later this year in Russia will provide an opportunity to further trade and economic relations between the two countries.

Alexei Overchuk said, "Our goals and visions for development and economic ties within the SCO are very much aligned including connectivity, addressing the climate agenda, food security, energy transition and energy security".—RT/Agency

US Reaffirms 'Longstanding Policy' Of Withholding Support For Pakistan's Ballistic Missile Program

WASHINGTON: The United States has reiterated its "longstanding policy" denying support to Pakistan's ballistic missile programme, saying it will continue to use sanctions and other tools to ensure its own national security and protect its financial system from being used by "proliferators".

In a press briefing, addressing a query regarding the recent sanctions considered "biased and politically motivated" by Islamabad — as per the journalist, State Department Spokesperson Matthew Miller said that while Pakistan has been a long-term partner of the US, there are disagreements.

"... and when we have disagreements, we won't hesitate to act on those to protect America's interests," he said, emphasising on the country's policy to deny support to Pakistan's missile programme.

"... we will continue to use our sanctions and other — our other tools to ensure our national security cannot be impacted, and that the US financial system cannot be used by proliferators," said Miller.

The statement comes days after the US imposed sanctions Washington had similarly targeted three China-based companies with

sanctions in October 2023 for supplying missile-applicable items to Pakistan.

The Beijing Research Institute of Automation for Machine Building Industry, according to Miller's statement last week, had worked with Pakistan to procure equipment for testing rocket motors for the Shaheen-3 and Ababeel systems and potentially for larger systems.

The sanctions also targeted China-based firms Hubei Huachangda Intelligent Equipment Co, Universal Enterprise, and Xi'an Longde Technology Development Co, alongside Pakistan-based Innovative Equipment and a Chinese national, for knowingly transferring equipment under missile technology restrictions, said Miller.

In the briefing, the spokesperson also addressed a question pertaining to the

"real reasons and concerns" that triggered the sanctions imposed on a Chinese research institute and several companies involved in supplying Pakistan's ballistic missile programme.

"So the United States is committed to strengthening the international nonproliferation regime by taking action against networks supporting activities of proliferation concern," said the spokesperson. He added that the executive order action that was taken last week followed Washington October 2023 and April 2024 designation of six Chinese entities and one Belarusian entity that have worked to supply Pakistan's missile programme as well as the listing of numerous Pakistani and third-country entities on the Department of Commerce Entity List for decades.—RT/Agency

Russian Deputy PM Alexei Overchuk Arrives In Pakistan

ISLAMABAD: Russia's Deputy Prime Minister Alexei Overchuk reached Pakistan today, a day after the Foreign Office announced his two-day official visit from September 18 till 19. In a statement today, the FO said that the Russian dignitary was welcomed by Pakistan's Ambassador in Moscow Muhammad Khalid Jamali and Additional Foreign Secretary (Europe) Shaqat Ali Khan at the Islamabad Airport. Deputy PM Overchuk, the FO added, will hold extensive talks with President Asif Ali Zardari, Prime Minister Shehbaz Sharif and his counterpart Ishaq Dar during his time in the federal capital. His visit comes after last The News reported that Islamabad and Moscow were considering liquefied natural gas (LNG) transactions in future Russia, the publication said citing a senior official at the Ministry of Energy, had communicated that its LNG

export terminals would get ready in 2026 for gas trade with Pakistan in light of the fact that the price re-opening clause with Qatar under two long-term agreements under government-to-government arrangements would be invoked in 2026. Furthermore, an official informed the subcommittee that a Russian delegation was due to visit the country to discuss the establishment of a state-of-the-art steel mill on the existing site of the Pakistan Steel Mills (PSM). Speaking exclusively to media on his visit, the deputy PM expressed Moscow's readiness to share knowledge with Islamabad in various sectors to assist the latter. Stressing on increasing socio-cultural ties between the two countries, Overchuk said that he hopes constructive collaboration to continue with Pakistan under Russia's presidency of the Shanghai Cooperation Organisation (SCO) Council of Heads of State.—RT/Agency

Law Minister Seeks Legal Community's Input On Adjusting Judges' Retirement Age In Constitutional Package

ISLAMABAD: Addressing a crucial session of the country's legal fraternity to discuss contentious constitutional amendments proposed by the coalition government, Federal Law Minister Azam Nazeer Tarar on Wednesday sought recommendations from lawyers to decide on the retirement age of judges whether it should be 65 or 68 years.

The federal minister was addressing the lawyers following in-camera session of the Pakistan Bar Council (PBC) and the Supreme Court Bar Association (SCBA) to brief and review the proposed constitutional changes that have become a challenge for the coalition government to pass them in parliament as it lacked two-thirds majority.

The amendments allegedly include legislation to extend the tenure of Chief Justice of Pakistan (CJP) Qazi Faez Isa — who is retiring in October this year — as well as the retirement age of the judges.

Shaukat, PBC Vice Chairman Farooq H Naek, Law Minister Tarar, and senior lawyers.

"The constitutional amendments package, which is circulating everywhere, is just a draft consisting of a set of recommendations," said Tarar while addressing the event, "[...] it cannot be called a government bill unless it is approved by the cabinet."

"There should be a constitutional court in which we get the glimpse of the federation," he further said.

He detailed that a constitutional amendment is presented in parliament after its approval from the cabinet and it needs approval from a two-thirds majority of parliament.

He clarified that the Pakistan Muslim League-Nawaz (PML-N) was not solely ruling the country as "we are part of a coalition government".

Tarar said that the "constitutional package" was part of the "Charter of Democracy" signed by the ruling PML-N and its major ally, the Pakistan Peoples Party (PPP) in 2006 which also recommended bringing judicial reforms.

He detailed that discussions were held with the PPP from January to March over the judiciary-centric reforms via introducing constitutional amendments as per the ally party's push to "complete the agenda of the Charter of Democracy".—RT/Agency

Pakistan Denounces IIOJK Elections, Calls For Modi's Accountability Over Human Rights Violations

ISLAMABAD: President Asif Ali Zardari on Wednesday categorically rejected the elections for the legislative assembly of Indian Illegally Occupied Jammu and Kashmir (IIOJK), asserting that these polls were no substitute for the Kashmiri people's right to self-determination.

Provincial elections are being held in the occupied territory for the first time in a decade.

The occupied Muslim-majority region enjoyed a special status of partial autonomy until 2019 which was then revoked by the far-right Narendra Modi-led Bharatiya Janata Party's government.

IIOJK's special semi-autonomous status — constitutionally enshrined power to control its affairs — had meant that only those who descended from residents of the territory in 1934 could vote and own property.

The polls are being held after the Indian Supreme Court, last year, upheld the government's decision and set a deadline of September 30 this year for local polls.

President Zardari, talking to a delegation of migrants from IIOJK — residing in Pakistan since 1989 — led by Uzair Ahmed Ghazali at Aiwan-e-Sadr, emphasised that such elections were unacceptable to the people of Kashmir and called upon the international community to hold the Modi government accountable for ongoing human rights violations in IIOJK. He further urged the need to take concrete steps toward conducting a plebiscite in line with relevant United Nations Security Council Resolutions Welcoming the delegation, the president condemned the legislative assembly elections in IIOJK, terming them as part of India's broader strategy to consolidate its illegal occupation of the region. He highlighted that such measures could neither legitimise India's occupation nor suppress the freedom struggle of the Kashmiri people.

ADB Pledges \$2 Billion Annually To Pakistan For Climate Resilience Over The Next Three Years

ISLAMABAD: The Asian Development Bank (ADB) has announced that it will provide \$2 billion in annual assistance to Pakistan over the next three years to support infrastructure development and climate-resilient initiatives.

In 2022, massive floods triggered by climate change devastated several parts of Pakistan, killing 1,700 people, washing away swathes of agricultural land, affecting 33 million people, and incurring losses worth \$30 billion, according to government estimates.

A report by the Policy and Strategy Committee (PSC) and the Oversight Board on Post-Flood Reconstruction Activities showed last week that the country had only received \$10.9bn from international development partners

out of the total estimated loss for post-flood reconstruction work, leaving a \$19.1bn shortfall that has halted the rehabilitation of flood-affected communities in three provinces.

According to a statement from the President's House, the announcement was made during a meeting between President Asif Ali Zardari and ADB's head Masatsugu Asakawa in Islamabad on Tuesday.

"[The President of the Asian Development Bank] said that the ADB would provide \$2 billion in annual assistance to Pakistan over the next three years, and reaffirmed the bank's commitment to supporting infrastructure development and climate-resilient initiatives," the statement said.—RT/Agency

PTI Ties Constitutional Amendment Talks To Imran's Release

ISLAMABAD: Senior Pakistan Tehreek-e-Insaf (PTI) leader Ali Muhammad Khan has urged the government to release the party's founder, Imran Khan, from Adiala Jail before engaging in talks on constitutional amendments.

Speaking to the media in Islamabad on Wednesday, Ali Muhammad outlined PTI's stance, stating, "First, release Imran Khan from prison, then we can discuss constitutional amendments." He added that any approval of amendments must be accompanied by the restoration of the public mandate.

The PTI leader questioned the legitimacy of the process, asking, "How can a constitutional amendment be passed by an incomplete parliament?" He also raised concerns about the role of the Pakistan People's Party (PPP) in the process, criticising PPP leader Bilawal Bhutto-Zardari. "It's unfortunate that the grandson is undermining the very Constitution his grandfather created," he remarked.

Hamid Khan, who was present during the conversation, reinforced PTI's position on the judiciary, stating, "We only recognise the Supreme Court. Justice Mansoor Ali Shah is the rightful

chief justice, and no one else is acceptable." He added, "We will not let institutions be mocked."

Meanwhile, PTI's founder, Imran Khan, has made serious allegations, claiming that the government is pushing constitutional amendments to extend the terms of key officials, including Chief Justice Qazi Faez Isa, the Chief Justice of Islamabad High Court, and the Chief Election Commissioner.

From Adiala Jail, Imran alleged, "The government, having lost previous political battles, is now changing the Constitution to safeguard rigged elections and extend the terms of three umpires." He further warned that if

Chief Justice Isa is removed, investigations into the May 9 protests and alleged rigging in the elections would be initiated. "They are trying to dismantle my party," he said, adding that over 140 legal cases had been filed against him before the May 9 events, and efforts to remove him intensified afterward.

Khan expressed concern over the delay in investigating the May 9 incidents, claiming that if the new chief justice takes office, the truth behind the events will emerge.

He also criticised the government for undermining Pakistan's judicial and electoral processes, citing the delay in tribunal decisions on the February 8 election.—RT/Agency
