Bilawal Affirms PPP's Commitment To Justice And Democracy

ISLAMABAD: Chairman Pakistan People's Party (PPP) Bilawal Bhatto Zardari has reaffirmed the party's commitment to the ideals of peace, justice, democracy and human dignity.

In a message on the occasion of International Peace Day, he stressed that peace is not just the absence of conflict but the presence of justice, equality, and respect for human rights.

"True peace can only be achieved when every individual, regardless of their background or beliefs, is treated with fairness and dignity," he said.

He highlighted that Pakistan, as a nation, has faced challenges in its pursuit of peace, both domestically and internationally, but has remained resilient in its quest to build a harmonious and prosperous society.

"PPP has always been at the forefront of advocating for peace, dialogue and reconciliation, values that were championed by Shaheed Zulfiqar Ali Bhutto and Shaheed Mohatma Benazir Bhutto," he added.

Bilawal Bhatto also acknowledged this year's United Nations theme for International Peace Day, "Cultivating a Culture of Peace".



He urged the global community to work together in addressing shared challenges such as poverty, inequality, and climate change, which are critical to fostering lasting peace.

"Peace is interconnected with development, and the sustainable progress of any nation depends on the well-being of its people and the fairness of its systems," he said.

He also cautioned the international community that the ongoing Indian atrocities in Indian Illegally Occupied Jammu and Kashmir (IIOJK) and the Israeli brutality in Palestine pose a grave threat to global peace and stability.

He further emphasized that in today's world, emerging technologies, including artificial intelligence, must be governed ethically and responsibly to ensure that they contribute to peace and do not exacerbate inequality or conflict.

"It is vital that we use technology as a force for good, promoting transparency, justice, and inclusivity," he remarked.

Bilawal Bhatto calling on all citizens of Pakistan to contribute to the peaceful development of society.

"Let us honor this International Peace Day by standing firm in our resolve to build a Pakistan where peace, justice, democracy, and where every citizen can live without fear or oppression," he said.—RT/Agency

PTI Lahore Rally Abruptly Ends After City Administration Cuts Power And Seizes Stage

LAHORE: The much-hyped Pakistan Tehreek-e-Insaf (PTI) Lahore rally ended abruptly with the firebrand leader Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur even failing to reach the venue before the 6pm deadline set by the local administration in a no-object certificate (NOC).

Following the expiration of the deadline, Lahore police took control of the stage and turned off the microphone and lights, with PTI Chairman Barrister Gohar Ali Khan and other party leaders leaving the stage.

Except Gohar and Salman Akram Raja, first tier leadership didn't manage to address the participants of the rally — which Punjab Information Minister Azma Bokhari claimed at-



tended by a few hundreds. Bokhari also censured Gandapur for turning a blind eye to the issues his province was facing and instead focusing on public gatherings.

Gandapur and Leader of Opposition in the National Assembly Omar Ayub, who were leading convoys from Khyber Pakhtunkhwa, had not arrived at the venue by the end of deadline.

The chief executive was reportedly bringing rescue 1122 ambulances and heavy machinery to remove any hurdles on their way, drawing flak from the Punjab government for "using KP's resources" for Lahore rally.

On the other hand, the deputy commissioner Lahore has warned of "stringent action" if the former

ruling party violated the conditions mentioned in the NOC. He ordered the Jalsa administration to end the public gathering immediately.

Today's rally comes after a no objection certificate (NOC) was issued by the provincial capital's deputy commissioner a day earlier following the Lahore High Court's (LHC) instructions which had directed the city's administration to decide on the Imran Khan-founded party's request for a public gathering.

Addressing the participants of the rally, Barrister Gohar said that his party would not accept anything other than independent judiciary.

Congratulating the PTI Lahore chapter for organis-

ing such a 'huge rally', Gohar urged the authorities to refrain from creating obstacles for party workers and open the roads leading to Lahore and the venue.

For this part, PTI leader Sardar Latif Khosa castigated the government over controversial constitutional package, saying that they will now allow anyone to make decisions against the Constitution of Pakistan.

"The government was being run through an ordinance," he said, adding that the sitting rulers want favourable judges and decisions.

Meanwhile, Sheikh Waqas Akram noted that PTI founder Imran Khan has instructed to stand by the judiciary and fight for 'real freedom'.—RT/Agency

Chinese Minister Meets Naqvi



ISLAMABAD: Chinese Minister for Legal and Political Affairs Chen Mingguo called on Federal Minister for Interior and Narcotics Control Mohsin Naqvi on Saturday.

Naqvi welcomed the high-level delegation led by the Chinese Minister at the Interior Ministry office. The duo discussed joint counter-terrorism efforts while agreeing to enhance cooperation against smuggling.

The two sides also discussed effective border control to avoid any untoward incident.

It was also agreed in the meeting that the Gilgit Baltistan policemen will be trained at China's Xinjiang Police College. For that, it was decided that a Pakistani delegation would also visit Xinjiang soon.

"Xinjiang province is very vital for Pakistan as we share a 600-kilometre-long border with this Xinjiang. The China Pakistan Eco-

nom Corridor (CPEC) also passes through Xinjiang. Pakistani delegation's visit will further strengthen the coordination between two countries," Naqvi said.

The Chinese Minister noted that terrorism was a mutual problem for both China and Pakistan. He said that Xinjiang remained in the grip of terror for a long time, suggesting that Pakistan could learn from Xinjiang for eliminating terrorism from its soil. The Chinese delegation included Xinjiang's Deputy Secretary of the Committee for Parliamentary and Legal Affairs, Executive Director General of Police, and Vice President of the Xinjiang Police Academy whereas Interior Secretary Khuram Ali Agha, Special Secretary of the Interior Waqas Ali Mahmood, and the Additional Secretary of the Interior, Nazir Muhammad Buzdar, were also present in the meeting from Pakistani side alongside Naqvi.—RT/Agency

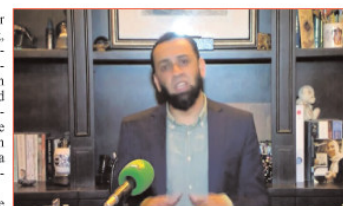
Atta Tarar Claims PTI Won't Dare Hold Another Jalsa After Lahore Setback

ISLAMABAD: Minister for Information, Broadcasting, National Heritage and Culture Attallah Tarar on Saturday said the Pakistan Tehreek-e-Insaf (PTI) would not dare to hold another public gathering anywhere in the country after a flop show in Lahore which witnessed a minimal turn-out of the people.

Talking to the media, the minister said the PTI had miserably failed to galvanize the support of their workers for the public gathering in Lahore, despite the all-out facilitation by the administration which not only kept the roads completely open but also provided a foolproof security in the designated area.

No obstacle was placed in any city, including Islamabad, Attock, and Mianwali, from where the PTI had asked their workers to participate in the public gathering. He said, adding that their leader and workers were given free access to enter Lahore from across the country.

He said similarly, the PTI



had failed to gather the people in their public gathering of Islamabad, which also saw the presence of a small number of the people.

The minister challenged the PTI leadership to release drone shots of their public gathering in Lahore, which exposed their support among the masses.

Tarar said this showed that the people of Pakistan had rejected them completely, showing full confidence in the governance of Prime Minister Shehbaz Sharif and Chief Minister of Punjab Maryam Nawaz Sharif, who have been taking crucial steps to provide relief

to the masses. He said the people of Pakistan knew that the inflation had been reduced to a single digit, which, during the tenure of the PTI, reached a double digit from the four percent that was achieved under the leadership of Nawaz Sharif.

The international financial institutions are acknowledging that the Pakistani economy was taking off, while Bloomberg identified Pakistan's stock market as an emerging and best market in Asia, he said, adding Fitch and Moody had improved ratings for Pakistan as well.—RT/Agency

Imran Claims Musharraf and Zia's Martial Laws Were Superior To Current Democratic Setup

RAWALPINDI: In a fresh salvo against the incumbent ruling coalition, the Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan has said that former military rulers Pervez Musharraf and Zia-ul-Haq's martial law regimes were "better" than the current democratic setup. The News reported on Saturday.

Speaking to reporters during the hearing of the £190 million case at Rawalpindi's Adiala jail on Friday, Khan said that those who respect democracy and vote were standing on one side of the divide whereas on the other were those who only respected the powers that be.

The former prime minister, who has been behind bars for over a year now, has time and time again criticised the Prime Minister Shehbaz Sharif-led administration for not being a legitimate power while citing alleged interference and manipulation in the February 8 polls.

Refusing to hold talks with the ruling parties, the ex-premier, however, has expressed willingness for negotiations with the establishment — a move criticised by the government for dragging them into politics.

"Given Pakistan's geo-



graphical position and the military's significant role in the private sector, it would be foolish not to foster such a relationship," Khan had said last month, adding that there was "no harm" in engaging with the "establishment".

"We are open to any dialogue that could help improve the dire situation in Pakistan," he remarked. Speaking about the party's Lahore rally being held today (Saturday), the PTI founder questioned why his party wasn't allowed to hold a rally at Minar-e-Pakistan monument when the permission for the same was given to Jamiat Ulama-e-Islam-Fazl (JUI-F) chief Maulana Fazlur Rehman in the past.

It may be noted that the PTI had sought permission from the Lahore district ad-

ministration for holding the rally at the historic site but it was allowed to organise the event at Kahna under strict conditions. Addressing the prospective highly controversial constitutional amendments planned by the incumbent rulers, Khan said that the chief justice would be a direct beneficiary of the concerned changes in the constitution. Earlier, Islamabad's Special Accountability Court Judge Nasir Javed Rana adjudged the hearing of Al-Qadir Trust reference against Imran Khan and his wife Bushra Bibi in £190 million financial scandal ill Sept 24.

In addition to the two accused and their lawyers, NAB lawyers including Sardar Mazaffar Abbasi and Amjad Parvez were also present.—RT/Agency

JUI-F Chief Declines Support For Political Arrests



ISLAMABAD: Jamiat Ulama-e-Islam (JUI-F) chief Maulana Fazlur Rehman refused to support political arrests saying they affect the lives of common people adversely.

In the media talk, Maulana Fazlur Rehman reiterated his stance against the PTI-led government. He stressed that all institutions should operate within their defined limits to ensure the country's progress.

When asked about the possibility of a new constitutional amendment, Maulana Fazlur Rehman deflected,

suggesting that the question should be asked from those backing the amendment.

It is to be recalled that Fazlur Rehman categorically rejected the bill drafted for the constitutional amendment, asserting that it would be an utter dishonour with the nation to support it.

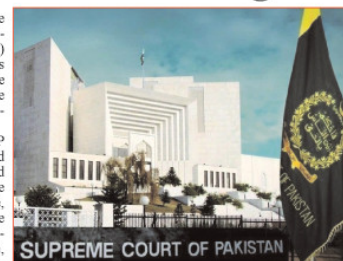

Supreme Court Bar Association Decries Attack On 'Judicial Independence And Constitutional Rights'

HYDERABAD: Hyderabad police have arrested a former Special Assistant to the Chief Minister of Sindh, Sardar Ismail Dahiri, along with his accomplice, Inayat Otho. The arrest occurred during an operation on Auto

Bahn road, where police

covered over 1000mg of hashish and unlicensed Kalashnikov from Dahiri's vehicle, while the unregistered vehicle was also confiscated.

The police later filed two separate cases against Dahiri

and Otho for drug possession and illegal weapons.

Police revealed that the accused have confessed to using drugs in their initial statements. Further investigations are underway, as Dahiri has a history of criminal cases.—RT/Agency

MIRPURKHAS: The newly posted SSP Mirpurkhas Shabbir Ahmed Sethar has started work after assuming the charge of his office. After assuming the charge he chaired a meeting of the police officials which was attended by SDPOs and SHOs. He conducted a detailed review of police performance and discussed the current law and order situation in Mirpurkhas district with the participants of the meeting. The SSP emphasized that he will operate under a unified command and that as SSP, he is committed to protecting the lives and property of the public 24/7, stating that this is a top priority. He instructed all officers to strictly implement the National Action Plan re-

SHOs will conduct search operations and snap checking on a daily basis, ensuring the purpose of checkpoints and police pickets is achieved and maintaining regular patrols in their circuits. A crackdown on criminal drug dealers and absconders will be intensified. Any SHO failing to control crime within their jurisdiction will face departmental action, as will the respective DSP. A zero-tolerance policy will be adopted against criminals, drug dealers, Gutka sellers, and livestock thieves.

Chief Secretary Sindh announces package for industrial development in Hyderabad

HYDERABAD: Chief Secretary Sindh, Syed Asif Hyder Shah, reaffirmed the government's commitment to enhancing Hyderabad's infrastructure during a meeting with the Hyderabad Chamber of Small Traders & Small Industry (HCSTSI). Following a request from HCSTSI and directives from PPP Chairman Bilawal Bhutto Zardari, he announced a PKR 5 billion development package aimed at addressing water supply, sewerage, and road issues. The Chief Secretary directed the Managing Director of SITE to allocate 1,000 acres for a new industrial zone and expedite the 300-acre SITE-II Project, with PKR 1,100 million already allocated for restoring SITE's infrastructure. He emphasized the need to remove encroachments swiftly, and the MD assured that actions were underway. To improve planning, the Chief Secretary sug-

gested transferring the Hyderabad Development Authority's responsibilities to the Planning & Development Department. He approved HCSTSI representation in HDA's governing body and agreed to sell remaining inventory from the Gulistan-e-Sarmast and Kohsar Extension schemes to fund development. Funds for the development of the Jan-nat-ul-Tayaba Graveyard will soon be released, and measures against illegal lands will be enforced. The Mass Transit Project and installation of new traffic signals were also approved to tackle traffic issues. HCSTSI President Farooq Shaikhani praised the Chief Secretary's responsiveness and urged continued focus on developing industrial zones, restoring infrastructure, and digitizing land records. The meeting included key officials from various departments, all committed to advancing Hyderabad's development.

HESCO Chief urged to take notice of department's inept performance in Badin

BADIN: The operation against electricity theft in Badin has been unsuccessful due to collusion between HESCO officials and the Kanda mafia, leading to an increase in theft by private companies and extortionists. Despite strict directives from the HESCO Chief and oversight from the Ministry of Water and Electricity, the situation remains dire. According to citizens and internal HESCO sources, local officers are losing crores of rupees monthly due to rampant electricity

theft and embezzlement. The extra load on transformers, resulting from this theft, has caused many to explode and fail, particularly on Cant Road, Shah Abdul Latif Press Club Road, Shahbaz Road, Quaid-e-Azam Road, and Sirani Road. This has left residents facing severe hardships in the intense heat, with prolonged power outages disrupting urban business life. Citizens report that when monthly allowances aren't received, extortionists mix their electricity fees and wires, leading to transformer explo-

sions. They are then charged around 2,000 rupees per person for repairs and pressured to contribute an additional 5,000 rupees. Despite numerous complaints about illegal connections, HESCO officials have been reluctant to disconnect these lines or take legal action against the line-men involved. The citizens and traders have urged the HESCO Chief to take notice of the inept performance of the HESCO officials in Badin district, besides taking steps to facilitate the consumers, who pay their bills regularly.

Supreme Court Practice And Procedure Ordinance Challenged In Lahore High Court



LAHORE: The Supreme Court Practice and Procedure Amendment Ordinance, 2024 was challenged in Lahore High Court in a petition requesting the court to declare it unconstitutional and all orders or actions taken in this regard to be set aside. The petition made the request arguing that the sole objective of this Ordinance is to target PTI's founding chairman Imran Khan and to divide the judiciary. Petitioner Munir Ahmed filed the petition through advocate Azhar Siddique praying the court to declare this Ordinance ultra vires in view of Articles 9, 10, 10-A, 14, 17, 25, 37, 38, 46, 48, 75 & 89 read with Articles 4 & 5 of the Constitution of the Islamic Republic of Pakistan, 1973. Petitioner's counsel implored in the petition that all orders or actions taken pursuant to this Ordinance are in violation of the fundamental rights provided in the Constitution of the Islamic Republic of Pakistan, 1973. He further requested the court to direct the respondents to share all the required information (s), details and document(s) under Article 19-A of the Constitution of the Islamic Republic of Pakistan, 1973. He submitted that these amendments cannot be supported, therefore, the Ordinance should be withdrawn with immediate effect. The petition highlighted recent statements made by the Chief Justice of Pakistan Justice Qazi Faez Isa, who had questioned "through ordinances, the will of one person is imposed on the entire nation.—RT/Agency

CTD Detains 5 Suspects In 65 Intelligence-Based Operations Throughout Punjab



LAHORE: Punjab's Counter-Terrorism Department (CTD) arrested five "suspects allegedly linked to terrorist organisations" during 65 intelligence-based operations (IBOs) carried out across the province, the agency said on Saturday.

The Punjab CTD regularly carries out operations across the province to prevent and investigate terrorism-related activities and gather intelligence. Operating under the provincial police department, the agency plays a key role in maintaining internal security and countering terrorism within the country.

In a statement issued today, the CTD said 63 individuals were interrogated during the actions, which were taken in Lahore, Mianwali, Bahawalpur, Jhang and Toba Tek Singh.

Three of the arrested suspects were identified as Amjadur Rehman from Toba Tek Singh, Sher Ali from Jhang and Zahab Ullah from Lahore - who it said were connected to the banned group Fina-al-Khawarij (Tehreek-i-Taliban Pakistan).

The other two were Tayyab Raees from Bahawalpur, who CTD said was associated with the militant Islamic State group (IS) - also known as Daish - and Baaz Khan, alias Bahar Khan, from Mianwali.

Five first information reports (FIRs) were registered under Pakistan's Explosives Act and the Anti-Terrorism Act (ATA) of 1997, among other statutes, with cases filed in the Faisalabad, Lahore, Bahawalpur, and Sargodha districts.

During the operations, the CTD said it recovered 2,570 grams of explosives, four hand grenades, three detonators, 18-foot safety fuse wire, a Kalashnikov rifle with 40 rounds of ammunition, a 30-bore pistol with 20 bullets, four hand grenades, mobile phones, Rs22,100 in cash, and materials linked to IS such as stickers and pamphlets.

The Punjab CTD conducted 980 combing operations this week, in collaboration with local LEAs, resulting in the screening of 32,662 individuals, the statement added. "These operations led to the arrest of 109 suspects and the registration of 102 FIRs with 88 recoveries reported." —RT/Agency

SSWMB Steering Committee, Led By Saeed Ghani, Extends Waste Disposal Contracts For Three Karachi Districts



KARACHI: The provincial steering committee of the Sindh Solid Waste Management Board (SSWMB) has approved a three-year extension for contracts awarded to private contractors responsible for garbage disposal services in Malir, West, and Keamari districts of Karachi.

Local Government Minister Saeed Ghani chaired the third session of the provincial steering committee, emphasizing the importance of effective waste management. The committee also agreed to compensate the contractors in Pakistani rupees rather than US dollars.

During the meeting, it was reported that renewing these contracts is expected to reduce waste disposal costs by 25% in Malir and by 28% in West and Keamari districts.

The Minister received a comprehensive briefing on a research study regarding the waste disposal in these areas. The new contracts will enhance waste collection and disposal operations, accompanied by an effective monitoring system. The committee also decided to issue a tender for contractor services in District East, with interim services provided until the tendering process concludes.

Additionally, a proposal was discussed to consult with town municipal corporations in Karachi to establish waste collection fees for residential, commercial, and industrial sectors to generate revenue for the SSWMB. The committee approved an assessment report for waste disposal efforts in Shaheed Benazirabad and Mirpurkhas.

Furthermore, the selected sanitation services company has been authorized to manage landfill sites in Sukkur and Hyderabad. The Local Government Minister was informed about the ongoing tender process for managing Jam Chakro and God Pass landfill sites in Karachi, allowing the current company to continue operations until the tendering is finalized.

The meeting included participation from Additional Chief Secretary for Local Government Syed Khalid Hyder Shah, SSWMB Managing Director Imtiaz Ali Shah, and various local officials, with mayors from Hyderabad, Sukkur, and Larkana joining via video link.—RT

Lahore Police Establish Special Teams To Apprehend May 9 Fugitives



LAHORE: The Lahore Police have established special teams to apprehend fugitives from the events of May 9, 12 to 15. Specialised teams have been created, with the names of the wanted individuals provided to them. The police teams were actively working to arrest these fugitives.

Five armed men loot a building materials shop in Larkana

LARKANA: In the Sheikh Zayed Colony Mor area under the Sachal Police Station in Larkana, armed robbers on two motorcycles entered a building materials shop, held the owner and employees at gunpoint, and fled with 65,000 rupees in cash and two mobile phones. Despite being informed, the police arrived late at the scene. Shopkeeper Shoaib Ahmed Abbasi reported that five armed men entered the store, took him and his three employees hostage, and stole the cash and mobile phones before escaping.

He noted that lawlessness in Larkana has escalated, with police limited to their stations.

He mentioned a similar incident two months ago when motorcycle-riding robbers stole 250,000 rupees and four mobile phones in the same manner, and expressed frustration that the police have not taken action against criminals. He appealed to the SSP of Larkana to take notice of the situation, apprehend the robbers, recover the stolen money and mobile phones, and ensure protection for the citizens.

In the limits of the Allahabad Police Station in Larkana, an unidentified young man's body was found,

showing signs of violence, near the Abu Bakar Graveyard. Residents of the area informed the local police about the discovery. Upon receiving the report, police arrived at the scene to gather details and have started an investigation from various angles. According to the police, the body was found severely injured, with marks indicating it was struck with a sharp weapon, and identification has not yet been established. As of the latest reports, the identity of the deceased remains unknown, and the reasons behind the incident are still unclear.

Former SAU VC Dr. Zaheer Memon files constitutional petition against promotions

TANDO JAM: The former Vice Chancellor of Tando Jam Agriculture University, Dr. Zaheer Memon, has filed a petition in the Hyderabad High Court against the Chief Secretary of Sindh, the Secretary of the Universities Board, the Vice Chancellor of Agriculture University, and the Registrar of Agriculture University, citing irregularities, favoritism, and violations of merit in recent promotions of meritorious professors to grade 22 through the Special Selection Board. According to reports, the former Vice Chancellor claims that as per the law, all university professors should

have been informed via a circular about the grade 22 promotions.

However, the administration allegedly issued the circular on 18/09/2023 and only distributed it among preferred professors without informing Dr. Memon, despite his seniority and high-ranking position. Dr. Memon further claims that he was deliberately kept in the dark while promotions were granted to favored individuals in violation of laws and the Constitution, disregarding merit. Sources reveal that the current Vice Chancellor, Dr. Fatah Muhammad Marri, promoted seven professors to grade 22 as meritorious professors, despite the fact that

the required quorum for the Syndicate was not met.

The total number of Syndicate members is 22, but only 14 attended the Selection Board meeting held on 10/08/2024. Legally, any candidate for promotion or their family member is not allowed to participate as a member of the Syndicate during such meetings. However, four candidates, including Dr. Inayat Rajpar, Dr. Jan Muhammad Marri, Dr. Aijaz Khuharo, and Dr. Ghayyuddin Shah, were part of the Syndicate and voted for themselves, which is both illegal and unethical. As a result, senior professors were unfairly deprived of their rightful promotions.

"I mean, from day one, from the moment he put his foot down in Miami, it's been a dream, honestly."

Additionally, he spilled that, despite having the eight-time Ballon d'Or award winner as a part of Inter Miami for over a year, he still cannot believe it.

"To be able to say that we've signed the world's greatest ever player to ever play the game. Everybody's got their opinion on who they think is the best player of all time - whether it be Diego Maradona, Pele, all of these great players," he said.

"But to say that we have in the MLS, in Miami, the greatest player to play the game, it's just like a dream, you know? It's a dream every time that I'm there," Beckham continued.

"If I go for the whole of the summer, which I went for four weeks this summer, I go into training every single day because, personally, I can't believe we've got Leo. Secondly, I just want to watch what he does. And that's a special thing for us." Beckham will attend Saturday's match as Messi and Inter Miami face New York City FC at Yankee Stadium, which will also be the Argentine footballer's third game after returning from a right ankle injury.—Agency

FIFA unveils Intercontinental Cup schedule with Real Madrid to play final in Qatar



DOHA: The first edition of the annual FIFA Intercontinental Cup for club teams from around the world will have five matches, with European Champions League winners Real Madrid to play in the final on December 18 in Doha, the world soccer body said.

The tournament, which was announced in December last year, replaces the annual Club World Cup which will now be played every four years with 32 teams from 2025.

AFC Champions League winners Al Ain will first host OFC Champions League winners Auckland City on September 22 in the African-Asian-Pacific Cup playoff, with the winners set to face CAF Champions League winners Al Ahly in Cairo on October 29.

The first two games will be on the home turf of the higher-ranked team, allowing locals to watch their club play.

The action then switches to Doha, Qatar, where the 2024 CONMEBOL Libertadores winners play Mexican side Pachuca, the winners of the CONCACAF Champions Cup, on December 11 - a match described by FIFA as the "Derby of the Americas".

The winners of the these two matches play each other in the Challenger Cup three days later to earn a spot in the Intercontinental Cup Final against Real Madrid on December 18.

The day is celebrated as Qatar's National Day while it also marks the two-year anniversary of the 2022 World Cup final where Argentina beat France.—Agency

Wow! Can you believe this? Afghanistan secure historic first ODI series victory over South Africa

SHARJAH: Afghanistan reached a major milestone by securing their first-ever bilateral ODI series win over South Africa.

In the second match in Sharjah, Afghanistan's commanding 177-run victory gave them an unsailable 2-0 lead in the three-match series.

This triumph also marks their first series victory against a top-five ICC-ranked ODI team, making it a landmark achievement for Afghan cricket.

The triumph was Afghanistan's largest margin of victory in ODI cricket, surpassing their previous best, a 154-run win over Zimbabwe in 2018 at the same venue.

Rahmanullah Gurbaz and Rashid Khan were the standout performers in this landmark win.

Gurbaz showcased his talent with an impressive century, his seventh in ODIs—the most by any Afghan batter in the format.

His innings was well-supported by Rahmat



Shah, who scored a solid 50, and Azmatullah Omarzai, who smashed an unbeaten 86 off just 32 balls. Omarzai's blistering knock included the fastest fifty by an Afghan player in ODIs.

Thanks to these contributions, Afghanistan posted a formidable total of 311/4 in their 50 overs,

marking the 10th time they have crossed the 300-run mark in ODIs and their highest-ever score ever.

With the ball, Rashid Khan celebrated his 20th birthday in style, taking a brilliant five-wicket haul that dismantled South Africa's batting lineup.

Nangeyalia Kharote, playing only his third ODI, also impressed by taking four wickets, as South Africa crumbled from a strong 73/0 to being bowled out for just 134.

Afghanistan will look to complete a historic whitewash when they face South Africa in the final ODI on Sunday, September 22.—Agency

Fakhar Zaman urges consistency in Pakistan's domestic cricket structure

Arsenal's mean defence faces acid test to shut out Man City again

MANCHESTER: Arsenal's Premier League title ambitions face the ultimate test on Sunday when a relentless Erling Haaland aims to fire Manchester City five points clear of the Gunners at the top of the table.

Mikel Arteta's men managed to stop City scoring twice last season, but still could not deny the English champions a record fourth consecutive Premier League title.

For the past two seasons Arsenal have finished second to Pep Guardiola's winning machine.

Many believe this is their season to end a 21-year wait to win the title since Arsene Wenger's "Invincibles" romped to glory without losing a game.

City remain their biggest obstacle, although the path could be cleared should the



holders be hit by a points deduction for 115 alleged breaches of Premier League rules by the end of the campaign.

Haaland has struck a record nine times in the first four matches of the new Premier League campaign.

The Norwegian's stunning form has ensured City are the only side in the English top-flight yet to drop points.

But Arsenal are on their tails again - just two points behind - after proving their

competitions, Arsenal have conceded just one - a goal that arrived when down to 10 men against Brighton.

"We all want to achieve something. Winning this Premier League is not easy, but when you finish twice second, you want to win," said Saliba.

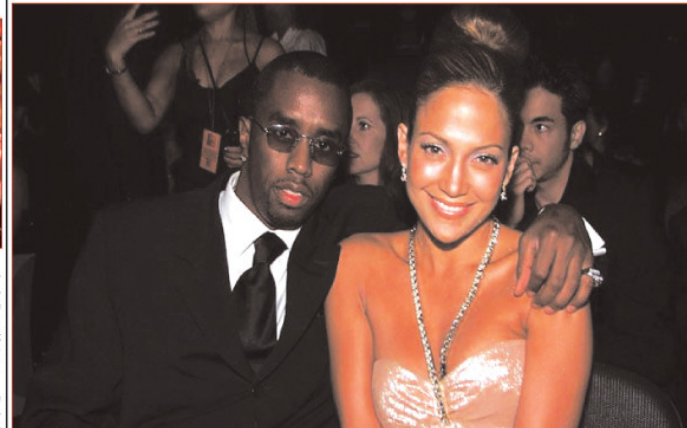

KARACHI: Sindh Chief Minister Murad Ali Shah has suspended the Deputy Inspector General (DIG) and Senior Superintendent of Police (SSP) of Mirpurkhas, as per an official notification issued by the Chief Secretary. Sindh Home Minister Zia Hassan Janjani confirmed that the SSP of the CIA and the concerned Station House Officer (SHO) had already been suspended prior to this move.



Janjani emphasized the Sindh government's commitment to the rule of law, noting that there was no hesitation in taking action against officials. A formal letter has been sent to the Establishment Division for further proceedings against the suspended DIG and SSP, reinforcing the government's dedication to justice and accountability.

Separately, the Election Commission of Pakistan (ECP) suspended three senior officers, including the Director of Administration and Provincial Election Commissioner Sindh, over charges of "misconduct and inefficiency." The officers will remain suspended for 120 days as the ECP continues its investigation. Meanwhile, in Punjab, the irrigation secretary suspended four officials, including a superintendent engineer (SE) and executive engineer (EXEN), for corruption and negligence related to a project involving Rs300 million.—RT

He alleged that the ballot papers from his constituency were stolen and that he would be filing a petition in court regarding this matter. Other PTI leaders present included Rashid Nawaz Abbasi, Umair Shahid, Zubair Baloch and Junaid Shah.

Afghan Citizens Using Pakistan For Illegal Travel To Other Countries

KARACHI: A recent report has revealed that Afghan citizens are allegedly exploiting Pakistan to illegally travel to other nations. Authorities have apprehended nine Afghan nationals attempting to reach Japan and the United States using fraudulent medical visas issued from Pakistan. Immigration sources suggest that this rise in forgery is linked to the suspension of

Pakistani visit visas for Afghan citizens. These individuals reportedly entered Islamabad from Kabul under the pretense of seeking medical treatment, armed with fake medical certificates, and subsequently applied for visas at various embassies and consulates for onward travel. In the last three days, immigration officials at Karachi Airport detained these nine individuals, resulting in the filing of three cases (No. 205, 207, 213/2024) against them. Following court directives, the arrested suspects have been transferred to jail. The arrests have sparked concerns regarding the potential involvement of certain Pakistani officials and agents who may be facilitating this illegal activity.—RT/Agency

Rs 20 Million Worth Of Crystal Meth Seized At Karachi Airport

KARACHI: Customs officials at Jinnah International Airport foiled a drug smuggling attempt, seizing 1,250 grams of methamphetamine (ice) valued at approximately Rs. 20 million. The contraband was found in the luggage of Muhammad Mithal Jamali, a passenger en route to Jeddah, Saudi Arabia. Customs Deputy Collector Hamad Ahmed initiated the operation after suspicions arose during baggage scanning. Upon inspection, the drugs were discovered concealed in the suitcase. Preliminary investigations revealed the meth's value exceeded Rs. 2 crore. Jamali has been detained for further questioning regarding his possible links to smuggling networks. In a separate incident, customs officials intercepted two Dubai-bound passengers attempting to smuggle over AED 100,000 out of Pakistan.—RT/Agency

First Phase Of Karachi Safe City Project Kicks Off

KARACHI: The first phase of the Safe City project has officially commenced in Karachi. Director General of Sindh Safe Cities Authority, Asif Ijaz Sheikh, announced that the process of installing cameras on poles, linked to the S-4 control room at the Central Police Office (CPO), has begun. Power Minister Anticipates Tariff Relief Following Completion Of IPPs' Review

ISLAMABAD: Federal Minister for Power Awaiz Ahmad Khan Leghari has said that the masses will get relief in electricity tariffs in the coming weeks as the Power Sector Task Force has completed its review of Independent Power Producers (IPPs) and state-run power plants, media reported on Saturday.



"The committee has been provided with all necessary information regarding the IPPs [...] We will soon share the good news with the public about the IPPs," Leghari said during a briefing to the Senate Standing Committee on Power.

The minister's remarks come at a time when Prime Minister Shehbaz Sharif-led coalition government is under the spotlight over sky-high electricity tariffs which have further burdened the inflation-weary masses.

Owing to the flak received regarding the IPPs, the government has been renegotiating contracts with the power producers to rein in "unsustainable" electricity tariffs — the highest in the region.

The announcement regarding relief in tariffs fol-

lows the Power Division's earlier statement on a relief of up to Rs2.65 (tax inclusive) in electricity bills for September courtesy of fuel adjustments.

Combining both the adjustments, agricultural and domestic consumers using up to 300 units would get relief of Rs2.19 per unit in their September bills, while Rs2.65 per unit (tax inclusive) would be provided to other consumers, the Power Division had said.

Expanding on the measures taken up by the government, Leghari informed the Senate committee — chaired by Senator Mohsin Aziz — that the task force had conducted a comprehensive assessment of the return on equity (ROE), operation and

costs to consumer grievances and shared her family's experience of having to visit the power office 28 times in three months due to incorrect meter readings.

Senator Palwasha condemned the behaviour of officials, likening it to mafia conduct, and called for stringent action against those responsible. She proposed referring the matter to the Federal Investigation Agency (FIA) to dismantle the alleged group behind the malpractice and set a precedent for accountability.

Committee Chairman Senator Mohsin Aziz acknowledged the senator's concerns, agreeing that the issue was of public importance and likely indicative of a broader problem, whereas a senior Power Division official confirmed that action had already been taken, including the transfer of the employee responsible for the faulty meter readings.

In response, Leghari remarked that the senator's concerns fell under customer care, which is not directly part of electricity distribution companies.

Moving on, committee

chair Senator Aziz stressed the urgent need to address electricity theft and over-billing, instructing the Power Division to clarify inconsistencies in reports regarding Bagasse-based IPPs and their tariff structures. He raised concerns over the pricing of bagasse, suggesting that its historical valuation has led to exploitation.

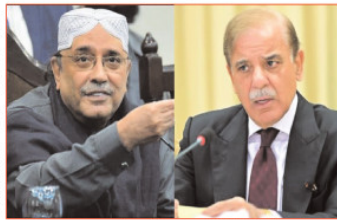
"We have no price of Bagasse," National Electric Power Regulatory Authority (Nepra) Chairman Waaseem Mukhtar informed the committee while acknowledging that the authority determines tariffs for Bagasse-based power plants.

It is to be noted that Pakistan's eight bagasse-based IPPs, with a combined capacity of 259.28 megawatts, are operating under the 2006 power policy, with agreements set to expire between 2044 and 2049.

Additionally, the parliamentary panel also reviewed a detailed report on load-shedding and electricity distribution from Peshawar Electric Supply Company (Pesco) and Sukkur Electric Supply Company (Secpo). —RT/Agency

President And PM Condemn Indian And Israeli Atrocities On 'Peace Day'

ISLAMABAD: President Asif Ali Zardari and Prime Minister Shehbaz Sharif on Saturday emphasised the significance of "tolerance" and "dialogue" in the road to achieving global peace as the world marked yet another International Day of Peace.



The president emphasised the need for collective efforts to promote a "culture of peace, tolerance, and respect for the dignity of all individuals."

"Together, we can shape a peaceful future and a better world where our successive generations could live in peace and harmony", he said in a message.

Meanwhile, PM Shehbaz called for fostering "peace and stability" in the region by resolving longstanding disputes through dialogues.

The premiers' remarks come at a time when the world is witnessing some of the most deadly conflicts and their escalations, especially in the Middle East region and the Indian Illegally Occupied Jammu and Kashmir (IIOJK).

Zardari stressed that the theme of this year's International Day of Peace — "cultivating a culture of peace" — "calls upon us to promote a culture of peace, tolerance, and coexistence among the comity of the nations."

He expressed regret over Israel's "reign of terror in Palestine" and its "genocide" which has killed over 41,000 Palestinians. He emphasised that such geopolitical tensions and conflicts in certain regions are threatening world peace.

His remarks came after around 14 were killed in an Israeli air strike on Lebanon's capital Beirut. This followed days after 37 people were killed in the country in an "unprecedented" attack in which paggers and walkie-talkies blew up, injuring over 3,000 people.

However, he also noted that, "together, we can shape a peaceful future and a better world where our successive generations could live in peace and harmony."

Similarly, Zardari stressed that the Hindutva-inspired Modi regime was committing grave human rights violations in IIOJK and was persecuting Muslims and other minorities in India and depriving them of their fundamental rights.

He said these blatant violations of international law and human rights endangered global peace and security. "We need to raise our voices against injustice and oppression. The priority of the world should be to address the problems being faced by humanity, including poverty, hunger, injustice, oppression, inequality, and the violation of basic human rights rather than disputes and conflicts," he added.

Additionally, the president added that world could not achieve progress and development in the absence of peace as wars and conflicts increase the problems and miseries of people. —RT/Agency

Shehbaz Leaves For New York As Dar Skips UNGA Session Due To Diplomatic Engagements

ISLAMABAD: The Ministry of Foreign Affairs on Saturday reacted to media speculation regarding Deputy Prime Minister and Foreign Minister Senator Ishaq Dar skipping the 79th session of the United Nations General Assembly (UNGA) scheduled to be held from September 23 to 27 in New York.



PM Shehbaz and Dar along with senior government officials were scheduled to visit New York to attend the upcoming UNGA session, however, it was rumoured that Dar cancelled his foreign visit due to uncertain political situation in the country.

However, Foreign Office (FO) Spokesperson Mumtaz Zahra Baloch clarified in a statement today that Dar was skipping the UNGA session in view of some important upcoming diplomatic engagements. The deputy premier was also not proceeding for the UNGA session due to the "ongoing preparations for the 23rd Meeting of the Council of the Heads of Government (CHG) of the Shanghai Cooperation Organisation (SCO)," she added. However, Premier Shehbaz's programme for participation in the UN summit remains unchanged, concluded Baloch.

PM Shehbaz has departed for New York to represent Pakistan at the 79th UNGA session from Islamabad today. He will make a stopover in London for two days before reaching New York on September 23. The premier said in an X post, "Departing for New York to represent Pakistan at the 79th UN General Assembly. Looking forward to a busy week full of engagements." "During our interactions we will take up global issues, promoting peace, development & climate action. Will present Pakistan's perspective to the world, advocate our interests & strengthen international partnerships," he concluded. In a briefing two days ago, the FO spokesperson detailed that PM Shehbaz, in his speech at the UN summit, will reaffirm Pakistan's steadfast commitment to

multilateralism and express support for the role of the United Nations in forging global peace, security, and prosperity. The premier will also emphasise the importance of addressing longstanding issues on the agenda of the UN Security Council, including the question of Palestine and Jammu and Kashmir. Moreover, he will attend several high-level meetings on the sidelines of the UNGA session, including the high-level meeting on existential threats posed by sea-level rise and the UN Security Council's open debate on leadership for the world. The bilateral meetings with world leaders, meetings with the UN Secretary-General, António Guterres and President of the UNGA, Philomena Yang, and members of the Pakistani diaspora are also on the agenda of the prime minister's visit. —RT/Agency

Islamabad ATC Issues Non-Bailable Arrest Warrants For Gandapur And Three Others



ISLAMABAD: An anti-terrorism court (ATC) in Islamabad on Saturday issued non-bailable arrest warrants for Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur and three other politicians over terrorism charges in the case pertaining to vandalism at the Judicial Complex, Islamabad.

Some of Pakistan Tehreek-e-Insaf's (PTI) current and former leaders had been booked in a case under terrorism charges in Islamabad at I-9 police station in Islamabad.

Beside Gandapur, the court issued non-bailable arrest warrants for former deputy speaker Punjab Assembly Wasiq Qayyum Abbasi, Isteekham-e-Pakistan leader Aamer Mehmood Kiani and PTI leader Raja Rashid Hafeez are among those it also declared exempt to PTI leader Umer Tanveer

Butt an absconder over his continuous absence at the case proceedings. However, the court approved PTI leader Faisal Javed's plea for exemption from appearance in the case hearing.

ATC Judge Tahir Abbas Sipra, while issuing the arrest warrant of Gandapur, turned down his bail petition, saying relief could not be provided every time without a solid reason. The defendant's lawyer informed the judge that the KP chief minister had told him that he could not appear before the court due to closure of routes. "The court should grant one [more] chance, Ali Amin will [definitely] appear before the court," the lawyer said. To which, the judge replied that he fixed the hearing date of Gandapur's choice last time as well, but to no avail. —RT/Agency

PTI Pledges To Oppose Proposed Constitutional Amendments

LAHORE: Pakistan Tehreek-e-Insaf (PTI) Chairman Barrister Gohar said that his party will resist proposed constitutional amendments and not let any restrictions be imposed on an independent judiciary, media reported.



Addressing a public gathering in Lahore, Barrister Gohar took a jibe at the government for "creating hindrances" for the public gathering. "We were not given a No Objection Certificate (on time) to hold the public gathering. Getting a US visa is easier than acquiring a NOC," the PTI chairman added.

Barrister Gohar said that his party does not want institutions to fight each other. "We will continue to struggle for judicial independence."

Speaking on the occasion, PTI MNA Sardar Latif Khosa slammed the government for attempting to pass the constitutional amendment unlawfully.

"This is a Form 47 government imposed on us; the country is occupied. PTI's founder will lead the people to freedom," Khosa added.

"Navaz Sharif vowed to uphold the respect of the vote. This how you respect the vote?" Sardar Latif Khosa asked.

Meanwhile, Chief Minister Ali Amin Gandapur and Leader of Opposition in National Assembly Omar Ayub who were leading convoys from Khyber Pakhtunkhwa, had not reached the venue by the end of the gathering.

According to reports, the chief executive was "using KP's resources" for the Lahore rally by bringing heavy machinery and rescue 1122 ambulances to clear any obstacles in their path, which infuriated the Punjab administration. After exceeding the time allotted by the district administration, the PTI power show in Lahore faced law enforcement intervention. The police and district officials contacted the rally organizers, urging them to end the rally as agreed on the allotted time, warning of

legal action for violating the terms of the NOC. As the event extended beyond the permitted time, the DJ switched off the sound system and lights, leaving the crowd in darkness. In response, attendees turned on their mobile phone flashlights, while some began to exit the venue. The police also started to close the key entry points to the city, including Ring road, Motorway Babu Saba Interchange, Shahdara, and Abdul Sattar Edhi interchanges, resulting in long traffic queues.

Deputy Commissioner Syed Musa Raza stated that any violation of the NOC would be handled legally, as law enforcement officers followed directives to block key roads and manage the situation. —RT/Agency

Pakistan Committed To Dialogue With Taliban Despite Existing Differences: UN Envoy Munir Akram

NEW YORK: Pakistan's Permanent Representative to the United Nations, Munir Akram, stated that Pakistan remains committed to maintaining its ties with the Taliban, despite any differences.



Speaking in an interview with a US broadcaster, Munir emphasised that the mistakes of the Afghan government should not be borne by the Afghan people, highlighting Pakistan's enduring relationship with its neighbour.

Munir pointed out that Pakistan has always supported engagement with Afghanistan, stressing that diplomacy aims to transform situations through dialogue and policy. He reiterated that while the Taliban's mistakes are recognised, Afghanistan's internal and external issues require a joint strategy and collective efforts. Therefore, ambassador Munir Akram, raised alarms at the United Nations Security Council (UNSC) regarding the increasing terrorist threat emanating from Afghanistan. He emphasised that the Tehreek-e-Taliban Pakistan (TTP), a

terrorist group which Pakistan refers to as Fitna al-Khawarij, is rapidly expanding its influence with the support of the Afghan interim government. Backed by the Taliban, these terrorists are equipped with advanced weaponry and increasingly collaborate with other insurgent factions, including secessionist groups like the Majed Brigade. Pakistan fears that the TTP's growing alliance with Al-Qaeda could elevate it to a central role in regional and global terrorist activities. The ambassador also stressed Pakistan's readiness to collaborate with regional and international bodies to curb this growing menace, as Islamabad continues its nationwide crackdown on Fitna al-Khawarij. Furthermore, the ambassador criticised the Afghan interim government for its ongoing human rights abuses, particularly against women and girls.

He condemned Kabul's failure to uphold promises regarding gender equality, highlighting that these regressive policies not only contravene Islamic values but also hinder Afghanistan's potential for international engagement. —RT/Agency

Asad Qaiser Accuses Bilawal Of Supporting Undemocratic Figures To Abolish 1973 Constitution

The PTI leader was referring to the support of Bialwal Bhutto for the PML-N led incumbent government on proposed constitutional amendment.

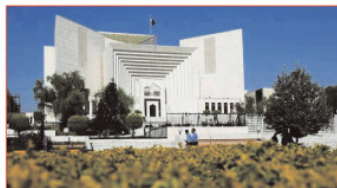

PTI Approaches SC For Clarification On NA Speaker's Letter To ECP Regarding Reserved Seats

ISLAMABAD: The Pakistan Tehreek-e-Insaf (PTI) on Saturday moved the Supreme Court seeking clarification on the letters written by National Assembly Speaker Ayaz Sadiq and Punjab Assembly's custodian Malik Muhammad Ahmad Khan to the Election Commission of Pakistan (ECP) on the matter of reserved seats.



The plea, filed by PTI Chairman Barrister Gohar Ali Khan via lawyer Uzair Karamat Bhandari, seeks the top court's clarification that "the Elections (Second Amendment) Act, 2024 had no bearing or effect on the binding nature of the short order dated 12 July 2024 and the implementation thereof cannot be refused on the basis of the said statute."

The petition comes after NA Speaker Sadiq wrote to the ECP terming the SC ruling, which had declared the PTI eligible for reserved seats, "incapable of implementation" after the amendments to the Election Act 2017 — a similar letter was

also written to the ECP by the Punjab Assembly's speaker as well.

The incumbent ruling coalition, following the ruling, had bulldozed the Elections (Second Amendment) Act, 2024 in both house of parliament on August 6 and the legislation came into force with President Asif Ali Zardari's assent on August 9.

In his letter to the electoral body, the speaker underscored two "particular provisions" — amendments to Section 66 and Section 104-A, which he said, were relevant for the Election Commission's consideration. In its amendment to Section 66 of the Elections Act, the bill says that if a candidate does not submit a declaration of his affiliation with a political party to the returning officer (RO) before seeking allotment of the election symbol, they shall be "deemed to be considered as an independent candidate and not a candidate of any political party." Meanwhile, the amendment to Section 104 reads that the declaration, consent or affidavit, by whatever name called, of an independent returned candidate once given for joining a political party shall be irrevocable and cannot be substituted or withdrawn. —RT/Agency
