Bilawal Bhutto-Zardari Vows To Establish Constitutional Court Regardless Of Obstacles

KARACHI: Pakistan Peoples Party (PPP) Chairman Bilawal Bhutto Zardari has categorically said that the formation of the constitutional court is compulsory and his party will ensure its formation come what may.

Addressing the Sindh High Court Bar Association on Tuesday, the PPP chief said that 19th constitutional amendment was introduced under duress "following a threat from the Supreme Court".

"The judicial reforms would be undertaken in line with the Charter of Democracy (COD) come what may," he vowed.

The government pushed the proposed constitutional package amid speculation about a potential extension in the tenure of Chief Justice of Pakistan (CJP) Qazi Faez Isa, who is set to retire in October this year, following the Pakistan Tehreek-e-Insaf's (PTI) request last month for the early issuance of a notification regarding the appointment of the next top judge.

Bilawal continued that the parliament had replaced the judges' appointment procedure with a globally recognised law via 18th amendment. "In the United States, entire parliament decides on the appointment of judges that is why martial law is never imposed in the US," he added.

Terminating the ex-premier Zulfikar Ali Bhutto's death sentence a "judicial murder", Bilawal said that it was "necessary and also our compulsion" to establish a constitutional court so no other prime minister could be executed and justice would be served to the people.



He came down hard on military rulers and said that her mother Benazir Bhutto had seen the military dictator General Zia-ul-Haq's era in which all political workers went through brutal torture.

The politico recalled that our system was broken. At that time, [former chief justice] Iftikhar Chaudhry was not a revolutionary, but a PCO judge."

"[...] nor there was any 'dam wala judge,'" Bilawal said while referring to ex-CJP Mian Saqib Nisar without naming him.

He said that a decision was taken to form a constitutional court citing the need of the people to get justice "when courts were fixing the prices of pakora and tomatoes at that time".

Despite claims of securing the "magic number" needed to push the bill through, the government

failed to table the judiciary-centric amendments — possibly including the establishment of a separate constitutional court — in parliament and postponed its move indefinitely.

To pass the constitutional amendments, the government is short of 13 votes in the National Assembly (NA) and nine in the Senate.

To attain the required parliamentary strength for passing the judicial package, the ruling coalition parties — the PPP and the Pakistan Muslim League-Navaz (PML-N) — held a flurry of meetings to woo Jamiat Ulema-e-Islam-Fazl (JUI-F) chief Maulana Fazlur Rehman, but to no avail.

The ruling coalition is inclined towards the politico-religious party as it remained a close ally of both parties in the previous government led by the Pakistan Democratic Movement.

This multi-party party alliance successfully ousted former premier Imran Khan from office via a no-confidence motion in 2022.—RT/Agency

Biden Emphasizes Diplomacy Over Conflict In Final UN Address As President

NEW YORK: US President Joe Biden makes his final appearance at the UN General Assembly in New York on Tuesday, after dropping out of the race in July and endorsing his vice president as the Democratic nominee, the 81-year-old is not taking any chances.

Prime Minister Shehbaz Sharif also attended the opening session of the 79th UNGA being held today marking the beginning of the annual gathering of world leaders.

Biden asked world leaders to prevent "full-scale war" over Lebanon, as clashes escalated between Israel and Hezbollah, prompting the UN chief to warn of a situation "on the brink".

The UN General Assembly, the high point of the diplomatic calendar, comes as Lebanese authorities say Israeli strikes killed 558 people — 50 of them children.



"Full-scale war is not in anyone's interest. Even though the situation has escalated, a diplomatic solution is still possible," Biden said in his farewell address to the global body.

"In fact (it) remains the only path to lasting security to allow the residents from both countries to return to their homes on the border safely," Biden said.

Biden also pushed again for an elusive ceasefire between Israel and Hamas,

condemned the "senseless and incomprehensible" inaction by the UN against Israel.

Israel's ambassador to the UN, Danny Danon hit back at the UN chief, calling the General Assembly debate an "annual charade of hypocrisy."

"When the UN Secretary General speaks about the release of our hostages, the UN assembly is silent, but when he speaks about the suffering in Gaza, he receives thunderous applause," Danon said.

Since last year's annual gathering, when Sudan's civil war and Russia's Ukraine invasion dominated, the world has faced an explosion of crises.

With Israel's leader Benjamin Netanyahu and Palestinian president Mahmoud Abbas expected to address the General Assembly this week, there could be combustible moments Abbas

took his seat alongside the Palestinian delegation in alphabetical order for the first time after the delegation received upgraded privileges in the assembly in May.

Biden said that Russian President Vladimir Putin's war has failed at its core aim. He set out to destroy Ukraine, but Ukraine is still free "It is unclear if the grand diplomatic gathering can achieve anything for the millions mired in conflict, poverty and climate crisis globally. Additionally, he urged all countries to stop arming rival generals in Sudan, whose bloody war has triggered a major humanitarian crisis.

"The world needs to stop arming the generals. Speak with one voice and tell them: 'Stop tearing your country apart. Stop blocking aid to the Sudanese people. End this war now,'" Biden told the UN General Assembly.—RT/Agency

Ji Chief Hafiz Naem Calls For 'Referendum' On Payment Of Electricity Bills



MANCOORAH: Jamaat-e-Islami (JI) Pakistan leader Hafiz Naemur-Rehman has announced that a 'public referendum' will be held to decide whether citizens should continue paying electricity bills or not.

Speaking at a press conference in Mansoorah, Hafiz Naem revealed that the referendum will take place from October 23 to 27, following a series of nationwide protests.

The JI leader criticised the government for imposing 'unjust taxes' and allowing 'Independent Power Producers' (IPPs) to 'benefit at the public's expense'.

He accused the government of failing to deliver on its promises of providing relief to citizens and vowed to launch a fresh wave of

protests after October 7 if the situation does not improve.

As part of its 'Haq Do Awam Ko' (Give People Their Rights) movement, Jamaat-e-Islami has organised a series of demonstrations against rising electricity bills, and taxes.

Hafiz Naem also highlighted the party's successful shutter-down strike, which, according to him, fostered national unity. He called for an end to the privileges given to government ministers and IPPs, arguing that the common people are paying the price for policies favouring a few. He added that JI's upcoming protests and 'referendum' are aimed at ensuring justice for the public and putting pressure on the government to take corrective measures.—RT/Agency

Imran Accuses PML-N Government Of Turning Pakistan Into A 'Police State'

RAWALPINDI: Jailed former premier and PTI founder Imran Khan has claimed that the country has been turned into a "police state" while prevailing conditions are even harsher than what was witnessed during the martial law.



"This is a martial law which is far stricter than [former military rulers] Zia-ul-Haq and Pervez Musharraf's martial law," Khan said while taking a jibe at the incumbent government led by the Pakistan Muslim League-Navaz (PML-N) during an informal conversation with journalists at Rawalpindi's Adiala Jail.

Last week, the deposed premier, who has been behind bars for over a year now, had termed the former military rulers Pervez Musharraf and Zia-ul-Haq's martial law regimes "better" than the current democratic setup.

The deposed prime minister said that the Supreme Court's verdict on the reserved seats had made everything clear.

He added that the bid to keep the former ruling party out of the election and remove his party from the country's political landscape was "fully exposed".

He has time and time again criticised the Prime Minister Shehbaz Sharif-led administration for not being a

"legitimate" while citing alleged interference and manipulation in the February 8 polls.

Throwing shade at the coalition government, Khan said that the subordinate judiciary was in complete control of the current rulers. He further alleged that any judge, who is not in control of the rulers, got transferred.

The former premier also claimed that a judge was also replaced who was going to give a verdict in the May 9 mayhem cases.

Expressing displeasure over the judiciary's lack of response, Khan claimed that the PTI's request for hearing its petitions against the National Accountability Bureau (NAB) amendments' case was also turned down.

He also alleged that the amended Supreme Court Practice and Procedure Ordinance was promulgated to "violate the democratic procedure to fix hearing of

cases".

He was referring to the Supreme Court (Practice and Procedure) Amendment Ordinance 2024 approved by President Asif Ali Zardari last week which granted additional powers to the chief justice to nominate a judge as a member of a committee and assign cases.

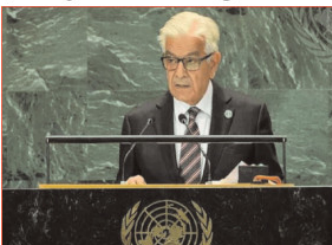
The cricketer-turned-politician also unveiled a schedule of his party's upcoming protests and a power show.

He said that the PTI would register a protest for the independence of the judiciary on Thursday followed by another demonstration on Friday.

He added that a power show would be organised in Rawalpindi on September 28 and warned that his party would strongly react if permission is not granted for the public gathering.—RT/Agency

Sustainable Development Unattainable Amid Tragedies Like Gaza, Says Khawaja Asif

NEW YORK: Federal Defence Minister Khawaja Asif has stated that sustainable development will remain out of reach as long as tragedies like Gaza continue, blaming developed nations for perpetuating such crises.



Speaking at the UN's Summit of the Future in New York, Khawaja urged the international community to address global economic disparities and ensure equitable growth for developing countries.

In his address, Khawaja called for improved representation of developing nations in international financial institutions and advocated for a review of the sovereign debt framework to ensure fairness.

He also pressed for the creation of an equitable international tax system.

reforms in the World Trade Organization (WTO). Khawaja argued that such changes would help developing countries expand exports and promote development.

He warned against introducing new forms of environmental protectionism that could hinder progress.

The Defence Minister also expressed support for adopting the UN's Pact for the Future, describing it as a vital document reflecting the global community's determination to tackle pressing challenges.

He emphasised the importance of upholding the commitments made in the pact.—RT/Agency

UN Chief Warns Lebanon On The 'Brink' Following Israeli Strikes

NEW YORK: UN Secretary-General Antonio Guterres told world leaders on Tuesday that Lebanon was "at the brink" and warned against allowing the country to turn into "another Gaza," a day after Israeli strikes killed more than 550 people there.



"Gaza is a non-stop nightmare that threatens to take the entire region with it. Look no further than Lebanon," Guterres said at the opening of the UN's annual gathering as hostilities between Israel and Hezbollah, an Iran-backed armed group, threatened to plunge the region into all-out war.

"We should all be alarmed by the escalation. Lebanon is at the brink. The people of Lebanon, the people of Israel, and the people of the world cannot afford Lebanon to become another Gaza." War featured prominently in the UN chief's remarks, with references to Gaza, Lebanon, Ukraine, Sudan, and other ongoing conflicts. "Nothing can justify the abhorrent acts of terror committed by Hamas on October 7, or the taking of hostages — both of which I have repeatedly condemned," said the 75-year-old former prime minister of Portugal. "And nothing can justify the collective punishment of the Palestinian people," he continued. Humanity faces three major threats to sustain-

ability that must be confronted, said Guterres: impunity, which erodes international law, inequality, which destabilizes nations, and uncertainty, "where unmanaged global risks threaten our future in unknowable ways." "Uncertainty, he said, was compounded by the existential threats of the climate crisis — long a signature issue for the UN chief — and the rapid advance of artificial intelligence, which he said would require a global approach to manage.—RT/Agency

ISLAMABAD: Pakistan on Tuesday condemned in the strongest possible terms, Israel's latest military aggression against Lebanon, massacring hundreds of civilians in a statement, the Foreign Office (FO) said that the act of aggression against the Republic of Lebanon is a grave violation of the UN Charter and international law. "It is a dangerous escalation that has further endangered peace and security in an already volatile region," it

Army Chief Reaffirms Support For KP Police, Law Enforcement During Wana Visit

WANA: Chief of Army Staff (COAS) General Syed Asim Munir emphasised that Pakistan Army will continue to provide steadfast support and technical assistance to law enforcement agencies (LEAs), particularly Khyber Pakhtunkhwa (KP) police, to enhance their capacity, the Inter-Services Public Relations (ISPR) said in a statement on Tuesday.

DC, SSP Dadu hold talks with protesting residents of Wahi Pandhi

DADU: In Wahi Pandhi, following the murder of a woman, concerns arose regarding the filing of an FIR against the culprits. To address the situation, Deputy Commissioner Dadu Mukhtiar Ali Abro reached the ongoing protest on the Indus Highway, which had been organized by the Birhamani community for three consecutive days. During the meeting with the protesters, the Deputy Commissioner expressed his condolences for the loss and inquired about their demands, assuring them that their issues would be resolved. After gaining assurance regarding action against the perpetrators, partial restoration of traffic on the Indus Highway was implemented, and a delegation of

protesters was invited to the DC office in the presence of the SSP Dadu. The plea stated that the family's inclusion on the PCL was preventing their travel plans.

Parveez Elahi, who is also the President of PTI, had recently emerged from a year-long legal battle, securing his release from prison.

In a statement, Elahi expressed gratitude to his supporters and the judges, thanking them for standing by the truth.—RT/Agency

Barrister Saif Urges Action Against ECP Chief Under Article 6

He dubbed the ECP chief responsible for all the mess going on in the country, adding that both the premier and the ECP chief had committed contempt of court.—RT/Agency

Senate Committee Instructs PWD To Transfer Constantia Lodge Possession

ISLAMABAD: The Senate Standing Committee on Housing and Works Tuesday directed the Pakistan Public Works Department (PWD) to facilitate the demarcation process and transfer possession of the Constantia Lodge to the ministry, as well as to resolve all related issues.

The Senate body that met here with Nasir Mehmood in the chair addressed agenda items, examining the jurisdiction mechanisms, and processes for implementing the Building Code of Pakistan 2021, including the Seismic Provisions of 2007 and environmental protection measures nationwide.

It was noted that the Pakistan Engineering Council (PEC) oversees the building code and that notifications are issued by the Ministry of Science and Technology. The code establishes minimum standards for building safety, structural integrity, and sustainability.

Provinces can modify specific provisions to address regional characteristics, such as seismic risks and climate conditions.

Local planning departments evaluate submitted plans for compliance with structural and environmental standards, often involving expert consultants.

Senator Bilal Ahmed raised concerns that the involvement of consultants and contractors could lead to fraud and urged the need for clearly specified authorizations.

It was revealed that approximately 90% of buildings do not conform to approved structures.

The committee highlighted that while the Building Code of Pakistan 2022 provides a framework for safe, sustainable, and environmentally responsible construction, it lacks the authority to approve building plans or monitor construction; these powers rest with local departments.—RT/Agency



The Exploitation of Pakistani Artists Must End

The recent controversy surrounding Ghotki-based artist Seffy Soomro's misused artwork is a stark reminder of how Pakistan fails to appreciate and protect its artists. Soomro's paintings, initially reported missing by Karachi's Frere Hall, later surfaced in a popular television drama without his consent. This issue, which has now been brushed off as a "misunderstanding" in a government inquiry, underscores the broader systemic negligence faced by artists in Pakistan.

The inquiry, ordered by the Sindh Culture Minister, reveals the disrespect and disre-

gard often shown to those in the art world. Soomro's paintings were not only wrongfully withheld but also exhibited and rented

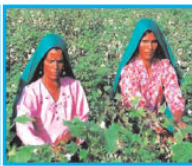


out for profit — all without his knowledge. The report's claim that Soomro did not take a "serious interest" in retrieving his work is absurd. Is an artist expected to constantly beg institutions for what is rightfully theirs? This is not just about Soomro; it's about a broken system where artists, instead of receiving support, are dragged into

unnecessary controversies and exploitation.

Art, an essential reflection of culture and society, is constantly sidelined in Pakistan. The country's artists are rarely given the recognition and support they deserve. Instead, their work is treated as a commodity, easily misappropriated by those in power. The lack of accountability in this case sets a dangerous precedent for others, and the government must take immediate action to safeguard the rights of artists. Otherwise, this pattern of exploitation will only continue, pushing talent away from the very institutions meant to protect them. Artists must be uplifted, not taken advantage of.

LARKANA: The residents of the Channa Muhalla, Aqil Road in Larkana have staged a protest by blocking the Naudeto Chowk against the suspension of electricity supply for three days. They chanted slogans against SEPCO. During the protest, residents Zubair Soomro, Madad Khuhro, Nadeem Abbasi, Abdul Haq Surhio, and others expressed their grievances, stating that they have been receiving electricity from the Bahapur feeder for the past 30 years. However, four months ago, this feeder was shut down, and they were switched to the Kachi Tube Well feeder, which is frequently inoperative.

They further explained that SEPCO cut 11,000 elec-



tricity wires three days ago, leaving them without power. The residents mentioned that they have previously protested to restore electricity from the Bahapur feeder, but no officials have addressed their concerns, leading to ongoing electricity issues in their area. Due to the power outage, men, women, and children are

facing significant hardships, especially in the intense heat. The protesters demanded the immediate restoration of the 11,000 electricity wires and the provision of electricity from the Bahapur feeder instead of the Tube Well feeder, threatening to escalate their protest if their demands are not met.

New Zealand Women's team fined for slow over-rate in T20I against Aussies

MACKAY: New Zealand Women's cricket team has been fined for maintaining a slow over-rate during the first T20I against Australia in Mackay.

The team was found to be one over short of the required rate after taking time allowances into account.

As a result, the players were penalized five percent of their match fees for every over they failed to bowl within the allotted time, according to Article 2.22 of the ICC Code of Conduct.

This rule applies to minimum over-rate offences.

New Zealand captain Sophie Devine accepted the penalty, and since she pleaded guilty, a formal hearing was not required.

The charge was laid by on-field umpires Andrew Crozier and Troy Penman, along with third umpire Ben Treloar and fourth umpire Daryl Brigham.

The sanction was imposed by Match Referee David Gilbert.

Australia won the first T20I by five wickets and followed it up with a 29-run victory in the second match at the same venue.

The two teams are set to face off again in the third T20I on Tuesday, September 24, before heading to the UAE for the ICC Women's T20 World Cup, which starts on October 3.

In the first game, New Zealand, who batted first, posted a total of 143 runs and also lost 7 wickets. Even with the ball, they failed to apply pressure on the opposition as they went on to lose the first game of the series by 5 wickets as Australia chased the target in just 18.4 overs.

Mikel Arteta stands by defensive tactics in fiery Man City clash



LONDON: Mikel Arteta stood by Arsenal's defensive tactics in their explosive Premier League clash with Manchester City, saying he would have been "thick" not to learn from previous clashes.

Leonardo Trossard was shown a second yellow card for kicking the ball away when Arsenal were 2-1 up at the end of the first half at the Etihad.

After the break the Gunners sat back and soaked up pressure, ceding almost all the possession to the Premier League champions until John Stones netted a stoppage-time equaliser.

Arsenal, who had led for most of the contest after goals from Riccardo Calafiori and Gabriel Magalhães, were accused of employing the "dark arts" by City defenders Kyle Walker and Stones.

City forward Bernardo Silva accused them of "time-wasting".

But Arsenal boss Arteta stood by his team's approach on Tuesday, referencing their 5-0 defeat to Manchester City in 2021, when former captain Granit Xhaka was sent off.

Speaking ahead of Wednesday's third-round League Cup tie against third-tier Bolton, the Spaniard said his team "had to play the game that we had to play."

"Unfortunately we've been in the same situation," he said. "We were in that same situation with Granit and when we lost 5-0. So we'd better learn. If not I would be very thick."

Erling Haaland threw the ball at Arsenal defender Gabriel's head after City's equaliser as tempers flared but Arteta played down the tensions. —Agency

MANCHESTER: Manchester City star Erling Haaland recently reached a significant milestone, netting his 100th goal for the club during a 2-2 draw with Arsenal, placing him alongside football legend Cristiano Ronaldo.

The 24-year-old Norwegian footballer's swift ninth-minute strike at the Etihad Stadium placed him alongside the 39-year-old Portuguese player as the fastest man to score 100 goals for a European club.

Ronaldo, a five-time Ballon d'Or award winner, made the record while playing for Real Madrid, back in 2011. Meanwhile, both players managed to achieve the feat in their 105th appearance for their clubs, ESPN India reported.

In 2024, Kevin De Bruyne became the 18th Manchester City player to reach 100 goals, achieving the accolade in his 372nd appearance for the club.

Haaland, whose goal-scoring prowess has solidified his status as a prominent figure in European football, had already broken the record for most goals through four games of the Premier League season with nine, including two hat tricks.

Such a prolific start meant he went into the Champions League game at home against Inter Milan on 99 goals from 103 game appearances and with a chance to break Ronaldo's record.

Legislation Banning Protests Without Permission Challenged In IHC



ISLAMABAD: The legislation banning peaceful assemblies without permission in Islamabad has been challenged in the Islamabad High Court.

Chief Justice Amir Farooq heard the case, while Advocate Iman Mazari represented the petitioner.

During the hearing, Iman Mazari argued that peaceful protests were a fundamental right of every citizen and should not be prohibited.

The Chief Justice remarked that assemblies were subject to permission and designated locations, highlighting that in Europe, the UK, and worldwide, gatherings typically require authorization.

Mazari pointed out that violators were to face a three-year imprisonment according to the legislation, to which the Chief Justice stated that such a penalty contradicted fundamental rights.

The court subsequently issued notices to the federal government and the Secretary of Law and has acquired a response. The court while summoning the Attorney General for judicial assistance, adjourned the hearing for two weeks. It is noteworthy that on September 5, the Peaceful Assembly and Public Order Bill 2024 was passed by a majority vote in the Senate amidst strong protest from the opposition party, Pakistan Tehreek-e-Insaf.—RT/Agency

Demo staged for increase in laborers' daily wages

22 LPG shops sealed in Hyderabad

Justice Mansoor Ali Shah Urges Dialogue To Fortify Institutions

Sanaullah Predicts Major Breakthrough On Constitutional Package Soon

LAHORE: Prime Minister's Adviser on Political and Public Affairs and PML-N leader Rana Sanaullah on Tuesday hinted at evolving "minimum consensus" among political parties on controversial judiciary-centric constitutional amendments that also included proposal to establish constitutional court.



Sanaullah signalled a possible breakthrough in the coming days on the constitutional package as alongside the ruling Pakistan Muslim League-Nawaz, the Pakistan Peoples Party (PPP) and the opposition party — Jamiat Ulema-e-Islam-Fazl (JUI-F) were separately preparing the draft of the constitutional amendments.

Speaking on private tv programme, the PM's aide responded to the query regarding the progress on the proposed constitutional amendment that could not be tabled in parliament as the government lacked two-thirds majority in both houses to pass the judiciary-centric legislation.

The government pushed the proposed constitutional package amid speculation about a potential extension in the tenure of Chief Justice of Pakistan (CJP) Qazi Faez Isa, who is set to retire in October this year, following the Pakistan Tehreek-e-Insaf's (PTI) request last

month for the early issuance of a notification regarding the appointment of the next top judge.

He added that the drafts could be discussed in the forthcoming consultative sessions after Prime Minister Shehbaz Sharif's return from the United States where he would address the United Nations General Assembly's session.

He was of the view that the government would table the constitutional package after developing a "minimum consensus", including the legislation related to the establishment of a constitutional court.—RT/Agency

Governor House sources asserted that while the provincial government can propose three candidates for each vice-chancellor position, the final appointment authority lies with the governor, who is also chancellor of the varsities. They also pointed out that the 14-day period for six universities' summaries had not yet expired. The governor's office highlighted that no appointments would be made beyond merit. On the other hand, sources in the Chief Minister's office argued that the governor's role is merely ceremonial. The appointments made were legal. The discord comes just a day after the provincial government appointed vice-chancellors for prominent institutions, including Punjab University, University of Gujrat, and Bahauddin Zakariya University and some others.—RT/Agency

Sindh Govt Has Allocated Rs 434m For Restoration Of Islamkot RO Plant: Saeed Ghani

KARACHI: Sindh Minister for Local Government and Public Health Engineering, Saeed Ghani, announced that the provincial government has earmarked Rs 434 million for the restoration of the reverse osmosis (RO) water filtration plant in Islamkot. This allocation, he clarified, is not for any new development project.



Ghani made the statement while responding to questions during the Sindh Assembly's session on Tuesday. He informed lawmakers that Islamkot's RO plant, a major facility of filtering 1.5 million gallons of water daily, has been non-functional due to technical difficulties. He explained that Engro Corporation had initially requested Rs 1.4 billion for the plant's revival, and while the provincial cabinet approval, an additional Rs 600 million needed to operate the plant over four years was not provided.

KARACHI: Sindh Chief Minister Syed Murad Ali Shah has expressed satisfaction with the progress made on the Karachi Safe City Project, describing it as a significant step toward improving the city's security through advanced surveillance and rapid response systems.



"I have significantly accelerated the long-delayed Safe City Project. Phase-I, and it has now reached several important milestones aimed at enhancing public safety in Karachi," CM Shah stated during a meeting held at CM House on Tuesday.

The meeting was attended by Home Minister Ziaul Hassan Lanjar, Secretary to CM Raheem Shaikh, and other officials.

The Inspector General of Police briefed the Chief Minister on the project's developments, revealing that 1,300 cameras are set to be installed across various locations in the city. Surveys of 300 pole sites and 18 Points of Presence (POP) have been completed, along with the necessary Right-of-Way (RoW) approvals. Foundation work at 200 pole sites

has also been completed, and 50 poles have already been installed, with work continuing on the remaining sites. The CM was further informed that equipment, including Control Room and Data Center components as well as a Video Wall, has been installed at the Central Police Office (CPO), enabling live monitoring through 35 cameras across seven locations. All necessary shipments of equipment from suppliers, including Hikvision, Huawei, Vertiv, and others, have been received and safely stored.

Additionally, five Emergency Response Vehicles (ERVs) have been procured and branded, while the allocation of 18 POP sites within police stations has been completed, with renovation and groundwork underway.

Finance Minister Confident Of Securing \$7bn IMF Deal Today

ISLAMABAD: Finance Minister, Senator Muhammad Aurangzeb, voiced confidence on Tuesday that the International Monetary Fund's board will greenlight a \$7 billion, 37-month Extended Fund Facility (EFF), at its meeting tomorrow (Wednesday).



"Pakistan successfully concluded a 9-month SBA (Stand-by Arrangement) with IMF and we have its board meeting tomorrow (Wednesday) here in the US. We are very hopeful the board would approve the 37-month 7 billion Dollars programme," he said speaking at "High Level Private Sector Dialogue - CPEC-II and the Region" virtually through Zoom.

The finance czar said Pakistan was committed to structural reforms under the programme, and it needed to pursue the reform agenda, whether in taxation, the energy sector, state-owned enterprises, or privatisation. "We will stay on course," he resolved.

The event was organised by the Pakistan Regional Economic Forum. Pakistan and the IMF reached an agreement on a loan programme in July. The IMF said the programme was subject to approval from its executive board and obtaining "timely confirmation of necessary financing assurances from Pakistan's development and bilateral partners."

Earlier this month, finance minister vowed to persevere with plans for new taxes on the retail sector despite strike threats, as a step towards winning approval from the board of the IMF for a \$7-billion loan.

"One thing I want to be very clear (about) ... This is not going to be taken back," Aurangzeb said in a televised speech urging wholesalers,

He said the currency and foreign exchange reserves were stable, with two months of import cover, while inflation had decelerated, leading to a reduction in policy rates and eventually KIBOR, to the benefit of the industry.

Aurangzeb said the government had recently rejected Treasury Bills (T-bills) and Pakistan Investment Bonds (PIBs), saying the decision aimed to convey a clear message that the government was no longer desperate to borrow domestically.

"If required, the government will borrow domestically on its own terms, signalling the banking sector to lend to the private sector," he said.

However, he said investment inflows in terms of debt and equity were welcome, as they would bring foreign direct investment (FDI) into the country.

Attaching great importance to macroeconomic stability, the finance minister said a foundation had been laid to promote economic stability.

No Final Decision Yet On Imran Khan's Military Trial, AAG Informs IHC

ISLAMABAD: On the Islamabad High Court's (IHC) seeking clarification from the government over Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan's possible military trial, Additional Attorney General (AAG) Munawar Iqbal Duggal on Tuesday apprised the court that no decision had so far been taken in this regard.



Hearing the former prime minister's plea, the high court on September 16 ordered the Ministry of Defence to give a clear stance about his military court trial on the next hearing on September 24 (today), upon which the ministry had sought time.

The PTI founder had petitioned against the military trials in the May 9 case that witnessed military installations being vandalised following his arrest in a graft case in 2023.

Khan's petition had come in the wake of statements by government high-ups including Defence Minister Khawaja Asif and Law Minister Azam Naezer Tarar that fuelled rumours of his military trial, over his alleged involvement in the May 9 riots.

It is pertinent to know that in July 2023, an anti-terrorism court in Lahore — in a four-page written verdict — had said that reasonable grounds existed to connect

the PTI founder with the May 9 incidents.

Meanwhile, the additional attorney general said if any decision about Khan's military trial was taken then legal procedure would be adopted for it.

"If a decision about military trial is taken, the plea will be submitted to the civil magistrate first," he said.

At this, IHC Justice Misgungul Hassan Aurangzeb disposed of the PTI founder's petition.

Apart from the AAG, a representative of the Ministry of Defence was also present during the hearing.

It is to be noted that the Pakistan Democratic Movement (PDM) led government had initiated military trials of those involved in targeting state and military installations in 2023's riots.

The matter ended up in the Supreme Court which declared civilians' trials in military courts null and void in its October 23, 2023, verdict which was later suspended by the apex court in a 5:1 majority ruling in December.

Durable World Peace Hinges On Resolving Palestine And Kashmir Disputes, Says Tarar

NEW YORK: Federal Broadcast for Information, Broadcasting, National Heritage and Culture Attallah Tarar said on Tuesday that durable peace in the world was not possible without permanent resolution of Palestine and Kashmir issues.

He said the Kashmir issue would figure in the Prime Minister's engagements in the United Nations.

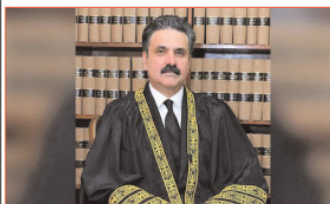
He said the UN secretary general had himself visited Pakistan and himself saw the impact of climate change in Pakistan due to heavy floods.

Justice Yahya Directs ECP to Reassess Reserved Seats Notification



ISLAMABAD: As the reserved seats saga continues to grip the country's political landscape, Supreme Court Justice Yahya Afridi's separate note has been issued by the apex court with the pensive judge directing the Election Commission of Pakistan (ECP) to revisit its notification of returned candidates on the reserved seats.

A returned candidate, who declared himself to represent a political party, duly submitted a certificate of nomination and didn't withdraw the declaration via any written intimation, has to be declared a returned candidate representing the said political party and not otherwise, reads Justice Yahya's note originally dated August 13, 2024.

The development comes a day after the top court issued the detailed judgment of its July 12 short order which had declared the Pakistan Tehreek-e-Insaf (PTI) eligible for reserved seats.

Supreme Court Reserves Verdict On ECP's Appeal Against LHC's Election Tribunals

ISLAMABAD: The Supreme Court on Tuesday reserved the verdict on the Election Commission of Pakistan's (ECP) appeal against the Lahore High Court's order appointing eight election tribunals in Punjab to address election disputes after the February 8 general polls.



The development comes as the country's top electoral authority's plea was heard by Chief Justice of Pakistan (CJP) Qazi Faez Isa-led five-member bench comprising Justice Amin-ud-Din Khan, Justice Jamal Khan Mandokhel, Justice Naeem Akhtar Afghani and Justice Aqeel Ahmed Abbas.

The matter involves the authority to constitute election tribunals which have been a point of contention between the LHC and the ECP for months.

The issue arose first when the ECP, on February 14, sought a panel of serving judges from the LHC for election tribunals.

The then LHC chief justice nominated two judges on February 20 which was followed by the nomination of another six judges by the CJ on April 14.

Out of these six nominated judges, two were notified

by the ECP on April 26. However, the electoral body then additional names for the appointment to Rawalpindi and Bahawalpur election tribunals.

This, however, was denied by the LHC chief justice with the high court's registrar calling on the electoral body to notify the election tribunals consisting of the judges nominated by the CJ.

On May 29, Justice Shahid Karim ordered the electoral body to appoint six more judges, nominated by the LHC chief justice, as election tribunals for hearing election petitions regarding the general elections and said that the notification was deemed to have been issued in case of the ECP's failure to comply by the court's orders.

The electoral body, while refusing to accede to the high court's registrar's demand, said that if it went through with notifying the election tribunals it would mean that they were in fact solely appointed by the LHC CJ and not as a result of consultations between the ECP and the chief justice — which essentially would be a violation of Section 140(3) of the Elections Act.

The then LHC Justice Malik Shahzad Ahmad then constituted eight election tribunals for hearing cases related to the February 8 polls — a move which was then challenged by the ECP in the apex court. The dispute owes its origins to the amendments made to the Election Act 2017 regarding which judges could be part of election tribunals.—RT/Agency

£190m Reference: Court Issues 'Final Warning' To PTI Lawyers For Cross-Examination

ISLAMABAD: An accountability court in Rawalpindi on Tuesday gave lawyers of Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan and his wife, Bushra Bibi, a "last chance" to cross-examine the sole remaining witness in the £190 million settlement case. The court expressed discontent over the defendant's counsels once again seeking to postpone the hearing without cross-examining the witness.



Accented court judge Nasir Javed Rana heard the case at the Adiala Jail in Rawalpindi against the couple that is accused of causing billions of rupees loss to the national exchequer through embezzlement. The lawyers apprised the court that Bushra's counsel Usman Gul could not show up as he was unwell. Hence, he said, cross-examination could not be held from the investigation officer (IO), the last witness in the reference. The National Accountability Bureau (NAB) prosecutor opposed the request for adjourning the hearing, saying 12 letters of attorney had been submitted by the suspects' lawyers. Therefore, he was of the view that other senior lawyers present in the

court could cross-examine the witness. The accountability watchdog prosecutor said the last witness of the 190 million pound reference had been appearing for the previous 23 hearings, but he was not being cross-examined. "Barrister Ali Zafar and Intazar Panjutha are present in the court. They should cross-examine the witness," the NAB official said.

He also said the Islamabad High Court (IHC) stopped the trial court from announcing a verdict, but not from carrying a trial. Giving the last chance to cross-examine the witness, the court has adjourned the hearing till Wednesday (tomorrow) IHC on September 18 stopped the accountability court from issuing a final verdict in the £190 million settlement case against incarcerated

The PTI founder on September 7 had filed a plea seeking acquittal in the £190 million case, after the Supreme Court's verdict in the NAB amendments case wherein the court accepted the intra-court appeals filed against last year's verdict which struck down the changes made to the National Accountability Ordinance (NAO).—RT/Agency

CJP Questions Salman Akram Raja: 'Do You Want Judges Of Your Choice?'

ISLAMABAD: The Supreme Court (SC) Tuesday reserved the verdict on the Election Commission of Pakistan's (ECP) plea against the Lahore High Court's (LHC) order to form election tribunals in Punjab, media reported.



A five-member bench, headed by Chief Justice of Pakistan (CJP) Qazi Faez Isa conducted the hearing today. The bench also comprises Justice Amin-ud-Din Khan, Justice Jamal Khan Mandokhel, Justice Naeem Akhtar Afghani and Justice Aqeel Ahmed Abbas.

In the previous hearing, on July 5, the bench had suspended the LHC's decision to establish eight election tribunals until further notice.

The top court also directed the chief election commissioner and the LHC chief justice to resolve the matter through meaningful consultation.

On May 29, LHC's Justice Shahid Karim ordered the ECP to notify additional

election tribunals for Punjab. Later on June 12, the LHC CJ formed eight election tribunals in line with the May 29 order. The ECP had challenged the order in the SC.

During the hearing today, Salman Akram Raja's lawyer Hamid Khan raised an objection and appealed the CJP to rescue himself from the case which was turned down the CJP Qazi Isa.

"If you want to withdraw from the case, then you can," the CJ replied to Hamid Khan and instructed him to remain seated.

Following this, Salman Akram Raja's lawyer Hamid Khan left the courtroom.
