## Imran Expresses Full Support For Justice Mansoor Ali Shah As CJP

RAWALPINDI: Pakistan Tehreek-e-Insaf (PTI) jailed founder Imran Khan has said his party is completely backing Supreme Court's Justice Mansoor Ali Shah to become the country's next top judge.

"The appointment of the next chief justice should be announced soon. [We] completely back Justice Mansoor Ali Shah," the former prime minister said while speaking to journalists informally in Rawalpindi's Adiala Jail on Wednesday.

Khan, who was removed from power via a parliamentary vote in April 2022, said that the purpose of the constitutional court is to end the power of the Supreme Court's chief justice, adding that the "government is bent on destroying the judiciary."

"They want their own judges to cover the [2024] election fraud," the PTI founder insisted, stressing that the government "does not want the PTI to rise at any cost."

The ousted premier made these comments in light of the ongoing saga surrounding the constitutional package chalked out by the ruling coalition which allegedly provisions regarding extension in the retirement ages of the high court and supreme court judges.

The government pushed the proposed constitutional package amid speculation about a potential extension in the tenure of Chief Justice of Pakistan (CJP) Qazi Faez Isha, who is set to retire in October this year, following the PTT's



request last month for the early issuance of a notification regarding the appointment of the next top judge.

However, the Pakistan Muslim League-Nawaz (PML-N), despite having the support of its allies such as the Pakistan Peoples Party (PPP) and others, had postponed introducing the constitutional amendments in the parliament despite claiming to have secured the "magic number" earlier.

The deferment came after Jamiat Ulama-e-Islam-Fazl (JUI-F) refused to lend its support to the ruling coalition, short of 13 votes in the National Assembly (NA) and nine in the Senate as the said legislation, aimed at amending the Constitution, requires a two-thirds majority in both houses in the National Assembly, the ruling coalition needs 224 votes to pass the constitutional amendments, whereas in the Senate the number stands at 64. Currently, as per reports, treasury benches have 211 members against the opposition's 101 MNAs. Although JUI-F chief Maulana Fazlur Rehman has so far remained seemingly

unwilling to back the amendments, which he, in fact, has termed a bid to protect the coalition government.

Adviser on Political and Public Affairs and PML-N leader Rana Sanaullah had hinted at evolving "minimum consensus" among political parties on controversial judiciary-centric constitutional amendments that also included the proposal to establish constitutional court — which PPP Chairman Bilawal Bhutto has said would be introduced "come what may".

The PM's aide also said that the consultation process with other political parties on the judicial package has not stalled as the Bilawal Bhutto Zardari-led PPP and Maulana Fazlur Rehman-led JUI-F were working on their draft amendments. He added that the drafts could be discussed in the forthcoming consultative sessions after Prime Minister Shehbaz Sharif's return from the United States and opined that the government would table the constitutional package after developing a "minimum consensus".—RT/Agency

## PM Calls For Resolution Of Kashmir Dispute And Ceasefire In Gaza

NEW YORK: Prime Minister Shehbaz Sharif has called on UN Secretary-General Antonio Guterres to use his good offices for the implementation of the relevant Security Council resolutions on Jammu and Kashmir and to ensure the right of self-determination of Kashmiris.

He was talking to Guterres on the sidelines of the UN General Assembly's session in New York on Wednesday.

Briefing the UN chief on the situation in Indian Illegally Occupied Jammu and Kashmir (ILOJK), the premier underscored Pakistan's serious concerns over PM Modi-led government's egregious actions in the occupied valley and stressed upon the need to resolve the dispute to ensure lasting peace and stability in South Asia.

PM Shehbaz also condemned Israel's genocidal campaign against the Palestinians and called for an immediate and unconditional ceasefire in Gaza. He urged the international community to hold Israel accountable.

He reaffirmed Pakistan's support for the establishment



of a viable and sovereign State of Palestine.

The PM also underscored the need for stemming the rising tide of Islamophobia and discrimination against Muslims worldwide. He reaffirmed Pakistan's commitment to actively contribute towards international peace and security as a non-permanent member of the UN Security Council for the year 2025-26.

Besides, the prime minister welcomed the initiative by the UN secretary general to organise the "Summit of the Future", and expressed his hope that its outcome would help the developing countries in bridging the financial gap for the imple-

mentation of SDGs and climate goals.

Guterres thanked PM Shehbaz for Pakistan's active engagement at the United Nations as well as for its role towards international peace and security in the form of its UN's Peacekeeping Force.

Minister for Defence Khawaja Muhammad Asif, Information Minister Attaullah Tarar, Education Minister Dr Khalid Maqbool Siddiqui and Special Assistant Tariq Fatemi accompanied the prime minister. Yunus warmly welcomed PM Shehbaz and members of his delegation at the ceremony held on Tuesday night on the sidelines of the UNGA session.—RT/Agency

## IHC Questions Government On ISPR's 'Exclusive Right' To Define Defense Analysts

ISLAMABAD: The Islamabad High Court's Justice Babar Sattar has grilled the federal government on how the military's media wing was assuming the "exclusive right" to decide who qualifies as a defence analyst, it emerged on Wednesday. The development came to light on Tuesday when the IHC issued an order about a case that challenged Penna's directives mandating retired officers to seek permission from the Inter-Services Public Relations (ISPR) before appearing on television. In April 2019, Penna instructed all television channels to seek prior clearance from the ISPR before inviting retired military



officers on news and current affairs programmes "to solicit their views on matters of national security". The directives were challenged by the Ex-Servicemen Legal Forum in the IHC while the Pakistan Ex-Servicemen Society sup-

ported them. The IHC order, a copy of which is available with media, said Assistant Attorney General Adeel Akhtar Raja had relied on the response filed by the defence ministry and ISPR during the hearing.—RT/Agency

## IMF Board Approves \$7 Billion Bailout Package For Pakistan

ISLAMABAD: The International Monetary Fund (IMF) on Wednesday approved a \$7 billion new bailout package after Pakistan promised to overhaul its agriculture income tax, transfer some fiscal responsibilities to provinces and had to take the most expensive loan in the nation's history.

The Executive Board of the IMF approved the 37-month Extended Fund Facility totaling \$7 billion. It also authorised to immediately release the first loan tranche of nearly \$1.1 billion. It is the 25th IMF programme that Pakistan has obtained since 1958 and 6th EFF.

The IMF board has approved the programme without addressing one of the root causes of taking these loans — the need for restructuring of the external and domestic debt that consumed 81% of Pakistan's tax revenues in the last fiscal year.

The new bailout package targets achieving the macroeconomic stability by consolidating public finances, rebuild foreign exchange reserves, reduce fiscal risks from state-owned enterprises, and improving the business



environment to encourage growth led by the private sector.

To qualify for the programme, the government imposed Rs1.4 trillion to Rs1.8 trillion in additional taxes, increased electricity prices up to 51% and committed to bringing transparency in the affairs of the Sovereign Wealth Fund.

The government also took Pakistan's history's most expensive loan of \$600 million to win a board meeting date from the IMF.

Unlike in the past, when the provincial budgets were out of the purview of the IMF, the new programme is also expanded to the provincial budgets and their revenues. There are nearly one dozen IMF conditions that

directly impact the provinces under the new programme.

The federal and four provincial governments would sign a new National Fiscal Pact by next Tuesday to transfer the responsibilities of health, education, social safety net and road infrastructure projects to the provincial governments.

All the four provincial governments would align their agriculture income tax rates to the federal personal and corporate income tax rates by amending their laws by October 30. As a result, the agriculture income tax rate would increase from 12-15% to up to 45% from January next year.

All the provincial governments would not give any further subsidies on electric-

ity and gas and these governments would not establish any new Special Economic Zones or Export Processing Zones.

The federal government would not be entitled to have any new such economic zone and would end the tax incentives of the existing zones by 2035.

According to another condition, Pakistan would show a primary budget surplus of 4.2% of the Gross Domestic Product during the three-year programme period. The primary budget surplus is calculated after excluding interest payments.

A 4.2% of the GDP deficit would significantly squeeze non-interest expenses and put an additional tax burden equal to 3% of the GDP on the existing taxpayers.

Under the IMF programme, a primary surplus equal to 1% of GDP will have to be shown in this fiscal year and about 3.2% over the next two years to put the debt-to-GDP ratio on a sustainable declining path.

In case of tax shortfall, the government has committed to bring a mini

budget that would result into increasing tax rates on imports, contractors, professional service providers and on fertilizer.

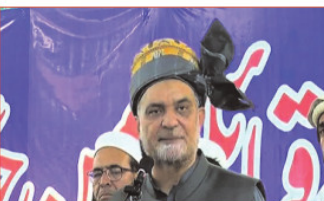
For this fiscal year, Pakistan will be bound to keep the spending on defence and subsidies at the previous fiscal year's level in terms of the size of the economy.

However, the design of the programme has not completely addressed the issue of debt unsustainability and is built around the strategy of rolling over the maturing external debt during the programme period.

Pakistan has committed that it would not repay the \$12.7 billion debt to Saudi Arabia, China, the United Arab Emirates and Kuwait during the programme period.

The Asian Development Bank warned on Wednesday that the rising political and institutional tensions may make it difficult to implement the reforms that Pakistan has committed to deliver to the IMF. It said that these reforms were crucial to make sure that the external lenders keep lending to Pakistan.—RT/Agency

## Hafiz Naem Proposes Mediation For Pakistan-Afghanistan Talks



PESHAWAR: Jamaat-e-Islami emir Hafiz Naemur Rehman expressed his willingness to mediate between Pakistan and Afghanistan, underscoring the importance of dialogue over military action.

Speaking at the Tribal Peace Jirga in Peshawar, the JI head criticised the role of the United States in promoting terrorism in the tribal areas. He stressed that Afghan territory should not be used against Pakistan. He said that constitutional limits should guide governance in every institution to ensure

peaceful resolutions to tribal conflicts.

Rehman underscored the need for the government to prioritise education, healthcare, and employment opportunities in the tribal areas, warning that the nation cannot be controlled through force alone. He stressed the Pakistani government to engage in dialogue with the Afghan Taliban, stating that negotiations are the only practicable solution for both nations. Hafiz Naem further offered Hafiz's services in facilitating these negotiations.—RT/Agency

## ECP Divided Over Implementation Of SC Ruling On Reserved Seats



ISLAMABAD: The Election Commission of Pakistan (ECP) remains divided over the implementation of the Supreme Court (SC) order regarding reserved seats.

According to sources, two ECP members support the SC's decision, citing no alternative but compliance.

However, the chief election commissioner and three other members favour a "wait and see" approach.

Despite holding its seventh meeting, the commission has yet to reach a final decision.

It has been suggested to delay action until the legal team's review petition is resolved. The matter will be discussed again in a meeting scheduled for Thursday.—RT/Agency

## Trump Alleges 'Significant Threats' To His Life From Iran

WASHINGTON: Donald Trump said Wednesday there were "big threats" on his life posed by Iran after the Republican presidential candidate's campaign team said US intelligence warned him of "real and specific" threats from Tehran.

"Big threats on my life by Iran. The entire US Military is watching and waiting," Trump said on his Truth Social platform.

"Alleges" were already made by Iran that didn't work out, but they will try again... I am surrounded by more men, guns, and weapons than I have ever seen before," he said, following increased scrutiny of the US Secret Service since two attempts on Trump's life this year.

Trump's campaign team said in a statement Tuesday that US intelligence had warned the former president from Iran to assassinate him.

It was not immediately clear if the threats referred to by the campaign and Trump himself were new or threats that have previously been reported.

"President Trump was briefed earlier today by the Office of the Director of National Intelligence regarding



real and specific threats from Iran to assassinate him in an effort to destabilise and sow chaos in the United States," campaign communications director Steven Cheung said in the statement.

"Intelligence officials have identified that these continued and coordinated attacks have heightened in the past few months, and law enforcement officials across all agencies are working to ensure President Trump is protected and the election is free from interference," he added.

The campaign did not elaborate on the claims, which come as world leaders scramble to try to avert hostilities between Iran-backed Hezbollah and Israel escalating into a wider regional war.

Iran has rejected accusations that it is trying to kill

Trump this summer, shortly after a gunman opened fire at a rally in Pennsylvania, killing one person and wounding the presidential candidate.

Days after the July 13 assassination attempt, US media reported that authorities had received intelligence on an alleged Iranian plot against the Republican, prompting his protection to be boosted. Iran rejected the "malicious" accusations.

"If they do 'assassinate' President Trump," which is always a possibility, I hope that America obliterates Iran, wipes it off the face of the Earth — If that does not happen, American Leaders will be considered 'gutless cowards!' Trump said on his social media platform, Truth Social, at the time.—RT/Agency

## Turkish President Commends Shehbaz's Economic Policies At UN General Assembly Meeting

NEW YORK: In an important diplomatic encounter on the sidelines of the 79th Session of the United Nations General Assembly in New York, Turkish President Recep Tayyip Erdogan lauded Prime Minister Shehbaz Sharif for his government's impressive economic performance.

Insiders who observed the meeting told media that President Erdogan specifically commended Prime Minister Shehbaz's administration for successfully improving Pakistan's macroeconomic indicators and bringing inflation down to single digit.

The Turkish leader expressed optimism about Pakistan's continued economic progress under PM Shehbaz's leadership.

"Prime Minister Sharif's economic policies have played a crucial role in stabilising Pakistan's economy,"



President Erdogan remarked during their bilateral meeting. He further praised the prime minister for his commitment to economic reform and strong leadership under challenging financial circumstances. The two leaders engaged in discussions on various bilateral matters, agreeing to strengthen cooperation in trade, investment, defence, and security domains. They also reviewed preparations for the upcoming 7th session of the Pakistan-Türkiye High-Level Strategic Cooperation Council (HLSCC) scheduled to be held in Islamabad. Regional and global issues were on the agenda as well, with both leaders expressing concern over the humanitarian situation in Gaza and calling for an immediate ceasefire. ## Professors of SUTA Sufi Group posted on all administrative posts including Directorate of campus security

JAMSHORO: In a move that has stirred considerable controversy, Sindh University Vice Chancellor Dr. Muhammad Siddique Kalhoro has appointed several teachers to administrative posts, contravening a Sindh High Court ruling. Since his appointment on January 21, 2021 as VC, he has replaced many officers with teachers, leaving the university's administrative staff unsettled and uncomfortable.

According to university regulations and the Sindh High Court's decision, these administrative positions should be filled by officers of the appropriate grades. The appointees are reportedly all members of the Sufi Group of the Sindh University

Teachers' Association, led by Dr. Irfana Mallah. With the new postings by the VC other group of teachers is being deprived of fair promotions and postings even as chairpersons and directors of academic departments. Senior professors including Dr. Muhammad Hassan Agham and Professor Ayaz Haider Mugheri have already written a joint letter to the Chancellor of Sindh Universities and the Chief Minister of Sindh against the injustices and disparities of incumbent Vice Chancellor, but no solid action has been taken yet.

The situation escalated when the Assistant Professor at the Department of Media & Communication Studies Dr. Abdul Razaque Chhachar wrote to the Chief Minister Sindh Syed Murad Ali Shah, demanding an investigation against Vice Chancellor Kalhoro as he deliberately bereaved him of the promotion. Another Assistant Professor at IBA SU & Sindh poetess Naveeda Katpar, who was also denied promotion as Associate Professor also complained to the Chief Minister and Chancellor of Sindh about being overlooked for promotion despite fulfilling all requirements. In response, the Chief Minister instructed the Universities and Boards Department to take action against the VC. This unfolding controversy continues to impact the university's administration and academic environment. The officers are decisive to launch a protest movement against the VC and his policies.

## Barrister Saif Calls Constitutional Amendments 'An Insult To Constitution and Democracy'

PESHAWAR: Adviser to the Khyber Pakhtunkhwa Chief Minister on Information Barister Muhammad Ali Saif on Wednesday lashed out at the prospective constitutional amendments, terming them as an "insult to the Constitution and democracy". "How can the current parliament introduce constitutional amendments? It is incomplete and unconstitutional and therefore lacks the authority to legislate" the CM's adviser questioned in a statement. Barrister Saif's remarks come against the backdrop of the ongoing saga surrounding the constitutional package chalked out by the ruling coalition which allegedly provides extension in the retirement ages of the high court and supreme court judges. The Pakistan Muslim League-Nawaz (PML-N), despite having the support of its allies such as the Pakistan Peoples Party (PPP) and others, had postponed introducing the constitutional amendments in the parliament despite claiming to have secured the "magic number" earlier. The deferment came after Jamiat Ulema-e-Islam-Fazl (JUI-F) refused to lend its support to the ruling coalition, short of 13 votes in the National Assembly (NA) and nine in the Senate as the said legislation, aimed at amending the Constitution, requires a two-thirds majority in both houses.—RT/Agency

## Gojra Police Seize 890 Kilos Of Contaminated And Harmful Meat

In a major operation by the PFA in the jurisdiction of City Police Station, Gojra, 890 kg of harmful and contaminated meat was recovered, with one suspect arrested and two fleeing. A case has been registered. According to details, a notorious group involved in selling meat from sick, weak and dead animals in Gojra

was caught by the Punjab Food Authority. During a major raid at a unit in the City Police Station area, 890 kg of decayed and harmful meat was recovered. Two suspects fled the scene, while one was arrested and handed over to the police. City Police has registered a case against the suspects.

After veterinary doctors declared the recovered meat to be substandard and hazardous, the PFA destroyed it on the spot. Additionally, the Punjab Food Authority confiscated equipment and other items used in the meat processing and distribution. According to a spokesperson from the Punjab Food Authority, Toba Tek Singh, the poor-quality meat was intended to be supplied to various hotels and other food outlets. A case has been registered at the City Police Station, and further investigations are ongoing. The operation was carried out under the leadership of the Deputy Director (Operations), with the participation of police and livestock officials.

## University Closed Following Death Of Female Student In Multan Bus Accident

MULTAN: Muhammad Nawaz Shareef University of Agriculture (MNSUA) in Multan has been closed for two days after protests erupted over the death of 21-year-old Minahil, a 5th-semester biochemistry student, who was fatally struck by a university bus on Monday.



Minahil was riding her motorcycle when she collided with a bus approaching from the opposite direction. The accident occurred inside the campus, and she died on the spot. Rescue officials confirmed that her body was taken to Nishtar Hospital.

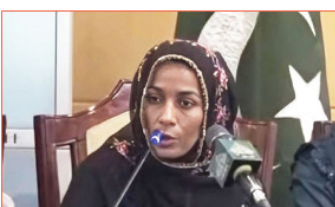
Following the incident, a large number of students gathered outside the university, chanting slogans against the administration and demanding accountability for the tragedy. In response, the university administration decided to close the campus for two days in mourning.

A university spokesperson expressed deep sorrow over Minahil's death, stating that the closure was a mark of respect. The bus driver involved, identified as Aamir, has been suspended and is currently under investigation. Shah Shams Police Station House Officer (SHO) Rao Mehtab stated that Minahil's father informed the police that he did not wish to lodge a formal complaint. However, the police will begin an investigation if a formal application is submitted.

MNSUA spokesperson Riaz Hiraj provided further details about the incident, explaining that the accident occurred at 8:30 am Minahil, who was reportedly driving at a high speed, lost control of her motorcycle after seeing the bus, leading to the collision. Resultantly, she was run over by the bus and died on the spot, he added. The university spokesperson added that CCTV footage of the accident was shown to Minahil's parents, and her father acknowledged that the bus driver was not at fault.—RT/Agency

## Suspected Baloch Woman Suicide Bomber From Turbat Claims She Was Brainwashed For Terrorism

TURBAT: A suspected female suicide bomber, who was arrested in Balochistan's Turbat, has revealed that she was rescued by security agencies after a Baloch separatist organization tried to lead her astray to use her for their own vested interests.



"I was brainwashed for terrorism. The youth are being lured into terrorism," Adeela Baloch said while addressing a press conference on Wednesday, flanked by Farah Azeem Shah and Shahid Rind, the Balochistan government's spokespersons.

The suspected suicide bomber's parents were also seated on her right during the presser. Baloch said she was walking on the "wrong path" and was "deceived". "I survived because of the Balochistan government."

She revealed that, apart from her, there was another girl in the mountains

who was beguiled towards terrorism. The woman, who received her primary education from Turbat and pursued a nursing course from Quetta, said terrorists use people for their purposes. "Some people lured me towards suicide bombing. I did not think that innocent people would die because of that."

Speaking during the press conference, Baloch advised the people not to get lured by terrorists. The woman's father, who was present at the session, spoke about his daughter's kidnapping. "I knew that those who are taken to the mountains do not return," her father said, adding that he contacted the government of Balochistan about his daughter's disappearance. He said that his daughter was brought back after the provincial administration's timely action. "Parents of missing persons should go to the government. They should monitor their children's activities."—RT/Agency

## Karachi Encroachment Removal And Development Projects Discussed In High-Level Meeting

## The Perils of Upper Sindh: A Haven for Banditry and Lawlessness

Upper Sindh continues to spiral into an abyss of lawlessness, where banditry reigns unchecked and the rule of law remains a distant dream. The recent incident in Shikarpur, where eight individuals, including four women, were lured into a trap under the guise of a marriage proposal, starkly illustrates the state of extreme insecurity. This is not an isolated case but part of a long-standing pattern where the notorious katcha area has become synonymous with organized crime and violence.

Despite occasional operations by the po-

lice and Rangers, the situation has shown little improvement. Law enforcement's sporadic success, like the recent killing of a no-



torious bandit, does little to ease the daily fears of residents who remain at the mercy of these criminal networks. Tragically, even those tasked with restoring order, such as the 12 policemen martyred in Rahim Yar Khan, are regularly ambushed and out-gunned.

Under these conditions, it's no wonder that investment in the region remains non-existent. Who would want to live, let alone invest, in an environment where basic safety cannot be guaranteed? The plight of the common man, trapped in this cycle of violence and fear, is continuously ignored by the government and stakeholders who seem oblivious to the urgency of the situation.

It is high time that the authorities prioritize the restoration of law and order in Upper Sindh. Until then, the region will remain a no-go zone, abandoned by both its people and the prospects of development.

### ARI calls for accelerated efforts to provide affordable and effective services for tobacco cessation

KHAIRPUR: The Alternative Research Initiative (ARI) has called for accelerated efforts to provide affordable and effective services for tobacco cessation across the country. Currently, around 31 million people in Pakistan use tobacco in various forms. ARI's Project Director, Arshad Ali Syed, made this demand during a recent event, emphasizing that tobacco use is a major health issue in Pakistan, leading to cancer, heart disease, and lung conditions. Beyond health, tobacco use incurs significant financial and social costs, including billions in healthcare expenses and reduced productivity, which cost the country billions annually.

Arshad Ali Syed highlighted the need for affordable and accessible services to help people quit smoking, stressing that the issue cannot be delayed



further. Arshad noted that many people want to quit smoking but lack any government support. While some smoking cessation programs have had partial success, they remain largely inaccessible to most people, especially in rural areas. He stressed that a comprehensive strategy could help adult smokers quit, which should include public awareness campaigns, improved access to counseling, and affordable nicotine replacement therapy (NRT) clinics.

Arshad Ali Syed, along with NARI Foundation Chairperson Afshan Asghar and Executive Director Anwar Mahar, urged the establishment of affordable clinics at the district level to significantly reduce the number of smokers. This, they said, would lessen the financial and social burden of tobacco use on the country. They called on the government and all stakeholders to join them in this mission to improve public health and save lives.

### Nine arrested for burning Dr Shahnawaz Kumbhar's dead body presented in court

MIRPURKHAS: In Mirpurkhas, nine suspects arrested in the case of burning the body of Dr. Shahnawaz Kumbhar, who was allegedly killed in a police encounter, were presented in an Anti-Terrorism Court.

Abdul Ghani added to the scoreline in the 56th minute, extending Pakistan's lead to 5-0. Sri Lanka managed to score their lone goal in the 76th minute, but it was too little, too late to challenge Pakistan's dominant performance.

In the previous game, Pakistan ended in a 3-3 draw against Bhutan.

Both teams showcased impressive skills, keeping the fans involved in the game.

Pakistan's Khabib Khan initiated the game after smashing a goal in the 38th minute of the match.

Subhan followed the footsteps of Khabib and doubled the lead by scoring in the 46th minute.

In regard to this, Bhutan made a strong comeback and equalised the score.

However, the Men in Green eyeing for victory regained the lead with Abdul Samad smashing the third goal in the 67th minute, which was countered by Bhutan ending the match in a draw.—Agency

### Hundred hero Brook keeps England alive in Australia ODI series

**ENGLAND:** England captain Harry Brook's maiden one-day international century revived his side's series hopes against Australia as they beat the world champions by 46 runs at Chester-le-Street.

Victory in the third ODI left England 2-1 down with two to play. England slumped to 11-2, chasing 305 to win, after Mitchell Starc removed openers Phil Salt (nought) and Ben Duckett (eight) in the space of four balls.

But Will Jacks (84) and Brook (110 not out) then added 156 in a third-wicket partnership of good judgement as well as shot-making skill.

Rain stopped play with England 254-4 off 37.4 overs.

But they were 46 runs ahead of where they needed to be under the Duckworth-Lewis-Stern method for weather-affected matches.

And, with a down-pour preventing any further play, England had ended Australia's run of 14 consecutive ODI wins.

Player-of-the-match Brook was understandably elated by a first century in his 18 ODI's, with the 25-year-old Yorkshireman saying at the presentation ceremony: "It's nice to get the first one on the board and hopefully plenty more to come."

"We just have to keep doing what we said we are going to do (in Friday's fourth ODI at Lord's) and keep being positive, take the game to them (Australia)."

Jacks missed out on a maiden century when he perupercut a Cameron Green bouncer to backward point to end an 82-ball innings featuring nine fours and a six.

Brook, however, went to 99 by driving Starc back over his head for four before a single off the paceman saw him to a an 87-ball hundred including 12 fours and two sixes.—Agency



**KARACHI:** Former Chief Selector Haroon Rashid has expressed grave concerns about the current state of Pakistan cricket, stating that the sport is facing numerous challenges that require more than a quick fix.

Speaking to the media in Karachi, Rashid emphasized that these issues cannot be resolved in a brief one or two-hour meeting, and pointed to his own past association with the Pakistan Cricket Board (PCB).

"Such a situation has never been witnessed before," he remarked, adding that the world is now mocking both the PCB and the national team due to poor management and decision-making.

He specifically criticized recent actions by the PCB, such as starting an Under-19 tournament only to abruptly cancel it, and scheduling a white-ball tournament just before a crucial red-ball series.

"It Naseer, described the camp PCB are confused and lack vision," Rashid observed.

The former cricketer called for more in-depth discussions and strategic planning to address the growing concerns. "If we want to improve Pakistan cricket, we need to hold lengthy sessions. A short meeting won't be enough," he said, adding that after such sessions, the conclusions reached must be implemented to bring about meaningful change.

Rashid also highlighted a lack of unity within the national side, which became apparent during the recent connection camp. "The camp revealed to the world that the team is not united," he noted. "It was made clear that there is no cohesion within the team."

It must be noted that on Monday PCB organised a "Connection Camp" on Monday to enhance communication, collaboration, and performance among the national cricket team members.

PCB's Chief Operating Officer (COO), Salman Naseer, described the camp as timely, considering the busy season ahead for the team.—Agency

### Former Pakistan chief selector slams PCB over lack of vision



**DUBAI:** Board of Control for Cricket in India (BCCI) secretary Jay Shah is set to continue in his role until the end of November, despite his recent appointment as the chairman of the International Cricket Council (ICC).

Reports from an Indian media outlet indicate that the BCCI will not be seeking a replacement for Jay Shah during the upcoming Apex Council meeting.

Jay, who has been elected unopposed to the ICC position with support from 15 member nations, will officially take charge of the global cricket governing body on December 1.

However, his dual responsibilities pose a significant challenge for the BCCI, which now faces the task of finding a new secretary as Jay departs.

The Apex Council is scheduled to convene on Wednesday to address various operational issues within the board.

Eight key issues will be addressed during the AGM, but the agenda does not include any discussions regarding the nomination process for a new secretary.

While the appointment of a new secretary was anticipated to be on the agenda, it has been confirmed that Jay will continue in his role until the transitions to the ICC.

Among the key issues to be discussed is the matter of Byju, the former title sponsor for the BCCI, which terminated its contract prematurely and has outstanding dues from October 2022 to March 2023.

There will also be a discussion on the inauguration of the state-of-the-art National Cricket Academy.—Agency

### Future ICC chairman Jay Shah plans to stay on as BCCI secretary



**PARIS:** Carlos Alcaraz has secured his place in the season-ending ATP Finals to be held in Turin in November, joining world number one Jannik Sinner and twice champion Alexander Zverev.

Alcaraz, 21, won the French Open and Wimbledon this year to take his Grand Slam tally to four, before bagging the silver medal at the Paris Olympics.

The world number three from Spain, who also won the Indian Wells title, has qualified for the season finale for the third consecutive year and will be aiming to win the trophy for the first time after reaching the semi-finals last year.

An abdominal injury forced him out of the 2022 edition.

Sinner, last year's runner-up, qualified in August during his run to the Montreal quarter-finals, while 2018 and 2021 champion Zverev earned his spot after making the last eight of the U.S. Open this month.

The ATP Finals, which features the world's best eight singles players and doubles teams determined by the separate Race to Turin rankings, will run from November 10-17.—Agency

### Alcaraz joins Sinner, Zverev in ATP Finals field



**MADRID:** Kylian Mbappe struck for the fourth consecutive game as Real Madrid survived a late scare to beat Alaves 3-2 in La Liga.

Real Madrid, second, cut the gap on Barcelona to one point before the leaders host Getafe on Wednesday.

Madrid dismantled Alaves with goals from Lucas Vazquez, Mbappe and Rodrygo before a late salvo from the visitors rocked Carlo Ancelotti's side.

Carlos Protezioni and Kike Garcia scored two goals in two minutes in the final stages but Madrid held on.

"This is football, you can think the game has finished, (then there's) a small slip and they score the first, they get confidence and you lose it, this is what happens," Ancelotti told reporters.

The second-seeded Asim triumphed over third-seeded Ashab with scores of 11-7, 7-11, 4-11, and 4-11. This victory marks Asim Khan's third PSA title of the year and the 10th of his career.

She had a rather confused expression on her face and comically stammered during her response as Perry answered, "It's a great game... with a ball," she meekly responded to much applause and laughter in the studio.

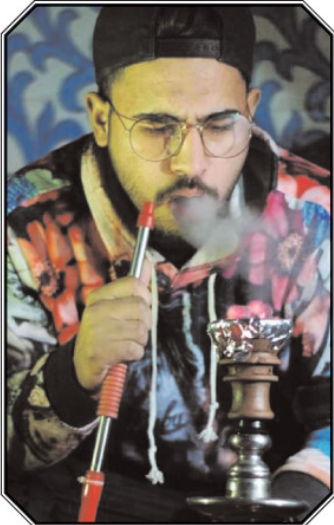
However, she is aware of one aspect of the game, the attire of the players when the panelist, Sarah Harris asked if she had seen the uniforms that the AFL players wear.

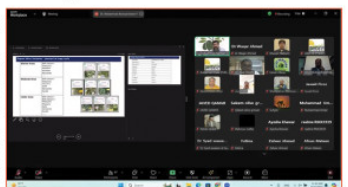

## Sindh High Court Seeks Arrest Of Israeli PM Netanyahu Over War Crimes

KARACHI: On Wednesday, the Sindh High Court (SHC) initiated proceedings for the arrest of Israeli Prime Minister Benjamin Netanyahu in connection with alleged war crimes in Gaza.

According to reports, the plea, filed by Advocate Sohail Hameed, accuses Netanyahu and other Israeli officials of causing the deaths of over 41,000 Palestinians, including 15,000 children, amidst the ongoing siege of Gaza.

The petition emphasized that the International Criminal Court (ICC) has already issued arrest warrants for Netanyahu and several other Israeli officials. It calls on the court to direct respondents—including the Ministry of Foreign Affairs, the Secretary of the Cabinet, and the United Nations—to adhere to these warrants and ensure accountability for those implicated in war crimes.

Notably, in May, the ICC prosecutor sought an arrest warrant against Netanyahu concerning war crimes related to the conflict in Gaza.—RT/Agency

## Father Killed, Son Injured In Karachi Robbery Shooting



KARACHI: A tragic robbery incident in Karachi's Bilal Chowringhi area resulted in the death of a father and serious injuries to his son when armed robbers opened fire after the duo resisted their attempts.

The victims, identified by rescue officials as 50-year-old Abdul Malik and his son Kashif, were attacked near a petrol pump in the Korangi area shortly after withdrawing money from a bank. The robbers, a gang of three on motorcycles, attempted to snatch the cash in front of a factory entrance.

When Abdul Malik and Kashif resisted, the assailants fired upon them, fatally wounding the father while injuring the son. CCTV footage captured the struggle, showing Kashif trying to defend them and firing back at the robbers, hitting one of them in the back.

Authorities later apprehended one of the suspects, identified as Imtiaz Ahmed, who had sustained a gunshot wound during the incident. Police recovered the stolen amount of Rs 300,000. Witnesses also reported that some bystanders managed to seize additional cash during the chaos.

## ADB Predicts IMF-Backed Reforms Will Lift Pakistan's Growth To 2.8% In FY25

ISLAMABAD: The International Monetary Fund (IMF)-backed reform agenda is expected to boost Pakistan's economic growth in fiscal year 2025 (FY25), according to the Asian Development Bank's (ADB) Asian Development Outlook September 2024 report.

The Manila-based lender projects a moderate growth rate of 2.8% for Pakistan in FY25, driven by the 37-month Extended Fund Facility (EFF) agreement between Pakistan and the IMF.

The ADB reported that growth in Pakistan rebounded to 2.4% in FY2024, while inflation was lower than anticipated.

Inflation has seen a significant decline, averaging 23.4% in FY 2024, down from 29.2% the previous year.

This economic improvement was attributed to fiscal discipline, a market-driven exchange rate, and enhanced efficiency in the energy sector.

Furthermore, increased agricultural income and higher remittances supported private consumption, while improved crop production helped control food prices.

The ADB also highlighted that the IMF-supported re-



form programs is expected to create a more stable macroeconomic environment, promoting economic activity.

Private investment is forecasted to rebound due to better macroeconomic conditions, including easier access to foreign exchange, which will benefit the manufacturing and services sectors.

However, the ADB raised concerns about higher personal income tax rates and the government's spending restrictions, which could limit both private and public consumption in FY25.

Additionally, growth in the agricultural sector is expected to slow due to increased gas prices and re-

duced fertiliser subsidies.

The report noted that public debt is expected to decline as a percentage of GDP, though interest payments have reached nearly 60% of fiscal revenues.

Inflation in Pakistan is projected to moderate to 15% in FY25, supported by tighter monetary policies and stable global commodity prices.

Pakistan's current account deficit is anticipated to remain moderate but may rise to 1% of GDP in FY25.

The trade deficit is likely to expand as domestic economic activity recovers, leading to higher imports.

However, higher remittances and improved access to multilateral and bilateral financing

due to the IMF programme will help offset some of the deficit.

Despite a larger current account deficit, international reserves are expected to grow to 2.1 months of import cover by FY25.

The ADB warned that Pakistan's economic outlook remains vulnerable to shortfalls in external financing and potential lapses in policy implementation, which could lead to increased pressure on the exchange rate and worsen debt vulnerabilities.

The report also noted that external risks, including geopolitical tensions, higher food and oil prices, and tighter global financial conditions, could impact Pakistan's macroeconomic stability.

However, improved global financing conditions and lower international food and fuel prices would help reduce fiscal and external vulnerabilities.

Pakistan's economy has shown notable improvement, supported by a combination of economic discipline, increased agricultural income, and remittances from abroad.

These factors have contributed to a steady recovery, with the GDP projected to grow by 2.8% during the

## ₹190 Million Case: Court Offers 'Final Chance' To Lawyer Representing Imran And Bushra Bibi

ISLAMABAD: The accountability court hearing the ₹190 million case, has given a final deadline to the lawyers representing Pakistan Tehreek-e-Insaf (PTI) founding chairman Imran Khan and his wife Bushra Bibi for cross-examination of the National Accountability Bureau (NAB) investigation officer.

The hearing took place at Adiala Jail, where both Imran Khan and Bushra Bibi were present.

The court adjourned the next hearing until Friday due to the absence of Bushra Bibi's lawyer, Usman Gul, who was reported to be suffering from dengue.

The defence requested a delay, explaining that Usman Gul's illness prevented him from attending NAB lawyers, however, pointed out that Bushra Bibi had four lawyers named in the case, and any of them could have conducted the cross-examination.

NAB lawyers argued in court that the defence themselves brought an order from the Islamabad High Court to proceed with the trial. Now, the defence lawyers are deliberately causing delays in the hearing of the reference. The court instructed the defence lawyers that they are being given a 'final opportunity,' and the cross-examination of the NAB investigation officer must be completed in the next hearing. The court, led by Judge Nasir Javed Rana,



granted the defence one final opportunity to cross-examine the NAB officer during the next hearing. The ₹190 million reference hearing was conducted inside Adiala Jail, where the PTI chairman and his wife were presented before the court.

Defence counsel, including Intizar Panjutha, Naem Panjutha, and Faisal Fareed Chaudhry, were present, while the NAB team was represented by Sarin court that the defence themselves brought an order from the Islamabad High Court to proceed with the trial.

On September 18, the Islamabad High Court (IHC) barred the accountability court from delivering a final judgment in the ₹190 million case involving Imran Khan and Bushra Bibi. While the court ordered the trial court to continue the proceedings, it instructed that no final verdict should be issued at this stage. On September 7, Imran Khan had filed an acquittal plea in the case, citing the Supreme Court's ruling on NAB amendments, which reinstated previous legal provisions.

However, the accountability court rejected Imran Khan's plea on September 12, after hearing arguments from all sides during a hearing held at Adiala Jail in Rawalpindi.—RT/Agency

## Court Reserves Judgment On Future Of Toshakhana Vehicles Case Involving Zardari And Nawaz

ISLAMABAD: An accountability court in Islamabad on Wednesday reserved the verdict on whether to refer the Toshakhana reference against President Asif Ali Zardari, former prime minister Nawaz Sharif and Senate Chairman Yusuf Raza Gilani back to the National Accountability Bureau (NAB).

Accountability court Judge Abida Sajjad heard the plea, filed by the anti-graft body, involving the former prime ministers and the incumbent head of state, and reserved the verdict set to be announced on October 14.

The case relates to the 2020 reference filed by NAB against the trio alleging that President Zardari and ex-PM Nawaz obtained vehicles from the Toshakhana by paying 15% of the price of the cars — and all of this was facilitated by Gilani.

During today's hearing, President Zardari's lawyer Farooq H Naek said the said court lacks the authority to hear the case following the NAB amendments and, therefore, it should be referred back to the anti-graft body.

"Earlier such a case was sent back to NAB," said the counsel.

At this, the NAB prosecu-



tor said that when a case does not fall within the jurisdiction of the accountability court, then the merit of the case will not be discussed and the court has to decide if the reference is to be sent back to the NAB.

The case against President Zardari cannot proceed as he has presidential immunity, the prosecutor remarked, adding that the case against him will be referred to the Federal Investigation Agency (FIA).

The NAB official further requested the court to refer Nawaz's case back to the watchdog and maintain the stay order to the extent of the president.

The reference filed by the NAB alleges that President Zardari was gifted luxury cars by the governments of Libya and the United Arab Emirates (UAE), and he used

them instead of submitting them to the Toshakhana.

Meanwhile, Nawaz, as alleged by the anti-corruption watchdog, was given a car from the Toshakhana by the PPP government in 2008 even though he did not hold any official position in the government.

It is pertinent to note that in May this year, the accountability court halted proceedings against President Zardari owing to the immunity enjoyed by the country's head of state. Prior to it, NAB exonerated Nawaz in the said vehicle reference and requested the court to acquit the PML-N president saying that the car in question was not a part of the Toshakhana at the time of purchase by the former prime minister.—RT/Agency

## Shahid Khaqan Calls For CJP Isa To Retire After Completing His Term



MURREE: Former prime minister and Awam Pakistan Party leader Shahid Khaqan Abbasi has called for Chief Justice of Pakistan Qazi Faez Isa to retire after completing his tenure, amidst what he described as political instability and chaos in the country.

Speaking to the media at the Murree Press Club on Wednesday, Abbasi stressed that Pakistan is facing severe political turmoil. "The country is in a state of political instability and unrest. There is no option but to run the country according to the

Constitution," he said. Abbasi criticised the lack of transparency in recent constitutional amendments. "Parliament is unaware of the constitutional amendments being made. Attempts have been made to undermine the Constitution in the dead of night," he remarked, reiterating that Justice Isa should retire after completing his term.

Reflecting on Pakistan's political history, the former premier said, "Every election in Pakistan has been rigged, yet no one has learned any lessons.—RT/Agency

## Irfan Siddiqui: Judiciary Has Never Opposed Martial Law Amid Constitutional Amendment Controversy

ISLAMABAD: Pakistan Muslim League-Nawaz (PML-N) Senator Irfan Siddiqui has criticised the judiciary for failing to stand against martial law, while a heated debate surrounds a recent constitutional amendment.

Speaking at a press conference in Islamabad on Wednesday, Siddiqui questioned the legal basis of recent court decisions, particularly in relation to reserved seats and party defections.

"No member in the case of reserved seats said they wanted to change parties. Under what law can the judiciary tell someone to join another party?" Siddiqui asked, adding, "The judiciary has never stood up against martial law, and now there's an uproar over parliament's constitutional amendment."

He expressed concerns over a recent court ruling that, according to him, created unnecessary complications. "The decision regarding reserved seats has raised many questions. It has made the situation so complex that it seems impossible to resolve."

Siddiqui also criticised the frequent striking down of



laws by the judiciary. "We often hear that certain laws are in conflict with the Constitution, and the judiciary interprets and rules on them. But is it possible for a judiciary bench to make a mistake? What were the reasons behind such errors?" he asked, referring to the Election Act being repeatedly violated in this case. The senator pointed to the constitutional requirement that members join a party within three days. "These people joined the Sunni Ittehad Council within the given time. The Constitution restricts this for five years, but the judiciary breaks this rule and tells the 'birds' to fly out of the cage and join PTI.

How does the judiciary have this authority? If it has been assumed, it has been wrongly done. He further criticised the principle of "complete justice," stating, "No member expressed a desire to switch parties. Under what law can you force them to do so? The judiciary never stood firm against martial law, and now it's challenging parliament's constitutional amendments. We are left wondering which direction to take." Siddiqui concluded by pointing to Article 239 of the Constitution, which states that constitutional amendments cannot be challenged in court.

"This provision has been effectively nullified, and the authority of parliament is being restricted. Due to overreach, constitutional provisions are being paralysed," he said.—RT/Agency

## Shehbaz Attends Bangladesh's 50th Anniversary Of UN Membership

NEW YORK: Prime Minister (PM) Shehbaz Sharif attended a ceremony celebrating Bangladesh's 50 years of United Nations membership at the invitation of Chief Advisor Dr Muhammad Yunus.

Accompanying the Prime Minister Shehbaz Sharif were federal ministers Khawaja Asif, Atta Tarar, Khalid Maqbool Siddiqui, and Special Assistant Tariq Fatemi. Dr Muhammad Yunus warmly welcomed Prime Minister Shehbaz Sharif and the Pakistani delegation.

Both Pakistan and Bangladesh, during the event, agreed to enhance cooperation in various sectors and discussed expanding bilateral relations.

It is pertinent to mention here that Bangladesh officially joined the United Nations on September 17, 1974, becoming the 136th member state. This milestone came after the country gained independence in 1971, following a brutal liberation war.



The relatively young South Asian country, Bangladesh, has made remarkable progress in various sectors, since joining the UN, including human development, economic growth, and social reforms while being a strong advocate for global issues such as climate change, poverty alleviation, and women's empowerment.

Bangladesh's commitment to multilateralism is evident through its active engagement in UN forums and its election to the UN Security Council for terms in 1978-1980 and 2000-2002.

## 'Culture Of Depriving Women Of Inheritance Must End': SC Orders Transfer Of Widow's Inheritance



ISLAMABAD: The Supreme Court of Pakistan has ordered the immediate transfer of a widow's inherited property after 26 years of false litigation. The court imposed a fine of Rs 500,000 on the opposing parties for submitting false testimonies and filing bogus claims in an attempt to deprive the widow of her rightful inheritance. A three-member bench, led by Chief Justice Qazi Faez Isa, ruled on a 456-kanal land dispute in Chakwal. The case had dragged on for years due to false claims and fake witness testimonies produced by the opposing parties.

The court ruled that the fine must be paid within three months, failing which the revenue department will recover the amount from the property. During the proceedings, Chief Justice Isa remarked that a simple inheritance case was made unnecessarily complex, stating, "The culture of depriving women of their inheritance must end." He further added that the parties responsible for providing false testimonies should face legal consequences for their actions. The case involved the widow of Mehrban, who passed away in 1998. His nephews, from his second wife Akser Jan's side, had falsely claimed that the land had been gifted to them. The court's decision brings an end to the decades-long legal battle, with the Chief Justice urging the guilty parties to reflect on their actions, warning them of consequences in both this world and the next.—RT/Agency

## Awais Leghari Emphasizes Need For Energy Reforms

ISLAMABAD: Federal Minister Awais Ahmed Leghari on Wednesday highlighted the need of reforms in energy sector, media reported.

Addressing a gathering Awais Leghari said that the country's power sector faces many problems and required energy reforms.

Energy minister said that Pakistan has reservations with regard to the Independent Power Producers (IPPs).

Leghari said an absence of strategy has been the reason of expensive electricity. "Consumers are bearing the burden of high interest rate and circular debt," he said.

He said EV charging stations will be made across the country, petroleum imports will be decreased.

Energy minister said that 10 power distribution companies will privatize by the end of current year.



10 rupees per unit with reforms adding that the power tariff can be reduced for industries.

Well-informed sources on Tuesday said that the Task Force on IPPs has completed its work.

The owners of four independent power producers (IPPs) set up under the 1994 policy and another, established under the 2002 policy, have been warned of consequences if they won't terminate the power purchase agreements (PPAs) voluntarily, sources said.

The task force has asked the owners of the IPPs to end capacity charges payment and charge against the power supplied to the government only. The Independent Power Producer owners have also been warned of forensic audit if they continue to go with the present PPAs, the sources said.

Earlier on September 22, the government sources made startling disclosures about the negative role of some of the country's IPPs that have damaged the national economy.—RT/Agency
