PM Shehbaz Urges UN To Sanction Israel, Stop 'Genocidal War' In Gaza

NEW YORK: Prime Minister Shehbaz Sharif called on the United Nations Security Council to end Israel's "genocidal war" against Palestine and impose sanctions, during the "Leadership for Peace" debate. "We must compel Israel to halt its genocidal war in Gaza and prevent its attempt to provoke a wider conflict in the Middle East," he stated. "It is time to consider sanctions against Israel, including an arms and trade embargo." He maintained that holding Israel's leadership accountable for crimes against Palestinians is necessary. Sharif urged the Security Council to craft an impartial ceasefire plan and a peaceful solution to the Ukraine war, emphasizing the need to avoid further escalation. The conflict, sparked by a Hamas attack on October 7, 2023 in response to deteriorating conditions for



Palestinians, has since claimed over 43,000 lives, including women and children, according to Palestinian health officials. World bodies, including the International Court of Justice, have condemned Israel's occupation and criticized the war's disproportionate civilian casualties, especially those in hospitals and residential areas. PM Shehbaz also brought attention to the ongoing situation in Indian Illegally Occupied Jammu and Kashmir, saying, "The Council must call for a halt to the massive violations of the fundamental rights of the Kashmiri people and implement its resolutions that demand a plebiscite for self-determination in Kashmir." He also raised concerns over regional security, particularly the resurgence of terrorism in Afghanistan, mentioning Da'ish and Tehreek-e-Taliban Pakistan, and called for a global commitment to reverse the arms race, reaffirming Pakistan's cooperation.—RT/Agency

ECP Seeks Supreme Court's Guidance After Prolonged Deliberations On Reserved Seats Dilemma

ISLAMABAD: The Election Commission of Pakistan (ECP) has once again approached the Supreme Court to seek its guidance whether to follow amended Election Act 2017 or its judgment on the matter of allocating reserved seats to the Pakistan Tehreek-e-Insaf (PTI). In its plea on Thursday, the top electoral authority mentioned the National Assembly Speaker Ayaz Sadiq's letter stating that amendments were made to the Election Act after the top court's verdict declaring the opposition party eligible for the reserved seats. It is worth mentioning here that Speaker Sadiq had told the ECP in his letter that the apex court's July 12 ruling was "incapable of implementation" after the amendments to Election Act 2017. The ECP sought SC's advice on whether to prioritise the amended Election Act or the detailed verdict to resolve



the reserved seats' row. It also informed the SC that denotified lawmakers had also approached to seek implementation of the amended law and the ECP implemented the court order to the extent of 39 Members of the National Assembly (MNAs). The amended act has been applied retroactively with modified laws relating to reserved seats, the ECP stated. It added that the court gave clear verdicts that parliament's wisdom could not be reviewed, therefore, it would be a question mark if the Election Act is not implemented in view of the court orders. In his last week's correspondence, the NA speaker urged the ECP to maintain the supremacy of parliament by allocating reserved seats in accordance with the Election Act Amendment Bill. He pointed out two "particular provisions"—amendments to Section 66 and Section 104-A, which he said, were relevant for the ECP's consideration. In its amendment to Section

66 of the Elections Act, the bill says that if a candidate does not submit a declaration of his affiliation with a political party to the returning officer (RO) before seeking allotment of the election symbol, they shall be "deemed to be considered as an independent candidate and not a candidate of any political party". Meanwhile, the amendment to Section 104 reads that the declaration, consent or affidavit, by whatever name called, of an independent returned candidate once given for joining a political party shall be irrevocable and cannot be substituted or withdrawn. "As the SC judgement was rendered based on the law prior to the enactment of the amendment, the said judgment is now incapable of implementation," it said, noting that it is the amended Election Act that shall prevail and supersede the prior ruling. Following his letter, Sadiq had also changed party position in the lower house of the parliament in which 80 PTI MNAs were shown as Sami Iftikhar Council (SIC) members. The ECP, after submitting a fresh petition in the apex court today, detailed that it took steps after days-long deliberation on the SC's detailed verdict and the Election Act amendments related to the reserved seats. A review has been filed on a few points in the Supreme Court's detailed verdict, according to a declaration issued by the ECP, adding that additional grounds were added to the previous review plea. It stated that a Civil Miscellaneous Application (CMA) was submitted to seek guidance on whether to implement the reserved seats' allocation formula in light of the amended law or the top court's judgment.—RT/Agency

New Toshakhana Case: Imran And Bushra Bibi To Face Indictment On October 2

RAWALPINDI: Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan and his spouse Bushra Bibi will be indicted in the new Toshakhana reference on October 2, it emerged on Thursday. The proceedings of the new Toshakhana reference started last week after the National Accountability Bureau (NAB) was barred from pursuing the matter and the case was transferred to the Federal Investigation Agency (FIA) in line with the Supreme Court's verdict restoring amendments to the anti-corruption laws. The deposed prime minister has been imprisoned for almost a year upon his conviction in four cases — two Toshakhana references, the cipher case, and the Iddat case, in which his wife is also incarcerated. The new Toshakhana reference against the couple came to the fore after NAB arrested them shortly after a district and sessions court in Islamabad acquitted Khan and Bushra in the Iddat case



— also known as the Islamic nikah case which was the last hurdle in the couple's release from jail. Meanwhile, Imran and Bushra came to the rostrum Arjumand heard the post-arrest bail applications of the party founder and his spouse, who were brought to a makeshift court in Adiala prison. During the hearing, defence lawyers completed their arguments on the applications while the prosecution sought more time in this regard — a demand which drew strong opposition. Security Forces Neutralize 8 Terrorists In North Waziristan Operation



RAWALPINDI: At least eight terrorists have been killed after the security forces conducted an intelligence based operation (IBO) in general area Razmak of the North Waziristan District, the Inter-Services Public Relations (ISPR) said on Thursday. According to the military's media wing, the operation was conducted on the "reported presence" of terrorists on the night between September 25 and 26. "During conduct of the operation, intense fire exchange took place between own troops and Khawarij, as a result of which, eight Khawarij were sent to hell," read the statement. The ISPR added that the security forces also recovered weapons and ammunition from the killed terrorists, who remained actively involved in terrorist activities against security forces as well as target killing of innocent civilians. "Sanitisation of the area is being carried out to eliminate any other Khawarij found in the area as security forces are determined to wipe-out the menace of terrorism from the country," the media wing added.—RT/Agency

Info Minister Optimistic About Pakistan Joining Growing Economies As IMF Deal Concludes



ISLAMABAD: After the International Monetary Fund (IMF) approved a \$7 billion Extended Fund Facility (EFF) for Pakistan, Minister for Information and Broadcasting Attaulah Tarar said efforts for economic rehabilitation were underway alongside further steps for country to join world's growing economies. Tarar, while addressing a presser in New York, said the world was acknowledging Pakistan's efforts towards economic recovery. "Government's prudent policies are yielding positive results in the form of decline in inflation and stability in prices of daily commodities. Reforms are being implemented to augment economic growth and provide relief to people," said the minister. Tarar's remarks, highlighting other measures taken by the government with regards to the country's economy, came after the Washington-based lender sealed the deal with Islamabad, approving Pakistan's loan with its first tranche of \$1.1 billion likely to be released by September 30, 2024. The interest rate on the loan is less than 5%, sources

in the Ministry of Finance said, adding the IMF may disburse the second instalment within this fiscal year. Meanwhile, Tarar claimed that all economic indicators in Pakistan are positive and the rate of inflation has slowed down. Statements he added, about the drop in inflation were not imaginary, as prices of petroleum products and edible items had slumped significantly during the last few months. "The government launched a crackdown on illegal money exchanges and prevented dollar smuggling," he said. Tarar acknowledged that a big chunk of the country's revenue was generated from Karachi, therefore, justice (in terms of expenditures) should be served to the metropolis. Prime Minister Shehbaz Sharif, he said, highlighted the effects of the climate changes, which inflicted a loss of more than 30 billion dollars across the globe. The countries that emitted the most carbon had the resources in abundance, he maintained. Senior Provincial Minister Mariyum Aurangzeb on September 15 praised the premier for bringing economic stability to the country. She had noted that the historic reduction in inflation from 38% to 9.6% was nothing short of a miracle. "The decrease in the interest rate (policy rate) from 22% to 17.5% is proof of successful economic policies," she had said.—RT/Agency

Donald Lu Commends Strengthening Ties With Shahbaz Sharif's Government

NEW YORK: The United States is enjoying a stronger relationship with Pakistan under Prime Minister Shehbaz Sharif's government, according to Donald Lu, US Assistant Secretary of State for South and Central Asia. In an interview with a local private media channel, Lu expressed optimism over Pakistan's economic recovery and ongoing reforms. "We are greatly encouraged by the economic recovery Pakistan is undergoing," Lu remarked during the interview, following his recent meeting with Pakistan's Finance Minister, Aurangzeb, at the World Bank headquarters. They discussed Pakistan's economic reforms, which Lu described as essential for its future. "These reforms are not easy, but they are crucial for Pakistan's long-term stability," he said, adding that their successful implementa-



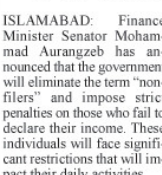

NEW YORK: Prime Minister Muhammad Shehbaz Sharif on Thursday reaffirmed the government's commitment to achieving Pakistan's development goals, aligned with Vision 2025 and the United Nations Sustainable Development Goals (SDGs). The prime minister was talking to President of the World Bank Ajaypal Singh Banga in a bilateral meeting on the sidelines of the UNGA in New York. Finance Minister Muhammad Aurangzeb was also present in the meeting. During the meeting, the prime minister appreciated the World Bank's continuous support to the Government of Pakistan in introducing criti-

Pakistan To Abolish 'Non-Filer' Status, Introduce Strict Penalties For Tax Evaders: Aurangzeb



ISLAMABAD: Finance Minister Senator Muhammad Aurangzeb has announced that the government will eliminate the term "non-filers" and impose strict penalties on those who fail to declare their income. These individuals will face significant restrictions that will impact their daily activities. In an interview with VOA on Thursday, the minister stated that the government has gathered extensive data on non-filers, including their lifestyles, vehicle ownership, and international travel. "We are now at a point where we cannot afford leniency. Those who hide their income and evade taxes will be restricted from many essential services," Aurangzeb said. He highlighted plans to reduce the tax burden on salaried individuals, while expanding the tax net to uncovered sectors like retail, wholesale, agriculture, and real estate. "We aim to ease the load on the working class while ensuring that previ-

ously untaxed sectors contribute their fair share," he explained. When asked about the IMF's concerns regarding debt repayment, the finance minister said the government had presented a comprehensive economic reform plan. "We had no choice but to implement these reforms, and we will also bring all uncovered groups into the system," Aurangzeb noted that despite a 29% increase in tax revenues last year, the tax-to-GDP ratio remained at 9%, a figure too low to stabilise the economy. He credited support from China and Saudi Arabia for securing \$7 billion in IMF loan and emphasised that large-scale reforms are necessary if Pakistan hopes to avoid future IMF programmes. "Pakistan cannot sustain its economy on such a low tax-to-GDP ratio if we wish this to be the last IMF programme, we have to bring large-scale reforms for long-term economic stability," he added.—RT/Agency

Protests continue for kidnapped shopkeeper Saddam Bhatti's recovery

THUL: In Thul, relatives and political party leaders including Waseem Qureshi, Liaquat Sarki, Sultan Bhatti, and Babu Bhatti staged a protest at Rahbar Chowk for the recovery of shopkeeper Saddam Bhatti, who was abducted over a month and a half ago from the jurisdiction of Garhi Hassan police.



The protesters set up a hunger strike camp in front of the press club, which is now in its fifth day. The demonstrators stated that it has been 54 days since Saddam Bhatti was kidnapped, yet Garhi Hassan police have failed to secure his release. They expressed that the family of the kidnapped man is in despair, as the abductors have demanded a ransom of one crore rupees and threatened to kill him if not paid. The protesters accused the police of not taking the situation seriously and claimed that the elected representatives have not supported this poor family's plea for help. They emphasized that Saddam Bhatti, a daily wage earner, has not been rescued by the police despite the passage of time, labeling it a failure on the part of law enforcement. The protesters urged the authorities to ensure the immediate recovery of Saddam Bhatti without further delay.

Muhammad Farooq Shaikhani urges to extend deadline for filing income tax returns

HYDERABAD: President, Hyderabad Chamber of Small Traders and Small Industry, Muhammad Farooq Shaikhani, has urged the Government of Pakistan to immediately extend the deadline for filing income tax returns, which is currently set for September 30, 2024. He highlighted the severe challenges faced by the business community in submitting their returns on time due to the current economic conditions and disruptions in business activities.



Shaikhani highlighted that rising inflation, record-high electricity prices, and the increasing burden of taxes over the past years have placed immense pressure on traders. In such circumstances, not extending the deadline for filing returns would be unfair to the business community. He further added that in the midst of the ongoing economic crisis, where the

business community is already struggling financially, enforcing strict deadlines from the Federal Board of Revenue (FBR) could further exacerbate the situation.

At this moment, he also urged traders to file their annual returns as soon as possible and play their part in strengthening the national economy. Chamber President Farooq Shaikhani stated that offering traders some respite in these tough times would not only support business activities but also reflect business-friendly policies, which are essential for the growth of the national economy.

Shaikhani appealed to the Prime Minister of Pakistan Mian Shabbaz Sharif, the Minister of Finance Muhammad Aurangzeb and the Chairman of FBR, Rashid Mehmood Langrial, to consider the difficulties faced by traders and to announce at least a one-month extension for filing income tax returns. This extension would provide relief to those traders who have been unable to file their returns so far, allowing them to fulfill their legal obligations. He pointed out that such a step would also encourage more people to enter the tax net, benefiting the national exchequer. Moreover, Shaikhani referred to the recent disagreements between the FBR and the business community over tax collection matters. The traders argue that the government's implementation of tax laws without any relief is creating further hardships for them.

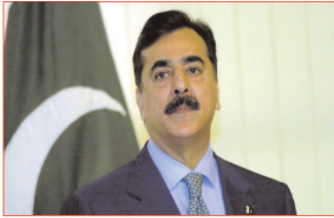

Pakistani Conjoined Twins Successfully Separated In Turkiye

ISLAMABAD: Pakistani twins who were joined at the head have been successfully separated with the help of a team of medical professionals led by Kashmiri-British neurosurgeon Owase Jeelani in Turkiye.



11-month-old Mirha and Minal underwent a couple of operations lasting around 14 hours at Bilkent City Hospital in the Turkish capital city of Ankara.

The twin girls were taken to Turkiye in May this year after Turkish President Recep Tayyip Erdogan assured to help the family, who was unable to get the suitable treatment in Pakistan.

President Erdogan was contacted by the London-based pediatric neurosur-

geon Jeelani for assistance in the case.

The separation was done in two stages under the supervision of the surgical team led by Dr. Jeelani, along with Turkish physicians Dr. Harun Demirci and Dr. Hasan Murat Ergani.

The final 14-hour surgery was conducted on July 19,

successfully separating the twins. The successful surgery demonstrates the brotherly relations between the two Islamic countries besides sending a message globally that nations should prioritise collaboration in goodwill efforts to overcome challenges.—RT/Agency

Fawad Chaudhry Acquitted In ECP Contempt Case

ISLAMABAD: The District and Sessions Court in Islamabad has acquitted former federal minister Fawad Chaudhry, in the Election Commission of Pakistan (ECP) contempt case, media reported.

As per details, the case was filed against Fawad Chaudhry for allegedly using derogatory language

against the ECP during a press conference in Lahore.

The counsel told the court that the press conference was held in Lahore however the case was registered in Islamabad.

The court ruled in favor of Fawad Chaudhry, acquitting him of the con-

tempt charges. It is important to note here that PTI founder and former federal minister Fawad Chaudhry were indicted in the ECP contempt case on Jan 3, 2024.

During the hearing, the accused in the case were formally charged through a read-aloud indictment.—RT/Agency

PTM Accused Of Using Afghan Refugees For Anti-Pakistan Protests

ISLAMABAD: The Pash-tun Tahafuz Movement (PTM) has allegedly been using Afghan refugees to organise protests against Pakistan.



According to reports, PTM's leadership abroad, including Afghan demonstrators, has been coordinating anti-Pakistan protests.

Some Afghan individuals with clear pro-Indian leanings are said to be promoting PTM's propaganda in Western countries.

Abdul Rehman Hanif, recently appointed as PTM's Nebraska State Coordinator in the USA, is a former member of the Afghan military and has openly expressed admiration for India and Hin-

duism. This suggests PTM's connections with both Afghanistan and India.

Similarly, Sharifullah Sharafat, an Afghan national based in Virginia, USA, has been appointed as PTM's State Coordinator for Maryland-Virginia. Recently, Afghan individuals, allegedly incited

by hostile forces, participated in an attack on Pakistan's embassy in Germany.

These Afghan nationals are believed to be following PTM's agenda, which is viewed as a foreign-backed proxy aimed at creating division rather than addressing legitimate concerns.—RT/Agency

Powerful Blast At Swabi Police Station Claims One Life, Injures 16



PESHAWAR: At least one person was killed and another 16 injured, including police officers on duty, after a powerful explosion rocked the Swabi City police station in Khyber-Pakhtunkhwa on Thursday, causing the building to collapse, local authorities confirmed.

The blast occurred in the station's storage room, where explosive materials seized from terrorists were reportedly being kept. According to initial reports, the explosion was triggered by a short circuit, which caused multiple detonations.

District Police Officer (DPO) Swabi said investigations are underway to determine the exact nature of the blast. "The explosion has severely damaged the building, and rescue teams are on the ground," he stated. Rescue workers and fire brigade personnel quickly reached the scene, transferring the injured to nearby hospitals, including the Bacha Khan Medical Complex, where an emergency has been declared.

A hospital spokesperson confirmed that eight injured have been admitted so far, with two in critical condition. "All necessary medical care is being provided, and the hospital administration is closely monitoring the situation," the spokesperson added. Bomb disposal squads have been called in to ensure the area is safe and assess the remaining risks.—RT/Agency

Neptra Hearing Raises Concerns Over Declining Power Consumption

ISLAMABAD: The Central Power Purchasing Agency (CPPA) informed in the NEPRA hearing that 12.75 billion power units were sold in August this year.



The National Electric Power Regulatory Authority was hearing an application on the Fuel Adjustment Charges for the month of August. The CPPA said that the power consumption was decreased by 20 percent in August and called the reduction in industries' power consumption as alarming. Member Neptra Rafiq Shaikh

said that the consumption has dropped in industries and agriculture sector. "Hike in power tariff has been one of the reasons for reduced consumption," he said. Chairman Neptra said the au-

thority has concern over decrease in the power consumption. "The industries are being shutdown owing to which the power demand is decreasing," Neptra member said.—RT/Agency

Two Killed In Shooting Outside Islamabad Judicial Complex

This is not the first such incident of violence inside courts nationwide as recently in Lahore, two people facing murder charges were shot dead outside a sessions court in Lahore.—RT/Agency

FO Unaware Of Diplomats' Visit To Swat: Baloch

ISLAMABAD: In a startling revelation, the foreign office on Thursday disclosed that it was not aware of the recent visit of about a dozen ambassadors to Swat where they narrowly escaped a terrorist attack.



At least one police official part of the security squad was martyred when an explosion hit the vehicle leading the diplomats on the way to Malam Jaba earlier this week. All foreign ambassadors, who attended an

event organised by the chamber of commerce, were unharmed and returned to Islamabad safely.

No group claimed responsibility for the attack.

However, the incident raised serious questions about the security arrangements. The Khyber-Pakhtunkhwa government claimed it was not informed about the visit of foreign diplomats to the region which was once a hotbed of terrorism.

On Thursday, Foreign Office Spokesperson Mumtaz Zahra Baloch was asked a series of questions about the incident, protocols and the role of the foreign ministry.—RT/Agency

Gujranwala Police Intensify Anti-Narcotics Operations Under CM Maryam's Directive

GUJRANWALA: In alignment with Chief Minister Maryam Nawaz Sharif's vision for a drug-free Punjab, targeted anti-narcotics operations are being intensified across various districts, including Gujrat. Under the supervision of IG Punjab Dr. Usman Anwar and DPO Mustansar Bajwa, the police have conducted a total of 80,910 raids on drug dealers' hideouts this year.

The operations have led to the arrest of 44,830 suspects involved in drug trafficking and

Additionally, 1,240 individuals suffering from addiction have been admitted to rehabilitation centers. Robbers Loot Goods Transport Warehouse

TOBA TEK SINGH: Unknown armed robbers broke the locks and chains of a local goods transport warehouse and escaped after looting dinner sets, lentils, and other items worth millions of rupees. It has been learned that Malik Muhammad Younis of Chak No. 298 JB had set up a warehouse for a goods transport company near the PASCO warehouse on Toba Road. Early last night, Malik Muhammad Younis loaded a truck loaded with goods from various cities for different shopkeepers and locked up the warehouse before going home. During this time, three unidentified armed robbers broke into the warehouse, stealing 24

expensive dinner sets, several sacks of lentils, and other goods, loading them onto a loader rickshaw, and fleeing the scene. The stolen goods are estimated to be worth over 450,000 rupees.

Notably, one of the robbers was allegedly carrying a wireless set and stopped two motorcyclists passing by, impersonating a police officer. He searched them under the

pretense of checking and snatched thousands of rupees in cash and mobile phones before escaping. So far, the City Police Station, after some delay, has registered a case of theft from the goods transport warehouse. The public has expressed concern over the increasing incidents of theft, robbery, and snatching within the limits of the City Police Station.

Welcoming Pakistan's Last IMF Deal

Pakistan's recent approval of a \$7 billion loan agreement from the International Monetary Fund (IMF) marks a crucial turning point in the country's economic history. Supported by "significant financing assurances" from China, Saudi Arabia, and the UAE, this deal offers a temporary respite from the immediate financial crisis. The backing from these key allies goes beyond simply rolling over \$12 billion in loans, signaling strong international confidence in Pakistan's economic potential. However, the larger question remains—will this finally be Pakistan's last IMF bailout?

Prime Minister Shehbaz Sharif's commit-

ment to making this the last IMF program for Pakistan brings hope to a nation weary of decades of dependency on international finan-



cial aid. This is Pakistan's 23rd IMF program since 1958, an alarming number that reflects deep-seated economic issues that need urgent resolution. The new agreement calls for "sound policies and reforms" to stabilize the economy, and the Pakistani government must not only follow through but also take bold, long-term steps to strengthen macroeconomic

stability.

While this deal offers a necessary lifeline, it is critical that Pakistan breaks the cycle of recurring financial crises. Economic reforms must focus on promoting sustainable growth, reducing fiscal deficits, and diversifying the country's economy. The international backing provides a platform for rebuilding, but the responsibility now falls on the leadership to ensure this opportunity is not wasted. If Pakistan follows through on the Prime Minister's promise, this could indeed be the last IMF deal, providing a pathway toward self-reliance and economic independence. Now is the time to make that promise a reality.

Chlorine gas leak at WASA Filter Plant leaves 25 children unconscious

HYDERABAD: In the Khurshid Town area near the Panjari Police Station, a chlorine gas leak from the WASA filter plant caused widespread panic, leading to 25 children fainting due to inhalation. According to doctors, three of the children are in critical condition.

Local residents evacuated the area as Rescue 1122 teams arrived to initiate cooling operations. The Medical Superintendent of the Civil Hospital reported that 25 unconscious and semi-conscious children

have been admitted for treatment, with efforts being made by the civil administration and doctors to ensure their recovery. Some children's health remains critical.

MD WASA Zahir Khamtio, discussing the incident, confirmed that a chlorine gas cylinder at the filter plant had leaked. He speculated that unknown individuals may have attempted to steal the cylinder, but he had no prior knowledge of the leak. He added that the leak has now been sealed. They highlighted that covers for manholes, procured years ago, were sourced from pre-

ferred contractors who provided substandard products. Calls for proper inspections of these contracts were made, suggesting that many underlying issues would come to light.

WASA sources indicated that while this incident occurred in the pumping area, similar chlorine cylinders are present at every water pumping station, raising concerns about potential leaks elsewhere. They emphasized the importance of testing chlorine cylinders upon purchase, asserting that the favoritism in contract awards has led to these safety oversights.

Farmers warn of strong protests against rice mills and traders

SUJAWAL: In Sujawal district, farmers are deeply troubled by rice mills and traders lowering the prices of paddy after the harvest. According to reports, the paddy harvest has begun in various towns of Sujawal, where rice mill owners and traders have set their preferred prices, causing difficulties for the farmers.

Farmers Abdul Ghafoor Palipot, Raees Shaukhat Ali Laghari, Syed

Abdullah Shah, Raees Amin Chang, Raees Manzoor Ali Laghari, Azeem Lund, Maqbool Ali, and others spoke to journalists, stating that after the paddy harvest, the rice mill owners and traders have established a monopoly by lowering prices. They reported that before the harvest, paddy was selling for 3,750 rupees per mound and 75,000 rupees per acre, but now that the crop has entered the market, the price has dropped to 2,800 rupees per mound

and 56,000 rupees per acre, which they describe as outright injustice. The farmers also mentioned that recent rains have severely damaged the crops, causing standing water in the fields, which has adversely affected the harvest. They called on the Sindh government and higher authorities to take strict action against the rice mills and traders, demanding fair prices, or else they will announce strong protests.

Asim Khan triumphed over Yahya Al-Nawasani with scores of 11-7, 4-11, 11-6, 7-11, and 11-7. This impressive victory has secured Asim a place in the tournament's quarter-finals.

Meanwhile, another Pakistani player, Ashab Irfan, was knocked out in the second round by Egypt's seventh seed Ibrahim Al-Kabbani. Ashab suffered defeat with scores of 11-7, 7-11, 4-11, and 4-11. This victory marks Asim Khan's third PSA title of the year and the 10th of his career. Earlier in 2024, Asim had already clinched two titles, winning the Wild Card Challenger in Washington and the Squash Inspire Challenger in March.—Agency

England captain Stokes 'on track' to play Pakistan Tests

LONDON: England Test captain Ben Stokes on Thursday, has been given a green signal to participate in the three-match Test series against Pakistan, scheduled to commence on October 7.

The all-rounder has been out of action since suffering a hamstring injury while playing for the Northern Superchargers in The Hundred 2024.

Stokes underwent scans on Wednesday, which indicated that he is 'on track' to attain match fitness for the upcoming series against Pakistan.

"The results of the scans were positive and confirmed that his recovery, since sustaining the injury six-and-a-half weeks ago, remains on



track to participate in the upcoming Test series against Pakistan," an England and Wales Cricket Board (ECB) statement said.

England are set to depart for Pakistan on October 1 with the opening Test scheduled to begin on October 7.

Despite being on track to participate in the upcoming series, there are some doubts about whether Ben Stokes would be able to bowl.

"I think that's you getting ahead of yourself. Obviously I've been six-and-a-half weeks now of just walking and doing stuff in the gym," said Stokes in response to a question regarding the chances of him bowling in the Pakistan Tests.

"There's a lot more than just my hamstring that I need to get back firing and working up again in terms of bowling, because you use everything, so I need to get that all right to make sure I don't do any damage to other parts of my body," he added.

The three-match Test series between Pakistan and England, part of the ICC World Test Championship (WTC), will run from October 7 to 28 with matches scheduled in Multan and Rawalpindi.

For the unversed, this will be England's second tour of Pakistan in two years. They won the last Test series 3-0 in December 2022.—Agency

Under-fire Bangladesh ex-skipper Shakib announces retirement



KANPUR: Bangladesh ex-captain Shakib Al Hasan, facing prosecution for his relationship with the country's former leader, said on Thursday he would soon retire from international cricket but hoped to play at least one more match back home first.

Shakib is facing murder charges along with dozens of other members of ex-premier Sheikh Hasina's party who have been accused of culpability in a deadly police crackdown on protesters.

The 37-year-old, who briefly served as a lawmaker under Hasina this year, has not returned to Bangladesh since the toppling of her government last month in a student-led revolution.

Shakib said that next year's Champions Trophy in Pakistan would be his last international outing.

But he added that he wanted to return home for a slated two-Test series against South Africa, and had asked the Bangladesh Cricket Board if he could come back.

"It's my desire, I have said this to BCB and the selectors," Shakib told reporters ahead of Friday's second Test against India in Kanpur.

"They agreed with me, that they are trying to organize everything if possible, so that I can go back to Bangladesh, play those two Test matches in Mirpur and finish my Test career there."

He added: "If that doesn't happen maybe this is my last one."

The South Africa tour due to start on October 21 is still under a cloud, with the Proteas assessing whether Bangladesh is safe enough after last month's revolution. Shakib told reporters ahead of Friday's second Test against India in Kanpur that he did not "want to talk much" about the criminal proceedings against him. "You all know what type of case it is, and where I was and what I was doing at that time," he said. Shakib was playing in a domestic Twenty20 cricket competition in Canada during the unrest that ousted Hasina.—Agency

Red-ball coach Jason Gillespie stresses importance of showing faith in cricketers

FAISALABAD: Pakistan's red-ball cricket team head coach Jason Gillespie has emphasized on the importance of giving confidence and showing faith in existing group of cricketers.

"We picked a squad which is not too dissimilar to what we had against Bangladesh. I'm really keen to show our faith and belief in our players," said Gillespie.

The head coach also discussed a range of topics, from player development to fitness challenges and the lessons he has learned so far while speaking during commentary at the Champions Cup match between Lions and Stallions on Wednesday.

"We don't want to have knee-jerk reactions after every bad game or a result that hasn't gone our way. We want to show the faith and belief in these players be-



cause they're very good players, and we showed glimpses of good cricket in both the first and second Test against Bangladesh in Pindi," Gillespie said.

However, the head coach recognized the need for greater consistency. "We just need to do it a little bit more consistently," he added, stressing that maintaining trust in the players could help them achieve the desired results.

Gillespie - who also

ting to know the players, the support staff, and everyone within Pakistan cricket has been fantastic."

Gillespie, himself a renowned fast bowler, also acknowledged the importance of fitness in Test cricket.

"Fitness has been well-documented in the press. That's certainly something, as far as I'm concerned, and having spoken to Gary Kirsten, is controllable. It's something that we can control. We can continue to develop and work on that because, as we know, Test cricket is a challenge," Gillespie remarked.

One player who has caught the eye of the cricketing community is Kamran Ghulam, who has been in outstanding form in the Champions Cup, scoring two centuries.—Agency

FBR Dismisses Mini-Budget Rumors, Confident In Meeting Revenue Targets Despite Hurdles

ISLAMABAD: The Federal Board of Revenue (FBR) ruled out the mini-budget, asserting confidence in meeting its revenue targets despite the challenges ahead, media reported Thursday.



Earlier, the tax-collecting authority was poised to introduce a mini-budget with an aim to generate around Rs650 billion in revenue primarily by cracking down on tax evaders and increasing general sales tax (GST) on properties, tractors and other items.

During a meeting of Senate Standing Committee on Finance and Revenue, chaired by Senator Saleem Mandviwalla, FBR Member Policy Hamid Ateeq Sarwar acknowledged the difficulty of reaching the tax target

challenges, Sarwar announced plans to hire 4,000 auditors and integrate an additional 2 million traders into the tax net. He emphasized that "there are no new tax measures under consideration." The FBR is also focused on bringing wholesale markets into the tax system, despite ongoing difficulties in this area.—RT/Agency

Umerkot Blasphemy Suspect Killed In 'Staged' Police Encounter: Sindh Home Minister

KARACHI: Sindh Home Minister Ziaul Hassan Lanjar disclosed on Thursday that a probe committee has concluded that Dr. Shah Nawaz Kunbhar, a blasphemy suspect from Umerkot, was killed in a fabricated police encounter. The minister vowed to take strict action against those involved in the incident.

Dr. Kunbhar, a medical professional, had been charged under Section 295-C of the Pakistan Penal Code by the Umerkot police for allegedly sharing blasphemous content on social media. He was taken into "protective custody" on September 18, and subsequently transferred to Mirpurkhas. However, the following day, he was shot dead by Sindhri police in what was claimed to be an encounter.

Sindhri SHO Niaz Khoso alleged that the doctor, along with his accomplices, fired upon the police, leading to retaliatory action in which Dr. Kunbhar was killed, while one accomplice managed to escape. Following the incident, the doctor's body was handed over to his family, but a mob later re-emerged and set it ablaze.

The alleged encounter sparked widespread public outrage, prompting Sindh Chief Minister Murad Ali Shah to take notice of the incident. As a result, the



DIG and SSP of Mirpurkhas, along with other police officers, were suspended.

At a press conference on Thursday, Home Minister Lanjar revealed that the investigation, led by DIG Pervaiz Chandio of Shaheed Benazirabad, determined the police encounter was staged. He noted that the suspension of such high-ranking officials and the initiation of a thorough probe is an uncommon occurrence.

Lanjar detailed that the 31-page investigation report included analysis of CCTV footage, call data records (CDR), and mobile phone tracking. "Our police officers are implicated in this incident," he stated, adding that an FIR will be filed against them, and the chief minister has been informed of the findings.

Furthermore, the minister confirmed that the DIG and SSP of Mirpurkhas have been suspended, and an FIR will be registered against them. "At least six cases have been filed so far, and no one involved will be spared," he emphasized.

He also mentioned that the suspect's family has been briefed on the ongoing inquiry and urged them to file a case, stating that if they refuse, the state will proceed with filing the FIR. Lanjar clarified that the investigation is focused on the circumstances of the encounter, rather than the blasphemous charges against Dr. Shah Nawaz.

The minister also announced that a new DIG has been appointed, and the inquiry committee, consisting of two SSPs from Umerkot and Shaheed Benazirabad, will continue investigating the FIRs. He assured that after the investigation is complete, Chief Minister Murad Ali Shah will announce compensation for the suspect's family, affirming that no extrajudicial incident will be tolerated.

Sharjeel Calls For Constitutional Courts And Judicial Reform

KARACHI: Sindh Senior Minister Sharjeel Inam Memon reiterated the Pakistan People's Party's (PPP) long-standing demand for the establishment of constitutional courts, a proposal also advocated during the signing of the Charter of Democracy. Speaking to the media after inaugurating the Pakistan Sustainability Week exhibition on alternative energy at the Expo Center in Karachi, Memon emphasized the need for swift and direct justice for the people, noting that the PPP is committed to this cause. He highlighted that justice has often been delayed for decades in Pakistan, citing the unresolved murder case of Shaheed Zulfiqar Ali Bhutto as a tragic example.



Memon criticized former Chief Justices Ifkhar Chaudhry and Saqib Nisar, describing them as a "disgrace" to the judicial system and calling for the revocation of their privileges. He also expressed frustration over the indefinite postponement of the murder case of Shaheed Mohtarma Benazir Bhutto, contrasting it with the judiciary's focus on less critical cases.



Memon affirmed the PPP's respect for the judiciary, stating that despite the hardships the party has faced due to judicial activism, it has never disrespected the courts. He criticized the practice of political figures endorsing judges from jail, referring to recent statements made by the founder of PTL, and called for reforms to ensure the judicial system operates fairly and without bias. During the exhibition, Memon praised the efforts to showcase alternative energy technologies, stressing the importance of reducing reliance on costly conventional energy sources. He noted that over 200 national and international companies participated in the event, which he sees as a positive step towards enhancing trade relations and providing affordable energy solutions to the public. Memon also toured the exhibition, reviewing the modern machinery on display and commending the organizers for their successful event.

Rehan, who holds the position of General Secretary within the PML-N Youth Wing, allegedly drove his Revo vehicle in the wrong direction, striking Athar, a father of two and an employee at Karachi Medical and Dental College (KMDC). Eyewitnesses reported that two women, suspected to be involved in a motorcyclist's head injuries and is currently in a coma, receiving treatment in the ICU at Civil Hospital. Police investigations revealed that Rehan resides with his father, a doctor, in a home owned by a retired DSP of Sindh Police. The accused has been on the run since the incident, with authorities intensifying their search, tracing his last known location to the Drigh Road area—RT/Agency

STEVTA Signs MoU With Avari Hotels International For Hospitality Training

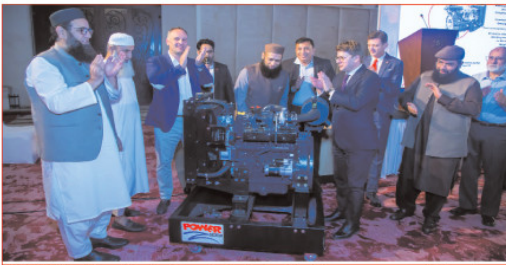

Arshad Pappu Murder Case: Court Informed Of Missing Victim's Wife

KARACHI: The Sindh High Court (SHC) was informed on Thursday that the wife of Arshad Pappu, the complainant in his murder case, has gone missing during a hearing on a bail petition of one of the accused.

The court was considering the bail plea of Zubair Baloch, the brother of Lyari gang leader Zubair Baloch, in connection with the 2013 murder of rival gangster Arshad Pappu and two others.

The government prosecutor revealed that a notice was issued to Arshad Pappu's wife, but it could not be delivered as she had changed her address. The defense lawyer further noted that an investigation officer had reported to the trial court that the complainant could not be located.

The court directed the investigation officer to trace the complainant and adjourned the hearing for three weeks.

Uzair Baloch, former Lyari MNA Shahjahan Baloch, Zakir Dada, Zubair Baloch, Yusuf Baloch, and others have been accused in the triple murder of Arshad Pappu, Yasir Arafat, and Shera Pathan in 2013. The case's FIR was filed at the Kalakot police station in Lyari.

The case has been marred by violence, with a key witness, former police inspector Chand Khan Niazi, being murdered, and another accused, Javed Baloch, also killed on January 14, 2022.—RT/Agency

CJP Isa Explains Removal Of Justice Akhtar From Judges' Committee

ISLAMABAD: In response to senior puisne judge Justice Mansoor Ali Shah's letter raising questions on removing Justice Munib Akhtar from the judges committee, Chief Justice of Pakistan (CJP) Qazi Faez Isa on Thursday gave 11 reasons to justify his action.



He gave 11 reasons for his replacing Justice Akhtar from the body.

The ordinance empowers the chief justice to nominate a judge in the committee that constitutes the benches. As per the ordinance, the body will comprise the chief justice, the most senior judge after the CJP and the judge nominated by Justice Isa.

In his letter, the CJP said legally he could not be asked about why he nominated a judge as the committee's third member, however, "Since I have always advocated accountability and transparency I shall provide reasons why Justice Akhtar has been replaced."

"Let it be remembered that this I do because of your

insistence, lest someone takes umbrage." "The Act [also] stipulates that urgent cases are to be fixed within 14 days but this statutory provision and the constitutional right to seek review was negated by his [Munib Akhtar's] refusal to hear urgent constitutional cases while he was vacationing."

"Disrespecting those who were his seniors (ad hoc judges) and selecting 1,100 specific cases and confining them to hear only those cases, something wholly unprecedented," it stated as additional reasons for removing the senior judge from the committee.

The letter mentioned Justice Akhtar's not allowing ad hoc judges to be part of the Shariat Appellate Bench of the Supreme Court to hear the long pending cases as an-

other reason behind the chief justice's decision.

Giving further reason for his choice of cutting Justice Akhtar from the committee, CJP Isa mentioned the display of his rude and unreasonable behaviour towards a distinguished member of the committee and walking out of the meeting. The said committee comprised all the chief justices, senior puisne judges, and distinguished members of the bar.

The apex court's chief justice also said the bench headed by Justice Akhtar adjudged most of the cases and often finished its work before 11am; a concern expressed by his companion judges.

He also said the senior puisne issued a stay order in the audio leaks case and did not fix it for hearing.

In a letter written to the secretary of the Supreme Court on September 23, Justice Shah raised concern over the judges' committee's re-constitution and Justice Akhtar's removal from the composition of the committee within hours of the promulgation of the ordinance.

Justice Mansoor, in his letter, noted that no reasons were given as to why the second senior-most judge, Jus-

Imran Rejects Raof Hasan's Claims, Says Talks With Establishment Are Futile

ISLAMABAD: Jailed Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan has rebuffed the claims of his party's chief spokesperson that the embattled opposition is ready to hold talks with the establishment.



The former ruling party's spokesperson Raof Hasan had claimed that a dialogue between his party and the establishment is inevitable for which PTI is prepared.

Speaking to journalists at Rawalpindi's Adiala Jail on Thursday, the PTI founder said there is no use in holding talks with the establishment.

The cricketer-turned-politician said that Hasan had some misunderstanding, adding that he gave a clear message after the Islamabad power show that his party would not hold talks with anyone.

Prior to Khan's statement, the PTI spokesperson had told a private television channel that the Imran-founded party was ready for talks with the establishment yesterday and was prepared even today

for this exercise. "It has been PTI's policy that we want to engage with the establishment and I will go a step ahead to say that dialogue between my party and the establishment is inevitable for this state and we must not delay this," Hasan contended.

He advocated the initiation of dialogue so that solutions to the country's problems and challenges could be found and Pakistan taken forward.

He disagreed with the questioner that, currently, the policy of establishment was not to engage with PTI and

added they have engaged with his party and why he should not be hopeful that they would again engage. Hasan, however, maintained that a conducive environment would have to be created for which both sides would have to make efforts.

Earlier this month, Khan had closed his doors to talks with all the parties, including the establishment, signalling a hardened stance amidst an ongoing political turmoil.

He also alleged that the establishment had deceived them, and he was closing the doors to negotiations with all the parties.—RT/Agency

Pakistan Secures Contract To Sell JF-17 Block-III Fighter Jets To Azerbaijan

During deployment, JF-17 carried out air-to-air refuelling from the PAF Multi-Role Tanker Transport (MRTT) aircraft deploying in a single hop to Baku, demonstrating long haul capability and reach of the PAF's fighter jet.

President Aliyev witnessed the static display of JF-17 BLOCK-III and later witnessed its enthralling aerial demonstration, showcasing the agility and manoeuvrability of the fighter jet alongside the professional competence of PAF pilots.

The JF-17 Thunder Block-III is an AESA radar and long-range BVR-equipped 4.5 generation multi-role fighter aircraft capable of undertaking a wide array of combat missions providing contemporary air power employment options, thus strengthening the National Security Paradigm of Azerbaijan.—RT/Agency

PTI Challenges SC Practice And Procedure Ordinance In Supreme Court

ISLAMABAD: The Pakistan Tehreek-e-Insaf (PTI) on Thursday moved the apex court against the Supreme Court (Practice and Procedure) Amendment Ordinance 2024, requesting for it to be declared "unconstitutional".



The constitutional petition, filed by PTI Chairman Barrister Gohar Khan, requested that all the decisions of the Practice Procedure Committee — taken after the approval of the ordinance — should be declared "illegal" and "annulled".

The newly-constituted practice and procedure committee should be suspended from work for as long as the constitutional petition is pending, read the plea. It added that the old committee should be allowed to function during the petition against the ordinance.

The PTI petition has been filed a week after the president and federal government approved the much-debated ordinance.

The federal cabinet adopted the ordinance "through a circulation" after

the Ministry of Law had sent it to the prime minister and cabinet on the night of September 19.

The ordinance said the court bench would look at the cases keeping in view the fundamental human rights and public importance.

As per the ordinance, each case will be heard on its turn otherwise reason will be furnished for its taking out of turn. "Each case and appeal will be recorded and its transcript will be prepared, which will be available to the public," it also stated Gohar's petition — that includes the federation, law ministry and President Asif Ali Zardari as

parties — stated. "... pending the disposal of the titled Constitutional Petition, the operation of the Impugned Ordinance may kindly be suspended.

"Further, the committee purportedly re-constituted pursuant to the Impugned Ordinance may kindly be restrained from constituting benches and fixing any cases before them and the lawfully constituted Committee under Supreme Court (Practice and Procedure) Act, 2023 consisting of the Chief Justice of Pakistan and the two next senior most judges may be allowed to continue functioning."—RT/Agency
