PM Shehbaz Vows Firm Response To Indian Aggression In UN Address

NEW YORK: Prime Minister Shehbaz Sharif has reiterated that Pakistan will give befitting response to Indian aggression as he highlighted the belligerence of the Modi-led government.

The premier made these remarks while addressing the plenary meeting for the UN General Debate at the 79th session of the United Nations General Assembly (UNGA) in New York.

In his 21-minute address, he touched on multiple regional and international issues including Palestine and Kashmir disputes, Ukraine war, climate change, rising poverty and debt burden particularly induced by climate change impacts.

"It is an honour for me to address the United Nations General Assembly for the second time as the prime minister of the country that has always been the proactive member of the UN Assembly," the premier said in his opening remarks.

PM Shehbaz said the Father of our nation, Quaid-e-Azam Muhammad Ali Jinnah, declared in 1947 that, "we stand by the United Nations Charter, and will gladly make, our full contribution, to peace and prosperity, of the world." Pakistan has stood by this commitment unwaveringly.

"Today, we are facing most daunting challenges to the world order — Israel's genocidal war in Gaza, a dan-



gerous conflict in Ukraine, destructive conflicts across Africa and Asia, rising geopolitical tensions resurging terrorism, galloping poverty, stifling debt and a mounting impact of climate change. We feel the chill of a new cold war."

Likening the current situation of Gaza to Indian Illegally Occupied Jammu and Kashmir (IIOJK), the prime minister said that the people of occupied territory 'too' have struggled, for a century, for their freedom, and right to self-determination.

"Instead of moving towards peace, India, has resiled, from its commitments to implement the Security Council resolutions on Kashmir dispute," he said, adding: "These resolutions, mandate a plebiscite, to enable the Kashmiris, to exercise, their fundamental right to self-determination."

Since 5 August 2019, the premier said, India has initiated, unilateral illegal steps, to impose, what it's leaders ominously call, a "Final Solution" for the occupied territory.

"Day in and day out, nine hundred thousand Indian troops, terrorise the people of occupied Kashmir, with draconian measures, including prolonged curfews, extra-judicial killings, and the abduction, of thousands of young Kashmiris."

He added: "At the same time, in a classic settler-colonial project, India is seizing, Kashmiri lands and properties, and settling outsiders, into occupied Jammu and Kashmir, their nefarious design, to transform the Muslim-majority into a minority. This hackneyed tactic, is employed by all occupying powers, but it has always failed. In Jammu and Kashmir too, it shall fail, by Grace of God!"

PM Shehbaz pointed out that the Kashmiri people are "resolute" in rejection of the false Indian identity, that New Delhi, seeks to impose upon them.

Criticising India's policy of brutal coercion and oppression in occupied Kashmir, he said such actions have ensured, that Burhan Wani's legacy, continues to inspire, the struggle and sacrifices, of millions of Kashmiris.

He noted that India was engaged in a massive expansion of its military capabilities which according to him were deployed against Pakistan. "Its war doctrines, envisage a surprise attack and a limited war under, the nu-

clear Overhang."

The prime minister further said that the neighbouring country has spurned Pakistan's proposals for a mutual, "Strategic Restraint Regime".

"Its leadership has often threatened to cross the Line of Control [LoC] and take over Azad Kashmir. Let me state, in no uncertain terms that Pakistan will respond, most decisively, to any Indian aggression," he maintained.

For durable peace, the premier called on India to reverse the unilateral and illegal measures, it has taken since 5 August 2019, and enter into a dialogue "for a peaceful resolution of the Jammu and Kashmir dispute, in accordance with the UN Security Council resolutions, and the wishes of the Kashmiri people"

Meanwhile, PM Shehbaz demanded an immediate end to the ongoing Israeli atrocities in the Gaza, terming it "systematic slaughter" and "bloodshed".

"This is not just a conflict, it is systematic slaughter, of innocent people. An assault on the very essence of human life and dignity. The blood of Gaza's children stains the hands of not just the oppressors, but also of those, who are complicit, in prolonging, this cruel conflict," the premier said while castigating the Israeli actions.

He said humanity was diminished when the endless suffering of Palestinians was ignored. "It is not enough to condemn. We must act now, and demand an immediate end, to this bloodshed. We must remember that the blood and sacrifice of the innocent Palestinians, will never go waste."

The prime minister asked the United Nations to work for a durable peace, through the Two-State solution.

"We must seek a viable, secure, contiguous and sovereign State of Palestine, based on the pre-1967 borders, with Al-Quds Al-Sharif, as its eternal capital," he said and also demanding that Palestine be immediately admitted as a full UN member.

He also pointed out that "in the span of a few days, Israel's unrelenting bombing of Lebanon has killed over 500 people."

"The failure to implement UN resolutions, has emboldened Israel. It threatens to drag the entire Middle East, into a war, whose consequences could be grave and beyond imagination," he added.

Apart from conflicts, PM Shehbaz noted, the 21st Century has brought a cascade of crises, including the reversal of development, and the mounting impact of climate change.

He referred to the devastation caused by climate change-induced floods in Pakistan in 2022 causing \$30 billion in damages despite the country's less than 1% carbon emissions.

"This is unfair in any calculus of global justice. We must uphold the axiom: the polluter must pay," he remarked and called for the fulfillment of commitments made by the developed countries in climate financing to support the achievements of the SDGs and climate goals.

Calling the debt burden on nearly 100 countries a "death trap" impacting their ability to meet the SDGs, he emphasised reforming and aligning the world trade and technology regimes to promote development and global equity.

The prime minister told the global leaders that his government had taken difficult but necessary decisions that had "rescued our economy from collapse, restored macroeconomic stability, controlled fiscal deficits, strengthened our reserves. As a result, inflation has come to a single digit."

He said while prioritising the geo-economics and regional connectivity, the government had launched the second phase of the China-Pakistan Economic Corridor (CPEC), and established the Special Investment Facilitation Council (SIFC) to mobilise investments, in resilient infrastructure, renewable energy, minerals, sustainable agriculture and technology.

The prime minister said that Pakistan had sacrificed around 80,000 lives of soldiers and civilians and suffered economic loss worth \$150 billion in its fight against terrorism.

He reiterated the nation's resolve to counter the new wave of "externally financed and sponsored" terrorism, especially by the Fina al-Khawarij (Tehreek-e-Taliban Pakistan) and its associates.

"Make no mistake, we are determined to eliminate this threat once again, through our comprehensive national effort, Azm-e-Istehkam And, we will work collectively with the international community to combat all forms of terrorism and reform the global counter-terrorism architecture," he reaffirmed.

Coming to Afghanistan, the prime minister said Pakistan desired the earliest possible normalisation of the situation in Afghanistan and joined the UN's appeal for \$3 billion in humanitarian assistance for the Afghan people.

He urged the Afghan interim government to meet international expectations to re-

spect human rights, including the rights of women and girls, promote political neutralisation, and take effective action to neutralise all terrorist groups within Afghanistan, especially those responsible for cross-border terrorism against neighbouring countries. These include ISIL-K (Daesh), the Al-Qaeda-affiliated TTP/Fina al-Khawarij, Majeed Brigade, BLA and others.

Prime Minister Shehbaz said that Islamophobia was manifested, by frequent desecrations of the Holy Quran, attacks on mosques, negative stereotyping of Muslims and acts of discrimination and violence against them. The most alarming manifestation of Islamophobia is the Hindu supremacist agenda in India seeking the subjugation of 200 million Muslims and the obliteration of India's Islamic heritage, he added.

Pakistan and the OIC would work with the UN Secretary-General and his Special Envoy to implement a plan of action to combat this scourge, he assured.

The prime minister also sought an immediate end to the tragic conflict in Ukraine, and its peaceful resolution, besides reaffirming Pakistan's resolve to continue to cooperate with Africa to counter terrorism and resolve regional conflicts, including through its role in UN peacekeeping and peacebuilding in the region. —RT/Agency

He also accused the government of manipulating parliamentary procedures and the Election Commission to serve their agenda, claiming that the political crisis in the country stems from the biased actions of the Election Commission. Despite obstacles, Akram confirmed that PTI will hold a protest at Liaquat Bagh tomorrow, asserting their right to peaceful assembly as a constitutional right.

"Attempts to block our protests will not stop us from exercising our democratic rights," he added. —RT/Agency

He condemned the recent constitutional amendments, calling them "satanic amendments," meant to manipulate the electoral process and secure power for the ruling elite.

Sheikh Waqas Akram, another prominent PTI leader and central spokesperson, repeated Faraz's concerns, accusing the current government of introducing constitutional amendments solely to harm Imran Khan and his party.

"These amendments are aimed at further weakening PTI, but as long as we exist, we will oppose these changes with all our might," Akram said.

The prime minister said this while talking to a delegation of prominent Pakistani American bankers on the sidelines of the 79th UN General Assembly. The delegation comprised high-ranking representatives from prestigious banks including JP Morgan, Natixis Corps & Investments, Sumitomo Mitsui Banking Corp, Goldman Sachs, Citizens Bank, Lazard, Audaud Group.

He informed the delegation about the key initiatives taken by the government to stabilize the economy and attract foreign investment to Pakistan, including broadening



the tax base, enhancing the ease of doing business, and ongoing reforms in the state-owned enterprises.

These steps have resulted in improved economic indicators and upgradation of Pakistan's credit rating by international rating agencies, including Fitch and Moody's.

He also briefed the delegation on the establishment of a Sustainable Finance Framework, which will allow the Government to carry out a green/sustainability bond is-

suance in the international capital markets.

Thanking the prime minister for the opportunity to interact with him, the delegation lauded the government's policies that have been instrumental in achieving the macroeconomic stability in Pakistan. The delegation also expressed a deep interest in cooperating with the government for the development of manufacturing sector, especially SMEs to help bolster the exports. —RT/Agency

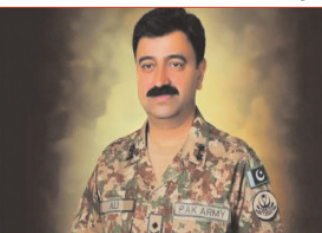

Lt. Gen. Muhammad Ali Appointed As New Defense Secretary

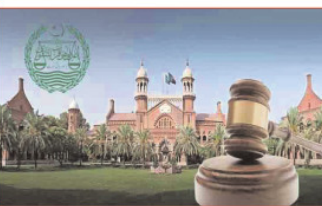

Transferred SAU employees protest for issuance of their withheld salaries

TANDO JAM: In Tando Jam, employees of Sindh Agricultural University staged a protest in front of the university's main gate against the forced transfer to Larkana University and the non-payment of salaries for the past eight months. As the employees attempted to protest outside the Vice Chancellor's secretariat, university security, along with guards and police, stopped them from entering the campus.



The employees remained at the main gate, voicing their grievances over the non-payment of salaries and the forced transfers. They expressed to the media that the university administration violated rules and regulations

by transferring them to Larkana University, and their salaries had been halted as a result. He mentioned that the lack of salary had led to dire economic conditions, affecting their children's education due to the inability to pay school fees. They stated that shopkeepers were refusing to provide goods on credit, leading to food shortages at home. During the protest, an employee's son, Owais Langah, fell ill and was taken to the Rural Health Center for medical assistance. With the Governor Punjab taking a stand against the procedure of the appointment of VCs of Punjab Sector Universities, Chief Minister Punjab Maryam Nawaz has said that they have thoroughly scrutinized the candidates and have chosen the best people for the slot of VCs.

When a summary was sent in contravention of law, so the number of days as required for Provincial legislation cannot be applied in this instance.

Government To Promote Private Sector Utilization Of Gwadar Port

ISLAMABAD: The cabinet has endorsed a suggestion that calls for gradually involving the private sector in import and export of commodities through Gwadar Port.



In a recent meeting, the cabinet also decided that the government would shift 60% of public sector imports and exports from Karachi Port to Gwadar Port to make the latter a fully functional facility.

arrangements to route at least 60% of shipments through Gwadar Port.

It took the decision while considering a proposal for 50% import of goods by the public sector from the deep-sea Gwadar Port.

The cabinet constituted a committee comprising the minister for commerce, minister for maritime affairs, commerce secretary, maritime affairs secretary, railways secretary, Federal Board of Revenue chairman, National Highway Authority chairman and Public Procurement Regulatory Authority managing director.

Sources said that it was decided that at least 60% of all public sector imports of wheat, fertiliser and sugar would be made through Gwadar Port. In addition to these, other commodities procured by public sector entities from overseas markets will also be identified for import through Gwadar Port.

The committee will ensure that 60% of public sector imports of wheat, fertiliser and sugar are made through Gwadar Port.

Meeting participants agreed that all the public sector entities engaged in the export of goods would make

autonomous bodies, to identify those commodities that can be imported through Gwadar Port (in addition to wheat, fertiliser and sugar).

Furthermore, the committee will review the export plans of public sector entities to identify the commodities that can be exported through Gwadar Port and to ensure that at least 60% of the identified commodities are exported through the port. It will identify the road and rail infrastructure that can be used for transporting goods to and from Gwadar Port and will identify the road and rail links that need to be repaired as well as new alignments that should be constructed.—RT/Agency

PTI-Led KP Government Cautiously Welcomes IMF Package Approval

PESHAWAR: Welcoming the International Monetary Fund (IMF) bailout package's approval, Khyber Pakhtunkhwa (KP) Adviser for Finance Muzammil Aslam has said the provincial cabinet has expressed reservations on some points of the deal with the international lender.



Talking to media on Friday, he said the cabinet had directed to seek clarification from the federal government on those points.

The latest bailout, coming to Pakistan in the form of loans, follows a commitment by the government to implement reforms, including a major effort to broaden the country's tax base — a measure reflected in the tax-heavy budget passed earlier this year by the incumbent administration.

The development came after the Executive Board of the Washington-based lender on September 25 approved a \$7 billion Extended Fund Facility (EFF) with the first tranche of \$1.1 billion likely to be released by September 30.

Furthermore, IMF Pakistan Mission Chief Nathan Porter has confirmed that multiple friendly nations have given "significant financing assurances" to Islamabad linked to the bailout package which go beyond the agreement to roll over \$12 billion in bilateral loans owed to these countries.

Sources in the Ministry of Finance have said that the interest rate on the loan is less than 5% and the lender might even disburse the second instalment within this fiscal year.

Family Heading To Saudi Arabia For Begging Arrested At Faisalabad Airport

FAISALABAD: The Federal Investigation Agency (FIA) on Friday arrested a family traveling to Saudi Arabia for 'begging' from Faisalabad airport, media reported. The spokesperson of FIA immigration revealed that the same family was offloaded from Lahore Airport last month. The spokesperson revealed that the arrested individuals — identified as Munawar Hussain and Shafia Bibi, along with their minor daughter — had been traveling

frequently to Iraq, Iran, and Saudi Arabia for the purpose of begging.

According to the Federal Investigation Agency (FIA), the individuals failed to provide legitimate sources of income or satisfactory explanations for the expenses incurred during their multiple foreign trips.

The FIA also noted that the accused had no tax return record in the Federal Board of Revenue (FBR) and lacked a return ticket or hotel

bookings, prompting their transfer to the Anti-Human Trafficking Circle in Faisalabad for further legal proceedings.

It's worth noting that last month, FIA Immigration arrested 11 individuals, including 8 women, at Karachi Airport traveling to Saudi Arabia for begging under the guise of performing Umrah. These individuals were offloaded as their return tickets and hotel bookings were found to be fake.—RT/Agency

Gandapur's Brother Files Rs500 Million Defamation Suit Against KP Governor Kundi

PESHAWAR: Faisal Amin, the brother of Khyber Pakhtunkhwa (KP) Chief Minister (CM) Ali Amin Gandapur has filed a defamation suit against Governor Faisal Karim Kundi for leveling corruption allegations, media reported.

Gandapur's brother filed a defamation case against Faisal Karim Kundi in the district court as the governor failed to reply to the legal notice urging him to seek an apology and pay Rs500 million.

He stated that Governor Kundi's allegations of corruption against him and the CM on a TV show had damaged his reputation and attempted to harm his political career.

Earlier, Khyber Pakhtunkhwa (KP) Chief Minister (CM) Ali Amin Gandapur sent a defamation notice to Governor Faisal Karim Kundi.

The notice demanded the Governor to retract his statement and apologize for

claiming that the chief minister had signed the draft of Operation Istehkam Pakistan in the Apex Committee meeting.

The notice stated that the Governor had made this statement on TV and if the Governor does not apologize, he will have to pay a fine of Rs 1000 million.

It is worth mentioning here that the war of words intensified between Ali Amin Gandapur and newly-appointed Governor Faisal Karim Kundi, with the former threatening to block latter's grant.

The altercation appeared to have started after CM Ali Amin Gandapur, while addressing a public gathering, threatened to occupy the governor's house if the governor's rule was imposed in the province.

Responding to the Gandapur's statement, Faisal Karim Kundi said he knew how to protect the Governor's House if Gandapur attacked it.—RT/Agency

KP Chief Minister forwarded the summary to the governor who gave his assent.

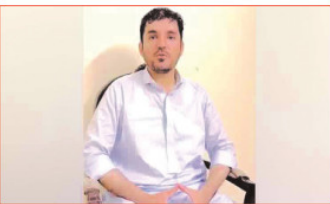

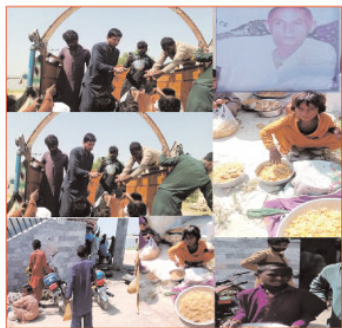

GALLE: New Zealand were in a state of bother at the Stumps on Day 2 of the second Test after Sri Lanka piled up a humongous total, courtesy of centuries from Dinesh Chandimal, Kusal Mendis and rising star Kamindu Mendis.

The hosts declared their first innings at 602/5, minutes before the Stumps and after an unbeaten 200-run partnership between Kamindu and Kusal.

The visitors had a shaky start to their innings as they lost both their openers Tom Latham (2) and Devon Conway (9) inside nine overs.

Skipper Kane Williamson (6) and nightwatchman Ajaz Patel (0) did well to survive the remaining 5.4 overs and will now resume New Zealand's innings at 22/2 on the third day.

Sri Lanka resumed their first innings at 306/3 with Mathews and Kamindu, unbeaten on 78 and 51 respectively.

The duo managed to add just 22 runs to their overnight

off 80 deliveries, hitting three fours and a six.

This was Phillips' third wicket in the innings as he cleaned up Dinesh Chandimal on 116 in the third session of the opening day.

But New Zealand's hopes of some fightback with the ball were dashed by a well-crafted partnership between Kamindu and Kusal.

When Sri Lanka captain de Silva called for the declaration, Kamindu was just 18 away from his maiden double century, while Kusal had just amassed his 10th Test century.

During his marathon 182-run knock, Kamindu breached the 1000 Test runs barrier.—Agency

Bangladeshi fan Tiger Roby 'thrashed' by Indian team's supporters



KANPUR: A Bangladeshi fan attending the India-Bangladesh Test match in Kanpur on Friday was rushed to the hospital after allegedly being heckled and assaulted inside the stadium, reported India's PTI news agency.

The fan, known as "Tiger Roby," was dressed in a tiger costume - the emblem of the Bangladesh cricket team - and was standing in the C Block balcony of Green Park Stadium, where the incident took place.

A clip on PTI Videos showed the fan being carried out of the stadium by medical officials and security personnel. He was later seated on a chair and given water.

In another account, PTI, quoting police, reported that the fan was not assaulted but suffered from dehydration.

A follow-up report by PTI claimed that Roby was hospitalised after falling ill. "He was gasping for breath when he met a constable. He became unconscious before we could speak to him, but now he is fine," Additional Commissioner of Police (Law and Order) Harish Chander was quoted as saying in the PTI report.

However, a journalist covering the game told media that the fan was manhandled, though not beaten or assaulted.

"Tiger Roby was manhandled after he angered Indian fans by insulting some of their players. They tried to snatch the Bangladesh flag from him, and he was slightly hit. He wasn't beaten, nor was it a case of dehydration. He did get hit slightly, but then he overdramatised the incident," the journalist told this correspondent.—Agency

Veteran cricket umpire Aleem Dar calls it a day



LAHORE: Aleem Dar has decided to put an end to his umpiring career at the end of the Pakistan Cricket Board's 2024-25 domestic season, concluding a career that spanned for nearly a quarter of a century, the PCB said in a statement on Friday.

Dar was a true gentleman for cricketers and fans both on and off the field and was awarded the highly prestigious David Shepherd Trophy for ICC Umpire of the Year three times from 2009 to 2011.

As for his cricket playing career, the maestro played 17 first-class and 18 List-A games from the year 1986 to 1988, then went on to umpiring games from the Quaid-e-Azam Trophy in 1998-99.

From 2003 to 2023, he served on the ICC Elite Panel of Umpires, where he earned a reputation for his player management skills, understanding of the playing con-

ditions, calm demeanour and outstanding decision-making.

He is currently part of the PCB's Elite Panel and remains one of four Pakistani umpires on the ICC's International Panel, making him eligible to officiate in ODIs and T20Is.

To date, Dar has officiated in a record-breaking 145 Tests, 231 ODIs, 72 T20Is, 5 WT20Is, 181 first-class matches, and 282 List-A matches.

"His contributions to the sport extend far beyond these numbers, with his professionalism and respectful manner making him a beloved figure worldwide," the statement read.

Reflecting on his decision to retire, the maestro of the umpiring world said: "Umpiring has been my life for nearly 25 years and I have cherished the privilege of officiating some of the most iconic matches involving the greatest players of this generation," Dar remarked.

"Throughout my career, I've strived to uphold the highest standards of sportsmanship, and it has been an honour to work alongside some of the finest match officials in the world."

"However, all great journeys must eventually come to an end, and the time has come for me to focus fully on my social and charity work. My hospital project and other initiatives are very close to my heart and require my full devotion and attention."

Dar acknowledged the support he has had from his colleagues during his journey further adding that it is the right time to hang the boots.

"Having achieved almost everything that I had aspired to in umpiring with the unwavering support of my peers and colleagues, I also feel it's the right moment to step aside and allow emerging umpires to shine.—Agency

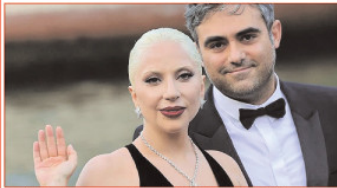

No Consensus Between JUI-F And PTI On Constitutional Amendments, Says Murtaza

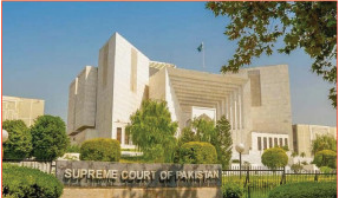

Supreme Court Schedules Hearing For Article 63-A Review Case

ISLAMABAD: A case of Article 63-A review has been fixed for hearing in the Supreme Court. A five-member bench headed by Chief Justice Qazi Faez Isa would hear the case on Monday. The bench includes Justice Munib Akhtar, Justice Aminuddin Khan, Justice Jamal Mandokhail and Justice Mazhar Alam Miankhal. It is pertinent to note that SC judgment on May 17, 2022 on presidential reference for explanation of Article 63-A stated that any vote of parliamentarian against party policy would not be considered. Parliament was responsible to decide on the duration of life-time disqualification or disqualification, SC order stated. A five-member bench headed by then chief justice Umar Ata Bandial heard the presidential reference and the verdict was delivered by a 3-2 majority of a full bench. Various views applications were filed on this matter but no application had been produced.—RT/Agency

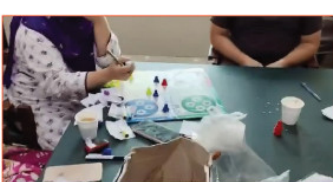


Gilani Invites Global Tourists To Discover The Beauty Of Pakistan

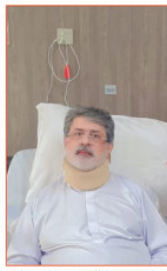

Born in the village of Lahri, near the borders of Sibi and Dera Bugti, Sardar Sarfraz was known for his humility, kindness, and soft-spoken nature, despite being the leader of the valiant Domki tribe of the ancient state of Kachi. Following the death of his father, Sardar Sarfraz was appointed as the chief of the Domki tribe by the tribal elite. Lawyers' team reaches Sindhri Police Station to register case of Dr Shahnawaz

They stated that he was killed after being taken into custody. In light of a law passed in 2022, which mandates that the FIA conducts inquiries into deaths during judicial custody, the lawyers have named several officials, including DIG Javed Jiskani, SSP Asad Chaudhry and SSP Asif Raza Baloch, in their complaint. They also included the SHO of Sindhri and Umar Jan Sarhandi, who allegedly incited violence. The lawyers identified other police personnel, such as DIB In-Charge Danish Bhatti and Sub-Inspector Hidayatullah Narejo, as involved. They emphasized that the allegations of torture against Dr. Shahnawaz could be confirmed after exhumation. The legal team stressed that all individuals who incited violence on social media should be held accountable. They reported that around 300 people are currently arrested across Sindh on blasphemy charges. The family of Dr. Shahnawaz demands a judicial inquiry, stating that the issue is not minor but significant on a national level. They have recommended that charges under the Anti-Terrorism Act and Section 302 be included in the case.



Punjab Government Imposes Section 144 Ahead Of PTI's Rawalpindi Power Show

LAHORE: The Punjab government on Friday imposed Section 144 in Rawalpindi for two days, banning public gatherings, ahead of a PTI rally scheduled in the city on the weekend. Section 144 of the Code of Criminal Procedure is a legal provision that empowers district administrations to prohibit an assembly of four or more people in an area for a limited period. It is usually imposed to prevent potential disturbances, maintain law and order, and curb any activities that might escalate into violence. The court directed to remove Shibli Faraz's name from ECL within a week and update the court about this matter. The court ordered the appearance of the Home secretary in personal capacity if the court order wasn't implemented. The court has adjourned the case hearing until one week.—RT/Agency

The LDA lawyer stated that they conducted operation in Tollinton Market yesterday and on-boarding of Tollinton Market Association was desired. Selling dead chicken meat was a legal offence. Justice Karim remarked that some restaurants were selling their water and its sale shouldn't be allowed if it didn't comply with Pakistani standards. Relevant authorities must take this matter under consideration, the court observed. Justice Karim remarked that extreme temperature in September was quite concerning as it's a result of climate change. LHC stated that half of the pollution would be reduced if lanes on roads were followed. The court has ordered a fine on throwing garbage on roads and not following lane traffic rules.—RT/Agency

FIR Filed Against Accused In Dr. Shahnawaz Murder Case After Inquiry Report Confirms Police Misconduct

UMERKOT: An FIR has been registered following an inquiry report that established the blasphemy accused, Dr. Shahnawaz Kumbhar, was killed in a suspected fake police encounter in Umerkot, Sindh, as reported on Friday. The case names 45 individuals, including senior police officials such as DIG Javed Jaskani, SSP Asad Chaudhry, SSP Asif Raza Baloch, and the SHO of Sindhri, alongside CIA team members. The FIR, filed under charges of murder, terrorism, and violations of the Torture and Custodial Death Prevention Act 2022, also implicates Umar Jan Sindhari, accused of inciting public unrest via social media, resulting in violent actions. The complaint was lodged by Advocate Ibrahim, Dr. Shahnawaz's brother-in-law, at Police Station Sindhri, alleging that the police staged the encounter and subjected the victim to torture. Additionally, DIB In-Charge Danish Bhatti, Sub-Inspector Hidayatullah Narejo, and other police personnel are named in the case, which includes both identified and unidentified suspects linked to the incident. Dr. Shahnawaz was reportedly apprehended in Karachi and subsequently handed over to Umerkot police, where his death occurred. The inquiry committee, established under the directives of Sindh Police Chief Ghulam Nabi Memon, has concluded its investigation of the Umerkot incident, revealing serious misconduct by police officials from Umerkot and Mirpurkhas. The inquiry report, prompted by public outcry, has detailed significant legal violations by the involved police personnel. Following blasphemy allegations against Dr. Shahnawaz, widespread protests erupted in Umerkot, compelling police to expedite his arrest. He was tracked down in Karachi and transferred to the Mirpur Khas police, who are alleged to have staged the encounter later that night. The committee confirmed that the police encounter was fabricated to provide legal cover for an extrajudicial killing, condemning the public celebrations and praise received by officers after Dr. Shahnawaz's death, which gained traction on social media. The inquiry committee recommended that Dr. Shahnawaz's family be allowed to record a statement and file a murder FIR against the implicated officers. Moreover, the committee called for stringent departmental action against Umerkot and Mirpur Khas police, including senior officers like the DIG and IJC to expedite his arrest. He was tracked down in Karachi and transferred to the Mirpur Khas police, who are alleged to have

Sindh Energy Minister Advocates For Affordable Solar Energy Solutions

KARACHI: Provincial Minister for Energy, Development, and Planning, Sindh, Syed Nasir Hussain Shah, has emphasized the importance of making affordable and high-quality solar panels accessible to the poorest segments of society. He expressed these views while visiting various stalls and speaking to the media on the second day of the ongoing three-day Solar Expo at the Expo Center Karachi. Accompanying him were Sindh Energy Secretary Mosaddeq Ahmed Khan and Project Director Sindh Solar Energy, Mahfooz Ahmed Qazi.



Minister Nasir Shah highlighted the need for locally and internationally manufactured and marketed all components related to solar panels, including batteries and lithium, at affordable prices. He stressed that the people of Sindh cannot bear the burden of expensive electricity and costly solar systems, and it is essential to make alternative energy solutions more accessible to the general public.

He noted that competition among companies has already led to a decrease in the prices of solar panels at both domestic and international levels, but there is still room for further reduction.

In response to a question, the minister acknowledged the severe problems people face due to high electricity costs, load shedding, and over-billing. He assured that the Sindh government is aware of these issues and that the public will receive positive news soon. He also mentioned that Sindh is providing the cheapest electricity to the National Grid.

Addressing concerns about the high cost of fertilizers, Nasir Shah revealed that a solution is being developed to produce affordable fertilizer from Thar coal, which will benefit farmers and the agriculture sector.

The minister also praised the ongoing Solar Expo, noting that over 200 companies from 10 countries are participating, with 80% of

them being world-class enterprises. He commended the organizers for their efforts, stating that the exhibition not only enhances the image of the Sindh government but also showcases Pakistan positively to the international community.

He suggested extending the duration of the exhibition beyond three days to allow more people to gain awareness and learn about the quality offerings of local and international companies. Additionally, Nasir Shah announced that more than 160,000 solar systems with inverters and battery backups will be provided free of cost to poor and underdeveloped areas in Sindh. He also mentioned that hybrid solar parks are in the pipeline, aiming to further promote renewable energy in the region.—RT

Sindh Government To Establish Fusion Center For Enhanced Anti-Narcotics Coordination

KARACHI: The Sindh government has announced the establishment of a Fusion Center aimed at enhancing intelligence sharing and coordination on drug-related matters between provincial and federal institutions. This initiative is part of a broader strategy to strengthen anti-narcotics efforts across Pakistan. Additionally, the government plans to collaborate with the Health Department to establish rehabilitation centers for drug addicts.



The decision was made during the second meeting of the High-Powered Committee for Anti-Narcotics, chaired by Sindh Senior Minister Shajeel Inam Memon at his office in Karachi. The meeting was attended by key officials, including Secretary Excise Muhammad Saleem Rajput, Secretary Universities and Boards Abbas Baloch, Secretary Social Welfare Parvez Ahmad Sehar, Commander ANF Brigadier Umar, DIG CIA

Muqadas Haider, and others. Representatives from the United Nations Office on Drugs and Crime (UNODC), Tom from Geneva and Sajid Aslam from Islamabad, also participated online. During the meeting, it was resolved to establish a Fusion Center to improve coordination on drug-related issues between all provinces and the federal government. Senior Minister Memon directed that the High-Powered Committee meet every fortnight to expedite and review ongoing anti-narcotics operations.

He stressed the importance of all stakeholders working together to combat the drug menace. DIG CIA Muqadas Haider briefed the committee on the anti-narcotics operations carried out by the Sindh Police and the Anti-Narcotics Force (ANF). It was reported that 13 suspects involved in supplying drugs to educational institutions have been arrested, and the number of applicants in rehabilitation centers has reached 9,000. The committee also decided to seek the Health Department's assistance in managing these centers.

UNODC representatives assured the Sindh government of their full support in its anti-narcotics efforts. Senior Minister Memon emphasized the need for a Fusion Center in every province and at the federal level to ensure more coordinated and effective actions against drug-related challenges.

He reaffirmed the Sindh government's commitment to a zero-tolerance policy on drugs, underscoring the critical importance of this fight for the future of the younger generation. Memon stated that the campaign against drugs is ongoing and called on all segments of society to play an active role in this effort. He also highlighted that former President Asif Ali Zardari has issued clear directives for the complete eradication of drugs.

Memon announced that drug tests will be conducted in educational institutions, not to embarrass anyone, but to confront the issue head-on. He warned that the drug problem is pervasive, affecting families and communities across all social strata. The minister emphasized that urgent action is needed to address the significant challenge posed by drug use, and directed that rehabilitation centers be reactivated. He also stressed the importance of identifying and eliminating key drug hideouts. "No drug dealer will be spared," Memon declared, noting that indiscriminate actions against drug-related activities are currently underway and will continue. He vowed that strict action will be taken wherever drug use is reported, whether in homes, shops, or social gatherings.—RT

People protest against Mehmood Goth Police picket In-charge

KARACHI: Residents near the Link Road Police picket in Mehmood Goth protested, accusing In-Charge Tahir Khan of illegal detentions and extortion. They claimed he arrests poor workers, drivers, and laborers, threatening them with false charges unless they pay bribes. Protesters

shared that Khan forcibly took three workers from a hotel and extorted 120,000 rupees, holding them in custody at the Mehmood Goth police station. They called for action from senior officials, including the Sindh Home Minister and Anti-Corruption authorities, demanding Khan's suspension for his alleged mis-conduct.

ABAD Voices Concerns Over Encroachments And Tax Hikes In Meeting With KDA

KARACHI: The Chairman of the Association of Builders and Developers (ABAD), Asif Samsam, along with Senior Vice Chairman Ibrahim Habib, has raised serious concerns about the growing issue of illegal encroachments, the abrupt increase in service charges and taxes related to the sale, purchase, and transfer of plots, and the commercial misuse of KDA-leased residential plots in Clifton. They have called for swift action to resolve these pressing matters.



These concerns were discussed during a meeting with the Director General of the Karachi Development Authority (KDA), Syed Shujaat Hussain, held at ABAD House. During the meeting, Senior Director of KDA, M. Waryal Andhar, was designated as the focal person to address ABAD's issues. Additionally, it was agreed to include an ABAD representative in the KDA Governing Body, with a formal request letter from ABAD to follow.

The meeting saw the participation of ABAD Vice Chairman Zeeshan Siddiqui, Southern Region Chairman Mustafa Sheikhan, KDA officials, and numerous ABAD members. Chairman Asif Samsam voiced particular concern over illegal encroachments on plots owned by ABAD members, which has caused significant distress among

builders and developers. He urged the DG KDA to take decisive action against these encroachments. Senior Vice Chairman Ibrahim Habib also highlighted the misuse of KDA-leased residential plots in Clifton Blocks 8 and 9 for commercial purposes, demanding immediate KDA intervention. He suggested forming a high-profile committee, including representatives from KDA, ABAD, and the Clifton Residents Society, to conduct a survey and recommend the cancellation of leases for those misusing residential plots.

Habib further expressed concern over the sudden increase in fees related to the sale, transfer, mutation, lease extension, and NOCs of plots by KDA. He urged that any such tax hikes should be discussed with stakeholders to maintain harmony. He also pointed out that ABAD members, who had purchased auctioned plots on University Road were facing illegal oc-

cupation and requested the activation of the anti-encroachment cell to clear these plots. DG KDA Shujaat Hussain assured that addressing ABAD's concerns is a top priority, acknowledging the construction industry's vital contribution to the national economy. He emphasized that construction activities generate significant tax revenue and help reduce unemployment. He pledged strict action against encroachments on auctioned plots on University Road and announced the formation of a committee to address the commercial misuse of residential plots in Clifton, with a mutual consultation to find a resolution.

The DG also announced the creation of a committee consisting of ABAD members and KDA officials to address issues related to plot sales, transfers, and taxes, with a meeting scheduled for October 1st.—RT

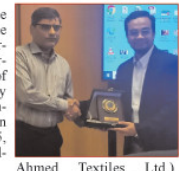

Army Chief Praises China, Saudi Arabia, And UAE For Economic Assistance

KARACHI: Chief of Army Staff (COAS) General Asim Munir has expressed appreciation for the all-out support extended by friendly nations, particularly China, Saudi Arabia, and the United Arab Emirates (UAE), in assisting Pakistan to stabilise its economy, the Inter-Services Public Relations (ISPR) said in a statement on Friday.



The army chief's statement came as he visited the Karachi Corps area of responsibility, where he was briefed on operational preparedness and key training initiatives undertaken by the army, the military's media wing said.

His remarks came a day after the International Monetary Fund's (IMF) Executive Board approved of a \$7 billion Extended Fund Facility (EFF) for Pakistan.

In a statement, IMF Pakistan Mission Chief Nathan Porter said that China, Saudi Arabia and

the United Arab Emirates have given "significant financing assurances" to Islamabad linked to the country's \$7 billion bailout package.

The financial assurances by the countries go beyond the agreement to roll over \$12 billion in bilateral loans owed to these countries, added the official.

"I won't go into the specifics, but UAE, China and the Kingdom of Saudi Arabia all provided significant financing assurances to join up in this programme," Porter told reporters virtually.

The IMF official's

statement echoes the remarks made by Finance Minister Muhammad Aurangzeb last month wherein he claimed that the aforementioned countries had confirmed the rollover for three years with renewal to take place every year.

During his visit today, the COAS also interacted with the business community of Karachi.

The ISPR said Gen Munir hailed contributions of business community and entrepreneurs towards the country's economic growth.

"Participants expressed confidence and praised

SIFC for its role towards achieving the positive economic indicators, which are providing an enabling environment for further economic growth," it added.

Moreover, the COAS also commended the efforts of federal and provincial governments towards supporting all initiatives and remarked that naysayers who made failed efforts towards creating despair and despondency in the society have been defeated through the collective efforts of all stakeholders.

"[The] COAS appreciated the praiseworthy role performed by brotherly and friendly countries especially China, Kingdom of Saudi Arabia and UAE in the economic recovery of Pakistan by helping us in multiple domains," read the ISPR's statement.

He highlighted that Pakistan has remarkable potential in various domains and all must have unflinching trust and confidence in the bright fu-

ture of Pakistan. "Given the immense resources and potential, Pakistan is destined to achieve its rightful position in the comity of nations, InshaAllah."

The army chief also inaugurated Innovista Indus IT Park, a hub aimed at empowering Pakistan's youth by fostering academia-industry collaboration in the field of Information Technology. Technology, particularly artificial intelligence, Sindh Murad Ali Shah, and notable civil community members attended the inauguration ceremony, as per the ISPR. CM Murad emphasised the importance of IT domain for optimal exploitation of potential of youth and economic growth. The army chief highlighted that such projects are aimed at providing the most conducive environment to further promote the growth of IT industry in the country, which is already accelerating at a respectable pace.—RT/Agency

Pakistan Secures First \$1.02 Billion Tranche From IMF Under EFF

ISLAMABAD: State Bank of Pakistan (SBP) on Friday received the first tranche of SDR 760 million (equivalent to \$1.0269 billion) from the International Monetary Fund (IMF) under the \$7 billion Extended Fund Facility (EFF).

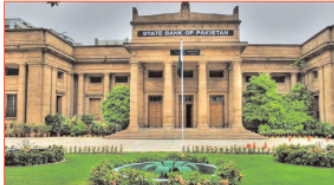
The IMF Executive Board approved a 37-month programme on Wednesday.

These inflows will be reflected in SBP liquid reserves to be released on Thursday, September 30, 2024, the central bank said in a statement.

Following the long-awaited approval, the IMF said the new programme would require "sound policies and reforms" to strengthen macroeconomic stability and address structural challenges alongside "continued strong financial support from Pakistan's development and bilateral partners".

Pakistan had been working on implementing conditions deemed "strict" to complete the loan programme agreed to in July, which Prime Minister Shehbaz Sharif time and again hoped would be Pakistan's last.

Though, the country's economy has stabilised since it came close to defaulting last summer, it is dependent on IMF bailouts and loans from friendly countries to service its huge debt, which swallows up half of its an-



nual revenues. "There will be transitional pain, but if we are to make it the last programme, then we have to carry out structural reforms," Finance Minister Muhammad Aurangzeb told Geo News in an exclusive talk.

The IMF said in a statement it would issue an "immediate disbursement" of around \$1 billion.

"This past year has seen a very welcome return to economic stability in Pakistan," IMF Pakistan mission chief Nathan Porter told reporters on Thursday.

"The challenge confronting Pakistan now is to move beyond this renewed sense of stability and towards stronger and sustained growth, with its benefits shared more broadly and evenly across society," he added.

Speaking on the sidelines of the United Nations General Assembly in New York on Wednesday, Prime Minister

Shehbaz Sharif said the deal came through thanks to the "tremendous support" of Saudi Arabia, China and the United Arab Emirates. "In the final phase (of negotiations), the IMF's conditions were related to China. The way the Chinese government supported and strengthened us during this time is something I am truly grateful for," he told reporters shortly before the deal was announced.

Last month, Aurangzeb had said Pakistan was negotiating a \$12 billion loan reprofiling from bilateral lenders.

The amount comprised \$5 billion from Saudi Arabia, \$4 billion from China and \$3 billion from the UAE for a three-to-five-year period.

Porter said all three countries had "provided significant financing assurances," beyond these commitments to rolling over the \$12 billion in existing loans.—RT/Agency

ECP Submits New Plea To Stay SC Verdict On Reserved Seats

ISLAMABAD: In a fix over how to proceed on Supreme Court's detailed verdict in the reserved seats case after the newly-enacted Election Act Amendment Bill 2024, the Election Commission of Pakistan (ECP) has submitted two more petitions in the apex court, seeking stay on its July 12 order.



In its 70-page detailed judgment issued on Sept 23, the apex court termed the PTI "a political party" and eligible for the seats reserved for women and minorities.

The electoral watchdog, a day earlier, approached the top court to seek its guidance whether to follow amended Election Act 2017 or its judgment on the matter of allocating reserved seats to the Pakistan Tehreek-e-Insaf (PTI).

The ECP mentioned the National Assembly Speaker Ayaz Sadiq's letter stating that amendments were made to the Election Act after the top court's verdict declaring the opposition party eligible for the reserved seats.

Speaker Sadiq had told the ECP in his letter that the apex court's July 12 ruling was "incapable of implementation" after the amendments to Election Act 2017.

Besides civil miscellaneous petition, the Election Commission also filed two other petitions for review concerning the "clarification order" and seeking stay with regard to the July 12 order's implementation till the pleas were decided, it emerged on Friday (today).

Through the petitions, the commission sought SC's guidance with respect to the effect of the Elections (Second) Amendment Act, 2024 on the short order of the apex

court of July 12, clarification order dated Sept 14 and detailed judgment dated Sept 23 in the interest of justice.

The ECP, in its petition, noted the apex court's reserved seats verdict was based on "assumptions", adding: "It cannot rewrite the Constitution on pretext of interpretation."

"The Supreme Court in its detailed judgment dated Sept 23, 2024, deviated from [the] July 12 verdict," it said, noting that the court in the detailed order declared the 41 returned candidates as the members of the former ruling party.

The ECP pointed out that the Constitution binds independent lawmakers to

join any political party within three days, but "the Supreme Court granted them 15 days—a move which changed the words of the Constitution".

The independent candidates submitted affidavits of allegiance to Sunni Ittehad Council (SIC), which the body says, was "completely ignored" in the court's ruling.

"Even if the certificates, submitted by PTI Chairman [Barrister Gohar Ali Khan], are recognised or accepted, the number of PTI members does not reach 39," the ECP said, adding that the candidates did not submit party affiliation certificates under Section 66 of the Election Act.

The electoral body maintained that the reserved seats cannot be allocated to Imran Khan-founded party, noting that the PTI did not claim its share at any forum.

In what it called a major victory for Pakistan Tehreek-e-Insaf (PTI), a 13-member full bench of the top court on July 12 ruled that the Imran Khan-

founded party was eligible for the allocation of reserved seats for women and non-Muslims in the national and provincial assemblies.

Justice Mansoor Ali Shah announced the 8-5 majority verdict, nullifying the Peshawar High Court's (PHC) order wherein it had upheld the Election Commission of Pakistan's (ECP) decision denying the reserved seats to the Sunni Ittehad Council (SIC).

The PTI candidates contested the Feb 8 general elections as independents after the top court upheld the ECP decision to deprive the opposition party of its iconic electoral symbol—but over "unlawful" intra-party polls.

The decision forced the PTI-backed winning candidates to join the SIC in a bid to claim reserved seats.

However, the ECP denied the reserved to the SIC over its failure to submit list of candidates within the stipulated time.—RT/Agency

Pakistan Seeks Climate Financing From IMF Amid Ongoing Economic Challenges

ISLAMABAD: Pakistan has requested the International Monetary Fund (IMF) to review the possibility of extending another \$1 billion to \$1.5 billion programme to meet the financing requirements for long-term reforms for mitigating the impacts of climate change.

The issue of the new programme? The Resilience and Sustainability Facility (RSF) was raised by Pakistani authorities during a meeting between Prime Minister Shehbaz Sharif and IMF Managing Director Kristalina Georgieva. The meeting was held after the IMF board meeting on Wednesday and on the sidelines of the United National General Assembly session in New York.

"During the meeting, they discussed the urgent need of mobilising adaptation financing for climate change," said a statement from the Prime Minister's Office on Thursday. The prime minister agreed to have the finance minister take up this critical issue with senior IMF management during the Annual Meetings in October, it further stated.

A day earlier, the IMF approved the \$7 billion loan programme for a period of three years, which also helped fulfilling one of the eligibility criteria for qualifying for the IMF's highly concessional climate related



climate financing a few months ago but the IMF said the country did not meet one of the conditions of having a larger programme. During the meeting, Minister for Finance Muhammad Aurangzeb highlighted that after the approval of the \$7 billion programme, Pakistan has met the eligibility criteria.

Aurangzeb would now take up the issue of the new programme with the IMF during his next month visit to Washington to attend the World Bank-IMF annual meetings. The Pakistani authorities said the country can access up to \$1 billion to \$1.5 billion concessional financing.

Pakistan also meets the requirement of the Country Climate and Development assessment report, which the World Bank carried in 2022/another eligibility criterion.

The Resilience and the Sustainability Facility is one of concessional loans, which is repaid over a period of 20 years, unlike the Extended Fund Facility that has to be paid back in four and half years to 10 years.

The Resilience and Sustainability Facility provides affordable long-term financing to countries undertaking reforms to reduce risks to prospective balance of payments stability, including those related to climate change and pandemic preparedness.

This facility provides long-term financing to strengthen economic resilience and sustainability by supporting policy reforms that reduce macro-critical risks associated with climate change and pandemic preparedness, and augmenting policy space and financial buffers to mitigate the risks arising from such longer-term structural challenges.—RT/Agency

PM Shehbaz Advocates For Increased Investment And Trade Relations With The US

NEW YORK: Prime Minister Shehbaz Sharif emphasized his government's commitment to strengthening trade and investment ties between Pakistan and the United States during a meeting with a delegation from the US-Pakistan Business Council in New York on Friday.



Addressing the delegation, which included the president, senior officials, and corporate leaders from leading US companies, he expressed a strong desire to attract American investments in key sectors to foster growth and prosperity.

During his remarks, the prime minister highlighted the government's focus on improving the ease of doing business in Pakistan, noting that gathering insights from the corporate sector is a top priority.

He introduced the Special Investment Facilitation Council (SIFC), a high-level, one-stop agency designed to assist foreign investors in planning and executing projects in four critical areas: agriculture, information technology, energy, and mining.

Attendees included prominent representatives of US investors in Pakistan, such as John Murphy, Senior Vice President and Head of International at the US Chamber of Commerce; Esperanza Jelalian, President of the US-

Pakistan Business Council; and Steven Kobos, President and CEO of Exceelerate Energy. Other notable participants came from PepsiCo, TRG Pakistan, Mastercard, Procter & Gamble, Illumina, and Abbott.

In her remarks, Ms. Jelalian noted that Pakistan is a favored destination for US investments and has significant potential. She mentioned that a USPBC delegation is being organized this year to explore additional investment opportunities in Pakistan.

The meeting concluded with an interactive discussion, during which the prime minister addressed various questions from representatives of US enterprises.—RT/Agency

JUI-F Declines Support For CJP Isa's Constitutional Amendments After Mubarak Sani Verdict



ISLAMABAD: Jamiat Ulama-e-Islam-Fazl (JUI-F) Secretary General and National Assembly member Abdul Ghafoor Haideri has declared that his party will not support Justice Qazi Faez Isa in the ongoing constitutional amendment process.

Maulana Abdul Ghafoor expressed this stance while speaking informally with journalists at Parliament House.

Abdul Ghafoor criticised Justice Qazi Faez Isa's decision in the Mubarak Sani case, stating that it was "deliberately" made to hurt the sentiments of many Muslims.

He explained that the decision was reversed only due to public pressure.

"How can we support such a person in constitutional amendments?" Abdul Ghafoor questioned.

The JUI-F leader also voiced concerns over the government's haste in pushing forward with constitutional amendments, saying that coalition parties were not properly consulted.

"We requested negotiations on the amendments, but the draft was shared with us under an oath of secrecy," he added.

Abdul Ghafoor further highlighted the lack of transparency in the legislative process, particularly regarding human rights violations found in the government's draft. He noted that the Pakistan People's Party (PPP) had requested to see the draft before engaging in negotiations, but the government did not take the process seriously.—RT/Agency

Ban On X Enforced Over National Security Concerns: Information Minister

ISLAMABAD: Information Minister Attaullah Tarar said on Friday that social media platform X has been banned due to national security issues, not to curb freedom of expression.

In March this year, in its first direct admission regarding imposing an official ban on X (formerly Twitter), the interior ministry informed the Sindh High Court (SHC) that the social media platform was blocked in February till further orders on the reports of intelligence agencies.

Access to X has been disrupted in many areas of the country since February 17.

In July, Tarar told a senate panel that X had been banned by the caretaker government over "compliance issues" while in August, Punjab Information Minister Azma Bokhari said the government



may lift the ban on X if social media rules and regulations were framed.

Earlier this month, two lawyers representing the telecom regulator, during a case in the SHC, adopted contradictory stances on whether or not X had been restored.

Today, in an interview with Voice of America, Tarar dispelled the impression that it was an unannounced ban, saying that the caretaker gov-

ernment had banned X before the February 8 general elections due to issues related to compliance. "Separatists and terrorists were using the platform against Pakistan, which could not be allowed," Tarar said.

He added that terrorists belonging to the "so-called" Balochistan Liberation Army (BLA) were using the platform to promote their anti-state activities.—RT/Agency
