

CJP Isa-Led Bench To Tackle Explosive Constitutional Amendment Petition On Oct 17

ISLAMABAD: The Supreme Court on Saturday fixed for hearing a petition against the proposed constitutional amendment proposed by the coalition government aimed at introducing judicial reforms including establishing separate court to hear constitutional matters.



A three-member bench of the apex court headed by Chief Justice of Pakistan (CJP) Qazi Faez Isa will hear the case on October 17. The bench will also include Justice Naem Akhtar Afghan and Justice Shahid Bilal Hassan, according to a supplementary cause list issued by the registrar's office.

The petition was filed by former Supreme Court Bar Association (SCBA) president Abid Shahid Zuberi, Shafiqat Mahmood, Ishfaq Ahmad, Shahab Sarki, Munir Kakar and others. In a constitutional petition filed under Article 184(3), the apex court has been requested to set aside the proposed amendments and declare them "ultra vires" the Constitution, principle of separation of powers, independence of judiciary and fundamental rights enshrined under the law. "It is prayed that the separation of powers and independence of the judiciary and its powers and functions to enforce the fundamental rights be kindly declared as sacrosanct under the Constitution and beyond the power and competence of the Parliament to withdraw, interfere or tamper with in any manner whatsoever," the petition read. The petitioners requested the court to restrain the federal government from tabling the bill, order the suspension of the operation of the proposed amendments, and stop it from being signed into law by the president of Pakistan even if it sails through both houses of parliament. The constitutional package, among other things, aims to set up a federal constitutional court and fix the tenure of the Chief Justice of Pakistan (CJP) for three years. The government had attempted to present the bill to amend the Constitution last month, but its allies as well as members of the opposition benches vehemently opposed the proposal, forcing the the rulers to begin a consultation process. It is pertinent to mention here that CJP Isa is set to retire on the 25th of this month. A full court reference for the outgoing top judge has been scheduled for the said date.—RT/Agency

Law Minister Sets October 24 Deadline For New CJP: Countdown Begins!

ISLAMABAD: As the coalition government stepped up its efforts to evolve consensus on the proposed judicial package, Law Minister Azam Nazeer Tarar has said that the notification for the new chief justice of Pakistan can be issued one or two days ahead of the retirement of the incumbent top judge Justice Qazi Faez Isa. "The notification will be issued InshaAllah. The cut-off date [of notification] for the Ministry of Law is October 25," Tarar said while responding to a question in his interaction with journalists in Islamabad.



"Government will issue the notification on October 24 for the venue of oath-taking ceremony [for new CJP]," he added.

He added that notification of new CJP is issued one or two days before the retirement of the incumbent in line with the tradition.

Detailing reason behind early notification of Justice Isa as the chief justice, the law minister said that it was issued early in view of the formation of the caretaker government. It is noteworthy to mention here the major opposition party, Pakistan Tehreek-e-Insaf (PTI), had demanded the federal government for naming the next CJP at the earliest, alleging that the government was planning to extend Justice Isa's tenure via its judiciary-centric constitutional amendment which the party strongly opposed.

The Imran Khan-founded party had announced backing Justice Mansoor Ali Shah, who is next in line to become the chief justice, as the next top judge of the country. Tarar, commenting on progress on proposed constitutional amendment, said that the contentious legislation could be passed after before or after October 25 — the day of CJP Isa's retirement.

"We have formed a sub-committee of legal experts to give recommendations to the parliamentary committee. [...] discussions are underway on four to five items [of the draft amendment]," he added.

His statement came after a sitting of the special parliamentary committee — a body led by Pakistan Peoples Party (PPP) MNA Syed Khurshid Shah having representation of all parties — formed to discuss the contentious constitutional amendment and evolve a consensus.

The proposed amendments, also called constitutional or judicial package, among other things, aims to set up a federal constitutional court and fix the tenure of the CJP for three years.

The government had attempted to present the bill to amend the Constitution last

month, but its allies as well as members from the opposition benches vehemently opposed the proposal, forcing the administration to begin a consultation process. However, a progress was witnessed in the ongoing consultation process on the 56-point draft as the Jamiat Ulema-e-Islam-Fazl (JUI-F) Chief Maulana Fazlur Rehman, a day ago, showed a willingness to support the government's "constitutional package" with "ifs and buts". However, after today's meeting the Fazl-led party has refused to back the government's proposal to form separate court to hear constitutional matters, instead proposing to form constitutional bench for such cases. To pass the constitutional amendments, the government needs two-thirds majority in parliament, while it is short of 135 votes in the National Assembly (NA) and nine in the Senate.—RT/Agency

Chaos In Kurram: 15 Dead, Dozens Wounded In Violent Tribal Clashes

KURRAM: Khyber Pakhtunkhwa's Kurram district witnessed violence once more as a clash between two tribes led to the death of at least 15 people, officials told Geo News on Saturday.




Kurram Deputy Commissioner (DC) Javidullah Mehsud said that the unfortunate incident took place at the Kunj Alizai mountains, situated near the Pak-Afghan border.

The six people who sustained injuries have been transported to a hospital, the deputy commissioner said. The official added that steps are being taken to make the roads safe and bring the situation back to normal in the district. Local police said that its personnel and security forces have reached the area and have started an investigation into the clash. The clashes stopped last month and the authorities also re-opened the Pak-Afghan border crossing at Kharfachi. Last month's clash saw 60 people's deaths and dozens of injuries, KP Governor Faisal Karim Kundi had said. The dispute involves two rival tribes who have been fighting over a piece of land. In August, the two sides had reached a two-month ceasefire after the armed clashes resulted in 50 casualties and wounded 226 others.—RT/Agency

Government Vows 'Full Force' Crackdown To Crush PTI Protest During SCO Summit

ISLAMABAD: The government on Saturday vowed to use "full force" to stop the Pakistan Tehreek-e-Insaf's (PTI) planned protest, which coincides with the Shanghai Cooperation Organisation (SCO) summit on October 15.



"The call for protest on October 15 is an attack on the integrity of the country [...] We will not allow [anyone] to damage the honour and reputation of the country [...]. The state will use it's all of its power and resources to prevent the invasion of Islamabad," said Asif while speaking to the media in Stalok.

The defence minister's remarks refer to the Imran Khan-founded party's announcement to hold a demonstration in the federal capital on the same day the city is set to host representatives of several countries who will be visiting Pakistan to attend the Council of Heads of Government meeting scheduled from October 15 to 16.

The demonstrations, if held, would be the second in a month in the city. The previous one last week saw violent protests as the workers of the former ruling party, under the leadership of Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur, took to the streets in what the party claimed was meant for the "independence of the judiciary" — as the government aims to introduce constitutional amendments — and for the release of its incarcerated founder.

The said protests, as per a report submitted to the city's chief commissioner by the Islamabad Inspector General's office, caused damages worth Rs240 million to private and public property.

Firing a fresh salvo, Asif said that the PTI wanted to repeat the events of the May 9 riots — which saw military installations being vandalised — and that the party wanted to prevent the country's progress and development.

The politician also called for the courts to intervene and take notice of the matter. "Do the courts not see what the PTI founder is doing with the integrity of the country? The actions of the judiciary today will determine their role in history," he remarked.

For his part, Federal Minister for Planning, Development, and Special Initiatives Ahsan Iqbal said that nine heads of state would visit Pakistan during the SCO summit and the government will aim to bolster ties with them. "The Chinese prime minister is going to visit Pakistan after 11 years [...] However, tehrak-e-intehsar [PTI] has decided to hold a protest," Iqbal told media persons in Islamabad. He also drew parallels between the Karachi airport attack — which killed three including two Chinese — and PTI's October 15 protest. "I think that their script writer is the same. In 2014, PTI postponed the Chinese president's visit through their sit-in."—RT/Agency

JUI-F Pushes For New Constitutional Bench Amid Judiciary Shake-Up

ISLAMABAD: The Jamiat Ulema-e-Islam-Fazl (JUI-F) on Saturday suggested the government to constitute a constitutional bench instead of establishing a separate court to hear constitutional matters.



The JUI-F proposed this during a meeting of the special parliamentary committee formed to discuss the contentious constitutional amendment. JUI-F chief Maulana Fazlur Rehman and PTI senior leader Asad Qaiser attended the key meeting via video link, while Pakistan Peoples Party (PPP) Chairman Bilawal Bhutto-Zardari was not among the attendees.

Hoping to reach a consensus with the PPP on a joint draft, JUI-F Senator Kamran Murtaza said the drafts prepared by the two parties had just one difference of constitutional court and constitutional bench. Otherwise, he said, his party had no objection to the PPP's rest of the draft. Meanwhile, the special parliamentary body's meeting was adjourned till October 17, while a sub-committee was formed to contemplate all the drafts pertaining to the constitutional amendment. The sub-committee will submit its report to the main committee. The constitutional package, among other things, aims to set up a federal constitutional court and fix the tenure of the Chief Justice of Pakistan (CJP) for three years. The government had attempted to present the bill to amend the Constitution last month, but its allies as well as members from the opposition benches vehemently opposed the proposal, forcing the administration to begin a consultation process. It is pertinent here to mention that, JUI-F chief Fazl on Friday showed a willingness to support the government's "constitutional package" with "ifs and buts", while stressing the need for building consensus among all political forces.

Interacting with journalists after a meeting of the Special Committee of Parliament in Islamabad a day earlier, the JUI-F chief said: "We can agree on a very suitable draft if our proposals are accepted [by the government]." Fazl said: "We are trying to remove the 'controversial' contents from the draft." He said that people have rejected the concept of the government's draft of the constitutional amendments. "People are hailing the JUI-F's stance over the contentious constitutional amendments, Fazl stated, adding: "If parliament is representative of the people then it should not ignore their wishes."—RT/Agency

Senatorial reforms, recognizing that unity among parties is crucial for the nation's interest, he highlighted. By building alliances and fostering cooperation, Siddiqui hopes to create an environment conducive to passing the amendments. This collaborative approach demonstrates the PML-N's commitment to prioritizing the country's well-being over individual interests, he mentioned. Replying to a query, he said two key parties had submitted their proposal drafts for constitutional amendments to the committee overseeing the process, adding, Mulaana and PTI will jointly present other. Senator Irfan Siddiqui has clarified that there is no rush to amend the constitution and the date for the amendment can be adjusted as needed. However, he expressed optimism that the amendment proposals will mature following the Shanghai Cooperation Organization (SCO) conference.—RT/Agency

Bilawal Invites Public To Weigh In On PPP's Bold 26th Amendment Proposals

ISLAMABAD: Pakistan Peoples Party (PPP) Chairman Bilawal Bhutto-Zardari has called for public suggestions on improving the 26th constitutional amendment, sharing his party's proposed draft and inviting input for judicial reforms.



In a series of tweets on Saturday, Bilawal emphasised that the proposed amendment aligns with the unfinished agenda of the Charter of Democracy. He stated, "We propose the establishment of a federal constitutional court with equal representation from all federating units." According to Bilawal, the proposed court would address issues related to fundamental rights, constitutional interpretation, and disputes between the federation and provinces. "Our recommendation is to end the current process of judges being appointed by judges for judges," he said.

advocating for a new system that merges judicial and parliamentary committees to ensure equal roles for the judiciary, parliament, and the legal community. Bilawal also mentioned that the PPP had shared its draft proposal with the government months ago and recently with Jamiat Ulema-e-Islam (JUI-F) and a special parliamentary committee. "We are in productive talks with opposition parties, including JUI-F, to reach a consensus," he added. The PPP chairman invited citizens to submit "valid and meaningful suggestions" to further improve the amendment. He stressed that the party had already launched a broad nationwide consultation campaign, engaging political parties, bar associations, and civil society in the process. Bilawal expressed hope that the consultations would lead to a unified draft, paving the way for broad political consensus to pass the 26th amendment. "We believe a joint draft could form the foundation for wider political agreement," he stated.—RT/Agency



Over 5400 students compete in SAU's entry test for Undergraduate Admissions 2024-25

TANDO JAM: More than 5,426 candidates from across Pakistan participated in the entry test for Sindh Agriculture University (SAU), Tando Jam, for undergraduate admissions in the 2024-25 academic year. The entry test, conducted on Saturday at four different centers, included 955 female candidates among the total of 5,426 participants, all competing for various undergraduate programs. The test centers were established at Public School Hyderabad, Public School Sukkur, SAU Campus Umerkot, and the Balochistan University of Information Technology, Engineering, and Management Sciences (BUTEMS), Quetta. According to the university's official statement, 4091 candidates, including 631 females, appeared at the Hyderabad center. At Umerkot campus, 579 male and 77 female students took the test, while 566 male and 57 female candidates



participated in Sukkur. In Quetta, 54 male and 2 female candidates took the test. The entry test consisted of 100 multiple-choice questions (MCQs), which candidates had to complete within 100 minutes. The seat allocation for successful candidates includes 1,785 seats at the main campus, 318 at the Umerkot campus, and 220 at other centers. Strict security measures were in place at all test centers, including walk-through gates and the deployment of police and university security personnel to ensure a smooth and safe testing environment. Vice Chancellor of Sindh Agriculture University, Dr. Fateh Marri, visited the main test center at Public School Hyderabad to oversee the arrangements. He praised the excellent management and commended the enthusiasm of the candidates. Dr. Marri further stated that the inclusion of women in the agriculture sector is a game-changer and that the university is committed to providing every possible opportunity for their success in this field. Senior faculty members, deans, and heads of administrative departments were also present at the event.

Recovery of abducted student demanded in Khairpur

KHAIRPUR: Fourteen days after high school student Abdul Faheem was abducted, his family is in distress, with his parents deeply worried and his mother frequently fainting. Special Task Force raids drug factory, arrests three

JAM NAWAZ ALI: The Special Task Force against drugs, led by DSP Dr. Muhammad Moosa Abro, conducted a raid at a gaska factory in the Muzka Khaskheli village near Tando Adam. The operation resulted in the seizure of a large quantity of prepared gutka and machinery, along with the arrest of three suspects. During the raid at the residence of Mukhtar Ali Khaskheli, police recovered over 700,000 PKR worth of gutka, including more than ten bags filled with illegal substances. DIG Syed Pir Muhammad Shah, DC Fayaz Husaain Abbasi review arrangements for women's marathon


SUKKUR: A separate marathon race for women has been announced on December 25, as part of the Kotdiji-Sukkur Marathon 2024. The women's marathon will stretch over a distance of 10 kilometers, starting from Babro to Public School Sukkur. DIG Sukkur Pir Muhammad Shah made the announcement while chairing a meeting on marathon race arrangements, accompanied by Commissioner Sukkur Fayaz Husaain Abbasi at commissioner's office. Deputy Inspector General (DIG) Sukkur added that the city will host a marathon on December 25, featuring two events. The men's category will comprise a 42.195-kilometer marathon from Kotdiji to Sukkur, while the women's category will feature a 10-kilometer run from Babro to Public School Sukkur. He said that this is a national event aimed at showcasing the world that we have no shortage of talent. He further stated that to ensure participant safety, medical check-ups will be facilitated through the presence of 1122 ambulance services, doctors, medical staff, and essential medications during the marathon. He pointed that the road from Bhurgani to Garhi Bridge is severely damaged and falls short of national standards, requiring urgent upgrades. He sought



cooperation from the Motorway Police officers for arrangements for the closure of one side of N-5 traffic from Therli to Babro for 3 hours and assured that additional police personnel will be provided if there is a shortage of staff. He further stated that first aid camps will be established at various locations for the marathon race. These camps will be set up at intervals of either 10 kilometers or 5 kilometers, and the final decision will be made in the next meeting. Commissioner Sukkur, Fayaz Husaain Abbasi, directed that the repair work on Sukkur Barrage should be suspended on the day of the marathon and the historical site should be decorated. He also instructed the DC and DHO of Khairpur to arrange for medical check-ups and deploy doctors and paramedics for the local participants of the marathon. He directed that a report be presented regarding the establishment of an emergency ward at Khairpur Hospital on the day of the marathon. Moreover, he emphasized on all lined departments to demonstrate 100% performance to ensure the success of the marathon. He directed that work should be initiated immediately to improve the road conditions at various locations between Kotdiji and Sukkur. Additionally, the road from Kot Bungalow to Shah Abdul Latif University should be cleared before December 25. If funds are not available for road repairs, an urgent request should be made under M&R (Maintenance and Rehabilitation). Time is extremely limited, therefore, the road repair work must be completed on time. No compromise will be tolerated in this matter, he added. The meeting was attended by Deputy Commissioner Khairpur Syed Ahmed Fawad Shah, Additional Commissioner One Muhammad Amir, Regional Head 1122 Gulam Mustafa, Deputy Director Sports Mir Muhammad Kalhoro, XEN Sukkur Barrage Muhammad Zahid Mughal, Deputy Director Sukkur Irrshad Ali Memon, Additional DHO Khairpur Dr. Muhammad Rafique, Agha Haroon from Lok Sahaita, and officers from Motorway Police, among others.

Mehar Court brawl over property dispute leaves nine injured



MEHAR: In Mehar, a property dispute erupted into a violent brawl between two groups, injuring nine individuals during a court hearing. The chaos unfolded at the main gate of the Mehar court, resulting in the area resembling a battleground. Among the injured were Nawab Maheser, Abdul Rasool Maheser, Mehboob Liaquat, Sarfraz, Intiaz Maheser,

Shoukat, and Deedar Khoso. They were taken to the Taluka Hospital in Mehar for treatment. Despite the violence, police response was delayed, taking over half an hour to arrive as the two groups clashed within the court premises. During the altercation, attempts were made to snatch a rifle from a police officer on duty, who managed to retain it. Four police officers eventually apprehended three of the assailants. Former Mehar Bar Secretary Advocate Saeed Panhwar stated that incidents of violence have become common due to a lack of police presence in courts, citing a similar incident last year that resulted in the deaths of three individuals, including two brothers. The failure of Mehar police to enhance security in the court has allowed such violent occurrences to continue unabated.

Punjab Government Boosts Public Welfare Programs In Toba Tek Singh

PTI's D-Chowk Protest During SCO Conference A Conspiracy: Governor Kundi

ISLAMABAD: Governor Khyber Pakhtunkhwa Faisal Karim Kundi on Saturday said that the announcement of a Pakistan Tehreek-e-Insaf (PTI) protest at D-Chowk during the conduct of Shanghai Cooperation Organization (SCO) conference is part of a conspiracy.



He criticized PTI for consistently pursuing an agenda against the country and collaborating with enemies of the state. Kundi emphasized that they will not allow any plots to destabilize Pakistan to succeed and urged PTI to retract their call for protest on October 15.

Military Intervention Not Needed In Balochistan: CM Bugti



QUETTA: Balochistan Chief Minister Sardar Saifraz Bugti has emphasized the importance of creating a consensus against terrorism, stating that there is no need for military operations in the province.

Speaking to media at the Civil Hospital in Quetta on Saturday, Bugti asserted, "Balochistan is a vast province, and we will defend every inch of the state."

He highlighted the recent surge in terrorist activities, pointing out that militants often target soft targets in the region.

"Recently, individuals have been martyred in Balochistan as terrorists seek out these vulnerable targets. In Turbat, our forces successfully intercepted a vehicle loaded with explosives," he added.

Bugti expressed grave concern over the ongoing violence, stating that mere condemnation of terrorism is insufficient.

"If resigning could stop terrorism, I would do it in a heartbeat. My resignation is not a significant action, I

Sindh Outpaces All Provinces in Tax Collection Despite Lower Rates

KARACHI: Sindh's tax collection has outperformed all provinces this year, according to the Sindh Revenue Board (SRB), despite a lower tax rate. Chairman of the Sindh Revenue Board, Wasif Memon, revealed that the target for the previous financial year was set at Rs235 billion, but the province managed to collect Rs237 billion.

He added that for the current financial year, a target of Rs350 billion has been set.

In an exclusive interview with media on Saturday, Memon noted that the restaurant sector has been increasing, particularly after the implementation of the Point of Sale (POS) system, which has seen tax collection rise from Rs20 million to Rs80 million.

He explained that an eight per cent tax is applied to card payments, while a 15 per cent tax is levied on cash payments.

Some restaurant owners have expressed their objection to the higher cash payment tax, insisting they would only charge 15 per cent. Memon emphasized that technology is being utilized to combat tax evasion. He also mentioned that this financial year, intra-city goods transporters have been included in the tax net, as well as educational institutions and hospitals, which is expected to further boost the province's revenue. —RT/Agency

A perennial source of embarrassment for Pakistan

The Pakistan cricket team, once a symbol of national pride and a formidable force in the cricketing world, now finds itself in a state of disarray. What was once a team that evoked fear and admiration on the pitch has become a laughing stock, unable to string together consistent performances. Their recent series of defeats, including a whitewash by Bangladesh and a humiliating innings loss to England despite scoring over 500 runs in the first innings, has left fans and experts questioning the state of the game in the country.

The problem isn't just about losing matches; it's about a systemic decline. Pakistan cricket has long been known for producing world-class talent and thrilling matches, but now the team appears to lack direction, consistency, and mental resilience. Frequent second-innings collapses have become a painful routine, and despite efforts to improve physical and mental fitness, little progress has been made. The

leadership, both on and off the field, seems unable to stop this downward spiral.

With six consecutive Test losses under their belt, it's clear that the current setup isn't working. Harry Brook has everything to be England's finest: Anderson



MULTAN: England batter Harry Brook has all the attributes needed to overtake the country's highest run-scorer in Test cricket, Joe Root, and former top order batter Kevin Pietersen, bowling great James Anderson said.

The 25-year-old Brook became the first England batter in 34 years to score a triple-century when his side thrashed Pakistan by an innings and 47 runs on the fifth day of their opening Test of the three-match series in Multan on Friday.

Root, 33, made a double ton during the same Test, placing him fifth on the all-time list with 12,664 runs.

"He's on the way to being in the top three that I've played with," Anderson said on the Tailenders podcast on Friday.

Root, Pietersen and him. He's definitely got all the attributes to overtake them.

"He's just got everything. Without trying to big him up too much because he's still really early in his Test career, I

do think that he's got the perfect amount of each of those two and that's what will make him the best that we've ever had."

Anderson, 42, retired in July after finishing his 188th Test and having taken 704 wickets in a career spanning 21 years, during which he became the third-highest wicket-taker in the format.

"But he's got the shots of both Root and Pietersen. He can destroy an attack if he wants to, he can play a longer innings if he needs to," Anderson added.

"The thing that's really similar between Root and Brook is that they love batting. They literally couldn't care less what format it is. They just want to bat."

Pakistan's Asim Khan, Aashab Irfan advance to final of Mile High 360 Squash Classic

KARACHI: Pakistan's Muhammad Asim Khan and Muhammad Aashab Irfan secured their places in the final of the Mile High 360 Squash Classic after winning their semifinal matches earlier on Saturday.

seeded Tom Walsh, winning 11-8, 11-7, 11-3 in 46 minutes.

Irfan's aggressive play gave Walsh little opportunity to respond as he swiftly advanced to the final.

The final will feature an all-Pakistani clash between Khan and Irfan. Earlier, Khan faced a challenging quarter-final against second seed Cesar Salazar of Mexico. After taking a 2-1 lead, Salazar retired in the fourth game, handing Khan victory with a final scoreline of 12-10, 2-11, 11-7, and 11-0.

On the other side, as Khan defeated India's Veer Chotrani, Irfan produced a strong showing against Dillon Huang of the United States.—Agency

Women's national football team finally gets clearance for SAFF Championship



KARACHI: In a positive development, the women's national football team finally received on Saturday a no objection certificate (NOC) to participate in the SAFF Women's Championship.

The team received the clearance from the Pakistan Sports Board (PSB) just three hours before their flight to Kathmandu, Nepal, where the event is scheduled to take place from October 17 to 30.

The PSB had initially declined the NOC request, citing delays in the necessary documentation from the Normalisation Committee (NC) of the Pakistan Football Federation (PFF).

The board had demanded the NC to submit the required paperwork to facilitate the NOC process. However, due to administrative issues, this wasn't followed and technicalities left the team in an uncertain scenario just days before the championship.

In a letter from the PSB, the board stated: "Based on the undertaking given by Muhammad Shahid Niaz Khokhar, Member, Normalisation Committee of Pakistan Football Federation, the Pakistan Sports Board has no objection on participation of Pakistan Women National Football Team to participate in SAFF Football Championship to be held in Nepal from 17th to 30th October, 2024."

The PSB sources claimed that the board's decision to issue the NOC was driven by a committee to support the athletes, despite the procedural shortcomings from the PFF. The sources noted that the PSB aimed to ensure the team's participation in the SAFF Championship, recognising the importance of international competition for the development of women's football in Pakistan.—Agency

Over-hyped players lose touch with reality, Arthur warns Pakistani stars

KARACHI: Former Pakistan cricket coach Mickey Arthur has expressed concerns over the impact of excessive promotion of players, stating that it distances them from reality and makes them believe they are more important than they actually are.

"The inconsistency around selection, environment, and administration plays a role in team morale, gives the players structure, and they will perform," said Arthur in a post on X.

His remarks come against the backdrop of the Shan Masood-led side's baffling defeat against England where the latter secured an innings and 47-run victory on the fifth day of the first Test in Multan.

During the match, despite



scoring 556 runs in the first innings, the national side found themselves under the gun trailing England by 115 runs at the end of the fourth day and subsequently crumbled under pressure on the final day.

Arthur emphasised that Pakistan's players are exceptionally talented and deserving of their spots on the team. However, he stressed that in order to improve performance, consistency in selection, environment, and administration is crucial.

"The players are very, very skilled and are the right ones," said ex-coach.

He also pointed out the harmful role of media-driven narratives, describing how the media's negative rhetoric can hurt the team noting that the "vile rhetoric from media and media-driven agendas do not help".

A key point in Arthur's critique was the overpromotion of players by agents or the media, which he believes gives them a false sense of importance.

"The promotion of players by player agents or media makes the player sometimes think he is way more important than he is in reality, creating a false view," Arthur highlighted. The former coach emphasised that representing Pakistan should be the highlight of a player's career.—Agency

PCB will conduct fitness tests of four players before second Test against England



LAHORE: The Pakistan Cricket Board (PCB) has decided to conduct fitness tests for four national team players ahead of the second Test match against England, set to begin in Multan on October 15.

According to sources, Kamran Ghulam, Zahid Mahmood, Imam-ul-Haq, and Nauman Ali have been summoned to Multan for these fitness evaluations, which are expected to take place today.

Prior to the series opener, Nauman and Zahid were released from the squad for the first Test due to their inability to meet the required fitness standards.

Additionally, sources

reveal that spinner Abrar Ahmed, who has been ruled out of the second Test, remains under medical care in a hospital.

It is worth noting that England defeated Pakistan by an innings and 47 runs in the first Test at Multan, starting at 152/6, were bowled out for 220, with Salman Ali Agha top-scoring (63). Jack Leach took 4 wickets for England, while Aamir Jamal remained unbeaten on 55.

The second Test is crucial for Pakistan, as they aim to bounce back due to a defeat in the first Test, which has given England a 1-0 lead in the series.—Agency

Plimmer's half-century helps New Zealand thump Sri Lanka

SHARJAH: Georgia Plimmer's anchoring half-century powered New Zealand to a thumping eight-wicket victory over Sri Lanka in the 15th match of the ICC Women's T20 World Cup 2024 here at Sharjah Cricket Stadium on Saturday.

Opting to bat first, Sri Lanka only managed 115/5 in the allotted 20 overs despite Chamari Athapaththu's sensible knock up the order.

The Asian champions got off to a briefly flying start to their innings with Athapaththu dominating the Proteas bowlers.

The brisk opening stand ended in the fourth over when Vismithi Gunaratne perished after a scratchy eight-run knock.

Gunaratne's dismissal pushed Sri Lanka to the backfoot, and Athapaththu then put together a cautious partnership with Harshitha Samarawickrama that lasted for 10 overs and only yielded 48 runs.



Sri Lanka then suffered a massive blow to their batting expedition as both Athapaththu and Samarawickrama perished in quick succession, leaving their side reeling at 76/3 in 14.2 overs.

Athapaththu remained the top-scorer for Sri Lanka with a 41-ball 35 while Samarawickrama made 18 off 29 balls.

Sri Lanka soon lost two more wickets as Kavisha Dilhari and Anushka Sanjeevani walked back after modest contributions before an unbeaten 18-run partnership between Nilakshika Silva and Ama Kachana gave a late push to their total.

Leigh Kasperok and Amelia Kerr claimed two wickets each for New Zealand, followed by Eden Carson with one.

In response, New Zealand comfortably chased down the modest target for the loss of just two wickets and 15 balls to spare.

They highlighted that surgeries, which usually cost lakhs, are provided at no charge as part of their campaign to raise awareness and encourage early intervention. Dr. Musyri also noted that prenatal ultrasounds can detect clubfoot, and post-birth symptoms include short, wide feet, downward heels, upward-pointing forefeet, stiff heels, and tightened shin tendons. The SAFCO Group founder Suleman G. Abro expressed gratitude to the doctors, commending Dr. Musyri and his team for their dedication to this noble cause.

Sindh CM Approves Key Reforms, Increases Minimum Wage For Labourers



KARACHI: The Sindh Government has approved a significant increase in the minimum wage, raising it to Rs 37,000 during a provincial cabinet meeting chaired by Chief Minister Murad Ali Shah. The session also focused on improving policing across the province.

Under the new reforms, 407 police stations across Sindh will receive allocated budgets, with Station House Officers (SHOs) authorized to utilize special funds. Police stations in different categories will have tailored budgets, with Category A stations in Karachi receiving Rs 15.2 million. SHOs will be permitted to spend up to Rs 0.2 million per month. The cabinet also approved amendments to the rules of the Sindh Public Service Commission (SPSC), allowing for the creation of a waiting list for vacant positions. In addition, nine dispensaries in Tharparkar will be operated in partnership with NGOs, and the Health Department plans to abolish 731 vacant posts. During the meeting, the cabinet also called for a halt to the excessive fines being imposed on the public by electricity distribution companies.—RT

Political Interests, Not Principles, Driving Constitutional Amendments: Farooq Sattar

ISLAMABAD: MQM Pakistan leader Farooq Sattar has stated that the proposed constitutional amendments were being made not on principles but based on political interests.



In response to a question about supporting the proposed amendments, Sattar noted that the MQM has yet to see the draft of the constitutional reform.

He further explained that the amendments being introduced were influenced by political necessities, noting that if the PTI were in power, they would also propose similar amendments. Sattar added that the PTI was also in agreement on enhancing the role of Parliament in the appointment of judges and constitutional courts.—RT/Agency

Karachi Airport Blast Tied To Foreign Intelligence Agency

KARACHI: A preliminary investigation into the recent explosion near Karachi's Jinnah International Airport suggests foreign intelligence agency involvement in the attack, according to a report submitted by the Counter-Terrorism Department (CTD) to an anti-terrorism court.



The report indicates that the suicide bombing, which targeted Chinese engineers, was part of a broader conspiracy aimed at undermining Pakistan-China relations. The Balochistan Liberation Army (BLA) has been identified as a key player in orchestrating the attack.

The investigation reveals that an unidentified terrorist parked a vehicle near a convoy of Chinese nationals before detonating the explosives. The blast took place near the exit signal at Jinnah International Terminal, directly in front of the Civil Aviation Authority (CAA) guardroom. International Lawyers Forum Urges National Referendum On 26th Constitutional Amendment

KARACHI: The International Lawyers Forum (ILF) has called for a nationwide referendum on the proposed 26th Constitutional Amendment, raising concerns about the credibility of current parliamentarians and the lack of unity among political parties.



Addressing the media, ILF Chairman Nasir Ahmed Advocate stressed that public confidence in the existing political leadership is at an all-time low. He pointed out that unresolved election disputes in the courts have further complicated the country's political situation. "Given the current parliamentary and political turmoil, the most appropriate step is to allow the public to express their views directly through a referendum," said Nasir Ahmed. He argued that with the ongoing lack of national cohesion and the significance of this constitutional amendment, relying solely on parliamentary procedures may not accurately represent the people's will. The 26th Constitutional Amendment could bring significant changes to Pakistan's governance framework, and the ILF believed that a referendum would ensure transparency and restore public trust in the democratic process. The ILF's appeal comes amid rising political tensions, with both government and opposition factions struggling to reach an agreement. The forum hopes that a referendum would offer a more democratic and inclusive resolution to the current political deadlock.—RT

Sialkot School Trip Tragedy: One Student Killed, Several Injured In Islamabad Bus Crash

ISLAMABAD: A school trip took a tragic turn when a bus carrying students from Sialkot on Saturday involved in an accident at Shakarparian, Islamabad.



According to a spokesman for the Islamabad Capital Territory (ICT) administration, one student lost his life, and seven others sustained serious injuries in the crash. Officials stated that they are working closely with both the school administration and Sialkot district authorities to ensure the students' safe journey back home.—RT/Agency

Coal Miners Strike Following Duki Terror Attack


DUKI: Labour organisations have gone on strike, with coal miners ceasing operations to protest the deadly terror attack in Duki earlier this week.

IMF Alarm Bells: Pakistan Trails Regional Neighbors In Living Standards

ISLAMABAD: The International Monetary Fund (IMF) has underscored "the need for urgent" policy reforms in Pakistan in its recent staff report, saying that the country has failed to match the living standards of its peers in the region, media reported on Saturday.

"Pakistan has been falling behind its peers in recent decades in terms of income per capita, competitiveness, and export performance. From 2000 to 2022, Pakistan's GDP per capita grew at an average annual rate of only 1.9%," the report read.

As per the report, Pakistan's peers achieved more than twice the aforementioned growth of 4.5%. India reached 4.9%, Vietnam 5%, and China a growth of about 7.5%," the Washington-based report stated.

The IMF has reviewed the last 10 years of its sponsored programmes in Pakistan and acknowledged that



underlying challenges have persisted, recommending enhanced ownership as a key lesson learned.

The IMF evaluated Pakistan's performance over the past decade. During this period, Pakistan had three upper credit tranche arrangements and one use of the Rapid Financing Instrument under the General Reserve Account (GRA).

These programmes were generally initiated against the backdrop of weak external conditions or unprecedented external shocks, such as the COVID-19 pandemic

and floods, combined with prolonged fiscal and external vulnerabilities, along with structural challenges. Although early progress was often made due to stronger policies under fund-supported programmes, this progress was not sustained, leading to the re-emergence of imbalances and the need for successor programmes.

To be effective, programme conditionality needs to evolve to capture emerging risks and policy issues. For the new Extended Fund Facility (EFF), this is particularly important. During the 2013 EFF, reform efforts weakened, leading to 13 waivers being required. While spending and external borrowing were initially contained, large future borrowing commitments set the stage for the re-emergence of imbalances.

It has emerged, under the IMF's \$7 billion EFF, Pakistan has accepted 22 conditions, including a written commitment to phase out incentives for Special Economic Zones (SEZs) by 2035.

The government will prepare a phased plan by June 2025 to eliminate all current SEZ incentives. Additionally, Pakistan has agreed to adjust gas tariffs by the end of December 2024 and impose a 5% Federal Excise Duty (FED) on fertilisers and pesticides in the 2025-26 budget.

To enhance the anti-corruption framework's effectiveness, the government will amend the Civil Servants Act by February 2025.

Brace For Impact: Petrol and Diesel Prices Set To Soar In Upcoming Review

KARACHI: The price of petroleum products is likely to rise up to Rs10 per litre in the upcoming review in the wake of a spike in global petroleum prices, media reported on Saturday.

According to estimates from the oil sector, petrol price may surge by Rs3-4 per litre, while the price of high-speed diesel (HSD) is expected to increase by more than Rs10 per litre.

The price of HSD is expected to increase by more than Rs10 per litre in the next price review, following a spike in global oil prices.

The demand for petroleum products, particularly HSD, has surged significantly in recent days, driven by expectations of the upcoming price hike in the next fortnightly review.

According to insiders in the oil sector, the rise in HSD demand is unexpected, as there was no significant increase in demand from the industrial or agricultural sectors.

"The surge is primarily due to dealers hoarding petroleum products, especially HSD, in anticipation of a price hike," they explained.

Industry experts noted that the average daily sale of HSD has jumped to 24,000



litres, compared to the usual 16,000-17,000 litres per day.

They dismissed claims that the government's crackdown on smuggling has contributed to the increase in legal HSD sales.

"It is mainly hoarding by oil marketing companies (OMCs) and dealers aiming to maximise profits before the expected price hike," they said.

A top official at a refinery confirmed the recent surge in HSD sales.

"We are selling more HSD than usual, but we're unsure if this is due to hoarding by oil marketing companies or dealers ahead of the price increase," the official said.

He added that the true demand for HSD will become clear after the price review, which will show whether the increased sales are driven by

genuine demand or hoarding. In recent months, the country has faced an oversupply of diesel due to low consumption. HSD demand has dropped from 750,000 tonnes per month to just 500,000 tonnes, driven by several factors, including smuggling. "With reduced demand, local refineries can easily meet about 80% of the country's needs," the Oil Companies Advisory Council (OCAC) wrote in a letter to the government a while back.

The letter opposed the government's decision to allow a private oil marketing company to import HSD. "There is no justification for importing excessive HSD, yet imports were allowed in recent months, leading to a serious glut and operational challenges for local refineries," the OCAC had said.—RT/Agency

'Political Terrorism': Ahsan Iqbal Slams PTI's October 15 Protest Plans

ISLAMABAD: Planning Minister Ahsan Iqbal on Saturday strongly condemned the PTI's D-Chowk protest call for October 15, when the two-day Shanghai Cooperation Organisation (SCO) summit is set to begin, as "political terrorism," aimed at maligning the country and stopping its development and economic progress.

The PTI has announced the suspension of its protests in Punjab and issued a nationwide call urging party leaders and workers to converge in Islamabad on Oct 15. The PTI has also demanded immediate action for party leaders and family members to its founder, Imran Khan, who is incarcerated in Adiala Jail. The government earlier banned visits to prisoners at Adiala Jail until Oct 18 due to security concerns related to the high-profile SCO summit.



Addressing a press conference in Islamabad, the planning minister expressed disappointment at the timing of the PTI's protest coinciding with the SCO summit, which he said was a great honour for the country.

"Now there is no doubt, that terrorism in Karachi and political terrorism protest calls are similar," the minister said adding that the "scriptwriter" was the same person who on one hand was using terrorists to carry out

economic recovery efforts. It's crucial to acknowledge the damage caused by these actions and consider the consequences of supporting policies that hinder Pakistan's growth and development," he urged.

The minister said the country cannot afford to indulge in destructive politics. "Just because PTI's leader is jailed, doesn't justify chaos," he said.

The minister said that it was a proud moment for Pakistan to host the SCO summit on Oct 15-16 and a significant diplomatic achievement for the country.

Separately, Defence Minister Khawaja Asif said while speaking to the media in Sialkot that the courts should take notice of the protest call, saying they were bound to do so.

"The state will use all its power, resources and might ... to stop this attack at the

country's repute," he said, adding that the government would not allow anyone to sabotage the SCO moot.

"Absolutely not," the defence minister vowed.

Meanwhile, Federal Minister for Kashmir Affairs and Gilgit Baltistan Amir Muqam also strongly rejected the PTI's protest call.

"It is proof of anti-nationalism. There is no doubt that PTI's agenda seemed to be anti-Pakistan because PTI has declared the protest on this important occasion."

He added that the PTI "once again showed its real face as the meeting of SCO is very important for Pakistan."

The minister noted that in any case, the protest could not be allowed on the occasion and the protest call was "condemnable and very sad," adding that protests and processions could be held at any other time.—RT/Agency

Abbasi Fires Back Against Controversial Constitutional Amendments

ISLAMABAD: Senior politician Shahid Khaqan Abbasi has strongly opposed the proposed 26th Constitutional Amendment, stating that undermining the judiciary's independence is not a solution to past mistakes.

In a statement on the proposed amendments, Abbasi, an Awam Pakistan Party leader, voiced concerns over the government's actions, questioning its mandate.

He warned that the proposed amendment would severely impact the judiciary's autonomy.

"The proposed law allowing the transfer of High Court judges will be used to put them under pressure," Abbasi said, further stating that this would weaken the protection of citizens' fundamental rights.

He also criticised the introduction of a Federal Constitutional Court, suggesting it would diminish the role of Supreme Court judges.

Abbasi also raised alarms over the potential expansion of military court trials, describing them as a direct assault on civil liberties.

"Destroying judicial independence is not a remedy



for the bad decisions of the past," Abbasi concluded, firmly opposing any move that threatens the core values of the justice system.

He has previously called for Chief Justice of Pakistan Qazi Faez Isa to retire after completing his tenure, amidst what he described as political instability and chaos in the country.

Furthermore, Jamiat Ulama-e-Islam (JUI-F) Chief Maulana Fazlur Rehman on October 11 expressed conditional support for the government's proposed constitutional amendments, emphasising the need for consensus among political forces.

Following a Special Committee of Parliament meeting, Rehman said: "We are trying to remove the controversial contents from the draft."

He added that the public had rejected the government's initial draft.

The constitutional package aims to establish a federal constitutional court and set a three-year tenure for the Chief Justice of Pakistan (CJP). The government initially attempted to present the amendments last month, but faced resistance from both allies and opposition members, prompting a consultation process.—RT/Agency

Pakistan Army Shines With Gold At UK's Elite Cambrian Patrol 2024

LONDON: The Pakistan Army Cambrian Team has won gold in Exercise Cambrian Patrol 2024 by securing the highest points 864 in Ex CP-24 and defeated 118 teams representing Europe.

The 67 Punjab Regiment won the gold medal by securing the highest-ever 864 points in the competition which also included teams from entire Europe. 67 Punjab Regiment participated in the event for the second consecutive year after standing first in the Pakistan Army's internal competition. The premier patrolling event has been running for over 60 years and is the British Army's principal All Arms



Patrol Exercise. It is open to all three Services (Regular and Reserve) and international participants. Army and Air Adviser UK Col Taimur Rahat said that Cambrian Patrol is the world's most challenging test of basic soldiering skills, especially under

The deposed prime minister has been incarcerated at the facility for over a year since his arrest in case related to state gifts.

The jailer said that all facilities were available to the PTI founder as before and he never complained about the comfort and convenience in

the jail. "Shaukat Khan Hospital doctors came to the jail, examined his teeth and gave medicines which made him healthy. He did not complain of hemorrhoids or any other such ailment after coming to prison," he added.

Khan is imprisoned under better-class (B-class) facilities with high security due to his status as a former premier. He is facing several cases, including the £190 million reference, the Toshakhana case and others.

Anjum termed the speculations about Khan's health baseless, saying that the cricketer-turned-politician "works out for about three hours intensely without interruption".
