Nawaz Calls For Cricket Diplomacy, Urges Peace with India In Meeting With Indian Journalists

ISLAMABAD: Pakistan Muslim League-Nawaz President Nawaz Sharif met with a delegation of Indian journalists covering the Shanghai Cooperation Organisation (SCO) conference, where he shared his thoughts on the restoration of Pakistan-India relations and cricketing ties.



The meeting took place in Lahore, with Punjab Chief Minister Maryam Nawaz also in attendance. During the discussion, Nawaz expressed optimism about the potential for the SCO conference to serve as a starting point for improved relations between the two neighbours.

Shehbaz-Zardari Huddle: High-Stakes Talk On Constitutional Amendments

ISLAMABAD: Prime Minister Shehbaz Sharif has met with President Asif Ali Zardari at the President house to discuss proposed constitutional amendments and the prevailing political situation.



The meeting on Thursday comes as the Pakistan Muslim League-Nawaz (PML-N) and Pakistan Peoples Party (PPP) step back from their earlier proposal to establish constitutional courts, media reported.

Moreover, during a special parliamentary committee meeting, chaired by Khurshid Shah, discussions were held on the 26th constitutional amendment draft. According to sources, the governing coalition parties and Jamiat Ulema-e-Islam (JUI-F) have agreed to drop the proposed 26th constitutional amendment, which called for the creation of constitutional courts.

Instead, they reached a consensus on forming a constitutional bench.

The special committee meeting concluded with the government and JUI-F deciding to consult the Pakistan Tehreek-e-Insaf (PTI) on a joint draft. JUI-F leader Maulana Fazlur Rehman will share the finalised draft with PTI leadership, marking the nearing completion of the amendment process.

PM in High-Level Talks With SCO's Zhang Ming: Development On The Agenda

ISLAMABAD: Prime Minister Shehbaz Sharif met with the Secretary-General of the Shanghai Cooperation Organisation (SCO), Zhang Ming, to discuss Pakistan's leadership role in the organisation.



The meeting took place at the Prime Minister's House in Islamabad, according to media.

Zhang Ming visited Pakistan to attend the SCO Council of Heads of Government (CHG) meeting. During their discussion, the Prime Minister welcomed Zhang, recalling his visit to Pakistan in July 2022.

Shehbaz expressed gratitude for the support provided by the SCO Secretariat for the upcoming CHG meeting. Reaffirming Pakistan's commitment to the SCO charter, the Prime Minister

assured Zhang that Pakistan would continue to work diligently to promote the organisation's developmental priorities for the benefit of member states and the wider region. He further emphasised that Pakistan aims to strengthen and enhance the effectiveness of the SCO in collaboration with member nations. Zhang congratulated the Prime Minister on the successful organisation of the CHG meeting and commended Pakistan's constructive contributions across all SCO sectors.—RT/Agency

Israel Boasts: 'We Took Out Hamas Boss Yahya Sinwar'

GAZA: Israel claimed on Thursday that its forces killed Hamas chief Yahya Sinwar in a Gaza operation, dealing a massive blow to the group it has been fighting since October 7, 2023.



"Eliminated: Yahya Sinwar," the Israeli Defence Forces (IDF) said in a post on X.

The military said that "after a year-long pursuit", soldiers "eliminated Yahya Sinwar... in an operation in the southern Gaza Strip" on Wednesday. Hamas has not confirmed his death.

"The mass murderer Yahya Sinwar, responsible for the massacre and atrocities of October 7th, was eliminated today by IDF (Israeli Defence Forces) soldiers," Israeli Foreign Minister Israel Katz said in a statement sent to media.

Israel accused Sinwar of masterminding the attack and was hunting him down since the start of the Gaza conflict. Israel's raging military offensive has killed over 42,000 Palestinians, including women and children.

In a brief statement, the military earlier said that during "operations in the Gaza Strip, three terrorists were eliminated".

Israeli defence agencies "are checking the possibility that one of the terrorists was Yahya Sinwar. At this stage, the identity of the terrorists cannot be confirmed", the statement added.

Akhtar Mengal's Dramatic Return: Will He Steer Through The Political Storm?



ISLAMABAD: Sardar Akhtar Mengal, leader of the Balochistan National Party (BNP), has decided to return to Pakistan in light of the country's current political situation, media learnt on Thursday.

Supporting the constitutional amendments "in such a situation, our only option may be to ask both senators to resign," he stated.

A day before, Islamabad police had visited Mengal's apartment in the Parliament Lodges. BNP's acting president, Sajid Tareen, alleged that the police raided the flat, though Mengal was not present. The police, however, claimed they acted based on intelligence reports regarding the occupants of the apartment.

Tareen condemned the raid, asserting that such actions would not intimidate the BNP into supporting the government. He maintained that the party's senators would not yield to pressure during the judicial reforms voting.—RT/Agency

He is expected to arrive in Islamabad tomorrow morning from Dubai and will announce his next steps after consultations.

Two days ago, Mengal claimed on social media that two of his party's senators were being harassed for not supporting the constitutional amendments.

The ruling parties, Pakistan Muslim League-N (PML-N) and Pakistan Peoples Party (PPP), succeeded in convincing MQM. However, MQM's constitutional amendments will be considered in the next 27th constitutional amendment, with the party expressing agreement with the government's suggestions.—RT/Agency

Drama Unfolds: Government And Opposition Strike Deal On 'Constitutional Bench'

ISLAMABAD: All the political parties, including the opposition, have finally reached a consensus on the formation of a constitutional bench after the Pakistan Muslim League-Nawaz (PML-N) and the Pakistan Peoples Party (PPP) took a step back on the matter of the constitutional court, sources privy to the development claimed.



The matter, initially focused on the constitutional court, has now advanced to the formation of a constitutional bench, they told media on Thursday.

After high-level discussions, four leaders of the Pakistan Tehreek-e-Insaf (PTI) and the PPP claimed an agreement had been reached among all the political parties on the formation of the constitutional bench, as per the insiders.

This comes after another meeting of the special committee on constitutional amendments draft concluded on Thursday. The parliamentary committee's meeting has been adjourned till noon on Friday (tomorrow).

To pass the constitutional amendments, the government requires a two-thirds majority in parliament, with sources indicating a shortfall of 13 votes in the National Assembly and nine in the Senate.

The PTI chief said he would later hold a meeting with Jamiat Ulema-e-Islam-Fazl (JUI-F) chief Maulana Fazlur Rehman on the matter as well.

Earlier, the PTI chief claimed that the coalition government's seven members of the National Assembly (MNAs) would vote against the proposed constitutional amendments.

The government had attempted to present the bill to amend the Constitution last month, but its allies as well as members from the opposition benches vehemently opposed the proposal, forcing the ruling parties to begin a consultation process.

"The government's numbers are only complete in their books. The government neither consulted its members nor answered out of fear," he told Geo News.

He said he had received the news about the seven treasury benches members' refusal to cast vote from reliable sources.

"The government members said they will not vote even if they are disqualified," he said, adding that the legislators believe those voting in favour of the constitutional amendments would be doing so against their conscious.

Probably, he said, PPP Chairman Bilawal Bhatto-Zardari also knew that parliamentary members of his own party were not going to vote for the amendment.

Talking to media, after conclusion of the meeting, PPP leader Syed Khurshid Shah said the constitutional amendments' draft would be completed in two days.

Finance Minister Updates US Ambassador On Pakistan's Economic Makeover

ISLAMABAD: Minister for Finance and Revenue Senator Muhammad Aurangzeb on Thursday reiterated the government's resolve to carry on with broad-based reforms on taxation, energy and state-owned enterprise (SOE) fronts. The minister was talking to United States (US) Ambassador Donald Blome who called on him and discussed matters of mutual interest and bilateral cooperation, said a news release. Aurangzeb said the government was committed to raising the country's tax to Gross Domestic Product (GDP) ratio to 13.5 per cent by plugging leakages and bringing untaxed sectors in the net. He said the government under dynamic leadership of Prime Minister Shehbaz Sharif had approved a comprehensive transformation plan for Federal Board of Revenue (FBR) and brought in experts on the Board of PRAL (IT arm of



FBR) The minister called the macroeconomic reforms "work in progress" and pointed to more serious challenges of climate change and child stunting which threatened to perpetuate inequalities and disrupt the pace of economic growth and stability in Pakistan over the medium to long term. Pakistan looked forward to build climate resilience through adaptation reforms and averting malnutrition with the technical and financial support of development partners for ensuring holistic development goals, he added. US Ambassador appreciated Pakistan's efforts for improving macroeconomic stability and lauded the government for initiating challenging and bold reforms, particularly in the taxation and energy sectors. He reaffirmed his commitment to enhancing bilateral cooperation in technical and development initiatives, and promoting high-quality US investment for economic growth of Pakistan.—RT/Agency

Tando Allahyar Police arrest 842 suspects during ongoing anti-crime operations

TANDO ALLAHYAR: In a concerted effort to combat crime, the Tando Allahyar police have successfully arrested 842 suspects as part of a series of anti-crime operations initiated under the direction of DIG Hyderabad Range, Tariq Razzaq Dharejo, and implemented by SSP Tando Allahyar, Abrez Ali Abbasi. These operations have focused on tackling drug dealers, habitual offenders, and the trafficking of illegal substances over the past six months.

From April 11, 2024, to October 15, 2024, the police conducted extensive operations, resulting in the registration of 514 cases. The crackdown has yielded significant quantities of contraband, including the seizure of 54 kg of hashish and 9,427 kg of raw materials used in drug production. Additionally, authorities confiscated a staggering 333,850 pieces of Indian Safina Gutka and 6,943 liters of locally-produced

alcohol. In a further effort to dismantle illegal operations, law enforcement officials seized 571 grams of ice/heroin, 39,385 pieces of mainpuri, and 12,380 pieces of mawa gutka. The operations also led to the recovery of 39 motorcycles, two four-wheel vehicles, and 36 illegal firearms, indicating a robust response to both drug-related crimes and violent offenses in the district.

These operations reflect the police department's commitment to enhancing public safety and reducing crime rates in Tando Allahyar.

The continued focus on eradicating illegal substances and apprehending offenders is seen as a crucial step in fostering a safer environment for residents. The police leadership has emphasized the importance of community cooperation in these efforts, urging citizens to remain vigilant and report any suspicious activities.

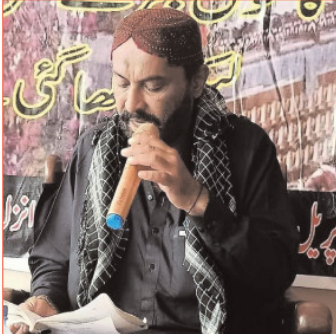

Controversial police encounter claims life of Tando Adam law student

TANDO ADAM: In a tragic turn of events, 20-year-old Sajjan Malookani, a law student from Tando Adam, was reportedly killed by police during a controversial encounter in Rahimiyar Khan. The shocking news of his death has sparked outrage among his family and the local community, prompting them to mobilize as they make their way to collect his body. Sajjan had been missing for 14 months, during which his family tirelessly protested across various cities in Sindh, advocating for his safe return. His mother, Lakhi, wife of Ali Dost Malookani, had taken her fight to the legal arena by filing a petition in the Sindh High Court through Advocate Mohib Ali Azad, alleging that her son had been forcibly taken.

His brother, Rawal Malookani, confirmed that Sajjan had been shot six days prior, and his body was subsequently found at the morgue of Rahimiyar Khan Civil Hospital. Frustration mounted within the family as they faced delays in the police's release of the body, which took over ten hours following identification. The family plans to lay Sajjan to rest in their village, Dhani Bus Malookani, Rawal emphasized that his brother had no political affiliations and was solely dedicated to his studies. He further noted that a petition regarding Sajjan's abduction had already been submitted to the Hyderabad High Court, reflecting the family's ongoing struggle for justice. This incident has raised serious concerns about police conduct and the handling of encounters, igniting calls for accountability and reform within law enforcement. The Malookani family's tragedy highlights the broader issues of enforced disappearances and the need for greater protections for individuals, particularly those who are vulnerable.

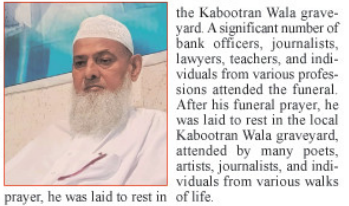

Canada Must Stand Firm Against India's Rogue Behavior

Canada's strong stance against India's alleged involvement in the murder of a Sikh leader on Canadian soil marks a critical moment. Prime Minister Justin Trudeau's statement that India made a "horrific mistake" by interfering so aggressively underscores the need for Western nations to prioritize sovereignty and security over economic enticements. For too long, India's strategic importance as a large market has allowed it to evade scrutiny over questionable actions, from its aggressive posture in Kashmir to crackdowns on dissenting voices abroad. But now, Canada's resolve signals a necessary shift.

India's alleged actions reflect a disturbing pattern, reminiscent of strategies employed by Israel in targeting perceived threats beyond its borders. This "rogue state" behavior, if left unchecked, sets a dangerous precedent where powerful nations can operate with impunity on foreign soil, violating international norms and threatening the safety of dissidents worldwide. By expelling Indian diplomats, Canada has sent a message that such actions will not be tolerated. However, more than symbolic gestures

are needed; Canada must lead efforts to hold India accountable through international diplomatic pressure and alliances. Western powers must no longer turn a blind eye in exchange for economic ties. Upholding the rule of law and respecting the sovereignty of nations should be non-negotiable principles. India's denial of wrongdoing and subsequent expulsion of Canadian diplomats only deepens the need for a unified global response. Canada's leadership in this matter could set the stage for other nations to join in demanding accountability. The world must take a stand: national sovereignty cannot be compromised, no matter how tempting the economic gains may be.

Kohli Dethrones Dhoni as India's Ultimate Ironman



Indian cricket legend Virat Kohli has added another achievement to his name by becoming the second most capped player in India's cricket history.

Kohli overtook former captain MS Dhoni, making his 536th international appearance during the first Test against New Zealand. Dhoni, who played 535 matches for India between 2004 and 2019, now sits in third place.

The only player ahead of Kohli in terms of international caps is the legendary Sachin Tendulkar, who played a record-breaking 664 matches across all formats from 1989 to 2013.

Kohli, who has already represented India in 115 Test matches, has scored 8,947 runs, including 29 centuries and 30 half-centuries.

Close behind Kohli are current Indian skipper Rohit Sharma, with 486 matches, and all-rounder Ravindra Jadeja, with 346 appearances.

If India manages to sweep the three-Test series against New Zealand, they will only need to win one match in the upcoming Border-Gavaskar series against Australia to secure their place in the WTC final.—Agency

Mercurial Pakistan Crumbles at 221, England on Hunt for Victory in Second Test

Spinners Shaohab Bashir and Jack Leach shared seven wickets to bowl Pakistan out for 221 on the third day in Multan, setting England a target of 297 to win the second Test.

Bashir finished with 4-66 while Leach grabbed 3-67 but Pakistan were lifted from a precarious 134-5 by Salman Agha (63) and Sajid Khan (22) with a 65-run ninth-wicket stand.

The hosts made 366 in their first knock.

Brydon Carse ended Salman's innings in 58th over, who also grabbed the key wicket of wicketkeeper-cum-batsman Mohammad Rizwan in 31st over.

Pakistan off-spinner Sajid took 7-111, his second five-wicket haul, to bowl England out for 291 on a pitch — also used for the first Test — offering a sharp



turn.

On a track where the ball turned sharply and shot-making was difficult, England off-spinner Shaohab Bashir then delivered three huge blows to keep England in the contest.

England captain Ben Stokes stayed with spin even when Leach had to be rested, pressing part-time off-spinner Joe Root into service.

Bashir drew first blood when he had Pakistan opener Abdullah Shafique caught behind for four. England successfully reviewed the original not-out decision and replays confirmed the faintest of edges.

Bashir dismissed Shan Masood for 11 after the

Pakistan captain tried to flick a ball only to offer an edge to Ollie Pope at second slip.

Saim looked comfortable before falling to the same Pope-Bashir combination in the final delivery before the lunch break.

Saud Shakeel (10*) and Mohammad Rizwan (0*) are currently on the crease after lunch with the score at 77-4 after Kamran was dismissed at 26.

England had earlier resumed on 239-6 and lost their remaining four wickets in the first hour to concede a first-innings lead of 75 to the hosts.

Left-arm spinner Noman Ali claimed the remaining three as England lost all 10 wickets to Pakistan's spin-heavy attack, which has Aamer Jamal as the lone seamer.—Agency

Major Shake-Up: PCB Cuts Captain and Head Coach Out of Selection Process



The Pakistan Cricket Board (PCB) has made a major overhaul to its selection process, granting full authority to a newly appointed five-member committee, after Pakistan's heavy defeat in the first Test in Multan, which led to the appointment of the new captain and head coach.

Several notable players, including Babar Azam, Shaheen Shah Afridi, and Naseem Shah, have been stripped of their voting rights, leaving the selectors with the exclusive power to decide the playing eleven for upcoming matches.

Joining Javed on the selection panel are Aleem Dar, Azhar Ali, Asad Shafiq, and Hassan Cheema, who will have the final say on team composition.

While they are expected to consult with the captain and coach, all decisions will rest solely with the selectors. This restructuring reduces the size of the selection committee from seven to five members and aims to streamline the decision-making process.

This shake-up comes after Pakistan's heavy defeat in the first Test in Multan, which led to the appointment of the new captain and head coach.

Several notable players, including Babar Azam, Shaheen Shah Afridi, and Naseem Shah, have been rested, with new players like Haseebullah, Kamran Gulam, and Mehran Muztaz included in the squad.

The PCB also made further adjustments to the non-voting positions within the committee, removing the captain, head coach, and other advisory roles from the selection process altogether. A PCB official confirmed that the current structure is final and aims to provide clarity and accountability in team selection moving forward.—Agency

Sarfaraz Khan fell to Henry thanks to a stunning catch by Devon Conway at mid-off, leaving the hosts teetering at 10-3.

New Zealand could have had a fourth wicket shortly after a brief rain interruption but for some sloppy wicketkeeping by Tom Blundell, who dropped a simple chance to hand Rishabh Pant a lifeline when the left-hander was on seven.

Opener Yashasvi Jaiswal was not as fortunate when a well-timed cut off O'Rourke went straight to Ajaz Patel, before the impressive pacer-man sent back KL Rahul for a duck.

Henry compounded India's woes by removing Ravindra Jadeja for another duck, the fourth of the innings before lunch, and then added Ravichandran Ashwin to that list in the first ball after the break.—Agency

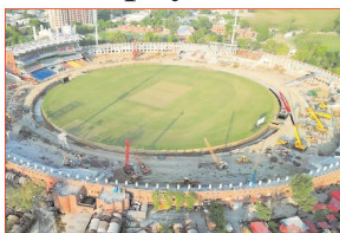

Gaddafi Stadium to Expand for Record-Breaking Champions Trophy 2025



The Pakistan Cricket Board (PCB) has announced a substantial increase in the spectator capacity at Gaddafi Stadium in Lahore. The iconic stadium, which currently accommodates 21,000 fans, will see its capacity doubled to 34,000 ahead of the 2025 Champions Trophy.

Jawaid Qazi Ahmed, the PCB's Director of Infrastructure, revealed that construction work is underway around the clock to achieve this expansion.

The project, estimated to cost Rs7.5 billion, is expected to be completed by December 31, 2024. To improve viewing angles, trees are being removed, and enclosures are being brought closer to the pitch.

With the ICC delegation scheduled to visit Pakistan in late October or early November, the PCB is working diligently to ensure that Gaddafi Stadium is ready to host international cricket matches.

The upcoming Champions Trophy, to be held from February 19 to March 9, will serve as a major test for the expanded stadium.

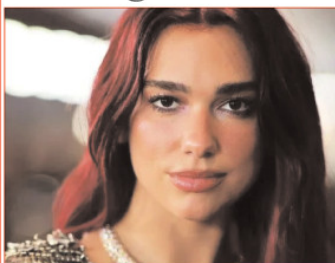
According to media reports, the proposed schedule includes three matches for Indian teams in Lahore, with a match against Bangladesh on February 20 and another against New Zealand on February 23.

SSGC Sets Record Straight On Controversial Conical Baffle Charges

KARACHI: In Karachi, under the special directives of Additional IG Karachi Javed Alam Odho, an operation was conducted at Yousaf Chowranghi by SP Malir Operations Muhammad Saeed Rind and SSP Traffic Azam Khan Jamali. DSP Quaidabad Mansoor Buzdar and SHO Quaidabad Syed Farasat Hussain Shah led the operation, which targeted vehicles with tinted windows

and fancy number plates. During the operation, police from Quaidabad and staff from the Landhi Industrial Area traffic post removed tinted windows from over 20 vehicles and issued fines and tickets to their owners.

SP Malir Muhammad Saeed Rind and SSP Traffic Azam Jamali stated that following a recent suicide bombing in a suspicious vehicle near the airport, Sindh's Provincial

Interior Minister Zia-ul-Hassan Lanjar and IG Sindh Ghulam Nabi Memon imposed Section 144. This enforces a strict ban on tinted windows and fancy number plates for all vehicles, regardless of size, as they are considered illegal. They reiterated their commitment to maintaining law and order in Karachi and across Sindh, emphasizing the responsibility to ensure the safety of residents and citizens.

Pakistan Navy's Dramatic Drug Bust: Massive Narcotics Cache Seized In Arabian Sea

Explosive Senate Showdown Tomorrow: Constitutional Package Bill To Hit The Floor

ISLAMABAD: Ruling Pakistan Muslim League-Nawaz (PML-N) Parliamentary Leader in Senate Irfan Siddiqui said on Thursday that the bill on contentious constitutional package would be tabled in the upper house of the parliament on Friday (tomorrow) after "three parties reached consensus on a comprehensive draft".



Siddiqui, speaking to journalists in the parliament after attending a special committee meeting on constitutional reforms, detailed that a final draft would be finalised by Friday evening and presented before the Senate in tomorrow's session.

He said that Law Minister Azam Nazeer Tarar gave a briefing on the draft in the meeting, adding that Jamiat Ulema-e-Islam-Fazl (JUI-F) Senator Kamran Murtaza also expressed optimism about the proposed amendments.

90% of the work on the amendments has been completed, and hopefully, the package will be tabled in the Senate on Friday. Substantial progress has been made on the proposed constitutional amendments package, with just a few finishing touches needed, he added.

Signaling a consensus between the ruling PML-N, the Pakistan Peoples Party (PPP), and the JUI-F, he said the religious-political party chief Maulana Fazlur Rehman had shown a "general agreement" on all matters. He said that "it is a matter of give and take" and the coalition government has also accepted recommendations from the politico-religious party. Those points which drew reservations from major parties have been precisely modified [in today's meeting], he added.

The PML-N senator claimed that they saw a "very comprehensive draft" in the meeting today in which judiciary-related constitutional reforms were added. The draft was free from any act which affects public opinion or judiciary powers, he clarified.

Siddiqui's remarks came after media learnt via sources that the ruling coalition took a step back on the matter of the constitutional court and reached a consensus with all parties, including the opposition, on the formation of a constitutional bench. After high-level discussions, four leaders of the major opposition party Pakistan Tehreek-e-Insaf (PTI) and the coalition government's ally PML claimed an agreement had been reached among all the political parties on the formation of the constitutional bench, as per the insiders.

However, the Imran Khan-founded party a day ago announced staging a nationwide protest tomorrow to resist the proposed 26th constitutional package a day after the PPP and the JUI-F forged consensus on the joint draft.

The constitutional package, among other things, aims to set up a federal constitutional court and fix the tenure of the Chief Justice of Pakistan (CJP) for three years.

The government had attempted to present the bill to amend the Constitution last month, but its allies as well as members from the opposition benches vehemently opposed the proposal, forcing the ruling parties to begin a consultation process. To pass the constitutional amendments, the government requires a two-thirds majority in parliament, with sources indicating a shortfall of 13 votes in the National Assembly and nine in the Senate.—RT/Agency

PM's Big Claim: Parties And Institutions Joining Forces For Pakistan's Future

ISLAMABAD: Prime Minister Shehbaz Sharif on Thursday said all political parties and institutions are working together for the national development.



He said the government and allied political parties worked diligently to ensure economic stability by setting aside their political interests.

"You have all sacrificed your politics and worked hard, the results are economic stability and diplomatic successes," the prime minister conveyed to the leaders of coalition parties in the Senate.

He said all political parties and the people had made sacrifices to help the country overcome difficulties.

He said foreign remittances have also been witnessing consistent increase for last several months which reflected the confidence of the overseas Pakistanis on the incumbent government.

The premier hailed the successful hosting of the

Shanghai Cooperation Organization (SCO) Heads of Government meeting as a major achievement for Pakistan on diplomatic front.

"Pakistan's diplomatic profile further strengthened internationally after successfully hosting this summit," he said.

Congratulating the political parties' leaders on successful conclusion of the SCO summit in Pakistan, the prime minister said all relevant institutes worked together as a team in this regard.

He said before the SCO meeting, visit of the Chinese Premier also proved to be very successful.

He specifically mentioned the crucial role of Deputy Prime Minister and

Foreign Minister Ishaq Dar in making the event successful.

He expressed confidence in the country's ongoing economic recovery and stability, asserting that the government will respond to its political opponents through tangible development and prosperity in the country.

The prime minister said due to the government's prudent policies, the country's economy had stabilized and it achieved the 2025 targets before time even in 2024. The prime minister said the inflation rate witnessed a quick decline in very short time. Chairman Senate Syed Yousef Raza Gilani, DPM Ishaq Dar, and government allied parties' senators attended the event.—RT/Agency

Bombshell Claim: Pakistan Behind Imran's Disqualification From Oxford Chancellor Race

LONDON: Syed Zulfi Bukhari, former prime minister Imran Khan's adviser on international affairs, has claimed that Oxford University was put under pressure by Pakistani government sources to block the PTI founder from contesting the chancellor election.



Bukhari ran a high-profile media campaign for the imprisoned Pakistan Tehreek-e-Insaf (PTI) top leader to run in the election but the university decided to not allow Khan to stand in the election, let alone become the chancellor, over Toshakhana conviction and politicisation of the issue.

Speaking to media, Bukhari said he was convinced that the government forces from Pakistan campaigned against Khan's candidacy and put the university under some kind of pressure to block him from contesting the chancellor election.

"The Oxford University has made a very narrow-minded and pressured decision to block Imran Khan. The decision came as a big disappointment because the whole of Pakistan wanted Imran Khan to take part in the Oxford University chancellor election. People from India, Bangladesh, Indonesia and many Islamic countries wanted Imran Khan to take part, he claimed.

The PTI leader further said that nearly 200 Oxford alumni signed the petition in Khan's support, saying there were no legal grounds to block Imran Khan.

"Before we submitted Imran Khan's nomination papers we took advice from many King's Counsels (KCs) and they agreed that nothing is barring Imran Khan legally from taking part. The Oxford Uni has made a narrow-minded and pressured decision to block Imran Khan. To say that Imran Khan is convicted in the Toshakhana case would not justify the decision because in the same case, the United Nations Working Group has said that Imran Khan's detention is illegal and cases against him are politically motivated.

In all other cases the sentences have been appealed and set aside so there is no legal standing. At the end of the day, Oxford University has a charitable status and according to the UK rules governing charities, Imran Khan is eligible to open his bank accounts and become a trustee or become a charity director." Bukhari said one of the biggest awareness campaigns in the history of Oxford University was run around Khan's candidacy and the whole world got to know about his case through this campaign. He said he was aware that the varsity was petitioned against Khan — first started by social media activists R A Shehzad and Hajra Khan and later picked up PML-N UK's Khurram Butt and several other actors played a role too. He said: "I understand that many pressures came alongside his candidacy. I believe that Oxford Uni has made a 'pressured decision' and Lord Daniel Hannan clearly said a decision was made in pressure. I do not think the UK government has played a part but the Pakistani government certainly has. Political differences aside, the Pakistani government should have supported Imran Khan as he would have presented Pakistan on a global stage. They should have supported him as a Pakistani hero. There is no doubt that there was enough pressure applied and Oxford University may have thought that they did not want to get involved in a muddy situation." Bukhari has also said he is considering legal action against the university and already written to the varsity. "Naturally, before taking the advice of KCs, top solicitors across the country, barristers — and with their consent and their opinion did we go ahead.—RT/Agency

FBR Cracks Down CFOs And Fraudsters Nabbed In Massive Sales Tax Scam



ISLAMABAD: Pakistani authorities have arrested five senior executives, including a prominent fraudster, in a sweeping crackdown on businesses involved in sales tax fraud, the Federal Board of Revenue (FBR) said.

This operation, which was conducted with assistance from the Lahore Directorate, exposed a fraudulent scheme that resulted in over PKR 1 billion in losses to the national exchequer.

An FIR had been lodged against the company's executives, who now face charges of abetment and connivance in sales tax evasion. In a separate intelligence-based operation in Faisalabad, authorities arrested the CFOs of two sister concerns and a major textile unit for their involvement in claiming fake input tax on coal.

This fraudulent activity, led by a gang of tax evaders, caused revenue losses running into hundreds of millions of PKR. In another significant development, the pre-arrest bail of Taswar Shahid, a leading figure in multiple sales tax fraud cases, was rejected by a court. Shahid was arrested outside the courtroom and is believed to be a key member of a gang that created fake sales tax inputs used by end users and beneficiaries, causing billions in revenue losses.—RT/Agency

Among those arrested were four Chief Financial Officers (CFOs) accused of tax fraud, as well as a notorious fraudster known for orchestrating complex schemes to avoid tax liabilities.

In Hyderabad, officials apprehended the CFO and Purchase Officer of a prominent Lahore-based battery manufacturer for allegedly claiming fake input tax on

Supreme Court Slams Down Appeals Against 26th Constitutional Amendment

ISLAMABAD: The Supreme Court dismissed petitions on Thursday challenging the 26th proposed constitutional amendments after the petitioners sought withdrawal.



The government's much-talked-about constitutional package aims, among other things, to establish a federal constitutional court and set a three-year tenure for the Chief Justice of Pakistan (CJP).

A three-member bench of the Supreme Court, headed by Chief Justice Qazi Faez Isa and comprising Justice Naeem Akhtar Afghan and Justice Shahid Bilal Hassan, heard the joint petition.

The petition was filed by former president of the Supreme Court Bar Association and current member of the Pakistan Bar Council, Abid S Zubairi, along with other council members, against the proposed constitutional amendments.

During the hearing, lawyer Hamid Khan requested the bench to withdraw the petitions. At this, the CJP wondered whether the petitioners had only hired Hamid, a leader of the Pakistan Tehreek-e-Insaf (PTI), to withdraw their pleas.

"Abid Zubairi could have withdrawn the petition himself [...] Six lawyers had filed the petition; they could have appeared before the court themselves to withdraw it," the top judge said.

The CJP then told the lawyer that two cases — the main petition and the plea against the objections to the petition — had been fixed for hearing.

The lawyer said that his clients wanted to withdraw all the pleas.

Zubairi, along with other Pakistan Bar Council members, had filed the petition in the apex court under Article 184(3) of the Constitution on September 16. The petitioners requested the Supreme Court to declare that the separation of powers, judicial independence, and its authority to enforce fundamental rights are sacrosanct under the Constitution and beyond the power of Parliament to withdraw, interfere with, or alter in any way.

Furthermore, the petitioners asked the court to declare the proposed amendments, introduced through the bill, as unconstitutional and in violation of the basic structure of the Constitution, the principle of separation of powers, judicial independence,

and the fundamental rights enshrined in the Constitution.

They also sought an injunction restraining the federal government from presenting the bill in Parliament, suspending the operation of the proposed amendments, and preventing the bill from being enacted into law if passed by both houses.

It is worth mentioning that several other petitioners had also challenged the proposed constitutional amendments in the Supreme Court, seeking a declaration that they violated the basic framework of the Constitution. Similarly, many petitioners had challenged the proposed amendments in various high courts across the country as well. Just a day before the withdrawal of the petitions, top political parties — Pakistan Muslim League-Nawaz, Pakistan Peoples Party, and the Jamiat Ulema-e-Islam-Fazl — had also forged a consensus on the amendments.—RT/Agency

PTI Drops A Bomb: 'Seven Government MNAs Set To Defy Constitutional Amendments'

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) said on Thursday that the coalition government's seven members of the National Assembly (MNAs) would vote against the proposed constitutional amendments.



"The government's numbers are only complete in their books. The government neither consulted its members nor answered out of fear," PTI Chairman Barrister Gohar Khan told media.

He said he had received the news about the seven treasury benches members' refusal to cast vote from reliable sources.

"The government members said they will not vote even if they are disqualified," he said, adding that the legislators believe those voting in favour of the constitutional amendments would be doing so against their conscious.

Probably, he said, PPP Chairman Bilawal Bhutto-

Zardari also knew that parliamentary members of his own party were not going to vote for the amendment.

His remarks came as the Special Committee of the parliament met again on Thursday to discuss the draft amendments in the Constitution, proposed by the government.

Special committee's chairman Khurshid Shah said the meeting on the 26th constitutional amendment was convened at the request of the PTI chief whip Aamir

Dogar. The constitutional package, among other things, aims to set up a federal constitutional court and fix the tenure of the Chief Justice of Pakistan (CJP) for three years. The government had attempted to present the bill to amend the Constitution last month, but its allies as well as members from the opposition benches vehemently opposed the proposal, forcing the administration to begin a consultation process.—RT/Agency
