Bilawal Warns of 'Brute Majority' As Opposition Faces Constitutional Showdown

HYDERABAD: Pakistan Peoples Party (PPP) Chairman Bilawal Bhutto-Zardari has said that he will be compelled to take "controversial path" for the passage of the 26th constitutional amendment if the opposition parties refused to support his efforts to pass the judicial package with consensus.

"I myself making last attempt to convince the opposition parties to vote for the constitutional amendment in a non-controversial way," he said while addressing a rally in Hyderabad held to mark the 17th anniversary of Karsaz incident.

The PPP chief said if he failed to evolve consensus on the proposed constitutional amendment "then we all have to pray for the country's democracy".

"If the opposition still refuses to support us despite so many compromises then I will be compelled to pass the amendment with the support of Pakistan Muslim League-Nawaz and the extra members," the PPP chief said.

He added that he will have to pass the 26th constitutional amendment in parliament via "brute majority"



with the support of extra members if opposition refused to evolve consensus on the draft.

"It is necessary for us to establish a forum for the equal representation of all provinces but if the opposition shuts the door on us so then I will be compelled to take the 'controversial path,' which is not my favourite path and I tried not to take it, along with my allies to form constitutional bench at the federal and provincial level," he added.

Referring to his recent meetings and consultations with Jamiat Ulema-e-Islam Fazi (JUI-F) chief Maulana Fazlur Rehman and other political parties in the backdrop of much-touted constitutional amendments, Bilawal said:

"They said there will be a constitutional bench but not court. I said let's make bench but there should be equal representation [of provinces] in the bench."

Highlighting the "historic" verdicts of Chief Justice of Pakistan (CJP) Qazi Faez Isa, the PPP chairman said that he even accepted their demand that the top judge should not be given extension.

"CJP Isa provided justice to Shaheed Zulfiqar Ali Bhutto," he said, adding that no other judge could dare to give such a verdict which he gave after hearing the "Faizabad Dhama case".

"Justice Qazi Faez Isa sahib! the nation salutes you."—RT/Agency

SC Declares Elections Act Amendment Powerless To Reverse Reserved Seats Ruling

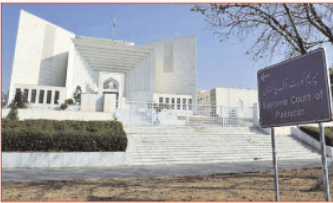
ISLAMABAD: The Supreme Court has reiterated that parliament's amendment to the Elections Act does not have a retrospective effect and it cannot undo the top court's judgment in the reserved seats case.

The second clarification comes after the Election Commission of Pakistan (ECP) and the Pakistan Tehreek-e-Insaf (PTI) separately approached the apex court last month, seeking a clarification on its order to grant reserved seats to the Imran Khan-founded party.

The top court declared on July 12 that the embattled PTI was eligible for seats reserved for women and minorities. However, the government passed an amendment to the Election Act, 2017, forcing the ECP to seek clarification from the top court.

In response, the apex court's judges, who issued the order, stressed that the request was "misconceived" and ordered the poll organising authority to follow through on the verdict.

Then, the court on September 23 issued a detailed verdict declaring the PTI a parliamentary party, stating that 39 of the 80 MNAs are affiliated with the PTI, while



the remaining 41 have the chance to re-submit their party affiliations.

However, despite the court's clarification and the detailed verdict, the ECP has yet to allot reserved seats to the PTI.

The ECP, in its civil miscellaneous application (CMA), submitted that the top court's short order was based on the law which has since been altered by the amendments made to Sections 66 and 104 of the Elections Act, 2017 and a new Section, namely 104-A, has also been inserted with retrospective effect from the date of the commencement of the act, the SC stated in the clarification.

On the other hand, PTI submitted in its CMA that the short order passed by the SC was based on the interpretation and enforcement of con-

stitutional provisions, therefore the amendments cannot supplant the effect of the short order, it added.

"The court [SC] granted the relief in the short order to enforce the right of the electorate through political parties to have proportional representation in the reserved seats under paragraphs (d) and (e) of clause (6) of Article 51 and paragraph (c) of clause (3) of Article 106 of the Constitution, therefore, the amendments made in the Elections Act after the release of our short order will have no bearing and the Commission is bound to implement the judgment passed by the Supreme Court of Pakistan in its letter and spirit, without seeking any further clarification."

In its previous clarification on September 14, the top court had come down hard on the ECP for its "attempts to create confusion" on its July 12 reserved seats verdict, saying that the clarification sought by the commission was nothing but an attempt to "obstruct implementation" of the judgment declaring PTI eligible for reserved seats in parliament.

"Putting together the record placed before us [top court], and considering the same in light of the short order, leaves in little doubt that the clarification sought by the commission is nothing more than a contrived device and adoption of dilatory tactics," the eight judges had stated in the clarification.

In its four-page clarification, the SC said having itself issued notices to the PTI through Barrister Gohar Ali Khan as its Chairman, the Commission "gave recognition to both the party and the office holder".

On September 23, hours after the SC issued a detailed verdict of the reserved seats case wherein the PTI was declared eligible for seats in assemblies. Law Minister Azam Naeze Tarar rejected that decision of joining any political party by independents is "irreversible", saying that the Imran Khan-founded party was not even a peti-

tioner in the case.

"Legal question still remains in place [...] the detailed judgment didn't interpret how the reserved seats will be allocated to the party as per the current regulations," the minister had said.

The law minister had said Articles 51 and 106 of the Constitution warrant that independents will have to join a political party within three days of the publication in the official Gazette of the names of the returned candidates.

Tarar had said parliament has amended the Sections 66 and 104 (a) of the Election Act, which is now the existing law in the country.

Referring to the PTI-backed returned candidates, the minister had said the independents, who have already joined the Sunni Ittehad Council, cannot join any other party, adding that parliament is fully empowered to make or amend laws.

In its 70-page judgment issued today, the apex court had termed the PTI "a political party" and eligible for the seats' quota. It stressed that the lack of an electoral symbol does not affect its constitutional right to take part in elections.—RT/Agency

Hamas Leader Sinwar Confirmed Dead In Israeli Strike

GAZA: Palestinian militant group Hamas on Friday confirmed its leader Yahya Sinwar had been killed by the Israeli military in Gaza, a day after Israel announced his death.

"We mourn the great leader, the martyred brother, Yahya Sinwar, Abu Ibrahim," Qatar-based Hamas official Khalil al-Hayya said in a recorded video statement broadcast by Al Jazeera.

Sinwar became Israel's most wanted man after the October 7, 2023 attack, the deadliest in Israeli history.

Khalil Hayya, adds that captives held in Gaza will not return until Israel stops its attacks on Gaza and withdraws its forces from the besieged enclave.

Speaking in a televised address, Khalil Hayya spoke of "the memory of the fallen martyr, Yahya Sinwar".

Describing him as "steadfast, brave and intrepid", Hayya said Sinwar "sacrificed his life to the cause of our liberation".

"He met his end standing brave, with his head held high, holding his firearm, firing until the last breath, until



the last moment of his life. "[Sinwar] has lived his whole life as a holy fighter. Since his early days, he was engaged in his struggle as a resistant fighter. He stood defiant behind Israeli bars and after his release in a swapped deal, he continued with his struggle and his dedication to the cause."

Hayya added that Sinwar's "martyrdom" and the leaders who preceded him "will only increase the strength and resilience of our movement".

"The occupation prisoners will not return unless the aggression on Gaza stops,

there is a complete withdrawal from [Gaza], and our prisoners are released from the prisons," Hayya said. "Hamas will continue until the establishment of the Palestinian state on all Palestinian soil with Jerusalem as its capital." In his statement, Hayya said Hamas would not release the hostages it seized from Israel during the attack until the war in Gaza ends.

Hayya said the Hamas would take strength from Sinwar's killing, which he said has set him among "the leaders and symbols of the movement who preceded him".—RT/Agency

Shehbaz In High-Stakes Talks Over Constitutional Amendment



ISLAMABAD: Prime Minister Shehbaz Sharif started informal consultations with senior cabinet members regarding the approval of a proposed constitutional amendment.

Sources indicate that a meeting took place between PM Shehbaz Sharif and the members, including Law Minister Azam Nazir Tarar and the Attorney General, who briefed the Prime Minister on critical constitutional and legal matters.

PM Sharif during the discussion shared details of his late-night meeting with JUI-F Chief Fazlur Rehman, while also reviewing the draft constitutional amendments presented by the Pakistan People's Party (PPP) and Pakistan Muslim League-Nawaz (PML-N).

Government insiders said that efforts are underway to conclude a unified draft with input from coalition partners. The government also sees reserved seats through the Election Commission of Pakistan.—RT/Agency

PM Hails Navy's Major Drug Bust: 1.3 Tons Seized



ISLAMABAD: Prime Minister Shehbaz Sharif on Friday lauded the Pakistan Navy for successfully carrying out an operation in the North Arabian Sea in which 1.3 tons of narcotics were seized.

The prime minister, in a statement, said that the vibrant leadership of the Pakistan Navy led to the seizure of huge quantity of narcotics in the operation.

He said that foiling the attempt to smuggle a huge quantity of narcotics was laudable.

"The whole nation feels proud of the officials of the Pakistan Navy. The elimination of narcotics was essential for the welfare of humanity," he remarked.

Prime Minister Shehbaz reiterated that the government was determined to extend all possible facilities to the Pakistan Navy in its mission to purge country of narcotics.—RT/Agency

Special Committee Gives Green Light To Controversial Amendment Draft

ISLAMABAD: In a major breakthrough, the special parliamentary committee — comprising government and opposition members — has "unanimously approved" the draft for 26th constitutional amendment.

The development comes after the special committee formed to debate the contentious judicial package met under the chairmanship of PPP lawmaker Syed Khurshed Shah on Friday.

Speaking to the reporters, Shah said the draft would be presented in the federal cabinet meeting tomorrow for approval.

"The draft has been approved unanimously," he said adding that the committee has also agreed on allowing overseas Pakistanis to contest the elections. Leaders from all major political parties, sans Awami National Party's Aimal Wali Khan, were present in the meeting. MQM-P leader Farooq Sattar agreed that PTI principally agreed on the draft but the party had reservations on some points.

PTI Chairman Barrister Gohar Ali Khan, however, said that consultation on the fourth draft shared by the government today is underway, adding that they would make final decision on the constitutional package after meeting with his party founder, who is currently incarcerated in Adiala Jail in multiple cases.

Co-sponsored by more than 50 Member States, Pakistan-led resolution was adopted at the 220th Session of the UNESCO Executive Board in Paris.

Pakistan took this initiative in the backdrop of proliferation and intensification of

disinformation, misinformation and hate speech around the world.

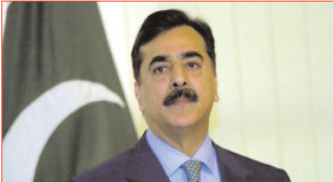

LHC Assembles Full Bench To Tackle Alarming Rise In Female Student Harassment

LAHORE: The Lahore High Court (LHC) announced constituting a full court bench to hear the case of different incidents of harassment of female students, saying that the matter was of immense importance.

LHC Chief Justice Aalia Neelum on Friday directed the authorities to take the statement of alleged victim linked to the much-hyped claims of "rape" of a private college's student in Lahore that sparked violent protests in the province that continue till date.

Nearly 400 individuals protesting harassments and sexual abuse against female students at educational institutions have been arrested in Rawalpindi alone as Section 144 has been imposed in the province, banning gatherings and demonstrations.

Several hundred others have been booked in Lahore and other cities for the viola-



tion of Section 144. Meanwhile, all private and public schools, universities and colleges in the province remained closed today.

As unrest shrouds Punjab, the LHC took up the matter of three separate incidents including the protests against alleged rape, an alleged suicide in Punjab University and a case of harassment in Lahore College of Women University (LCWU).

During the hearing, Punjab Inspector General of Police Usman Anwar and other officials appeared before the court with complete report sought by the court.

LHC CJ Neelum expressed displeasure with the police chief over failure in preventing the videos from going viral on the social media and controlling unruly students from taking to streets. She asked the reason for delay in reaching out to the relevant agencies for restricting the viral videos.—RT/Agency

Dark Conspiracy To Disrupt Punjab's Peace, Azma Bokhari Sounds The Alarm



LAHORE: Punjab Information Minister Azma Bokhari said on Friday that few political elements tried to play with the lives of innocent children by misusing social media.

Speaking to reporters, the provincial minister said that a conspiracy was being hatched to disrupt peace in Punjab. She warned against giving threats calls, adding that whoever was accusing the college of alleged incident should bring evidence.

She said lives and honour of girls especially in Punjab were not 'cheap', adding that teachers, parents and media should also fulfil their responsibilities.—RT/Agency

Lahore 'Rape' Protests Erupt: 380 Students Arrested, Over 1,500 Charged In Rawalpindi



RAWALPINDI: Police have arrested more than 380 participants of student protests in Rawalpindi and booked more than 1,500 unidentified persons in eight cases, it emerged on Friday.

A large number of Rawalpindi students on Thursday staged demonstration against the alleged rape of a college-going girl in Lahore.

Police said the protesters infringed Section 144, interfering in the state affairs, damaged and torched properties, hurled stones at police mobile vans.

As per the FIRs, the demonstrators injured police officials and spread terror, as the students ransacked a hostel after forcefully entering the hostel premises, pelted stones and damaged the vehicles there.

New Constitutional Amendment Aimed To Corner PTI, Barrister Saif Claims



PESHAWAR: Khyber Pakhtunkhwa Information Advisor Barrister Saif said on Friday that proposed constitutional amendment was aimed at further sidelining the Pakistan Tehreek-e-Insaf (PTI).

In a statement, Saif said that people were taking to the streets against the "fascist" government on a daily basis, adding that the PTI would continue its protest till PTI Founder Imran Khan and other political prisoners' release from the prison.

He criticised the Pakistan Peoples Party (PPP) for working in cahoots with the Pakistan Muslim League-Nawaz (PML-N) against the ideology of former party's founder Zulfikar Ali Bhutto.

"An independent judiciary can stand in the way of any infringement on people's rights carried out by use of force and oppression. The fake rulers are pressuring people to vote in favour of the constitutional amendment. I urge legal community to defend the freedom of judiciary," he added.—RT/Agency

FBR Launches Aggressive Crackdown On Tax-Dodging Firms And Individuals

ISLAMABAD: The Federal Board of Revenue (FBR) has expedited its action against the tax evader companies and individuals, media reported, quoting sources. For the first time in history, FBR arrested tax evaders after registration of FIRs, the sources said and added that the lists of tax evader companies and individuals have been finalised to speed up the action. Connected tax commissioners will serve show-cause notices over tax irregularities. Meanwhile, the FBR officials have said with the new steps, the tax evasion will be reduced in Pakistan as no one will be able to hide his tax returns. Non-filers will be barred from doing any business, buying house or a vehicle. It is to be mentioned here that the government has extended the deadline for filing income tax returns for the tax year 2024 again until October 31, providing an opportunity for those who did not file their returns before October 14.—RT/Agency

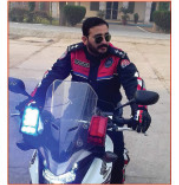

Ben Stokes Issues Surprising Apology After Crushing Defeat to Pakistan



MULTAN: England captain Ben Stokes has stated that he apologised to his teammates for showing his frustrations during his side's crushing 152-run defeat in the second Test against Pakistan in Multan.

"The visitors were left to rue two dropped catches on day three in Multan, Salman Agha escaping on four and six on his way to a crucial half-century as Pakistan made 221 in their second innings.

England were set to chase an unlikely 297 to seal the series with a match to go but never got close on a sharply turning Multan pitch that was recycled from the first Test.

"No one means to drop catches but it just proves how important catches are out in these subcontinent conditions because they don't come along that often," Ben Stokes told Sky Sports.

"I actually apologised to the group up there last night."

Stokes, who missed England's innings victory in the first Test in Multan because of injury, added: "It's the first time in my captaincy that I've felt my emotions, how I was feeling as the game was unfolding, show in my body language."

"I owned up to that and I'm very annoyed with myself for letting that out and it's something I don't want to do or be seen to be doing."

"So I apologised to the group about that and I said it was poor old me coming out, tired, grumpy old man last night but you won't see that happen again."

The third and final Test is in Rawalpindi from October 24 and Stokes refused to look backwards or wonder what might have been. "Next week is going to be good. I'm sure everyone's enjoyed watching here and back home," said the skipper. "Hopefully we can get a win next week and go home with another series win."—Agency

England Caught in Spin Web as Pakistan Storm Back to Level Series

MULTAN: Noman Ali took eight wickets as Pakistan's leading spinners guided the team to a 152-run win over England in the second Test in Multan on Friday, leveling the three-match series at 1-1. Chasing 297 for victory on a turning track at the Multan Cricket Stadium, England were all out for 144 in the fourth day's morning session.

Skipper Ben Stokes was the top scorer for England with 37 but their frontline batters struggled against the turning ball.

Left-arm spinner Noman was pick of the Pakistan bowlers claiming 8-46. Noman and player of the match Sajid Khan, who claimed seven wickets in the first innings, shared all 20 England wickets in a terrific display of spin bowling.

It ended Pakistan's winless run on home soil where they had not won a Test match since February 2021.

"I think the first one's always special, and it's come after some hard times, some rough times," Shan Masood said after his first Test win as Pakistan captain. "Noman and Sajid coming in for their first games - it's never easy, and they seemed like two seasoned campaigners coming in and doing their job in the second innings."

"We didn't need a third bowler, so that just speaks volumes for them." Soon after putting an end to a winless home run, congratulations poured in from President Asif Ali Zardari and Prime Minister Shehbaz



Sharif for the team. In his congratulatory message for the Men in Green, Zardari praised the team's spinners, noting that they "played an important role in winning this match".

"I hope that this series of excellent performances will continue in the future", he said. Meanwhile, taking to X, Shehbaz lauded the team for ending a winless streak at home.

"We are back," said the prime minister in his post on X. "Well done, Team Pakistan, for winning the first home Test after a long haul with a historic win against England," he added. "Spectacular performances by Sajid Khan wickets & Noman Ali wickets."—Agency

Keep it going, Inshallah," he posted. Meanwhile, Babar Azam posted a picture of the team along with a heartfelt message for his teammates. "Fantastic win. Proud of the effort and spirit," Babar posted. It's worth noting that Noman and Sajid took eleven and nine wickets respectively, becoming only the second Pakistani pair to share 20 wickets in a Test match.—Agency

Pak vs Eng: Noman Ali and Sajid Khan Etch Their Names in Cricket History

KARACHI: In a remarkable turnaround, Pakistan has triumphed over England in the second Test in Multan, finally breaking their 11-Test winless streak at home and securing their first Test victory in 15 months.

This victory not only marks a significant milestone for the team but also ends a prolonged home drought of 44 months without a Test win, bringing a wave of relief and celebration to cricket fans across the nation.

The match was dominated by Pakistan's spin duo, Noman Ali and Sajid Khan, who delivered a masterclass in spin bowling. Noman shone brightly, claiming 11 wickets in the match, including an impressive 8 for 46 in the second innings. This performance has made him the first Pakistani spinner to take 8 wickets in the fourth innings of a Test match.

The previous best fourth-innings figures for a Pakistani spinner were held by Mushtaq Ahmed, who took 7 for 56 against New Zealand in Christchurch in 1995. The all-time best for a Pakistani in a fourth innings remains Sarfraz Nawaz's 9 for 86 against Australia in Melbourne in 1979.

Sajid also played a crucial role, taking 9 wickets in the match. This duo's combined effort is a historic achievement, as it marks only the seventh instance in Test history, where two bowlers have taken all 20 wickets of the opposition.

The last time this feat was accomplished by Pakistani bowlers was in 1956, when the legendary pair of Fazal Mahmood and Khan Mohammad took all wickets against Australia. This record underscores the significance of their performance, as it highlights a rare and noteworthy achievement in the record books of cricket history.

Furthermore, the Multan Test was notable for the fact that all 20 wickets for Pakistan were claimed by spinners. This marks only the third time that Pakistani spinners have collectively taken all 20 wickets in a match, with the last instance occurring against England in Lahore in 1987, when Iqbal Qasim, Tauseef Ahmed, and Abdul Qadir combined forces to achieve the same feat.

In another rare display of endurance and determination, Noman and Sajid became the first Pakistani bowling duo in 30 years to bowl unchanged through an entire innings; this feat was last achieved by the pair of Wasim Akram and Waqar Younis against Sri Lanka in Kandy in 1994.

The victory is especially significant as it marks a breaking of the "curse" that had seen Pakistan struggle for over a year in Test cricket.—Agency

Pakistan Cricket Needs Game-Changing Performances, Not PR Gimmicks, Warns Hafeez



KARACHI: Pakistan's former captain Mohammad Hafeez took a dig at players' PR agencies after Pakistan beat England by 152 runs in Multan Test on Friday.

Taking to X after the win, Hafeez praised the "impeccable" performances of Kamran Ghulam, Salman Ali Agha, Sajid Khan, and Nauman Ali who played an important role in Pakistan's Test victory at home after almost three years.

"Pakistan cricket needs impactful performances like Kamran Ghulam, Salman Agha 50, Sajid Khan 9 wickets & Noman Ali 11 wickets for winning cause. Surely not PR agencies," he wrote.

For the past three-four years, PR agencies of Pakistani players have dominated the cricket corridors as

also reported in the previous era of PCB heads Zaka Ashraf & Najam Sethi. The ex-PCB management committee's chair Ashraf also tried to launch a crack down on such PR agencies for blackmailing the board through players. However, Ashraf's tenure was cut short earlier this year when the PCB elections were held. Magical spin spells from Nauman Ali and Sajid Khan propelled Pakistan to a convincing win against England on day 4 of the Multan Test. Nauman took eight wickets while Sajid bagged two wickets in the second innings to ensure Pakistan doesn't go winless at home this time. The continuity of dominance from the first innings helped the spin duo give a strong statement to the opposition out there.—Agency

This is the amendment for which 177 of our workers were martyred today," he said referring to the 2007 Karachi's Karsaz blast incident. He said former prime minister Benazir Bhutto had returned to Pakistan to campaign for the same amendment. "We will never let this sacrifice go in vain," he added.—RT/Agency

Latif Day celebrated at Govt Girls Degree College Larkana

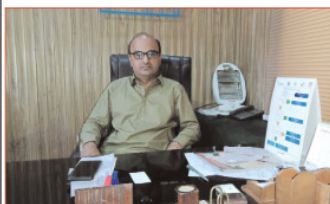

Arif Hussain Mirani reported that 57 GP Fund cases, 35 Teaching Allowance cases, and 39 pension cases were resolved this month, with 125 LPR cases to follow. The meeting saw strong participation from retired and serving employees.

SC Strikes Down Quota System For Government Employees' Children

ISLAMABAD: The Supreme Court (SC) has declared the quota policy and packages for government employees' children as null and void.

The 11-page ruling, penned by Justice Naem Akhtar Afghan, deemed all policies and packages regarding the quota for government employees' children "unconstitutional". The apex court granted the appeal of the General Post Office (GPO) and annulled the Peshawar High Court's (PHC) 2021 decision. Furthermore, the top court invalidated the Prime Minister's Package for Employment Policy and its office memorandum related to the quota. It also struck down Section 11-A of the Sindh Civil Servants Rules 1974 and Section 10 Subsection 4 of the Khyber Pakhtunkhwa Civil Servants Rules 1989. Additionally, it declared Section 12 of the Balochistan Civil Servants Rule 2009 as null and void. The court ruled that granting jobs to widows or children of government employees without advertisement or open merit contradicts Articles 3, 4, 5(2), 25, and 27 of the Constitution. In its ruling, the court directed all federal and provincial governments to abolish the policy of providing employment to government employees' children without advertisement or open merit. The judicial ruling will not affect the quotas already granted to government employees' children. It also clarified that the decision does not apply to the legal heirs of individuals killed in terrorist incidents. The court stated that the ruling would not impact the packages and policies awarded to the heirs of martyrs. It emphasized that the prime minister does not have the authority to soften the rules regarding the quota. "Good governance cannot be achieved through unequal treatment," the court noted.—RT/Agency

Railway Workers Facing Late Paychecks Due To Delayed Government Grant, Reveals Awaissi

ISLAMABAD: Parliamentary Secretary for Railways, Muhammad Usman Awaissi on Friday submitted before the lower house of the Parliament that the lower cadre staff of Pakistan Railways was receiving late salaries due to grant in aid provided by the Ministry of Finance.



The Parliamentary Secretary was responding to a calling attention notice of Member National Assembly (MNA) Aliya Kamran regarding failure of Pakistan Railways to pay monthly salaries to its employees on the due date, causing grave concern amongst the public. Muhammad Usman Awaissi apprised the House that basically the Railways payment of salaries awaits grant in aid to ensure disbursement of its salaries. However, the Finance Ministry needs to resolve the matter by disbursing grant in aid at the end of the previous month instead of start of the

month to ensure swift transfer of salaries, he added. He expressed his support for the employees receiving late salaries and assured the move to take up the matter with the Ministry of Finance and Revenue citing the calling attention notice to resolve the matter. Private Company Bags Rs135m Deal To Overhaul Lahore Safari Park

LAHORE: The Punjab Wildlife Department has awarded a contract worth Rs135 million to a private company for the management of Lahore Safari Park. The department will continue to oversee the care and breeding of wildlife, including animals and birds.



Under the agreement, the private company will manage key operations such as parking, entry tickets, aquarium maintenance, electric vehicles, and lion safari vehicles. The contract was signed today, and the company has already begun reviewing operations alongside the Lahore Safari Zoo administration. Project Director Mudassar Hassan stated that the reserve price was set at Rs80 million, taking into account all associated costs. "We are pleased that the contract was awarded

for Rs135 million," he said. Hassan added that the contractor will be responsible for vehicle repairs, electricity bills, and the upkeep and feeding of fish in the aquarium. Separate auctions will be held for the café, electric rides area, and horse riding concessions, with a review of previous contracts also in the works. Hassan further noted that the park staff previously involved in parking management, ticket collection, and driving electric vehicles will now focus solely on caring for the animals and birds. "Efforts will also be made to ensure that contract-based employees continue their work under the new contract, preserving their jobs."—RT/Agency

PTI Backs Constitutional Amendment Draft-But With Conditions, Says Raja Pervaiz

Murad Defends Government's Actions In Dr. Shahnawaz Case, Slams Section 144 Violators

KARACHI: Sindh Chief Minister Syed Murad Ali Shah, addressing the media after paying tribute at the Karsaz Martyrs Memorial, reaffirmed the PPP-led government's transparent stance on the Dr. Shahnawaz Kumbhar incident. He criticized those violating Section 144, stating that they claim tolerance while ignoring the law.

The CM highlighted the swift disclosure of the initial report and emphasized the government's commitment to transparency, noting that senior police officers were named in the FIR and placed under investigation. Despite this, he said some were politicizing the issue rather than recognizing the government's efforts.

Shah explained that Section 144 was enforced to prevent clashes between religious groups and the Rawadari March but was still



violated. He reiterated that law enforcement and the judiciary, not mobs, should handle such matters. He also apologized to the March participants and ordered an impartial inquiry into the incident.

Reflecting on the Karsaz incident, Shah remembered Shaheed Mohtarma Benazir Bhutto's return from exile and the tragic blast that claimed 180 lives during her convoy. He praised her bravery,

recalling how she visited the injured and bereaved families the very next day.

Shah emphasized that the sacrifice of Bhutto and the party workers helped restore democracy in Pakistan, calling it a "priceless" gift bought with her life. He expressed frustration over the lack of evidence hindering investigations into the Karsaz attack, citing the washing of the crime scene as a major obstacle.—RT/Agency

Social Media Influencer Issues Apology For Controversial Video Targeting Sindh Police

KARACHI: A TikTok influencer, who sparked controversy with a video criticizing the Sindh Police, has issued a public apology, media reported on Friday.

The individual, identified as Shahnawaz from Rahim Yar Khan, currently residing in Manzoor Colony, expressed deep regret over the viral video, which was filmed near the

Defense Police Station and surfaced online at 3 PM the previous day.

"I should not have made the video. It was a serious mistake," Shahnawaz admitted, apologizing to the officers and employees of the Sindh Police. "I sincerely ask for forgiveness from the Sindh Police. I am deeply ashamed of my actions and plead for your forgiveness."—RT/Agency

SSGC Adds Geyser Charges To Gas Bills, Sparking Debate

KARACHI: The Sui Southern Gas Company (SSGC) has started collecting conical baffle charges as part of its geyser campaign, media reported.

Consumers across SSGC's 3.2 million customer base have received additional charges of Rs2,085 in their gas bills under the label "conical baffle" charges. Many customers expressed frustration as they were billed despite not having geysers installed in their homes, with the extra charges applied before the baffle installations.

In response to the outcry, the Oil and Gas Regulatory Authority (OGRA) clarified that the conical baffles were approved to enhance safety and lower gas bills. The regulator advised affected consumers to lodge complaints with either SSGC or OGRA if they were incorrectly charged.

SSGC officials confirmed that surveys were conducted prior to the application of charges, following OGRA's approval, and contractors have begun installing the baffles. Customers facing issues are urged to contact their nearest Customer Facilitation Center (CFC) for assistance.

This move follows a government directive from a January 2023 meeting, chaired by the prime minister, which mandated the installation of conical baffles in existing geysers as part of energy conservation measures.—RT/Agency

Stone-Pelting Protest In Karachi Leaves Six Police Officers Injured

KARACHI: Tensions at Regal Chowk were brought under control after protesters dispersed following a heavy police presence, media reported on Friday.

Authorities confirmed that a large contingent of anti-riot police was deployed in the area to restore order. Police personnel entered the streets surrounding Regal Chowk, and partial traffic flow resumed on the main roads.

The protest in the Saddar area escalated into clashes, resulting in injuries to six police officers, including two female officers. Rescue teams quickly responded, and the injured officers were

taken to Civil Hospital for treatment.

The injured personnel - identified as Taha, Munir Ali, Ismail, Manthar Ali, and Shaheen - were stationed at Kalri, Napier, and Eidgah police stations. The Karachi administration has imposed a two-day ban under Section 144, prohibiting gatherings

and rallies on October 18 and 19 to maintain public order. The ban covers assemblies of five or more people, processions, and public meetings. It's worth noting that the Punjab government has also enforced Section 144 across the province for two days, starting Friday, October 18.—RT/Agency

Wednesday, the PTI's political committee vowed to oppose the constitutional amendments and directed regional and local bodies to hold peaceful protests. The party aims to block the passage of the proposed amendments, which include the establishment of a federal constitutional court and the fixation of the Chief Justice of Pakistan's tenure at three years.—RT/Agency

Karachi Sees 50% Drop In Street Crimes In Early 2024: Police Chief Reveals

KARACHI: Karachi Police Chief Javed Alam Odho announced on Friday that street crimes in the city have decreased by 50% in the first quarter of 2024, despite the fact that 100 lives have been lost to such incidents so far.

Odho, who assumed his role as Karachi's top cop in July, emphasized the police force's dedicated focus on combating street crimes. Last week, he ordered combing operations, increased patrols, and other measures to crack down on criminal activity in the city.

Speaking on a private TV show, the police chief highlighted the need for a modern command and control center to effectively address crime. He revealed that in the first phase of the Safe City project, 25% of the cameras will be installed to



enhance surveillance across Karachi.

The Safe City project, which has faced delays over the years, is crucial to improving security, though its progress has been slow. Last month, Sindh Chief Minister Murad Ali Shah provided an update on the project, calling it a key initiative to boost the city's safety through advanced surveillance and response systems.

Shah noted that work on the first phase of the project has been significantly expedited. Sindh Inspector General of Police (IGP) Ghulam Nabi Memon added that 1,300 cameras will be installed at various locations throughout the city. Surveys for 300 pole sites and 18 points of presence (POP) have been completed as part of the project's implementation.—RT/Agency

Karachi Administration Extends Colonial Era Section 144 Clampdown For Two More Days

KARACHI: The Karachi administration has extended the enforcement of Section 144 for an additional two days, until October 19, as per a notification issued on Friday.

Karachi Commissioner Hassan Naqi, under the powers delegated by the Sindh Home Department, has implemented a complete ban on protests, demonstrations, sit-ins, rallies, and gatherings of more than five people in the city.

According to the notification from the Karachi Commissioner Office, the ban was enforced at the request of the Additional Inspector General (AIG) Karachi. Station House Officers (SHOs) of relevant police stations have been authorized to file complaints against any violations of Section 144 during this period.

Previously, Section 144 had been imposed for five days, from October 13 to 17, as a security measure ahead of the Shanghai Cooperation Organisation summit in Islamabad.

Meanwhile, the Pakistan Tehreek-e-Insaf (PTI) has announced a nationwide protest on Friday (today) against the proposed 26th constitutional amendment package.

In a declaration issued on Wednesday, the PTI's political committee vowed to oppose the constitutional amendments and directed regional and local bodies to hold peaceful protests. The party aims to block the passage of the proposed amendments, which include the establishment of a federal constitutional court and the fixation of the Chief Justice of Pakistan's tenure at three years.—RT/Agency

CM Pressed To Expand Emergency Services In Hospitals Amid Rising Demand

KARACHI: Muhammad Jawed Bilwani, President of the Karachi Chamber of Commerce & Industry (KCCI), has expressed urgent concerns over the increasing prevalence of viral and epidemic diseases in Karachi and throughout Sindh. He has requested Chief Minister Syed Murad Ali Shah to direct the Health Department to enhance the capacity of emergency departments in all hospitals. In a letter addressed to the Chief Minister, Bilwani highlighted a recent KCCI survey indicating that emergency departments across hospitals are overwhelmed,

often forcing patients to wait for hours for available beds. He urged the Sindh government to verify this by conducting similar surveys at various hospitals in Karachi to fully understand the situation's severity. Bilwani emphasized the critical need for action, noting that Sindh is currently grappling with a surge in epidemic diseases. He warned that any negligence could lead to tragic loss of life and that the existing strain on hospitals could escalate to disastrous levels in the event of a natural disaster. He pointed out that emergency departments, including those

run by the Sindh Government, KMC, NGOs, the armed forces, and private hospitals, are struggling to accommodate the growing influx of patients. This increase is attributed to rising cases of Chikungunya, dengue, Zika, monkeypox, and other viral infections across Sindh, particularly in Karachi. Bilwani expressed hope that the Chief Minister would recognize the urgency of the situation and promptly issue directives to the Health Department, instructing all hospitals to significantly expand their emergency department capacities.—RT/Agency

Fazl Slams Government On Amendment Strategy, Points To Positive PTI Dialogue

ISLAMABAD: After engaging the Pakistan Tehreek-e-Insaf (PTI) leadership in an hour-long discussion, Jamiat Ulema-e-Islam-Fazl (JUI-F) Chief Maulana Fazlur Rahman has confirmed that consultations on the proposed 26th constitutional amendment are progressing, however, stressing that the government is not taking the opposition's reconciliatory approach seriously.



Talking to the media along with PTI Chairman Gohar Ali Khan and other party leaders in Islamabad late on Thursday, the JUI-F chief said: "We are engaging with the government with absolute open-heartedness."

However, at the same time he has warned that if the federal government presents the same draft as before, "we will reject it once again."

Rehman, 71, reiterated that the government's initial

draft was rejected by his party and it still remains unacceptable to him. "We continue to reject the initial draft even today," he said, but also noted that some issues are still open for discussion." Maulana Fazl also mentioned his recent meeting with former prime minister Nawaz Sharif, where they reached a consensus on several matters concerning the constitutional package.

However, he underlined

harassment of opposition members, saying, "On one hand, negotiations are taking place, and on the other, members are being abducted and offered large incentives."

He added that the coalition government is not taking the opposition's reconciliatory approach seriously.

Echoing Fazl's concerns, Barrister Gohar said that "our senators and assembly members are being harassed," and warned that the PTI might be unable to move forward if the government's attitude remains the same.

They also praised the PTI's positive attitude during the discussions over the Constitutional amendment, adding both parties would continue the discussion today. He added that the PTI cannot be held in the dark about the constitutional amendment.

Expressing hope for a headway, he noted, "We want to witness a change in the situation by the morning."

Fazl also called on both the PPP and the PML-N-led government to increase representation in the special committee.

Maulana Fazl also said that his party issued notices to all its members of parliament under Article 63(A).

"Our members are bound to vote in accordance with the party's decision," he underscored. Similar directives were issued to the PTI's members of parliament as well, Barrister Gohar confirmed, saying, "The PTI has instructed its members to vote as per the party's decision."

"The JUI-F chief warned, "If the amendment is forcibly passed, we will declare that this parliament has no right to legislate." —RT/Agency

Shehbaz Presses Biden For Dr Aafia Siddiqui's Freedom

ISLAMABAD/KARACHI: Prime Minister Shehbaz Sharif has written a letter to the United States President Joe Biden, seeking Dr Aafia Siddiqui's release as she continues to languish in an American prison for several years.



In his letter, written to Biden on October 13, the premier wrote about seeking the US president's intervention in the matter that deserves to be viewed with compassion, as Siddiqui remains incarcerated at the Federal Medical Center (FMC) Carswell in Texas.

The FMC Carswell houses female inmates of all security levels, primarily with special needs pertaining to their medical and mental health.

"She has been serving an 86-year sentence there, without the possibility of parole, imposed by the Southern District Court of New York. "Now 52 years old, she has spent approximately sixteen years behind bars in the US," PM Shehbaz wrote in the letter.

Dr Aafia, a Pakistani neuroscientist, was indicted by a New York federal district court in September 2008 on charges of attempted murder and assault, stemming from an incident during an interview with the US authorities in Ghazni, Afghanistan — charges that she denied.

After 18 months in detention, she was tried and convicted in early 2010 and sentenced to 86 years in prison. She has since been imprisoned in the US.

The premier further mentioned that numerous Pakistani officials have paid consular visits to Siddiqui at the prison facility over the years and have raised "serious concerns about the treatment she has received".

The treatment meted out to her has severely impacted her "already fragile mental and frail physical health".

"In fact, they even fear that she could take her own life," the prime minister mentioned in the letter.

PM Shehbaz further praised Biden for passionately fighting for the rights of US citizens, particularly those stranded or held captive abroad.

Therefore, the premier added, it is his "solemn duty" as Pakistan's premier to intervene when it becomes absolutely necessary to ensure a citizen's well-being, particu-

larly when the circumstances are as dire as they are in her case.

"Keeping these facts in view, I request you, Mr President, to kindly exercise your constitutional authority and accept Dr Siddiqui's clemency petition and order her release, strictly on humanitarian grounds," he wrote urging the American president to pardon the neuroscientist.

The prime minister added that he trusts Biden to accord the most serious consideration that the request deserves.

"Her family, and millions of my fellow citizens join me in seeking your blessings for a favorable outcome of this request," the prime minister wrote, concluding the letter.

Reacting to Premier Shehbaz's letter, Clive Stafford Smith — American human rights lawyer who represents Dr Siddiqui — told Geo tv that the letter is "very welcome and very heartfelt from the PM". —RT/Agency

Final Word On Amendments Hinges On Imran Khan's Orders: Gohar aka Uncle Tom

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) leader Barrister Gohar Ali Khan said on Friday that a consensus has been nearly reached with Jamiat Ulema-e-Islam-Fazl (JUI-F) chief Maulana Fazlur Rahman regarding the 26th Constitutional Amendment, and a final announcement will be made after consultations with PTI founder Imran Khan.



Speaking to the media following a meeting with Maulana Fazlur Rahman in Islamabad, Barrister Gohar explained that PTI held a meeting with its allies, including the JUI-F chief, to discuss the constitutional amendments. He stated that there was a strong possibility of reaching an agreement during the previous talks, and Friday's meeting further solidified that understanding.

"We are still in talks. Once we finalise our position, we will seek Imran Khan's instructions. Today, we will request a meeting with him, and we aim to meet him tomorrow. Based on his directives, we will announce our final stance," Barrister Gohar said.

He added that significant progress was made in the discussions with Maulana Fazlur Rahman, bringing them closer to an agreement. "We had a detailed discussion with Maulana Fazlur Rahman, and we are nearly at a consensus," he noted.

Barrister Gohar also mentioned that representatives from both PTI and JUI-F participated in the Special Par-

liamentary Committee discussions on the amendment. PTI was represented by Aamir Dogar, while JUI-F also had its representatives present. The committee approved the draft amendment, which formed the basis for negotiations between PTI and JUI-F.

"We are hopeful that tomorrow, after receiving directions from Imran Khan, we will make a final announcement. For now, we have almost reached an agreement with Maulana Fazlur Rahman, which we will present to Imran Khan and share his guidance tomorrow," he said.

Responding to a question, Barrister Gohar clarified that Pakistan Peoples Party (PPP) Chairman Bilawal Bhutto Zardari also made an appearance during the meeting. Although Bilawal greeted everyone, there was no discussion on the draft amendment with him. "Bilawal Bhutto arrived, and Maulana Fazlur Rahman gave him time. We exchanged pleasantries, but there was no conversation on the draft," he stated.

The prime minister condemned the impediments being created by Israel in the relief efforts and lauded the NGOs supplementing the Government of Pakistan's relief efforts.

He said the government would make no compromise on the quality of the relief items and asked the authorities concerned to dispatch the fireproof tents.

Expressing his concerns over the growing Israeli barbarism, he called for the international community's role to end the genocide of Palestinian people.

He said the major reason behind the world war in the 20th century was the indifference of the world powers to the conflicts. In the briefing, it was told that since October 8, 2023, 12 carnos had been dispatched to Palestine through six chartered, three PAF special flights and another three through

the sea route. The consignments consisted of 3145 tents, 12625 blankets, eatables, milk powder and medicines. Besides, another 3,000 tents and 12,000 blankets were being sent through three flights soon. The prime minister was told that two batches of Palestinian medical students had reached in Lahore and Islamabad. The prime minister asked the relevant authorities to make arrangements for Palestinian students to study in other disciplines as well, other than the medicine. JUI-F Fires Back Against Forward Bloc Claims Over 26th Amendment

ISLAMABAD: The Jamiat Ulema-e-Islam-Fazl (JUI-F) has firmly denied reports suggesting the formation of a forward bloc within the party in the backdrop of the proposed 26th Constitutional Amendment, reiterating that all their lawmakers will follow the party's direction on the matter.

Bushra Bibi's Bail Plea In Toshakhana-II Case Heads To Court

ISLAMABAD: The Islamabad High Court (IHC) has fixed former first lady Bushra Bibi's bail plea in the Toshakhana-II case for hearing on October 22, media reported.

Earlier, Islamabad High Court (IHC) notified the Federal Investigation Agency (FIA) in Toshakhana-II case against Bushra Bibi.

The plea was presided over by Justice Miangul Hassan Aurangzeb of the IHC. At the commencement of the hearing, Bushra Bibi's lawyer said his client is in jail from 13 July.

The trial court rejected the bail plea and directed to move to the high court, the lawyer stated.

After the initial hearing, the IHC notified FIA to submit their response on the plea, next week.

On July 13, Imran Khan and his wife Bushra Bibi were arrested in a fresh Na-

tional Accountability Bureau (NAB) reference related to Toshakhana, hours after their acquittal in the Iddat case.

The NAB team headed by Deputy Director Mohsin Haroon arrested Imran Khan and Bushra Bibi from the Adiala Jail.

The development came after the Islamabad district and sessions court accepted the appeals filed by former prime minister Imran Khan and his spouse Bushra Bibi against their conviction in the Iddat case. The couple was sentenced to seven years in prison and awarded a fine of Rs500,000 each, in February earlier this year after a trial court found their nikah to be fraudulent. —RT/Agency
