## Senate Passes 26th Constitutional Amendment After Lengthy Standoff

ISLAMABAD: The Senate on Sunday approved long-awaited 26th constitutional amendment with two third majority (65 votes) aimed at ensuring speedy justice in the country and bringing transparency in judicial system, by incorporating all amendments proposed by Ulama-e-Islam-Fazl (JUI-F).

Minister for Law and Justice Azam Nazeer Tahir piloted the Constitution (Twenty-Sixth Amendment) Bill, 2024 in the House. The House passed the bill through clause by clause reading.

In the bill having 27 clauses, amendments to various Articles of the constitutional document have been proposed. A new Article 9 A regarding clean and healthy environment is also incorporated in the bill under which every person shall be entitled to a clean, healthy and sustainable environment.

As many as 65 members voted in favor of the bill

while only four voted against it.

Kamran Murtaza of JUI-F moved amendments one by one which were incorporated in the bill after not opposing by the government.

Earlier, speaking in the House, Minister for Law and Justice Azam Nazeer Tahir said that the government, its allied parties and JUI-F reached a consensus on the draft of the constitutional amendment bill. As part of the government's efforts, a special parliamentary committee comprising representatives of all the political parties including the opposition Pakistan Tehreek-e-Insaf (PTI) discussed the proposed constitutional package.

He went on to say that the procedure to appoint judges in the superior judiciary had been changed in the 18th Amendment. Both the prime minister and the president surrendered their powers and handed over their authorities

to the parliament to bring more transparency in the appointment of judges, he added.

He said the parliamentary committee was empowered to approve or reject nomination of judges. However, he said the 18th Constitutional Amendment was challenged in court of law and message was given to the then government during the proceeding of the case that the amendment would be struck down.

The minister conceded that 19th Amendment was passed in haste to change the composition of the judicial commission (JC) and parliamentary committee on appointment of judges. Hence, the powers of parliamentary committee were reduced, he added.

Azam Nazeer said even the bar councils and other lawyers representative organizations including Pakistan Bar Council criticized and demanded to revisit the deci-



sion. They demanded to make appropriate amendments in Article 175-A of the constitution, he said.

Now, he said that the JC, responsible for the appointment and confirmation of judges would consist of the Chief Justice of Pakistan (CJP), four senior Supreme Court judges, four parliamentarians, the Law Minister, an advocate having at least 15 years experience, and the Attorney General. Out of four parliamentarians, two members each from Senate and National Assembly, he added.

He said one member of the JC would be either a woman or a non-Muslim qualified to become a senator on a technocrat seat, clarifying the nomination would be made by the Speaker National Assembly.

He said no changes have been made to the provincial Judicial Commissions, where the Chief Justice of the High Court, a senior judge, and the provincial law minister would continue to assess judges' performance.

The minister said that the amendment outlines the procedure for appointing the CJP, clarifying that the Prime Minister would no longer exercise this authority, instead delegating it to the Parliament. A 12-member committee would finalize the nominations and forward them to the PM, with the CJP serving either until retirement or for a maximum of three years, he said.

He said that the appointment of the CJP was a part of the reform package, with three senior judges being considered for the position, from which one would be selected as Chief Justice of Pakistan (CJP).

The minister said that the mechanism for forming constitutional benches at the Supreme Court and provincial levels had been clarified, with logistical preparations needed at the provincial level. Provincial assemblies, with a 51 percent majority, could pass a resolution to establish a provincial constitu-

tional bench, he said.

He said the formation of these benches would be under the authority of the JC headed by the CJP.

He said setting up constitutional court was part of Charter of Democracy (CoD) signed by Shahab-e-Benazir Bhutto and Muhammad Nawaz Sharif in 2006. The Chairman PPP Bilawal Bhutto also took up the matter which was pending agenda part of the CoD, he added.

He said in past, elected prime ministers were removed from their offices by exercising Article 184 of the Constitution although there was clear procedure given in the Article 195 of the constitution. In 2022, the elected prime minister was removed in the constitution through vote of no confidence, he added.

He clarified that incumbent CJP Qazi Faez Isa was

not interested in any extension adding, "During the pre-meetings that I had held with the top Judge, he reiterated his disinterest in his extension of his tenure, saying that any amendment would come into effect after his retirement".

Azam Tahir said that the JC would have the authority to draft rules and establish a clear process for evaluating judges' professional capabilities. The JC in collaboration with the CJP and provincial high courts, would regularly review judges' performance, he added. He said the JC would provide reports on judges' professional skills, and five technical advisors could be appointed in the National and Provincial Assemblies under the constitution. He said Kamran Murtaza of Jamiat Ulama-e-Islam (JUI) proposed five amendments which have already been included in the draft.—RT/Agency

## Bilawal Cheers Nation On Landmark Passage Of 26th Amendment

ISLAMABAD: Chairman Pakistan Peoples Party (PPP) Bilawal Bhutto Zardari on Sunday extended his felicitations to the nation on the passing of the 26th Constitutional Amendment package.

Talking to the media here at the Parliament House, he said that the PPP is fulfilling the promises made in the Charter of Democracy (CoD) particularly those concerning judicial reforms.

He described the day as monumental both politically and personally, as he would be implementing one of the points of his mother's unfinished mission.

Bilawal Bhutto emphasized that this achievement,



like others, has been secured through political consensus, even in the current political environment.

He noted that there were no objectionable or controversial points in the Bill.

Both the government and opposition parties involved in the discussions have reached a compromise.

Even parties that may not vote for the Bill today have no substantive objections, as they have already endorsed the consensus formed between Maulana Fazal ur Rehman and the PPP.

Describing it as a historic day, Bilawal Bhutto shared that he had contacted Maulana Fazal ur Rehman by phone to congratulate him.

He praised the efforts of the JUI and Maulana Fazal ur Rehman in evolving consensus on the amendment, saying that their dedication was not for political gain but for the integrity of the Constitution, which is as vital to them as it is to the PPP.

In a separate address at the PPP parliamentary party meeting, Bilawal Bhutto said

that as Parliamentary Party Leader of the PPP and PPPP, it is his instruction to all parliamentary members that they are to vote in favour of the constitutional amendment being presented in the House. Bilawal Bhutto said that he would be there to guide the members on the specifics, and Sherry Rehman would do the same in the Senate. He said that all members should consider his official instructions. Those who are not or could not be present here today, should consider the video message his public instructions that they are bound to vote in accordance to party instructions, he added.—RT/Agency

## US State Department Presses Pakistan And India To Clarify Scope Of Dialogue

WASHINGTON: After some ice finally melted between Pakistan and India during the recently held Shanghai Cooperation Organisation (SCO) Council of Heads of Government summit in Islamabad, Washington has said that it is for both the nations to decide the scope and role of any bilateral dialogue.

Matthew Miller, the spokesperson for the United States Department of State, reacted to the positive development between the two rival countries in the mega diplomatic event held in the federal capital last week.

"We have bilateral relations with Pakistan and India. The US values its relations with both countries," said Miller in an exclusive conversation with Geo News in Washington.

Reacting to the meeting between India's External Affairs Minister Dr Subrahmanyam Jaishankar with Pakistani leaders during the summit, the spokesperson said that it is now up to both the nations to decide the scope and role of any dialogue that they may have with regards to bilateral ties.

Both Pakistan and India witnessed their usually con-



tentious relations ease during the SCO Council of Heads of Government Summit that welcomed top leaders of member countries in the federal capital.

India, ensuring its participation in the high-level summit, sent its External Affairs Minister Dr Subrahmanyam Jaishankar, who termed the event as a "productive meeting", soon after his speech on October 16. Jaishankar, who attended the SCO mood held in Islamabad, was the first foreign minister of the neighbouring country to visit Pakistan in nearly a decade.

"Signed eight outcome documents. India made a positive and constructive contribution to the deliberations," he wrote on X. While departing from Islamabad after the regional event, Jaishankar thanked PM

Shehbaz Sharif, Deputy Prime Minister and his Pakistani counterpart Ishaq Dar and the government for the "hospitality and courtesies".

Relations between the two countries have witnessed periods of thaw from time to time but have been largely strained since Islamabad downgraded diplomatic ties with New Delhi in 2019 following the abrogation of Article 370 — revoking special status of Indian Illegally Occupied Jammu and Kashmir (IIOJK). Pakistan has since its decision to normalising ties with India with the restoration of the special status of the IIOJK. Despite the frosty ties, the two countries agreed to renew the 2003 ceasefire agreement along the Line of Control (LoC) in February 2021.—RT/Agency

## IHC Judge Lauds Judiciary's Role In Defending Citizens' Rights Amid Tough Times

LONDON: Islamabad High Court's (IHC) Justice Tariq Mehmood Jahangiri has said that judicial independence is essential for any society, its progress and its survival through the maintenance and implementation of the rule of law.

The IHC judge was speaking at the Annual Law Conference organised by the International Lawyers (global), a group of Pakistan-origin lawyers working in the UK as solicitors and barristers.

IHC Justice Arbab Muhammad Tahir and Justice (retired) Shahid Jamil, who recently resigned from the Lahore High Court, also addressed the conference, held at the Society of Lincoln's Inn.

Justice Jahangiri said: "In Pakistan, judicial independence is enshrined in our Constitution as a fun-



damental pillar. Judicial independence means that the courts must be free from any kind of pressure and interference. It allows judges to make decisions solely on the basis of law and nothing else. Pakistan's Constitution safeguards independence of the judiciary and it also safeguards the judiciary from any kind of interference, ensuring it operates as a distinct and equal branch of the government.

Justice Jahangiri said

with the burdens.

The judge praised the role of the Supreme Court and high courts in how they have delivered under challenging circumstances.

"Despite the challenges the judiciary has faced over the decades, it has made commendable strides. The SC and high courts have performed well despite several limitations and have introduced many game-changing reforms. Our courts have taken steps to end unnecessary litigations by introducing Alternative Dispute Resolutions (ADR) and mediation to avoid lengthy court proceedings to save money and to protect the system from taxing burden on the system," he said.

"Meditation centres have been established in many parts." The judge

said that fair trial is right of the citizens and along with the rule of law — ensured by an independent judiciary — they must be strengthened to protect rights of all citizens in every sense. He told the audience: "The SC and high courts are acting as the champion of judicial reforms and are facilitating institutional capacity to deal with numerous challenges." Justice Jahangiri added: "The courts have ensured that justice is served and rule of law is held. The judiciary has made significant progress in the protection of human rights. Courts have been instrumental in defending and maintaining the rights of religious minorities, gender equality and ending enforced disappearances. The courts are acting as the defenders of people rights."—RT/Agency

## PTI Senator Ali Zafar Slams 26th Amendment, Calls It 'Unconstitutional'

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) Senator Ali Zafar has refused to support the 26th Constitutional Amendment, terming the manner in which it is being passed a "crime".

During his speech in a Senate session on Sunday, the parliamentary leader for PTI expressed his concerns, stating that the constitution unites the people rather than divides them. He argued that without consensus on a constitution, it loses its legitimacy. He drew comparisons to the 1956 and 1962 consti-



tutions, noting that both lacked national consensus and ultimately failed. "The 1956 constitution did not have the support of the nation, and it died out. Similarly, the 1962 constitution

also lacked consensus and met the same fate," he added. Zafar criticised the current process of pushing through the 26th amendment, alleging that individuals are being coerced into voting and that genuine consent is not involved. He condemned this as a violation of both the constitution and democracy, pointing out that two previous governments had fallen victim to Article 58 of the constitution, a controversial provision that allowed for the dissolution of parliament.—RT/Agency

## CJP Isa Demands Answers From Eight SC Judges Over Reserved Seats Controversy

ISLAMABAD: Chief Justice of Pakistan (CJP) Qazi Faez Isa, for a second time, expressed reprobation over the clarification issued by eight judges on the reserved seats case.

According to the clarification, the amendments made in the Elections Act 2017 cannot overrule the apex court's July 12 judgment pertaining to the matter, media reported on Sunday.

Seeking an explanation from the relevant department on the second clarification issued by the judges, CJP Isa on Saturday questioned how the



eight judges issued a clarification without filing the original file of the case.

He has sought an explanation from Deputy Registrar Mujahid Mahmood, Assistant Registrar Shahid Habib and Web

Master Asim Javed.

The eight-member majority judges of the apex court in the reserved seats case on Friday held that the amendments made in the Elections Act cannot undo their judgment with retrospective effect, so

the Election Commission of Pakistan (ECP) was bound to implement the judgment in letter and spirit.

In response to the Civil Miscellaneous Applications (CMAs) filed by the ECP and Pakistan Tehreek-e-Insaf (PTI) seeking clarification, the eight judges of the Supreme Court issued the clarification in chambers at Islamabad and Karachi.

The eight judges included Justice Syed Mansoor Ali Shah, Justice Munib Akhtar, Justice Muhammad Ali Mazhar, Justice Ayesha A Malik, Justice Athar Minallah,

Justice Syed Hasan Azhar Rizvi, Justice Shahid Waheed and Justice Irfan Saadat Khan. They held that the judgment of the apex court has a binding effect in terms of Article 189 of the Constitution and should have been implemented. Meanwhile, CJP Isa also sought an explanation from the webmaster asking how the clarification was uploaded on the SC website without filing the original file of the case. Meanwhile, the Public Relations Department of the apex court has not issued any press release in this regard till the filing of this report.—RT/Agency

## GDA plans to continue protest movement against IRSA Act amendment and illegal canal construction

BADIN: The Grand Democratic Alliance (GDA) and allied parties commenced a protest march from Karachi to Badin against the amendment of the IRSA Act, illegal canal construction from the Indus River, unconstitutional amendments, and other public issues. The protest march, which started from Karachi Mahir, aims to address several issues, including the amendment of the IRSA Act, illegal canals from the Indus River, undemocratic constitutional changes, and the reduction of paddy prices in Sindh. A joint meeting of leaders and workers from coalition parties involved in the GDA was held at the Mirza farmhouse of former Interior Minister Dr. Zulfiqar Mirza to prepare for the protest march and the public meeting in Badin. During this meeting, GDA leader Barrister Hasnain Mirza, along with Advocate Ameer Azad Panhwar, Central Vice President of the Sindh United Party, and leaders from the Muslim League Functional, addressed the attendees. They stated that once again, forces hostile to Sindh are attempting to exploit the IRSA Act to divert water from the Sindh region of the Indus River, with plans to extract six to seven illegal canals.



Pro-Sindh parties, along with the people of Sindh and various political, social, academic, and literary circles, have reacted strongly against this conspiracy and initiated their struggle. In addition to protesting against the amendment of the IRSA Act and illegal canal construction, there will also be protests against the reduction in paddy prices. There are concerns about a conspiracy to undermine democracy and the constitution once again. Hasnain Mirza highlighted that Dr. Fehmida Mirza was instrumental during the 18th amendment, as she consulted all political parties over nine months. The GDA comprises various parties, including the Pakistan Muslim League Functional, Mirza Group, Sindh United Party, Awami Jamhoori Party, Jamaat-e-Islami, Pakistan Tehreek-e-Insaf, Jamiat Ulema-e-Islam Fazl, and Sindh Progressive Party. Additionally, intellectual, literary, and social circles from Sindh are involved in this struggle. Participants emphasized that water is a matter of life and death, and the people of Sindh have united to fight against every conspiracy threatening Sindh and democracy. Key figures including Zain Shah, Dr. Safdar Abbasi, Ayaz Latif Palijo, Dr. Qadir Magsi, Liaquat Jatoi, Arbab Gulam Rahim, Dr. Zulfiqar Ali Mirza, and Muhammad Hussain from Jamaat-e-Islami are expected to speak at the public meeting. Due to scheduling conflicts, provincial officials from Jamiat Ulema-e-Islam will address the gathering instead of the central leadership.

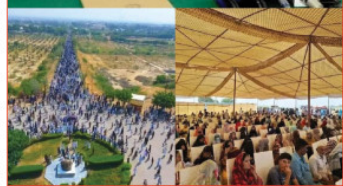

## Over 11,000 Candidates Take Part In SU Pre-Entry Test at Jamshoro Campus In Second Phase

JAMSHORO: The second phase of the pre-entry test for admissions to 20 various bachelor's degree programs for the academic year 2025 was successfully conducted at Sindh University (SU) on Sunday. A total of 11,068 candidates, including 3,390 females, participated in the test at the Jamshoro campus, competing for approximately 11,000 available seats.



In the first phase, 9,001 candidates had already taken the test for various degree programs, further underscoring the high demand for SU's academic offerings. The Vice-Chancellor, Prof. (Meritorious) Dr. Muhammad Siddique Kalhoro, visited the examination centers at the main campus to oversee the process and interact with candidates to ensure they were satisfied with the facilities provided. He was accompanied by key university officials, including Registrar Prof. Dr. Mush-taque Ali Jariko and Director Admissions Prof. Dr. Ayaz Keerio.

The test began at 10:20 am and lasted for 90 minutes. Separate blocks were allocated for the female candidates at various institutes, including the Institute of Microbiology, Institute of Biotechnology & Genetic Engineering, and the Department of Media & Communication Studies. Male candidates were placed in different buildings such as the Arts Faculty Building and the Institute of Physics.

Stringent security measures were implemented at all centers, with walkthrough gates, police presence, and SU security personnel ensuring a peaceful environment. Speaking to the media, Dr. Kalhoro highlighted the increasing interest in SU's undergraduate programs, especially with the introduction of new market-oriented degrees that focus on modern technological and scientific advancements. He emphasized that the participation of women in science and technology was crucial and expressed the university's commitment to supporting their academic success.

In addition to Jamshoro, pre-entry tests were also held at various SU campuses across the province. According to data from the Directorate of Admissions, 422 candidates appeared at the Laar Campus in Badin, 461 at Dadu Campus, 142 at Thatta Campus, and 95 at Naushero Feroze Campus.

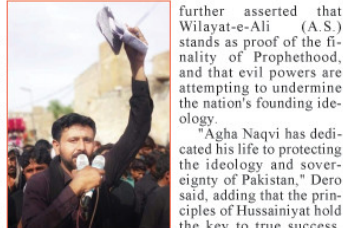

## Boat carrying more than 100 Rohingya sighted off Indonesia

INDONESIA: A boat loaded with more than 100 Rohingya refugees was spotted off Indonesia's westernmost province with at least one dead body seen on board, local officials said.



body of a Rohingya woman was found at sea.

The mostly Muslim ethnic Rohingya are heavily persecuted in Myanmar, and thousands risk their lives each year on long and dangerous sea journeys to try to reach Malaysia or Indonesia.

The Rohingya boat is anchored around three to four miles (5-6km) off the coast of South Aceh district with its engine turned off, community leader Muhammad Jabal told AFP.

He said the boat was first seen on Friday when he and others set out to deliver food and water to the refugees, estimating more than a hundred were on board.

"I saw with my own eyes there was a body. There were many children too aboard the boat," Jabal said.

The day before the sighting of the boat, the

Local police chief Sabda Man Sobri confirmed she was a member of the ethnic group, but could not comment on whether she was connected to the boat.

Yuhelmi, a South Aceh district spokesperson, confirmed the boat sighting but said locals were waiting for an immigration team from provincial capital Banda Aceh to arrive before deciding the next step for the refugees.

"Whether (the refugees) will be brought on land, that's within the authority of the immigration. For now, there has been no decision," said Yuhelmi, who goes by one name.

The United Nations refugee agency (UNHCR) said it had been informed by local authorities about the vessel and hoped the refugees would be rescued immediately.

Many Acehnese are sympathetic to the plight of the Rohingya but some locals have opposed their arrival, accusing members of anti-social behaviour.

In December 2023, hundreds of students forced the relocation of more than a hundred Rohingya refugees, storming a function hall in Aceh where they were sheltered and kicking their belongings.— Agency

## Israel Hits Hezbollah Intelligence HQ After Drone Launched At Netanyahu Home



Fighting raged on two fronts Sunday as Israel targeted what it said was a Hezbollah "command centre" in the Lebanese capital, while in Gaza rescuers reported 73 people killed in a single air strike.

The strikes on Hezbollah's south Beirut stronghold came after Israeli Prime Minister Benjamin Netanyahu accused the Iran-backed group of attempting to assassinate him by targeting his residence.

It also came as Israelis marked the major week-long Jewish holiday of Sukkot, which last year saw the October 7 Hamas attack that sparked the Gaza war.

Lebanon's official National News Agency (NNA) said Israel's strikes on Beirut hit a residential building in Haret Hreik near a mosque and a hospital.

The Israeli military said it hit a Hezbollah "command centre of Hezbollah's intelligence headquarters" and underground weapons facility in Beirut, and that it also killed three Hezbollah militants in other strikes.

It later said about 70 projectiles fired from Lebanon crossed into Israel within a matter of minutes, and that it intercepted some of them.

Gaza's civil defence agency meanwhile said an Israeli air strike on a residential area killed at least 73 Palestinians in Beit Lahia in the territory's north.

"Our civil defence crews recovered 73 martyrs and a large number of wounded as a result of the Israeli air force targeting a residential area... in Beit Lahia in northern Gaza," said civil defence agency spokesman Mahmud Basal. The Israeli military said it struck a "Hamas terror target".

It added that the toll figures given by Gaza authorities "do not align" with the information it possessed.— Agency

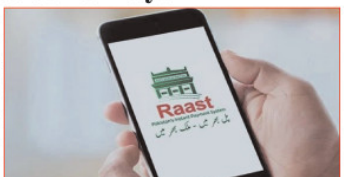

## Raast Payment System Shatters Records, Processes Rs1 Trillion In Just 16 Days

KARACHI: Pakistanis recently made financial transactions totalling Rs1 trillion via Raast, an instant payment system, in just 16 days, compared to the first Rs1 trillion transacted over 336 days two years ago, marking a significant shift towards the adoption of digital payment solutions.



The State Bank of Pakistan (SBP) reported that Raast has processed 892 million transactions amounting to Rs20 trillion, with the latest trillion achieved in just 16 days. "This reflects SBP's commitment to making digital payments easier and accessible for all," the bank stated. The data suggests that the average payment size through the online system stood at Rs22,421.52.

According to the SBP's Governor's Annual Report 2023-24, the major driver of this volumetric growth in Raast transactions was the Person-to-Person (P2P) module, which was launched in February 2022. Pakistan's digital payments and financial markets

are experiencing continuous improvements, including the SBP's introduction of the Person-to-Merchant (P2M) module in Raast. This module allows businesses to accept payments via QR codes, Raast IDs, bank account numbers, and request-to-pay options, thereby expanding payment choices for customers and further boosting digital payments. This initiative is expected to enhance convenience for businesses in carrying out their transactions. Meanwhile, the expansion in the total number of accounts maintained a double-digit growth, up 18% to reach 215 million accounts by the end of FY24. "This fast growth is conducive to raising financial inclusion in the country," the report highlighted. The significant increase in accounts was supported by the expansion of SBP-regulated entities, including banks, microfinance banks (MFBs), and development financial institutions (DFIs), whose branch networks grew to 18,355 in FY24, up from 17,751 in FY23. These branches, along with increasing alternate delivery channels (ADCs), facilitated financial intermediation and served a large number of customers during FY24.—RT/Agency

## Prabowo Subianto takes oath to become Indonesia's eighth president

Indonesia's Prabowo Subianto on Sunday took over as president of the world's third-largest democracy, vowing to combat internal issues such as corruption and to make it more self-sufficient.



The 73-year-old has undergone a remarkable transformation, from being a former military commander facing unproven allegations of rights abuses to sweeping the polls and now leading the country of 280 million people.

Prabowo officially became Indonesia's eighth president on Sunday morning after he was sworn in during a ceremony at Indonesia's parliament.

The ex-military commander, who unsuccessfully ran for presidency twice before, said in a fiery speech to lawmakers he would be president for all Indonesians and challenged the nation to help him face down the country's problems.

"We must always realise that a free nation is where the people are free," Prabowo said, at times raising his voice.

"They must be freed of fear, poverty, hunger, ignorance, oppression, suffering," he said.

In a wide-ranging speech lasting about an hour, Prabowo said self-sufficiency for food was possible within five years, while also pledging to

come self-sufficient in energy. Flower boards outside the palace either congratulated Prabowo and Gibran or thanked Jokowi for his decade of service.

Indonesian police and military have put in place strict security measures, deploying at least 100,000 personnel across the city, including snipers and anti-air units.

Prabowo is expected to meet with foreign dignitaries, including a number of heads of state, later on Sunday at the presidential palace, said Hasan Nasbi, the head of the presidential communications organisation.

Prabowo also touched on foreign policy during his speech, saying Indonesia was non-aligned on the global stage, but that he stood in support of the Palestinian people and said Jakarta was ready to send more aid to Gaza.

During his campaign, Prabowo billed himself to voters and investors alike as the "continuity candidate".— Agency

## Musk gives away millions to attract Republican supporters



Founder and CEO of SpaceX and The Boring Company Elon Musk vowed on Saturday to hand out \$1 million each day until November 5 to people signing his online petition underpinning the US Constitution.

Keeping his word, Musk immediately granted a \$1 million cheque to John Dreher, a participant of event intended for gathering supporters for former US president and Republican representative Donald Trump, according to event staff.

"By the way, John had no idea. So anyway, you're welcome," the Tesla founder said as he handed Dreher the check.

The generosity is the latest example of Musk using his extraordinary wealth to influence the tightly-contested presidential race between Trump and his Democratic rival Kamala Harris.

He said on Saturday that if Harris wins, it will be "the last election," suggesting the US will no longer exist.

He also said the two assassination attempts against Trump prove he is ruffling feathers and upending the status quo in ways Harris won't. He said that's why no one is trying to kill Harris.— Agency

## Saudi Arabia arrests over 21,950 illegal immigrants in one week

RIYADH: The authorities in Saudi Arabia have arrested 21,971 people in one week for breaching laws related to border security, residency and labour.

The Saudi Press Agency (SPA), on Saturday, reported that the Ministry of Interior conducted inspection campaigns in the Kingdom of Saudi Arabia (KSA) between October 10 and October 16 to ensure compliance with the residency, labour and border security laws.

The authorities found 13,186 people non-compliant with the laws of residency, 5,427 of border security, and 3,358 of labour laws across the country, as per an official report.

The SPA said 1,421 individuals were found attempting to illegally cross the border into the KSA. It said 34% of them were

Yemenis, 64% Ethiopians, and 2% of other nationalities. Whereas, 53 people were arrested for trying to leave the Kingdom illegally.

Furthermore, the ministry officials arrested 18 people involved in transporting, sheltering and employing violators. The SPA said 8,370 people detained for violating laws were instructed to contact their countries' embassies or consulates to obtain proper travel documentation. While, 2,054 of them were told to make booking arrangements for their departure, and 12,355 were repatriated. Total 15,775 immigrants (13,885 men and 1,890 women) "are currently undergoing procedures for enforcing regulations", the news agency said.— Agency

## UK Man Bites Off Teen Girl's Face In Front Of Horrified Bus Passengers

A teenager in the UK suffered a horrific attack on a bus when an inebriated stranger allegedly assaulted her. According to Metro, the incident occurred last year when Darren Taylor, 53, began making inappropriate comments about Ella Dowling and her friends. An argument between them followed, but as the bus pulled up at the Promenade and the teen tried to get off, Taylor lunged at her. He grabbed the 19-year-old's face and repeatedly bit her nose and mouth.



The young woman was quickly taken to Cheltenham General Hospital before moving to Gloucestershire Royal Hospital for emergency surgery. She required 50 stitches for her injuries.

In March 2024, Taylor pleaded guilty to GBH with intent at Gloucester Crown Court. On July 18, he received a sentence of six years and nine months in prison, accompanied by a lifelong restraining order.

A man has been jailed after he bit a woman's face and caused significant injuries to her. Ella, a social work student at Portsmouth University from Cheltenham, Gloucestershire, said, "The pain I felt when he sank his teeth into my face is something which will stay with me forever. He was like a dog with a toy - moving his head side to side - I put my hands around the back of his head because I knew if I didn't he would rip my lip and nose off completely. When I saw my face for the first time after the attack, I didn't recognise my own reflection, and I couldn't look in the mirror for months after that.— Agency

## 26th Amendment: A Wake-Up Call for PTI and Imran Khan's Everest of an Ego!

The ease with which the coalition government secured a two-thirds majority in the Senate for the 26th Amendment should be a harsh reality check for Imran Khan and his party, PTI. Despite vocal opposition and attempts to disrupt the process, the bill passed with overwhelming support, and is likely to sail through the National Assembly as well. This marks a significant psychological and strategic defeat for PTI, revealing their diminishing influence within the political arena.

The government's success in pushing through controversial judicial reforms demonstrates that it has managed to unite its allies, while PTI finds itself increasingly isolated. This development

underscores a critical flaw in PTI's political strategy — a failure to build consensus and adapt to the changing dynamics of Pakistan's



political landscape. Imran Khan's reluctance to engage meaningfully with other parties and his confrontational approach have only alienated potential allies, leaving him with little leverage at crucial junctures.

For Imran Khan, this setback should serve as a moment of introspection. The former prime minister's political missteps and ego have led to

a steady decline in his support among key stakeholders, who are now aligning themselves with his rivals. His party's decision to boycott the vote, instead of participating in the legislative process to offer amendments, highlights a lack of strategic planning and adaptability.

If PTI hopes to regain its footing, it must accept the political realities and re-evaluate its approach. Building alliances, engaging in constructive dialogue, and shedding the confrontational mindset are essential if the party intends to remain relevant in the future. The 26th Amendment has proven that political victories are won not through obstinacy, but through negotiation and collaboration.

LAHORE: The Pakistan Cricket Board (PCB) has proposed that the Indian team may return to their country after each match to minimise their stay in Pakistan during the Champions Trophy 2025, media reported on Sunday.

The board, owing to security concerns, has suggested that the Men in Blue's return to Chandigarh or New Delhi after each match in the mega tournament set to be hosted by Pakistan from February 19 to March 9, 2025.

The development comes due to uncertainty over India's participation in the tournament, as the Board of Control for Cricket in India (BCCI) seeks the Indian government's approval to visit the country for the mega tournament.



In light of the fact that the neighbouring country's cricket team have not travelled to Pakistan since 2008. The arch-rivals have also not had any bilateral series since 2012-13.

The ICC Champions Trophy 2025 is set to feature eight elite teams including India, Australia, New Zealand, England, South Africa, Bangladesh, and Afghanistan, based on their performances in the 2023 ODI World Cup.

Three venues - Karachi, Rawalpindi and Lahore - will host the matches of eight teams and according to PCB's proposed schedule to ICC, all of India's matches will take place in Lahore.

The PCB has reassured the BCCI of its commitment to providing every possible

comfort and security to the Indian team, offering flexible arrangements to ensure their involvement in the highly anticipated event.

Initially, all of India's matches were scheduled to take place in Lahore for convenience and ease of access for the Indian team and their fans.

However, recent proposals suggest that one of India's group-stage matches - potentially against New Zealand - might be shifted to Rawalpindi.

This adjustment was suggested by broadcasters, who recommended distributing India's matches between Lahore and Rawalpindi to enhance broadcast reach and fan engagement.—Agency

## Mbappé's Shocking Inclusion In Madrid Squad Despite Explosive Rape Allegations



SPAIN: Real Madrid star Kylian Mbappé will start for the Spanish champions at Celta Vigo in La Liga amid reports he is being investigated for an alleged rape during a visit to Sweden.

The 25-year-old France striker, who visited Stockholm during time off granted by Madrid, said the reports were "fake news" and his lawyer said Mbappé will take action for libel.

A Swedish prosecutor confirmed that an investigation has been opened, without naming Mbappé.

Real Madrid coach Carlo Ancelotti selected Mbappé in attack for the visit to face Celta, along with Vinicius Junior.

Ancelotti said Friday

Mbappé looked a "different player" after the international break, having worked on his fitness following an injury, and said he thought the player seemed unaffected by the investigation reports.

"In this moment (the reports) are speculations. I see him working every day, he is happy, content, he doesn't seem affected to me at all," Ancelotti told a news conference.

"He's looking forward to keep on helping the team."

Mbappé completed a dream move to Madrid in the summer after seven years in French champions PSG. The striker scored five goals in his first seven La Liga appearances before suffering a thigh injury.—Agency

## New Zealand Ends India's Dominance: Stuns Hosts For First Test Win In 36 Years

BENGALURU: New Zealand on Sunday secured an eight-wicket win to mark their first victory in India since 1988 as the Black Caps chased down 107 and humbled the home side early on the final day of the rain-interrupted series opener.

Dismissing the Indian team for their worst home total of 46 and making 402 in reply, the visitors bowled out Rohit Sharma's side for 462 in the second innings on Saturday to lay the platform for a 1-0 lead in the three-match series.

Will Young (48\*) and Rachin Ravindra (39\*) remained calm under pressure after the loss of two early wickets to get the job done, earning New Zealand only their third win on Indian soil in 38 attempts going back to 1955.



"It was probably a good toss to lose," said New Zealand skipper Tom Latham.

"The guys came out in that first innings, put the ball in the right areas for long periods of time and managed to get the results." "The first two innings of the game [...] I think we set the game up beautifully. We knew India were going to come back in the third innings and they put us

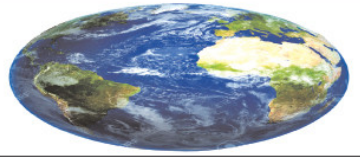

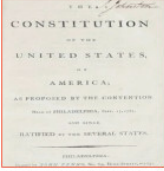

## Rare US Constitution Copy From 1787 Fetches Over \$11 Million At Auction

A rare copy of the United States Constitution, printed after the 1787 Constitutional Convention, has sold for more than \$11 million during a live auction in Asheville, North Carolina, on Thursday evening.

The auction, conducted by Brunk Auctions, ended with a final bid of \$9 million, excluding a 23 per cent buyer's premium and undisclosed taxes. The identity of the buyer remains confidential as of now. The bidding of this rare copy commenced at \$1.1 million and escalated fast, reaching the final bid within a period of a brief seven minutes. NBC Los Angeles reported that there were 62 bids in total.

The Constitutional Convention, which took place in Philadelphia from May to September 1787, was a pivotal moment in American history. Initially assembled to amend the Articles of Confederation, the need for a new framework of government due to the loopholes in the existing system was



North Carolina. The farm was owned by Samuel Johnston, the governor of North Carolina from 1787 to 1789. It is one of approximately 100 copies printed back then, with only eight or nine known remaining today.

In addition to the Constitution, other notable items sold at the auction included a painting of George Washington crossing the Delaware River, which fetched over \$307,000, and a copy of the Articles of Confederation that sold for more than \$1.2 million.

Seth Kaller, a historical document expert involved in the auction, said that while there were hopes for a sale price comparable to a previous record-setting sale in 2021 when another early Constitution copy sold for over \$43 million, this outcome was anticipated due to differing market conditions this time.

Kaller was also representing one of the bidders in this auction. — Agency

quickly pointed out. This resulted in a new constitution, which established a federal government with checks and balances among its branches. This document thus remains foundational to American democracy, making it all the more historically significant at an auction such as this one.

Nancy Zander, the director of external affairs for Brunk Auctions, described the sale as a "spectacular price" to The New York Times. "It's really important that important things get strong prices," she said in an interview on Friday.

## "Had Weird Taste": Woman Freed From ISIS Reveals They Made Them Eat Babies

Two weeks after her rescue by the Israeli Defense Forces (IDF) from Gaza, Yazidi survivor Fawzia Amin Sido has recounted the harrowing atrocities she endured during her time in captivity under ISIS. Ms Sido recounted how, at the age of nine, she was captured along with her brothers and forced to march from Sinjar to Tal Afar. The group was starved for three days before being fed rice and meat, which they later discovered was the flesh of Yazidi babies.



Fawzia Sido's ordeal did not end with the forced consumption of human flesh. She was held captive for nine months in an underground prison alongside 200 other Yazidi women and children. Some of the children died due to contaminated water. Ms Sido was also sold to multiple jihadi fighters, including Abu Amar al-Makdisi, with whom she had two children. After years of captivity, she was rescued by the IDF in a joint operation with the US Embassy and returned to her family in Iraq. However, her children remain in Gaza with her parents' family, where they are being raised as Arab Muslims. — Agency

"They made rice and gave us meat to eat with it. The meat had a weird taste, and some of us had stomach aches afterwards," Ms Sido recalled, as per the Jerusalem Post.

"When we were done, they told us that this was the meat of Yazidi babies. They showed us pictures of beheaded babies and said, 'these are the kids that you ate now.'"

"One woman suffered heart failure and died shortly after," Ms Sido said, adding that no other even recog-

nisied her own child because of the baby's hands. "They forced us. But it's very hard to know that it happened. But it was not in our hands," she said.

Fawzia Sido was one of many Yazidi women enslaved by ISIS in 2014 during the group's reign of terror. The Yazidis, a religious minority in northern Iraq, were subjected to unimaginable horrors.

Ms Sido's revelation follows previous accusations that ISIS fed human meat to their captives Yazidi parliamentarian Vian Dakhlil first brought this practice to light in 2017, but Ms Sido's firsthand account is one of the clearest confirmations of this depravity.

## UK Woman Fired After Coming Back From Maternity Leave Pregnant Again, Awarded Compensation

A woman in the UK who was fired from her job when she came back from maternity leave pregnant again, has been awarded 28,000 pounds by an employment tribunal. Nikita Twitcheen, a former admin assistant at First Grade Projects in Pontypridd launched an unfair dismissal claim, alleging her pregnancy was the reason for her termination, Metro reported. During her back-to-work meeting with Managing Director Jeremy Morgan in early 2022, Ms Twitcheen revealed she was expecting another child, which she claims caused her boss off guard.

Both countries on Monday ordered six diplomats in a tit-for-tat move over Ottawa's allegations that New Delhi was targeting Indian dissidents on Canadian soil. Trudeau specifically tied the six to the murder of Sikh separatist Hardeep Singh Nijjar last year in British Columbia. Sanjay Kumar Verma, India's envoy to Canada, told CTV

## Trump brings McDonald's into political spotlight during final days of election campaign

Donald Trump is bringing McDonald's into the political spotlight during the final days of his third bid for the White House.

The former US president is expected to visit one of the fast-food chain's Pennsylvania franchises during his campaign stop on Sunday. Trump is reportedly planning to take on the role of a fry attendant, according to CNN.

This move mirrors a job Vice President Kamala Harris held as a young woman, a key part of her middle-class upbringing narrative during her presidential campaign. Harris worked at McDonald's while she was a student, a detail that has featured prominently in her political biography.

Trump, known for his love of McDonald's, has been fixated on Harris' employment there. On the campaign trail and in interviews, he frequently casts doubt on her claim, accusing her of fabricating the story. His visit to the fast-food chain appears to be an attempt to undermine her work history.

"I'm going to McDonald's to work the french fry," Trump told supporters at a rally in the Pittsburgh area. "I think I'm doing it tomorrow, and I think it's in Pennsylvania."

Harris has not responded to Trump's allegations or the questions raised by conservative media. Her campaign has remained silent



on Trump's planned visit to McDonald's.

However, a campaign official told CNN that Harris worked at a McDonald's in Alameda, California, during the summer of 1983. She was then a student at Howard University and took on tasks such as working the register and the fry machine.

In a recent interview on Drew Barrymore's talk show, Harris recalled her time at the chain, saying, "I did fries. And then I did the cashier." She also mentioned her McDonald's stint during the 2019 campaign when she stood with striking workers on the picket line. During this summer's Democratic National Convention, Harris' time at McDonald's was repeatedly mentioned as a contrast to Trump's wealthy upbringing.

Trump's wealthy upbringing, former President Bill Clinton joked that she might surpass his record for spending time at the fast-food chain. Others emphasized her modest background compared to Trump's privileged lifestyle.

"Can you picture Donald Trump working at a McDonald's?" quipped Harris' running mate, Minnesota Governor Tim Walz. "He couldn't even run the McClurry machine."

Trump has often attacked the backgrounds of his political opponents without evidence. He previously led the debunked "birther" movement against Barack Obama and falsely linked Ted Cruz's father to JFK's assassination. This time, he has turned his focus to Harris, questioning her heritage and work history. Despite these accusations, Trump has exaggerated his own biography on multiple occasions. In his autobiography "The Art of the Deal", he coined the term "truthful hyperbole" to describe his tendency to stretch the truth, claiming it was a promotional tool. — Agency

## Harris to celebrate birthday with church visits, Trump to 'leisure' in McDonald's

Democrat Kamala Harris will commence her 60th birthday celebrations on Sunday with two church visits in Georgia where she will strategise to rally early voters.



However, her Republican opponent Donald Trump will be enjoying his weekend at McDonald's in Pennsylvania.

With only 16 days before the election on November 5, both candidates are almost deadlocked for the presidency in the most contested states.

The candidates have intensified their criticism recently, encouraging early votes by mail or in person.

Earlier, Harris said that she worked at McDonald's when she was young but Trump says he does not believe her.

Trump, after escalating personal attacks on Harris on Saturday, told Breitbart News he would work at a McDonald's restaurant in Pennsylvania on Sunday "just for fun" to mock Harris.

Trump adviser Jason Miller said Trump would be working in the french fries area of the restaurant.

Trump also plans a rally in Lancaster, Pennsylvania, in the late afternoon. He is seeking to take advantage of

what he felt was an improved position for him in opinion polls that show a tight race.

Moreover, VP Harris and former President Trump, are concentrating on Pennsylvania, Michigan, and a few other states that will probably determine the outcome of the election, where both parties have substantial support, as electoral outcomes have been tight in previous election cycles.

Following her Saturday appearances with hometown rapper Lizzo in Detroit and pop singer Usher in Atlanta, the VP will also receive a birthday boost on Sunday from Stevie Wonder, another music giant, when he drops by one of the churches she plans to visit.

Harris and her running mate, Minnesota Governor Tim Walz, will double down on Sunday on a "Souls to the Polls" initiative aimed at using gospel performances, national and state faith lead-

## Millions Of Cubans Still Without Power After 3rd Grid Failure



Millions of Cubans awoke on Sunday to find their homes still without power after another partial grid failure overnight, deepening a crisis that has raised questions over the viability of the government's efforts to reestablish electrical service.

The country's top electricity official, Lazaro Guerra, confirmed a partial grid collapse in the western provinces of Cuba, which includes Havana, late on Saturday.

Technicians were working to resolve the issue, Guerra said, but did not provide a timeline for when power would be restored to the region.

The capital of nearly two million residents appeared to be entirely without electricity early on Sunday, as many Cubans formed lines for subsidized rations and mullied the situation outside their homes.

## Classified US Intelligence Leaked, Documents Show Israel's Plans For Iran

Two highly classified US intelligence documents have leaked, allegedly exposing Israel's military preparations for a potential strike on Iran, the New York Times reported. The documents, originating from the National Geospatial-Intelligence Agency (NGA) - "responsible for analysing images and information collected by American spy satellites" - offer insights into Israeli military exercises and operational readiness.

The two documents, dated October 15 and 16, were circulated on Telegram by accounts largely associated with pro-Israel sentiments. They provide detailed analyses of satellite images showing Israel's military exercises, which appear to be in preparation for a retaliatory strike on Iran. The potential strike comes in the wake of escalating tensions following an Iranian missile barrage on October 1, itself a retaliation for an earlier Israeli attack.

One of the documents is titled "Israel: Air Force Continues Preparations for Strike on Iran" and outlines recent Israeli exercises that seem to rehearse a potential military operation against Iran. These preparations reportedly in-



clude air-to-air refuelling operations, search-and-rescue missions, and the repositioning of missile systems in anticipation of potential Iranian strikes. The second document reveals Israeli efforts to move munitions and other military assets to strategic locations.

Although the documents describe Israeli military movements and exercises, they do not provide satellite images themselves. The US intelligence gathered from these images suggests that Israel is gearing up for a strike, but it is unclear whether these documents reveal the full scope of Israel's plans for Iran.

The leaks have reportedly prompted immediate concern within the US government. US officials are divided over the severity of the leak, with some downplaying its impact

While the exact source of the leak remains unknown, early indications suggest that the documents may have been taken by a lower-level US government employee. A joint investigation by the Pentagon, US intelligence agencies, and the FBI is underway to determine how the information was leaked and whether more documents could follow. — Agency

## Vusted Two Passengers Arrested At Karachi Airport For Attempting To Use Fake Documents



KARACHI: The Federal Investigation Agency (FIA) Immigration team apprehended two passengers at Jinnah International Airport for attempting to travel abroad with counterfeit visas, according to media reports on Sunday. The suspects, identified as Nazir Abbas and Umme Salma, were arrested after the FIA team discovered fake visas affixed to their flight IA-432 with a fraudulent Iraqi visa, while Nazir Abbas, from Karachi, was heading to the Turks and Caicos Islands on flight TK-709 with a fake Cuban visa.

A forensic report from the Scandline Office confirmed that the visas lacked key security features, prompting their arrest. Both individuals have been handed over to the Anti-Human Trafficking Circle in Karachi, resident of Multan, was for further investigation. —RT/Agency

## Sindh Hit by Two New Polio Cases As National Tally Climbs To 39

ISLAMABAD: Two fresh cases of the wild poliovirus type-1 (WPV1) have been confirmed in Sindh, raising the total number of country-wide cases to 39 so far in 2024, said the National Emergency Operations Centre (EOC).



The emergence of the new cases shows the extent of deterioration with regards to the poliovirus crisis in Pakistan.

Polio Eradication Initiative (PEI) officials, on Sunday, told media that the two new victims are kids - a boy from Mirpurkhas and a girl from Sanghar. Both are the first known instances of the disease in their respective areas this year. According to the PEI officials in Islamabad, Sindh is experiencing an increase in virus transmission, particularly after multiple environmental samples from Mirpurkhas tested positive for WPV1 earlier this year. After a nationwide anti-polio vaccine campaign from October 28, said the EOC. Misinformation and conspiracy theories continue to fuel vaccine hesitancy across Pakistan, es-

pecially in regions like Balochistan and KP. Many parents refuse polio vaccines due to baseless myths, such as the false claim that vaccines cause infertility or are part of a foreign conspiracy. ## Dar Claims Passage Of 26th Amendment Fulfills Long-Pending CoD Commitments

ISLAMABAD: Deputy Prime Minister and Foreign Minister Mohammad Ishaq Dar on Sunday expressed his gratitude to all political parties for voting in favor of the 26th Constitutional Amendment and said that the incomplete agenda of the Charter of Democracy (CoD) had now been fulfilled.

ISLAMABAD: The Adiala jail authorities have rubbished the claims made by the Pakistan Tehreek-e-Insaf (PTI) about ill-treatment meted out to the former prime minister Imran Khan, while revealing exquisite menu of meals provided to the party founder in prison.



The menu was revealed after PTI Chairman Gohar Ali Khan mentioned about alleged mistreatment towards the deposed prime minister in the jail following the former's meeting with the latter in Adiala — where Imran remains incarcerated for over a year now.

Addressing journalists in Islamabad, the PTI chairman said it was for the first time after his imprisonment at the Adiala jail that Imran mentioned about conditions of his prison cell, media reported. He said electricity supply to his cell was suspended for five days, while he had not been provided a newspaper or TV facility for the last fortnight and he was allowed to spend just two and a half hours out of his cell in a day.

Condemning the "ill-treatment", Gohar said the authorities should look after

the rights of the former prime minister and provide him the facilities he was entitled to in his "solitary confinement". He asserted that keeping him in a small cell was a serious violation of constitutional and legal rights.

Plan before the gathering of some 1000 guests from over 50 countries, Mushahid said the first step should be for President Erdogan to take the lead and constitute an International Leaders Delegation, comprising leaders from the Global South, including Pakistan, Indonesia, Malaysia, South Africa, Algeria and Brazil, who should visit Washington immediately after the November 5 US Presidential polls to meet the American President-elect, and urge the new US President to reverse the occasion due to either fear or expediency," he added.
