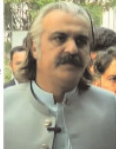

## PM Hails 26th Constitutional Amendment As A Game-Changer For National Stability And Welfare

ISLAMABAD: Prime Minister Shehbaz Sharif on Tuesday said that the 26th Constitutional Amendment Bill passed by the parliament with a two-thirds majority would prove to be a milestone for the country's political and economic stability and public welfare.

The prime minister, addressing the meeting of the federal cabinet he chaired, said the new legislation would surely bring ease for the common man who had to suffer owing to inordinate delays in seeking justice.

Besides, he said the 26th constitutional amendment, passed following an in-depth consultation among the ruling coalition and opposition parties, was also an accomplishment of the vision of the Charter of Democracy signed by Shaheed Benazir Bhutto and Mian Nawaz Sharif in 2006.

He said the tireless efforts led to the successful legislation which also manifested a true spirit of consultation.

Prime Minister Shehbaz thanked the leadership of the supportive political parties including President Asif Ali Zardari, Bilawal Bhutto Zardari of PPP, JUI-F's Maulana Fazlur Rehman, Muttahida Qaumi Movement, National Party, Awami National Party, Balochistan Awami Party and, also the in-



dependent candidates for their vote.

The prime minister also congratulated on the successful holding of the 23rd meeting of the SCO Council of Heads of Government (CHG) in Islamabad, which he said had uplifted Pakistan's image.

Holding the summit despite challenges with terrorism and security on top, was a great success for the country, he said and appreciated the efforts by the ministries of foreign affairs, information and broadcasting, and interior, law enforcement agencies, police, Pakistan Rangers, Pakistan Army and intelligence agencies.

Also appreciating the Capital Development Authority for beautifully adorning the federal capital on the occasion, he said the prime ministers of China and Russia had specifically lauded the beauty of Islamabad.

He also mentioned the "successful" bilateral visit of Chinese Premier Li Qiang — after a hiatus of 11 years — which led to the further strengthening of the bilateral relationship.

The prime minister highlighted the improving national economy with inflation down to 6.9% and the declining policy rate.

Coming to the unabated Israel's barbarism in Gaza and Lebanon, he said the resolution of the UN Security Council and the rulings by the International Court of Justice had been thrown into the "dustbin of history".

Reiterating his appeal for donations to the PM Relief Fund on Gaza and Lebanon, he said the government was working on a comprehensive plan to send relief supplies to Gaza and Lebanon as a committee was working under Planning Minister Ahsan Iqbal.—RT/Agency

## Justice Yahya Afridi's Shocking Rise: Nominated As Next CJP In Controversial Parliamentary Move

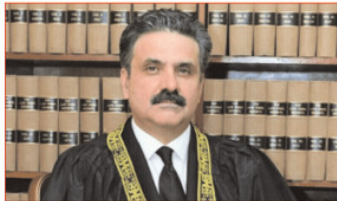
ISLAMABAD: The special parliamentary committee responsible for appointing Pakistan's next Chief Justice has approved the nomination of Justice Yahya Afridi with a two-thirds majority, forwarding his name to the prime minister for final approval.

The decision came after a meeting lasting over an hour and a half, attended by the committee members on Tuesday.

The Speaker of the National Assembly, Sardar Ayaz Sadiq, had also hosted a dinner for the members of the committee.

The parliamentary committee was formed to select the country's top judicial position, but its proceedings were initially marred by the absence of key members.

Earlier, representatives from Pakistan Tehreek-e-Insaf (PTI) and the Sunni It-



tehad Council confirmed their decision to boycott the committee, citing dissatisfaction with the process. This move delayed the selection of the next Chief Justice.

The decision not to participate was conveyed by PTI's Barnster Gohar Ali Khan following a meeting with parliamentary representatives in the speaker's chamber. "We have made our decision. We will not be part of this committee's meetings," Khan

confirmed after discussions. The committee, led by Speaker Sadiq, had previously tried to engage PTI members, hoping to involve them in the critical judicial selection process. A four-member subcommittee was formed, consisting of Ahsan Iqbal, Rana Ansar, Raja Pervez Ashraf, and Kamran Murtaza, to negotiate with PTI. However, despite these efforts, the boycott proved significant. The boycott has signif-

icantly impacted the appointment process, as the parliamentary committee is tasked with finalising the selection for the Chief Justice role. The absence of PTI and Sunni Ittehad Council members has created further complications in the proceedings.

The committee initially postponed its meeting, which was set to discuss the three senior-most judges nominated for the position: Justice Mansoor Ali Shah, Justice Munib Akhtar, and Justice Yahya Afridi. These judges represent the most senior ranks of Pakistan's Supreme Court, and one of them is expected to succeed the current Chief Justice, Qazi Faez Isa.

Despite the absence of PTI and Sunni Ittehad Council members, the committee pressed ahead with the judicial appointment process. The Secretary of Law and

Justice presented the profiles and qualifications of the nominated judges, which included their legal careers, educational backgrounds, and timelines of their judicial appointments. After reviewing the profiles, the committee approved Justice Yahya Afridi's nomination with a two-thirds majority and forwarded his name to the Prime Minister for final approval. Justice Afridi's appointment is expected to proceed to the President for formalisation once approved by the Prime Minister. This appointment marks a significant moment in Pakistan's judiciary, as the process for selecting the Chief Justice has undergone recent reforms. Under the new system, the three senior-most judges are shortlisted, and the parliamentary committee is responsible for making the final selection.—RT/Agency

## IMF Official Presses Pakistan For Multi-Sector Overhaul In High-Stakes Talks With Delegation



ISLAMABAD: A top official of the International Monetary Fund (IMF) has stressed that Pakistan should stay on the course of reforms — which had helped it secure crucial funding from the lender.

The development came during a high-level Pakistani delegation's meeting with IMF's Director of Middle East and Central Asia Department, Jind Azour, in Washington on Tuesday, a statement from the Ministry of Finance said. Federal Minister for Finance Muhammad Aurangzeb is leading the Pakistan delegation to the Annual Meetings of the World Bank Group and IMF, being held in Washington DC from October 21-26.

Other delegates include Finance Secretary Imdad Ullah Bosal, Secretary Economic Affairs Dr Kazim Niaz, and State Bank of Pakistan's Governor Jameel Ahmad, the ministry added.

The delegation thanked the IMF for its continued support to Pakistan, especially for the recently ap-

proved \$7 billion Extended Fund Facility.

The delegation outlined the government's efforts towards fiscal consolidation, revenue expansion, energy and SOE reforms, aimed at transitioning Pakistan from stabilisation to growth.

Meanwhile, the Pakistan delegation held a meeting with the representatives of Alvarez & Marsal Sovereign Advisory Services, comprising Dr Reza Baqir, Managing Director and Global Practice Leader, Peter Briggs, Division Executive for Sovereign Advisory Services, and Thibaud Fourcade. The Alvarez & Marsal team congratulated Pakistan on the successful conclusion of the EFF with the IMF and discussed various approaches through which Pakistan could access the international capital markets and external creditors. The team outlined the steps needed for the country to chart an accelerated path to capital markets following a well-sequenced strategy.—RT/Agency

## Cabinet In Chaos: Key Bills Approved, But Hajj Policy Postponed Yet Again

ISLAMABAD: Pakistan's federal cabinet, chaired by Prime Minister Shehbaz Sharif, approved eight key agenda items in a meeting at the Prime Minister's House on Tuesday.

However, the approval of the Hajj Policy 2025 was postponed once again due to the absence of Federal Minister for Religious Affairs, Chaudhry Saik.

One of the major approvals was for the Domestic Violence (Prevention and Protection) Bill 2024, which was sent to the Cabinet Committee for Legislative Cases.

The bill, limited to the Islamabad Capital Territory, aims to establish an institutional framework for the prevention of domestic violence.

"The bill will not only help in curbing domestic violence but also provide relief to victims and ensure appropriate punishment for offenders," the cabinet was informed.

In another decision, the cabinet approved the appointments of three private members, Lt Gen (ret) Moazzam Ijaz, Engineer Fa-



heem Iqbal, and Asim Shehry Hussain, to the Board of Management of the National Vocational and Technical Training Commission, based on recommendations from the Ministry of Federal Education and Professional Training.

## Government Sparks Outrage By Axing Power Subsidy For Protected Consumers

ISLAMABAD: The federal government has officially withdrawn the electricity subsidy for consumers using up to 200 units per month, media reported on Tuesday.

This decision means that consumers in this category will now face charges, starting from October, ranging from Rs9 to Rs29 per unit without any further relief in their electricity bills.

Protected consumers using up to 50 units will be charged Rs9.39 per unit, while those consuming between 51 and 100 units will pay Rs13.64 per unit.

For consumers using between 101 and 200 units, the rate will increase to Rs29.21 per unit, significantly impacting these households.

In addition, the National Electric Power Regulatory



Authority (NEPRA) has introduced a revised surcharge policy for late bill payments.

As per the reports, a 5 percent surcharge will apply to bills paid within three days after the due date, while a 10 percent surcharge will apply to payments made beyond that period. Previously, a uniform 10 percent surcharge was imposed for late payments.

However, no surcharge will be applied if payments are made within the three-day grace period following the due date, offering some flexibility to consumers.

Earlier, a uniform 10pc late payment charge was imposed on overdue bills, but this new structure aims to provide more flexibility for consumers.—RT/Agency

## CJP Isa Drops Bombshell: July 12 Reserved Seats Verdict Not Final Amid Brewing Legal Storm

ISLAMABAD: In a detailed minority judgment, Chief Justice of Pakistan Qazi Faez Isa on Tuesday stated that the implementation of the top court's July 12 verdict in the reserved seats case was not binding as the review petitions in the case were still pending and not fixed for hearing.

The detailed note came days after the eight judges of the top court, in its second clarification, reiterated that parliament's amendment to the Elections Act does not have a retrospective effect and it cannot undo the SC's judgment in the reserved seats case — a move that irked the top judge.

In his dissenting note, the CJP pointed out the "constitutional violations and illegalities in the majority's short order of 12 July 2024, and the majority's detailed judgment of 23 September 2024, the order/clarification of 14 September 2024 and the Clarification of 18 October 2024."

The CJP hoped that his colleagues in majority would "reflect and correct their mistakes" and ensure that Pak-



istan is governed in accordance with the Constitution.

In a detailed dissenting note, Justice Isa said that unfortunately, the review petitions against the majority short order could not be heard because his colleagues — Justice Syed Mansoor Ali Shah and Justice Munib Akhtar — outvoted him on the committee constituted under the SC Practice and Procedure Act, 2023.

He went on to say that the majority of eight judges decided to part ways with the court, comprising of thirteen judges, which had heard the appeals.

"The majority set up its own virtual court, permitted the making of an appropriate application" by the ECP and

PTI, and directed that such appropriate application would only be heard by them whilst cloistered in Chambers."

He further said: "In doing this the majority of the Hon'ble Judges effectively legislated, because neither the Constitution nor any law permits what they did."

Incidentally no party or counsel during the hearing ever suggested the course of action which the majority adopted, and neither the majority's short order nor the majority's judgment offers an explanation to justify it, CJP Isa added.

"In effectively legislating the Hon'ble Judges in the majority also contradicted themselves."—RT/Agency

## “We Will Never Allow This!” Syed Zain Shah Vows To Block Indus River Canals In Explosive Statement

TANDO ADAM: Syed Zain Shah, the Central President of the Sindh United Party, delivered a powerful message at a workers' convention in Tando Adam, asserting that his party will steadfastly oppose any plans to construct canals on the Indus River. ## Gandapur Threatens To Unleash Nationwide Protests Over Controversial Constitutional Amendments

PESHAWAR: Without giving a date, Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur on Tuesday said he would lead the Pakistan Tehreek-e-Insaf's (PTI) nationwide protests against the recent constitutional amendment.

Addressing the media persons in Peshawar, Gandapur said the PTI did not accept the constitutional tweaks focused on judicial reforms.

"The amendment is an onslaught on independent judiciary. We will raise our voice against this 'illegitimate' tweaks to the Constitution," he said, vowing that his party would revoke the amendment.

Through this legislation, he alleged, the incumbent rulers would get judges of their choice appointed for favourable verdicts.

His remarks came after the ruling coalition succeeded in pushing the highly contentious judicial reforms through the parliament via a two-thirds majority with 225 and 65 votes in the lower and upper houses, respectively.

Under the judicial reforms - opposed by the PTI which boycotted the voting process - the chief justice of



Pakistan will now be selected by a parliamentary committee and have a fixed term of three years. A new constitutional bench will also be formed under the constitutional package.

Following the late-night marathon session in the parliament which began on Sunday evening and ended in the early morning hours on Monday, PM Shehbaz sent an advice to President Asif Ali Zardari to give his assent and sign the legislation into law.

After the president's assent, the Constitutional Amendment Bill 2024 has now become a law followed by the formation of a Special Parliamentary Committee responsible for the appointment of the new CJ under clause 3 of Article 175A of the Constitution.

## Pollution Crisis Escalates As Pakistan And India Detain Farmers Over Crop Burning Catastrophe

As part of their efforts to curb alarming levels of hazardous air pollution on both sides of the border, Pakistan and India arrested dozens of farmers for illegally burning crop waste.

At least 16 farmers have been arrested in India's northern state of Haryana for illegally burning paddy stubble to clear fields, a practice that stokes air pollution in the region around New Delhi at the onset of winter, authorities said on Tuesday.

India's national capital region battles pollution each year as temperatures fall and cold air traps construction dust, vehicle emissions and smoke, much of which officials say travels from the neighbouring breadbasket states of Punjab and Haryana.

Police in Haryana's Kaithal region told Reuters that 22 complaints of stubble burning have been registered this year, and 16 people have been arrested.

Birbhan, a deputy superintendent of police, who uses only one name, said those arrested had been released on bail.

Investigations have been launched against almost 100 farmers across Haryana, while fines have been imposed on more than 300, local media reported.

Delhi recorded "very poor" air on Tuesday morning, according to the Central Pollution Control Board states of Punjab and Haryana.

Police in Haryana's Kaithal region told Reuters that 22 complaints of stubble burning have been registered this year, and 16 people have been arrested.

It was the second-most polluted city in the world on Tuesday, a live ranking by IQAir indicated, after only Lahore in neighbouring Punjab's northern state of Haryana.

At least 182 complaints have been registered and 71 people arrested for burning stubble and trash, operating prohibited brick-kilns and driving smoke-emitting vehicles, Punjab police said.

"Resources have also been allocated for artificial rain and other measures," said senior Punjab minister Marriyur Aurangzeb, adding each instance of artificial rain will cost between 5 million rupees (\$18,000) and 7 million rupees (\$25,200).—RT/Agency

## From Chaos to Control...?

The nomination of Justice Yahya Afridi as Pakistan's next Chief Justice marks a turning point for a country in desperate need of stability. After months of political infighting, judicial gridlock, and an economy teetering on the edge, the approval of Afridi's appointment by a two-thirds majority is a crucial step toward restoring confidence in the nation's institutions. His leadership at the Supreme Court offers hope for a return to a balanced judiciary, one that can function above the fray of political disputes.

Pakistan has been plagued by a lack of cohesion between its branches of government, leading to widespread confusion and diminished

public trust. Justice Afridi's nomination signals an opportunity to correct course, offering the judiciary a chance to focus on what it does best—



ensuring justice and protecting constitutional rights. In recent months, the judiciary has been drawn into political drama, often seen as a battlefield for party interests. This appointment could serve as a reset, restoring the Supreme Court's role as an impartial and stabilizing force.

At a time when the country is in dire need of direction, his nomination provides an opportunity for stability and progress, particularly in areas of governance and justice that have been strained in recent months.

Naresh detailed that Mukesh and Om Prakash had seized 15 million rupees in cash that belonged to their late father. Additionally, he accused them of manipulating bank accounts, resulting in a loss of 30 to 40 million rupees in their date market business. The situation escalated as they allegedly confiscated 70 tolas of gold that belonged to their father, along with 150 tolas of gold stored by their mother at their sister's house. Fearing for his life, Naresh asserted that when he sought to reclaim his rights, he and his family faced threats

of financial and personal harm. He reported that despite some false cases against him being dismissed due to lack of evidence, he continues to worry about additional cases being filed. Naresh emphasized that the intimidation tactics are exacerbated by the connections his brother and nephew have with criminals and local law enforcement. Despite attempts to resolve the matter through discussions with business leaders in Sukkur's date market, including Chairman Abdul Majeed Sheikh of Thari, Naresh lamented that Mukesh and Om Prakash refuse to adhere to any agreements reached in his appeal for justice, Naresh Kumar called upon several officials, including the Provincial Minister for Minority Rights, the Inspector General of Sindh, the Deputy Inspector General of Sukkur, the Hindu Panchayat of Sukkur and Khairpur, and the Senior Superintendent of Police of Khairpur. He urged them to take notice of his plight and to take necessary legal action against Mukesh, Om Prakash, and their associates to ensure his safety and the restoration of his rights.

## Toxic Oil Scandal: Substandard Depot Sealed And Fined In Thatta After Shocking Discovery

Sources within the Sindh Food Authority revealed shocking details about the production process of this adulterated oil, which involved boiling bones and discarded organs from poultry and animals. The fraudulent oil was reportedly being sold at 400 rupees per kilogram and was widely used in local hotels, bakeries, and among rural households in Thatta. ## Bloody Attack In Home: Woman Shot Dead, Another Clings To Life After Savage Assault

In total, Pakistan has claimed 27 gold, 27 silver, and 28 bronze medals across all Commonwealth Games appearances.

The sports to be featured in the 2026 Games include athletics and para-athletics, swimming and para-swimming, artistic gymnastics, track cycling and para track cycling, netball, weightlifting and para weightlifting, boxing, judo, bowls and para bowls, along with 3x3 basketball and 3x3 wheelchair basketball, which leaves Pakistan's realistic hopes dependent mainly on two sports i.e., athletics - if Ahsad Nadeem participates - and weightlifting.—Agency

PAK vs ENG: Major Shake-Up As Mohammad Ali Poised To Replace Zahid For Third Test



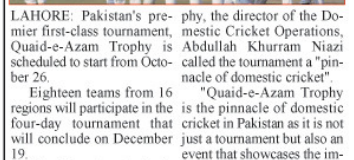
RAWALPINDI: As the third Test is set to take place from Thursday, October 24, Pakistan has decided to make a change in their playing XI, sources told media.

Brydon Carse, who made his debut in the first Test, and Matthew Potts who played the second Test, will sit out of the final of the three-match series.—Agency

BAN vs SA: Verreynne's Stunning Century Puts South Africa In Command, Leaving Bangladesh Reeling

DHAKA: A hard-fought century by Kyle Verreynne on Tuesday helped South Africa take themselves into a strong position on the second day of the first test against Bangladesh at the Sher-e-Bangla National Cricket Stadium.



Verreynne scored 114 as South Africa took a 202-run first innings lead, advancing from 140-6 overnight before being dismissed for 308.

Bangladesh were 101-3 in their second innings when bad light brought play to a close, trailing by 101 runs as they attempted to fight back after South African speedster Kagiso Rabada took two wickets in his second over to have them reeling at 4-2.

Rabada reached the milestone of 300 test wickets on the first day on Monday as Bangladesh were skittled out for 106 in their first innings after winning the toss and choosing to bat.

Opener Mahmudul Hasan Joy, who top scored for his team in the first innings, will resume on Wednesday on 38 not out, along with veteran Mushfiqur Rahim on 31.

The pair put together an unbeaten partnership of 42.

Earlier on Tuesday, Verreynne and Wiaan Mulder defied the conditions, after 16 wickets had fallen on the opening day, to extend their overnight partnership to 119 runs and take South Africa from 140-6 to 227-7 before Mulder was dismissed after scoring a maiden test 50.

Allrounder Mulder made 54 before getting a healthy edge to a delivery from Hasan Mahmud, after Bangladesh brought back their lone seamer into the attack as their spinners failed to make a breakthrough.

Verreynne then featured in a 66-run ninth wicket partnership with Dane Piedt, who contributed 32 runs and helped see his teammate to a second test century, brought up in 134 balls.

Verreynne was eventually stumped off a slower ball from Mehdi Hasan Miraz as the visitors' innings came to a close. Tajul Islam proved Bangladesh's best bowler with figures of 5-122 in 36 overs but was unable to add a wicket on Tuesday. The test in Dhaka is the first of a two-match series with the second in Chittagong next week.—Agency

Solarization of Public Buildings: As part of the government's renewable energy push, solar power projects were inaugurated at Dow University Hospital, Ojha Campus, and Central Jai Karachi. Dow University has been equipped with 2.32 MW of solar power under a Rs290 million project, while Central Jai Karachi now runs on a 614.8 KW solar energy system. Both projects are set to generate significant savings and reduce reliance on traditional power sources.

Shaheen Football Ground and Park: In Manzoor Colony, the CM inaugurated the newly rehabilitated Shaheen Football Ground, a project costing Rs213 million as part of the 2022-23 CLICK schemes. ## Sindh Energy Minister Demands Constitutional Gas Supply Rights In Heated Showdown



KARACHI: Sindh Energy Minister Syed Nasir Hussain Shah has reiterated that Sindh is the largest gas-producing province in Pakistan, contributing between 1,800 and 2,000 million cubic feet per day (MMCFD), which accounts for 65% of the country's total gas output. However, he expressed concern that the province is only receiving 900 MMCFD of gas, while its actual requirement is 1,600 MMCFD.

Speaking during a high-level meeting of the Directorate of Oil and Gas, the minister emphasized that under Article 158 of the Constitution, the province from which gas is extracted has the first right to its use, but this right is not being implemented. As a result, the people of Sindh are facing a severe gas shortage.

Also present at the meeting were Secretary Energy Mosaad Ahmad Khan, Chairman District Council Sukkur Syed Kumail Haider Shah, Director Oil and Gas Khadim Hussain, and Aamir Mujtaba. Discussions centered around the unequal distribution of gas resources and the lack of representation for Sindh in the boards of major federal oil and gas companies, such as PSO, PPL, OGDCL, OGRA, and Sui Southern Gas. Despite multiple efforts, Sindh's representation in these companies has not been ensured.

The minister also raised concerns about the interim government's decision to allow the sale of 35% of natural gas to third parties and the approval of the Tight Gas Policy 2024, both of which he claimed were outside its authority. Additionally, the federal government's proposed new LNG policy has sparked further apprehension within the Sindh government.

Syed Nasir Hussain Shah called for immediate action to ensure Sindh's rightful representation on the boards of oil and gas companies in accordance with Article 172(3) of the Constitution, which mandates equal distribution of mineral resources between the Federation and the provinces. He pledged to engage with the federal government for the enforcement of Articles 158 and 172(3) to safeguard the province's interests. The minister concluded by stressing that the gas consumers of Sindh are the government's top priority, and directed that solid steps be taken to boost revenue in the oil and gas sector.—RT

## SECP Sounds Alarm On Fraudulent 'SMARTPAYS' Investment Scheme, Warns Public Of Massive Scam

KARACHI: The Securities and Exchange Commission of Pakistan (SECP) has uncovered an illegal investment platform operating under the name "SMARTPAYS," according to media reports on Tuesday. The platform, promoted through a misleading website, falsely promises high returns on investment schemes. A press release issued by the SECP revealed that "SMARTPAYS" also falsely claims to be a licensed non-banking finance company, displaying a fake Certificate of Incorporation under the name "SMARTPAYS/SMART FINANCE (PRIVATE) LIMITED." The SECP clarified that "SMARTPAYS/SMART FINANCE (PRIVATE) LIMITED" is neither registered nor authorized as a non-banking finance entity. The public is strongly advised against depositing or investing any funds with this platform or any similar unauthorized entities.

The SECP has added "SMARTPAYS/SMART FINANCE (PRIVATE) LIMITED" to its "List of Companies Engaged in Unauthorized Activities" available on its website, and the matter has been referred to the relevant investigation authorities.—RT/Agency

## SHC Takes On Explosive Case Of Tree Cutting For Controversial Red Line Bus Project

KARACHI: The Sindh High Court (SHC) was informed on Tuesday that more than 16,000 trees will be planted to compensate for those removed during the construction of the Red Line bus project, according to media reports.

During the hearing of a petition against the tree cutting, the contractor's lawyer stated that 1,564 trees were felled along the Malir Halt to Mosmiat stretch, with 75% of them being Conocarpus. The replacement plan includes the plantation of Gulmohar (Royal Poinciana), Sukhchain (Indian Beech), and Neem trees.

Justice Zafar Ahmed Rajput questioned the choice of Sukhchain, quipping, "If it's planted in Karachi, neither 'Sukh' nor 'Chain' (peace) will come to the city." The bench emphasized the importance of planting native species like Neem, Bargad (Banyan), and Peepal, and questioned why the project's contract didn't include a tree transfer clause.

The Secretary of Transport informed the court that 2,000 trees are being grown in a nursery, to be planted upon the completion of the Red Line project corridor. The bench also expressed concern about the loss of parrots and the broader impact of environmental degradation.

The court granted one week for a report on trees suitable for Karachi's climate and summoned the forest department, adjourning the hearing until October 29. The cutting of trees during extreme weather events has sparked concerns about worsening the city's climate challenges, including prolonged heat waves and rising temperatures.—RT/Agency

## Quaidabad Police On A Roll: Three Criminals Snagged In Multiple High-Stakes Operations

KARACHI: Under the special directives of SP Malir Muhammad Saeed Rind and the supervision of DSP Quaidabad Mansoor Bozdar, SHOs of Quaidabad, Ayed Farasat Hussain Shah, arrested three suspects during various operations, recovering weapons and drugs. In a conversation with the media, SP Malir Muhammad Saeed Rind reported that the Quaidabad police apprehended three criminals in separate actions. In the first operation, the patrolling police stopped a suspect, Zohaib son of Ali Akbar, near the Sherpao Colony rice godown. Upon a thorough search, a pistol was recovered. The police seized the weapon, rounds of ammunition, cash, and a mobile phone from him. It was found that he had two pending cases registered at the Ban Qasim police station. In the second operation, conducted near the NADRA office at the Hospital Chowring, the police arrested Abdul Hamid son of Ali Muhammad while he was selling harmful mawa gutka. Fifty packets of mawa were recovered from him, and he also has a case registered against him at Malir City police station for selling mawa. In the third operation, the Quaidabad police arrested Azmat Khan son of Fazal Rabi with prohibited drugs, including crystal meth. The suspect is reportedly involved in selling crystal meth to addicts in the area and has three previous drug-related cases registered against him at the Quaidabad police station.

## PTI Escalates Tensions, Confirms Explosive Boycott Of Chief Justice Appointment Committee

ISLAMABAD: Members of the Pakistan Tehreek-e-Insaf (PTI) and Sunni Ittehad Council have confirmed they will not participate in the parliamentary committee tasked with appointing the next Chief Justice of Pakistan, further delaying the judicial selection process.

The decision was conveyed after a meeting between members of the parliamentary subcommittee and representatives from the PTI-SIC, held in the speaker's chamber on Tuesday.

Despite efforts by the committee, including National Assembly Speaker Sardar Ayaz Sadiq, to convince the PTI members to attend, Barrister Gohar Ali Khan confirmed that their political committee had decided to abstain from the proceedings.

"We have made our decision. We will not be part of this committee's meetings," Gohar Ali Khan stated, following discussions in Speaker Sadiq's office.

Earlier in the day, the speaker met with members of



the special parliamentary committee to discuss the ongoing deadlock. The committee had formed a four-member subcommittee to engage with the PTI, consisting of Ahsan Iqbal, Rana Ansar Raja, Pervez Ashraf, and Kamran Murtaza, in an attempt to bring them into the discussions. Despite these efforts, the boycott continues.

The absence of both PTI and Sunni Ittehad Council

members has caused the committee to postpone its meeting, initially scheduled to discuss the three senior-most judges nominated for the role of Chief Justice: Justice Mansoor Ali Shah, Justice Munib Akhtar, and Justice Yahya Afridi.

Despite the setback, the committee remains determined to push forward with the judicial appointment process, but it faces mounting pressure to ensure inclusivity in its final decision.

The Supreme Court Registrar had earlier submitted three names for consideration by the committee. These include the most senior judge, Justice Mansoor Ali Shah, followed by Justice Munib Akhtar and Justice Yahya Afridi. The nominees represent the three most senior justices of the Supreme Court, and one of them will be selected to succeed the incumbent Chief Justice, Qazi Faez Isa.

The submission also included a brief one-page report providing a summary of

the judges' backgrounds, including their dates of birth, educational qualifications, legal careers, and timelines for when they were appointed as high court chief justices and their elevation to the Supreme Court.

During the committee's meeting, the Secretary of Law and Justice presented the profiles and qualifications of the nominated judges. However, the absence of PTI and Sunni Ittehad Council members led to a delay in proceedings, and the meeting was rescheduled for later that evening, at 8:30 pm. The absence of PTI members from the meeting highlights the ongoing political tensions surrounding the appointment of the Chief Justice, a post that has become increasingly politicised in recent years. Sources suggest that PTI's reluctance to participate may stem from its dissatisfaction with the current political setup, especially after several judicial decisions went against the party in recent months.—RT/Agency

## Shehbaz Demands Immediate Report On Shocking Surge In Polio Cases

ISLAMABAD: Prime Minister Shehbaz Sharif on Tuesday sought a report on the growing number of polio cases in the country and directed the authorities concerned to immediately formulate a comprehensive strategy on the matter.

The prime minister, chairing a meeting of the federal cabinet, expressed his concern over the surge in polio cases and called a meeting to discuss the situation.

## CII Pushes Controversial Proposal For One-Year Jail Term For Dowry Law Violators

ISLAMABAD: The Council of Islamic Ideology (CII) has suggested tweaks to the Dowry and Bridal Gift Act proposing an enhanced penalty from six months to up to one-year imprisonment for those found violating the law, media reported on Tuesday.

During its 239th meeting on Monday, the CII also recommended increasing the maximum limit of the amount of dowry from Rs5,000 to two tolas of gold along with a hike in expenses of marriage from Rs2,500 to the amount equivalent to the same amount of gold.

On the change of the family laws, the body further proposed tweaks to the family laws and suggested declaring the announcement of three divorces in one sitting a punishable act.

Furthermore, the council decided to convene a conference involving health experts, religious scholars, and other stakeholders to gather input regarding Pakistan's first human milk bank, a sensitive issue that has sparked considerable debate within the country.

The CII's decision comes in the wake of intense criticism from religious circles, leading to the suspension of the milk bank, which had been launched in collaboration with Unicef at the Sindh Institute of Child Health and Neonatology (SICHN) in Karachi in March this year.

The meeting, chaired by Dr Raghbir Hussain Naemi, deliberated on the issue which had been referred to the council by the Sindh government after Ulema raised



concerns. These concerns centred on the Islamic concept of "milk kinship" which stipulates that a parental bond is formed when a woman provides breast milk to a child who is not her biological offspring.

Islamic teachings suggest that this bond could create future complications, particularly regarding incestuous marriages between milk siblings, if not properly documented.

The Pakistan Pediatric Association (PPA) welcomed the CII's decision to consult all the stakeholders and urged the council to expedite the planned conference, emphasising that timely action is crucial for saving neonatal lives. The milk bank at SICHN, considered a "significant milestone in maternal health," was suspended after Darul Uloom Karachi issued a revised fatwa in June 2024.

The updated fatwa cited religious concerns and instructed the immediate discontinuation of the bank's operations.

In response, SICHN issued a statement affirming their compliance with the latest religious guidance, while expressing their intent to seek further clarity from both Darul Uloom and the CII.

## Shehbaz Orders Urgent Dispatch Of Humanitarian Aid To War-Torn Gaza And Lebanon



ISLAMABAD: Prime Minister Shehbaz Sharif on Tuesday directed the authorities concerned to immediately dispatch two plane-loads of relief goods to Gaza and Lebanon and called for using both land and aerial routes for the aid supply.

The prime minister, chairing a meeting to review the relief activities for Palestine and Lebanon, asked for improving coordination with Pakistan's ambassadors in Palestine, Lebanon, Jordan and Egypt to ensure a better supply of relief goods.

Stressing for an accelerated pace of relief aid, he called for ensuring that the relief goods reached the deserving people.

## IMF Sounds The Alarm: Global Growth Forecast Slashed For 2024 And 2025

ISLAMABAD: Global growth is expected to ease slightly to 3.2 per cent this year and remain at that level in 2025, the International Monetary Fund (IMF) announced on Tuesday, while warning that the stable figures masked "important" regional and sectoral shifts.

In its new World Economic Outlook (WEO) report, the IMF also estimates that global inflation will continue to ease, hitting 5.8 per cent this year, before falling to 4.3pc in 2025.

"We are seeing inflation moving in the right direction without a major slowdown in economic growth or a global recession," IMF chief economist Pierre-Olivier Gourinchas told AFP in an interview ahead of the report's publication.

"In our baseline analysis, in advanced economies [inflation] will be back at central bank targets in 2025," he continued, adding it would take "a little bit longer" for emerging markets.

The Fund's WEO report is expected to trend to a lacklustre 3.1pc by 2029, and warned of growing risks to that metric.

Beneath the relatively calm outlook for growth through 2025, "the picture is far from monolithic," the Fund said, warning of "important sectoral and regional shifts" taking place over the past six months.



The WEO's publication comes a day after the IMF and World Bank Annual Meetings got underway in Washington, bringing together finance ministers and central bankers from around the world for meetings on the health of the global economy.

The report finds that the United States has remained an engine of global growth — in sharp contrast with the euro area, where expansion remains slow.

The world's largest economy is now expected to grow by 2.9pc this year, down ever-so-slightly from the 2.9pc seen in 2023, but still a shade better than the Fund's previous estimate in July.

It is then expected to ease somewhat to 2.2pc in 2025 — up 0.3 percentage points from July — as fiscal policy is "gradually tightened and a cooling labour market slows consumption," the IMF said.

"The US economy has been doing very well," Gourinchas said, pointing to strong productivity growth

and the positive effects of a surge in immigration on economic growth.

He added that the US is "very close" to achieving a soft landing — a rare feat in monetary policy, where inflation falls to within targets without spurring a severe recession.

In Europe, growth is still trending higher, but remains low by historical standards, and is on track to be at an anemic 0.8pc this year, rising slightly to 1.2pc in 2025.

While France and Spain saw upgrades in their outlook for 2024, the IMF cut its projections for German growth by 0.2 percentage points this year, and by half a percentage point next year, citing its "persistent weakness in manufacturing".

There was some good news in the United Kingdom, where growth is projected to accelerate in both 2024 and 2025, "as falling inflation and interest rates stimulate domestic demand".—RT/Agency

## ECP Gives Punjab 6-Week Ultimatum To Implement Local Government Laws

ISLAMABAD: The Election Commission of Pakistan (ECP) on Tuesday granted the Punjab government six weeks to finalise the draft law and legislation for local body elections, allowing adequate time to ensure that all necessary preparations are in place for a successful electoral process in province.

The Election Commission of Pakistan (ECP) was approached for a six-week extension to prepare the draft and legislation for local body elections in Punjab.

This request for a six-week extension to prepare for the Punjab local government elections was made by top officials, including the Chief Secretary of Punjab, Local Government Secretary, Interior Secretary, and Islamabad Chief Commissioner, during an in-chamber hearing at the ECP.

The Punjab Chief Secretary briefed the Election Commission, revealing that the draft Local Government Act is nearly complete, with 99 per cent of the work



done. He assured that six months would be needed to complete the final adjustments to the draft law.

Accepting the request of top officials, the ECP granted Punjab extra time to finalise election arrangements. The Interior Secretary updated the Election Commission on a committee's progress, formed after the ECP's September 11, 2024 meeting.

"Originally signed on 24 October 2019 for a five-year term, the Agreement is set to complete its initial duration on 24 October 2024. Its renewal underscores Pakistan's enduring commitment to fostering interfaith harmony and peaceful coexistence," the statement added.

The agreement continues to offer visa-free access to pilgrims from India enabling them to visit the sacred site of Gurudwara Darbar Sahib Kartarpur, where Baba

## PTI's Swati Granted Bail In Explosive Terrorism Case Linked To Fiery Protests

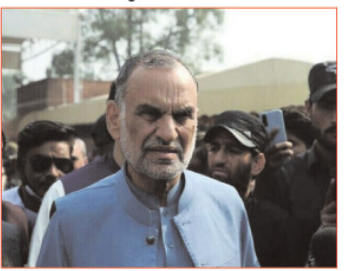
ISLAMABAD: An anti-terrorism court (ATC) in Islamabad granted bail to Pakistan Tehreek-e-Insaf (PTI) leader Azam Swati in a case filed under terrorism provisions.

The case, registered at Sangiani Police Station, charged Swati with terrorism-related offences following protests and vandalism.

Judge Abu Al-Hasanat Muhammad Zulkernain presided over the case and approved Swati's post-arrest bail against surety bonds of Rs20,000.

The PTI leader is currently in judicial custody. Swati had been detained under terrorism clauses following allegations of inciting protests that led to property damage. Swati's legal team maintained that the charges were politically motivated.

Meanwhile, an ATC ordered the publication of a newspaper advertisement against Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur in the ongoing case related to vandalism charges during the so-



called Azadi March yesterday.

The court has initiated proceedings under Section 87 of the Criminal Procedure Code to declare the K-PCM, Ali Amin Gandapur, a proclaimed offender.

The hearing was conducted by Anti-Terrorism Court Judge Abu Al-Hasanat Muhammad Zulkernain. The court summoned Ali Amin Gandapur through an advertisement to appear on November 21.

It is noteworthy that the court has already issued non-bailable arrest warrants for Ali Amin Gandapur.

Including CM Gandapur, around 350 PTI leaders and activists, including Azam Swati, Omar Ayub, and Barrister Saif, were charged with blocking GT Road and engaging in vandalism during the Azadi March.

A total of 12 cases, including terrorism and attempted murder, have been registered across multiple police stations in Islamabad.—RT/Agency
