## President Zardari and PM Shehbaz Unite To Condemn Deadly Ankara Attack

ISLAMABAD: President Asif Ali Zardari and Prime Minister Shehbaz Sharif have strongly condemned the terrorist attack in Ankara, which resulted in the tragic loss of lives on Wednesday.



In separate statements on Wednesday, both leaders expressed deep condolences and affirmed Pakistan's solidarity with Turkiye in this time of grief.

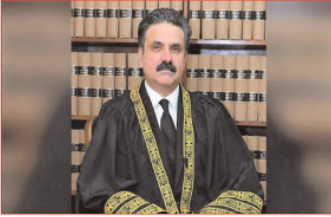
President Zardari extended his heartfelt condolences to the families of the victims and expressed solidarity with the Turkish government and people. "We stand in full solidarity with our Turkish brothers and sisters in this difficult time," he said, adding that Pakistan understands the pain caused by such brutal acts, having endured the scourge of terrorism.

"Terrorists are enemies of peace and humanity," Zardari stated, stressing the need for united global efforts to combat terrorism and ensure a secure future for all nations. PM Shehbaz took to social media platform X to express his shock and sorrow over the attack. He offered condolences to President Recep Tayyip Erdogan and the Turkish people, stating, "Pakistan stands in complete solidarity with its Turkish brothers."

Sharif also prayed for the families of the victims and wished a speedy recovery for the injured. Both leaders reiterated Pakistan's strong stance against terrorism in all its forms. The attack, which took place at Turkish Aerospace Industries' headquarters near Ankara, left four people dead and 14 others wounded, with three in critical condition. Turkish Interior Minister Ali Yerlikaya confirmed that two attackers were killed in what he called a terrorist attack. Witnesses reported hearing gunfire and a loud explosion at the site. TV footage showed armed assailants entering the TUSAS building. President Tayyip Erdogan, who was attending a BRICS conference in Kazan, Russia, alongside President Vladimir Putin, also referred to the incident as a terrorist attack.—RT/Agency

## Justice Yahya Afridi Appointed As New Chief Justice By President Zardari

ISLAMABAD: President Asif Ali Zardari has approved the appointment of Justice Yahya Afridi as the next chief justice of Pakistan.



The appointment was made in accordance with Articles 175A(3), 177, and 179 of the Constitution.

Justice Yahya Afridi will take over the role from October 26 for a three-year term.

The president has also given his approval for the oath-taking ceremony, scheduled for October 26. This decision follows a recommendation from a parliamentary committee, which met for a second

time to finalise Afridi's appointment. The committee, which deliberated for over an hour and a half, approved Afridi's name with a two-thirds majority. All parties except Pakistan Tehreek-e-Insaf (PTI) participated in the proceedings. PTI boycotted the committee session, refusing to take part in the discussions on the new chief justice. Despite efforts to bring PTI to the table, the party declined to engage, citing disagreements over the selection process.

Earlier, the Supreme Court's registrar had submitted three names to the parliamentary committee for consideration. Alongside Afridi, Justice Mansoor and Justice Muneeb were also considered. The committee ultimately endorsed Afridi's nomination after reviewing brief profiles and backgrounds of all candidates.—RT/Agency

## Hezbollah Confirms Assassination Of Nasrallah's Potential Successor By Israel



BEITUR: Hezbollah confirmed on Wednesday that Israel killed Hashem Safieddine, the apparent successor of its slain leader Hassan Nasrallah, in a strike, without saying when or where it happened.

The announcement came a day after Israel said he was killed along with other Hezbollah leaders in an air strike in Beirut's southern suburbs three weeks ago.

"We mourn... the head of the Executive Council of Hezbollah, his eminence the scholar Sayyed Hashem Safieddine," the group said in a statement, adding he was killed by "a criminal and aggressive Zionist raid" alongside other Hezbollah fighters. The deeply religious Safieddine, a cleric with family ties to Nasrallah, had been widely viewed as the most likely candidate for the party's top job after the assassination of Nasrallah on September 27 in a huge Israeli air strike on Beirut's southern suburbs.

Safieddine, a member of the group's governing Shura Council, had strong ties to Iran after undergoing religious studies in Iran's holy city of Qom. The United States and Saudi Arabia had put him on their respective lists of designated "terrorists" in 2017. Last week, Israel claimed to have killed Hamas chief Yahya Sinwar in Gaza. Sinwar was tracked by an Israeli mini drone as he lay dying in the ruins of a building in southern Gaza, which filmed him slumped in a chair covered in dust, according to a video released by Israeli authorities.—RT/Agency

## Justice Hasan Rizvi Issues Critical Additional Note On NAB Amendments Case



ISLAMABAD: Supreme Court Justice Hasan Azhar Rizvi issued an additional note on the NAB review case, expressing concerns about the majority judgment.

While Justice Rizvi concurred with the overall verdict, he noted that he was not fully convinced by the reasoning provided by the majority bench, stating that the original claim lacked sufficient justification.

In his note, Justice Rizvi also took issue with certain remarks made in the judgement regarding former judges, emphasising that judicial dissents should be expressed with civility to preserve the dignity of the institution. He stressed that criticism should focus on the legal principles of the decision, rather than ridiculing the individuals behind it.

In addition, Justice Rizvi clarified that he wrote his separate reasons to ensure that the discourse remained respectful and principled. He further pointed out that the intra-court appeal under the Supreme Court's Practice and Procedure Law differs from traditional appeals, as it allows for a re-examination of the court's findings. In September, the Supreme Court approved the intra-court appeals while delivering its verdict on the NAB amendment case.—RT/Agency

## Ankara Under Siege: Four Dead, 14 Injured In Attack On Turkish Aerospace Industries HQ

ANKARA: Four people were killed and 14 others wounded in an attack at the Turkish Aerospace Industries' headquarters on Wednesday, the government said, and witnesses said they heard gunfire and a loud explosion at the site near Ankara.



Turkish Interior Minister Ali Yerlikaya said two attackers were killed in what he called a terrorist attack, adding three of the injured are in critical condition. TV broadcasters earlier showed footage of armed assailants entering the TUSAS building.

President Tayyip Erdogan, alongside Russia's Vladimir Putin at a BRICS conference in the Russian city of Kazan, also called it a terrorist attack.

The cause and perpetrators of the blast and subsequent gunfire remained unclear. No group had claimed responsibility. Prosecutors have launched an investigation, state-run Anadolu Agency reported.

Some media reports claimed a suicide attack had occurred and that there were hostages inside the building, though officials have not confirmed this. Witnesses told Reuters that employees inside the building were taken by authorities to shelters and no one was permitted to leave for a few hours. They said the blasts they heard may have taken place at different exits as employees were leaving work for the day. Broadcasters showed images of a damaged gate and footage of an exchange of gunfire in a parking lot, as well as attackers carrying assault rifles and backpacks as they entered the building. Ambulances and helicopters later arrived. TUSAS is Turkey's largest aerospace manufacturer, currently producing a training craft, combat and civilian helicopters, as well as developing the country's first indigenous fighter jet, KAAAN. Owned by the Turkish Armed Forces Foundation and government, it employs more than 10,000 people.—RT/Agency

## PTI Cracks Down On Defiance, Issues Show-Cause Notices To Zain Qureshi And Others

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) has issued show-cause notices to party members Zain Qureshi, Riyaz Fatyana, Aslam Ghuman, and Miqdad Ali Khan for violation of party instructions ahead of the passage of the 26th Constitutional Amendment in the Parliament House.



In its show-cause notice to the lawmakers, issued by the party's central secretariat on Tuesday, PTI said it had directed all its members of the National Assembly and Senate to remain safe, secure, and not to be in touch with anyone for or on behalf of the government for the purpose of the constitutional tweaks.

The party's notices were issued two days after the ruling coalition government-backed 26th Constitutional Amendments were passed in both the upper and lower house of the parliament — the process of which began on Sunday evening and ended in the morning hours on Monday (October 21).

During the vote on the contentious amendments brought forth by the administration of Prime Minister Shehbaz Sharif, strongly opposed by the PTI, the government secured 225 votes, surpassing the required 224, with support from a handful of independent MNAs, including members of the Imran Khan-founded party.

Zahoor Qureshi, Aurangzeb Khichi, Usman Ali and Mubarak Zeb were the PTI-backed independent MNAs who voted in the tweak's favour, while Pakistan Muslim League-Quaid (PML-Q)'s Chaudhry Ilyas also supported the legisla-

tion. Meanwhile, Zain was in communication since October 16 and his video regarding his status began circulating on October 21 following the passage of the legal reforms. On the other hand, PTI Opposition Leader Omar Ayub claimed about the lawmaker's wife being arrested from her house, Miqdad Ali being disappeared while travelling to Islamabad and Fatyana's son being "disappeared" twice. Ghuman, too, was not in contact with the party both before and during the legislative process.

"These instructions were issued to every MNA and Senator in order to avoid, not only harassment but also to be in touch with the party or its authorised representative for further instructions in the aforesaid matter," read the notices.

In the separate notices to all four lawmakers, the party maintained that each of them had the instruction and directions communicated to them. "Needless to add that you were bound to follow these party directions and instructions, including the direction to be at the designated location, and those abroad not to come to Pakistan till further instruction, and not to be in communication with anyone for or on behalf of the Government for the purpose of the 26th constitutional amendment," it added.

However, it further read, the members left the designated location, and you avoided contact with the party or its authorised persons in the several days leading up to the vote in "disregard of the aforesaid directions and instructions".

"We have been provided with credible evidence and statements from reliable sources that you had full intention of defecting in case your vote was needed," the letter stated. The party has, therefore, asked the lawmakers to respond to the notice within seven days, explaining why they should not be declared to have defected from the party and/or that "you have violated the party instructions, thus liable to be expelled from the Party forthwith." "Should you fail to respond to this notice, it would be assumed that you have nothing to say in your defense and you will be proceeded against without further notice, including expulsion from the party," read the notice.—RT/Agency

## Four Hindu families leave Kashmir for India

KASHMIRE: The recent wave of unrest and a troubling rise in criminal activities have compelled four Hindu families to make the difficult decision to leave Kashmir for India permanently. This migration comes on the heels of several high-profile incidents of abduction and robbery that have instilled fear within the local community.

Among those departing is Sagar Kumar, who experienced a harrowing ordeal just months ago when he was kidnapped by robbers. His release came after a historic protest at Dera Mor, a pivotal intersection of three provinces, where community members rallied to demand his freedom, ultimately resulting in the payment of a substantial ransom.

Today, Sagar Kumar has cited the deteriorating security situation in Kashmir and persistent fears of re-abduction as primary reasons for his departure. His decision reflects a broader trend of insecurity felt by many residents in the region, leading to disappointment and distress within the local Hindu community, which has deep historical ties to the area.

The departure of these families highlights urgent concerns regarding safety and the need for effective measures to combat the escalating culture of violence and crime in the district.

Community leaders and activists are calling for increased protection and support for minority communities facing such threats.

## SECP And PSX Lead The Way With IPO Roundtable 2024: Paving Future Of Capital Markets

## The United Nations: A Failing Guardian Of Global Peace?

Through history, treaties and organizations have been established to promote peace and harmony across the world. Early examples include the Treaty of Hudaibiyah and the Charter of Madina, both initiated by the Prophet Muhammad (PBUH) to maintain peace and coexistence between Muslims and non-Muslims. These early agreements set a precedent that later influ-

enced the founding charters of modern organizations, such as the League of Nations and the United Nations (UN).

The UN was formed on October 24, 1945, following the failure of the League of Nations, which was unable to prevent World War II. The UN's primary goal was to maintain global peace, ensure security, and foster cooperation among nations. Member states pledged to resolve disputes peacefully and avoid interfering in each other's affairs. The UN Security Council was given the authority to enforce peace, with provisions in Chapters 6 and 7 of the UN Charter dedicated to resolving conflicts. However, the effectiveness of the UN has come under scrutiny, especially concerning its response to conflicts involving Muslim-majority countries. Recent events, particularly the ongoing crisis in Gaza, have highlighted perceived biases and failures within the organization. Despite its mandate to uphold peace, the UN has been criticized for inaction and for appearing powerless, especially as Secretary-General Antonio Guterres has struggled to address the crisis effectively. Many believe the UN has not adequately addressed the plight of Palestinian Muslims, leading to accusations of bias and double standards. The ongoing suffering of Palestinians, coupled with what some view as UN indifference, has eroded confidence in the organization's ability to fulfill its founding mission. As the world marks UN Day on October 24, it raises a critical question: Can the United Nations truly be seen as a successful guardian of peace, or has it become an institution that falls short when needed most?

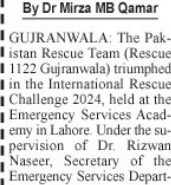

The recent surge in polio cases in Pakistan is a stark reminder of a persistent health crisis that has yet to be fully addressed. The confirmation of the 40th polio case this year, involving a child from Kohat, is deeply alarming. With new cases emerging in Sindh, Balochistan, and Khyber Pakhtunkhwa, the virus has shown its ability to persist, threatening to undo years of progress. The presence of the virus in sewage samples further highlights the urgency of a nationwide effort to close immunity gaps.

The government has recently demonstrated its ability to mobilize and act decisively, as seen in the swift passage of the 26th Constitutional Amendment. It is now time for the same sense

of urgency and determination to be applied to polio eradication. The upcoming nationwide vaccination drive is a step in the right direction, aim-



ing to immunize over 4.5 million children across the country. However, this must be part of a broader, more sustained effort that includes enhanced coordination with neighboring countries, better management, and thorough oversight.

Pakistan's struggle against polio is not just about administering vaccines; it involves tackling structural issues like poor sanitation, misin-

formation, and vaccine hesitancy. The presence of poliovirus in environmental samples underscores the need for improvements in basic health infrastructure.

Education campaigns must also continue to dispel myths about vaccines, especially in regions like KP, where reluctance to immunize children remains a significant barrier.

Pakistan cannot afford to lose this battle. The government's resolve in passing crucial legislation shows that rapid, decisive action is possible. Now, the same energy must be directed towards achieving a polio-free future. Only through a holistic, persistent approach can Pakistan finally eradicate this crippling disease.

### Bhutto Welfare Organization organizes community program

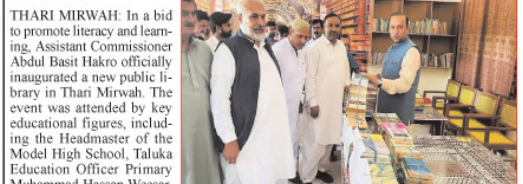

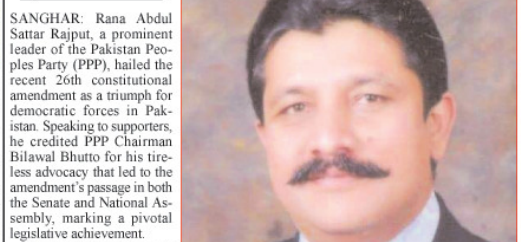

## White-Ball Captaincy Fate Hinges On Crucial Naqvi-Rizwan Meeting: Rashid Latif



KARACHI: Former Pakistan wicketkeeper Rashid Latif has revealed that the national team's white-ball captaincy will be determined following a crucial meeting between PCB Chairman Zaka Ashraf and wicketkeeper-batter Mohammad Rizwan. Latif shared this update on social media, stating that the decision, which has been delayed due to Naqvi's absence from the country, will soon be finalised. "The decision regarding the captaincy for ODIs and T20s will be made after a meeting between the PCB chairman and Mohammad Rizwan," Latif posted, hinting at Rizwan as the frontrunner for the leadership role. The captaincy position has been uncertain since Babar's resignation on October 2. Babar's departure came after a series of leadership changes within Pakistan cricket, including his earlier resignation as all-format captain under former PCB Chairman Zaka Ashraf. At that time, Shan Masood took over the red-ball team, and Shaheen Afridi was handed the T20 captaincy. However, Babar was reinstated as the white-ball captain ahead of the 2024 T20 World Cup during Naqvi's tenure as PCB chairman. With Babar now stepping aside from white-ball leadership, Rizwan and Mohammad Harris have emerged as the main candidates for the captaincy. Rizwan is believed to be the likely successor to lead the team in both formats. The Pakistan Cricket Board is expected to announce the squads for the upcoming white-ball tours of Australia and Zimbabwe within the next few days. —Agency

## Zimbabwe Sets T20I World Record With Dominant Win Over Gambia



NAIROBI: Zimbabwe's cricket team smashed a series of T20 international records in a commanding 290-run victory over Gambia during the Africa Sub-Regional World Cup Qualifiers on Tuesday in Nairobi. Zimbabwe posted an astonishing total of 344/4, the highest-ever score in a T20 international, surpassing the previous record of 314/3 set by Nepal against Mongolia in 2023. The remarkable innings featured a record-breaking 27 sixes, eclipsing Nepal's previous record of 26 sixes, achieved against Mongolia. In addition to their dominance with sixes, Zimbabwe equaled the record for the most fours in a T20I innings, hitting 30 boundaries, a record previously set by Sri Lanka in a match against Kenya in 2007. The team amassed 282 runs from boundaries, surpassing the previous highest of 216 set by Punjab against Andhra in India's domestic Syed Mushtaq Ali Trophy. In T20Is, the previous record for amassing most runs from boundaries was 212, created by Nepal, against Mongolia, in Asian Games match. Zimbabwe's inning run-rate was 17.20, which is highest ever in a completed T20 innings, surpassing the previous record of 15.7 runs per over - also by Nepal against Mongolia. Zimbabwe's all-rounder Sikandar Raza played a pivotal role in the record-breaking performance, smashing an unbeaten 133 off 43 balls. Raza's innings included 33-ball century, tying him for the second-fastest T20I century alongside Namibia's Jan Nicol Loftie-Eaton, who also reached the milestone in 33 balls. The fastest T20I century remains 27 balls, held by Estonia's Sahil Chauhan against Cyprus. In reply, Gambia was bowled out for 54 runs to mark a record-breaking 290 runs win for Zimbabwe. The victory margin of 290 runs also set a new record for the largest win by runs in T20 internationals, surpassing Nepal's 273-run win over Mongolia. —Agency

## Pakistan Shaheens Surge Into Semi-Finals With Commanding 74-Run Victory Over UAE



AL-AMERAT: Pakistan Shaheens progressed to the semi-finals after defeating United Arab Emirates (UAE) by 74 runs in a virtual quarter-final of the ACC Emerging Team T20 Asia Cup on Wednesday. The UAE was bundled out by Mohammad Harris and Co at 65 runs in 16.3 overs. Earlier, Harris, leading his side from the front, scored a rapid 71 off 49 runs to help his side post a 180-run target against UAE. Harris, who demoted himself in the batting order following back-to-back failures as an opener, smoked six boundaries and three maximums and remained not out at till the end. Omair Bin Yousuf, after Shaheens opted to bat first, opened the innings alongside Yasir Khan. The first 21 runs of the opening innings were fired by Omair after which he was unlucky to get run-out. Harris came in and joined Yasir at the crease who then gave confidence to his skipper while hitting a couple of hits out of the park. Muhammad Farooq, the leggie, cleverly bowled to Yasir who tried to play with the spin but failed to clear the long-on boundary. UAE skipper Rahul Chopra took a stunning catch running backward which also saw him falling where the back of his head was hit hard on the ground. He was taken off the field for a while. Meanwhile, Shaheens' skipper went berserk on the opposition bowlers with his traditional cheeky style. Qasim Akram, who sailed the ship of Shaheens in the match against Oman, managed just 23 runs. Whereas, Haider, who returned after resting in the previous match, proved his worth this time by scoring 32 off 17 balls including a boundary and three maximums. —Agency

## David Warner Eyes Test Comeback, Declares Himself Ready For Action



MULTAN: The former Australian opener David Warner expressed willingness to play against India in the five-match Test series, scheduled to start from November 22. Speaking to the Code Sports, he stated: "I'm always available, just got to pick up the phone. I'm always dead serious. Honestly, if they really needed myself for this series, I'm more than happy to play the next Shield game and go out there and play." It is worth noting here that the 37-year-old Warner announced his retirement from the red-ball format following three-match Test series against Pakistan late last year. Despite bidding farewell, the veteran mentioned that he would be willing to showcase his skills for his domestic side, New South Wales in the Sheffield Shield. In addition, the former Test vice-captain retired last summer after scoring 8,786 runs and 26 centuries, including a career-best 335 not out. Reflecting on his excitement, Warner said he messaged Australia's head coach and chief selector to include him in the squad for the Indian series. "I did retire for the right reasons to finish the game, and I wanted to finish. But my hand is up if they desperately need someone. I'm not going to shy away from that," Warner said, adding that he had cheekily messaged both Australia's head coach Andrew McDonald and chief selector George Bailey about the situation. "I've spoken to Torch (McDonald) and his answer back to me was, 'you retired,'" Warner laughed. "I don't think he wants to give me the pleasure of him saying, 'can you come back?'" Meanwhile, the Baggy Greens are looking for a capable opener batter for the series as Steve Smith has returned to his usual spot at four after Warner's retirement. —Agency

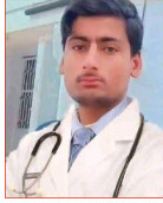

## Local contractor criticizes tender irregularities

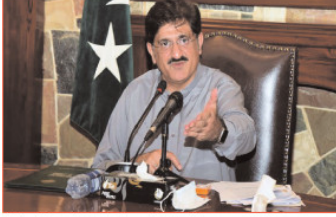

## Son of MQM-P MNA Rana Ansar Dies In Karachi Car Crash



KARACHI: Shahzaib Naqvi, the youngest son of Murtahida Qumi Movement Pakistan (MQM-P) MNA Rana Ansar, tragically lost his life in a car accident on Wednesday in Karachi.

According to rescue officials, the accident occurred in the early hours near the Clifton underpass, where the vehicle overturned and struck the sidewalk. Shahzaib succumbed to head injuries, while his friend Muhammad Ilyas sustained injuries in the crash. Police reported that Shahzaib was a resident of Askari 4, located on Rashid Minhas Road. He was the youngest son of MQM-P MNA Rana Ansar and the late senior journalist Syed Ansar Ali Naqvi. After completing the necessary legal procedure, authorities handed over Shahzaib's body to his family. His funeral prayer will be held tonight after Isha prayers at the Askari 4 mosque, according to the family.—RT/Agency

## Sindh Govt Targets Ghost Teachers: Over 1,300 Salaries Suspended Amid Absenteeism Crackdown

KARACHI: The Sindh government has ordered the suspension of salaries for 1,369 teachers and employees who have been permanently absent from their duties across the province.

A thorough investigation into absenteeism has been launched by a scrutiny committee formed by the Sindh Education Secretary. The committee's report revealed that a significant number of teachers and employees had been absent for extended periods, with many residing abroad.

In response, the Education Secretary directed the immediate halting of salaries for those found to be permanently absent. The investigation, led by an Additional Secretary along with two Deputy Secretaries and a Section Officer, gathered attendance records from Monitoring Officers and District Education Officers to substantiate the findings.

The Sindh Education Department's Monitoring and Evaluation unit confirmed



the absence of these 1,369 employees, prompting swift action to withhold their salaries.

In a related move, the Sindh government has introduced a new GPA-based grading system for matriculation and intermediate exams. This policy will eliminate the competition for top positions and replace traditional marks with grades, making Sindh the first province in Pakistan to adopt this modern approach. The Sindh government's efforts to advance education are also reflected in its recent partnership with Tech Valley Google through a memorandum of understanding (MoU) aimed at driving technological progress in the education sector. Speaking on the occasion, Sindh Chief Minister Syed Murad Ali Shah expressed his commitment to transforming education through innovative technology. "This marks an important day in our journey towards educational transformation in Sindh," Shah said at the signing ceremony held at the Chief Minister's House.—RT/Agency

## Karachi Horror: 7-Year-Old Boy Stabbed To Death, Mother And Sister Fighting For Their Lives

KARACHI: A tragic stabbing in Karachi's Orangi Town has claimed the life of a seven-year-old boy, while his mother and younger sister remain hospitalized with severe injuries, police reported on Wednesday.

"Two children and a woman were discovered with stab wounds inside a house near Liaqat West School in Orangi Town," said a statement from the local police. The victims were immediately rushed to Abbasi Shaheed Hospital, where the boy,

identified as Subhan, 7, succumbed to his injuries.

Dr. Summaiya Syed, Police Surgeon, confirmed that Subhan sustained fatal head trauma, resulting in bleeding from his nose and ears. His sister, Aleeza, 5, suffered serious head and facial injuries, while their mother, Kinsha, 30, has multiple deep wounds to her face and skull. Both remain in critical condition.

Police have launched an investigation, with initial findings pointing to personal enmity as the motive behind the attack. Authorities suspect a close family member's involvement, and District West Police have confirmed that the suspect himself contacted the police regarding the incident.

Senior Superintendent of Police (SSP) West Tariq Elahi Mastoi has formed a special team to pursue and apprehend the suspect. Further investigations are underway.—RT/Agency

## PPP Set To Push For Constitutional Bench Resolutions In Sindh And Balochistan Assemblies

KARACHI: The Pakistan People's Party (PPP) has announced plans to table and pass resolutions in the Sindh and Balochistan assemblies for the establishment of constitutional benches in both provinces.

Under clause-7 of Article 202-A, introduced through the 26th Constitutional Amendment, the formation of constitutional benches in a province requires a resolution passed by a simple majority in its assembly.

With a majority in both provincial assemblies, the PPP is expected to move

swiftly, instructing its legislators to ensure full attendance and vote in favor of the resolutions. Sources indicate that the Sindh Assembly may be convened today to pass the necessary resolution.

Meanwhile, the creation of constitutional benches in Khyber Pakhtunkhwa has been delayed due to the provincial government's stance on the matter. The ruling Pakistan Muslim League-Nawaz (PML-N) is also expected to push for a similar resolution in the Punjab Assembly soon.—RT/Agency

## Sindh Govt Tightens Grip: Private Use Of Official Number Plates To Face Legal Action

## Street Crime Sweep: Shah Latif Police Nab Three Suspects In Major Operation

## IHC Grants Bushra Bibi Bail In Latest Twist To Toshakhana Case

ISLAMABAD: The Islamabad High Court (IHC) on Wednesday accepted the post-arrest bail plea of Bushra Bibi, former first lady and wife of Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan, in the new Toshakhana case involving alleged illegal sale of state gifts.

The former first lady's bail plea was accepted against Rs1 million surety bonds during the hearing conducted by Justice Mianqul Hassan Aurangzeb.

The PTI founder's wife had moved the IHC on October 3 seeking bail in the jewellery set case. The petition, filed via Advocate Yousef Chaudhry, contended that the petitioner was a housewife and the allegations against her were baseless.

It added that the investigation was not transparent and the case was aimed at keeping the petitioner in jail. It said that the same case was



being run with different angles.

Previously, a trial court had terminated the post-arrest bail of the former first lady on September 30.

The case pertains to a reference filed by the National Accountability Bureau (NAB) against the couple in August.

It involves a jewellery set gifted to Bushra by the Saudi crown prince when Khan was the prime minister of the country from 2018 to 2022. The jewellery set — com-

prising a ring, bracelet, necklace a pair of earrings — was gifted to the former first lady on her visit to Saudi Arabia in May 2021, and the duo kept it illegally, alleges the NAB's reference.

During the hearing today, the Federal Investigation Agency's (FIA) prosecutor Umair Majeed said that the jewellery set in the said case was priced while the suspects were in possession of it. However, he added, the market value of a jewellery item could not be determined until

it was physically available. Complaining that the state was not given an opportunity to estimate the price of jewellery set correctly, the FIA prosecutor said that the said item should be placed in an auction and should be priced accordingly.

The official further stressed that a gift remains the property of the state until legally purchased and maintained that as per the procedure, a gift can be bought four months after its price has been assessed.

"A state gift cannot be kept by a person without being bought first," noted Majeed.

In response to Justice Aurangzeb's question about what would happen if the Bvlgari (Bulgari) set was returned, the FIA prosecutor said, "There is a plea bargain in the NAB law, but there is no such provision in that law."

Speaking during the hearing, the judge remarked that an accurate estimate of the price of a Toshakhana gift can only be assessed via an auction.

However, Justice Aurangzeb questioned why the PTI founder was made a suspect in the case if it was his wife who did not deposit the jewellery set in the Toshakhana.

To this, the FIA official contended that Khan was a public official.

"This is a similar case to that of the Chief Justice of Pakistan Qazi Faez Isa," remarked the judge. "This case is slightly different from that," responded prosecutor Majeed.

After hearing the FIA official's arguments, the court then granted bail to the former first lady who's been incarcerated in the said case in Rawalpindi's Adiala jail.—RT/Agency

## Hamid Khan Blames 'Out-Of-Turn' Chief Justices For Setbacks

ISLAMABAD: The Pakistan Tehreek-e-Insaf (PTI) has rejected the nomination of Justice Yahya Afridi as the next Chief Justice of Pakistan (CJP), vowing to launch a protest movement against the Special Parliamentary Committee's decision.

"As lawyers, we will condemn this nomination and will launch a protest movement," PTI leader Hamid Khan said while speaking to media following the parliamentary panel's meeting, which the former ruling party boycotted.

However, he expressed hope that Justice Afridi would not accept the nomination as chief justice.

Chief justices have been appointed twice out-of-turn and it caused "a great loss to the country", Hamid said. "[This move] has been done to create a divide within the Supreme Court."

Meanwhile, Planning Minister Ahsan Iqbal has rejected the opposition's allegations of creating a "constitutional crisis" by picking a



chief justice after neglecting high courts.

The minister further said that the country needed a statesmanship and a strong leadership to end polarisation in the top court's benches and judicial system besides strengthening the judiciary and bringing harmony to the institution.

The nomination came after two rounds of in-camera meeting of the parliamentary panel with the PTI-backed Sunni Itehad Council (SIC) boycotting the proceedings "in line with the party's political committee's decision".—RT/Agency

## Liquor Case Escalates: Islamabad Police Ordered To Arrest CM Gandapur

ISLAMABAD: A district and sessions court in Islamabad on Wednesday directed the Islamabad police to execute arrest warrant issued for Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur in a 2016 case, wherein he is accused of carrying liquor and unlicensed weapons.

Civil Judge Mubashir Hassan directed the SSP operations of Islamabad police to ensure implementation of the court's order to arrest the PTI firebrand chief minister.

During the course of hearing, a report on CM Gandapur's arrest warrant was submitted to the local court. The police did not execute the arrest warrants for the provincial chief executive, read the report.

Irked by his continuous non-appearance, the court maintained his non-bailable arrest warrants and directed the authority concerned to produce the chief minister before the court after taking him into custody.

Meanwhile, the court adjourned the hearing till October 26.

Earlier this month, Judicial Magistrate Mubashir Hussain Chishty issued non-bailable arrest



warrant for the KP CM in arms and liquor recovery case.

A case was lodged against the PTI leader after the alleged recovery of five Kalashnikov rifles, a pistol, six magazines, a bullet-proof vest, three teargas shells, and bottles of alcohol in October 2016.

Gandapur, who was then serving as a provincial minister in KP, was charged under the illegal arms and anti-drugs laws after illicit arms and a bottle of liquor were allegedly recovered from his car. A local court in Islamabad on March 7 this year overturned the trial court orders declaring KP CM Gandapur a "proclaimed offender" in the said case registered against him in Bazarhaku police station.

Earlier, a trial court had declared Gandapur an ab-

scender for evading the law in the case.

District and Sessions Court Judge Shahrux Arjumand had nullified the trial court's order over a review petition filed by the suspect. The petitioner's lawyer had informed the court that Gandapur couldn't appear in court because of his official engagements as the new KP chief minister. He had requested the court to exempt Gandapur from the proceedings hearing that day. The lawyer had said that the trial court had declared Gandapur a proclaimed absconder for continuously skipping the proceedings in the case.

He had said that Gandapur hadn't received the court's summons due to non-compliance by the process server, designated for delivering the legal documents.—RT/Agency

## Final Countdown: Loss-Making PIA To Be Auctioned Off On October 30



ISLAMABAD: The incumbent government has decided to hold the final auction of the loss-making Pakistan International Airlines (PIA) Corporation on October 30.

This was revealed by Parliamentary Secretary for Communication Gul Asghar Khan on Wednesday during the seventh session of the National Assembly in response to Pakistan Peoples Party (PPP) MNA Sharmila Faruqi.

The government had delayed the bidding process due to low bidder interest and unresolved issues, well-placed sources privy to the development said. The process was earlier scheduled for October 1.

The sources added that the delay may have resulted from issues including unresolved court cases, fleet ageing and civil aviation issues.

During the assembly session today, Khan said the privatisation of the state-owned entity was a detailed process conducted under the elaborate structure of privatisation. The process was initiated in February 2024 and would

be finalised on October 30, he apprised the lawmakers.

The parliamentary secretary said the process involved different institutions including the Privatisation Commission Board chaired by the minister and the secretary Privatisation Commission Usman Bajwa.

The PIA's privatisation decision, he said, was approved by the Cabinet Committee on privatisation. "PIA assets have been parked separately as its operational assets have been separated whereas final auction will be held under PIA Corporation on October 30."

Last month, Bajwa informed the National Assembly's Standing Committee on Privatisation that the final bid documents were shared with six pre-qualified bidders. The six consortia that were pre-qualified to bid for a 60% stake in PIA, included Fly Jinnah Limited, Air Blue Limited, Anif Habib Corporation Limited, a consortium led by YB Holdings (Private) Limited, a consortium led by Pak Ethanol and Blue World City.—RT/Agency

## UN Rights Watchdog Sounds Alarm Over Swift Adoption Of 26th Amendment

UNITED NATION: United Nations Human Rights chief Volker Turk has voiced concern over the newly enacted 26th Constitutional Amendment, saying it was "adopted hastily and without broad consultation and debate".

The ruling coalition, after weeks of political manoeuvrings and deliberations, finally managed to pass the contentious 26th Constitutional Amendment bill, empowering the country's parliament to pick the next Chief Justice of Pakistan (CJP) from among the three most senior Supreme Court judges.

In a post on X (formerly Twitter), Turk said that "hastily adopted" amendments will "seriously undermine the independence of the judiciary".

"Constitutional reforms must be in line with international human rights law," the statement added. The passage of the contentious package drew strong criticism from the



opposition and lawyers community, with Pakistan Tehreek-e-Insaf (PTI) vowing to launch a protest movement across the country.

The Human Rights Commission of Pakistan (HRCP) has also expressed strong reservations over certain aspects of the amendments.

The amendments brought numerous changes to the country's judicial system, including taking away suo motu powers, formation of constitutional benches, AFSPA as the next chief justice and performance evaluations of high court judges.

In light of the fresh opposition and lawyers community, with Pakistan Tehreek-e-Insaf (PTI) vowing to launch a protest movement across the country. After nomination, President Asif Ali Zardari appointed Justice Afridi under clause 3 of Article 175A read with Articles 177 and 179 of the Constitution, according to a notification issued by the Ministry of Law and Justice today. It stated that the president was pleased to appoint Justice Afridi as the next chief justice "for a term of three years with effect from" October 26.—RT/Agency

## Pakistan And Saudi Arabia Forge Stronger Ties With Pledge To Boost Key Sector Investments

WASHINGTON: Appreciating the historical and fraternal bonds between Pakistan and Saudi Arabia, both sides have expressed resolve to further deepen mutually beneficial economic ties, enhance bilateral trade, and facilitate investment in key sectors.

The commitment was renewed at a meeting between Finance Minister Muhammad Aurangzeb and Saudi Minister of Finance Mohammed Al-Jadaan on the sidelines of the World Bank-IMF Annual Meetings in Washington DC.

Al-Jadaan shared his experience of reforms in the energy sector. Both sides agreed to advance cooperation in areas of mutual interest, the finance ministry said in a post on X.

Aurangzeb is leading a Pakistan delegation to the WB-IMF Annual Meetings, being held in Washington DC from October 21 to 26, state-run APP reported.

Other delegates include Finance Secretary Imdad Ullah Bosal; Secretary Economic Affairs Dr Kazim Niaz and State Bank of Pakistan



(SBP) Governor Jameel Ahmad.

It is noteworthy to mention here that Pakistan and Saudi Arabia had inked signed several memorandums of understandings (MoUs) for \$2 billion bilateral investment agreements during Saudi Investment Minister Khalid Bin Abdul Aziz Al Falih's visit to Islamabad last month.

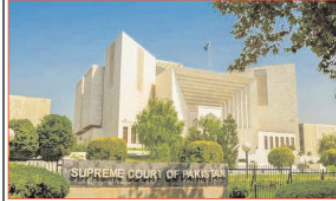

ISLAMABAD: The Supreme Court of Pakistan (SC) has sent the application pertaining to restoration of terminated employees case to the constitutional benches after the recently passed 26th constitutional amendment.

A three-member bench of the apex court, headed by Justice Mansoor Ali Shah, heard the case on Wednesday.

Applicants' lawyer Waseem Sajjad stated that every citizen had a constitutional right to live a peaceful life.

Justice Mansoor remarked that a constitutional question was raised in this

case therefore, constitutional benches would be formed to hear and decide the constitutional cases in the wake of enactment of 26th amendment.

Justice Ayesha also remarked that a constitutional bench would proceed the case.

The apex court mentioned that constitutional benches would hear the constitutional cases after the 26th amendment and applications were being sent to benches.

Seven employees of the Ministry of Petroleum and Natural Resources moved the SC against a high court decision.—RT/Agency

## Pakistan Sees Light At The End Of The Tunnel With China's Positive Response On Debt Refiling

WASHINGTON: Pakistan is advancing economic ties with China, Saudi Arabia, and Türkiye, as Federal Finance Minister Muhammad Aurangzeb held high-level discussions on the sidelines of the World Bank-IMF Annual Meetings in Washington DC.

The meetings focused on debt reprofiling, trade cooperation, and joint ventures to strengthen Pakistan's economic prospects. Aurangzeb revealed a "promising response" from China over Pakistan's request to reprofile its power sector debt, a move aimed at providing the country with breathing room to lower electricity prices. "We have just started that discussion, and the re-



sponse is encouraging," the minister told Bloomberg, while stressing the importance of continuing structural reforms.

He noted that Pakistan seeks to extend the maturity of debt for nine power plants

built by Chinese companies under the China-Pakistan Economic Corridor (CPEC). China has already rolled over \$16 billion in debt from a total of \$26 billion in the current fiscal year.—RT/Agency

## ECP Grants PTI Senator Abro More Time To Respond In Disqualification Row

ISLAMABAD: The Election Commission of Pakistan (ECP) on Wednesday granted PTI Senator Saifullah Abro additional time to submit his response in the disqualification reference, and adjourned the hearing until Nov 11.

A three-member bench headed by Chief Election Commissioner (CEC) Sikandar Sultan Raja heard the disqualification reference

against Senator Saifullah Abro. During the hearing, both Abro's lawyer and People's Party Senator Shahadat Awan appeared before the election commission.

Abro's lawyer informed the commission that they had not received a copy of the application and requested additional time to respond. Approving the request, the ECP

directed Saifullah Abro to submit his response and postponed the hearing until November 11. Notably, Majid Mahmud and Senator Shahadat Awan filed a reference against PTI Senator Saifullah Abro, alleging that he submitted false experience documents for a technocrat seat and did not declare all his assets in the nomination papers.—RT/Agency
