Imran Slams 26th Amendment As A 'Constitutional Assault'

ISLAMABAD: In a meeting with Pakistan Tehreek-e-Insaf (PTI) lawyers held on the Islamabad High Court (IHC) orders, party founder Imran Khan termed the newly enacted 26th Constitutional Amendment, which empowers parliamentarians to pick chief justice, an "attack on Constitution of Pakistan."



Speaking to journalists after the meeting, PTI lawyer Faisal Chaudhry said that the incarcerated former prime minister has expressed displeasure over the 26th Constitutional Amendment. "The PTI founder said the nation has been tyrannised by this act," the lawyer said, adding that Khan refused to comment on appointment of Justice Yahya Afridi as next Chief Justice of Pakistan (CJP).

founder is not afraid of any adversity," he added. He noted that they were making efforts to reduce hardships being faced by the PTI founder. Chaudhry claimed that the PTI founder is kept in a six by eight cell, adding that he has been subjected to psychological torture. "An application will be filed in IHC against the circumstances the former premier is being kept."

Bilawal Declares That 26th Amendment Would Have Been Unthinkable Under Any Other Chief Justice

ISLAMABAD: Pakistan Peoples Party (PPP) Chairman Bilawal Bhattu-Zardari has said that enacting the 26th Constitutional Amendment was not possible under any other chief justice, as he praised outgoing CJP Qazi Faez Isa.



The Shehbaz Sharif-led government, with the assistance of allies including the PPP, passed the contentious legislation in both lower and upper houses of parliament, which changed the procedure for the Chief Justice of Pakistan's (CJP) appointment, fixed the post's tenure, and formed constitutional benches.

minister during the previous government under PM Shehbaz, said that the allies had a window while CJP Isa was in power and they availed it. "We did have a window because we have seen how other judges have moulded the Constitution whether it's [Article] 63-A or the reserved seats case, to serve their personal interests. "On the other hand, we had a chief justice who could withstand pressure from other judges also that may have tried to investigate him that this is not a question about you, but about the power [of the judiciary]."

In his interview with BBC Urdu, Bilawal defended the timing of the legislation, which the opposition says did not only come at a "questionable time" but was also "person-specific". When asked about the timing, he said: "In the judicial history of Pakistan, there's one man [...] that has shown us that he's willing to obey parliament even at the cost of his personal power."

Bilawal said that the allies had a window "of a man who would not undermine what we were doing". The interviewer also asked the ex-PM whether he believes the government would not have been able to pass the amendments had Justice Mansoor Ali Shah, who is the senior-most judge, become the CJP. In response, he said that the judgment of the reserved seats was "orchestrated" to undermine the strength of parliament and that the Article 63-A decision was not based on the Constitution.

Nine Terrorists, Including Mastermind, Eliminated In Bajaur Operation

RAWALPINDI: The security forces on the night between October 23 and 24 eliminated nine terrorists — or "khawarij" — including two suicide bombers and a ring leader in an intelligence-based operation (IBO) in Khyber Pakhtunkhwa's Bajaur district.



During the operation, high-value target (HVT) and terrorist ring leader Said Muhammad alias "Qureshi Ustad" was also killed following an intense exchange of fire with the troops, said the Inter-Services Public Relations (ISPR) on Thursday. With the sanitisation operation underway to eliminate any further militants in the area, the security forces also recovered large quantities of weapons, ammunition, and explosives from the terrorists.

Centre for Research and Security Studies (CRSS), the total fatalities from three quarters of this year have surpassed the total fatalities recorded for the entire of 2023 with 1,534 deaths compared to last year's 1,523. A total of 722 people were killed, including civilians, security personnel, and outlaws, while 615 others were wounded in as many as 328 incidents recorded during the third quarter.

The militants, the military's media wing added, remained actively involved in numerous terrorist activities against the security forces as well as innocent civilians. The ISPR further reaf-

firming the security forces' resolve to wipe out the menace of terrorism from the country. Last week, at least five militants were arrested in an IBO in Balochistan's Pishin district. Whereas two terrorists were killed in a separate IBO in the province's Zhob district. The IBOs are part of the concerted efforts by the government, security forces and law enforcement agencies (LEAs) to tackle the menace of terrorism which has witnessed an increase in recent months. Bushra Bibi Walks Free On Bail After Months Of Incarceration

RAWALPINDI: Bushra Bibi, the wife of Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan, is finally out of prison on bail after remaining behind bars for around nine months. The release from Rawalpindi's Adiala Jail came a day after the Islamabad High Court (IHC) granted her bail against surety bonds worth Rs1 million in the new Toshkhana case.



The former first lady was arrested after a court on January 31 convicted and sentenced the couple to 14 years in prison after finding them guilty of retaining and selling state gifts in violation of government rules (Toshkhana case) while Khan was in power.

Her release was expedited compared to the usual legal process, as typically, when a rokbar (release order) is issued, the imprisoned person is released within two hours. However, Bushra Bibi was released in just 20 minutes. While media personnel and PTI workers waited outside the prison to engage

with Khan's wife, the former first lady quickly departed without speaking to anyone. However, the workers showered her car with flowers as it sped away. Adviser to Chief Minister Akhtar Ijaz said that Bushra Bibi reached

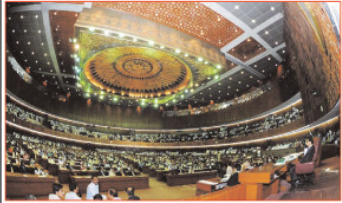
Peshawar safely after her release and will stay there for some time. The IHC granted her bail on Wednesday, but due to the absence of a judge to sign the release order, she remained behind bars. Today, Judge Shaukrul Arjumand signed her rokbar. The former first lady was arrested in the said case along with her husband, who remains behind bars in the same facility, soon after their acquittal in the iddat case — also known as the un-Islamic nikah case.

Toshkhana case wherein the couple was sentenced to 14 years in prison and was handed down a fine of Rs1.57 billion — Rs787 million each — in January. The ex-first lady was then placed under house arrest at Her Bani Gala residence. However, she was later transferred to the Adiala jail in May at the IHC's orders which came in response to her petition that challenged the Islamabad Commissioner's decision that declared Bani Gala a sub-jail.

However, her legal woes have seemingly witnessed a respite as she exited the Adiala jail via its gate number 5. They said the case is not to be mixed with the first

Ex-Attorney General Exposes Critical Flaw In 26th Amendment



ISLAMABAD: The constitutional package passed by parliament in the form of the 26th Amendment has some drafting issues and a "serious anomaly" has been pointed out by a legal expert which if not addressed through a 27th Amendment, may become a hurdle in the formation of constitutional benches in the Supreme Court. A former attorney general, who left his office not long ago and who does not wish to be named, told media that because of the serious anomaly, the new Judicial Commission of Pakistan (JCP) cannot be created and no constitutional benches can be appointed unless this provision is amended via another constitutional amendment. "In my view, until then the old benches will continue and there will be no constitutional benches," he said. The former AG also pointed out confusion and some drafting mistakes in the latest constitutional amendment's language but his view about the constitutional benches is really alarming. Given this, media repeatedly tried to contact both Law Minister Azam Nazir Tarar and Attorney General Mansoor Awan but neither of them responded. The view of the former attorney general was also shared with them via WhatsApp, but they did not reply nor offer any comment.—RT/Agency

Pakistan Seeks Urgent \$1 Billion Relief From IMF, Confirms Finance Minister

WASHINGTON: Pakistan is targeting around \$1bn in a formal request for funding from the IMF facility that helps low and middle income countries manage external shocks, its finance minister told Reuters.



"We have formally requested to be considered for this facility," Finance Minister Muhammad Aurangzeb said in an interview on the sidelines of the IMF/World Bank autumn meetings in Washington. The International Monetary Fund had already agreed a \$7bn bailout for Pakistan, but has further funding available via its Resilience and Sustainability Trust (RST). The RST, created in 2022, provides long-term concessional cash for climate-related spending, such as adaptation and transitioning to cleaner energy. The South Asian nation is one of the most vulnerable countries to climate change according to the Global Climate Risk Index.

Pakistan's foreign exchange reserves should reach \$13 billion by the end of March, Aurangzeb said, which would help with commercial lending, and potentially its credit rating. The foreign exchange reserves reached \$11.04 billion in the week ending Oct. 18, the central bank said. Moody's upgraded Pakistan's ratings to "Caa2" in August, citing improving macro-economic conditions, and Fitch boosted its rating to CCC+ in July following the IMF staff level agreement. But both ratings are sub investment grade.—RT/Agency

Pakistan And Saudi Arabia Set To Bolster SME Ties And Business Exchanges



ISLAMABAD: Pakistan's Minister for Industries and Production, Rana Tanveer Hussain, and Saudi Arabia's governor for small and medium enterprises (SME) general have agreed to enhance bilateral cooperation in the SME sector, Pakistan's ministry said on Thursday. Hussain is in Saudi Arabia to attend the United Nations Multilateral Industrial Policy Forum (MIPF), being held from 23-24 October in Riyadh. The forum brings together international delegates to discuss industrial growth and sustainable practices.

Dar Champions Youth Empowerment At Commonwealth Summit

APIA: Deputy Prime Minister and Foreign Minister Ishaq Dar on Thursday calling the youth leadership vital for a resilient and inclusive Commonwealth. Pakistan's strong commitment to providing platforms that empower youth to take on leadership roles.



The deputy premier, in his remarks at the Commonwealth Intergenerational Dialogue held in Samoa, highlighted initiatives like the Prime Minister's Youth Programme in Pakistan, which has supported millions of young people in education, employment, and engagement. Food Department's Negligence Leads To Spoilage Of Thousands Of Wheat Bags In Thul

THUL: A shocking case of negligence by the local Food Department has resulted in the spoilage of thousands of wheat bags, raising serious concerns among residents and officials alike. The mishap occurred at a food center situated in a rice mill on Colleague Road, where thousands of purchased grain sacks were left exposed to the elements, leading to significant damage from recent rainfall.



Eyewitness reports indicate that the bags of wheat, which were meant to be stored securely, were carelessly abandoned without proper protection. The lack of oversight and maintenance has resulted in the deterioration of these essential supplies, which are crucial for local food security.

In an alarming development, it has come to light that the Food Department officials are now attempting to transfer the spoiled wheat bags to the Pipri warehouses in Karachi. Within just two days, 25,000 out of the 50,000 wheat sacks have already been moved, many of which were found to be damaged and unsuitable for use. This swift action has raised questions about the accountability of the officials involved and the fate of the remaining wheat bags.

Protests Held Against Power Outages In Kotri

KOTRI: Residents of Kotri have been enduring unannounced and prolonged power outages for over a month, prompting elected councilors from the municipal committee to organize a large protest march. The demonstration culminated at the local press club, where participants chanted slogans against the ongoing power crisis. Led by councilors Jala Rind, Rao Shahid, Babar Iqbal, Apa Yasmeen, and Salma Otho, the protesters demanded the removal of the current Executive Engineer (XEN) of Jamshoro and immediate action to address the unscheduled load-shedding. They reported that since the arrival of the current XEN, the electricity supply has drastically decreased, with officials attributing the outages to ongoing grid maintenance. Protesters highlighted the severe impact of these power cuts on various neighborhoods, including Salahuddin Dargah, Nango Lain, Yousif Baloch Goth, Rasam Mori, Shah Latif Colony, Kotri City, Subhan Allah Colony, Station Colony, and Khanpur, where electricity has been cut from 8 AM to 5 PM daily. Speakers emphasized their refusal to meet with the XEN and SDOs, insisting on an end to the artificial load-shedding and the removal of the current XEN. They warned that failure to address their demands would result in a shutter-down strike across the city.

President Of Awami Press Club Complains Against Information Department In Sukkur

KUMB: Naz Solangi, the President of the Awami Press Club, has called on the Secretary of Information in Sindh to take immediate action against the Deputy Director of Information in Khairpur, citing his inadequate performance in fulfilling his duties. Solangi expressed that the Awami Press Club has not received proper support from the registered journalist community for over a decade. Despite being officially registered, the Sukkur Regional Information Department has consistently failed to provide necessary information, which he described as a mockery of the law. He highlighted that when historical sites are visited by foreign delegations, the local press is often left uninformed, and there have been no press visits conducted as required by protocol. Solangi urged the Sindh Information Department to promptly provide a list of registered press clubs to the Sukkur Information Department to rectify this ongoing neglect. -RT

DC Muhammad Naem Sindhu Leads Polio Eradication Efforts In Key Committee Meeting

TOBA TEK SINGH: A meeting of the District Polio Eradication Committee was held under the chairmanship of Deputy Commissioner Muhammad Naem Sindhu. The meeting reviewed the preparations for the five-day polio eradication campaign starting on October 28, 2024. Additional Deputy Commissioner Zeeshan Labha Mash, CEO Health Dr. Kashif Mahmood Kambhoj, WHO representative Dr. Wasiq, and other officials were also present at the meeting.

CEO Health Dr. Kashif Mahmood Kambhoj, while briefing about the polio eradication campaign, informed that preparations for the campaign, running from October 28 to November 1, 2024, have been completed, and the relevant staff has been trained. During the five-day campaign, 333,838 children under the age of five will be given polio vaccines and Vitamin A drops. Deputy Commissioner Muhammad Naem Sindhu emphasized that any shortcomings identified during the previous polio campaign should be addressed, and fake entries should be strictly avoided during the campaign. He said that the day is not far when Pakistan will become a polio-free country. During this time, we must perform our professional duties responsibly, ensuring that every child receives the polio vaccine drops. He also appealed to parents to ensure that their children are vaccinated against polio to protect them from lifelong disability and to fully cooperate with the polio eradication teams.

ARI And TDP Call For Urgent Strengthening Of National Quit-Line And Anti-Smoking Services

ISLAMABAD: The Alternative Research Initiative (ARI), in collaboration with the Transparent Development Program (TDP), is urging immediate measures to enhance the national smoking quit-line and smoking cessation services. They emphasize the importance of ensuring these services are supported by adequate human and financial resources to help adult smokers quit. The statement highlights that effective cessation programs are vital for achieving a smoke-free Pakistan. This dream cannot be realized if effective cessation services are not widely accessible across the country, said Arshad Ali Syed, Project Director of ARI. In addition to making the quit-line functional, there is a pressing need to support it with adequate resources. The statement points out that local stop smoking services in the UK, including England, Scotland, Wales, and Northern Ireland, provide advisers to assist individuals in their quit journey. These services involve evaluating smoking habits, assessing the urge to quit, and conducting breath tests to measure carbon monoxide levels, an indicator of smoking exposure. NHS-endorsed treatments, including nicotine replacement products, are also provided, and advisors offer guidance on using e-cigarettes as a cessation tool. Advisors play a crucial role in helping individuals identify challenging situations that may lead to relapse into smoking. The statement urges Pakistan to research and implement smoking cessation services from developed nations, stressing that without assisting adult smokers in quitting, the goal of a smoke-free Pakistan will remain unattainable. According to the WHO, approximately 80% of the world's 1.3 billion tobacco users reside in low- and middle-income countries. Currently, Pakistan has over 31 million tobacco users, with more than half identified as smokers.—RT

Karachi Biennale Trust Unveils KB24 With Provocative Theme Of Rizq/Risk

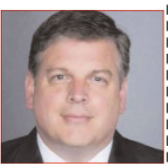
KARACHI: The fourth Karachi Biennale, themed "Rizq/Risk," will open on October 27 and run for two weeks, featuring art across the city. Announced at a press conference, this edition aims to connect visitors with contemporary food issues through interactive projects by over 40 artists from 10 countries, including installations, performances, videos, and paintings at five venues. The theme addresses recent floods and heatwaves in Pakistan that have affected food security, encouraging reflection on colonial and neoliberal food production policies that prioritize profit over hunger and ecological concerns. The works will highlight indigenous wisdom and the vital role of women as



custodians of traditional knowledge and food cultures. Nilofur Faruq, Managing Trustee of KBT, stated that art can tackle challenging issues, fostering awareness and dialogue around food justice. With the tagline "Nai fasal ki umeed" (In the Hope of a New Harvest), the exhibitions aim to inspire hope and solutions. Curator Waheeda Baloch emphasized her global perspective on "Rizq/Risk," shaped by her experiences in Mirpur Khas and her studies in Sweden and Germany. Aleem And Jam Unveil New Bridge Over Hub River, Easing Traffic Woes

HUB: Federal Minister for Board of Investment, Privatization and Communications Abdul Aleem Khan and Federal Minister for Commerce Jam Kamal Khan on Thursday inaugurated the newly constructed bridge over the Hub River. The newly constructed bridge over the Hub River on National Highway N-25, connecting the provinces of Balochistan and Sindh. The project has been completed in two years at a cost of Rs 1.18 billion, aims to enhance connectivity and facilitate trade between the regions, said a press release issued here. Addressing the inauguration ceremony, Abdul Aleem Khan emphasized the importance of business activities for regional development. "We have to ensure maximum development of Balochistan, even by collecting revenue from other provinces," he stated. Aleem Khan noted that while Balochistan boasts the largest network of the National Highway Authority (NHA) in the country, covering 4,500 km, the province generates relatively lower toll revenue. The minister expressed concerns over the bridge's width, deeming it insufficient for current traffic demands, and announced plans for the construction of an additional parallel bridge. He also approved the conversion of the N-25 highway from Karachi to Quetta into a two-way road to prevent accidents caused by traffic congestion. "We will build new bridges and roads in Balochistan," Aleem Khan assured attendees, highlighting that a new bridge at Pinjara is also nearing completion. He further revealed aspirations for developing a six-lane Karachi-Hyderabad motorway through a Public-Private Partnership model, alongside plans for a Northern Bypass as a major highway project.



Aleem Khan commended the National Logistics Cell (NLC) and the National Highway Authority (NHA) for their exemplary performance in the bridge's construction and expressed optimism that this development would significantly contribute to the economic growth of the Hub area and the province. Federal Minister for Commerce Jam Kamal Khan echoed these sentiments, stating that the current government prioritized resolving issues of Balochistan.—RT/Agency

US Deploys Mobile Vans With X-Ray Machines To Boost TB Detection In Sindh

KARACHI: On Thursday, US Ambassador to Pakistan, Donald Blome, donated five mobile tuberculosis (TB) vans and three digital X-ray machines to the Sindh Health Department to improve TB detection and treatment in remote areas of the province. Health Minister Dr. Azza Fazal Pechuho expressed her gratitude for the US government's ongoing support, stating, "This initiative highlights the strong bilateral relations between Pakistan and the United States and aims to strengthen Sindh's health system." Ambassador Blome praised the Sindh Health Department's commitment to combating TB and highlighted the significance of these mobile units in expanding access to quality healthcare. "These vans will allow the provincial health



department to better serve vulnerable communities by providing essential care," he said. Since the 2022 floods, the US has contributed over \$74 million in health aid, including TB diagnostic vans and mobile X-ray units, enhancing healthcare services for at-risk populations. This initiative is anticipated to increase access to TB diagnostic services, strengthen community engagement, improve service delivery, and reduce TB cases in targeted districts, supporting Pakistan's public health objectives and the global goal to end TB by 2030.—RT

Motorcycle Brazenly Stolen From Police Station Parking Lot In Karachi

KARACHI: In an unusual turn of events, a motorcycle was stolen from the parking lot of Karachi's Korangi police station, local media reported on Thursday. According to the victim, he had arrived at the station around 10:30 pm for an investigation with a relative. However, upon returning to the parking area, he discovered that his motorcycle was missing. Korangi police have registered a complaint and promised to track down the thief using CCTV footage. However, sources revealed that the station's CCTV cameras have been non-functional for several months. This incident comes amid a surge in motorcycle thefts in Karachi, with over 40,000 bikes either stolen or snatched in the first nine months of this year alone.—RT/Agency

Pakistan Introduces Major Taxpayer Amendments

KARACHI: The Federal Board of Revenue (FBR) has introduced significant amendments to the Income Tax Rules 2002, ensuring the Active Taxpayers List (ATL) is now updated daily, media reported Thursday. As per an SRQ issued on October 18, 2024, under Section 237 of the Income Tax Ordinance 2001, taxpayers who file their returns for the 2024 tax year within the prescribed deadline will be immediately included in the ATL. However, those who miss the deadline will need to pay a surcharge to be added to the list. These reforms highlight the FBR's commitment to enhancing transparency and operational efficiency, streamlining processes for taxpayers and stakeholders to create a more effective tax system.—RT/Agency

The recent book fair in Lahore, intended as a celebration of literature, turned into a culinary spectacle, raising serious concerns about our nation's misplaced priorities. Reports revealed that only 35 books were sold throughout the event, while food stalls thrived, selling over 1,200 shawarmas and 800 plates of biryani. This overwhelming focus on food rather than books highlights a troubling trend in Pakistan, where we seem more inclined to satisfy our stomachs than nourish our minds.

Lahore, known as the cultural heart of Pakistan, has produced some of the greatest

literary figures, from Saadat Hasan Manto to Faiz Ahmed Faiz. This city has been a beacon of intellectual thought and creativ-



ity, yet the dismal book sales at the fair signal a drift away from this rich legacy. When an event designed to promote reading and intellectual engagement turns into a food fest, it reflects a deeper cultural issue that needs urgent attention.

We must ask ourselves: why is there such a lack of enthusiasm for books and learn-

ing? Have we forgotten the importance of knowledge in shaping our future? The disparity between food and book sales is not just embarrassing; it is a wake-up call. If we continue to neglect intellectual pursuits, we risk losing our cultural and academic heritage.

It is time for Pakistan to prioritize education, reading, and intellectual growth. We must foster a culture where the love of books is cherished and celebrated, not overshadowed by fleeting culinary delights. Only then can we hope to build a prosperous future, driven by knowledge and informed thinking.

Concerns Raised Over Journalists' Safety In Umerkot

UMERKOT. The safety of journalists in Umerkot has become a pressing issue, with senior journalist Zahid Hussain Khatak highlighting the dangerous conditions faced by reporters in the area. His remarks came during a meeting organized by the Trust for Democratic Education and Accountability (TDEA) at the Umerkot Press Club, where a range of issues affecting the local media landscape were discussed.

Journalist Naheed Hussain Khatak underscored the critical need to prioritize the security of journalists, emphasizing that without proper protection, those in the field are at significant risk. Muhammad Iqbal Bhatti pointed out a worrying trend in the media industry, where owners have transformed institutions into profit-driven businesses, often sidelining experience and education. This shift has led to a situation where anyone with a

smartphone can be labeled a journalist, diluting the standards of reporting.

Utam Sangrasi highlighted the importance of training journalists on sensitive issues, advocating for education that empowers them to report responsibly while minimizing risks to their safety. He noted that, without adequate training, journalists may inadvertently put themselves in harm's way while covering crucial stories.

Ali Murad Dal raised alarms about the lack of salaries for journalists in Umerkot, stating that poor economic conditions hinder their ability to serve society effectively. He lamented the absence of unity among journalists, arguing that this fragmentation weakens their collective voice and undermines their efforts to advocate for their rights and safety.

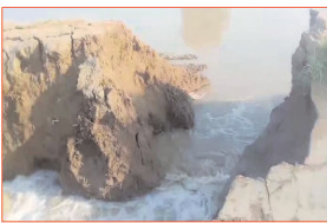
The meeting also addressed broader issues of injustice faced by journalists in the region. Jaipal Malhi pointed out the existence of

five press clubs in the Samaro area of Umerkot, none of which are officially registered. He criticized the declining standards of web channels, suggesting that this further complicates the media landscape.

Senior journalist and leader of the Pakistan Federal Union of Journalists (PFUJ), Nasir Zaidi, discussed the government's measures for journalist protection, emphasizing the need for systemic change to safeguard those in the profession. TDEA representative Abdul Ahad informed attendees about the Safe Media Program, which aims to enhance journalists' professional skills, empower them, and strengthen their collective advocacy.

As concerns about journalist safety continue to grow, this meeting served as a crucial platform for addressing the challenges faced by media professionals in Umerkot, advocating for necessary reforms and support to ensure a safer environment for reporting.

Sui Kandhar Branch Suffers A 10-Foot Wide Breach

Despite timely notifications, the irrigation staff failed to respond promptly to the crisis. After several hours of efforts, the irrigation department finally arrived with heavy machinery to address the breach. QAZI AHMED. The family of Allahyar Lund, a shopkeeper tragically murdered nine months ago by unidentified gunmen during a robbery, continues to seek justice as the main suspects remain at large. Today marks the fourth day of protests outside the Qazi Ahmed police station, where the victim's family, holding photos of Allahyar Lund, has staged a symbolic hunger strike while chanting slogans demanding accountability and action.

The demonstration is led by Muhammad Achar Lund, Allahyar's father, who is joined by his sons—Muhammad Hanif Lund and Sajid Ali Lund—as well as community members Abdullah Lund and Ghulam Qadir Lund. Together, they have expressed their deep frustration over the lack of progress in the investigation. Allahyar Lund was shot dead in broad daylight



while seated in his shop, a shocking act of violence that has left the family and community in mourning.

Despite a case being filed against the suspects nearly nine months ago, the police have yet to make any arrests, which has only heightened the family's sense of injustice. The protesters have openly criticized SSP Shaheed Benazirabad Tanveer Hussain Tunio for failing to act on directives from Deputy Speaker of the National Assembly Syed Ghulam Mustafa Shah, which called for the immediate apprehension of the sus-

pects.

As the protests continue, the Lund family and their supporters are calling on local authorities to take decisive action. They demand not only the arrest of the culprits but also a thorough investigation into the circumstances surrounding Allahyar Lund's death. The community stands united in their plea for justice, urging law enforcement to fulfill their duty to protect and serve. Without swift action, the family fears that the case may fade into obscurity, leaving them without closure and justice for their beloved Allahyar.

Sajid Khan Praises Selection Committee For 'Supportive' Pitches In Pakistan's Favor



RAWALPINDI: Right-arm spinner Sajid Khan lauded the new selection committee for making a spin-friendly pitch for the third Test between Pakistan and England, underway here at Pindi Cricket Stadium.

Sajid once again troubled the English batters with his mastery of spin and claimed a six-wicket haul, helping Pakistan to book England on 267 despite wicketkeeper batter Jamie Smith's 89-run knock.

The right-arm spinner reflected on the eventful day, which saw 13 wickets fall as Pakistan got to 73/3 in response to England's 267.

He claimed that the pitch at the Pindi Cricket Stadium is different to that of Multan, explaining that he used variations and utilized the crease to take six wickets. "This pitch is different [to that of Multan]. After 25-30 overs, when the ball softens, we used to get something there [on the previous surface] by hitting the patches but we do not get it on this pitch," said Sajid.

"Some deliveries were bowled well and they played a few bad shots," he added. "So, the wicket is not like that as if one hits a certain patch and would benefit immediately. So, I varied the pace and utilized the crease and it helped me to take wickets." Sajid also shared his experience of bowling long spells alongside Noman Ali, stating the latter is well-experienced and guides him. "Noman Ali is very experienced. I enjoy bowling with him a lot. He always guides me during my spells and it's a wonderful feeling to bowl alongside him," said Sajid.—Agency

Former Pakistani Cricketer Slams ICC For 'Blatantly Biased' Pitch Ratings In Explosive Rant



LAHORE: Former Pakistan cricketer and renowned spinner Saad Ajeem has shed light on the development of spinners and their performance in international cricket.

In an exclusive interview with a local sports platform, Ajeem, famous for his mastery over spin bowling, pointed out that most successful spinners tend to be over the age of 30, as that's when they truly mature and reach their peak.

"Spinners are typically played after 30 when they've lost some of their initial edge. A spinner starts to mature after 25, but it's after 30 that they truly understand their skills and begin performing at their best," Ajeem explained.

He further emphasized that spinners need experience, particularly in first-class cricket, to learn the spin on flat tracks, but that on spin or flat tracks, but not when teams face similar conditions in India, Australia, or England," he concluded.—Agency

Bugti Community Protests For Justice In Sanghar

Reports indicate that Nazir Muhammad remains at large, openly issuing threats of violence and death, creating an atmosphere of fear and uncertainty.

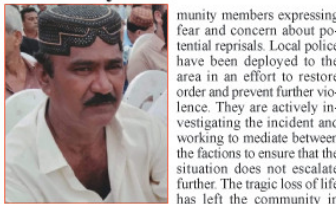

They discussed potential Public-Private Partnership (PPP) options for the project and the CM's team will explore the feasibility of this proposal.

The meeting, attended by various officials, outlined the plan for a 306-kilometer, six-lane, access-controlled motorway aimed at enhancing transportation efficiency and safety. Previously, a PPP agreement was signed in December 2022, but the project stalled, leading to its cancellation. Minister Khan suggested the revised route to accommodate port traffic, which the CM approved.

Maid Caught Stealing Rs13 Million Worth Of Valuables In DHA Karachi

KARACHI: A domestic worker in Karachi's Defence area fled with valuables, including cash, foreign currency, and gold, amounting to Rs13 million, local media reported on Thursday, citing police sources.

The maid, who had been employed only 20 days earlier, stole Rs2 million in cash, \$10,000, and 32 tolas of gold from her employer's home. Authorities revealed that the worker had used fake identification when she was hired. The police have launched an investigation, obtaining CCTV footage of the maid's escape and assuring the public that efforts are underway to apprehend her and recover the stolen items.

Brazen Daylight Robbery: Woman's Gold Chain Snatched In Karachi

KARACHI: Armed robbers, disguised in office attire, snatched a gold chain from a woman in Karachi's Yaseenabad area in a brazen 20-second robbery, according to CCTV footage obtained by the media.

The incident took place on October 21, with the footage showing the criminals passing through the street on a motorcycle before circling back and targeting the woman. One of the robbers, seated on the back, instructed the woman to remove her chain. When she hesitated, the robber dismounted, subtly keeping a pistol concealed.

SHO Mumtaz Marwat Unmasks Drug Smuggling Racket



KARACHI: Under the directives of Additional IG Karachi Javed Alam Odho and the supervision of DIG East Captain (Retd) Azfar Mahesar, Shah Latif Police, led by Mumtaz Marwat, uncovered an inter-provincial drug trafficking network following a tip-off. SHO Shah Latif, Mumtaz Marwat, reported the arrest of two women along with the most wanted suspects he added brought to Karachi via secret routes. Upon receiving the intelligence, the police acted swiftly to apprehend the suspects and recover the drugs. SHO Mumtaz Marwat revealed that the arrested individuals were involved in supplying and selling drugs in various secret locations in Karachi and interior Sindh. The police are currently checking the criminal records of the suspects. Cases have been registered against them, and further investigations are underway.

Man Who Sold Wife's Jewelry For Daughter's Treatment Brutally Killed By Karachi Street Criminals

KARACHI: In a tragic incident, a man was fatally shot during a mugging in the SITE-Superhighway Industrial Area, as he returned home after selling his wife's jewelry to pay for his daughter's medical treatment, media reported Thursday.

The victim, Farhan, who worked at a pharmaceutical company, had been facing financial hardship due to his daughter's illness, according to his family.

He was shot three times by the assailants who robbed him, and no arrests have been made. His father-in-law revealed that the police had yet to file a case, and the family was only contacted to visit the police station after the incident, which occurred on Tuesday. The murder comes just days after Karachi's Police Chief, Javed Alam Odho, claimed that street crimes had decreased by 50% in the first quarter of 2024. Despite this, deaths linked to street crimes in the city have exceeded 100 this year. In a separate incident, a man named Umar was shot and killed in the Defence area near Mubarak Mosque in what police suspect to be a case of personal enmity. Umar was waiting in his car

IHC Orders Imran To Be Brought To Court Today, Directs Adiala Jail

ISLAMABAD: The Islamabad High Court (IHC) on Thursday ordered the Adiala jail administration to present the incarcerated Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan before the court today at 3pm.

"Bring the PTI founder, he will have a meeting with his lawyers," said the IHC during the hearing of a contempt of court case against the Adiala jail superintendent for not allowing the lawyers to meet the ex-PM.

The development comes as the jailed politician has been behind bars at the Adiala facility for more than a year due to being embroiled in a plethora of legal cases — of which only one remains, i.e., the New Toshkhana security relating to alleged illegal sale of state gifts.

Khan, along with his wife Bushra Bibi were arrested in the said case soon after their acquittal in the Iddat case — also known as the un-Islamic nikah case.



The incarcerated former premier had appeared before the Supreme Court via a video link in the National Accountability Bureau (NAB) amendments case in May.

IHC's orders come against the backdrop of the party's ongoing strenuous efforts to secure its founder's release.

Apart from PTI's demand for Khan's freedom, more than 60 members of the United States House of Representatives have also written a letter to President Joe Biden seeking the ex-PM's release.

In their letter, the Democratic lawmakers urged President Biden to prioritise human rights in US policy towards Pakistan.

"We write today to urge you to use the United States' substantial leverage with Pakistan's government to secure the release of political prisoners including former Prime Minister Khan and curtail widespread human rights abuses," the lawmakers said.

During the hearing today, Justice Sardar Ejaz Ishaq Khan said that the Adiala superintendent will have to

present reasons if he fails to ensure Khan's presence before the court.

"The court does not accept the security threats [...] the lawyers were not allowed to meet, this is contempt of the court," remarked Justice Ishaq while directing the jail official to provide the Interior Ministry's report and explain what precise threats were there.

The judge also said that reasons will have to be given and the court will have to be satisfied as to what exact threats existed if the PTI founder is not presented before the court.

During the course of the proceedings of the case filed by Advocate Faisal Chaudhry, the applicant's lawyer stated that Khan's lawyers have not been able to meet him since October 3.

"If we go to jail, are there any security threats from us?" he questioned.

In response, the state counsel informed the court

that the Punjab government has proposed a ban on meetings inside the jail facility due to concerns related to the law and order situation.

"Is there a ban on lawyers meeting him? If the Punjab government has prohibited the meeting of the lawyers, it would have committed contempt of court; whoever issued this notification has also committed contempt of court," remarked the court.

In response to the additional attorney general's objection to the court's initial instructions directing the Adiala jail superintendent to facilitate a meeting between Khan and his lawyer via a video link, the court then ordered the authorities to present the PTI founder before the court instead.

The court also summoned the joint secretary of the Interior Ministry along with the relevant records and issued a notice to the attorney general's office to assist the court. —RT/Agency

US Lawmakers Urge Biden To Demand Imran's Release From Prison

WASHINGTON: Around 60 Democratic lawmakers from the US House of Representatives have written to President Joe Biden urging him to pressure Pakistan into releasing Imran Khan, the jailed founding chairman of the Pakistan Tehreek-e-Insaf (PTI).

"We write today to urge you to use the United States' substantial leverage with Pakistan's government to secure the release of political prisoners including former Prime Minister Khan and curtail widespread human rights abuses," the lawmakers wrote in a letter on Wednesday.

US Representative Greg Casar, who led the letter, said it marked the first such collective call from multiple members of the US Congress for the release of Khan, who otherwise has had tenuous relations with Washington as a long standing critic of US foreign policy.

Imran has been in jail since August 2023 and has faced dozens of cases after he was removed from the prime minister's position in April 2022 through a parliamentary vote of no confidence. His party has said that the more than 200 cases are politically motivated.

He has been acquitted or



granted bails in most of the cases filed against him.

The pending cases against him mostly pertain to the May 9 violence. Khan has denied responsibility and has been acquitted or granted bail in many of those cases.

He also faced the 190 million pound Al Qadir v. v. land corruption case. Foreign Office Challenges OHCHR's Claims On Constitutional Amendment

ISLAMABAD: The Foreign Office of Pakistan rejected a statement made by the High Commissioner for Human Rights (OHCHR) regarding the 26th constitutional amendment, labelling it as based on inaccurate information, as reported by Radio Pakistan.

Foreign Office Spokesperson Mumtaz Zahra Baloch addressed the media during a weekly briefing in Islamabad, asserting that the High Commissioner had drawn unwarranted conclusions from media reports, social media posts, and politically motivated speculative analysis.

She urged the OHCHR to focus on the actual and severe human rights violations occurring globally, where international human rights standards have been rendered ineffective or where draconian laws have been enacted to oppress occupied peoples.

When asked about the recent blacklisting of approximately two dozen companies by the United States, the spokesperson described the action as biased and politically motivated. She noted that similar listings in the past were based on mere suspi-



tion.

The spokesperson pointed out that the items involved were not listed under the export control regime but were categorised as sensitive under broad catch-all provisions.

Baloch stressed that some countries while professing strict adherence to non-proliferation norms, have conveniently waived licensing requirements for advanced military technologies to favoured nations.

She argued that such double standards and discriminatory practices undermine the credibility of global non-proliferation regimes, increase military asymmetries, and jeopardise international peace and security.

The spokesperson also confirmed that Prime Minister Shehbaz Sharif had written to US President Joe Biden, requesting consideration of Dr Aafia Siddiqui's mercy petition on humanitarian grounds. She stated that Pakistan has been in contact with the US to provide all possible support for Dr Siddiqui's welfare.

Responding to questions regarding the Kashmir issue, Baloch reiterated that Pakistan has never accepted the validity of the Indian constitution in Indian illegally occupied Jammu and Kashmir. She affirmed that the people of Jammu and Kashmir should decide their future based on UN Security Council resolutions. —RT/Agency

LAHORE: Jamaat-e-Islami (JI) Emir Hafiz Naeem Rehman to challenge the 26th constitutional amendment in the court.

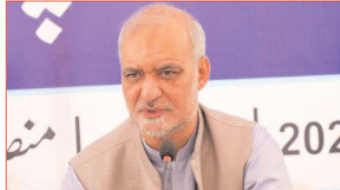
He was talking to media in Lahore on Thursday.
