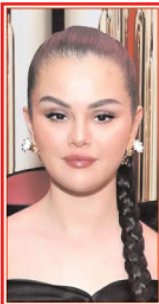

## Justice Yahya Afridi Becomes Pakistan's 30th Chief Justice

ISLAMABAD: Justice Yahya Afridi was sworn as Pakistan's 30th chief justice on Saturday, succeeding Justice Qazi Faez Isa as the country's top judge.



President Asif Ali Zardari administered oath to the newly-appointed top judge in a prestigious ceremony at the Aiwan-e-Sadr. The new CJP will serve the post for a fixed three-year term.

Justice Afridi has succeeded former CJP Isa, who retired and relinquished charge as the top judge yesterday (October 25).

The top judge is the first to be appointed following new rules for selecting a chief justice, introduced through the 26th Constitutional Amendment passed by the government last week.

The oath-taking ceremony was attended by Prime Minister Shehbaz Sharif and heads of the tri-services, including Chief of Army Staff General Asim Munir.

Moreover, Supreme Court

judges, including Justice Athar Minallah and Justice Aisha Malik, former CJP Iftikhar Chaudhry, Punjab Chief Minister Maryam Nawaz, Governor Sardar Saleem Haider, Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur and Governor Faisal Karim Kundi, alongside parliamentarians were also in attendance.

The committee, formed under Section 2(1) of the Supreme Court (Practice and Procedure) Act, 2023, which is responsible for fixing

cases, has been reconstituted. Justice Afridi is now the head, while its members include Justices Mansoor Ali Shah and Munib Akhtar.

Meanwhile, the Supreme Judicial Council has also been reconstituted following the appointment of the new chief justice.

The top judge has also assumed the role of chairman of the council, with Justices Shah and Akhtar as members of the body, along with the two most senior CJs from the high courts.—RT/Agency

## Iran Vows Retaliation After Israeli Airstrikes Target Military Sites, Leaving Two Soldiers Dead

TEHRAN: Foreign Minister Abbas Araghchi said Saturday that Iran was determined to defend itself after Israeli warplanes struck military bases and missile sites in several Iranian provinces, killing two soldiers.

"I think we've shown that our determination to defend ourselves knows no limits," Araghchi said in an interview with the official website of supreme leader Ayatollah Ali Khamenei.

The minister's comments were the first by a senior Iranian official since the pre-dawn strikes.

Israel had vowed to retaliate after October 1, when Iran fired around 200 missiles in its second ever direct attack against its arch-foe.

In April, in its first direct assault against Israeli territory, Iran launched more than 300 drones and mis-



siles.

Tehran said that barrage was retaliation for a strike on Iran's consular annex in Damascus that killed commanders of its Islamic Revolutionary Guard Corps.

"We will defend our territory and our homeland," Araghchi said. "I think everyone has already seen that."

Iran's official IRNA news agency quoted the For-

Iranian air defense command announced on Saturday that Israeli airstrikes on military centers in Tehran, the western province of Ilam, and the southwest province of Khuzestan were intercepted and successfully countered.

According to a report by the news agency, the air defense system intercepted and countered these attacks.

"The Zionist regime's continued occupation, illegal actions, and crimes—particularly the genocide of the Palestinian people and aggression against Lebanon, sustained by the comprehensive support of the United States and other Western countries—are the primary causes of tension and insecurity in the region," the statement added.

The Middle East has been on edge in anticipation

of Israeli retaliation for a ballistic missile barrage carried out by Iran on October 1, in which around 200 ballistic missiles were fired at Israel. Iran's second direct attack on Israel in six months.

"In response to months of continuous attacks from the regime in Iran against the State of Israel—right now the Israel Defense Forces is conducting precise strikes on military targets in Iran," the Israel Defense Forces said in a statement.

Meanwhile, in its statement, Pakistan said that Israel bears full responsibility for the current cycle of escalation and expansion of the conflict. The press release called on the world to play its role in restoring regional peace and security.—RT/Agency

## Dastardly Suicide Attack In North Waziristan Claims Six Lives, Including Four Police Officers

N WAZIRISTAN: At least six people including four cops were martyred and several others were injured in a "suicide bombing" in North Waziristan, police said on Saturday.



The law enforcers said that the attack targeted a police post in Eidak area of Mir Ali. Four of the slain individuals were police personnel, they added.

The injured were shifted to hospital after a rescue operation was launched. Meanwhile, the area was cordoned off by the security forces.

Pakistan has experienced a spike in terrorism since the Taliban returned to power in Afghanistan in 2021. Most terror incidents are reported in provinces bordering the neighbouring country—Khyber Pakhtunkhwa and Balochistan.

Around a dozen militants were eliminated during anti-terrorism operations by the security forces in KP's Dis-

trict North Waziristan this month, as the military strives to deal with the menace of terrorism in the country.

A report published by the Centre for Research and Security Studies (CRSS) earlier this month stated that the third quarter of 2024 saw a sharp increase in fatalities of terrorist violence and counter-terrorism campaigns with a 90% surge in violence in the country.

The total fatalities from three quarters of this year surpassed the total fatalities recorded for the entire 2023,

## Zain Qureshi Steps Down As PTI's Deputy Leader Amidst Loyalty Probe



ISLAMABAD: PTI MNA Zain Qureshi stepped down on Saturday as the party's deputy parliamentary leader amid an internal inquiry on the loyalty of certain lawmakers.

Earlier this week, the PTI decided to take legal action against its lawmakers who had voted in favour of the 26th Constitutional Amendment in clear violation of the party policy.

Zain, the son of former PTI vice chairman Shah Mahmood Qureshi, denied reports at the time that he was present on the premises of parliament at the time of the amendment's passage. He claimed that he was underground as per the instructions of his father.

According to the PTI, the party was unable to contact

him. Zain was issued a show-cause notice on Tuesday.

In a post on X today, he announced: "Based on my belief for a free and transparent inquiry and in recognition of the sentiment of our party supporters, I am resigning from my role as deputy parliamentary leader. I do so until and unless I have the confidence and trust of my party and our founding chairman, Imran Khan."

Zain added that in the "interest of public transparency for all PTI supporters", he had formally replied to his show-cause notice and provided a comprehensive account.

"I was, am and will remain faithful to my party, to my leader Imran Khan and to my father and all that he stands for."—RT/Agency

## PTI Leaders Blocked Meetings With Imran Khan, Faisal Vawda Confirms

ISLAMABAD: Senator Faisal Vawda has said that the ban on Pakistan Tehreek-e-Insaf leaders meeting with party's founding chairman Imran Khan was imposed at the request of the PTI leaders themselves.

In a special discussion on a private channel, Senator Vawda said that the meeting was not intended to take place because the PTI leadership advised against seeking permission for it, saying, "When he (Imran Khan) tells us to come out, it becomes difficult for us."

He added that the PTI members had summoned a letter from 62 US senators, which further widened the gap between Imran Khan and the establishment.

He claimed that they had pushed Imran Khan and his politics into oblivion.

When asked about the deal under which Bushra Bibi was released, Senator Vawda remarked that if her release wasn't under a deal, then how could there have been weeks of renovation at Bani Gala? He noted that trees had been planted and cleaning had taken place. However, Vawda did not provide details about the alleged deal.



He mentioned that it is unclear when Imran Khan will be released, as no one knows what cases are pending against him.

The Senator went on to say that General (R) Faiz Hamid was implicated in multiple issues, including the events of May 9 and the murder of Arshad Sharif, and predicted that there will be a court martial for Faiz Hamid, leading to his conviction. He raised a question about why Murad Saeed, a minister under Imran Khan, has been absent from the Arshad Sharif murder case, asserting that he hasn't been seen in two years.

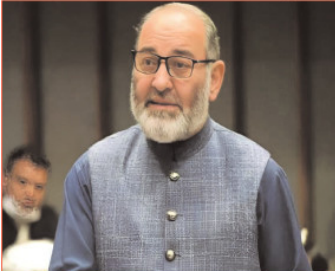
In response to a question, Faisal Vawda noted that he had mentioned the 27th amendment before the 26th amendment. He stated that

after the 27th, more amendments, including the 28th, would follow.

On the social media platform X, Vawda wrote that he had announced the previous day that Bushra Bibi would be released, expressing gratitude that he does not make baseless claims. He claimed there are no new cases against Bushra Bibi and that her vehicle was allowed to enter VIP style. As I mentioned, the founder of PTI will also meet with lawyers today, and regular meetings will commence in jail from October 26. He assured the nation that he would not hide anything. He noted that many of the founder's companions and those close to him have abandoned him, throwing him into the fires of hell.—RT/Agency

## Ex-Senator Mushtaq Faces Terrorism Charges For Leading Gaza March To US Embassy

ISLAMABAD: A terrorism case has been registered against former Senator Mushtaq Ahmed for organising a march towards the US Embassy in support of Gaza.



The case was filed at Islamabad's Aabpara Police Station against Mushtaq Ahmed, a former Senator and leader of Jamaat-e-Islami, media reported.

He had called for a march from Aabpara to the US Embassy as part of the "Save Gaza" campaign to show solidarity with the people of Gaza.

The case text further states that stones thrown by the protesters broke the windows of six public and two government vehicles. Some protesters also allegedly snatched an anti-riot kit and helmet from Constable Zafarullah.

Last month police detained former Mushtaq Ahmed, along with his wife, son, and over two dozen protesters, during a march expressing solidarity with Gaza.

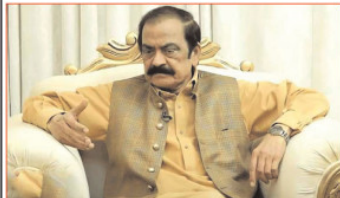
The ex-senator had called on the public to gather at Express Chowk, an entry point to Islam-

abad's Red Zone from the D-Chowk side.

In response, the Islamabad administration enforced Section 144 of the Criminal Procedure Code, prohibiting all gatherings, and warned that violators would face legal repercussions.

The capital police reported that individuals defying the ban were detained from areas such as Express Chowk, China Chowk, Embassy Road, and Serena Chowk, and later moved to police stations including Secretariat, Kohsar, and Shalimar.—RT/Agency

## 26th Amendment Has Closed The Door On Political Power Manipulation: Rana Sanaullah



LAHORE: Prime minister's political adviser Rana Sanaullah said on Saturday the 26th amendment would help prevent coming into power through backdoor.

Speaking to media in Lahore, he said the PML-N had always worked for the betterment of the state.

"Pakistan is out of crisis and political and economic stability would be achieved soon," he added.

He also gave the credit of ending terrorism and energy crisis to his party and said the PML-N had always played a positive role in national development.

As for the constitutional amendment, he said the 26th amendment gave the hope that no one would be able to hold the reins of power in Pakistan through backdoors.—RT/Agency

20 targets including Tehran, Shiraz and Kurd.

The Israeli forces attacked missiles manufacturing and other defence systems sites of Iran.

**Protests erupt in Ghotki against transfer of SHO Barkat Ali Bhatti**

The agriculture sector plays a crucial role in Pakistan's economy, contributing 21% to GDP and employing 44% of the labor force. However, the sector's productivity lags behind global and regional standards. Experts believe that Pakistan can enhance agricultural output both vertically (increasing yields) and horizontally (expanding cultivated land), with the potential to double the current cultivable area of 9.4 million acres of wasteland.

Despite possessing fertile soil and an established irrigation system, Pakistan struggles to utilize its agricultural potential effectively. Challenges include market inefficiencies, inadequate public

policy, limited research and development, restricted credit access, and inefficient resource management.

Sindh province, with its favorable climate, can grow various crops, including wheat, rice, cotton, sugarcane, and fruits like mango and citrus. Developing cultivable wastelands presents opportunities for increased production. Currently, Pakistan spends approximately \$1.9 billion annually on importing food items, indicating a significant domestic market opportunity and potential for exports.

In response to these challenges, the Government of Pakistan introduced Corporate Agriculture Farming (CAF) in 2001-2002. The policy aims to enhance effi-

ciency, expand cultivation, and attract investment and technology, ultimately boosting revenue and exports. Corporate agriculture involves large-scale food production integrated with processing and marketing. This model contrasts with family farming, as it encompasses a broader range of agricultural service. The transition to corporate agriculture could transform Pakistan's agricultural landscape, addressing food security and sovereignty challenges while boosting economic growth. By fostering partnerships with foreign corporations and investing in local labor and technology, Pakistan can unlock its agricultural potential and enhance its global market position.

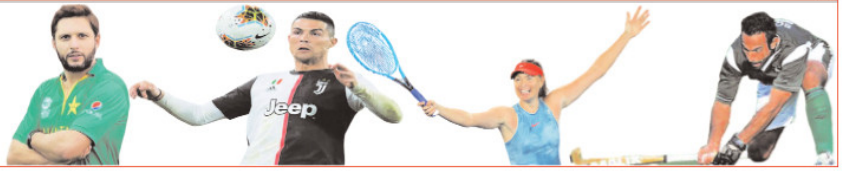

RAWALPINDI: Pakistan's rawlings outclassed England's batting lineup on Saturday, sealing a 2-1 victory in the three-match Test series and marking a long-awaited home triumph.

The Green Shirts had been on the ascendancy since claiming a handy first-innings lead of 77 on a track where spinners from both sides dominated.



Noman Ali (6-42) and Sajid Khan (4-69) bundled out England for a paltry 112 in their second innings to leave Pakistan needing only 36 to win the series.

Pakistan lost the wicket of Saim Ayub before wrapping up victory on day three of the contest.

Resuming their second innings at 24-3, England collapsed against Pakistan's (23\*) sealing the win to clinch the three-match series. During the match, Noman and Sajid claimed 19 of the 20 English wickets while Pakistan did not use their lone seamer Amir Jamal at all in the match in a stark indication of how spin-friendly the surface was. "Like London buses, they come to-

gether," said Masood while referring to their back-to-back wins in the series. "The first win came after a long time and it was backed up by a series win. It's special," he remarked. "To be here and standing as the winning team, it's the most special thing for us [...] So many characters in this series and everyone has chipped in," added the captain. Sajid, who finished with a 10-wicket match haul, was adjudged player of the series. He and Noman claimed 39 of the 40 English wickets in the last two Tests since their selection after the series opener. Meanwhile, Pakistan's Saud Shakeel was adjudged player of the match for hitting the lone hundred in the spin-dominated contest.—Agency

RAWALPINDI: Pakistan captain Shan Masood on Saturday heaped praise on his colleagues saying the national side showed tremendous character to register back-to-back victories against England and win their first Test series on home soil since 2021.



Coming from an innings defeat in the series opener, Pakistan levelled the series in Multan before arriving in Rawalpindi where they rolled out a raging turner.

For Pakistan, spin twins Noman Ali and Sajid Khan claimed 19 of the 20 English wickets to secure a nine-

duo of Naseem Shah and Shaheen Afridi. Sajid and Noman were brought in and the duo claimed 39 of the 40 English wickets in the last two Tests, apart from producing useful cameos with the bat, to vindicate the move.

Sajid with his chin while batting on Friday and had to change his bloodied shirt but returned on Saturday to spin a web around the English batters. "For everyone to stand up and give their best means a lot," said Shan, who sealed Pakistan's victory with a six off England spinner Shoaib Bashir.—Agency

## Nasser Hussain Lauds Pakistan's Tactics, Declares 'Bazball Kryptonite' Discovered



Former England captain Nasser Hussain has commended Pakistan for their impressive performance during their recent series triumph over England, declaring that the team has "found the kryptonite to Bazball." Hussain's remarks come in the wake of England's disappointing nine-wicket defeat, which occurred before lunch on the third day of the decisive Test match, where they were bowled out for a mere 112 runs.

"Pakistan clinched victory in a swift 19 balls, with captain Shan Masood hitting a spectacular six to seal the win. This decisive outcome followed England's remarkable first Test performance, where they posted a colossal score of 823 for seven declared on a flat Multan pitch. However, the team struggled on the spinning tracks in the latter two Tests, leading to their series loss.

In his analysis on Sky Sports, the former England skipper praised Pakistan for making necessary changes following their six-match losing streak, a period that included Masood's challenging tenure as captain.

## India Stunned At Home, Loses Test Series To New Zealand For First Time In 12 Years

PUNE: India collapsed to a humiliating series defeat at home, their first for 12 years, when they were bowled out for 245 by New Zealand in their chase of 359 on the third day of the second test on Saturday as Mitchell Santner took six wickets.



Santner ended with 6-104 for a match haul of 13 to set up the historic win and it was his senior spin partner Ajaz Patel who picked up the last two Indian wickets, including Ravindra Jadeja for a defiant 42, to settle the contest.

It was a stunning defeat for India, who were dismantled by eight wickets in seamer-friendly conditions in the opening match at Bengaluru, as they suffered their first series loss on home soil since falling to England in 2012.

Their proud run of 18 successive home series wins since that 2-1 humbling was ended by the inspired Black Caps, who were by far the better side in both matches and will target a clean sweep in the finale at Mumbai from Friday.

India's highest successful run chase at home is the 387-4 they scored to beat England in Chennai in 2008 but any hopes of a similar effort faded on the black-soil turner at Maharashtra Cricket Association Stadium where spinners wreaked havoc.

They made a blazing start as Yashvi Jaiswal snacked some spectacular boundaries, but his dismissal for 77 by Santner and Rishabh Pant's shocking run out for a duck after lunch left India in deep trouble at 127-4.

Santner, who had earlier removed Rohit Sharma for eight and Shubman Gill for 23, continued to torment India as the left-arm spinner trapped trump card Virat Kohli lbw for 17 and set the alarms blazing ringing in the home changing room.

Sarfraz Khan was unable to recreate his batting heroics from the opening match, perishing for nine after missing a low delivery from Santner to hand the bowler back-to-back five-wicket hauls.

The shoulders really dropped when Washington Sundar fell for 21 to Glenn Phillips late in the afternoon session and Santner had Ravichandran Ashwin caught for a solid 18 as India were staring down the barrel at 206-8.—Agency

## ATP Stunner: Ben Shelton Overthrows Andrey Rublev To Advance To Basel Semis

Sixth-seeded Ben Shelton won all eight break points in the match and emerged with a 7-5, 6-7 (3), 6-4 upset of top-seeded Russian Andrey Rublev in the quarterfinals of the Swiss Indoors Basel.



Shelton saved all six break points he faced and converted each of his two break chances -- one to end the first set, the other for a 5-4 lead in the third set. He closed out the match with a service-game win at love.

Next up for Shelton is a semifinal match against seventh-seeded Arthur Fils of France, who beat third-seeded Stefanos Tsitsipas of Greece 7-6 (5), 6-3. Fils never faced a break point in the match.

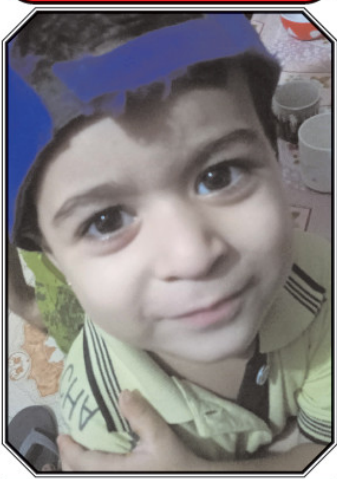

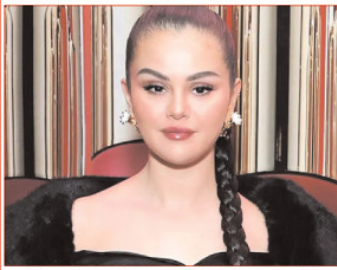

The protesters claimed that the Jhol police demanded a hefty bribe for his release, questioning how poor individuals like them could afford such amounts. They further alleged that the police subjected Chandar to brutal torture. The community members called on high-ranking officials, including the IG Sindh, DIG Hyderabad, SSP Sanghar, and SSP Tando Allahyar, to release Chandar Kachhi, dismiss the false charges against him, and ensure justice for the minority community. They warned that if their demands were not met, they would escalate their protest.

## Report In Dr. Shahnawaz's Murder Case Investigation Released

MIRPURKHAS: In Mirpurkhas, the complete investigation report of the Dr. Shahnawaz Kumbhar murder case, compiled by the IG Sindh, has been made public. The report includes statements from 21 police officers, 3 senior officers, 4 hotel staff, and relatives of Dr. Shahnawaz. Among the officers interviewed are former DIG Javed Sonharo Jiskani, former SSP Mirpurkhas Chaudhry Asad Ali, and former SSP Umerkot Asif Raza Baloch. During the report's release, many people gathered with flowers, indicating they came to congratulate the SHO Sindhri, according to Javed Jiskani's statement. Dr. Shahnawaz Kumbhar was reportedly set on fire by individuals in Umerkot and was subsequently placed under the protection of Mirpurkhas police.

The SSP Umerkot stated that this transfer was for his safety. Sub-Inspector Abdul Sattar Samo mentioned that Dr. Shahnawaz was arrested from a hotel in Karachi and handed over to Mirpurkhas police upon the orders of the SHO Sindhri. The SHO Sindhri stated that while they were checking at a stop near Sindhri, two individuals on a motorcycle attempted to flee. The police, which led to Dr. Shahnawaz being shot due to crossfire. The committee report formed by the IG Sindh has already led the Sindh government to declare the police encounter as fake. The family has also filed a murder case against the police. The Sindh High Court in Mirpurkhas rejected petitions from the police and Pir Umar Jan Sarhandi to dismiss the FIR filed by the family, thus maintaining the FIR. The High Court has ordered the investigation to be handed over to the FIA, revoking the police's jurisdiction. A post-mortem report conducted after exhuming Dr. Shahnawaz's body revealed broken bones in his shoulder and five fractured ribs. Additionally, the report indicated burns on his skin, hair, feet, and both hands. In this case, Pir Umar Jan Sarhandi, SSP Asif Raza Baloch, and CIA officials have been granted interim bail.

During a meeting at CM House with provincial ministers and officials, Shah emphasized the need for modernizing Karachi's public transport system, which is struggling to cope with the city's growing population and outdated vehicles. Transport Minister Sharjeel Memon high-

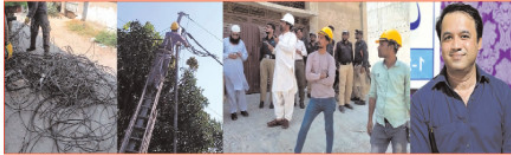


lighted the initiative to enhance urban mobility, improve the commuter experience, and reduce air pollution. In addition to the electric buses, the meeting discussed procuring 300 elec-

tric and diesel-hybrid buses for intercity transportation to connect divisional headquarters. Shah stressed the importance of providing cost-effective and safe transport options to the public.

The Chief Minister also addressed the Yellow Line BRT project, which aims to establish a 21-kilometer corridor from Dawood Chowrangi to Numaish, and directed that feasibility studies for this and other initiatives be completed by the end of November. Further, Shah reviewed the West Karachi Recycled Water Project, which will treat wastewater for industrial use, and the TP-4 wastewater treatment project, both of which are in various stages of planning and funding. Additionally, he discussed the potential of coal gasification technology to address energy needs and directed the Energy Department to develop a project proposal. The meeting concluded with plans to explore advanced agricultural technologies to improve farming in arid regions of Sindh.—RT

## Visitation Ban Lifted At Adiala Jail For Prisoners

The restriction, initially imposed on October 4, was implemented due to heightened security concerns following a potential terrorist threat and subsequent drills at the facility.

Adiala jail authorities where Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan is currently detained, had extended the restriction on all visits until October 25.

This is the same facility



where Khan's wife, Bushra Bibi, was held until her release on bail two days ago, per Islamabad High Court (IHC) orders.

With the ban now lifted, sources state that all prisoners, including high-profile individuals, may again receive visitors.

The visitation ban had stirred discontent within the IHC.—RT/Agency

## SPLA stresses need for STR implementation, promotions in college education

KARACHI: In Karachi, members of the Sindh Professors and Lecturers Association (SPLA) have raised serious concerns regarding the lack of attention to the issues faced by college educators. They highlighted that the Student-Teacher Ratio (STR) needs to be improved to enhance educational quality and to implement the Sindh government's policy of education for all. According to

the association's senior leaders, including Professor Kareem Ahmed Narejo and Professor Aziz Memon, there has been no progress on the promotions for Assistant Professors for over two years, leading many educators to retire after only one promotion. Despite the working papers for promotions being prepared six months ago, delays caused by certain officials in the College Education Department have prevented these cases from being sent to the Provincial Selection Board. The SPLA leaders expressed their disappointment over the prolonged stagnation in the careers of lecturers, particularly female lecturers and Physical Education Directors, who have been waiting for promotions since their appointments in 2012. They stressed the need for immediate action to prevent further frustration among educators, which negatively impacts their teaching performance.

## Sindh CM: No Deal Behind Release Of Bushra Bibi And Imran Khan's Sisters



KARACHI: Sindh Chief Minister Murad Ali Shah stated on Saturday that he does not view the release of former first lady Bushra Bibi and Imran Khan's sisters, Aleema and Uzma Khan, as part of any deal. In a media briefing, he emphasized that politicians should not interfere in judicial matters and acknowledge the right to peaceful protest, provided it follows proper procedure. Regarding the recent clash between Sindh police and Rawadadi March organizers, he confirmed receipt of an inquiry report and insisted that anyone who broke the law must be held accountable, noting that police are in a difficult position that necessitates action.—RT

## Maryam Aurangzeb: Eliminating Smog In Lahore Will Take 8 to 10 Years

LAHORE: Punjab's Senior Minister Maryam Aurangzeb has addressed the issue of air pollution in Lahore, urging citizens to take action against smog. She emphasized that despite significant measures, it would take eight to ten years to eliminate smog from the city. In a press conference regarding the Anti-Smog Action Plan, Aurangzeb highlighted that certain hotspots in Lahore are plagued by methane clouds and heat islands.

She mentioned that out of 45,000 motorcycles in the city, 1,800 are emitting smoke, along with one hundred thousand vehicles, 1,200 kilns, and 60,800 industrial units all while the city supports a population of 15 million. Aurangzeb pointed out that Lahore has 275 days of unhealthy Air Quality Index (AQI) levels throughout the year, with temperatures rising by 3.2 degrees Celsius. She called on Lahore's residents to declare war against smog, acknowledging that individual and collective efforts would still require 8 to 10 years to see results.

She clarified that only 30% of the smog in Lahore originates from India, while the remaining 70% is produced locally.

The senior minister also noted that Chief Minister Maryam Nawaz has been implementing a multi-sector mitigation action plan for the past six months, with regulations and awareness campaigns underway.

She revealed that 700 kilns have been demolished in the province, with 212 in Lahore alone, emphasizing a zero-tolerance policy towards emissions. The Environmental Protection Department has conducted 15,000 visits to industrial units, sealing 64 mills and demolishing 152 factories.

To combat pollution, the government is promoting efficient waste disposal practices among farmers and has filed over 400 FIRs against those burning crop residue. Targeted anti-smog squads are operating in affected areas, monitoring vehicle emissions, and ensuring



that no smoky vehicles enter Lahore without proper fitness certificates. The cabinet recently decided to clamp all smoke-emitting vehicles in Lahore, with efforts being made to enhance the capacity of the Environmental Protection Agency.—RT/Agency

## CJP Afridi Reshapes Judges Committee On His First Day To Restore Justice Akhtar

ISLAMABAD: Newly-appointed Chief Justice of Pakistan (CJP) Yahya Afridi on Saturday reconstituted the SC Practice and Procedure Committee, bringing back Justice Munib Akhtar to the three-member key panel established for the purpose of fixing cases and forming benches.

The development comes hours after Justice Afridi was sworn in as Pakistan's 30th chief justice earlier today, succeeding Justice Qazi Faez Isa as the top judge.

According to a notification, the chief justice will head the special bench formed by the judges committee under the SC (Practice and Procedure) Act, 2023. He also included senior puisne judge Justice Mansoor Ali Shah and Justice Akhtar to the judges' committee.

On September 20, President Asif Ali Zardari approved the Supreme Court (Practice and Procedure) Amendment Ordinance 2024, allowing the CJP to pick any



Justice of the apex court to be the third member of the body.

Following Justice Akhtar's removal, Justice Shah wrote a letter to the secretary of the Supreme Court, expressing concerns over the ordinance.

Justice Mansoor, in his letter, noted that no reasons were given as to why the second senior most judge, Justice Akhtar, was removed from the composition of the committee. "Furthermore, no reasons were given why the next senior most judge was ignored and instead, the fourth senior most judge was nominated as a member of

the Committee." "Such unfortunate cherry picking and undemocratic display of one-man show are precisely what the Act tried to discourage and replace a stance that was upheld by the Full Court Bench of this Court in Raja Amer," he wrote.

Justice Shah had also refused to become a member of special bench, stating he was unable to participate in the bench over his concerns regarding amendments to the practice law via ordinance.

In his October 23 letter, the senior judge also made his participation in the special bench conditional, saying that "until the full court bench determined the constitutional validity of the promulgation of the ordinance as well as of the amendments made thereby or the judges of the SC resolve to act upon those amendments in a full court meeting pending adjudication upon the constitutionality thereof, or the earlier committee comprising

the HCJP and two senior most judges is restored, I will not participate in special benches formed by the new committee and will only attend sittings of the regular benches to hear the cases of ordinary litigants in the larger public interest."

Responding to Justice Shah's letter, then-CJP Isa had said legally he could not be asked about why he nominated a judge as the committee's third member. Still, the then chief justice had provided the reasons for his action, saying he did it because he "always advocated accountability and transparency".

Moreover, the Supreme Judicial Council (SJC) was also reconstituted with CJP Afridi becoming the chairman. Earlier, the newly-appointed top judge was not part of the SJC.

The council also includes Justice Mansoor, Justice Akhtar and chief justices of the high courts —RT/Agency

## 20 British MPs Urge Action For Imran's Release, Pressing UK Government

LONDON: As many as 20 British parliamentarians from cross-party have urged UK's Foreign Secretary David Lammy MP to call for Imran Khan's release from Adiala Jail and engage with the Pakistani government.

The letter has been written by Kim Johnson, MP for Liverpool Riverside, on Imran Khan's adviser on International Affairs Zulfi Bukhari's request and signed by members of both the Commons and the Lords, on all parties.

The signatories are Kim Johnson MP, Paula Barker MP, Ansana Begum MP, Liam Byrne MP, Rosie Duffield MP, Gill Furniss MP, Paulette Hamilton MP, Peter Lamb MP, Andy McDonald MP, Abtism Mohamed MP, Bell Ribeiro-Addy MP, Zarah Sultana MP, Steve Witherden MP, Nadia Whittome MP, Baroness Jane Bawell, Baroness Christine Blower, Lord Peter Hain, Lord John Henty and Lord Todenafel.

It says: "We are writing with grave concern about the continued detention of former Pakistani Prime Minister Imran Khan. As you will know, Mr Khan was imprisoned in 2023 in a move which the United Nations Working Group on Arbitrary Detention found had no legal basis and appears to have been intended to discourage him from running for political office. Thus, from the outset, that prosecution was not grounded in law and was reportedly instrumentalised for a political purpose."



The letter to Lammy said: "As a result, Mr Khan's ongoing detention represents a grave threat to democracy in the country. Indeed, there has been speculation that his fate will likely be decided by a military court, which would represent a worrying and completely illegal escalation. Following a recent review of Mr Khan's case, Amnesty International has found that there has been a 'pattern of weaponisation of the legal system to keep Imran Khan under detention and away from all political activity'."

They have also observed that in at least three trials Khan has not been allowed adequate time and facilities for the preparation of his defence. It has become apparent that the number of cases against the jailed PTI founder are now "consistent with a pattern of misuse of the justice system in Pakistan to intimidate, harass and target political opposition leaders — while inflicting upon the enshrined independence of the judiciary."

It further said the recently passed 26th Constitutional Amendment would take powers, such as banning po-

## IMF Predicts Pakistan's Inflation To Plummet To 10.6% by 2025

ISLAMABAD: The International Monetary Fund (IMF) projects that Pakistan's inflation rate, which dropped from 29% to 12.6% this year, will further decline to 10.6% by 2025, according to IMF's Director for the Middle East and Central Asia, Jihad Azour.

In a recent statement on Pakistan's economic outlook, Azour remarked that Pakistan's economy is expected to grow at a rate of 3.2% in the 2024-25 fiscal year, an improvement that signals economic recovery.

Azour emphasised that Pakistan's reform package aims to achieve several key objectives, including fiscal stability, increased revenue, and reduced deficits. He highlighted that improvements in tax collection and addressing systemic issues could boost Pakistan's revenue.

He also noted that reforms within state-owned enterprises remain a priority, which could open more opportunities for the private sector, attract foreign investment, and strengthen Pakistan's export potential.

The IMF official further explained that creating a favourable environment for additional investment in Pakistan is essential. Current fiscal policies, he said, are helping reduce inflationary



pressures and facilitate capital flows, easing the burden on Pakistan's current account.

Azour expressed optimism that these measures would stabilise the economy, mitigate financial risks, and enhance the energy sector.

Moreover, Pakistan is targeting around \$1 billion in a formal request for funding from the IMF facility that helps low and middle-income countries mitigate climate risk, Finance Minister Muhammad Aurang told Reuters.

"We have formally requested to be considered for this facility," the minister said in an interview on the sidelines of the IMF/World Bank autumn meetings in Washington.

The International Monetary Fund had already agreed to a \$7 billion bailout for

Pakistan but has further funding available via its Resilience and Sustainability Trust (RST). The RST, created in 2022, provides long-term concessional cash for climate-related spending, such as adaptation and transitioning to cleaner energy.

"We think we are a very good candidate to be considered for a facility like this," Aurangzeb said, adding that they aim to conclude the request, in all areas of mutual benefit.

Both the deputy prime ministers/foreign minister met on the sidelines of the Commonwealth Heads of Government Meeting (CHOGM) in Samoa, Foreign Office Spokesperson said in a press release.

The finance minister also thanked the Government of China for its unwavering support to Pakistan's socio-economic development and assistance in securing the IMF's Extended Fund Facility (EFF).

Muhammad Aurangzeb said that Pakistan is eager to learn from China's experience in economic reforms. He also welcomed Chinese automobile company BYD's decision to introduce electric vehicles in Pakistan.

The finance minister apprised the Chinese side that Pakistan aims to launch an inaugural Panda bond in the Chinese market to diversify its financing base.

He committed to providing foolproof security to Chinese workers. Shared that the majority of Chinese companies are interested in ex-



panding their investments and increasing employment opportunities in Pakistan.

## Hafiz Naeem: Israel, Backed By US, Aims To Ignite Regional War

KARACHI: Ameer Jama'at-e-Islami (JI), Hafiz Naeem ur Rehman, stated that Israel, with US support, is aiming to impose war on the entire region.

Responding to the Israeli airstrikes on Iran, Hafiz Naeem ur Rehman condemned the attacks, labelling them as highly reprehensible.

He asserted that Israel, under American patronage, seeks to drag the entire region into conflict.

In a statement shared on social media, the JI leader remarked that the airstrike on Iran reflects the expansionist mindset of an illegitimate state.

He added that since the establishment of the Zionist state, the Middle East has been plagued by instability and turmoil. To address this threat, Muslim countries must unite.

Israel conducted airstrikes on Iranian military sites early Saturday, escalating tensions between the rival nations after a recent Iranian missile strike.

Residents in Tehran reported multiple explosions during the night, with state-run media initially attributing the blasts to air defence systems. At least seven load



explosions shook the area, a Tehran resident said.

Following the strikes, Iran's civil aviation authority closed the country's airspace until further notice, with flight tracking data showing several civilian planes rerouting around Tehran.

Israel's military statement confirmed the airstrikes, calling them "precise" operations targeting Iranian military assets.

Saudi Arabia has condemned Israel's recent airstrikes on Iran, calling them a "violation of Iranian sovereignty" and a breach of international law.

In a statement, the Saudi Foreign Ministry de-

nounced the early-morning attacks as a "serious violation" of Iran's territorial integrity and a disregard for international norms.

The United Arab Emirates (UAE) and Qatar called for de-escalation, both emphasising diplomacy as the preferred path forward.

The UAE's Foreign Ministry also highlighted the importance of reducing tensions to maintain regional stability.

Syria's Foreign Ministry additionally expressed solidarity with Iran, affirming Iran's right to protect its territory and citizens amidst the escalation. —RT/Agency

ISLAMABAD: After the reduction in the RLNG consumption, Pakistan has formally asked Qatar for the reschedule of five LNG cargoes that are to be imported in the calendar year 2025, and now the country would get those in 2026 under the flexible clause, a senior official of Ministry of Energy told media. "However, authorities are also trying to firm up the plan to shelve import of 13 more LNG cargoes that are to arrive in Pakistan in 2025, or Qatar may halt the export of 13 cargoes to Pakistan," the official said. The official added: "The RLNG consumption has now started tumbling by 150 million cubic feet (MMCF) in a month, which means that the



have started brainstorming on how to tackle the issue of 13 cargoes, keeping in view the agreements. Pakistan imports 108 LNG cargoes from Qatar under two GIG agreements. The country, under the terms, imports nine LNG vessels a month (five cargoes a month under 13.37% of the Brent and 4 cargoes under 10.2% of the Brent). One cargo is imported through a term agreement with the ENI. This is how the country imports 10 LNG cargoes a month in toto. However, under the agreements, the official said, there is no clause under which 13 more cargoes could be halted by Qatar as a supplier or importer allows Pakistan to sell 13 cargoes in the open market. —RT/Agency
