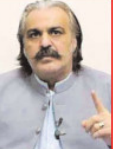

Tarar Doubts Imran's Freedom Despite Toshakhana Case Bail

ISLAMABAD: Information Minister Ataulah Tarar has said that PTI founder Imran Khan is unlikely to walk free despite securing bail in the new Toshakhana case. "There is no chance of the PTI founder's release," the information minister said while speaking to media on Wednesday. Tarar said that the case regarding the selling of state gifts was being heard in a trial court and that sufficient evidence was available against the PTI founder. "The trial is yet to be concluded," he added. He further noted that the "bail can be cancelled" in case of non-cooperation on Imran's part, particularly if he emulates his wife, Bushra Bibi, who has a history of such conduct. The information minister reiterated that case would continue for a long time. Addressing the possibilities of Imran Khan's release, Tarar said the PTI founder had not received bail in eight FIRs related to the May 9 mayhem when the party and its members targeted defence structures, in-



cluding monuments for the martyrs. "Release for him is not possible; there are many other cases he needs to secure bail in," he said while speaking to media. When asked about negotiations between the federal government and PTI leadership, Tarar questioned, "Even if there were negotiations, who would guarantee that PTI will remain peaceful?" citing the party's history of violating peaceful protest norms. The minister's remarks came following a major development ahead of the looming November 24 protest by Pakistan Tehreek-e-Insaf (PTI). The Islamabad High Court (IHC) on Wednesday approved the bail plea of party founder Imran Khan in the new Toshakhana case. Imran Secures Bail in Toshakhana Case Ahead Of PTI's Crucial Nov 24 Protest

RAWALPINDI: In a major development ahead of the looming November 24 protest by Pakistan Tehreek-e-Insaf (PTI), the Islamabad High Court (IHC) on Wednesday approved the bail plea of party founder Imran Khan in the new Toshakhana case. IHC's Justice Miangul Hassan Aurangzeb accepted Khan's bail plea against two surety bonds worth Rs1 million each, which must be submitted by separate guarantors. PTI founder is no longer wanted in any other case within Islamabad's jurisdiction following the latest development. Meanwhile, the IHC cautioned the ousted prime minister not to "misuse the concession of bail and appear before the trial court on each and every date of hearing unless a specific exemption is granted." The bail can be revoked if the petitioner [Imran] does not cooperate with the trial court, it added. Imran and his wife, Bushra Bibi, were arrested in the case on July 13, shortly after the husband-wife duo



was acquitted by a district and sessions court of Islamabad in the iddat case — also known as the un-Islamic nikah case. Bushra Bibi was released last month from jail in the Toshakhana 2.0 case after spending around nine months behind bars. The case was previously being heard by the National Accountability Bureau's (NAB) accountability court, however, it was transferred to the FIA in line with the Supreme Court's verdict restoring amendments to the anti-corruption laws. During the hearing, the FIA prosecutor voiced concerns over media narratives, claiming that reports had prematurely suggested the approval of bail. Justice Aurangzeb advised the prosecutor to disregard media speculation, emphasising that the court's decisions would not be influenced by such narratives. The judge remarked on certain claims made in the media, questioning their credibility. He also inquired about the valuation of a jewellery set, asking how its worth was determined. Barrister Salman Safdar, representing the PTI founder, responded that the prosecution was responsible for clarifying this matter in court. He also highlighted discrepancies in the receipts, noting that the receipts in question were issued in the name of Bushra Bibi, not the PTI founder. The defence argued that

the prosecution's case relied on testimonies from key witnesses such as Sohail Abbasi, who had been granted pardon and declared an approver in the case. Barrister Safdar clarified that Abbasi alleged threats from the PTI founder but denied any direct interaction with either the PTI founder or his wife. The court further asked whether customs officers involved in the valuation had mentioned any intimidation, to which the defence replied that no such claims had been made by these officials. The FIA prosecutor argued that the Bulgari jewellery set was not deposited in the Toshakhana and alleged that its undervaluation caused financial harm to the state. Justice Aurangzeb asked how the PTI founder benefited from the undervaluation, to which the prosecutor responded that his wife's gain inherently benefited him as well. Justice Aurangzeb dismissed this logic, questioning such assumptions. "My wife's things are not mine. I don't know what year are we living in." Barrister Safdar defended his client by stating that all gifts were acquired under the Toshakhana policy of 2018, and the valuation was conducted according to the law. He added that payments were made as per the policy, and no wrongdoing was evident. Justice Aurangzeb noted that the previous government had withheld Toshakhana details, despite inquiries from the court. The prosecution highlighted the conduct of the accused during trial proceedings, alleging legal tactics. The FIA prosecutor presented evidence that Abbasi had submitted an apology for undervaluing the set, which was accepted by the NAB chairman. The defence, however, criticised the expedited manner in which the FIA had filed its challan, stating that essential aspects of the investigation were overlooked. As the hearing progressed, the court observed that the Toshakhana case had faced significant delays, with over three years passing before its registration.—RT/Agency

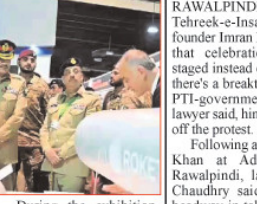

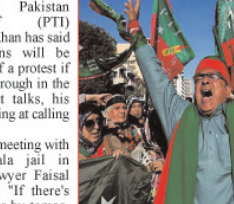

PTI Signals Potential Nov 24 Protest Cancellation If Talks Succeed

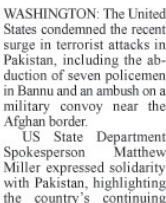


RAWALPINDI: Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan has said that celebrations will be staged instead of a protest if there's a breakthrough in the PTI-government talks, his lawyer said, hinting at calling off the protest. Following a meeting with Khan at Adiala jail in Rawalpindi, lawyer Faisal Chaudhry said: "If there's a headway in talks by tomorrow, there'll be celebrations instead of protests. Otherwise, we are prepared for peaceful demonstrations." The lawyer went on to say that the PTI founder has said that this was the second time he had given a protest call since the May 9 protest — which saw state installations being ransacked. Khan also said that there is no option left except for protests, emphasising that political parties are crucial in keeping the country united. The PTI founder also expressed concerns over restrictions faced by the party, saying, "We are not allowed to hold rallies or gatherings." "I have always called for peaceful protests," he claimed. The former premier fur-

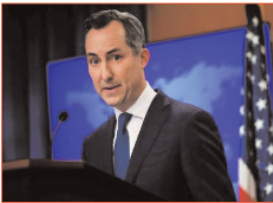


stated that he had given time for the negotiations until tomorrow. "Talks will only take place with those who hold the real power," the deposed prime minister's lawyer quoted him as saying. The cricketer-turned-batter, the lawyer said, reiterated that PTI's demands would form the basis of any dialogue and that the cancellation of protests depends on the acceptance of those demands. "It takes effort from both sides for progress to be made." Moreover, the PTI founder also clarified that reports of spending Rs1 billion on protests were baseless, Chaudhry added. US Denounces Escalating Militant Violence In Pakistan, Pledges Continued Support



WASHINGTON: The United States condemned the recent surge in terrorist attacks in Pakistan, including the abduction of seven policemen in Bannu and an ambush on a military convoy near the Afghan border. US State Department Spokesperson Matthew Miller expressed solidarity with Pakistan, highlighting the country's continuing struggle against terrorism and pledging continued counterterrorism cooperation. "We condemn these and all terrorist attacks," Miller stated during a press briefing. "The Pakistani people have suffered greatly at the hands of terrorists and violent extremists, and our hearts go out to the families and loved ones of those killed or impacted by recent attacks." Miller reiterated the United States' commitment to collaborating with Pakistan's government and institutions to counter militant threats. He emphasised the ongoing counterterrorism partnership, which includes high-



level dialogues and consultations to strengthen Pakistan's civil and military capabilities to detect, prevent, and respond to such threats. "We remain committed to engaging with government leaders and civilian institutions to identify opportunities to build capacity in detecting, preventing, and responding to threats posed by militant terrorist groups," he said. When asked about the role of militant groups based in Afghanistan, Miller underlined the need for bilateral cooperation but did not comment on specific actions against terrorist hideouts in Kabul. ISLAMABAD: The Supreme Court of Pakistan (SC) has annulled the Islamabad High Court's (IHC) decision in a case pertaining to allotment of plots to judges and bureaucrats in the federal capital's Sectors F-14 and F-15. The apex court accepted the Federal Government Employees Housing Au-



thority's plea while annulling the reserved verdict in the case. The court directed the IHC to review the matter. A three-member bench, headed by Justice Munib Akhtar, reserved the verdict on May 21. Justice Ayesha Malik announced the reserved decision.—RT/Agency

hinted at calling the PAC session itself, if the committee's meeting not being summoned formally. Senator Mandiwalla has requested the Speaker for help. "The members themselves elect the head until a permanent chairman being decided," the letter suggested. The Speaker has again asked the PTI to suggest its list of names for the PAC chair, sources said. "The PTI is insisting to make the party's Shaikh Waqas Akram as chairman of the public accounts committee," sources said. Former speaker Asad Qaiser has also held a meeting with Speaker Ayaz Sadiq over the matter. Sources while said that the PML-N has hinted at backing the People's Party for the PAC top seat.—RT/Agency

Haris Rauf surges ahead while Shaheen Afridi slides in ICC T20I Rankings



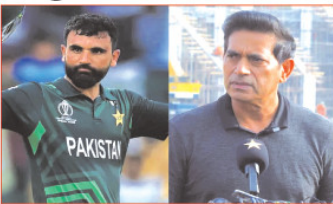

The Green Shirts suffered a humiliating whitewash in the three-match series against Australia, which resulted in Pakistani players' steep fall in the rankings.

Shaheen Afridi had a disappointing outing during the series, struggling to find his rhythm on the field. He managed to claim just one wicket, resulting in a frustrating bowling average of 107.00 and a high economy rate of 11.88 runs per over.

This below-par performance caused him to drop 10 spots to settle in the 24th position in the ICC T20I Bowling Rankings.

Aaqib Javed hints at Fakhar Zaman's long-awaited comeback



LAHORE: Aaqib Javed, the interim white-ball head coach of Pakistan, has discussed the potential return of top-order batter Fakhar Zaman to the national team on Wednesday.

Fakhar was excluded from the central contracts for the 2024-25 international season, as well as the squads for the tours to Australia and Zimbabwe last month.

However, Aaqib, who recently took charge as the interim head coach, heaped praise on Fakhar, calling him a match-winner.

The former pacer shared that Fakhar is dealing with some fitness issues and he will be back in the team once he achieves full recovery.

DUBAI: Pakistan batters Babar Azam and Mohammad Rizwan experienced a drop in their positions in the latest ICC T20I Batting Rankings released on Wednesday.

The Green Shirts suffered a humiliating whitewash in the three-match series, mainly courtesy of the team's below-par batting performance.

Babar managed a meagre 47 runs in the series at an average of 15.66 and a strike-rate of 142.42, meanwhile, Rizwan scored 16 runs in two games at a dismal strike-rate of 57.14. Consequently, both batters dropped one place each in the ICC T20I Batting Rankings.

Mohammad Rizwan is currently in 6th place with 719 rating points, while



Babar Azam has dropped from 4th to 5th place with 742 rating points.

It's worth noting that other than Babar and Rizwan, no Pakistani batter is among the top 50 batters in the T20I rankings, with Fakhar Zaman (64) being the third-highest-ranked batter from the country.

Meanwhile, Indian batter Tilak Varma made a massive leap in the ICC T20I Batting Rankings, jumping a whopping 69 spots to clinch third place after his stellar performance in the four-match series against South Africa.

Varma smashed two undefeated centuries in the series, amassing a total of 280 runs over the course of four innings with a remarkable average of 140.00 and an explosive strike rate of 198.58.

It's worth noting that Australia's Travis Head, who missed the series against Pakistan, is leading the batting rankings, followed by England's Phil Salt.

Varma's team-mate Sanju Samson, who was the second-highest run-scorer in the series against South Africa, also made a notable gain, rising 17 places to reach 22nd.

Samson also struck two centuries during the series and accumulated 216 runs at an average of 111 and a strike rate of 194.59.—Agency

Former Pakistan captain delivers harsh verdict on Sahibzada Farhan's potential



LAHORE: Former Pakistan captain Salman Butt has criticised top-order batter Sahibzada Farhan for his repeated failures in the recently concluded T20I series against Australia.

The Green Shirts suffered a humiliating whitewash in the three-match series, mainly courtesy of the team's below-par batting performance.

Farhan made his return to the team during the series, having last played in the T20I series against New Zealand earlier this year, however, he failed to impress particularly struggling against short-pitched deliveries.

In a dismal display of batting, he scored just 22 runs across three innings at a strike rate of 104.76, with his highest score being a mere nine.

However, what made his shortcomings even more remarkable was the identical nature of his dismissals in all three matches.

He consistently attempted to execute a pull shot against the short-pitched deliveries from Spencer Johnson, only to find himself caught by Xavier Bartlett at mid-wicket each time.

Salman Butt, in a video on his YouTube channel, after the third T20I, expressed his concerns about Farhan's struggles against pace and bounce.

"He was late on the ball. After getting out once or twice, a batter realizes that he's late on a particular shot, especially here (in Australia), where there is steep bounce and the new ball is coming at pace," said Butt. The former captain pointed out that Sahibzada Farhan failed to adjust his technique and kept getting out in a similar way, which highlights his limitations.

"You either avoid such deliveries or if you can't avoid them, you take a single towards third man on such short-pitched balls.—Agency

Head coach addresses Mercurial Babar Azam's future in men's T20Is squad

LAHORE: Newly-appointed head coach of Pakistan's white-ball cricket team Aaqib Javed touched on star batter Babar Azam's inclusion and position in the T20I team.

The former captain, who has been going through a tough patch across all formats of the game, also had an unimpressive run in the recent three-match T20I series against Australia where he only scored 47 runs at a meagre average of 15.66 and strike-rate of 142.42.

Aaqib while addressing the media in Lahore on Wednesday, was asked whether Babar would be considered for T20Is.

"Senior players like Babar and Rizwan have a value. They performed over the years for Pakistan," he said. Earlier, commenting on Babar's woes in the aforementioned series, former cricketer Basit Ali had claimed that the third T20I against Australia was the bat-



ter's last in the format, since Aaqib - one of the most vocal critics of star batter - had taken the reins of the white-ball side.

"As long as Aaqib Javed is the head coach, this may be Babar Azam's last T20 match," Basit had said during a local TV programme. "I am simply stating what is evident. You have a premium batsman averaging just 14 runs across three matches. What kind of batsman gets dismissed before the eighth over?" he had questioned.—Agency

Shoaib Akhtar confirms India's Champions Trophy 2025 tour to Pakistan



RAWALPINDI: In a recent interview with a local TV channel, former fast bowler and renowned cricketer Shoaib Akhtar, also known as the "Rawalpindi Express," expressed his belief that back-channel negotiations between Pakistan and India will eventually lead to India's participation in the Champions Trophy, despite the current uncertainties.

Akhtar emphasized the importance of not losing hope and waiting for a solution.

Akhtar pointed out the crucial role of India in the global cricket ecosystem, stating, "We all know that 95 to 96 percent of sponsorship in the International Cricket Council (ICC) comes from India, which is why the In-

dian board can exert pressure."

He added that the situation was not solely in the hands of the Pakistan Cricket Board (PCB) or the Board of Control for Cricket in India (BCCI) but ultimately depended on the governments of both countries.

He also raised a hypothetical scenario, saying, "Imagine Virat Kohli playing in Pakistan and scoring a century."

While Pakistan cannot host major events like the World Cup, the Champions Trophy could be a significant step towards such larger tournaments. I still believe the Indian team will come to Pakistan.—Agency

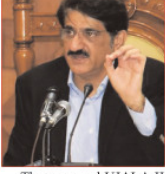

Murad Unveils New Park And Expanded Care For Children With Disabilities

Ji Karachi Accuses PPP Of Orchestrating Fake Mandate In By-Elections

KARACHI: Jamaat-e-Islami (JI) Karachi has accused the Pakistan People's Party (PPP) of securing a fraudulent mandate in the city's local council by-elections and demanded the resignation of the Election Commission official.

JI Karachi chief Munim Zafar Khan alleged irregularities in Li-aquatabad's UC-7, claiming that 9,727 voters were registered in a block with only 1,178 residents. "They are attempting to impose fake representatives on Karachi through such practices," he said, adding that JI plans to challenge the election results in court.

The JI leader also demanded the announcement of results in accordance with Form-11 and accused PPP of manipulating the polls. He revealed that JI has filed a petition with the Election Commission contesting the results of Model Town's UC-7 by-election. "We possess Form-11 and Form-12 for all 10 seats," Khan asserted, underscoring the party's commitment to pursuing justice against alleged electoral rigging.—RT/Agency

Murad Sounds The Alarm As Polio Cases Surge Across Sindh

KARACHI: Sindh Chief Minister Murad Ali Shah has voiced serious concerns over the increasing number of polio cases, revealing that out of 50 cases reported nationwide, 13 are from Sindh. Chairing a high-level meeting on polio eradication efforts, the CM was briefed by Health Minister Dr. Azra Fazal Pechuho, Chief Secretary Asif Haider Shah, and other key officials. It was disclosed that the affected areas in Sindh include Shikarpur (1), Kemari (2), Hyderabad (2), East Karachi (1), Sajawal (1), Malir (1), Jacobabad (2), Mirpurkhas (1), Sanghar (1), and Ghotki

and 205,531 children absent during the drive. Expressing dissatisfaction, CM Shah directed district commissioners and senior police officers to personally oversee vaccination efforts in areas with refusal cases. "Refusals will no longer be tolerated. I want 100% vaccination coverage," he asserted, warning that any official showing negligence would face dismissal.

The provincial government has intensified efforts to combat polio, with a renewed focus on reaching every child and eliminating gaps in immunisation.—RT

Police Crack Down After Land Encroachment Clash In Rind Village

KARACHI: In a crackdown against land encroachments in Rind Village near Bhains Colony, police forces, along with anti-encroachment teams and revenue officials, launched an operation that involved demolishing houses, fences, and walls. The operation faced strong resistance from local residents, leading to a tense standoff. The police responded with baton charges resulting in the arrest of 10 individuals. The incident

took place in the jurisdiction of Sukhan Police Station near the Labor Square area of Rind Village. The operation targeted illegal land occupations, with the authorities demolishing walls, fences, and several homes. As news of the operation spread, a large number of local residents gathered to resist the action, resulting in a violent confrontation. According to the authorities, the operation was part of an ongoing effort to reclaim government land from illegal occupants. Malir District Administrator, Mukhtiar Ibrahim Hyderi, along with anti-encroachment officials, stated that anyone found occupying government land illegally would be dealt with. However, local residents claimed that they were being unfairly treated and that police and revenue officials were forcibly seizing their land.

Karachi Airport And Surrounding Areas Declared High-Security Red Zone

Travelers heading to the airport are urged to carry their flight tickets and national identity cards to streamline security checks. All passengers are advised to arrive well in advance to ensure smooth processing and avoid delays.

Officials have emphasized vigilance at all checkpoints, with strict monitoring of suspicious individuals and vehicles to maintain security during the event.—RT/Agency

Shehbaz Reaffirms Commitment To Eradicating Polio From Pakistan

ISLAMABAD: Prime Minister Muhammad Shehbaz Sharif reaffirmed commitment to becoming a polio-free nation, emphasizing the joint efforts of the federal and provincial governments in the fight against the disease.

Speaking on Wednesday, the Prime Minister assured that all provinces were fully aligned and taking decisive steps towards the eradication of polio.

"The federation, along with all the provinces, is taking active measures for polio eradication," Sharif said, adding that all provincial governments had been brought into confidence regarding the strategy to combat the disease.

He expressed his confidence that with coordinated efforts, the nation would successfully eliminate polio.

A high-level delegation from the Polio Oversight Board, including key representatives from global health organisations, met with the Prime Minister to discuss ongoing efforts.

The delegation comprised Christopher Elias,



representative of the Bill and Melinda Gates Foundation, Rotary Foundation, UNICEF, and CDC, all of which have been instrumental in the campaign.

"These global organisations have played a significant role in our battle against polio," Sharif said.

"We are confident that with their continued support, we will overcome this challenge and rid the country of this debilitating disease once and for all."

The delegation praised Pakistan's commitment and progress towards polio eradication. Bill and Melinda Gates representatives noted that the country's current anti-

polio strategy had been effectively implemented and that positive results were beginning to show.

Dr Hanan Balkhy stressed the need for strengthened regional cooperation to combat public health challenges, including polio. She urged neighbouring countries to maintain dialogue and share resources for a more unified approach.

In response to the challenges posed by the disease, the Prime Minister's office confirmed that a third-party audit of the polio eradication drive had been conducted as part of the ongoing evaluation. The government has focused on ensuring proper care for polio-affected children, while polio vaccination rates in areas with previously low coverage have shown significant improvement.

The meeting concluded with renewed optimism, with the Prime Minister and global partners reaffirming their collective goal to eradicate polio and protect future generations.—RT/Agency

Apologetic Fawad Chaudhry Seeks Reconciliation In ECP Contempt Case

ISLAMABAD: Former federal minister Fawad Chaudhry has pleaded for an apology in the contempt of the Election Commission of Pakistan (ECP) case.

During the hearing, Chaudhry requested the ECP to solve the matter through an apology, Express News reported.

A four-member ECP bench, led by Member Sindh Nisar Durrani, heard the case in which Fawad appeared and stated that he had already apologised in three related cases.

"I have submitted apologies for these cases," Fawad Chaudhry said. However, Justice Ikramullah, a member of the ECP, reminded him that charges were to be framed today.

In response to a question from the ECP, Fawad requested that the matter be resolved with an apology. "Sir, please settle this with an apology," he pleaded. The ECP member responded, "Are you saying the same thing outside as well, or has something changed?" Fawad retorted, "These days, you are not paying attention."

The commission member said, "The witnesses have arrived in this case; let them mark their attendance."

Fawad Chaudhry replied, "You forget others' matters, but you remember mine." Afterward, the Election Commission adjourned the hearing.

Fawad Chaudhry said after the hearing that if a resolution is found through negotiations, it could improve politics. He added that the Pakistani ambassador in the US had opened the doors for Pakistanis, highlighting that political and human relations are interconnected.

He further claimed that there is no government of elected representatives in Pakistan at the moment.

A prime minister with only 18 seats has come to power. Fawad also noted that the founder of PTI had announced a protest on November 24, stressing that this

protest is not limited to one party or individual, but is for all Pakistanis.

Fawad Chaudhry mentioned that if a solution is found through negotiations, it would lead to improvement in politics. He urged that such negotiations should not be seen as a compromise. The release of political prisoners, he added, is an issue in line with Pakistan's constitution, and they will continue their struggle for the restoration of the constitution and rule of law.

He concluded by saying that the final decision regarding the protest is expected by Thursday. If talks take place, it could lead to a decrease in the political temperature. The founder of PTI currently has three demands: the return of the mandate, the 26th constitutional amendment, and the release of political prisoners.—RT/Agency

Deadly Suicide Attack In Bannu Claims Lives Of 12 Valiant Security Personnel



BANNU: At least 12 security personnel were martyred in a suicide attack in Khyber Pakhtunkhwa's (KP) District Bannu, the Inter-Services Public Relations (ISPR) said on Wednesday.

The military's media wing, in a statement, said that terrorists or "khawari" attempted to attack a joint check post in the general area of Mali Khel in Bannu on November 19 (Tuesday).

"In [the] ensuing fire exchange, six terrorists were sent to hell," the statement read, adding that the attempt to enter the post was effectively thwarted by the troops, which forced the attackers to ram an explosive-laden vehicle into the perimeter wall of the post.

Explaining the attack further, the military's media

wing said that the suicide blast led to the collapse of a portion of the perimeter wall and damaged the adjoining infrastructure.

This, the ISPR said, resulted in the martyrdom of 12 brave sons of soil that included 10 soldiers of the security forces and two soldiers of Frontier Constabulary.

Following the attack, the statement mentioned, a sanitisation operation was being conducted in the area and the perpetrators of this heinous act would be brought to justice.

"Security forces and law enforcement agencies of Pakistan are determined to eliminate the menace of terrorism and such sacrifices of our brave men further strengthen our resolve."—RT/Agency

Naemi Clarifies Controversial VPN Statement As CII Typographical Blunder

ISLAMABAD: As the federal government gears up for a crackdown on unregistered virtual private networks (VPNs), Council of Islamic Ideology (CII) Chairman Dr Raghbir Hussain Naemi clarified on Wednesday that this was a "clerical error" in its previous statement which caused confusion that the use of these encrypted networks is against the sharia.

"No one has declared the VPNs against sharia or un-Islamic," said Naemi in a press conference in Islamabad, adding: "A typing error in our previous statement created a misunderstanding after 'not' was omitted from it."

This formal statement came after the council's November 15 fatwa (Islamic decree) declaring the use of VPNs "un-Islamic" drew much criticism from different quarters.

He said that the council held a session to discuss the use of social media in the country in light of the Islamic principles.

Elaborating on the CII's stance on using social media platforms, Naemi said that these platforms are effective



mediums of public expression, however, they should not be used for blasphemy, religious hatred, extremism, and terrorism.

"If these regulations are being violated, then the use of social media will be un-Islamic," the cleric said.

Earlier this week, the CII chairman had given a clarification regarding the body's decree for the private gateways, saying its nature as being Islamic or un-Islamic mainly depended on its usage.

"No matter if VPN is registered or unregistered, it will be un-Islamic if it is used for indecent content and false propaganda," said Naemi speaking on Geo News morning show, "Geo Pakistan".

It is noteworthy to mention here that the Pakistan Telecommunication Authority (PTA) has extended grace period for unregistered Virtual Private Networks (VPNs) until November 30.

The decision comes amid increasing concerns over the misuse of unauthorised VPNs for illicit activities, including bypassing internet restrictions and accessing prohibited content.

Starting December 1, a nationwide crackdown on unregistered VPNs.

A successful trial of VPN blocking has already been conducted, and a second trial is planned in the coming days to ensure readiness for the full-scale shutdown, as per sources.—RT/Agency

SC Judge Highlights Pakistan Judiciary's Alarming Global Reputation

ISLAMABAD: Supreme Court Justice Jamal Khan Mandokhail has expressed annoyance over global bodies' rankings of Pakistan's judiciary, which place it extremely low.

"I do not know where these numbers emerge from. Some place our judiciary on 120 while others on 150," he said during a hearing conducted by the constitutional bench over litigants' lack of access to the apex court.

World Justice Project's Rule of Law index for the year 2024 shows Pakistan's global ranking at number 129 out of a total of 142 countries assessed, which is a slight improvement from the previous year.

Justice Mandokhail is part of the constitutional bench—led by Justice Amin-ud-Din Khan—formed under the 26th Constitutional Amendment, highlighting the challenges faced by the public in seeking justice.

Apart from Justices Khan and Mandokhail, the bench includes five other members—Justice Ayesha Malik, Justice Muhammad Ali Mazhar, Justice Hassan Azhar Rizvi, Justice Naem Akhtar Afghan, and Justice Musarrat Hilali.

Multiple pleas were heard by the constitutional bench today, which included a lack of petitioners' access to SC and government employees



who were not assigned duties. A petition was also heard against declaring the Sunni Itehad Council (SIC) as a parliamentary party.

The SC heard a petition regarding the lack of access for litigants to the country's highest court.

During the proceedings, the petitioner argued that 90% of litigants are unable to approach the Supreme Court, highlighting the challenges faced by the public in seeking justice.

Responding to the claim, Justice Mandokhail remarked that the petitioner's arguments were being heard directly, questioning what further access was required.

Justice Mandokhail also expressed annoyance, stating that such petitions undermine the institution itself.

Referring to international rankings, he noted that while some claim Pakistan's judi-

ary ranks 120th globally and others 150th, it remains unclear where these figures originate.

After deliberation, the constitutional bench ultimately dismissed the petition.

Moving on, the seven-member bench heard a petition challenging the declaration of the SIC as a parliamentary party.

The petitioner argued that the petition had been submitted within the prescribed time frame; however, now a review plea was currently pending.

The petitioner also requested the court to consider this matter in connection with other relevant cases.

In response, Justice Mandokhail questioned the petitioner's intent, asking why they were seeking an unconstitutional action from the court.—RT/Agency

Justice Ayesha Excluded From Military Trial Appeal Bench

ISLAMABAD: The Supreme Court's three-member constitutional committee has removed Justice Ayesha Malik from the seven-member constitutional bench hearing intra-court appeals related to military court trials of May 9 suspects.

The third meeting of the constitutional committee, chaired by Justice Amin-ud-Din Khan, was held with Justices Jamal Khan Mandokhail and Muhammad Ali Mazhar also in attendance, media reported.

Minutes from the meeting have been released.

During the meeting, the scheduling of cases related to civilian trials in military courts was reviewed.

According to the minutes, Justice Ayesha Malik had already heard the May 9 military court case. Consequently, the appeal against the decision remains pending before a seven-member intra-court appeal bench, which will now hear the case.

The matter concerning military courts has been referred to the Judicial Commission, which will nominate the seventh member for the bench.



The meeting decided to establish a separate branch for constitutional cases and to implement green tagging for categorising such cases.

It was also decided that under Article 186-A, the Supreme Court has the authority to transfer cases from one High Court to another.

Furthermore, the constitutional bench judges will hear five chamber appeals daily, and to manage the growing workload, the nominated constitutional judges will seek the assistance of civil judges. The responsibility for the procedures and regulations of the constitutional bench has been assigned to the Registrar. Based on the

advice of Justice Muhammad Ali Mazhar, the Registrar of the Supreme Court will establish the rules and regulations. The Constitutional Bench Committee has requested the assistance of a civil judge to reduce the workload. Until the rules are finalised, all urgent hearing requests will be presented to the Constitutional Bench Committee. The Supreme Court may refer cases with substantial constitutional and legal questions to the Constitutional Bench. The judges' committee has decided to establish a separate branch within the Supreme Court for the Constitutional Bench.—RT/Agency

Siddiqui Updates PM On Senate Parliamentary Party's Milestones



ISLAMABAD: Senior PML-N leader and chairman of Senate's standing committee on Foreign Affairs Irfan Siddiqui on Wednesday called on Prime Minister Shehbaz Sharif in Islamabad.

Irfan Siddiqui briefed the prime minister regarding the performance of parliamentary party in the Senate.

The PML-N leader also lauded the prime minister on achieving the major economic targets.

"The senators of PML-N are playing a great role in the upper house of parliament under the leadership of Irfan Siddiqui," said the prime minister. Shehbaz Sharif directed

Irfan Siddiqui to remain in touch with other political parties as well in the upper house of the parliament.

He hoped that the Senate's standing committee on Foreign Affairs would guide the government on key issues related to diplomacy.

Earlier, Senator Irfan Siddiqui expressed skepticism about the PTI founder's 13th "final call" for a revolution, predicting it will likely to meet the same fate as his previous 12 such attempts since his ouster following a no-confidence vote.

He said that the PTI's four-year tenure was the worst period in Pakistan's history.—RT/Agency
