## Hyderabad Police Nab Three in Security Operation

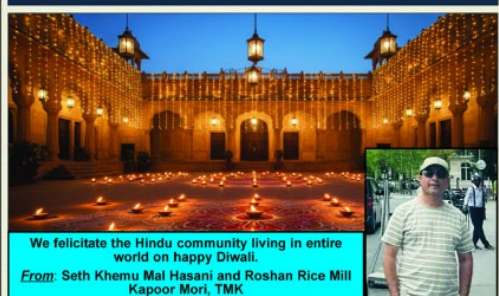
## Ghotki DC Orders Daily Anti-Mosquito Fogging Across UCs

## MDCAT 2025 Test Centers Announced Nationwide

ISLAMABAD: The Pakistan Medical and Dental Council (PMDC) has announced test centers for the Medical and Dental College Admission Test (MDCAT) 2025, scheduled for October 26. In Karachi, tests will be held at Dow University (Ojha Campus) and NED University, while in Islamabad, the venue is the Pakistan National Council of Arts. Centers have also been set up in Hyderabad, Jamshoro, Sheeraz, Benazirabad, Mirpurkhas, Larkana, Jacobabad, and Sukkur. A total of 35 centers will operate nationwide, including one international center in Riyadh, Saudi Arabia.—RT/Agency

## Chaiwala Arshad Khan's CNIC Restored After Legal Battle

LAHORE: Social media star Arshad Khan, famously known as 'Chaiwala', has had his computerised national identity card (CNIC) reinstated by the National Database and Registration Authority (Nadra) after a verification process, the Lahore High Court (LHC) confirmed on Monday. Khan, who gained global attention in 2016 for a viral photo of him serving tea, had filed a case in April after Nadra and the Directorate General of Immigration and Passports blocked his identity documents. The court's ruling ends his legal struggle.—RT

## Over 43.7 Million Children Vaccinated in Massive Polio Campaign: NEOC

ISLAMABAD: National Emergency Operations Centre (NEOC) on Sunday said that during the first six days of the nationwide campaign, more than 43.7 million children have been vaccinated against polio.

According to the National Emergency Operations Centre (NEOC), in Punjab, over 23 million children received the vaccine, while in Sindh, more than 10.4 million children were immunized.

In Khyber Pakhtunkhwa, more than 6.16 million children were vaccinated, followed by 2.58 million in Balochistan, 466,000 in Islamabad, 294,000 in Gilgit-Baltistan, and 733,000 in Azad Jammu and Kashmir, NEOC added.

## TikTok Deletes 25 Million Videos in Pakistan Amid Ongoing Controversies

ISLAMABAD: TikTok removed over 25 million videos in Pakistan during Q2 of 2025, citing violations of community guidelines, according to its latest report. The platform has faced repeated bans by Pakistan's Telecommunication Authority (PTA) for immoral content, with the first ban occurring in October 2020. Despite reassurances to block inappropriate accounts, the platform continues to grapple with content regulation issues, as evidenced by the massive volume of video removals.—RT

## IHC Gives Police 3-Day Ultimatum to Recover Abducted NCCIA Official

ISLAMABAD: The Islamabad High Court (IHC) on Monday ordered police to recover Muhammad Usman, allegedly abducted by armed men on October 14. ## China Hits Back: Adopts US-Style Tactics in Escalating Trade War with Washington

WASHINGTON: China likes to condemn the United States for extending its arm too far outside of its borders to make demands on non-American companies. But when it sought to hit back at the US interests this month, Beijing did exactly the same.

In expanding export rules on rare earths, Beijing for the first time announced it will require foreign firms to obtain approval from the Chinese government to export magnets containing even tiny amounts of China-originated rare earth materials, said James Greer, the US trade representative. "This rule gives

direct product rule. It extends the reach of U.S. law to foreign-made products, and it has been used regularly to restrict China's access to certain U.S. technologies made outside of the United States, even when they are in the hands of foreign companies.

It is the latest example of Beijing turning to U.S. precedents for tools it needs to stare down Washington in what appears to be an extended trade war between the world's two largest economies.

"China is learning from the best," said Neil Thomas, a fellow on Chinese politics

at Asia Society Policy Institute's Center for China Analysis. "Beijing is copying Washington's playbook because it saw firsthand how effectively U.S. export controls could constrain its own economic development and political choices."

He added: "Game recognizes game."

It was in 2018, when President Donald Trump launched a trade war with China, that Beijing felt the urgency to adopt a set of laws and policies that it could readily deploy when new trade conflicts arise. And it looked to Washington for ideas.—RT/Agency

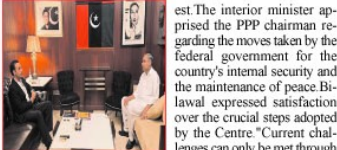

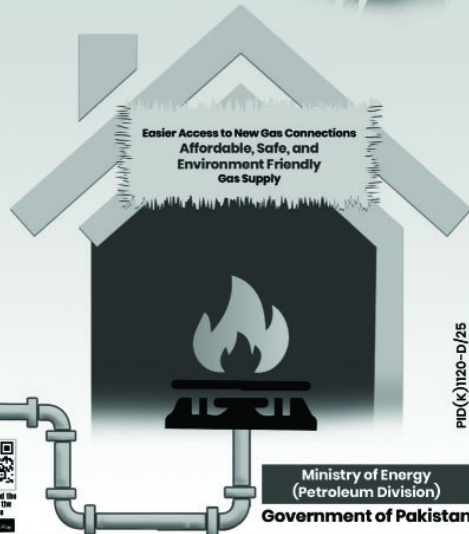
